

The Servants of India Society

PREAMBLE

Extracts from the original Preamble to the Constitution of the Society written by the illustrious founder the late Gopal Krishna Gokhale, in 1905.

For some time past the conviction has been forcing itself on many earnest and thoughtful minds that a stage has been reached in the work of nation-building in India when, for further progress the devoted labours of a specially trained agency applying itself to the task in a true missionary spirit are required. The work that has been accomplished so far has indeed been of the highest value. The growth during the last fifty years of a feeling of common nationality based upon common traditions and ties, common hopes and aspirations, and even common disabilities has been most striking. The fact that we are Indians first, and Hindus. Mahommedans, Parsees or Christians afterwards is being realised in a steadily increasing measure, and the idea of a united and renovated India marching onwards to a place among the nations of the world, worthy of her great past, is no longer a mere idle dream of a few imaginative minds, but is the definitely accepted creed of those who form the brain of the community-the educated classes of the country. A creditable beginning has already been made in matters of education and of local self-government; and all classes of the people are slowly but steadily coming under the influence of liberal ideas. claims of public life are every day receiving wider recognition, and attachment to the land of our birth is growing into a strong and deeply cherished passion of the heart. The annual meetings of Congresses and Conferences, the work of public bodies and associations, the writings in the columns of the Indian Press — all bear witness to the new life that is coursing in the The results achieved sofar are unveins of the people. doubtedly most gratifying, but they only mean that the jungle has been cleared and the foundations laid. The great work of rearing the superstructure has yet to be taken in hand, and the situation demands on the part of workers devotion and sacrifices proportionate to the magnitude of the task.

The Servants of India Society has been established to meet in some measure these requirements of the situation... Much of the work must be directed towards buildings up in the country a higher type of character and capacity than is generally available at present, and the advance can only be slow. the path is beset with great difficulties; there will be constant temptations to turn back; bitter disappointment will repeatedly try the faith of those who have put their hand to the work-But the weary toil can have but one end, if only the workers grow not faint-hearted on the way. One essential condition of success in this work is that a sufficient number of your countrymen must now come forward to devote themselves to the cause in the spirit in which religious work is undertaken. Public life must be spiritualised. Love of country must so fill the heart that all else shall appear as of little moment by its side. A fervent patriotism which rejoices at every opportunity of sacrifice for the motherland, a dauntless heart which refuses to be turned back from its objects by difficulty or danger, a deep faith in the purpose of Providence which nothing can shakeequipped with these, the worker must start on his mission and reverently seek the joy which comes of spending oneself in the service of one's country.

The Servants of India Society will train men, prepared to devote their lives to the cause of the country in a religious spirit and will seek to promote, by all constitutional means the national interests of the Indian people. Its members will direct their efforts, principally towards (1) creating among the people by example and by precept, a deep and passionate love of the motherland, seeking its highest fulfillment in service and sacrifice; (2) organizing the work of political education and agitation, basing it on a careful study of public questions and strengthening generally the public life of the country; (3) promoting relations of cordial goodwill and co-operation among the different communities; (4) assisting educational especially those for the education of women, the education of backward classes and industrial and scientific education: (5) helping forward the industrial development of the country;

(6) the elevation of the depressed classes.

The Servants of India Society places on record its profound grief in passing away of Shri S. R. Venkataraman, its President and Shri R. S. Misra, former Vice-President on the 30th December, 1985 and 17th February, 1986 respectively.

Shri S. R Venkataraman

Shri S. R. Venkataraman was born on 17th March. 1887. After taking his Law Degree in 1924, he joined the Bar at Coimbatore in 1925. He joined the Society in 1929 and during his fifty-six years of membership of the Society he worked ceaselessly in various fields of public activity, political, social, educational and cultural. He was Commissioer of Scout at Madras, Secretary of Depressed Classes Mission (Manglore), Assistant Secretary of the All India Harijan Sevak Sangh, Hon. Secretary of the Indian Council of World Affairs (Madras Branch). Vice-President of the Indian Conference of Social Work, Vice-President of the Guild of Service, Madras.

He wrote many books in Tamil and English. Among these are Grandpapa Gandhi's Story, Dr. M. G. Ranade, Dr. Annie Besant, Tribes of India, What is Indian Scouting etc. He translated "Jawaharlal Nehru's Letters to his Daughter" in Tamil, which was prescribed as a Text-Book by the Madras University. Every year, he brought out "Gokhaleana" and "Sastriana". Shri Venkataraman was elected President of the Servants of India Society in June 1978. In his death the Society has lost a sincere and dedicated Member.

Condolence meetings were held by various Organisations in Madras and resolutions were passed eulogizing his services in various fields. "With the exit of Mr. S. R. Venkataraman, President of the Servants of India Society, the last link with Gokhale-Sastri tradition in public life and social work in Madras is snapped", reported the Hindu of Madras. "Informed patriotism and unostentatious" service, with a sense of duty, were the hallmark

of the life and career of Mr. Venkataraman, who had the rare opportunity of being an understudy of the Rt. Hon. V. S. Srinivasa Sastri and later of Pandit H. N. Kunzru", acclaimed the Hindu. Shri R. Venkataraman, Vice-President of India said in his condolence message, "It is with great sorrow that I have learnt of the sad demise of Shri S. R. Venkataraman. I had the good fortune of knowing him for five decades. His self-abnegation, sincerity and total dedication in the best traditions of the Servants of India Society will for ever be model of selfless service".

Shri R. S. Misra

Shri R. S. Misra, former Vice-President of the Society, was practising advocate before he joined the Society in 1937

Shri Misra was Chairman of the Sarsa Town Area Committee for a number of years. He had occupied the positions of Chairman of the Central Marketing Society of Small Farmers and also of the Co-operative Society of Tanners at Sarsa. He started aboriginal welfare work in 1947 in Mirzapur District of Uttar Pradesh and thereafter was constantly engaged, among other things, in welfare activities for the trible people in Mirzapur; Allahabad and Nainital. He primarily devoted his attention to the starting of schools, libraries, dispensaries, Women's Welfare Centres etc., in the tribal areas. He was a Member of the Executive Committee of the Bharativa Adim Jati Sevak Sangh, a Member of various Committees and boards relating to the tribal people set up by the U. P. Government, General Secretary of the All India Seva Samiti, Allahabad and a Member of the Committee set up by the Khadi and Village Industries Commission for starting Welfare Work in the Indo-Tibetan border area. He was elected Vice-President of the Servants of India Society in 1978. In the death of Shri R. S. Misra, the Society has lost a person of great abilities and of enterprising nature.

The Society offers its sincere condolences and sympathies to members of bereaved families.

Report For 1985-86

Introduction

The Servants of India Society was founded by Gopal Krishna Gokhale on June 12, 1905. Its objects are the training of national missionaries for the service of India and the promotion by all constitutional means, of the interests of the Indian people without distinction of caste or creed. The members of the Society are pledged to give throughout their lives the best that is in them to the cause of the country in all secular fields. The circumstances in which the Society was founded and the objects, which the Founder had in view in founding it, are explained in the preamble he wrote to its constitution in 1905, extracts from which are given in the preceding two pages. The preamble has been a source of inspiration to the Society during the eighty—one years of its existence.

Organisation

The Headquarters of the Society are at Poona, where the members meet every year in June for its annual session. The Society has branches in Madras, Bombay, Nagpur, Allahabad and Cuttack.

Shri S. S. Misra was elected President of the Society after Shri S. R. Venkataraman, who passed away on 30th December 1985. Dr. R. G. Kakade continued to be Vice-President of the Society. Shri S. S. Misra, Dr. R. G. Kakade, Shri S. S. Ajgaonkar and Shri P. K. Dwivedi continued to be Senior Members of the Society's Branches in Cuttack, Nagpur, Bombay and Allahabad respectively. Shri Damodar Sahoo, Shri A. N. Misra and Shri R. V. Neve were elected to the Council by the members of the Society. Shri S. S. Ajgaonkar was also Secretary of the Society.

Gokhale Day

Shri S. S. Misra spoke on the occasion of the 120th Jayanti of the founder of the Society on 9-5-86 at Cuttack which was

presided over by Dr. Sadasiv Misra, Ex-Vice-chancellor of the Utkal University. The distinguished speakers on the occasion were Messrs M. Ahamed, (Retired I. A. S. & President of the Urdu Library, Cuttack), Shri G. N. Das, M.A.LL.B. & a well-known anthropologist & Dr. Hrudananda Roy, Vice-Principal of the Revenshaw College, Cuttack. Shri Damodar Sahoo read out a report on the different welfare activities of the Orissa Branch of the Society.

L. N. Sahoo Day

Shri Damodar Sahoo organised the 23rd death anniversary of late lamented L. N. Sahoo and the 12th Foundation Day of the Destitute Children's Home at Choudwar on 18-1-1986. Dr. Kunja Bihari Das a well-known litterateur of Orissa acted as the Chief Guest on the Occasion and the meeting was presided over by Shri Bichitrananda Kar, Editor of Matrubhumi, an Oriya daily of Cuttack. Shri S. S. Misra spoke on the occasion.

Thakkar Bapa Jayanti

The 116th Birthday Anniversary of Thakkar Bapa was observed at Thakkar Bapa Ashram in Rayagada (Orissa). The programme of the Day included a procession of all students through the town, lunch to students and guests and a public meeting in the evening. Shri J. K. Panigrahi presided over the meeting which was addressed by Shri Madanmohan Sahoo and Shri S. K. Pattnaik. The function concluded with entertainment programme by inmates of the Ashram.

General

Shri S. S. Misra published an article, written in oriya, in the important language dailies of Orissa giving an account of the views of his eminent contemporaries on Gopal Krishna Gokhale on the occasion of his 120th Jayanti. He wrote articles in many oriya dailies criticising the Central budget and characterised it as anti-socialist and therefore violative of the directive principles of the constitution of our Country. Under the caption 'a beautiful combination of simplicity and scholarship', he wrote an article, in oriya, giving an account of the achievements and the simple life of the late Prof. D. R. Gadgil whom he had the privilege of knowing since 1936. This article was published in the souvenir volume of the 'Samaja' on the occasion of the 57th death anniversary or late Pandit Gopabandhu Das.

Shri Damodar Sahoo wrote articles in local news-papers of Cuttack and addressed meetings at N. C. C. and Scout Camps. He spoke at the 87th Birth Anniversary of Dr. H. K. Mehtab at Rayagada. He took active part in activities organised by the Rotary Club, Choudwar of which he was Director of Community Service.

The members of the Orissa Branch of the Society condemned the dastardly attack on Dr. Radhanath Rath, President of the Servants of People Society and his friends as they were returning to Cuttack after attending a public meeting in the Puri District of Orissa. The Orissa Branch of the Society strongly demanded a judicial enquiry into the whole incident.

- Shri R. G. Kakade was re-elected Chairman of the Pune District Industrial co-operative Association. The Association conducts one handloom cloth shop, mill cloth shop and handicraft emporium at Pune and one hides and skin shop for leather workers in Baramati. As the Chairman of D. I. C. A. Shri Kakade was a member of the Zilla Parishad of Pune. Shri Kakade was honoured by the Yeravada Gadi Wadar Majdur Society which presented to him a crowbar and a hammer of silver plate at the meeting held in November 1985. Shri Kakade founded the Society in December 1985.
- R. G. Kakade was a member of the Board of Management of the Gokhale Institute of Politics and Economics, Pune. He attended all the meetings of the internal committee of the institute.

He continued to be Hon. Secretary and a Trustee of the Institute of Regional Development and Planning at Nagpur.

He continued to be Hon. Treasurer of the Maharashtra Association for the cultivation of Science, Pune. In that capacity he was a member of the Executive Committee, the Budget Committee and the Building Committee. He attended all the meetings of the Association during the year.

He continued to be the Chairman of Padmasri Dr. Vithalrao Foundation at Pravaranagar. The Foundation conducts an Engineering college and a poly-technic at Ahmednagar and a poly-technic in Parner taluka of Ahmednagar.

Shri Kakade continued to be the Chairman of the Academy of Education and youth Services, Pune. During the year under report the Academy conducted number of camps at Pune and Taluka towns to mark the International Youth Year.

He continues to be the Chairman of the Canara Welfare Trust. He is the Managing Trustee of Justice Mahadev Govind Ranade Charitable Trust. The trust distributes small donations to about 50 institutions in Pune, Bombay and other places.

Shri Kakade is Hon. Secretary of the Town Planning Study Group of the Gokhale Institute of Politics and Economics. He was re-elected Chairman of the District Probation and Aftercare Association which conducts two Remand Homes, one for Boys and other for girls. He continued to be the Vice-President of the Maharashtra State Probation and Aftercare Association. He continued to be one of the Hon. Secretaries of the Society for the Welfare of the Physically Handicapped at Wanawdi. continued to be a member of the Managing Committee of the Mahila Seva Mandal, Pune. He continued to be a member of the Managing Committee of Navajeevan Mandal which works for the rehabilitation of the released prisoners. He continued to be a member of the David Sassoon Asylum. Shri Kakade is Trustee of the Late R. P. Paranjpe Trust and continued to be a member of the Gokhale Elocution Competition Committee of the Nowroji Wadia College.

Shri S. S. Ajgaonkar continued to be a Secretary of the Bombay Social Reform Association, a non-political and non-party organisation, founded by the late Justice Narayan G. Chandavarkar and other fellow workers of Justice Ranade after his death in 1903. It was an offshoot of the National Social Conference started by the late Justice Ranade in 1887. The Association which stands for elimination of such disruptive forces as casteism communalism and others, and for complete social and national integration, has a distinguished record of service for the furtherance of social reforms in the country. It has played a valuable part in bringing many beneficial measures on the statute book.

During the year under report, the Association submitted its recommendations to the Government with regard to 'Reservation Policy'. The Association also held a meeting to arouse public opinion against the Government of India's proposal to place on the statue book the Muslim Women Bill 1986. The Association published its considered opinion that the bill was a retrogate step and was against the secular character of the Constitution. It apprehended that the Bill would set in separatist tendencies in India and thus would create a formidable challenge to National Integrity. The Association expressed its opinion that the provisions of the Bill were violative of Articles 14 & 15 of the Constitution and if struck down by the Supreme Court would once again involve the Supreme Court of India into unnecessary contraversy. The Association appealed to the Government of India to take steps to create public opinion in favour of the uniform Civil Code and to remember that the directive principle (Art. 37) of the Constitution regarding uniform Civil Code is fundamental in the governance of the country and that it was the duty of Government to apply these principles while making laws.

The Association conducts G. L. Mehta Project for Education and Cultural enterprise; with the object of spreading formal as well as social education in villages, conducting and aiding schemes which would induce villagers to undertake more construtive approach towards life. Under this project, hearing-aid

apparatus were given to the needy children from the Central School for the Deaf, Bombay and School Uniforms to the students of Jambulpada (District Raigada) and Chaddars to Adivasi Boarding at Maneri.

Dr. P. K. P. Nair helped prepare a booklet on Organic Farming on the basis of seminar discussions and with requested contributions. The booklet is under publication. Nair took up for intensive study and propogation, the topic, the Preservation of India's Genetic Resources, Base and consequently of the problem of a grave nature created by the vanishing base of our rich genetic foundations of rather ingenious varieties. The emphasis was mainly on grains, cattle and trees. He also participated in a few meetings on the subject.

Dr. Nair conducted a few classes for two courses on National Integration held in Sevagram. The first course was for candidates from Maharashtra, Madhya Pradesh and Gujarat, and they were sent to the Southern States for a month after which they reassembled for further discussions. The Second course was for candidates from Andhra Pradesh, Tamilnadu and Karnataka and they were sent to places in the noth before they reassembled.

Dr. Nair participated in the All India Constructive Workers Conference at Sevagram organised by the Gandhi Smarak Nidhi of New Delhi. He attended a seminar on Goraksha convened at New Delhi by the Gorakshan Samiti of India.

Dr. Nair spoke twice upon request before a conference of the Progressive and People Oriented Science and Technology (PPST) group of academicians and research workers held in Sevagram. The subjects on which he spoke were; the Concept of the Village and on the Alternate Models of Development available for consideration to the Government of India at the time of the setting up of the Planning Commission.

Dr. Nair conducted a few Study Circles on the three connected themes, namely, (1) The elements and working of a

non-exploitative politico-socio-economic system, (2) The functioning of the present economic system in India and the open and concealed points of its exploitaive nature and (3) The steps available to the Indian Polity to move from the second to the first of the positions indicated above.

Dr. Nair addressed the All India Catholic Christian Social Workers Conference held at Sevagram on the subject: The Tests to be applied in Rural Development Programmes. The tests are for satisfying that the programmes would not lead to the strengthening of any existing exploitative ventures or aspects of the economy.

Education

Shri Madhusudan Sahoo undertook the Sadachar Shikshan Programme for School Students of Orissa. During the year 1985/86 he visited 50 Schools in the District of Cuttack, met around 6,500 students in 58 meetings and discussed with them topics ralating to the values of life. During his discussions he referred to incidents from the lives of Mahatma Gandhi, Gopal Krishna Gokhale, Ramakrishna Paramhansa, Swami Vivekananda and other saints and patriots of the Country.

- Dr. P. K. P. Nair participated in the Maharashtra Educational Reforms Conference organised at Sevagram under the auspices of the Government of Maharashtra.
- Dr. Nair attended two camps conducted at the instance of the Government of Maharashtra for the trasning of teachers of non-formal and adult education.
- Shri A. N. Misra managed Dr. Kunzru Nursery and Primary School on the Society's premises at Allahabad with 400 students on its role with nine qualified teachers.
- Shri S. S. Misra continued to work as a member of the Board of Trustees of the Kala Vikas Kendra, a well-known institution of Orissa for the promotion of music, dramatics and

dance. He attended all the meetings of the Board of Trustees which discussed and took decisions on many administrative matters relating to the Kendra.

As secretary of the Bhoksa Gram Vikas Samiti Shri P. K. Dwivedi convened its several meetings at Bazpur.

As Astt. Manager of the Adarsh Kanya Junior High School, Bazpur, Dwivedi collected an amount of Rs. 40,000/- as donation for construction of its building.

Shri Ajgaonkar continued his work on the Education Committee of the Social Service League, Bombay. The Committee manages four High Schools—A Day High School and three Night High Schools—A Pre-Primary School, a Primary School, two Junior Colleges in Arts, Science and Commerce-one for day-students and the other for the benefit of night-students. All these institutions are in predominantly labour areas of Bombay.

Shri Ajgaonkar continued to be a member of the Mafatlal Gagalbhai Textile Technical Institute Supervising Committee of the Social Service League. The Institute was started in 1924 to provide for systematic training to those who seek entry in the textile industry as a career and those who are already in the industry. The School is only one of its kind in the country which imparts theoretical and practical training in textile technology to students without interfering with their jobs.

Shri Ajgaonkar was a member of the League's Supervisory Committee for six Industrial Schools for Women. These Schools are conducted in different parts of the City. They were started in 1925, with the object of giving women such practical training in crafts and professions as would enable them to supplement their family income and promote special intercourse among women of different classes, castes and creeds.

Shri Ajgaonkar was actively associated with the N. M. Joshi Social Workers' Training Class of the League which is

conducted in the Servants of India Society's Home, Bombay. The Class was started in 1925 with a view to equip people for better citizenship by disseminating the knowledge of social theories and social problems. The Course which is of six months' duration is held every year from July to January by experts in these subjects and visits to 35 social welfare Institutions.

Shri D. Sahoo looked after ten pre-primary schools organissd by Choudwar Centre of the Society in the villages where there is no facilities for any type of education within seven kilometres radius.

Shri S. S. Ajgaonkar continued to be a member of the Board of Management and a member of the International Management Committee of the Gokhale Institute of Politics and Economics, Pune.

Social Service (Welfare)

Shri S. S. Misra continued to be the Vice-President of the Guild of Service (Orissa Branch). This institution is looking after the day-to-day sponsorship programme of 'Save the Children Fund' of England under which 450 children both boys and girls are getting monthly sponsorships ranging from 110 to 130 Rupees per mensem for the prosecution of their studies confined mostly to primary and secondary schools. In addition to this sponsorship programme, the Orissa Branch of the Guild of Service meets the entire management expenses of five Upper Grade Primary schools of the state.

At Allahabad the Society has constructed WORKING WOMEN'S HOSTEL with two blocks consisting of 32 rooms each. The total rooms constructed are 64, out of which fifty well equipped rooms with furniture and fans were alloted to working women. The U. P. Branch has claimed enhancement of Rs. 300,000/- as grants from the Central Government as per the revised P. W. D. rates. The Government of India has

sanctioned Rs. 2,28,159.00/- as an additional grant for the Hostel.

Shri Ajgaonkar continued to be Vice-President of the Social Service league, one of the oldest institutions in Bombay. The league conducts among other things, four High Schools, a Textile Trianing Institute, six Industrial schools for women, primary and Pre-Primary school, three libraries, a Gymnasium, a co-operative credit Society, a co-operative Dramatic Association and two dispensaries.

Shri Ajgaonkar was a member of the Health Committee of the Association for Social Health in India (Maharashtra State Branch).

Medical Aid and Relief Work

Shri Kakade continued to be Honorary Secretary of the Maharashtra State Association of the Relief & Eradication of Famine, a registered Public Trust. The Association held four meetings of its executive Committee during the year. The State has been suffering very severely from drought conditions. The supply of drinking water both for human beings and cattle and the supply of fodder for cattle have been creating critical situation in several parts of the State. The Association has taken up the problem of distribution of canal water equitably with a view to attaining social justice and helping eradication of famine from certain areas that might get Irrigational facilities under the revised policy. The Association organised a conference at Tembhurani in Sholapur district and encouraged workers from other districts to organise conferences to popularise its demands. Accordingly, conferences were organised by members of the Assn. at Masur (Satara dist.) at Vita in Sangli dist., at Baglan in Nasik district and conferences except that in Nasik.

Shri D. Sahoo visited flood affected area of Cuttack and Balesore District and gave a report for publication in the newspaper. He attended the managing committee meeting of

Jhoteswar High School as a member. In the capacity of a member of the Basudev Charitable Trust, he attended the most of the meetings of Choudwar.

He attended medical relief camps with Dr. A. A. Khan, Dr. B. N. Swain, organised by the Society in Rural Tribal and Harijan villages.

R. V. Neve developed the health care centre in Shendurjana Bazar to help the villagers.

Neve continued to give assistance to the Maharogi Seva Mandal Tapovan in Amaravati to help rehabilitate leprosy patients up to 14 August 1985.

Shri S. S. Ajgaonkar was a member of the Florence Nightingale village sanitation Fund Committee of the Social Service League, Bombay. From this fund, grants not exceeding Rs. 1,000/- are paid to institutions and individuals in rural areas undertaking to do rural sanitation work.

He was also a Member of the Supervising Committee of the Bai Bachubai Kanji Karsandas Charitable Allopathic and Ayurvedic Dispensaries of the League. Both the Dispensaries are located at League's Parel Office and the patients are treated there at subsidised rates.

RURAL DEVELOPMENT

Maharashtru (Pune)

Shri Kakade continued to be Hon. Secretary of the Deccan Agricultural Association till Dec. 1985 when he exchanged the position for Hony. Treasurership at the Annual General Meeting. He continued to look after the administration of the Assn. and after the editing of the journal. "the Shetaki & Shetakari".

The Association is planning to hold the second session of the Maharashtra State Agricultural & Rural Development conference during 1986-87. It had held the session of the Conference at Aurangabad in October 1960.

Shendurjana Bazar

Shendurjana Bazar Centre which was opened by the Society Fifty-three years ago, continued to function actively under R. V. Neve.

The handloom Section was functioning smoothly in Shendurjana Bazar the production was sold through Tapovan. As Neve discontinued his assistance to Tapovan, he discontinued the Handloom Section also.

Neve discontinued goat farm which was started in Shendurjana Bazar. Due to Nagpur work he could not supervise the goatfarm often.

Sevagram (Wardha)

Dr. P. K. P. Nair continues to supervise the programmes started with Sevagram as centre by the Rural Development Wing of the Servants of India Society. 103 Ambar Charkhas have been distributed so far among five villages. Common worksheds have been provided by the villagers. Ambar Charkhas have been received as donations from the Marathwada Khadi Samiti. This year, the piece-wage was raised further from 40 paise to 45 paise per hank. Production increased from about 15,000 hanks in 1984-85 to about 60,000 hanks in 1985-86. Efforts are being made to arrange for a 10 paise subsidy with the help of some financing bodies, in which case, it is expected that production may go up to about two lakhs hanks. The Ambar Charkha scheme in these villages functions as employment guarantee on a limited scale. A person could earn from Rs. 5/- to Rs. 6/- a day working on the Ambar Charkha.

Dr. Nair attended a seminar on District Planning held under the auspices of the Planning Commission and another seminar on Technology for Villages at the initiative of the Department of Science and Technology, Government of India. The Rural Marketing Centre which also was established five years ago as per requirement of the project financed by the Handloom Development Corporation of India under the scheme to help rural artisans, continued to function satisfactorily.

Dr. Nair attended the All India Rural Workers' Conference held at Sevagram organised by the Khadi Mission.

Marathwada

Shri M. M. Dhanore continued to work in the Marathwada area in Maharashtra State. Details of work done by him during the year under report are as under:—

1) Non-Formal Education Centres:

Under the auspicies of 'Kheri Vikas Mandal, Deoni' distt. Latur, of which Shri Dhanore is Chairman, 16 Non-formal Educational Centres were being run for drop out village girls of the age group of 6 to 14 years, 480 girls took benefit of these classes during the year under report.

A Rally of all these Non-Formal Classes students was organised with a view to make these classes more efficient and to test their working.

2) Seminar for Women Social Workers:

Under the auspices of 'Kheri Vikas Mandal, Deoni' Shri Dhanore organised Seminars of the Women Social Workers at Deoni' in Distt. Latur in the month of October 1985. 150 women social workers from different districts of Maharashtra State participated in this seminar. Prominent among them were Prof. Desarda, Mrs. Mangal Khivasara, Mrs. Nirmala Sathe, Mrs. Lohia and Mrs. Lata Madhukar.

3) Handicraft Training Centres:

Under the auspices of District Industries office Shri Dhanore organised Sisal Fiber Handicraft Training Centre for rural

women at village-Shiwoor and Daulatabad of Distt. Aurangabad. 25 rural women took benefit of these centres during the year under report. With a view to train the rural unemployed youth Shri Dhanore organised two carpet weaving centres under the auspices of District Industrials office in the villages mentioned above. 10 unemployed youths are taking benefit in these centres.

- 4) Shri M. M. Dhanore was co-opted as a member of district famine relief Committee by Shri Vasant Kale, M.L.C. As a member of this Committee Shri Dhanore visited 40 drought affected villages of Marathwada Region and submitted his plan to the Government to provide relief in some measure. He started well digging and Nalla binding wones to provide employment to the people suffering from famine.
- 5) In December 85 a Handicraft exhibition was organised by the District Administration of Aurangabad on which Shri Dhanore was co-opted as a Judge. 42 Handicraft Units participated and prizes were given to the winners in this exhibition.
- 6) Shri M. M. Dhanore continued to be the Honorary President of 'Prahlad Smarak Vachanalaya, Deoni a reputed library of Deoni area.
- 7) Shri Dhanore continued to guide the two Bricks Manufacturing Co-operative Societies which were formed by him two years back.

Bazpur Centre (U. P.)

In order to enhance the earning capacity of the villagers, P. K. Dwivedi has taken up a programme for the development of fishing, sericulture and bee-keeping. Demonstration farms for the purpose have been established in the premises of the Bhoksa Boys Hostel at Bazpur. The total income from these farms was Rs. 8,000/- during the year.

Choudwar (Orissa)

Sadhu Charan Durry and Carpet Weaving centre at Choudwar, Cuttack district, Orissa.

Damodar Sahoo has started a production unit for Durry and carpets at Choudwar. As the Secretary of the Choudwar centre, Shri Sahoo continued to look after the day-to-day management of the following institutions of the centre and their progress.

- 1. Servindia Destitute Children's Home for 85 children
- 2. Vocational Unit;
 - a) Ashok Pratap Tailoring School
 - b) Sadhu Charan Durry & Carpet Weaving Centre
- 3. Leprosy Clinic, 4) Laxminarayan Pathagar 5) 12 Pre schools (Early childhood education centres in rural villages) 6) 4 Creche centres in slum area and tribal villages, 7) Servindia L. N. Project (A family helper sponsorship programme with the financial assistance of C. C. F. Bangalore).

Education of Bakeward Classes

Shri P. K. Dwivedi, Senior Member of the U. P. Branch was in charge of the following Schemes in Uttar Pradesh.

The Society feels that education is most essential for the Social, political and economic advancement of Backward, Scheduled Caste and Scheduled Tribes People.

The Society has maintained 32 Balwadies in the Tribal Belt of U. P. from Nainital to Goda district. Out of these Balwadies 14 are being financed by Central Social Welfare Board through Bharatiya Adim Jati Sevak Sangh, New Delhi, 7 by U. P. Govt. Janjati Vikas Dept, Lucknow and Eleven by Tarai Anusuchite Jan Jati Vikas Nigam Lucknow.

Balika Ashram Type School

The Govt. of India Ministry of Welfare has sanctioned Two Ashram Type School for ST Girls where residential accommodation duly furnished with light and water is provided free of charge. Besides residential facilities these Ashram Type Schools provide fooding, lodging and clothing, Books and medical facilities without any charges to the girls.

Part time Doctor is also appointed who visited Ashram Type School Twice in a week to look after the health of the girls and to give necessary treatment.

Boys Hostel

Having the view to provide more facilities to the students of ST & SC and Backward classes the Govt. of India has sanctioned Five Hostels to the Servants of India Society. The Society has managed 5 Hostels in a renewed building two in a Gonda, two in Lakhempur-Kheri and one in a Nainital district.

The hostel provide free residential accommodation to the students. Arrangment of fooding and lodging is also done by the Society free of charges.

The Total expenditure on the maintenance of these hostels was Rs. 4,78,127.50 during the year under report.

Children Creches

The Servants of India Society is maintaining two creches in Nainital district which is financed by Bhartiya Adim Jati Sevak Sangh, New Delhi.

The Centres provide nutrition, medicine and playing material to the infants. A qualified Doctor is also appointed to look after the children. 56 Children are taking advantage of the centres. Out of 56 inmates 25 are Buxa and 31 scheduled Tribes. The total expenditure on the maintenance of these centres during the year under report was Rs. 16,788.16

Training Centres: Typewriting & Shorthand Institute

Servants of India Society is maintaining two Type-Writing Schools, one at Bazpur in the premises of Buxa Boys Hostel, Bazpur and other at Sitarganj in view of two provides technical education to ST/SC students. Thirty trainees were taking advantage during the year. The total expenditure on the maintenance of these two Type writing Institutes was Rs. 16,671.00 during the year under report.

Mahila Shilp Kala Kendra

Servants of India Society is maintaining a Mahila Shilp Kala Kendra for Buxa Ladies to give proper training in tailoring. The total number of beneficiaries was 30. The uniforms and other garments of Ashram Type School, Bazpur were stitched by the trainees. The total income during the period under report was Rs. 1,630.00 and total expenditure was Rs. 8,404.25.

Shri A. N. Misra, Secretary of the U. P. Branch was in charge of Aboriginal Welfare Work at Mirzapur, U. P. He managed the following Schemes in U. P.

1. Primary Schools

The Society maintained 40 primary schools in the Mirzapur district. Out of these 40 schools, ten were financed by the Govt. of India (Ministry of Welfare SC & BCD Section), six were financed by the U. P. Harijan and Social Welfare Department and twenty four were financed by Tribal Directorate of U. P. Govt. All these schools have their own buildings and are regularly inspected by the inspectorate of the Education Department, Harijan & Social Welfare Department and Revenue Department.

During the year under report, total number of students attending these schools was 2057 of whom 1546 were SC and 362 BC. Four hundred SC students reading in ten primary schools financed by Govt. of India were provided with clothing and mid-day meals.

Total expenditure incurred on the maintenance of these primary schools was Rs. 3,47,192.55 Ps. during the year under report.

2. Junior High Schools

The Society maintained three Jr. High Schools in the Mirzapur district situated at the Village-Siltham and Muripur with financial aid from the U. P. Harijan & Social Welfare Department and at Village-Salkhan with financial aid from the Education Department of U. P. Govt. All these schools are recognised by the State Govt. and have their own Pakka buildings. Total number of students attending these schools was 612 of whom 270 were SC and 151 BC.

Results of the VIIIth Class of these Jr. High Schools in the last examination conducted by the Education Department were good. Out of 54 students of the Hr. High School Siltham, who appeared in the examination, 53 secured first division and one second division. Most of them secured distinction in different subjects. Of the 40 students of Birla Vidya Mandir Jr. High School Muripur, 21 secured first division, 12 second division and 5 third division. Of the 26 students of Raja Baldeo Das Birla Songhati Vidyalaya Salkhan, 6 secured first division and 20 second division.

During the year under report the expenditure incurred on the maintenance of Jr. High School Siltham was Rs. 64,122.73 Ps. Jr. High School Muripur was Rs. 45,105.97 Ps. and Jr. High School Siltham was Rs. 1,18,291.45 Ps. total of which comes to Rs. 2,27,520.15.

3. Hostels

With financial aid from the U. P. Harijan & Social Welfare Department, the Society maintained three Harijan & Adivasi Hostels at Muripur, Salkhan and in Mirzapur City. Only free residential and cooking facilities are provided in these Hostels.

During the year under report 143 SC & BC students took benefit of these Hostels. Total expenditure incurred on the maintenance of these Hostels was Rs. 21,423.90 Ps. during the year under report.

4. Ashram Type Schools

With grant-in-aid from the Govt. of India (Ministry of Welfare SC & BCD Section) the Society maintained two Ashram Type Schools, one at Siltham in Robertsgani and the other at Khantara in Sadar Tahsil of the Mirzapur district. There were 60 Harijan & Adivasi inmates in each Ashram who were given free fooding. lodging, clothing and reading & writing materials. inmates of these Ashram Schools were reading in Jr. High School Siltham and Upper Primary School, Khantara maintained by the Society and in Jr. High School Rajohan run by the Education Department. During the year under report all of the 5 students of Class Vth of the Ashram School Khantara, passed their primary school examination conducted by the Education Department. Results of Ashram School Siltham were exemplary during the year under report. Sixteen inmates of the Ashram had appeared in VIIIth Class examination conducted by the Education Department. All of them secured first division with distinctions in different subjects.

Total expenditure incurred on maintenance of the Ashram school Khantara was Rs. 1,08,785.15 Ps. and on the Ashram School Siltham was Rs. 98,632.60 Ps. during the year under report.

5. Women's Welfare Schemes

With grant-in-aid from the Govt. of India (Ministry of Welfare SC & BCD Section) the Society maintained 5 Women's Welfare Centres located at Ramgarh in the Robertsganj Tahsil and at Bidar, Dhanora, Chandrabhan Nagar and Kundadih in Dudhi Tahsil of the Mirzapur district. Facilities for general dedication were provided to 150 SC & BC women attending these centres besides training in tailoring, embroidery and knitting by hand. Total expenditure incurred on the maintenance of these Centres was Rs. 33,227 50 Ps. during the year under report.

6: Harijan & Adivasi Typewriting Institute

With financial aid from the Govt. of India, (Ministry of Welfare SC & BCD Section) the Society maintained three Harijan & Adivasi Typewriting Institute at Sarsa in the Allahabad district and in Mirzapur and Lucknow Cities. 102 BC & ST students took benefit of these Institutes during the year under report. Total expenditure incurred on the maintenance of these Institutes during the year under report was Rs. 31,377.99 Ps.

7. Medical Relief

Previously the Society was maintaining three Ayurvedic Dispensaties at Khantara, Tikuria and Ghuwas. But with a view to protect the Society from continuous deficit two dispensaries located at Khantara and Ghuwas were closed from July 85 as per Council Resolution No. 51 dt. 13th June 1985. Now only one dispensary located at Tikurai is being maintained by the Society through which 1905 patients took benefit during the year under report.

Total expenditure on the Medical Relief Work during the year under report was Rs. 5,400.00/-.

Narsannapet (Andhra Pradesh)

Shri S. S. Misra supervised the management of the Gokhale Children's Home which was founded by our Society in March 1945. During the year there were 21 inmates in the Home of which one belonged to economically backward communities, 18 to the Backward communities & 2 to the Scheduled Castes. Three boys appeared for S. S. C. examination & two boys for the 7th class public examination. Their results are awaited. We are continuing the vocational training in tailoring & typewriting.

This Institution is providing besides free boarding & lodging, clothing soaps, oil, education in the local schools, recreation. medical aid and every other minimum comfort required by the

inmates of the Home. Each boy is supplied with a cot, bedlinen, mosquito net, steel plates, cup & tumbler for his use.

Rayagada, Dist. Koraput (Orissa)

Damodar Sahoo was in charge of the Thakkar Bapa Ashram, at Rayagada in the Koraput District of Orissa. The Servants of India Society which started its tribal work in the District 46 years back now runs the Thakkar Bapa Ashram for the ST and SC students at Rayagada.

Thakkar Bapa Upper primary School and four primary schools in the rural areas of the Rayagada Tahsil are also managed by the Society. He maintains on behalf of the Society 14 creches with financial assistance from the Bharatiya Admijati Sevak Sangh, New Delhi and the Central Social Welfare Board. The children belong to ST families from Andhra Pradesh and Orissa. All the children are provided with supplementary nutrition, medical care and other facilities as have been provided by the Scheme. Two Balwadi centres are also managed by the Society with financial assistance from State Social Advisory Board. Damodar Sahoo has taken up an International Sponsorship project through the Christian Children's fund, Bangalore.

As the Secretary of the Rayagada Centre, Shri Sahoo was in-charge of the following Welfare Activities of the centre.

- Thakkar Bapa Ashram (A hostel for 75 ST & SC students)
- 2, Four Primary Schools (in rural tribal villages)
- 3. One U. P. School (in Ashram premises)
- 4. Two Balwadi centres (in tribal villages)
- 5. Five night Schools (,, ,,)
- 6. One Maternity centre (at Hajaridangu)

Madras Branch

Thakkar Bapa Gurukulam, Nirgacimund is a residential School for Todas and Kotas, tribal children of the Nilgiris in

Tamil Nadu. During the year 1984-85 there were 100 tribal boarders in the hostel, 53 Toda and 47 Kota children. They were provided with free meals, books and clothes. The hostel was subsidized by the Harijan Welfare Department of Tamil Nadu. There were 263 children in the middle School.

Mrs. Sitalakshmi Sadashiv M.A. was the manager and correspondent of this institution. Mr. S. N. Sadasivam, B.A. who is an Associate of the School gave the maximum help to the school. The Deputy Inspectors of schools and many other visiting dignitaries expressed favourable opinion about the management of the School.

The five schools in Kerala, namely Devdhar U. P. School, Nediyiruppu, Devdhar L. P. School, Karulai, Devdhar L. P. School, Pulliyil, Gokhale U. P. School, Mudadi and Sastriar U. P. School, chalode situated in the interior of Malapuram and Nilamber forest areas, continued to function under the guidance of Venkataraman satisfactorily as in the past, serving the educational needs of the Backward classes and Mopla Muslims. K. Viswanathan Nair, Society's attache was in immediate charge of the schools.

Other Activities

Shri Ajgaonkar continued to be a member of the Social Service League's Gymnasium Committee which was started in 1923 and inaugurated by Sir Roger Lumley, former Governor of Bombay. The Gymnasium which is located in predominantly Labour Area of Bombay, has produced outstanding weight-lifters of All-India and International repute. Shri Ajgaonkar is member of League's Property Committee which manages Damodar Hall, Rs. Forty-five lakhs prestigious complex of the League. These two activities cater to the recreational needs of the working Class population of Bombay. Shri Ajgaonkar was also member of the Library Committee of the League which conducts three Libraries and Reading Rooms in different parts of the City. It also looks after Children's Toy Library and vacation Library

which loans toys for Children to play at home and provides education and recreation.
