

Preamble

Extracts From the original Preamble to the constitution of the Society written by the illustrious founder the late Gopal Krishna Gokhale, in 1905.

For some time past the conviction has been forcing itself on many earnest and thoughtful minds that a stage has been reached in the work of nation-building in India when, for further progress the devoted labours of a specially trained agency applying itself to the task in a true missionary spirit are required. The work that has been accomplished so far has indeed been of the higest value. The growth during the last fifty years of a feeling of common nationality based upon common traditions and ties, common hopes and aspirations, and even common disabilities has been most striking. The fact that we are Indians first, and Hindus, Mohammedans, Parsees or Christians afterwards is being realised in a steadily increasing measure, and the idea of a united and renovated India marching onwards to a place among the nations of the world, worthy of her greatpast, is no longer a mere idle dream of a few imaginative minds, but is the definitely accepted creed of those who form the brain of the community - the educated classes of the country. A creditable beginning has already been made in matters of education and of local self-government; and all classes of the people are slowly but steadily coming under the influence of liberal ideas. The claims of public life are every day receiving wider recognition and attachment to the land of our birth is growing into a strong and deeply cherished passion of the heart. The annual meetings of Congresses and Conferences, the work of public bodies and associations, the writings in the columns of the Indian press-all bear witness to the new life that is coursing in the veins of the people. The results achieved so far are undoubtedly most gratifying, but they only mean that the jungle has been cleared and the foundations laid. The great work of rearing the superstructure has yet to be taken in hand and the situation demands on the part of workers devotion and sacrifices proportionate to the magnitude of the task.

The Servants of India Society has been established to meet in some measure these requirements of the situation. Much of the work must be directed towards building up in the country a higher type of Character and Capacity than is generally available at present, and the advance can only be slow. Moreover, the path is beset with great difficulties; there will be constant temptations to turn back; bitter disappointment will repeatedly try the faith of those who have put their hand to the work. But the weary toil can have but one end, if only the workers grow not faint-hearted on the way. One essential condition of success in this work is that a sufficient number of your countrymen must now come forward to devote themselves to the cause in the spirit in which religious work is undertaken. Public life must be spiritualised. Love of country must so fill the heart that all eise shall appear as of little moment by its side. A fervent patriotism which rejoices at every opportunity of sacrifice for the motherland, a dauntless heart which refuses to be turned back from its objects by difficulty or danger, a deep faith in the purpose of providence which nothing can shakeequipped with these, the worker must start on his mission and reverently seek the joy which comes of spending oneself in the service of one's country.

The Servants of India Society will train men, prepared to devote their lives to the cause of the country in a religious spirit and will seek to promote, by all constitutional means the national interest or the Indian people. Its members will direct their efforts, principally towards (1) creating among

the people by example and by precept, a deep and passionate love of the motherland, seeking its higest fulfilment in service and sacrifice; (2) organising the work of political education and agitation, basing it on a careful study of public questions and strengthening generally the public life of the country; (3) promoting relations of cordial goodwill and co-operation among the different communities; (4) assisting educational movements especially those for the education of women, the education of backward classes and industrial scientific education; (5) helping forward the industrial development of the country; (6) the elevation of the depressed classes.

The Servants of India Society Report for the year 1993-94

Introduction

The Servants of India Society was founded by Gopal Krishna Gokhale on June 12, 1905. Its objects are the training of national missionaries for the service of India and the promotion, by all constitutional means, of the interests of the Indian people without distinction of cast or creed. The members of the Society are pledged to give throughout their lives the best that is in them to the cause of the country in all secular fields. The circumstances in which the society was founded and the objects, which the Founder had in view in founding it, are explained in the preamble he wrote to its constitution in 1905, extracts from which are given in the preceeding pages. The preamble has been a source of inspiration to the Society during the eighty nine years of its existence.

Organisation

The Headquarters of the Society are at Poona, where the members meet every year in June for its annual session. The Society has braches in Bombay, Nagpur, Allahabad, Cuttack and Madras.

Shri S. S. Misra continued to be President till 8th December 1993 and Dr. R. G. Kakade Vice President of the society respectivelly. Shri S. S. Ajgaoukar continued to be Secretary of the Society. Shri Ajgaonkar, Dr. Kakade, Shri P. K. Dwevedi and Shri S. S. Misra continued to be Senior Members of Bombay, Nagpur, Allahabad, and Cuttack branches of the Society respectively. The Madras Branch was looked after by the Head quarters. Shri Damodar Sahoo, Shri Atmanand Misra and Shri M. M. Dhanore were elcted members of the Council.

Loss

The President Shri S. S. Misra passed away on the 8th December 1993. The council has passed the following resolution recording its deep sense of grief at his death.

The Council of the Servants of India Society places on record its deep sense of sorrow and grief at the passing away of Shri Shyam Sundar Misra on the 8th December 1993. After a distinguised academic career at the Patna University, he joined the Society in 1936. During the period of his membership he was closely connected with the Trade Union movement, more particularly of primary school teachers in Orissa, Utkal University and some cultural organisations in Cuttack. He was a member of the All India Civil Liberties Council and organsied its conference in Cuttack. He used to take lead in organising relief for people in distress. An illness in fifties created severe permament handicps in him which limited the number and range of his activitees but did not affect his deep interest in and devotion to his work. He was elected President in 1986. In his dealth the society has lost an honest, sincere and devoted senior member and has suffered an irreparable loss.

Gokhale Day

The 127th birth anniversary of the Founder of the Society was observed as usual at the Headquarters on May 9, 1993.

The Gokhal Day was observed in Nagpur. Smt. Vimalabai Patwardhan, Head of the Rashtriya Apang Vickas Manch presided over the function and Shri Pandurang Tekale of Apang Foundation was the chief guest.

The Gokhale Day was also observed in Cuttack (Orissa) on May 9, 1993 and also at Choudwar Centre in Nari Sangh Sadan.

Thakkar Bapa Anniversary

The 124th Brith Anniversary of Thakkar Bapa was observed at Rayagada of Koraput District in Orissa under the Presidentship of Shri Ramchandra Ulaka, M.L.A. Shri Prafulla Samal, Minister for Labour and Employment, Orissa and Shri Anadi Sahu, I.P.S. President, Utkal Sahitya Samaj joined the function as chief Guest and Chief Speaker respectively.

Shri Damodar Sahoo wrote an article on Thakkar Bapa which was published by local dailies on the Anniversary day.

The 31st Death Anniversary of late L. N. Sahoo and 20th foundation day of the Choudwar Shishu Sadan were celebrated on 18th January 1994.

General

Dr. R. G. Kakade continued to be Honorary Treasurer of Kunzru Centre for Defence Affairs Studies which aims at educating public opinion on all aspects of National Defence and thereby help to evolve a non-official expertise on defence matters. The Centre was started by the Late Shri N. G. Goray with Col. M.G. Abhyankar as its Hon. Director. Shri V. N. Gadgil, Bar-at-Law, is the Chairman of the Centre.

Dr. Kakade continued to be Managing Trustee of the Late Justice Mahadeo Govind Ranade Charitable Trust. The Trust gives donations to educational and social welfare institutions in Pune and outside on Ranade Day, 18th January.

Dr. Kakade continued to be a member of Gokhale Cup Elocution Competition Committe of Nowrosjee Wadia

College. The Cup was endowed by the Late Raja of Sangli soon after the death of Gokhale.

Shri S. S. Ajgaonkar continued to be the Honorary Secretary of The Bombay Social Reform Association, a non-political and non party Organisation, founded by the late Justice Naravan G. Chandawarkar and other fellowworkers of Justice Ranade after his death, in 1903. It is an off-shoot of the National Social Conference started by the late Justice Ranade in 1887. The Association, which stands for elimination of such disruptive forces as castism, communalism and others, and a common civil code. has a distinguished record of service for furtherance of Social Reform in the Country. It has played a valuable part in bringing many beneficial measures in the statute book. During the year under report, the Association celebrated 90th Foundation Day of the Bombay Social Reform Association on the 30th September 1993. The Association organised two seminars to celebrate the occassion, one on "Social Reform Movement and its future in India" and the other on "Ranade the visionary". The Association also donated Rs. 10,000/- to Andha-Sraddha Nirmulan Association for its Seminar on religious thoughts of Ranade. Phule and Ambedkar held on 2nd and 3rd October 1993 at Satara. The amount was paid through funds collected by B.S.R.A. to celebrate Sesquicentennial Anniversary (150th Birth Anniversary) of Justice Ranade. To these funds, Shri Sudhakar Naik, then the Chief Minitter of Maharashtra, had Contributed Rs. One lakh as the gesture of financial aid to B.S.R.A. for worthy cause of enlightening public on Ranade and his contribution to the Nation building. In this connection Shri S. S. Ajgaonkar submitted Paper elaborating Mahatma Phule's views on religious begotary, Casteism and other evils crept in Hindu ethos during Phule's times. He referred to educational limitations of Phule and humiliations suffered by him. He referred to Phule's attractor to Christianity and Islam, which he thought were based on equality and brother-hood and his firm

belief that caste-ridden Hindu Society would never allow depressed classes to progress. It was worth noting that BSRA was the first organisation to celebrate Phule's Birth Anniversary long back in thirties and before independence dawn on the country. Shri S. S. Ajgaonkar also referred to Dr. Ambedkar's determination not to die as Hindu and his vain and aborted attempts to embrace Islam and Sikhism to which his followers were not willing to join and about Dr. Ambedkar's after thought that he would loose his political force if he had embraced Moulvi dominated Islam. Shri Ajgaonkar also referred to Dr. Ambedkar's comparative and comprehensive study of different religions and his attraction to moral basis and ethical values of budhha's teachings (no priestly class, no rituals) converted him to Budhism. He elucidated with facts and available record that Dr. Ambedkar was not impressed by Christianity which was theocratic relegion, where once Pope wielded both religious as well as State powers. It was left to Martin Luther to start secular movement, while Hinduism was basically secular, where King had no power to interfere with religion. While referring to Ranade's religious thought, Shri Ajgaonkar brought out his rationalistic approach to religion. He believed God, the unknown, and laid emphasis on Prayer. He totally discarded rituals (Karmakanda) and Casteism. Shri Ajgaonkar concluded his paper with views expressed by Samuel P. Hutington on the new perspective on clash of civilisations and views of Edward Tirykian on dimensions of religious exceptionalism and referred to post-indepedent India, getting divided into smaller and smaller caste loyalties and conflicts with danger of bulkanisation of the country.

The B.S.R.A. donated Rs. 15,000/- for bringing out biography of Justice Ranade for children. The work was executed by Shri Raja Mangalvedhekar, welknown writer of biographies for children. The B.S.R.A. donated uniforms

to deaf children of Central School for Deaf, Agripada, Bombay during the year.

Shri S. S. Ajgaonkar also contributed an article on Justice K. T. Telang to mark the Death Anniversary of Telang held in Bombay on the 7th September 1993 and was published in Independent. He was interviewed by the Chief-Reporter of "The Metropolist" on "Servants of India Society Past and Present."

Shri S. S. Ajgaonkar contributed an article on Servants of India Society in Hindi to be published in the Souvenir to be brought out by U.P. Branch on the occasion of Silver Jubilee of Bazpur Centre.

Shri Damodar Sahoo took active part in receiving Shri. S. N. Subbarao and 250 young boys and girls of different states and in organising a meeting on National Integration at Choudwar in Cuttack district of Orissa.

During the year Shri Damodar Sahoo participated in more than 100 functions as chief speaker and Guest at different Schools, Colleges, Govt. & Public Institutions. He visited Allahabad, Mirzapur, Vijayawada, Bangalore, Bhubaneswar, Puri and Balasore on official visits and attended Discussions, Seminars on different subjects in connecetion with Child, Woman, Leprosy Welfare Programmes.

Shri Damodar Sahoo's talk on Prevention of Cruelty to animals was broadcast on All India Radio's Cuttack centre on 4-10-1993 for 10 minutes on 18th January 1994. Shri Damodar Sahoo contributed his articles to the Samaj and the Prajatantra on irregularities of the Entrance Examinations of Medical and Engineering students.

Shri Gangadhar Sahoo was a nominated member of the Tangi Choudwar Block Development Committee and actively participated in its meetings. He countinued to work as honorary press reporter of the daily news paper "The Prajatantra" and sent regular news of various incidences in Choudwar to the newspaper for publication.

Shri Neve was associated with the Human Resources and Development Centre and also with Shri Dajisaheb Dnyan Vistar Sanstha which arranged discussions on various topics during the year at Nagpur. He partcipated in discussions arranged by various organisations in Nagapur on topics like national intergration, population, casteism etc.

Shri Lenka continued to be the President of Rayagada of Koraput district in Orissa Sahitya Sansand and he organised a number of literary meets during the year. He submitted documents of the Sahitya Sansad to Collector Rayagada for registration of the Sansad and got it registered under Societies Registration Act 1860.

Shri Lenka continued to be the President of "PARIBARTAN", a Social service Organisation, which was developed by Shri Jagadish Baxipatra. It was a registered Organisation. Being the President of the Organisation Shri Lenka attended and took part in its activities.

Shri Lenka was nominated as a member of the District level Co-ordination Comimittee of Voluntary Organisations by the Collector of Rayagada during the year under report and he attened its meetings and took part in the discussion. The Collector, Rayagada was its Ex-officio Chair person.

Welfare Work for Tribal and Backward Classes

Uttar Pradesh

In order to speed up and also to make the welfare work more useful and effective the Senior Member of the U. P. Branch Shri. P. K. Dwivedi has divided the entire work, spread over eight districts, into three working zones viz South-Eastern Zone, Central Zone and North-Western Zone. The South-Eastern Zone covers Mirzapur and Sonebhadra districts and was looked after by Shri. Atmanand Misra. The Central Zone covers Allahabad District and its adjacent area. The North-Western Zone covers all the Tarai belt of tribals of U. P spread over from Haridwar district in the West to the Gonda district in the East touching Nepal border. Shri Dwivedi looked after the work of latter two Zones with the help of Shri Dinesh Misra and Shri Amresh Chand Tripathi from Bazpur in Nainital district.

Western Zone

The Society maintained 20 Primary Schools, 16 in Nainital district and four in Haridwar district. The children reading in them numbered 1644 including those of Scheduled Tribes 1055, Scheduled Castes 180, Backward class 175 and other communities 234. Out of 20 schools seven schools are getting recurring grants from the Directorate of Tribal Development Department of Uttar Pradesh, two are running without recurring grants and eight new primary schools, (started in the building constructed under special Central Assistance) are expected to come under grant-in-aid. The total expenditure on the maintenance of the schools was Rs. 10,53,517.61 only during the year.

The society conducted two Junior High Schools at Dopulia and Mazarabidhi with VI, VII and VIII standards. Both of them are recognised and receive grants from the Education Department, A new Senior Basic School was started during the year at Azimulla. Efforts are under way to upgrade Dopulia school and extend its section. Poor boys are given preference at the time of admission to these schools. The total exprenditure incurred on the schools came to Rs. 3,71,420.00.

The Society conducted five hostels for boys one at Bazpur (Nainital district), two at Palia-kalan and Chandanchowki (Lakhimpur Kheri district) and two in Gonda District at Tulsipur and Pachperwa. The inmates of the hostels were reading in local intermediate Colleges with VI th to XII th standards. The total number of inmates was 273, which included 255 of Geneduled Tribes and 18 of Scheduled Castes. The inmates were provided, free of charge, lodging, boarding, clothing, bedding, reading and writing materials and medical aid. The hostels were sponsored by the Government of India's Ministry of Welfare (T. D. Division). The expenditure incurred on these hostels totalled up to Rs. 14,39,424.63 only during the year.

The Society maintained three Ashram type schools for girls. Two of them were for tribal girls located at Bazpur and Chandanachowki and the third one located at Paliakalan was exclusively for Harijan girls. The inmates in all the Ashram-type schools were provided, free of charge, lodging, boarding, reading and writing materials etc. as in the boys hostels. For regular health-check-ups a part-time doctor was appointed for each Ashram type school.

The total number of girl inmates in the schools was 278, which included 213 Scheduled Tribes, 53 scheduled Castes and 12 Backward class girls. The expenditure incurred on these Ashram-type schools for girls totalled up to Rs. 14,43,490.30

A Type-writing and Short-hand Institute was conducted by the Society on the premises of Pandit Kunzru Complex at Bazpur to provide vocational training to the inmates of the hostel there. 24 hostellars took benefit of it. The total expenditure incurred on the Institute came to Rs. 43,822.50 during the year.

The Society maintained five Balwadi schools in backward villages in Nainital district to associate the tribals and other Backward children with education-cult from early childhood. 215 children including 204 Scheduled Tribes, 3 scheduled castes and 8 other children attended them. Midday meal and medical facilities were provided in the schools free of charge. The total expenditure incurred on these schools came to Rs. 80,338.50 only during the year.

The Society maintained seven creche centres to look after the children of working women. 175 children, including 125 of Scheduled Castes, 25 of Scheduled Tribes and 25 of Backward classes, were taken care of in them. Six centres were financed by the Central Social Welfare Board, New Delhi and two were sponsored by the Adim Jati Sevak Sangh. New Delhi. The expenditure on these Chreche Centres totalled up to Rs. 1,22,338.18 only.

A group of 25 tribal girls from different villages was sent to the Educational Excursion Camp held in the Society's quarters in Allahabad in February 1994. The camp was sponsored by the State Welfare Advisory Board Lucknow. The total expenditure incurred in organising the camp was Rs. 22,006 only.

Two camps were organised by the Society at Bhuri and Khambhari in Nainital district to create awareness in women towards their children and about betterment of living conditions. The Women's Awareness programme was sposored by the Research and Publication Division of the Central Social Welfare Board, New Delhi. Poor and identified

tribal women attended them. An expenditure of Rs. 20,500 was incurred on these camps.

Shri Dinesh Misra, a Resident Member of Bazpur looked after the day-to-day working of all the activities of the Society, under the guidance of Shri P. K. Dwivedi, who continued to be the secretary of the Bhartiya Adim Jati Sevak Sanghs, Nainital district cell.

Eastern Zone

Being fully in charge of the zone Shri Atmanand Misra carried on various activities for the welfare of the tribals and backward class children in Mirzapur and Sonebhadra districts. He conducted 16 Primary Schools, three Junior High Schools, one Adivasi High School, three Adivasi and Harijan Hostels (two of them without boarding facility), two Ashram-type schools for boys and one Ashram type school for girls, five women's welfare centres, three Harijan and Adivasi Typewriting institutes, five creche centres and one Ayurvedic Dispensary. The number of children reading in all schools was 699. The number of students who took benefit of the hostel facilities totalled up to 102, 149 students were taking benefit of the Ashram-type schools. The hostels provided accomdation to 180 boys and girls. The Women's welfare centres provided facilities for training in tailoring. embroidery and Knitting by hand to 174 women free of charge, along with primary education. The benefit of training in typewriting was taken by 102 students. The Ayurvedic Dispensary continued to provide medical aid, free of charge, to poor patients as in the past. The expenditure incurred on Government aided welfare schemes totalled up to over Rs. 27.19 lakhs during the year.

Orissa

The tribal and backward class welfare work was undertaken by the Society since 1939 from the Rayagada

Centre in Koraput district. Though Shri Madhusudan Sahoo continued to be the Secretary of the Thakkar Bapa Ashram there Shri Ramakant Lenka, Resident Member, looked after the various activities that are carried on from there. The Ashram provides free of charge, lodging, boarding, educational facilities etc. to 39 scheduled Castes and 53 scheduled Tribe students. Intensive coaching is provided to improve standard of education of the inmates. A group of students visit every year some important places. The centre also manages an upper Primary school in the Ashram in which 235 children are reading. The total exprenditure incurred on maintaining the Ashram was Rs. 3,86,781.45 during the year.

The Centre manages four primary schools in four tribal villages in which 145 S.T. 4 S.C. and 7 other students were reading. The students are provided reading and writing material along with mid-day meal. The total expenditure incurred for conducting the schools was Rs. 1,17,634.35 during the year. The Centre conducts a Typewriting Institute for boys and a Tailoring training class for girls on the premises of the Ashram. 23 trainees took benefit of the Typewriting and 18 trainees of the Tailoring class. The Centre incurred an expenditure of Rs. 44,037.25p on the training courses during the year. The centre conducts a Maternity Centre which serves 23 tribal villages. The midwife conducted 75 deliveries and attended to 97 pregnacy cases and distributed, free of chagre, medicines to 551 patients for minor ailments. The total expenditure incurred on maintaining the Centre was Rs. 31,099.05 P. during the year. The Centre conducted as in previous years two Balwadies and a Centre for training of Anganwadi Workers. During the year a new scheme known as "Educational Complex in low literacy pockets for development of women literacy in tribal areas", sactioned for Rayagada area by Ministry of welfare (T.D. Division) Government of India, had been taken up by Centre. Shri Lenka started the complex for the present in the Thakkar Bapa Ashram and has

selected a suitable plot of land in Halua village for setting up the Complex thereon on permanent basis.

. Tamil Nadu

The Society conducted the Thakkar Bapa Gurukulam at Nirgacimund (8 miles from Oottacmund on Ooty-Mysore road). This residential school caters to the needs of children of Toda and Kota tribes in the Nilgiris. Facilities upto VIII th standard are provided to students. The Gurukulam receives grants from the Tamil Nadu Government.

Kerala

The Society conducts five schools in the hilly and backward areas of Nilambur, Mullapuram and Calicut Districts of the state. The Schools were first started in 1921-22 as a part of the welfare activities after the Moplah Rebellion in Malbar. The five Schools namely Devdhar Upper Primary School at Nadiyiruppu, Devdhar Lower Primary School at Kurulai, Devdhar Lower Primary school at Pulliyil, Gokhale Upper Primary school at Mudadi and Sastriar Upper Primary School at Chalode worked satisfactorily and received grants from the State Governments. Shri Vishwanathan Nair, Attache, looked after them.

Rural Development

Dr. Kakade continued to be Honorary Treasurer of the Deccan Agricultural Association founded by late G. K. Deodhar of the Society along with Dr. Harold H. Maan in 1910. He was looking after the publication of the Association's 84 year old monthly journal the Shetaki and Shetakari. At the annual meeting of the General Body of the Association held on 27th March 1994 Padmashree Dr. D. G. (Appasaheb) Pawar and Dr. B. V. Nimbkar of Phaltan have been elected President and Hony. Secretary of the Association respectively. Consequently the office of the Association is shifting to Baramati from where the journal is going to be published.

Dr. Kakade continued to be a Director of the Pune District Industrial Cooperative Association. The Association conducted two cloth shops (one at Baramati) and a Handicraft emporium in Pune.

Shri Ajgaonkar continued to be a Member of the Florence Nightingale Village Sanitation Fund Committee of the Social Service League. Grants are paid from this fund to institutions and individuals in rural areas undertaking to do rural sanitation work. Shri Neve was looking after the Society's Rural Development Centre at Shendurjana Bazzar in Amaravati district in Maharashtra.

For his rural development work Shri Dwivedi Selected such villages in his project area in U.P. as were lacking in roads, electricity, drinking water etc. He frequently met the officers of the concerned departments and urged them to take up the requisite work in hand. He got electricity poles erected and water tabs installed in some villages to expedite completion of work. He tried to carry modern technology to villages and to make villagers aware of the necessity of soil and water conservation. Shri Dwivedi has adopted two

Bengali villages viz Saujanagar and Mohanpur for development as ideal villages.

Shri. Dwivedi met Government officers of Hill Development and Rural Development at various levels and requested them to introduce some fruitful schemes in villages to provide gainful employment to unemployed youths in them. He provides information to the rural youths about the self-employment schemes like J.R.Y, N.R.Y. Trysem etc. started by Government.

With a view to carry modern technology to villages Ship Dwivedi oraganised demonstrations of growing vegetables like cabbage, Cauli flower, palak, potato etc. at Chandanchowki and Paliakalan. The income from the vegetables demonstration farms totalled up to Rs. 17,698.95p. only.

The Fisheries Demonstration Pond at Bazpur that Shri Dwivedi has been conducting for some years is proving very useful as a source of earning income as well as for imparting practical knowledge to villagers. The income accruing from this demonstration pond came to Rs. 8,000/- only.

As Secretary of the Sashwat Mangalam Trust Shri. M. S. Sahoo arranged one Milch Cow Exhibition at Kudahat Balikuda P. S. On 2-10-1993 in Orissa.

Education

Shri Kakade continued to be associated with the Gokhale Institute of Politics & Economics which is awarded Deemed to be University status by the UGC from 9th May 1993 (which happens to be G. K. Gokhale's Birth Day). The Institute can hereafter devise its own courses and curriculum conduct M. A. Ph. D. examinations and give its own degrees. The Board of Management has been expanded with nominees of UGC, Ministry of Education and of the State Government. The statutory committees have been formed and have been approved by the Board of Management. Shri. Kakade presided over the meetings of the Board held in June and Septembter 1993 and in March 1994.

Shri Kakade continued to be a trustee, and a member of the Council and Governing committee of the Maharashtra Association for the Cultivation of Science. He continued to be chairman of the Mashroom Development Committee. He attended all meetings of those Bodies. After the carving out of the Agharkar Institute, the Association has started Home Garden Courses, organising Camps for talented students and Science teachers and has started some other new science promotion activities with its own funds.

Dr. Kakade having given up chairmanship has coutinued to be one of the trustees of the Kanara Welfare Trust in North Kanara district, Karnatak State.

Dr. Kakade continued to be chairman of Padmashree Dr. Vitthalrao Vikhe Patil Foundation. The Foundation conducts an Engineering College, a Poly-technic; an Institute of Business Management and a Diploma Course in Pharmacy in Ahmednagar.

Dr. Kakade continued to be chairman of the Academy of Education and Youth Services.

Dr. Kakade Continued to be the Society's re-presentative on the Executive Committee of the Vidya Jyoti School for slow learners. The School is a joint venture of the Society and the Vidya Jyoti Institute of Education. The VIE has been trying to get a plot of land and to construct its own suitable buildings thereon to meet the ever-increasing demand for admission to the School.

Shri S. S. Ajgaonkar, Vice-President of the Social Service League of Bombay, was a member of the Education Committee and of its Mafatlal Gagalbhai Textile Institute, the only one of its kind in the country. The committee manages one day high school and three night high schools, a Pre-Primary school, a Primary school, two Junior Colleges in Arts, Science and Commerce (One for day students and another for night students). It is worth noting that Dr. B. R. Ambedkar and Shri. S. K. Patil were the Honoray teachers of the Night school, one of the oldest in the city of Bombay. It is recorded that Dr. B. R. Ambedkar was inspired to Start his 'Peoples Education Society' with his experience with the League's Night School, in the campus of which Dr. Ambedkar resided. All the academic activity from mini K.G. level to Junior College is conducted in the Damodar Hall Educational Campus at Parel, Worli and at Jacab Circle. All these schools cater to the needs of the working class families residing in thickly populated textile Mill areas of Bombay, with Marathi as the medium of instruction. Children admitted to the mini K.G. Classes at the age of three have the facilities to go right upto Junior College level in the faculties of Arts, Science & Commerce. The League maintains three libraries and two reading rooms, a children's vocational library, a toy library for Children. It also runs six Industrial schools for women. The League's Gymnasium and Physical Culture Centre, run in its owned Damodar Thakersey Moolii Hall Complex in Parel, has been giving a very good account of itself for the past several years.

Shri Ajgaonkar was a member of the Board of Management of the Gokhale Institute of Politics and Econimics and also of the Executive Committee of the Vidya Jyoti School at Pune. He was associated with the Gurukul of the Vidya Vinay Sabha at Tungarli, Lonawala in Pune.

During the year under report Shri Dhanore conducted four schools for children of harvesting and carting labour of Co-operative Sugar Factories of Kannad, Gangapur, Paithan and Deogiri in Marathawada. The number of children studying in them was 317. Out of them 63 children appeared for the IV th Std. examination of the Board and came out successfully. The Karkhanas concerned supplied to the children supplementary nourishing food at their own expense.

Shri. Dhanore has conducted a survey of Children below 14 years of age that are working in hotels, shops, garrages etc. in Aurangabad city. The number of children surveyed upto March 1994 has gone upto 3450. He plans to organise educational and medical facilities for them. Last year he organised two meetings of the working children.

Shri. R. V. Neve looked after the Gokhale Memorial Library at Nagpur and kept the library open to public particularly for reserach scholars and authors for use. The Society conducts Dr. Kunzru Nursery and Primary school at Allahabad in U.P. to cater to the needs of poverty stricken children in the locality. The School with 1st to VII th standards had 240 children on its roll. It has been recognised by Basic Shiksha Parishad of Uttar Pradesh. For smooth functioning of the school nine teachers were appointed. The expenditure on the school was Rs. 71,456.77P only.

Shri. P. K. Dwivedi continued to be the Secretary of Shiksha Prasar Samiti and a Life Member of Adarsha Kanya Junior High School, a private educational institution of Bazpur. Shri. Dinesh Misra was a member of both the above bodies.

In Orissa Madhusudan Sahoo continued his moral education Programme in Secondary Schools. During the last 10 years he has contacted around 60,000 students.

As the Secretary of the '1950 Chhatrasangha' he distributed merit scholarships in Balikuda High School on 15th August 1993. He is the Founder Secretary of the Subarna Jayanti Trust of the Balikuda High School.

Shri Damodar Sahoo continued to be Honorary Secretary of Gokhale Ideal College at Shankarpur in Cuttack District in Orissa. He was connected with several educational organisations from high Schools to colleges and welfare agencies operating in Orissa. Shri. Damodar Sahoo was the Chief Guest of National Sevice camp and distributed clothes to the poor imhabitants of that locality. The Camp was organised by Dhabaleshwar College.

The Society conducted as in previous year 21 Centres under the early childhood Education Progamme for children between the age group of 3 to 6 years in backward and under developed areas of Cuttack Division. In these centres reading and writing materials, play materials and health care are provided. The Society also conducted 10 creche centres in various villages in three Blocks of Cuttack district. During the year under report one Early Childhood Education Centre, 6 New Creche Centres and one Typewriting Training Centre were opened in Choudwar Municipal area and in two other villages.

Shri. Gangadhar Sahoo a Resident Member of Choudawar Centre, organised 5 batches of Anganwadi Workers Training Programme in which 280 Anganwadi workers got training.

Shri. Gangadhar Sahoo organised 5 camps on Food Preservation and Preparations of Nutritious Food, sponsord by the Community Food and Nutrition Extension Centre, Ministry of Food, Government of India, Bhuvaneshwar. More than 160 ladies of rural areas were imparted training.

Shri Gangadhar Sahoo attended 3 meetings of Executive heads of the voluntary agencies running Anganwadi Workers Training Centres, jointly organised by the N.I.P.C.C.D., New Delhi and Department of Panchayati Raj, Government of Orissa, at Bhuvaneshwar. Shri. Ramakant Lenka who conducts Training Centres at Rayagada also attended the meetings at Bhuvaneshwar.

Shri Lenka Continued to be the member of the Managing Committee of Bari High School, Bari M.E. School and Bari Balika Bidyalaya of Balasore district. During the year Shri. Lenka attended many public meetings and seminars including the Political Science seminar organised by the Rayagada College on (1) Centre State Relation and (2) Rural Poor-Problems and Remedies.

Shri. Dinesh Misra, who looked after the activities of Bazpur Centre in Nainital district, continued to be the member of Advisory Committee of tribal development and Yuvak Dishadarshak Sangh, a non-potilical organization. He organised a Youth Camp in a tribal village. He conducted a survey of Tharu Villages namely Bankati in Kheri district and Sirsia in Bahraich district with a view to establishing an educational complex in them under the Government of India's Schemes.

Social Welfare

Dr. Kakade continued to be a member of the Managing Committee of the District Probation and Aftercare Association which conducts two Remand Homes for Boys, one Remand Home for Girls and a child Guidance Clinic for problematic children. He attended all the meetings of the Committee. He was a Trustee of the Association.

Dr. Kakade continued to be a member of the Managing Committee of the Society for the Welfare of the Physically Handicapped at Wanavadi. The Society has been very fortunate to have a good Cosmopolitan team of young workers. The Workshop is also doing very well.

Dr. Kakade continued to be a member of the Managing Committee of the Mahila Seva Mandal. The Mandal runs Kusumbai Motichand Sevagram for women in moral danger, a hostel for working women, a Pre-Primary and Primary School and Udyog Mandir. To facilitate rehabilitation of girls and women arrangements have been made to provide them training in a number of trades and crafts on the premises of the Mandal itself. It also runs a Fit-Person institute for Court-committed children.

Dr. Kakade continued to be a member of the Executive Committee of the Nav-Jeevan Mandal and attended its meetings.

Dr. Kakade countinued to be a member of the David Sassoon Infirm Asylum now known as Niwara(shelter). It has been catering to the needs of old people. A small hospital and dispensary are also conducted for diabetic patients at Niwara.

The Vidarbha Maharogi Seva Mandal has continued Dr. Kakade as member of its Managing Committee.

Shri. Ajgaonkar was re-elected Vice-President of the Social Service League founded in Bombay in the year 1911. It has pre-eminent place amongst institutions which pioneered welfare services in the country. He is the senior Member of the Association for social Health in India.

To enable working women, widows and deserted women to become socially and economically self-reliant Shri. Dhanore has established in 18 villages their 30 Saving Groups in Aurangabad district. 820 women are participating in them and saving an amount of Rs. 8,200 every month. This amount is kept in saving Bank Accounts jointly in the names of three members.

Shri Dhanore has started an organisation of people below the poverty line and of backward classes. This organisation helps the concerned people in getting financial assistance from several schemes of Government and in securing employment. Shri Dhanore has established contact with 1800 families below the poverty line from 30 villages. He has submitted for assistance 335 cases of people out of whom 188 people have received loan under Government Schemes.

He organised and registered an organisation of women in 68 villages in Paithan, Aurangabad, Kannad and Gangapur talukas. He plans to get financial assistance from the Integral Rural Development Programme for women and children.

Shri Dhanore conducted since last two years a Balwadi at Paithan Sugar Factory. 45 children attended it by paying a nomical fee.

Shri. Neve extended help to women in distress in Nagpur by arranging for them legal advice and by securing reconciliation in the family discord. He also helped the crippled persons by solving their various problems relating

to educational, physical, Psychological, social and economical matters under the guidance of experts in the related fields. He secured work for their gainful employment and provided to them tricycles, creches etc. as per their requirements. As a trustee of the Apang Vichar Manch he tried to organise all disabled in Maharashtra State and create awareness among them.

In Uttar Pradesh the Society maintained at Allahabad a hostel for working women to provide residential accommodation to women coming from different parts of the country and working in Allahabad. 55 working women availed themselves of this facility. The total expenditure incurred on the hostel was Rs. 92,198.37P Shri. Amresh Chand Tripathi, a Resident Member, looked after the management of the hostel.

Shri. Dwivedi took keen interest in the welfare of women and children. Considerable unemployment amongst women in rural areas, particularly during periods of natural calamities, attracted his attention. In his meetings under the women's Awareness Programme he advised the Tribal and Backward class women to start small scale industries like carpet weaving, knitting etc. to improve their financial condition. He met several times the Chief Development Officer of Nainital district and other officers and requested them to help the women in setting up samll-scale industries under various government schemes. Shri. Dwivedi also advised the women to start dairies in their villages and helped them to complete the procedure of getting subsidy under the schemes. Many dislinguished doctors who attended the meetings under the Programme gave guidance to women about brining up the babies and about protecting them from diseases through immunication in time. In the Balwadies and creches of the Society care was taken to provide Balanced nutritlious food to children. Shri. Dwivedi maintained a hostel for working women to provide temporary accommodation to them on nominal rent.

The Choudwar Centre of the Society in Orissa continued to conduct a child Development Programme in its Shishu Sadan. The Home provides all prossible parental care and protection. The Centre conducts an Observation Home. As a part of the development programme, the Centre maintains a printing press and some suitable trades for imparting vocational training to the inmates. The Sponsorship programme was conducted by the centre as in the past with the patronage of Christian Children Fund Inc. Bangalore.

Shri M. B. Deshmukh devoted his considerable attention to the work of the Navjeevan Mandal which works for rehabilitation of released prisoners. Shri Deshmukh is actively participating in every activity of the Oldage Home conducted by the David Sasson Infirm Asylum (Niwara) as a member. He arranged Group meetings and health shibir with the help of Karve Institute of Social Work in Pune.

Medical Aid

The Choudwar Centre of the Society has been conducting a leprosy clinic since 1927. The main object of the Clinic is detection and eradication of the disease and to rehabilitate the patients. The Clinic opens on every Sunday in the week and patients are given prescribed tablets and mid-day meal. As in the past the patients were supplied winter clothing during the year. The Centre arranges to get old age pension for the patients from the State Government.

The Centre also runs Saraswati Sahoo Maternity unit for the health and care of women and children. It is full-fledged hospital run with the voluntary services of well-known medical doctors. The hospital undertakes immunisation programme and supplies medicines to poor people in the locality.

During the year Shri. Damodar Sahoo inauguarated Matru-Shishu Kalyan Shibir and Immunisation Camp organised by Mother Teresa Philanthropic Association in the district of Balasore on 21-11-93, where 577 patients were treated and given medicines.

Shri. Damodar Sahoo attended the Eye Camp organised by Satya Sai Seva Sangh where 54 patients were operated and 87 patients were given medicines after check-up. The Centre organised several free medical Camps at the Society's education Centres with the help of several renowned doctors and medicines were distributed as per prescriptions of the doctors.

Shri. M. M. Dhonore arranged to provide medical aid to women and children in ten villages in the hilly tract of the Aurangabad District in Maharashtra where no medical facilities exist and consequenty patients are required to go

10-15 miles away for getting treatment. He supplied medical kits to four trained health Visitors who visit the villages and treat the patients. The Health Visitors also treat the patients residing on two co-perative Sugar Factories in the area. During the year under report a total number of 1034 sick persons got the benefit of the medical aid.

Shri Madhusudan Sahoo, as the Chairman of the Banabashi Vikas Trust arranged to provide a sum of Rs. 20,000 to undertake medical relief to give instant relief during natural calamities and render educational help to S.C & S. T. studends in Orissa.

Shri. Ajgaonkar was a member of the Supervising Committee of the Bai Bachubai Kanji Charitable Dispensary and Ayurvedic Dispensary of the Social Service League, both located in Parel, Bombay. Patients are treated at subsidised rates.

Distress Relief

Maharashtra

Shri. Dhanore went to earthquake striken areas of Latur and Usmanabad districts with his workers on 2nd Oct. 1993 just a day after the earthquake. They visited number of families, collected food and supplied it to the affected people for five days. They also saw to it that the aid provided by government and other agencies reached the affected people only. They also helped in Killari (the centre of the earthquake) in cremation of the dead perseons. By securing permit from the Collector of Latur in the name of the Servants of India Society Shri Dhanore helped the affected families in getting medicines, ration, milk, tea, Kerosene, temporary shelter etc. for 20 days.

Dr. Kakade continued to be the Honorary Secretary of the All-Parties Maharashtra Association for Relief and Eradication of Famine (Regd). In company of Prof. V. M. Dandekar (Chairman) and Shri. S. P. Mohite (Vice Chairman) he visited the earthquake striken areas in Latur district and surveyed the damage and relief operations in October 1993. They found that medical relief facilities were not adequate in the stricken area to meet the needs in times of calamities like earthquake. They, therefore, decided (which decision had subsequently been approved by the Executive Committee of the Association) to donate an amout of Rs. 6,00,000/- for construction of a cottage hospital at a convenient place in the district. The Vivekanand Medical Trust of Latur, which has been runing a well-equiped hospital at Latur and rendering good medical service to the people for some years past, has agreed to construct the hospital, appoint the requisite staff and run the cottage hospital. The construction work is in progress. The Association has already remitted half of the amount of donation to the Vivekanand Medical Trust.

Orissa

As a Founder member of the Sarvodaya Relief Committee Shri Damodar Sahoo attended all meetings of the committee during the year. He took active part in sending relief Materials to Kalahandi District under the leadership of Shri. Rati Das, Secretary of the Committee. A mass relief camp was organised by Shri. Damodar Sahoo in Collaboration of O.T.M., District Leprosy Control Unit and Choudwar Centre on 15-8-93, where medicines and clothes were distributed.

Shri Damodar Sahoo played an active role in the Relief Committee and sent the collected amount to the Chief Minister of Maharashtra as committee's token contribution for relief to earthquake striken people in Latur district. He issued an appeal to the people of Orissa through local newspapers for sending their contribution to the Chief Minister's Relief Fund in Maharashtra on humanitarian grounds.

General

The Central library of the Society is basically managed and funded by the Gokhale Institute of Politics (Deemed to be University), with trained and qualified staff. It is mainly utilised by Students, Staff members of the G.I.P.E. and Research Scholars on behalf of the Governing Body 'Servants of India Society'.

Shri R. G. Kakade held charge of the Society's Central Library. The Library has a rare collection of old Parliamentary blue books of the East India Company's time, about an unbroken series of proceedings of Legislatures in India and abroad and a large collection of reports of commissions and committees appointed by the Governments of India, U.S.A., U.K., etc. It is a depository Library of the U.N, UNESCO, F A O, ILO etc., specialising only in Social Sciences. It has a collection of about two lakhs books. It is open to the general public under suitable safeguards and fees or subscription. The Library also serves as the Library of the Gokhale Institute of Politics and Economics in particular and research scholars in general. The number of books added during the year was 4,600. About 380 periodicals are received in the Library.

The Library is on the free mailing list of the U.N., UNESCO, FAO, ILO, the International Monetary Fund, the International Banks, etc. as in previous years. Parliamentary proceedings of Australia, Sourth Africa, Canada, New Zealand, Trinidad and Tobago and Aden are received free of charge as before.

The Library continues to be on the free mailing list of the Rajya Sabha, Lok Sabha, some Central Ministries and all State Governments and Legislatures.

ANNUAL REPORT

The Gokhale Institute of Politics and Economics is one of the oldest research and training institutes in Economics in the country. It was founded on 6th June 1930 with an endowment offered to the Servants of India Society by the late Rao Bahadur R. R. Kale, Member of Legislative Council from Satara. The Servants of India Society, founded by Late Shri Gopal Krishna Gokhale, are the Trustees of the Institute. The Institute is registered under the Societies Registration Act, 1860 and the Bombay Public Trusts Act, 1950.

The object of the Institute is to conduct research into the economic and political problems of India and to train research workers in these subjects. Under the pioneering leadership of Late Professor D. R. Gadgil, the first director of the Institute, the Institute set standards for high quality research and training in a number of branches of economics.

Keeping in view the eminence of the faculty, the contribution the Institute has made in teaching, training and

research in Economics, the availability of physical infrastructure and the potential of the Institute, the Government of India, on the advice of the University Grants Commission, declared the Institute as deemed to be a University from May 9, 1993, the birthday of late Shri Gopal Krishna Gokhale after whom the Institute is named. The Institute started functioning as deemed to be a University with effect from that day.

During the year 1993-94 ten studies were completed in various areas such as agricultural economics, demography. transport economics, etc. A report of the Banjara-Vanjari Committee was also prepared and submitted to the Government of Maharashtra. A number of studies in agricultural economics, demography, macro economics, monetary economics and transport economics were in progress during the year. The members of reserach staff published 13 research papers during the period under report. The research staff also participated in several national and international Conferences/Seminars/workshops/ delivered lectures in other institutions/organizations and continued to work on various committees appointed by the Central and State Government and by other public agencies. Scholars and academicians from other institutions and foreign countries visited the Institute and gave seminars.

Apart from the work on various research projects, the members of the research and training staff were engaged in the teaching programme for the M. A. Course in Economics. They also continued to guide the Ph.D. research students in Economics.

During the year under report, there were 52 students in the M.A. Class in the Institute. Seven Research Fellows under the UGC Fellowship Programme continued to work in the Institute on their research studies.

Three students of the Institute were awarded the M. Phil. degree and two students Ph. D. degree in Economics by the University of Poona during the year 1993-94.

UGC Sponsored Refresher Courses and Seminars:
