

PREAMBLE

EXTRACTS FROM THE ORIGINAL PREAMBLE TO THE CONSTITUTION OF THE SOCIETY WRITTEN BY THE ILLUSTRIOUS FOUNDER LATE GOPAL KRISHNA GOKHALE IN 1905.

For some time past, the conviction has been forcing itself on many earnest and thoughtful minds that a stage has been reached in the work of nation-building in India when, for further progress the devoted labours of a specially trained agency applying itself to the task in a true missionary spirit are required. The work that has been accomplished so far has indeed been of the highest value. The growth during the last 105 years of a feeling of common nationality based upon common traditions and ties, common hopes and aspirations, and even common disabilities has been most striking. The fact that we are Indians first, and Hindus, Mohammedans. Parsees or Christains afterwards is being realised in a steadily increasing measure, and the idea of a united and renovated India marching onwards to a place among the nations of the World, worthy of the great past, is no longer a mere ideal dream of a few imaginative minds, but is the definitely accepted creed of those who form the brain of the community, the educated classes of the Country. A creditable beginning has already been made in matters of education and of local self-government; and all classes of the people are slowly but steadily coming under the influence of liberal ideas. The claims of public life are every day receiving wider recognition, and attachment to the land of our birth is growing into a strong and deeply cherished passion of the heart. The annual meetings of Congresses and Conferences, the work of public bodies and associations, the writing in the columns of the Indian Press - all bear witness to the new life that is coursing in the veins of the people. The results achieved so far are undoubtedly most gratifying, but they only mean that the jungle has been cleared and the foundations laid. The great work of rearing the superstructure has yet to be taken in hand, and the situation demands on the part of workers devotion and sacrifices proportionate to the magnitude of the task.

The Servants of India Society has been established to meet in some measure these requirements of the situation. Much of the work must be directed towards building up in the country a higher type of Character and capacity than is generally available at present, and the advance can only be slow. Moreover, the path is beset with great difficulties; there will be constant temptations to turn back; bitter disappointment will repeatedly try the faith of those who have put their hand to the work. But the weary toil can have but one end, if only the workers grow not faint-hearted on the way. One essential condition of success in this work is that a sufficient number of your countrymen must now come forward to devote themselves to the cause in the spirit in which religious work is undertaken. Public life must be spiritualised. Love of country must so fill the heart that all else shall appear as of little moments by its side. A fervent patriotism which rejoices at every opportunity of sacrifice for the motherland, a dauntless heart which refuses to be turned back from its objects by difficulty or danger, a deep faith in the purpose of providence which nothing can shake equipped with these, the worker must start on his mission and reverently seek the joy which comes of spending oneself in the service of one's country,

The Servants of India Society will train men, prepared to devote their lives to the cause of the country in a religious spirit and will seek to promote, by all constitutional means, the national interest of the Indian people. Its members will direct their efforts principally towards - (1) creating among the people by example and by precept, a deep and passionate love of the motherland, seek its highest fulfilment in service and sacrifice; (2) organising the work of political education and agitation, basing it on a careful study of public. questions and strengthening generally the public life of the Country; (3) promoting relations of cordial good will and co-operation among the different communities; (4) assisting educational movements especially those for the industrial development of the women, the education of backward classes and industrial scientific education; (5) helping forward the industrial development of the country; (6) the elevation of the depressed classes.

REPORT OF THE YEAR 2009-2010

.

INTRODUCTION

The Servants of India Society was founded by Gopal Krishna Gokhale on June 12, 1905. Its objects are the training of national missionaries for the service of India and the promotion by all constitutional means of the interest of the Indian people without distinction of caste or creed. The members of the Society are pledged to give throughout their lives the best that is in them to the cause of the Country in all secular fields. The circumstances in which the Society was founded and the objects, which the Founder had in view in founding it, are explained in the preamble he wrote to its constitution in 1905, extracts from which are given in the preceeding pages. The Preamble has been a source ... of inspiration to the Society during the 105 years of its existence.

ORGANISATION

The Headquarters of the Society are at Pune, Maharashtra State, where the members meet every year in June for its annual session. The society has branches in Chennai, Mumbai, Nagpur, Allahabad, Cuttack, Ravoada and Kerala,

Shri M.S. Sahoo is the President of the Society. Shri A.C. Tripathi is the Vice-President of the Society. Shri M.B. Deshmukh is the Secretary of the Society. Shri S.S. Ajgaonkar, Shri R.V. Neve, Shri Ramakant Lenka. Shri Gangadhar Sahoo, Shri Dinesh Misra continued to be the Members of Mumbai, Nagpur, Cuttack and Allahabad branches of the Society, respectively. The Chennai Branch was looked after by the Head Quarters Shri Ramakant Lenka. Shri S.S. Ajgaonkar, Shri R.V. Neve, Shri A.C. Tripathi and Shri Gangadhar Sahoo were elected members of the Council.

BRANCH ACTIVITIES OF THE SOCIETY

SHRI M.S. SAHOO

Shri Madhusudan Sahoo was elected as the President of the Servants of India Society on June 12, 2009. In list of incumbency, he became the 10th President of the Society.

He tried to revive the old system of writing weekly letters. In place of weekly letters, writing of monthly letters have been introduced. He looked into the accounts of the Mirzapur Centre and advised to close down the centres for which Government grants were not forth-coming since 1998.

A Special Council Meeting of the Society was held at Allahabad from July 25 to 31, 2009. Some important decisions were taken to convert the leasehold land to freehold land. A sub-committee has been formed which is pursuing the matter.

A Special Council Meeting of the Society was held at Nagpur on September 11, 2009 in which some resolutions to operate the S.B. A/c. No. 19980 with the Bank of India, Mumbai, were passed.

A Special Council Meeting of the Society was held at Cuttack on March 4, 2010. Alongwith other resolutions, it was resolved to fill up the campus of Cuttack office with sand to provide protection to the main building of the Cuttack Centre.

Being the ex-officio President of the Board of Management of the Gokhale Institute of Politics and Economics he presided over all the four meetings which were held on dates 13.06.2009, 09.10.2009,14-01-2010 and 10.04.2010. He presided over the 16th Convocation of the G.I.P.E. on Jaunary 15, 2010. In the said meeting, the Kale Memorial Lecture was delivered by Mr. C.B. Bhave, Chairman, SEBI.

In the revised MOA of the G.I.P.E., the President of the Servants of India Society will be designated as the Chancellor of the G.I.P.E. The G.I.P.E. has already arranged a quarter for its Chancellor in the Hostelcampus of the Institute.

During the year under report Shri Madhusudan Sahoo could not visit schools for imparting moral education as he was doing in previous years. His works in other fields also were curtailed. He resigned from the L.N. Sahu Memorial Trust. He was holding its Joint Secretary post from 1983.

He had to suspend the activities of the Subarna Jayanti Trust, Balikuda High School. The Trust was registered in the year 1992 to award scholarships to meritorious students of the Balikuda Tahashil. An organization namely 'Trust Sashwat Mungalam was

registered in the year 1990. This trust constructed a Shiva Temple in 1993 and is arranging annual religious discourses on Shiva Ratri davs.

He published three booklets in Oriva in Sadachar Bharati series. Till today 30 booklets have been bublished. Total number of pages of these books is 708. These booklets deal with different aspects of moral education. Having assumed the Presidentship of the Servants of India Society, Shri Sahoo was felicitated by his friends and well-wishers at different places.

By nature, he abhors publicity. However, he had to chair some public meetings at Cuttack. The Orissa Branch of the Society celebrated centenary of the late Shyam Sundar Misra, the Sixth President (1986-1994) of our Society on February 15, 2010. Shri Madhusudan Sahoo had to chair this function. A souvenir was published on this occaion. Shri Damodar Sahoo, the Secretary of the Orissa Branch took all pains to make _ Women's Hostel. As a Member Incharge Shri Tripathi the function a grand success.

Shri Madhusudan Sahoo was associated with Banabashi Seva Samiti, ANGO, which was founded in the year 1972 in the Kandhamal District. Shri Biswanath Patnaik, popularly known as 'Ajna' in Orissa, who was a freedom fighter, a great Sarvodaya leader and a companion of Binobaji during Bhoodan movement was its founder. Aina expired on March 29, 2010 at the age of 94. Thousands of people from all parts of Odisha had assembled and took part in the funeral procession. We cannot even dream to rise to that height and become such a great social leader who had adored the hearts of adivasis in Odisha.

SHRI A.C. TRIPATHI

Shri Tripathi continued to be member of Adivsai College Siltham, Birla Vidya Mandir, Muirpur and Raja Baldeo Das Birla Soneghati Vidyalaya Saikhan in Sonebhadra District and Serve India Siksha Samiti. Bazpur, Udhamsingh Nagar, managed by the Servants of India Society.

As a member of the Advisory Committee of Working looked after the management of various schemes in Allahabad, Mirzapur and Balrampur District of Uttar Pradesh running under the Servants of India Society.

Ashram School Kendra

With financial help from the Government of India / Ministry of Social Justice and Empowerment, New Delhi, the Ashram school was maintained by the Servants of India Society, during the year. The beneficiaries on the roll was 64 who were from SC communities. The Ashram school provided books and stationary, fooding, lodging and uniform facilities to the inmates free of charge.

The Total Expenditure of the Maintenance of the Ashram Schools was Rs. 4,90,074.66 during the year under report. The Classwise strength detail as below :

Dr. Kunjaru Nursery and Primary School

The School was maintained by the Servants of India Society, U.P. Branch, Allahabad for educational advancement of the below poverty line students. During the session on role was 115. The total expenditure on the Maintenance of the School was Rs. 1,12,042.00.

Working Women's Hostel

As Resident Member of the U.P. Branch Allahabad Centre, Shri Tripathi was looking the day-to-day management of Working Women's Hostel. The total income of the Working Women's Hostel of Rs. 4,88,507.00 only and on the maintenance of the Hostel was Rs. 2,40,507.00 only during the year under report.

SHRI M.B. DESHMUKH

As a Secretary of the Society, I looked after the dayto-day affairs of the Society's Head Quarters office at Pune. These included the maintenance and administration of the Society's property, Society's day-to-day correspondence including correspondence from various branches and centres of the Society and to look after the budget and accounts matters of the Society. I also worked on the Building Committee and Finance Committee of the Gokhale Institute of Politics and Economics.

I had to devote considerable amount of time towards the court cases of the Society and the Gokhale Institute, as well. This involved the studying the case papers, appointing the advocates and briefing them about the cases and also attending the hearings in the different courts. The ownership of Gokhale Hall was vested in our Society by the Charity Commissioner, Pune in March 2010. This ownership was so far in the name of Deccan Sabha, Pune.

During the year, under report, I attended the meetings of the Board of Management, Finance Committee and Staff Selection Committee of the Gokhale Institute of Politics and Economics, as a nominated member of the Society as and when such meetings were called for by the Director of the Institute.

Besides, 1 shouldered the responsibilities as mentioned below and carried them out satisfactorily.

- as a Secretary of the Nav Jeevan Mandal, Pune;
- as a Member of the Niwara Vridhashram, Pune;
- as a Member of the Maharashtra Girls Education Society (Huzurpaga), Pune;
- as a Managing Trustee of the Kalawati Adarsha Mahila Vikas Kendra, Pune.

There were innumerable problems with the Society's premises in Mumbai. The tenants were not giving any heed to the Society. These tenants included the Bank of India also. Therefore with the sanction of the Council, the premises were handed over to a renowned builder in June 2009. This action not only relieved the Society of the continuous harassment from tenants but also fetched Rs. 4 Crores and one specious flat in the proposed building at the same place.

SHRI ATMANAND MISHRA

From February 2009 to January 2010, Shri A.N. Misra was suffering from severe pain in his right leg because of which he could not move very much and confined himself for very important works only. The most important work which he was bound to attend was the case of his son which was pending in the High Court. Shri A.N. Misra devoted most of his time during the - year under report for this case-only.

Shri Misra continued to be the Joint Secretary of 'Girivasi Banavasi Seva Prakalp', Gharwal, Sonebhadra . and attended almost all the meetings and other . programmes of the Prakalp held during the year under report.

Shri Misra continued to be a member of the Advisory Committee of "Uttar Pradesh Vidyalaya Prabandhak Mahasabha", but he could not attend any meeting of the Mahasabha during the year under report because of his physical inability and court case. Why they did not expel him from the Committee and used to send copies of the proceedings of every meeting, Shri Misra does not know.

Shri Misra continued to be a member of "Bharatiya Itihas Sankalan Samiti" and attended only one meeting of the Samiti which was held on February 7, 2010 in the premises of the Kashi Vidyapith, Varanasi.

Following schemes of the Society were managed by Shri Misra detailed report of which have been submitted separately.

- Adivsai Inter College, Siltham, Sonebhadra.
- Birla Vidyamandir Intercollege, Muirpur, Sonebhadra.
- Raja Baldeo Das Birla Soneghati Higher Secondary School, Salkhan.
- Ten Primery Schools previously financed by the Government of India which have been closed.
- Five Women's Welfare Centres previously financed by the Government of India which have been closed.
- Girls A.T.S. Khaliary, Sonebhadra.
- Six Primery Schools founded by U.P. Social Welfare Department.
- Two Junior High Schools founded by U.P. Social Welfare Department.
- One Junior High School financed by U.P. Education Department.
- Two Hostels without fooding facilities financed by U.P. Harijan and Social Welfare Department.

SHRI RAMAKANTA LENKA

Shri Ramakanta Lenka managed the following grant aided activities and devoted his time for its smooth management.

- Thakkar Bapa Ashram 100 inmates
- Educational Complex for ST Girls 60 students.

Shri Lenka organized 140th Thakkar Bapa Jayanti in the premises of the Rayagada Centre of the Society. A public meeting was held in which Dr. Ratan Das presided over the meeting. Shri Ashok Kumar Sarada joined the function as Chief Guest. Shri Madhusudan Sahoo, President, Servant of India Society delivered welcome address and Shri S.N. Gantayat joined as a Chief Speaker.

Shri Lenka attended a conference of Indian Media Centre at Rayagada and proposed vote of thanks in the Conference. He was nominated as the Chairman of the Indian Media Centre, Rayagada Chapter and Shri Lenka formed the Executive Committee of the Rayagada Chapter of the India Media Centre.

Shri Lenka alongwith the President discussed with the U.G.C. Committee regarding change of Governance structure of the Gokhale Institute of Politics and Economics. Being a Nominee of the Society to the Board of Management of Gokhale Institute of Politics and Economics, Shri Lenka attended all of its Board Meetings.

Alongwith others, Shri Lenka took active part in organizing "Rayagada Poetry Festival 2009" in S.C. Jain Memorial Auditorium, J.K. Mill, Rayagada in which renowned poets and writers of the State were joined.

During the year, Shri Lenka attended the Special Council meetings held at Allahabad, Nagpur and at Cuttack.

Shri Lenka presided over the meeting of Mega Blood Donation Camp organised by Challengers Youth Association, Rayagada which was held at Rayagada College.

Shri Lenka also attended the Inaugural Ceremony of Central University at Koraput, which was inaugurated by Shri Kapil Sibal, Union H.R.D. Minister and 31st All Odisha Sri Aurobindo Mahila Patha Chakra Sammilani at Rayagada and he also attended the Convocation ceremony of Gokhale Institute of Politics and Economics. Besides that Shri Lenka also attended a number of public meetings / workshops and functions during the year.

SHRI GANGADHAR SAHOO

Shri Gangadhar Sahoo as the Resident Member of the Choudwar Centre of the Society, looked in to the regular activities of the units of the Choudwar Centre, as assigned to him, with close association of Shri Damodar Sahoo, Secretary, Odisha Branch.

Shri Sahoo, during the year, paid regular visits to the 30 numbers of Creche Centres run by the Choudwar Centre, in the Choudwar Municipality area and the rural sectors of Tangi-Choudwar and Athgarh Block of Cuttack District and Rasulpur Block of Jaipur District and looked in to the smooth management of those centres. Amongst those 30 centres, 22 centres are sponsored by the Bharatiya Adimjati Sevak Sangha, New Delhi and another 5 centres are financed by the Odisha State Council for Child Welfare, Bhubaneswar. Rest 3 centres are managed by the Choudwar Centre from its own resources. In those 30 centres more than 750 children within the age group of 1 to 6 years from poor, scheduled caste and tribal families and the children of working and ailing mothers are being cared. They are being provided with supplementary nutritious food, medical care and education through play way method in a beautiful homely atmosphere. Sixty numbers of well gualified and trained lady workers are engaged in those centres for caring and educating the small children. Shri Sahoo also attended several meetings of villagers of the villages where our creche centres are functioning and had discussions on various socio-cultural, economic and overall problems of those villages. He also attended zonal committee meetings of staff members organised in a regular basis. During the year, Shri Sahoo organized several medical camps in the villages of rural sectors with the help of many renowned physicians of the locality. The doctors checked the health of the small children and women of the villages. Free medicines were distributed to the patients as per prescriptions.

During the year, 16 batches of training were organized in the Anganwadi Worker's Training Unit in which 550 untrained Anganwadi Workers of various ICDS Projects of Odisha undergone training on the policies and management of Anganwadi activities. Among 16 batches, 4 batches were imparted one month long job course training and rest 12 batches were given seven days long refresher training each. Shri Sahoo looked into the overall management of the said units. He also took some of the classes in the training. He arranged field placement of the trainees in the near by ICDS projects.

Shri Sahoo also managed the Anganwadi Helper's Training Unit functioning in the premises of Choudwar Centre since 2003. This time 27 batches of training were organized during the year in which 1,140 untrained Anganwadi helpers were imparted Orientation Training of ICDS activities.

Shri Sahoo continued to be the Joint Secretary of Gokhale Ideal College, Shankarpur and Executive Member (Representative of MLA) in the Servindia L.N. Education Complex, Sardarkharida and look into the smooth management of those education centres. Shri Sahoo during the year visited several State Government Offices, met the high officials and had discussions with them on smooth functioning of the Units of Choudwar Centre. Shri Sahoo attended the General Council

Meeting of B.A.J.S.S., New Delhi organized in the last week of November and actively participated in the discussions held in the meeting.

The Council Members of the Society visited Odisha in the first week of March 2010 and arranged council meeting in the Odisha Branch Office at Cuttack. Shri Sahoo received the members of Council, attended them during their stay and accompanied them at the time of their visit to Puri, Konark, Sarala Temple, Dhabaleshwar Temple and various tourist places of Bhubneswar.

Shri Gangadhar Sahoo has become the life member of Indian Red Cross Society. He attended two meetings of Life Members in the Red Cross Bhawan at Bhubaneswar. Shri Sahoo, during the year, attended several meetings on Disaster Management and Rescue Operation System as the representative of Choudwar Centre of the Society. The meetings were organized by the Indian Red Cross, Bhubaneswar, The Choudwar Centre of the Society is assigned the responsibility of creating awareness among people on rescue operation and system of precautionary measures during different natural calamities of four Grampanchayats of Tangi-Choudwar block of Cuttak District. In this regard a task force is being formed to work in the field at the time of any natural calamity in the district, in which Shri Sahoo is a leading member.

Shri Sahoo organized four numbers of National Pulse Polio Programmes in the Choudwar Municipality area during the year. Seven lady volunteers of the Choudwar Centre lead the programme and fed Polio Drops to the children within the age group of 0-6 years at their doorstep level. Shri Sahoo played key role in making such programmes successful. National Filaria Eradication Programme were organized in the Choudwar Municipality area in which 100 lady volunteers distributed D.C.C. (Di-ethyl Carbomazine Citrate) tablets to more than 40 thousand people of Choudwar Municipality.

Shri Gangadhar Sahoo attended the Birth Centenary Celebration of Late Shri Shyamsundar Mishra, Ex-President of Servants of India Society organized in the Satabdi Bhawan, Cuttack on February 15, 2010. A souvenir named "Smruti Arghya", published in memory of Late Mishra, was released by the guests in the meeting. Shri Gangadhar Sahoo shouldered the responsibilities of editing and printing of the said magazine.

Shri Sahoo actively participated the 144th Gokhale Jayanti, celebrated by the Odisha Branch of the Society. He also took part in the 47th Death Anniversary of Padmashree L.N. Sahoo and 36th Foundation Day Celebration of Sishu Sadan, organized in the premises of Choudwar Centre on January 18, 2010. He also attended the "Bishuv Milan Utsjav" organized by the Prajatantra Prachar Samiti, Beharibag, Cuttack. Shri Sahoo continued to be the honorary correspondent of the leading Oriya Daily Newspaper "The Prajatantra", sent regular articles and news on various problems and happenings of the area which were published in the news paper in a regular basis.

SHRI DINESH MISHRA

As the Member Incharge of the Paliakalan and Chandan Chowki Centre, he looked after the dayto-day management of the Tribal Boys Hostel and Balika ATS in the district Lakhimpur Kheri in Uttar Pradesh. Brief report of the projects is given below :

Balika Ashram School

Servants of India Society has been running Two Ashram Types schools in Lakhimpur Kheri District. One of them Tharu Balika Ashram Type School (ATS) at Chandan Chowki by financial help from the Government of India / Ministry of Tribal Affairs and second SC Balika ATS at Paliakalan by the Government of India / Ministry of Social Justice and Empowerment, New Delhi. The Ashram School provide, fooding, lodging, readingwriting and playing materials free of cost to the inmates alongwith three sets of uniform. To provide medical facility to the inmates, a qualified part-time Doctor has been appointed who regularly visits and prescribes the

Working Women's Hostel

To solve the residential problems of the working women, the Servants of India Society has been maintaining Working Women's Hostel since 1984. Total 42 women coming from different districts were taking the advantage of this hostel during the year. The total expenditure on the Maintenance of this Working Women's Hostel during the year under report was Rs. 2,40,742.00.

Mandpam

The facilities, the native short of Land for organizing various ceremonies, the Society has been started the Mandpam - a marriage gardan. This Guest House alongwith being a medium of social gathering is also a tool for increasing the earnings of the Society. The total income during the year under report was Rs. 7,72,000.00 and the total expenditure on taxes and etc. was Rs. 1,43,866.00 during two years under report.

SHRI DAMODAR SAHOO

During the year, Shri D. Sahoo was looking after the day-to-day affairs of the Orissa Branch Office at Cuttack and the activities of the Choudwar Centre o the Society. He also devoted some of his time looking after the smooth management of other organizations where he was acting as Patron, Advisor, Member, Chair man and Secretary etc. He attended number of Seminars where he expressed his ideas and thoughts organized by the Government and Non-Government organizations in the State. During the year, Shri Sahoo accompanied by Shri Bidyadha Sahoo, Associate of the Society organized three 'Mega Eye Camps in the district of Jajpur with the help of Kalinga Eye Hospital, Dhenkanal where 197 patients were operated and 327 patients were checked up.

There are many problems in the State which were located during the Ex-President of the Society Shri A.N. Misra and Shri M.B. Deshmukh, Secretary in the year 2009. They also had a discussion with Dr. Raman Singh. Hon'ble Chief Minister of Chhatishgarh and Hon'ble Governor Shri K.M. Seth alongwith Chief Secretary of the State. Shri Qureshi was inspired by the learned members of the Society headed by the Ex-President Shri A.N. Misra and established the Centre in the year under report with the financial assistance of the Head Quarters of the Society. The proposal prepared by Shri Qureshi was approved by the Council and the Raipur Centre was established at Abanti Bihar of Raipur city. During the yea 110 ponds were cleaned in the tribal villages of the State.

Two proposals were prepared by him on constructic of cultural; building and Tribal Museum as the welfar activities of the Society which will be submitted to th Ministry of Cultural Affairs for sanction after the approvof the Society.

The Servants of India Society, U.P. Branch took up the Tribal Welfare work in the year 1969, subsequent to the Buxas being given the status of scheduled tribe along with 4 other communities in 1967. The initiative was taken by the Servants of India Society and it started the Buxa Boys Hostel in Bazpur, Udham Singh Nagar (then the Nainital District). Since the majority of the Tribes welfare works. The Society after establishing itself at Bazpur, turned towards other welfare works also. It then started various schemes like Balwadis, Primary Schools and Adult Education Centres in the Tarai region. In 1979, the Society then spread its wings in the districts situated on the Indo-Nepal Border, and started 2 Ashram Type Schools for girls and 2 Hostels for boys of Tribal Communities in Lakhimpur Kheri District and 2 hostels were started in the Gonda district. Taking a step further, the Society also established Senior Secondary Schools for the Tribal students. The Society also followed up its various students and helped them in getting employed successfully.

These works of the Society were applauded when it got a mention in Chapter 15 of the National Planning Commission Report of 1995. The report expressed that the Servants of India Society is doing good work in the field of Tribal Welfare. Later, the Servants of India Society was awarded the status of 'Established Voulantary Organisation' by the Ministry of Social Justice and Empowerment in the year 2000, and by the Ministry of Tribal Affairs in the year 2004.

Hostel for Tribal Boys - Buxa Boys Hostel, Bazpur

The Buxa Boys Hostel has had a key role in the educational upbringing of the Tribals of the Region ever since its establishment in 1969. The foundation of the hostel was laid down by Shri N.D. Tiwari, the then Finance Minister, Government of U.P. in May 1969. Its establishment was backed by the personal request of Shri Tiwari, who is solely responsible for bringing the Servants of India Society to the Tarai region. The hostel has remained a light house in the advancement of the Tribals and this is evident from the success of its alumnae. Some of the successful alumnae of the Hostel are -

The Buxa Boys Hostel is run with the financial support of the Ministry of Tribal Affairs, New Delhi. The Hostel has a lush green 5 acre campus which contains a building, playground and a fishery demonstration farm. The Hostel provides fooding, lodging, reading, writing material free of cost to the inmates alongwith three sets of uniform. A tuitor has been appointed to give tuition to . the inmates. A part-tme qualified doctor was also appointed for the inmates.

The Hostel has 30 residential rooms, 10 latrines, 7 bathrooms, along with one kitchen, one store-room and a warden-room. The hostel has provided land to the Uttarakhand Jal Sansthan for a deep bore well to provide 24 hour water facility to the inmates. A hand pump for water needs is also available. The total expenditure on the maintenance of the Hostel during the year was Rs.12,74,839.00. The classwise strength is given below :

Balika Ashram Type School, Bazpur.

To meet the need of literacy among the tribal girls, the Servants of India Society maintained an A.T.S. at Bazpur in the Uttarakhand State. The Scheme is financed by the Ministry of Tribal Affairs, New Delhi.

An A.T.S. is a residential school where education, fooding, lodging, clothing with other necessary facilities is provided free of cost. A part-time doctor has also been appointed for the medical supervision. The School has 5 latrines, 5 bathrooms, one kitchen and one warden room. The classes are conducted in a hall measuring 41 x 28.5 feet an adjoining verandah of 8.5 x 41 feet. The girls of the A.T.S. were taken to Haridwar for an excursion.

The total expenditure on the A.T.S. during the year under report was Rs.13,57,580.00. The strength details are given below :

Primary Schools

For providing an easy access to education to the Buxa Tribe Children, 14 primary schools were run in the Tribal belt of Udham Singh Nagar in Uttarakhand state. These schools are recognised by the Basic Siksha Parishad, Uttarakhand and the State Government provides grant for the salary of the teachers accoorincing to the Scales of the Education Department. These schools are run in buildings owned by self.

The total number of teachers employed in these was 34. A total of 1,334 students were taking benefit of these schools.

Serve India Inter College, Roshanpur.

For the educational advancement of the Buxa tribe and other communities of the region, the Serve India Shiksha Samiti, maintained an Intermediate College at Roshanpur in the District of Udham Singh Nagar. The College is recognized by the Madhyamik Shiksha Parishad, Uttarakhand. The College is ranked in the top ten schools of the District with 91.7% result in the State Board Senior Secondary Examination. The College got a new room constructed with Rs. 1.15 lakhs from the Member of Parliament quota. The College completed 25 years of its establishment. The School celebrated its Silver Jubilee Function on February 2, 2010. The M.L.A. Gadarpur was the Chief Guest of the function which included various cultural programmes. The Chief Guest sanctioned Rs. 2 lakhs for construction of a new room from the M.L.A. Fund.

GOKHALE CHILDRENS HOME (G.C. Home)

The most historic and memorable event in the long history of G.C. Home since its inception on March 15, 1945 occured during this year by the visit of the incombent President of SIS Shri A.N. Misra, Vice President Shri Rama Kanta Lenka, Secretary Shri M.D. Deshmukh and the Senior Member Shri Gangadhar Sahoo of Servants of India Society on September 1, 2008 when they were pleased to inaugurate the reconstructed Kitchen and Dining Hall Building of oUr Gc. Home which was named as Kunju Hall.

The inaugural function was well attended by the Project Director, DRDA Shri T. Baburao Naidu and the local public representatives like the President, Local Mandal Parishat Smt. P. Sarada, Member, Zilla Parishat Shri Ch. Rama Rao and Sarpuch Smt. V. Rajasri and several other important citizens.

In the meeting, philanthropic people like Shri Oruganti Eswara Rao, a local entrepreneur donated a sum of Rs.10,000/- to G.C. Home on the occasion, Smt. G. Satyavathi came forward to donate Rs.5,000/annually and others like Sarvashri Krishna offered to donate @ Rs.100/- per month on a sustained basis.

The consensus of the meeting was that more such philanthropic people from the locality should be effectively motivated to be empanelled as recurring donors so that the services could be extended to more children to the optimum capacity of the Home and the Home should ultimately grow into an ideal centre for integrated services to the needy and neglected children

in the area and develop the infrastructure of the Home into a model centre, while focusing greater attention on the development of children academically, physically while inclucating the qualities like discipline, character and patriotism in the children.

Sarvasri Chintu Rama Rao, Member, Zilla Parishat and Shri B. Ramesh, an industrialist from Kotabommali to together hosted a magnificent dinner to all the guests who attended the meeting. Shri K. Bodenna, a major donor for the reconstruction of Kunzru Hall who donated Rs. 60,000/- was fittingly honoured on the occasion. The distinguished guests from SIS gave inspiring messages appreciating the local efforts to improve the G.C. Home. A pledge was taken by some of the local elders who attended the meeting that efforts would be further mounted to make our G.C. Home, a model centre for child development in the area.

A Local Management Committee has been constituted to monitor the efforts in the G.C. Home to achieve the objectives for the integrated growth of the needy and neglected children. The Committee is evincing keen interest in the Home, which is a healthy beginning for boradening the involvement of the local public more effectively in the efforts of the home.

On behalf of all the office bearers and members of the newly constituted Local Management Committee when a request was made the local Legislator Shri D. Krishnadas, he immediately responded positively by issuing a letter to the concerned authorities to utilize a sum of Rs. 1,00,000/- for the establishment of a Mini Water Supply Scheme in the premises of G.C. Home, which is to be grounded soon. Besides, efforts are now on to involve all the members effectively in the development efforts to the home. The Constitution of this Committee was approved by the President of SIS during his visit.

It should be a matter of interest to all the well-wishers of the Home to note that Ms. Avanthika Tankala, now a school student in USA happened to visit of G.C. Home with her parents Smt. Sudha and Shri Kanishka Tankala recently and she collected the basic information about G.C. Home and the inmates collecting some photographs made a presentation in her school in USA and some of her co-students responded by donating

collectively a sum of Rs. 2,323/- from their pocket money. She sent the money alongwith their good wishes to the inmates in the G.C. Home. She is interestingly the daughter of Shri Kanishka Tankala who is already an empanelled recurring donor of G.C. Home.

We very much wish for a very bright future for Avanthika and her friends and we hope that there could be more such initiatives like that of Avanthika. The local Lions Club of Narasmmapeta sponsored a medical checkup for the inmates on March 22, 2009 and some medicines were distributed to the children.

The inmates of G.C. Home are now 13. Their nutritional status is continuously monitored. Special facilities are being provided for sports.

The number of inmates would be increased at least to 20 this year. The infrastructure needs will receive continuous attention. We are getting a master plan ready for the total development of G.C. Home. It is indeed a unique happening with our Home this year that the esteemed President and other from Servants of India Society are pleased with the efforts being locally made here and they have released a special grant of Rs.50,000 this year and we hope this will turn out to be a recurring grant on annual basis from Servants of India Society.

We particularly place on record our sincere thanks to the donors for their munificent donations but for which G.C. Home could not have been what it is today. Please visit G.C. Home unfailingly when you visit these parts, since the local management and the inmates look forward to greet you with gratitude and warmth.

An action plan is being prepared to establish a full scale children park as a part of D.C. Home. As usual D.C. Home's financial accounts are audited on annual basis. We herewith furnish the following documents for your notice.

GOVERNMENT OF INDIA SCHEMES

The following Schemes were being run by the Society in Orissa, U.P. and Uttarakhand States which were funded by the Union Ministry of Social Justice and Empowerment and Ministry of Tribal Affairs.

SCHEMES OF MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT

U.P. STATE (SONEBHADRA DISTRICT)

1. Primary Schools (Ten)

Ten Primary Schools were run by the Society which were located in the Sonebhadra district. These schools were financed by the Union Ministry of Social Justice and Empowerment (SCD-Division). All these schools are duly recognized by the U.P. Education Department and are regularly inspected by the concerned authorities.

2. Ashram School, Siltham

The Ashram provides free residential accommodation, food, clothing, oil and soap, reading and writing material to SC students. Thus, this has been functioning as a Hostel for SC Boys from its very inception but it is named as Ashram School because the Government of India, Ministry of Social Justice and Empowerment has been sanctioning the Scheme with this name.

3. Girl's Ashram School, Khaliyari

The Ashram provides free residential accommodation, food, clothing, oil and soap, reading and writing materials to SC girls attached with the Ashram.

4. SC Boys Hostel, Ghuwas

The hostel provides free residential accommodation, food, clothing, oil and soaps, reading and writing material to SC students in the Primary School, Ghuwas run by the Society.

5. Women Welfare Centres (Five)

.........

These five Women's Welfare Centres were located in the Village Bidar, Mahuariya, Supachuwan and Kudari in Dudhi Tahesil and in Village Barhauli in the Robertsganj Tahesil of Sonebhadra District. Training in Tailoring, Embriodory and Knitting by hand were being provided through these Centres to women attending these Centre.

U.P. STATE (LAKHIMPURKHERI DISTRICT)

Balika Ashram Type School at Paliakalan

With the financial assistance from Ministry of Social Justice and Empowerment, Government of India, Balika Ashram Type Residential School was maintained by the Society at Paliakalan in Lakhimpur Kheri district for educational advancement of girls belonging to SC community. During the Session 2009-2010, the Ashram School provided food, lodging, clothing, books and stationary and also medical facilities to the inmates free of cost.

U.P. STATE (MIRZAPUR DISTRICT)

Ashram Type School, Khantra

The Society maintained an Ashram Type School at Khantra in Marzapur district which was funded by the Ministry of Social Justice and Empowerment, Government of India. The Ashram provided food, lodging, clothing and reading writing material free of cost to SC students.

ORISSA STATE (RAYAGADA DISTRICT)

Residential Hostel for SCs (Thakkar Bapa Ashram)

The Rayagada Centre of the Society maintained a residential hostel for SC students popularly known as Thakkar Bapa Ashram. The Ashram provided free boarding, lodging, educational facilities to SC students. The students were provided with necessary reading writing material and intensive coaching to improve their standard of education. Facilities like indoor and outdoor game, oil and soap, uniforms and free medical assistance were also supplied to them. A group of students visited Puri, Konark in an educational excursion.

SCHEMES OF MINISTRY OF TRIBAL AFFAIRS, GOVERNMENT OF INDIA

U.P. STATE (BALARAMPUR DISTRICT)

1. Thar Janjati Boy's Hostel, Tulsipur.

The Society maintained a hostel for Tharu Janjati

Boy's Hostel at Tulsipur for educational advancement of Tharu ST Communities with the financial aid from the Union Ministry of Tribal Affairs. The hostel provided lodging, boarding, clothing, reading and writing material and also medical aid to the inmates free of cost.

2. Tharu Janjati Boy's Hostel, Pachperwa.

The Society maintained a hostel for Tharu Janjati at Pachperwa in Balarampur district with the financial aid from the Ministry of Tribal Affairs, Government of India. The hostel provided free lodging, boarding, reading writing materials, medical aid, uniforms to Tharu ST inmates.

3. Tharu Janjati Boy's Hostel, Chandan Chowki and Lakhimpur, Kheri District.

The Society maintained a hostel for Tharu Janjati Boys at Chandan Chowki in Lakhimpur, Kheri District for educational development of Tharu Communities. The hostel provide free boarding, lodging, reading, writing materials, uniforms, medical aid to the inmates free of cost. This project was financed by the Ministry of Tribal Affairs, Government of India.

Balika Ashram Type School (ATS) at Chandan Chowki and Lakhimpur, Kheri District.

The Society runs a Balika Ashram Type School at Chandan Chowki with the financial aid from the Union Ministry of Tribal Affairs for educational development of tribal girls. The inmates of the ATS are provided with food, lodging, clothing, bedding, reading writing material free of cost to the Tharu ST girls in the ATS. The ATS has got the basic recognition from Basic Siksha Parishad, U.P.

UTTARKHAND STATE (UDHAM SINGH NAGAR DISTRICT)

1. Buxa Boys Hostel, Bazpur.

The Society maintains a hostel for Buxa preemptive tribe boys at Bazpur in Udham Sing Nagar District with the financial aid from Union Ministry of Tribal Affairs. The Hostel provides free food, lodging, uniforms, reading writing materials, medical aid to ST inmates.

2. Balika Ashram Type School (ATS), Bazpur.

The Society maintains a Balika Ashram Type School (ATS) at Bazpur in Udham Singh Nagar District with the financial aid from the Ministry of Tribal Affairs, Government of India. There are ST girl inmates in the ATS and they are provided with free food, lodging, reading writing materials, uniforms, free of cost. Free medical aid is provided to them through a medical officer, who visits the ATS twice a week. The ATS has got the basic recognition from the basic Sikhsya Parishad, Uttarakhand State.

ORISSA STATE (RAYAGADA DISTRICT)

1. Educational Complex for ST Girls

The Society is managing an Educational Complex for Tribal girls at Village Halua in Rayagada District with 100% financial aid from the Union Ministry of Tribal Affairs. The Educational Complex is running with a view to improving the tribal female literacy. The Complex provides the facilities of free boarding, lodging, uniforms, cosmetics, reading writing material, medical aids and medical checkups to ST girls. It has the facility for reading of ST girls upto Class V. In order to motivate the parents to send their daughters to the complex an incentive of Rs. 50/- per month per parent was paid. All girl students of the Complex went on an educational tour and visited Shri Jagnnath Temple, Puri Sea Beach, Konark, Nandan Kanan Zoo, Planetorium and Lingaraj Temple at Bhubaneswar.

ORDER UNDER SECTION 80G (5)(vi) OF THE INCOME TAX ACT, 1961 READ WITH RULE 11AA OF THE INCOME TAX RULES 1962.

Donations made to the Servants of India Society, 846, Shivajinagar, Pune 411 004. will be eligible for the benefit of deduction under section 80G of the Income Tax Act, 1961, in the hands of the donors subject to the limits and conditions prescribed therein.

3. If further renewal is required, an application in Form No. 10G should be made to this office by the Trust/Society along with:

- (I) Statements of accounts for the last 3 years,
- (II) Copies of acknowledgments of Returns of Income,
- (III) Certificate under Section 13(1)(c) of the Income-tax Act, 1961, signed by the trustees, and,
- (IV) List of donors of amounts of Rs. 500/- and above for the last 3 years.

3.1 Assessee has been advised to incorporate the following clauses in the Trust Deed/Constitution/ By Laws/Memorandum of Association and submit the revised deed by 30-11-2010.

a) "Any amendment to the Trust Deed/Constitution/By laws/Memorandum of Association will be carried out only with the approval of the Competent Income tax authority, i.e. the Commissioner of Income Tax-III, Pune."

b) "In the event of dissolution, the surplus assets / funds of the Trust/ institutions, as would remain after discharging all liabilities, shall be transferred to any other public charitable institution having similar objects and also registered u/s 12A of the Income-tax act, 1961; and the same shall not under any circumstances be distributed among the members."

c) "The trust is Irrevocable."
