#### FOREWORD

It is now generally known that the industrial expansion during, the three plan periods has led to the creation of considerable unutilized capacity in a number of industries in India. The reasons for this, however, have not yet been properly investigated into and hence not well understood. Conditions of recession which have appeared in certain industries have complicated the situation further. Therefore, in order to assess the extent of unutilized capacity and the reasons therefor, in certain selected industries, the Institute conducted a quick investigation. The present memiographed publication is a preliminary report of this investigation.

The investigation was confined to important industries manufacturing capital goods and intermediate goods and therefore covered coal and other mining, paper, chemicals, fertilisers, cement, metal and metal products, machinery, transport equipment and other engineering industries. Kothari's Economic Guide and Investors' Handbook of India 1965 lists approximately 1200companies having factories in these lines. As the idea was to conduct a quick enquiry, the method of mailed enquiry was adopted and a brief questionnaire was mailed to all these companies, actually 1175 in number. After waiting for a while, a reminder was sent. In all 207 companies sent in replies but about half of them were indifferent or incomplete. Only 151 replies were complete and they form the basis of the present report.

Considering the general reluctance to reply to mailed questionnaire, we are not discouraged by the response to our However, it must be admitted that the small response deprives the results of much of their validity. Nevertheless, we are venturing to forward the results of the enquiry for two reasons. Firstly, the present report will indicate the kind of results that can be secured from such an enquiry and the nature of the problems that they can throw light on provided that they were based on a fuller response from the industries. It is hoped that these results will create greater interest in such enquiries and that we shall obtain better response from the industry to similar enquiries in future. Secondly, in spite of the admittedly inadequate base, it may be noted that the results are not entirely It will be seen that the enquiry covered 234 industrial products and obtained estimates of unutilised capacity in these cases and the reasons therefor. Moreover, it should be noted that only 87 of these 234 products appear in 'Monthly Statistics of Production' so that very little information is available from ather sources on a large number of products covered by the present enquiry.

The enquiry was conducted under the guidance of Professor P.N.Mathur and forms part of a series of studies in inter-industry relations he is organizing in the Institute. It is needless to say that the validity and utility of these studies will depend upon the extent of willing co-operation that the industry extends.

# CAPACITY UTILISATION AND FACTORS AFFECTING IT, IN CERTAIN INDIAN INDUSTRIES, 1966-67

#### Introduction

l. It is a common knowledge that certain Indian industries have considerable unutilised capacity. The reasons for the unutilised capacity, however, are not known in detail. Knowledge of both these would be very helpful for a detailed planning. With a view to quickly assess the situation in this regard, a survey of certain selected industries was undertaken recently. In this paper the results of this survey are analysed. The necessary background for the discussion of the results is given in paras 2 to 15. The extent of unutilised capacity, reasons for the same are discussed in detail, product-wise, in paras 16 to 32. Analysis of important industries is made in paras 33 to 43. Main conclusions are given in paras 44 to 49.

#### Scope of the Survey

2. The intention of the survey was to cover only important industries that manufacture capital goods and intermediate goods. The industries selected, therefore, were coal and other mining, paper, chemicals, fertilisers, cement, metal and metal products, machinery, transport equipment and other engineering. It was also decided to contact these industries by mailing a proforma. The first problem, therefore, was that of a suitable sampling frame. The best frame would be the list of all factories in these industries giving their postal addresses and their size by capacity. Such a frame was not available. The 'Indian Industries, 1963' was not useful because it meant contacting about 10,000 factories (which was unwieldy) since sampling was not possible in the absence of information regarding the size of the factory. Compared to this, Kothari's 'Economic Guide and Investors' Handbook of India, 1965' was found to be useful because it was more recent, it meant contacting about 1400 companies (on a rough count). Moreover, the coverage was expected to be greater in this case because a company may have more than one factory\* and the size of the factory also is likely to be bigger. Hence it was decided to contact all these companies. Proforma was posted to all of them (which were actually 1175 in number) and was followed by only one reminder. (See Appendix A for proforma).

The response was 25%. (See Appendix B for details). However, 151 companies (13%) could be incorporated in this study since the response from the rest of the companies was not helpful.

#### Nature of inquiry

3. As mentioned earlier, the object was to quickly assess the latest position regarding the capacity utilisation and reasons affecting it. Each company was, therefore, requested to give approximate figures of production, capacity and reasons for unutilised capacity, productwise. The reasons were to be given in order of importance. Since our interest was more in the reasons 'lack of demand' and 'shortage of raw materials', among other things, more particulars are sought regarding these two reasons (See the proforma). As a background for the discussion of the results given in detail in Table 1, some points are elaborated below.

#### Best and latest years

4. The companies were requested to furnish the particulars for the 'best' and 'latest' years. For the purpose of this survey, the best year was defined as 'the year since January 1960 in which the total production was the highest' and the latest year was defined as the latest year possible for which particulars are readily available. The particulars required for best year were the figures of production and the pattern of sales of various products, productwise. The parti-culars required for the latest year were the figures of production, pattern of sales, figure of capacity, and the reasons for unutilised capacity, if any, product-wise. (See proforma). It was expected that the latest year for a majority of responding companies would be about the year 1966 The distribution of 140 responding companirs according to latest and best years, given in Appendix D, shows that the latest year in respect of 102 companies (73%) was within the period January 1966 to April 1967, as expected. Though the analysis of the latest situation was the immediate object, particulars regarding best year were also asked, with a view to have comparison between the situations in the latest and best years, to some extent. Considering the periods to which the latest and best years refer, it is significant to note that these are same in case of 75 companies (54%), these differ by one year in case of 30 companies (21%), and by two years in case of 20 companies (14%). Considering the definity tion of best year, that it could be any year since January 1960, it may be noted that practically all companies (123) have best year falling after January 1963.

## Concept of capacity

5. A given company may have only one factory. If the factory is producing only one product, the maximum output of that product technically possible, should be the capacity.

This pre-supposes absence of restraints on account of raw materials, labour, market etc. In other words, the maximum output possible with the existing set of equipments and machinery, given all other things, is the capacity, which may be termed the technical capacity. If the factory is producing two or more products (and they are not joint products) and if those products are competitive in respect of the use of at least one equipment, then the capacity of the factory as a whole would be a function of the product-mix. In such cases the estimation of capacity is a difficult task and may involve use of different techniques.\* If the company has more than one factory the capacity in respect of the company as a whole would just be the addition of capacities of individual factories the company has. Such a concept of capacity is relevant here since our interest is to know what is technically possible and what the reasons are for under-utilisation, if any.

6. In view of the possible difficulty in estimating the technical capacity and the time it may take, a practical definition of capacity is given considering what best can be quickly obtained. The definition given was: 'Capacity means the optimum production possible with the equipment during the latest year assuming normal operating conditions. All the products and their quantity mentioned under this should be capable of being produced together during that year.' The words 'normal operating conditions' were intended to mean the number of shifts normally worked, normal period of time for repairs etc. Obviously, the capacity based on this definition would be less than the technical capacity to the extent the institutional factors, like less number of shifts worked etc., affect. Under these circumstances, one should not expect production to exceed capacity. The returns, however, show that in case of some products the production exceeds capacity.\*\* Secondly, a given product is manufactured by different companies working different number of shifts. This clearly indicates that the reported figures of capacity are less than the technical capacity in those cases. It would be interesting to estimate the difference between theitechnical and actual capacities. This would need closer examination of the basis of capacity. This is not atempted here. Whatever the companies have reported as capacity is considered in this study.

## Unutilised capacity

- 7. The figures of production and capacity during latest year, in physical units, are given in Tables 2 and 3 of the proforma. The excess of capacity over output as a per cent of the capacity is the unutilised capacity (U). The excess of output over the capacity as a per cent of capacity is the overutilised capacity (O). Whenever a given product is manufactured by two or more factories, or whenever two or more products/aggregated, it is necessary to seggregate the unutilised and overutilised capacities so that, for the aggregate product, the real unutilised capacity regarding some of its 'members' is not offset by the overutilised capacity of other 'members' constituting that aggregate product. For example, if a product is manufactured by two companies and the capacity is 100 units in each case, while the production is 60 and 120 units respectively, then U = 20 and O = 10, the percentages of unutilised capacity and overutilised capacity, respectively, for that product
- 8. The companies were requested to report the value of production also during the latest year. The value of capacity, therefore, can be obtained. Percentages similar to U and O can be calculated on the value basis. These would be same as U and O if the product is single but may be different if the product is an aggregate product. In the latter case it indicates differences in the prices of products aggregated. In this study covering 234 products, a small number of them are aggregate products. In the latter case the percentages calculated on the basis of either physical or value units are not much different practically. Hence the analysis here runs in terms of the percentages based on physical units, U and O, which are given in Table 1. However, the value of unutilised and overutilised capacities in respect of only those products that have both unutilisation and overutilisation is given in Appendix F.

#### Data in MSP publication

- 9. Since only 25% of the companies responded to the survey it is desirable to see the extent of coverage by this survey in context of the published data available. The 'Monthly Statistics of Production of Selected Industries of India', January and February, 1967, (referred as MSP hereafter) is a publication that gives the latest position regarding capacity utilisation of a large number of products. Before the comparison is made the nature of data in MSP may be considered in relation to that in the survey.
- 10. Firstly, the number of products covered by MSP, as far as the industries under study are concerned is 354, while the survey covers 234 products. 87 products are common in both. The comparison is possible only in respect of these 87 products. Secondly, the unutilised capacity of a common product during the calendar year 1966 according to MSP is compared with the unutilised capacity of the same product for the

latest year according to the survey. Although the periods should be the same, it could not be considered in view of the time it would take to collate the data given in MSP so that it referred to the latest year of the common product (which period may vary from product to product). Perhaps this would not seriously affect the comparison. Thirdly, the figure of capacity given against the calendar year 1966 in MSP is the monthly capacity at the end of the year 1966 whereas the figure of production given is the monthly average. These two figures are not comparable because the figure of monthly capacity is found to change during the year 1966. For our purpose, the annual capacity for the year 1966 is obtained by adding the relevant monthly figures which is comparable with the annual production for getting the unutilised capacity. Fourthly, the figure of production given in MSP, against a product, seems to be the aggregate of individual figures corresponding to the different factories manufacturing that product. The real unutilised capacity, therefore, is not necessarily borne out by the difference between the figures of capacity and production because, for a given product some factories may have unutilised capacity while others may have overutilised capacity so that the latter may partly offset the former, in the aggregate. Finally, the basis of capacity used in MSP is not necessarily the same as the one used by the responding companies. This, it is felt, may be a serious limitation affecting the comparison. For instance, the annual installed capacity of superphosphate is computed in MSP assuming 330 days of working and 3 shifts per day. According to survey, it is seen that three out of six companies manufacturing superphosphate report capacity on the basis of 2 shifts while the other three report on the basis of 3 shifts. Similarly the capacity of wire ropes and railway wagons is on the basis of 2 shifts according to MSP while the basis is 3 shifts according to survey. And so on.

11. Using the figures of production and capacity given in MSP, the excess of capacity over production as per cent of capacity is obtained in respect of these 87 products only, and given in Table 1 under the column (u). A few salient features may be given here. Firstly, the figures of installed capacity are not available in case of 13 products. These are mining products, machinery like boilers, sugarcane crushers, electric motors etc. and transport equipments like trucks, three-wheelers etc. Secondly, overutilisation (u is negative) is reported in case of 17 products, important among them are products like steel ingots, Rolling mill and foundry products, Diesel engines, pumps, power transformers etc. for all of which the survey shows unutilised capacity. Considering the products having more than 50% unutilised capacity, some fertilisers, steel castings, tractor, conveying equipments, cables and wires etc. are the important ones among a total of 11 products.

#### Coverage by the Survey

The extent of coverage by the survey in the context of MSP may be considered. The number of products covered by MSP and survey according to broad groups of industries is given in Appendix D. The coverage by the survey appears to be adequate in most of the industries except 'metal mining' and 'nonmetallic mineral products' industries. In fact it covers greater number of products than MSP in case of Electrical machinery and transport equipment industries. The last column of Appendix D lists 147 products which are in the survey but not MSP. In respect of 87 products common to both MSP and survey, it is possible to know the coverage product-wise. For this purpose, the production of a given product according to the survey is expressed as a per cent of the production of the same product according to MSP (which is given in Table 1 under 'column'c). The figures of capacity are not used for this purpose for fear of non-comparability. In Appendix E the distribution of products according to coverage (c) is given. This indicates that the coverage by survey is more than 30% in about half the number of common products. It may be pointed out here that the survey covers a large number of products which are not covered by MSP, indicating less extensive coverage by the latter source. But, it should be noted that the number of factories covered by MSP for a given product is quite large.

## Representative Character of the Survey

- 13. It may be recalled here that no sampling was possible in selecting the companies so that the responding companies cannot be taken to constitute a random sample. In such a survey as this one may anticipate that the companies experiencing relatively more unutilised capacity chose to respond. It would, therefore, be pertinent to examine whether these 151 companies analysed are "biassed". The statistical procedure should be to sample the non-responding companies and make a judgement. This might mean personal interview. Neither the time nor the resources permitted this. The only thing that can be examined is to see whether there is any 'bias' with respect to MSP.
- 14. Consider those 87 common products. If the unutilised capacity reported in the survey (U-0) is greater than the one reported in MSP (u), in case of relatively large number of products, we may infer that the companies are experiencing relatively greater unutilised capacity, or there is bias. A scatter diagram of 74 products (because u is not available for the other 13 products) according to U-0 and u shows that 13 products fall within 5% or either side of the line of equal unutilised capacity (U-0-u), while 22 products show less unutilised capacity in the survey and 39 show more unutilised capacity. The inference is that there is probably bias in the responding companies. This inference is subject

comparability of the basis of capacity as given in MSP and in survey, which is elaborated in para 10.

15. MSP covers one group of products while the survey covers another. We may examine whether the percentage number of products aving unutilised capacity to the total number of products covered by the survey is different from the similar percentage corresponding to MSP. The following table gives the number of products according to capacity utilisation.

considering the figures in column 4; it appears that these percentages are not much different.

#### Detailed results of the study

16. The figures of production, capacity, per cent unutilised and overutilised capacities, all based on physical units, are given in Table 1 along with the reasons for unutilised capacity. These data are product-wise and products are listed in a sequence similar to that of MSP. The values of production and capacity are also given. The Note preceding the Table 1 explains the various columns of that table. The survey covers 234 products of which 20 have fully utilised capacity and 14 have overutilised capacity. The distribution of the remaining 200 products, according to the inutilised capacity U, is given in Table 2. By looking into the list of products falling in different ranges of unutilised capacity, it is difficult to name the industries that are to be found exclusively in one or the other range. Considering the set of products that have more than 60% unutilised capacity, \* it appears that some Chemicals, Fertilisers and Drugs, Steel tubes, Steel forgings and Non-ferrous alloys, some metal products, Textile and other machinery, Conductors and cables and some transport equipments are the important ones. It is clear that the extent of unutilised capacity is quite considerable. Although it is important to consider specially those products which have large unutilised capacity, the relative importance of the products cannot be judged solely on the basis of unutilised capacity.

For instance, Steel ingots has only 12% unutilised capacity according to the survey, but it is difficult to treat this product as unimportant. Perhaps, the value added by manufacturing a given product is a reasonable basis to judge the importance of that product. ce of that product. In the absence of such data, we are considering the value of unutilised capacity reported in the survey as indicative of the importance of the product. A word

of caution is very necessary here. A product important according to this survey need not be important in the context of the economy. This is so, because, firstly, the survey covers only a part of the economy. In particular, it does not cover a large number of products covered by the MSP. Secondly, the coverage of a given product by the survey is only a part of the capacity of that product in the economy. For a large number of products (about 140) covered by this survey but not by MSP, there is no way of knowing their capacity in the economy. We, therefore, repeat the word of caution, that, the analysis based on the value of unutilised capacity reported in the survey should be considered strictly within the frame of the survey.

17. The value of the capacity of all the 234 products is 18376 million rupees of which the 200 products having unutilised capacity account for 16350 million rupees. The value of unutilised capacity is 3432 million rupees and that of overutilised capacity is 209 million rupees, constituting 18.7 and 1.4 percent of the total capacity of all the 234 products. The unutilised capacity of those 200 products having unutilised capacity is 21%. Of these 200 products, only six products have an unutilised capacity each worth more than 100 million rupees, which together account for nearly half the total unutilised capacity as shown in the following Table.

It may also be seen that the first four products mentioned above have unutilised capacity between 12 to 21 per cent, but their value is substantial. The reasons for the unutilised capacity may be considered now.

#### Reasons for unutilised capacity

18. The companies were requested to state the reasons for unutilised capacity in order of their importance. In some returns, more than two reasons are listed. It may be recalled that our interest is primarily in the reasons 'lack of demand' and 'shortage of raw materials'. Hence,

both the reasons were found in the list, no others were taken into account. If only one or none of these reasons was there the other important reason(s) was picked out, so that only two were considered. Thus the reasons may be 'lack of demand', 'shortage of raw materials' or 'others' or any combination of only two of these. According to these reasons, the number of products, the value of unutilised capacity etc. are given in Table 3. 'Lack of demand', 'shortage of raw materials' and 'other' reasons are important in that order, solely affecting 56, 53 and 45 products respectively. 19 products are affected both by 'lack of demand' and 'shortages'. This category would be dealt with later. No reasons are given in case of 14 products. If the number of products affected, whether wholly or partly, is considered, 'shortages' and 'lack of demand' become important factors affecting 81 and 77 products respectively, while 'other' reasons affect 56 products (See last 3 rows of Table 3). In terms of the unutilised capacity, reason-wise, 'shortages' and 'lack of demand' again seem to occupy important positions causing 47% and 36% unutilised capacity. Considering the total value of unutilised capacity in the survey, these two reasons together account for about 60%. Thus, from all considerations these two reasons are more important than 'other' reasons, though the latter is not insignificant. All these three may be dealt with in greater detail.

#### Lack of demand

- 19. This is the only reason for the unutilised capacity in case of 56 products which show 36% unutilised capacity on an average, the value of which is 401 million rupees. This value is 12.8% of the total value of unutilised capacity. Though 56 products are affected, it is possible that the lack of demand for certain products may lead to reduced demand for certain other products and so on. In order to see if such a thing exists, a list of 27 important products is considered for a closer examination. All the products common to MSP and survey, and all those which have considerable value of unutilised capacity according to survey, are included in this list (See Table 4). This list accounts for 335 million rupees worth unutilised capacity, or 82% of the unutilised capacity of all 56 products.
- 20. It can be seen that the textile machinery, Machine tools, House service meters and plastic moulding machinery lack demand on one hand; Railway wagons, truck and trailer lack demand on the other. Further, refractories, stoneware,

sanitaryware, cement products and road rollers also lack demand. These in turn seem to have affected steel castings, cast iron spun pipes, electrodes and automobile wheels. Coal and iron ore seem to follow next. Wire ropes, used largely in coal mining, is also lacking demand. The lack of demand in chemicals, however, seem to be connected with certain other industries. A word of caution may be added here. In interpreting 'lack of demand' the related questions like (i) at what price? (ii) whether there is excess capacity in relation to requirement? are relevant. This will need further probe into the other data. It will suffice to add here that there is a possibility of excess capacity built in the economy in respect of certain products. In fact, the companies manufacturing wire ropes and House service meters have remarked that the capacity for them is far in excess of the requirement in the country.

21. We may now consider all the 77 products affected by lack of demand. One of the intentions of the survey was to locate the source of demand lacking, so that the interdependance could be traced to some extent. The companies were requested to mention the source of demand lacking. In case of only 21 products, the concerned companies have mentioned the source. In case of the remaining 56 products it may be possible to enumerate the industries using a given product, with the help of detailed input-output table, but it would be difficult to locate the source of demand lacking. Obviously one cannot be precise. We have, therefore, considered broad sources and classified all the remaining products. This together with the sources mentioned for those 21 products is given in Table 5. Considering the number of products each source affects, Engineering industry, Industry (general) and Textile industry are the important sources accounting for half the number of products. In terms of unutilised capacity, the first two sources retain their order of importance, while Electricity Supply takes the third position. These three account for 72% of the value of unutilised capacity of these 77 products.

## Shortage of raw materials

22. Whenever the reason for unutilised capacity was 'shortages', the companies were requested to mention the name of the raw materials in short supply, the quantity of each of them for full capacity production and whether the materials are produced in India or not. The quantity data provided by the companies, however, are not analysed here. It may be noted from table 3 that this is the only reason for the unutilised capacity of 53 products which together show 47% unutilised capacity on an average and account for 632 million rupees. This value is 19.7% of the total value of unutilised capacity under the survey. For a detailed study a set of important products is picked out on considerations similar to those listed in table 4. These are 23 products having 534 million rupees worth of unutilised capacity, or 83% of the value of unutilised

capacity of all 53 products. These are given in Table 6. The names of raw materials in short supply and whether they are not produced in India are also given. Some comments on Table 6 would be useful.

- 23. It is important to note that MSP shows overutilisation of capacity regarding Crown corks, bright steel bars and shaftings, storage batteries etc. while the survey shows unutilised capacity (and has reasonably good coverage of MSP). Many products, viz., Sulphuric acid, certain fertilisers, certain chemicals are directly affected due to shortage of sulphur, which is to be imported. Through shortage of sulphur, the products Nitric acid, Alum etc. have unutilised capacity. The shortage of Nitrogeneous fertilisers has affected NPK Mixtures. Thus sulphur is the dominant material in short supply. Nonferrous alloys are affected due to shortage of non-ferrous metals. Crown corks and containers report shortage of tinplates. Bright steel bars & shaftings are affected by shortage of Alloy steel, which is to be imported. Oil engines have shortage of castings to be imported. These castings must be of special type. (We have seen earlier that castings lack demand). Motorcycles, Autocycles, cycles face shortage of tyres and tubes besides other parts and components, some of which are to be imported. According to MSP, there is overutilisation of capacity of tyres and tubes. Such a detailed table as this, therefore, helps in locating areas of action. Of course, the decisions (like creation of additional capacity or importing or such) will depend on certain other considerations also.
- 24. We may now consider all the 83 products affected by shortages. The list of these products and the raw materials in short supply is given in Table 7. The table shows that 63 raw materials are in short supply. If these are available, 18.7% of the total unutilised capacity can be wiped out while there will be some improvement in the utilisation of capacity of other products where 'shortages' is one of, the reasons. It is interesting to see the structure of interdependance provided by this table. As an aid to this, the fact whether the raw materials listed have unutilised capacity or overutilised capacity is indicated by symbols - or + respectively in the last column of this table. For instance, Aluminium is a raw material in short supply which has unutilised capacity, because bauxite is in short supply. There are, however, some instances which cannot be explained. For instance Coke is a raw material reported to be in short It has unutilised capacity due to lack of demand, according to survey! This table is useful to trace the interdependance. It is possible to pick out different complexes such that within each there is greater interdependance. such are picked out and dealt with below. These two account for an unutilised capacity worth 1148 million rupees or 65% of the unutilised capacity affected by shortages.

#### Chemical complex

25. The first is regarding chemical complex. If sufficient\* amount of six products namely Sulphur, Hydrochloric acid, Sodium Nitrate, Bauxite, Rock and Murate of Potash are available, eleven products, chiefly fertilisers and sulphuric acid, would have full capacity utilisation since these suffer only due to shortage of raw materials (See Table 8, for details). This would mean importing sulphur and Murate of potash. Such an availability will wipe out the unutilised capacity worth 186 million rupees. The implicit assumption in this statement is that there is no structural imbalance in the economy. For example, unless sufficient amount of Nitrogeneous fertilisers is available, the capacity of NPK mixtures cannot be fully utilised and in the above statement it is assumed that sufficient Nitrogeneous fertilizers would be available to feed the NPK mixtures if the capacity of the former is fully utilised.

## Metals Complex

26. The second is regarding Metals. If sufficient amount of steel ingot, certain non-ferrous metals and PVC and Insulating paper are available, the shortages affecting 18 products, mainly structurals, metal products, aluminium conductors, cables and wires, and transformers, can be wiped out (See Table 9). The value of unutilised capacity of these 18 products is 962 million rupees. The following table shows the extent of unutilised capacity according to reasons.

It is clear from this that not much of utilisation is possible by overcoming shortages only, unless the associated reasons are also overcome. The implication of the joint reasons 'lack of demand' and 'shortages' would be considered below.

#### Lack of demand and shortage of raw materials

- 27. From table 3, it can be seen that only 19 products are affected by this. But the value of unutilised capacity is 1001 million rupees, or 29% of the total unutilised capacity. If only 11 important products are considered, their share would be 974 million rupees or 97.3% of the unutilised capacity of all 19 products (See Table 10). The number of companies manufacturing each of these products is two or more except in case of two products. Looking into the returns of the individual companies, the extent due to 'lack of demand' and due to 'shortages' is separated and given in the same table.
- 28. It is clear that some companies report lack of demand for a given product and some others report shortages for the same product. While the latter companies imply that there is demand for the product manufactured by them, the former set of companies face lack of demand. This indicates product differentiation. On the other hand, the set of companies reporting lack of demand probably do not have shortage of raw - materials (or at least they seem to have a command of raw materials market) while the other set of companies report shortage of raw materials. This indicates differential abilities to procure raw materials. For instance, aluminium conductors are manufactured by three companies of which two report shortage of raw materials and one reports lack of -demand. Similarly, in case of diesel engines manufactured by five companies, one has full capacity utilisation, two have unutilised capacity due to lack of demand and the remaining two have shortage of components to be imported. It would require separate study to probe into such situation more deeply. Considering the situation where a given product manufactured by only one company has unutilised capacity due to lack of demand and shortages, the following may be the explanation. It is possible that one of them is a reason for explanation. unutilised capacity upto certain stage of capacity utilisation, beyond which another reason also becomes operative. Barrels and paper insulated power cables are examples of these (See Table 10).
  - 29. Turning to the consideration of Metal group described in para 26, the extent of utilisation by removing the bottleneck of raw materials can be easily worked out from Tables 9 and 10 as 404 million rupees worth. There may be slight improvement in respect of products affected by shortages and 'other' reasons. It may be recalled that the chemicals group would have a recovery of about 186 million rupees worth of unutilised capacity. By removing the bottleneck of raw materials in case

of chemicals and Metals, capacity utilisation will improve by 590 million rupees worth. This amount is one-third of the total unutilised capacity affected by shortages; or it is 17% of the total unutilised capacity in the survey. At the same time it should be noted that the Metal group suffers from the lack of demand and the value of the unutilised capacity due to this is 338 million rupees. Considering that the Metal group includes 7 products each of which is affected by both the reasons, 'shortages' and 'lack of demand' sharing 514 and 338 million rupees worth of unutilised capacity respectively, (See tables 9 and 10) one wonders whether there is excess capacity also besides the market imperfection mentioned in para 25. There is scope to study this further.

#### Other reasons

- 30. It is seen from table 3 that the 'other' reasons affect 45 products solely, accounting for 1134 million rupees worth of unutilised capacity, or 33% in the survey. It is an associated reason in case of another 11 products accounting for only 3.4% of the total unutilised capacity in the survey. The details of various reasons under 'other' are given in Table 11. Though 56 products are affected, only few products falling in 'Iron and Steel' industry account for nearly three-fourths of the total.
- 31. Considering the importance of various reasons, it appears that labour troubles and power shortage are very important barring the reason 'Fire, damage etc. ..'. These two account for 40 and 12 per cent while the latter accounts for 34 percent of the total value of unutilised capacity due to 'other' reasons. This observation is subject to the arbitrary manner in which the value of unutilised capacity of the product affected by two or more reasons (within 'other') is distributed

## Overall position

32. From the above analysis the following overall position emerges in respect of important reasons affecting the unutilised capacity.\* (See next page for the Table).

It is clear from the above table that shortage of raw materials and lack of demand are the most important reasons. Labour troubles is also a disturbing factor.

## Industry-wise analysis

33. So far, the analysis has been product-wise. To focus attention on broad sectors industry-wise analysis would be made in this and subsequent paras. The industrial classification chosen is the one that roughly corresponds with the one given in MSP. All the products covered by survey are classified according to this classification, and it is seen these products correspond to 49 industries. Considering the extent of unutilised capacity in each industry and the share of unutilised capacity of each industry in the total, it appears that there are ten important industries. These are dealt with here. These ten industries cover 77 products and account for 82% of the total unutilised capacity (See Table 12). Further they account for 73% of the total capacity covered. Textile machinery, other machinery, cables and wires, NPK mixtures are the industries which have more than 60% unutilised capacity in each of them. Iron and steel, Automobile etc. have relatively a large share in the total unutilised capacity. These may be discussed industry-wise.

#### Fertilisers

34. NPK mixtures has unutilised capacity due to shortage of Nitrogeneous fertilisers and Murate of Potash. The latter is not produced in India. All the fertilisers, namely, Ammonium sulphate, Ammonium chloride, superphosphate and Ammonium phosphate have unutilised capacity due to shortage of sulphur, Sulphuric acid, Hydrochloric acid and Rock. It is clear that this industry is affected only by shortages. The shortage of sulphur is very crucial.\*

#### Iron and Steel

- 35. (i) Basic metal: Pig iron, semi-finished steel and steel ingots are included here. While pig iron suffers from shortage of electrode paste, mechanical trouble and damages, the other two are affected largely by labour troubles, power shortage and damages.\*\*
- (ii) Heavy structurals etc.: Transmission towers, Rolling mill and foundry products, Heavy structurals including bars, mild steel tubes and cast iron spun pipes are the products included in this. The first product is the only product facing shortage of zinc (to be imported) and also power shortage. The next three products suffer due to lack of demand as well as shortage of raw materials, but the former reason accounts for two-third of the total unutilised capacity of these three products. The materials in short supply are zinc, steel ingot and tin ingot. (Zinc is to be imported; Steel ingot itself has unutilised capacity due to the reasons stated earlier; position regarding tin ingot is not known). The last product, namely, cast iron spun pipes has lack of demand. The position regarding this group may be summed up by saying that lack of demand is the main reason.
- (iii) Castings etc.: Cast iron pipes, steel castings and malleable castings lack demand. Die casting and Foundry casting face shortage of copper and aluminium. Cast iron castings and Ferro alloys have lack of demand as well as shortage of raw materials; the former needs pig iron and coke

of good quality while the latter needs manganese ore. Steel forgings are affected by power shortage. Regarding Laminations and stampings a small part of its unutilised capacity is explained by delay in supply of raw materials while for the rest no reason is given. Iron casting is the only product in this group that has overutilised capacity. It, therefore, follows that some products face lack of demand while others face shortage of copper, aluminium, pig iron etc. To sum up the position regarding these three subgroups of Iron and steel industry, it may be stated that the basic metal has considerable unutilised capacity due to important reasons like labour troubles, power shortage and damages. The reduced availability of this may affect many industries like the second and third subgroups. Some products under Heavy structurals and castings lack demand.

#### Metal Products

36. Wire ropes, barrels and industrial components are the only three products facing lack of demand. The remaining eight products\* face shortage of raw materials, principal among these raw materials are special steel and certain non-ferrous metals. Certain varieties of special steel are not manufactured in India. Here again the effect of inadequate supply of basic metals can be seen.

## Agricultural machinery and implements

37. The tractor making industry has unutilised capacity. Lack of demand and shortage of parts and components (to be imported) equally share the reason for this unutilised capacity. The tractor-drawn implements and other agricultural equipments also lack demand. The plough and other agricultural tools, however, have no unutilised capacity. It is, therefore, clear that tractor and tractor-drawn implements (the use of which is indicative of mechanised farming) lack demand and face shortages, while the other tools and implements (indicative of traditional but improved farming) do not have unutilised capacity.

# Diesel and oil engines

38. The unutilised capacity of diesel engines is largely due to lack of demand and to a lesser extent is due to non-availability of certain components to be imported. Regarding oilengine, non-availability of the castings is the reason.

The boiler and pressure vessels have unutilised capacity due to shortage of various parts and components to be largely imported. The thin-walled products, Nozzles and Nozzleholders (which are required for diesel and oil engines) face shortage of bi-metal strip and alloy steel. In case of valves, the mechanical trouble is the reason, while lubricators have no unutilised capacity. In respect of this industry, shortages are dominant, though Diesel engines face lack of demand also.

## Textile machinery

39. Power looms and other items of textile machinery lack demand.

## Other machinery

40. Five items of machinery are included here. Rice mill machinery is affected due to labour troubles, while industrial engines are affected by labour troubles and power shortage. Cement machinery faces shortage of parts and components to be largely imported. Plastic moulding machinery is lacking demand. Decorticators has no unutilised capacity. The picture, therefore, is of a mixed type, with shortages as the dominant reason.

## Cables and wire

41. Aluminium conductors, electric cables and wires, paper insulated power cables have unutilised capacity due both to lack of demand and shortage of raw materials. The latter reason is more dominant. The solidal underground power cables, conductor accessories and High tension galvanised steel wires suffer from shortage of raw materials. Important raw materials reported to be in short supply are Aluminium, PVC, special steel sheets, and alloy steel, lead, and Electrolytic zinc and insulated paper, affecting all the products mentioned above. Though lack of demand is a reason, the shortages are affecting these products much more.

## Automobile

42. Heavy duty chassis (trucks) faces lack of demand. The other trucks also have unutilised capacity but no reasons are given for that. Comet passenger and good chassis is affected by labour troubles. It, therefore, follows that the commercial trucks lack demand. The unutilised capacity in this seems to have affected the products Automobile wheels and Automobile shock absorbers which report lack of demand.

#### Other transport equipments

43. Trailer is the only product lacking demand. This is in line with the lack of demand for heavy trucks, 3-wheelers, scooters, autocycles and cycles have shortage of raw materials, important of which are alloy steel, steel sheets, tyres and tubes, besides many components and parts to be largely imported. The products pistons, brake parts, oil seals which are required in this and automobile industry have no unutilised capacity. Leaf springs (another product required in this industry) has slight unutilised capacity, but no reason is given. Recalling that the tyres and tubes are overutilised (according to MSP) the picture that emerges is that the capacity of these equipments cannot be fully utilised untill the supply of these parts produced in India and of the parts and components to be imported is substantially increased. Thus, the items like scooters etc. face shortages and some of the parts required by these are having no unutilised capacity. It is significant that trailers lack demand.

#### Conclusions

44. A brief account of this survey may be given as an introduction to the conclusions. This survey was taken up with a view to know the reasons for unutilised capacity in important capital and intermediate goods manufacturing industries in India during the recent past. Out of 1175 companies to whom a proforma was mailed for getting particulars, though we got replies from 287 companies, only. 151 companies furnished adequate details. This study is based on these 151 companies, which cover the industries we intended to cover, to a reasonable extent. Compared to the publication 'Monthly Statistics of production', there appears to be no 'bias' in the responding companies, in the sense, that the companies which have responded to this survey are not those which had relatively more unutilised capacity. The survey covers 234 products of which there is no unutilised capacity in case of 34 products. Product-wise figures of capacity utilisation and reasons for unutilised capacity

are thrown by the survey. Indeed, this survey gives extent of capacity utilisation in case of a large number of products (about 147 products) which are not covered by the 'Monthly Statistics of production'. The survey covers a capacity of 18376 million rupees worth of which the value of capacity of the 34 products that have no unutilised capacity is 2026 million rupees. The capacity of the remaining 200 products is unutilised to the extent of 21%.

45. Shortage of raw materials and lack of demand come out to be equally important reasons affecting 30.5 and 29.4 percent, respectively, of the total value of unutilised capacity in the survey. Labour troubles are next in importance affecting another 15 per cent. The other reasons are, natural

calamities like fire, damage etc. and power shortage. The number of products affected by each of the above mentioned three important reasons also indicates the same order of their importance.

- 46. Lack of demand is the reason for unutilised capacity of products, important of which are, Textile machinery, plastic moulding machinery, Machine tools and House service meters on one hand; Railway wagons, trucks and trailers on the other hand. Further, Refractories, stoneware, cement products, and to some extent Tractors, diesel engines, Electric cables and wires are also facing lack of demand. This situation, perhaps, explains the lack of demand for Heavy structurals, cast iron spun pipes, steel castings and to some extent Rolling and foundry products. The lack of demand for coal, iron ore, electrodes, automobile parts, wire ropes and certain industrial chemicals seem to follow.
- Shortage of raw materials is faced by many products, important among which are, sulphuric acid, Fertilisers and certain other chemicals. Sulphur (to be imported) is the principal product in short supply affecting many chemical products. Heavy structurals and certain castings are partly affected and Non-ferrous alloys, Bright bars and shaftings, certain metal products are facing shortages of raw materials, important among which are Alloy steel, special steel and nonferrous metals most of which are to be imported. Aluminium conductors, power cables, steel wires face shortages, important of which are aluminium, PVC and special steel. Tractor, cement machinery, Boilers and pressure vessels oilengines, electrical goods like storage batteries, dry cells and batteries, radio and transistors are suffering due to shortage of raw materials, chiefly the shortage of crucial parts and components to be imported largely. The Scooters, 3-wheelers, motorcycles, cycles also suffer due to shortage of parts and components many of which are to be imported and for some of which (like tyres and tubes, etc.) that are produced in India, the domestic capacity seems to be inadequate.
- 48. Coming to the other reasons (including labour troubles) affecting the various products, the vital sector of our economy is involved in this. Pig iron, semi-finished steel and steel ingots suffer due to labour troubles, power shortage and damages, fire etc. The labour troubles and power shortage have affected Hoists, cranes, industrial engines, comet passenger and goods chassis, etc.

49. It is obvious that the unutilised capacity in such a vital sector as iron and steel basic metal has resulted in the lack of demand for coal, iron ore etc. on one hand and in shortages of this metal being felt by castings, metal products etc. The lack of demand for items of machinery, transport equipment (mainly commercial type) and construction listed in para 46 seems to result in the lack of demand for products demanded by these items and so on. The shortages, particularly of basic iron and steel metal and aluminium (produced in India) and that of non-ferrous metals and vital parts and components (which are largely to be imported) are at the base of the unutilised capacity of metal products, machinery items listed in para 47.
