separate Gynaecological one in case of girls). One list was sent to the respective school, one to the respective specialist having consulting rooms in the vicinity of the school and in this way the work was got done. Attempt was made to check up the follow-up work twice or thrice during the year.

Expert advice and examination regarding pathological X-ray, skin defects, etc. were available to the Association at any moment it was deemed essential. I was closely associated with the work of planning and execution of the medical examination in the capacity of the Honorary Secretary of the Association since its inception till my relinquishing the post in June 1958 — in order to be able to devote more time for this analytical work.

3. Selection of the Sample:

The details regarding the health of the pupil examined were noted on the prescribed schedule in which space was provided for seven years continuous record. So the form moved with the pupil taking on it the previous records of the medical examination from standard to standard in the school. The table No. 1.1 shows the total number of pupils medically examined in each year from 1950-51 through 1956-57.

Financial considerations necessitated the number of continuous cases of boys and girls to be limited to about 30,000. Such a type of material could be called out from 20 schools only. So all cases of girl pupils and every

alternate schedule of boys of ages 10 through 18 studying in Standard V to Standard XI were picked out for the purpose of analysis from the standardwise arranged yearly records for the four years 1953-54, 1954-55, 1955-56 and 1956-57 in each of these 20 schools. With this procedure we could cover, on the basis of treating each pupil in each year as a case, 16,828 cases of girls and 14,957 cases of boys.

Table No. 1.2 gives distribution of schools with the total number of medically examined cases of boys and of girls for the four years, by wards. This would give an idea of the representative spread on the supposition that large bulk of pupils in a school were residents of the locality round about it.

4. Peculiarity of the Data:

Data used was the result of team work of medical professionals, changing from year to year, though the same
team in a year observed the same physiological system in the
school. Part of the schedule was the actual record of the
health examination by a professional, viz. visual acuity,
pulse rate, diseases of teeth, E.N.T., Renal, Circulatory,
and respiratory, digestive, etc.; another part relating to
measurements by trained assistants viz. height, weight,
chest expiration and inspiration, etc.; and the rest from
the information supplied by the guardians viz. history of
diseases, operations, etc. and by the examinee regarding
diet, exercise, etc. Details of monthly course and menarche

were obtained from girl examinees. Riased trends were slightly observable in the schedules completed by these categories. On the whole they were not significantly prominent
in items particularly covered in this study. Detailed characteristics are noted at the appropriate place in the
study while discussing the item.

In the scrutiny of the schedules it came out that residential address and community and marital condition were not noted at all and age was given in round figures. At this late stage to fill in this type of lacunae from other school records would have been a stupendous task by itself and so was not adopted.

5. Some Definitions:

- (1) Age: Use of the word "Age" without any qualifiin years
 cation means the age at the time of medical
 examination.
- (ii) Case, Schedule, pupil etc: Separate set of data relating to medical examination of the pupil in each year.

Section - II: Report with general observations

1. Standard and Age:

This study is based on the medical examination reports of pupils studying in Standards V to XI of ages 10 through 18 during the years 1953-54, 1954-55, 1955-56 and 1956-57,

Large bulk of the examination work used to be over by October vactation in each year. Distribution of finally included cases of 14,957 boys and of 16,828 girls by standards and ages is given in Table No. 1.3. It would be easily observed that the spread of pupils by standards and by age is smooth. The highest proportion is about 19 in Standard VIII gradually coming down on either side to nearly 13 at standards V and X in the cases of boys and girls. Highest proportion of pupils at standard VIII might be due to the direct admission to this class from the primary school. Cases at standard XI were in proportion a little less than X for both boys and girls.

Generally, pupils admitted in the Vth standard were of age 10. So the average age of pupils in the VIIIth standard would be 13 or 14. Highest percentage slightly less than 15 was at age 14 for both sexes, gradually tapering down to round about 9 at age 10 and 17. It would be natural to have very low percentage of cases at age 18, because the average age of pupils in Standard XI would be 16 or 17, for both boys and girls.

It is interesting to note that sufficient number of cases were wailable for the study of pre-pubertal and puber-tal and post pubertal periods. The last might be overlapping the on-set of adolescence state. Details of secondary characteristics were not available from the collected data. This puts a sort of limitation on the exhaustiveness of the

analysis. Continuous examination reports of pupils afforded us to have growth in height and in weight by ages.

2. General Constitution (Health):

Height and weight at a specific age for both boys and girls might be taken to represent the net effect in the bodily transformations and changes due to known and unknown biological growth of some and or decay of other parts of the human body. A composite scale in the form of the standard table (see table No. 1.4) was prepared by the Four Man Committee of the Students Health Association, Poona, in 1953 under the chairmanship of Dr. M.P. Joshi. This was mainly based on the data collected during the years 1951 to 1953, after referring similar materials. In this table normal average height with its corresponding average weight for every age for boys and girls separately was underlined. Taking this as a norm every examinee was graded. Grade A. B, or C was given to those who had their weight within the limits of plus 10 lb. or more to minus 10 lb. to mean good healthy constitution, below minus 10 lb. to minus 25 lb. average normal health, and below minus 25 lb. weak or poor health, respectively. Every examinee was given his appropriate grade according to this Standard table throughout the four years period under consideration for this report.

Agewise distribution of boys and girls by health scores is given in Table No. 1.5. On an average nearly a third of boys showed good health (Grade A) and only 4.28 per cent poor health, (Grade C). Corresponding percentages

for girls were found to be 38.54 and 6.07. It is interesting to note that consideration of both grades A and B together showed the attainment of the same level i.e. 95 percent, comparatively girls were higher than boys in the case of grade A, and grade C, but vice versa regarding grade B. Highest proportion in grade A was found at the age 18 for boys and at 15 for girls. Similarly for grades B & C it was at age 11 and 16 for boys and 10 and 12 for girls. Rate of increase or decrease from age 10 onwards regarding grades A, B or C was different in boys than that in girls. Highest rate of increase between two consecutive ages in grade A and Grade B was observable at the age range 14 to 15, and 10 to 11 for boys; and at the age range 12 to 13 and 16 to 17 for girls respectively. Similarly the age ranges of highest decrease were 10-11 for grade A and 14-15 for grade B in the case of boys and 16-17 for grade A and 12-13 for grade B in the case of girls.

Maximum percentage of cases with grade A, good health, were observable at age 18 for boys and age 15 for girls. This coincided roughly with the pubertal approach age for both sexes respectively. Calculation of the pubertal age of boys was not a simple affair. But average age of meman menarche in girls was found to be 14.1. Accepting menarche age as one of the prominant manifestations of pubertal approach, it would be most important and interesting to note the concurrance of menarche age of girls with nearly maximum the same age range within which the percentage for grade A,

good health, fell. In case of boys we had no other supplementary data (i.e. about factors which might have been of use to decide the pubertal age or the pre-pubertal age). Same was the case with girls too. But data relating to menarche, one of the prominent indications of pubertal approach, age of girls being available, we might perhaps be nearer the truth by its use.

Another most important thing, which ought to have been mentioned before giving the comparative figures of findings for boys and girls, is that there is a wide variation in the development and its age in boys and girls and hence the comparison will not be a fair one. Study of this type may only be possible to a certain extent, if one studies the data in both cases under the same circumstances continuously for a long time say 5-10 years, something important may then be available for detailed analysis. Differences as regards only grades A, B & C detected in boys and girls are shown, simply because they are interesting ones.

3. <u>Vaccination and B.C.G.</u>

Information regarding vaccination and B.C.G. was collected from the guardians. It could not be correctly ascertained the exact age at which primary vaccination (P.V.), Revaccination (R.V.) or B.C.G. was not z done. Agevise data regarding these is given in Table No. 1-6.

Data revealed that the small-pox incidence was a bit higher in boys than in girls. Detailed information was lacking for knowing whether the small-pox attack was before P.V., or was after P.V. or even R.V.; and whether primary vaccination or Re-vaccination, as the case might have been, was done later on after the attack of small-pox. It was also difficult to say what percentage of small-pox incidence was during childhood and what latery on upto the age of 19.

Some cases of Re-vaccination being done twice or even thrice were on record, but the interval between primary vaccination and Re-vaccination, or between Re-vaccination and Re-vaccination was not known.

primary vaccination was done on an average in 98 percent boys and in 99 per cent girls and Re-vaccination in
75.7 percent boys and 86.3 percent girls. Re-vaccination
was not got done in 24.3 percent boys and 13.7 percent girls
on an average upto the age of 18, too long an interval.
Percentages of primary vaccination as also Re-vaccination
being got done was higher in girls than that in boys.

If information regarding exact age at which primary vaccination and Re-vaccination was done was available, it would have been possible to draw out some conclusions regarding fixing Re-vaccination age and also maximum possible safe interval between primary vaccination and Re-vaccination and between Re-vaccination and Re-vaccination. The information available now might even help to decide the Re-vaccination age and make it compulsory as done in primary vaccination and thus avoid even the rare possibility of occurence of Encephelitis Lethargica, etc. or a small-pox attack during the epidemics.

B.C.G. innoculation was introduced on mass basis in schools only recently. Cases of B.C.G. innoculation were 21.5 percent in 1953, 27 percent in 1954, 57 percent in 1955 and 65.5 percent in 1956 (taken from SHA reports). Thus the tendency went on increasing considerably every year. On an average we found that 68.17 percent boys and nearly the same percent of girls got B.C.G. done. This information was collected from guardians and lacked the details regarding the age at which B.C.G. was got done. In some cases it might have been done more than once.

The most important thing in this respect is to study the reactions of B.C.G. by following the pupils later on. As the means at our disposal were very very limited, it was not possible for the SHA to undertake this work. The work of B.C.G. innoculation was entirely entrusted to the Poona Municipal Corporation. It might be having detailed records of this work. While studying this subject in detail that information will prove to be of great value. This is however, a subject of such an urgent importance, that immediate steps regarding its further study are essential.

4. Diet i.e. Drinking Tea, Coffee, Milk or No Drinks:

Record of drinking tea, coffee or milk was collected both quantitatively and qualitatively. Those who used to take regularly daily at least a medium size cupful (say about 5 oz.) were reckoned to fall in the appropriate category of tea, coffee, milk severally or jointly.

Normally it appeared to be the usual practice of taking drinks twice in a day most probably in the morning and in the evening. Though this was a good topic of study from the point of nutritional value, the pattern of medical examination itself put a limitation on its usefulness in analysis. No attempt was made to use the quantitiative data except for giving appropriate category. Minimum level of consumption of each variety can be roughly calculated from the Tables No. I, 7 and 8.

On an average it was observed that among both boys and girls about 5 percent were in the habit of taking no drink at all, and about 27 percent taking milk regularly. Percentages of tea and coffee drinkers among boys were 60.37 and 16.81 and among girls 42.17 and 28.88. On an average percent of taking tea was greater in boys than in girls and regarding coffee reverse was the case.

4.1 Hot Drinks and General Health:

Bearing in mind the limited effect of drink statistics and its pattern on the study of nutrition as a whole, we attempted to correlate this with the general health grades. These are given in Table No. 1.9. In all the column heads except in Tea only and Milk only, prevalence of taking one alone or two conjointly of nearly the same proportion as the average for it was seen in both boys and girls. In the case of coffee only there were 12.25 percent boys and double this i.e. 26.51 percent girls. In rest of the items the level was low.

The following table is an abstract from the abovementioned one giving the distribution by health class with tea only and milk only.

Applying Chi-test, it would be observed that the value of $\frac{2}{x}$ (i.e. 150.30) was nearly 11 times the value of $\frac{2}{x}$ for a probability of 0.001 in the case of boys and was 2 times (i.e. 17.59) that for a probability of 0.01 in the case of girls and in both boys and girls the contribution by the milk cells was nearly two-thirds of the respective values of the calculated $\frac{2}{x}$. This conformed to the common concept of the relation of milk with good health.

5. History of Diseases during Childhood:

Details regarding diseases during childhood were communicated to us by the guardians. In many of the reply slips mention of the date, month or even year or even the age of pupil, at the time the occurance of the diseases was not made and hence it was not possible to calculate the agewise incidence of particular diseases. It was the general

observation that in the majority of pupils the occurence of the diseases was before the age 10. What we could achieve was to have a cumulative number of pupils having been affected with the specific disorder sometime in the past. This is given in Tables No. I, 102 & 11.

Average number of diseases per pupil came to 1.78 for boys and 2.02 for girls. Total count of diseases was 26,604 for boys and 33,997 for girls. Normal or no disease percentage for boys was 25.15 and for girls 15.01.

Virus diseases so also diseases in general had a higher proportion (53.92 percent and 85 percent) in girls than the corresponding ones (43.28 per cent and 75 percent) in boys. Whether this was due to low vitality or low immunity in girls, was difficult to assess. Bacterial diseases stood at about 12 per cent for both. Only mumps and small-pox percentages were higher in boys than those in girls. All this, being very important, needs further detailed study separately.

6. <u>Diseases of Digestive, Renal, Respiratory and Nervous</u> Systems:

(1) Digestive diseases were observed on an average of the age-wise percentages to be more or less the same i.e.

2.63 for both boys and girls. On the basis of total records the highest percentage was noted at age 11 and lowest at age 18 for both boys and girls. Percentages in general were wery small and in this also the majority of the cases were

of chronic constipation, a few of abdominal pain, and only a few of intestinal worms history, etc. Although in the last two cases the number noted was small, further study and care should not be neglected. (See Table No. 1.12).

- (2) Renal diseases were observed only in small number of both boys (8 i.e. 0.05 percent) and girls (37 i.e. 0.21 percent). So it was a bit more in girls than that in boys. Urine examination was not done and hence no information in this respect was available. Though the incidence itself was low, the majority of the cases were of puffiness on face, aedema of feet, and of highly anaemic condition and a few with history of burning micturition, etc. This meant all these cases came to the notice at a late stage, a point for serious consideration.
- (3) Respiratory trouble was detected in 0.59 percent boys (74 in number) and in 0.56 percent girls (95). Inci-dence was nearly the same. These were in majority the cases of chronic cough, (reflex in some cases) chronic asthmatis, chronic pulmonary T.B. (thickened plura in some), etc.

It might be thus seen that each and every case of this type would need further consideration as the pupils concerned were not only injurious to themselves but also to others in the class.

(4) Diseases of the nervous system were detected by overt means only, 3 of boys (i.e. 0.02 percent) and 7 of girls (i.e. 0.04 percent). Mental testing was not under-

taken. Once we gave a trial of administering mental tests, but it took a lot of time and so could not be adjusted with the general medical examination team-work for budgetory considerations. This might have been the reason for the small number. In this group most of the cases were of chronic headache, polic, gross mental deficiency, etc.

It appeared to be quite essential that every pupil should be mentally examined soon after admission to the Secondary School and thereafter only suspected cases should be followed up.

7. Heart - diseases and defects:

Heart affections were detected on an average in 1.91

per d slightly more, i.e. 2.19 percent in girls.

Highest ge of 3.09 was observed for boys at age 18,

and 2.79 for als at age 15. (Table No. 1.13). Curiously

these are the ages of maximum growth. Unfortunately many

of these cases were labelled under the common terminology

of heart disease and further detailed analysis was not

possible. In some of the records mention was made of the

definite form: congenital, rhimatic, mitral stenosis,

mitral regurgitation and haemic murmers, tachycardia, etc.

In almost all these cases, it was noted, Physical Training

exemption was recommended.

Though the total number itself appeared to be small, it should not be treated as insignificant. Further treatmental analysis, say E.C.G., etc. would be quite essential in such cases.

8. Pulse Rate:

pulse rate itself is a fickle factor depending largely on the psycological condition at the moment due to the environmental effect on the examinee. At the time of the actual examination count for half a minute was measured by one and the same doctor and twice this was recorded in the schedule to mean pulse rate per minute. Nervous factor was there; but that was a common factor for all. Making proper allowance for these factors while noting (Table No. 1.14), some common trends were noted.

On an average as well as at each age the numerical value of pulse rate was observed to be higher in girls than that in boys. In general in girls on an average pulse rate in majority of cases and for all the ages was between 90 and 99 p.m. while for the boys it was between 80 and 90 per minute. Another feature of note was that the pulse rate at the lower age slowed down with higher age till from age 14 onwards pulse rate was in the range 85 to 95 per minute in both boys and girls.

The available data could not be significantly used to finding out whether pulse rate bore any relation to an, if so, its nature during monthly course as well as to the menarcheal age in girls.

9. Diseases of the Genitory System in Boys:

On an average normalcy was found in 92.63 percent, the lowest being 86.52 percent at the age 10, gradually improving to the level of 96 percent at age 15 and onwards. All diseases of genitory system combined were 7.37 percent comprising Hernia 0.40 percent, Hydrocele 0.14 percent, Phimosis 5.04 percent, undescended testicles 1.72 percent, and the rest 0.28 percent. (Table No. 1.15).

In the order of frequencies the most predminent was phimosis followed by undescended testicles. Age-wise occurance of hernia, hydrocele and the rest of the diseases was meagre.

Percentage of undescended testicles at age 10 was \$\pm\$. 5.48 and at age 18 only 0.42. As in majority of cases the descent took place at the age 12, it might be said that this was simply delayed till the 18th year in the remaining cases. The only care in these cases wild be that they should be kept under observation of a surgeon and checked up every six months or so.

Phimosis figured in 5.04 percent. The percentages at age 10 and 11 were 6.89 and 7.35 respectively. Generally the necessary development is emplete at age between 8 and 10 roughly. So the defective cases would be detected easily after the age 11. Maximum percentage occurred at age 12 and the minimum at 18. The lowest at the age 18 might have been partially due to surgical steps taken in several cases

or due to complete development of the respective muscles. It was difficult to assess which factor predominated in the reduction.

It would be difficult to attribute any particular cause to any particula occurrence of the disease.

Diseases of genitory system in girls are treated in the next Section.

10. Defective Vision and Eye Diseases:

Acuity of vision and diseases like unilateral blindness, squint, etc. and in particular trachoma were the outcome at the time of medical examination, by administering the test of reading the standard chart from the appropriate distance. It was observed that the nervous effects were there to some extent similar to those occurring at the time of noting pulse rate, and that a few examinees committed to memory the normal grade line writing on the standard chart. On the whole the record might be taken to be representative of the situation. (See Table No. 1.16).

Squint: Detected cases were 46 among girls and 26 among boys. The majority of these belonged to the caver-gent group and had amblyopia in the squinting eye. This would have been avoided to a great extent, if chek check up would have been done in pre-primary or Montesory schools. From the experience in this respect it might be mentioned that the patients should be made more squint conscious and properly guided as regards treatment of amblyopia and early correction of refractive errors.

Unilaternal Blindness: Encountered cases of unilateral blindness were only of 8 boys and 3 girls.

visual Acuity: Incidence of low visual acuity (6/24 to 6/36, and 6/60) increased generally, with a little variation in between, from 4.6 per cent at age 10 to 9.4 percent at 18 among girls. This showed growing myopic tendency with advance in age. Percentage in this respect for boys varied from 3.7 to 5.09, the highest being at ages 11 and 17. So as regards low visual acuity incidence was found to be higher in girls than that in boys. Such a group of students would need check up work and correct glasses prescription.

Trachoma: Trachoma incidence varied from 9.2 percent to 4.5 percent in girls and from 3.9 percent to 1.9 percent in boys (i.e. only about 1/3rd of that found in girls). Generally this percentage dropped gradually from age 10 to age 18 in both boys and girls equally. The lower incidence in the older age group might be attributed to treatment carried out in between.

The cases of trachoma belonged mainly to the first two stages, the majority being in the first stage group. Pannus has nearly always been restricter to the limbal crescent.

Very few students had any complaints whatsoever and most had no knowledge of this disease in their eyes until it was brought to their notice at the time of the examination.

The extraordinary quiet nature of trachoma in most of the cases might have been, amongst other things, due to dust-free and equable climate of Foona, besides greater maintenance of hygeinie care by the school going population, preventing complications of secondary infection.

The highest incidence in the earlier younger age would possibly suggest the occurrence of infection in the preschool period.

- 11. Affections of E.N.T. (Ear. Nose and Throat) and Teeth: (See Table No. 1.17)
- (1) Ear diseases: These were found on the average in 0.85 percent boys and 0.69 percent girls. These consisted of imparted wax in the ear, ear discharge, ear-ache, and so on. There were hardly one or two cases which required extra care regarding Mastoiditis, etc. Highest percentages were observed at age 10, 14 and 18 in boys and at age 11 and 12 in girls. Occurrence of effection could not be related to casual factors.
- (2) Nose diseases: Percentage of affected cases itself was small, 1.18 percent in boys and nearly a third of this, i.e. 0.41 percent in girls. Most of the cases were of nose bleeding, getting cold, masal discharge off and on, congested or di deviated septum, etc. There were hardly 5 or 6 cases of masal polypi. Highest percentage was at age 14 and 15 for boys and at age 17 and 18 for girls.
- (5) Throat diseases: Among the E.N.T. group the incidence 0.23 p.c. of throat diseases was too small, £x2\$/in boys and 0.08 p.c. in girls. Majority were with congested condition of the throat due either to enlarged or septic tonsils, ear trouble, long uvula and so on. The number of affected girls was

nearly a third of that of boys. Highest percentage was found to be at age 18 in boys and at age 15 in girls.

- (4) E.N.T.Group: Considering E.N.T. group together one would find 2.26 percent boys and 1.18 percent girls affected. Fractically these were common eases met with in daily practice of the general medical practitioner and could be avoided or at least minimised if regular check up would have been possible.
- (5) Teeth Carles: This is one of the most confronting problems not only with the school going children but also with adults. It may be that the decey started in early age may have been earlied to later ages.

Mearly a fifth of school going children were found with teeth earles. (20.86 percent boys and 18.40 percent girls). The maximum incidence of 41.45 percent in boys at age 10 come down to 14 percent at age 14 and more or less maintained this level till the age 19. The highest amongst girls was 29 percent at age 10 and came down to 14.83 at age 14 and nearly stayed at this level upto age 18. It would be easily noted that the incidence was higher in boys than that in girls during the first four years and the difference meanly disappeared afterwards. So nearly 14 percent with carried teeth were found at the age 14 onwards.

The classes in which diseases of teeth were noted were two - caries and dirty.

The overwhelming predominence of decay in milk teeth would be a result of a long drawn process, since the early childhood; unhygeinic methods of complete neglect of teeth cleaning, accompanied by the vitamin defficiencies and some hereditary effects. From the type of available information it was found rather difficult to guess other details.

A contributery factor to teeth decay is the habit of eating sweet-meats and taking sweet drinks. Though information regarding drinking tea, coffee, etc., was available quantitatively, and the general observations of the high prevalence of eating chocolates and consuming sweet-meants, these could not be used properly in their relative connection with teeth decay. Other well-reorganised contributery factors are calcium and vitamins deficiency, and hereditary factors. The part played by these and their extent could not be observed though we came across pupils from the same families having caries and pupils from different sets of families having no caries at all.

In short this is again most important subject dependent on diet and several other factors and needing detailed study and investigations separately.

11.5.1 Defective Teeth and Health Grades:

Prevalence of Teeth saries was round abut 20 percent in all the health grades for boys and girls except in health grade A of girls it was found to be 16 percent. (See Table No. 1.18).

12. Tonsils:

At the time of examination record was sealed to three stages of tensil enlargement. The first stage was denoted by (a) and this was to mean slight enlargement, which was in most of the cases negligible; by (b) more enlarged and were recommended for removal if found causing obstructive symptoms or septic; and by (c) enlargement of the extent requiring removal altogether. Information in this behalf is given in Table No. 1.19.

In general the normal condition of tonsil enlargement was found in 71.77 percent boys and 76.55 percent in girls. Tendency of removal of tonsils was more marked in girls, 12.52 percent than in boys, 9.11 percent but this was just the eppesite with regard to the enlargement of tonsils in all the three grades together, 19.09 percent in boys and 11.11 percent in girls. The number in tonsil enlargement stages (a) and (b) each was round about 8 percent in boys and 4.75 percent in girls. The stage (c) indicating the earliest removal of tonsils was present in 3.21 percent in boys and meerly a half of this, 1.49 percent in girls. That the guardians paid early attention more specifically in girls to the tonsil affectation at all stages of enlargement including to noil removal would be apparent from the table wherein from age 14 enwards normal state gradually increased along with the corresponding lower incidence. This was but natural in consideration of the approach of marriage-Rgo.

Whether the decrease in the percentages of tonsils enlargement with advancing age was due to removal of tonsils or removal of the underlying cause, viz. any outside sepatic focus, say general throat affection or ear, nose or teeth trouble, was difficult to say. Anyhow the fact that pupils showed, though gradually better results with advancing age was a matter of some satisfaction.

12.1 Health grades and Tonsil-Condition:

Tensil condition was mearly the same, in health grades A and B, in girls as well as in boys. Prevalence of high percentage, Septie and excessive enlargement of tonsils, was found rather in a high percentages in Grade C, (See Table No. 1.20).

13. Miscellaneous:

Skin Diseases: Some cases of severe and many others of minor skin trouble were noted but as a group the proportion was too small for worthwhile deductions.

Lice infection: Lice infection was found to be present in nearly 90 percent both in boys and in girls studying in a purely refugee High School. Prevalence of this elsewhere was negligible.

Leprosy: During the course of 7 years, only four cases of leprosy were met with. These were got treated by experts.

III - MENARCHE

1. Introductory:

There are varied opinions about what Menerche actually means. A few views noted below are self-explanatory.

- (a) Onset of first monthly course is taken as the point, when puberty is more or less established. This does not imply that puberty by any means is complete. The word 'MENARCHE' is frequently used to denote this initial menstruation and is not strictly speaking synonimous with puberty. (See Baird: Obste. & Gyneeic., 5th Edition 1950, p. 60).
- (b) Menarche, a Greek word meaning month beginning, refers
 to the first period of physiological uterine bleeding.
 Puberty has been used by some as synonimous with
 Menarche and by others as the time, when reproduction
 becomes possible. (See Hamblen, 3rd Edition 1945,
 pp. 114, 125 to 128).
- (e) Cecurence of first monthly course has long been considered the climax or the end point of the pubertal period and that once the menses have their appearance the individual has reached full maturity. It is however now believed that this concept is incorrect and that the Menarche is merely a single event in a process, which terminates some years later. (See Davis: Obste. Gynesic., 1943 edition, Vol. I p. 1-4; Vol. II p. 17; & Vol. III p.5).

Without going into details regarding the controversy about what Menarche really means, whether it means puberty is incomplete or it is an end point or an event in the process, and whose opinion should be valued. I have taken here the simple meaning of Menarche as only the onset of first monthly course for the purpose of this report.

2. Menarche Age:

Average age at Menarche was found to be 14.120 with s.d. ±1.089 (See Table No. 1.21). It would be appropriate in this context to reiterate the relevant part from a paper entitled "What is Menarche?" This was read by the writer at the Second Poona Medical Congress in June 1957 and was based on the information for the same four years as covered by this report of study from the secondary schools. The paper presented the variations in Menarche age in relation to (i) easte and community, (ii) locality, and (iii) economic status of the guardians.

- (i) Menarche age by communities: Christians 14.0 (133);
 Parsis 13.75 (160); Sindhis 14.34 (67); Gujaratis 14.40
 (98); Madrasis 14.28 (89); Muslims 14.12 (129) Marathas
 14.17 (71); and the rest 14.56 (2330).
- (ii) Menarche age by locality: (1) Deccan Gymkhana Area 14.18 (359); (2) City area more or less congested area) 14.70 (2484); and Camp area 13.96 (548).
- (111) Menarche age by economic status: (1) Poer class 14.71 and (2) Rich class 14.89 (944).

Note:- Enclosed in bracket is the number on which the average was based.

From this it might be said that the average menarchal age was in the range from age 14 to age 15, with relatively no effect due to caste, locality, or economic status.

In the present report the engal factors of Menarche delay, i.e. ill heelth, malnutrition, anaemia, tuberculosis, severe long illness, malnutrition of genetalia or imperforate hymen, could not be studied. But it was observed in the follow-up work that adequate diet with vitemins and iron for improving general health induced menarche in delayed cases. Unfortunately this impression could not be factually presented.

Vague or very little information is available on the menerchal age in tropical scantries. Although none of the figures quoted for Indian women are based on the large data series of eases, the average age of menarche is as: 15.63 (Dr. Curjel from Calcutta); 13.65 (Dr. Purandare from Bombay) and 13.79 (Dr. Parvatidevi from Madras). In the absence of data available on the large series, the age of 14 is taken as an average age of menarche for Indian women. (See Obste. & Gynaeico. Journal of India, December 1955, p. 168).

In the context of the gens rel statement: "Age at Menarche 14.5 varies with different countries and nationalities staying in the same country", Dr. Dugald Baird makes

a mention that (i) Jewish girls menstruate earlier than others, Indian girls earlier than European girls staying in India, and (ii) Due to the wide normal variation menarche should not be considered as unduly delayed until a girl is 17 or 18 years old. (See D. Baird: Obste. & Gynseic. 5th edition, 1950, p. 60).

Hamblen refers to the very interesting Tilt's (British Gynaeicologist) statistical report: age at menarche in hot elimate is 13, temperate zones 14.3, cold countries 15.8, Europe (temperate zone) 15.5, Norway and Denmark 16, Spain 18.2, North America (i.e. temperate zone) 13.9, and in Tropics 14.8; and goes on the observe that this shows that factors other than climate alone operate. (See Hamblen: Endocrynology. pp. 125-127).

While observing the average menarchal age to be from 12 to 14, Dr. Moorwhite notes that in some Lendon families monthly course started at the age of 17 or 18 or even later, girls being normal in all other respects. (See Margaret Moorwhite: Daignosis and Treatment of Gynasic Disorders. 2nd Edition. 1946).

Average menarchal age was observed to be 14 for white Women of U.S.A. and Canada in the investigation of 20,000 cases by Englemann (referred in Eden & Lockyer: Gynaeic. 1928 Edition. pp 78-79).

5. Pecularity of phenomenon:

The following two remarks are noted down as they contain reference to many important influences affecting and the side effects of the memarchal age.

- (1) Present generation daughters get menarche earlier than that of their mothers. Menarche at early age is found in early sexual life or residing in large cities as compared with rural districts. Poor girls late while rich ones early. Heredity is one of the important things. Goulds found menarche earlier by 3 months in daughters than in their mothers, only 18% menarche eacurs in Summer. Menarche in July is twice that of any two months in the year. (See Mills in Human Biology, 1937, Vol. 9.43).
- (ii) Somatic and sexual developments are closely related to each other (BOAS) i.e. body growth attains maximum rate as menarche approaches. This period is called the age of maximum rate of growth. First monthly course is generally found one year earlier. For this reason, girls at menarche age are taller than average individuals of the same age. Earlier the menarche more rapid is this completion of growth process. Thus women, who have menarche very early tend towards a short stature. (See Davis, \$0\$, eit. Vel. I p.2).

In our survey we found that height and weight in girls are more for the menarchal age than those at the same age on the average. This is 4 described in detail in Part II.

4. Interval between Monthly Courses (M.C.) in days:

Interval days were meant to be the duration from the first day of the monthly course to the first day of the next following monthly course. This information was supplied by the examinee.. For the sake of convenience of notation and not for any specific reason the interval days were put in five groups: (1) 20 days and below, (11) 21 to 24 days. (111) 25 to 27 days, (1v) 23 & 29 days, and (v) 50 days or more.

Out of 10, 964 schedules specifying menarche, the required information was furnished on 6,277 only. Break-up of this frequency is given in three different ways in order to see whether early or late menarche has any peculiar effect or effects on the duration. (See Table Nos. 1.22 to 24.)

On the whole 95.42 percent were in group V, meaning 30 or more days, only 3.21 percent in group IV, nearly one percent in groups I & II together meaning 24 or less days. The end group V had large concentration round about 51-52 and rarely a few exceeded 36. So nearly 98 percent were found to lie in the range of interval days 23 to 32. In the absence of similar data, it was thought advisable to leave to experts the question of deciding whether this range of interval days 28 to 32 would itself be a normal one or above normal. Even though the cases belonging to the first three groups was found to be small, they should be studied deeply and it should be seen, in the absence of any other complications, whether this would form a normal pattern for those individual cases.

Classification of memarche age a cases according to groups of monthly course interval days was done (See Table Me. 1.5.4). General pattern as described above was to be seen in this also. For such an analysis our data fell too short, as we had taken only four years consecutive data in general. Bearing this in mind it might be observed from the table that persistance in continuing in same interval days-group from one year to next, as the one at the time of memarche, did not depend on the memarche age. In other words it formed a normal pattern for those individual cases.

Whether the variations in the monthly course interval days has any relation, and if so to what extent, with general health constitution, which in turn is the outcome of effects due to diet, climate, city life and several other factors including heredity, needs further investigation.

This remark is equally applicable to the related topic of monthly course length (flow of discharge) days and quantitative measure.

5. Duration of Monthly Course:

Monthly course may start any time during day or night, count is made in days according to established convention. It was difficult to get this information in hours. Available information was in conventional day, which might contain some instances wherein less than a day had been reckened as one whole day.

For the sake of convenience duration days were divided into 8 groups, the first 7 being the same as the serial number of days of duration and the last 8th group taking in all the cases of duration of days 8 and more. Information relating to duration in mere days would have been more enlightening if measurements of quantity of discharge during the monthly course would have been available. But this was not possible at the time of medical examination. A little less than a half were in the group four i.e. monthly course duration of 4 days only, and from one-fourth to one-fifth in duration period of 5 days in the average as well as at each age. This pattern was observed in the case of groups 5 and 6 with the strength round about one-tenth of the total. On the assumption that there would be no other complicating factors, groups three to six together might be treated as normal in consideration of possible individual variations. Cases belonging to the rest of the groups would need thorough investigation. The last group, i.e. 8 or more days had almost all eases with 8 days duration except a few with 9 or 10 days and about 5 with as long as 14 days duration. (See table No. 1.25).

The most important phenomenon in respect of Monthly Course interval and duration days is that of 'Regularisa-tion'. Majority of girls take some time to get monthly course regularly established and this is of normal occurence. Some girls take a year or so while a few even more than a year. Disturbing factors of 'Regularisation' in this growing period, include psychological factors

i.e. upsetment, examination pressure, etc., and marriage.
results
Study of isolated factors will not give definite requisite
and hence it is necessary to study this as one whole problem in which all the depending factors have been included.

6. Gynaeicological Diseases:

Most common of the gynacicological diseases found for the ages 10 to 18 of girls under consideration were in the descending order of frequencies; Dysmenorrhoea (69.68 p.c.), Menorrhegia (15.02 percent), Combined Menorrhegia and Dysmenorrhoea (4.66 p.c.), Amenorrhoea (5.36 p.c.) and all other diseases combined (7.25 p.c.) of the total affected cases. Actual number of the diseased was only 386 i.e.

3.52 percent of the total number examined (10, 964 with menarche). See Table Nos. 1.26 & 27).

Roughly it might be said that total disease incidence gradually fell down from menarche age 11 enwards. These diseases are mainly due to uterine muscular development, psychological conditioning, or disturbed endocrinel imbalance. Girls generally require some time to establish Monthly Course regularity and hence it is also quite possible to have predominance of such diseases.

Dysmenorrhoea: In the agewise break-up its presence
was seen mearly 24 percent at ages 15, 16 and 17; and
about 11 percent at ages 14 and 18. Majority of these
it was noted
cases were of spasmoidic type and that with antispasmoidie
line of treatment they got better. This type generally
disappears after child birth. Many cases of menorrhegia

and some of dysmenorrhoea showed considerable improvement by iron and calcium treatment. In the course of the examination it was also observed that generally either weak or too strong girls, who started monthly course at an early or late age were prone to suffer 4 from Dysmenorrhoea. It may be that as uterine inertia or muscle rigidity is found in some cases of late primipara, the same principle may be applicable to Dysmenorrhoea in girls who start monthly course either at an early or a late age.

We get a pretty big number of eases of phimosis in boys and of dysmemorrhoes in girls. It would be worth while to study whether there is any common underlying causative factor.

7. Height and Weight:

Effects of menarche age on height and weight are studied in detail in Part II, though some point are touched upon in the next section. (Section III: Height and Weight - serialized para 2 of same name).

IV - HEIGHT & WEIGHT & CHEST GIRTH:

1. Introduction:

Trained teachers or clerks recorded the height, weight and chest measurements. This work was however checked up every now and then by the head examiner. The head examiner noted how pupils stood on the weighing machine, or underneath the height stand, and also if there was any case of

deformity, say, hunch back, etc. Weighing machines used were with original German or English springs and got checked up and corrected off and on. It was not possible to use costly and heavy machines.

2. Chest Expiration and Chest Inspiration:

Now a word regarding the measurement of Chest. We used to take chest measurements at the mipple line and having once adopted a set procedure, it became incumbent on us to continue with the same in order to maintain uniformity and comparability of the data. Many of the pupils, even after proper instructions, would not know when to expand chest and when not to, with proper posture of standing straight with shoulders thrown back. So chest measurements could not be considered to be of high accuracy and more so in the case of girls predomineatly due to the existence of movable fat. There were more accurate methods, such as syrtometer, etc., but these could not be made available in the general medical examination on a mass scale. Some do adopt the procedure of taking chest measurements at the level of the highest point of the axillary fold and this will be a bit more accurate than the one of taking these at nipple line.

For obvious reasons noted above no attempt could be made to relate chest measurements with height. Average chest expiration at each age for boys and girls are given in Table No. 1.28 and the difference between chest inspiration and chest expiration, in Table No. 1.33. Average chest expiration was 23.01 inches at age 10 and steadily went up to 29.24° at age 18 in boys. Similarly it was 22.72° at age 18 in girls. Items

It may be simply mentioned that absolute increase between the averages at consecutive ages assumed a peak-and-trough trend, throughout in both sexes.

In general the average difference between chest expiration and chest inspiration was more inclined forwards the value of 2", in boys and nearer to 1.5" in girls. Closer observation of the table would distinctly show that the average difference at an age, steadily but markedly increased with age in boys, whereas he the same tendency was noticeable in a narrow range in the case of girls.

5. Height and Weight (Absolute and annual increase or decrease):

From the view point of methodology it is considered helpful to present here the ordinary analysis in detail, as this
would compare itself with the results of the full statistical
analysis, a highly technical and specialized job, presented
as Part II of this Report. Some duplication there would be,
but it would be unavoidable.

Delpherately no attempt was made to calculate the averages of height and weight for all ages for reasons explained earlier in this part. Suffice it to say that the occurence of spurt in growth of the human body at a particular age, though varying from individual to individual in each sex, between the ages 10 and 18, would take away the utility of the average at any specific age. So it would not be meaningful for the whole group, for all these ages together.

The total net increase in height between the ages 10 and 18 was nearly 11"in boys and nearly 8-1/2" in girls, and corresponding total net increase in weight was 46 Lbs. and 35 Lbs. respectively. (See Table No. 1.28 & 29). Maximum increase in height between two consecutive years was 2 inches in both boys and girls. But maximum increase in weight between consecutive years was 10 lb. in boys and 7 lb. in girls. Average height at the age 18 was 63.11" in boys and nearly 60" in girls (See Table Nos. 1.31 and 1.32).

Attention is simply drawn here to Table No. 1.30 wherein average height, average weight and average chest expiration in girls for each menarchal age, cases subdivided by the agewise data for the ages 10 through 18 eovering premenarchal, menarchal and post-menarchal periods. Fuller discussion would be found in Part II of the Reports.

4. Bhusrath's Nutrition Index:

Mearly 26 years back Dr. Bhusrath devised an emperieal formula in the course of medical examination of
children of the ages 6 to 10 in the primary schools of
Bombay Municipal Corporation. This was known as the
Bhusrath's Nutrition Index and calculated in the case of
an individual by taking ten times the ratio of weight in
1b. to height in inches. In a normal case this is to be
9 at age 6 rising to 14 at age 14. Results arrived at by

the application of this formula to the averages at ages 10 to 18 are given in Table No. 1.34. Its utility as a normalcy measure upto the age 14 has remained uncontradicted but it becomes rather difficult to say anything regarding its validity in the extended period to the age 18. According to this Index our boys and girls were found to be a little at the lower level and a slight difference was observable amongst both boys and girls.

5. Physical Training in High Schools:

While arranging P.T. time-table for different standards in a school recourse to the prescribed table, prepared by the State Inspector for Physical Education, Bombay State, as a guide had to be made for P.T. group formations. Though individual attention could not be possible while giving mass training, initiation at improving health standard amongst school going children might be said to have been made by attempting standardisation of P.T. reference table was prepared by taking into consideration age, height and weight. (See Table No. 1.35). The composite score was used to grading and then alletting a class to standard (See Table No. 1.36). On this basis the average performance came all as c, Junior class, with the average composite score 21.56 for boys and 19.33 for girls. Upto the age 14 both boys and girls were found to have the same class with mearly the same composite score. At age 16 though both were in the same class the boys showed a lead of 3 in their score over girls. A lead in score with the next higher class was to be found in the rest of ages in favour of boys.

Average period in minutes devoted for physical training on a working day for both boys and girls are given in Table No. 1.57. Thus at age 10 and 18 boys had to do daily P.T. for 52.5 minutes and 16.25 minutes respectively; and the girls for 23.5 minutes and 16.75 minutes respectively.

No consideration regarding whether pupils required more exercise at particular age or less, whether girls should have different exercises than those for boys, whether it would be necessary to select appropriate games with the idea of helping the increase in height of pupils, etc. seemed to have been given to these along with many other problems needing immediate attention while arranging P.T. for boys and girls. The physical training in schools was ranged by three agencies: Schools, recognised Samitis and Vyayam Shalas and Home. Appropriate time and suitable type of exercise would alone bring in real and lesting healthy improvement in the existing conditions.

6. Miscellaneous:

A trial of giving milk to pupils in 5-6 schools was given for nearly three years and it was found that on an average pupils decidedly showed an increase in weight, but a the added gain was upset by an equivalent loss during both the long vacations of May and Dipaveli, most likely due to the non-availability of milk. Factual material relating to this is not presented here. The point is

mentioned here because occurrence of discontinuity in the regular in-take of milk needs careful watching when free feeding is instituted so that lasting beneficial effects would be forthcoming.

V - GENERAL REMARKS:

1. Preliminary Remarks:

The situation regarding the care of health of school going children on the eve of the establishment of the Students Health Association in 1949 can rightly be depicted by use of the word "SCANT", i.e. almost > neglegible, attention was paid to the health of growing children, the wealth of our country, by the State, by the school authorities or even by the guardians. Even during the past ten years of our experience we observed that majority of the schools could do nothing beyond arranging an annual medical examinations, a few sent the health reports to the respective guardians, and here ended the whole show. In some schools doctors as well as school-principals were very enthusiastic, but attempts to improve the defectives failed due to the non-cooperative attitude of the guardians. It is not the intention to accuse guardians of the deliberate negligence. Genuine causes like poverty, ignorance, circumstantial difficulties, etc. might have been present. Result of all these is that many defects or diseases as defective vision, teeth caries, etc. remained untreated

or even undetected and prove detrimental to the child in its future life. In this regard the methods adopted in other countries are worth noting. In England and other countries there is a law and if the guardians do not follow the instructions given by the school-doctors, they are fined to the extent of Rs. 75 or so.

In the Second Five Year Plan school health service did not receive proper emphasis directly. But indirect hope-ful signs may be perceived from the appointments of chief inspectors of Physical Education in the States and from the alletment of functional activities in the State on behalf of the Central National Discipline and the everall general support to spots. In order to get and achieve concerted benefitial results, all these activities need a well-thought-out coordinated plan which will have its rightful place in the Third Wive Year Plan.

2. Plan for annual Medical Examination:

From the experience of nearly past ten years a "One Rupee Scheme" was submitted to the Central Government Educational Department through the Bombay State in August 1957. In it, it was shown how it would be able to manage the whole work of medical examination and t its ancillary follow-up work satisfactorily at a cost of one Rupee per pupil per year, excluding the cost of actual treatment and how it would be possible to accumulate valuable data side by side for further analysis.

3. Nature of Coordinated Plan of Health Examination:

The End view of a perfect plan is to be that every individual will have a thorough medical examination accompanied by suitably administering of psycho-analytical tests soon after the admission to the secondary school, another at the age of 14 and the last when the individual will be in the II th Standard. These are to be interspersed by regular check-up type of annual medical examinations. All the observations being recorded on a suitably designed card which is to move with the individual from one standard to the next in the same school or with the school leaving certificate when desiring transfer to another school. The difficulties in the way of achieving such a desired end end are varied and numerous. Participaents in shouldering the responsibility will of course be the Government, the School Authorities, and the guardians. Cooperation from medical associations and from public workers will largely help to lighten the financial burden in addition to quickening the space of reaching the target.

The part to be played by the State-Government will be of the nature of suitably revising the existing Grant-in-Code of schools in addition to properly enforcing the already existing provisions relating to school medical end-physic examination and physical training. At present the Educational Inspector, in addition to his work of educational inspection, looks after this in so-to-say a salutary manner. Really beneficient arrangement will

be to bring in a proper professional from the Health
Department to scrutinise the work, such that Inspector of
Physical Education will work as a lisison officer.

Schools will have a School Doctor encumbered with the responsibility of ennual medical examination, properly filling and maintaining the individual health record cards, apportioning and vigilance over the follow-up work of detected defectives, and over physical training and sports work.

Guardians will have to be dissuaded from neglecting necessary follow-up instructions of the School Doctor and from refusing or neglecting the furnishing of the disease history of the pupil, even with the aid of suitable legislative enactment. Such a legal measure will have to include some ameliorative measures to lighten the financial burden of the guardians due to the costly follow-up treatments.

What type of part a private social association can play is very well exemplified by the Work of the Students Health Association, Poons, since 1949. Appropriate financial support at proper stages of work and some legislative piece of ensetment with proper ender enforcing machinery will help to achieve better results most economically and speedily.

SECTION I:

Historical Resume* and Introduction:

 Special importance of this age period - years of ages 10 to 18.

The rate of growth of the body, measured by weight and stature (i.e. height) increases very rapidly until the fifth month of the factal life. From this time on t the rate of growth degreases, first rapidly, then more slewly, until about four years before the age of suberty i.e. about the age between 9 and 11. During ADOLESCENCE the rate of growth is considerably accelerated, and decreases again rapidly after sexual maturity has been reached. Thus a curve of growth represents a line which pessesses a very high maximum at about the fifth menth of factal life. It decreases rapidly and has a second although much lower maximum shortly before sexual maturity is reached, and long afterwards reaches the zero point. The increase in bulk of the body i.e. weight continues much lenger than that of length. In the beginning the rates of growth of the two sexes are about equal, that of male probably exceeding slightly that of the female. Since however sexual maturity begins to develes earlier in the female than in the male, the concemnitant acceleration also sets in at an earlier time. with

the result that for a few years girls have a large bulk of body than boys. Not all individuals pass through these stages of development with equal rapidity.

Striking physical and emetional changes announce the enset of puberty. The straight, compact, childish body of the individual lengthens and becomes heavier, the shoulders and the chest of the bey broadens, the girls figure become rounded. Primary and secondary characteristics develop. The features lose their childish chubbiness and begin to take on contours of an adults. The changing body is accompanied by a quickening of the entire tempo of life, an intensification of feeling responses even to sensory stimulii, and the appearance of strange and disturbing erotic sensations.

Importance of this period was recognised since early times. This period is more transitary and less definite than the long period of childhood of relative dependency and the still lenger period of adulthood of self-sufficiency. The beginning of adolescence is fairly well recognised but the end is left vague. Many societies signative the beginning of adolescence by elaborate puberty ceremonies as performances of traditional ritual acts. In Western countries this group started receiving investigational status during the latter half of the nineteenth century in the course of the study of human biological functioning, the health of civil and military students, and inmates of poor asylums, and delinquents in society.

2. Limitations and findings of published reports of investigations.

Fifty years ago the results of the investigations, including these of large numbers of different boys and girls at various ages, were presented in the form of averages without any indication as to the variations and an illusionary impression of regularity of growth was conveyed by the graphs which pertrayed the findings of such measurements for different groups. When, for example, graphs were constructed which showed the average heights of groups of boys and girls at different ages from one year to twenty, there was a temptation to forget that an average represents merely the central tendency of a set of findings and that there are necessarily many normal girls and boys whose actual dimensions differ very considerably from those of the average of their group. Observation of the groups showed marked acceleration at certain ages and statements were made which implied an expectation of the uniform appearance of increased growth at these periods - about the age 10-1/2 for girls and 12-1/2 for There was a tendency to lable as abnormal the deveboys. lepment of those boys and girls in whom it failed to appear and also a tendency to exagerate the extent of differences between all members of the groups of girls and boys. Older reports tended, by their method of presentation. to over-emphasise the sameness of this sequence. If. however, a calculation is made of the extent of variation from the mean of these measurements at each age, it is more easy to realise both the degree of overlapping in

actual dimensions from one year to another and the wide differences at each age between the most fully developed child and the least mature. The recognition of this everlapping and the differences is probably the most important finding of the second quarter of this century, predominantly due to the statistical work of Karl Pearson and others.

So one method of analysis of these data was to calculate averages and the variations at each age for boys and girls separately. Another type of analysis of such data was in terms of average yearly increments in growth. When this was done it was shown, in the case of height for example, that the average height (length) of boys is somewhat greater than that of girls at birth, that it increases approximately at the same rate to about the age eight, that the rate of girls then begins to exceed that of boys and that this relatively larger increase maintains itself for approximately five yearly measurements. About the age of ten therefore the average height of girls equals that of boys. From the ages of 11 to 14 their yearly increment is greater than that of the boys, but from ages thirteen to nineteen their annual increment decreases stedily to such an extent that by the age of 15 the boys on the average have again become somewhat taller. An even more spectacular difference in the relative increment of growth is reported in the girls' increase in weight about the age of 11 and the boys' spurt about the age of 14.

In recent long term studies which report data obtained from successive measurements of same individuals over a

period of years it has been revealed very clearly that

(i) all adolescents do not experience their period of maximum growth at the same age; (ii) so the pronouncements upon the physical attributes of adolescents in terms of group averages and comparison of individuals with the average measurements of their contemporaries are more hazardous and misleading than is such a use of averages in early childhood (upto the age of 8 or 9 or earlier) or in adult life (age of 19 or 20 and over); (iii) the nature of the degree of variability in the development of boys and girls is such that each seems to follow his own pattern of growth in relation to the average of the group; (iv) there exist other differences between early and late maturing adolescents.

Development rate is not uniform in all bodily organs. The origin and extent of such discrepancies have been the subject of extensive studies in recent times. There has in consequence been a considerable increase in knowledge of the endocrine changes which are believed to be involved in growth and development such that premature sexual development is followed by premature cessation of bodily growth, on the other hand, in cases where sexual development is too long delayed, the growth of the limbs continues to disproportionate extent.

3. References to some recent studies.

Results of one of the most comprehensive studies of some 2,000 pupils of the Psycho-Educational Clinic of the

Harvard Graduate School of Education with semi-annual observations for a continuous period of 12 years, relating to physical measurements, intelligence tests (both verbal and non-verbal), scholatic achievements, personal attributes and family history are given in Dearborn*. Contributions of others which are not so comprehensive are also referred (Flemming 1949). Mention has to be made of the series of articles entitled "Studies in Growth" by Franz Boas in the early volumes of Human Biology (1932-35).

4. Criteria of Maturity.

It is not, of course, easy to determine the most satisfactory criteria of physical maturity. The frequent irregularity of menstruation in the first few years after its appearance and the fact that this evert criterion is not useful for boys make it less useful than other criteria such as skeletal age (determinable from X-ray photographs of the growing areas of bones in the hand or the knee) or the simpler measure obtainable from recording the period (yearly or six-monthly) in which a child shows the most rapid growth in bodily size. There are secondary and tertiary characteristics of maturity e.g. change in pulse rate and blood pressure, swelling of the breasts in girls (and occasionally in boys), the appearance of pigmented public hair and later of hair under the arm-pits

in both boys and girls, voice changes and more or less sturdy growth of facial hair in boys (and sometimes in There are so many individual variations in the rate of development of each and each other secondary characteristics that no two of the normal group of adolescents may prove to be experiencing quite the same rate or incidence of growth. Thus evertly and easily accessible criteria of maturity - according to which individuals can be grouped for fruitful statistical analysis of agevise physical characteristics such as height, weight, chest circumference, etc. separately as well as jointly - would be the period of rapid growth for both boys and girls. In the case of girls, however, the age at the first menstruation gives a good criteria. In the former case long series of observations for nearly ten years beginning with the age 10 for a sufficiently large group of same individual would be necessary with preferably semi-annual. Interval of consecutive measurements.

5. Limitations of the present study.

Any acceptable criterion of segregation is not so easy a problem as initiation of primary and secondary apparent effects of puberty is spread over a longer interval over the age-continuum. In the case of girls, the overt recognisable fact of the first menstrual course may broadly be taken as heralding the well past occurance of the pubertal spurt. Segregation of the girls into groups having first menstruation in the same age interval is one of the

available methods of study. Only draw-back in its use, if at all it is to be called a draw-back, is the non-available lity of so simple a criterion for segregating boys. Nevertheless it appears that this will be useful for the study of the relation of menarche with somatic and psychological developments during adolescence. Stature and weight are the important somatic characteristics and these will be studied in detail with the pubertal age segregation of girls in the following sections.

Another criterion of segregation, which was largely used in many of the recent Western investigations, was of grouping individuals according to maximum rate of growth, more particularly in stature. One main hazard for this is the necessity of having continuous observational data of the same individuals for longer period at short interval. say six-monthly. This is applicable for both boys and girls and will yield comparable pointers almost on all pertinent issues. Our present data fell short in that the period of continuous recording was of only four years annual data of individuals with latest age at report being any one from 13 to 18. To exactly locate the interval of maximum increment is extremely hazardous as there should at least be three to four years data on either side of the period of the maximum rate of growth. However, an attempt is made to utilise this type of available information.

The tempo of development of the body during adolescence varies along the different traits of the body, stature reaches its high limit at round about the beginning of adulthood. Increase in bulk of the body (weight) goes on longer. Though both these characters depend, on here-dity and the individual physiognomy, the environmental factor bears some influence on the shaping of the bulk of the body.

6. Comparability of certain generalisations with the aid of our data.

With the limitations of our data, we will be in a limited position to verify more exhaustively the pattern of growth in girls. But it would not be possible to do much by way of either comparison or special deductions in the case of boys except presenting the averages with standard deviations, and correlation between physical characters at each of the ages 10 to 18.

The nature of such generalisations in case of girls would be:

- In the interval of rapid growth, the correlation coefficient would also be maximum;
- ii) Earlier the menarche occurance, stunted the growth and larger the bulk of body in later years;
- iii) Tall girls get menarche earlier;
- iv) Small variability amongst segregated series in comparison with that in the total pooled series for the same years.

7. Social and Community importance of such studies.

when physical measurement studies are supplemented by psycho-analytical ones e.g. administering of intelligence tests, results and deductions will prove useful in vocational, dietic and hygeinical planning for the future. "Efforts to produce greater similarity by organised exercise or additional feeding are in most cases foredoomed to failure and merely increase the difficulties of the adolescents who are already sufficiently burdened with the complications attendent upon their endeavour to adjust their ways of living to their own changes in bodily structure." (Flemming 1949 p.11)

8. Outline of the analysis presented.

Data used for the statistical analysis here was collected as a part of the general annual medical check-up of high school pupils in Poona. Detailed analytical treatment is confined to only two of the physical characteristics i.e. height and weight separately and jointly at each of the ages 10 to 18 for boys, for girls and for each of the segregated group of girls by menarchal age 11 & 12, 13 to 16 and 17 & 18. Similar agewise presentation is also carried out for the physical measurement of chest expiration. Tables of averages, variabilities, and the rate of growth as measured by the difference between the consecutive averages relating to Stature and Chest Expiration are discussed in Section II and those relating to Weight in Section III. Similar treatment of correlation between height and weight will be found in Section IV. The

menarchal peculiarities will be brought together and the accumulation graph and table relating to the menarchal incidence by age in the population will form the Section V.

In Section VI are given the linear relationships of height and weight for specific ages and also is given in a tabular form the calculated statistical constants i.e. correlation coefficient, average height, average log-weight, the first with the standard error and the other two with their standard deviations — and then the linear regression equation. There will be eight such tables. An equal number of such tables which will have the heading — Weight (in Lb.) for each inch of Height: Girls with Menarchal Age — (say 15) at ages 10 through 18, will follow. The last Section VII will be devoted for concluding remarks as such.

9. Definitions and some explanations.

Age: All throughout this part, as in the previous one, the age is noted in years and when the word 'age' is unqualified or not it means the age in completed years of the pupil at the time of the medical examination. This usage is uniformly adopted in tables and the report.

Logs Values: All logarithms are with the base 10.

Variabily: This is often used as synoumous with the well known statistical term standard deviation usually abbreviated as s.d.

Case or Schedule: A separate set of data relating to a pupil forms a case or schedule. So maximum number of

schedules pertaining to one pupil included in this report would be four. Frequencies are given in Table No. II.1.

Mode of taking measurements: Detailed explanation relating to the measurements of stature and weight is noted in the Section VI - Statistical Note.

*SECTION II:

Stature by Sex and Age:

1. Uniqueness of stature.

Of all the bodily measurements stature received predominant attention atk the hands of the investigators and research workers since long time. Its unique character can best be gauged by the absence of any invented accelerators and regulators excepting the recent experimental stage of Hormone therapk for the treatment of individual height. So the representative character stays unique in addition to its amenability to simple measurement. Another characteristic of this measurement is that the increase in height comes to an end some time in the beginning of adulthood. Even though of common place occurence is the dependence of height on age in cases of children and teen-agers with the peculiarity that knowing of age is not sufficient to guess height accurately as heights are scattered over an appreciably large range in a frequency distribution, characteristic of that age. But the mean, one of the features of the distribution, will be a continuous function of age.

2. Average Height By Age (Both Sexes):

Average height for each age in the range 10 to 18 for total boys and for total girls as well as for menarchesegregated series is shown in Table II - 2. Average stature of total boys and total girls at age 14 was a little less than 59" and below this age girls were found to be

taller than boys and above, the position was reverse i.e. boys taller than girls. The higher limit of the average height for girls was observed to be 60°. Considering this in relation to the menarche-segregated series of girls it would be clearly brought out that this high limit was attained at the age about 14 to 15 in the series of those who had menarche at the age 14 or below, and at the age 17-18 by those who had menarche at the age 15 or later. Giving due allowance for the short continuity of this data it was clearly observable that the early menarche had nothing to do with stunted growth.

3. Annual Increments in Height:

These are given in Table No. II - 4. These were simply obtained by taking the difference between average values at successive ages. In each series there would be a high figure of increment sloping downwards on both sides as successive ages. In the series of total girls it was between the ages 12 and 13; and a little less high at the age 11-12. It went on diminishing till it was nearly zero at age 17-18. In the series of total boys the high was placed at the ages 13-14 and 14-15, with the gradual decline at upper ages and would reach the value zero at an age beyond the age 18.

The location of the high increment in the menarch-segregated series would be observed to have taken place at an age about one or rather one and half years earlier than the menarche age. The occurence of spurt and its time lag in relation to the menarche age was obscured in the information given by the total girls-series.

The rate of growth in stature is recommended as a criterion to be used in the segregation of the data of boys and girls, to utilise such procedure needs data continuous over longer duration, say from age 10 to at least age 20, having successive measurements at shorter intervals, at least half-yearly, in order to enclose in the right moment of the occurence of spurt. In the absence of the availability of this procedure recourse was taken to the readily available information relating to the menarche age in the case of girls. Some such procedure could not be utilised for the case of boys and so the information was presented for all the boys group.

4. Variability:

similar to the table of average stature, the corresponding standard deviations are presented in a separate table (Table No. II - 3). This was done for the simple reason of readily available comparability. It is well-known that nearly two-thirds of the total frequency is found to be distributed in the interval plus and minus the standard deviation round the average, and only 5% are beyond the range of plus and minus twice the standard deviation.

Variability among total boys was found to be wide as compared to total girls from age twelve and onwards. The wideness of the variability suggests the necessity of

segregating. This will become apparent from observing the effects of menarche-segregation for girls. The variability amongst any of the menarch-segregated series will be found to be less than that for the total girls at all ages. In short the variability gets narrowed down, a sign of a relatively homogeneous grouping.

SECTION III:

Weight by age and sex:

1. Introductory.

Inroughout the discussion of weight it is to be borne in mind that weight of the individual, particularly in the growing stage, largely depends on the economic living conditions at home, the other contributory factors being heredity, environmental conditions, etc. In the course of the study height is the only related factor with which weight has been correlated exhaustively. What has been said regarding height and age is generally so with reference to weight and age with the difference that there cannot be any postulated upper limit to the growth in weight during the period under study or even afterwards more due to the availability of weight the existing situation.

2. Average Weight by age and sex.

These were obtained in the course of fitting linear regressions in-the-course between height and weight for various ages. Adoption of the logarithmic value of weight instead of absolute one is explained in the Statistical Note later. Geometric mean is always lower than the arithmetic average but at the same time it (the geometric mean) possesses an additional important feature of being less affected by the extreme values in the series. It is interesting to compare figures of this table with appropriate ones in Table Nos.

I - 28 to I - 30. For the series of total boys and of total girls the arithmetic means are greater than the corresponding geometric means. The similar pattern would be observed in those of menarche with the difference that the narrower differences in the types of averages might be most likely due to the more homogeneous assembly of the data due to segregation.

All the points regarding the trend and agewise peculiarities made out in the previous Section, regarding average height more or less equally hold good in the case of average weight and so will not be duplicated.

3. Annual increments in meight.

Similarly it would be found to be true in the case of annual increments in weight. The annual increments in weight are presented in Table No. II - 6.

:SECTION IV: Correlation between Height, Weight and Age:

1. Introductory.

Correlation coefficient itself is void of scale utility still it possesses the utility value due to its being an indicator of degree of association between the two observations under study. In the present study we are concerned with the correlationary relation between weight and height in connection with age separately as well as jointly. In the derivation of the correlation coefficients logarithm of weight were used throughout for reasons explained earlier and later.

2. Correlation Coefficients.

Correlation coefficients at observed ages 10 through 18 between log. Weight and Height for the series of total boys, of total girls, and 8 menarche-segregated girls are shown in Table No. II - 8. All these were found to be significant at 0.10 level. Many of these indicated very high significance. Similarly high significant value of the correlation between age and height for total boys series was 0.80 and between age and log. weight was 0.79. Nearly the same values were in the case of total girls series. The high amongst the values of correlation coefficients for the total boys series was 0.83 at the age 15 gradually lowering down on the left to 0.75 at age 12 and steeply coming down on the right to 0.58 at age 17. More or less the similar pattern of relative placings was observable for the total girls series the high of 0.79 being at age 12 and for menarche segregated series it would be found to be at an age one or one-and-half years earlier to the menarche age.

SECTION V:

Menarche and its influence on Weight & Height:

1. Preleminary.

In Section III (Menarche) of Part I of this report, it was made clear that menarche simply means, for the purpose of this study, the on-set of first monthly course without going into the merits of the controversial aspects of the definition of puberty, menarche, etc. Menarchal period was simply used as a readily available indicator for segregation and thus try to study the location of the pubertal spurt in relation to the occurence of the first monthly course. such overt and simple criterion was not available for partitioning boys. We had at our disposal the period of e menarche in annual intervals. It needs to be remembered that at the time of the medical examination it was not possible to narrow down this period of occurence to even a particular month. This rather long annual interval would have been one of the reasons of over-alapping and erroneous mixing of individuals of adjacent ages in segregating, the relative position in the short period of continuity remaining unchanged.

2. Menarche with its relation to height and weight.

Average menarchal age was found to be 14.120 with s.d. plus minus 1.089 (See Table No. I - 21). Menarchal occurence was found to be preceded by pubertal spurt by nearly one or one-and-half years. This became quite clear in

relation to height as well as weight in the earlier sections. Prior and after the spurt the annual increases in height and also in weight went on lowering year after year more rapidly on the right than on the left.

3. Accumulation Curve.

In order to throw light on the pattern of menarche in girls, the adoption of the common cumulative-frequency curve, generally known as Ogive, will be of very little use. curve is satisfactory only when the property under consideration has been experienced by the cent percent of the population and there is no place for those who have not experienced this. On the contrary this technique is unapplicable when only a part of the population is eligible for experience in each age group. A satisfactory statistical tool, styled as Accumulative Curve (Kinsey, et al. 1948) will be useful to show the number of experienced in the age group in relation to the total number in that group. The only draw-back in such a curve is that it is less accurate near its end as the population which establish the successive points on the curve become smaller at the upper age levels. Such a curve is a useful in visualising at a glance the per cent of the population which have had the experience byth the given age. Another usefulness of such a curve is that it furnishes a good base for predicting what percentage of the population of any group will ever be with the experience, care being taken that the attached meaning should not too much be streched.

4. Accumulative Menarche-Incidence Curve.

The experience of menarche at particular age for girls during the ages 10 through 18 is suitable for such type of presentation. This is presented in Table No. II - 9. column headings in this table are self explanatory. Still the implied meanings are: (1) age at menarche; (2) summation of Col. 1. This is the Ogive: (3) ages at reporting, of experienced individuals; (4) Summation of Col. 3, one step in advance. This represents the ages which the exprienced individuals had not yet reached at the time they were examined; (5) Substraction of Col. 4 from Col. 2. This represents the years actually lived by the experienced individuals; (6) ages at the time of medical examination, of inexperienced individuals: (7) addition of Cols. 3 & 6. This is the age distribution of all the subjects (both experienced and inexperienced) at the time of medical examination; (8) Summation of Col. 7, in reverse. This is the basic population for incidence calculations at each age; (9) Division of Col. 5 by Col. 8. This is the percent of the population at each age with the experience in that year, or in any previous years.

From this table it will be clear that nearly 99.2 percent of the girl population experience menarche by the age 18 or earlier.

SECTION VI:

Statistical Note relating to linear regression of Weight (Logarithm of) on Height:

1. Preliminary.

The data used for this analysis was obtained in the course of the medical examination of the pupils of the Secondary Schools in Poona, of ages 10 through 18 studying in Standards V to XI during the years 1953-54 to 1956-57. Height was measured correct to a quarter inch when the individual was in a position standing erect against the vertical scale with eyes straight in front with footwear (along with the socks, rather rarely in use,) removed. Weight was recorded in whole pounds when the individual stood straight on the platform of the weighing machine with eyes in front without foot-wear but with outdoor conventional routine wearing apparels on; five-yard Sari with skirt and blouse by almost all girls; and shirt and short of stiff cloth or white pyjamas by boys invariably. Tetal apparel weight would come to about two to five pounds for both boys and girls. Weigh-scale dials were graduated for stone and pound.

2. Weight-Height Relationship.

Frequency tables of weight and height for each age from 10 to 16 were prepared. For the purpose of this analysis heights were pooled into one inch interval groups to remove observational bias. Strong bias for even figures

was observed in recorded weights. Convenient method of smoothing adopted was to half the frequency of old weights and to add these in the adjacent even ones in each of unit interval height. These modes of smoothing were uniformly adopted in finalising the form of weight-height bivariate distribution tables used for this analysis. Preliminary calculations of the correlatory analysis were worked out before finalising the uniform procedure, in the cases of five finalised tables. It was revealed that the standard deviations of actual weight for each inch of height went on increasing as height increased and the corresponding coefficients of variations were observed to be very nearly the same. This plainly pointed out the use of semi-logarithmic relation between weight and height. (Kenney & Keeping, 1952. Part II p. 210). The analysis of variance also showed the significant a effect of linear regression of weight on height.

Finally corrected for bias i.e. the smoothed frequency tables of height and logarithm of weight instead of actual weight were used in computing by standard procedures the necessary statistics means, standard deviations, and co-variances needed for the correlation analysis and subsequently for calculating the regression constants. These were obtained for each age from 10 to 18 for total boys series, total girls series, and for each of the menarchesegregated series.

The correlation coefficients, regression equations, and standard errors of estimate are given in Table Nos. II - 10 to 17.

3. Weight-Height Standard Tables by Age and Sex.

Substituting in these regression equations of logarithm of weight (1b) on height (inches) for the age the serial values of height in whole inches incorporated in the range 10 inches on either side of the rounded integral value of the average height, corresponding expected mean values of weight were calculated. Adding to and subtracting from the mean weight, twice the standard error of estimate, the upper and lower limits were obtained which between themselves would cover 95 per cent of the individuals of that height and age. In all these conversion by use of antilogarithm tables was effected at the last stage. These weight values are presented in Table Nos. II - 18 to 25.

4. Weight-Height-Age Relationship.

Regression equations referred in para 2 of this Section relate to weight and height only for each specific age. An attempt was made to introduce age as an additional variable in the regression equations for the two series of total boys and total girls. The partial correlation coefficients were found to be highly significant and the multiple correlation coefficient was also found to be high. All the relevant coefficients together with the equation are noted

down in Table Nos. II - 26 & 27 for the series of total boys and of total girls respectively. Using these equations standard mean weights with lower and upper limit values for the mere purpose of illustration, were calculated for heights at quinquennial intervals starting at 40° for age 10 to 18.

5. Remarks on Weight-Height Tables.

values show their presence in case of series of weights which should generally be increasing for the same height at increasing ages i.e. Table No. II - 21 height 54" and age 17. To reason out this occurence satisfactorily was rather found to be difficult. But a suggested course in such a situation would be to adjust the depressed value in alignmentwith the trend traced by weight values for preand post-ages at the particular height in question. Computed figures in these tables are presented without any adjustment.

Occurence of such a phenomenon in menarche-segregated series of tables might be due, amongst other things which remain unexplanable, to relative smallness of the frequencies in the available data. Adjustment suggested in the previous para might be resorted to, when the use of these tables would be contemplated. Chief object in presenting these weight-height for menarche-segregated series had been to show the lay-of-the-land in order to suggest usefulness in actual practice.

6. Comparison of various standards relating to weight by age and height presented in this report.

For the purpose of ready comparison the table No. II - 28 is constructed by bringing together the calculated weights for average or for nearby average height for each of the ages 10 to 18 for both total series of boys and of girls, presented in both parts of the study. We do not know of similar other material, otherwise it would have been placed along with this to facilitate comparison.

Standards of weight and height by age (Table No. I - 4) as devised by the Students Health Association, Poona, in 1953 and later on used to grade pupils in health classes in subsequent examinations are noted in the first row (a) of the table. This is followed by (b) direct averages from Table Nos. I - 28 and 29; by (c) geometric mean weights and average heights at each age, as obtained along with the computations of correlation coefficients and presented in Table Nos. II - 2 and 5, by (d) the value of weight against the average height for the age from the computed standards with two variable regression (Table Nos. 18 and 19) and in the last row (e) with three variable relation (Table Nos. 26 and 27).

This clearly shows that the SHA 1953-standard weights are comparatively high on the average. The two variable regression affords a good means for computing standards. The three variable regression also gives values representing a realist picture round about and rather tending

towards unrealistic for points away from the average values of the variables. This limits its use for the calculation of the standard weights for heights and ages.

SECTION VII

Conclusion:

The object of the statistical analysis of weight and height in relation to age by sex was to fill out a gap relating to the availability of a type of standard tables pertaining to our conditions. Upto this time the standard weight-height tables were those found in medical text-books, predominantly foreign relating to foreign situations. Only experience would prove their utility and confirm the success attained in the fulfillment of the objective.
