General remarks.

The year under report opened with a brighter outlook than that of the preceding one owing to the gradual clearance of the political atmosphere in India. For the first time, after a long spell of political weariness, the trade had breathing time to take stock of the existing position. It was expected that the World Economic Conference and the Disarmament Conference which were to be held during the year would so adjust and improve conditions abroad that India would also be beneficially affected by the results of such delibera-But these expectations were not realized, as the Conferences did not succeed in formulating schemes for the solution of the economic difficulties which had beset the nations of the world. Needless to say that the failure to find the expected relief had its repercussions in India. The American experiments for the improvement of business and economic conditions caused considerable instability and uncertainty in trade circles. There was another factor which made trade apprehensive and nervous in placing orders for goods. Although by the commencement of the official year, it had got accustomed to the preferential tariff imposed as a result of the Ottawa Agreement, it was generally known that other changes in the tariff were contemplated, and while the

negotiations and discussions with the Japanese and Lancashire Trade Delegations lasted, considerable uneasiness as to the final outcome of these was felt. Badly bitten as the trade was by years of continued depression, it was in no mood to take a leap in the dark, and a cautious and conservative spirit guided it in putting through its transactions. The local Textile Industry felt very severely the strain imposed on it by Japanese competition. The depreciated prices at which goods of Japanese manufacture continued to be imported and sold dislocated not only the Textile Industry but also trade in general to a considerable extent. Some deflection of trade to non-British Indian ports and the poor purchasing power of the masses resulting from the low prices which agricultural produce continued to fetch constituted the other factors which contributed to the marked set-back which the Foreign trade of the Presidency of Bombay (excluding Sind) suffered during the year under review.

Exports of gold though lesser than those of the previous year continued to be heavy. The appreciable increase in the exports of Indian produce is a redeeming feature of the year and gives some definite hope of a revival in the export side of the foreign trade.

Imports of private merchandise which had been declining for 4 years since 1928-29, though improved by Rs. 4.55 crores in 1932-33, again contracted by Rs. 8.13 crores or nearly 15 per cent. to Rs. 46.19 crores. This is partly due to falling prices and partly to the general trade depression. It will be seen from the itemised list in paragraph 16 that most of the principal articles of import have shared in this contraction, the more important being cotton raw (including waste), cotton manufactures, artificial silk, oils and cotton twist and yarn. The only important articles which have recorded noticeable increases are machinery and millwork and motor cars and motor cycles (including omnibuses, etc., and parts). Imports of treasure further declined from Rs. 1.91 crore to Rs. 1.01 crore.

- 3. Exports of Indian produce improved by Rs. 4.24 crores or nearly 18 per cent. to Rs. 27.41 crores. Had it not been for the low level of commodity prices, the improvement would have been more noticeable. Most of the principal articles of export have contributed towards it, the more important being cotton raw (including waste), seeds, wool raw and hides and skins raw; cotton manufactures, grain pulse and flour and oil cakes however recorded decreases.
- 4. The percentage distribution of Bombay's trade indicates that the United Kingdom has regained the pride of place which she had yielded to Japan last year. The share of the United Kingdom in the total trade improved by nearly 3½ per cent, while that of Japan declined by 2½ per cent. owing chiefly to smaller takings of cotton, raw. Trade with the Continent of Europe showed a slight improvement while that with America declined by over 2½ per cent.
- 5. The value of the total foreign trade of Bombay Presidency, excluding Sind, further contracted by Rs. 11.56 crores, or 8 per cent, to Rs. 130.49 crores. Both imports and exports shared in this heavy decline—the former by Rs. 9.03 crores and the latter by Rs. 2.53 crores, in spite of heavy shipments of articles of Indian produce. Both imports and exports of the precious metals also declined by Rs. 89.77 lakhs and Rs. 6.95 crores respectively.
- 6. The value of the total coasting trade also declined by Rs. 1.58 crore, or 3 per cent. to Rs. 49.96 crores, exports decreasing by Rs. 1.91 crore, but _ imports increasing by Rs. 33.04 lakhs.

7. The gross collections of the Bombay Customs House declined from Rs. 15,80,23,178 to Rs. 14,03,82,418. These figures exclude the collections on account of various cesses such as the cotton cess and the tea cess. The ratio of true expenditure to revenue was $1\cdot07$ as against $\cdot 9$ per cent. in the previous year.

- 9. The aggregate value of the Foreign trade (private) of Bombay further fell by Rs. 11.63 crores to Rs. 130.4 crores, i.e., 8 per cent., or if treasure be excluded, by Rs. 3.78 crores, or nearly 5 per cent., to Rs. 75.66 crores. During the same period the foreign trade of Calcutta improved by Rs. 3.64 crores, or 4 per cent., to Rs. 90.65 crores while that of Karachi declined by Rs. 50.67 lakhs, or nearly 2 per cent. to Rs. 27.19 crores. Imports of merchandise into Bombay fell by nearly 15 per cent. while those into Calcutta and Karachi by 7 per cent., and 20 per cent. respectively. Cotton raw (including waste), cotton manufactures, artificial silk, oils, cotton twist and yarn, silk raw (including waste), metals and ores, sugar, paper and pasteboard, glass and glassware, silk manufactures, and fruits and vegetables mainly account for the decrease at Bombay; cotton goods (excluding twist and yarn), sugar, salt, grain, pulse and flour and tobacco at Calcutta; and cotton manufactures and sugar at Karachi. On the other hand, there were noticeable improvements in the imports of machinery and millwork, motor cars and motor cycles (including omnibuses, etc., and parts), instruments and apparatus, etc., and grain, pulse and flour at Bombay; machinery and millwork, metals and ores, motor cars and motor cycles and mineral oils at Calcutta and machinery and millwork at Karachi.
- 10. Exports of Indian produce advanced by Rs. 4·17 crores, or 18 per cent., to Rs. 27·34 crores at Bombay, by Rs. 6·15 crores, or nearly 12 per cent., to Rs. 58·12 crores at Calcutta and by Rs. 2·75 crores, or 25 per cent. to Rs. 13·58 crores at Karachi. Cotton raw (including waste), seeds, wool, raw and hides and skins, raw are chiefly responsible for the increase at Bombay; tea, lac, hides and skins, raw, jute, raw, opium and cotton, raw at Calcutta and cotton, raw, wool, raw and hides and skins, raw at Karachi. On the other hand, the only noticeable decreases were of cotton manufactures at Bombay, grain, pulse and flour and jute manufactures at Calcutta and seeds and grain, pulse and flour at Karachi.
- 11. The total value of the private Coasting trade, excluding treasure also fell away by Rs. 2.25 crores, or 5 per cent. to Rs. 42.07 crores. Imports improved but exports declined. Of the principal articles under imports, cotton raw (excluding waste) and grain, pulse and flour showed an improvement while oils—petroleum dangerous, etc., jute manufactures (excluding twist and yarn) and tea declined; under exports noticeable decreases were recorded under cotton piecegoods, cotton twist and yarn and grain, pulse and flour. Reexports of foreign mechandise increased by Rs. 27.44 lakhs to Rs. 4.41 crores mainly as a result of larger re-shipments of carriages and carts and parts thereof.

^{13.} Imports.—All the classes except the unimportant class IV recorded decreases. The most important group under imports is class III—Articles wholly or mainly manufactured—which recorded a decrease of Rs. 3.04 crores owing mainly to smaller arrivals of most of the principal articles, the more important among them being cotton yarn and manufactures, other yarn and textile fabrics, metals other than iron and steel, glass and glassware, paper, paste-board and stationery, silk yarn and manufactures, rubber manufactures, chemicals drugs and medicines and leather and manufactures thereof. Machinery of all kinds, vehicles (excluding locomotives for Railways), electrical goods and apparatus (other than machinery), woollen yarn and manufactures, cutlery, hardware and instruments and apparatus, etc., however, showed noticeable

increases. Class II recorded a greater fall, viz., of Rs. 4.6 crores which was chiefly due to smaller arrivals of cotton raw and waste, oils, silk raw and waste, and wool raw. Smaller receipts of sugar, fruits and vegetables, provisions and oilman's stores, spices, tea, and tobacco account for the decrease of Rs. 48.04 lakhs in class I.

- 14. Exports—Indian Produce.—Classes II, IV and V showed an improvement. The increase of Rs. 4·28 crores in the most important Class II is due mainly to larger shipments of cotton, raw and waste, seeds including nuts for oils, wool raw and waste and hides and skins, raw and untanned. Smaller despatches of grain, pulse and flour and spices account for the fall of Rs. 11·65 lakhs in Class I and those of cotton yarn and manufactures are responsible for the falling off of Rs. 2·71 lakhs in Class III. Shipments of hides and skins, tanned or dressed and leather and dyes and colours, however, showed marked increases.
- 15. Re-exports.—The increase of Rs. 22.38 lakhs in Class III was almost entirely due to larger reshipments of other yarns and textile fabrics and silk yarn and manufactures. Smaller re-exports of hides and skins, raw and untanned, were, however, chiefly responsible for the decrease of Rs. 2.03 lakhs in Class II.

17. The total value of imported merchandise which had been successively declining from 1928-29 to 1931-32, though improved by Rs. 4.55 crores in 1932-33 again contracted by Rs. 8.14 crores to Rs. 46.16 crores in the year under review. This is chiefly attributable to lower level of commodity prices consequent upon the general trade depression and reduced purchasing power of the The contraction is more marked in cotton raw (including waste); cotton manufactures, artificial silk, oils, cotton twist and yarn, silk raw (including waste), and metals and ores. Sugar, paper and paste-board, glass and glassware, silk manufactures including silk yarn, noils, and warps and fruits and vegetables also recorded decreases. The only articles in which increases were noticeable were machinery and millwork, motor cars and motor cycles, etc., and instruments and apparatus, etc. The more important of these commodities are separately dealt with, in subsequent paragraphs. Of the rest, the following items call for comments. The decrease of Rs. 14.9 lakhs under paper and pasteboard can be traced to reduced supplies from all the principal supplying countries except the United Kingdom whose shipments increased from Rs. 15.67 lakhs to Rs. 19.55 lakhs and the fall of Rs. 14.83 lakhs under glass and glassware mainly to smaller arrivals of bangles from Japan and Czecho-Slovakia. Fruits and vegetables fell by Rs. 12.25 lakhs chiefly owing to smaller receipts of dates from Iraq. Shipments of almonds from Italy, however, improved by Rs. 3.19 lakhs but those from Persia declined by Rs. 1.68 lakh. Smaller supplies of canned and bottled provisions from the United Kingdom and the Netherlands were mainly responsible for the fall of Rs. 8-59 lakhs under provisions and oilman's stores. In spite of larger arrival from Japan of chemicals and chemical preparations the total imports thereof declined by Rs. 7.91 lakhs owing mainly to smaller supplies from all the other sources of supply while the decrease of Rs. 6.13 lakhs under rubber is accounted for by smaller shipments of pneumatic motor covers from the United States of America, Italy and Germany. The United Kingdom, however, increased her supplies. Imports of carriages and wagons and parts for railways declined by Rs. 4.36 lakhs due almost entirely to reduced despatches of wagons and parts from the United Kingdom while those of earthenware and porcelain fell by Rs. 3.62 lakhs owing to smaller arrivals from Japan. Imports of tobacco recorded a decrease mainly as a result of smaller receipts of unmanufactured tobacco from the United States of America and of cigarettes from the United Kingdom. Imports of instruments, apparatus and appliances, etc., on the other hand, showed an improvement of Rs. 20.34 lakhs mainly on account of increased shipments of electrical appliances from the United Kingdom and cinematograph films from Germany and the United Kingdom. Supplies of grain, pulse and flour also rose by Rs. 11-38 lakhs owing to larger receipts of pulse from Iraq and rice not in the husk from Japan.

The increase in imports is due partly to larger arrivals of Australian coal and partly to the imports of 3,920 tons valued at Rs. 57,818 from the Union of South Africa (Natal) against nil during the previous year and represents replacement of stocks. Imports from the United Kingdom however considerably declined. Arrivals of Bengal coal also fell away from 442,000 tons to 416,000 tons.

Prices of English coal were Rs. 19 to 20 per ton while those of Bengal coal were about Rs. 12/8 per ton.

- 19. Dueing and tanning substances.—Imports under this head declined from Rs. 1.66 crore to Rs. 1.65 crore in value, but owing to the fancy of the public for lighter shades of dyes important qualities of coal tar dyes showed an increase. Germany's share in the total imports improved from 51 to 52.6 per cent. Imports of alizarine dyes increased from 1,440,429 lbs. to 1,564, 827 lbs. in quantity and from Rs. 10.37 lakhs to Rs. 12.74 lakhs in value. Imports from the United Kingdom improved but those from Germany declined. Imports of aniline dyes increased from 6,921,130 lbs. to 7,852,176 lbs. in quantity but decreased from Rs. 1.33 crore to Rs. 1.28 crore in value. The remarkable feature of the year is the serious entry of Japan into this field, her imports amounting to 908,643 lbs. valued at Rs. $9\cdot06$ lakhs as against 157,087 lbs. valued at Rs. $2\cdot4$ lakhs in the previous year. Imports from Germany rose from 3,912,338 lbs. to 4,377,719 lbs. in quantity and from Rs. $71 \cdot 18$ lakhs to Rs. $72 \cdot 7$ lakhs in value. Arrivals from the United States of America also rose from 684, 226 lbs. to 1,044, 188 lbs. in quantity and from Rs. 8.04 lakhs to Rs. 10.29 lakhs in value, but those from the United Kingdom fell from 1,216,449 lbs. to 877, 149 lbs. in quantity and from Rs. 23.04 lakhs to Rs. 18.59 lakhs in value. Supplies from Italy, France and Switzerland also declined. Imports of Saffron increased from 43,472 lbs. to 48,337 lbs. in quantity and from Rs. 9.72 lakhs to Rs. 10.9 lakhs in value. The average price of saffron increased from Rs. 22-5-9 to Rs. 22-8-9 per lb.
- 20. Hardware.—Imports under this head representing a large variety of articles such as agricultural and other implements and tools, builders' hardware, domestic hardware, enamelled ironware, gas mantles, lamps, stoves, etc., declined from Rs. 101.43 lakhs to Rs. 95.22 lakhs owing mainly to smaller arrivals from Germany. Imports from Japan and the United States of America have however advanced. Germany maintained her position as the largest supplier but her share in the total imports declined from 40.7 to 33.7 per cent. The shares of the United Kingdom, Japan and the United of States of America correspondingly advanced from 27.1 to 29.3 per cent., 8.2 to 11.8 per cent. and 5.3 to 7.1 per cent., respectively.

The total imports of liquors shows an increase in value but a decline in quantity. The fall in imports of ale, beer and porter in bulk is due partly to the general trade depression and unemployment and partly to lack of demand for cheaper brands in consequence of the closing of mills in the latter part of the year. Importers of liquors had throughout the year expected a decrease in the rate of duty on whisky and accordingly did not place their usual orders. The decrease in whisky was however partly made up by an increase in the arrivals of brandy.

Ale, beer and porter.—Imports of bottled beer improved from 837,793 gallons to 856,720 gallons due mainly to larger arrivals from the Netherlands and Japan. Imports from Germany declined considerably. Imports of beer in bulk fell from 355,158 gallons to 253,258 gallons owing chiefly to smaller receipts from the United Kingdom. Arrivals of stout and porter both in bottle and in bulk also declined.

Spirits.—Imports of spirits except whisky and gin increased as a result of larger arrivals of brandy and liqueurs from France, spirit present in drugs from the United Kingdom, perfumed spirit from France, the United Kingdom and Germany and rum from the United Kingdom. Imports of methylated spirit which represent rectified spirit received from Java and denatured at this port on arrival, also increased from 316,537 gallons to 325,247 gallons in quantity and from Rs. 3·3 lakhs to Rs. 5·23 lakhs in value. Imports of whisky and gin, on the other hand, decreased owing to smaller receipts from the United Kingdom.

Wines.—The slight increase recorded under this head is chiefly due to larger arrivals of sherry, madeira and marsala from the United Kingdom and Spain, champagne from France, and port from Portugal.

- 22. Machinery and millwork.—As a result of the expansion of industries the total value of imports under this head further increased from Rs. 3.67 crores to Rs. 4.22 crores. The most noticeable increase is under sugar machinery. Imports of sugar machinery, chiefly from the Netherlands and the United Kingdom, rose from Rs. 11.09 lakhs to Rs. 65.93 lakhs and those of electrical machinery, mainly from the United States of America and the United Kingdom from Rs. 33.9 lakhs to Rs. 47.65 lakhs. Arrivals of prime movers also increased from Rs. 43.62 lakhs to Rs. 48.1 lakhs. Imports of textile machinery however decreased from Rs. 1.87 crore to Rs. 1.55 crore owing almost entirely to smaller arrivals of cotton spinning and weaving machinery from the United Kingdom. Although the United Kingdom continues to be the largest supplier, her share in the total imports declined from 74.2 to 64.3 per cent. The shares of Germany and the United States of America however advanced from 10.7 to 12 per cent. and 5 to 6.3 per cent., respectively.
- 23. Matches.—Imports under this head entirely representing safety matches have slighly increased. Arrivals from Sweden amounted to 27,519 gross of boxes valued at Rs. 21,000 as against 15,000 gross of boxes valued at Rs. 11,000, while those from Japan were practically nil against 10,002 gross of boxes valued at Rs. 4,000 in the previous year. There were no imports of undipped splints and veneers for match boxes during the year.

Iron and Steel.—In spite of the prevailing unsettled condition of trade and industry, the British Steel Industry showed definite signs of expansion and the total imports from the United Kingdom which had been continuously declining since the year 1929-30 increased during the year under report from 32,000 tons to 44,000 tons in quantity and from Rs. 57.87 lakhs to Rs. 74.97 lakhs in value. A noticeable feature of the year is Japan's improved position in the market, her imports increasing from 2,000 tons to 8,000 tons in quantity and from Rs. 4.16 lakhs to Rs. 13.3 lakhs in value compared with those of last year. Imports from Germany increased only slightly, and those from Belgium decreased from 39,0.00 tons to 23,000 tons in quantity and from Rs. 51.01 lakhs to Rs. 27 lakhs in value. Arrivals from the other Continental ports and the United States of America also recorded decreases.

A comparison of imports of the protected articles of iron and steel with those of the preceding year shows a further fall of 6,453 tons under galvanised sheets and plates due entirely to smaller receipts from Belgium, and of 1,129 tons under wire other than fencing wire owing to decreases from Belgium, Germany and Czocho-Slovakia. Imports of sheets and plates not galvanised or tinned, and of beams, channels, pillars, girders and bridge-work recorded decreases owing mainly to smaller arrivals from the United Kingdom and France respectively. Imports of bars other than cast steel, on the other hand, increased from 14,210 tons to 15,798 tons due chiefly to larger arrivals from the United Kingdom and France and those of tubes, pipes and fittings wrought from 5,104 tons to 6,650 tons owing mainly to larger arrivals from Poland, the United Kingdom and Germany. Imports of other manufactures of iron and steel also advanced from 5,420 tons to 6,455 tons as a result of larger supplies from the United Kingdom.

Other metals.—Imports of mixed or yellow metal for sheathing—the principal item under brass from Germany fell from 155,267 cwt. to 94,066 cwt. in quantity and from Rs. 46.6 lakhs to Rs. 25.75 lakhs in value but those from the United Kingdom rose from 12,065 cwt. to 31,817 cwt. in quantity and from Rs. 3.62 lakhs to Rs. 8.7 lakhs in value. Arrivals from Japan declined by 237 cwt. in quantity and by Rs. 4.65 lakhs in value. Imports of copper decreased from 182,670 cwt. to 136,251 cwt. in quantity and from Rs. 62.76 lakhs to Rs. 42.46 lakhs in value. Arrivals of sheets from Germany and Japan fell away from 136,934 cwt. to 70,293 cwt. and from 12,450 cwt. to 898 cwt. in quantity and from Rs. 46.77 lakhs to Rs. 21.12 lakhs and from Rs. 3.94 lakhs to Rs. 22,000 only in value respectively but those from the United Kingdom improved from 12,796 cwt. to 51,569 cwt. in quantity and from Rs. 4.36 lakhs to Rs. 16.31 lakhs in value. Receipts from France amounted to 22 cwt. valued at about Rs. 1,000 only as against 2,011 cwt. valued at Rs. 80,000 while those from the United States of America were nil as against 20 cwt. valued at Rs. 1,000 in the previous year. Imports of German silver declined from 13,807 cwt. to 11,938 cwt. in quantity and from Rs. 10.02 lakhs to Rs. 8.62 lakhs in value owing chiefly to smaller receipts from Switzerland and Italy. Shipments from Germany and Austria however increased. Imports of circles, the chief item under aluminium improved from 6,679 cwt. to 14,854 cwt. in quantity and from Rs. 4.68 lakhs to Rs. 10.69 lakhs in value. Arrivals from the United Kingdom and Germany advanced from 2,156 cwt. to 6,277 cwt. and

157 cwt. to 3,939 cwt. in quantity and from Rs. 1.47 lakh to Rs. 4.61 lakhs and Rs. 10,000 to Rs. 2.85 lakhs in value respectively. Receipts from Japan however declined by 1,077 cwt. in quantity and by Rs. 83,000 in value. Smaller shipments from the Straits Settlements and the United Kingdom are chiefly responsible for the fall in imports of tin which decreased from 13,140 cwt. to 7,838 cwt. in quantity and from Rs. 13.09 lakhs to Rs. 11.34 lakhs in value and lesser supplies from Italy account for the decrease from 92,826 lb. to 77,246 lb. in quantity and from Rs. 3.29 lakhs to Rs. 2.06 lakhs in value in the imports of quicksilver.

25. Motor cars and motor cycles.—Owing to a drop in American exchange and reduction in prices, the total imports of motor cars, motor cycles, commercial vehicles and parts and accessories improved during the year under report and the value thereof increased from Rs. 1.19 crore to Rs. 1.69 crore. Imports of motor cars increased by 2,214 in number and by Rs. 29.64 lakhs in value. Arrivals from the United States of America rose from 614 to 1,722, those from Canada from 281 to 1,046 and those from the United Kingdom from 1,177 to 1,697 in number. The average declared value of the British car further declined from Rs. 2,139 to Rs. 2,105. Imports from Italy also rose from 63 to 99 cars but those from Germany and France fell from 136 to 102 and from 72 to 55 cars respectively. Imports of motor cycles declined from 318 to 249 in number and from Rs, 1.56 to Rs. 1.2 lakh in value; the United Kingdom sending 227 in number valued at Rs. 1.14 lakh against 305 in number valued at Rs, 1.5 lakh in the previous year. Arrivals of commercial vehicles advanced from 2,112 to 4,472 in number and from Rs. $29 \cdot 31$ lakes to Rs. $49 \cdot 22$ lakhs in value almost entirely due to larger arrivals of chassis from the United States of America and Canada. Imports from the United Kingdom fell from 440 to 387 in number but rose from Rs. 7.73 lakhs to Rs. 8.95 lakhs in value.

Imports of mineral oils from foreign countries decreased from 894 million gallons to 844 million gallons in quantity and from Rs. 2.61 crores to Rs. 1.97 crore due to smaller receipts of both kerosene oil and other sorts. The fall in prices is greater in proportion to the fall in quantity on account of the keen competition among the oil companies. Imports of kerosene oil in bulk declined by over 2½ million gallons in quantity and by Rs. 44.38 lakhs in value, there being no imports from Persia and the Celebes and other Islands in the Pacific as against over 32 millions gallons valued at Rs. 24.05 lakhs and over 11 million gallons valued at Rs. 8-21 lakhs respectively in the previous year. Arrivals from the Union of Socialist Soviet Republics (Russia)-Southern, which includes Georgia, however, advanced by over 14 million gallons in quantity but fell by Rs. 7.75 lakhs in value due to lower prices. Receipts from Roumania also increased by nearly 11 million gallons in quantity but declined by Rs. 4.37 lakhs in value. Imports of kerosene in tins, almost entirely from the United States of America, increased by 82,126 gallons in quantity and by Rs. 60,199 in value. Imports of kerosene from Burma further advanced from over 281 million gallons to nearly 301 million gallons in quantity but declined from Rs. 1.62 crore to Rs. 1.58 crore in value. Imports of fuel oils from foreign countries fell by over 1 million gallons in quantity and by Rs. 7.28 lakhs in value due mainly to smaller receipts from Persia and the Union of Socialist Soviet Republics (Russia) Southern-Georgia. Receipts from Roumania, however, were more than double of those in the preceding year in quantity. As a result of lack of proper demand from Cotton mills and ginning factories arrivals of foreign lubricating oils, chiefly from the United States of America, decreased by 8,000 gallons in quantity and by Rs. 3.43 lakhs in value due to a fall in American exchange. Receipts from the United Kingdom however increased both in quantity and in value.

Imports of petrol entirely from the Union of Socialist Soviet Republics (Russia) though increased by 71,000 gallons in quantity decreased by Rs. 2.68 lakhs in value due to lower prices. Imports of petrol from Burma amounted to 682,000 gallons valued at Rs. 1.71 lakh as against nearly 1½ million gallons valued at Rs. 10.77 lakhs during the last year. Imports of Benzine and motor spirit amounted to nearly 10½ million gallons valued at Rs. 25.16 lakhs and nearly 7½ million gallons valued at Rs. 18.17 lakhs respectively against 1¾ million gallons of motor spirit valued at Rs. 5.42 lakhs in the previous year.

27. Postal articles not specified.—Five specified articles, viz., (1) Gold and silver thr ad, (2) Cinematograph films, (3) jewellery, (4) precious stones and (5) cigarettes are included under the relative heads in the general imports and are excluded from this head. The total value of the unspecified articles imported by post further fell from Rs. 1·26 crore to Rs. 1·23 crore. The number of parcels assessed however increased from 178,862 to 191,223 with a corresponding increase in duty from Rs. 29·17 lakhs to Rs. 30·37 lakhs. The number of letter packets found to contain dutiable articles, on the other hand, fell from 60,733 to 53,232 but the duty collected rose from Rs. 8·57 lakhs to Rs. 9·57 lakhs.

28. Precious stones and pearls, unset.—In the year under report the trade under this head improved from Rs. 39.99 lakhs to Rs. 45.62 lakhs, and mostly

represented diamonds from Belgium which contributed Rs. 31.95 lakhs against Rs. 28.43 lakhs in the previous year. The increase under diamonds is partly due to the fall in the sterling-florin exchange and partly due to a larger marriage season in the Bombay and Madras Presidencies. Imports of pearls unset almost entirly from the Bahrein Islands and Muscat increased from Rs. 10.06 lakhs to Rs. 11.04 lakhs.

29. Sugar.—As mentioned in the previous year's report the passing of the Sugar Industry Protection Act 1931 has given a decided impetus to the sugar industry of India. Arrivals of Indian sugar from the interior made themselves felt in the Bombay market during the latter part of the year, in competition with Java sugar. The earthquake disaster in the United Provinces and Bihar in January 1934 however rendered some mills out of action and this affected the Indian supply. African sugar also was in competition to some extent in the local market.

The pre-war C. I. F. price of sugar ranged round Rs. 7-12-0 per cwt. and in war time rose to Rs. 50 per cwt. whereas in December 1933 it declined to Rs. 4 per cwt. the lowest noticed so far. The wholesale price of 23 Dutch Standard and above which stood at Rs. 15 per cwt. at the end of the last year declined to Rs. 14-9-0 in the beginning of May and advanced to Rs. 15-2-0, the highest figure of the year, by the end of June. It then gradually fell to Rs. 14-10-3 in the beginning of September but again rose to Rs. 15-2-0 in the beginning of November. A reaction set in and the price again fell to Rs. 13-9-3, the lowest figure of the year by the end of January 1934. It stood at Rs. 14-8-0 in the beginning of March 1934 and at Rs. 14-4-0 at the end of the year.

The total imports of sugar into British India recorded a fall of 138,000 tons, Bombay sharing in the fall to the extent of more than 13,000 tons. Arrivals of sugar, 23 Dutch Standard and above from Java into Bombay fell by 12,227 tons to 74,743 tons but those from Portuguese East Africa rose by 2,566 tons to 15,218 tons. Imports of beet sugar fell by 3,975 tons to 4,804 tons due chiefly to cessation of shipments from Southern Russia, Belgium and Czecho-Slovakia. Receipts from the Netherlands however rose by 831 tons to 1,270 tons. 3,484 tons valued at Rs. 3.48 lakhs were also received from the United Kingdom as against nil in the previous year.

30. Tea.—Imports of foreign tea fell from 4,567,000 lb. to 4,036,000 lb. in quantity and from Rs. 27·76 lakhs to Rs. 21·55 lakhs in value. Arrivals of black tea from Ceylon and Java declined from 1,357,000 lb. and 99,000 lb. in quantity and from Rs. 8·46 lakhs and Rs. 38,000 in value to 709,000 lb. and 3,000 lb. in quantity and to Rs. 4·44 lakhs and Rs. 1,000 only in value respectively. Receipts of green tea from China though showing an increase from 2,883,000 lb. to 2,950,000 lb. in quantity decreased from Rs. 17·55 lakhs to Rs. 15·45 lakhs in value. Arrivals from Japan, however, rose from 101,000 lb. to 351,000 lb. in quantity and from Rs. 62,000 to Rs. 1·46 lakh in value. Supplies of tea from Calcutta declined from 14,680,000 lb. to 6,243,000 lb. in quantity and from Rs. 61·42 lakhs to Rs. 27·27 lakhs in value but those from Madras advanced from 1,118,000 lb. to 2,178,000 lb. in quantity and from Rs. 5·62 lakh to Rs. 10·72 lakhs in value.

Exports of Indian tea advanced from 161,000 lb. to 185,000 lb. in quantity but declined from Rs. 1·31 lakh to Rs. 1·28 lakh in value due to a fall in prices in consequence of internal competition. About 66,000 lb. valued at Rs. 49,000 were shipped to Egypt against nil in the previous year. Shipments to Persia also increased but there were falls in those to Iraq and Portuguese East Africa.

31. Textiles.—A—Cotton, Raw.—Imports of foreign cotton declined from 82,175 tons to 41,482 tons in quantity and from Rs. 7.04 crores to Rs. 3.42 crores in value. This considerable decrease is partly attributable to adverse American prices and to the acreage reduction schemes of the American Government, and partly to conditions in the local mill industry. Imports from the United States of America fell from 44,338 tons to 8,071 tons in quantity and from Rs. 3.73 crores to Rs. 63.6 lakhs in value and those from Egypt from 8,330 tons to 5,420 tons in quantity and from Rs. 70.9 lakes to Rs. 46.7 lakes in value. Arrivals from Anglo-Egyptian Sudan also declined from 6,349 tons to 871 tons in quantity and from Rs. 65.4 lakhs to Rs. 7.19 lakhs in value. Shipments from Kenya Colony and Tanganyika Territory, on the other hand, advanced from 20,511 tons to 23,646 tons and from 944 tons to 2,526 tons in quantity and from Rs. 1.76 crore to Rs. 1.97 crore and from Rs. 8.14 lakhs to Rs. 22.51 lakhs in value respectively. Of the 32,463 tons of cotton imported from Africa only 345 tons were re-shipped, the balance being apparently consumed by the Indian mills.

Cotton piecegoods.—The import trade in cotton piecegoods which showed substantial improvement in the previous year, was again adversely affected in the year under report owing to adverse political and economic conditions, despite the reduction in duty on non-British goods. The total imports of foreign cotton piecegoods declined by over 20 per cent, in quantity and by 25 per cent, in value as compared with the figures of the previous year. The competition of Japan remained unabated but the share of the United Kingdom in the total piecegoods trade improved from 46 per cent, to 54 per cent, and that of Japan from 41.2 per cent, to 42 per cent, only.

The total value of imported piecegoods (including fents) fell from Rs. 5.93 crores to Rs. 4.44 crores, coloured goods representing Rs. 2.09 crores, whites Rs. 1.2 crore and greys Rs. 83.93 lakhs. Imports of coloured goods declined by Rs. 74.47 lakhs, of greys by Rs. 33.74 lakhs and of whites by Rs. 28.63 lakhs. Although the total imports of fents declined by Rs. 11.99 lakhs to Rs. 31.92 lakhs owing chiefly to smaller receipts from the United States of America, those from Japan advanced from Rs. 88,000 to Rs. 10.28 lakhs.

Long cloth and shirtings, the principal items under greys, were almost entirely supplied by Japan. Other important items are Jaconets (including madapolams, etc.) and dhuties, saris and scarves the bulk of which was supplied by the United Kingdom. The imports of Japanese long cloth and shirtings declined from Rs. 85·37 lakhs to Rs. 61·06 lakhs and those of sheetings from Rs. 7·05 lakhs to Rs. 2·19 lakhs. The share of Japan in greys further declined from 80 per cent. to 76 per cent., while that of the United Kingdom further improved from 19 per cent. to 23 per cent.

Of the total imports of whites, arrivals from the United Kingdom represented 61 per cent. as against 51 per cent. in the previous year. Of the principal varieties, imports of long cloths and shirtings chiefly from Japan and the United Kingdom declined from Rs. 54·65 lakhs to Rs. 41·32 lakhs. The other principal varieties, viz., mulls, drills and jeans and twills came principally from the United Kingdom and nainsooks from Japan. Supplies of jaconets and madapolams from Switzerland fell from Rs. 7·72 lakhs to Rs. 33,0000 only but those from the United Kingdom rose from Rs. 7·41 lakhs to Rs. 10·21 lakhs.

Of the total imports of coloured piecegoods valued at Rs. 2.09 crores, the United Kingdom was responsible for Rs. 1.36 crore and Japan for Rs. 70.24 lakhs.

The total imports of foreign cotton yarn dropped 'rom 174 million lb. to 91 million lb. in quantity and from Rs. 1.65 crore to Rs. 86.82 lakhs in value owing chiefly to the reduced consumption of foreign yarns and to the increased output of cotton yarns by the Indian mills themselves in preference to imports of foreign yarus. The figures under "Other countries" represent almost entirely the imports from China. Arrivals of two-fold yarns from Japan decreased from nearly 81 million lb. to 42 million lb. in quantity and from Rs. 93.74 lakhs to Rs. 46-45 lakhs in value while those from the United Kingdom from nearly 21 million lb. to 11 million lb. in quantity and from Rs. 26.02 lakks to Rs. 15.07 lakhs in value. Receipts of yarns of higher counts from Japan declined from 12 million lb. to 104,000 lb, in quantity and from Rs. 10.27 lakhs to Rs. 67,000 only in value while those from the United Kingdom from nearly 3 million lb. to 1 million lb. in quantity and from Rs. 6.39 lakhs to Rs. 5.48 lakhs in value. Imports of mercerised cotton yarn, almost entirely from Japan, also fell from nearly 62 million lb. to over 31 million lb. in quantity and from Rs. 79.99 lakhs to Rs. 37.95 lakhs in value. In the table given below the production of yarn in the Bombay Presidency is compared with the imports from foreign countries. The percentage of the production of the mills in the Bombay Presidency of lower counts fell from 84 per cent. to 83.5 per cent. while that of higher counts remained the same. Imports of cotton yarn of lower counts also declined from 620,000 lb. to 172,000 lb. in quantity and from Rs. 3.15 lakhs to Rs. 1.03 lakh in value due entirely to smaller receipts from Japan.

D. Silk, raw and manufactured.—Imports of raw silk declined from 2,310,000 lb. to 1,653,000 lb. in quantity and from Rs. 82.96 lakhs to Rs. 48.79 lakhs in value owing to depressed trade conditions and fluctuations in exchange, Receipts from China fell from 1,683,000 lb. to 1,169,000 lb. in quantity and from Rs. 62.38 lakhs to Rs. 36.16 lakhs in value and those from Hongkong from 366,000 lb. to 303,000 lb. in quantity and from Rs. 13.73 lakhs to Rs. 8.39 lakhs in value. Imports of silk yarn, noils and warps also declined from 2,582,000 lb. to 1,627,000 lb. in quantity and from Rs. 75.04 lakhs to Rs. 37.66 lakhs in value. All the principal supplying countries shared in this decline except China and the United Kingdom. On the other hand, the trade in piecegoods of silk and silk mixtures showed a notable improvement. As regards silk piecegoods the rise was from nearly 30 million yards to nearly 36½ million yards in quantity and from Rs. 1.52 crore to Rs. 1.6 crore in value. Despatches from Japan alone rose from over 21½ million yards to nearly 30 million yards in quantity and from Rs. 1.12 crore to Rs. 1.29 crore in value and those from Hongkong from 96,000

yards valued at Rs. 79,000 to over \(\frac{3}{4} \) million yards valued at Rs. 3.3 lakhs. Shipments from China however declined from 7\(\frac{3}{4} \) million yards to nearly 5\(\frac{1}{4} \) million yards in quantity and from Rs. 38.04 lakhs to Rs. 26.24 lakhs in value. As regards silk mixtures, the rise was from 4\(\frac{3}{4} \) million yards to over 7 million yards in quantity and from Rs. 27.37 lakhs to Rs. 42.58 lakhs in value; this was shared by all the principal supplying countries except Italy, the United Kingdom and Germany.

E. Artificial silk.—Imports of artificial silk yarn declined from over 61 million lb. to nearly 6 million lb. in quantity and from Rs. 53.63 lakhs to Rs. 51 lakhs in value possibly owing to the limited production of rayon. Arrivals from Italy—the chief supplier—amounted to nearly 3 million lb. valued at Rs. 26.49 lakhs as against over 31 million lb. valued at Rs. 31.46 lakhs in the previous year. Receipts from the United Kingdom and France, on the other hand, improved and those from Japan were almost the same as in the previous year. Imports of piecegoods made entirely of artificial silk all from Japan decreased from 80 million yd. to 31 million yd. in quantity and from Rs. 1.85 crore to Rs. 86.68 lakhs in value. This considerable decrease is attributable to the heavy duty and to diversion of trade. A notable feature of this trade is the replacement in the bazar of the cheaper qualities of pure art silk by art silk and cotton, the competition of the latter being facilitated both by price and duty considerations. Imports of piecegoods made of cotton and artificial silk advanced from 63 million yd. to over 12 million yd. in quantity and from Rs. 30-21 lakhs to Rs. 44.74 lakhs in value; increased shipments from Japan accounted for 51 million yd. valued at Rs. 14.07 lakhs as against 11 million yd. valued at Rs. 3.29 lakhs in the previous year. Imports of piecegoods made of cotton embroidered or super-imposed with art silk which are included under the head piecegoods made of cotton and art silk amounted to nearly 3 million yards valued at Rs. 13.68 lakhs and were received from Switzerland, Austria and Italy.

F. Wool, raw and manufactured.—Imports of raw wool declined by over 11 million lb. in quantity and by Rs. 5.78 lakhs in value compared with the previous year owing mainly to smaller receipts from all the supplying countries. Supplies from Persia fell from 11 million lb. to 633,000 lb. in quantity and from Rs. 2.97 lakhs to Rs. 1.48 lakh in value. Arrivals from the United Kingdom also slightly declined and those from Australia and Iraq amounted to 434,000 lb. and 2,576 lb. valued at Rs. 2.83 lakhs and Rs. 1,000 only respectively as against 690,000 lb. and 397,000 lb. valued at Rs. 4.61 lakhs and Rs. 1.2 lakh respectively. Imports of yarn and knitting wool showed an increase from 467,000 lb. to 534,000 lb. in quantity and from Rs. 6.2 lakhs to Rs. 7.48 lakhs in value, reduced supplies of knitting wool from France, the United Kingdom and Germany being more than counter-balanced by larger shipments of worsted yarn for weaving from the United Kingdom and Japan receipts of which from the latter amounted to 225,000 lb. valued at Rs. 3.25 lakhs against 2,000 lb. valued at Rs. 2,166 in the previous year. Arrivals of woollen piecegoods, the most important item in the group, further advanced from 33 million yards valued at Rs. 58.23 lakhs to over 4 million yards valued at Rs. 62.17 lakhs representing larger receipts from the United Kingdom, Japan and Germany. Imports from the United Kingdom further rose from 11 million yards to over 11 million yards and from Japan from 586,000 yards to 788,000 yards in quantity and from Rs. 26·14 lakhs to Rs. 33·4 lakhs and from Rs. 4·46 lakhs to Rs. 6·36 lakhs in value respectively. Shipments from Germany though increased by 31,536 yards to 227,592 yards in quantity fell by Rs. 38,000 to Rs. 3·63 lakhs in value. The share of the United Kingdom, the principal supplier, in the total import of piecegoods improved from 45 per cent. Of the other manufactures of wool, imports of blankets mainly from Italy, shawls from Germany and the United Kingdom and hosiery from Japan increased while those of carpets and rugs showed a falling off owing entirely to smaller receipts from Persia.

33. The entrepôt trade of Bombay which had been continuously declining since 1927-28 improved during the year under report and amounted to Rs. 2.16 crores as against Rs. 1.97 crore in the previous year. The increase of Rs. 19 lakhs is mainly due to larger re-shipments of metals and ores, cotton manufactures, cotton raw and silk manufactures. Re-exports of metals and ores advanced from Rs. 9.69 lakhs to Rs. 17 lakhs in consequence of increased demands from Japan and Italy particularly for scrap iron for remanufacture. Reshipments of cotton manufactures further rose from Rs. 46.25 lakhs to Rs. 51-41 lakhs representing increased re-exports of coloured piecegoods to Persia, of white to Persia and Iraq and of grey to Aden and Dependencies, Ceylon and Muskat Territory. Reshipments of cotton grey piecegoods to Iraq fell from 3 million to nearly 13 million yards in quantity and from Rs. 6.89 lakhs to Rs. 3.52 lakhs in value. Smaller demand from the United Kingdom and the United States of America is chiefly responsible for the fall of Rs. 7.62 lakhs in the re-exports of hides and skins. Re-exports of cotton twist and yarn also fell by Rs. 5.51 lakhs to Rs. 4.11 lakhs due to lesser demand from Persia and those of wool manufactures by Rs. 3.56 lakhs to Rs. 4.7 lakhs as a result of reduced demand for carpets and rugs from the United Kingdom.

- 35. Exports of Indian produce and manufactures which were continuously declining for the last four years improved from Rs. 23·17 crores to Rs. 27·34 crores during the year under review. This increase is chiefly spread over cotton, raw, seeds, wool raw, hides and skins, raw and tanned, metals and ores, myrabolans, etc., which represent nearly 77 per cent. of the total export trade. Owing to the depression in the Textile Mill Industry in Bombay and Ahmedabad there was more shipment of raw cotton. There was an increase in the export of seeds, specially of linseed to America. Larger shipments to the United Kingdom account for the increase of Rs. 5·49 lakhs under myrabolans. Exports of oil cakes declined in consequence of smaller demand for groundnut cakes from Germany and for linseed cakes from Belgium, the Netherlands, the United Kingdom and Germany. The fall in the exports of spices is accounted for by lesser demand for ginger, cardamoms, and pepper from almost all the principal buying countries.
- 36. Grain, pulse and flour.—Wheat, wheat-flour, jawar and bajra, pulse and rice are the most important items under this head. Exports of jawar and bajra declined by 7,615 tons to 4.940 tons in quantity and by Rs. 6.39 lakhs to Rs. 4.7 laklis in value owing mainly to the complete cessation of shipments to Germany and the Netherlands which took 5,679 tons valued at Rs. 4.56 lakhs and 1,566 tons valued at Rs. $1\cdot 14$ lakh respectively in the previous year. Exports of wheat flour also fell further from 6,393 tons to 5,626 tons in quantity and from Rs. 12-12 lakhs to Rs. 9-23 lakhs in value as a result of smaller despatches to all the principal consuming countries except "Other Native States" in Arabia whose takings rose from 903 tons to 1,295 tons in quantity and from Rs. 1.47 lakh to Rs. 2 lakhs in value. Exports of pulse on the other hand further increased from 12,341 tons to 16,736 tons in quantity and from Rs. 21-39 lakhs to Rs. 25.03 lakhs in value, due chiefly to larger shipments of lentils to the United Kingdom and Ceylon and of other sorts to Ceylon. Exports of rice, though increased in quantity by 843 tons to 12,680 tons owing mainly to better demand from Bahrem Islands, Muskat Territory and Other Native States. in Arabia, fell in value by Rs. 2.08 lakhs to Rs. 18.11 lakhs.
- 37. Hides and skins (raw and tanned).—There was a better demand from all the principal buying centres and exports under this head consequently improved from 2,790 tons to 5,075 tons in quantity and from Rs. 43·1 lakhs to Rs. 68·3 lakhs in value. Exports of raw hides rose by 427 tons to 900 tons in quantity and by Rs. 2·14 lakhs to Rs. 4·66 lakhs in value owing mainly to larger supplies to the Netherlands. The increase of 1,456 tons in quantity and of Rs. 15·1 lakhs in value under raw skins is due chiefly to larger despatches to the United States of America which took 2,041 tons valued at Rs. 21·07 lakhs as against 1,268 tons valued at Rs. 11·84 lakhs in the previous year. The United Kingdom and France also took 461 tons and 198 tons more in quantity and Rs. 3·82 lakhs and Rs. 1·36 lakh more in value respectively. Exports of tenned or dressed hides and skins advanced from 568 tons to 947 tons in quantity and from Rs. 21·72 lakhs to Rs. 29·74 lakhs in value almost entirely due to larger shipments to the United Kingdom.
- 38. Metals and Ores.—The principal item under this head is manganese ore. Exports of this ore from the whole of British India rose from 198,000 tons to 266,000 tons in the year under report. Shipments from Madras showed.

a marked improvement and rose from 14,000 tons to 71,000 tons while those from Bombay advanced from 46,000 tons to 61,000 tons. The improvement in the shipments from Bombay entirely represents larger offtake by the United Kingdom which took 29,000 tons as against 9,000 tons in the previous year. Shipments to Belgium and Germany also increased from 2,500 tons to 4,700 tons and from 1,200 tons to 2,600 tons respectively. On the other hand, France took only 25,000 tons against 33,000 tons in the previous year.

39. Seeds.—Oil seeds rank next in importance to raw cotton in the export trade of Bombay. Shipments of seeds improved from 181,000 tons to 347,000 tons in quantity and from Rs. 3.07 crores to Rs. 4.6 crores in value owing chiefly to the unusual demand from the United States of America for linseed in consequence of the new Argentine crop being considerably damaged. Exports of linseed rose from 25,000 tons to 185,000 tons in quantity and from Rs. 38.87 lakes to Rs. 2.43 crores in value owing mainly to larger shipments to America which took 83,961 tons valued at Rs. 1.09 crore against 200 tons valued at Rs. 24,000 only in the previous year. Demand from the Continental ports except Germany was also good. The United Kingdom took 47,000 tons valued at Rs. 58.8 lakhs as against 320 tons valued at Rs. 75,000 only. Despite heavy consumption in oil producing factories in India exports of sesamum seed also advanced by 4,461 tons in quantity and by Rs. 2.38 lakks in value owing chiefly to increased demand from Italy which took 8,454 tons as against 4,596 tons in the previous year. Shipments of cotton seed also rose by 3,336 tons in quantity and by Rs. 1.86 lakh in value. The United Kingdom took 1,834 tons more than in the previous year. Shipments of groundnuts on the other hand increased by 8,306 tons in quantity due to larger supplies to all the principal buying countries except France and Belgium but the value was lower by Rs. 33.42 lakhs on account of lower prices due to Chinese competition in foreign markets. There was a further falling off of 15,763 tons in quantity and of Rs. 29-84 lakhs in value in the exports of castor seed in consequence of direct shipments from Masulipatam and Cocanada. Rape seed recorded a decrease due partly to smaller demand from all the principal countries and partly to direct shipments from Karachi.

40. Textile.—A.—Cotton Raw.—The Dollar-Sterling Exchange Rate had its effects on the prices of cotton generally and American cotton in particular. In spite of the Japanese boycott the total exports of cotton increased considerably during the year under report as a result of the uncertainty caused by the American policy and the continued depression in the Indian Mill Industry. A large number of the local Textile mills was closed down entirely or worked short time during the year and in consequence consumption of Indian cotton declined. As a result of the acreage reduction scheme in America and the trade agreement with Japan, the future of the cotton export trade is hopeful.

The Liverpool spot quotation for middling American which stood at 5.05d at the end of the last year showed an upward tendency during the first quarter of the year and rose to 6.54d in the first week of July. From the middle of August the quotation began to decline gradually and dropped to 5.06d, the lowest of the year, on 25th November. It soon began to recover and on 17th February reached 6.64d the highest of the year. The quotation stood at 6.5d on 31st March 1934. The price of Indian cotton which was Rs. 175 at the beginning of the year also showed an upward tendency in sympathy with American cotton during the first three months of the year and rose to Rs. 236 on 14th July, the highest of the year. With a gradual decline from the beginning of August, the price came to Rs. 178 by the end of November. It again rose to Rs. 216 on the 9th February, and with a lowering tendency stood at Rs. 193 at the end of the year.

The total exports which showed a considerable decrease during the last two years increased during the year under report from 217,018 tons valued at Rs. 12.57 crores in 1932-33 to 250,350 tons valued at Rs. 14.66 crores. Shipments to Japan declined by 19,845 tons in quantity and by Rs. 1.06 rore in value as a result of the Japanese boycott, but those to all other buying countries showed marked improvement. Stocks in Bombay at the end of March 1934 amounted to 1,073,000 bales as against 788,000 bales at the end of March 1933.

The low purchasing power of the masses who have suffered from successive crop failures coupled with low prices, the continued labour troubles and the Japanese competition owing to the depreciated value of the yen, were the main factors that adversely affected the Textile Industry. The mills in Bombay as well as upcountry on the whole did worse than in the previous year. The future is still uncertain since the effect of the quota system on the Indian mill industry is yet to be properly gauged. During the year the local production of cotton goods showed a decline of 10·2 per cent.

The Persian Gulf and the East African ports are the chief markets for Indian cotton riece-goods. The total shipments during the year further declined by over 53 million yards in quantity and by Rs. 20.64 lakhs in value due mainly to reduced exports of coloured piece goods to the East African ports. Ship ments of coloured piece goods to Iraq and Other Native territories in Arabia also decreased, but those to Persia, Muskat Territory and Trucial Oman and Siam increased. The fall under grey piece goods mainly represents smaller shipments to Portuguese East Africa and Kenya Colony. Exports to other buying countries showed slight improvement.

The price of standard longcloth which was As. 10‡ per lb. at the end of last year declined by a quarter of an anna in May and was quoted at As. 10‡ per lb. in the beginning of August. But at the end of that month the quotation again lowered to As. 10‡ per lb. and remained steady till the end of November. The price again fell to As. 9¾ per lb. in January and with a gradual rise stood at As. 10‡ per lb. at the end of March 1934.

Coloured piece-goods constituted 88.1 per cent. and grey nearly 11.2 per cent. of the total exports trade in cotton piece goods, the changes in which are indicated more clearly in the following table.

On account of the heavy sales effected by Japan who had the advantage of a depreciated currency and the low purchasing power of the people stocks of Indian mill products continued to accumulate. This gave an impetus to the export of cotton yarn. Better demand from Persia, Syria, the United Kingdom and Straits Settlements mainly accounts for the rise. Exports to French Somaliland and Iraq however recorded decreases. On the whole shipments of cotton yarn which showed a decline of nearly 33 per cent. last year recorded during the year under review an increase of 10% over those of the preceding year.

D. Wool Raw.—Although a feeling of uncertainty prevailed in the beginning of the year owing to the abandonment of the Gold Standard by the United States of America, the June auction at Liverpool revealed an encouraging demand for East Indian wool and prices which were sagging lower and lower since 1931 advanced proportionately. The results of the two subsequent auctions were also encouraging owing to the revival of trade in carpets and blankets. Since the close of the December auction wool markets recorded an appreciation in prices and in consequence the total shipments increased from nearly 111 million lb. to nearly 20 million lb. in quantity and from Rs. 46-39 lakhs to Rs. 82.75 lakhs in value representing increased demand from all consuming Exports to the United Kingdom rose from over 91 million lb. valued at Rs. 38.34 lakhs to over 141 million lb. valued at Rs. 58.14 lakhs, and those to Belgium from over a million lb. valued at Rs. 3.96 lakhs to over 21 million Ib. valued at Rs. 9.93 lakhs. Shipments to the United States of America also: increased from nearly 1/2 million lb. to 11/4 million lb. in quantity and from Rs. 1.79 lakh to Rs. 8.28 lakhs in value. France and Germany took double the quantity taken in the previous year.

42. The preceding table indicates in detail the direction of Bombay's trade. A significant feature is that the United Kingdom again regained the principal place which she had yielded to Japan last year, and her share in the total trade increased from 22·19 to 25·67 per cent., while that of Japan decreased from 22·95 to 20·71 per cent. The proportionate share of Continental Europe also improved while that of America declined.

Under imports, the share of the United Kingdom advanced from 25.97 to 31.06 per cent. and the total figure rose from Rs. 14.1 crores to Rs. 14.34 crores owing mainly to larger despatches of sugar machinery, metals iron and steel, rubber manufactures, electrical instruments and machinery, motor cars. woollen piecegoods and beet sugar. Imports of cotton piecegoods and cotton spinning machinery however recorded noticeable decreases. The figures for British Possessions other than the United Kingdom declined, chiefly as a result of smaller arrivals of raw cotton from the Anglo-Egyptian Sudan despite larger despatches of raw cotton from Kenya Colony and of motor cars from Canada. Imports from foreign countries in Europe also fell owing mainly to lesser arrivals of copper and brass from Germany, iron and steel from Belgium and silk and artificial silk yarn from Italy, in spite of increased shipments of sugar machinery from the Netherlands. Under foreign countries in Asia, imports from Japan recorded a noticeable decrease due chiefly to smaller receipts of cotton and artificial silk piecegoods and cotton twist and yarn. Imports from China also fell away on account of lesser despatches of silk raw and silk piecegoods while those from Persia decreased due mainly to smaller supplies of Kerosene and Reduced shipments of sugar are responsible for the fall in imports from Java while smaller despatches of dates mainly account for the decrease in arrivals from Iraq, in spite of larger supplies of pulse from that country. Imports from Africa recorded a decrease owing entirely to reduced shipments of raw cotton from Egypt, despite increased supplies of sugar from Portuguese East Africa, while smaller despatches of cotton, raw and cotton fents are chiefly responsible for the heavy fall in imports from America, in spite of the improvement in the despatches of motor cars, motor omnibuses and cinematographs films.

Under exports, the share of Japan, though that country continues to occupy the first place, declined from 33.77 to 25.27 per cent. and her figure fell from Rs. 8.49 crores to Rs. 7.45 crores which is entirely due to smaller takings, of cotton, raw. The share of the United Kingdom, however, rose from 14.06 to 17.23 per cent. i.e., from Rs. 3.53 crores to Rs. 5.08 crores. This rise is attributable to increased shipments of raw cotton, seeds, raw wool, groundnut cake, hides and skins tanned, manganese ore and myrabollans. Among other countries the proportionate share of Italy, Germany and Belgium increased in consequence of larger takings of raw cotton and seeds though Germany reduced her supplies of groundnuts cake. The share of France, however, declined, the increased shipments of raw cotton having been more than counter-balanced by smaller exports of seeds. The proportionate share of the Netherlands improved owing to increased shipments of seeds and groundnut The share of China also increased on account of larger supplies of raw cotton. Larger shipments of cotton twist and yarn are responsible for the increase in the share of Persia while smaller despatches of cotton coloured piecegoods chiefly accounted for the fall in the share of Iraq. The decline in the share of Africa mainly represents smaller shipments of cotton piece-goods to Portuguese East Africa and cotton twist and yarn to French Somaliland, while the most noticeable rise in that of America represents larger shipments of seeds—especially linseed—and raw wool.

43. Government Transactors (Stores).—The total value of stores imported on Government account increased from Rs. 39.73 lakks to Rs. 45.01 lakks mainly representing larger supplies of machinery and millwork, printing paper, arms, ammunition, etc., and woollen piecegoods. Imports of vehicles and Persian fuel, oils, however recorded decreases. Exports on Government account also improved from Rs. 2.56 lakks to Rs. 4.62 lakks owing chiefly to increased shipments of hardware and instruments, etc.

With a balance of trade in favour of India, viz., Rs. 35 crores as against Rs. 3 crores in the preceding year imports of treasure on private account

further fell from Rs. 1.91 crore to Rs. 1.01 crore. Both gold and silver contributed to this fall. Imports of gold bullion further declined from Rs. 40.19 lakhs to Rs. 33.56 lakhs. Receipts from Bahrein Islands amounted to Rs. 5.94 lakhs as against Rs. 13.61 lakhs while those from Iraq were nil against Rs. 3.21 lakhs in the previous year. Arrivals from the United Kingdom were worth Rs. 4.04 lakks as against nil and those from Zanzibar and Pemba and Aden and Dependencies were valued at Rs. 3.06 lakhs and Rs. 4.23 lakhs against Rs. 1.76 lakh and Rs. 3.21 lakhs respectively during last year. Arrivals of sovereigns and other British gold coins also fell further from Rs. 34.81 lakhs to Rs. 20.99 lakhs owing to smaller receipts from all the sources of import, chiefly the Union of South Africa (Natal), Aden and Dependencies, Bahrein Islands and Zanzibar and Pemba. The slight improvement in the receipts of other coined gold is chiefly brought about by larger despatches from Other Native States in Arabia. Imports of bar silver further decreased from Rs. 27.03 lakhs to Rs. 3.38 lakhs only. This decrease is due in the main to reduced supplies from the United Kingdom which sent worth Rs. 3.22 lakhs as against Rs. 24.25 lakhs in the previous year. Despatches from South Australia and the United States of America were nil as against worth Rs. 1.08 lakh and Rs. 74,000 last year. Arrivals of Government of India rupees also fell from Rs. 82·37 lakhs to Rs. 36·95 lakhs as a result of reduced supplies from all the sources except Other Native States in Arabia. Shipments from Iraq declined by Rs. 41·11 lakhs to Rs. 29·45 lakhs and those from Muscat and Bahrein Islands by Rs. 1.39 lakh and Rs. 1.36 lakh to Rs. 2.43 lakhs and Rs. 72,000 respectively. Receipts from Other Native States in Arabia, on the other hand, increased by Rs. 1.33 lakh to Rs. 3.29 lakhs. Imports of other coins amounted to Rs. 3,000 only as against Rs. 24,000 last year.

Exports of gold on private account amounted to Rs. 53 · 64 crores as against Rs. 60.53 crores in the previous year. Exports of bullion fell by Rs. 5.74 crores to Rs. 52.11 crores. This fall is entirely due to reduced shipments to the United States of America and the Netherlands which took worth Rs. 7.16 crores and Rs. 2 crores as against Rs. 21.17 crores and Rs. 4.22 crores last year. Shipments to the United Kingdom and France, on the other hand, amounted to Rs. 40.54 crores and Rs. 1.87 crore against Rs. 32.24 crores and Rs. 21 · 86 lakhs respectively. Italy also took worth Rs. 54 · 39 lakhs against nil in the previous year. Exports of sovereigns also declined from Rs. 2.66 crores to Rs. 1.53 crore. Shipments to the United Kingdom fell from Rs. 2 crores to Rs. 1.05 crore, to the United States of America from Rs. 42.13 lakhs to Rs. $5 \cdot 1$ lakes and to the Netherlands from Rs. $9 \cdot 06$ lakes to Rs. 5,000 only but those to France rose from Rs. 10.7 lakhs to Rs. 41.91 lakhs. Exports of other coined gold decreased from Rs. 1.78 lakh to Rs. 2,000 only owing almost entirely to smaller shipments to the United Kingdom. Exports of silver declined from Rs. 14.74 lakhs to Rs. 8.82 lakhs. Shipments of bullion amounted to Rs. 2.02 lakhs as against Rs. 6.36 lakhs in the previous year owing entirely to reduced takings by the United Kingdom. Exports of Government of India rupees fell from Rs. 8 · 17 lakhs to Rs. 6 · 7 lakhs representing smaller despatches to Muscat and Bahrein Islands. Shipments to Zanzibar and Pemba however amounted to Rs. 2 lakhs as against nil in the preceding year. There were no

exports of British or Straits dollars as in the previous year while those of other coin recorded a fall from Rs. 21,000 to Rs. 10,000 owing to cessation of shipments to Muscat.

There were no imports or exports of gold on Government account. Imports of silver which amounted to Rs. 57,000 against Rs. 8,000 in the previous year, entirely represent arrivals of Government of India rupees from Aden and Dependencies. Exports amounted to Rs. 4.48 crores against Rs. 1.33 crore. Shipment to the United States of America were valued at Rs. 3 crores as against nil while those to the United Kingdom amounted to Rs. 1.47 crore against Rs. 1.33 crore in the preceding year.

48. Exchange.—The rate of exchange for demand bills on London which was 18 1/32d. at the end of March 1933, remained almost steady till the beginning of September 1933, and declined to 17 15/16d on the 15th of that month. The rate again went up to 18 1/32d. by the end of September; came down to 17 15/16d. by the end of October, and with slight fluctuations fell to 17 25/32d. on 18th November. It then showed a rising tendency, went up to 18 3/32d. on 13th January 1934 and stood at 18 1/16d. at the end of the year.

50. It will be seen from the above table that the average prices of all the principal articles of import except iron and steel, have fallen. The fall is more marked in the case of kerosene oil, silk raw, cotton grey piecegoods, silk piecegoods, copper and brass. With the exception of cotton raw, and wool raw, the export figures also show a noticeable decline especially in the case of til or jinjili seed, castor seed, linseed, grain, pulse and flour and cotton coloured piecegoods.

52. Imports from coast ports into Bombay consist almost entirely of articles of Indian produce which are intended partly for consumption in the Presidency and partly for re-export to foreign countries.

Imports which showed a falling off of over Rs. 23 crores last year improved during the year under report from Rs. 19.29 crores to Rs. 20.12 crores owing entirely to larger arrivals of cotton, raw, and grain, pulse and flour. Imports of raw cotton increased from Rs. 3.69 crores to Rs. 5.53 crores due chiefly to larger shipments from British Ports within the Province, Kathiawar and Madras. Arrivals from Goa however declined. The improvement of Rs. 90.53 lakhs in the imports of grain, pulse and flour almost entirely represents larger arrivals of rice from Burma and wheat from Sind. Imports of kerosene oil, on the other hand, declined by Rs. 3.56 lakhs only but those of petroleum dangerous, etc., fell from Rs. 1.3 crore to Rs. 45.09 lakhs as a result of smaller arrivals from Burma. Imports of jute manufactures also decreased by Rs. 52.79 lakhs to Rs. 35.62 lakhs owing to lesser receipts from Bengal. The fall of Rs. 29.45 lakhs under tea is due to reduced supplies from Bengal and that of Rs. 9.14 lakhs under seeds entirely represents lesser receipts from Kathiawar and Travancore. The fall of Rs. 8-34 lakhs under spices is attributable to reduced shipments from all the sources of supply while that of Rs. 7.37 lakhs under coal is due entirely to reduced shipments from Bengal.

53. Exports from Bombay to coast ports further declined by Rs. 3.09 crores to Rs. 21.95 crores due to reduced shipments of Indian produce, exports of foreign merchandise recording a slight increase. Exports of Indian produce which constituted nearly 80 per cent. of the total export trade contracted by Rs. 3.36 crores to Rs. 17.54 crores due chiefly to smaller shipments of cotton piecegoods, cotton twist and yarn and grain, pulse and flour. Shipments of raw cotton however increased. The fall under cotton piecegoodsis due to a

heavy fall in the shipments to Bengal in spite of larger exports to Burma, Sind, Travancore and Madras. Reduced shipments to all the principal ports except Sind are responsible for the fall under cotton twist and yarn while that under grain, pulse and flour is accounted for by smaller exports of pulse to Madras; rice to British ports within the Province and Kathiawar. Exports of jawar and bajra to Kathiawar and of wheatflour to Burma and Madras recorded increases. Re-exports of foreign merchandise advanced from Rs. 4·13 crores to Rs. 4·41 crores mainly as a result of larger re-shipments of carriages and carts, etc., to all the principal ports, of aniline dyes to Bengal and of machinery to Kathiawar and Madras. Re-exports of cotton piecegoods to Madras and Kathiawar, of cotton twist and yarn to Madras and Sind, of metals and ores to Madras and British ports within the Province, of sugar to Kathiawar and of fruits, dried, salted and preserved to Burma and Bengal, on the other hand, recorded decreases.

SUBORDINATE PORTS OF THE BOMBAY PRESIDENCY.

Foreign Trade.

54. The foreign trade of the subordinate ports, though insignificant, slightly improved. Imports, which consisted of dates from Iraq, raw cashewnuts from Portuguese East Africa and Tanganyika Territory, and rice from French Ind. China and Japan, further increased from Rs. 1,46,574 to Rs. 2,28,487 Exports, mainly representing skinned cashew kernel to the United States of America, also further increased from Rs. 27,180 to Rs. 7,15,577.

Coasting Trade.

55. The total value of the coasting trade of the subordinate ports further rose by Rs. 87.91 lakhs to Rs. 7.69 crores. Imports declined by Rs. 22 lakhs to Rs. 3.34 crores, but exports increased by Rs. 1.1 crore to Rs. 4.35 crores. Over 66 per cent. of the total trade of the subordinate ports is with the Chief Port.—Bombay.
