I have the honour, under instructions from the Chief, to submit the Annual Administration Report of the Miraj Senior State for the Fasali year 1334 ( 1924-25 ) ending 31st May 1925.

#### CHAPTER I.

##### General and Political.

2. The State is divided into three Talukas, Miraj, Laxmeshvar and Modnimb. It has an area of 342 square miles and its population is 82,580; of these 42,284 are males and 40,286 females. The gross revenue of the State is Rs. 4,06,048-9-5 based on the average of five years.

3. The Miraj State pays an annual tribute of Rs. 12,557-13-0 to the British Government.

4. The Chief, Sir Gangadharrao Ganesh Patwardhan, alias Balasaheb. K. C. I. E. is 60 years of age.

5. Shrimant Narayanrao Tatysaheb, the elder son of the Chief has completed his 26th year and his younger brother 23rd year of their respective ages.

Shri. Narayanrao Tatysaheb's son Shri. Madhavrao has completed his 3rd year.

The Chief had been to Mahabaleshwar to pass the summer season as usual whence he returned to Miraj on the 4th June 1925.

6. The Assistant Political Agent S. M. Country paid his annual visit to the Miraj Senior State during the year under report.



## CHAPTER II.

7. Revision Survey of the whole State is being made by the party of surveyers brought from the British Government.

8. The villages belonging to the Sub-Saranjamdars of Kavathe-Guland and Sub-Saranjamdars Shripatrao Moreshvar and Kurlekar remain without survey settlement. They are going to be surveyed with the rest of the villages in the State.

9. The following table gives the particulars as to the waste land in the State:—

11. Takavi advances were made to the extent of Rs. 7,591-3-3 during the year.

12. There were no boundary disputes during the year under report.

13. Out of 203 cases of alienation 116 were disposed of during the year.

14. The Revenue Accounts of the State have been kept after Hope's land Accountant General's forms.

15. There were no variations in the demand and collections. No fresh land taken up in this year for cultivation.

16. No remissions or suspensions are made in the land revenue.

## CHAPTER III.

## Protection.

17. Appendix II gives the laws in force in the State. No new law was introduced during the year under report.

18. There is no military force in the State.

19. The total strength of the police in the State is 232. 224 foot police and 8 Swars against 238 of the last year. Total

expenditure incurred for the maintenance was Rs. 32953-13-11 against 29523-6-9 of the last year. The swars are employed on escorts and miscellaneous duties.

Out of the foot police 60 are armed with smooth bore muskets and the rest with batons only.

20. Appendix IV gives the particulars as to the total strength, cost etc. of the police in the State.

21. The ratio of the police to the population is 1 to '355'9 and that to area is 1 to 1.4 square miles. The number of the village police was 131 against 129 of the last year. The cost was Rs. 2,600-10-11 against Rs. 2,684 -6-1 of the last year.

22. Appendix V will show the working of the police. The average period of an accused person detained in custody before trial was less than 24 hours.

#### Criminal Justice.

23. There is one District Magistrate, two first class, three second class and three third class Magistrates. The State Karbhari is invested with the duties of the District Magistrate, and the Sir Nyayadhish and the Treasury Officer are each of them first class Magistrates. The Mamlatdars and Aval Karkuns are given the powers of second and third class Magistrates respectively.

24. The details of the work done by the several Magistrates will be found in appendix VIII.

25. There were 7 Sessions cases committed to the Chief's Court. One of these cases was transferred to the file of Shrimant Tatysaheb's Court. This case before Shrimant Tatysaheb and two other cases in the Chief's Court i. e. 3 in all are pending at the end of the year while the rest viz. 4 are finally decided.

26. The following table will show the work of the Sessions Court.

## Civil Justice.

29. There are three Sub-ordinate Civil Courts in the State. The Sir Nyayadhish is invested with the powers of a District Judge and the Sub Judges at Laxmeshwar and Modnimb are empowered to try suits up to the value of Rs. 2,000 and 1,000 respectively. The Sir Nyayadhish is also empowered to try summery suits up to the value of Rs. 500.

30. Appendices X and XI show the work done by the three Civil Courts in detail.

The question involved in the two appeals before the State Karbhari, appeal court is to substitute the names of the parties. Some of the old litigants are dead and the names of the heirs are to be substituted in their places. The question, who are the legal heirs of the deceased parties, is being tried by the lower court and when that question is decided then these appeals will be ready for hearing. It can not therefore be said definitely at this stage when they will be ready for hearing.

The Appeal Court presided over by Shrimat Narayanrao Tatyasaheb is doing the same kind of work as reported in the last year's report

34. One offender was surrendered to the British Government during the year under report for trial and none was received by the State from the British Government.

#### Prisons.

35. Besides the central jail at Miraj which is in charge of the medical Officer Miraj, there are two sub-jails, one at Laxmeshwar and the other at Modnimb. They are sufficient for requirement of the State. The details under this head will be found in Appendix XIII.

36. Out of 92 prisoners 5 suffered from fever and other minor diseases.

#### Registration.

37. Appendices XIV and XV give detailed particulars of the Registration Department.

#### Municipal Administration.

38. Appendix XVI shows the receipts and expenditure of the five Municipalities in the State.

### CHAPTER IV.

39. Appendix XVII gives the figures of the rain-fall for all the Talukas in the State, during the year under report. The average yield of crops was annas 7. The rain-fall was less than normal. This accounts for the fall in yield of crop. The scarcity of food supply however was not felt. Water famine was felt this year and is still felt in some villages.

40. The daily wages of skilled and unskilled labourers throughout the State ranged from annas 12 to 1-4-0 and 6 to 10 annas respectively. Appendix XVII will show the prices of staple food grains in the State.

41. Forest. There are no Forests in the State.

42. There is one ginning and pressing factory at Miraj and one ginning factory at Laxmeshwar. The village Malgoau exports a considerable quantity of a bittle nut-leaves. Owing to the scarcity of water this export seems to have decreased to some extent. There is no other trade or manufacture worth the name in the State.

43. Miraj work-shop has been making the same work as in the last year.

44. The expenditure of public works was Rs. 80,004-6-3 against Rs. 8,9,622-1-1 of the last year. Appendix XIX will supply further details regarding public works

45. There are in all eight Post Offices in the State. Miraj Town has a Telegraph Office also.

46. The majority of the State subjects consists of the farmer class. There are no other trades or manufactures worth the name in the State. The condition of the subjects therefore depends upon the nature of each year's season.

47. Appendix XXII compares the receipts and expenditure of the State for the years 1923-24 and 1924-25.

## CHAPTER VI.

50. There are three Charitable Dispensaries in the State. The cost was Rs. 8,842-4-11 against Rs. 10,986-12-10 of the last year.

Dispensaries.

51. The total number of operations during the year was 663 against 635 of the last year.

52. Appendix XXIII shows the amount of medical relief afforded to the sick during the year in all the dispensaries.

53. There was no plague at Miraj or in Miraj Taluka. But Laxmeshwar and some of the villages under that Taluka and three villages in the Modnimb Taluka were affected. The total number of attacks and deaths in the Laxmeshwar Taluka being 439 and 299 respectively, and that in the Modnimb Taluka being 34 and 28 respectively.

Plague.

54. Appendix XXIV shows the number of births and deaths during the year under report.

56. The number of re-vaccination was 155 against 110 of the last year.

57. The expenditure incurred by the State for maintaining this department was Rs 1,323-7-11 against Rs 1,233-10-6 of the last year.

#### CHAPTER VII.

58. The Anglo Vernacular School at Modnimb called Shri. Uma Vidyalaya is making good progress. Appendix XXV will give the particulars regarding the management of the schools.

59. Besides the schools shown in Appendix XXV there are 9 unaided vernacular schools giving instructions to 447 pupils. Thus there were 52 schools providing instructions for 3,690 against 55 schools providing instructions for 3,844 pupils in the last year. 14 boys were sent up for the Vernacular Final Examination this year and 11 were successful. The percentage of pupils to population was therefore 4.4 against 4.6 of the last year.

#### The Miraj High School.

60. At the annual examination of the school 186 boys presented themselves for the examination of whom 77 passed under all heads. The percentage of passed to presented was 41.39. 17 boys were sent up for the Matriculation Examination of whom 4 were successful.

61. The number of attending the Drawing Class was 133 against 145 of last year. 2 boys appeared for the Elementary Art Examination of whom all passed. 4 boys appeared for the Intermediate Grade, of whom all passed.

6. A special Record Officer is appointed to arrange and classify old records in a certain fixed form. This work is not yet finished.

63. There is a Printing Press at Miraj kept at the State expences. It is generally used for printing official forms and other work required by the several departments in the State.

There is one more printing press owned by a private gentleman, which is doing only job work.

64. No change has taken place under this head as it was reported in the Library, last years report.

65. In conclusion, I am desired by the Chief to thank you and the Assistant Political Agent S. M. C. for the kind advice given in the administration of the State from time to time.
