Sir,

I have the honour to submit the Annual Administration Report of the Annuh State for the year 1330 Fasli ending 5th June 1921,

2. The Appendices as per list annexed accompany.

CHAPTER' I.

GENERAL AND POLITICAL,

3. The area of the Aundh State is 501 square miles. For the sake of administrative convenience it is divided into three Talukas and three Thanas. The gross revenue of the State, including alienations, local funds and all other items is Rs. 3,41,828-10-10, which is based on the average of the past five years.

4. The State pays no tribute to the Paramount Power or to any other State.

Census.

5. Government in their Memorandum No. 3612 dated 28th May 1919, Political Department, decided the inclusion of Native States in the British Territory in the Census of 1921. They also fixed the 18th of March 1921 as the date for taking the decennial Census. The work was followed on the same lines as in the British Territory. The final Census was taken on the night of the 18th March 1921 between 7 P. M. and mid-night. The population of the State according to this Census is 64,504 as against 68,995 of the last Census. There is a decrease of 6 5 per cent in the total number which is mainly due to the ravages of Influenza epidemic and partly to migration on account of unfavourable season.

6. The Census work was carried on smoothly owing to the co-operation of the official and non-official staff. There was no interference in consequence of the non-co-operation movement in the State. All the persons connected with the work did it cheerfully and satisfactorily. I acknowledge the services of all these persons.

7. The Enumeration books with circle summaries have been sent to the Deputy Superintendent of Census Abstraction office, Sholapur, according to the instructions received from you.

Family.

6. L

8. My name is Bhawanrao Shriniwasrao alias Balasaheb Pandit Pratinidhi. My age is 52 years. I am a Deshastha Yajurvedi Brahman by caste. I am a graduate (B. A.) of the Bombay University, a Treaty Chief and a First Class Sardar.

9. I am married to the Rode family of Poona. My wife's name is Shrimati Sowbhagyawati Ramabaisaheb alias Maisaheb.

10. I have got three sons and one daughter. The eldest son is 28 years old. His name is Trimbakrao alias Rajesaheb. The second son is 8 years old. His name is Parashuramrao alias Appasaheb. He is learning Marathi V standard and English II standard. The third son is 4 years old and is called Bhayasaheb. My youngest daughter is named Wasantikabai alias Taisaheb. She is running her second year.

11. Rajesaheb is a double graduate (B. A., L. L. B.) of the Bombay

University. He is married to the Pandit family of Nagpur. His wife's name is Shrimati Sowbhagyawati Parvatibaisaheb alias Wahinisaheb. She has got two daughters and one son. The eldest daughter by name Krishnabai alias Akasaheb is 6 years old. The son is about two years old. He is not named as yet. The youngest daughter who is born in England is now running her sixth month. She is named Mainataisaheb.

12. Rajesaheb, who has gone to England in June 1920 for prosecuting further studies and getting insight into the Western arts, industries and economics, is progressing very well. He had the honour of being presented to His Gracious Majesty the King-Emperer. He had also the honour of being present as an official guest at the unveiling and dedicating ceremony by His Royal Highness the Prince of Wales of the Chhatri erected at Brighton over the ashes of the gallant Indian soldiers who lost their lives after wounds received during the first shock of war in Flanders. He was introduced to His Royal Highness who honoured him by shaking hands with him.

13. Rajesaheb has been attending the lectures at the London School of Economics and at the Middle Temple. He has taken lessons in riding also. He has become a member of the National Club and has been in touch with the higher circle in London. He had the pleasure of interviews with Mr. Montague, the Secretary of State for India, Lord Sydenham, Lord Sinha, Sir Sankaran Nair and several other high personalities. He is going to stay in England for one year more and I hope his stay would be of immense good to him and eventually to the State. Rajesaheb's wife is also taking lessons in English painting and needle work. His eldest daughter is regularly attending a school and is progressing very well.

14. During the year of report, the important domestic event was the death of my grand-son (Rajesaheb's son) Shrimant Bhutesaheb who was three years old. He died of Diphtheria. The best medical help was availed of but to no purpose. When Rajesaheb went to England he left with me his two sons, the elder of whom died.

15. My nephew Shriniwasrao alias Annasaheb, son of my deceased brother Shrimant Tatyasaheb is living with me. He is 15 years old and getting his education in the High School at Aundh in the English 6th standard. His health and progress are good.

Political.

16. During the year of report the most important event was the visit of His Excellency Sir George Lloyd, G. C. I. E., D. S. O., Governor of Bombay, to Kirloskarwadi near Kundal Road station in this State.

17. On arrival at the Kundal Road station at 8-30 A. M. on 16th July 1920 His Excellency and his staff were received with due honour by you, Mr. Smith, the District Superintendent of Police, Satara, Rao Bahadur Kale M. L. C., Mr. L. K. Kirloskar, the founder of the works and myself. A guard of honour accompanied by the State band was also drawn up for His Excellency's reception.

18. After His Excellency was introduced to my relations and the officers

of the State the party went to the factory. The town and works were gaily de corated with flags and arches to welcome the distinguished visitor. On alightin at the works 'Mr. Kirloskar conducted His 'Excellency through the various de partments of the factory, such as the office, machine shop, 'smithy, 'foundry plough assembling and finishing section, electric power house, printing press & and explained the methods and various operations of the manufacture. 'A plough made in the factory was also kept working in the adjoining field. After inspection of the works, 'His Excellency was shown the housing arrangement for the work men, the co-operative shop of grains, the library, the play-ground and the schoo for the children of employees. His Excellency was pleased with what he saw.

19. 'His Excellency was then taken 'to the Samaj Mandir, a spacious hall where 'Rao Bahadur Kale delivered an address to His Excellency.' He gave a brief history of the foundation and growth of 'the factory, the help which it received from the State at the opportune time, the facilities accorded 'by the M. & S. M. Railway Company and concluded with an expression of 'hearty thanks for the visit of His Excellency and with a request that His Excellency and his Government would extend the same sympathy and patronage to this industry as they have been according in the past.

20. His Excellency then gave a reply befitting the occasion and observed that his Government made a mistake in allowing a person like Mr. Kirloskar to go out of Belgaum but was glad that the State had profited thereby. His Excellency told that everywhere people were insisting on him to provide industrial education which he would only be too glad to do, if people take upon themselves to provide men like Kirloskar.

21. His Excellency also highly applauded Mr. Kirloskar for his enterprise, perseverance and indomitable courage and offered a few remarks to him by way of suggestion as to how Mr. Kirloskar should prepare to meet the future American competition and also added some hints about the housing system. He said that he was greatly interested with the model village and declared that he had not seen anything like it so far in the Western India. In concluding 'His Excellency assured that he and his Government would always he pleased to help Mr. Kirloskar.

22. I then thanked His Excellency for his kind visit and added that I would very soon have an opportunity of requesting His Excellency to open an industrial school at Aundh,

23. Mr. Kirloskar then treated his honourable guest to a light refreshment and the party drove back to the station at 10-30 A. M. amidst loud cheers. His Excellency's visit had attracted a crowd of more than 5000 people from the surrounding villages.

24. During the year of report, I had the pleasure of interviews with His Excellency the Governor, the Honourable members of Council, the Commission. er C. D., the Agent for Sardars in the Deccan and the Director of Public Instruction. I had also the pleasure of attending the "At Home" party given by His Excellency the Governor in the month of July last.

25. I had also the pleasure of several interviews with you at Satara in the months of June, July, August and November last. While I was in Satara in the month of July last I paid official visits to the District Judge, Satara and to you and also received return visits from you both.

In the month of July last I had an invitation to attend the Darbar 26, for the Sardars in the Deccan held by His Excellency the Governor at Poona. I went to Poona and attended it.

27. In the month of October last I had the pleasure to attend the Deccan Gymkhana Tournaments, held under the patronage of His Excellency the Governor, and to work there as an umpire.

In the month of December last I had the pleasure of being invited 28. by Mr. Solomon, the Principal of the Sir J. J. School of Art, Bombay for the prize distribution and the unveiling the mural painting entitled "The Recrowning of India" at the hands of Their Excellencies the Governor and the Honourable Lady Lloyd. A vote of thanks to Their Excellencies was proposed by me on the occasion.

29. In the month of February last, I was invited to be present in Bombay on the occasion of the arrival of His Royal Highness the Duke of Connaught. I went to Bombay and attended all the functions pertaining to His. Royal Highness's visit such as the inauguration ceremony of the Legislative Council, the review of the St. John Ambulance Brigade, the Boy scouts and the Girl guides, the "At Home" given by His Excellency the Governor, presentation of the address by the Bombay Municipal Corporation and the Garden party given by them and the departure of His Royal Highness.

30. During the year of report Doctor F. W. Thomas, Librarian India Office, London was pleased to visit Aundh in the month of January last. During his stay he saw my library and other rare collections which I possess and was very much pleased with them, He delivered a lecture on his impressions gathered by him in his tour in Southern India which was very interesting and instructive.

31. The distinguished persons who visited Aundh during the year of report were Captain W. E. Gladstone Solomon, Principal Sir J. J. School of Art, Bombay, Mr. A. Audy, Manager, Government Photozinco Office, Poona, Mr. R. Honner, Superintendent of the Excise Department, Mr. I. W. Bond of the Foreign and Colonial Publishing Co., Doctor Vail of the Miraj Mission Hospital, Mr. A. C. Miller M. A., officer on special duty for the Boyscout organization of the Bombay Presidency and Shri Gangadhar Swami of Chaphal.

32. During the year of report Government in their Resolution No. 9029 dated 3rd December 1920, Political Department, received with your No. M. S. C./ 633 dated 17th idem, were pleased to confer on me as well as the other Satara Jaghirdars enhanced criminal powers similar to those possessed by the Jaghirdars of the S. M. country,

Tours.

33. During the year under report I made a tour in all the Talukas of the

State for the Jamabandi and inspection work. I also visited some of the villages to see the condition of the people and to ascertain their wants which were attended to as far as possible. I also visited Bombay, Poona and Satara for administrative purposes.

34. Mr. N. V. Goliwadekar, Head Master of the High School was appoint. ed Deputy Educational Inspector, during the year of report and Mr. G. B. Vable B. A. was appointed in his place as Head Master. Mr. G. B. Vable having resigned his post Mr. K. K. Vable B. A. is appointed as the Acting Head Master of the High School. Except this there were no changes in the personnel of high officials.

35. There are no Residency officials in the State.

CHAPTER II.

ADMINISTRATION OF LAND.

Survey.

36. The revenue survey in the Aundh, Kundal and Gundal Talukas and the revision survey in the Kinhi Thana were introduced in the year 1895-96. The revision survey of the Atpadi Taluka was made in the year 1913-14. The terms of settlement are guaranteed for 30 years. The rates of assessment are light and the Ryots pay them with ease.

Waste Land.

37. The total area of the cultivable waste land at the end of the last year was 2123 acres and 14 gunthas. 20 acres and 23 gunthas were thrown out of cultivation this year. The total area of the waste land thus available for cultivation was 2143 acres and 37 gunthas. Out of this 47 acres and 23 gunthas were taken up for cultivation this year. The net area of cultivable waste land at the end of the year was 2096 acres and 14 gunthas. The area lying waste was smaller than the last year which was due to larger area being taken up for cultivation.

Alienations.

38. There were no alienations.

Boundary Disputes.

39. There were no boundary disputes.

Takavi.

40. As there was scarcity last year there was a great demand for Takavi-While I was on tour I ascertained the needs of the people and a sum of Rs. 23,985 was distributed among the agriculturists for digging new wells, excavating old ones, erecting Tals and for other agricultural purposes.

Demand, Collection, Remissions and Suspensions.

41. In para 33 of the last year's Administration Report the total demand was shown as Rs. 2,77,481-I4-3 which included the items of Land revenue, Sayar revenue and Local Funds. From the 3rd para of your remarks on this report it appears that the demand of actual Land revenue is required to be shown and it has been done so now.

42. The total demand of Land revenue for the year including the arrears was Rs. 2,35,702-1-2 as against Rs. 2,15,253-8-11 last year. The increase was due to sale proceeds of the occupancy rights of some of the lands belonging to the State. Out of the demand Rs. 2,11,26I-10-6 were recovered as against Rupees 2,02,407-I-5 in the previous year, leaving arrears of Rs. 24,440-6-8 at the close of the year. Out of this amount Rs. 5,05I-I-0 were the arrears of the past years and Rs. 19,389-5-8 were for the year under report. As the season was bad postponement was granted in the deserving cases which accounts for the large outstanding arrears at the end of the year.

43. No remissions or suspensions were granted. In order to mitigate the severity of scarcity the War Loan money which the Ryots had paid was refunded to them to a large extent which amounted to Rs. 1,16,55I-9-11. This measure together with the liberal amount of Takavi distributed and the postponement granted gave much relief to the people.

44. The total land under cultivation in the State was 2,84,067 acres and 30 gunthas. Out of this 2,81,971 acres and 16 gunthas were brought under cultivation.

OHAPTER III.

PROTECTION.

Legislation.

45. The laws and regulations in force in the State are given in Appendix No. II. No new laws were introduced during the year of report.

Military Force.

46. There is no military force in the State. Appendix No. III is, there. fore, blank.

Police.

47. The details regarding the strength, discipline, education and cost of the police, both mounted and unmounted are given in Appendix No. IV. The number of police is 65 as against the same number last year. Out of the force only 16 are armed with breech-loading guns and the rest with 16 muzzle-loading guns, 39 swords and 5 lances. The ratio of the police force to area is 1 to 8 miles and that to population is 1 to 992 souls. The number of police able to read and write is 44 and 21 are under instruction. All the police are trained in drill.

48. The conduct of the whole police force was good. Seven men were suspended for neglect of duty and 11 were rewarded with money,

49. Besides the regular police force there are 76 sundry armed men called Shibandi against the same number in the previous year. They are instructed in drill and are employed in guarding my palace, the treasuries and jails and are also used for escorts.

50. As remarked by you on the last year's Administration Report, I have increased the salaries of the whole police force as much as the finances of the State could permit. There is now not a single constable who gets less than Rs. 10 as his monthly pay. The cost of the Police and Shibandi is Rs 23,201-14-2 against Rs. 17,945-14-9 in the previous year.

51. The work of the Police was on the whole satisfactory as will be seen from Appendix No. V. During the year there was no serious offence such as murder or dacoity and crime was much on the decrease. The number of offences which the police had to deal with was 56 as against 73 in the previous year. The number of persons arrested and sent for trial was 106 and 103 as against 133 and 134 respectively last year. The percentage of convictions to the number of accused arrested and sent for trial was 821 and 84.5 as against 69.3 and 65.5 respectively in the previous year.

52. Appendix No. VI shows the value of the property stolen and that of recovered during the year of report which was Rs. 8,278-3.6 and 2,668-3.6 as against Rs. 5,979-10-0 and 2,565-2-6 respectively in the previous year. The percentage of property recovered was 32 2 as against 42 8 last year.

The village police.

53. The village police consist of police patels and watchmen who are all watandars. They perform the duties enjoined by the Village Police Act. No police patels are invested with powers under the Village Police Act VIII of 1867. The conduct of the village police was on the whole good except two police patels who were suspended for neglect of duty,

Accidental deaths.

54. The number of accidental deaths during the year was 22 as against 21 last year. Of these 10 were from drowning in wells and river, 2 from lightning, 2 from snake-bite, 3 from fall from the trees, 1 from committing suicide and 4 from other causes.

Criminal Justice.

55. The work of the various criminal courts in the State will be seen from Appendices Nos. V11 and V111. The Huzur Criminal Court, presided over by myself is the chief Criminal Court and ordinarily exercises High Court criminal powers. The Karbhari exercises the powers of the District Magistrate, 56. During the year all the courts had to dispose of 96 cases as against 114 in the previous year. Of these 93 were disposed of, leaving 3 at the close of the year. The total number of persons dealt with was 206 as against 240 last year. Of these 132 were convicted, 65 were acquitted or discharged, 2 died before or during trial and 7 remained awaiting trial at the close of the year. The percentage of convictions to the number of persons brought to trial was 64.8 as against 59.5 last year.

57. The Village Panchayat Courts have been established in 28 villages of the State. They are invested with civil and criminal powers in petty cases. They are also entrusted with the work of supervising schools, sanitation, water supply etc. subject to my general control. In civil and criminal matters the Panchayat courts exercise powers according to the regulations framed for their guidance.

58. The Village Panchayats as criminal courts had to dispose of 42 cases as against 47 in the previous year. Of these 36 were disposed of, leaving 6 at the close of the year. The total number of persons dealt with by the Panchayat courts was 79. Of these 6 were convicted, 6 were discharged of acquitted, 60 were let off on compromise and 7 remained awaiting trial at the close of the year. The work of these courts is detailed in Appendices Nos. VII-A and VIII-A. The work of the Panchayat courts was, on the whole, satisfactory.

Criminal Appellate Work.

59. The work done by the Criminal Appellate Courts is shown in Appendix No. 1X. The Huzur Appellate Court had to dispose of 22 appeals. In 10 appeals the decisions of the Lower Courts were confirmed, in 3 they were reversed, in 4 they were modified and 5 remained pending at the close of the year. The District Magistrate had to dispose of 4 appeals. In one the decision of the Lower Court was confirmed, in one it was reversed, in one further enquiry was ordered and one remained pending at the close of the year.

Civil Justice.

60. There are four civil original Courts in the State. Appendices Nos. X and XI will show the work done by them. The total number of suits for disposal including the balance was 414 as against 352 last year. Of these 285 were disposed of, leaving 129 undisposed at the close of the year as against 214 and 138 respectively last year. The average duration of suits was 2 months and 9 days as against 3 months and 7 days in the previous year. The value of suits filed was Rs. 49,552-6-10 and that of disposed of was Rs. 41,605-2-0. The comparing figures for the last year were Rs. 45,761-14-4 and Rs. 41,327-5-4. The number and value of landed property and money suits was 235 and Rs. 38,718-1-1 as against 188 and Rs. 42,176-0-7 last year.

Execution Work.

61. Appendix No. XI shows the work of execution of decrees by the various courts. There were 536 applications including the balance for disposal as against 522 in the previous year. Of these 331 were disposed of against 322 leaving a balance of 205 against 200 last year. Of the applications that remained

over, 78 were below six months, 75 were below 12 months and 52 were above 12 months. Owing to unfavourable season orders were issued to suspend the execution work in the deserving cases according to the discretion of the courts.

Civil Work of the Village Panchayat Courts.

62. The Panchayat Courts are invested with civil powers to decide money suits only up to Rs. 100. The execution of the decrees made by these courts is done by the Subordinate Judges' courts.

63. Appendix No. X-A shows the work done by the Panchayat Courts. They had to dispose of 95 suits including the balance as against 61 last year. Of these 67 were disposed of, leaving 28 undisposed of as against 25 and 36 respectively at the close of the year. The value of suits filed and disposed of was Rs. 2,908-6-2 and 2,647-10-2 as against Rs. 1,938-2-10 and 1,093-6-10 respectively in the previous year. The average duration of suits was one month and 21 days as against 3 months and 3 days in the last year. The work of the Panchayat courts was this year done more promptly than the last year. There was no appeal against the decisions of the Panchayat courts which is very creditable to them. It thus appears that these courts are becoming popular and are hence working satisfactorily.

Civil Appellate Work.

64. Appendix No. XII shows the work done by the Appellate Courts. The Special Appellate Court had to dispose of 16 appeals of which 13 were disposed of. The District Judge had to dispose of 88 appeals of which 42 were disposed of. The average duration of appeals in the Special Appellate Court was one month as against one month and three days and that in the District Judge's court two months as against two months and 15 days.

The Mamlatdars' Courts Act.

65. There were 10 suits including the balance of one of the past year for disposal under this Act. All of them were disposed of. There were no applications for revision against the decisions of the Mamlatdars.

Extradition.

66. Applications were made for the surrender of 35 persons from the British Territory and Native States. All of them were ordered to be surrendered. Four accused persons from the State were arrested and taken away into the British Territory for trial. There was no want of reciprocity in the surrender of accused persons.

Prisons.

67. The Huzur Jail is at Aundh. There are besides 4 lock-ups at the Taluka stations which are in charge of the Mamlatdars. The jail building at Aundh is spacious and well-ventilated. The total number of prisoners in the Huzur Jail as well as in the lock-ups at the close of the year was 46 and 12 re-

spectively as detailed in Appendix No. XIII. The health and conduct of the prisoners was good. The Medical Officer at Aundh superintends the Huzur Jail. One under-trial female prisoner in the Huzur Jail at Aundh committed suicide by strangulation. The prisoners are generally employed on printing press, sardens and other miscellaneous work. The cost of the Jail Department was Rs. 6,022—14-7 against Rs. 3,236-14-9 in the previous year.

Registration.

68. Appendices Nos. XIV and XV give particulars of the work done by the Registration Department. The number and value of documents presented for registration were 964 and Rs. 4,30,800-1-3 as against 654 and Rs. 2,43,599-9-11 respectively last year. The fees realized were Rs. 2,486-3-3 as against Rs. 1,778-4-0 last year. The increase both in the number of documents and the fees realized is due to unfavourable season and to the Circular orders issued by me regarding the compulsory registration of different instruments with consideration of Rupees less than one hundred executed on the same date and with respect to one and the same property in order to avoid the registration fees. There was no appeal to the District Registrar under the Act during the year of report.

Municipalities.

69. There are three Municipalities in the State viz. at Aundh, Kundal and Atpadi. Appendix No. XVI shows the receipts and expenditure of these institutions. The income was Rs. 2,798-8-9 as against Rs. 2,505-11-9 and the expenditure was Rs. 2,671-1-10 as against Rs. 2,395-6-3. The income is also supplemented from State funds. The chief items of income are house-tax, cattlepound-cess and wheel-tax. The items of expenditure are sanitation, lighting, water-supply and road repairs.

70. The Municipalities have been invested with powers to elect their president, vice-president and members. Although the institutions are small the members work with zeal and interest which is very creditable to them.

CHAPTER IV.

PRODUCTION AND DISTRIBUTION.

Rainfall and Crops.

71. Rainfall was, on the whole, insufficient and ill-distributed throughout the State during the year as will be seen from Appendix No XV11. The rain for Khariff sowing was fairly adequate except in the Atpadi and Gundal Talukas, but it held out afterwards in almost all the parts of the State except at Kinhi which resulted in a very poor harvest. As for the Rabi crops the rain was fairly sufficient and seasonable at the beginning but owing to the scarcity of it afterwards the crops suffered heavily except at Kinhi and at those parts where there was well or canal water available for irrigation. The out-turn of both Khariff and Rabi crops varied from annas 4 to 8. The irrigated crops did fairly well. Area under groundnut, linseed and wheat decreased on account of the insufficiency of rain. Cultivation of sugarcane increased owing to the better supply of water this year at the time of planting. Area under cotton also increased owing to the adequate rainfall at the sowing season and partly due to the uncultivated Khariff area being brought under cotton cultivation. The supply of water for drinking and irrigation was adequate at the beginning, but it began to run short afterwards. The season was, on the whole, unfavourable and one of scarcity.

Locusts.

72. The State was free from the visit of locusts during the year.

Wages and Labour.

73. The rates of wages and labour practically remained the same as those of the last year on account of the unfavourable season. The rates of skilled labour varied from Rupee one to Rupees one and a half while those of unskilled labour ranged from annas 6 to 8. The rate of cart hire was also the same as that of the last year i. e. from Rs. 2 to Rs. 2-8 per day.

74. Appendix No. XVIII shows the rates of food-grains. It will be seen that the prices of Jowari and Bajri rose up while those of wheat and Tur pulse-fell down.

Forest.

75. There is no separate establishment for this Department. The Taluka Officers do the supervision work. The forest chiefly consists of rocky hills and unarable lands which are sold for grazing every year. The area of the land set apart as forest was 3,248 acres. No new land was reserved during the year.

Trade and Manufacture.

76. There are, of course, very little prospects of trade increasing in the State on account of its isolated nature. Rice, sugar, salt,, spices, coceanuts, stationery, kerosene oil, piece goods, yarn, timber, tiles, stones, metal-pots, bangles, coke, coal, raw materials for making glass, soda, cast-iron, pig-iron, chemical apparatus, photographic materials etc. are the chief imports.

77. The principal exports are wheat, gram, Jowari, Bajri, groundnut, turmeric, jaggery, cotton, linseed, safflower seed, wool, khadi, camblis, cattle, tanned leather, hides, iron agricultural implements, iron decorative railings, glass chimneys, globes, bangle glass and coregum.

78. Out of the exports coregum is sold on a very small scale as there is not much demand for it. Of the imports coke, coal, raw materials etc. are largely consumed by Messrs. Kirloskar Brothers, the Ogale Glass works, the State Laboratory, the Ayurvedic Chemical Pharmacy, the Dispensaries, the electric plant and oil engine.

79. The control system as regards the export of foodstuffs from the State has been maintained as it has been found very beneficial in the interests of the cultivators.

Manufaciure, Aris and Industries.

80. The Iron Factory of Messrs. Kirloskar Brothers which was converted into a Limited Liability company is progressing steadily though the sale of ploughs was much affected on account of the unfavourable season. The factory manufactures iron implements of the improved pattern such as ploughs, hand-hoes mote-wheels, corn-shellers, sugarcane-crushers and drilling machines.

81. The factory had this year the unique honour of being visited by His Excellency the Governor of Bombay who was pleased with the working and other arrangements. The remarks of government servants and other gentlemen both European and Indian of high rank and position who visited the factory are also very satisfactory.

82. The Ogale Glass Works Ltd. at Ogalewadi near Karad station in the Kundal Taluka of this State, are making gradual progress in spite of the difficultjes of coal supply. The factory has been able to double its unit of work and also turns out now pressed ware such as sky-lights or glass roofing tiles, electric shades and dishes artistically designed. By way of improving upon the present methods of manufacture, the Company has bought new machinery for fusing, polishing and cutting chimneys, globes, tumblers etc. The factory was visited by Mr. A. C. Miller M. A., officer on special duty of the Boy-sccut organization, Bombay Presidency who was quite pleased with the slow but steady progress shown by the factory. I had also the pleasure of visiting the factory.

83. The Ayurvedic Chemical Pharmacy of Kinhi is doing useful work under the able management of Dr. G. K. Patankar, whose medicines are finding favour with the public and having a wide sale. Dr. Patankar had the honour of being appointed an examiner at the exhibition held by the All-India Physicians' Conference in Bombay.

84. The Aundh State Laboratory has taken into hand, during the year of report, a series of experiments such as the manufacture of Hydrochloric acid and washing soda from salt, calomel, bar, toilet and transparent soaps from pure castor, arachis and karanj (pongamia glabra) oils.

85. Mr. M. S. Mulay M. A., State chemist worked on his altogether new method of turning sugar from jaggery and scored a fair amount of success therein and now a suitable plant that can turn out without waste from about two to four cwts, of sugar daily is under contemplation. Mr. Mulay is also busy with experiments on matches both "Strike-any-where" and "Safety." The manufacture of Hippuric acid has been stopped as there is no demand for it. Coregum is. ' being manufactured as before and has got a fair demand.

86. Weaving :-- With a view to improve the cottage industries in the Atpadi Taluka and other parts of the State such as weaving blankets, khadis, saris etc. encouragement was given to the weavers in every possible way. A loan of Rs. 5000/- was advanced to a weaver at Kundal to start a weaving industry with improved fly shuttle looms and he has been weaving cloth of a superior kind. In order to give a stimulus to the weaving industry a reward of Rs. 1000/- has been offered to a subject from the State who would invent a simple wooden spinning machine worked by feet alone and able to produce ten times the yarn produced by the ordinary country spinning machine.

87. As contemplated before a big weaving industry has been opened at Aundh and arrangement has been made therein for the education of boys of weavers etc. who are taught practically the methods of working on improved patterns of hand and power looms. It is hoped that these boys will be very useful in bringing about the spread of the improved types of looms among the weavers in the State.

88. Leather-work: — At Kinhi and in the Atpadi Taluka the Dhors tan hides which are exported to Karachi, Bombay and other trade centres.

89. There are many country oil presses in the State and especially in the Atpadi Taluka. Oil is extracted from safflower seed, ground-nut and Karanj seed and it is consumed locally.

Public works.

90. Appendix No. XIX gives details of the expenditure incurred on account of public works. The expenses amounted to Rs. 13,040-6-4 against Rs. 7,836-5-6 in the previous year. No new works were undertaken during the year. The chief items of expenditure were the usual repairs to offices, public buildings, roads, ferry boats etc. and the expenses incurred on account of the arrangements made for the water supply by digging wells etc.

Post Offices.

91. The number of Post offices remained the same as that of the last year viz. 8. Of these two are Sub Post Offices and the rest are Branch Offices. The Aundh Sub Post Office transacts business with the Aundh State Treasury as sanctioned by Government in their Resolution No. 2,841 dated 4th September 1911, Financial Department.

92. The Tonga Service is in use for carrying mails from Aundh to Rahimatpur station and this arrangement is convenient both for the Postal Department and the public. Motor service has been recently started from Aundh too Rahimatpur station and it is under contemplation to extend the service as far as Waduj via Pusesavli as it would meet the greatest conevnience of the public.

Telegraph.

93. There is only one combined Post and Telegraph office at Aundh which meets the convenience of the State as well as of the public. It is still a guaranteed Telegraph office.

Mint.

94. There is no mint in the State. The currency of the British Government is in use.

General condition of the State and the people.

95: On account of the insufficient rain both the Khariff and Rabi crops

yielded a poor out-turn and the cultivators suffered much in consequence. The season was, on the whole, unfavourable and one of scarcity. Those cultivators who had got irrigation facilities reaped very good crops and could, therefore, afford to sell their corn and fodder at a great profit owing to the high prices, while those who had no such means fared very badly. The labourers both skilled and unskilled had a good demand and the rates of wages also continued to be high. Consequently their condition was not bad. Some agriculturists had to borrow money from savkars to maintain themselves and their cattle. Some migrated to Bombay and other trading centres for their maintenance. The condition of the people was, on the whole, unsatisfactory. The resources of the people are almost exhausted and a few favourable years are quite essential to bring them back to their normal condition.

96. Trade was hampered to a certain extent but the weavers did not suffer at all on account of the increasing demand for cloth.

97. Public health was generally good. There was no material loss of human life from epidemic diseases during the year. The birth rate was higher while the death rate remained almost the same.

98. The agricultural stock did not fare well as will be seen from Appendix No. XX. This was due to scarcity of fodder on account of the unfavourable season. The supply of both fodder and water was insufficient and there was consequently a decrease in the number of cattle.

Emigration and Immigration.

99. There was no immigration. Some of the people migrated to trade centres such as Bombay, Berars etc. on account of the scarcity to earn higher wages. The emigration was not general but simply confined to some parts.

Excise.

100. The management of the country liquor including Toddy has been leased to British Government for a further period of 10 years commencing from 1st August 1914 for a yearly compensation of Rs. 11,500 subject to revision after a period of three years. The agreement about the Hemp-drugs which was renewed for a further period of five years from 1st April 1916 for a yearly compensation of Rs. 8,820 expired on the 31st March 1921. Opium farming is managed by the State on the same lines as those of the British Government.

CHAPTER V.

REVENUE AND FINANCE.

101. Appendix No. XX11 shows the receipts and expenditure of the year.

Receipts.

102. The total receipts of the year, exclusive of the opening balance, were Rs. 3,88,240-7-3 as against Rs. 3,52,041-0-6, thus showing an increase of Rs.

. 36,199-6-9 over the last year. The perceptible increase is under the heads (1) Land Revenue, (2) Local Funds, (3) Opium and (4) Judicial. The occupancy rights of some of the lands belonging to the State were sold; the license fees on account of farming the opium shops were larger; the sale of court fee and general stamps was large; so also was the case with the recovery of fines imposed by the criminal courts and hence the increase under all these heads.

The decrease under the heads Abkari, Miscellaneous and Education. fees is due to the fluctuating nature of the income received under these heads.

The recovery on account of Takavi was small; there were small re-, ceipts on account of Deposits and hence the decrease under these heads.

There was a large account adjustment of Advances and hence the increase under this head.

No new debt was contracted. The amount shown under the head is the amount of interest on the debt previously contracted.

Some of the War Loan bonds were sold and hence the decrease in the interest.

The amount of interest received from the State Bank was larger and hence the increase under this head.

Expenditure.

103. The total expenditure of the year was Rs. 6,15,080-15-4 as against Rs. 3,74,381-5-2 last year. There was a net increase of Rs. 2,40,699-10-2 which was principally due to the repayment of Ryots' War Loan, grant of Takavi, general increment in the salaries of servants in all the departments of the State, greater expenditure on Public Works and Investment in the State Bank.

The amount invested in the State Bank viz. Rs. 1,40,352-12-2 and the amount of Takavi viz. Rs. 23,985 are practically savings and if they are deducted from the amount of expenditure, there remains a net increase in expenditure of Rs. 76,361-14-0 only. The causes of increase and decrease under different heads will be seen from the remarks made on each head as under.

104. The increase under the head Khasgi is partly due to high rates of food stuffs and partly to the promotion given to all the servants in the Khasgi department.

There was no arrear payment on account of the Allowances and besides, Lady Laxmibai, one of the recipients of the allowance died and hence the decrease under this head.

The amount shown under the head Incidental was the amount remitted to England for the expenses of my son Shrimant Rajesaheb, his family and children.

There was no elephant for the State. A young tusked elephant was purchased from the Mysore side and hence the increase under this head. The salaries of all the servants in all the departments of the State were increased on account of the prevailing high rates of all the articles of daily use and hence the increase in the items Nos.5, 6, 8, 9 and 10.

• The decrease under the head Judicial is due to less expenses incurred on account of pleaders' fees etc.

There was a large number of prisoners admitted in the Jail and hence the increase under this head.

The increase in the heads Dispensaries, Forest and Minor Establishment being small calls for no remarks.

The amount spent on Public Works was larger and hence the increase under this head.

The arrear payment on account of Dewasthan and Watandars and Hakdars was made this year and hence the increase under these heads.

Instead of paying the debt, the Ryots' War Loan money was repaid as it was of primary importance and hence a decrease under this head and a large increase under the head (28) Repayment of Ryots' War Loan.

The increase under the head Miscellaneous is due to account adjustment of the interest drawn on the debts previously contracted.

* The amount paid on account of Deposits was large while that of Advances was small and hence the increase and decrease under these heads.

The increase under the head Pensions is due to the addition of some pensioners and the arrear payment made to some of them.

A large amount was invested in the State Bank as it was found more advantageous to do so. The War Loan bonds fetched less interest than what the investment in the State Bank could fetch. Some of the War Loan bonds were consequently sold and the proceeds invested in the State Bank and hence the increase under this head.

On account of unfavourable season Takavi was granted on a liberal scale and hence the increase under this head.

The increase under the head Plague and decrease under Recruiting being small call for no remarks.

Instead of paying the grain compensation the salaries of all the servants were increased and hence the decrease under this head.

The expenditure incurred on account of the State Laboratory was included in the expenditure of the Educational Department last year. During the year of report, the amount spent on the State Laboratory has been shown separately and hence the increase under this head.

The increase under the head Printing Press is due to the purchase of

some more type and other articles which were necessary for the equipment of the press.

The amount shown under the head Census is due to the expenses incurred in connection with the preliminary Census operations.

State Debt.

105. Including the amount of the Ryots' War Loan the State Debt at the beginning of the year was R^s. 3,09,502-0-11. Adding to it Rs. 24,553-7-1, the amount of interest, the total amount came to Rs. 3,34, 055-14-0. Out of this, Rs. 1,16,551-9-11 were paid back to the Ryots on account of their War Loan. There remains now Rs. 2,17,504-4-1 as State Debt at the close of the year.

Financial condition of the Slate.

106. As a set off against this there is a balance as under:---

There are, besides, amounts of Rs. 23,985/- and Rs. 24,440-6-8 on account of Takavi and outstanding arrears to be recovered from the Ryots which, when added to the above amount, will be in excess by Rs. 64,206-13-0 than the amount of the State debt which is satisfactory.

CHAPTER VI. VITAL STATISTICS &c.

Medical Relief.

107. There are four dispensaries in the State all of which are in charge of qualified Medical officers. The number of patients treated was in all 13,867 as a gainst 13,782 of the previous year as shown in Appendix No. XXIII. There was an increase of 85 patients during the year as compared with the last year which is insignificant. The major and minor operations performed in all the dispensaries were 554 as against 364 last year. Out of the patients treated, 1,123 were from the British Territory. The prevailing diseases during the year were fevers of intermittent type, diseases of the eye, stomach and skin, bowel complaints, respiratory affections and intestinal worms. The system of collecting one anna per six doses from patients outside the State is in force.

108. Besides the dispensaries there are two native physicians at Kundal and Kinhi and their medicines are used by people who have got objections against taking English medicines.

109. I visited all the dispensaries during my tour in the Talukas and found them working satisfactorily.

110. The cost on medical relief was Rs. 3,911-2-0 as against Rs. 4,479-14-4 in the previous year.

Sanitation.

111. There are, besides the three Municipalities, four Village Sanitation Committees in the State and their duty is to look after the sanitation of their respective villages. The Taluka officers under my directions look after the sanitation of those villages where there are no Municipalities or Sanitation Committees. These institutions derive their income mostly from house-tax. The items of expenditure are cleaning the village, improving the water supply, street-lighting and road repairs.

Vaccination.

112. The Medical Officers of the State, who are trained at the Vaccine Institute, Belgaum, are appointed Vaccination Inspectors. They do the inspection work of their respective Talukas, the Medical Officer of Aundh being in charge of the vaccination of the villages of Kinhi and Sangam Mahuli besides the Aundh Thana. There are two Vaccinators in the State viz. at Kundal and Atpadi who do the vaccination work of the whole State. Glycerined lymph is bought from the Belgaum Depot for vaccination purposes. The work is carried on on the same lines as in the British Territory.

113. The number of vaccinations was 1,893 against 1,863 last year. Of these 1,683 were successful, 5 were unsuccessful and the result of 205 was unknown.

114. The cost of the working of the Vaccination Department was Rs. 1,476-4-8 as against Rs. 839-8-6 in the previous year.

Births and Deaths.

115. The total number of births and deaths during the year as shown in Appendix No. XXIV. was 2,356 and 1,600 against 2,222 and 1,711 respectively last year. The ratio of births was higher than that of the last year while the ratio of deaths remained nearly the same.

116. The registers of births and deaths are properly kept by the village officers and they are examined by the Taluka officers and the vaccinators. Great care is taken in making the entries punctually.

Epidemics.

117. There was no plague in any part of the State during the year. As a precautionary measure, killing of rats was seriously taken into hand and a large number of them was destroyed. Strict orders have been issued to the village officers to carry on rat killing operations vigorously. Small-pox appeared only in one village. The number of attacks was 3 but there were no deaths. Influenza did not prevail in any part of the State.

118. Cholera broke out in 9 villages. It was of a mild type. The number

of attacks was 290 while that of deaths was 109. Necessary measures were adopted to put down this epidemic by observing strict cleanliness. Public health was, on the whole, generally good except the slight ravages of cholera.

CHAPTER VII.

EDUCATION.

Primary Education.

119. There are 49 Primary Schools including the Compulsory Schools against 43 last year as detailed in Appendix No. XXV. During the year 9 new schools were opened; 5 in Gundal Taluka, 3 in Kundal Taluka and 1 model' school at Atpadi. The Girls' school at Dighanchi was amalgamated with the Boys' school for want of attendance. One school was closed for want of proper attendance and another aided school was converted into a State school.

120. The total number of students in all the schools was 2,349 as against 1,972 last year. The average daily attendance was 1,563 as against 1,525 in the previous year. The classification of students is 338 Brahmins, 9 Jains, 293 Lingayats, 1,346 Marathas and other Hindus, 220 Mahomedans, 1 aborigine, 140 depressed class and 2 Native Christians. Out of these 337 are girls attending the girls' schools and the boys' schools.

121. Education in all the primary boys' schools is given upto the III standard according to the curricula of the State and some schools also teach the IV, V and VI standards according to the number of pupils in these standards. The girls' school at Aundh also teaches IV and V standards. Needle work, sewing, rangoli, drawing and other useful things are also taught in the girls' schools. In the Mahomedan School at Aundh Urdu and Arabic are taught and for other subjects the students attend the primary classes. This school teaches 3 Urdu standards.

122. During the year one student who was studying in the 3rd year of the Training College for men at Poona passed his final examination and was appointed head master of the middle school at Kundal. One teacher was sent to the T. C. for 3rd year. Two teachers passed the Elementary Drawing examination. All the schools showed a good progress.

Compulsory Education.

123. There are in all 41 compulsory schools in the State of which 7 are in the Aundh Thana, 9 in the Atpadi Taluka, 10 in the Kundal Taluka and 15 in the Gundal Taluka. The details of these schools and the standards which they teach will be seen from Appendix No. XXV - A.

124. All the schools observe the rules of the compulsory education so far as making the attendance of children between the ages of 7 and 10 (both including) compulsory and in a very few places only there are separate primary schools. This was the desired object in the beginning which has been slowly and unknowingly attained, as people always requested to make their schools compulsory. 125. Compulsory education is given free to all the students for the first year and after this period those who are not State subjects are charged nominal fees. A scheme of making education compulsory throughout the whole State is under contemplation.

Middle Schools.

126. There are three middle schools at Aundh, Atpadi and Kundal. They teach Vernacular V to VII standards along with English I to III standards. Owing to the want of space standards II, III and IV are attached to the Middle School at Kundal. They are the feeder schools to the High School at Aundh. The number of students in these schools was 271 including one girl as against 244 last year. The daily average attendance was 186 as against 167 in the previous year. The classification of students is 101 Brahmins, 4 Jains, 23 Lingayats, 129 Maratha's and other Hindus, 12 Mahomedans and 2 Low-classes.

and the second second

127. Drawing is taught in all these schools. Debating Unions for students as well as teachers are established and model lessons classes are held in these schools and are very useful in supplying general knowledge to the students and teachers and instructing untrained teachers. In the Atpadi Taluka teachers from almost all schools in the Taluka are called to Atpadi 4 or 5 times a year to take instructions in teaching. This system is recently introduced in the Kundal Taluka also, but some schools being far away from Kundal much advantage is not taken of this arrangement. The Aundh Middle School derives other benefits also in being under the direct supervision of the High School staff, in getting free boarding and boarding scholarships and in having carpentry, singing and weaving classes etc. Besides it takes part in all the events and activities of the High School.

128. During the year of report 15 students appeared for the Vernacular. Final Examination and 13 for the Elementary Drawing Examination of whom 9 and 5 passed respectively.

Secondary Education.

129. The Shri Yamai Shrinivas High School, Aundh, teaches English from IV to VII standard. The number on roll was 76 as against 100 last year. The classification of boys was 66 Brahmins, 2 Lingayats, 6 Marathas and other Hindus, 1 Mahomedan and 1 Low caste. There were 3 Brahmin girls in the High School. During the year under report 9 students were sent for the School Leaving Examination of the Joint Board and all of them passed. Three were sent for the first part of the Government Service Examination and all of them passed in the subjects for which they appeared. Out of the successful candidates one was a lady student. Eight students were sent for the Elementary Drawing Examination and 9 for the Intermediate Examination out of which 5 and 5 passed respectively. The results are very satisfactory and especially that of the School Leaving Examination, the general University result being only 40 to 45 per cent. This is very creditable to the High School staff.

130. In order to increase the efficiency of the High School, all the classes were put in charge of graduates. There are 4 graduates and 2 under graduates in

. . .

the High School besides the Drawing, Gymnasium and Carpentry teachers. The Superintendent himself taught the VII standard English poetry for 6 months and all the standards Science for nearly the whole of the year as no Science teacher was available till December 1920.

131. To increase the efficiency of the staff one experienced B. A., L. T. teacher was appointed as the Head Master but he left the service in about a couple of months owing to ill health and domestic difficulties. One teacher appeared for the S. T. C. examination but he failed. The Superintendent inspects all the teachers in the teaching of different subjects turn by turn and gives them hints as regards the correct method of teaching. The teacher who is given some concession to prosecute his studies in the College is progressing well and is in the Senior B. A. Class.

132. The students play at Indian and foreign games and have got gymnasium and ordinary and Swedish drills under the supervision of the teachers. Due attention is thus given to the physical education and health of students. Religious and moral instruction was continued and a better programme is arranged this year. The class libraries and the debating classes are also doing well and the general standard of the education of students is being raised slowly.

133. The Volunteers from the Boy scouts worked on all public occasions and Mr. A. C. Miller M. A., I. E. S., Officer on special duty of the Boy-scout organization, Bombay who paid a visit to Aundh examined the drill, games and other activities of the scouts. A report was also submitted to him of the scouts' work for the last two years. He was quite pleased with what he saw. His remarks speak for themselves. They are:--

"With regard to the scout troop I have nothing to say but praise for the excellent spirit of self-sacrifice shown by the boys. Their work in connection with the Influenza epidemic was beyond praise."

. 134. The High School Laboratory was well equipped. Drawing, weaving, hosiery, carpentry, paper-folding, card-board-work etc. were continued during the year.

General.

 $\sqrt{135}$. The important event, during the year under report, was that people of several villages in the State and those of all the villages in the Gundal Taluka generously declared to pay an Educational Fund of one anna per Rupee of the land revenue in response to the appeal made by the State to meet the increase in expenditure of the Educational Department on account of the proposed opening of schools in all the villages of the State. Accordingly schools are opened in all the villages of the Gundal Taluka; Some villages where there were schools already offered to pay the fund to get trained teachers for their schools in order to increase the efficiency of teaching. This shows that people have begun to realise the importance of education. This is really a great step towards the achievement of the object of the compulsory education and making the population literate. 136. Another thing worth mention was the preparation of a scale of pay for graduates, under graduates, trained and untrained teachers in the Educational Department. Both time and efficiency are considered and the scale is quite sufficing from the teachers' point of view as well as that of the State.

137. Students of different places took part in the wrestling matches held at their places. Three won medals at the Poona Deccan Gymkhana Tournaments. The Atpadi schools played a foot-ball match with the Aundh schools. The hosiery and Carpentry teacher Mr. M. R. Hinge competed in the 27 miles race at Poona and came fifth and also competed in a 30 miles race at Jamkhandi and stood 2nd.

138. Shimaga sports and races were held at Aundh and Atpadi. At Aundh there were also other programmes of lectures, dialogues, speeches, farces, cinema and magic lantern. Prizes were distributed. The public also took active part in the races. At Atpadi the public themselves contributed to the Prize Fund and distributed prizes to the winners. Visual instruction with the aid of cinema, projectascope and magic lantern was given at Aundh and Atpadi. Stereo-scopes with geographical slides are supplied to all the Taluka schools.

139. The Students' Industrial Exhibitions were opened at Aundh, Atpadi and Gundal. Owing to lack of time no exhibition was opened at Kundal but the Kundal schools sent their articles to Aundh. The exhibitions present new and more useful articles every year and the tendency to prepare useless articles is rapidly diminishing. So also natural resources of the places are being used by the students and they are thus known from these exhibitions. For instance in the Gundal Taluka, almost all the schools sent buttons made from mother of pearl, cocoanut shell etc. in addition to other articles. One of the teachers was given some inducement last year for preparing fine buttons and this year he has invented a small instrument by means of which the mother of pearl is cut and the button prepared from it in one operation. He has also been given a reward this year. That these exhibitions are popular is seen from the large crowds of students and their parents attending them. The people of Atpadi always show their interest by contributing generously to the prizes. Students from almost all the schools sent articles to the exhibitions. These annual exhibitions will give good facilities for the introduction of industrial education in the several schools. Arrangements are made with the Weaving Factory at Aundh to teach the students from the High School and other schools at Aundh weaving on hand looms and power looms.

 \checkmark 140. The Hostels were full during the year and it shows that students take full advantage of them. Boarding and boarding scholarships were given to students on the same condition as in the last year viz. keeping their numbers within 10 in the class and passing all the examinations. There were no candidates for the scholarship to be awarded to students getting more than 60 per cent marks in all the examinations of the year. Two lady students were given scholarships in the High School and one in the Middle School, Aundh. Loans at a very low rate of interest are given to a few students to prosecute higher education at the University, in the Sir J. J. School of Art, Bombay and in the Kalabhuvan at Baroda. One student is given a scholarship to study medicine in the Aryangla-Vaidyak School at Satara. 141. A nominal fee of 4 annas is levied in the High School and in the other schools from half an anna to two annas. Owing to these facilities many poor students from different parts of the Bombay Presidency come to this State for their education The Nene-milk scholarship was awarded to B. R. Joshi of the VII standard at the High School.

142. Two Co-operative Stores were opened during the year with the help of the Registrar, Co-operative Societies, Aundh State viz. one in the S. S. High School at Aundh for the Aundh schools, and one at the Kundal Middle School for the Kundal schools. The one at Kundal is recently opened but that at Aundh is progressing satisfactorily since June 1920. It deals in stationery and other articles useful for the schools and is managed entirely by the students under the guidance of the teachers. The students will thus naturally get commercial education from the working of these institutions.

143. During the year under report the High School was inspected by Mr. M. Hesketh M. A., Educational Inspector, C. D. and Mr. G. G. Padhye B. A., Deputy Educational Inspector, Satara District and the other schools in the State were inspected by the Educational officers of the Satara District as well as by the State Educational Officer. Their remarks are satisfactory. The Mamlatdars of the several Talukas and other State officers also inspected the schools. I also visited several schools while I was on tour.

144. Mr. W. E. G. Soloman, Principal, Sir J. J. School of Art, Bombay, Dr. F. W.Thomas, Librarian, India Office, London and Mr. A. C. Miller M. A., Officer on special duty of the Boy-scout organization, Bombay Presidency visited the High School at Aundh and their remarks are good. Dr. F. W. Thomas writes in his letter "In your school I was very favourably impressed by the general arrangements for an all round education including art and handi-craft and by the liveliness of the teaching and the behaviour of the young students;- everything testifies to the paternal interest of the Chief of the State and his officials."

145. Mr. P. A. Inamdar M. A., B. Sc. was in charge of the Educational Department as Superintendent throughout the whole year and he managed the lepartment with great care, tact and ability. He brought about many improvements in the department. He inspected almost all the schools in the State and showed to the teachers the methods of teaching which had a very salubrious effect. Mr. Inamdar deserves credit for the improvements introduced in the department.

146. The total expenditure for the Educational Department for the year under report was Rs. 31,001-11-6 as against Rs. 27,990-2-1 last year.

CHAPTER VIII.

MISCELLANEOUS.

State Bank.

147. The State banking is thriving very well under the able and tactful supervision of its manager Mr. V. K. Kulkarni B. Com. (Bombay). The in-

stitution has been very popular and has won the confidence of the constituents as is evident from the fact that deposits were received, to a large extent from people both in the State as well as from outside. The debtors have now learnt to return the amounts with interest borrowed by them regularly.

148. The working capital of the Bank is mainly derived from the State Treasury. Great care is being taken to return the amount of deposits in due time. In order to create confidence among people a circular was issued about the guarantee of the State to the depositors to pay back their money at fixed dates and it had a wholesome effect.

149. The year under report being a year of scarcity the Bank did not sanction any loan to people for marriages or such other unproductive purposes as the recovery of such debts is very troublesome. On the other hand the Bank advanced a considerable amount of money to agriculturists for useful purposes and also to merchants at Aundh to buy food stuffs in large quantities when the situation was rather serious on account of scarcity. By this measure the poor could get food stuffs at comparatively cheap rates. The merchants are now convinced of the fact that the Bank advances loans on reliable securities as well as on personal securities to carry on their business and this will, it is hoped, increase transaction between the merchants and the Bank in future.

150. The State Bank has kept deposits in the Shilotri and the Bombay Central Co-operative Bank, Bombay in order to meet the demands of the depositors and to advance loans to merchants at any time. The Bank, by way of experiment, has done some Hundee business, but the local merchants and the merchants of the adjoining villages not being aware of this could not take advantage of this Hundee business. But it is hoped that next year merchants will take full advantage of the Hundee business and give due commission to the Bank.

.

151. Another important change in the working of the Bank is that printed forms and books have been introduced to write the accounts of the Bank. The auditor will not find any difficulty in auditing the accounts of the Bank as they are written systematically in printed books. Last year the accounts of the Bank were not audited by a qualified auditor but this year a very competent and experienced Union Secretary was requested to audit the accounts of the Bank and in his report he says that the accounts have been properly and correctly written.

152. The Bank has advanced nearly Rs.40,000 for industrial purposes at a reasonably low rate of interest and Rs. 11,473-2-4 to Co-operative Societies. As the Bank has advanced loans to merchants, agriculturists and to persons starting new industries, it has facilitated the development of agriculture, commerce and industries. The Bank has increased its rate of interest on current deposits from two to three per cent. Loans were sanctioned not at a uniform rate of interest, the rate varying from 6 to 12 per cent.

153. In order to encourage the development of Co-operative Societies, the Bank has made it a point to advance loans to societies at $7\frac{1}{2}$ per cent fixed rate of interest.

154. The present difficulty of the Bank viz. non-recovery of the debts on the fixed dates, makes it impossible for the Bank to pay back the depositors. their amounts on due dates. To avoid this difficulty, framing of new rules and regulations is under consideration.

155. The opening balance of the Bank at the beginning of the year was Rs. 1,83,725-7-4. The receipts during the year on account of deposits, investments, interest etc. were Rs. 2,01,321-10-3. The total amount at the close of the year was Rs. 3,85,047-1-7. The expenditure was Rs. 8,183-5-3 on account of interest, deposits and establishment charges. The net balance at the close of the year was Rs. 3,76,863-12-4 including cash and bonds.

Co-operative Credit Societies.

156. The working of the Co-operative Credit Societies shows a considerable progress as will be seen from Appendix No. XXVI. The beginning was made with a small number of members but now the total number of members has risen to 230. The deposits at the beginning of the year were Rs. 2,423 but now the amount has increased to Rs. 4,251-15-3. The Bank has advanced a loan of Rs. 11,473-2-4 to different societies and the total working capital of these societies is more than Rs. 15,000. Five Co-operative Credit Societies were working last year and no addition has been made this year.

157. During the year two Co-operative Stores have been opened; one at Aundh in the S. S. High School and the other at Kundal. Appendix No. XXVI-A gives details about their working. The former was opened in the monthof June 1920 and it has been working satisfactorily. Last year's profit of this Store amounted to Rs. 32-6-6, out of which a dividend of 6½ per cent was paid to the share-holders. As the Store deals in stationery and other necessary articles, almost all the students as well as the members get articles of a superior quality at a cheaper rate. This Store is being managed by the students of the High School under the supervision of the High School teachers. There is thus every chance of the students being impressed with the principles of co-operation and of gaining commercial insight. The second Store was opened at the Kundal school on 31st May 1921 but as it is still in infancy regular business is not yet carried on.

158. A competent Union Secretary in the Satara District has inspected all the societies and the stores and in his report he says that all the societies have been working well. Apart from the fact that only two new Co-operative Stores have been started, the increase in the number of members as well as the increase in the amount of deposits and the working capital go to show that the societies are making progress and their financial condition is also improving.

Agricullure.

159. The Agricultural Inspector Mr. S. G. Darshane B. Ag. had his usual tours in the Talukas during the year. He visited some villages and gave advice to the people in matters of agricultural improvement, encouraging the use of improved agricultural machinery and better and profitable methods of cultivation. The year under report being one of scarcity people were recommended from the very beginning to grow fodder crops on a large scale wherever irrigation facilities existed in order to save their cattle from starvation and many availed themselves of the timely advice and were thereby profited.

160. On account of the unfavourable season and the consequent shortage and scarcity of Kadbi and grass people were asked to try the prickly pear as fodder for their cattle and in order to convince them of the cheapness as well as harmlessness of this stuff, demonstrations were held in the Talukas at important places under the supervision of the Taluka officers showing the method of preparing and feeding this new fodder to the cattle. People, however, did not take much advantage of the cactus fodder.

161. With a view to encourage the use of time and labour saving machinery by the cultivators several improved agricultural implements and hand tools of the best pattern were ordered by the State from America and they have beenkept at the State gardens at Aundh for demonstration purposes and are used in the State gardens. Their use is being demonstrated to the public who are gradually realising their importance and utility. Arrangements have also been made to give these implements to the cultivators on a low rate of hire and people are slowly taking advantage of this concession. Some iron ploughs manufactured by Messrs. Kirloskar Brothers Ltd. have been also kept at important places in the Talukas for hiring them to the public at a low rate.

162. Efforts are thus being made to bring about the agricultural improvement of the State by giving people lectures and necessary advice pertaining to agriculture as well as by demonstrating the use of improved agricultural implements and superior and less costly methods of cultivation, by hiring improved implements at concession rates and by giving necessary help to the public as far as possible. It is gratifying to note that people are showing a greater tendency towards agricultural improvement and it is to be hoped that they will not fail to profit themselves by adopting improved implements and improved methods of cultivation in the near future.

163. I am glad to note that Mr. Darshane, since his appointment, has been taking great interest and trying hard for the material advancement of the Agricultural Department.

Minors' Estates.

164. The number of estates of the minors that were under the State management, at the beginning of the year was 12 with the balance of Rs. 1,27,713-1-0. Of these two estates of the value of Rs. 62,367-0-1 were handed over to the minors as they attained majority. There thus remained 10 estates of the value of Rs. 65,346-0-11. One more estate of a minor was added during the year. The value of the estates of all these minors after deduction and addition was Rs. 78,369-0-1 including the receipts of the year. The expenditure was Rs. 13,946-3-1. The closing balance was Rs. 64,422-13-0. Out of this amount Rs. 61,130-5-2 are in the shape of bonds and Rs. 3,292-7-10 in cash. The education of the minors is properly attended to and they are showing good progress.

The Ryots' Assemblies.

165. These were held during the year at Kundal, Atpadi and Gundal as usual while I had gone there for the annual inspection work. The meetings were largely attended by people both literate and illiterate from all the villages in the Talukas. Several grievances were put forth and they were redressed as far as practicable.

Dewasthans,

166. There are eleven Dewasthans managed by the State. The fairs that were held in connection with these were attended by a large number of people. Cattle bazars were also held at some of these fairs and good many cattle were sold therein. Police arrangements were properly made and sanitary measures were strictly observed in these fairs.

Callle Breeding.

167. The total number of the Khillar cattle kept at Atpadi was 49 in all. They did not thrive well during the year on account of the insufficient grazing and fodder due to the unfavourable season. There are, besides, 12 camels kept for carrying loads.

Taxes on Trade.

168. There are no taxes on trade-

Tolls.

169. There are two toll-bars within the State limits-one at Dighanchi and the other at Bhivghat. Government have sanctioned, in their Resolution No. A/114 dated 20th January 1911, P. W. D., received with your No. 46 dated 2nd February 1911, the exemption of State officials whose status corresponds to the status of those exempted in British India, from payment of toll at certain tollbars in the Satara and Bijapur Districts. The same concession is also given by the District Local Board at Local Fund toll-bars. I have also granted similar concessions to British Officers who happen to pass toll-bars in the State on official duty.

Wild Animals.

170. Wolves and pigs are the only wild animals in the State. There was not much damage from wolves during the year. Prizes were given for the destruction of wild pigs who cause much damage to the crops.

Libraries.

171. There are three libraries in the State, which are very useful to the public. No proscribed books or papers are allowed to be subscribed.

Printing Press.

172. There is only one type-printing press of the State at Aundh. It is

generally used for printing standard forms required for the use of the offices in the State and Court fee and general stamps. No newspapers or magazines are printed in it. The "Aundh State Gazette" which has been started from October 1920 is printed in this press and published every month.

Records.

173. The records have been carefully assorted and they are in a good condition.

Record of Rights.

174. The work of the Record of Rights is complete. Rewriting is going on in the Talukas where the term has expired.

Family Pension Fund.

175. The fund has been started for giving relief to the widows and children of the State second who die prematurely and it has been of a very great use to them. The amount of the fund is credited into the State Bank. About 29 widows and 42 children in all enjoy pensions from this fund.

Maratha and Lingayat Funds.

176. These funds are started for helping poor and deserving students from the Maratha and Lingayat castes. The proceeds of these funds are used in granting loans to agriculturists and from the interest realised scholarships are given to the boys of these castes.

Departmental and Pleaders' Examinations,

177. During the year of report 4 candidates appeared for the Lower Standard Examination and 2 for the Pleaders' Examination and all of them passed.

178. In conclusion, I thank you, the Commissioner, C. D. and the Government for the kind support and advice which I have received from time to time and which, I hope, will ever be continued.


