Volume III contains a history of the Cape Colony from 1846 to 1860, of Natal from 1845 to 1857, of British Kaffraria from 1847 to 1860, and of the Orange River Sovereignty and the Transvaal Republic from 1847 to 1854.

Volume IV contains a history of the Orange Free State, the South African Republic, Zululand, Basutoland, Betsuana-land, and Matabeleland from 1854 to 1872.

Volume V contains a history of the Cape Colony and Natal to 1872, Griqualand West to 1880, Great Namaqualand, Damaraland, Transkei, Tembuland, and Griqualand East to 1885, Pondoland and the Portuguese Territory to 1894.

Each of these volumes is indexed and may be had separately from the others.

PREFACE.

THE preparation of a history of South Africa has occupied my almost undivided attention during the last forty years. I kept it constantly in view while connected in different capacities with Bantu tribes, and while keeper of the archives of the Cape Colony and subsequently I have made the closest possible research among official documents of all kinds. Of printed books upon the country I have one of the best collections in existence, and though I have not made many extracts from them, they have often served me as guides. To the utmost of human ability I have striven to write without fear, favour, or prejudice, to do equal justice to all with whom I had to deal. I can therefore, without laying myself open to the accusation of vanity, place my work confidently before the public as not alone the only detailed history of South Africa yet prepared, but as a true and absolutely unbiassed narrative.

APPENDIX.

Note 1. Page 32.

THE tone of Lord Macartney's instructions regarding the Bushmen was humane, though he was quite ignorant of their true position in the country. He wrote :—

“ With the Bushmen, who are perfect savages, it will be always difficult to maintain, at least without much bloodshed, the limits to be fixed, still good order requires that they also should be forced to remain in their own country. Amicable endeavours must be used to oblige these savages to leave the country which they have overrun, or if these should fail then the inhabitants of those districts which they at present occupy must unite and use force. After which no better boundary can be found between the Bushmen and the inhabitants than the Zeekoe river situate behind the Sneeuwberg, the Karree or Roodeberg behind the Camdeboo, and the Zak river, forming the one with the other a half circle from the east to the west. The principal duty of the landdrost is x x x, and afterwards by ordering regular expeditions to protect the other inhabitants in their possessions against the Bushmen.

“ But as the landdrost is bound to protect the inhabitants against the savages, so is he to keep a watchful eye that the inhabitants do not encroach beyond the places granted by the former government in loan. The said grants and the rents thereof being enjoyed by government has authorised the possession of those places, although in itself very unjust and originating in the oppression of the natives, but all further enlarging of this colony would be an absolute cruelty with respect to the natives, who thereby are molested in their possessions and expelled, which would be directly against the justice and humanity of his Majesty, whereby the landdrost is to guard against such encroachments.

“ The proper Bushmen inhabit a very extensive tract of land behind the Zeekoe river ; they feed upon venison and the produce of their fields, digging out of the ground certain anthills full of ant eggs which they call rice and which serve them for a great part of their food, but they keep no cattle. Even the cattle which some of them steal from our inhabitants they do not keep for breeding, but consume immediately with the greatest profusion, according to the known custom of savages. Of these, some robbers have x x x come down into the Roggeveld and the Hantam. These are therefore in every possible manner to be compelled to return to their own country x x x. If these people would by gentle means be persuaded to do so it would be fortunate, and a great deal of human blood would thereby

be saved, but finally some means will be unavoidable for self preservation, especially if their considerable procreation is considered, which according to reports thereof is inconceivable, notwithstanding their wild and uneasy manner of life and the disasters to which they are continually subject.

"It is said that sixty years ago × × × some Bushman kraals were surrounded, the principal Bushmen thereof apprehended, transported to this town, and given to understand what would be the consequence of their not retreating immediately into their own country; that thereupon they were dismissed with some presents, and that the said manner of proceeding had very fortunately caused the greatest part of them to retreat. Should the like measures be once again adopted, they might produce a very good effect, and the landdrost, from a principle of humanity, should undertake something of this kind prior to his proceeding to order a general expedition of the inhabitants for the purpose of forcibly expelling the Bushmen. But should we be obliged to adopt such a deplorable expedient, then the landdrost is particularly required to take care that in such expeditions a more humane treatment be observed than that which I am informed sometimes on these occasions takes place."

Note 2. Page 40.

At the close of the eighteenth century benevolent sentiments had not yet acquired much force, and the severest discipline was regarded as necessary on a man-of-war, whose crew was often largely composed of pressed men. The log books of the ships, the proceedings of the courts martial, and the lists of punishments inflicted at sea, which were delivered by the respective captains to the admiral when ships arrived in port, together with the correspondence between the naval officers and the government, form the evidence upon which my account of the mutiny in the fleet on the Cape station is given. Though not directly connected with the history of the Cape Colony, an account of such an event, which occurred in South African waters, could not with propriety have been omitted.

Note 3. Page 41.

After his arrival in England Lord Macartney was offered a high office in the government, with a seat in the cabinet, but felt himself obliged to decline it, on account of the precarious state of his health. He died on the 31st of March 1806, in his sixty-ninth year, and as he left no children the title became extinct.

Note 4. Page 76.

Mr. (afterwards Sir) John Barrow, who travelled through the district of Graaff-Reinet in 1797, gives the following account of the swarms of locusts seen by him in October of that year:—

"Of the innumerable multitudes of the incomplete insect, or larva, of the locusta, that at this time infested this part of Africa, no adequate idea could possibly be conceived without having witnessed them. For the space of ten miles on each side of the Seacow river, and eighty or ninety miles in length, an area of sixteen or eighteen hundred square miles, the whole surface might literally be said to be covered with them. The water of the river was scarcely visible on account of the dead carcasses that floated on the surface, drowned in the attempt to come at the reeds which grew in the water. They had devoured every green herb and every blade of grass; and had it not been for the reeds, on which our oxen entirely subsisted while we skirted the banks of the river, the journey must have been discontinued, at least in the line that had been proposed. The larva, as generally is the case in this class of nature, are much more voracious than in the perfect insect; nothing that is green seems to come amiss to them. They are not, however, without a choice in their food. When they attack a field of corn just struck into the ear, they first mount to the summit, and pick out every grain before they touch the leaves and the stem. In such a state it is lamentable to see the ruins of a fine field of corn. The insect seems constantly to be in motion and to have some object in view. When on a march during the day it is utterly impossible to turn the direction of a troop, which is generally with the wind. The traces of their route over the country are very obvious for many weeks after they have passed it, the surface appearing as if swept by a broom, or as if a harrow had been drawn over it. Towards the setting of the sun the march is discontinued, when the troop divides into companies, which surround the small shrubs, or tufts of grass, or ant-hills, and in such thick patches that they appear like so many swarms of bees; and in this manner they rest till daylight. It is at such times as they are thus formed that the farmers have any chance of destroying them, which they sometimes effect by driving among them a flock of two or three thousand sheep. By the restlessness of these they are trampled to death.

"Luckily the visits of this gregarious insect are but periodical, otherwise the whole country must inevitably be deserted, for they rest, as the prophet in Holy Writ hath said, 'upon all thorns and upon all bushes.' Even at this time the cattle in many parts are starving for want of food. The present year is the third of their continuance, and their increase has far exceeded that of a geometrical progression whose ratio is a million. For ten years preceding their present visit, they were entirely free from them. Their last exit from the colony was rather singular. All the full-grown insects were driven into the sea by a tempestuous north-west wind, and were afterwards cast upon the beach, where it is said they formed a bank of three or four feet high, that extended from the mouth of the Bosjesman's river to that of the Beeka, a distance of near fifty English miles; and it is asserted that when this mass became putrid, and the wind was at south-east, the stench

was sensibly felt in several parts of Sneeuwberg. Fortunately they were driven thus to sea before they had deposited their eggs in the ground. The larvæ at the same time were emigrating to the northward. The column passed the houses of two of our party, who asserted that it continued without interruption for more than a month. The gryllivori in myriads were close at their heels, and departed along with them, since which, till the present year, not one of them was to be found in the country."

Note 5. Page 337.

A man whose name was afterwards famous accompanied Major Colebrooke to South Africa in the humble capacity of his servant or valet, and remained in the country about twelve months. This was Richard Lander, who accompanied Captain Clapperton in the same capacity on his journey to endeavour to trace the course of the Niger from its head waters to its mouth, and was the only European survivor of that ill-fated expedition. On this occasion Lander was in Western Africa from November 1825 to February 1828, and upon his return to England an account of the journey along the Niger was published from his statements. He was then engaged by the British government to return and endeavour to follow the river from the point where he had left it to its mouth, and with his brother, John Lander, he reached Cape Coast Castle in February 1830. Before the close of the year he solved the question that had previously baffled all explorers, by travelling inland to the Niger and descending the river to the Nun mouth of its delta in the bight of Benin. Once more he visited the African coast, on this occasion as head of a commercial venture, with two small steamers intended to explore the Niger and its tributaries, and establish trading stations at suitable places. In October 1832 he began the passage up the river, and after much exploratory work in February 1834 died from the effects of a wound received from some blacks in the Brass river.

- Fiscal** : before the appointment of an attorney-general in 1828 the fiscal was the adviser of the government in points of legal difficulty. He was the public prosecutor in all criminal offences committed in Capetown and in some special offences committed in other parts of the colony—ordinary cases being prosecuted by the respective landdrosts,—and he conducted all civil cases for the government. He could interfere with the landdrosts in any part of the colony in cases where they might be suspected of showing partiality, and in exceptionally difficult or important matters. Before the appointment of a police magistrate in Capetown he exercised summary jurisdiction over slaves, vagabonds, and runaway sailors in petty offences ; and he had control of the constabulary arrangements

van Jaarsveld, Adriaan : in March 1796 is one of the leading men of the Graaff-Reinet party that refuses to receive the landdrost appointed by the English government, 7 and 8 ; in August 1796 signs a document promising fidelity to the English government, 16 ; in January 1799 is arrested at Graaff-Reinet on a charge of having committed forgery, 44 ; is rescued from the guard by a party of farmers under the leadership of Marthinus Prinsloo, 45 ; in April is arrested again by a party of soldiers, and is sent a prisoner to Capetown, 48 ; in September 1800 is brought to trial, and is sentenced to death, 63 ; the execution of the sentence is suspended by the governor, 64 ; but the prisoner dies in confinement, 103

Judges : before the establishment of the supreme court in 1828, the judges, in addition to their judicial duties, had various tasks imposed upon them. Two in succession were required to hold a weekly court in the colonial secretary's office, for the purpose of passing and registering transfers of landed property, registering mortgages and other deeds of security, ascertaining the competency of the parties to the acts, and seeing that the deeds were legally prepared. The signature of a member of the high court of justice was requisite to the issue of each note of the paper currency. Two members were required

to be present when defaced or worn-out notes were burned, and two attended to the stamping of fresh notes, the dies whereof were kept under the joint seals of the court and the governor. A member of the court was required to attend the impression of stamps, and his certificate of issue was the check upon the collector of stamp duties. The dies for the stamps were kept under the joint seals of the court and the governor. The judges were also required to execute the duties of coroners in Capetown and the Cape district

Under the English administration the landdrosts were required to visit each ward or feldcornetcy of their districts at least once a year, and to transmit to the governor a report upon its condition. They were political commissioners in the consistories, and presidents of the school boards. The board of landdrost and heemraden formed the matrimonial court of the district. Before it came in the first instance all disputes relative to boundaries of land, roads, or water-courses. To it were referred all applications for land within the district, which it reported upon, and assessed the value if the ground could be alienated without inconvenience. An officer entitled the inspector of lands and woods then commented upon this report and valuation for the governor's information. The board of landdrost and heemraden had the management of the district finances, and performed duties similar to those of the present divisional councils, but could not expend for any single purpose more than five hundred rixdollars without the express sanction of the governor. The district accounts were submitted annually to the examination of the colonial auditor, and were open to the inspection of every

Madikane: is leader of a Bantu horde driven westward by the armies of Tshaka, 390; on the 20th of December 1824 is defeated and killed in a battle with the Tembus and Xosas, *ib.*; his followers are the first Fingos

Mahlapo tribe: mention of, 405

Mail packet service: in 1815 is first established between England and the Cape, 222

Makaba, chief of the Bangwaketse tribe: in 1823 defeats the Mantati horde, 384; is killed in battle with the horde under Sebetsoane, 414

- Ma Ntatisi**, the renowned leader of the horde called after her Mantatis: is daughter of Mochage, chief of the Basia, and wife of Mokotsho, chief of the Batlokua, 370; acts as regent of the Batlokua during the minority of her son Sikonyela, 380; is one of the leaders of a great horde that lays waste the southern portion of the Transvaal territory, 382; is defeated by the Bangwaketse, 384; and in June 1823 by the Griquas, 385; then returns to the banks of the Caledon, and assists to devastate that country, 385; in 1823 attacks Moshesh, but unsuccessfully, 402; in 1824 again attacks him and drives him from Butabute, *ib.*

Matiwana, chief of the Amangwane tribe : in 1821 when trying to escape from Tahaka attacks and disperses the Amahlubi, 380 ; pursues them across the Drakensberg, 381 ; during seven years follows a murderous career in the country west of the Drakensberg, 386 ; in 1827 is defeated on the Caledon by a Zulu army, and retires across the Drakensberg into Tembuland, 392 ; drives the clan under Bawana over the Zwart Kei into the Cape Colony, *ib.* ; devastates a large portion of the Tembu country, *ib.* ; and then settles on the eastern bank of the Umtata, *ib.* ; on the 26th of July 1828 some of his people are attacked and beaten by Vusani's Tembus, aided by an inspecting party of Europeans under Major Dundas, who believe they are opposing Tahaka's Zulus, 393 ; on the 27th of August 1828 his tribe is utterly broken and ruined in an engagement with a colonial commando under Colonel Somerset and an army of Xosas and Tembus under Hintsa and Vusani, 394 ; with a few of his warriors he flees northward to Dingan, who causes them all to be put to death, *ib.*

Maynier, Honoratus Christian David : in September 1799 accompanies General Dundas to the frontier, and makes an arrangement with the Xosas and Hottentots which he calls peace, 53 ; in December 1799 is stationed as commissioner in the frontier districts with very great power, 55 ; gives great dissatisfaction to the colonists, 76 ; in July 1801 parties of farmers appear in arms at the drostdy of Graaff-Reinet, and require him to leave the district, 77 ; by a display of military force some of them are intimidated, and others retire beyond the colonial boundary, 77 ; in October they appear at the drostdy again, and invest it, 77 ; Major Sherlock with a strong military reinforcement is then sent to Graaff-Reinet, 78 ; but so many petitions and letters from friends of the government are sent in imploring the removal of Maynier that General Dundas recalls him, 78 ; and as soon as this becomes known the insurgent farmers disperse to their homes, 79 ; the complaints against Maynier are subsequently investigated by a special commission, 79 ; and he is acquitted of all misconduct, 80 ; after which he sits as a member of the high court of justice, and receives from General Dundas £1,000 as compensation for his losses and expenses, 81

- Synnot, Captain Walter: in 1820 brings a party of Irish settlers to the Cape, 292; and is located at Clanwilliam, 294; subsequent movements of the party, 295
- Taaibosch, Gert: succeeds Jan Hanto as captain of the Koranas at Merumetsu, 420
- Table Bay: plan of Captain Robert Knox for the construction of a safe harbour in, 367
- Table Mountain: fall of masses of rock from, 91
- Tait, Peter: in 1818 and 1819 introduces a few Scotch labourers as immigrants, 287

- Taylor, Rev. John: in 1818 leaves the service of the London missionary society and becomes the first clergyman of the Dutch reformed church at Beaufort West, 248; in December 1823 is transferred to Cradock, 311
- Tembu tribe: in 1809 is found by Colonel Collins living near the sea between the Bashee and Umtata rivers, except one small clan, under a captain named Tshatshu, that occupied a kraal east of the Tsomo, 173; condition during the early years of the nineteenth century, 388 and 389; genealogical table of the chiefs, 389
- Thaba Ntshu: in December 1833 becomes a Barolong settlement and a Wesleyan mission station, 418
- Theatre: during the first English occupation a theatre—now St. Stephen's church—is built in Capetown, 93
- Theopolis, station of the London missionary society: in 1814 is founded, 211; is twice unsuccessfully attacked in the fifth Kaffir war, 276; investigation of Dr. Philip's charge against the government concerning taking land from, 440
- Third Kaffir war: in March 1799 Ndlambe, who has been for some time a prisoner at Gaika's kraal, makes his escape, and with a large body of followers crosses the Fish river and invades the colony, 49; he is joined by all the clans that since 1793 have been living in the Zuurveld, the Gunukwebe only excepted, 49; the farmers flee before the invaders, some of them being obliged to abandon all their property, 50; the Gunukwebe clan, without allying itself with Ndlambe, attacks a column of British troops on the march towards Algoa Bay, 50; afterwards attacks General Vandeleur's camp, but is repulsed with heavy loss, 51; cuts off and massacres a detachment under Lieutenant Chumney, 51; the insurgent Hottentots under Klaas Stuurman and other leaders now join the Xosas, 51; in June two large burgher commandos take the field, 51; but become dispirited by being kept waiting while the authorities carry on long

and fruitless negotiations with the invaders, 52; the united Xosas and Hottentots now overrun and pillage nearly the whole district of Graaff-Reinet, 52; in July a band ravages Longkloof and murders fifteen white people, 52; in September an arrangement is made by the government with the Xosas and Hottentots, under which the Zuurveld is abandoned to the invaders, who promise not to trespass beyond it, 54; after this arrangement the district of Graaff-Reinet remains in a very wretched state, 76; the Hottentots continue to roam about and plunder such colonists as attempt to carry on farming, 81; early in 1802 a commando is called out to punish them, 81; but so few men appear that the operations undertaken are not successful, 81; in May a much larger number of burghers are called out, 83; very favourable terms are offered to Klaas Stuurman, but he declines them, 83; he and his Xosa allies are then attacked by a burgher force under Commandant Tjaart van der Walt, 84; and for several weeks success attends the colonists, 84; on the 8th of August, however, Commandant Tjaart van der Walt is killed in battle, 84; and immediately afterwards the burghers disperse in great confusion, 84; General Dundas then proceeds to the frontier, taking Mr. H. Maynier with him, 84; a few petty Hottentot captains are induced by Mr. Maynier to lay down their arms, but most of the marauders remain defiant, 85; the combined Xosas and Hottentots ravage the country as far west as Kaaiman's river, near the present village of George, 85; in January 1803 a large burgher force takes the field, but as the Hottentots and Xosas are quarrelling about a division of the spoil, they now profess to desire peace with the white people, 86; and on the 20th of February a general cessation of hostilities is agreed to, 86

- Tshaka, son of an inferior wife of Senzangakona, chief of the Zulu tribe : about the year 1783 is born, 374 ; the Zulus are at the time vassals of the Abatetwa, *ib.* ; he grows up to be a handsome and exceedingly agile youth, *ib.* ; excites the jealousy of his father, and is obliged to flee for his life, 375 ; takes refuge with Dingiswayo, chief of the Abatetwa, *ib.* ; in whose army he becomes a soldier, 376 ; and owing to his courage and address soon raises himself to a position of command, *ib.* ; upon the death of his father Senzangakona he is appointed chief of the Zulus by Dingiswayo, 377 ; and upon Dingiswayo's death is raised by the army to supreme power, *ib.* ; he then conceives schemes of conquest on a vast scale, *ib.* ; organises a great army, which he subjects to severe discipline, *ib.* ; as a weapon of offence adds to the assagai a short-handled long-bladed spear formed to cut or to stab, *ib.* ; brings the various regiments under the most perfect system of obedience, 378 ; devises a terribly formidable method of attack, 377 ; then carries on a series of wars of extermination, 379 ; and though he governs with ferocious cruelty gains the devoted attachment of his people through their pride of military fame, 378 ; in July 1828 sends an army westward, which marches to within eighteen miles of the Bashee, 393 ; accompanies the army himself as far as the Umzimkulu river, where he fixes his head quarters, 394 ; lays waste the Pondo country, *ib.* ; then withdraws his army from Tembuland, and returns home, *ib.* ; further mention of, 424
- Tshatshu, chief of a Tembu clan : in 1809 is found by Colonel Collins to have wandered away from the Tembu country proper, and to have settled with his people on the eastern bank of the Tsomo, 173
- Tulbagh, district of : in July 1804 a portion of the district of Stellenbosch is cut off by proclamation of Commissioner-General De Mist, 114 ; to the tract of land thus cut off General Janssens gives the name Tulbagh, 115 ; in August a landdrost is appointed to the new district, 115 ; in September a farm adjoining Roodezand's church is fixed upon as the site of the drostdy, 115 ; in February 1808 a portion of Stellenbosch is cut off and added to it, 166 ; in

- November 1822 it is renamed by Lord Charles Somerset the district of Worcester, 322
- Tijdschrift, het Nederduitsch Zuid-Afrikaansch*: in April 1824 the first number of this magazine appears, 361
- Tyler, Rear-Admiral Charles: on the 7th of February 1813 assumes command of the Cape squadron, 213; on the 15th of October 1815 is succeeded by Rear-Admiral Sir George Cockburn, 242
- Uitenhage, district of: in February 1804 a portion of the old district of Graaff-Reinet is cut off by proclamation of Commissioner-General De Mist, 113; in April the name Uitenhage is given by Governor Janssens to the tract of land thus cut off, and a landdrost is appointed to it, 113; in October a portion of the old district of Swellendam is cut off and added to Uitenhage, 114
- Uitenhage, village of: in 1804 is founded, 114; in March 1817 is first provided with a resident clergyman, 256
- Umjusa, son of Makana: note concerning, 281
- Umpangaxita, Hlubi chief: in 1821 when fleeing from his enemies crosses the Drakensberg, 380; falls upon the Batlokua, 382; is killed in a battle near Lishuane, 392
- Umilikazi: see Moselekate
- Unandi, mother of Tahaka, mention of, 374
- Vanderkemp, Dr. J. T.: in March 1799 arrives in South Africa as an agent of the London missionary society, 59; attempts to form a station near the kraal of the Xosa chief Gaika, 60; but not succeeding in this, he removes to Graaff-Reinet, 60; towards the close of 1801 with a party of Hottentots he proceeds from Graaff-Reinet to a farm near Algoa Bay, where he is assisted by the government to form a temporary station, 81; in 1803 a tract of land is selected for a mission station, which the government grants to the London society, and to which Dr. Vanderkemp gives the name Bethelsdorp, 104; in January 1812 he dies, 201
- Vereker, Lieutenant: in April 1817 is in command of a patrol sent into Kaffirland in search of stolen cattle, 266
- Vice Admiralty Court: in 1828 is abolished, and its duties are transferred to the chief justice, 430
- Volontaire*, French frigates: in March 1806 is captured in Table Bay, 155
- Voa, Rev. Michiel Christiaan: in April 1802 proceeds to Europe, 82; returns from Europe, and in March 1810 is stationed at Zwartland's church, 209; in April 1811 assumes duty as first clergyman of Caledon, 169; in May 1818 retires on account of illness and old age, 257
- Vusani, paramount chief of the Tembu tribe: in 1828 assists in destroying the Amangwane who have devastated his country, 394; further mention of, 390

- Walfish Bay : in December 1795 is taken possession of for Great Britain, 23 ; note upon the name of, 23
- van der Walt, Tjaart : in February 1802 commands in the operations against Hottentot marauders, 81 ; in an engagement on the 13th of February loses one of his sons, 81 ; in June 1802 is commandant-general of the large force called out, 83 ; but on the 8th of August is killed in battle, 84
- Waterboer, Andries, Griqua captain : obliges the Barolong chief Sifunelo to pay six hundred oxen for a theft committed by Molitsane's Bataung, 413 ; but under pressure from the colonial government restores the cattle to their owners, *ib.* ; in June 1823 assists to defeat the Mantati horde, 384 ; in 1832 assists a commandant under Mr. W. C. van Ryneveld, civil commissioner of Graaff-Reinet, against the robber captain Stuurman
- Water supply of Capetown : particulars concerning the, 185
- Wentzel, Willem Adriaan : in January 1828 is appointed resident magistrate of George, 433
- Wesleyan chapel in Capetown : in June 1822 the first is opened, 348
- Wesleyan society : in April 1816 commences mission work in South Africa, 259 ; particulars concerning, 258, 291, 300, 348, 412 *et seq.*
- Wesleyville mission station : in 1823 is founded by the reverend William Shaw, 349
- de Wet, Olof Godlieb : from 1797 to 1803 is president of the high court of justice, 64 ; loses office on the restoration of the colony to the Batavian Republic, 102 ; in 1806 again becomes president of the high court of justice, 154 ; in March 1809 retires on account of ill health, 199
- Whale fishing on the coast : in 1795 is extensively carried on, 23
- Whaling establishment at Robben Island : note concerning, 280
- Wheat : exportation of, 21 ; price of in 1800, 68 ; and in 1806, 155 ; in 1820 the growing crop is attacked by blight, and completely fails, 299 ; in 1821 it is again destroyed by blight, 312
- White, Lieutenant Thomas : in 1820 brings a party of British settlers to the Cape, and is located on the river Zonderend, 293 ; subsequent movements of the party, 295
- William Pitt*, Indiaman : during the night of the 13th of December 1813 is lost on a shoal about nine miles to the eastward of Cape Recife, when all on board perish. The disaster becomes known through a box of letters and some of the passengers' trunks with other wreckage washing on shore
- Williams, Joseph : in June 1816 forms a mission station on the Kat river in connection with the London society, 265 ; in August 1818 dies, 258
- Willshire, Lieutenant-Colonel : in February 1819 succeeds Lieutenant-Colonel Brereton as commandant of the forces acting against Ndlambe, 277

- Willson, Thomas : in 1820 brings a party of British settlers to the Cape, 291 ; subsequent career of, 300
- Wine : encouragement given by the British government in 1800 to the production of, 65
- Wool : account of an abortive effort of the earl of Caledon to compel the farmers to breed woolled instead of African sheep, 187
- Worcester, district of : in November 1822 the district of Tulbagh is thus renamed, 323 ; in March 1824 a small portion is cut off and added to the district of the Cape, 322
- Worcester, village of : in October 1819 a deputy landdrost is stationed at this place, 249 ; in February 1820 the first erven for a village are sold, 249 ; in October 1822 it is made the residence of the landdrost of Tulbagh, 321 ; in September 1824 it is first provided with a clergyman, 310
- Woyer, Jan Pieter : in 1795 and 1796 is one of the chief opponents of British rule in Graaff-Reinet, 8 ; the government endeavours to have him arrested, but fails, 9 ; he proceeds to Batavia in a Danish ship that puts into Algoa Bay, and procures assistance for the nationals of Graaff-Reinet, 18
- Wylda, Sir John : on the 1st of January 1828 becomes chief justice in the newly established supreme court, 431
- Xoas : mention of, 368 ; depredations by in 1813, 261
- Yonge, Sir George : in December 1799 becomes governor, 62 ; is greatly disliked by all classes of the inhabitants, 69 ; complaints of his mismanagement and corruption are sent to England, 69 ; in April 1801 he is dismissed, and is required to return to England, 69 ; a commission is appointed to inquire into his conduct, 71 ; and a mass of evidence of a scandalous nature is collected, 71 to 74 ; measures that may be placed to his credit, 75 ; on the 25th of September 1812 dies at Hampton Court, *ib.*
- Zevenfontein, on the right bank of the Caledon : in 1833 is occupied by a party of colonists, 423
- Zulu tribe : mention of, 374 ; see Tshaka
- Zuurveld, the : attempt by Sir John Cradock to settle a population in, 263 ; similar attempt by Lord Charles Somerset, 263 ; description of by Lord Charles Somerset, 288 ; in 1820 is occupied by a large number of British settlers, 292 *et seq.*
