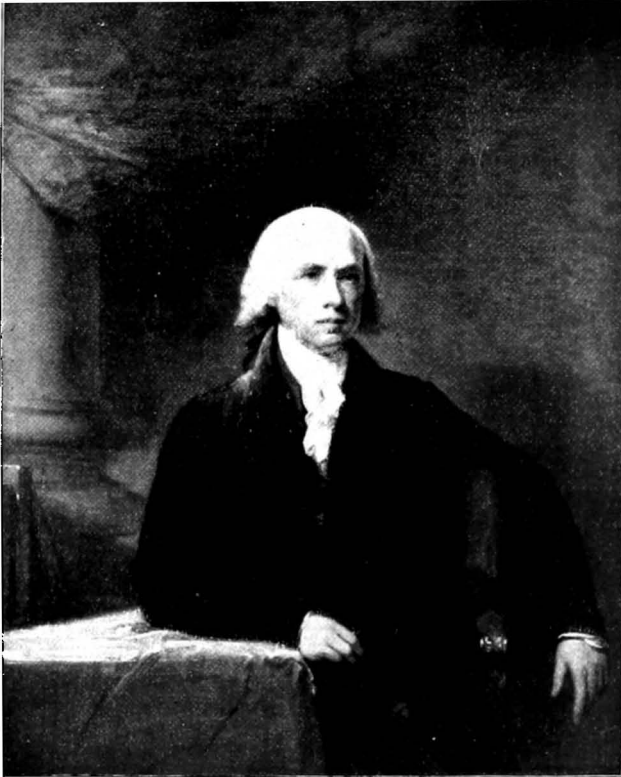

- LORD GRENVILLE.**—William Wyndham, Baron Grenville of Wotton, from an engraving by J. S. Agar after the painting by W. Owen. Lord Grenville was the principal Secretary of State for Foreign Affairs for England and was appointed, in 1794, to negotiate the treaty with the United States known as Jay's Treaty, which was signed on November 19, 1794. . . . . 239
- OFFICE OF THE SECRETARY OF FOREIGN AFFAIRS.**—From an old print. A picture of this building appears in Watson's *Annals of Philadelphia*. The building was situated on the eastern side of South Sixth Street (No. 13), Philadelphia. Robert R. Livingston, in 1782-3 appointed the first Foreign Secretary of Foreign Affairs of the United States, occupied the front room in the second story, and his two under-secretaries, Louis R. Morris and Peter S. Duponceau, occupied an adjoining back room. . . . . 243
- TIMOTHY PICKERING.**—After an engraving by T. Welch from a drawing by J. B. Longacre of the picture by Gilbert Stuart. Pickering was appointed Washington's Secretary of State December 10, 1795, having succeeded Edmund Randolph, and he continued to hold the same office in Adams's Cabinet till May, 1800. . . . . 245
- FACSIMILE OF WASHINGTON'S PROCLAMATION OF NEUTRALITY, APRIL 22, 1793.**—From *Harper's Magazine*, vol. cviii. At this time the relations between the United States and Great Britain were unsatisfactory, and in February, 1793, with the outbreak of war between France and England, certain questions came up for discussion with France. By the Treaty of 1778, the United States had guaranteed certain privileges to France which if now allowed would be very embarrassing to the United States as a neutral power. Washington, however, resolved to maintain an impartial position toward England and France, and issued, April 22, 1793, a proclamation of neutrality, thus antedating the first American Neutrality Act of 1794. . . . . 252

The Supreme Court of the State of Louisiana still holds its sessions in the room where the illustrious Cabildo held theirs—in the room where the transfer of Louisiana took place. Louisiana comprised what is now the States of Louisiana, Arkansas, Missouri, Iowa, Nebraska, parts of Minnesota and Colorado, nearly all of Kansas and Montana, North and South Dakota, Wyoming, part of Idaho, and the Indian Territory . . . . .	296
