Agreeable to your Commands under the 30<sup>th</sup>. Ultimo a proper person was Sent to the Ports adjacent to Enquire with the greatest secrecy what Pepper was to be contracted for and delivered in all February whom is now returned with the following Answer that Mamo Modelier will deliver Ten Candies of Pepper by the 25<sup>th</sup>. Instant at One hundred and twenty Rupees P Candy in Callicut if ready money be immediately advanced him. Maqui will deliver by the 15<sup>th</sup>. Instant the Same quantity at One hundred and ten Rupees in Panany but will not bring it to Callicut. Modeen Cutty will deliver the Same quantity upon the very Same conditions so that the whole quantity procurable according to Babajees report is no more than thirty Candys.

Condoty Paquy has a Servant at Panany who has bought twenty five Candys of Pepper more Since you were last advised for which he gave one hundred and Sixteen Pondicherry Rupees & Candy His Nephew also has purchased Seventeen a half Candys at this place for which he has given from one hundred and nine Rupees to one hundred and Eleven & Candy.

But as there is no probability of any Such Conveyance at present from hence to Tellicherry, We must desire that you leave room in one or part in both of the Ships to take in One hundred and thirty eight (138) Bales being  $34\frac{1}{2}$  Tonns which we have now ready in our Warehouse.

SIR & SIRS

This dispatch is purposely to acquaint you that Oppah Puttarah and his Brother have been some days at Panany enquiring the price of Pepper and as I am informed are in want of a large quantity though as they have made no purchase I have made all the private enquiry possible to find out by whom they are emploied but to no purpose and should they not be for you I fear it is for the French.

I thought it necessary to advise you of this as soon as it came to my knowledge that you might send a proper person thither if you deemed it needfull I haveing only one person here and whom I am obliged to keep to give me what advices may be necessary Relating to this business.

Since my last address under the 6<sup>th</sup>. Instant Condoty Paquy his Nephew has purchased by two and three Candies fifty five Candys of southern heavy Pepper for which he gave from one hundred and nine Rupees to one hundred and twelve Rupees & Candy which is Shipped off for Mahie as also forty Candys bought by his Servant at Panany at one hundred and twenty Pondicherry Rupees & Candy. There is now in this place twenty five Candys procurable at one hundred and Ten Rupees # Candy.

The 11th. Instant returned the Puttarah which carried Mr. Douglas and my joint letter to the Samorine who sent me the following answer that he did not think it needfull to reply thereto as he did not think we had any inclination to bring things to a Conclution or otherwise Mr. Douglas would not have so soon proceeded to Tellicherry though I am certain had he staid till now it would have been just the same he having I realy believe and which plainly appears by his a quevalate [sic] no thoughts either of discharging his Olas or putting them in a speedy course of pay-ment or give us due satisfaction for the loss of the Anjengo Sloop.

His Rajadores as before informed you that the Storekeepers bill for Powder and Ball should be discharged by the 5<sup>th</sup>. Instant though as yet have heard nothing further from them on that head either do I believe I shall

Nothing Extraordinary has happened here then that all is Well, I remain with Dutyfull Respect.

## Sirs

JUST as we were apreparing Advices for the Hoñble Company to be sent to your Factory by the Stafford in Company of the Boscawen and Bombay Grab in order to be forwarded on the first Ship you dispatched Home, private Advices arrived from Bengall dated the 19<sup>th</sup>. November, by which we learn that the Prince William was to be Sent from thence directly for Great Brittain and that the Dragon would be the only Ship dispatched from that Presidency to take in a Loading on the Mallabar Coast and as the Prince William is thus provided for we have come to a Resolution to dispatch home the Salisbury from the Mallabar Coast and she will Shortly proceed to your place in company with the Boscawen this being dispatched by the Stafford and Bombay Grab in order to send you a Supply of 30 Chests of Treasure amounting to Rupees three hundred thousand (300000) as P Invoice and Bill of Lading enclosed, which is equally divided on those Ships.

On the Stafford proceeds Thomas Dorrill Esq<sup>r</sup>. in order to take upon him the Chiefship of your Settlement agreable to the Hoñble Companys Commands having the Presidents Commission for that purpose he has Received his Sall<sup>ry</sup>. to the 24 Dec<sup>r</sup>. and Diet money to the last of that Month.

We would have you dispatch the Stafford and Bombay Grab with all convenient expedition down to Anjengo on whom Thomas Byfeld Esq<sup>r</sup>. is to proceed being appointed Chief of that Settlement as P the Presidents Commission enclosed and M<sup>r</sup>. Bourchier will come hither on the Stafford agreable to the directions now sent to that Settlement. We hereby direct that M<sup>r</sup>. John Robinson proceed to the assistance of Anjengo Factory either on the Stafford or Bombay Grab.

Enclosed is a List of Sundry Articles to be provided for the Boscawens Cargoe to Mocha which you are accordingly to procure on the best terms possible immediately sending a Companys Servant to Mangulore for Such as are to be purchased at that place; M<sup>r</sup>. William Man one of her Supra Cargoes now takes his passage to Tellicherry whom you are duely to acquaint of your proceedings in the purchasing the above Cargoe.

Let Lieutenant Wardman proceed to Anjengo to take upon him the Command of the Military there.

We would have you provide on the best terms possible the like quantity and Scrtments of Sandall Wood as ordered the last Year for the Dodington being wanted for part of the Staffords Cargoe to Canton.

Dispatch the accompanying Packet to Anjengo immediately on receipt hereof.

M<sup>r</sup>. William Hornby now proceeds to the assistance of your Factory He commenced Factor on the  $23^d$ . February 1745/6 and is to take his Seat at your Board accordingly. His Salary has been paid him to the 1<sup>st</sup>. Instant and Diet Money to the end of December.

We shall Supply you with Such Stores as you indented for and can be Spared by the Ship Salisbury.

As we expect that you are advised from the Chief and Factors at Anjengo what money they are in want of you are to supply them accordingly out of the Treasure now consigned you on these Ships which you must continue from time to time to do as formerly ordered.

Should you be under a certainty when the Stafford and Bombay Grab return from Anjengo of there being Pepper Sufficient either at that Settlement of your Place for to load home the Salisbury You are then to dispatch the Commodore and Bombay hither without loss of time but should there not be Pepper Sufficient for that purpose the Salisbury is to be returned to the Presidency in company with the Stafford and Bombay which Vessells in case of necessity you may detain till the 20<sup>th</sup>. February longer than which they must on no Account be kept, as the Stafford must return to your Port for taking in the Sandall Wood for her China Voyage.

In respect to the Princes fixing his Son by Boyanores Sister in a Pallace in the Province of Errevadanaddu which Son is to succeed Boyanore according to the Laws of the Country and will doubtless be in Boyanores Interest during his Uncles Life which Interest is that of the French, and he may likewise at present be a great Check upon the Nombiers which may be prejudicial to the Hoñble Companys Pepper Trade we would have you use your best endeavours to prevail on the Prince to desist from placing his Son in that province with all acquainting him that we desire his Highness will not desturb the peace of the Country on that Account (which you Say he has promised to do untill you receive our Answer in this particular) as we are very Sensible it cannot be to the advantage of it to be in a State of War of that Account And on the other hand use your best endeavours with the four Nombiers to make his Highness suitable acknowledgements for any disobedience they have been guilt [sic] of.

Several of the Articles you sent us under N<sup>o</sup>. 18 in regard to this Affair we cannot clearly comprehend especially the first to fight a Battle, but we cannot conceive to what end as by the 10<sup>th</sup>. Articles All parties are to be put in quiet possession of what they enjoyed before The War commences. Upon the whole is appears to us that the Prince is endeavouring to agrandize his Son (who will be Boyanore) at the expence of the House of Cherrica, you are therefore to use your best endeavours to prevent it on which you on the Spot will be doubtless the best judges [of] the Nature of occurrences but take care to avoid expence without being well assured it will turn in the end to the Hoñble Companys advantage.

We would have you use your best endeavours for recovering the Samorins Debt or as much thereof as you possibly can.

We observe you have Stop'd giving the Samorins Munchues and Vessels passports, but as that will look rediculous without making Reprizals which may prevent your geting the usual necessarys you are frequently in want of from Callicut and involve the Factory there we would therefore have the New Chief make it as an act of favour to the Samorin on account of the good harmony that formerly Subsisted between him and the Hoñble Company and which we hope will be renewed to grant his Subjects Passports as formerly except you find that persisting in not giving them Passports may have a good effect in recovering the Goods that were saved out of the Wreck of the Anjengo Sloop in Respect to which we must Rely on your prudent management.

We admire at your advancing so large a Sum as Nineteen thousand Rupees for Rice so early in the Season especially as your Cash was so low.

It was expressly ordered in our Letter of the 12<sup>th</sup>. September last that the Officers and Europeans belonging to the Military and Artillary of your place should receive their pay from the 1<sup>st</sup>. April last which ought to have been complyed with. The Officers under the Lieutenant fireworker must receive the usual pay.

We would have you inlist as many good Men as are willing to come hither out of those you proposed to discharge from your Garrison.

Let your best endeavours be used to clear the Achamars Debt on the best terms possible.

Remember to Send the Hoñble Company Cap<sup>t</sup>. Masons Obligation for Sending out the People you Spared him for the Service of his Ship agreable to his request keeping an Attested Copy of the Same.

Ensign Target now returns to his duty at Tellicherry also Pasqual Rodrigues Topass Soldier and Peter Advaches who was formerly a serjeant but broke here for misbehavior, Richard Pates is to be sent to Anjengo and they have received pay here to the end of December.

This is to advise you that we have this day contracted for five hundred (500) Candies of Pepper and have a promise that we shall have a much larger Quantity but the latter is uncertain, which we were Ordered by the Board to inform you of as soon as Effected.

We must desire that you will send us a supply of fifty or Sixty thousand (60,000) Rupees as soon as possible being quite out of money.

You will please to dispatch the Express Boat as soon as possible as the Bengall General Letter may be of Consequence as well as the advices from this Factory.

#### GENTLEMEN

WE have been favoured with what you wrote us under the 25<sup>th</sup>. September and now send you inclosed the Duplicate of our last of the 7<sup>th</sup>. October by our Honble Masters own Ship Duke of NewCastle, The Commander of which having omitted to send ashore at Fort St. George thirty half Pieces of Blue Cloth which We put on board him for that place and which We were unacquainted with when he left us We are therefore to request You will demand the Same of him and bring the amount of it to our Credit.

On the 19th. of October sailed the Honble Rear Admiral Boscawen in the Exeter for Great Brittain taking with him all his Majestys Ships and Vessells except the Vigilant, Ruby, Tartar and Swallow Snow, on board the former of which is Commodore Lisle who Sailed for the Eastw<sup>d</sup>. and We understand by the Elizabeth that arrived from Atcheen the 25th. Ultimo was there when she came away. The Chesterfield and Royal George belong<sup>g</sup>. to our Hoñble Masters have both been dispatched for Europe the former near loaded the 12<sup>th</sup>. October and the latter about eighty Tons dead freighted the 2<sup>d</sup>. November, The Fort S<sup>t</sup>. George We have sent to Madagascar for a Cargo of Slaves whither She proceeded the 1<sup>st</sup>. November and by advices from Bengall We learn Edgbaston and Tavistock were to be dispatched from thence directly for England, The Walpole for Juddah, and the Severn and Brittannia for Surat. The Dragon in Consequence of the Directions of our Hoñble Masters sailed for your Coast the 1<sup>st</sup>. Ultimo and must before this reaches You We imagine be arrived with You.

The Augusta that left England some time last February bound for this Place and China having fallen to Leeward was obliged to go to Malacca from whence She arrived the 26<sup>th</sup>. Ultimo and brings Advice that all our Hoñble Masters Shipping of last Year bound from hence to China had passed that Port in Safety.

SIR AND SIRS

Your Commands dated the 19<sup>th</sup>. came to hand this day to which I shall now reply.

A List of Sundrys to be provided for Ship Boscawen I rec<sup>d</sup>. and am to acquaint you that I have purchased the following in part of her indent.  $viz^{t}$ .

Twenty five Candys (25) of Cua fifteen of which I have given twenty three Rupees & Candy Eight twenty two and the Remainder twenty two a half. Saffron two Candys at forty eight Rupees & Candy Ginger four Candys two at eighty five Rupees and the Remainder at eighty five a half Rupee & Candy and Copra five Candys at thirty One a Quarter Rupees & Candy all which please to observe we are to be at the Charge of Shipping off what remains shall be provided if possible but must inform you that their is not a Candy of Saffron or Ginger more at this juncture to be sold that I can hear off though if you can stay fifteen days I can contract for about twelve Candys of each sort at four Rupees & Candy advance I must now advise you that Malabar Goods in general are most Extravegantly dear and much fear their prices will still rise occasioned by the Number of Small Craft which duly arrive.

Your Indent of Teak Beams and plank are not procurable here at present. There are some Timbers though not near enough to say into the quantity of Plank you are in want of and those at Seven rupees and three Quarters & Candy a price I beleive seldom or ever was heard off in this place before therefore defer buying the some till I receive further orders from you relating thereto.

That part of the Tellicherry Indent which is procurable shall be purchased and sent you as opportunity's may offer and no pains shall be wanting to comply with the whole though fear so large a quantity of Wax Candles are not to be obtained the twenty five Timbers you'l please to advise me whether you would have small or large there being a considerable differences in their prices as also the Tallies wither Bamboe or Wood.

I duely observe what you say concerning Pepper which shall be strictly adhired to to the utmost of my ability and as you intend writing me particularly on that Subject I shall only now acquaint you that unless we purchase (as you were formerly advised) as the French have done by two and three candys at a time we shall not be able to do any thing at this Port and this to be done daly as it may Rise or fall which is almost hourly the case here as to goods in general. a Small quantity is now procurable at one hundred and Ten Rupees  $\mathcal{P}$  Candy. Should you aprove of purchasing in this manner you will please to send me such a further Supply of Cash as you may think proper it being impossible for me to inform you what quantity I may be able to procure and as to contract to any considerable amount at this Port or those adjacent I am advised is impracticable.

You will receive by this Toney one Chest of Wax Candles q<sup>t</sup>. five Md<sup>s</sup>. in part of what indented for being agreeable to your directions.

Being in great want of Stationary Ware request you will comply with the enclosed List.

This instant arrived a Pacquet from Fort S<sup>t</sup>. David for your Settlement which I now transmit you.

My Cash Account for last Month is Eronious having omitted crediting your Factory for a Bill of Exchange in favour of Thomas Byfeld Esq<sup>r</sup>. drawn by me on the Chief and Council for value Rec<sup>d</sup>. here therefore now Enclose you a Rectified one.

The five thousand Rupees Rec<sup>d</sup>. this day you have due Credit for. The Letter I received for the Samorine I dispatch [ed] on its arrival.

FROM the advices we have received of the 16<sup>th</sup>. Nov<sup>r</sup>. from Anjengo Factory there is no reason to apprehend but at that Settlement there is Pepper Sufficientwith what you have in Warehouse to give the Duke of Newcastle Dragon and Salisbury their full Charter Party Tonnage and as you must have been advised from thence according to our directions thither of the quantity they have we doubt not but you have given the Duke of Newcastle her full Charter Party Tonnage and with the Dragon likewise so soon as she arrives with you.

The Salisbury will want about three hundred and eighty Tons to compleat her Charterparty Tonnage when She arrives with you the remainder will be supplied here.

You wrote us under the [...] Nov<sup>r</sup>. that you had sent to know what quantity of Pepper could be procured at Cochin, since when you have mentioned nothing further concerning it although we doubt [not] but you have acted therein conformable to the quantity of Tonnage you have been apprized is to be compleated so as the above Ships may be dispatched in time.

But if contrary to our expectations there should be a failure of Pepper at Anjengo and at Cochin so as not to be Sufficient to compleat the Charter Party Tonnage abovementioned lessen the Dragons Charter Party Tonnage conformable to the Hoñble Companys Orders which you have acknowledged to have received and the Duke of Newcastles likewise if not already dispatched and as it is reasonable to judge that the Dragon will be with you before the Salisbury we would have you order those Ships to take in at Cochin what Pepper may be necessary so as the Salisbury may meet with as little delay as possible.

We would have you return this Boat so soon as you can give us certain information when, and in what manner the above Ships can be dispatched. We are

SIR AND SIRS

CONFORMABLE to an Order of Council we are now to lay before you the enquiry We have made regarding the loss which appears on Pepper from April last to December following.

In weighing off five Maunds We found a difference of  $1\frac{1}{4}$  lb Gain between weighing the same off in the manner delivered to the Shipping that is to say at one draft and weighing the said five Maunds at three drafts two Maunds in two and One Maund at another draft which the Merchants deliver their Pepper by.

In comparing our weights with those belonging to the Ship Stafford We found a difference of  $\frac{1}{4}$  lb in 150 lb<sup>s</sup>. ours being so much less.

Muccatum Paqui, Combem Allipy Nelearte Tupy and Cherriandy Cunhamod Pepper Merchants attend and the undermentioned questions put to them.

They are asked in what manner they deliver their Pepper and if before the same is weighed off whether its Sooped and whether its dried and how long. They answer that what Pepper is brought by Sea or in the rainy Season sometimes is wet but that the Warehousek<sup>rs</sup>. Assistants always dry the Same Sufficiently before weighing keeping it out in the Sun for two three or more days as the case may require, and in respect to Sooping they Say that the stones if any happens to be mixt with the Pepper as is Sometimes the case the Warehousek<sup>rs</sup>. Assistants take the Same out before weighing but its in no ways sooped or garbled.

They are asked whether they give the turn of the Scale or weigh the Same exactly. They answer as exact as possible.

They are asked for their daily account of delivery of Pepper. They answered the Same is delivered to the head Linguist Pedroe Rodrigues.

They are asked whether directly or indirectly they have given at any one time or more any present by way of bribe to the Warehousek<sup>r</sup>. or any of his assistants to bring to either of their Accounts more Pepper than they actually deld. To which they all answer they never did neither were they at any time asked for any such thing and were then dismissed. The Warehousek<sup>r</sup>. M<sup>r</sup>. Robinson and his Assistants are asked in what manner the Pepper is issued to the Europe Ships? who answer that the Pepper after garbling is put into Robins or Bags of five Maunds each in order to have it in readiness against the arrival of any Europe Ship, and for the greater dispatch the Commanders generally weigh from 60 to 100 Bags or Robins Gross when the Same is Started and the Tare ascertained and agreeable to what the Nett Pepper of those Drafts turn out they take the whole Cargoe.

The Warehousek<sup>rs</sup>. Head Assistant is asked whether the loss on Pepper from April last to Dec<sup>r</sup>. does not appear somewhat Extraordinary which he thinks is so and is asked how so large a one can arise who says he cano't account for it.

The Warehousek<sup>r</sup>. (M<sup>r</sup>. Robinson) and his Assistants are asked if they keep the garblings or fling the Same away. Who answer that the Garblings is nothing but the Dust of no manner of Service, and that its always flung away, and declare that no Profit by way of perquisite is made by said Garblings.

The assistants are asked for their Day Book who now deliver the Same to us.

Erom these Circumstances it appeared to us there has been no fraud or Embezzelment, but how this Extraordinary loss has arose We must leave to Your Consideration. We are with respect.

I HAVE received the honour of your Letter which informs me of your arrival at Tellicherry to take upon you the Chiefship of that place after congratulating you on your safe arrivall I assure and promise to live with you in the Same good harmony which was always observed with your Predecessors being well perswaded that its the best way to hinder the Mallabars from taking advantage of either of us.

To show your Predecessors how much I wanted to keep up the harmony that was formerly between the two Settlements I desired him to follow the terms of Agreement for Exchanging Dissertors, he always answered me that he had no orders from his Superiors on this head. I supposed that when you arrived you would be empowered to follow the Steps made used [sic] off between the two. Settlements before the War broke out what I request this is on no other account but for the good and tranquillity of both Colonies. Notwithstanding you may have received no orders from your Superiors to follow that agreement yet I can see no Inconveniency that it can be to either of us following the Same.

There is one more essential point that is to hinder the Mallabars taking an advantage of our want of Pepper. I think it will be convenient for us to fix on a price for this Year without which it will vary greatly therefore desire you'l inform me what seems best to you in this particular promising not to give more than what we shall fix on, I hope you'l be perswaded of the Sincerity of my Sentiments having nothing else in view but the good of the two Settlements.

In October and November 1748 M<sup>r</sup>. Douglas procured 6000 which were better being longer and so they ought as there is upwards of twenty two P Cent difference in the prices besides there has been none of that sort to be had since I received the Indent (which was last Month) or any other so good as those I have bought having Pick'd them out of a Quantity however if they will not do please to advise me thereof and I will dispose of them.

Observing what you say in regard to the deficiency of the Spirits of Wine I now send you the Bottle it was measured by and which by what I can learn is the very same measure that has been used for Some years past therefore on Examining the Same should there be any loss I will make the person I bought it off be answerable on being advised thereof.

I am Surprised theese should be so large a deficiency in the Wax in so short a time and its being sent loase may possibly be the cause therefore and which was certainly a neglect but in future the like shall not happen.

You will now receive Invoices from August to January and so soon as what is transmitted you that was purchased last Month you shall have a General Invoice thereof which shall continue monthly to do.

There is at present little or no Pepper in the Place and that from one hundred twenty four to 125 Rup<sup>8</sup>. <sup>(\*)</sup> Candy I have bought none since I wrote you last relating to this Article when I requested to know if I should give that Extravagant price or not and must now beg you will advise me as soon as possible as also inform me how long you intend purchasing as I shall then be a better judge how to proceed as should the French give over soon this Article must consequently fall the Maccaw Ships not caring to buy any at so dear a Rate.

to come to a resolution for dispatching Our Hoñble Masters Ship Dragon whom we kept here untill the 4<sup>th</sup>. Instant and then dispatches her home Thirty Tons 2484 Decimals short of her Tonnage on being advised by you that the Salisbury was to be dispatched to us for filling up but there being no Probability of compleating her Charter Party Tonnage time enough to Safe her Passage Home this Season we loaded on her arrival the 10<sup>th</sup>. Instant forty five Candies One Maund and twenty four (45. 1. 24) Pounds of Pepper being all we had in Warehouse and dispatched her the 11<sup>th</sup>. to Great Brittain Fifty three Tons 71854 Decimals short of her Tonnage Captain Burrows having Declared he was determined to push for his Passage.

We received a Letter of Advice from  $M^r$ . William Hornby by the Salisbury of his Transactions at Cochin likewise a remittance of Rupees Five thousand Seven hundred and forty three and a Quarter (5743. 1. -.) which Sum Shall be brought to the Credit of your Factory.

We are still short of our Contract with the Government Sixty Candys three Maunds and fifteen Pounds (60. 3. 15) of Pepper and have no prospect at present of making a further Investment therefore cannot advise what Sum we may hereafter want to be supplied with thê we shall take bare, and do the same whenever Our Occasions require agreeable to Orders received from the Presidency.

We have now in Warehouse thirteen hundred Pieces of Cloth so much inferior to Muster the we could not accept it besides a thousand more received yesterday and two thousand Peices we Expect daily from Cotata all which we shall Examine without loss of time and endeavour to get Our Merchants to make a proper Abatement for what may be bad Manufacture or return it on their Hands.

It is reported here that the French at Maihie are to send three Ships with proper Forces for Settling at Coletchy therefore if You hear of any movements being made for that purpose please to send us the necessary Advices that we may endeavour to frustrate their Intentions as much as our Circumstances will permit.

OUR last was dated the 7<sup>th</sup>. February Since when we have received your advices of the 31<sup>st</sup>. January # Express Boat 20<sup>th</sup>. February # Ship Stafford Duplicate of the 7<sup>th</sup>. Ult<sup>o</sup>. (the Original of which is not yet come to hand) and your last of the 20<sup>th</sup>. # Ship Mamoody; also your General Books and the Papers enclosed in each of the Packets received agreeable to the List to the Needfull of all which we shall now reply.

We observe you wrote the Hoñble Company in your Letter P Duke of New Castle that you had not received any directions for purchasing Cardamoms which was an omission of ours but you ought to have contracted for them as it is an annual provision and which the Chief and Factors on the like occasion in the Year 1746 very prudently did. But it is likewise an omission in you in taking no notice thereof to us in any of your advice the whole Season which you ought to have done 1749-50-6

on your not receiving any with the Paragraphs of the Hoñble Company's Letter Boscawen transmitted you under the 12<sup>th</sup>. September last when you might have received them time enough to have provided the quantity wanted. However the least consideration would have induced you to act in the manner the Chief and Factors at your Settlement did in the Year abovementioned. You must therefore take care to contract in proper time, as usual for the annual quantity of twelve thousand Pounds weight for next Year.

Our former directions for your providing the Same quantity of Sandall Wood for the Stafford as ordered last year for the Dodington, which was two hundred Candies is what we intended you should procure, and our mentioning three hundred Candys in our advices of the 7<sup>th</sup>. February was a mistake of the Secretarys.

You tell us in your last of the 20<sup>th</sup>. March, that as your Pepper Merchants had failed in clearing their Ballances according to Contract, you were obliged for the Company's Security to Attach their Effects; we suppose you found all other methods ineffectual or you would not have made use of that which has always been esteemed a great hardship as it is hurtfull to their Credit and the usual means made use of on Such occasions has been muleting them which method we would have you pursue.

In regard to the Samorines debt we are Sorry to find there is so little reason to expect a clearance thereof; however force must be the last means made use of and therefore we would have you use all other endeavours for recovering it.

We find on due examination that Ally Rajahs Ambergrease is of a very inferior sort and greatly adulterated and will therefore fetch but a very low price of which we shall more particularly advise by another Conveyance by which we shall write you before the Rains.

The Boyanores taking the title of King we apprehend proceeds from the inducement of the French but as it is greatly derogatory to your Prince, and may be prejudicial to the Hoñble Companys Affairs we would have you engage him to obstruct it all he can.

You do not acquaint us what quantity of Pepper you expect you may have in readiness by the Month of October next which let us know as early [subsequent portion of this letter is lost.]

The King of Travancore keeping the Pepper Trade Still in his own hands we have not been able to make a Contract for this Articles the price he dimands for it greatly exceeding what we are limited to purchase at by the Hoñble the President and Council. And we cannot yet Say what Quantity of Cloth will be provided this Season as the Weavers are pretty exorbitant in their Demands at present so that every thing necessary to mention about Investments is to acquaint You we have in Warehouse this day Ninety two Candies Nineteen Maunds and three Pounds (92. 19. 3) of Pepper and three thousand four hundred and ninety three Pieces of Cloth (3493).

Your favour dated the 13<sup>th</sup>. Instant we rec<sup>d</sup>. the 21<sup>st</sup>. and upon reperusing Our Letter under the 21<sup>st</sup>. Ultimo we imagine that the omission of the word Duplicate must occasion the remark therein Concerning the Pacquet  $\mathcal{P}$  Ship Salisbury as we never cou'd imagine it was detained by you being not only certain at that very time Captain Burrows brought it on Shoar upon his arrival but that the Duplicate thereof and Our Superiors Commands dated the 7<sup>th</sup>. February was what came enclosed to Us under your cover the 25<sup>th</sup>. and which we hope will in every respect clear up this Affair to Satisfaction.

We shall be glad to find what you mention of the French may prove true as their Settling at Coletchey may be of very great prejudice to Our Honble Masters Affairs and we are very Certain an Officer (who had a meeting with the King of Travencore the 6<sup>th</sup>. of Dec<sup>r</sup> last) lined out the Ground for a Fort and procured Musters of the Cloth we Contract for annually (carrying the same to Mahie) besides which M<sup>r</sup>. Bourchier advised the Chief from Cochin that the Commodore gave it as his Opinion the French cause Some Disturbance if the King would not let them Settle Quietly at Coletchee orders for so doing having been sent them from France so that you will observe Gentlemen, we had more Sufficient reasons than Mallabar reports to desire an Information concerning your Neighbours movements.

I DISPATCH this Puttarah purposely to acquaint you that the Governour of this place jointly with the Samorines Ministers insists upon our paying Customs on Wax Candles which was never heard off before in this port and what neither French or Portugueze are desired to do. On Representing to them the unjustness of such a demand they had the impudence to tell me that If I would not comply therewith they would endeavour to make me by Sending Nairs to the Factory which should they do before I Receive your directions I will do all in my power to turn them back again which I have intimated to them that should an accident happen they may blame themselves.

I am now to inform you that the Custom Masters are got to Such a height of impe[r]tinance and Villany that unless they are fel'd they will not absolutely weigh our Goods and by that means will detain our Vessells which may be a great disservice to the Hoñble Companys affairs I was obliged this Season to keep a Grab twenty four Hours on this very Account as also two Munchuas.

In my humble opinion the best way to proceed will be to send Some Gentlemen to the Samorine to lay before him the affronts we have Received from his Ministers and Custom Masters as also the impositions lately imposed on us by which means I doubt not but we shall be Releived it having been many times intimated to me by his Rajahdores that he should be glad of a conference with us.

I must beg leave to acquaint you that if some methods are not taken we shall not only be impeeded doing business with the Same dispatch as other Nations but be daily lyable to further affronts, which I flatter myself you will find some method to put a Stop to.

SINCE my last to you under the  $31^{st}$ . Ultimo I have Received your Commands dated the  $27^{th}$ . by which I duely observe what you are pleased to say concerning the great affront intended the Honble Comp<sup>9</sup>. by the Samorines Ministers unknown to himself which was the reason I thought there would be no danger in turning them out of the Factory besides I was of opinion had I admitted those Nairs to have continued in the Factory (had they fulfilled) have been very justly censured being well assured that on every frivilous pretence afterwards we should be lyable to be treated in the same manner. Theese [sic] Gentlemen are the reasons for my writing you that I would do all in my power to send them back again should they have come before I rec<sup>d</sup>. your directions.

Neither French or Portugueze have that I can learn visited the Samorine therefore cant advise you of the Expence of such a Trip and why we should be the first Nation they endeavour to impose upon I cant pretend to Say. you tell me they where [sic] formerly obliging and why they should be otherwise now is what you cant judge to which I must beg leave to reply they were not so in March 1748/9 which the Second of your board is well acquainted with he being Resident here at that time when one of the Hoñble Companys Vessells Commanded by Captain William Dix was detained here two days by then [sic] not permitting the Captain to go on board aledging that he had received goods out of a Ship in their Road without paying customs which they not only demanded but incested [sic] upon Searching his Vessel, both of which were concented to, and our Second Linguist (Manuel Netto) Sent on board with the Custom Masters. This being a Custome that never before was heard off in this part shows that they were no more obliging then than at present and had I in the Same manner concented, the consequence would have been just the Same, they now looking upon Customs on Reshipping Goods in the Road as the Samorines Real Right and which we Experienced this Season.

In my las[t] Address you were informed that the Governour came to the Factory when we Settled the dispute he no longer incesting [sic] upon the said customs being paid therefore shall say no more on this head, but reply to the other parts of your Commands.

The Grab you desire to be acquainted with that was kept 24 hours longer than necessary by the Remisness of the Samorines Custom Masters was the Dolphin and although she did not belong to the Hoñble Comp<sup>3</sup>. I thought it necessary to advise you of it, as it plainly appears (had She been therrs [sic]) the consequence would have been the Same by the two Munchuas I also wrote you concerning which were sent by your Selves to load with Pepper on Account the Hoñble Company.

WE wrote you last under the 15<sup>th</sup>. Ultimo # Express Boat Duplicate whereof goes enclosed and on the 26<sup>th</sup>. past came to hand Duplicate of your Advices of the 7<sup>th</sup>. April and Original of the 21<sup>st</sup>. # Ship Dadalay. The Original of the 7<sup>th</sup>. is not yet come to hand.

As Pepper is at Such an exorbitant Price as one hundred and forty (140) Rupees P Candy and So Small a quantity as about fifty (50) Candy's only to be procured you acted very right in not contracting for it. Make the earliest enquiry what quantity of this Article may be procurable to the Southward the ensuing Season where it may be expected to be procured at a much more moderate rate as at the abovementioned price we are Sensible it cannot answer at any market in India nor indeed in Europe except on Such an emergency as the dispatch of a Ship rather than bear the expence of her abroad which it may be Supposed was the case of the French the last Season but we need not give you further Directions on this head as you have the Company's orders for your guidance.

As the Prince in such an unreasonable manner expected to be Supplied not only with People but that you should also pay the Expence of the War your refusing him assistance on those terms was very right and in regard to your engaging at any time as Principals in any Disputes with the Country Powers we have frequently given you our Sentiments thereon particularly in our Advices of the 6<sup>th</sup>. January last # Ship Stafford. We cannot consistently with the Honble Company's Orders in respect to monthly allowances to Widows and deceased Soldiers Family's &c<sup>a</sup>. approve of your Setting apart one thousand (1000) Rupees as a found [sic] for their maintainance; althô to the Widows or Family's of such deceased Officers or Soldiers as have on all occasions behaved gallantly and well and at their decease left their Wives or Familys in actual want you may give them once for all Something for their immediate Substance and to Such Widows of Covenant Servants or other European Servants as are left real Objects of Charity, and are desirous of goin[g] to England in Such cases you are to allow each of them forty (40) Pounds to pay for their Passage and provide necessary's for their Voyage which is conformable to a very Charitable Order of the Honble Company.

And in respect to Invalids you are not to make any allowance to Such but those who have behaved well and are worn out by long Service and incapable of earning a livelihood or as have been disabled in Battle or otherwise in doing their duty in the Service and thereby rendered incapable of maintaining themselves to Such you may allow half pay or Something more according to their merit or Circumstances of their Family's This in Substance we directed in our Letter to you of the 29<sup>th</sup>. January last.

Under the 27<sup>th</sup>. October last we transmitted you the Hoñble Company's Military Regulations which direct that the pay of each Company after the Muster Rolls at the beginning of the Month are regularly passed in Council be given to the respective Commanders for them to pay the men which method we understand was practised at your Settlem<sup>t</sup>. Some time before the said Regulations came out but as the same gives a large latitude to the Captains to make what Stoppages they please out of the mens pay and Several instances have been known of the poor Soldiers having been oppressed by such means, we have thought proper to diviate from those Regulations of the Hoñble Company's at this Place and to order that the Military and Artillery Companys be regularly paid by the Military Pay M<sup>r</sup>. at the beginning of every Month (as heretofore Costumary at this Presidency and subordinates) and that he See there be no other Stoppages made out of their pay on account of their Officers than according to the Standing rules of your Garrison. This we esteem the most proper method to prevent the private Men being oppressed, and therefore on receipt hereof (if you have not done it already) you are to put the same in practice again at your Settlement, and continue it in future and to take particular care that no means whatever be made use of that may be oppressive to the Soldiers.

You mention in your Advices of the 20<sup>th</sup>. February **P** Stafford one hundred Rupees (100) to be Advanced the Recruits Sent on that Ship and the Bombay Grab Captain Mostyn has likewise wrote hither that they were advanced one hundred Rupees by him but as we find they only rec<sup>d</sup>. one hundred Rupees in all we Suppose the hundred Rupees advanced by him was on the Company's Account and the same you mention we have therefore given you Credit for only one hundred Rupees on that Account and for Six hundred and ninety Rupees and Seventy Seven Reas for provisions Supply'd them and the Detachm<sup>t</sup>. on board the Stafford and Bombay Grab.

Your rectified Invoice of Arms and Ammunition Sent with the Detachment on the Syren and Louisa is Still erronious as the Drum mentioned therein was not rec<sup>d</sup>. for which you must give us Credit as also for two Musquets two Cartouch Boxes, and two Slings amounting to Rupees thirty three two Quarters and twenty Reas (33. 2. 20) returned you in January last P Ship Stafford in charge of Ensign Target and a Topass, also for fifteen days provisions amounting to Rupees Sixteen three Quarter and Seventy four Reas Supply'd the said Ensign and Topass and an European that was returned in their Company as P Account enclosed.

Enclosed likewise is an Account of pay and Provisions, amounting to Rupees ninety nine and twenty Six Reas to a Naique and three Seepoys that came up from your Settlement in April 1749 and were returned thither in September last by whom an original Copy of said account was transmitted you but which we do not find you have acknowledged receipt of or given us Credit for the Amount, which you must do accordingly.

The Account you sent us of provisions supply'd the Detachm<sup>t</sup>. by the Syren and Louisa is very difficient being no more than a List of the quantitys without the Price to any one Article or the amount you must therefore send us a rectified one that we may give you Credit for the Same.

You must take particular Care to transmit us by the first Conveyance at the opening of the Season and by every Conveyance afterwards a regular and just Account of Quick Stock drawn out conformable to the Paragraphs of the Hoñble Companys Commands of the 30<sup>th</sup>. of Aug<sup>st</sup>. last sent you with our Advices of the 15<sup>th</sup>. Ult<sup>o</sup>. P Express Boat and this must be a Standing Rule at your Settlement in future from which you must on no Account diviate as we shall not esteem any excuse you may make a Sufficient reason for your non compliance herewith you must also take due care to forward it to the Hoñble Company by every Conveyance that offers agreeable to their Directions in the aforesaid Paragraphs.

In our advices of the 24<sup>th</sup>. April P Stafford we took notice of your great neglect in not transmitting us your Diary for last year by that Ship or the Mamoody and altho' two Conveyances has since offered Viz<sup>t</sup>. the Severn and Dadaloy Still you have omitted to send it nor do you take any notice thereof in your Advices by those Ships. However as we hope the Brittannia from Bengall has touched at your Place in her Passage hither we hope you have not omitted that opportunity likewise of forwarding it to us.

On the 28<sup>th</sup>. Ultimo arrived the Jenny belonging to Hodjee Tarr from Bengall As on the 30<sup>th</sup>. did the Walpole Captain Benjamin Lowe Mess<sup>rs</sup>. Holmes Griffith and Lowe SupraCargoes having lost her Passage to Juddah also two Dutch Ships the one on the 27 Ult<sup>o</sup>. from Surat and the other the 1<sup>st</sup>. Inst<sup>t</sup>. from Gombroon (having lost her Passage to Batavia) and are to lye here the Rains.

Sirs

OUR last was under the  $24^{\text{th}}$ . Ultimo by Ship Stafford Duplicate of which accompanys this and by the Severn Captain Richard Dorrill which imported here the  $3^{\text{d}}$ . Instant, came to hand your Letter of the  $2^{\text{d}}$ . Ultimo, whom we shall reimburse the Charges incurred account the Evidences and Prisoners Sent on him as mentioned in your Seperate Letter of the above Date.

As it appears from M<sup>r</sup>. Hornby's representation to you that the Loss he suffered was not through any negligence of his own and that the Money he had with him was to defray his Expences while on the Hoñble Companys Service you may pay him the four hundred and thirty three Rupees and a half but this is not to be esteemed as a precedent on Such like occasions.

You will perceive in the accompanying Duplicate that for the Dispatch of the Duplicate expected Shipping next Season we shall actually be in want of twenty Seven hundred Candy's of Pepper but in respect to the purchase of that Commodity you must have regard to the Honble Company's repeated Orders: we observe the exorbitant and before unheard of Prices that are given for it on the Coast but as it was on an extraordinary Occasion for the Dispatch of the Ships and they are the lowest Prices you could get it at we must acquiesce thereto.

We have examined the Books of your Settlement with as much exactness as well could be as your Diary was wanting to which your Books in many respects refer and the following are such remarks as at present appear necessary to us to be made on them.

We observe that through the Stores Books not being closed the Garrison Stores could not be particularized on opening your General Books and that it occasioned other irregularitys in Gunpowder &c<sup>a</sup>. therefore in future let the Storekeeper be carefull to Ballance the Stores Books in due time that the Accounts of the Settlement may not be kept back and appear distinct and clear.

And for want of the necessary Care in the Stores Books we also take Notice that Several heads are opened on your Books for very Small Sums, Several of which might have been recovered before the close of your Books and those irrecoverable should have been wrote off to Profit [sic] and Loss.

There also appearing the Sum of Six hundred and thirty three Rupees wrote off for Fish and Biscuit [said] to be Spoiled and destroyed, we Suppose it might be from a larger Quantity than usual being laid in account the French War, and although it was So very considerable still we are willing to hope it was not for want of due Care and to which Suitable regard must be had on all Such like occasions.

We also observe very great Irregularitys in the manner of your introducing the Warehousekeepers and PayM<sup>rs</sup>. Sales in your Books, by which means we find on close of them the Produce of the Sales were not paid in till more than a year after they are made, and as that Practice may Subject the Hoñble Company to Losses in case of Mortality in their Servants therefore the Sales must be brought on every three Months, which, as they are Small is a Sufficient time when their amounts is to be paid into the Treasury and in future on your Books Substitute the General Heads of Warehousekeepers and Store K<sup>r</sup>. instead of the Several Persons that have Charge of the Offices who being frequently changed and often holding them provisionally occasion a needless Variety of Heads which will be Sufficiently answered by the above observing that when the Charge of any Office is delivered over that the name of Such Person who takes charge be Specified in the first Journal Entry made afterwards relating to the Office and reference had to the Consultation wherein the Change of Office is made.

In the Journal Page 161 Account Current Bombay is Charg'd eight hundred and ninety one Rupees two quarters and twenty One Reas a Loss in weight and difference in Price of Cardamoms sent to England. The latter is what has frequently happened the Cardamoms being Shipped off before the Price was adjusted with the Merchants therefore that Difference may be justly charged to Account Current Bombay But in Respect to the Loss in weight being dirt and Stones as expressed in the Journal amounting to Rupees three hundred and sixty, two quarters and forty three reas it is otherwise as it ought to have been allowed for by the Merchants before the receipt of them into Warehouse and which Sum you ought to Recover for them. We also Observe in page one hundred and three Interest allowed for Cardamoms to 31<sup>st</sup>. March a Contract of the late M<sup>r</sup>. Rawdon's taken on Records of Fort St. George

the Honourable Company's Accounts a reason should have been assigned why they were not paid for before that time as Interest was running on account this Contract [and] you were in Cash.

We are Surprized to see such mistakes in the head of Cash on your Books which shew agreed [sic] want of Care in keeping them and that your head of Cash in the Ledger and General Cash Book were not regularly adjusted till the Close of your Books or such an Irregularity must have been perceived before for we doubt not of your counting your Cash monthly agreeable to the Company's Standing Orders and Care must be taken that such Errors may not happen in future.

It is exceedingly inconsistent with the distinctness required in Accounts to bring on the Hoñble Company's Estate at Callicut in the manner you have done for some years past as if it consisted only of an Empty House. Regard must be had in future to distinguish the Particulars that compose the Ballance of that Factory.

We observe the Plantations on Durmapatam are an annual Expence of about two thousand Rupees and in the Course of Seven Years the Charges on them have amounted to fourteen thousand three hundred and ninety seven Rupees you no where take notice whether there is any Income for this great Expence or when any Produce may be expected to recompence it whence we are not able to Judge whether they are worth the carrying on at such an Expence or not we also observe this Charge arises Chiefly from Provisions &c<sup>a</sup>. to the Madagascar Slaves who Cultivate the Plantations and as their Charge of Diet run so high we would have you consider whether their Labour is equivalent to their Expence or whether the Plantations could not be equally well Cultivated by hired People at easier Rate therefore we would have you charge [subsequent portion lost].
