V2, L: 194.438.M5 A852.1 14305 In the present posture of our affairs on the eastern frontier of India, it is not nnimportant to consider the character of the people inhabiting the regions beyond the Ganges, when it is remembered how much our intercourse with those semibarbarous nations has been impeded by our ignorance of their national prejudicas and our contempt for their mental qualities.

The extra Gangetic nations divide themselves into upwards of thirty branches, which, they maintain, possess in common the same physical conformation. Their average height is 5 feet 3 inches, and they weigh about 120 lbs. each; they are active, fleshy, strong, and symmetrical in form. The Chinese, Siamese, and Kareens, are the fairest; the Arracanese, Burmese, and Peguers the darkest. The first three are of a bright cane colour; the last three are dark bamboo: the other Aribes are of every intermediate shade. They have all a more uniform standard of confermation than prevails in the Caucasian race; the deviations from the fixed standard being few, and these not of an important character.

With regard to the Burmans, it is obvious to the most clasual observer on the spot, that the country is gradually falling to decay. While the people of India are pressing forward with rapid strides, in defiance of the trammels of gasts, scarcely glancing behind them, and then only to smile at the errors of their ancestors, the Burmese are receding from twilight into darkness, gathering their wisdom from books fourteen hundred years old, turning the fables of their forefathere into truths, pausing in puerile admiration over the knowledge and exploits of their ancestors, and lamenting their own fallen condition ; the government meanwhile, regardless of the value of life, draining an already half peopled country of its inhabitants, towns dwindling into villages, and villages disappearing altogether, communication becoming less frequent, the people, dispirited by oppression, passionately attached to the soil, anxiously waiting the fulfilment of the prediction, which promises them restoration of their lost happiness and power, under a wise and just dynasty.* The wars, which had prevailed since the twelfth century, at one time between the Shans and Burmans, at another between the Siamese and Peguers, and at a later period between the Peguers and Burmane, had almost stripped those regions of their inhabitants, when the warlike propenmities of the successors of Alongpora gave the final blow to the prosperity of Burmah. They robbed their cities of every able-bodied man and carried their arms into Siam, Arracan, Assam and Cassay, exterminating the people wherever they came, till the whole tract, from the 95th to the 100th degree of longitude, and from Cape Nagrais to the Tropic, became nearly untenanted, by human beings. This vast tract is now overrun with an extensive jungle which enclosed within its gigantic embrace the ruins of numerous forts and temples, that serve to indicate the spots which in former times were crowded with a dense population, whose descendants are gathered in scanty groops upon the banks of the magnificent rivers, which still water the land. But they have lost the enterprise and valour which for ages rendered them the terror of every neighbouring country, and retain only the vanity, obstinacy, and reatlessness by which they have always been characterized. These degenerate people seldom engage in any pursuit which demands much mental application ; their books upon religion and scientific subjects are translations from the Palee : they have no knowledge of perspective, sheir drawings being all in profile; their poetry is confined to odes and songs of love and war, the larger poems being paraphrastic translations of the great Hindu opics; their knowledge of music is very limited ; their system of anatomy is imperfect ; they are unacquainted with chemistry, and believe in the transmutation of metals. On the other hand, they are acquainted with vegetable physiology, and zecognise the sexes of plants ; they can work in gold, with considerable taste ; they can weave intricate patterns, which even in England have been found difficult to imitate, and they can carve in wood with tolerable ingenuity; but, upon the whole, they do not excel, or even attain mediocrity, in any art which demands elaberate manipulation ; and the few manufactures which they still possess floursched among them in higher perfection at the moment of our first acquaintance with them than they do at the present moment.

The vivacity of the Burmans is observable in their conversation ; they taik over trifles with the same sest and interest as the people of other countries discuss events of momentous importance. We are sorry to add, that they season their discourse with the most astounding falsehoods, which pass without any other notice than a smile, for lying is not held in much disesteem ; on the contrary, it is a national boast, that the Burmans are without equals in their adroitness in concealing the truth. Candour and sincerity are unknown to them; they are early taught by experience to study precaution, and practice dissimulation in every action of their lives. Happy or asd, their physiognomies announce neither pleasure not grief; questioned upon the simplest topic, they return an indirect reply. Empty are their promises, and idle their professions of regard; artifice and curcumventions are resorted to as the legitimate means of obtaining their ends, and so necessary are they considered, that the man who should employ neither deceit nor stratagent in the attainment of his object would be looked upon as little better than a fool. At the commencement of hostilities in 1823, such had been the discouragement to respectable English merchants, that there were no more that three houses in Avs, and four at Rangoon, to supply a population of nearly three millions with foreign goods, and it was not till the termination of the war that trade was placed upon a firm footing. Numerous restrictions having been removed by a commercial treaty, the return of peace brought a considerable influx of [English traders, and imports of plain and coloured cottons, muslins, Sopium, arms, and wrought iron, were made to a large amount, which was annually increasing, the returns being teak, bullion, rice, and cutch, when a suspension of friendly intercourse between the Company and Tharawaddy suddenly annihilated the trade, and what, is infinitely more deplorables left us without a guarantce for the performance of the remaining articles of the treaty of Yandabo.

The Burmans are vain, obstinate, and suspicious ; the uniformity which pre-Tails throughout the entire population, in their physical structure, extends in an equal degree to their moral development of 'character; the diversity of talent, the variety of aspect, and disparity of form, so conspicuous in individuals of the civilized countries of Europe, are scarcely to be found in Burmah ; the king and the Mekran prince are almost the only exceptions to the mediocrity which every where prevails. The national characteristics are, perhaps, less strongly marked in the priests, arising from the life of study and devotion which they are compelled to observe; but these are not perpetuated, in consequence of their celibacy. Each person conforms to the habits of the mass ; and, in respect of fortune, they are more upon a par with each other than any people who dwell in cities. Each has the same opinion of himself, of his country, and of foreigners in general. Symmetrical and robust, the Burman affects a contempt for the "black stranger" of India, who is lightly formed, and trammelled with the observances of casts. With respect to his country, it is the most favoured region of the south-island : its rocks are rubies, gold its sand." Its king receives tribute from a hundred and e vassal princes of Shans and Kareens; he once conquered Arracan, Assam, Siam, Pegu, and Tenasserim, and drove away an army of Chinese invaders, "whose weight pressed the earth from its centre." With regard to foreigners, all Living to the west of the Ganges (with the exception of the Arabs) are "strangers," divided by caste, black, poor, and timid. The Chinese live near the rising sun, are fain of complexion, ingenious, and industrious ; the Siamese are the handsomest, and the most cowardly; the Arracanese the darkest, the poorest, and the most servile. With these extravagant notions of themselves, the Burmans enter-. wd upon the war with the company in 1823, and, notwithstanding our signal success, their ideas have undergone very little change. The courage and magnanimity of the English have excited no admiration ; our moderation has been oversooked, and our retention of the kingdoms which we conquered has inflicted an incurable wound upon the national vanity. Even his highness, Tharawaddy, who fied before our troops at Prome, and entreated his brother to make peace with the terrible foreigners, has outlived his own fears, and forgotten his own advice. The sich presents from the viceroys to the north, south, and east, no longer pour into his treasury : the splendour of his court is diminished, and the reliance of the people upon the excellence of sovereign power has already begun to waver. In contemplating these evils, he ascribes them to the wrong cause, and is about to attempt their cure by the wrong means. Instead of looking to the insatiable ambition of his predecessors, and more immediately to the hostile propensities of his brother, as the cause of the invasion of Burmah in 1823, and to the inability of an impoverished country to maintain a struggle with a wealthy and flourishing state, as the occasion of the series of disasters which befel the Burman army, he traces the first to the artful policy of the company, in making the collision of two. parties on the frontiers of the two states a pretext for guarrel between the powers **themselves:** and finds the origin of the second in the imbecility and treachery of his brother's advisers ! Instead of seeking the remedy for the wasting malady which has brought the country to the point of dissolution, in remodelling the government and adapting it to the emergencies of the times, he imagines that the resumption of the lost provinces will arrest the progress of decay, and ultimately restore his kingdom to its former vigour. To accomplish this undertaking, he well knows he must be aided by other powers, and to enlist their sympathies he must make them sensible of the dangers which encompass them. The Company's inordinate thirst for universal dominion is the theme which they best understand ; it speaks to their experience, and kindles their alarm; they have all suffered more or less by our propinguity, and if any of them have received occasional be-. nefit from our protection, it has rendered them envious of our prowess.

To drive out the common enemy by a simultaneous movement of the Indian princes, has been contemplated a hundred times, and attempted upon more than one occasion; it is still the favourite project of the discontented, and will be put in operation again, whenever a fitting moment may present itself.

in operation again, whenever a fitting moment may present itself. • A tradition is now circulating among the Burmans, that the seventh sovereign of the dynasty founded by Alongpra will be replaced by a prince of supernatural wisdom to whom universal dominion will be given over the "south island," that is, the world bateral ridges of less height, which however present rapid declivities on the east and west. Three mountain-passes traverse the Anaupeetau-meaw Mountains and connect Birma with Aracan. The most southern, called the Tongho Pass, leads from Padaong Mew on the Irawaddi, 13 ° 34, to Tongho in Aracan, 19 ° 15' N. lat. The highest point of the pass is 4,692 feet above the sea, and many parts of it are so difficult that it cannot be travelled by beasts of burden. The eastern ridges are contmonly covered with bamboo jungle, but on the westeru declivity there are extensive forests of lofty trees. The second pass connects Sembeghewn, in the valley of the Irawaddi (20 ° 40' N. lat.), with Aeng in Aracan (19 ° 53' N. lat.), and is called the Nairiengain Pass, from a small stockade of that name erected on the highest part of it. The Birmans used it as a military road to Aracan, and had rendered it passable for beasts of burden by building bridges over the pre-cipites and cutting away the rocks in many places. Before the occupation of Aracan by the British, a considerable commerce was carried on by means of this road. This commerce is said to have occupied 40,000 persons, but this number seems greatly exaggerated. This road is now rapidly falling into decay, being exposed to the destructive influence of the south-west monsoons. The third mountain-pass begins likewise at Sembaghewn and leads to Talak in Aracan, 20 ° 10' N. lat.: by this Pass the Birmans entered Aracan at the time of the con-quest of that country. But it seems that they did not use it afterwards, probably because that which leads to Aeng presented less difficulties. We have no infor-mation of any kind respecting this road. To the north of 21 ° N. lat the mountains appear to decrease considerably in height, but at the same time they divide into several ranges, running mostly north and south, and occupying a considerable tract of country. tribes are the Kookis, and on that account this country is called the highland of the Kookis.' It has not been ascertained how far the authority of the court of Ava extends into this region. Thus far the western boundary of the Birman Empire is formed by mountain-ranges. The remainder, from 24 ° N. lat. up to the Nagas Mountains, which divide it from Assam, is bounded by the territories of the Rajah of Munipoore, a prince who has placed himself under the protection of the British, and whose country extends eastward as far as the Nampagna River, a branch of the Khyan-duaen, which constitutes the boundary line of the Birman Empire in this part. The northern extremity of Birma is again separated by mountain-ranges from the neighbouring country. The ranges called Patkoi or Poapno Mountains, which rise to a great height, and the still higher Langtan Mountains, divide it from Assam and the countries along the Upper Brahmapootra. In the high summits, whence the Brahmapootra decends to the west, are also the sources of the Irawaddi, which river may with great propriety be called the river of Birma, as all the sountries drained by it and its tributaries belong to that emipre, with the single exception of the Southern part of Munipoore. It has lately been ascertained that no part of the Chinese empire extends so farwest as the banks of the Irawaddi. We shall, therefore, follow the course of this river, and make some observations on the countries drained by it. The different opinions respecting the source of the Irawaddi, and its identity with the Zangbo-tain of Tibet, will be examined under the head of BRAHAFOOTRA-Lieutenant Wilcox was informed that its source was at no great distance from Manchi, a fown of the Bor Khamti. From the country of the Bor Khamti the Irawaddi continues its southern course through three degrees of latitude to Bhanmô, through countries about which we have scarcely any information at all. It would seem that high mountain-ranges frequently close upon it, and at other places plains of considerable extent border its banks. Such on its western side are the Samokhtura Mountains and the plain of Mungkung, extending on both sides of the Mungkung river far to the west. The mountain-ranges are partly in possession of the Singfos, a powerful mountain which also occupies a considerable portion of the mountains south of Assam, and every where maintains its independence in the mountain-fastness. The ranges which divide this portion of Birma from the Chinese province of Yuunan seem to be exceedingly rugged, and the difficulties encountered in traversing them have always frustrated the attempts of the Chinese to conquer the countries along the Irawaddi. From Manchi to Bhanmò the river falls in the course of about 350 miles 1,300 feet, being at the latter place only 500 foct above the sea. Bhanmò is a place of some noto, being the principal market for Chinese goods, which are brought to this town on horses and asses. Below Bhanno the river, suddenly turns to the west, but soon resums its southern course, and thus continues to a few miles east of Amsrapoora. The river flows in this tract through a valley of no great breadth, the mountains inclosing it on each side, and frequently advancing to the very banks of the river, espacially on the east. The city occupies the north-east angle of the whole, and extends nearly up to the mouth of the Myiting' river. The outer town lies to the south-west of the city. The whole is surrounded by a brick wall fifteen and half feet high and ton feet in thickness, with innumerable embrasures about the distance of five feet from each other; or the island of the wall there is thrown up a bank of earth, forming an angle of about forty-five degrees. The ditch round this wall is inconsiderable, and during all the dry season fordable in every part. The Myitinge on the east face forms a founderable defence on that side. The city is enclosed by a separate wall, which is better constructed than that of the large town. The ditch on the south and west faces of it is also broader and deeper and not fordable; the east side is de-fended by the Myiting, and the north by the Irawaddi. It is mostly occupied by the palace of the king, the Rung d'hau, or hall of justice, the Lut d'hau, or council chamber, the arsenal, and the habitations of a few courtiers of distinction. All these buildings are situated in a square, which is surrounded by a strong well-built wall about twenty feet in height; and on the outside of this wall and at no great distance is a teak-wood stockade of the same height as the wall.

The most important place on the Irawaddi, between the mouth of this river and the capital of the Birman empire, is Prome (about $18 \circ 50^{\circ}$ N. lat.), called by the Mahommedans Pron, whence the European name derives its origin: the Birmans call it Pri (pronounced Pyi). It is a thriving town, and contained in 1827, short-ly after the war, upwards of 10,000 inhabitants. This place, or rather one lying about six miles to the east of it, is reported to have been the most ancient seat of the Birman government, at an epoch which begins some centuries befor the Christian era. The ruins of the ancient town consists of a broad, earthen wall, of a quadrangular form, from five to gix feet in height.

country is much more considerable, and here the water of the river is used for irri-gating the rice-grounds. The country which extends to the eastward of the Delta seems to be of the same description. It is drained by the Pegu river and the Setang. The Pegu river, which is called by the natives Bagoo Kioup, or 'Pegu Rivulet,' has its source in the Galladzet hill, and unites with the Rangoon branch of the Irawaddi three miles below the town of Rangoon. It is navigable only a few miles to the north-ward of the town of Pegu, which advantage it owes wholly to the action of the tide. - In the fair season it is almost dry at low-water. The Setang has its sources near the 20th parallel, and runs southward the whole of its course; till it empties its waters into the northernmost angle of the Bight of Martaban. This river, where it is of great breadth, is rather a considerable arm of the sea than a river. Beyond the reach of the tides it is an inconsiderable stream ; and even as low down as the town of Tongo it is only navigable for boats. Its mouth is confied by sand-banks, and is liable to a dangerous bore, which renders its navigation im-practicable for large vessels, and difficult for vessels of all descriptions.

Of Upper Lao, or that portion of Birms which extends on the left bank of the Saluen river, botween the Chinese province of Yunnan and the kingdom of Siam, we have so little information, that we only know it to be a mountainous country, which however contain some fertile and cultivated tracts along the courses of the rivers. It seems to be rich in metallic wealth.
We conclude our description of the Birman Empire with a short notice of the Saluen river, which forms the eastern boundary-line between it and Siam, and the Birtish province of Martaban, for between 500 and 600 miles. The Birmans, who call themselves Mranmas (pronounced Myanmas) or Brahmas (pronounced Byahmas), occupy the centre of the empire, between 18° and 22° or 23° N. lat. and extend from the Aracan mountains to the Saluen river. The lan-guages spoken by the Yo or Io, and those of the Kyain and Karcna, are only dia-lects of the Birmain language. The Yo inhabit the billy country extending west -of the Danghii hills to the mountains of the Kockis; we know very little of them. The Kysins, who call themselves Kolour, are the inhabitants of the Aracan mountains, but many of them have soutled in the valleys on the west of the Ira-waddi; they are a peaceful industrious tribe, who cultivate the ground and weave soloth of cotton and silk. The men and women tattoo their faces all over, in lines mostly describing segments of circles. The Karens or Kariaus live partly inter-mized with the Peguans in the Delta of the Irawaddi, where they call themselves Play, and are the most industrious cultivators of the soil. They occupy also the hilly and mountainous country on the upper branches of the Sciaing, near Tongo, where, according to the statement of Sangermano, they have preserved their in-taban, as far as the mouth of the Junzalen. The Peguans, who as no distant time formed an independent and powerful sa-ton, seem at present not to be very numerous. They are called Talains by the Birmans, and by themselves Moan : they occupy nearly exclusively the low coun-try between the Delta of the Irawaddi and the Saluen river. nipoore and Chittagong. The Singfos and the Naga live in a state of independ-ence. The Birmans are greatly inferior to the Hindoos in civilization, and still more so to the Chinese. Like the Talains or Peguans, they tattoo or stain the skin with an indelible tint, but this practice is confined to the men. Not to be tattooed is considered a sign of effeminacy, and there is no one who is not tatteoed more or less. They bore the lobe of the ear, making a very large and unseemly aperture, into which a gold or silver ornament is put, or a piece of wood, or roll of paper. If the aperture is not occupied, a man or woman, after smoking half a cigar, thrusts the remainder into the ear for future use. They consume large quantities of to-bacco in the form of cigars ; and also much betel, which they mix with the areca nut, lime, and a little tobacco. Their dress, though upon the whole not unbecoming, is much less to than the flowing and graceful garments of the western nations of India. Too much of the body is left naked, and the fabrics worn are comparatively coarse and homely. Umbrellas, which are in general use among all classes, are among the principal insignia of rank or office. The colour of the dress of the priest is yellow, and it would be deemed nothing less than sacrilege in any one else to use this colour. The Birmans are very uncleanly in their food. They eat all kinds of reptiles, lizards, iguanas, and snakes; and as their religion forbids them killing animals for food, they generally eat those which have died of disease. Venison is the enly meat permitted to be sold in the markets. The killing of a cow is punished with peculiar severity. The Birmans are of a gay character, and fond of amusements, which are princi-pally chees, music, the exhibition of fire-works and some kinds of dramatic raver.

All their cotton fabrics are for an high priced, and British piece-goods are imported in considerable quantity. Silk articles are coarse and high-priced, but durable. All the colours given to these fabrics are fugitive, especially those of the cottons. Coarse and un-glazed earthenware is of very good quality, and cheap. Those known in India under the name of Pegu jars often contain 180 gallons; but the Birmans are un-acquainted with the art of making any kind of porcelain. Their iron manufac-tures, which are always coarse and rude, consist of swords, spears, knives, scissors, and carpenters' tools. Muskets, or rather matchlocks, are made at Ava, and the best tempered swords are imported from the country of the Shans. Brass ware is not much used, lacquered ware being chiefly substituted for it. The manufacture of this ware is very much extended, and in this the Birmans display invention and taste, but the best description is imported from Lao. Gold and silver ornaments are manufactured at the capital; some are good, but in general the jewellery is clumsy and rude, and inferior to that of India. In Birma, as among other nations which have embraced the religion of Buddha, priests to instruct youth. The monasteries are the only schools, and the priests generally the only teachers. Education is entirely eleemosynary : the children even live at the Kyaongs, and the parents only make occasional presents to the priests. The children are instructed for about six hours in the day in reading, writing, and the four common rules of arithmetic. There are few persons who do not know how to read, and not many who do not write. The girls are instructed by the nune, or female priestesses, in reading, and some also in writing, but that is less general.

The precise time of our arrival in Birmah is uncertain, but we very early pos-sessed factories at Prome, Ava, and on the borders of China, probably at the Birman frontier town of Bamau. These were afterwards forfeited by the miscon-duct of the Dutch, who likewise had settlements in the country ; and Europeans of all nations were banished from Ava. In 1687, Captain Weldon was sent to Mergui, to declare war against Siam, and yon his return, he took possession of the Island of Negrais, in the name of the Bri-tish. By Captain Weldon's report, the island appears to have belonged to the Siamese at that period. On this island the Government of Fort St. George estab-lished a settlement. Prior to this, however, the British Government made two unsuccessful attempts to obtain a location in the country, and particularly 'at Peammoo on the confines of China.'

of China.' Notwithstanding the early date of the arrival of the British in Birmah, no re-gular official intercourse appears to have been instituted until the year 1695, when Messrs. Fleetwood and Sealy were sent as ambassadors to the Court of Ava; some trifling advantages were obtained from this mission. In 1697 the Govern-ment of Madras again deputed a Mr. Bowyear as ambassador to the Birman Court. He did not however proceed to the capital; and commerce was carried on without further protecting efforts on the part of the British Government. In 1709, Mr. Fitt, Governor of Madras, deputed a Mr. Allanson or Alison to the Court of Ava. This gentleman was twice at Ava, and we may reasonably conclude that his missions were successful; for several years after the date of his missions, the English were settled at Syriam, and trading freely be-tween the British possessions and Birmah, under the protection of residents, who were, however, supervisors of private trade, and not immediately in the service of the Company; that body itself having had no commerce with the Birmans, after its expulsion in the 17th century. The supremacy of the Birmans over the Peguers continued throughout the seventeenth, and during the first forty years of the eighteenth century; when the Peguers in the provinces of Dalla, Martaban, Toungo, and Prome, revolted, a civil war ensued, which was prosecuted on both sides with savage ferocity. These advantages they pursued with so much vigor that early in the year 1752, the capital of Ava was invested. The Birmans, dis-heartened by repeated defeats, after a short siege surrendered at discretion. In 1754, both the English and French nations had re-established their factories at Syriam, and of course had their separate interests. The French favored the Pequers, whils the English leaned to the Birmans; but until the vicinity of their residence again became the seat of war, neither engaged in open hostility; their partialities were manifested by giving assistance, but in secret, and supplies clan-destinely conveyed, probably more with a view to private emolument than from any enlarged political consideration. The seat of war between the Birmans and Peguers becoming likely to be con-fined to the mouths of the navigable rivers, and the numerous creeks and canals that intersect the lower provinces of Pegue, and communicate between the largeer streams, the Birman king Alonpra, formed a right estimation of the advantage to be derived from an alliance with nations versed in the arts of maritime war; in order, therefore, to gain the good offices of the English, or at least stipulate for their neutrality, he sent a deputation to Mr. Burke, Resident at Negrais, and at that time chief of all the English factories. The Birman deputies were escorted by Captain Baker from Bassein, and arriv-d at Negrais on the night of the 22d March 1755. Birman Monarch. The English deputation proceeded slowly up the river. "On the Sth of September, Captain Baker reached Ava, lately the metropolis of the empire. Alonpra had removed the seat of government to Moutshobo, which he constituted his capital. On the 12th he reached Kyouk Myoung, situated on the west bank of the Irrawaddy, and on the 16th he received a summons to at-tend "the golden feet." During the interview, the new monarch vaunted of his wictories, and the extent of his empire; he upbraided our national character in an affair at Dagon, where some English had fired on some Birmans, alleging that he had treated the English with kindness, which they repaid by perfidiously break-mine of friendship given to him on his departure from Dagom. At a second audience, a tew days subsequent to the next, his Majesty dictated a letter, addressed to Mr. Burke, in which the granted permission to the Company to establish factories at Dagon and Bassein, having determined on the total demolition of Syriam. Captain Baker made a further requisition of the island of Negrais. Although this desire was not refused, the formal assignment was post-pond; but as it was his Majesty's intention shortly to repair to Rangoon, to con-duct in person the Pegue war, the completion of the grant was deferred to a fu-ture opportunity. Captain Baker having obtained his dismissal set out for Khyouk Myoung, and on the 29th of September-embarked to return to Negrais. The English interests in India, during the time that hostilities still continued between the Birmans and Peguers, were suspended in a doubtful scale; Negrais was in consequence neglected, though not yet abandoned. The Talion or Pegue government, by the surrender of their capital, being now extinct, it became ne-cessary for foreigners to conciliate the new sovereign. Alonpra had summoned Mr. Newton, Resident on the part of the East India Company at Negrais, to at-tend him at Prome. An that instant, a number of armed Birmans rushed into the house, and harbarously murdered every soul except Mr. Robertson and three Europeans, who after defending themselves in a godowun surrendered on an assurance that the slaughter commenced, but perceiving the danger, he fied to the water-side, and was brought away by one of the ship's boats. After the Europeans had been despatched, a general massacre of the natives took place; and of the whole sottle-ment out 960 men, 4 women, and one child escaped to the ships. The Birmans thus becoming masters of the fortified works, turned the guns of the battery against the English ships, which were greatly damaged. In the per-formance of this diabolical assassination seems to have been executed under this direction. Captain Alves, the Commander of the Victoria, was fortunately not on shore when the massacre took place. He returned to Bengal in the begin-thing of November, with the tidings of our misfortunes. Upon the subjugation of Arracan, great numbers of the native population field from the cruelty and oppression of their conquerors, and either found an asylum in the British territories, or secreted themselves amongst the hills and thickets, and alluvial islands along its southern and eastern boundaries. From these haunts they occasionally sallied, and inflicted upon the Birmans in Arracan a feeble reta-liation for the injuries they had sustained, 'retiring to their fastnesses when their purpose was effected, or when encountered by a "superior force; and even taking refuge in Chittagong unknown to the British authorities. On its being ascertain-ed that three distinguished leaders of these robbers had sought refuge in the Bri-tish districts, a Birman army entered our territories in pursuit of them, without any previous representation of the cause of their aggression or intimation of their purpose, whil at a force of twenty thousand men was assembled at Arracan for their support. To meet these threatening and hostile demonstrations, the British Government promptly despatched a force under General Erskine to the Chitta-

Rangoon on the 1st November. The viceroy arrived at Hangoon a few days after, and issued a Coust Order pro-hibiting the departure of the mission from the country, and instructions were is-sued to the pilots to run ashore all armed vessels entering the port. At this time His Majesty had been taken with a mania for fire-arms, and wish-ing our Envoy's assistance to procure them, sent down an order acknowledging him as Resident at Rangoon, and granting ground for a factory and garden. This or-der came too late; for the mission was at the mouth of the river, on its return to Bengal, Captain Cox having left Rangoon on the 1st of March. In November 1798. The Raja of Arracan wrote a most violent and menacing letter to the Governor General, demanding the instant surrender of some Mugh fugitives who had taken refuge in Chittagong from Birmese oppression. The Governor General, (Marquis Wellesley) contemplated some further com-munication with the Birman Government, on which Major Franklin was to have been employed. Early in 1802, however, Captain Symes having arrived from Eu-rope with the encreased rank of Lieutenant Coloncl, the Governor General resolv-ed upon deputing him to the court of Ava.

Colonel Symes was well received and treated at Rangoon, but he was destined to experience the same slight and indignities, as Captain Cox at the Court where De arrived on the 30th Septembers.
After great delay and difficulty, His Majesty deigned to acknowledge the British Ambassador, who received an audience of. His Majesty on the 28th of November.

Lieutenant Colonel Symes quitted the court on the 27th of December, having only obtained in answer to the Governor's letter, a verbal message as if from the King, through the Viceroy of Rangoon, that no further demand should be made for the Arracan fugitives, and that the Governor of that district was not autho-rized to make any disrespectful or threatening demand for them. His Majesty would offer no apology, neither would he listen to any new treaty, nor permit the establishment of a British Resident at Rangoon, as promised to Captain Cox, but insisted that commercial affairs should remain on the footing settled by the treaty of 1795, and declared he would not grant either lands or settlements in Birmah to any European power whatever. At Rangoon further indignities were passed upon him. Colonel Symes, how-ever, satisfied himself with forwaiding a statement of the Rangoon Governor's Londuct to the capital, and took his departure from Rangoon on the 20th January 1803.

We must next notice the appointment of Licutenant Canning as Agent at Rangoon, on the part of Colonel Symes. The objects of the mission were: —

To give the Birman Court an opportunity of apologizing for the insults which had been offered to the two preceding missions.
To obtain good and early information of the state of French interests in Birmah, and to observe the general conduct and feelings of the Birman Court towards the British Government.
Captain Canning having arrived at Rangoon was received with attention, and having duly forwarded Colonel Symes' letters to the Court, he received a reply with orders to the Rangoon. Officers stating, that His Majesty having granted Colonel Symes every wish, saw no necessity for sending Birman Envoys to Calcutt as at first intended; and that, 'in consequence of the Governor General's desire to seek refuge under the Golden Feet, Licutenant Canning was permitted to reside at Rangoon.' This unusual condescension from the Court, as well as the eivility of the local officers, may probably be traced to the constraintin created by the near approach to the walls of the capital of a Siamese army, which, however, after defeating the Birmans, and driving them from Zimmay, were obliged to return to the Eastern bank of the Salween, in consequence of all English letters to be opened. The French interest had also in other ways been for some time on the decline at Court. Having brought his mission to a conclusion, Captain Canning returned to Calcutta in May 1804.

In the early part of the succeeding year a native of Arracan, named Khyen byen, a Mugh chief, who had before taken refuge with a number of his followers, in the District of Chittagong, made an aggression into Arracan of a most serious mature. He was joined by many Mughs from Chittagong, and being aided by those still resident in Arracan, they soon overran that province, and recovered the whole of it, except the capital, from the Birmans. The Indian Government, learning that the local authorities in Arracan entertained a conviction, that the Birman Government of Rangoon would be to seize and barbarously revenge them-selves on the persons and property of the British subjects residing there, determin-ed on sending another mission to Ava. Captain Canning was for the third time deputed with the following instructions :--I. Our differences were in a fair way of adjustment, and the Envoy was even pre-paring for his journey to the capital, when, on the 18th March, advices arrived from the Supreme Government of a second invasion of Chittagong by the Birman Army. Captain Canning therefore declined to proceed to the capital, and the Viceroy finding all his persuasions in vain, endeavoured to obtain forcible posses-sion of the Envoy's person, but fortunately he escaped with his suite to the ahip. The Viceroy, sensible of the unjustifiable nature of his late attempt, made over-tures to Captain Canning, and the latter returned to his residence on ahore. In the meantime he was recalled, but peremptory orders had arrived from Ava to for-ward him to Court, by 'force, if necessary.' They were discovered endeavouring to intrigue with the native powers in a scheme to drive us out of India, and they carried matters so far as to forcibly detain the Agent of the Magistrate of Chittagong at Arracan for twenty days under a guard. In consequence of this insult, all communication with the Rajah of Arracan ceased. King Berring, who had been crippled by the efforts of the British and Birman

biorchily detain the Agent of the Magiatzet of Chittsgong at Arracan for twenty days under a guard. In consequence of this insult, all communication with the Rajah of Arracan cessed. King Berring, who had been crippled by the efforts of the British and Birman Governments, died in 1815; the dispersion of his adherents, and the confinement of the principal leaders, produced a favorable change in the state of the contry. The insurgents generally manifested a disposition to return quietly to their homes, but a few continued to lurk in the hills and jungles of Chittsgong, under the com-mand of Ryngunring. The depredations of this chief and his adherents were inally suppressed by the surrender of the chief. Their existence, however, ought not to have furnished the Court of Ava with any additional ground of complaint, as the chiefs were kept as state prisoners, and persons of lesser rank and import-ance were liberated, but restricted to the Company's territorics. The perfect immunity of the Birman frontiers from aggression, and the assur-ances of the British Government, that so far as depended upon their officers, this desirable state of things should be perpetuated, might have'satisfied the Government of Ava of sincerity of the pledge, and justified the expectation that amicable re-lations would be permanently formed. The restoration of tranquillity had not, however, lasted long, when the demand was renewed for the surrender of the Mugh Chiefs. Several embassies were sent both to Bengal and Chittagong with the above object, but the Governor General, the Marquis of Hastings, refused to deliver them up, and wrote a temperate letter application on the subject. The peremptory and firm tone assumed by the British Government was for a short time stiended with salutary consequences, but in October 1817, an attempt at intrigue with the Court of Lahore was discovered and prevented.
