WHEREAS it is expedient to amend the Negotiable Instruments Act; 1881, in manner hereinafter appearing; It is hereby enacted as follows:—

1. This Act may be called the Negotiable In-

struments Act, 1885.

An Act to amend the Indian Ports Act, 1875.

WHEREAS it is expedient to amend the Indian Ports Act, 1875, in manner hereinafter appearing; for 1875. It is hereby enacted as follows:—

1. 'In section 42 of the said Act, for the words

An Act to amend the law in force in the Pánch Maháls.

WHEREAS it is expedient that the law in force in the territory comprised in the Panch Mahals should, on and from the first day of May, 1885, be the same as the law in force in the district of Kaira, in the Bombay Presidency, and that the said territory should, on and from that day, cease to be a scheduled district under the Scheduled lof 1874. Districts Act, 1874, and the Laws Local Extent 4 1874. Act, 1874; It is hereby enacted as follows:—

1. This Act may be called the Panch Mahals Laws Act, 1885.

2. (1) Save and except the enactments specified in the schedule hereto annexed, all enactments which, on the first day of May, 1885, are in force in the district of Kaira and not in the Panch Mahals shall be deemed to come into force in the Panch Mahals on that day.

(2) All enactments which on that day are in force in the Panch Mahals and not in the district of Kaira shall be deemed to be repealed on and from that day in the Panch Mahals.

3. All proceedings commenced before any authority in the Panch Mahals before the first day of May, 1885, and still pending on that day, shall be disposed of by such authority as the Local Government may direct, and, save as aforesaid, shall be carried on as if this Act had not been passed.

Territory to cease to be a scheduled district.

4. On and from the first day of May, 1885, the Pánch Maháls shall cease to be a scheduled district; and in Part II. of the First Schedule to the Scheduled Districts Act, 1874, and in the same Part of the Sixth Schedule to the Laws XIV. of 1874. Local Extent Act, 1874, the words "The Pánch XV. of 1874. Maháls" shall be repealed.

An Act to amend the law relating to the carriage of passengers by sea.

Whereas by section 99 of an Act of the Imperial Parliament called "The Passengers Act, 1855," it is enacted that "it shall be lawful for the Gov-& 19 Vie., 119. ernor-General of India in Council, from time to time, by any Act or Acts to be passed for that purpose, to declare that this Act or any part thereof shall apply to the carriage of passengers upon any voyage, from any ports or places within the territories of British India, to be specified in such Act or Acts to any other places what in such Act or Acts, to any other places what-soever, to be also specified in such Act or Acts;" and it is thereby also enacted that "on the passing of such Indian Act or Acts, and whilst the same shall remain in force, all such parts of this Act as shall be adopted therein shall apply to and extend to the carriage of passengers upon such voyages as in the said Indian Act or Acts shall be specified. The provisions of such Indian Act shall be enforced in all Her Majesty's

2. The papers contain several suggestions both by officials and by commercial bodies which might be well worthy of consideration if the

question were one as to the amendment of the English Passengers Acts, but which, having regard to

the conditions under which we are now proceeding, it is beyond our power to entertain.

Acting, as we are, under the 99th section of the 18 & 19 Vic., c. 119, which is recited in the

Acting, as we are, under the 99th section of the 18 & 19 Vic., c. 119, which is recited in the preamble to the Bill, we are restricted to applying to the voyages here in question the provisions of the English Passengers Acts as they stand; and if we were to introduce any modifications in the substance of those provisions, we should in all probability fail to secure for our Act the effect referred to at the end of the preamble, namely, that its provisions "shall be enforced in all Her Majesty's possessions in like manner as the provisions" of the English Passengers Acts.

3. Thus, we have no power to adopt the suggestion of the Bengal Chamber of Commerce that we should amend section 5 of the Bill so as to compel a Colonial Governor or Consular Officer to accept an undertaking to forward passengers offered by the owner, charterer or agent of a ship. We may observe, however, that, having regard to the definition of "master" in the Passengers Acts, and to the duties of a master of a wrecked ship, the contingency of there being no master of a wrecked ship, which this amendment was intended to meet, is one likely to be of very rare occurrence.

Moreover, as the Governor or Consular Officer is not compelled to act under the section, but has a discretion in the matter, there can be little doubt that in the case put he would accept the undertaking

discretion in the matter, there can be little doubt that in the case put he would accept the undertaking

of the owner, charterer or agent.

4. Similarly, it would be beyond our powers, even if we thought it desirable to do so, to adopt the suggestion of the Madras Chamber that a shipowner should be relieved of the liability imposed by section 6 of the Bill in cases in which the ship is prevented from completing her voyage by the act

of God or the Queen's enemies.

It appears to us, however, that the risk involved is one which should be provided against by insurance; and, in order to remove all doubt as to the possibility of so providing against it, we have introduced into the Bill a section (7) similar to section 55 of the Passengers Act, 1855, expressly

legalizing such insurances.

5. The Government of Bombay draw attention to the want of a provision like section 14 of the Passengers Act Amendment Act, 1863, to meet the case of passengers who may be left in British India owing to their ship being wrecked before she leaves the territorial waters, or who may be brought back to British India owing to their ship being wrecked or disabled after proceeding some short distance on her voyage. We are disposed to agree in thinking some such provision desirable, but the extraordinary powers under which we are now acting are not needed for its enactment, and we think the matter could be more conveniently dealt with in our Native Passengers and Emigration Acts,

where we should be free to mould the law as we think fit to suit local requirements.

6. We have, at the suggestion of Brigadier-General Blair, the Political Resident at Aden, amended section 3 (c) so as to extend the Bill to voyages to ports on the East Coast of Africa and in the

Gulf of Aden.

We have also made such amendments as were necessary to render it clear that the Bill extends, as the English Acts do, to cabin-passengers.

An Act to amend the law relating to Telegraphs in India.

WHEREAS it is expedient to amend the law relating to telegraphs in India; It is hereby enacted as follows:

PART I.

PRELIMINARY.

- 1. (1) This Act may be called the Indian Short title, local extent and commencement. Telegraph Act, 1885.
- (2) It extends to the whole of British India, and, so far as regards subjects of Her Majesty, to the dominions of Princes and States in India in
- alliance with Her Majesty; and

2. The Indian Telegraph Repeal and savings. Act, 1876, is hereby repealed.

But all licenses granted and rules made under that Act or any Act thereby repealed, and now in force, shall, so far as they could be granted or made under this Act, be deemed to have been respectively granted and made hereunder.

3. In this Act, unless there is something repugnant in the subject or Definitions. context:-

- (1) "Telegraph" means an electric, galvanic or magnetic telegraph, and includes appliances and apparatus for transmitting or making telegraphic, telephonic or other communications by means of electricity, galvanism or magnetism:
- (2) "Telegraph officer" means any person employed either permanently or temporarily in connection with a telegraph established, maintained or worked by the Government or by a person licensed under this Act:

(Part II.—Privileges and Powers of the Government.—Sections 4-9.) (Part III.—Power to place Telegraph Lines and Posts.—Section 10.)

(3) "Message" means any communication sent by telegraph, or given to a telegraph officer to be sent by telegraph or to be delivered:

(4) "Telegraph line" means a wire or wires used for the purpose of a telegraph, with any

casing, coating, tube or pipe enclosing the same, and any appliances and apparatus connected therewith for the purpose of fixing or insulating the

(5) "Post" means a post, pole, standard, stay, strut or other above-ground contrivance for carry-

ing, suspending or supporting a telegraph line:
(6) "Telegraph authority" means the Director General of Telegraphs, and includes any officer empowered by him to perform all or any of the functions of the telegraph authority under this Act.

(7) "Local authority" means any municipal committee, district board, body of port commissioners or other authority legally entitled to, or entrusted by the Government with, the control or management of any municipal or local fund.

struction of Telegraphs, and to amend the Indian Telegraph Act, 1876, was referred, have considered the Bill and the papers noted in the margin, and have now the honour to submit this our Report.

- 2. We are of opinion that it would be for the convenience of the Telegraph Department and the public that Act I of 1876 should be repealed and re-enacted with most of the modifications and most of the modifications and additions proposed by the Bill as introduced. We have accordingly re-drawn the Bill as a consolidating measure.

- 1. We have also amended the definition of "local authority" so as to make that expression include a cantonment authority and clearly exclude any commercial association however incorporated (section 3, clause (7)).
- 5. In declaring, in section 4, the exclusive privilege of the Government to extend to establishing, maintaining and working telegraphs, and in empowering the Government to grant licenses to establish, maintain or work telegraphs, we formulate what is, and has always been understood to be, the existing law, and at the same time avoid the necessity of using the words "lease" and "lessee" which were introduced into the Bill of last year (section 13). A lease is a license to work a line established and maintained by the Government, and a lessee is the holder of such a license.
- 6. By section 7, sub-section (2), clause (b), we propose to give the Government the power of requiring licensees to provide for the seclusion of telegraph instruments at all offices open for the receipt of public messages. Clauses (c) and (d) of the same sub-section have been suggested to us by correspondence that has been placed at our disposal by the Public Works Department of the Government of India, respecting applications from time to time made by private persons to the Telegraph Department for the preservation of telegrams.
- 7. Most of the objections that were taken to the Bill as introduced, chiefly by commercial bodies in Calcutta, will, it is believed, have been met by our proposal that the power of placing telegraph lines and posts shall only be exercised by the Government Telegraph Department for the purposes of telegraphs established or maintained by the Government.
- 8. In section 11 we have, following a recent English Act, proposed to empower the telegraph authority to enter at any time on property for the purpose of examining, repairing, altering or removing any telegraph line or post that has been placed on it.
- 9. In section 14 we have adhered to the provisions of the English Act (26 & 27 Vic., c. 112, sections 6 and 8), though in practice the officers of the Telegraph Department will doubtless arrange for the alteration of the position of any pipe or drain being carried out by the authority having control
- 10. In section 15 we have provided, on the suggestion of the Government of Bombay, that disputes between the telegraph authority and local authorities shall be determined by a local officer whose decision will be subject to appeal to the Local Government.
- 11. In section 16, sub-sections (1) and (2), we have provided for recourse being had by the telegraph authority to the District Magistrate where the exercise of the powers conferred on that authority is resisted. We have also provided in this section, sub-section (4), in accordance with the suggestion of the Government of Bombay, that the telegraph authority may pay compensation into Court where any dispute arises as to the persons entitled to receive it.

12. We have met the objections that were taken to section 10 of the Bill as introduced by pro-

12. We have met the objections that were taken to section 10 of the Bill as introduced by providing in section 17 of the present Bill that a person desiring the removal or the alteration of the position of a telegraph line or post shall tender the cost of the removal or alteration in those cases only in which compensation has been paid by the telegraph authority, and that in those cases he shall not be required to tender more than half the sum that was paid to him as compensation.

13. By section 18 we have proposed to provide for the removal by order of a Magistrate of trees interrupting or likely to interrupt telegraphic communication. A somewhat similar provision in the case of trees dangerous to railways is contained in the Regulation of Railways Act, 1868 (31 & 32 Vic., c. 119, section 24).

14. By section 26 we propose to subject a person who is not a telegraph officer, but has official duties connected with an office which is used as a telegraph office, to the same penalty as that to which a telegraph officer is liable for secreting or altering telegrams or unlawfully intercepting or disclosing them. Many post offices in India are now used as telegraph offices, and we consider that postal officials should be restrained by penalty, as they are under the English Telegraph Act of 1868, from abusing such opportunities as they may have of becoming acquainted with the contents of telegraphic messages.

(3) If the repair or removal is not at once effected, or, if the Local Government so thinks fit, without waiting for the same to be effected by the owner, lessee or occupier, the Local Government may execute the same and recover from the owner, lessee or occupier the expense occasioned thereby.

which Mines or Minerals are situate under land which it is desired to acquire under the Land Acquisition Act, 1870, was referred, have considered the Bill and the papers noted in the margin, and have now the honour to submit this our Report.

2. Some of the Local Govern-ments have objected to the Bill be-ing applied to the provinces under their administration on the ground that, having regard to the manner in which the right to minerals is regulated in those provinces, it is unnecessary there, and that, if unnecessary, it would only prove an encumbrance and complication in the acquisition of lands. To meet these objections we have made the

From Assistant Secretary to Chief Commissioner, Central Provinces, No. 2655— measure applicable by its own 77, dated 11th July 1885 [Paper No. 14]. vigour only to the territories under the administration of the Governor of Madras in Council and the Lieutenant Governor of Bengal, but have empowered the remaining Local Governments to extend it to the whole or any part of the territories administered by them if they think fit.

- 3. An apprehension has been expressed in some of the opinions received that the Bill might by implication affect the rights which the Crown has to all minerals throughout a very large portion of this country. Such an apprehension is, we believe, unfounded, but by way of greater precaution, and to prevent misapprehension we have inserted a section (2) saving the rights of the Crown.
- 4. Section 2 of the Bill as introduced required the Government to determine, before it issued its declaration under section 6 of the Land Acquisition Act, whether the land should be acquired simply under that Act, that is to say, including the minerals, or whether the special provisions of this Bill should be put in force with a view to excluding the minerals from the acquisition.

It has been represented that it is not for the interest of any of those concerned that an irrevoc. able determination should necessarily be come to on so important a point at a stage of the proceedings when the circumstances of the case would in all probability be imperfectly known. The Government, it will be observed on reference to the Land Acquisition Act, has a discretion to withdraw from a proposed acquisition of land up to a considerably later stage, and it seems but reasonable that it should have a discretion to exclude the minerals from the acquisition at any time up to the same stage if it turns out that their acquisition is not essential to the undertaking, and that either the owners are unwilling to part with them or the Government or the local authority or Company concerned is unwilling to pay their full value. We have accordingly (in section 3) empowered the Collector, who in such a matter would, of course, act under the control of the Government, to exclude the minerals from the acquisition at any time up to the stage of the proceedings at which the land vests, and it is no longer in the discretion of the Government to recede from the transaction.

- 5. It has been urged that the notice of thirty days to be given to the Government, under section 3 of the Bill as introduced, by a mine-owner desiring to work his mines, is too short having regard to the delays in communication in this country. We think the objection is reasonable, and we have accordingly (in section 4 of the amended Bill) extended the period to sixty days.
- 6. It has been held by the House of Lords in an important case (Dixon v. The Caledonian Railway Co., 5 App. Ca. 820) that when a mine-owner gives notice under section 78 of the Railways Clauses Act, 1845, of his intention to work minerals, the Railway Company is not, for the purpose of giving its counter-notice to stop or control the working limited to the thirty days for which the mineowner's notice runs, that the period of thirty days is merely prescribed as a period until the expiration of which the mine-owner is debarred from working, and that the Company can at any time give its counter-notice, though of course if given at any time after the thirty days had expired and the workings had been commenced it would have no effect except as regards the further progress of the workings. The opposite view, as was pointed out by their Lordships, would involve somewhat serious consequences, and it is obviously necessary that there should be no mistake as to the effect of the Bill in this respect. It would doubtless have been sufficient, so far as regards the ultimate result, if we followed the exact

wording of the English Act, on the main lines of which we are proceeding throughout. The highest Courts in this country would, as a matter of course, follow the decision of the House of Lords, but it is to be apprehended that inferior authorities might in many cases be ignorant of that decision, and might mistake the effect of the wording of the English Act, which, it must be admitted, is by no means clear. We have therefore thought it safer to amend the sections concerned in such a manner that they will, in a clear and unmistakeable way, express the effect of the English Act as construed by the House of Lords.

7. Another important English decision which points to an amendment of the Bill is that in Smith v. Great Western Railway Co. (2 Ch. D. 2351, and in appeal before the House of Lords, 3 App. Ca. 165). We may have, under a Bill of this sort, a state of things to deal with, of which that case affords an illustration, where one person holding under a terminable lease has an immediate right to work the minerals, and another person is entitled to the reversion on the expiration of the lease and, perhaps, to a rent or royalty during its continuance. The lease may or may not be of such a length as to admit of all the minerals being worked out during its continuance, and it may or may not be liable to be put an end to by forfeiture, or otherwise, before the expiration of its term. The provisions of the English Act, which deal specially with the subject now before us, and which have been incorporated in this Bill, were found inadequate to provide for the exigencies of such a state of things as that referred to. They probably contemplate a settlement only with the person immediately entitled to work the mines, and, in order to provide for the case of a reversioner or other person interested, it was found necessary to call in the aid of a general provision of the law which would be out of place in a Bill like this.

It appears to us that the simplest mode of dealing with the various interests that may co-exist in the mines is to require, in accordance with the scheme of the Land Acquisition Act, that they should all, whether present or future, be considered and compensated for simultaneously whenever the owner of the surface has occasion to exercise his power of stopping or controlling the working.

We have accordingly provided in effect, that where the person immediately entitled to work the mines intimates to the owner of the surface his intention to work them, and the latter after that determines to stop or control the working, the settlement of compensation must extend to all persons interested in the mines, and the stoppage or control will be binding in perpetuity on all alike.

- 8. We have introduced three new sections (8, 9 and 10), corresponding to sections 80, 81 and 82 of the Railways Clauses Act, 1845. We question whether the object of these sections would not have been otherwise attained through the medium of the Land Acquisition Act, the provisions of which were made applicable by section 6 of the Bill as introduced; but as importance appeared to be attached to them in the memorial of the Coal Companies, we have thought it better to remove all doubt by including them. They will doubtless overlap section 6 of the Bill, but no practical harm will result from this.
- 9. An objection has been taken in some quarters to section 11 of the Bill as introduced (now section 14), which in effect gives to certain Companies the powers conferred on the Local Government by some of the foregoing provisions of the Bill. It appears to be overlooked that the section in question can apply only to Companies established for such purposes and occupying such a position, from a public point of view, as would warrant the Government in acquiring land on their behalf. In particular it is provided, by sections 48 and 49 of the Land Acquisition Act, that land shall not be acquired for a Company under that Act unless it is needed for a work likely to prove useful to the public, and the Company enters into an agreement with the Government settling, among other matters, the time within which and the conditions on which the work shall be executed and maintained and the terms on which the public shall be entitled to use it.
- 10. We may further observe that there appears from some of the papers considered by us to be a certain amount of misapprehension as to the nature of the powers referred to.

If the Local Government or the Company exercising the powers of the Local Government neglects to come to terms with the mine-owner on his giving notice of his intention to work, it does so at the risk of its property. If, considering that the mine-owner is working improperly, it takes steps under section 7 (new numbering) to remedy the mischnef with a view to charging the mine-owner with the cost, it does so at the risk of loosing its money and of incurring serious legal consequences if the Court before which the case may ultimately come takes a different view of the matter. Similarly, if it considers that the mines are being worked contrary to the provisions of the Act and proceeds to take steps under section 13 (new numbering), it still acts at its own risk, for it is by no means certain that it will appear to the Court that the mines were being so worked.

Thus the powers in question are very far from being so formidable as has been supposed, and we may add that they are framed as closely as possible on the lines of those conferred by Parliament on Railway Companies in England, the substance of which seems generally to have met with approval.

- 11. We have placed "local authorities" on a footing similar to that of Companies, as in many recent Acts the rrovisions of the Land Acquisition Act have been made applicable for the purpose of acquiring land for such authorities.
- 12. We are informed that there are certain land acquisition cases pending at this moment in Bengal, which have already proceeded beyond the stage at which the provisions of this measure would in its ordinary course be applicable to them, but in which it may nevertheless be thought desirable to have the benefit of it. To meet this, we have inserted a clause (15 (2)) which will admit—f the Bill being applied in such cases if those concerned unanimously desire that it should.

An Act to amend the law relating to Government . Secondities.

WHEREAS it is expedient to amend the law relating to Government securities in manner hereinafter appearing; It is hereby enacted as fol-

_(1) This Act may Short title and combe called the Indian Securities Act, 1885; and

(2) It shall come into force at once. Definitions. 2. In this Act

The expression "Government security" includes promissory notes, debentures, stock ce ficates, and all other securities issued by the Go ernment of India or by any Local Government in respect of any loan issued under notification in the official Gazette, whether before or after the passing of this Act, but does not include a stock note or a currency note: and

"prescribed" means prescribed by rules made from time to time by the Governor General in Council in this behalf.

IX of 1872.

3. (1) Notwithstanding anything contained in the Indian Contract Act, Right of survivors of joint payees of Government securities, section 45, when a Gov ernment security issued before the first day of

April 1886, is payable to two or more persons jointly and any of them dies, the security shall be payable to the survivor or survivors of those persons.

(2) Nothing herein contained shall affect any claim which the representative of the deceased person may have against the survivor or survivors in respect of the security jointly payable to them and the deceased.

(3) This section shall apply whether the death of the person to whom the security was jointly payable occurred or occurs before or after this Act comes into force.

- 4. A person claiming to be entitled to a Gov-Issue of renewed securities. ernment security as payable to him under an endorsement may, on satisfying the prescribed officer of the justice of his claim and paying the prescribed fee and delivering the security duly receipted to the prescribed officer, obtain from the officer a renewed security issued payable to himself.
- 5. (1) When a Government security alleged to have been wholly or partly lost or destroyed, partly lost or destroyed, and a person claims to be the person to whom but for such loss or destruction it would be payable, he may on application to the prescribed officer, and on producing

security said to be lost or destroyed pending the issue of a duplicate security; and

(b) the issue of a duplicate security payable

to the applicant.
(2) An order shall not be passed under subsection (1) until after the issue of the prescribed notification of the loss or destruction and after the expiration of the prescribed period, nor until the applicant has given the prescribed indemnity against the claims of all persons deriving title under the security lost or destroyed.

(3) A list of the securities in respect of which an order is passed under sub-section (1) shall be published in the Gazette of India at such times as the Governor General in Council may, from time to time, direct.

bility to respect of the original security of which such relewed or duplicate security has been issued-

(b) in the case of a duplicate security, after the lapse of six years from the date of the publication under section 5, sub-section (3), of the last in which the security is first mentioned, or from the date of the last payment of interest on the original security, whichever date is latest. security, whichever date is latest.

(1) The Governor General in Council shall, before making rules Publication of drafts and under the last foregoing section, publish a draft of the proposed rules in such manner as may, in his opinion, be sufficient for the information of the public.
(2) There shall be published with the draft a

notice specifying a date at or after which the draft will be taken into consideration.

(3) The Governor General in Council shall receive and consider any objection or suggestion which may be made by any person with respect to the draft before the date so specified.

(4) Every rule made under the last foregoing section shall be published in the Gazette of India, and the publication in the Gazette of India of a rule purporting to be made under that section shall be conclusive evidence that it has been duly made.

WE, the undersigned, Members of the Select Committee to which the Bill to amend the law relating to Government Securities was referred, have considered the Bill and the papers noted in the margin, and have now the honour to submit this our Report.

2. The only substantive alteration we have made in the Bill is in section 3, which, in cases in which one of a number of joint-holders of a Government security dies, applies what we may term the rule of survivorship as opposed to the rule of representation laid down by section 45 of the Indian Contract Act. The reasons which led to the insertion of this provision are fully set forth in the Statement of Objects and Reasons: but

we find that a considerable difference of opinion exists regarding it.

On the one hand, it is urged, among others, by so high an authority as the Advocate General of Bengal, that this provision should be generalized and extended to other classes of obligations besides those arising on Government securities.

On the other hand, it is argued in several of the papers that the rule of survivorship as applied to instruments of the description in question is one that does not fit in with the habits and ideas of certain classes of the Native population, and might, if extended to those classes as an absolutely binding rule, open a door to the perpetration of frauds.

The question thus raised is of considerable importance and difficulty. We do not think that we should be justified in entering fully upon it here in the absence of those members of the Council most competent to advise on legal and commercial matters, and we accordingly propose, with a view to avoiding it as far as possible, to confine the section to Government securities already issued, or which may be issued before the 1st of April next.

4. As regards securities already issued, the law must be settled without any further delay, delay which has taken place in obtaining opinions on the Bill having already led to considerable public inconvenience. Moreover, as it is impracticable to make any distinctions among those securities, one and the same rule must be laid down for all, and it is clear that that rule must be the rule of survivorship. The rule of survivorship has hitherto been applied to them, as well after the passing of the Contract Act as before, subject at most to rare exceptions or qualifications. It is the rule that is most suitable to the great majority of those who hold those securities, and if in exceptional cases it should be found to be less suitable it must be remembered that those securities have

been issued under a system which contemplated its application.

5. On the other hand, there is no necessity to settle the question at this moment as regards securities to be issued for all time to come, especially as a simple mode of providing, without the aid of the legislature, for securities to be hereafter issued has been proposed.

It has been suggested that it could be so arranged in the Loan Department of the Government that it should be in the continue of providing are first issued or to whom they

that it should be in the option of persons, in whose favour securities are first issued or to whom they are subsequently transferred by endorsement, either to take them simply in their several names, that is to say, in favour e.g., of "A, B and C," without qualification, in which case the rule of the Contract

Act would apply, or to take them under words giving a right of survivorship, as, e.g., in favour of "A, B and C, and the survivor or survivors of them," in which case we are advised the rule of the Contract Act would be excluded and the rule of survivorship would apply. This, it has been argued, would be likely to afford a more satisfactory solution of the difficulty as regards securities to be hereafter issued than any enactment establishing either the rule of survivorship or that of representation in a hard-and-fast manner, as it would leave it open to all concerned to adopt for themselves the rule best adapted to their requirements.

It is urged, on the other hand, that the requirements of the new system would be likely for some time to be overlooked, and that considerable hardship and inconvenience would thus result, but this danger might perhaps be averted by some device, such as that of a warning enfaced on the security in such a way as to attract attention.

We do not, however, recommend that any determination should be arrived at on this matter until it has undergone the fullest discussion. It will doubtless be settled during the course of the Calcutta Session; and we think that we are acting most in accord with the balance of convenience, and so as to occasion the least amount of discurbance in existing relations, by recommending that, as regards securities issued meantime, i.e., say up to the 1st of April next, the law should be placed on the same footing as for securities already issued, that is to say, that the rule of survivorship should apply.

- 6. The remaining changes which we have made in the Bill, being confined to matters of form or drafting, do not call for special notice. We may, however, mention that we have introduced words in the definition of "Government security" to make it clear that the Bill does not apply to stock notes or currency notes—classes of securities to which, as they are otherwise provided for, it was never intended to apply.

(1) This Act extends to the whole of British Extent and commence- India, and applies also, within the dominions of Princes and States India in alliance with Her Majesty, to British subjects in those dominions who are in the service of the Government of India or of a local authority established in the exercise of the powers of the Governor General in Council in that behalf; and
- (2) It shall come into force on the first day of April, 1886.
- (3) Any power conferred by this Act to make rules or to issue orders may be exercised at any time after the passing of this Act; but a rule or order so made or issued shall not take effect until the Act comes into force.
- 2. On and from the day on which this Act comes into force Repeal. enactments specified in the first schedule to this Act shall be repealed, except as to fees payable and other sums due under those enactments and the mode of recovering the same.
 - 3. In this Act, unless there is something repugcontext.
- (1) "local authority" means any municipal committee, district heard, body of port commissioners or other authority legally entitled to, or entrusted by the Government with, the control or management of any municipal or local fund:
- (2) "company" means an association carrying on business in British India, whose stock or funds is or are divided into shares and transferable, whether the company is incorporated or not, and whether its principal place of business is situate in British India or not:
- (3) "prescribed" means prescribed by the Governor General in Council by notification in the Gazette of India, or by the Governor General in Council or a Local Government by rules made under this Act.

(4) "salary" includes allowances, fees, commissions, perquisites or profits received, in lieu of or in addition to a fixed salary, in respect of an office or employment of profit; but subject to any rules which may be prescribed in this behalf, it does not include travelling, tentage, horse or sumptuary allowance, or any other allowance granted to meet specific expenditure:

PART IV

- (5) "income" means income and profits accruing and arising or received in British India, and includes, in the case of a British subject within the dominions of a Prince or State in India in alliance with Her Majesty, any salary, annuity, pension or gratuity payable to that subject by the Government or by a local authority established in the exercise of the powers of the Governor General in Council in that behalf:
- (6) "Magistrate" means a Presidency Magistrate or a Magistrate of the first or second class:
- (7) "person" includes a firm and a Hindu undivided family:
- (8) "defaulter" includes a company or firm making default under this Act:
- (9) "Collector" means the chief officer in charge of the revenue-administration of a district, and in a presidency-town any officer whom the Local Government, by notification in the official Gazette, may, by name or by virtue of his office, appoint to be a Collector for the purposes of this Act; in the case of a company or firm, it means the Collector, as here defined, of the district or presidency-town in which its principal place of business in British India is situate; and, in the case of any other person chargeable under this Act, it means the Collector, defined as aforesaid, of the district or presidency-town in which the person has his residence:
- (10) "principal officer," used with reference to a local authority or a company or any other public body or association not being a local authority or company, means—
 - (a) the secretary, treasurer, manager or agent of the authority, company, body or association; or
 - (b) any person connected with the authority, company, body or association upon whom the Collector has caused a notice to be served of his intention of treating him as the principal officer thereof: and
- (11) "Part" means a Part of the second sched-

CHAPTER II.

LIABILITY TO TAX.

4. Subject to the exceptions mentioned in the Incomes liable to the tax. next following section, there shall be paid, in the year beginning with the first day of April 1886, and in each subsequent year, to the credit of the Government of India, or as the Governor General in Council directs, in respect of the sources of income specified in the first column of the second schedule to this Act, a tax at the rate specified in that behalf in the second column of that schedule.

Exceptions.

5. (1) Nothing in section 4 shall render liable to the tax—

- (a) any rent or revenue derived from land which is used for agricultural purposes and is either assessed to land-revenue or subject to a local rate assessed and collected by officials of the Government, as such; or
 - (b) any income derived from-
 - (i) agriculture, or
 - (ii) the performance by a cultivator or receiver of rent-in-kind of any process ordinarily employed by a cultivator or receiver of rent-in-kind to render the produce raised or received by him fit to be taken to market, or
 - (iii) the sale by a cultivator or receiver of rent-in-kind of the produce raised or received by him, when he does not keep a shop or stall for the sale of such produce; or
- (c) any building owned and occupied by the receiver of the rent or revenue of any such land as is referred to in clause (a), or by the cultivator, or the receiver of rent-in-kind, of any land with respect to which or the produce whereof, any operation mentioned in clause (b) is carried on:

Provided that the building is on or in the immediate vicinity of the land, and is a building which the receiver of the rent or revenue, or the cultivator or the receiver of the rent-in-kind, by reason of his connection with the land, requires as a dwelling-house, or as a store-house, factory or other out-building; or

- (d) any profits of a shipping company incorporated or registered out of British India and having its principal place of business out of India and its ships ordinarily engaged in seagoing traffic out of Indian waters; or
- (e) any income derived from property solely employed for religious or public charitable purposes; or
- (f) any income which a person enjoys as a member of a company or of a firm or of a Hindu undivided family when the company or the firm or the family is liable to the tax; or,
- (g) subject to any conditions and restrictions which may be prescribed in this behalf, such portion, not exceeding one-sixth, of the income in respect whereof a person would, but for this exception, be chargeable under this Act, as is deducted from the salary of the person under the authority or with the permission of the Government for the purpose of securing a deferred annuity to him or a provision to his wife or children after his death or is paid by the person to an insurance company in respect of an insurance or deferred annuity on his own life or on the life of his wife; or
 - (h) any interest on stock-notes; or
- (i) the salary of any officer, warrant-officer, non-commissioned officer or private of Her Majesty's

Forces or of Her Majesty's Indian Forces who is not in an employment which, according to the ordinary practice, is held indifferently by military persons and civilians, and whose salary does not exceed five hundred rupees per mensem; or

- (j) any person whose income from all sources is less than five hundred rupees per annum.
- (2) An officer or servant is not exempt from taxation under this Act by reason only of the income of his employer being exempt therefrom under this section.
- 6. The Governor General in Council may, by notification in the Gazette Power to make exemptions. of India, exempt from liability to the tax the whole or any part of the income of any class or tribe, or of any persons residing in any specified area, and may, by a like notification, revoke the exemption.

CHAPTER III.

ASSESSMENT AND COLLECTION.

A.—Salaries and Pensions.

- 7. In the case of a person receiving any salary, annuity, pension or gratuity from the Gov-Mode of payment in case of Government officials and pensioners. ernment, any sum payable to him by the Government in respect of the salary, annuity, pension or gratuity shall be reduced by the amount of the tax to which he is liable under Part I in respect thereof.
- 8. (1) In the case of a person receiving any Mode of payment in case of servants and pensioners of local authorities.

 Mode of payment in case of salary, annuity, pension or of servants and pensioners of local authorities.

 Salary, annuity, pension or gratuity from a local authority, the tax to which he is liable under Part I shall, at the time of the payment to him of any of the salary, annuity, pension or gratuity, be deducted therefrom by the officer whose duty it is to make the payment, and be paid by that officer within the prescribed time to the credit of the Government of India or as the Governor General in Council directs.
- (2) If that officer does not deduct and pay the tax as required by sub-section (1), he shall, without prejudice to any other consequences which he may incur, be deemed to be personally in default in respect of the tax.
- (3) If, when any payment is made, the tax is from any cause not deducted, it may, and on the equisition of the Collector shall, be deducted when any salary, annuity, pension or gratuity is subsequently paid to the person liable to the tax.
- (4) The power to deduct under this section shall be without prejudice to any other mode of recovery,

Mode of payment in case of servants and pensioners of companies and private employers.

9. (1) The tax to which a person receiving any salary, annuity, pension or gratuity from a servants and pensioners company, or from any other public body or association not being a

local authority or company, or from a private

employer, is liable under Part I shall be payable by him at the time when any portion of the salary, annuity, pension or gratuity is paid to him.

- (2) The Collector may, subject to such conditions as may be prescribed, enter into an arrangement with any company, or any such body or association as aforesaid, or any private employer, with respect to the recovery on behalf of the Government by the company, body, association or employer of the tax to which any person receiving any salary, annuity, pension or gratuity from the company, body, association or employer is liable under Part I.
- 10. The principal officer of every local authority, and of every company, and of every other public and of every other public Annual return by princi-pal officer of company or association. body or association not being a local authority or company, shall prepare, and, on or before the fifteenth day of April in each year, deliver or cause to be delivered to the Collector, in the prescribed form, a return in writing showing-
- (a) the name of every person who is receiving at the date of the return any salary, annuity or pension, or has received during the year ending on that date any gratuity from the authority, company, body or association, as the case may be, and the address of every such person so far as it is known; and
- (b) the amount of the salary, annuity, pension, or gratuity so received by each such person, and the time at which the same becomes payable or, in the case of a gratuity, was paid.

B.—Profits of Companies.

- 11. The principal officer in British India of every company shall pre-pare, and, on or before the fifteenth day of April Annual statement of nett in each year, deliver or cause to be delivered to the Collector, a statement in writing signed by him of the nett profits made in British India by the company during the year ending on the day on which the company's accounts have been last made up, or, if the company's accounts have not been made up within the year ending on the thirty-first day of March in the year immediately preceding that for which the assessment is to be made, then of the nett profits so made during the year ending on the said thirty-first day of March.
- 12. (1) If the Collector has reason to believe that a statement deliver-Power to require officers of companies to produce accounts. ed under section 11 is incorrect or incomplete, he may cause to be served on the principal officer of the company a notice requiring him, on or before a date to be therein mentioned, either to attend at the Collector's office and produce, or to cause to be there produced, for the inspection of the Collector such of the accounts of the company as refer to the year to which the statement relates and as are in his possession or
- (2) On the day specified in the notice, or as soon afterwards as may be, the Collector shall, by an order in writing, determine the amount at

which the company shall be assessed under Part II, and the time when the amount shall be paid, and, subject to the provisions of this Act, that amount shall be payable accordingly.

PART IV

C.—Interest on Securities.

- Mode of payment of tax on interest on securities.

 at the time when and place where any of the interest is paid, be deducted therefrom by the person empowered to pay the interest, and be paid by that person within the prescribed time to the credit of the Government of India or as the Governor General in Council directs.
- (2) If that person does not deduct and pay the tax as required by sub-section (1), he shall, without prejudice to any other consequences which he may incur, be deemed to be personally in default in respect of the tax.

D-Other Sources of Income.

Ordinary Mode of Assessment and Collection.

- Mode of making assessment shall be made upon the income accruing to the person during the year ending on the day on which his accounts have been last made up, or, if his accounts have not been made up within the year ending on the thirty-first day of March in the year immediately preceding that for which the assessment is to be made, then upon the income accruing to him during the year ending on the said thirty-first day of March.
- (2) In the case of a person for the first time becoming chargeable under Part IV within the year for which the assessment is to be made or within the year next before that year, the assessment shall be made according to an average of his income for such period as the Collector, having regard to the circumstances, directs.
- 16. (1) The Collector shall in each year prepare a list of the persons two thousand rupees.

 List of incomes under two thousand rupees.

 a list of the persons chargeable under Part IV whose annual income does not, in his opinion, amount to two thousand rupees.
- (2) The list shall be in the prescribed language or languages, and shall state in respect of every such person the following particulars, namely:—
- (a) his name and the source or sources of the income in respect of which he is chargeable;
- (b) the year or portion of the year for which the tax is to be paid;
- (c) the place or places, district or districts, where the income accrues;
 - (d) the amount to be paid; and
- (e) the place where, and the person to whom, the amount is to be paid.
- (3) The list shall be filed in the office of the Collector, with a notification prefixed thereto re-

quiring every person mentioned in the list to pay, within sixty days from a date specified in the notification, the amount stated in the list as payable by him, or to apply to the Collector, within thirty days from that date, to have the assessment reduced or cancelled.

- (4) The list so filed shall be open to inspection at all reasonable times without any payment.
- (5) The list, or such part or parts thereof as the Collector thinks fit, with the notification prefixed thereto, shall be further published in suchmanner as the Local Government may consider to be best adapted for giving information to all persons concerned.
- (6) The list to be prepared in each year may be the list of the previous year with such amendments as the Collector finds to be necessary.
- 17. In the case of a Part IV whose annual incomes of two thousand rupees and upwards.

 Part IV whose annual income is, in the Collector's opinion, two thousand rupees or upwards, the Col-

pees or upwards, the Collector shall cause a notice to be served on him stating the particulars (a) to (e), both inclusive, mentioned in section 16, sub-section (2), and requiring him to pay, within sixty days from a date specified in the notice, the amount stated therein as payable by him, or to apply to the Collector, within thirty days from that date, to have the assessment reduced or cancelled.

- 18. (1) Notwithstanding anything contained power to modify ordinary procedure in special cases. In special the Local Government may make rules—
 - (a) authorising or directing a Collector in specified cases, or classes of cases, to include in a list under section 16 any person who is liable to be served with a notice under section 17 instead of or in addition to serving him with such a notice, and to serve a notice under section 17 on any person liable to be included in a list under section 16 instead of or in addition to including him in such a list.
- (b) authorising the Collector in any specified town or place to cause a general notice to be published, inviting every person chargeable under Part IV to deliver or cause to be delivered to the Collector, within a time specified in the notice, a return, in a prescribed form published with the notice, of his income during the year ending on the day on which his accounts have been last made up, or, if his accounts have not been made up within the year ending on the thirty-first day of March in the year immediately preceding that for which the assessment is to be made, then of his income during the year ending on the said thirty-first day of March;
- (c) authorising the Collector in any presidency-town to cause a special notice to be served on any person chargeable under Part IV, inviting him to deliver or cause to be delivered to the Collector, within a time specified in the notice, a return, in a prescribed form accompanying the notice,

of his income computed in the manner described in clause (b) of this sub-section.

- (2) A return delivered under rules made under clause (b) or clause (c) of sub-section (1) must state the period during which the income has actually accrued; and there must be added at the foot thereof a declaration that the income shown in the return is truly estimated on all the sources therein mentioned, that it has actually accrued within the period therein stated, and that the person making the return has no other source of income.
- (3) When a Collector authorized in that behalf by rules made under clause (b) or clause (c) of sub-section (1) has caused a notice to be published or served under those rules, he shall not include any person to whom the notice applies in any list made under section 16 or serve a notice on him under section 17 until the time specified in the notice published or served under those rules has expired.

 (4) Rules made under this section shall be

(4) Rules made under this section shall be published in the official Gazette.

19. Every amount specified as payable in a list or notice prepared or served under section 16 or section 17 shall be paid within the time, at the place, and to the person, mentioned in the list or notice.

Trustees, Agents, Managers and Incapacitated Persons.

Trustees, guardians and committees of incapacitated persons to be charged.

A person being the trustee, guardian, curator or committee of any infant, married woman subject to the law of England, lunatic or idiot, and having the control of the property of the infant, married woman, lunatic or idiot, whether the infant, married woman, lunatic or idiot resides in British India or not, shall, if the infant, married woman, lunatic or idiot, is chargeable under Part IV, be chargeable under that Part in like manner and to the same amount as the infant would be chargeable if he were of full age, or the married woman if she were sole, or the lunatic or idiot if he were capable of acting for himself.

21. Any person not resident in British India, whether a subject of Her Majesty or not, being in receipt, through an agent, of any income chargeable

under Part IV, shall be chargeable under that Part in the name of the agent in the like manner and to the like amount as he would be chargeable if he were resident in British India and in direct receipt of that income.

22. Receivers or managers appointed by any Receivers, managers, Courts of Wards, Administrators General and Official Trustees.

Trustees.

23. When a trustee, guardian, curator, com-Power to retain duties mittee or agent is, as such, charged on trustees, &c. assessed under Part IV, or when a receiver or manager appointed as aforesaid, a Court of Wards, an Administrator General or an Official Trustee is assessed under that Part in respect of income officially received,

the person or Court so assessed may, from time to time, out of the money coming to his or its possession as trustee, guardian, curator, committee or agent, or as receiver, manager, Court of Wards, Administrator General or Official Trustee, retain so much as is sufficient to pay the amount of the assessment.

Occupying Owners.

- 24. (1) Where a building is occupied by its Provision for tax on owner, it shall be deem-occupying owners. ed a source of income within the meaning of this Act, and, if liable to be assessed under this Act, shall be assessed at five-sixths of the gross annual rent at which it may reasonably be expected to let, and, in the case of a dwelling-house, may be expected to let unfurnished.
- (2) "Owner," as used in this section with reference to a building, means the person who would be entitled to receive the rent of the building if the building were let to a tenant.

CHAPTER IV.

REVISION OF ASSESSMENT.

25. (1) Any person objecting to the amount at which he is assessed, or denying his liability to be assessed, under Part IV may apply by petition to the Collector to have the assessment reduced or cancelled.

- (2) The petition shall ordinarily be presented within the period specified in the notification prefixed to the list filed under section 16, or in the notice served under section 17, as the case may be. But the Collector may receive a petition after the expiration of that period if he is satisfied that the objector had sufficient cause for not presenting it within that period.
- (3) The petition shall, as nearly as circumstances admit, be in the form contained in the third schedule to this Act, and the statements contained in the petition shall be verified by the petitioner or some other competent person in the manner required by law for the verification of plaints.
- 26. The Collector shall fix a day and place for the hearing of the petition, and on the day and at the place so fixed, or on the day and at the place, if any, to which he has adjourned the hearing, shall hear the petition and pass such order thereon as he thinks fit.

upwards, and may in his discretion if the amount of the assessment is less than two hundred and fifty rupees, call for the record of the case, and pass such order thereon as he thinks fit.

28. The Collector or Commissioner may, for Power to summon with the purpose of enabling him to determine how the petitioner or the company

which he represents should be assessed, summon and enforce the attendance of witnesses and compel them to give evidence, and compel the production of documents, by the same means, and as far as possible, in the same manner, as is pro-vided in the case of a Civil Court by the Code of Ty of 1882. Civil Procedure:

Provided that the Collector or Commissioner shall not call for any evidence except at the instance of the petitioner or in order to ascertain the correctness of facts alleged by him.

· CHAPTER V.

RECOVERY OF ARREARS OF TAX.

Provided that, where a person has presented a petition under section 25, such sum shall not be recoverable from him unless, within thirty days from the passing of the order on the petition, he fails to pay the amount, if any, required by that

- (2) The Local Government may direct by what authority any powers or duties incident under any such enactment as aforesaid to the enforcement of any process for the recovery of a municipal tax or local rate shall be exercised or performed when that process is employed under sub-section (1) for the recovery of the tax chargeable under this Act.
- (3) An order passed by the Collector under sub-section (1) shall have the force of a decree of a Civil Court in a suit in which the Government is the plaintiff and the defaulter is the defendant; XIV of 1882. and the order may be enforced in manner provided by the Code of Civil Procedure for the enforcement of decrees for money; and the procedure under the said Code in respect of the following matters, namely-

 - (a) sales in execution of decrees,(b) arrest in execution of decrees for money,

- (c) execution of decrees by imprisonment,
- (d) claims to attached property, and (e) execution of decrees out of the jurisdiction
- of the Courts by which they were passed, shall apply to every execution issued for levying the sum mentioned in the order; save that all the powers and duties conferred and imposed by said Code upon the Court shall be exercised and discharged by the Collector by whom the order has been made or to whom a copy thereof has been sent for execution according to the provisions of the said Code, sections 223 and 224
- (4) The Local Government may direct, with respect to any specified area, that the tax charge-able under this Act shall be recovered therein with, and as an addition to, any municipal tax or local rate by the same person and in the same mauner as the municipal tax or local rate is recovered.
- (5) No proceedings for the recovery of any sum payable under this Act shall be commenced after the expiration of three months from the last day of the year in respect of which the sum is payable.

CHAPTER VI.

SUPPLEMENTAL PROVISIONS.

Composition.

31. (1) If a company or person desires to Agreements for composition. sessable under Part II or Part IV, as the case may be, the Collector may, subject to such rules as may be prescribed in this behalf, agree with the com-pany or person for a composition for the tax on such terms and for such period as he thinks fit.

(2) The agreement shall provide for the pay ment, in each year of the period comprised in the agreement, of the amount of the composition; and that amount shall be recoverable in the same manner and by the same means as any other assessment made under Part II or Part IV, as the case may be.

Receipts.

- 32. When any money is paid under this Act to
 the Collector or is recovered thereunder by covered thereunder by him, he shall give a receipt for the same, specifying-
 - (a) the date of the payment or recovery of the money;

 - (b) the amount paid or recovered;
 (c) the person who was liable to the tax, and the source or sources of income in respect of which the tax was payable;
 - (d) the year or part of the year for which the tax was payable;
 - (e) the place or places, district or districts, where the income accrues; and (f) such other particulars, if any, as may be
 - prescribed.

Amendment of Assessment.

33. If a company or person assessed under Part
II or Part IV ceases to carry on the trade or business in respect whereof the assessment was made, or if any such person

dies or becomes insolvent before the end of the year for which the assessment was made, or if any such company or person is, from any other specific cause, deprived of or loses the income on which the assessment was made, then the company or person or its or his representative in interest may apply to the Collector during or within three months after the end of the year, and the Collector, on proof to his satisfaction of any such cause as aforesaid, shall amend the assessment as the case may require, and refund such sum, if any, as has been overpaid.

Penalties.

Power to make Rules.

38. (1) The Governor General in Council may make rules consistent with this Act for ascer-Power to make rules. taining and determining income liable to assessment for preventing the disclosure of particulars contained in documents delivered or produced with respect to assessments under Part IV, and, generally, for carrying out the purposes of this Act, and may delegate to a Local Government the power to make such rules so far as regards the territories subject to that Government.

(2) In making a rule for preventing the disclosure of any particulars referred to in sub-section (1), the Governor General in Council may direct that a public servant committing a breach of the rule shall be deemed to have committed an offence under section 166 of the Indian Penal XLV of 1860.

- (3) But a person committing any such offence shall not be liable to be prosecuted therefor without the previous sanction of the Local Government.
- (4) Rules made under this section shall be published in the official Gazette.

Miscellaneous.

- 39. No suit shall lie in any Civil Court to set Bar of suits in Civil aside or modify any assessment made under this Act.
- 40. All or any of the powers and duties conferred and imposed by Exercise of Collector and Commissioner of on a Commissioner of Division may be exer-

cised and performed by such other officer or person as the Local Government appoints in this behalf.

sources other than agriculture was referred, have considered the Bill and the papers noted on the margin, and have now the honour to submit this our Report.

2. We have provided in section 1 that the Act shall come into force cn the first day of April next. During the time which elapses between the passing of the Bill and that date, the Government will be able to prepare and issue its rules, and Collectors to make such arrangements for the assessment of the tax as they can make without calling in aid the

provisions of the Act.

It is important that Collectors should know as soon as possible what incomes will be assessable, and that the Government should at once be in a position to frame the necessary rules for assessment.

- 3. In section 5 we have, with advertence to section 24 (section 23 of the Bill as introduced) inserted a clause (clause (c)) excepting from liability to the tax the whole of the annual value of buildings which landholders and agriculturists own and occupy on, or in the immediate neighbourhood of, the land they hold and cultivate, and which are necessary to them in the exercise of their vocation as landholders and agriculturists. Thus, while a landholder will be exempt from the tax in respect of the annual value of the homestead (if any) appurtenant to his land, he will be assessable in respect of any other house he may own and occupy.
- 4. We have inserted in the same section a further clause (clause (g)), based on the English law, excepting from liability to the tax any portion, not exceeding one-sixth, of his income which a person pays either to the Government or to a company in respect of life-insurance or deferred annuity.
- 5. Clause (e) of section 5 (clause (c) of that section in the Bill as introduced) is based on a similar clause in Act VIII of 1872. The exemption appears to us to be sufficient to cover educational endowments, and does not, as has been suggested, open a door to the evasion of the Act by colourable gifts to idols or any like device.
- 6. We have omitted sub-section (2) of the same section in the Bill as introduced. There appears to us not to be sufficient ground for making, between official salaries and other incomes, the distinction which was proposed in that sub-section.
- 7. By the new sub-section (2) appended to section 5, we have made it clear that a salaried manager of land is not exempt from the tax by reason only of the income of his employer being exempt therefrom.
- 8 We have ascertained that companies and some other private employers are much opposed to that provision of the Bill as introduced which imposed on them the duty of deducting the tax from the salaries of their employés. To the argument that there was such a provision in force in the years 1869-72, they reply that the provision was then a fruitful cause of misunderstanding and disagreement between them and their subordinates. Under these circumstances it appears to us that companies ought not to be compelled to collect the tax. We have therefore modified section 8 of the Bill, and empowered the Collector, by a new section (section 9), to enter into an arrangement with any private employer, on terms to be mutually agreed on, for the collection by the employer of the tax payable by his employés.
- 9. Section 10 of the Bill as introduced followed the Acts of 1869 and 1872 in making special provision for the taxation of shipping companies. It has been stated, and we have satisfied ourselves, that the provision was unworkable and, in practice, inoperative. It has therefore been omitted from section 11, and the second schedule, of the Bill as amended by us: and we have added to section 5 a pecial exception (clause (d)), in favour of shipping companies incorporated or registered out of British India and having their principal places of business out of India and their ships ordinarily engaged in sea-going traffic out of Indian waters.

- 10. To section 18 (section 17 of the Bill as introduced) we have added clauses empowering the Local Government to authorise the Collector in any specified town or place to publish general notices inviting tax-payers to make returns of their income, and in any presidency-town to serve special notices on individual tax-payers inviting them to make such returns.
- 11. In section 24 (section 23 of the Bill as introduced) we have provided for houses occupied by their owners being assessed at five-sixths, instead of nine-tenths, of their annual value. We have thus reverted to the principle of section 132 of Act XXXII of 1860.
- 12. We have so modified section 27 (section 26 of the Bill as introduced) as to require the Commissioner to call for the record in the case of a petition for the revision of any assessment of two hundred and fifty rupees or upwards.
- 13. In section 30 (section 29 of the Bill as introduced) we have provided for the continuance of the summary process of recovery described in section 24 of the Bengal License Act, 1880.
- 14. In sub-section (5) of the same section we have provided that no proceedings for the recovery of any sum payable under the Act shall be commenced after the expiration of three months from the last day of the year in respect of which the sum is payable. The section as amended by us is more restrictive on the revenue-authorities than the corresponding section of the Bengal License Act, 1880, and less so than the corresponding section of the Northern India License Act, 1878.
  - 15. In section 31 provision has been made, as in Act XXXII of 1860, for composition of the tax.
- 16. Seeing that provision is made in Chapter IV for revision of assessment, we think that section 32, sub-section (1), of the Bill as introduced should be omitted, and that section 31 of that Bill may also be omitted, as being likely, by suggesting the disturbance of settled assessments, to create irritation with which the additional revenue raised under the section would be incommensurate.
- 17. In section 38 of the Bill as amended by us (section 37 of the Bill as introduced) we have provided for rules being made for securing secrecy in regard to information furnished in documents relating to incomes of assessees.
- 18. We have deemed it desirable to specify more particularly than in section 40 of the Bill as introduced the information which may be required by a Collector for the purposes of the Act. We have, therefore, for that section substituted sections 41 to 45 of the Bill as amended.
- 19. We have modified section 46 (section 41 of the Bill as introduced) by providing that the delivery of a letter duly posted shall only be presumed, and we have required the letter to be registered.
- 20. From the first column of Part III of the second schedule to the Bill as introduced we have omitted the clause relating to stock of, or shares in, guaranteed railway companies. The clause is unnecessary, as all railway companies will be assessed on their nett earnings. We have, however, provided in new clause (c) of Part III for the recovery, in the manner prescribed in section 13, of the interest on debentures issued by companies.

- 3. We have not overlooked the difficulties pointed out by Mr. Justice Field and others as to the valuation and place of trial of suits under this

An Act to provide for the voluntary Registration of certain Births and Deaths, for the establishment of General Registry Offices for keeping Registers of certain Births, Deaths and Marriages, and for certain other purposes.

WHEREAS it is expedient to provide for the voluntary registration of births and deaths among certain classes of persons, for the more effectual registration of those births and deaths and of the marriages registered under Act III of 1872 or the Indian Christian Marriage Act, 1872, and of certain marriages registered under the Parsi Marriage and Divorce Act, 1865, and for the establishment of general registry offices for keeping registers of those births, deaths and marriages;

And whereas it is also expedient to provide for the authentication and custody of certain existing registers made otherwise than in the perform-

ance of a duty specially enjoined by the law of the country in which the registers were kept, and to declare that copies of the entries in those registers shall be admissible in evidence;

It is hereby enacted as follows:-

## CHAPTER I.

## PRELIMINARY.

1. (1) This Act may be called the Births, Deaths Short title and comand Marriages Registration Act, 1886; and

(2) It shall come into force on such day as the Governor General in Council, by notification in the Gazette of India, directs.

(3) Any power conferred by this Act to make rules or to issue orders may be exercised at any time after the passing of this Act; but a rule or order so made or issued shall not take effect until the Act comes into force.

2. This Act extends to the whole of British India, and applies also, Local extent. within the dominions of Princes and States in India in alliance with Her Majesty, to British subjects in those dominions.

3. In this Act, unless there is something repugnant in the subject Definitions. or context.-

"sign" includes mark, when the person making the mark is unable to write his name:

"prescribed" means prescribed by a rule made by the Gövernor General in Council under this Act; and

"Registrar of Births and Deaths" means a Registrar of Births and Deaths appointed under this Act.

4. Nothing in this Act, or in any rule made under this Act, shall affect any law heretofore or hereafter passed providing for the registration of births and deaths within particular local areas.

14. Every Registrar of Births and Deaths shall be deemed to be a public servant with-in the meaning of the Registrar to be deemed public servant.

Births and Deaths, for the establishment of General Registry Offices for keeping Registers of certain Births, Deaths, and Marriages, and for certain other purposes, was referred, have considered the Bill and the papers noted on the margin and have now the honour to submit this our Report.

2. We have, on the advice of a leading member of the Parsi community at Bombay, proposed to extend to the scattered Parsi communities resident beyond the local limits of the ordinary original civil jurisdiction of the High Court at Bombay the same provisions for the more effec-

tual registration of marriages as were proposed by the Bill to be conferred on the classes to whom Act III of 1872 and the Indian Christian Marriage Act, 1872, apply.

3. By section 11, sub-section (2), we propose to enable Local Governments, with the previous sanction of the Governor General in Council, to extend the operation of the chapter respecting the registration of births and deaths to any classes of the community which may be desirous of taking advantage of the provisions of that chapter.

4. By sections 12 and 13 we have proposed to enable Local Governments in British India, and

the Governor General in Council in States in India in alliance with Her Majesty, to appoint Registrars of Births and Deaths for classes of persons as well as for local areas. It will thus be practicable to appoint ministers of religion to be Registrars of Births and Deaths for their own congregations only, without imposing on them duties for which they might have neither leisure nor inclination.

5. In section 14 we have provided that every Registrar of Births and Deaths shall be deemed to be a public servant. This provision appears to us to render it unnecessary to retain section 24 of the Bill as introduced.

6. By section 19 we have provided that if a Registrar of Births and Deaths has reason to believe any notice given to him to be in any respect false he may refuse to register the birth or death until he receives an order from the District Court directing him to make the entry and prescribing the manner in which the entry is to be made.

In the same section and in section 22, sub-section (3), we have reproduced the provisions of section 7

of the Statute 37 and 38 Vic., cap. 88.
7. In sections 20 and 21 we have classified, in a modified form, the persons authorized to give notices of births and deaths.

8. We have provided in section 24 that clergymen who may become Registrars of Births and Deaths shall send certified copies of the entries in their registers direct to the Registrar General unless

they are required by their ecclesiastical superiors to transmit the copies through them.

9. By section 26 we have proposed to empower the Governor General in Council to make rules authorising Registrars of Births and Deaths, on conditions and in circumstances to be specified in the rules, to register births and deaths occurring outside the local areas or classes for which they have been appointed. Events occurring in the course of journeys, or in places for which Registrars of Births and Deaths have not been appointed, may by those rules be made registrable.

10. We have made fine an alternative punishment for the offence made punishable under sec-

tion 27.

11. To section 36 we have added a clause enabling the Governor General in Council to make

rules as to the custody of registers and records sent to the Registrar General under section 32.

12. The other amendments of the Bill are unimportant and do not call for special remark.

13. In regard to the argument which has been urged in some of the papers before us that the existing registers of certain religious bodies are admissible in evidence, we are informed that the legal value of those registers has been questioned by high authority, on the ground that they are not maintained under any special injunction of law, or in the ordinary course of business, within the meaning of the Indian Evidence Act, 1872.

14. As regards the working of the proposed Act we understand that existing machinery will, so far as possible, be utilised, and that expenses will be defrayed from fees payable under the Act.

15. Other objections taken to the Bill are (a) that some Registrars may object to the provisions of section 16, sub-section (2) and (b) that difficulties may result from the requirement of section 22, of section 16, sub-section (2) and (b) that difficulties may result from the requirement of section 22, sub-section (1), that the person giving notice of a birth or death must sign the entry in the register in the presence of the Registrar. As regards the first of these objections we observe that section 16, sub-section (2), will not apply to all Registrars, but only to those to whom the Local Government applies the sub-section. As regards the second objection the risk of difficulties arising may be diminished, if not removed, by provision being made, in the rules under clause (c) of section 36, for an enlargement under certain circumstances of the time within which notices may be given of births and

The following Act of the Governor-General of India in Council received the assent of His Excellency the Governor General on the 8th March 1886, and was promulgated for general information in the Gazette of India on the 13th March 1886:-

### Act No. VII of 1886.

An Act to amend the Indian Registration Act, 1877.

WHEREAS it is expedient to amend the Indian Registration Act, 1877, in manner hereinafter appearing; It is hereby enacted as follows:

1. (1) This Act may be Short title and com-encement called the Indian Registration Act, 1886; and

(?) It shall come into force at once.

2. After clause (f) of section 17 of the Indian Registration Act, Addition to section 17 of Act III of 1877.

Act III of 1877. I of 1877. shall be inserted, that is

to say :-

- "(ff) any debenture issued by any such company and not creating, declaring, assigning, limiting or extinguishing any right, title or interest to or in immoveable property except in so far as it entitles the holder to the security afforded by a registered instrument whereby the Company has mortgaged, conveyed or otherwise transferred the whole or part of its immoveable property or any interest therein to trustees upon trust for the benefit of the holders of such debentures, or ".
- 3. (1) After clause (1) of section 17 of the Addition to sections 17 and 89, and amendment of section 58, of same Act. same Act the following clause shall be added, that is to say:—

"(m) orders granting loans under the Agricul-turists' Loans Act, 1884, and instruments for securing the repayment of loans made under that Act."

(2) In section 58 of the same Act, for the words "or a copy of a certificate under the Land IXVIo1871 Improvement Act, 1871, sent by the Collector to be registered," or, where the Land Improvement XIX of 1883. Loans Act, 1883, is in force, for the words "or a copy of an order under the Land Improvement IX of 1883. Loans Act, 1883, sent by the Collector to be re-

gistered," there shall be substituted the following words, namely :-

"or a copy sent to a registering officer under section 89".

(3) After the second paragraph of section 89 of the same Act the following paragraph shall be added, that is to say :-

"Every officer granting a loan under the Agriculturists' Loans Act, 1884, shall send a copy of any instrument whereby immoveable property is mortgaged for the purpose of securing the repayment of the loan, and, if any such property is mortgaged for the same purpose in the order granting the loan, a copy also of that order, to the registering officer within the local limits of whose jurisdiction the whole or any part of the property so mortgaged is situate, and such registering officer shall file the copy or copies, as the case may be, in his Book No. 1.

4. After clause (m) of section 17 of the same Further addition to section 17 of same Act.

Act as amended by this Act the following clause · shall be added, that is

"(n) any endorsement on a mortgage-deed acknowledging the payment of the whole or any part of the mortgage-money, and any other receipt for payment of money due under a mortgage when the receipt does not purport to extinguish the mortgage."

5. In the second paragraph of section 50 of the same Act, "(jj)" Amendment of section 50 of same Act.

Amendment of section 50 shall be inserted between "(f)" and (g)", and for the word and letter "and (l)" the letters and word "(l), (m) and (n)" shall be substituted.

6. (1) After clause (d) of section 90 of the same Act the following Addition to section 90. and amendment of section 91, of same Act. same Act the following clause shall be inserted, that is to say:—

"(e) notices given under section 74, or section 76, of the Bombay Land-revenue Code, Bom. Act V 1879, of relinquishment of occupancy or 1879. by occupants, or of alienated land by holders of such land".

- (2) In section 91, for the word and letter "and (c)" the letters and word "(c) and (e)" shall be substituted.
- (3) The said Act shall be construed as if the amendments made in it by this section had been made at the time the Act came into force.

The Bill as introduced has been approved by the authorities to whose criticism it was submitted. Some suggestions for the further amendment of the Act have been made; but, as the revision of the law relating to registration is understood to be under the consideration of the Gov-ernment of India, we have deemed it advisable not to deal with them generally in this Bill. On one suggestion, however, we have deemed it necessary to act

law should declare receipts for payments of mortgage-money to be optionally, and not compulsorily, registrable. In connection with this suggestion we have considered the case reported at I. L. R. 6 All. 335, and the cases there cited, and the replies of Local Governments and High Courts to a letter addressed to them by the Government of India on the subject of these cases. addressed to them by the Government of India on the subject of those cases. The authorities to whom the letter was addressed are almost unanimously of opinion that on grounds of convenience, receipts for payment of mortgage-money ought not to be compulsorily registrable. We concur in that opinion, and have added to the Bill a clause (section 4) excepting from the operation of clauses (b) and (c) of section 17 of the Act (i) any endorsement on a mortgage-deed acknowledging the payment of the whole or any part of the mortgage-money, whether the endorsement does or does not purport to extinguish the mortgage, and (ii) any other receipt for payment of money due under a mortgage when the receipt does not purport to extinguish the mortgage. In so framing the clause we have, as regards endorsements, followed the course recommended by the High Court at Bombay, and, as regards other receipts, the general tenor of the opinions expressed by the authorities whom the Government of India has consulted.

## The Indian Tramways Act, 1886.

## (Preliminary.—Orders authorising the Construction of Tramways.—Sections 1-4.)

An Act to facilitate the construction and to regulate the working of Tramways.

WHEREAS it is expedient to facilitate the construction and to regulate the working of tramways; It is hereby enacted as follows:—

## Preliminary.

Short title and commencement.

1. (1) This Act may be called the Indian Tramways Act, 1886; and

(2) It shall come into force at once.

Local extent.

2. (1) It extends in the first instance to the whole of British India, except the territories administered by the Governor of Fort Saint George in Council, the Governor of Bombay in Council, and the Lieutenant-Governor of Bengal.

- (2) But the Governor of Fort Saint George in Council, the Governor of Bombay in Council or the Lieutenant-Governor of Bengal may, by notification in the official Gazette, extend this Act to the whole or any part of the territories under his administration.
  - 3. In this Act, unless there is something repugnant in the subject or context,—
- (1) "local authority" means a municipal committee, district board, body of port commissioners or other authority legally entitled to, or entrusted by the Government with, the control or management of a municipal or local fund:
- (2) "road" means the way of a road, street, thoroughfare, passage or place along or across which a tramway authorised under this Act is, or is intended to be, laid, and includes the surface soil and sub-soil of a road, and the footway, berms, drains and ditches of a road, and any bridge, culvert or causeway forming part of a road:
- (3) "road-authority", in relation to a road, means—
  - (a) if a local authority maintains and repairs the road, then that authority;
  - (b) if a local authority does not maintain and repair the road, and the road is neither vested in Her Majesty nor maintained and repaired by the Government, then the person in whom the road is vested; and
  - (c) if a local authority does not maintain and repair the road, and the road is vested in Her Majesty or maintained and repaired by the Government, then the Local Government:
- (4) "circle", in relation to a local authority or road-authority, means the area within the control of that authority:
- (5) "tramway" means a tramway, or any part of a tramway, or any siding, turnout, connection, line or track belonging to a tramway:
- (6) "order" means an order authorising the construction of a tramway under this Act, and

- includes a further order substituted for, or amending, extending or varying, that order:
- (7) "promoter" means a local authority or person in whose favour an order has been made, and includes a local authority or person on whom the rights and liabilities conferred and imposed on the promoter by this Act and by the order and any rules made under this Act, as to the construction, maintenance and use of the tramway, have devolved:
- (8) "undertaking" includes all moveable and immoveable property of the promoter suitable to and used by him for the purposes of the tramway:
- (9) "carriage", in the case of a tramway on which steam-power or any other-mechanical power is used, includes an engine worked on the tramway for the purpose of producing that power:
- (10) "toll" includes any charge leviable in respect of the use of a tramway:
- (11) "lessee" means a person to whom a lease has been granted of the right of user of a tramway and of demanding and taking the authorised tolls:
- (12) "District Magistrate" includes an officer empowered by the Local Government by name or by virtue of his office to discharge within any local area all or any of the functions of a District Magistrate under this Act:
- (13) "District Court" means a principal Civil Court of original jurisdiction, and includes a High Court having ordinary original civil jurisdiction:
- (14) "Collector" means the chief officer in charge of the revenue-administration of a district, and includes an officer empowered by the Local Government by name or by virtue of his office to discharge within any local area the functions of a Collector under this Act; and
- (15) " prescribed" means prescribed by rules made by the Local Government under this Act.

Orders authorising the Construction of Tramways.

- 4. (1) The Local Government may make an Application for and consent necessary to making of order.

  Application for and construction of a tramway in a circle on application made—
  - (a) by the local authority of the circle, with the consent of the road-authority of any road or part of a road which is to be traversed by the tramway, and of which the local authority is not itself the roadauthority; or
  - (b) by any person with the consent of the local authority of the circle, and of the road-authority of any road or part of a road which is to be traversed by the tramway and of which the local authority is not the road-authority:

Provided that, if any part of the proposed tramway is to traverse land which is not included within the limits of a municipality or of a cantonment, the Local Government shall not make

the order without the previous sanction of the Governor-General in Council.

- (2) A local authority shall not make an application for an order, or be deemed to consent to an application being made by any person for an order, unless the making of the application or the giving of the consent has been approved by the local authority in manner prescribed.
- 5. When it is proposed to lay a tramway in Consent of local or road authority not necessary in a local authority or road-authority having control in either or any of the circles does not consent thereto, or attaches conditions to its consent, the Local Government may, nevertheless, make an order authorising the construction of the tramway in the circle, or by the order impose on the promoter any conditions which it deems fit, if, after considering the reasons of the authority for withholding its consent or attaching the conditions thereto, it is satisfied that the construction of the tramway in the circle is expedient, or, as the case may be, that the conditions attached by the authority to its consent ought not to be imposed.
- 6. (1) The Local Government on receiving an application shall consider Procedure for making it, and, if satisfied as to the propriety of proceeding thereon, publish in the official Gazette, and in such other manner as it deems sufficient for giving information to persons interested, a draft of a proposed order authorising the construction of the tramway.

(2) A notice shall be published with the draft stating that any objection or suggestion which any person may desire to make with respect to the proposed order will, if submitted to the Local Government on or before a date to be specified in the notice, be received and considered.

(3) If, after considering any objections or suggestions which may have been made with respect to the draft on or before the date so specified, the Local Government is of opinion that the application should be granted, with or without addition or modification, or subject or not to any restriction or condition, it may make an order accordingly.

(4) Every order authorising the construction of a tramway shall be published in the official Gazette in English, and in the other prescribed language or languages, if any; and that publication shall be conclusive proof that the order has been made as required by this section.

7. (1) An order made under section 6 shall

Contents of order. empower the promoter therein specified to construct and maintain the tramway therein described in the manner therein provided, and shall specify the time within which the tramway shall be commenced and the time within which it shall be completed and opened for public traffic.

completed and opened for public traffic.

(2) The order may also provide, in manner consistent with this Act, for all or any of the following, among other matters, that is to say:—

(a) a period before the expiration of which the tramway shall not be commenced,

- and the conditions subject to which the local authority, when it is not itself the promoter, may, within that period, elect to be substituted in the place of the promoter in respect of the undertaking or of so much thereof as is within its circle; and the limits of time within which, and the terms upon which, the local authority may, after the tramway has been constructed, require the promoter to sell to it the undertaking or so much thereof as is within its circle;
- (b) the acquisition by the promoter of land for the purposes of the tramway, and the disposal by him of land which has been acquired but is no longer required for those purposes;
- (c) the conditions subject to which roads may be opened and broken up for the purposes of the construction or maintenance of the tramway or any part thereof, and the method of, and materials to be used in, the re-instating of the roads, and the approval of the method and materials by the Local Government or the road-authority before the commencement of the work;
- (d) the conditions on which the tramway may be constructed over a bridge or across a railway or tramway when the carriageway over the bridge is to form part of the tramway or when the tramway is to cross a railway or another tramway on the level;
- (e) the space which shall ordinarily intervene between the outside of the carriageway on either side of a road whereon the tramway is to be constructed and the nearest rail of the tramway, and the conditions on which a smaller space may be permitted;
- (f) the gauge of the tramway; the rails to be used, and the mode in which and the level at which they shall be laid and maintained; and the adoption and application by the promoter of such improvements in the rails, and in their situation, and in the sub-structure upon which they rest, as the Local Government may from time to time require;
- (g) the portion of the road or roadstraversed by
  the tramway to be kept in repair by the
  promoter, the maintenance by the promoter to the satisfaction of the Local
  Government or the road-authority, or
  both, of that portion of the road or roads;
  and the liability of the promoter, on the
  requisition of the Local Government, from
  time to time to adopt and apply such improvements in the tramway as the Local
  Government may consider necessary or
  desirable for the safety or convenience
  of the public, and to alter the position or
  level of the tramway to suit future alterations in the road or roads;

- (h) the application of material excavated by the promoter in the construction or maintenance of the tramway;
- (i) the provision of such crossings, passing-places, sidings, junctions and other works, in addition to those specified in or authorised by the order, as may from time to time be necessary or convenient to the efficient working of the tramway;
- (j) the powers which may from time to time be exercised by the Local Government, the local authority, the road-authority or any person in respect of sewers, drains, telegraph-lines, gas-pipes, water-pipes or other things in or on land occupied by the tramway; the notice (if any) to be given of the intended exercise of those powers; the manner in which the powers shall be exercised; and the extent to which the tramway and the traffic thereon may be interfered with in the exercise thereof;
- (k) the conditions subject to which the promoter may from time to time interfere with, or alter or require the alteration of the position of, drains (not being sewers or main drains), telegraph-lines, gas-pipes, water-pipes or other things as aforesaid;
- (l) the provision of a temporary tramway in place of a part of a tramway which has been removed, or of which the use has been discontinued, by reason of the execution of any work affecting a road along which the part of the tramway was laid, or by reason of the use of the road being interrupted by floods or other cause;
- (m) the motive power to be used on the tramway, and the conditions on which steampower or any other mechanical power may be used;
- (n) the nature, dimensions, fittings, appliances and apparatus of the carriages to be used on the tramway, and the inspection and examination thereof by officers of the Local Government or the local authority, and the liability of the promoter or lessee, on the requisition of the Local Government, from time to time, to adopt and apply such improvements in the carriages and in the fittings, appliances and apparatus, as the Local Government may consider necessary or desirable for the safety or convenience of the public;
- (o) the traffic which may be carried on the tramway, the traffic which the promoter or lessee shall be bound to carry, and the traffic which he may refuse to carry; the tolls to be leviable by the promoter or lessee, and the periodical revision thereof by the Local Government; and the regulation of the traffic and of the levy of the tolls;
- (p) the use of the tramway free of toll by the local authority, with its own carriages, for specified purposes, during specified respectively, jointly to construct the whole, or hours, with power to the local authority separately to construct parts, of a tramway, and

- to make such sidings and other works as may be necessary for communication between its premises and the tramway;
- (q) the conditions subject to which the promoter may transfer the undertaking, or any part thereof, by sale, mortgage, lease, exchange or otherwise; and the conditions subject to which the local authority may be the transferee:
- (r) the performance by the Local Government or by the local authority or road-authority of any work required by the Act or the
- order to be done by the promoter; and
  (s) the penalty to be incurred by the promoter
  or lessee for failure to observe any condition or direction contained in the order, and the application of the penalty when recovered.
- (3) The Local Government may, in providing in the order for the acquisition of land for the purposes of a tramway of which the promoter is not a company, direct that land may be acquired for the promoter under the provisions of the Land Acquisition Act, 1870, in the same manner and on X. of 1870. the same conditions as it might be acquired for the purposes of the tramway if a company were the promoter.

- The order shall imply the condition-
- (a) in the case of a tramway of which a local authority is the promoter, that a lease thereof shall be granted only in manner by this Act provided; and
- (b) in the case of a tramway of which a local authority is not the promoter, that a lease thereof shall be only of the right of user and of demanding and taking the author-ised tolls, and shall not confer or impose on the lessee any of the powers or duties of the promoter in respect of the construction or maintenance of the tramway.
- 8. (1) The Local Government may, on the Further order. application of the promoter, revoke, amend, extend or vary the order by a further order.
- (2) An application for a further order shall be made in the same manner and subject to the same conditions as an application for an order.
- (3) The Local Government may, in its discretion, either grant or reject the application.
- (4) If it grants the application, it shall make the further order in the same manner as an order, except that no addition to, or modification of, the rights, powers and authorities asked for in the application, or restriction or condition with respect thereto, shall be made or imposed by the further order without the consent in writing of the promoter.
- 9. (1) Subject to, and in accordance with, the Power to authorise joint work by local authorities.

  provisions of this Act, the Local Government may, on a joint application, or on two or more separate applications make an order empowering two or more local authorities,

jointly or separately to own the whole or parts

- (2) All the provisions of this Act which relate to the construction of tramways shall extend and apply to the construction of the whole and the separate parts of the tramway, and the form of the order may be adapted to the circumstances of the case.
- 10. (1) If a promoter authorised by an order Cessation of powers given to construct a tramway—by an order.
  - (a) does not within the time specified in the order substantially commence the construction of the tramway, or
    (b) having commenced the construction, sus-
  - pends it without a reason sufficient in the opinion of the Local Government to warrant the suspension, or (c) does not within the time specified in the
  - order complete the tramway and open it for public traffic,

the following consequences shall ensue:-

- (i) the powers given by the order to the pro moter for constructing the tramway and otherwise in relation thereto shall, unless the Local Government, by special direction in writing, prolongs the time or condones the suspension, cease to be exercised except as to so much of the tramway as is then completed:
- (ii) as to so much of the tramway as is then completed the Local Government may either permit, or refuse to permit, the powers given by the order to continue;
- (iii) if the Local Government refuses to permit the powers to continue, then so much of the tramway as is then completed may be dealt with, under the provisions of this Act relating to the discontinuance of tramways, as a tramway of the working whereof the discontinuance has been proved to the satisfaction of the Local Government.
- (2) A notification published by the Local Government in the official Gazette to the effect that on a date specified in the notification the construction of a tramway had not been substantially commenced or a tramway had not been completed and opened for public traffic, or that the construction of a tramway had been suspended without sufficient reason, shall, for the purposes of this section, be conclusive proof of the matter stated therein.

Construction and Maintenance of Tramways.

- 11. A tramway shall be constructed and Mode of formation of maintained in the manner tramway. provided by the order.
- 12. A tramway, or portion or extension of, or Inspection of tramway shall not be opened for public traffic until an engineer appointed in this behalf by the Local Government has inspected it and certified it to be fit for such traffic.

13. Subject to the provisions of any order for Agreement between road authority and promoter as the time being in force with respect to the matters mentioned in section. to repair of roadway. ters mentioned in section 7, sub-section (2), clause (g), the road-authority and the promoter may from time to time enter into agreements as to the keeping in repair of the whole or a part of a road traversed by a tramway, and as to the proportion to be paid by either of them of the expense of keeping the road or part in repair.

## Traffic on Tramways.

14. (1) The promoter of a tramway shall, sub-Rights of promoters and he public over tramways. the other provisions of this Act and of the order, have the exclusive use of the tramway for carriages with flange-wheels or other wheels suitable to run on the rail described in the order as the rail to be used on the tramway:

Provided that nothing in this Act or in the order any rule made under this Act shall affect the right of any person authorised to use a tramway or railway to pass across a tramway constructed under this Act with carriages having wheels suitable to run on the rail thereof.

(2) The public shall have a right to pass along or across any part of a road along or across which a tramway is constructed, whether on or off the with carriages not having flange-wheels or other wheels suitable to run on the rail of the tramway: provided-

(a) that this sub-section shall not apply where the tramway is constructed on land the right to the exclusive possession of which has been acquired by the promoter; and

- (b) that the Local Government may by an order authorise the construction of a tramway on any part of a road with rails raised above the surface of the road, if it is satisfied that the convenience of the public will not be injuriously affected thereby.
- 15. (1) The promoter or lessee may demand Tolls leviable by promoter or lessee.

  and take, in respect of the tramway, tolls not exceeding the limits exceeding the limits specified in or determinable under the order, or, if the order contains no provision in this behalf, then such sums as may from time to time be fixed by the promoter or lessee with the previous sanction of the Local Government.

## (Licenses to use Tramways.—Discontinuance of Tramways.—Sections 17-20.)

(3) A person sending such goods by the tram-way shall distinctly mark their nature on the outside of the package containing them, or otherwise give notice thereof in writing to the servant of the promoter or lesses with whom he leaves them for the purpose of their being sent by the tramway.

(4) Any servant of the promoter or lessee may refuse to carry upon the tramway a parcel which he suspects to contain goods of a dangerous or offensive nature, and, if any such parcel has been received for the purpose of being carried upon the tramway, may stop the transit thereof until he is satisfied as to the nature of its contents.

(5) Where a servant of the promoter or lessee refuses under sub-section (4) to carry a parcel which has been received for the purpose of being carried upon the tramway, he shall, as soon as may be, give notice of his refusal to the consignor or consignee if he refuses at a time when neither of them is present.

17. If, at any time after a tramway or part of Grant to third parties a tramway has been for of licenses to use tramway in certain events.

the local authority of the circle represents in writing to the Local Government that the public is deprived of the full benefit of the transparence. is deprived of the full benefit of the tramway or of the part thereof, the Local Government may, if after considering any statement which the promoter or lessee or both may desire to make, and after such further enquiry as it deems necessary it is satisfied as to the truth of the representation, grant a license to any person to use the tramway conformably to this Act and to the order and the rules made under this Act, subject to the following provisions, namely :-

(a) the license shall be for a period not less than one year or more than three years from the date of the license, but the Local Government may in its discretion renew it;

(b) the license shall be to use the whole of the tramway for the time being opened for public traffic, or such part or parts of the tramway as the Local Government, having regard to the cause for granting the license, thinks fit;

(c) the license shall specify the number of carriages which the licensee shall run upon the tramway, the mode in which, and times at which, the carriages shall be run, the tolls to be paid to the promoter or lessee by the licensee for the use of the tramway, and the tolls, being those for the time being leviable by the promoter or lessee, which the licensee may demand and take for the use of his carriages;

(d) the licensee and his officers and servants shall permit one person, duly authorised for that purpose by the promoter or lessee, to travel free of toll in or upon each carriage of the licensee run upon the tramway for

the whole or any part of a journey;
(e) any provision of this Act, or of the order or rules made under this Act, relating to the

functions of a servant of a promoter or lessee shall be construed, so far as may be, as referring to a servant of the licensee; and

(f) the Local Government may revoke, alter or modify the license for any cause sufficient in its opinion to warrant the revocation, alteration or modification thereof.

18. A licensee shall, on demand, give to an officer or servant autho-

rised in that behalf by the promoter or lessee an exact account in writing,

signed by the licensee, of the number of passengers, or number or quantity of goods, conveyed by any and every carriage used by him on the tramway.

## Discontinuance of Tramways.

19. If it is proved to the satisfaction of the Local Government, at Cessation of powers of promoter and lessee on discontinuance of tramway. any time after the open-

promoter and lessee on discontinuance of tramway. ing of a tramway for public traffic, that the working of the tramway, or any part thereof, has been practically discontinued, for the space of three months, without a reason sufficient, in the opinion of the Local Government, to warrant the discontinuance, the Local Government, if it thinks fit, may, by notification in the official Gazette, declare that the powers of the promoter and of the lessee, if any, in respect of the tramway or the part thereof of which the working has been so discontinued, shall, from the date of the notification, be at an end; and thereupon the said powers shall cease and determine, except in so far as they may be purchased by a local authority in manner by this Act provided.

20. (1) Where anotification has been publish-

ed under section 19, the Powers of road-authority on cessation of powers of promoter.

ed under section 19, the road-authority may, at any time after the expiration of two months from

the date of the notification, remove the tramway or part of the tramway of which the working has been so discontinued, and use the materials thereof in re-instating the road.

(2) The promoter shall pay to the road-authority the cost incurred by that authority in removing the tramway or the part thereof and in re-instating the road.

(3) The cost shall be certified by an officer of the road-authority, and his certificate, countersigned by the District Magistrate, shall be con-

clusive proof as to the cost incurred.

(4) If the promoter does not pay the amount so certified within one month after the delivery to him of the certificate or of a copy thereof, the road-authority may, without any previous notice to the promoter and without prejudice to any other remedy which it may have for the re-covery of the amount, sell and dispose of such materials of the tramway or part thereof re-moved as it has not used in re-instating the road, either by public auction or by private sale, and for such sum or sums, and to such person or persons, as it thinks fit, and may, out of the

## Insolvency of Promoter.

21. (1) If, at any time after the opening of Proceedings in case of insolvency of promoter.

a tramway in a circle for public traffic, it appears to the road-authority or local authority of the circle that the promoter of the tramway is insolvent, so that he is unable to maintain the tramway, or to work it with advantage to the public, and either of those authorities makes a representation to that effect to the Local Government, the Local Government may, if after considering any statement which promoter may desire to make, and after such further enquiry as it deems necessary, it is satisfied as to the truth of the representation, declare, by notification in the official Gazette, that the powers of the promoter shall, at the expiration of six months from the publication of the notification, be at an end; and the powers of the promoter shall cease and determine at the expiration of that period, except in so far as they may be purchased by a local authority in manner by this Act provided.

(2) Where a notification has been published under sub-section (1), the road-authority may, at any time after the expiration of six months from the date thereof, remove the tramway in the same manner, and subject to the same provisions as to the payment of the cost of the removal, and to the same remedy for recovery of the cost, in every respect as in cases of removal under sec-

tion 20.

## Purchase of Tramways.

22. (1) Where the promoter of a tramway in Future purchase of undertaking by local authority. rity, with the previous sanction of the Local Government, may

(a) within such limits of time as may be speci-

undertaking or any compensation for compulsory sale or other consideration whatsoever.

(2) A requisition shall not be made under subsection (1) unless the making thereof has been approved by the local authority in manner prescribed.

(3) When a sale has been made under this section, all the rights, powers and authorities of the promoter in respect of the undertaking or part thereof sold, or, where a notification has been published under section 19 or section 21, all the rights, powers and authorities of the promoter previous to the publication of the notification in respect of the undertaking or part thereof sold, shall be transfer-red to the authority to whom the undertaking or part has been sold, and shall vest in, and may be exercised by, that authority in the same manner as if the tramway had been constructed by it under an order made under this Act.

(4) Subject to, and in accordance with, the preceding provisions of this section, two or more local authorities may jointly purchase an undertaking or so much thereof as is within their

circles

Working of Tramways owned by Local Authorities.

23. (1) When a local authority has under the Lease of, or working of, tramway by local authority of an order completed a tramway, or has authority. under the provisions of this Act or of an order acquired possession of a tram-way, it may, by alease to be approved by the Local Government, let to any person the right of user of the tramway and of demanding and taking the authorised tolls.

(2) On the determination of a lease the local authority may from time to time let the right for such further term and on such conditions as the

Local Government may approve.
(3) Every lease made under this section shall imply a condition of re-entry if at any time after the making thereof it is proved to the satisfaction of the Local Government that the lessee has practically discontinued the working of the tramway leased, or of any part thereof, for the space of one month without a reason sufficient, in the opinion of the Local Government, to warrant the discontinuance

(4) Notice of the intention of the local authority to make a lease shall be given in manner

prescribed.

(5) If the local authority cannot by means of a lease obtain what it deems to be a fair rent for the tramway, it may itself, with the previous sanction of the Local Government and for such term as the Local Government directs, place and run carriages upon the tramway, and demand and take the authorised tolls in respect of the use of the carriages.

(Settlement of Differences.—Recovery of Tolls.—Savings.—Sections 35-39.)

Settlement of Differences.

35. (1) If any difference arises between the promoter or lessee on the Differences between pro-moters or lessees and authorities. one hand and the Local Government, or the local

authority, or the roadauthority, or a person having the charge of any sewers, drains, telegraph-lines, gas-pipes, water-pipes, or other things in or on land occupied by the tramway, on the other hand, with respect to any interference or control exercised or claimed to be exercised by, or on behalf of, either party by virtue of this or any other Act, or of the order or the rules made under this Act, or with respect to the propriety of, or the mode of, the execution of any work, or with respect to any compensation to be made by or to the promoter or lessee, or or the question whether any work is such as ought reasonably to satisfy the Local Government or the road-authority or both, or with respect to any other subject or thing regulated by, or comprised in, this Actor the order or the rules made under this Act, and not otherwise expressly provided for therein, the matter in difference shall, except where the parties elect to proceed under section 523 of the Code of Civil Procedure, be settled, on the application of either party, by a referee.
(2) Where the difference is-

(a) between the promoter or lessee on the one hand and the Local Government, either as such or as the road-authority, on the other, or

(b) between the promoter on the one hand and the local authority on the other, with respect to the sum to be paid by the local authority for an undertaking or part of an undertaking which that authority has required the promoter to sell under section 22,

the referee shall be the District Court within the jurisdiction of which the tramway is situate, or, where the tramway is within the jurisdiction of more than one District Court, the District Court within the jurisdiction of which the greater part of the tramway is situate.

(3) In other cases, the referee shall be appointed by the Local Government.

(4) Except where the referee is the District Court, the powers and procedure of the referee

may be prescribed.

(5) In the case of a difference between a promoter on the one hand and a local authority on the other, with respect to the sum to be paid by the local authority for an undertaking or part of an undertaking which that authority has re-quired the promoter to sell under section 22, an appeal shall lie to the High Court from the award of the referee as from an original decree of the District Court.

(6) In the case of every other difference the award of the referee shall be final.

Recovery of Tolls.

36. Any of the following moneys, namely, any rent due to a local autho-Recovery of moneys due from promoters and, in certain cases, from lessees. rity from a lessee, any penalty recoverable from a promoter or lessee under an order, any sum payable by a promoter

or lessee under an award of a referee, the cost of the performance under this Act by the Local Government or by a local authority or road-authority of any work required by this Act or by an order to be done by a promoter, and the cost incurred by a road-authority in removing a tramway and re-instating a road under this Act, may, without prejudice to any other remedy that the authority to which the money is due may have by suit or otherwise, be recovered by that authority, on application made in this behalf to the Collector, as if the sum due were an arrear of land revenue due by the promoter or lessee or his surety (if any):
Provided that nothing in this section shall

authorise the arrest of the promoter or lessee or his surety in execution of any process issued

by the Collector.

37. (1) If a licensee fails to pay on demand the tolls due for the use Recovery of tolls from licensees. of a tramway, the promoter or lessee to whom the tolls are due may, without prejudice to the remedy which he may have by suit, apply to a Magistrate to recover the amount of the tolls, and the Magistrate may, after giving notice to the licensee if possible and allowing him an opportunity of being heard, proceed to recover the amount by distress and sale of any carriages or other moves his property of the licensee which or other moveable property of the licensee which may be found on the tramway or on premises connected therewith.

(2) When a licensee has failed to pay on demand the tolls due from him, the promoter or lessee to whom the tolls are due may seize any carriage or other moveable property of the licensee on the tramway or on premises connected therewith, and detain the same for forty-eight hours unless the tolls are sooner paid.

(3) When application is made to a Magistrate under sub-section (1), he may make an interim order of distraint pending his final decision.

Any toll due to a promoter, lessee or licensee from a passenger may be recovered either by suit or on application by suit or, on application to a Magistrate having jurisdiction within any local area in which any part of the tramway is laid, by distress and sale of any moveable property belonging to the passenger within the local limits of the jurisdiction of the Magistrate.

By section 5 we have empowered the Local Government to modify conditions sought to be imposed by a local authority with respect to the construction within its circle of part of a tramway

- which is to be laid in two or more circles. 4. In sections 17 and 21 we have provided for an opportunity being given to the promoter to state his case before the Local Government either grants licenses under the former section or deter-
- mines the powers of the promoter under the latter section. 5. By clauses (g) and (h) of sub-section (1) of section 24 we have enabled the Local Government to make rules as to the periodical submission of statistics relating to tramways, and as to the accidents of which report is to be made.
- 6. By clause (e) of sub-section (2) of the same section we have empowered local authorities to make rules as to the manner in which carriages using the tramway after sunset and before sunrise are to be lighted.
- 7. By section 27 we have made the previous sanction of the District Magistrate a condition precedent to the institution by a private person of criminal proceedings against a promoter, lessee or licensee for breach of any provision of the Act or of any direction of an order authorizing the construction of a tramway.
- 8. By section 35 we have provided that, except where the parties to a difference elect to proceed under section 523 of the Code of Civil Procedure, the matter in difference between them shall be settled, on the application of either party, by a referee, and that, where the difference is between the promoter on the one hand and the local authority on the other with respect to the sum to be paid by the local authority for an undertaking which that authority has required the promoter to sell under section 22, the referee shall be the District Court. We have also provided that, in that case, an appeal shall lie to the High Court from the award of the District Court.
- 9. To section 45 we have added a sub-section supplementary to Act XV of 1885 (an Act to amend the Local Authorities Loan Act, 1879).

- 11. By section 48 we have made provision for cases in which a local area comprising a tramway is excluded from the circle of one local authority and included in that of another.
- 12. By section 49 we have proposed so to amend section 54 of the Indian Railway Act, 1879, as to enable the Governor General in Council to apply that Act or any portion thereof to a tramway worked by any mechanical power.

- 13. The other amendments of the Bill are few and unimportant, and do not call for special notice.

## THE SCHEDULE.

An Act to regulate the importation, possession and transport of Petroleum and other fluids of a like nature.

WHEREAS it is expedient to regulate the importation, possession and transport of petroleum and other fluids of a like nature; It is hereby enacted as follows:

Preliminary.

1. (I) This Act may be called the Petroleum Act, 1886; and Short title, commence-ment and local extent.

- (2) It shall come into force on such day as the Governor General in Council, by notification in the Gazette of India, appoints.
- (3) The provisions of this Act relating to dangerous petroleum, and the importation of petroleum, extend to the whole of British India. The rest of this Act extends only to such local areas as the Local Government may from time to time, by notification in the official Gazette, direct.
- (4). Any power conferred by this Act to make rules or issue orders may be exercised at any time after the passing of this Act; but a rule or order so made or issued shall not take effect until the Act comes into force.
  - 2. (1) On and from the day on which this Act

"petroleum" includes also the liquids commonly known by the names of rock oil, Rangoon oil, Burma oil, kerosine, paraffin oil, mineral oil, petroline, gasoline, benzol, benzoline, benzine, and any inflammable liquid which is made from petroleum, coal, schist, shale, peat or any other bituminous substance, or from any products of petroleum; but it does not include any oil ordinarily used for lubricating purposes and having its flashing point at or above two hundred degrees of Fahrenheit's thermometer:
- (2) "dangerous petroleum" means petroleum having its flashing point below seventy-six degrees of Fahrenheit's thermometer: Provided that, when all or any of the petroleum on board a ship, or in the possession of a dealer, is declared by the master of the ship or the consignee of the cargo, or by the dealer, as the case may be, to be of one uniform quality, the petroleum shall not be deemed to be dangerous if the samples selected from the petroleum have their flashing points, on an average, at or above seventy-three degrees Fahrenheit's thermometer, and if no one of those samples has its flashing point below seventy degrees of that thermometer;

(3) "import" means to bring into British India by sea or land,

4. (1) The flashing point of petroleum means the lowest temperature at which the petroleum wields a various which yields a vapour which will furnish a momentary flash or flame when tested in accordance with the directions in the schedule to this Act with an apparatus which has been stamped and certified as provided by this Act within a period of five years immediately preceding the date on which the apparatus is used for the testing, and after the corrections (if any) which the certificate declares are to be applied to the results of the testing have been made.

- (2) Notwithstanding anything in the defini-tions of "import", "importation" and "trans-port", the Local Government, with the previous sanction of the Governor General in Council, may from time to time, by notification in the official Gazette, declare-
  - (α) that petroleum imported into its territories from any part of British India, by sea or across intervening territory not being part of British India, shall, for all or any of the purposes of this Act, be deemed to be transported; and

(b) that petroleum transported into its territories from any place in British India shall, for all or any of those purposes, be deemed to be imported;

and thereupon the provisions of this Act, and of the rules made under this Act, with respect to transport and import, respectively, shall apply to petroleum so imported or transported.

- 5. (1) No quantity of dangerous petroleum Dangerous petroleum in exceeding forty gallons quantities exceeding forty shall be imported or gallons.

  The quantities of the petroleum in exceeding forty gallons shall be imported or transported, or kept by any one person or on the same premises, except under, and in accordance with the conditions of, a license from the Local Government granted as next hereinafter provided.
- (2) Every application for such a license shall be in writing, and shall declare—
  - (a) the quantity of the petroleum which it is desired to import, transport or possess, as
  - the case may be;
    (b) the purpose for which the applicant believes that the petroleum will be used; and
  - (c) that petroleum other than dangerous petroleum cannot be used for that purpose.
- (3) If the Local Government sees reason to believe that the petroleum will be used for that purpose, and that no petroleum other than danger-

ous petroleum can be used for the purpose, ic may grant the license for the importation, transport or possession (as the case may be) of the petroleum, absolutely or subject to such conditions as it thinks fit.

Provided that nothing in this section shall apply in any case when the quantity of the petroleum kept by any one person or on the same premises, or transported, does not exceed three gallons, and the petroleum is placed in separate glass, stone-ware or metal vessels, each of which contains not more than a pint and is securely stopped.

21. (1) The Chemical Examiner shall, on pay-Verification of test-appa-tus, in Council may, from time to time, by notification in the Gazette of India, prescribe, compare with the said model test-apparatus and verify every apparatus for testing petroleum which is submitted to him for

the purpose.
(2) If any apparatus for testing petroleum, when compared and verified as provided by subsection (1), is found correct, or correct subject to certain corrections to be applied to the results of the tests, the Chemical Examiner shall stamp the same with a special number, and with the date of the verification, and shall further give a certificate in writing under his hand, in a form to be prescribed by the Governor General in Council, to the effect that on the date aforesaid the apparatus was compared and verified by him and found to be correct, or correct subject to certain specified corrections to be applied to the results of the tests.

(3) A certificate granted under this section shall, until the contrary is proved, be conclusive proof of the matters stated therein.

(4) The Chemical Examiner shall keep a register, in a form to be prescribed by the Governor General in Council, of the certificates granted under this section.

(5) Subject to the payment of such fees as the Governor General in Council may, by notification in the Gazette of India, prescribed in this behalf, the said model test-apparatus shall be at all reasonable times open to inspection by any person desiring to inspect it.

## THE SCHEDULE.

" I .- Nature of the Test-apparatus.

The apparatus consists of the following parts:

(1) the oil-cup;

- (2) the cover, with slide, test-lamp, and clockwork arrangement for opening and closing the holes in the cover and for dipping the test-flame;
- the water-bath or heating vessel;
- (4) the tripod stand, with jacket and spirit lamp for heating the water-bath;
  (5) the thermometer for indicating the tem-
- perature of the oil in the oil-cup;
  (6) the thermometer for indicating the temperature of the water in the water-

- (7) the thermometer for indicating the temperature of the oil before it is poured into the oil-cup; the dropping bottle, or pipette for replenishing the test-lamp; and a barometer standardised at the Meteoro-
- logical Office of the province or at any other place appointed by the Local Government.

The oil-cup is a cylindrical flat-bottomed vessel, made of gun-metal or brass, and tinned or silvered inside. A gauge is fixed to the inside of the cup to regulate the height to which it is to be filled with the sample under examination.

The cup is provided with a close fitting over-lapping cover which carries the thermometer, the test-lamp, and the adjuncts thereto. The test-lamp is suspended upon two supports by means of trunnions, which allow it to be easily inclined to a particular angle and restored to its original position. The socket in the cover, which is to hold a round bulb thermometer for indicating the temperature of the oil during the testing operation, is so adjusted that the bulb of the latter is always inserted in a definite position below the surface of the liquid.

The cover is provided with three holes, one in the centre and two smaller ones close to the in the centre and two smaller ones close to the sides. These are closed and opened by means of a pivoted slide. When the slide is moved so as to uncover the holes, the suspended lamp is caught by a projection fixed on the slide, and tilted in such a way as to bring the end of the spout just below the surface of the lid. As the slide moves back so as to cover the holes, the lamp returns to its original position. Upon the lamp returns to its original position. Upon the cover, in front of and in a line with the nozzle of the lamp, is fixed a white bead, the diameter of which represents the size of the test-flame to be used.

The water-bath or heating vessel is so constructed that, when the oil-cup is placed in position in it, an air-space or air-chamber intervenes between the two; consequently, in applying the test under ordinary circumstances, the heat is transmitted gradually to the oil from the hot water through the air-space. The water-bath is fitted with a socket for receiving a long bulb thermometer, to indicate the temperature of the water. It is also provided with a funnel, an overflow-pipe and two

The water-bath rests upon a triped stand, which is fitted with a copper cylinder or jacket, so that the bath is surrounded by an euclosed airspace, which retains and regulates the heat. of the legs of the stand serves as a support for a spirit-lamp, which is attached to it by a small swing bracket.

The clockwork arrangement, by which during the operation of testing the slide is withdrawn, and the test-flame dipped into the cup and raised again as the slide is replaced, is provided with a ratchet key for setting it in action for each test, and with a trigger for starting it each time that the test-flame is applied.

(The Schedule.)

11.—Directions for drawing the Sample and preparing it for Testing.

Drawing the sample. - In all cases the testing officer or some person duly authorised by him shall personally superintend the drawing of the sample from an original unopened tin or other vessel.

An opening sufficiently large to admit of the oil being rapidly poured or syphoned from the tin or other vessel shall be made.

Two bottles, each of the capacity of about 40 fluid ounces, are to be filled with the oil. One of these, the contents of which is intended to be preserved for reference in case of need, is to be carefully corked, the cork being well driven home, cut off level with the neck, and melted sealing-wax worked into it. The other bottle may be either stoppered or corked.

2. Preparing the sample for testing.—About ten fluid ounces of the oil, sufficient for three tests, aré transferred from the bottle into which the sample has been drawn to a pint flask or bottle, which is to be immersed in water artificially cooled until a thermometer, introduced into the oil, indicates a temperature not exceeding 50° Fahrenheit.

# III.—Directions for preparing and using the Test-apparatus.

- Preparing the water-bath. bath is filled by pouring water into the funnel until it begins to flow out at the overflow-pipe. The temperature of the water at the commencement of each test, as indicated by the long bulb thermometer, is to be 130° Fahrenheit, and this is attained in the first instance by mixing hot and cold water, either in the bath or in a vessel from which the bath is filled, until the thermometer, which is provided for testing the temperature of the water, gives the proper indication; or the water is heated by means of the spirit-lamp (which is attached to the stand of the apparatus) until the required temperature is indicated.
- 2. Preparing the test-lamp.—The test-lamp is fitted with a piece of cylindrical wick of such thickness that it fills the wick-holder, but may readily be moved to and fro for the purpose of adjusting the size of the flame. In the body of the lamp, upon the wick, which is coiled within it, is placed a small tuft of cotton wool, moistened with petroleum, any oil not absorbed by the wool being removed. When the lamp has been lighted, the wick is adjusted by means of a pair of forceps until the flame is of the size of the bead fixed on the cover of the oil-cup; should a particular test occupy so long a time that the flame begins to get smaller, through the supply of oil in the lamp becoming exhausted, three or four drops of petroleum are allowed to fall upon the tuft of wool in the lamp from the dropping bottle or pipette provided for that purpose. This can be safely done without interrupting the test.
- 3. Filling the oil-cup.—The oil-cup having been previously cooled, by placing it bottom downwards in water at a temperature not exceeding 50° Fahrenheit, is to be rapidly wiped dry, placed on

a level surface in a good light, and the oil to be tested is poured in very slowly, without splashing, until its surface is level with the point of the gauge which is fixed in the cup. The round bulb thermometer is inserted into the lid of the cup, care being taken that the projecting rim of the collar touches the edge of the socket; the test-lamp, prepared as already described, is placed in position, and the cover is then put on to the cup and pressed down so that its edge rests on the rim of the cup.

4. Application of the test.—The water-bath, with its thermometer in position, is placed in some locality where it is not exposed to currents of air, and where the light is sufficiently subdued to admit of the size of the entire test-flame being compared with that of the bead on the cover. The cup is carefully lifted without shaking it, and placed in the bath, the test-lamp is lighted, and the clockwork wound up by turning the key. The thermometer in the oil-cup is now watched, and when the temperature has reached 56° Fahrenheit the clockwork is set in motion by pressing the trigger.

If no flash takes place the clockwork is at once re-wound, and the trigger pressed at 57° Februheit, and so on, at every degree rise of temperature, until the flash occurs, or until a temperature of 95° Fabrenheit has been reached.

If the flash takes place at any temperature below 77° Fahrenheit the temperature at which it occurs is to be recorded. The fresh portions of the sample are then to be successively tested in a similar manner and the results recorded. If no greater difference than 2° Fahrenheit exists between any two of the three recorded results, each result is to be corrected for atmospheric pressure, as hereafter described, and the average of the three corrected results is the flashing point of the sample. In the event of there being a greater difference than 2° Fahrenheit between any two and the results, the series of tests is to be rejected and a fresh series, of three, similarly obtained, and so on until a sufficiently concordant series is furnished, when the results are to be corrected and the average taken in the manner already described.

No flash which takes place within eight degrees of the temperature at which the testing is commenced shall be accepted as the true flashing point of the sample tested. In the event of a flash occurring at or below 64° when the test is applied in the manner above described, the next testing shall be commenced ten degrees lower than the temperature at which the flash had been previously obtained (that is to say, at 54°, or thereunder), and this procedure shall be con-tinued until the results of three consecutive tests do not show a greater difference than 2°.

If a temperature of 76° Fahrenheit has been reached without a flash occurring, the application of the test-flame is to be continued at every degree rise of temperature until a temperature of 95° Fahrenheit has been reached. If no flash has occurred up to this point, and if the petroleum is

declared to be imported subject to the provisions of the Act, the tests shall not be continued, and the testing officer shall certify that the petroleum has a flashing point over 95° and is not dangerous. But if the petroleum is oil oadinarily used for lubricating purposes and is declared to have its flashing point at or above 200° degrees, or is oil to which a notification of the Local Government exempting it from the operation of the Act will be applicable in the event of the flashing point being found to be at or above 120°, the test shall be continued as follows:—The oil-cup is to be removed from the water-bath, and the temperature of the water in the water-bath is to be reduced to 95° Fahrenheit by pouring cold water into the funnel (the hot water escaping by the overflow-pipe). The air-chamber is then to be filled to a depth of 1½ inches with water at a temperature of about 95° Fahrenheit, the oil-cup is to be replaced in the water-bath and the spirit-lamp attached to the water-bath is to be lighted and placed underneath. The test-flame is then to be again applied, from 96° Fahrenheit, at every degree rise of temperature as indicated by the thermometer in the oil-cup until a flash takes place or until a temperature of 200° Fahrenheit or 120° Fahrenheit, as the case may be, has been reached. If during this operation the test-flame appears to diminish in size, the lamp is to be replenished in the manner prescribed at (2) without interrupting the test.

If a flash occurs at any temperature between 76° and 200° Fahrenheit, the temperature at which it occurs, subject to correction for atmospheric pressure, is the flashing point of the sample.

In repeating a test a fresh sample of oil must always be used, the tested sample being thrown away, and the cup must be wiped dry from any adhering oil and cooled, as already described, before receiving the fresh sample.

5. Correction for atmospheric pressure.—As the flashing point of an oil is influenced by changes in atmospheric pressure to an average extent of 1.6° Fahrenheit for every inch of the barometer, a correction of the observed flashing point may become necessary. The height of the barometer must therefore be determined at the time of making the test for the flashing point. The true height of the barometer for the purpose of the test shall be considered to be the height of the column of mercury measured at 32° Fahrenheit, which is supported by the air pressure at the time of the experiment; that is, the actual height of the barometer at the time of observation duly corrected for any error of the instrument and for its temperature if necessary. For the purpose of applying the correction to the flashing point of the oil obtained by the test, a table is appended to this schedule, giving the flashing points of its ranging from 65° to 80° Fahrenheit, under pressure ranging from 27 to 31 inches of mercury.

The table is used in the following manner:—
Example.—An oil has given a flashing point of 71°, the barometer being at 28.6 inches; take the nearest number to 71° in the vertical column headed 28.6. This number is 70.8. Substitute for this the number in the same horizontal line in the column headed 30 (the normal height of the

Act, 1881, was referred, have considered the Bill and the papers noted in the margin, and have now the honour to submit this our Report.

2. On the general question of standards and the definition of petroleum, dangerous we adhere to the scheme laid down in section 3 of the Bill. But Dr. Warden and Mr. Pedler suggest that the lowest standard for lubricating oils (the attainment of which would exempt them from the operation of the Act) should be fixed at 200° instead of

250° as in the present Act. It is, they explain, practically impossible with the Abel apparatus to test up to 250°. They consider the limit of 150°, which is proposed in some of the papers, too low for this country, and believe 200° would meet all reasonable requirements. In this view we concur. We are also of opinion that Local Governments should be empowered to exempt from the operation of the Act and rules oil certified to be over 120° when imported as ordinary cargo and in limited quantities.

3. We consider that section 4 of the Bill should be omitted. Messrs. Warden and Pedler point

out that the drawback of the fragility of glass for carriage is frequently more than counterbalanced by its impermeability. It is very difficult in this country to get tin or metal vessels made which shall be thoroughly impervious to highly volatile oil.

4. It is suggested by the Bombay Government and other authorities that it should be made clear that conveyance by sea from one part of British India to another is "transport" and not "import" within the meaning of the Act. We are of opinion that some discretion in the matter should be left to the Local Governments. It would be unsafe, for instance, at present to admit freely to Calcutta oil brought up from Burma. Experience has shown that in Burma refining is not yet thoroughly understood, and the local testing is not at present very trustworthy. The Local Governments in India should have nower to treat such oil as foreign oil until its quality generally improves. On the other hand, there is power to treat such oil as foreign oil until its quality generally improves. On the other hand, there is no reason why foreign oil once properly tested should be re-tested on arrival at a second port. We have taken power for the Local Governments of territories, such as Burma and Assam, in which oil is or is likely to be produced, to appoint testing officers at or near refineries, and to prevent the removal from the refineries of oil which does not satisfy the tests otherwise than under the regulations for the control of dangerous petroleum.

5. Turning now to the question of the method of sampling cargoes, we concur with the Bombay Government and other authorities in thinking that it should be open to the Local Government by rule to provide for sampling either before or after landing; to prescribe the number of samples to be taken from a cargo or consignment or any part thereof; to provide, when the first test is unsatisfactory, or when doubt is felt as to the uniformity of quality in the cargo, for the landing and sorting of the cargo in lots, or its delivery into boats, each of a certain capacity; and for the sampling of each lot or boat-load, and its ultimate treatment in accordance with the results of the test in each case.

When a doubtful cargo has to be landed and stacked, substantial fees should be levied, as much

additional work is thrown upon Government officers.

6. With reference to the objections taken by some Bombay officers to the provisions of the schedule requiring that the sample tin should be tapped in presence of the testing officer, we observe that Messrs. Warden and Pedler both attach importance to this, as all manipulation and airing of the oil tends to raise its flashing point, and the drawing of oil for testing purposes should in any case be under the control of a responsible officer of the testing department. They consider that in most cases the selection of one case from a cargo of oil certified before arrival to be ordinary petroleum is sufficient, if care is taken to get the samples from below, and thus to defeat any attempt at "facing" the cargo. The number of samples taken at Bombay appears to be unduly large, and has given rise to the objection that to convey them to the Chemical Examiner's laboratory would be an arduous task. We have so amended the Schedule, Part II, paragraph 1, as to provide that the testing officer or some person duly authorized by him shall superintend the drawing of the sample.

7. In revising the Bill we have had regard to the practice which obtains in Bombay of allowing

delivery into cargo-boats pending the result of testing, and to the suggestion of the Bengal Govern ment that the Local Government should have the power in special cases to order further tests in such

manner as it may deem expedient.

8. As regards the suggestion of the Bombay Government that a second standard apparatus should be maintained at Bombay, it appears to us to be highly important to secure uniformity in the tests throughout India. To this end there should be but one absolute and ultimate standard, and this can most conveniently be maintained in Calcutta.

9. We are of opinion that the Chemical Examiner should stamp any apparatus sent to him not only with a special number but also with the date of his verification of the apparatus, and further that he should give a certificate in writing under his hand, in a form to be laid down by the Governor General in Council, to the effect that the apparatus has been compared and verified by him on a given date and been found to be correct, or correct subject to certain specified corrections to be applied to the results of tests.

10. The Chemical Examiner should also keep a register of verifications.

11. Messrs. Warden and Pedler suggest that in the Schedule, Part I, provision be made for "a barometer standardised at the Meteorological Office of the province, or at any other place appointed by the Local Government." We have accepted the suggestion.

12. With respect to the changes in the Schedule, Part III, proposed by Dr. Lyon, Messrs. Warden and Pedler are inclined to hold that Sir F. Abel has in a paper before us sufficiently met Dr. Lyon's difficulty, and they believe that in practice no difficulty is likely to arise of the kind Dr. Lyon puts forward. They have, however, suggested, and we have acted on the suggestion, that all possible objection would be removed if it were provided that no flashing point obtained should be accepted unless it be at least 8° above the temperature at which the testing commenced.

13. Messrs. Warden and Pedler are of opinion that it is unnecessary in the case of ordinary petroleum to continue the tests when no flash has been obtained up to 95° Fahrenheit. It is only in the case of petroleum for which exemption from the Act is claimed that the test need be continued in the manner laid down in the fourth paragraph of the rules for "application of the test." We have modified that paragraph accordingly.

that paragraph accordingly.

14. In the Schedule, Part III, paragraph 5, we have pointed out that the height of the barometer must be determined at the time of making the test for the flashing point.

15. We are advised not to accept the suggestion made from Burma to adopt Hewmann's

apparatus in preference to Abel's.

16. We have had regard to the remarks of the Bombay Government with reference to the repeal of the municipal laws affecting petroleum, and to giving power to Port Trusts to regulate their own fees

for the storage of petroleum.

17. Having thus amended the Bill we have deemed it advisable to consolidate it and the Petroleum Act of 1881, and, in doing so, have taken the opportunity (a) to enhance the penalty for keeping, transporting, selling or exposing for sale dangerous petroleum in contravention of the Act, and (b) to empower the Governor General in Council to make rules as to the transport of petroleum from any part of Pritish India to any other part

of British India to any other part.

18. The other alterations we have made in consolidating the Bill and the Act are few and unim-

portant and do not call for notice

WHEREAS it is expedient to consolidate and amend the law relating to Government securities; It is hereby enacted as follows:-

1. (1) This Act may be called the Indian Securities Act, 1886; and Short title and com-mencement,

- (2) It shall come into force on the first day of April, 1886.
- (3) The power conferred on the Governor General in Council by section 7, sub-section (1), may be exercised at any time after the passing of this Act; but a notification issued in exercise of that power shall not take effect until the Act comes into force.

- (4) A writing on a Government security now or heretofore standing in the name of the holder of a public office, whereby the security has been or was made or indorsed payable to or to the order of the holder of the office for the time being, shall not be deemed to be or to have been invalid by reason only of the payee or indorsee being the holder for the time being of a public office by the name of the office.
- (5) This section applies as well to an office of which there are two or more joint holders as to an office of which there is a single holder.

The following Act of the Governor-General of India in Council received the assent of His Excellency the Governor-General on the 24th September 1886, and is hereby promulgated for general information:—

## Act No. XVIII of 1886.

An Act to amend Act XXXVI of 1858.

WHEREAS it is expedient to amend Act XXXVI. of 1858 (an Act relating to Lunatic Asylums); It is hereby enacted as follows:—

New section inserted after section 6.

1. After section 6 the following shall be inserted, namely:—

Detention of supposed lunatics under observation.

Delieved to be dangerous by reason of lunatic, or where a person believed to be dangerous by reason of lunacy, is apprehended and sent to the Magistrate or the Commissioner of Police, or where, on report or information that a person deemed to be a lunatic is not under proper care and control or is cruelly treated or neglected, the Magistrate or the Commissioner of Police sends for him and then determines to proceed as prescribed in section 4 of this Act, the Magistrate or the Commissioner of Police, on the request of the medical officer,

may, by order in writing, authorise the detention of the supposed lunatic for such time, not exceeding ten days, as, in the epinion of the Magistrate or the Commissioner of Police, may be necessary to enable the medical officer to form an opinion on the question whether or not the supposed lunatic is a person with respect to whom a certificate in the form A in the schedule to this Act ought to be signed.

- "(2) If the Medical officer certifies further detention than has been authorised under subsection (I) to be necessary to enable him to form his opinion on that question, the Magistrate or the Commissioner of Police may from time to time, by order in writing, authorise such further detention as he deems to be necessary:
- "Provided that a supposed lunatic shall not be detained for the purpose of this section for a longer time than fourteen days from the date on which the first order authorising his detention for that purpose is made.
- "(3) The Executive Government may from time to time make rules as to the place of detention, and the care and treatment, of supposed lunatics detained under this section."

2. The Bill as introduced was approved by the authorities to whom it was referred, but further amendments of the Act were proposed by the Governments of Bengal and the Puniab.

- 3. The former Government drew attention to the absence of any provision authorising the detention of supposed lunatics for observation, and the latter to the inconvenience ensuing from the provision which requires lunatics who are not natives of the country to be sent in all cases to an asylum at the presidency.
- 4. It appeared to us that express provision ought to be made for the detention of supposed lunatics. As a matter of practice they are detained, for in many cases the medical officer is not in a position to form an opinion on the question whether or not a person is a lunatic until he has had the person under observation for some days. The detention is probably legal where it is authorised by the Magistrate (I. L. R. 9 Cal. 341), but it is desirable that there should be no room for doubt as to the legality of a practice which is in fact absolutely necessary. We considered it desirable, however, before submitting our Report, to consult Local Governments, and we therefore circulated a draft clause proposing, in accordance with the advice of the Surgeon-General, a period of ten days as the maximum term of detention for purposes of observation. We have now, after considering the replies to our circular, proposed to extend the term to fourteen days, and to authorise Local Governments to make rules as to the place of detention, and the care and treatment, of supposed lunatics.
- 5. The proposal of the Punjab Government with respect to the establishment of asylums at other places than the presidency-towns for lunatics who are not natives of the country was referred by us to other Local Governments, and has been approved by them. We have provided, therefore, that the Governor-General in Council may, with respect to any part of British India which is not annexed to a presidency, or is more than three hundred miles from a presidency-town, direct that any lunatic asylum named in the order shall be deemed for that part to be a lunatic asylum at the presidency for the purposes of the Act purposes of the Act.
- 6. Section 9 of the Act empowers the visitors of a lunatic asylum to order the discharge of any person detained in the asylum. As the Code of Criminal Procedure, 1882, and the Prisoners Act, 1871, reserve that power in certain cases to other authorities, we have proposed to prefix to that section an express saving of the provisions of other enactments.

An Act to remove certain doubts in the construction of Section 9B of the Bombay Municipal Acts of 1872 and 1878.

## [First publication.]

WHEREAS doubts are entertained as to the power of Government, in rules framed by it under Section 9B of the Bombay

(a) that it divides the city of Bombay into wards and distributes the thirtytwo members of the said Corporation to be elected at a ratepayers' election amongst the said wards and requires that the number of the said members so allotted to each such ward shall be returned for the prescribed ward only;

- (b) that it contemplates the entry by the Municipal Commissioner of the names of persons qualified to vote at ratepayers' elections in the list to be pre-pared by him under Section 9D of the said Acts in one or more wards; or
- (c) that it prescribes the ward in which each person qualified to vote at rate-payers' elections shall exercise that right and restricts such person's right to voting at elections of members for the one ward so prescribed and for one candidate only at each such election.

An Act to amend the Bombay General Clauses Act, 1866, and to shorten the language of the enactments of the Governor of Bombay in Council.

(The assent of the Governor-General of India to this Act was first published by the Governor of Bombay on the 25th September 1886.)

Bo. X. of 1866. Whereas it is expedient to amend the Bombay General Clauses Act, 1866, and to make other provisions for shortening the language of the enactments of the Governor of Bombay in Council, and for explaining their meaning; It is enacted as follows:—

- 1. This Act may be cited as "The Short Title. Bombay General Clauses Act, 1886."

The following Act of the Governor of Bombay in Council received the assent of His Excellency the Governor on the 27th August 1886, and the assent of His Excellency the Viceroy and Governor General on the 20th October 1886, and is published for general information:—

#### Bombay Act No. IV. of 1886.

An Act to amend the Bombay Land Revenue Code, 1879.

(The assent of the Governor General of India to this Act was first published by the Governor of Bombay on the 10th November 1886.)

Whereas, for the purpose of assuring to holders of unalienated land the full advantage of all improvements in their holdings effected by them or at their cost, it is expedient to define more clearly the conditions affecting the revision of land-revenue assessments and, with this object, to amend the Bombay Land Revenue Code, 1879: It is enacted as follows:

1. For the latter portion of section one hundred and six of the said Code, beginning with and inclusive of the words "A revised assess
1v.—24

ment" the following words shall be substituted (namely):

- "Provided that when a general classification of the soil of any area has been made a second time, or when any original classification of any area has been approved by the Governor in Council as final, no such classification shall be again made with a view to the revision of the assessment of such area."
- 2. For section one hundred and seven of the said Code the following section shall be substituted (namely):

"107. In revising assessments of land-revenue to revisions of assessment. regard shall be had to the value of land and, in the case of land used for the purposes of agriculture, to the

profits of agriculture:
"Provided that if any improvement has been effected in any land during

the currency of any previous settlement made under this Act, or under Bombay Act I. of 1865, by or at the cost of the holder thereof, the increase in the value of such land or in the profit of cultivating the same, due to the said improvement, shall not be taken into account in fixing the revised assessyment thereof."

#### Bombay Act No. V. of 1886.

An Act to amend Bombay Act III. of 1874.

(The assent of the Governor General of India to this Act was first published by the Governor of Bombay on the 28th January 1887.)

- WHEREAS it is expedient to amend the Bom. III. of Bombay Hereditary Offices Act, 1874, in manner hereinafter appearing; It is enacted as follows:
  - 1. For section 5 of the said Act the following section shall be substituted (namely):—

### Bombay Act No. VI of 1886.

An Act to vest the Port of Karáchi in a Trust.

WHEREAS it is expedient to vest the port of Karáchi in a trust and to provide for the management of the affairs of the said port by trustees; It is enacted as follows:—

#### I.—PRELIMINARY.

Short title.

1. This Act may be called "The Karáchi Port Trust Act, 1886."

- 2. In this Act, unless there be something repugnant in the subject or context,
  - (1) "port" means the port of Kará-"port"; chi as defined for the purposes of this Act;
- (2) "high-water mark" means a line drawn through the "high-water mark"; highest points reached by ordinary spring-tides at any season of the year;
- (3) "low-water mark" means a line drawn through the low-water mark"; lowest points reached by ordinary spring-tides at any season of the year;
- (4) "land" includes the bed of the sea below highwater mark, and also things attached to the earth or permanently fastened to anything attached to the earth;
- (5) "master," when used in relation to any vessel, means any person having for the time being the charge or control of such vessel;
- (6) the word "goods" includes

  "goods"; wares and merchandise of every
  description;
- (7) "owner," when used in relation
  to goods, includes
  any consignor, consignee, shipper or agent for the sale or
  custody of such goods; and when used
  in relation to any vessel, includes any
  part-owner, charterer, consignee, or mortgagee in possession thereof.

- 3. Government may, with the approval of the Governor General in Council, by notification in the Bombay Government Gazette:
  - (a) 'define the limits of the port for the purpose of this Act, and
  - (b) from time to time alter such limits.

Such limits may extend to any part of the navigable approaches to the port, and may include any wharves, tramways, warehouses, sheds and other works made on behalf of the public for convenience of traffic, for safety of vessels, or for the improvement, maintenance, and good government of the port, whether within or without high-water mark, and, subject to any rights of private property therein, any portion of the shore within fifty yards of high-water mark.

# II.—Of the Board of Trustees. Constitution of Board.

- 4. The duty of carrying out the provisions of this Act shall, subject to such conditions and limitations as are hereinafter contained, be vested in a board to be called "The Trustees of the Port of Karáchi"; and such board, hereinafter referred to as "the board," shall be a body corporate and have perpetual succession and a common seal, and shall sue and be sued by the name first aforesaid.
- 5. The board shall consist of nine members of whom not less than two shall be natives of India residing in Karachi.
- Appointment of chairman and vice-chairman of the board and may, if they think fit, from time to time appoint a person to be vice-chairman of the board. Any person so appointed may be a public officer or not.

The chairman and, if any be appointed, the vice-chairman of the board, shall be trustees.

Nomination of other trustees.

Nomination of other trustees.

North-Western Railway as the said Manager shall from time to time appoint to act for him in this behalf, two shall be elected by the members for the

time being of the Karáchi Chamber of Commerce, and two shall be elected by the municipal commissioners of Karáchi from among their own number.

The remaining trustees shall be appointed by Government.

Any trustee elected or appointed under this section may be a public officer or not.

8. The election of trustees by the Karáchi Chamber of Commerce and by the municipal commissioners shall be conducted in such manner as shall from time to time be determined at a meeting of the members of the said chamber or of the said commissioners as the case may be, convened in accordance with the rules at the time in force in this behalf. The secretary to the said chamber and the President of the Municipality of Karáchi shall, respectively, make a return to the Commissioner of the name of every person so elected.

In the event of default being made by

Nomination by Government in default of

the chamber or by the municipal commissioners in electing any trustee under the

foregoing provisions within the period hereinafter prescribed in this behalf, it shall be lawful for Government to appoint a person, and the person so appointed shall be deemed to be a trustee as if he had been duly elected by the chamber, or municipal commissioners, as the case may be.

9. The name of every person appointed by Government to be Chairman or vice-chairman of the board, and the names of all trustees duly elected or appointed to the board shall be published in the Bombay Government Gazette and in the Sind Official Gazette.

Term of office of first trustees when to commence.

Term of office of first trustees shall commence on such date as shall be notified in this behalf by Government.

11. One of the first trustees elected by

Trustees to retire from office by rotation.

Trustees to retire of the chamber and one of the first trustees, other than the chairman, appointed by Government shall, unless they become in the meantime disqualified, hold office up to and inclusive of the thirty-first day of March next succeeding the date on which their term of office shall commence, the selection of the

said trustees being made by lot at such time and in such manner as the chairman of the board shall determine.

The rest of the first trustees, other than the chairman, shall, unless they become in the meantime disqualified, hold office until and inclusive of the thirty-first day of March next following the thirty-first day of March aforesaid.

In every other case every trustee, other than the chairman, shall, unless he becomes in the meantime disqualified, hold office for a term of two years.

The chairman shall hold office for a renewable period of five years, unless he becomes in the meantime disqualified for being a trustee, or is removed by Government.

Time for holding elections and appointments. The first election of trustees by the chamber and by the municipal commissioners shall be held on some day not

later than a month previous to the date which shall be notified by Government under section 10, and the first appointment of trustees by Government shall be made on some day during the said month.

Elections of trustees by the chamber and by the municipal commissioners to succeed trustees whose term of office expires shall be held on some day not earlier than the fifteenth and not later than the last day of the month of February next preceding the first day of April from which the term of office of the new trustees is to commence; and appointments of such trustees by Government shall be made on some day in the month of March next preceding the said first day of April.

Filling up of casual vacancies.

Table 1 a trustee or of his becoming incapable of acting previous to the expiry of his term of office, the vacancy shall be filled up, as soon as it conveniently may be, by the election or appointment, as the case may be, of a person thereto, who shall hold office so long only as the trustee in whose place he is elected or appointed would have been entitled to hold it if the vacancy had not occurred.

If a trustee departs from Karáchi with an Acting trustees. intention of being absent for a longer period than three months, or if a trustee shall have been absent from Karáchi for such period, a person shall be elected or

appointed as aforesaid to act for such trustee during his absence, or until he shall cease to be a trustee; and the person so acting shall be deemed for all the purposes of this Act to be a trustee.

Re-eligibility of trustees.

Re-eligibility of trustees.

trustee on one or more occasions shall, if not disqualified under section 15, be again eligible at any time for election or appointment.

#### Disqualifications of Trustees.

Disqualifications for office of trustee.

15. No person shall be qualified to be a trustee:

- (a) who, under any law for the time being in force, is an uncertificated bankrupt or an undischarged insolvent, or
- (b) who holds any office or place of profit under the board, or
- (c) who has, directly or indirectly, any share or interest in any work done by order of the board, or in any contract or employment with, by, or on behalf of the board; or
- (d) who has been sentenced by a criminal court to imprisonment or to whipping for an offence punishable with imprisonment for a term exceeding six months, or to transportation, such sentence not having been subsequently reversed or quashed, and whose disqualification on account of such sentence has not been removed by an order, which Government is hereby empowered to make, if it shall think fit, in this behalf; and any trustee who—

Trustee who becomes disqualified to cease to be a trustee.

(e) becomes disqualified for any of the aforesaid reasons, or

(f) is absent from the meetings of the board for a period exceeding twelve consecutive months, or, without the permission of the board, from six consecutive meetings of the board,

shall cease to be a trustee, and his office shall thereupon become vacant:

Provided always that no trustee shall vacate his office by reason only of his—

- (g) having a share in any joint-stock company which shall contract with or be employed by, or on behalf of, the board, or
- (h) having a share or interest in any newspaper in which any advertisement

relating to the affairs of the board may be inserted, or

(i) being interested in any loan of money to the board.

#### Remuneration of Trustees.

16. The chairman and the vice-chair

rupees as shall from time to time be prescribed by Government for each meeting of the board at which a quorum is present and business is transacted and which he attends from the beginning to the end thereof: provided that if more than one such meeting is held in any one week, no more than one fee shall be paid to any trustee for his attendance at all or any such meetings during that one week.

#### Proceedings of Board.

(4) A committee may elect a chairman of their meetings, Committees' meetand, if no such chairings to be presided man is elected, or, if he over by a chairman. is not present at the time appointed for holding the same, the members present shall choose one of their number to be chairman of such meeting.

board may, whenever he thinks fit, and shall, upon the written request of not less than two members of a committee, call a special meeting of such committee.

- (6) Questions at any meeting of a committee shall be Questions how to be decided by a madecided at committee's jority of votes of meetings. the members present, and, in case of an equal division of votes, the chairman of the meeting shall have a second or casting vote, but no business shall be transacted at any such meeting unless at least two-. thirds of the members of the committee are present from the beginning to the end thereof.
- (7) No act of the board, or of any committee, or Acts of board, &c., any person acting not to be invalidated by informalities. as trustee, shall be deemed to be invalid by reason only of some defect in the appointment of such board, committee, or trustee, or on the ground that they, or any of them, were disqualified for the office of trustee.

18. The chairman may, on behalf of the board, enter into Mode of executing any contract or agreecontracts. ment, whereof value or amount shall not exceed one thousand rupees, in such manner and form as, according to the law for the time being in force, would bind him if such contract or agreement were on his own behalf; but every other contract and agreement on behalf of the board shall be in writing, and shall be signed by the chairman and by two other trustees, and shall be sealed with the common seal of the board.

No contract or agreement not executed as aforesaid shall be binding on the board:

Provided that the signatures of the chairman and two other trustees may be engraved, lithographed or impressed by any mechanical process on coupons attached to debentures which the board is at any time authorized to issue under the Local Authorities Loan Act, 1879, or other law XI of 1879. for the time being in force, and the signatures so engraved, lithographed or impressed shall have the same validity as if they were written in the proper handwriting of the chairman and other trustees.

19. The board may compound or com-

The board may compound for claims against them.

promise for or in respect of any claim or demand made against them, for such sum

of money, or other compensation, as they shall deem sufficient.

The Chairman and Vice-chairman.

Duties of chairman, 20. The chairman shall—

- (1) attend every meeting of the board, unless prevented by sickness or other reasonable cause;
- (2) exercise supervision and control over the acts and proceedings of all officers and servants of the board in matters of executive administration and in matters concerning the accounts and records of the board; and, subject to the regulations at the time being in force framed by the board under section 22, dispose of all questions relating to the service of the said officers and servants, and their pay, privileges, and allowances;
- (3) furnish to Government a copy of the minutes of any of the board's proceedings and any returns or other information which Government may from time to time call for.

The vice-chairman shall exercise such of vice-chairman. of the powers and perform such of the duties of the chairman as the chairman from time to time deputes to him.

# III.—OF THE OFFICERS AND SERVANTS OF THE BOARD.

#### Strength of Staff.

21. The board shall from time to time

Schedule of officers and servants and of their payandallowances to be prepared and sanctioned by the board. prepare and sanction a schedule of the staff of officers and servants whom they shall deem it necessary and proper to maintain for the

purposes of this Act. Such schedule shall also set forth the amount and nature of the salaries, fees, and allowances which the board sanctions for each such officer or servant.

Until a schedule is prepared and sanctioned under this section, the staff of officers and servants maintained, on the day previous to the date notified by the Governor in Council under section 10, under the authority of Government, by the Karáchi Harbour Board and the officers and servants, if any, maintained on the

said day by Government at the cost of the provincial revenues for employment in the Karáchi harbour shall be deemed to be the staff sanctioned by the board under the foregoing provisions;

and all officers and servants holding any office on the said day under the said Karáchi Harbour Board and the officers and servants aforesaid, if any, so maintained by Government on the said day shall be deemed to have been appointed under this Act, and shall continue to hold the same offices, respectively, and to receive the same remuneration under the board, until it is otherwise directed under this Act:

Provisoes. Provided:

- (1) that artisans, porters, and labourers and mukádams of porters and labourers, and persons temporarily employed in the engineering department shall not be deemed to be officers or servants within the meaning of this section or of section 22, clauses (1) to (4), both inclusive, or of section 23;
- (2) that if an officer is lent to the board by Government, the board shall make such contributions, if any, on account of his pension and leave allowances as may be required by the rules in this behalf from time to time in force and shall not, except with the consent of Government, dispense with his further services at any time without giving the Government six months' previous notice;
- (3) that every officer and servant, if any, maintained by Government on the day aforesaid at the cost of the provincial revenues for employment in the Karáchi harbour shall, if he is entitled as a Government servant to pension and leave allowances, be deemed to be lent to the board on and from the date notified by the Governor in Council under section 10.

Board to frame regulations.

22. The board shall from time to time frame regulations:

- (1) for regulating the grant of leave to the officers and servants of the board;
- (2) for authorizing the payment of allowances; is aid officers and servants, or to certain of them, whilst absent on leave;

- (3) for determining the remuneration for fixing acting allowances; to be paid to the persons appointed to act for any such officers or servants during their absence on leave;
- (4) for regulating the period of service of all such officers and servants;
- (5) for determining whether any of the said officers and for fixing pensions, &c.; servants and, if so, which of them, shall on retirement receive pensions, gratuities or compassionate allowances, and whether compassionate allowances shall be paid to the surviving relatives of any of the said officers and servants who are killed in the execution of their duty, and, if so, to which of them, and the conditions under which such pensions, gratuities or compassionate allowances shall be payable and the amount of the same;
- for authorizing the payment of contributions to provident fund.

  tributions to provident fund.

  tributions at certain prescribed rates and subject to certain prescribed conditions to any provident fund which may be established by the board for the benefit of their officers and servants or which, with their approval, may be established by their officers and servants themselves:

Provided that no regulation framed by the board under clause (5) shall have validity, unless or until the same has been sanctioned by Government.

Powers of Appointment, &c.

23. Subject to the provisions of the said regulations and Appointments, &c., of the schedule for by whom to be made. the time being inforce framed by the board under section 21, the power of appointing, promoting, suspending, dismissing for misconduct, fining, reducing or granting leave to the officers and servants of the board shall be exercised by the chairman in the case of officers and servants whose monthly salary does not exceed one hundred rupees, and in every other case by the board.

An appointment so made by the board shall not be held to be a contract or agreement within the meaning of Section 18.

The power of dispensing with the services of any officer or servant of the board, otherwise than by reason of such officer's or servant's own misconduct, or of permitting any such officer or servant to retire on a pension, gratuity, or compassionate allowance, shall, subject to the aforesaid provisions, be exercised by the board alone.

Every order of the chairman dismissing for misconduct an officer or servant whose monthly salary exceeds thirty rupees shall be subject to the approval of the board.

24. Every order or regulation made by the board under Sanction of Commissioner when necessary. Same relates to any officer whose monthly salary is three hundred rupees or more, be subject to the previous sanction of the Commissioner.

IV.—OF THE PROPERTY AND LIABILITIES OF THE BOARD.

General Powers as to Property.

25. The board shall, for the purposes of
Powers of board as to property.

This Act, have power to acquire and hold moveable and immoveable property whether within or without the limits of the port or city of Karáchi; and shall also have power to lease, sell or otherwise convey any moveable or immoveable property which may have become vested in or been acquired by them:

Provided that no sale of immoveable property and no lease of any such property for a term exceeding twenty-one years shall be valid unless such sale or lease shall have been made with the previous sanction of Government.

Procedure to be observed when the board are unable to acquire, by agreement, any immoveable property.

Their discretion, order proceedings to be taken for acquiring the same on behalf of the board, as if such property were land needed for a public purpose within the meaning of the Land Acquisition Act, 1870. X. of 1870.

The amount of compensation awarded and all other charges incurred in the acquisition of any such property shall be forthwith defrayed by the board, and thereupon the said property shall vest in the board.

The property specified in schedule Transfer of Government property to the board.

A shall, upon and after the date notified. by Government under section 10, vest in the board:

Provided that-

(1) if any question arises between the Government and the board as to the boundaries of any portion of such property, Government may define and demarcate such boundaries, and the decision of Government in respect to such boundaries, when approved by the Governor General in Council, shall be conclusive;

(2) any portion of the land specified in the said schedule which shall be required by Government for a public purpose may be resumed by Government, with the approval of the Governor General in Council, without claim to compensation on the part of the board, except for buildings or other permanent struc-

tures erected thereon;

(3) the railway now under construction between the Bandar station and the Keamári station may be constructed by Government along the foreshore or on reclaimed land, and any other work which the Governor General in Council may consider necessary in the public interests may be executed by Government in or upon any of the property specified in the said schedule, without claim to compensation on the part of the board except for building or other permanent structures, which it shall be necessary to clear away for the purpose of such railway or work.

The loans specified in Schedule B,

and all sums of money due to the said Karáchi Harbour Board shall be deemed

to be due to the board;

and all suits or other legal proceedings, civil or criminal, instituted, or which might, but for the passing of this Act, have been instituted by or against the said Karáchi Harbour Board, may be continued or instituted by or against the board.

#### V.—OF THE POWERS AND DUTIES OF THE BOARD.

#### . Works.

- The works to be constructed and carried out by the board may include Works to be conthe following:-
  - (1) wharves, quays, stages, jetties, piers and docks, with all necessary and convenient arches, drains, landing-places, stairs, fences, roads, railways, and approaches;
  - (2) tramways, warehouses, sheds, engines, and other appliances for conveying, receiving, and storing goods landed, or to be shipped, or otherwise;
  - (3) light-houses, light-ships, beacons, pilot-boats, and other appliances necessary for the safe navigation of the port and of the approaches, thereto within a distance of three miles from the limits of the port;
  - (4) laying down moorings, and the erection of cranes, scales, and all means and appliances necessary for berthing, loading and unloading vessels;
  - (5) reclaiming, excavating, enclosing, and raising any part of the foreshore of the port vested in the board;
  - (6) the construction, procuring and application of dredges and other machines for cleaning, deepening, and improving any portion of the port or foreshore aforesaid;
  - (7) procuring and employing steamvessels for towing vessels into, out of, or within the port;
  - (8) the construction of such works, without the limits of the port, as shall be necessary for the protection of works executed by the board within the port, and all such other works and appliances as may, in the opinion of the board, be necessary or desirable for carrying out the purposes of this Act:

Provided always that no new work, the

But no new work to be commenced without a plan and estimate, if its cost shall exceed Rs. 1,000;

estimated cost of which excéeds one thousand rupees, shall be commenced by the board, nor shall any contract be entered

into by the board in respect of any such new work, until a plan and estimate of such work shall have been submitted to the board and considered and approved by

31. The board may occupy or remove or alter any bathing-place or landing-place within the port, and prohibit the public from resorting to or

using the same: Provided that the board shall provide for the use of the public such other bathing-places or landing-places, if any, as the Commissioner may direct.

Landing and Shipping of Goods.

32. The board shall, so far as the funds at their disposal will allow, provide and maintain wharves,

quays, stages, jetties, piers, warehouses, sheds and appliances for the expeditious and convenient shipment and landing of goods in and from seagoing vessels within the port and for the storing of such goods, and shall by their servants land and ship all goods from and in any such vessel coming to any such wharf, quay, stage, jetty or pier, except where there is a lawful excuse for refusing to land or ship such goods, or such vessel is, under any enactment for the time being in force, not entitled to have her cargo shipped or discharged: Provided that—

(1) the board shall not be bound to land, ship or move any single article or package exceeding ten tons of twenty hundredweight in weight, except at such special charge as may be agreed on in respect of such article or package;

(2) the board may, by special agreement with the masters of vessels or the owners of goods, permit goods to be landed and shipped by others than the servants of the board; but every such permission shall be subject to the condition that the means to be employed and the appliances to be used by the said masters or owners for landing or shipding goods shall be subject to the approval of the board, whose duty it shall be to satisfy themselves that the said

means and appliances are at all times such and in such condition as not to endanger the lives or safety of the persons employed.

33. When any wharf, quay, stage, jetty or pier has been made and completed, with sufficient warehouses, sheds and appliances

for landing or for shipping goods from and in sea-going vessels, the board may, with the previous sanction of the Commissioner, by a notification published in three consecutive numbers of the Sind Official Gazette, declare that such wharf, quay, stage, jetty or pier is ready for receiving, landing and shipping, or for landing or for shipping, as the case may be, goods from and in sea-going vessels.

From and after such publication, the board may from time to time, when there is room at such wharf, quay, stage, jetty or pier, order to come alongside of such wharf, quay, stage, jetty or pier, for the purpose of landing and shipping goods, or for landing or for shipping the same, as the case may be, any sea-going vessel within the port which has not commenced to discharge cargo, or which, being about to take in cargo, has not commenced to do so. In making such order the board shall have regard, as far as possible, to the convenience of such vessel, and of the shippers, in respect of the use of any particular wharf, quay, stage, jetty, or pier.

34. When a sufficient number of wharves, quays,

accommodation stages, jetties, piers, sufficient, all sea-going warehouses, vessels compelled to use and appliances have wharves, &c. provided as been aforesaid, the board may, with the previous sanction of the Commissioner, by an order published in three consecutive numbers of the Sind Official Gazette, direct that no goods shall be landed or shipped from or in any sea-going vessel within the port, save at such wharves, quays, stages, jetties and piers, and may, in like manner, alter, vary or revoke any such order: Provided that it shall be competent to the board at any time to exempt any specified vessel from the opera-

tion of any order made under this section. 35. The board may, in cases of emer-

gency, or for any reason which appears to them sufficient, by notice in writing, order the master or

owner of any vessel not to bring such

vessel alongside of, or to remove such vessel from, any wharf, quay, stage, jetty or pier belonging to the board, and, if such notice is not obeyed, the board may charge in respect of such vessel such sum as they think fit, not exceeding one hundred rupees for each day of twenty-four hours or portion of such day, during which such vessel remains at such wharf, quay, stage, jetty or pier:

Provided that in the case of a vessel ordered to be removed, such charge shall not commence to be made till after the expiry of thirty-six hours from the service of the board's notice on the master or owner of the vessel.

36. Notwithstanding anything contained Power to Commis- in sections 33 and 34, the Commissioner sioner to exempt from may, by notification in the Sind Official obligation use wharves, &c.; and Gazette, from time to time permit certain specified vessels or classes of vessels to discharge or ship cargo, or certain specified cargo or classes of cargo, at such part of the port, in such manner, during such period, subject to such payments and on such conditions, as he may think fit, and otherwise grant exemption from the provisions of such sections.

The Commissioner may also, by like notification, cancel or modify any such notification.

The Commissioner may also at any time require that any vessel belonging to to require preference to be given to Governor in the service of Her Majesty or the Government of India shall be permitted to come alongside of any wharf, quay, stage, jetty or pier belonging to the board in preference to all other vessels at the time in port: and it shall be incumbent on the board to give effect to any such requisition.

37. Whenever any goods are landed by the board from Discharge of liability any vessel, the board shall, if so required, give to the master of such vessel a receipt in the form or to the effect set forth in schedule C., and may in any such receipt include all goods landed from such vessel during one day.

No master or owner of a vessel from which the goods in respect of which such receipt is given may have been landed shall be liable for any loss or damage to such goods which may occur after they have been so landed.

40. Save as hereinafter provided, no Private wharves, &c., board shall make, erect or fix below prohibited. high-water mark within the port any wharf, dock, quay, stage, jetty, pier, erection or mooring.

Any matter or thing so made, erected or fixed may be removed by the board, and the person who has so made, erected or fixed any such matter or thing shall be punished with fine, which may extend to one thousand rupees, and with a further fine which may extend to one hundred rupees for every day during which such matter or thing has been permitted to remain so made, erected or fixed after notice to remove the same has been given to him, and shall also be liable to pay all expenses which may have been incurred by the board in removing such matter or thing.

41. The board may, by an order in writing and subject Power to permit ection of private wharves, &c., within the port subject to conditions. to the conditions contained in the same, permit any person to make, erect or fix

below high-water mark within the port any wharf, dock, quay, stage, jetty, pier, erection or mooring.

42. In case any wharf, dock, quay, stage, jetty, Wharves, &c., beyond erection or mooring is, after the date on which this Act comes into force, without the written consent of Government, made, erected or fixed below high-water mark without the limits for the time being of the port, and thereafter the limits of the port are extended so as to include the place in which such wharf, dock, quay, stage, jetty, pier, erection or mooring has been made, erected or fixed, the board may remove, fill up or destroy such wharf, dock, quay, stage, jetty, pier, erection or mooring without making any compensation therefor.

Such scales or altered scales shall be submitted, through the Commissioner, to Government and, after approval or modification by Government, shall be published in the Bombay Government Gazette and the Sind Official Gazette and shall thereupon have the force of law: Provided that no such scale or altered scale shall be approved or modified by Government until a draft of the same and a notice specifying a date at or after which the draft will be submitted to Government shall have been published in the Sind Official Gazette and in such other manner as Government from time to time prescribe.

From the time when any scale framed under this section comes into force, the Bombay Landing and Wharfage Fees Act, Bom. VII. of 1882, shall be repealed so far as regards 1882. the port of Karáchi.

In lieu thereof, a toll shall be payable by Government to the board on all troops and all the families of troops landing or embarking at Karáchi at the rate of one

rupee per head.

46. For the amount of all tolls, dues, rates and charges le-Board's lien for tolls viable under this Act in respect of any goods, the board shall have a lien on such goods, and shall be entitled to seize and detain the same until such tolls, dues, rates and charges are fully paid.

Tolls, dues, rates and charges in respect of goods to be landed shall become payable immediately on the landing of the goods, and, in respect of goods to be removed from the premises of the board or to be shipped for export, shall be payable before the goods are removed or shipped.

The lien for such tolls, dues, rates and charges shall have priority over all other liens and claims, except a lien for freight, primage and general average, where such lien has been preserved in the manner hereinafter provided, and a lien for money payable to Her Majesty or the Secretary of State for India in Council under any law for the time being in force.

47. If the master or owner of any vessel, at or before Owner's lien for the time of landing freight. from such vessel of any goods at any wharf, quay, stage, jetty or pier, gives to the board notice in writing that such goods are to remain subject to a lien for freight, primage or general average of an amount to be mentioned in such notice, such goods shall continue liable, after the landing thereof, to such lien.

Such goods shall be retained either in the warehouses and sheds of the board, or, with the consent of the Chief Officer of Customs, in a public warehouse, at the risk and expense of the owner of the said goods, until the lien is discharged as hereinafter mentioned.

Goods may be removed to warehouse. been left for five clear days on or in any wharf or shed belonging to the board, the board may cause such goods to be removed either to any warehouse belonging to them, or, with the consent of the Chief Officer of Customs, to a public warehouse; and the removal to and detention in any such warehouse shall be at the risk and expense of the owner of the said goods.

Whenever any goods are so removed, the board shall give notice of such removal to the consignee of such goods or to his agent, if any, if such consignee's or agent's address be known, by letter sent by post to such address or left thereat; and shall also publish in the Sind Official Gazette and in two local newspapers notice of such removal, and shall specify therein the numbers, marks and descriptions of such goods so far as the same appear; and the consignee of such goods, in addition to the expenses of the removal of the same, shall be liable, in case the goods are removed to any warehouse of the board, to a charge for warehousing for the time during which the goods shall remain in the said warehouse.

If the goods are removed to a public warehouse, the said consignee shall be liable to the charges for warehousing goods in such public warehouse; and the said goods shall remain subject to all liens to which they would have been liable if they had remained in the possession of the board and shall be subject to the power of sale hereinafter given.

50. If the tolls, dues, rates and charges payable to the board Recovery of tolls and harges by sale of under this Act in respect of any goods goods. have which landed are not paid, or if the lien for freight, primage or general average, where such notice as aforesaid has been given, is not discharged, the board may, and in the latter event, if required by or on behalf of the person claiming such lien for freight, primage or general average, shall, at the expiration of four months from the time when the goods were placed in their custody, sell by public auction the said goods, or so much thereof as may be necessary to satisfy the amounts hereinafter directed to be paid out of the produce of such sale.

Before making such sale at least tendays' notice of the same shall be given by publication thereof in the Sind Official Gazette and in two local newspapers.

If the address of the consignee of the goods or of his agent has been stated on the manifest of the cargo, or in any of the documents which have come into the hands of the board, or is otherwise known, notice shall also be given to the consignee of the goods or to his agent by letter delivered at such address or sent by post; but the title of a bond fide purchaser of such goods shall not be invalidated by reason of the omission to send such notice, nor shall any such purchaser be bound to enquire whether such notice has been sent:

Provided that, if such goods are of so perishable a nature as, in the opinion of the officer appointed by the board in that behalf, to render early or immediate sale necessary or advisable, the board may, within such period, being not less than twenty-four hours after the landing of the goods as they think fit, sell by public auction the said goods or such portion of them as aforesaid, in which event such notice, if any, shall be given to the consignee of the goods or his agent as the urgency of the case admits of.

And, in case any part of the said rates or penalties, or of the costs of the distress or arrest or of the keeping of the same, shall remain unpaid for the space of fifteen days next after any such distress or arrest shall have been so made, the board may cause the vessel, or other thing so distrained or arrested, to be sold, and with the proceeds of such sale may satisfy such tolls, dues, rates, charges or penalties and costs of sale remaining unpaid, rendering the surplus, if any, to the master of such vessel on demand.

notice stating that an amount therein specified is due in respect of tolls, dues, rates, charges or penalties chargeable under this Act, or any bye-laws or orders made in pursuance hereof, against such vessel or the owner or master of such vessel, in respect thereof, such officer shall not grant. such port clearance until the amount so chargeable shall have been paid.

If, at the time appointed in the summons and whether the person summoned appears or not, it is proved that the alleged damage was done through such negligence as aforesaid, and that the pecuniary amount of the same does not exceed two hundred rupees, the magistrate may issue his warrant of distress, under which a sufficient portion of the boats, masts, spars, ropes, cables, anchors or stores of the vessel may be seized and sold to cover the expenses of and attending the execu-

tion of the distress, and the pecuniary amount of damage as aforesaid, and such amount shall be paid to the board out of the proceeds of the distress:

Provided that if, at the time of the damage or mischief, the vessel was under the orders of a duly authorized officer belonging to the pilot service or to the harbour master's or port officer's department, the case shall not be cognizable by the magistrate under this section.

All fines and damages recovered from any offender or by any distress under section 76 shall be paid to the board.

78. Prosecutions under this Act may
be instituted by the
board or by any person authorized by them in this behalf, and
not otherwise.

#### VIII.—CONTROL.

79. Government may at any time order a survey and examination of any work of the board the cost of such survey or examination shall be borne and paid by the board.

same effect had been duly framed, sanc-

tioned and published under section 43. 82. If at any time the Government is satisfied that the purposes intended to Government may re-• voke powers of board. be accomplished under this Act have not been and are not likely to be properly accomplished by the board, the Government may, by notification in the Bombay Government Gazette, and in the Sind Official Gazette, give notice that, unless within six months the board take measures to the satisfaction of Govern-

ment for properly accomplishing such purposes, the powers by this Act conferred

on the board will, at the end of such period, be withdrawn and revoked.

On the expiration of the period aforesaid, Government may, if no such measures to its satisfaction have been taken by the board, with the approval of the Governor General in Council, declare such powers to be withdrawn or revoked, and thereupon such powers shall be withdrawn and revoked accordingly, and all the powers, rights and authorities and all the property vested by this Act in the board shall thereupon vest in Government.

#### IX.—MISCELLANEOUS.

83. All acts done and proceedings Saving of previous taken by the Karachi port regulations. Harbour Board before this Act comes into force, and all orders, rules and regulations relating to the port and to wharves, quays, stages, jetties, piers and landing places within the port made and issued before this Act comes into force, shall, whenever such acts, proceedings, orders, rules, or regulations would have been lawful if this Act had been in force, be deemed to have been respectively done, taken, made and issued under the provisions of this Act.

84. All fees and sums due on account Recovery of dues as of property for the fines under the Criminal time being vested in the board, and all arrears of tolls, charges, rates and dues imposed under this Act, may be recovered, in addition to the other modes hereinbe-

fore provided, upon a summary proceeding before a magistrate in the manner provided in the Code of Criminal Procedure, 1882, X. of 1882. for the recovery of fines.

85. No trustee shall be personally liable for any con-Trustees not persontract made or expense ally liable. incurred by or on behalf of the board; but the funds from time to time in the hands of the board shall be liable for and chargeable with all contracts made in manner provided in this

86. Every trustee shall be liable for any misapplication of Trustees liable for money entrusted to breach of trust. the board to which he has been a party, or which happens through, or is facilitated by, the neglect of

87. No suit shall be commenced against any person for any-Limitation of suits, thing done, or purporting to have been done, in pursuance of this Act, without giving to such person one month's previous notice in writing of the intended suit and of the cause thereof, nor after six months from the accrual of the cause of such suit; and in the case of a suit for damages,

if tender of sufficient amends shall have been made before the suit was brought, the plaintiff shall not recover more than the amount so tendered and shall pay all costs incurred by the defendant after such tender.

88. The board shall not be responsible

for any mis-feasance, mal-feasance or non-Board not responsible for certain acts of their feasance of any officer or servant appointed officers and servants.
