## ACTS PASSED BY THE GOVERNOR GENERAL OF INDIA IN COUNCIL

IN THE YEAR 1874.

- I. An Act for the quieting of Titles depending on judgments delivered by certain Settlement Officers in the North-Western Provinces.
- II. to consolidate and amend the law relating to the office and duties of Administrator General.
- III. to explain and amend the law relating to certain Married Women, and for other purposes.
- ✓ IV. to control recruiting in British India for the service of Foreign States.
- V. to invest the Assistant Commissioner in charge of the Kullu Sub-division of the Kángra District with certain appellate powers.
- VI. to consolidate and amend the law relating to appeals to the Privy Council from decrees of the Civil Courts.
- VII. to provide for the appointment of Municipal Committees in Towns in British Burma, and for other purposes.
- VIII. ✓ to provide for the exercise of the powers hitherto exercised by the Lieutenant Governor and Board of Revenue of Bengal in the territories forming the Chief Commissionership of Assam.
- IX. to consolidate and amend the law relating to European Vagrancy.
- ✓ X. to amend the Law relating to Salt.
- XI. to amend the Code of Criminal Procedure.
- XII. ✓ to provide for the exercise, in Sylhet, of the powers of the Lieutenant Governor and Board of Revenue of Bengal.
- XIII. to provide in the Panjáb and elsewhere for the guardianship of European British Minors.
- ✓ XIV. to ascertain the enactments in force in various parts of British India, and for other purposes.
- XV. for declaring the local extent of certain Enactments, and for other purposes.
- XVI. for the repeal of certain Obsolete Enactments.
