# PREFACE TO THE SECOND EDITION

A SECOND 'edition of this work has been published with the objects:-

- (1) Of correcting mistakes in certain of the tables that were pointed out by a Japanese correspondent, Mr. T. Nimagawa, of Kyoto Imperial University. These mistakes were made in the calculation of the "regression lines," from the correlation coefficients, in Tables 6, 10, 15, and 21.
- (2) Of incorporating certain additional work, of which Chapters VIII and IX have previously appeared in the Bankers' Magazine, to the Editor and Proprietors of which journal the writer wishes to express his thanks for permission to reproduce. He would like to have re-written these chapters to avoid a certain amount of repetition, but he was unable to do so.

Chapter VII, together with the charts in the pocket of the cover, have not been previously published. The writer thinks that the charts, on which are set out the prices of a number of commodities, relative to the general price level, for a period of seventy-four years, provide a new means of judging whether a particular price is likely to be too high or too low. This may be useful to those who have to buy or sell, or lend or borrow on, commodities.

# INTRODUCTION TO THE FIRST EDITION

The general object of the work described in the following pages was to discover facts connected with certain rates of interest and discount on the London Money Market, with the rates of exchange between London and two foreign centres, Paris and New York, with the relationships between the different rates, and with the prices of commodities.

Certain apparent relationships were found, and it was decided to examine in addition the rate of discount in Paris and the rates of interest on call money, and of discount in New York.

The more particular object of the work was to try and find some variation that would act as a guide to the future course of rates. Some success was obtained in this direction, for it was noticed that when the rate of discount in London was more than usual above the rate of interest on floating money, for the time of year, the floating rate showed a strong tendency to rise more (or to fall less, if it was a time of year when the rates usually fell) than usual, for the time of year. This relationship should chiefly be of use to those actively engaged in the Money Market, to whom it is probably already known, somewhat indefinitely, but it should also be of use to those, outside the Money Market, to whom movements in the floating rate are of interest, many of whom are certainly unaware of its existence.

Further than this, since the rate of interest given for the use of floating money is some guide to general trade conditions, the relationship may provide a means of measuring definitely, though partially, the probable future course of trade in general. As such, it may be a step towards turning the art of prophecy into an exact science. In making this suggestion we must not be taken as supposing that the future could ever be predicted with certainty. Cosmic upheavals, such as earthquakes, and political upheavals, such as wars, etc., may be quite unpredictable, but they only arrive occasionally, while many of the causes of the irregularities dealt with will be usually with us.

The period examined—1882 to 1913—consisted of years when the Money Markets of the world were unhampered by Government restrictions, and many

of the conclusions reached cannot, therefore, be applied directly to post-war years. In so far, however, as they depended on the free working of the law of supply and demand, and on secular variations in temperature throughout the year, causing harvests to be garnered at certain seasons, etc., they must be effective at the present time, though the apparent result may be different. The gathering of the harvest, for instance, indirectly causes a rise in the rate of discount in the autumn, and if in other years the rate of discount is fixed, so that it cannot move, the effect of the increased demand will be felt in some other way, in decreasing, perhaps, the amount of accommodation; in other words, if the shoe is not allowed to pinch in one place, it will pinch in another.

Looked at from a broad point of view, the work may be regarded as an attempt (a) to measure the effects of laws which have been arrived at either by the deductive method or by experience, (b) to increase our knowledge of economic laws by the inductive method, a method which, considering the amount of statistical material available, has obtained surprisingly few followers. The reasons for this seem to be that statistics and still more statistical methods are comparatively modern inventions, that the statistics available are, even yet, often incomplete, that much labour of a somewhat mechanical kind is involved, and that the method is not so attractive as the deductive. The ordinary practice of political economists has been to follow the deductive method, to arrive at a generalization, and then to expect facts to fit in with the laws arrived at. It is probably for this reason that they have been of less use to "practical" men than they otherwise would have been. "Practice and theory" have been found to disagree, to the detriment of both.

It would seem, too, that rules, sufficiently numerical, could never be "evolved," in some cases, by the deductive method. The prices of things, for instance, may depend quite definitely on the law of supply and demand, but what the "practical" man wishes to know is the variation in the price that may be expected to go with a definite variation in the supply. Such a desire could only be satisfied by an examination of the past, to see what had, in fact, occurred. An attempt to formulate such a law for wheat in England was, indeed, made about two centuries ago by Gregory King, who suggested that while a deficiency in the supply of Wheat of one-tenth caused a rise in the price of three-tenths, a deficiency of two-tenths caused a rise of eight-tenths. The formulation of further laws of such a kind was one of the ultimate objects of the work described in these pages.

Some of the work has already been published in the pages of the Bankers'

Magazine (for July and August, 1912, and for May, August, and September, 1921).

The proprietors of this magazine kindly gave permission for the articles referred to to be republished, and though advantage has only been taken of this permission as regards Chapter V, quotations, chiefly in the form of tables, have been freely made.

The thanks of the writer are due to Mr. W. S. Gosset, for much mathematical assistance, and particularly for the equation in Chapter V.

#### CHAPTER I

#### MATERIAL AND METHODS USED

THE greater part of the data used in the following pages has been extracted from the *Economist*, from the first number of each month.

Different, and perhaps, from some points of view, more representative, data could have been obtained by a raging either daily or monthly figures, but time, etc., did not permit of this being done. After the greater part of the work had been completed, however, the weekly figures, from the Economist, were averaged monthly, but these have only been used to a small extent. A cursory examination would seem to show that they uphold the main conclusions arrived at from the monthly figures.

The data extracted, details of which are to be found in the Appendix, are as follows, all being for the years 1882-1913, unless otherwise stated.—

The rate of interest on floating money in London.

The rate of discount on 3 months Bank Bills in London,

The rate of discount on 6 months Bank Bills in London.

The rate of exchange between London and New York; Telegraphic Transfers in and after July, 1886; before that date, "Short at interest."

The rate of exchange between London and Paris.

The "Market rate of discount" in Paris.

The rate of interest on Call Money in New York.

The rate of discount on "endorsed bills" in New York (for the years 1885-1910 only).

Sauerbeck's Prices of Commodities for 1850-1910 as quoted in the Journals of the Royal Statistical Society.

The methods adopted have been :-

- (1) To average the monthly rates for each year.
- (2) To average the yearly rates for each month of the year.

(3) To determine the size of the variations in the rates, and the relationships between them according to the statistical methods associated chiefly with the names of Professors Karl Pearson and F. Y. Edgeworth (which are described in Professor A. L. Bowley's The Elements of Statistics).

Methods (1) and (2) are simple; by means of the former, the average rates of the years are determined, so that one year can be compared with another. Since, however, there are well-known secular variations in the rates, within the years, it was necessary also to determine the positions of the rates at different times within the year, i.e. to average each month of the thirty-two years separately, as in (2).

By means of (3) the size of the variations in the different rates was measured by determining the "probable error," and the relationships between the series of data, as such, were measured by means of the "correlation coefficient."

As regards the former, the "probable error" of a series is such that half the variations fall between it and the average, and half further away. It thus provides a definite measure of variation when such is necessary. As an example, the rates of discount in London and Paris, which are cited on a later page, may be taken, and it will be seen that whereas the average rate of discount on 3 months bank bills in London for the years 1882-1913 was 2-69 per cent., the probable error was 55 per cent., i.e. half the average annual rates fell between 2-14 per cent. and 3-24 per cent.; in the case of Paris the average market rate of discount for the same period was 2-49 per cent., while the probable error was 41 per cent., i.e. half the rates fell between 2-08 per cent. and 2-90 per cent. Not only, therefore, was the Paris late lower, but the variation was less, being about two-thirds of that in London.

Coming now to the measurement of relationships, for which the correlation method has been used, this method consists in first plotting out on squared paper all the results to be considered. The scale of one variable is placed vertically and that of the other horizontally, and a mark is made for each case, according to its position on each scale. When all the cases to be examined have been plotted out a correlation coefficient is calculated, due weight being given to each individual according to its position on the chart. The correlation coefficients obtained vary between + 1.00, which indicates perfect positive correlation, such as would be given by correlating the diameters and circumferences of a number of circles, and — 1.00, which indicates perfect negative correlation, such as would be given by correlating the two portions of a number of cut packs of cards. It is obvious that in the former case the marks representing the individual cases will all lie along a diagonal formed by joining

two of the corners of the chart, while in the latter they will lie along the opposite diagonal. Where there is less complete correlation, the marks will be distributed generally about the diagonals, while if there is no correlation they will be distributed in no particular direction.

A sample correlation table is inserted in the Appendix. The method provides a means by which the relationship between two series of figures can be measured accurately and definitely; it enables the "Descriptive Statistician to present the inductive Scientist with a highly significant part of his data in a compact and instructive form," 1 and with a conciseness that was impossible until the method had been invented

It must be clearly understood, however, that the discovery of a correlation, perhaps a close one, between two series of data does not indicate that there is a connexion, in the nature of cause and effect, between the two series, for, leaving aside the fact that the apparent connexion may be the result of pure chance, they may be connected together through some common cause. It is necessary, therefore, to "take account of whatever extraneous knowledge may be available" in order that an explanation of any apparent relationships found may be provided, and in order that the full value of their use may be realized.

To give an example of two variables to which the method of correlation may be applied with usefulness, one may instance the case of the weather and the crops, where "extraneous knowledge" suggests that the variations in the latter are largely connected with those in the former. Variations in both are so numerous that probably no generalizations have been arrived at by the deductive method. There are, no doubt, many empirical rules which have been formulated as the result of experience, such, for instance, as "a peck of March dust is worth a king's ransom," but they are so indefinite (not to mention the possibility of the units of measurement being old-fashioned) that they are of very little practical value.

An attempt has been made by Hooker  $^{\circ}$  to measure definitely, by means for the correlation method, the relationships between the weather and the resulting crops in the eastern part of England, with some success, showing for instance that the rainfall just before the sowing period correlates to the extent of -62 with the resulting crop of wheat. Owing to incompleteness of data, it is probable that little practical use has been made of his work, but, where the connexion between the weather and the resulting crops is obviously so great and where it is of such importance, from a business point of view, to have as early an indication as possible of a coming crop, it would seem that further work in this direction cannot long be delayed.

One may also, perhaps, draw attention to another series of data, published in the first number of the *Manchester Guardian Commercial*, and giving weekly rates of exchange between London and New York and London and Paris, together with the rate at which exchange can be purchased four weeks ahead.

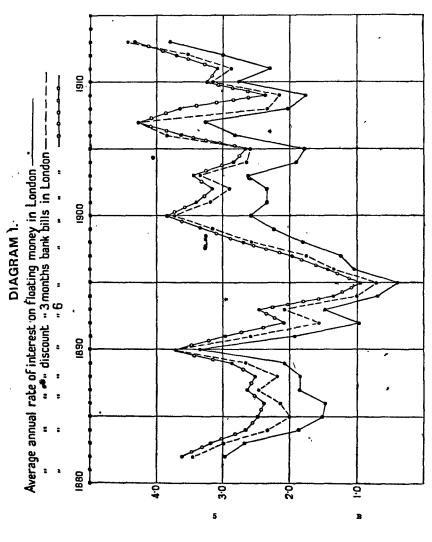
It is suggested 1 that "while the reader can see for himself by a study of the tables that no precise generalization would be accurate, nevertheless, the market has been broadly right when it has taken a very decided view as measured by forward rates."

Now, such a statement may sum up the situation, but, to any one who wishes to make practical use of the "forward exchange" mechanism and is not sufficiently in touch with the market to know whether its view is "very decided" or not, it is far from being sufficient.

In order to discover, therefore, to what extent the variations in the forward rate were a guide to the movements of the exchange to four weeks ahead, the weekly forward rates, for New York and Paris, for the year 1921 and the first three months of 1922 were correlated with the differences between the spot rate at the time the forward rate was quoted and the spot rate four weeks ahead.

Coefficients of + ·37 for the Paris rate and — ·14 for the New York rate were obtained, showing that there is an appreciable connexion, in the direction expected, in the case of the Paris exchange but not in the case of the New York exchange. Whatever, therefore, may be its use as a general guide to the future, the actual distance of the forward fate (for four weeks ahead) over or under the spot rate, at any particular time, is but a poor guide to the spot rate of exchange exactly four weeks ahead in the case of Paris, and none at all in the case of New York.

#### CHAPTER II

#### RATES OF INTEREST AND DISCOUNT IN LONDON

THE figures to be examined in this chapter consist of the rates of interest on floating money and of discount on 3 and 6 months bank bills in London, extracted, as already stated, from the first number of the *Economist* for each month for the years 1882-1913.

The average annual rates are set out in the table on page 7.

The averages are also set out in Diagram 1, in the form of a curve, from which the relationships between the rates can be seen more easily. The rates vary between 40 per cent. and 3.79 per cent. for floating money, between 70 per cent. and 4.41 per cent. for discount on 3 months bank bills, and between 92 per cent. and 4.38 per cent. for discount on 6 months bank bills.

The rates move up and down together, and the correlation between the floating rate and the 3 months discount rate is +.93 and between the floating rate and the 6 months discount rate +.92.

The rates are generally high when trade is active, and it has been shown  $^1$  that the rate of discount  $^2$  in London correlates to the extent of + 90 with the value of the exports of the United Kingdom per head of the population, and to the extent of + 69 with the imports, both for the years 1878–1907. The rate of discount is thus connected closely with the state of the trade of the country.

It was also shown I that the rises and falls in the rates of discount from year to year in the different centres correlate closely with the rises and falls in the exports and imports, not only for the United Kingdom, but also for France, Germany, and the United States of America, and it is interesting to note that the relationships are closer with the imports than with the exports. This might have been expected, for provision for payment has to be made by the buyer.

The average monthly rates are set out in the following table and in Diagram 2.

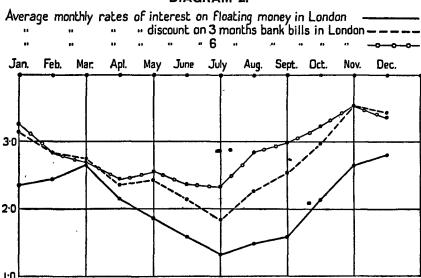

The rates are seen to have the same general trend; they are highest at the beginning and towards the end of the year, and lowest in the summer. There are some interesting irregularities; the floating rate rises from January to March, while, during this period, discount rates are falling. The floating rate descends regularly from March, to July, and rises regularly to December, while the discount rates fall less to May and then fall regularly to July, rising to a maximum in November.

The rise in the floating rate to March is due, of course, to the collection of the taxes at the end of the financial year, after which it falls, owing to the smaller demand for accommodation by the bill-brokers. After July it rises, together with the discount rates, owing to the increased requirements of billbrokers for financing the autumn crops.

Coming now to the differences between the floating and discount rates, it was noticed that although these rates moved roughly in the same direction, the distance between them was not always the same, and in order to examine the relationships between them, the differences between the floating rate and the two discount rates were determined, and the tables on the next pages set out the results.

It is seen that the differences between the floating rate and the 3 months discount rate vary between '30 per cent. and I-14 per cent., while the 6 months differences lie between '35 per cent. and I-26 per cent., the floating rate being, of course, in all cases the lower.

The "differences" are not appreciably greater when the rates are high, which is, perhaps, surprising (the correlation between the floating rate and the 3 months" difference" being slightly positive, at + .25, and the corresponding coefficients for the 6 months "difference" being slightly negative, at — .01), for it might have been supposed that the charge for risk, which must be included in the discount rate, would have been greater when floating rates were high.

The "differences" are lowest in March and highest in September, while the high level of the whole of the autumn and of January is noticeable. These peculiarities are due to the greater demands of the bill-brokers in the autumn, relative to the amount of floating money available, and to the greater demand for floating money, relative to their requirements, in the early part of the year.

The "differences" between the floating and discount rates for individual months were next examined, and it was noticed that in years when the discount rate was more than usual, for the time of year, above the floating rate, the floating rate tended to rise more (or to fall less, if it was at a period of the year when the rate was falling) than usual.

To measure this relationship, the "differences" were correlated with the rises and falls in the floating rates, from the month named, to the average of the remaining 2 and 5 months of the currency of the bills, with the results set out in Table V (page 12).

There is seen to be a connexion of considerable size between the two sets of figures correlated for each month, indicating that when the rate of discount, on 3 and 6 months bank bills is more than usual, for the time of year, above the floating rate, the floating rate tends to rise more than usual during the currency of the bill, or to fall less if it is a period of the year when the rate falls.

The relationship is particularly large in February, with both 3 and 6 months rates, while it is much smaller in May, with the 3 months rate, and in July, with the 6 months rate, than in other months.

It is interesting to note that the relationship is closer with the 6 months than with the 3 months "difference."

The average "differences," the average rise or fall in the floating rate from the month named to the average of the next 2 and 5 months, respectively,

and the variation in the last named that may be expected to correspond to a variation of 'I per cent. in the "difference," are set out in Table V.:—

As an example, to explain the use of the table, the 6 months "difference" for February may be taken, and it is seen that the average "difference" for the thirty-two years was :39 per cent., while the average floating rate for the 5 months, March to July, was :52 per cent. below that for February. A variation in the "difference" of :1 per cent. corresponds to a greater or lesse fall than usual in the floating rate from February to the average of March–July of :10 per cent., so that if in any year the "difference" had been :49 per cent. a fall in the floating rate of :42 per cent. might have been expected, while with a "difference" of :29 per cent. the fall would have been :62 per cent.

Looking at the relationships in another way, and again taking the February 6 months "difference," the best prediction that could have been made of the future of the floating rate without the assistance of the relationships pointed out would have been to have taken the average fall of the period. On doing this, it is found that the average "difference" between the rate predicted and

the actual rate is 70 per cent., while, if the relationship is used, the average difference between predicted and actual becomes 46 per cent., an advantage of 24 per cent., or of about a third of the 70 per cent.

The existence of the relationships pointed out are doubtless known in a general way, by "the Money Market," but as far as is known they have not been previously demonstrated. As has already been stated, the practical value of the relationships lies chiefly in the use to which they can be applied by dealers in "floating money"; their use should render "experience" more definite, and they have the advantage over general knowledge that exceptions to the rule can easily be discerned and examined. As a guide to future trade conditions they may also be useful.

Theoretically the relationships are interesting, and an attempt has been made to account for them. It was at first thought that they might have been due to a definite regulation of future rates by some authority, in accordance with the position at any particular time. This would not seem, however, to be a likely, or perhaps a possible, proceeding, and a further consideration was undertaken.

The business of discounting bills on the London Money Market is conducted

by the banks and bill-brokers, but it appears to be the latter to whom the most active part of the business appertains; it is they who, vis-à-vis the sellers of bills, perform the chief part of the operation of fixing the rates of discount. They buy bills at a discount, and in order to do this they borrow from the banks, chiefly floating money. It is thus their object, on the one hand, to buy bills at as high a rate of discount as possible, and, on the other hand, to borrow floating money as cheaply as possible.

When the supply of bills offering is larger than usual, then cateris paribus, the rate of discount will be high; when the supply of floating money is larger than usual the floating rate will, cateris paribus, be lower than usual; in either case the "difference" will be higher than usual. As, however, a larger offering of bills than usual will require a larger amount of "money" for financing them, the future supplies of floating money will be reduced, and the floating rate will rise more than usual—hence the relationships observed.

With this view of the situation, the question arises: Are the variations in the "differences" caused more by the variations in the floating rate or by those in the discount rate? And dealing with the 6 months rate, Table VII on page 15 sets out the correlations obtained between the "difference" and (a) the floating rate, (b) the rate of discount on 6 months bank bills.

The coefficients with the floating rate are seen to be much larger and more regular than those with the discount rate, indicating that the variations in the floating rate are generally a much more important factor in causing variations in the "difference" than are variations in the discount rate.

The floating rate tends to be low when the "difference" is high, in all months, the tendency being most marked in the first three months of the year, and being least marked in July.

The discount rates coefficients are generally negative in the early months of the year, the influence of the floating rates being probably overwhelming, while they tend to be positive in the later months, and particularly in July, August and September.

The next question that arises is: Does the "difference" correlate with the rises and falls in the discount rate? Table VIII sets out the coefficients obtained between the "differences" and the rises and falls in the 6 months rate of discount from the month named to the average of the next five months, the corresponding coefficients for the floating rate, already quoted, being set out for comparison.

In some months it is seen that a rise in the discount rate follows a high "difference," and in some they do not. From October to January, inclusive, and in June, the former is the position; in the remaining months it is the latter.

Generally speaking, the coefficients are not nearly so large as with the future floating rates, indicating that the "difference" is a less good guide to future discount rates.

The next question that arises is: At what period during the "next five months" do the rises and falls in the floating rate that have been shown to be connected with the "difference" occur?

An inspection seemed to show that it was chiefly in the first month. The "differences" were, therefore, correlated with the rises and falls in the floating rate to the next month, and the coefficients obtained are set out in the following table:—

It is seen that the coefficients vary much more than those set out in Table VIII; August, November and February are again larger than their neighbours, February being particularly notable in this respect, while July is again

Calculating from these coefficients, the variations set out in Table X are those corresponding to a variation of 'x per cent, in the "difference."

It is seen that in most months the rises and falls to the next month, corresponding to a constant variation of ·I per cent. in the "difference," are much the same as the rises and falls to the average of the next five months, showing that whatever causes the floating rate to rise and fall operates almost entirely in the first month.

It has been suggested that the "cause" of the relationships set out is the withdrawal of the floating capital from the market owing to the financing of a larger quantity of bills than usual, owing to which the rate on floating money is increased. Such a cause would be largely automatic in its effect, being due to the natural working of the laws of supply and demand. In post-war years such a cause might have ceased to be operative, but an examina-

tion of the data available would seem to show that it is still acting, though with so few years each month does not follow. Generally speaking, the rises and falls in the five months average follows the 1882–1913 relationships better than the rises and falls to the next month.

The 6 months "differences" and the rises and falls in the floating rate to the next month, and to the average of the next five months for the months of January, February, April and May, 1919–22, are set out in the following table:—

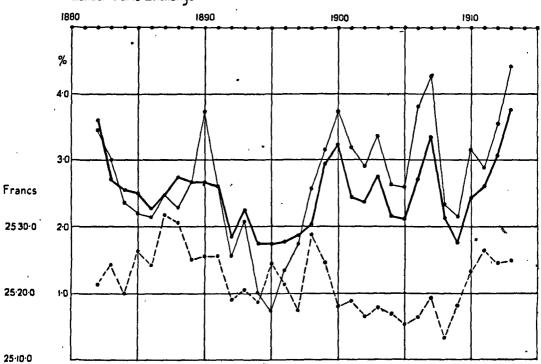

It is seen that the "difference" has again been a useful guide to the future course of the floating rates, but the rises and falls to the "next" month are not usually so great as those to "the average of the next five months."

Generally speaking, it would seem that the relationship between the "differences" and the variations in the rate of interest on floating money that have been pointed out are of general application. There seems to be no doubt about the fact, but the theory suggested to account for it may be fallacious.

#### CHAPTER III

#### THE LONDON-PARIS EXCHANGE

WE have now to examine the London-Paris exchange, its relationship with the rates of interest on floating money and of discount in London, and with the market rate of discount in Paris.

The table on page 21 sets out the annual average rate of exchange, the average rate of discount on 3 months bank bills in London, and the average market rate of discount in Paris, each being the average of the rates stated in the first number of the Economist at the beginning of each month.

It is seen that the rates of exchange were highest at the beginning of the period, though there is a high period during the last four years, while they were lowest during the first ten years of the present century. The average rate is 25.21.0 francs, which is almost exactly the par of exchange (which is 25.22 francs).

The average rate of discount on 3 months Bank Bills in London is 2-60 per cent., as compared with a market rate of 2.49 per cent. in Paris, while the variation as shown by the probable error is somewhat greater in London than in Paris. The rates are lowest in both Paris and London in the period 1891-99.

The relationship between the three series of figures may be more easily examined in Diagram 3, which sets them out in the form of a curve.

It is seen that the rates of discount move up and down roughly together, while the rate of exchange shows very little relationship to the other rates.

The correlation coefficients are as follows:-Between the average annual London-Paris rate of exchange and

of interest and discount in London and the London-Paris exchange, while there is a slight tendency for the Market rate in Paris to be high when the rate of exchange is high. The rates of discount in the two centres vary together and a movement in London goes with a movement of about half the amount in Paris; in other words, if the London rate rise by 5 per cent., the Paris rate is likely to rise by 25 per cent.

The lack of connexion between the exchange and the rates of interest and discount is unexpected, for, according to the orthodox theory of exchanges, a high rate of exchange should go with low rate of interest and discount in London, and with a high rate of discount in Paris. In fact, there is a slight connexion in the expected direction with the Paris discount rate, but the size of it is very small.

We have next to examine the average monthly figures, and these are set out in the following table.

The numbers are too small for correlation, and the averages are set out in the form of a curve in Diagram 4.

The curves show that the Paris discount rate moves roughly in the same direction throughout the year as the London floating and discount rates. It does not fall as much as the floating rate in the summer, however, and it does not rise as much as the London discount rate in the autumn, thus maintaining the greater constancy peculiar to the Paris rates.

There are differences in the smaller irregularities, the London discount rate being highest in November, and falling gradually to the following July, and then rising fairly regularly to the next November, showing thus one festoon.

The London floating rate is highest in December, and has another maximum point in March, thus showing two festoons.

The Paris discount rate has minima in March, June, September, and December, thus showing four inverted festoons.

The exchange rate is much more irregular; it shows distinct maxima in March and September, and smaller maxima in June and December.

We now have to examine the relationships between the different rates for the same months of the different years, and the following table sets out the correlation coefficients between the London-Paris exchange rate, and (a) the rate of interest on floating money in London, (b) the rate of discount for 3 and 6 months Bank Bills in London, and (c) the market rate in Paris, all being for the years 1882-1913.

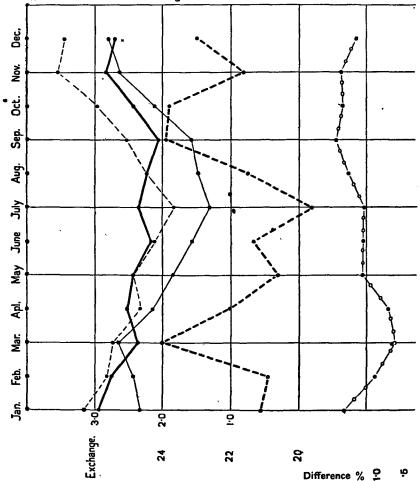

Almost all the correlations are positive, showing that high rates of interest and discount both in London and Paris go with a high rate of exchange, but many of the coefficients are very small. As far as Paris is concerned,

this supports the orthodox theory, according to which high rates of interest and discount should go with high exchange, when expressed in francs per f sterling.

The relationships are, on the whole, closer with the floating rate in London, and they are largest in the autumn months of the year, August to December.

The relationships between the exchange rate and the London rates is of course in the direction that would not be expected, i.e. high exchange goes with high rates.

A further table is given, showing the correlation obtained between the rate of exchange and (a) the difference between the floating and discount rates in London, (b) the difference between the London 3 months discount rate and the Paris Market rate.

Generally speaking, the rate of exchange is high when the difference between the floating and discount rate in London is small, this being particularly marked in the period October-February, and in June, and with the 6 months difference, while in May there are high positive correlations.

As will be seen later, the Paris exchange agrees in these general relationships with the New York exchange, and the reason for their occurrence may be the same, a high exchange signifying that there is a smaller amount of business than usual passing, and that the rate of discount is consequently lower than usual, relatively to the floating rate, as is shown by the "difference" being small.

The correlations with the differences between the rates of discount in the two centres are fairly large in many months, and are larger than those for the rates of discount themselves. They indicate that when the London discount rates are low relatively to Paris, then the rate of exchange also tends to be low. This is unexpected, and is probably due to the fact that when the Paris rate moves up and down, the London rate moves up and down to a greater extent; it has a greater range.

In three of the four quarterly "Paris" periods, namely March, June, and December, the coefficients are larger than their neighbours.

A final table, No. XV, is given on page 27, showing (1) the relationships between the Market rate of discount in Paris, and (a) the London floating rate; (b) 3 months discount rate; (2) the variation in the London 3 months rate that may be expected to accompany a variation of 1 per cent. in the Paris rate.

The rates in Paris and London are seen to be connected together; when they are high in Paris they are high in London. The discount rates in the two centres are more closely connected than is the Paris discount with the London floating rate, as might have been expected.

The connexion between the discount rates is fairly regular, but it is higher at the four quarterly periods, March, June, September, and December, than in other months.

The London rates vary more than the Paris rate, and, considering the discount rates only, a rise or fall in the Paris rate of 1 per cent. corresponds to a rise or fall in the London rate of about  $1\frac{1}{4}$  per cent., the quarterly periods noted above generally showing a higher figure than the neighbouring months.

Can an explanation be provided for the various apparent connexions between the rate of exchange and the rates in London and Paris?

The salient facts about the Paris market seem to be (1) that France was a creditor nation, to this fact the Governor of the Bank of France, in his evidence before the Aldrich Commission, attributed their ability to have a lower bank rate than that in force at other centres; (2) that the Bank of France, which acts on very "conservative" lines, was able to control the trade of the market to a very great extent, so that the actual dealers in bills were directly affected by its decisions. There is no lending of floating money for the discount of bills in Paris, as in London, bills being rediscounted at the Bank of France, by the other Banks as a routine, and the Bank is therefore able to bring pressure to bear on the purchasers of bills much more easily than the Bank of England, which only rediscounts bills in times of stress. Also

the Bank of France is not under the liability, like the Bank of England, to pay out gold on demand. It can therefore easily affect not only the rate at which business is done, but the amount of the business.

It would seem, therefore, that the failure of the London rates to be low when the exchange rate is high is due to the facts that the rate of discount tends to be high in both centres at the same time, and that when the rate is raised or reduced in Paris, the London rate rises or falls to a greater extent.

It is probably the conservatism of the French public reflected in the Bank of France (which is, of course, a national institution) that enables the rates to be kept lower in Paris than those in London, and in fact than those in all other centres. There is probably in each centre a "national" level for the rate of interest, which depends on the adventurousness of the investing public and on the supply of national capital.

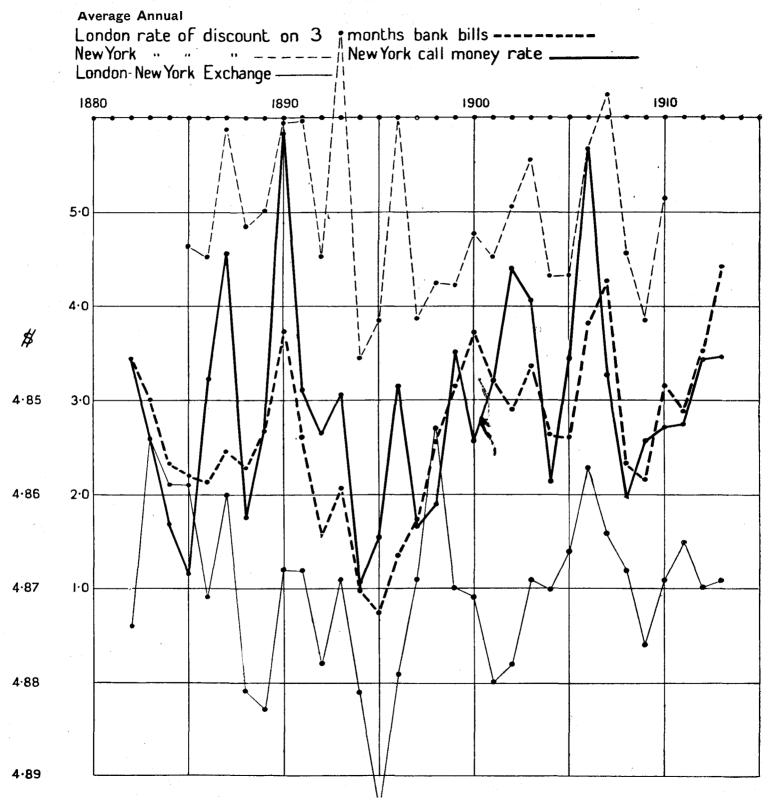
If the foregoing be true, it will be apparent that the conditions of the French money market during the period considered were somewhat artificial, the variations of supply and demand were not fully reflected in the price of money, but were met by regulation of the supply and demand themselves (though it is possible that more natural conditions existed at the quarterly periods noted). Such a state of affairs could probably only exist in a creditor market,

and in one where conservatism was the ruling instinct. This may, therefore, make this analysis of the relationships of the London-Paris rate of exchange for a pre-war period less useful as a guide to the immediate future than it otherwise would be.

An interesting point that was noticed after the above work was completed was that, if the weekly figures for the period examined (1882-1913) be taken, it is to be noted that in the months December to March a movement in the Paris exchange is followed the next week by a movement, in the same direction, of the floating rate in London (178 cases to 138, the odds that this is not a chance occurrence being about 15 to 1), while for the period April to November a movement in the floating rate in London is followed the next week by a movement in the same direction of the rate of exchange on Paris (336 cases to 242, the odds that this is not a chance occurrence being about 800 to 1).

The market rate of discount in Paris is not now quoted in the English journals, and the exchange rate between London and Paris is too irregular to make the data of four years worthy of examination. As far as can be seen the three-monthly periodicity of the period 1882-1913 does not exist at the present time, showing, perhaps, that the forces of Nature, upon which the law of supply and demand is based, have become too great for even the Bank of France to control.

### CHAPTER IV

## THE LONDON-NEW YORK EXCHANGE

THE London-New York exchange has been examined in the same way as the London-Paris exchange, and the facts discovered are stated in this chapter.

The table on page 30 sets out the average annual rate of exchange, the average rate of discount on 3 months Bank Bills in London, and the average rates of interest for call money and of discount on endorsed bills in New York (for the years 1885-1910). The figures are, as before, the averages of those quoted at the beginning of each month in the *Economist*; on and after July, 1886, the exchange is the "Telegraphic Transfer," before that date, "short at interest."

It is seen that the rates of exchange were lowest at the beginning of the period. The average rate is \$4.88.0, which is slightly in favour of London, par of exchange being \$4.86.5.

The rate of discount on 3 months Bank Bills in London is slightly lower than the rate of interest on call money in New York, and much lower than the rate of discount on endorsed bills. All the rates are low in the 1890-1900 decade.

The variation as shown by the probable error is almost the same for the two discount rates, and is appreciably greater for call money in New York.

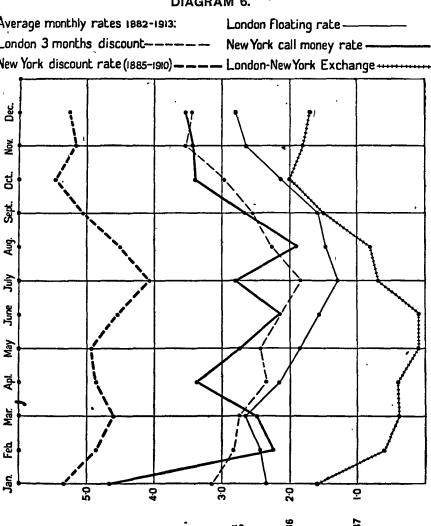
The relationships may be more easily examined in Diagram 5 attached, which sets out the annual averages in four curves. It is seen that the rate of exchange tends to be high when the rate of discount in London is low, and that on the whole the rates of interest and discount move up and down together.

The relationships are very different to those shown by the Paris rates; a high rate of exchange (London-New York) goes with low rates in London, while there is a very small correlation between the rate of exchange and the rate of interest on call money in New York. The New York discount rate correlates negatively with the rate of exchange, which would not have been expected, and this is doubtless due to the fact that the London and New York discount rates show a fair-sized positive correlation. It is not nearly as large, however, as the correlation shown between the Paris and London discount rates.

We next have to examine the monthly averages, and these are set out in Table XVII and in Diagram 6.

All the curves show some similarity, the rates being highest at the beginning and towards the end of the year. The agreement between the rates of interest and discount in the two centres is not nearly so close, however, as that between the Paris and the London rate. The rate of exchange, on the other hand, shows more apparent connexion with the other rates than the Paris rate of exchange.

The movement of the call money rates in New York shows the least connexion with the movements of the other rates, and there are quarterly maxima at the beginning of January, April, July, and perhaps October.

The New York discount rate shows maxima in May and October, the beginning and end of a six-monthly period, which may show that they are connected with each other.

The rate of exchange is at its minimum in October, when the New York discount rate is at its maximum.

We have now to examine the relationships between the different rates for the same months of the different years, and Table XVIII sets out the correlation coefficients between the London-New York exchange rate, and (a) the rate of interest on floating money, (b) 3 months discount and 6 months discount rates in London, (c) the call money and discount rates in New York, all except the last, which is for the years 1885–1910, being for the years 1882–1013.

Generally speaking the correlations are negative, showing that high rates of exchange go with low rates of interest and discount in both centres. This is in the expected direction as far as London is concerned, but is unexpected for the New York rate. The position is thus somewhat similar to that of Paris, only that, in the case of the New York exchange, it is London that gives orthodox connexions, while with the Paris exchange these were given by the foreign centre.

There are other dissimilarities; the correlation coefficients are somewhat

smaller with the New York rates than with the Paris rates, while the New York coefficients tend to be often high when the London coefficients are low.

In the case of both London and New York, the rates for short money appear

to be less closely connected with the exchange rate than are the discount rates.

It is also to be noticed that for the months of August, September and October the London rates tend to be positively correlated with the exchange rate, thus disagreeing with the rest of the year and with the annual average correlation.

A further table is given to show the correlations obtained between the rates of exchange and (a) the difference between the floating and discount rates for the years 1882-1913 in London, and (b) between the London 3 months discount rate and the New York discount rate for the years 1885-1910.

Looking first at the correlations with the differences between the London floating and discount rates, it is seen that for the first three months of the year a high discount rate goes with a large "difference," while the reverse holds for the remainder of the year; the coefficients are largest for April and for the last six months of the year.

Coming now to the correlations for the differences between the discount rates at the two centres, it is seen that the year is divided clearly into two portions, the earlier part, when a low rate in New York relative to London goes with a high exchange, and the latter, when the reverse obtains. A priori, one would have expected all the months to show positive correlations.

On considering together the relationships between the exchange and the London rates set out in the two previous tables, it is apparent that, as far as the London rates are concerned, the year divides itself into three parts:—

- (r) The first three months of the year, when high exchange rates go with low floating and discount rates, but with large "differences."
- (2) The months August, September, and October, when high exchange rates go with high floating and discount rate, and with small "differences."
- (3) The remaining six months, when high exchange rates go with low floating and discount rates, and with small differences.

To agree with these facts it will be apparent that in the first three months a variation in the rate of exchange must go with a larger variation in the discount rate than in the floating rate, and in the months August fo October with a larger variation in the floating than in the discount rate.

On calculating the amount of variation in the floating and discount rates corresponding to a constant variation in the exchange rate which has been done for the three months "differences" only, the above is, of course, found to occur, as is shown in the table on page 36 for the typical months January, May, and September.

A final table, No. XXI, is given on page 37 showing the monthly relationships between the London floating and 3 months rate of discount and the rate of discount in New York, together with the variation in the London rates that goes with a constant variation in New York rate, for the years 1885-1910.

The discount rates in the two centres are seen to be closely connected, as are the London and Paris rates, but in the case of New York the relationship is peculiarly small in October, and is a little low in April and July, i.e. in three of the four quarterly maxima of the New York call money rate.

The movement in London corresponding to a variation in the New York 'discount rate of I per cent. is seen to be, on the average, 4 per cent., a movement in New York thus going with a movement of about half the size in London. This should be compared with the movement in the French discount rate, which is a little less than that of London.

What explanation can be provided to account for the relationships set out?

The general negative relationship between the exchange rate and the floating and discount rates in London would have been expected, but the negative relationship with the New York discount rate requires explanation.

It would seem that it must be due to the fact that in the general movement of the rates at the two centres the influence of London is overwhelming, and the New York rate follows the London rate, giving like it a negative correlation. There is a slight indication that in the months of August, September, and October the movements in New York cause corresponding movements in London. This explanation is then similar, but in the opposite sense to that provided to account for the unexpected relationship between the London rates and the London-Paris exchange.

The power of London to "pull" the rates during the period examined was, perhaps, due partly to the fact that it was a creditor market, again similar to the London-Paris position, but in the opposite sense. There are, of course, great differences in the positions of Paris and New York relatively to London, the actual difference in distance naturally tending to make Paris have closer relationships. Economically speaking, also, London lies between Paris and New York, and perhaps partly on this account the London-New York exchange

correlates negatively with the London-Paris exchange for part of the year and positively for the remainder. From the point of view of its constitution, too, the London money market lies between Paris and New York. Paris is centralized, unfree, and carefully regulated. London is non-centralized, free, and subject very much to the movements caused by variations in supply and demand; while New York is (or at any rate was, during the period considered) ron-centralized, free, and almost unregulated.

It is likely that some of these peculiarities are in large part due to the nature of the inhabitants of the countries in which these markets are situated. The French are thrifty, conservative, not adventurous, and willing to be "administered," and the rate of interest can, therefore, be usually maintained at a low rate if it be desired.

The British may be conservative, but they are much more adventurous and much more independent, and the rate of interest cannot therefore be regulated in the same way; while the Americans, with their comparatively new country and less tradition behind them, cannot help being still more adventurous and independent (this, perhaps, in a somewhat different sense to the

independence of the British), and their natural rate of interest is considerably higher.

Dealing with the "difference" relationships, which as a rule are negative, it may be remembered that in Chapter II it was suggested that a large "difference" was an indication of the fact that a larger amount of bills than usual were being offered for sale. Assuming that this be correct, it is to be expected that a larger amount of "exchange" than usual will be required, and the rate of exchange will therefore be lower than usual when the "difference" is high. An explanation is thus provided for the negative correlation between the "differences" and the exchange rates. In the early months of the year, when the correlation is positive for the London-New York exchange, the absorption of floating money, due to the collection of taxes during the first quarter of the year, affects the floating rate so much more than the discount that the correlation between the London-New York exchange and the "difference" becomes positive, the rates themselves obeying the orthodox connexion with the exchange, according to which high rate of exchange goes with low rates of interest and discount.

An examination of the movements of the weekly rate for the years already considered, which was made after the foregoing work was completed, shows that if the floating rate in London moves up or down, the London-New York exchange generally moves up or down in the same direction the following week, except in the months of February and July, and excluding these two months the movements in the same direction are 394 as against 203 in the opposite direction, the odds against this being a chance occurrence being about 1,400 to 1.

During the months of June to September, a movement of the exchange rate up or down is followed the next week on 151 occasions by a movement in the same direction of the London floating rate, as against 124 in the opposite direction, the odds against this being a chance distribution being about 4 to 1.

Both the above disagree with the orthodox theory according to which a rise in the exchange rate should be followed by a fall in the rate of interest, as indicated by the "floating rate."

On the other hand, a rise or fall in the "difference" in one week is followed by a fall or rise in the exchange the next week on 179 occasions during February to May, as against 141 in an opposite sense (odds 10 to 1 against it being chance), which accords with the theory advanced in these pages, while during June to August a rise or fall in the exchange in one week is followed by a

fall or rise in the "difference" the next week in 130 cases as against 91 cases in the opposite direction (odds against chance being 60 to 1), again agreeing with the theory advanced.

The results set out in this and the preceding chapter seem to be of theoretical interest, as showing that the orthodox theory of "foreign" exchanges, according to which high rates of exchange go with low rates of interest and discount, does not always obtain. In many cases the coefficients are small, but they may be of practical interest, as measuring definitely relationships which are probably already known by experience to those engaged in dealing with the business of exchange and bill-broking; they may in fact be said to "crystallize experience." The method used has the advantages over "experience" that the more remote events are given as much weight as the more recent, and that exceptions to rule are more easily noticed. Further than this, the method can be applied more or less mechanically, so that more time can be spent on an examination of causes and effects, since less time is required for "learning by experience." Unfortunately, at the present time the actual relationships described do not seem to be directly applicable to post-war rates, but it is likely that the reasons causing them are still operative, though, perhaps, with different results, and that when free conditions again apply to the money markets of the world the knowledge may be directly applicable.

### CHAPTER V

CALCULATION OF AN EQUATION FOR THE PREDICTION OF THE FUTURE FLOATING RATE FROM THE DIFFERENCE BETWEEN THE FLOATING RATE AND THE RATE OF DIS-COUNT ON BANK BILLS, THE RATE OF EXCHANGE BETWEEN THE UNITED KINGDOM AND THE UNITED STATES OF AMERICA, AND THE RATE OF EXCHANGE BETWEEN THE UNITED KINGDOM AND FRANCE

In the earlier pages of this pamphlet it has been shown that the variations in the rises and falls in the floating rates for the coming five months can be foretold, to some extent, from the variation in the size of the difference between the floating rate and the rate of discount on Bank Bills. It has further been shown that the variations in the "difference" show connexions with the variations in the rates of exchange between the United Kingdom and the United States of America and France, while the variations in the two exchanges themselves also correlate with each other. To complete the series, the rises and falls in the future floating rates were correlated with the two exchanges, and it was found that in many months of the year fairly high relationships exist.

Now, it will be obvious on consideration that some of these relationships may be due to the existence of others. If, for instance, the "difference" correlates very highly with the future floating rate and also with the American exchange, it is likely that the exchange will show an appreciable correlation with the future floating rate, purely, perhaps, on account of the relationship of both with the "difference." Whether such a relationship is independent or not can be determined by applying the "multiple correlation" method. This method has been kindly applied for me to the month of January, for the six months rates, by Mr. W. S. Gosset, and he finds that the inclusion of the American exchange with the "difference" adds but little to the accuracy of the forecast of the future floating rate, but that the French exchange adds to it appreciably, and he suggests that the French exchange has an "effect" on the future floating rates separate from the "effect" connected with the "difference." The following table sets out the correlations between the different series:—

Now, in the absence of any outside knowledge (including the relationships set out above), the only conclusion that can be drawn from the data of the years examined is that the rise in the floating rate from a January to the "next five months" will be the average rise of the years examined, namely 33 per cent., and the "probable error" of this prediction will be 58 per cent., i.e. over a number of cases half will fall nearer to the average (i.e. 33 per cent.) than 58 per cent. and half will be farther away. If, however, we make use of the "difference" relationship, the probable error of the prediction falls to 4x per cent. If the American exchange relationship be included it falls to 40 per cent., if the French exchange relationship be included to 36 per cent., and if both exchanges are included, to the same figure. The inclusion of the American exchange does not, therefore, appreciably improve the prediction, but the inclusion of the French exchange gives some improvement. On this account it is suggested that the effect of the French exchange on the future floating rate is independent of that of the "difference."

The equation for calculating the probable rise or fall in the floating rate for January to the average of the next five months is:—

R = 1.055 D - 0433 F,

where D is the "difference," above or below the average.

F is the French exchange above or below the average, expressed in centimes.

R is the rise in the floating rate, expressed in percentage.

If, therefore, in a certain January the "differences" were 4 per cent. above the average for all Januarys, and the French exchange were 5 centimes below the average for all Januarys, then the most probable rise in the floating rate to the average of the next five months for the particular January taken would be:—

1-055  $\times$  4 + -0433  $\times$  5 above the average rise for Januarys, or -422 + -2165

or 64 per cent. above the average rise.

Equations could, of course, be worked out for the other months of the year and for the 3 months rates of discount; enough has been done, however, to give an indication of the way in which the "multiple-correlation" method may be put to practical use. The actual equation given cannot be directly applied, of course, to post-war rates, and may be altogether inapplicable, as far as the rate of exchange is concerned. With currency stabilization and a return to normal conditions of supply and demand it is likely, however, that a similar equation could be calculated.

### CHAPTER VI 1

## ON VARIATIONS IN THE PRICES OF COMMODITIES

Variations in the prices of commodities affect every one, but, in ordinary times, they, are usually small enough and they arrive sufficiently slowly to be left to the consideration of "economists." The variations during and since the war have been so great, however, that the subject has forced itself into general prominence.

Variation in prices is by no means a new phenomenon, for the rise in prices of some commodities during and after the Napoleonic Wars, the Civil War in America, and the Franco-Prussian War, were also sufficiently large to draw to themselves general attention. In modern times the more striking variations have been connected with wars, and, though it was fairly obvious before, it seems to be now generally accepted that such rises in prices are due to the increase in the amount of "money" available for spending, relative to the supply of commodities to be bought.

It must not be supposed, however, that variations in the price-level cannot take place during peace, for a great rise took place, in fact, in the middle of the nineteenth century, at the time of the gold discoveries in California and Australia, while a considerable fall took place during the last two decades of the same century, probably because, on the one hand, the supply of gold failed to meet the normal requirements (largely because Germany took to using gold as a basis for its currency), while, on the other, the supply of commodities increased faster than before, on account of improvements in manufacture and in the means of communication.

The price of things in general is usually said to depend on "supply and demand," but this "law" is subject to the proviso that the "demand" must be an actual demand, backed by money; the demand of Russia for locomotives at the present time, for instance, is only a potential, not an actual, demand, and, in the absence of any arrangement for the payment of their purchase price, is not likely to affect the price.

It might have been expected that the proper price for any particular commodity could have been fixed from a consideration of the supply of and the demand for it, but in addition to the difficulties of measuring these factors

there is the difficulty, which is quite external to the particular commodity concerned of the variations in the general price-level, which certainly depend on the varying amounts of money spent and goods bought. This is, of course, an obvious conclusion, about which there can be no dispute. It is equally obvious, too, that if only a certain amount of money is available for spending, and if the quantity of goods for sale remains constant, the price level of the goods cannot be as high as it might be if the amount of money were doubled.

What is known as "The Quantity Theory of Money" proceeds a step further and suggests that rises in the price-level are due to increases in the amount of money available for spending, while detractors of the theory suggest that prices rise first and that then the amount of the money to be spent has to be increased. It would seem that the theory is correct, but it is very difficult to prove it, in practice, at any particular time. In the first place, the available statistics are inadequate; in the second place, it is very difficult to give an exact definition of the term "money," which may consist in normal times of a golden sovereign, of a bank-note, or of a credit given by a banker, and this last may depend not on an actual rise in prices, but on a rise that is expected to take place. In this way a prospective rise in prices may be the cause of an increase in the currency, and, in so far as this is true, the Quantity Theory may be a somewhat incorrect expression of the truth.

In dealing with individual commodities, a further difficulty arises which is not connected with the supply and demand relationship for the particular commodity concerned, namely, that if a greater proportion than before of the available money is spent on some commodities, there will be less available for spending on the remainder. The prices of some commodities may, therefore, rise, while others are falling for reasons quite unconnected with the supply and demand relationship, for one set of commodities alone. Although, therefore, it is very difficult theoretically, and in practice impossible, to calculate what the prices of commodities should be, it is comparatively easy to obtain and tabulate actual prices, to see, in fact, what the result of the division of "money" by "goods" has been, and it is proposed to set out and consider the prices of various commodities for the years 1850-1910, which were all years when prices in the United Kingdom were uncontrolled by the Government. 'The data examined consist of the "index-numbers" provided by Augustus Sauerbeck, which have been published in the Journals of the Royal Statistical Society for 1886 and subsequent years. These data consist of the average annual prices of 43 commodities for the whole period, of a 44th (nitrate of soda) from 1866, and of a 45th (petroleum) from 1873.

The average price for the years 1867-77 for each commodity separately is taken as the unit 100, and the prices of each individual year are taken as a percentage of this figure. The 45 percentages for each year are then added together to obtain the total index number for the year.

It is obvious that in order to provide a perfect index number the price of each article bought and sold ought to be included, but, owing to their number, this is impossible of performance, and we have to be content with a selection. The 45 articles selected have been chosen as being representative of things sold, and in order to give more weight to some articles which are of more importance than the others two separate quotations have been assigned to such commodities as wheat, beef, mutton, coal, and cotton, so that they have more weight in the total than, for example, butter. The 45 items are made up as follows:———,

The diagram on the opposite page sets out the above in the form of a curve.

The highest figure reached is seen to be III, in 1873, while the lowest is 61, in 1896—about half the maximum.

The average of the whole series is 84, the first half giving 96, and the second 72.

The average differences between the index number of two consecutive years is 4-0 in the first half and 2-6 in the second. A greater difference would, of course, be expected in the first half than in the second, because the price level is higher, but, allowing for this by dividing the differences by the price levels, we find that the difference becomes 4-2 per cent. for the first half and 3-6 per cent. for the second, showing that the variation in the price level from year to year has been, roughly, the same in both periods.

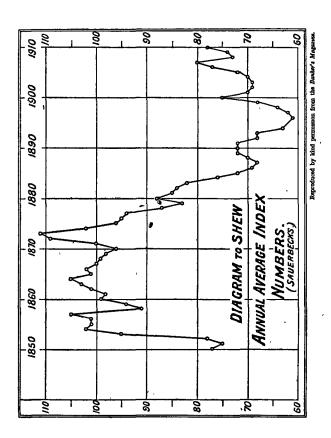
In so far as the index number is a good guide, this may be taken as the size of the variation in the price level, over the sixty years, that has been due to the variation in the proportion of money spent to goods sold, and it will be interesting to continue the same examination for the price level of the different groups of commodities, and for the individual commodities which go to make up the index number.

To take Sauerbeck's own grouping, according to the use to which the commodities are put, the following table sets out, for the two halves of the period taken, the average index number of the six groups of commodities.

The individual figures are, of course, closer to the average total figure in the first half than in the second, because this period contains the base years 1867-77, when each individual was brought to 100. It is seen that in the first half "animal food" is considerably lower than the other groups, showing that either a smaller proportion of the available money was spent on this kind of food, or that the supply of it was greater, relative to the demand, than



it afterwards became. This is, in fact, the chief feature of the earlier period. In the second period, the "sugar" group and "textiles" are well below the average, while "animal food" is well above it. In other words, the demand for "sugar, tea and coffee" relative to the supply has fallen off, while that for "animal food" has increased. What has happened? Has the supply altered, or the demand? It would not appear that the demand for sugar, tea and coffee has diminished (and, of course, in fact, it has increased enormously).

and, if this be the case, then the supply must have increased very considerably,

and this is what has happened.

With animal food there is no reason to suppose that the demand is less than it was; rather it would be expected to be greater, and the increase in the price level, relative to other commodities, is probably due to the relative fall in production of animal foodstuffs, and also to the fact that, as some other prices have fallen to a considerably greater extent, more money has been available for meat and has been spent on it. This may be taken as a result of the rise in the standard of living in the United Kingdom.

The textile group is in the same position as the sugar group, a greater supply and not a smaller demand probably accounts for the relatively reduced price.

Now we come to the year-to-year variations for the groups, and these, expressed as a percentage on the average index number, are set out in the following table for the two periods.

It is seen that most of the groups have a greater variation than the total index number, as would be expected, for they are affected by variations in their own peculiar supply and demand relationship, in addition to those in the proportion of total money spent to total goods sold. It is interesting to note, however, that two of the groups (animal food and sundry materials) show a variation no greater than that of the total index number, seeming to show that either there have been no variations in the prices of these commodities, except those due to the variations in the general relation between money and

goods, or that there has been some compensatory influence, which has caused their variations to be in opposition to the general movement of prices.

In order to measure how close has been the connexion between the movements in the individual groups, the index numbers for the sixty years for each group have been correlated together and the results are set out in the following table.

It is seen that the size of the coefficients is very various; they are all positive, showing that there is a tendency for the prices of all groups to move together. The average of all the coefficients is  $+\cdot59$ , and this may be taken as the value of the common factor that affects the prices of all groups about the mean of each.

We now come to individual commodities; the price level of these, together with their "year-to-year" variation, is set out in the table on page 50.

The table shows, in a striking way, what a great difference has occurred in the falls in the price level with different commodities, and also what a very large difference has occurred in the year-to-year variation.

To take the changes in price level first, the average fall in the total index number has been shown to be 24 points, from 96 to 72, between the first thirty years and the second. Now, certain commodities have fallen much more than this, cotton having fallen about 50 points, English wool 43, sugar about 40, silk 38, tallow 31, tea 49, and soda 38, while certain others have not only not fallen but have risen in price, namely, tin by two points and coal for export by three points.

These peculiarities have, of course, been caused by a change in the demand, relative to the supply. Which factor, the reduced demand or the increased supply, has been the more potent? For all the items that have been noted above as having fallen more than the average, it is almost certainly the increase in the supply that has been the effective factor, except, perhaps, in the case of silk, for which the demand may have fallen off more than sufficiently to counteract the cheaper cost of production.

With the two items that have shown an increase in value, the chief factor has probably been that the supply has failed to meet the increased demand.

Coming now to the differences in the variation in price of the different commodities from year to year, this is surprisingly great, many of them having a variation of as much as 10 per cent. of their price.

At the one end of the scale we find the following items which vary from year to year, over both periods, more than 10 per cent.: Potatoes, cotton, English wool, jute, West Indian and German sugar, tin, iron bars, English wheat, maize, pig iron, and copper.

At the other end of the scale we have the following varying less than 7 per cent.: Oats, soda, mutton, barley, bacon, timber, beef, leather, and butter.

As has already been pointed out, in dealing with the variations in the group index number, part of this variation is due to the varying relation between the money spent and the volume of goods in general sold. This accounts for 4-2 per cent. in the first half period and 3-7 per cent. in the second. From this point of view, one of the most striking things is that certain commodities, namely, beef, butter, and leather, show no more variation than that due to this general cause alone, and, in fact, for the second period the variations in the price level of leather show a smaller variation than the general one. This can only be accounted for by the price of this commodity being somewhat conventionally fixed, as is, for instance, a tram fare.

Generally speaking, the prices of animal products vary little, and those of vegetable and mineral origin much. Comparing animal and vegetable products, this is probably because the vegetable crops are much more variable than the animal, and there seems to be no more reason why the demand should vary more with one than the other. With mineral products it is probably the variations in the demand which cause the chief year to year variations in the price level.

A comparison of the price level of potatoes, the product that shows most variation, with that of coal and iron bars, is interesting. On thirty occasions during the sixty years a rise or fall in the price has been followed in the next year by a fall or rise, showing that the high or low price has tended to produce an increase or a decrease in the production, which has reversed the price movement of the previous year.

The cases of iron bars and coal are very different; in these cases a rise or fall has been followed in the succeeding year by a fall or rise, in only seventeen and fourteen occasions, respectively, showing that the variations in the price level have been much more continuous, i.e. have a greater "wave length," than those in the price of potatoes. This is due, of course, to the price of coal and iron bars being much more dependent on the rises in demand which are connected with the "trade cycle," and usually continue for several consecutive years, and with the subsequent falls that usually take place.

These peculiarities, are, perhaps, of little practical interest at present, but from a banking point of view a consideration of them might give an indication of the commodities upon which it was most safe to lend, either when they were actually in hand or when they were in a state of production.

To a central bureau of information, however, did such exist, the peculiarities should be of the greatest interest, for they would assist in forming an opinion as to whether one commodity or another was remaining too high in price, as compared with the general price level, and whether, therefore, it was desirable to embark fresh capital on its production, rather than on that of some other commodity which had got ahead of general prices. Such a point of view may be one for the far distant future, but the subject of the price level is of such vital importance to all business men and the amount of application of our knowledge has been so small that an active grappling with the subject may be anticipated and the "far distant future" may be, therefore, accelerated so that it is brought into the offing of time at an earlier date.

## CHAPTER VII

# CHANGES IN THE PRICE LEVEL OF INDIVIDUAL COMMODITIES 1

CHANGES in the general price level have been of almost daily interest during the last few years, on account of their size and of the rapidity with which they have sometimes come about. Since, however, the general price level is composed of the sum of the price levels of a number of individual commodities, there have, of course, been changes in these also, and it is to be noted that these have usually been greater than those of the general price level. These changes are of importance second only to those of the general price level, and it was thought that an examination of them would be of interest.

The method adopted has been to calculate each individual index number as a percentage of the total index number of the year, or group of years, taken. We are thus enabled to see at a glance whether an individual article has moved up or down when compared with the general price level. Sauerbeck's series of index numbers has been used, and it may be remembered that it deals with forty-five commodities, the average price of each of which, for the years 1868-77, is taken as 100.

The commodities taken may be divided into the six following groups:-

- (1) Vegetable foodstuffs.
- (2) Animal foodstuffs.
- (3) Sugar, tea and coffee.
- (4) Minerals.
- (5) Textiles.
- (6) Miscellaneous materials.

The years examined are:-

- (1) The five years 1892-6, these being the five years ending with the lowest price level of the last fifty years.
- (2) The five years 1909-13, the last five years before the war.
- (3) 1920, the year of the highest price level since the war.
- (4) 1922, the most recent complete year.

Beginning with the above six groups, the following table sets out the average

By far the most striking point about the table is the fall in the relative position of vegetable foodstuffs and the rise in that of animal foodstuffs. The greatest part of both these changes took place in or before the period 1892-6. The former was due to the increased supply caused by the opening up of new vegetable food-growing countries, together with the development of sea transport. The latter has also been largely due indirectly to the same cause, for with vegetable food cheaper there was more money available for the purchase of animal food, and, since the supply failed to keep pace with this additional demand, prices increased. This change in the relative price level of vegetable and animal produce accounts largely for the transfer of land in the United Kingdom from tillage to pasture.

The fall in the price level of the "Sugar, coffee, tea" group has been very great, again leaving more money to be spent on other commodities.

The changes in relative position have been surprisingly small in the remaining groups. Minerals have been as high as 121.8 per cent., but in 1920 the group stood at only 108.2 per cent. In the Textile group the percentage sank to 85 per cent. in 1892-6, but it has since been very near the general level.

Coming now to the prices of individual commodities, the following tables set out the percentage of each on the general index number for the same years as before, namely, the average of 1892-6, the average of 1909-13, 1920 and 1922. Attention is drawn to some of the interesting points in the notes to the tables.

Wheat and flour have ebbed and flowed; there was a great fall to 1892-6, a small rise to 1909-13, a fall to 1920 and a rise to 1922. On the whole period there has been a fall, from 1868-77, of about 25 per cent.

Barley has not fallen as much as wheat, but there has been a heavier fall

since 1802-6 and from 1920 to 1922. These have been connected with the reduction in the quantity and strength of the beer consumed.

Oats have fallen less than other home grown cereals. Maize has fallen, but the price was very high in 1920. Potatoes have fallen by about 20 per cent. over the whole period; this is probably due to the supply having exceeded the demand, on account of better methods of production. Rice, alone among vegetable foods, has improved its position; this is probably due chiefly to the increased demands of the rice consuming countries of the East.

There is a consistency about this table, only broken by the fact that in 1920 the prices of prime beef and mutton failed to maintain their relative price position.

Mutton has improved its position more than beef; pork and bacon have done best, taking the whole period.

Generally speaking, the position of all animal food producers ought to have been a happy one during the period under discussion; the price of their produce has gone up, the cost of their production ought to have gone down.

Sugar has descended; the demand has increased, but this increase has been more than met by the increased supply, chiefly from the Continent. It is to be noted, however, that the price level rose in 1920, owing, of course, to the temporary cessation of Continental supplies. Coffee appreciated in value up to 1892-6, during which period it had the highest position of all commodities. Generally speaking, it has since remained at the average level of commodities, except in 1920, when the demand from the Continent must have been smaller than usual.

Tea has descended to very low levels, and in 1920 was the lowest of all commodities; an appreciable rise has taken place to 1922. The general fall has been due to the production outrunning the market, while the special fall in 1920 was due to the cutting off of the Russian market.

Iron has gone up slightly in price level during the whole period, while it was higher than usual in 1920.

The behaviour of the price level of coal, which may be taken next, has

been extraordinary; up to the war it had gone up by about 20 per cent., export coal having been always somewhat higher than that sold on the home market. In 1920, however, whereas home-consumed coal was at a price level. only 57.7 of the general price level, export coal was at 254 per cent. This difference was due, of course, to Government restriction, and it brings out clearly (I) the great advantage obtained by home users of coal and (2) the high price charged to the "foreigner."

In 1022 the price level of export coal was still high, at 147.5 per cent... while coal for home consumption had risen to 110 per cent. This is the same relative position as in the period 1892-6, so that home consumers of coal are in the same position as during this period. Since, as noted above, the price of iron is relatively higher, the iron industry ought to be better off.

The movements in copper and tin price levels have been interesting. The former fell by about 10 per cent. for 1892-6, but rose to the general commodity level by 1909-13. In 1920 the level had fallen to 51.7 per cent., or to less than half its pre-war level: in 1922 the level rose to 64.1 per cent. This great reduction in the price level of copper was due, of course, to the disposal of stocks accumulated for war purposes.

The price of tin has pursued a somewhat similar course, in that there was a rise in its position from 1892-6 to 1909-13, but in this case the price level rose to such an extent that it was the highest relative to the base years of all. commodities, namely, 211.5 per cent. It fell to about half this value in 1920, at about which position it has remained. The recent fall in the prices of both copper and tin have been due to failure of the demand, caused by the bad state of trade. The price level of lead has followed that of the other metals noted, but on a lower level. Production has in this case rather more than met the demand.

For some unknown reason the price level of all textile materials fell from the base period to 1892-6, except that of jute. On the other hand, it rose from 1892-6 to 1909-13, English wool and silk being striking exceptions. Since then the striking features are that flax was very high in 1920 (largely owing to the cutting off of Russian supplies) and was still the highest textile in 1922. Jute and merino wool have appreciated and silk has recovered its position (which is surprising, in view of the present large production of silk substitutes). The price of English wool, on the other hand, has gone from bad to worse; in 1922 the price level was only at 37.4 per cent. of the general level. This fall in price is perhaps the most curious feature of the whole price list.

Hides and leather, two animal products, have done well. At the present time hides are relatively low, so that the leather trade ought to be doing well.

Tallow, another animal product, started well, but it has fallen from its high estate in the 1922 figure.

Oils have appreciated on the whole, under the lead of olive oil. \*Palm oil has been below the general oil level since the War, owing, no doubt, to the badness of trade.

Petroleum fell to 60.6 per cent. in 1892-6, since which time the price level has been rising.

Soda and nitrate have been below the average level for the whole period. Indigo had a heavy fall, due to the manufacture of artificial dye stuffs, but it has appreciated in value since the period immediately before the War.

Timber has improved its position, relatively to commodities in general, over the whole period, by about 15 per cent.

The above notes draw attention to the more important points that arise from the tables. They are not intended to be in any way an exhaustive examination, and they have only been inserted to illustrate the method by which the relative position of different commodities may be compared at a glance. To take an example, the case of copper may be mentioned. This metal was at an average price, over the five years immediately before the War, of almost exactly £63 per ton. In 1922, the average price was the same figure. From this it might have appeared that the position of copper producers in 1922 was satisfactory. When, however, it is stated that the general index number stood at 80.4 during the period 1909-13 and at 131 in 1922, the "constancy" in the price of copper does not strike one in the same wav.

## CHAPTER VIII

# CHANGES IN THE PRICE LEVEL OF INDIVIDUAL COMMODITIES (continued)

In the previous chapter the price levels of individual commodities as compared with the general price level were set out for the years 1892-6, 1920 and 1922. In the appendices to this chapter the same comparison is set out for each of the years 1850-1924.

The appendices are two in number, one showing the result of dividing the index number of each individual commodity for each year by the general index number of the year, while the other gives the same results in the form of a curve. For economy of printing, curves have been constructed only for 36 out of Sauerbeck's 45 commodities, the "secondary" items such as "middling beef" having been omitted.

Before dealing with the individual charts it is wished to make two general notes:—

(r) The variations in the price of anything with a constant general price level are due to variations in the supply and in the demand. On consideration, it will probably be agreed that it is often easy to say to which of these, variations in price are chiefly due. Potatoes are a very good example of this statement. On reference to the appendix it will be seen that the price of potatoes goes up and down from year to year differently to any other commodity. The reason of this is, of course, that the demand, depending as it does on the number of people to be fed, does not vary much from year to year. The supply, on the other hand, varies very much with the weather, etc.; one year it is short and the price rises. The next year the price would almost certainly be lower, even if the area under potatoes was not increased, but it is almost certain to have been increased, with a resulting fall in the price. There is thus a tendency for the price being alternately above and below the average.

The variations in the price levels of the commodities coal and iron will be seen, on reference to the appendix, to follow a very different course, a rising price one year being followed more often than not by a further rise the following year and a falling price by a further fall. The reason for this phenomenon is that, with these commodities, it is the variations in the demand

that chiefly affect the price level from year to year. The mines and ironworks will be able to produce much the same amount from one year to another under standard conditions but the demand will vary with the "state of trade," from depression to boom.

This point of view of the possibility of variations in price depending more on variations in either supply or demand may be usefully kept in mind in examining the charts..

(2) The price of a commodity at any time depends on the relation between the supply and demand and also on the amount of currency that is in existence. By taking the percentage that the index number of each commodity is on the general index number, as is done in the appendices to this chapter, the effect of variations in the amount of the currency is removed and we are able to concentrate our attention on the variations that are due to the variations in the supply-demand relationship. These are what may be called the "natural" variations, those due to what have been called the "inexorable" laws. It is interesting to see how comparatively small are the variations in the price levels when these "natural" causes are allowed to operate in an unfettered manner.

The following table sets out for the whole of the seventy-four years and for the forty commodities mentioned in Appendix III the only occasions when an individual commodity has been below 60 per cent. of the general price level or above 150 per cent., or, in other words, if 100 per cent. be taken as 1s., the only occasions when commodities have been outside the limits of 7.2 pence and 18 pence. It is to be noticed that about half the cases occur in the years 1862-66, 1873, 1900 and in or after 1914, during which war effects may be said to have been operating.

The following notes, which are not intended to be exhaustive, have been made on the curves:—

The Vegetable Group of Foods shows a gradually lowering price level during the seventy-four years considered, the fall amounting to about 20 per cent. on the original price. The increase in the production of cereals, due, of course, to the opening up of new countries, has more than kept pace with the increase in the population of the world. It is to be noted, too, that the variations in the price level have become less, as would have been expected with the bringing into use of a greater number of areas.

The Animal Group of Foods has a very different history. The price level has risen instead of falling, and to the extent of about 50 per cent. of the price at the beginning of the period. This is surprising, since both Australia and Argentina may be said to have "arrived" as meat producers since 1850. The chief part of the rise took place between 1860 and 1885, and it has certainly

been due to a rise in the standard of living in meat-purchasing countries, leading to a consumption of a greater quantity of meat per head of the population.

The variation in price is fairly regular over the whole period, with the exception of the years 1914-24.

The "Sundry Food" Group curve is peculiar in that it is divided into three fairly distinct parts, that before the middle of the Nineties, that after about 1902, and the years between these two periods. Between the first division and the last the price level fell by about 50 per cent.; this fall was certainly due to an increase in the supply of foods included in this group.

The Mineral Group curve shows no very decided tendency, though there was a very high period about 1873 and again for about twenty years after 1808.

The curve is somewhat peculiar and the festoons it forms suggest that the variations in the price level are more due to variations in the demand than to those in the supply.

. The Textile Group shows more regularity than the groups already discussed, though there are two outstanding periods, 1860–70 and 1914–24, both being due to wars.

The "Sundry Materials" curve is peculiar for its steadiness, though at both ends of the period the steadiness was less marked, with the result that from the beginning to the end there is a fall of about 40 per cent.

The following notes have been made on the curves for individual commodities:—

American Wheat.—There has been a fall of from 30-50 per cent. over the whole period, which is fortunate for consumers. The curve is peculiar for the rapidity and size of the changes, e.g. a fall of about 40 per cent. between 1855 and 1859 and a rise of about 80 per cent. between 1864 and 1867. The variations are certainly due almost entirely to variations in the supply, and their size has become less with the efflux of time.

Oats.—Prices show a comparatively small change in level over the period; the short distance variation is considerable.

•Barley.—The price level shows a fall of about 15 per cent. from about 1900, due, doubtless, to the reduction in the consumption of beer and whiskey that began at this date, and later, to the reduction in the strength of beer. The curve shows considerable irregularities.

Maize.—This curve shows no decided tendency; the irregularities are, however, very great.

Rice.—Rice is peculiar among cereals in showing a rise in price, which amounts to about 20 per cent. It has taken place entirely during the present century. This rise may be the fundamental cause of the unrest in China. Supply has failed to keep pace with the demand. The curve shows great irregularities.

Potatoes.—The price level shows no particular tendency, but it shows a larger year to year variation than any other; this is certainly due to variations in the supply.

Beef, Mutton, Bacon, Butter.—These curves have a great deal in common, e.g. all show a rise of about 50 per cent. from 1860 to 1880 and the level is then roughly constant till about 1900. With all except bacon there is then a fall to 1920 and a sharp rise and fall afterwards.

Mutton shows the greatest increase.

It would seem that up to about 1900 the demand, owing to the higher standard of living, had outrun the supply, but that about 1900 the supply began to catch up.

Tea, Sugar, give similar curves, the price of both commodities having about halved in the seventy-four years considered. In both cases this is, of course, due to the increase in the supply, on the one hand of Ceylon tea and on the other of beet sugar.

Coffee.—The variations in the price level of coffee are very great, e.g., the price more than doubled between 1882 and 1887, while it halved between 1895 and 1903 (incidentally arriving back at almost the point it started from in 1882); between 1912 and 1917 the price halved.

There seems to be no doubt that these variations are almost entirely due to variations in the supply and probably to its artificial regulation.

Coal.—The curves for home and export coal show the same general tendencies until 1914, after which date the price of coal for home use fell to a low level, while that exported rose to very great heights. The rise in price of export coal has been somewhat more marked all through the period.

The short period variations point to a connexion with the "trade cycle," and to their being caused by variations in the demand.

Compared with earlier years there should have been great prosperity in the coal trade during the period 1885–1914, while even after 1920 the price level of export coal has not fallen to anything like the level of the period 1850–80.

Pig Iron.—The curve is peculiar; generally speaking there is a slight tendency for the price level to rise. The striking feature, however, is that for the greater part of the period the curve is regular and perhaps uninteresting, but on five occasions, for a very short time, the price has dashed up or down, showing that the supply-demand relationship was out of joint. These occasions were in 1854, 1873, 1899 and 1921, when the price rose for one or two years to a great height; and in 1918, when it sank to a low level.

The variations are almost certainly due to variations in the demand. From the point of view of the cost of "other" things in general and of

coal in particular, the pig iron industry ought to be in as flourishing a condition at present as during the greater part of the last seventy-four years.

Lead.—The price level has fallen by about 30 per cent. during the whole period, though the highest point actually occurs in the year 1924. Judging from the curve, one would expect a fall in the price.

Copper.—The price level fell by about 30 per cent. from 1850 to 1870, and then remained approximately constant till just before the War, after the beginning of which it fell again, this time by about 40 per cent. During the whole period, however, there were violent ups and downs. The long distance movements are probably due to the supply more than keeping pace with the demand, increasing though the latter has been. The movements of shorter wave-length are, however, due to variations in the demand, and it will be seen on reference to the curve that the rises are more short-lived than those of any other curve. The fact appears to be that generally speaking the supply of copper has more than kept pace with the demand during the seventy-four years considered, but that a sudden rise in the demand may find the market short of supplies.

Tin.—The price level shows great variation. Up to about 1895 there was not much change of level, but after this date there was a very great rise, which was followed towards the end of the War by a striking fall.

The supply of tin varies very little from year to year and the variations in price are certainly caused chiefly by those in the demand.

Cotton.—Great variation is shown; it is difficult to say what is the general trend, because the curve is so coloured by the high price during the American Civil War. There seems, however, to be a tendency for the price level to rise during recent years.

It seems unlikely that the demand for cotton clothes varies to anything like the same extent as the price of cotton; and the variations in the price level are therefore probably due chiefly to variations in the supply.

Flax is a fairly even curve till the War, when the cutting off of the supplies of Russian flax raised the price level. The smaller variations in price are also probably due to variations in the supply.

Silk fell by about 40 per cent. from 1850 to 1914; there was then a rise followed by a fall. These features are probably chiefly caused by variations in the demand, caused again by changes of fashion.

Wool, Merino; Wool, Crossbred.—These two curves are surprisingly different when it is remembered that the chief use of wool is to make clothes for comfort, and not for appearance. Since 1876-77 merino wool has shown an increase of 20-40 per cent., while crossbred wool shows a reduction of even a greater amount. No explanation can be given of this phenomenon; it

can only be suggested that since 1867-77 the increased standard of living has led to more people wearing clothes of better appearance.

Hemp, Jute.—Both of these commodities show increases in price level of about 20 per cent. over the whole period; both curves have curious points about them. Hemp seems to vary somewhat in the same way as potatoes, but with waves of longer length.

The price of jute between 1903 and 1913 is peculiar.

Hides, Leather.—Both show increases over the whole period of about 50 per cent. The curves are somewhat similar, the chief difference being that after the War there was a great fall in the price level of hides, with no corresponding fall in the price of leather. The leather industry should therefore be doing well at the present time. Variations in the demand are probably the chief factor in the changes in price.

Timber is a festoon of a curve, a high price level occurring almost at the beginning of the period and again almost at the end. Except on these two occasions the price level is very regular, showing that the supply is "there," waiting, at a price, for the demand.

Indigo.—A peculiar curve; the price level had fallen in 1913 to about a third of what it was in 1871; this was due, of course, to the manufacture of dyes from coal tar. The price level of 1913 rose by 300 per cent. by 1915 owing to the cutting off of the supply of German dyes and to the increased demand for the manufacture of explosives. By 1918, however, the price level had come down almost to its position of 1913.

Soda.—The price level has fallen owing to the increase in the supply. It looks as if the price should come down still further from the height of 1922.

Nitrate has fallen in price level by about 50 per cent. during the period. A rise from 1924 would seem to be deducible from the curve, if indeed, the low price level is not due to the increase in the supply caused by the manufacture of synthetic ammonia.

Tallow, Palm Oil have both fallen in price level by about 50 per cent. over the whole period. The levels of post-war years look unduly low.

Linseed Oil shows a general tendency to rise till the War. The short-distance variations of pre- and post-1900 are quite different in nature.

At the present time a rise seems indicated.

Olive Oil.—There is no particular general tendency; there was a phenomenal rise in 1916, the price level more than doubling by 1918. Since 1921 the price level has been very stable and at the pre-war level.

#### CHAPTER IX

# THE BANKING PROBLEM FROM THE POINT OF VIEW OF A LAYMAN 1

# BEING THE APPLICATION OF THE STATISTICAL METHOD TO THE BANKING PROBLEM

The size of the reserve of currency required by a banking system must always be a debatable point, for it varies with a multitude of causes, many of which are very nebulous, and no permanent and definite law can ever be laid down. The question has often been raised in England, but attention has been drawn away from it of late by the difficulties of American banking. It was considered sufficiently acute, however, for the London Chamber of Commerce to appoint a committee to investigate the subject, and this committee reported on July 26, 1909, that it recognized the desirability of strengthening the gold reserves of the country. There were several dissentients to the report, and the Economist criticized it "by challenging the first resolution" (i.e., the one quoted) and adding "surely the perfection of banking consists in the economy of gold." There is clearly, therefore, a great difference of opinion on the subject which seems to merit examination.

The arguments which might be urged on behalf of any change in the present arrangements seem to be two in number: (1) that a banking panic might arise in which the present reserves would be insufficient; (2) that the variations in the money rates are too frequent or too extreme.

In this paper the general position will first be stated, and this will be followed by an investigation of the two reasons quoted above which may be brought forward in favour of a change.

### The General Position

It is only proposed to deal with the commercial banking institutions of the country, so that the Post Office and other savings banks will not be considered. It may, however, be remarked in passing that the proposed suggestions for selling "Consols" at Post Offices in small amounts would make for increased safety if it induced depositors to buy them, instead of depositing their money in the savings banks.

Banking, like most other businesses, is carried on with two objects: the profit of the capitalist, and the general good of the community. Both these

objects are furthered by the economy of the use of the currency metal, subject to the limitation that the stock must always be sufficient for the calls made on it. The way in which the currency is economized is by the use of paper money, which may be roughly divided for our present purpose into (a) bank notes, which are negotiable instruments; (b) cheques, etc., in which personal credit is a very important factor. These two classes of paper money are of very different importance in different countries, and it is difficult to make any exact comparison for two reasons: (1) that national habit in the use of different forms of currency is very different, and (2) that it is impossible to obtain exactly comparable figures for different countries, e.g., a Bank of England note must be paid in gold on presentation, while a Bank of France note can be paid in gold or silver at the option of the Bank.

We are not, of course, concerned here with the absolute amount of currency existing in any country, for the amount required will be different with different kinds of population (e.g., a rural population will probably require less currency than an urban) and with different amounts of trade. In countries using the same currency metal, the amount of the currency will tend to be what is required. Such countries may be compared to a number of lakes connected together so as to form one reservoir. They may be of widely different areas, but the level in each will be the same. Similarly, in a country where there is an excess of the currency, prices will tend to rise, exports will be checked, and the currency will be exported.

We have, therefore, only to consider the proportion between the different kinds of currency which exist, but here again we are without strictly comparable figures. Some idea of the differences which exist can, however, be obtained from the values of the note issues which are in circulation. These are set out for the three divisions of the United Kingdom and for France and Germany in the following table:—

Large differences are seen to exist in the value of the note circulation (per head) of the different countries. The English rate is the lowest, while the French rate is by far the highest.

It must not, however, be supposed that a large circulation of notes (e.g., as in France) is, on account of its size, a source of financial weakness. A population which is accustomed from long habit to the use of notes will probably not hoard gold in a panic any more than a population which uses a smaller proportion. Gold, too, is generally much safer in a bank, for when stolen and melted it cannot be distinguished from any other gold.

The Bank of England note is in an almost unassailable position. Clare, in the Money Market Primer (p. 23), says:—"So utterly improbable is the contingency of a 'run' on this" (i.e., the Issue Department of the Bank of England) "department as to be hardly worth serious consideration. It might, no doubt, occur in the event of a foreign invasion, and, as a matter of fact, did once happen in the last" (i.e., the eighteenth) "century, when the news reached London that the Highlanders, under the Pretender, had advanced as far as Derby. But apart from these exceptional circumstances, public confidence in the note has never been shaken, and in time of panic, even when every other promise to pay is discredited, the circulation, instead of falling off, invariably increases."

Any doubt about the Bank of England note need therefore only be considered when the general credit of the British Government is in jeopardy.

Coming now more to the details of the general position, we have to consider first the Bank of England, comparing it with the National Banks of France and Germany, and then to investigate the Joint Stock Banks.

# THE BANK OF ENGLAND, COMPARED WITH THE BANKS OF FRANCE AND GERMANY

In each of the three countries, the United Kingdom, France and Germany, there is a national bank which exercises control over the general financial situation of the country, and is the possessor of the chief stock of gold.

All these countries are on a gold basis, though, as will be pointed out later, England is the only country which pays freely in gold whenever required. In spite of restriction, however, gold tends to flow from countries which have payments to make, and all the national banks adopt the same method of guarding their stock of gold, in that they will raise their rate of discount in case of need.

• In France and Germany, where the outside banking establishments (and trade in general) are more under the control of the central institution, other means may also be adopted. The Bank of France may exercise its option of

paying in silver, while the Bank of Germany may in other ways prevent its customers withdrawing gold for export.

.In addition to this, both these banks keep a stock of foreign bills in their portfolios, which they can use for the purpose of influencing the exchange.

In England, the raising of the Bank rate has very little direct effect. It influences the rates on many loans and that allowed on deposits by the banks, but the market rate may not follow it closely and the Bank has then to make its wishes felt by borrowing money in the open market, or by selling Consols.

It is easier, therefore, for the Banks of France and Germany to guard their stock of gold, but the Bank of England can probably exert a greater magnetic force for attracting gold from other countries in case of need. Lord Avebury replied to the Aldrich Commissioners, "a sufficient bank rate always brings gold," while the Directors of the Bank of England say, "experience seems to prove that the raising of the bank rate to a sufficient level never fails to attract gold, provided the higher rate is kept effective"; also, "the bank rate is more effective now than in 1866 because of the more rapid means of communication between financial countries"; also, "in 1907 the Bank drew gold from twenty-four countries (including British Colonies)."

Coming now to the actual liabilities and reserves of the banks, and considering first the Bank of England, the following table sets out the proportion between the "reserve" and "liabilities" on deposit arranged in ten-yearly periods, (with a final three-yearly period) and obtained from the weekly statements.

It will be remembered that the "reserve" consists of a small amount of bullion in the Banking Department and of a large amount of notes, which are backed to the extent of about 80 per cent. by gold in the Issue Department.

The liabilities consist of those on public and on private deposits, the latter being about three times the former. In making a comparison with foreign banks, these facts will have to be taken into consideration, and it remains to point out here that the position is distinctly stronger than it was. This fact would be much more apparent than it is, were it not for the abnormal period 1894–1896, when the "proportion" stood at about 60 per cent.

During the years dealt with, the average annual "proportion" has never

fallen below 39 per cent., at which figure it stood in 1878 and 1882. The highest figures reached were in 1894, 1895 and 1896, when the "proportions" were 63 per cent., 61 per cent. and 57 per cent. respectively, while for the last three years it has been at a higher figure than for any of the previous ten years.

Taking individual monthly averages, the lowest was in December, 1898, when it was 32 per cent., but during the last thirteen years the "proportion" has only fallen below 40 per cent. in eleven months, and during the last three years not at all.

In addition to this raising of the "proportion," there seems to have been a greater constancy. This is shown in the following table, which sets out the "probable error" of the monthly averages about the yearly average. The "probable error" is merely the measurement of the variation, a "probable error" of (e.g.) 20 meaning that half the monthly averages are nearer to the annual average than 20 per cent. and half further away.

It is seen that there has been a slight reduction in the variation during the last few years. It is not possible, of course, to be certain whether this is a coincidence, or whether it is an indication of a change in policy.

The greatest variation occurred in 1879 when the probable error was 4:15 (i.e., in half the months the monthly average was nearer to the yearly average than 4:15 per cent., and in the other half further away) while the lowest was in 1910, when it was 1:55 per cent.

The general conclusion, therefore, would seem to be that a distinct effort has been made in the direction of raising the proportion and possibly of keeping •it more constant.

In order to compare the position of the Bank of England with that of the Banks of France and Germany, as regards the ratio of their supply of gold

to their liabilities, the following tables have been elaborated from the weekly statements of the Banks published in the Economist:—

It will be noted that the liabilities on Government deposits are not considered in these tables, since they do not involve the same risk in times of panic as liabilities on private deposit.

The chief points of interest are-

- (x) That the Bank of England proportion is comparatively constant over the whole period.
  - (2) That the Bank of France has very much strengthened its position.

- (3) That the Bank of Germany is less strong than it was.
- (4) That all these Banks have now much the same proportion between their gold and their "active" liabilities.

## THE JOINT STOCK BANKS

As already mentioned, the banks (other than the national banks) in France and Germany are very different to those in the United Kingdom. It is not possible to go into details, but some questions of the Aldrich Commissioners. with Sir Felix Schuster's replies,1 point out the difference.

Question .- "We found both in Germany and in France the question of the amount of the reserves in specie or in bank was regarded as of little importance by the Bankers. They depend on the Reichsbank or the Bank of France for rediscount in time of need."

Answer.—" Both in France and Germany banks are much more dependent on the central institution than we are. There is practically no banking system in our sense of the word in France, nor is there in Germany."

Question .- " Have you an idea of the amount of cash, gold and silver, in the banks of England?"

Answer .- "No, it is a figure you cannot arrive at because it is not published. Silver we can eliminate. . . .

"I believe the Mint made a census this last June of the amount of gold held by the banks in England who have been asked to supply the figures and have done so voluntarily, and I believe that amount, exclusive of the Bank of England, is £35 million, but I have not seen any official statement to that effect."

The position of the joint stock banks in the United Kingdom would seem, therefore, to be much stronger than that of similar institutions in France or Germany.

Coming now more particularly to the banks of the United Kingdom, these consist of the Joint Stock and the Private Banks. The latter constitute a small and constantly diminishing group as compared with the joint stock banks, and the foint stock banks will be mainly considered.

The figures showing the position of the joint stock banks of the three divisions of the United Kingdom for the years 1880, 1885, 1890, 1895, 1900, 1905 and 1910 are set out in the following tables (page 74).

The figures are obtained from the half-yearly banking supplements issued by the Economist, and it must be remembered that they are taken from the balance-sheets of the banks. They are, therefore, only statements at a particular date, and are subject to the influence of "window dressing." This makes

In all the years, except 1880 in England and 1880 and 1885 in Ireland, practically the whole (over 90 per cent.) of the joint stock banking capital is included in the tables.

It is seen, in the first place, how much larger the banking capital of England is than that of the other two divisions of the Kingdom, being about five times as large as that of Scotland and seven times as large as that of Ireland.

The number of banks has remained stationary in Scotland and Ireland but has now been reduced to about half what it was in England in 1880. The

number of branches, on the other hand, has increased enormously in all the countries, but there has been a much smaller increase in Scotland than in the other two countries.

Taking the other columns in order, the paid-up capital has remained constant in Scotland and Ireland but has increased by about 30 per cent. in England (i.e., from £29 million to £48 million) but part of this has been due to the absorption of private banks. The only figures to hand for these are those for 1895 and onwards. In 1895 the paid-up capital and reserve of the private banks was £12 million, in 1900 £7 million, in 1905 £4.5 million and in 1910 £3.5 million, while in Scotland and Ireland there do not appear to have been any private banks during the period under discussion.

The reserves (together with the undivided profits) have about doubled themselves in England and Scotland between 1880 and 1910 and have increased at about the same rate in Ireland between 1890 and 1910. The deposit and current accounts have doubled themselves in England between 1890 and 1910, have increased during the same period in Scotland by 20 per cent., and in Ireland by about 50 per cent.

The discounts and advances have increased in England (between 1890 and 1910) by about 70 per cent., in Scotland by about 20 per cent., and in Ireland by about 50 per cent.

It is unfortunate for our present purpose that the banks do not separate the cash in hand from "money at short call." It can only be said that they do not,1 and that we therefore have to deal with the two items together. In England the amount so held has increased by about 150 per cent., in Scotland by about 10 per cent., and in Ireland by about 30 per cent. between 1890 and 1010.

It must be pointed out that the Scottish banking system differs in some important particulars from that of the other parts of the United Kingdom, one of the chief differences from the point of view under discussion being that notes, which are very popular in Scotland, are largely used as till money. This enables gold to be economized at the branches, and as long as the popularity of the note continues (and it seems to be very much ingrained, for since 1765 the note has never varied from par)2 it is questionable how far this is a source of weakness.

In both Ireland and Scotland there is a large issue of notes by the banks, part of which is "authorized" (i.e., is not backed by gold and should therefore be added to their liabilities), and part of which is backed by 75 per cent. of gold, and the amount of gold so "earmarked" should be subtracted from the cash in hand.

In England the note issue of the joint stock banks is so small that it may be disregarded.

The figures for all three divisions of the United Kingdom are set out in the following table.

We must now attempt to estimate the comparative capacity of the banks to meet a "panic," and this is best shown by the proportion between the "cash in hand and money at short call," and the liabilities on deposit, and on notes issued.

The following table sets out this proportion, notes up to the authorized issue together with one-quarter of the excess issue being added to the liabilities on deposit, and three-quarters of the excess note issue being subtracted from the "cash in hand and money at short call."

The proportion is seen to be considerably higher in England than in the other divisions of the United Kingdom, and is now distinctly higher than formerly. In Scotland and Ireland the proportion is much lower, and was very low in 1880 and 1885. This was no doubt due, in Scotland, to the troublous times through which Scottish banking had been passing, and in Ireland to the non-inclusion of the largest bank in these years.

The increase in England is probably due to the force of public opinion, which seems to have left Scotland and Ireland untouched.

It will, no doubt, be pointed out that the figures are not exactly comparable, because the Scotch and Irish liabilities include those on the notes issued. This is, of course, quite true, but on paper it would certainly seem that the Scottish and Irish position should be strengthened. In Ireland the necessity is probably less great than in Scotland, because the trade of the country is different to that of England and Scotland, in that it does not participate to nearly the same extent in the fluctuations due to the short trade cycles.

In connexion with the relative strengths of the banks, it is desired to draw attention to two further points:-

(I) The proportion between loans and deposits. This proportion is set out in the following table:-

In all cases the proportion has increased, though since 1800 the increase has been slight. From our present point of view, therefore, the position is slightly less strong than it was before, for those customers who have both loans and deposits are less in the hands of the banks than they were. Such figures can, of course, only be used with great caution, but they have been used in another place as pointing to increased strength, as in fact they may, from other points of view.

## (2) The reduction in the number of banks.

The joint stock system lends itself very well, as pointed out by Adam Smith, to the business of banking—at any rate in an old established country—for caution and trustworthiness are the main qualities required for success. The increase in size of the banks, and the absorption of the smaller by the larger among them, has probably added considerably to the strength of the banking position on account of the greater uniformity and supervision which have accrued.

Having stated the position, it remains to consider the two reasons which may be urged in favour of making some alteration in the amount of reserves held.

## I. The Necessity for Increasing the Reserves for use in Time of Panic.

A banking crisis occurs primarily through fear on the part of depositors that they will not be able to obtain, on application, the currency to which they are entitled, or, on the part of note-holders, that the notes will depreciate in value. Such a state of affairs may be caused by any event, such as a declaration of war, the repudiation of a state debt, or by mismanagement (fraudulent or otherwise) on the part of a large financial concern suddenly coming to light, all of which may bring about a sudden fall in prices of stocks and commodities.

Since the passing of the Bank Act in 1844 there have been at least three such crises: in 1847, 1857 and 1866; and each of these was brought about by over-speculation on the part of banks or other financial companies, chiefly in the East Indian trade and in railway building (both in this country and in the U.S.A.). In each of these crises the reserve in the Bank of England sank to such a low level that application had to be made to the Government of the day for permission to suspend the Bank Act in order that a further issue of bank notes might be made against securities. The knowledge that such permission had been given was in all cases sufficient to allay the panic, and on one occasion only was the law broken.

These crises are chiefly of historical interest, for very different methods prevail both in the leading financial companies and at the Bank of England, as a result largely of the experience obtained.

As an instance of this, it may be mentioned that between August 29, 1846, and January 1, 1847, the reserve at the Bank was allowed to fall from £9,500,000 to £6,500,000 without any raising of the Bank rate from 3 per cent. As regards the 1866 crisis, Lord Avebury, in reply to the Aldrich Commissioners, says: "I remember 1866 well. The Bank Act was not so well understood then as it is now, and I think the rate should have been raised sooner." On two more recent occasions—in 1878, when the City of Glasgow Bank failed, and

in 1890, when the house of Baring got into difficulties—there has been great financial strain. In 1878 the reserve stood at about \$8,500,000 (28 per cent.) at the time of the smash, and a rise in the Bank rate from 5 per cent, to 6 per cent. caused an increase of about £3,500,000 (and to a percentage of 30). In 1890 the reserve was at £13,000,000 (41 per cent. at the time of the difficulty), and fell directly afterwards to £10,500,000 (31 per cent.), though it recovered almost immediately to £16,500,000 (45 per cent.), but it was thought necessary at the time to secure £3,000,000 in gold from France and Russia,

Comparing past events with the present situation, therefore, it would seem that the present position is satisfactory. Panics have become less frequent than formerly, and the position in the United Kingdom is considerably stronger than it was. It is also probably much stronger than that of France and Germany, though it is less strong relatively. Anything else could not be expected, for France and Germany have only firmly fixed themselves on a gold basis in comparatively recent times.

Looking to the future, the difficulty is that no definite rule short of the conduct of all transactions on a cash basis can be laid down.

Any sudden accretion of strength is to be deprecated, for it would probably lead to greater rashness on the part of financial concerns, since they might indulge in greater risks on the strength of the greater reserves.

As causes of a panic we have, as already mentioned, to consider two classes of events :--

- (1) Those of a political character, such as a war.
- (2) Those due to over-speculation (or over-trading, which is much the same thing), accompanied by fraud, or due to a genuine miscalculation of future events.
- (1) The beginning of a great war would certainly cause much commotion, and might cause a panic. There is this to be said, however, that the prices of commodities would probably rise, so that there should be no fear of a panic on this account.

It would probably be different with securities, and, at any rate, with Government securities, in which banks are chiefly interested. Giffen suggested that Consols might fall 15 per cent. in the event of a great war. Those banks, therefore, which had their assets in bills and loans which are repayable at their face value rather than in securities would probably be in a stronger position.

Of course, in the event of an unsuccessful war, and possibly of an invasion, a panic might occur; but such an event, if allowed to go on unchecked, would probably involve the chief banking systems of the world, and, at any rate, the increases in the gold reserves suggested would be of as much use as building a sand castle to stop the tide.

The actual financing of the war is not here considered, since that depends purely on the capacity to raise loans, and on the power of buying and selling goods.

(2) Over-speculation has been the cause of nearly all the panics which have occurred in England—and probably of those in nearly all other countries. It may have been accompanied by fraud (as in the case of the Glasgow Bank smash), by such absence of judgment as to amount almost to the same thing, or—since all business consists largely of speculation—by a genuine and legitimate miscalculation of the course of future events.

No rule, of course, can ever be laid down to prevent fraud or carelessness, without hampering trade, and the true remedy seems to lie in publicity. It would therefore be advantageous to compel all banking institutions to issue periodical statements more frequently and with fuller particulars than at present (as has often been suggested), not so much with the idea of increasing the average reserves held as of forcing the weaker into line with the stronger institutions. These returns should, if possible, deal with the average figures over periods and not with those at a particular date, so that the effects of "window-dressing" would be apparent. It is at the other end of the scale, apart from the world of politics and personalities, that some advance may be expected, for variations in prices are largely the result of very commonplace causes, though these may be none the less difficult to measure. In attempting to advance, however, direct experiment is out of the question, and we have usually to be content with indirect figures. In dealing with these, the correlation method, which has been brought forward and popularized by Professors Karl Pearson, Edgeworth and Bowley, and by Dr. Yule and Mr. Hooker, is a of great value-for with the use of it one can measure definitely the closeness of the relationship between two sets of figures, and can calculate how much of the one figure corresponds to how much of the other.

The method consists of plotting out the two series of figures on squared paper, the calculation of the correlation co-efficient from the diagram obtained being comparatively simple. One obtains figures varying between — 1-00 and + 1-00, the former indicating that the two sets of figures are as closely connected as possible (perhaps through some intermediate cause) in the negative sense (e.g., as for instance the length and diameters of a number of pieces of wire each drawn out from the same weight of metal), the latter the same thing in the positive sense (e.g., the diameter and circumference of a number of circles). Any intermediate figures may be obtained, so showing an absence of relationship.

This method provides us with a means of approaching economic problems

inductively and not deductively, for if two series of figures appear to be closely related to each other sufficiently often there is a strong probability that the same relationship will occur again and again—i.e., that there must be a connexion between the figures as cause and effect, or that there must be a common cause.

The following are examples of the use of the method in this direction. The increases and decreases in the average market rates for money in London, Paris, Berlin, and New York <sup>1</sup> have been correlated with the increases and decreases in the exports and imports per head of the population from year to year of the United Kingdom, France, Germany and the U.S.A. respectively, and the following co-efficients have been obtained:—

Now, there are not very many cases here, so that one cannot use the inductive method of argument with great certainty, but there are sufficient to enable one to suggest very strongly that the variations in the rate for money are connected in some way with the variations in trade—when imports and exports increase, the rate for money increases. Every one will probably say that this is well known—but there is a further point which may not be so well known, and that is that the variations in the money rate vary more closely with the variations in the imports than with those of the exports. This is probably due to payments having to be arranged in the country to which the goods are coming.

Even if the correlation method provided no new discoveries it would be very valuable on account of the exactness with which one can measure relationships. Such relationships may be generally known but they are so often masked by the fact that people are nearly always more influenced by the nearer rather than by the more remote event. Also any such knowledge is only obtained by years of study, the fruit of which is largely lost on the retirement of the individual from active service. Correlations require a great deal of care for their correct interpretation, but much of the routine work can be done on a system, and more attention could be given to other matters by the intellect at the head of affairs.

From the point of view of this paper, the object of the correlation method would be to secure a relationship from which an indication as to the course of future events could be obtained. We have very few indications of such a kind at present, because very little work has been done on the subject. The following is, however, a very striking instance.

J. P. Norton 1 has shown that the variations in the reserves of the New York bank correlate with the variations in the loans by the banks to the extent of  $+ \cdot 49$ , with the loans of a week later  $+ \cdot 62$ , with the loans of two weeks later  $+ \cdot 87$ , with the loans of three weeks later  $+ \cdot 96$ , and with loans of four weeks later  $+ \cdot 91$ .

Now, perfect correlation, as already mentioned, would give a correlation co-efficient of + 1.00, so that the relationship between the reserves of the banks and the loans of three weeks later is almost as close as it could be, and anyone requiring to know the loans of three weeks later could calculate them with practical certainty from the reserves.

In another case, R. H. Hooker (Royal Statistical Society's Journal, 1901. p. 491) has shown that for the years 1876-95 the variations in the bankers' clearing correlate to the extent of +92 with the variations in the marriage rate of a year later, while the variations in the marriage rate correlate to the extent of +90 with the exports of half a year earlier. It therefore seemed probable that the bankers' clearing could be used as a means of predicting the variations in the marriage rate, and in the other figures which vary in the same way, e.g., the London market rate.

With this object the increases and decreases (per head of the population) in the London Bankers' Clearing House returns have been correlated with the increases and decreases of the following year in the London Market rate, Sauerbeck's general index number and his index numbers for coal and iron. The results are set out in the following table:—

These co-efficients would lead one to the conclusion that about 25 per cent. of the variations in the market rate and the index numbers are connected with variations in the Bankers' Clearing House returns of the year before, i.e., four independent correlations of + 5 would account for all the variations in, e.g., the market rate. From these co-efficients the "regression" lines can be calculated, and as an example the money rate may be taken.

Over the years considered, the average rise per year in the bankers' clearing per head of the population has been £ 39, while averaging all the rises and falls there has been an average fall in the market rate of .005 per cent. Calculating from the correlation co-efficient, an increase of £1 per head of the bankers' clearing is found to correspond to an increase of .503 per cent. in the money market rate of the year after. Predicting from these figures for all the years, and comparing the result so obtained with the actual market rate, there is found to be a probable error of .508 per cent. (i.e., half the differences 1 will be less than this and half greater), as compared with a probable error of .78 per cent., which is what would have been obtained if the average rate had been predicted each year.

It may perhaps be thought that this is a very short way towards the \*desired object, and this is of course true. It is probable, however, that further work concentrated on particular points would make it possible to obtain much closer predictions.

## II. The Variations in the Rate for Money

The rate for credit—or as it is commonly called, for money—depends of course on the relative supply and demand, and with perfect knowledge and trustwerthiness should not be affected by the amount of gold held. Practically, it is found that some gold is required, and it is necessary to increase it whenever the credit in circulation increases. This happens in times of active trade, and since the supply of gold is a much more definite object than the demand for credit, public attention is focused much more strongly on the former than on the latter.

The control of the gold supply is in the hands of the Directors of the Bank of England, who vary the Bank rate and cause money to be cheaper or dearer as the situation may require. In former times the market rate followed the Bank rate very closely, for the general money market was nearly always in the hands of the Bank. At present, however, on account of the increase in the number of "outside" institutions, this is not the case, and the only direct effect of an increase in the Bank rate is to increase the rate demanded by the banks on most loans and the rate they give to depositors. The Bank of England, therefore, has sometimes to obtain control of the situation by borrowing money in the open market, or perhaps by selling securities whereby the floating stock of money is diminished and the required effect is produced.

Now, the rate for money is subject to two kinds of secular variation, one extended over several years—over what is generally known as the "short trade cycle"—and the other within the year itself.

As regards the former, Beveridge writes (in Unemployment, p. 41): The fluctuation in industrial activity is not limited to particular trades, it represents alternate expansion and contraction in the general demand for labour, and is only one aspect of a still more general ebb and flow dominating the economic life of the nation." As is well known, the rate is low in times of bad trade and high in times of good trade. It might be possible to reduce these variations to some extent by accumulating gold when the rate is low, so that it would be there for use when trade became more active. It would, however, be extremely difficult to know when to begin the accumulation and when to begin the dissipation (particularly as the length of a "cycle" cannot yet be predicted), and it would seem to be distinctly wrong in principle to do anything in this direction, for the differences in trade between the good and bad times would be accentuated. At present the low rates in the bad times are an encouragement, while the high rates in times of activity discourage excessive speculation.

There is no doubt, of course, that great fluctuations in the rate for money are a disadvantage to trade in general, as pointed out by Sir R. H. Inglise Palgrave (in *The Bank Rate and the Money Market*, p. 195). There can be no doubt that to the borrower, and every man of business practically must at times be a borrower, this high range of fluctuation has been a very serious disadvantage."

It will be useful, however, to show what the fluctuation in the market rate has been in London as compared with the other centres, and this is shown in the following table:—

It is seen that the average rate has been slightly lower in Paris than in London and somewhat higher in Berlin and in New York. The variation from year to year is also lower in Paris, while there is practically no difference between London and Berlin. New York shows more variation.

It must be pointed out that the variations in the stock of gold in reserve have comparatively little to do with these figures, for, as already pointed out, it is the variations in trade which have to be chiefly considered.

England has by far the largest external trade and almost certainly the largest internal trade, and it is conducted with much greater freedom than in France and Germany, where the Banks of Paris and Berlin can to some extent prevent excessive trading by refusing to grant accommodation. Though English trade may therefore be handicapped by greater variations in the rates for money, it is not likely that any of those involved would wish for a change to the French or German systems, which would probably also conduce to the removal of the financial centre of the world from London.

There is, however, one change which has been suggested, which might be useful as a means of preventing rises in the market rate when the withdrawals of gold, which cause them, are due to foreign demands, and that is that a stock of foreign bills should be kept by the English banks.

This is suggested by Sir R. H. Inglis Palgrave in The Bank Rate and the Money Market. "The English banker or bill broker has, as a rule, little knowledge of, or experience in, transactions in foreign bills. Hence there are very few, it might almost be said there are hardly any, foreign bills held in England; while the reverse of this is the case on the money markets of the continent of Europe, where English bills are very generally held, and form a most useful reserve to those who hold them, in the case of demands arising from an adverse rate of exchange."

The same change was advocated by Lord Swaythling in his interview with the Aldrich Commissioners.<sup>1</sup> "Why not imitate Germany, etc., and hold a portfolio of foreign bills . . . and hold them . . . until the danger occurs

of losing inconvenient sums of gold?" [This] "I have for many years urged upon the Bank of England; but they have always been opposed to it—at least not opposed to it, because in theory they approve of it—but in practice they are very difficult to move."

It would seem that the change suggested might tend to the reduction of many of the smaller fluctuations in the market rate.

With regard to the variations in the money rates within the year, it is well known that the rate is highest in the Autumn, that it is usually rather high till about April, and that in the middle of the year it is much lower.

The average monthly rates for London, Paris and Berlin are set out in the following table, together with the probable error:—

The variation is seen to be somewhat greater in London, but it shows much the same movement in all three countries. It is due to a large extent to the accommodation required for the gathering in of the harvests, and it would seem that the accumulation of gold in the summer by any particular market might reduce somewhat the variation in the rates from month to month in that market. The average rate would probably not be affected—only the variation.

#### Conclusions

Two reasons may be brought forward for increasing the stock of gold held as a banking reserve in the United Kingdom.

- (r) That a panic might arise in which the present reserves would be insufficient.
- (2) That the variation in the money rates should be reduced.

Comparing the United Kingdom with France and Germany, the national banks have much the same proportion of gold to liabilities (leaving out the liabilities on deposit to their respective Governments).

The general position in the United Kingdom is, however, probably much stronger than that in the other countries, for the joint stock banks have a considerable stock of gold and are more independent of the central institution than in France and Germany.

Comparing the present position with the past, in the United Kingdom the Bank of England has increased its proportion of reserve to liabilities, and the proportion now seems to be less subject to fluctuation.

The joint stock banks also seem to have strengthened their position to a considerable extent, but the Scotch and Irish banks hold a much smaller proportion of "cash in hand and money at short call" to their liabilities than the English banks.

This is due to a great extent to the existence of their liabilities on note issues. Such liabilities may require less backing with gold than those on deposit accounts, and differences in the nature of the trade in the different countries may justify the different ratios, but on paper the position in Scotland and Ireland may require strengthening to some extent.

Panics are caused by a sudden fall in the prices of stocks or commodities, which may be brought about by a political event, such as the declaration of a war, or the repudiation of a State debt, or by over-speculation suddenly coming to light.

It is impossible to guard against the effects of all possible political events, such, for instance, as a war between two Great Powers, which might involve the repudiation of both their national debts. It can only be said that the United Kingdom would probably be in at least as good a position as France and Germany for meeting such an event, and that the increases in the gold reserves suggested would be of very little use.

Parics in England have nearly always been caused by over-speculation accompanied by fraud, by bad management, or by a legitimate miscalculation of the trend of future prices, etc.

Fraud cannot be prevented without imposing undue restrictions on trade, and the true remedy for the prevention of panics due to such a cause seems to be the periodical and frequent publication of statements of liabilities, etc., with the idea not so much of causing the stronger banks to make any change as of forcing the smaller institutions to come into line with the larger.

All trade involves speculation, and a panic may therefore be caused by a perfectly legitimate miscalculation of the course of future prices, etc. Any method therefore by which future prices, etc., can be more accurately predicted will tend to less trouble on this score, and in this connexion the correlation method brought forward by Professor Karl Pearson and others may be of great use. By this method it is possible to calculate the closeness of the relationship between two sets of figures and to calculate how much of the one corresponds to how much of the other. As an instance, it is pointed out that the increases and decreases in the amount cleared at the London Bankers' Clearing House (per head of the population) can be used to predict to some extent the market rate for money, Sauerbeck's index numbers and the prices of coal and iron of a year afterwards. The prediction is at present not very close, but it can probably be improved.

As regards the money rates, it is pointed out that the market rate for money varies (a) from year to year, being higher in times of good trade and lower in times of depression; (b) within the year, being highest in the autumn and lowest in the summer.

The average rates for the years 1878–1908 in London, Paris, Berlin and for 1884 to 1908 in New York are given, and Paris is shown to have the lowest rate. London and Berlin are much the same, and New York is the highest. The variation in Paris is also the lowest, while London and Berlin are again almost the same. It is pointed out that the rates do not depend so much on the stock of gold kept as on the differences in trade in the different countries and on the fact that in Berlin and Paris gold is sometimes difficult to obtain for export. Any change in the system in use in England is to be deprecated, because extreme money rates tend to either encourage trade in times of slackness or to discourage it in times of speculation.

Within the year it is shown that the variation is the greatest in London, and it is suggested that the extremes might perhaps be reduced by keeping the rate higher in the summer, so as to cause the accumulation of gold for dissipation in the autumn.

It is also suggested that some of the smaller variations in the money rates might be obviated by the Bank of England keeping a stock of foreign bills (as has been suggested by Lord Swaythling and Sir R. H. Inglis Palgrave) by the sale of which it could, in case of need, prevent the temporary withdrawal of gold.

#### CHAPTER X

#### THE FORMATION OF A CENTRAL BUREAU OF INFORMATION 1

MODERN industry, looked at either from a parochial, a national or an international point of view, seems to be singularly ill-equipped with information, and this is, perhaps, surprising when the large size of many business organizations is remembered. It is true that there are trade journals, often dealing adequately with individual branches of industry, but no attempt is made as a rule to examine the statistics provided, and nowhere are the statistics for industry as a whole considered. We have, of course, Government Departments such as the Board of Trade, but these are handicapped in many ways by being Government Departments, though in other ways they may be in an advantageous position on this account. On the one hand they are often empowered to compel returns to be made to them, and this is, of course, an advantage; but on the other hand they can only issue as a rule plain, stereotyped statements of fact, and more than this is required. This latter difficulty is got over to some extent by the issue from time to time of papers by departmental officials, such as those by R. H. Hooker and J. C. Stamp, which are models of "trade research." Such research should, however, be permanent and continuous; and, further, it should be under the control of those who have to deal with actual commercial problems, who know what they are and are in a position to make use of the work done.

It might be held that work of this kind is a matter for the State, but in addition to the general undesirability of asking the State to increase the scope of its functions, no commercial organization is likely to make full use of a bureau such as is suggested unless it is, at any rate to some extent, under its own control.

Industry should "help itself" by forming a bureau. This might be undertaken by some such body as the Federation of British Industries, though it would seem to be preferable that it should be formed by one or by a combination of the big banks. The banks deal with the trade of the country as a whole and they are in a position to take a general view of it. They have almost endless information at their disposal from which material could

be provided for examination, and combined, they would have a more homogeneous point of view than, for instance, an alliance of organizations of different kinds, such as those which constitute the Federation of British Industries.

With a bureau under their own control it is to be hoped that the individual banks would feel themselves able to disclose to the bureau their "total" figures for different kinds of transactions, so that, for example, the total amount of money spent on foodstuffs at any time could be calculated. The staff of such a bureau would probably not be a nett addition to the staff of the banks, for the work proposed must be done to some extent at the present time by each bank. Duplication thus takes place and this would be avoided, for in place of several independent attempts to arrive at the same "statistic" or "fact," less total time would be concentrated on one attempt and with probably more accurate results. And there can only be one fact! A further concomitant advantage would be that such a bureau, if successful, would probably grow considerably, and as "brains" would certainly be required, some outlet would be provided for some of the intelligence which must exist in large quantities in the banks. Such intelligence is usually difficult to employ in large organizations, for obvious reasons, but the bureau would provide an almost unlimited field for it without "seniority" and other difficulties, for the officials of the bureau need have no executive authority.

The first object of the bureau would be to collect and arrange straightforward information after the manner of the Board of Trade, etc., but accelerating the returns as much as possible and checking them where necessary. Statistics would also be obtained for the chief industries of foreign countries, and it is most important that these should be considered as a whole for each trade, 'so that an international survey of each trade could be made. The second object would be to examine the statistics obtained by the comparatively new statistical methods discovered by Professor Karl Pearson and others, with a view to discovering relationships, in the nature of cause and effect, and to measure definitely the closeness of such relationships as are already known.

In attempting to discover new relationships by an examination of statistics, the bureau would be adopting, for economic science, the "inductive" method -that of arguing from the particular to the general. At a certain stage in the history of most sciences such a method is useful, and it is particularly applicable to economic and kindred sciences where the causes are so complicated as to baffle the "original" thinker. This method is not usually popular, for it involves doing a great deal of work without following any hypothesis. The work of R. H. Hooker on the connexion between the weather at different periods of the year and the resulting crops is a very good example of the nature and value of this method.

In attempting to measure the value of the "laws" which have been evolved by the deductive method, a method which has, up to the present, been that almost exclusively used in the science of political economy, the work would be complementary to that of the so-called "classical economists" who have evolved "general laws." By the use of the new method it would be possible to state definitely the value of many of the "laws" that have been laid down and we shall be spared the intellectual ignominy of reaching the conclusion frequently that theory and practice do not agree and that one must therefore be wrong.

It is almost superfluous to name the many questions that the business world as a whole requires answering. Many concern the future, and such questions can only be answered by finding out from the statistics of the past what are the relationships that have obtained. The administration of an individual concern cannot have much opportunity as a rule for correctly measuring either the details of the past or those of the world at large and it has usually quite enough to do to concern itself with its own local affairs. And yet the general course of trade in, for instance, the U.S.A., and the probable effect of variations in, for instance, the price level and in the prices of stocks and shares, may cause a complete eclipse of a business, however well managed it may be.

Without a knowledge of the figures from the banks, etc., that could be placed at the disposal of the bureau, it is impossible to state what results would be likely to be obtained. Even without such data, however, results have been obtained, and have been published in recent numbers of this magazine [i.e. The Bankers Magazine], which indicate that the results are likely to be extremely valuable from a practical point of view.

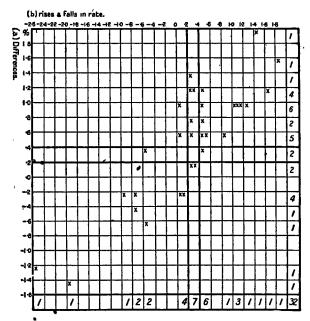

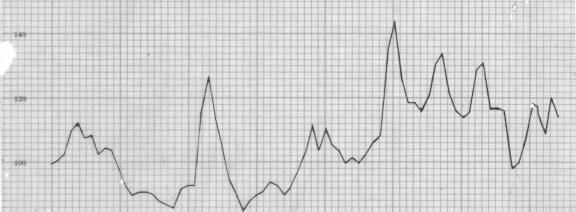

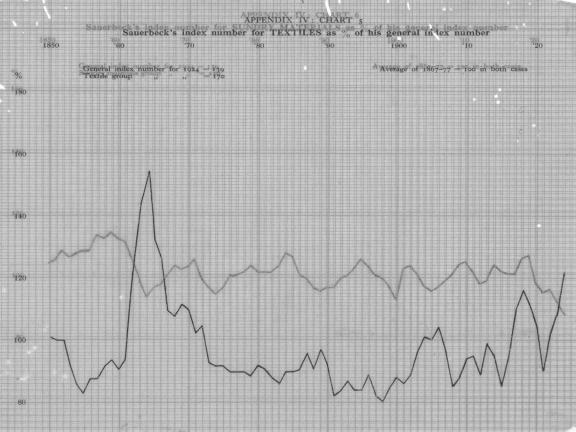

Sauerbeck's index number for SUNDRY MATERIALS as % of his general index number 1850 '60 1960

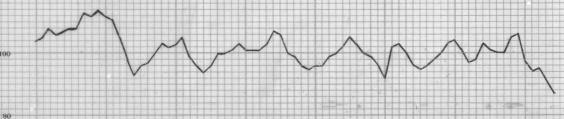

Sauerbeck's index number for AMERICAN WHEAT as % of his general index number

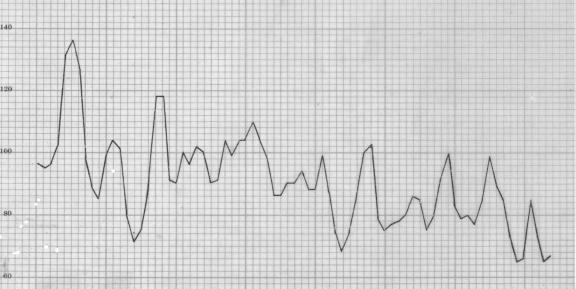

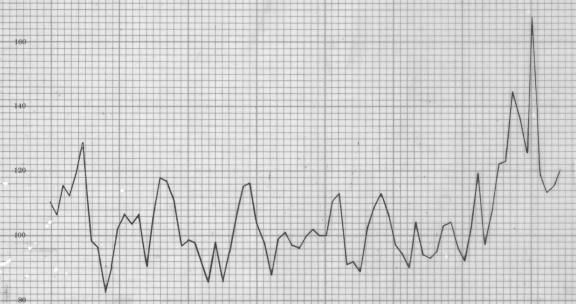
