Repatriation Of Indians

In spite of repeated requests by Indians who are entitled to be repatriated to India in accordance with the Immigration Ordinance. Chapter 208, large numbers of Indians have not been able to secure return passages to India.

The last ship to India in 1938 took 865 Indian repatriates - 525 men, 239 women and 101 children-We are advised that 1,186 actually registered their names but 321 did not find accommodation. Since then, owing to war conditions it was not possible to make further arrangements but now that it is well known that the European War will be over quite soon, Government should invite applications from those who are entitled to return to India and, not to wait until the majority of possible repatriates die out. We have no doubt that shousands of applications will received.

It seems clear to us. that it had been the policy of this Government, to repatriate as small a number as possible periodically, so that the majority of those entitled to repatriation would either die or become too old or impecunious to return to their Motherland. It must be remembered that Immigration started in 1838 and ended in 1917, and since the latter year only a small number were afforded the opportunity to take advantage of their legal right to return to India. During the first

few years of the first Great War Immigrant Ships sailed from India with thousands of indentured labourers, and we can see no great reason why, as soon as the present European War is over, every effort should not be made to organise a regular steamship service between India and the West Indies whereby this Government should carry out its legal responsibility.

We wonder if our leaders in India will be prepared to continue to take no real and abiding interest in the welfare of their Nationals in these parts. So far as we are able to gather our brethren in Trinidad, Surinam and Jamaica are also anxious to have an opportunity to return to India, and apart from this, other Indians who have not the legal right to return, yould like to travel to our Motherland in the interests of business, education, etc.

Perhaps our National Leaders are not aware of the actual conditions under which our people continue to live and labour in this Crown Colony. We shall endeavour to put the position to them as clearly as possible.

The Moribund Legislative Council of B G

Ten public meetings were belo recently in different parts of the colony by the seven joint organisations who are engaged in the matter of obtaining Universal Adult Suffrage forthwith for British Guiana.

It was revealed at these meetings that the majority of elected members of the Legislative Council did not consult their constituency.

It is simply shocking to find that men who are supposed to represent a given area of the colony, have not had the common courtesy to consult the people of that area on such a major matter; which on investigation has been found to be contrary to what they have expressed. This is a defi-nite breach of faith, especially when the fact is taken into account that the elected members are now sitting for 9 years in the Legislative Council without an election, four years more than what they are entitled to. The viewpoint or the metter the Legislative Council on the matter The viewpoint of the members of of Universal Adult Suffrage therefore is not more than that of their individnal opinion and as such cannot carry much weight.

Mutual Aid Agreement With U.S.A. And India

The Government of India nevertheless have accepted the principles underlying Mutual Aid, and continued to receive lendlesse goods_and services from the U.S.A., and to grant Reciprocal Aid in return, This Reciprocal Aid now takes three main forms:

(a) Reciprocal Aid to the U.S. forces in India in the shape of rations, clothing, ordnance and other stores, the fields and connected works, and the provision of transportation, communication and maintenance facilities of various kinds.

(b) Reciprocal Aid to U.S. shipping using Indian ports, in the shape of port dues of all kinds, ship repairs and so on.

(c) Available raw materials and available foodstuffe such as tea, require ed by the U.S. Government directly for war purposes.

The arrangements for granting Reciprocal Aid of the first two kinds are working smoothly, but the administrative arrangements governing Reciprocal Aid for raw materials are still being worked out

The estimated cost of Reciprocal Aid to be afforded the U.S.A., on present information, during the years 1943-44 and 1944-45 is about Re. 26 crores and Rs. 43 crores respectively and provision has been rentatively included in the Revised and Budget Estimates of the years concerned for these sums, total cost of such aid up to the end of 1942-43 was Rs. 12; crores so that the estimated progressive total

It is not possible at present to say what the total financial benefit that India will receive as a result of lendlease supplies from the U.S.A. during the same period will amount to, because the allocation of lend-lease goods and services received in India between the Government of India and H.M.G. has not yet been determined. Assuming that iend-lease goods and services continue to be received in India at approximately the same rate as is obtaining now, the total value thereof up to the end of 1944-45 may be estimated to be of the order of Rs. 350 crores. The allocation of these benefits between H.M.G. and the Government of India is a matter of great complexity since it can only be based on the actual use to which the goods and materials will have been put and the classification of that use in terms of measures for which H. M. G. and India are respectively liable. On such investigation as we have been able to make up to the present it seems reasonable to assume that India's share in these benefics will not be less than one-third. —"INDIAN INFORMATION"

QUESTION OF COMMUNAL UNITY

"ONLY GOD ALONE KNOWS MEN'S HEARTS"

Mr. Gandhi has offered to meet Mr. Jinuah, the president of the All-India Moslem League, and the two will probably meet in Bombay to dis-ouss the possibility of an agreement between India's two great communities, the Hindus and the Mosleme.

Details of the proposed meeting are contained in the text of a letter from Mr. Gandhi to Mr. Jinnah dated May 4, 1943, which was stopped by the Government of India last year in accordance with the policy of allowing no contact between Mr. Gandhi and

When, some time after my incaroration, the Government asked for a

Whenever it comes to me I read it carefully. I have followed the proceedings of the League session, reported in the "Dawa" columns.

I noted your invitation to me to write you. Hence this letter. welcome your invitation Lauggest our meeting face to face rather than talking through correspondence, but I am in your hands. I hope this letter will be sent to you and if you agree to my proposal that the Government will let you visit me.

One thing I had better mention. There seems to be an " if " about your invitation, Do you say I should write only if I have changed my heart? God alone knows men's hearts. I would like you to take me as I am.

Why should not both you and I approach the great question of communal unity as men, determined on finding a common solution, and work together to make our solution acceptable to all who are concerned with it or who are interested in it?

Repatriation Of Indian Right ()f A Return Passage

CONTINUED FROM LAST ISSUE

ent or wife of any immigrant entitled to a return passage shall, whatever may be the period during which that person has resided in the Colony, be entitled without payment to be provided with a reiurn passage passage to the port in India to which his or her natural or adoptive parent or husband returns, in the same ship wherein he returns.

In a case where the immigrant becomes destitute or disabled he is entitled without payment to be

provided with a return passage.

The Cost to the immigrant varies according to the time he exercises his right to a return passage. The sum which we are able to discover was paid by immigrants falling within the third category mentioned above was \$60; -or thereabouts,

Before such an immigrant, can exeroise his right to a return passage he must in accordance with the provisions contained in Section 181 of the Ordinance apply for a certificate of exemption from labour which will entitle him to apply to the Agent General for a passport, When such passport is obtained the immigrant can demand a return passage and Government would have no option but to afford a return passage to him. The right of the immigrant absolute,

By Section 193 of the Ordinance any such immigrant or anyone of those persons becoming entitled to a free passage to India in the same ship with such immigrant may, in consideration of a grant or transport of land or of a money payment, or of all or any of those considerations, surrender his right under the Ordinance or any other Ordinance to a return passage. There is nothing in the Section which compels Government to provide land or a money payment' if it can provide the immigrant with a return passage, failing which. however the immigrant is sutitled to ask for a grant or transport of land or a money payment, or of all or any of those considerations. This view is strengthened by the provisions contained in Section 195 where when anyone surrenders his right to return passage in consideration wholly grant or in part of any transport of land, a statement shall be inserted in the grant or transport that the land is granted or transported. in complete or partial satisfaction (as the case may be) of that person's right to a return passage. The value of the land to be transported in our opinion must be based on the cost, to be ascertained, of the passage at the time when the immigrant first acquired the right to be provided with a return passage, half of which in the case of Georgetown a male immigrant and two-thirds in

Everyone who is a child or depend- the case of a female immigrant represent Government's obligation, with respect to those immigrants introduced from the 1st day of October, 1898.

The immigrant cannot, in our view, postpone the right acquired and await a favourable opportunity when the steamship fares have been increased to demand his equivalent in land value or money payment based upon the cost of passage at that time.

Such land value or money payment is to be based on the cost of the passage when the right to demand a

return passage first arose.

We would suggest to Government that a soneme of assisted land settlement as an alternative to repatriation to India should be inaugurated, the cost of purchasing the lands, laying them out and draining them should not in any case exceed the sum equivalent ; to the cost to Jovernment of the proportion which Government have to contribute towards the return passage.
