NOTES AND NEWS

For The Peace Of The World

N the House of Assembly on Tuesday June 16 General Hertzog made a powerful speech in support of the authority of the League of Nations. He said: "If you do not want the League of Nations, then you must go back to a state of affairs under which every four or five nations ally themselves and with only one result, namely, to make war to-morrow or the day after against another four or five nations. The League of Nations must fulfil its obligations. Here you have the case of Italy legally declared the aggressor and it was, and is, the duty of every other member, who wants the League of Nations to continue and who wants to maintain the peace of the world, not to go back on its obligations, even if Italy eventually goes to war.' If the big powers like England and France should say that they are not prepared to go to that extent, then it does not remove our own obligation to support the League of Nations until the last. If the League must fail it must not be because we were unfaithful to our pledge. If the League fails, as it will fail in the contingency I have mentioned, then nothing will prevent a world war within the next twenty years.

If England, France and other Powers do their duty and declare that for the peace of the world they are prepared to stand by their obligations, there may be a war, but it will be a war with only one people.

General Hertzog pointed to the signs of alliances that were taking shape and that might endanger the peace of the world. He added, "I am not prepared in these circumstances to recommend that South Africa should do anything less than its duty. If it should happen that the League falls to pieces, we shall at least have this satisfaction that the world will know that we were not among those who ran away from duty."

Repatriation Of Indians

Interesting information relating to the assisted emigration of Indians from the Union to India was given by Mr. P. F. Kincaid, Commissioner for Immigration and Asiatic Affairs and Mr. P. I. Hoogenhout, Secretary for the Interior, to the Select Committee on Public

Accounts. Replying to Mr. Eaton, Mr. Hoogenhout said the number of repatriations had fallen off very considerably. Mr. Kincaid said that for the year ended December 31, 592 souls went to India under the scheme. Of that number 376 belonged to the Indian immigration class of Natal and the balance went from various provinces so that there had definitely been a considerable falling off.

Mr. Eaton: In spite of the Round Table Conference and the promise given by the Indian delegation?

Mr. Hoogenhout: Yes, and I ascribe it to the fact that there are very few of the original indentured Indians remaining who are prepared to go back. Where, however, the older ones go back they take the younger members of the family with them to maintain the family unit

Mr. Eaton: Would you be prepared to say that the whole question of repartriation is more or less ineffective?

—I think it has a good effect to keep the Act alive. After all, of the 592 who left last year a considerable proportion were young people who, in due course would help to increase the population.

Mr. Eaton: Is the Department active or passive. The Department is passive. There was a complaint that it was too active in its recruiting.

Mr. Hoogenhout told Mr. Eaton that the total number of men, women and children repatriated from 1927 was about 15,000. Mr. Eaton: The bulk of the people were the elderly class of women who were too old to bear children. What about all the children?—The families take their children when they go.

Mr. T. M. Wadley: A great number left under the old scheme than are leaving under the new?

Mr. Kincaid: Up to July 1927, the number was 22,000.

Mr. Wadely: And have these people stayed away?—Yes, there is no provision for their return.

Mr. Eaton: You cannot say why the Department is passive and not active? It is a matter of policy. There were representations made to the Government

that the recruiters misrepresented the position to Indians.

Mr Hoogenhout: I have the other figures under the old Indian Immigration Trust Board of Natal. Of the 152,641 Indians who entered Natal under the indenture scheme 58,354 returned to India at the expense of the Trust Board and Bureau.

A New Race In Abyssinia?

A new race may be born as the result of the Italian conquest and occupation of Abyssinia. In a letter to the Times Professor J. B. S. Haldane warns readers of the consequences for human biology of Mussolini's imperialist adventure in North Africa. "The Duce" he says, "proposes to settle a quarter of a million Italian families in that country They are to settle as peasants. It can be predicted that they will interbreed with the Ethiopians. - This is inevitable when European settlers are on an economic level not much above that of the natives. It is also inevitable if the Italian Government attempts to live up to the Roman policy embodied in Claudian's line, "Haec est, in gremium victos quae sola recepii" ("She alone takes the conquered to her bosom.")! The same Roman Policy will involve a far closer Union between Italy and Italian Ethiopia than exists between Britain and her Dominions, and a larger interchange of populations, "We must therefore look forward to a considerable influx of African blood into Italy. It would be impertinent for a biologist to predict the historical consequences of such a event. But I do not think that it would be negligible for the future of Europe." Some Italians seem to be aware of the dangers of miscegenation in Abyssinia. The Messageron a Rome newspaper, advocates a colonising policy of segregation of white and coloured populations and urges that only married Italian men should be sent with their wives to colonise the new empire. In the meantime the huge Italian expeditionary force remains practically intact in Abyssinia. Home leave is strictly limited to special cases. In the circumstances it is humanly possible that biologists (if not historians) will soon have enough data to work on.

India? India is admittedly over populated Until recent times she had outlets for her emigrants in South and East Africa The Dominion Government in South Africa and the British Government in Kenya have plugged. these outlets, and closed Africa to Indian settlement and citizenship Have not our Indian fellow-subjects a better claim for consideration in any such controversey as this than Germans,

Foles or Italians? What are Lord Linlithgow and Lord Zetland thinking on this point?

Assembly's Millions Of Words

Hansard reveals that during the past session of Parliament 3,750,000 words were officially recorded as having been spoken in the Assembly alone. Of that number 600,000 words were spoken during the joint sitting on the Native Representation Bill. If the joint sitting is not taken into account the total would, therefore, be 3,150,000, which was exactly 100,000 fewer than last session, which lasted 95 sitting days compared with 80 this year. The record number of sitting days for one single session is 109

Birth Control

N view of the fact that there are thousands of readers in South Africa who are interested on this aspect of our social question we give below the considered opinion of Mahatma Gandhi as it appears in Harijan He says: From a serious discussion I had with a sister I fear that my position on the use of contraceptives has not yet been sufficiently understood. My opposition is not due to their having come to us from the West. I thankfully use some western things when I know that, they benefit us as they benefit those in the West. My opposition to contraceptives is based on merits.

I take it that the wisest among the protagonists of contraceptives restrict their use to married women who desire to satisfy their and their husbands' sexual appetite without wanting children. I hold this desire as unnatural in the human species and its satisfaction detrimental to the spiritual progress of the human family. As against this is often cited, the following testimony among others of Lord Dawson of Penn:

"Sex love is one of the clamant, dominating forces of the World. Here we have an instinct, so fundaimental; so imperious that its influence is a fact which has to be accepted; suppress it you cannot, You may guide it into healthy channels but an outlet it will have,. and if that outlet is inadequate or unduly obstructed, irregular channels will be forced. Self-control has a breaking point, and if in any community-marriage is difficult or t late of attainment, an increase of irregular unions will inevitably result. All are agreed that the union of body should be in association with union of mind and soul;

all are agreed that the rearing of children is a pre-eminent purpose. Has not sexual union over and over again been the physical expression of our love without thought or intention of procreation? Have we all been wrong? Or is it that the Church lacks that vital contact with the realities of life which accounts for the gulf between her and the people? Authority, and I include under authority the churches, will never gain the allegiance of the young unless their attitude is more frank, more courageous, and more in accordance with realities.

Sex love has, apart from parenthood, a purport of its own. It is an essential part of health and happiness in marriage. If sexual union is a gift from God it is worth learning how to use it. Within its own sphere it should be cultivated so as to bring physical satisfaction to both not merely to one. The attainment of mutual and reciprocal joy in their relations constitutes a firm bond between two people and make for durability of their marriage tie: More mariages fail from inadequate and clumsy sex-love than from too much sex love. Passion is a worthy possession; most men who are any good are capable of passion. Sex love without passion is a poor lifeless thing. Sensuality on the other hand is on a level with gluttony, a physical excess. Now that the revision of the Prayer Book is receiving consideration, I should like to suggest, with great respect, that an addition be made to the objects of marriage in the Marriage Service in these terms: "The complete realization

of the love of this man and this woman, the one for the other"

I will pass on to consider the all. important question of birth control. Birth control is here to stay. It is an established fact, and for good or evil has to be accepted. No de nunciations will abolish it. The reason which led parents to limit their offspring are sonetimes selfish, but more often honourable and cogent. The desire to marry and rear children well equipped for life's struggle, limited incomes, the cost of living, burdensome taxation, are forcible motives; and, further amongst the educated classes there is the desire of women to take part in life and husbands' careers, which is incompatible with oft-recurring pregnancies. Absence of birth con. trol means late marriages, and these carry with them irregular unions and all the baneful consequences. It is idle to decry illicit intercourse and interpose obstacles to marriage at one and the same time. But say many Birth control may be necessary, but the only birth control which is justifiable is voluntary Such absteation abstention. would be either ineffective or, if effective, impracticable and harmful to health and happiness. To limit the size of a family to say, four children, would be to impose on a married couple an amount of abstention which for long period would almost be equivalent to celibacy, and when one remembers that owing to economic reasons the abstention would have to be most strict during the early years of marriage life when desires are strongest, l'maintain a demand is being made which, for the mass of people, it is impossible to meet; that the endeavours to meet it would impose a strain hostile to health and happiness and carry with them grave dangers to morals. The thing is preposterous. You might as well put water by the side of a man who is suffering from thirst and tell him not to drink it, No, birth control by abstention is either ineffective, or, if effective, is pernicious.

It is said to be unnatural and intrinsically immoral. Civilization involves the chaining of natural forces and their conversion to man's will and uses. When anaesthetics were first used at child birth there was an outcry that their use was unnatural and wicked, because God meant women to suffer. It is no more unnatural to control childbirth by artificial means. The use of birth control is good, its abuse bad. May I end by an appeal that the Church approach this question, in common with certain others, in the light of modern knowledge and

the needs of a new world, and unhampered by traditions which have outworn their usefulness?"

Lord Dawson's eminence is not to be denied. But with all due respect to his greatness as a physician, I am tempted to question the value of his evidence, specially when it is pitted against an experience of men and women who have lived a life of continence without suffering any moral or physical harm, Physicians generally come across those who have so defied laws of health that they have contracted some illness. They, therefore, often successfully prescribe what sufferers should do to become well, but they cannot always know what healthy men and women can do in any particular direction. Lord Dawson's evidence, therefore, about the effect of continence on married people has to be taken with the greatest caution. No doubt tendency amongst married people is to regard sexual satisfaction for itself as legitimate. But in the modern age, in which nothing is taken for granted and everything is rightly scrutinized, it is surely wrong to take it for granted that because we have hitherto indulged in the sexual appetite in married life, the practice is either legitimate or healthy Many old practices have been discontinued with good results. Why should

particular practice be exempt from examination especially in the light of the experience of those who even as married men and women are living a life of restraint with mutual benefit both physical and moral?

But I object to contraceptives also on special grounds in India. Young men in India do not know what sexual restraint is. It is not their fault. They are married early. It is the custom. Nobody tells them to exercise restraint in married life. Parents are impatient 'to see grandchildren. The poor girl wives are expected by their surroundings to bear children as fast as they can. In such surroundings, the use of contraceptives can only further aggravate the mischief. The poor girls who are expected to submit to their husbands' desires are now to be taught that it is a good thing to desire sexual satisfaction without the desire to have children. And in order to fulfil the double purpose they are to have recourse to conraceptives !!!

I regard this to be most pernicious education for married women. I do not believe that women is prey to sexual desire, to the same extent as man. It is easier for her than for man to exercise self-restraint. I hold that the right education in this country is to teach woman the art of saying no even

to her husband, to teach her, that it is no part of her duty to become a mere tool or a doll in her husband's hands. She has rights as well as duties. Those who see in Sita a willing slave under Rama do not réalize the loftiness of :- either her indépendence or Rama's consideration for her in everything. Sita was no helpless weak woman incapable of protecting herself or her honour. To ask India's women to take to-contraceptives is, to say the least, putting the cart before the horse. The first thing is to free her from mental slavery, to teach her the sacredness of her body and to teach her the dignity of national service and the service of humanity. It is not fair to assume that India's women are beyond redemption' and that they have therefore to be simply taught the use of contraceptive for the sake of preventing births and preserving such health as they may be in possession of,

Let not the sisters who are rightly indignant over the miseries of woman who are called upon to bear children whether they will or no, be impatient. Not even the propaganda in favour of contraceptives is going to promote the desired end overnight. Every method is a matter of education, My plea is for the right type.

MAHATMA GANDHI'S TRIBUTE TO DR. ANSARI

Mahatma Gandhi writes in Harijan: T is not usual in these columns to have obituary notices of all the men who pass away. This is a journal devoted to a special cause. Such notices are taken generally only of those who had specially identified. themselves with the Harijan cause. I had to use extraordinary self-restraint to avoid noticing Kamala Nehru's death. It almost became an oppression. But I need exercise no such restraint about Dr. Ansari's death. For he was a symbol of Hindu-Muslim Unity with Hakim Saheb Ajmal Khan. Dr. Ansari never wavered in his faith even when it was put to a severe test. He was an orthodox Mussalman proud of his descent from the helpers of the Prophet when the latter was most in need of of help. His very staunchness and his intimate knowledge of Islam made Dr.

Ansari a believer in Hindu-Muslim unity. It is no exaggeration to say that he had at least as many Hindu as he had Mussalman friends. He was one of the ablest physicians in all India. His advice was freely available to the poor of all races. And what he earned from the princes and rich men, he spent with both hands among his many needy friends. No beggar approached him without emptying, whatever, his pocket contained, and he never counted what he gave. He was a tower of strength to hundreds of men and women who swore by him. I have no doubt that he has left many literally weeping for the personal loss they have sustained. He has left a wife who is a philosopher though invalid. She is too brave and too much of a believer to shed a tear

I have in mind are no philosophers. Their faith in God is vapoury; their faith in Dr. Ansari was living. It was no fault of theirs that their faith in God was weak as with most of us. They had many proofs of the Doctor's friendship when they thought God had forsaken them. They little knew that even the great Doctor could only help them so long as his Maker allowed him. Would that what he could not accomplish while he was alive would be accomplished by his death.

TRANSVAAL ASIATIC LAND TENURE ACT AMENDMENT BILL

The above Bill which has been submitted by the Select Committee and which has now gone through the Parliament has just reached us. The following is a portion of the Bill 4—

BE it enacted by the King's Most
Excellent Majesty, the Senate and
the House of Assembly of the
Union of South Africa, as follows:—

1. Article two of Law No. 3 of 1885 of Transvaal is hereby amended—

(i) by the insertion in paragraph (b) after the word "point out" of the words "following what is written in paragraph (d)";

(ii) by the insertion in paragraph (d) after the words "aan te wijzen" of the words "Provided that Houses of Parliament have given their consent thereto by resolution."

2. The following new sub-section is hereby inserted in section ten of the Municipal Amending Ordinance, 1905, of Transvaal after sub-section (1) of that section:

"(1)bis. The Council may alienate and transfer to an Asiatic any land situate in an area set apart as aforesaid, and an Asiatic may acquire the ownership of or any other interest in such land; Provided that both Houses of Parliament have, by resolution authorised the alienation to Asiatics, of any land situate within that area."

3. (1) Sub-section (1) of section one hundred and thirty of the Precious and Base Metals Act, 1908, of the Transvaal (hereinafter referred to as the Gold Law), is hereby deleted and the following sub-section substituted therefor:

"(1) Save as is provided in section twenty-four or one hundred and thirtyone A or in any other law expressly permitting a coloured person to reside on or otherwise occupy any land or ground mentioned in this sub-section, a coloured person may not acquire any right under this . Act, or reside on or otherwise occupy any land or ground in respect whereof any other person holds any right acquired under this Act or Law No. 15 of 1898 or a similar prior law, and a person who holds any such right, or a person who has : acquired from such holder any right to any such ground or land, may not transfer any such right or part thereof or let any ground or land in respect whereof he holds any such right, to a coloured person or permit any such transfer or letting and may not permit any coloured person to reside upon or otherwise

Provided that a coloured person who is in the employ of a white person or of a company controlled and managed by a white person or white persons may, with the permission of the white person or company employing him and for the purpose of his employment, and subject to compliance with the requirements of any other law, reside upon or otherwise occupy any such ground or land as aforesaid which his said employer is entitled to reside upon or otherwise occupy."

(2) The reference, in section four of the Transvaal Asiatic Land Tenure Act, 1932 (Act No. 35 of 1932) to section one of that Act, shall be deemed to be a reference to sub-section (1) of this section.

4. Section one hundred and thirty-one of the Gold Law is hereby amended—

(a) by the addition of the following proviso to sub-section (1):

"Provided that any coloured person is in the employ of a white person or of a company controlled and managed by a white person or white persons may, with the permission of the white person of company employing him and for the purpose of his employment, and subject to compliance with the requirements of any other law, reside upon or otherwise occupy any such ground or land as aforesaid which his said employer is entitled to reside upon or otherwise occupy";

(b) by the deletion in sub-section (3) of the words: "to coloured persons in the employ of a white person in so far as they live on the premises where they are so employed nor";

5. Section one hundred and thirty-one A of the Gold Law is hereby repealed and the following section substituted therefor:—

131. A (1) Subject to the provisions of sub-sections (3) and (4) the Minister of the Interior may, by notice in the Gazette, exempt any land defined in that notice, to which the provisions of sections one hundred and thirty and one hundred and thirtyone apply, from the operation of those provisions in so far as they prohibit a coloured person from residing upon or otherwise occupying any such land or in so far as they prohibit any person from letting any such land to a coloured person or from permitting such letting or from permiting a coloured person to reside upon or otherwise occupy any such land, and thereupon those

provisions shall not prohibit a coloured person from residing upon or otherwise occupying such land and shall not prohibit any person from letting any such land to a coloured person or from permitting such letting or from permitting a coloured person to reside upon or otherwise occupy any such land,

(2) Subject to the provisions of sub-sections (3) and (4) the said Minister may, by notice in the Gazette, cancel any prohibition as is mentioned in sub-section (1), which is contained in the title deeds of any land which was formerly held under any right conferred by this Act or by any prior law relating to the winning of gold, and the tenure whereof was, in terms of the provisions of section sixty of the Townships Amendment Act, 1908, of the Transvaal (Act No. 34 of 1908), converted from a "voorkeurrecht" or leasehold into freehold.

(3) In a notice mentioned in subsection (1) or (2) the said Minister shall state whether the exemption or cancellation contained in that notice is—

(a) absolute and permanent; or

(b) qualified and terminable,

(4) The said Minister shall not exempt any such land or cancel any such provision in the title deeds to land—

- (a) unless he has consulted the Minister of Mines and if the land in question is situate within the area of jurisdiction of a municipal council or village council or health committee, then also that council or committee in regard to the proposed exemption or cancellation; and
- (b) if the exemption or cancellation is to be absolute and permanent, unless the proposed exemption or cancellation has been approved of by a resolution passed by both Houses of Parliament; or
- (c) if the exemption of cancellation is to be qualified and terminable, unless—
 - (i) a coloured person resided upon or otherwise occupied the land in question on his own behalf ever since the first day of June, 1932; and
 - (ii) the Commission which was appointed by the Governor-General on the first day of October, 1932, and was mentioned in Government Notice No.

1324 of 1932, in effect recommended (whether before or after the date upon which this section came into operation) the exemption of the said land from any such prohibition as is mentioned in sub-section (1) which is contained in any law, or in effect recommended the cancellation of any such prohibition as aforesaid, which is contained in the title deeds of the said land.

(5) When any land has been exempted in terms of sub-sections (1) from the provisions of sections one hundred and thirty and one hundred and thirty-one, any prohibition as is mentioned in sub-section (1) which is contained in the title deeds of any such land shall be cancelled, but subject to the provisions of sub-section (6).

(6) If any land which has been exempted in terms of paragraph (b) of sub-section (3) or in whose title deeds a prohibition was cancelled in terms of that paragraph, is no longer occupied by a coloured person or by the servant of an Asiatic company as defined in section eleven of the Asiatic (Land and Trading) Amendment (Transvaal) Act, 1919 (Act No. 37 of 1919) (as amended by section seven of the Iransvaal Asiatic Land Tenure Act, 1932) (Act No. 35 of 1932) on behalf cf that company, the Minister of the Interior may, by notice in the Gazette, annul the said exemption or cancellation.

(7) Upon the written request of a coloured person who lawfully re. sides upon or otherwise lawfully occupies on his own behalf a piece of land situate within the area of jurisdiction of a municipal council or village council or health committee and which has been exempted in terms of paragraph (b) of subsection (3) or in whose title deed a prohibition such as is mentioned in sub-section (1) was cancelled in terms of the said paragraph (b), or upon the written request of an Asiatic company as aforesaid, which or whose servant on its behalf lawfully occupies such a piece of land as aforesaid, the Minister of the Interior may, after consultation with the municipal council, village council or health committee within whose area of jurisdiction the piece of land in question is situate, by notice in the Gazette, in terms of sub-section (1) or (2) and paragraph (b) of sub-section (3) exempt any other piece of land defined in the said notice which is situate in the said area, if at the time of the said first-mentioned exemption or cancellation a coloured person on his own behalf occupied the first-mentioned piece of land and he was entitled to occupy that land by

virtue of the proviso to section four of the Transvaal Asiatic Land Tenure Act, 1932), or by virtue of the proviso to sub-section (1) of section five of that Act: Provided that the said Minister shall in that notice annul the first-mentioned exemption or cancellation.

- (8) When an exemption or cancellation has been annulled in terms of sub-section (6) or (7) the provisions from which exemption was granted shall again apply to the land in question and if the land has since the exemption or cancellation not been transferred to another owner, the cancelled prohibition in its title deed shall be revived.
 - (9) When the Minister of the Interior has published a notice in terms of sub-section (1); (2), (6) or (7), the officer in charge of the deeds registry in which is registered the title to the land to which such notice relates, shall note upon the title deed of such land which is filed in his registry and in the appropriate registers a reference to the said notice.
 - (10) The provisions of paragraph (b) of article two of Law No. 3 of 1885 of Transvaal and of sections two and three of the aforesaid Act No. 37 of 1919 shall not apply in connection with any land to which an exemption or cancellation mentioned in paragraph (a) of sub-section (3) has been published in terms of sub-section (1) or (2) and of sub-section (11)

(II) If a notice has been published in terms of sub-section (1) or (2) and paragraph (b) of sub section (3) in respect of the site of any trading premises, and it appears from the register mentioned in section thirteen of the Transvaal Asiatic Land Tenure Amendment Act, 1936, that the coloured person shown by such register as having been in occupation of such trading premises was, at the date of the relevant entry in such register, sharing with occupants of adjoining premises the use of any common yard, or using or sharing the use of any auxiliary premises erected in such yard, or ordinarily entered from; such yard, or forming part of the building which constitutes such trading premises, it shall be lawful for the owner of such common yard or auxiliary premises to allow any coloured person in occupation of trading premises to which the said notice applies and any coloured person employed by him on such premises, to use such common vardor auxiliary premises for such purposes as may be defined by regula. tion, and for any such coloured

person to use that yard or those auxiliary premises for such purposes, notwithstanding the fact that no certificate has been issued under sub-section (1) in respect of the land forming the site of such common yard or auxiliary premises.

(12) In sub-section (11)—

"auxiliary premises" includes any bathroom, lavatory, washing place, storage place, pump, tap, closet, urinal, stable or garage and any room used for the accommodation of native servants, and any passage, staircase or balcony leading to any such place orroom;

"common yard" includes any yard which, although it is not used in common by occupants of different premises adjoining that yard, is intended and in the opinion of the Minister of the Interior suitable for such common use;

"trading premises" includes any premises used for the purpose of a trade or busines carried on under the authority of a licence or certificate issued by a competent authority in terms of any law."

Control And Issue Of Licences

THE Inter-Provincial Consultative
Committee, under the chairmanship of Mr. J. H. Hofmeyr, Minister of the Interior, concluded a two-day
sitting in Maritzburg on Tuesday. The
Minister issued the following statement to the Press:—The Provincial
Consultative Committee, which has
been in session in Maritzburg for the
last two days, has dealt with a wide
range of subjects during its meeting.

One of the most important of those subjects was the question of uniform procedure in the control and issue of trading licences. This matter was raised by a deputation representing the Associated Chambers of Commerce of South Africa, which submitted a resolution asking for the introduction in the other three Provinces of the Natal system of the issue and control of licences, the main feature of that system being the issue of licences in urban areas by a licensing officer appointed by the local-authority.

The Federal Chambers have been asked to submit their views in greater detail by way of memorandum, which will be discussed in the first instance by each of the Provincial Executive Committees and then by the Consultative committee at its next meeting.

Hetoism Of Native

66 DID not expect anything. I just L did what I did because my master er was in trouble. Afterwards I did not think any more about it." Italian Bank Notes In Union

The Consulate will provide for their immediate transmission to Italy, where they will be deposited in lira to the credit of the owners in South Africa. At a later stage it may be possible for owners of these notes to be paid out in South African currency through the South African : banks. In the meantime the amounts will be received and credited by the Bunk of Italy to the South African holders.

Phones For Ships At Point

Ships at the Point will soon be in telephonic communication with the City and the rest of South Africa. The Railways and Harbours Administration has laid lines to the wharf at A. B. C. and D. sheds, and it only remains for the Telephone Depurtment to instal telephones which it will be possible to plug in on board a ship as soon as it has berthed. This development, for which the Harbour Advisory Board has been agitating for a considerable time, brings Durban into line with several other ports in the Union,

A One-ton Cheese For The Empire Exhibition

The Kromdraai Dairies, Ltd., of East Griqueland, made the one-ton cheese they are sending to the Empire Exhibition. Two thousand gallons of milk were used and a special mould, press and turning apparatus had to, be constructed at their Highflats factory.

Three Warships Due

Three ships of the Africa Station will arrive in Durbau on their annual visit during this month. The first to arrive will be H.M.S. Bridewater during the week. The Flagship, H.M.S. Carissie, which paid a flying visit to Durban on June 17, to pick up 22 naval ratings, will return on June 27 with H.M.S. Rochester. Vice-Admiral Francis Tottenham, C.B., C.B.E., Commander-in-Chief of the Africa station, will not travel in his flagship, but will arrive by car on June 29. He will open the Durban and Coast Agricultural Society's Show on the following day. The vessels will remain in port until July 13, when the Carliele will leave for Bazaruto, a small island off Portugees East Africa-The Rochester will go to Lourenco Margues and the Bridgewater will return to Simonstown.

A Farewell To Dr. Anning

Dr. C. P. Anning, who was given a farewell by the Indian community and thanked for his services, suggested that Indians should undertake a social survey of the Indian familes in Maritzburg. "In six months you ought to be able to complete such a survey, and I can assure you it would be the most valuable piece of organised health work that could be undertaken in Maritzburg. You may not get a new world in a year, but surely it is worth while trying to get a new housing scheme, on an instalment system. Above all, produce the facts, let them be unchallengeable and then take your firm stand on them," said Dr. Anning. Cone of the things he had learnt in Maritzburg, said Dr. Anning, had been to appreciate that the local Indian community was by no means behind any of the other racial groups in developing a health conscience. He had only to quote the example of the Indian Benevolent Home, the Indian women's endeavour in their infant clinic to realise that. Mrs. R. M. Shirely appealed for the co-operation of the Indians in social work that

was being done for them. Mr. F. J. Lewis, Chairman of the Maritzburg Health Committee, on behalf of the Indian community, said how sorry they were in losing the services of Dr. Ann-: ing. Mr. S. R. Naidoo, in the course of a challenging statement, declared that the Indian community was never slow in responding to any appeal made to it. "If I was a lawyer appearing before a judge, I would certainly indict the City Counoil, not so much for negligence but formoving too slowly. There was the housing scheme for the Indians which was being considered for many years. The scheme was stagnant. The Indians were always willing to co-operate. We want the guiding hand but that was not forthcoming quickly enough," he said. " Maritzburg Welcomes Mr. Swami-

Dr. Rabindranath Tagore, a Nobel: prize-winner and outsanding Indian literary figure, was made to take a diotstion test when he visited Canada, said Mr. K. T. Swaminathan, of Madras, whois presently engaged in making a study: of Indian conditions in the British colonies and Dominions. He was welcomed in the supper room of the City Hall by the Maritzburg branch of the Natal Indian Congress on Saturday afternoon. The act of the Canadian immigration agent, declared Mr. Swaminathan, who did not know that Tagore was a Nobel prize-winner, brought disgrace to an international literary figure who was required to pass a distation test. 'It was auch ignorance that led to friction. India contained one-fifth of the human race, and it was a good thing that it was not war-minded like most of the European nations. Otherwise, with the huge army that it could command Europe would be at its feet. Fortunately Indiahe went on, was filled with a spirit of spirituality, a spirit of non-violence-These were the great heritages of his country. It was on account of this spirit that Indians as a nation would play a great part in the British Commonwealh, with which it was providentially united. Touching on the question of immigration within the Empire, Mr. Swaminathan referred to his own diffioulty when he landed in Durban: 'He had come on a passport from India and he had also informed the Secretary to the Department of Interior and the Agent-General of the Government of India, but it was only on the intervention of his friends that he was allowed to land. The visits of tourists and educated indian are curtailed in the Union, and even the franchise had been gradually taken away. The position called for consideration and for that purpose there was to be a Colonial Conference in London next year simultaneously with the

Imperial Conference. With proper understanding there would be better relationship between one unit and another within the Commonwealth.

The Tamil Community's Welcome

The M. K. Gandhi Library, Queen Street, Durban, was packed to capacity on Sunday afternoon June 14 when a reception was accorded by the Tamil Community to Mr. T. K. Swaminathan B.A. The function was organised by the Young Men's Vedic Society and was held under its auscices. The President Mr. T. M. Naicker occupied the chair and amongst those present were Messrs. P. S. Aiyar, A. M. Padayachy, S. R. Pather, Dr. M. G. Naidoo. Abboy Naidoo. C. R. Naidu and G. B. Chetty. The Vedic. croestra was in attendance under the direction of Messrs. M. S. Reddy and R. Murthi. An excellent programme of music and songs were rendered. Swaminathan spoke at length in Tamil and in English, dealing with the activities of his Society and of what he has observed throughout his tour. He was pleased to note the remarkable progress made by the Tamalians and he appreciated the value the community places upon Indian literture and culture. He exhorted the audience to consolidate all the forces and work in co-operation.

Moslems' Welcome

The proposed visit of Union Parlismentarians to India is a "move in the right direction," said Mr. T. K. Swaminathan at a meeting held under the auspices of the young Moslem Debating Society in the Gandhi Library on Tuesday June 16. "We must take steps," he said. "to see that the visitors should see the best of Indian life and get into touch with the best men of that country so that they might bring away impresions of India that would react to the improvement of the conditions of Indians of this land. There should also be a deputation of Indians from this country too." Explaining the subject of Indian immigration, Mr. Swaminathan said that they had continued sending out men to the Colonies without forming any organisation to study the question and it was with a view to studying the subject that they had started the Colonial Society. There were many in India who had once taken up the attitude of noconcern in oversea Indian affairs. But that view had altogether changed and it .was now regarded as a vital issue in the programme of Indian politics. He believed that the Indian Colonial would play a great part in the regeneration of the motherland. He concluded with an sppeal to the leaning South African and other Colonial Indians to attend the London Conference. Hajee Rooknoodeen, who recently returned from a visit to Arabia and Europe, gave an interest-ing talk on his tour. Asia And Africa

'The Foreign Department of the A,I,C,C, has released for publication the following letter received by Pandit Jawaharlal Nehru, President, Indian National Congress, from Mr. Robert O. Jordan, President, Ethiopian Pacific Movement, New York City:--

"After reading your address in the New York Times, we, the coloured people in the West Indies and the United States, highly appreciate the wonderful spirit of the Indian people who are struggling for freedom. We do hope that you and your co-workers will carry on the great work, to see the struggle initiated by Mahatma Gandhi come true. We, the coloured people in the Western Hemisphere, are suffering in the same way as our brothers in India and we hope it won't be long before the dark people of the world will get away from the yoke of the white man. After England realized that the West-Indian people had developed a different attitude since the World War England disbanded the British West-Indian regiment evidently fealising that the dark people cannot be fooled any longer. Now England is calling back for the West-Indian regiment since she knows that Europe is likely to go into a great war at any time. I can assure the Indian people that the darkmen in the Western Hemisphere will not be an obstacle in the way of coloured people's freedom in other parts of the world. We hope that the Indian people not only the members of the Nationalist Movement, but the 360,000,000 British Indians will cooperate with other coloured people of the world to emancipate themselves from the Imperialist domination by white men. We beg the Indian people to protest to the House of Commons and the league of Nations on behalf of Ethiopia. We realise that Africa and Asia must organise to emancipate themselves from the yoke of this Imperialist cum-Capitalist aggression. We can only do it by uniting all the coloured people of the world. We send our best wishes to Mahatma Gandhi and also to the great gentleman who is now at the head of the Indian Nationalist Movement, Pandit Jawaharlal Nehru,

It is intended that their cars which will be manufactured to an original design, will be marketed at a moderate price.

CASTE OR NO CASTE—THAT'S THE DUESTION

A masterly analysis of caste, its influence on society in general and in India in particular, the various forms in which it exists all the world over, and the true Muslim's duty in regard to it is given in a long letter we reproduce below, written by Halide Edib Khanum the well-known Turkish feminist and social philosopher to Prof. Malkani of

The following is Halide Edib Khanum's reply to Professor Malkani:-

Dear Friend.

RECEIVED your last letter and the literature concerning the caste question which has evidently become a burning issue in India because of Dr. Ambedkar's statement—or menace shall I say-to pass into another religion with all his followers if Hinduism will not do away with untouchability. I have already seen the pale reflection of the statement and its repercussions in the English Press. Now, in all sincerity, you ask me to give up humble views on the subject. And in all sincerity I am giving them in this open letter for what they are worth.

. In the first place let me say that it is a tribute to and the fruititof Gandhiji's gallant struggle against untouchability, If there were nothing else accomplished in the vast field of his activities, this alone would justify his significance and make him a blessing to the world. When I was at Delhi he told me that abolition of caste and untouchability would mean nothing if there were no corresponding change in minds. And Dr Ambedkar's statement proves that there is a change, and it is where it should be.

. A World Problem

In the second place, you are asking my views on a subject which has been uppermost in my mind for some time. Not because it concerns India but because it concerns the world in general.

There was a time when I believed, with the rest of the world, that caste was peculiar to India. It was in prewar years. We either were absorbed by our own troubles or we were not aware of the significance of that much abused word for the world-interdependence. For good or for evil the human world is getting to be like a single body. Any lack of healthy functioning in no matter what part of the body affects it as a whole. And India is one fifth of the human body. Any objective student of history interested in all international upheavals can see caste, though not always under its proper name. It penetrates all moral, social, political even

economic issues. The world dilemma resolves itself into "Caste or no Caste; that is the question."

You say in your previous letter that there was always caste in the world. True. Class was a modified form of it, Slavery was only an abuse of class mentality, just as untouchability was an abuse of caste system. The slave. master had the same attitude of mind towards the slave just as the casteman had towards the untouchables. Both denied the rights of man to a certain section of the human race. Africa was, for instance, the Continent where the slave-castes dwelt. Coloured men could be bought and sold. Under certain conditions white men were also bought and sold. But when you tell me that untouchability was always better than slavery l beg to differ. Slavery is an unmixed evil. One could attack it without any consideration. But caste is not an unmixed evil and for those who believe it to be necessary there will always be an excuse to swallow its inevitable abuse-untouchability.

Class And The French Revolution

The French Revolution did away with class and its privileges. The West thought democracy established for good. But there are and were always men who. believe that a certain section of society must do the harder and the dirtier job, And to reconcile their victims to their hard destiny they always manage to create sanctions-religious, moral or economic. No amount of force can tie a slave to his chains or an untouchable to loss of all human dignity if he does not believe it to be necessary for some reason or other. To fule without the consent of the ruled 'for any length of time' has not been discovered yet.

To be fair, the West sincerely believed to have done away with all caste and class privileges. But even in the West there were bright democrats who man. aged to sit on the top of their less bright fellow creatures and make them do the harder jobs. Abuses of capitalism were only modern forms of caste mentality. Abuses of Imperialism, specially in its colonizing forms, were other forms of caste-mentality. The coloniser and the colonised shared it. But in spite of all these ugly facts the Western armies fought in all sincerity to make the world safe for democracy. Their sacrifices may not have been in vain. But that belongs to the future.

The Great War upset all equilibrium. Confusion reigned and reigns still. Western civilization seemed doomed to some. And gradually the democracy for which twenty millions of the world's best have died to preserve was being held responsible for the world's plight. Why?

Division Of History

Henry Adams, an American thinker and original student of history who attempted to create a science of history, divides human history into three phases —the instinct; the religious and the mechanical. The instinct period runs over an incalculable span of time, the religious lasts 90,000, the mechanical begins in 1600 and lasts up to 1900. He predicts the electrical period from 1900-1917 after which he prophesies the new. era. Interesting as Henry Adam's theology of history is there is one fact which is a reality and interests us all. After the end of the religious period, historic phases become infinitely shorter. There is a lack of stability.

Consciously or unconsciously this lack of stability has been an obsession in the mind of all post-war reformers and creators of new states. This obsession, this dessre for stability has had remarkable results which should interest all those who study caste-mentality. Single-party rules have reinstated caste. Judging from this point of view, German attitude towards the Jews is understandable. Jews on whole constituted a revolutionary, that is unstable element. The reducing of the Jew into an untouchable is logical for a caste mind. Untouchability is sanctianed on the basis of race purity. But that is only the apparent reason for it and one which should interest the Hindu historian. Aryan conquerors of India had created caste and Out caste systems first for the sake of race-purity. Supposing Germany becomes a supreme power in the West. The logical outcome would be that all those who are not Nordics-especially the French-should be turned into untouchatles. The Anglo-Saxon may have a higher caste, but the Germans must belong to the highest caste. They must be the Brahmins On the other hand, Italy's choice of Ethiopia as a colony and her attempr to make the Ethiopians realize that, as a coloured race, they must be the milking cow of the white Italians, is only understandable on the caste basis.

Schmeling's victory came as a surprise to Germany and was received with jubilation throughout Germany. Dr. Goebbels, the Minister of Propaganda, cabled to Schmeling: "I congratulate you heartily on your wonderful victory. I know you fought for Germany. Your victory is Germany's victory. We are proud of you."
