NOTES AND NEWS

Nationalists "White South Africa" Stunt

ESOLUTIONS urging the intro-duction of legislation to prohibit mixed marriages, to prevent the employment of Europeans by non-Europeans and to institute separate residential areas for Europeans and non Europeans were passed unanimously at a Nationalist Party meeting in the Maitland Town Hall, Capetown, on April 16. Mr. D. P. de Klerk was in the chair,. Advocate J. G. Strydom, MP, leader of the Nationalist Party in the Transvaal, spoke of a White South Africa, and declared that the Afrikaans nation would not be able to keep its selfrespect if, for instance, it allowed the employment of Europeans by natives and Asiatics. White children, he said, should not be permitted to play with coloured and native children. "We must have a White South Africa," he said; "and to get that we must see that whites and coloureds and natives don't work and live together."

For Not Greeting His Master

J. K. J. Dames and N. G. van der Skyff, farmers of the Helpmekaar district, states the Natal Advertiser's Dundee correspondent, appeared before Mr. J. F. van der Plank, the Magistrate of Helpmekaar, charged with having assaulted an umfaan. Evidence was led that the umfaan was milking a cow early in the morning, when Dames and Van der Skyff came up to him. Dames smacked him in the face, asking him why he (the umfaan) did not greet his master. The umfaan was then made to lie down and was thrashed by Dames and Van der Skyff with a double whip. Dames and Van der Skyff were both found guilty and fined £1 or seven day's imprisonment with hard labour each.

When will this brutality of the white masters towards their Native employees end? It will never end by such altogether too mild punishment in comparison with the crime, imposed by magistrates. If the case had been the reverse in the above matter we do not know what the fate of the guilty Native would have been. These 'White' masters are certainly no credit to their race nor to the civilisation they represent.

Wonderful Example Of Sacrifice

The Zoutpansberg Review And Mining Journal in its issue of Friday April 16 writes:—"Mr. V. M. Ghelani, a local Indian Merchant, on Wednesday handed over a cheque for £500 to the local Hospital Committee as a donation towards the building of a Hospital at Louis Trichardt. It may be mentioned that Mr. Ghelani is by no means a wealty man, and that such a magnificient gift as given by him is a definite sacrifice. It is hoped that this wonderful example will be followed by others."

Mr. V. M. Ghelani's desire to make the above donation was referred to in these columns some time ago. We fully endorse the well-deserved compliment given by our contemporary to Mr. Ghelani,

Unbeneficial Occupation Of Farms Bill

A general meeting of the Natal Indian Farmers' Union was held last week in Durban, Mr. Jaffer Khan presiding. There was a large gathering as the subject for discussion was the Unbeneficial Occupation of Farms Bill, which it is felt, threatens the existence of the Indian farming community in the Union. The Chairman explained the essence of the Bill and after several sepeakers expressed their opinions on the measure a resolution was unanimously adopted strongly protesting against it on the grounds that the Bill gave autocratic powers to the Minister for the appropriation of lands for reasons that would not stand the test of examination. Subsequently the meeting authorised the Secretary to send telegrams to the Minister of Lands as well as the Agent General for India conveying the meeting's protest.

Wage Bill

The Second Reading of the Wage Bill was passed last Tuesday and the Committee Stage was set down for Thursday.

Malanite Amendment Rejected

Mr. J. G. Strydom (Rep. Nat., Waterberg had moved as an amendment:—

"That this House refuses to pass the Second Reading of the Wage Bill unless provision is made therein for (a) differentiation and discrimination between the wages of all employees on the basis of colour or race; (b) determining by means of quotas the number of Europeans and non-Europeans employed in any industry; (c) the reservation of certain trades or sections of trades exclusively for White employees; (d) the principle of separate spheres of work for White or non-White employees in separate sections of the industry concerned.

Mr. D. C. Burnside (Soc., Umbilo) said:-"That the Malanite amendment was nonsense because the wealth of the country was produced very largely by the non European. It had been pointed out by the Wage and Economic Commission of 1925 that South Africa had a lop-sided economy. At one end of the scale were Europeans earning very high wages indeed-he did not for a moment object to that—and at the other end Natives very low wages. In no other country in the world was there such a disparity. The commission had recommended that before the wages of skilled workers were increased those of unskilled workers should be raised. Unfortunately that recommendation had never been carried out. As long as we—the Union—were prepared to keep the non-European at the present wage level, so long would the European run the risk of being dragged down to that level:

The Amendment was rejected by 65 votes to 19.

Mahatma Gandhi Prefers Honourable Deadlock

Lord Zetland, Secretary of State for India, in his speech on April 8, ruled out as impossible the suggestion that the Governors should give assurances that they would not use their special powers but indicated that the Viceroy would willingly explain the provincial position further if approached by Mahatma Gandhi or any other Congress representative.

According to a Reuter's message form London, Mahatma Gandhi, in a message to the Times, rejects Lord Zetland's interpretation and says that the refusal to submit his interpretation to examina tion by a legal tribunal will raise

strong presumption that the British Government does not intend to deal fairly by the majority, whose advanced programme they dislike. "I prefer an honourable deadlock" says Mahatma Gandhi, "to dishonourable daily scenes between Congressmen and the Governors, in the sense that the British Government mean that the working of the Act by Congress seems impossible. It is therefore for the British Government to show Congress, by every means open within

their constitution, that Congress can advance towards their goal, even by taking office." Having affirmed that he is not actuated by any question of false prestige, Mahatma Gandhi says: "My function is that of mediator between Congress and the Government which, unlike many Congressmen, I believe to be as capable of being converted under moral pressure as of being coerced under physical pressure."

Perverse And Slavish Mentality

throughout the Union is agitated over the so-called "Gentlemen's Agreement" arrived at between the Government and the self-styled representatives of the Congress over the White Women's Employment Restriction Bill which has now been dropped. It has necessitated an explanation both from the Agent-General and Messrs. Kajee and Nana. We regret to have to say that their explanation does not satisfy us,

Mr. Kajee, in the name of the community, should never have taken up a position of an importunate beggar and at the same time urged upon the Government and the people of India to come to the rescue, as he has quite obviously done before the Select Committee. It amounted to saying to the Government: "Please Sir, save us from being insulted by inflicting this legislation upon us, we would rather voluntarily fulfil the object the legislation has in view!" The S. A. I. C. executive states that the statement of its spokesmen should not be considered as a compromise.

"It has been stated," it goes on further to say; "that there exists a small minority of the European public which takes exception, under certain special circumstances, to the employment by Indians of European female labour. This feeling, the executive admits, is based on race prejudice and is, therefore, wrong and cannot be upheld on the grounds of reason or equity. Notwithstanding this, the executive appeals to Indian employers of European female labour, to which special exception has been taken, to respect this feeling and, take steps to dispense with the services of such employees."

This logic baffles our intelligence. The whole European public and the Government are against this "small minority" of their fellow citizens who have failed to establish their case, and pray why has the Congress executive become so over-generous as to ask

Indian employers of European female labour to respect this feeling?

The Agent-General says that the offer of Congress is that they will endeavour to secure the cessation of the employment of girls working in out-of-the-way places under direct supervision of Indians and that he undertakes to give the Congress his fullest support to implement this offer.

The fact that seems to be overlooked by the Agent-General is that this is not a question of degree but one of vital principle, of the self respect and honour of the whole Indian nation. There has not been a single instance brought before the Select Committee of any immoral relations having taken place through such employment. And even if it had, we would still have opposed any legislation branding the whole nation as immoral, and we oppose the proposed voluntary action agreed to by the Congress. There is the Immorality Act that can always be applied in any individual cases of immorality. To ask people to cease employing white women or to dismiss those who are already employed, without rhime or reason, is to insult both the employers and the employees.

But Messrs, Kajee and his associates have gone a step further. Not only do they ask Indian employers concerned to dismiss their white women employees but they ask them to give them a bonus and also to find other employment for them in European-owned establishment! Well, well, we do not know what to say of these good friends who have been responsible for this novel suggestion. We can only say that they have lost their mental equilibrium. Firstly, the suggestion implies that these white women have been serving their employers as a matter of special favour, which, in fact, is not the case. They applied, like all other employees, for employment and that is how they came to be employed. Secondly, if they are dismissed, in the present circumstances, it is not for any

fault of their employers. If, therefore, they resent being dismissed. they have just as strong a case to fight against the Government for this uncalled-for and impertinent interference in their private affairs and their uninvited concern about their morals which they can well look after themselves. Thirdly, since they are to be dismissed at the behest of the Government the responsibility of securing employment for them and of giving them relief falls on the shoulders of the Government and not their Indian employers. And, lastly, the Government has ample funds for the relief of white unemployed while the non-whites are woefully neglected. This appeal on the part of the Congress to the employers concerned, seems to us, therefore, to be wholly unnecessary and far from depicting a generous mind it depicts an extremely perverse and slavish mentality.

We are not prepared to advise our people to dismiss any of their white employees without just cause nor are we prepared to advise them to give bonuses to those who have had to be dismissed owing to Government pressure guided by European public opinion.

Grievances Of Nigel Indians

Indians to shift from the present Asiatic Bazaar into the new one opened for them, where, as has already been pointed out before, Indians will not be allowed to trade, rading rights are given to Natives in the Native Location adjoining the Asiatic Bazaar and a European has applied for a licence to trade just outside the boundary of the Asiatic Bazaar. But Asiatics within the Bazaar may not trade. Moreover, we are told, the Bazzar is to be fenced all round with a man-proof fence.

As Indians have shown no inclination to shift, the Municipality has adopted coercive methods to force them to do so. The Superintendent of the Native Location, we understand, has been instructed to visit every Indian house and to threaten the Indians that unless they submit their plans for building their houses in the proposed new Asiatic Bazaar immediately, the compensation for their present houses will be forseited and the Council will use force and break them down. Indians, we are told, were informed by the Fown Clerk that trading rights would, under no circumstances, be granted in the proposed new Bazaar, that the Council was not concerned about the welfare of the Indians and that if the Indians could not see their way to accepting the proposed Bazaar with the restrictions imposed, they were at liberty to leave Nigel and go elsewhere.

The case of the Indians is that they have been in residence there for nearly

thirty five years and when the matter of shifting into the new Asiatic Bazaar was broached the Indians expressed their willingness to do so provided they were given the right to trade therein. This is by no means an extravagant request especially in view of the fact that Indians are not allowed to trade in townships nor in Gold areas and that in many places in the Transvaal they are not allowed to trade anywhere

but in Bazaars. In fact there is no Asiatic Bazaar in the Transvaal where Indians are prohibited from trading. We do not, in the circumstances, see any justification for the Nigel Municipality to impose this restriction and set a new precedent. Why are Indians differentiated as against the Natives on the one hand and the European on the other? We cannot see any other motive behind this move on the part of the Nigel

Municipality but to kill the Indians out of that town.

The Nigel Indians have referred the matter to the Agent-General for Indian and the Transvaal Indian Congress. I will be interesting to know what they have done. This is but another warning to Indians to become united and properly organised to be able to face the impending calamity. Will they take the warning?

CONGRESS AND AGENT-GENERAL MAKE EXPLANATIONS

TO PLACATE PUBLIC OPINION

PUBLIC opinion on the compromise entered into by the "Congress representatives" with the Government on the White Women's Employment Restriction Bill, has quite naturally been aroused and has made both the "Congress representatives" and the Agent-General for India somewhat uneasy. Both have, therefore, made statements explaining the position.

Agent-General's Statement

The Agent-General, Sir Syed Raza Ali, made the following statement to a Press representative at Capetown: "Information has just reached me that a few of my countrymen in the Transvaal have unfortunately misunderstood the nature of the offer made by the Congress leaders to the Select Committee.

When the Congress appeared before the Select Committee, Mr. A. I. Kajee expressed the willingness of Congress to endeavour voluntarily to dispense with the services of those European girls about 12—to whose employment, in view of particular conditions, special exception had been made.

I hough this offer was a voluntary one and not a compromise, it indicated an honest desire by the South African Indian Congress to persuade those small traders, whose trade had been built up with the help of one or two European employees, to make a voluntary sacrifice.

"The offer of Congress amounts to this—that they will endeavour to secure the cessation of the employment of girls working in out-of-the-way places under the direct supervision of Indians. To implement this offer I undertake to give the Congress my fullest support...."

Statement By "Congress Executive"

The following statement has been made to *The Star* (Johannesburg) by the "executive of the South African Indian Congress":—

"The executive of the South African Indian Congress considers it imperative to define its position with regard to the

statement made by its spokesman when giving evidence before the select committee on the subject of the Provincial Legislative Powers Extension Bill and of the Transvaal Asiatic Land Bill.

"The statement made by Mr. A. I. Kajee was in these terms:—

'Personally I would go so far as to say that we, as Indians, would consider a proposal to dismiss our European employees but we do not want to be insulted by having this legislation inflicted upon us. We would rather do it voluntarily.'

"The executive notes that its standpoint on the Bills, which were prompted by race prejudice and for political ends and which sought to cast a slur on the Indian community of South Africa and on the Indian nation as a whole, has been vindicated and that the Bills have, therefore, been dropped.

"The executive desires it to be clearly understood that the statement of its spokesman which is now being termed as an assurance, shall not be construed as a compromise, or as an acceptance in any form of the principles underlying the Bills These objections are fundamental and unalterable.

"It has been stated that there exists a small minority of the European public which takes exception, under certain special circumstances, to the employment by Indians of European female labour.

"This feeling, the executive repeats, is based on race prejudice and is, therefore, wrong and cannot be upheld on grounds of reason or equity."

"Notwithstanding this, the executive appeals to Indian employers of European female labour to which special exception has been taken, to respect this feeling and take steps to dispense with the services of such employees.

"The executive realises that this step will not only necessitate a sacrifice on the part of the Indian employer, but also inflict an undeserved hardship on the European emyloyees and appeals to Indian employers to mitigate this hardship by all possible means."

Bonus To Girls Recommended

"An appeal to give a bonus, in addition to the usual or a longer notice, to European girls who are dismissed will be made by the South African Indian Congress to all Indian employers," said Mr. A. I. Kajee, in an interview to the Press in Durban.

"We are hoping," he added, "that' this bonus will tide the girls over the period they are out of work."

Mr. Kajee said that employers would also be asked to try to obtain work for the girls in European-owned establishments which were friendly with the 1n-dian employers. The number of girls affected would be decided when the representatives of Congress met Mr. Hofmeyr.

The Minister Questioned

Replying in the House of Assembly to Mr. Van den Berg (Lab., Krugersdorp), who had asked how many European girls employed by Indians would be discharged as a result of the assurance given to the Government by the Indian Congress that they would discharge European girls in their employ, and whether the Government intended making any provision for finding suitable employment for European girls so discharged, the Minister of Labour (Mr. Hofmeyr) said: "Until I have had the opportunity of going into the question in detail with the representatives of the South African Indian Congress, it is not possible to make a statement."

Opinion In India ,

The Times of India says: "General Hertzog's announcement regarding the Asiatic Bills will be received in India with relief and satisfaction. The solution, such as it is, of a most unhapped denoument would not have been attained without the courageous stand by Mr. Hofmeyr and an influential minority for which India is duly grateful."

Under the caption, "Not a Victory the Bombay Chronicle says: "We are afraid we cannot compliment the South African Indian Congress upon this self denying ordinance."

MAHATMA GANDHI ON RELIGION

HOW TO BREAK THE CASTE

A ROMAN CATHOLIC FATHER who saw Gandhiji the other day asked how Gandhiji proposed to break the caste.

"It is already breaking," said Gandhiji.
"All it requires is education, and under the education that is being imparted for some time it is breaking. But by education I do not mean literary education but the spread of true knowledge. Caste has -no religious basis, but it is certainly regarded as bound up with religion, though it is not derived from scriptures. Untouchability is the last word in caste, and as soon as untouchability goes, caste goes. The outcaste has been all over the world. In Europe the Jews were outcastes and confined to the ghettoes where life was much worse than in the untouchables' quarters. The degradation to which the outcastes in India is reduced is bad enough, but what one knew of ghettoes from Israel Zangwill's works, which years ago I read at the instance of a friend, was something blood-curdling. Such a thing cannot happen in India, because of the non-violence of a sort that we are practising. However, though we have no ghettoes, there is nothing to choose between them and untouchability. Take untouchability out and the fabric of caste is destroyed."

And here Gandhiji explained the distinction between caste and varna, which was not only a law for Hindus but a universal law, to which we conform, with or without knowledge, and if we do not we do so at our peril. Caste had been the best target for missionaries to assail Hinduism with, and rightly, but caste in the sense of varna and trade guilds, as Sir W. W. Hunter described it, will live for ever.

God And Gods

"If Hinduism became mono-theistic," suggested the father, "Christianity and Hinduism can serve India in co-operation."

"I would love to see the co-operation happen," said Gandhiji, "but it cannot if the present-day Christian missions persist in holding up Hinduism to ridicule and saying that no one can go to Heaven unless he renounces and denounces Hinduism. But'l can convince a good Christian, silently working away, and shedding the sweet aroma of his life on Hindu communities, like the rose which does not need any speech to spread its fragrance but spreads it because it must. Even so a truly spiritual life. Then surely there would be peace on earth and goodwill among men. But not so long as there is militant or 'muscular' Christianity. This is not to be found in the Bible, but you find it in Germany and other countries."

"But if Indians begin to believe in one God and give up idolatory, don't you think the whole difficulty will be solved?"

"Will the Christians be satisfied with it? Are they all united?"

"Of course all the Christian sects are not united," said the Catholic Father.

"Then you are asking only a theoretical question. And may I ask you is there any amalgamation between Islam and Christianity, though both are said to believe in one God? If these two have not amalgamated, there is less hope of amalgamation of Christians and Hindus along the lines you suggest. I have my own solution, but in the first instance I dispute the description that Hindus believe in many gods and are idolato.s. They do say there are many gods, but they also declare unmistakably that there is one God, God of gods. It is therefore not proper to suggest that Hindus believe in many Gods. They certainly believe in many worlds. Just as there is a world inhabited by men, and another by beasts, so also is there one inhabited by superior beings called gods, whom we do not see but who nevertheless exist. The whole mischief is created by the English rendering of the word deva or devata for which you have not found a better term than 'God'. But God is Ishwara, Devadhidheva, God of gods. So you see it is the word 'god' used to describe different divine beings that has given rise to such confusion. I believe that I am a thorough Hindu but I never believe in many Gods. Never even in my childhood did I hold that belief, and no one ever taught me to do so,"

Idolatry

"As for idol-worship, you cannot do without it in some form or other. Why does a Mussalman give his life for defending a mosque which he calls a house of God? And why does a Christian go to church, and when he is required to take an oath he swears by the Bible? Not that I see any objection to it. And what is it if not idolatry to give untold riches for building mosques and tombs? And what do the Roman Catholics do when they kneel before Virgin Mary and before saints—quite imaginary figures in stone or painted on canvas or glass?

"But," objected the Catholic Father,
"I keep my mother's photo and kiss it
in veneration of her. But I do not worship it, nor do I worship saints. When
I worhip God, I acknowledge Him as
Creator and greater than any human
being."

"Even so, it is not the stone we worship, but it is God we worship in images of stone or metal however rude they may be."

"But villagers worship stones as God." "No, I tell you they do not worship anything that is less than God. you kneel before Virgin Marry and ask for her intercession, what do you do? You ask to establish contact with God through her. Even so a Hindu seeks to establish contact with God through a stone image. I can understand your asking for the Virgin's intercession. Why are Mussalmans filled with awe and exultation when they enter the mosque? Why, is not the whole universe the mosque? And what about the magnificent canophy of heaven that spreads over you? Is it any less than a mosque? But I understand and sympathize with the Muslims. It is their way of approach to God. The Hindus have their own way of approach to the same Eternal Being. Our media of approach are different, but that does not make Him different."

"But the Catholics believe that God revealed to them the true way."

"But why do you say that the will of God is expressed only in one book called the Bible and not others? Why do you circumscribe the power of God?

"But Jesus proved that he had received the word of God through miracles,"

"But that is Mahomed's claim too. If you accept Christian testimony you must accept Muslim testimony and Hindu testimony too."

"But Mahomed said he could not do miracles."

"No. He did not want to prove the existence of God by miracles. But he claimed to receive messages from God."

When one comes to think of it, how simple and naive is man's fanaticism! "The attempt to make the one religion which is their own dominate all time and space, comes naturally to men addicted to sectarianism," said Gurudeva Rabindranath Tagore at the Parliament of Religions in Calcutta. "This makes it offensive to them to be told that God is generous in His distribution of love. and His means of communication with men have not been restricted to a blind lane abruptly stopping at one narrow point of history. If humanity ever happens to be overwhelmed with the universal flood of a bigotted exclusiveness, then God will have to make provision for another Noah's ark to save His creatures from the catastrope of spiritual desolation."

MY VISIT TO INDIA

EVERY Indian quite naturally has an inclination to see India, his Motherland, one day in his lifetime. This opportunity came my way at the end of last year. My ambition in life reached fulfilment. Friends who had achieved this object were ready with advice. Needless to state much of this proved useful. Leaving Durban on December 21 ex the Kenya, my first voyage at sea, doubts as to sea sickness arose, but I was not a victim. The first port of call was Delagoa Bay. To one coming from Natal, a big surprise lay in store, the question of colour prejudice was marked by its absence. The same was noticed at the various ports of call en route, the passengers on board being both hospitable and sociable. The voyage proved to be a happy one. Bombay was reached on the 9th of January. A hectic week of visiting places of interest in and around Bombay proved to be very interesting. Our hosts interested themselves to an extent that we leave with good impressions of the place. What applied to Bombay, we found, applied to nearly all the large towns we had the good fortune to visit, that is, it can be safely stated that there are but two classes in India, the rich and the poor. The former have everything at their

disposal but for the latter nothing but abject poverty is their lot. A day and night in the mail train found us in Madras. This city is beautiful. One surprising feature which struck us was the number of temples in the city, all beautifully built and with splendid architecture. The cost of each of them can be conjectured rather than described. The opportunity was taken to attend a Congress meeting at Tilak Ghat. Amongst the various speakers were Sir Rajgopalachari, Mr. Satyamurti and Mrs. Lakshmibai.

Being a cane farmer, the opportunity of visiting Coimbatore, the house of the cane known as C.O 290 etc, experiments from which is being made at the Natal Experimental Station, Mount Edgecombe. Our guide was keenly interested in us and showed us around many cane fields and their experimental station. It was in Madras that we were advised to obtain a special ticket of a round tour beginning and terminating in Madras for the sum of approximately Rs, 200, The tour covering such places

as Ramesvaram, Trichinopoly where Mahatma Gandhi joined the train, Jaggernath Puri, Calcutta, Gaya, Benares, Threebayne, Sultanpore, Parataj, where I met relatives, Ajodhiapuri, Ganda, Fyzabad, Lucknow, Haridwar, Agra, Mathura, Bombay, and Wardha. At the latter place a visit was paid to Mahatma Gandhi who received us with pleasure.

To describe these places singly would occupy many pages and as the space at my disposal is limited, one can state but briefly that India is a place worthy of a visit. No amount of reading descriptions of any of these places would give one a true impression such as a personal visit would do. I came away with such an impression as I could not adequately describe. In. a general way one can state one or two things. As regards education, for those that can afford it, there is much available, but for the poorer classes, it is very limited. In the villages there is but little or none. The sugar industry is progressing by leaps and bounds.

While the climatic conditions of India would in no way suit the South Africanborn Indian, a visit to India would prove beneficial in more ways than one.

DEFEATIST POLICY OF THE S.A.I.C.

To The Editor "INDIAN OPINION"

SIR,—The following views on recent happenings in the tragic story of our ill fated community, is not so much my personal viewpoint as that of the majority of Indian opinion in Port Elizabeth and I make hold to say, also of a considerable section of Indian opinion of all grades of thought throughout the Union.

One is in duty bound to one's own conscience, and the community's interests, to query the wisdom, and the precipitate surrender of the defeatist policy of the South African Indian Congress in its "willingness to secure by voluntary action the cessation of all employment of the kind to which exception has been specially taken," May one inquire whether the Congress obtained its mandate from all sections of South African Indian opinion, and that the concensus of that opinion empowered the representatives of the Congress to appear before the Select Committee to give evidence to the effect "that in order to avoid the application of legislative compulsion, with the stigma which this would imply etc, etc." what guarantee does the Congress possess that its wishes will be honoured? Or if willingness to obey and honour the behests of Congress be present, did that august and representative body reckon with the inconveniences and financial losses to be incurred, consequent upon a complete change of policy of such firms effected?

How did they arrive at the complex imagination finding that "legislative compulsion," howsoever unfair and selective, carried a "stigma"?

We must face the facts, that Congress, recognised custodian of our national honour, has been out-manouvered, and rushed into an unnecessary surrender.

Neither we, individually, nor the Congress as a body, should be divided and lulled into a false sense of security by the shelving of the anti-Asiatic legis-

lation this session. We have witnessed only the preliminary skirmish, resulting in the survival of the Fusion Government, and the surrender of the Congress. More important engagements loom ahead. Untiring inquiry is to proceed during recess of Tarliament, wherein "recommendations may eventually be made to the Government regarding conditions under which trading licences may be issued to Asiatics."

The future looms dark and ever increasing.

India Letter

[FROM OUR OWN CORRESPONDENT]

Nation's Resolve

The following is the Independence Day Pledge, made in India, which is repeated every year:—

WE believe that it is the inalienable right of the Indian people, as of any other people, to have freedom and to enjoy the fruits of their toil and have the necessities of life, so that they may bave full opportunities of growth. We believe also that if any government deprives a people of these rights and oppresses them, the people have a further right to alter it or to abolish it. The British Government in India has not only deprived the Indian people of their freedom but has based itself on the exploitation of the masses, and has ruined India economically, politically, culturally and spiritually. We believe, therefore, that India must sever the British connection and attain Purna Swaraj or Complete Independa ence.

"India has been ruined economically. The revenue derived from our people is out of all proportion to our income. Our average income is seven pice (less than two pence) per day and of the heavy taxes we pay, 20% are raised from the land revenue derived from the peasantry and 3% from the salt tax, which falls most heavily on the poor.

"Village industries, such as hand-spinning, have been destroyed, leaving the peasantry idle for at least four months in the year, and dulling their intellect for want of handicrafts and nothing has been substituted, as in other countries, for the crafts thus destroyed.

"Customs and currency have been so manipulated as to heap further burdens on the peasantry. British manufactured goods constitute the bulk of our imports, Customs duties betray clear partiality for British manufactures, and revenue from them is used not to lessen the burden on the masses but for sustaining a highly extravagant administration. Still more arbitrary has been the manipulation of the exchange ratio which has resulted in millions being drained away from the country.

"Politically, India's status has never been so reduced as under the British regime. No reforms have given real political power to the people. The tallest of us have to bend before foreign authority. The rights of free expression of opinion and free association have been denied to us and many of our countrymen are compelled to live in exile abroad and cannot return to their homes. All administrative talent is killed and the masses have to be satisfied with petty village offices and clerkships.

"Culturally, the system of education has torn us from our moorings and our training has made us hug the very chains that bind us.

"Spiritually, compulsory disarmament has made us unmanly and the presence of an alien army of occupation, employed with deadly effect to crush in us the spirit of resistance, has made us think that we cannot look after ourselves or put up a defence against foreign aggression, or even defend our homes and families from the attacks of thieves, robbers and miscreants.

"We, therefore, pledge ourselves afresh to this great cause of India's freedom and to the ending of the exploitation of our people and resolve to work to this end till success comes to our people."

Pandit Jawaharlal At Jallianwalla Bagh

- President Nehru, addressing a gathering of about 100,000 in the famous Jallianwalla Bagh of Amritsar, said that, all over the country, elections were on. That was the chief topic. But his own mind was not very much occupied with that. He thought of the bigger problem of hunger and poverty and unemployment of the Indian people.

"A Cup Of Poison"

Mrs. Sarojini Naidu, in the course of a speech in Amritsar recently, said: "What is the goal of the Congress? It is that the country, its peasants in the fields and its workers in the factories and various other vocations may have a right to determine its own form of Government." he described the new Government of India Act as a cup of poison. She appealed to the audience to vote for the Congress and help it in combating and wrecking the Act.

How Government Interfered In Elections

Some more instances of how private violence is practised by pro-imperialist interests and of official interference in the recent elections in India, are given. Under orders of the district Magistrate of Bangalore, Mrs. Kamaladevi Chattopadhyaya was prohibited from addressing public meetings in the City and suburbs for a period of 6 months. Mr. Biyani, President, Vidarbh Provincial Congress Committee and member, Council of State, was prosecuted for sedition. The Government refused to postpone the sessions of the Central Assembly from January 25 to February 20, as suggested by a majority of elected members. For, while the representatives of the people were engaged in the election campaign the

government obviously wished to push through its business in the Central Legislature.

Growing Illiteracy In India

Mr. Lohia writes in the All-India Congress Committee News Letter:

The statistical statement of the educational progress in India for 1928-29 to 1934 35 shows a decline both in the percentage of the scholars to the population and in the amount of expenditure. A retrenchment of Rs. 20,000,000 has been effected in the educational budget, thus bringing down the expenditure from 28½ to 26½ crores. The number of primary schools for boys in British India has, during the period under review, come down from 171,386 to 166,588. The percentage of scholars to the population has decreased from 7.49 to 7.19.

'Hindustan Times' On S. Africa

Commenting on the S. African situation the Hindustan Times writes:-"With such grave developments threatening our countrymen in South Africa, it is bewildering that Sir G. S. Bajpai should "resolutely refute" the suggestion that the position of Indians abroad had deteriorated. But what is more important is, what do the Government of India and the people of this country propose to do to prevent the calamity that is about to befall our countrymen in South Africa? From the apologetic attitude of both Sir Jagdish Prasad and Sir G. S. Bajpai, it is quite evident that, in their utter helplessness, they are not likely to take the initiative in having recourse to any strong action, unless their hands are forced. Their constitutional position induces in them pusillanimity in their dealings with others, while they reserve all their arrogance to the people of this country. The Act of 1924 still lies unused and will remain so for ever, if the Government have their own way. To talk of the Government's objective, under such circumstances, being "equality both of entry and of status and settlement in every part of the Empire" appears to be a cruel mockery. But whatever the hesitations of our Government and the prejudices of their masters in Whitehall, to which the former are here to pander, India is determined to assert the self-respect and honour of her name and the legitimate claims of her countrymen abroad, in the face of all the difficulties crowding round them. The impotence of the Government is not an indication of the paralysis of our people. India. will leave no stone unturned to prevent our countrymen in South Africa from becoming the tragic community.

Things In General

A European Maternity Nurse For Bulawayo Indians

R. NAGRANI informs us from Bula-I wayo that by the kind courtesy of the local Child Welfare Society, the Indian community will have the assistance of the District Nurse Sister in their maternity cases. The Sister, who has been in Zanzibar, has worked among Indians of all classes. Local Indians will be very glad of these services as they were very much handicapped in regard to a maternity Anybody desiring to have the nurse. services of the Sister should advise Mr. Nagrani, Bhagwanti Vilas, Rhodes Street, 4th Avenue, or Phone 4665, when arrangements will be made for the Sister to visit. As regards fees the committee. has left it to Mr. Nagrani's discretion to charge according to the means of the person. Mr. Nagrani wishes to thank, on behalf of the Indians of Bulawayo, the officials of the Child Welfare Society for their kind assistance.

Andhra New Year Celebration

The Andhra community celebrated its New Year on Sunday April 11. The Andhra Maha Sabha (S.A.) held a "Social" at the Hindu Tamil Institute, Cross Street, Durban. The hall was packed and a large number of women and children formed the greater portion of the gathering. Mr. V. C. Naynah Raj performed the Havan ceremony, and thereafter all assembled in prayer. South African News In Brief

Commissions To Be Appointed

HERE is every likelihood of the Government appointing two commissions to investigate the Asiatic problem during the recess. One commission, says the Capetown correspondent of the Natal Advertiser, will devote its attention solely to the question of mixed marriages and the other will concentrate on the economic aspect, including the question of illegal occupation of land in the Transvaal, the evasion of the law relating to the possession of land through the medium of mixed marriages, particularly with Malays, and the effect of Indian participation in South African trade. The principle of the commissions has been accepted, but the terms of reference will not be known and the commissions will not be appointed until Mr. Stuttaford, Minister of the Interior, who is on long leave through illness, returns on duty. Members of Parliament, not confined to the Transvaal, have been agitating for these investigations, which they regard as being far more useful than the two measures which were introduced this session and which the Prime Minister

has intimated will not be proceeded with. If the results of the commissions' inquiries warrant it, legislation will in all probability be brought in at a later stage.

Pretoria Government Indian School

The Indian community of Pretoria is grateful to the Transvaal Provincial Administration for the new Government School which is modern and up-to-date in every respect. Within a little over twelve months the school has made such progress that the Transvaal Education Department has been pleased to grant permission to extend education to the Junior Certificate. An appeal is made to the public for donations towards the following items which are very necessary: A Piano; Malthoid to cover corridors, (Granolithic is cold to bare feet in winter); Pictures; a junior library. (There is an excellent library for senior pupils); gardening equipment; sewing machine; wireless set; playground equipment, viz. swings, see-saw, roundabouts, giant strides, etc. The appeal has been well responded to by the parents for, in one week, the sum of £26 had been raised from the children alone. This sum is
