DEPARTURE OF PHOENIX

N Sunday evening an interesting event took place in connection with the impending departure to India of Mr. Maganlal K. Gandhi and tamily together with the students of the Phoenix Settlement school who will re-join Mr. Gandhi in The Reception Committee formed in Durban to arrange the reception and farewell testivities in connection with Mr. Gandhi's departure had invited about three hundred guests including a goodly number of ladies, to a fruit and sweetmeat banquet in honour of the occasion. The gathering was held in Mr. Rustomjee's spacious hall which was prettily decorated with evergreens, flowers and flags, whilst a band gave selections. Mr. Omar H. A. Jhaveri presided and amongst those present were Swami Mangalanand Purijee, Miss Schlesin, Mr. Polak and Mr. Medh who arrived that after oon from Johannesburg specially for the occasion, Messrs. Dawad Mahomed, Parsee Rustomjee, G. H. Miankhan, Hajee Ismail Abboobaker, Imam Abdul Kadir Bawazeer, P. V. Sanghavee, G. D. Hansraj, A. Christopher, L. and B. Gabriel, J. M. Lazarus, C. V. Pillay and a fully representative gathering of all sections of the Indian community as well as a sprinkling of Europeans.

The Chairman expressed, on behalf of his Committee, hearty goodwill to the departing guests and hoped that their going to India would be of benefit not only to themselves but to the people of India and of benefit the Indians of South Africa. He referred to his close relationship as a trustee with the Phoenix Settlement and spoke very highly of the settlers who were, in his estimation, doing a great and useful work. He then

asked Mr. Polak to say a few words.

Mr. Polak referred in cordial terms to the work of those who were about to leave, recalling how some of them had gone to gaol at a critical moment, taking or sending their wives there too, whilst others had fulfilled their duty by remaining at the Settlement in order to devote themselves to the issue of Indian Opinion, and in this connection he especially spoke of the quiet and self-effacing work of Mr. Maganlal Gandhi. He made a spirited appeal to those present to appreciate the meaning to the community of the Phœnix Settlement. The settlers had never performed their task selfishly. They had worked solely for the advantage of others. Their ideal had been to bring together more effectively the various sections of the Indian community in South Africa and to bring Europeans and Indians into closer and more fraternal relations. They might not have achieved the whole of their ambition, but it was not for want of trying, and if the ideal was a lofty one, it was rarely achieved in one's own lifetime. Nevertheless, the settlers might take pride in having done a great deal to realise their ideal. They had been excellent passive resisters and he claimed for the Settlement that it had been the heart and soul of the Passive Resistance movement (applause). He was sure that those who were about to depart would carry with them the good wishes,

the blessings, of those present. But the settlers who were remaining even more needed their friendship and sympathetic help. Mr. West and Mr. Chhaganlal, with their fellow-workers who were remaining behind, were carrying on the work that they had taken up with their great leader Mr. Gandhi. Phœnix was not to be deserted. It would and must grow. Those of them who were present, and who could not settle at Phœuix, could do something to spread the Phœnix ideals outside the settlement. But there was room at Phœnix for more settlers and he hoped that they would be forthcoming, in order to carry on the national and patriotic work, the work of social reform and self-sacrifice, for which Phœnix stood and from which it derived its peculiar meaning.

Other speakers followed including Mrs. K. R. Naidoo on behalf of the Hindu Women's Sabha, Miss Sigamoney on behalf of the Indian Women's Association, Messrs. Dawad Mahomed, Swami Mangalanand Purijee, Dulabhbbai, A. Christopher, Parsee Rustomjee, Imam Aodul Kadir Bawazeer, S. B, Medh and C. V. Piliay. All the speakers dwelt upon the work of the settlers as passive resisters and otherwise, and expressed their appreciation of the ideals for which the Phoenix Setdement stands. The references were of a touching character in which the spirit of brotherliness was largely evident. Special mention was made by the speakers of the excellent example set by the young boys in going to gaol in the public cause and the no less useful work of the younger children who helped in no small degree in sharing the buiden of extra work that fell upon those who were left to carry on the duties of the Settlement.

The Chairman then asked Mr. Polak to hand over a present to each of the departing guests and perform fo Mrs. Maganlal the pretty ceremony of garlanding. Gandhi was presented a beautiful silk shawl enclosed. in a carved and embossed sandalwood box of Indian workmanship. Mr. Maganlal and each boy and girl received a suitable book. Mr. Fakira, who accompanies the party to India also received a book

Mr. Maganlal Gandhi, in thanking the Reception Committee for the very kind reception and the company for their presence, referred to the many kindnesses he had received at the hands of the people of Durban. He thanked them on behalf of his wife, who did not consider that she had done any more than her duty in going to gaol, and when she considered how the Tamil community had suffered and how they had lost by death that brave young woman, Valiamma, she did not feel that she had done anything to deserve so much In regard to his own work at Phœnix and especially his duties in taking care of the children whilst their mothers were in gaol, he could not take the praise. Miss West, whom they ail loved to call Devi Bahin, and who, he was sorry to say, was not with them that evening, was the one who did most and worked so unselfishly at all times in acting as a mother and sister to those remaining under Mr. Gandhi's roof. He would also like to say a word for young Devdas Gandhi who worked quite equal to a man in the press and the house and never seemed tired of doing something to help. Amongst the many friends who had been kind and helpful to them at the Settlement he would like to mention Mr. Omar Haji Amod Jhaveri, one of the trustees. He was much more than that for he had on many occasions shown his keen interest in the welfare of the Settlement by visiting them and becoming a brother to them. Of Mr. Rustomjee he could only speak in the most affectionate terms. To them he was their revered uncle, their Kahaji, and he had no hesitation in describing him as the "Grand Old Man" of the Indian community of South Africa. (Applause.)

Mr. West, on behalf af the Phoenix Settlers, said he wished to thank most heartily the Reception Committee for arranging such a splendid banquet in their honour. This was the first occasion on which they had been the subjects of so much bonour and he could assure those present that they appreciated it very much indeed. In the departure of Mr. Gandhi and n.w a number of the Phœ.ix Settlers there might be an inclination to regard such events as a calamity to the community. But such should not be the feeling. He could say, so far as the Phoenix Settlement was concerned, that the work would proceed. And after all, many who were going to India were students who would join Mr Guidh; in India to continue their training under his direction. This was necessary and he hoped that some day they would prove worthy sons of As for Mr. Maganial, whom he regarded as a brother as well as a fellow-settler, he did not consider that he was in any way severing his connection with the Phoenix Settlement and its ideals. Some day he would return still better fitted to do the work which he had been doing. His stay in India would be in the nature of a wider and more thorough training for the future. They all regretted the departure of Mr. Gandhi, and it seemed almost impossible to fill his place, but, he maintained, it was the duty of all to fit themselves for leadership. All could be leaders in a sense and exert their influence in their own eircle; and so to some extent fill the gap and be of service to the community. In looking round the foom he saw so many faces of those who had visited the Settlement and whose kindly interest they appreciated. He hoped and believed that they would continue their interest in Phoenix. Their sympathy and help was needed. Those who could not join them in the work at Phoenix could at least show their appreciation of the work which was being done by visiting the place and offering advice and exchanging ideas. That he and the Phoenix settlers certainly expected of them and he had no doubt that they would not disappoint them.

Mr. Shalkh Mehtab and his pupils sang in their best style original songs in Hindustani and a specially-composed song in English in honour of the Phoenix Settlers and their friends.

The gathering terminated with the singing of "God save the King."

On Monday afternoon the Phonix settlers gathered together to bid farewell to those departing for the Motherland. Some hymns in English and Gujarati were sung and a few words spoken suited to the occation. Mr. Polak was present and expressed his regret at losing such a brother and sister as Mr. and Mrs. Maganlal had been to him, but at the same time rejoicing in the knowledge that their departure would only mean a temporary separation. Similar sentiments were expressed by Messrs. West, Chhaganlal Gandhi, Imam Abdul Kadir B. wazeer, S. B. Medh and Pragji Desai. The party, which numbers about thirty, sails by the s.s. Pundus to morrow morning.

A Passive Resister Honoured

On Sunday, the 26th ultimo the Koli community of Johannesburg held a meeting at Mr. Morgan's Bioscope Hall in-honour of Mr. Fakira, (an eight-times gaol-pird) on the occasion of his departure for India. Among t those present were Mr. and Mrs. Polak, Mrs. Bush, Mrs Murgasa Pillay, and Miss Schlesin. The guest was garlanded in time-honoured fashion, and after speeches eulogising his work had been made by Messrs. Premabhai Jogi (Chairman), Mithabhai (Secretary), Polak, Ramjee, Medh, Chhiba Gonal and Bhanabhai Chanabhai, a cheque was presented to Mr. Fakira by the Chairman. Mr. Fakira suitably responded. A presentation was made to Miss Schlesin at the same time.

Mr. Fakira left the same evening for Natal, whence he leaves for India with the Phoenix party. He was seen off at the station by a large number of friends and well-wishers.

The Press on Mr. Gandhi's Departure

The articles which have recently appeared in the Johannesburg papers on Mr. Gandhi are as amazing as they are a nusing. The whole of the South African press indiced seems suddenly to have discovered his virtues and the righeousness of his cause. Since we ourselves discovered both some years ago, we may perhaps be forgiven for exclaiming "We told you so." And yet this man who is acclaimed by the Transvaal Leader and The Rand Daily Mail, and other educators of public opinion as a saint, one living upon a higher astral plane then it is possible for us to conceive, an acceptic, is one of the men that, according to our Municipal Bye-laws, may not walk upon our footpaths, ride in our trains, or reside in our town.

Like the old Indian priest in "Kim," Mr. Gandhi is about to forsake the turmoil of the political arena,

and devote his time to "acquiring merit."

He has gained all he fought for; he has beaten General Smuti by tact, diplomacy and decision, perhaps because the heart of the Minister of the Literior was never really in the fight, since, having the judicial mind, he must have recognised the injustice of his cause. Nevertheless, Mr. G ndhi has won, and won without exciting or leaving behind him any bitter feeling, as witness the eulogies bestowed upon him by

he papers.

The policy which we advocated eight or ten years ago has now been brought to consummation, that is, the policy of excluding Indian immigration and treating the Indians in South Africa not only with justice, but with generosity. There still remains something to be fought for There is the question of the franchise. The Labour Party have entranchised prostitutes and criminals and loafers municipally. The only qualification for municipal voters is that they shall have resided in the town for three months, and s all be white in colour. The most respected and honoured Indian, no matter how long he may have resided in the town, no matter how deeply he may be involved in the town's destiny, no matter his education, his wealth or his high character, is not permitted a voice in our affairs while, on the authority of the Labour Party, the lowest degenerate criminal brought here to serve his sentence from the slums of Johannest urg or elsewhere, is entitled to a voice and a vote, if he be white. Mrs. Gandhi, an ascetic, a woman of the highest character, could not under any possibility vote for the election of Town Cou cillors but Doll Tearsheet, light o'love and disreputable, may do so.

Isn't it a little hypocritical to suggest that the Indians have nothing left to fight for? Certainly a truce has been called. The passive resistance movement has ceased, and the Government has granted all that Mr. Gandhi asked, but so long as injustices of his sort exist we have not finished, and cannot finish, with the Asiatic question.

From the Editor's NEW REGULATIONS

During the last fortnight, the Government, in accordance with the undertaking given by them to adopt in full the recommendations of the Commission, have issued new regulations on three of the matters dealt with therein. The Indians' Relief Act provided for the issue of regulations setting forth the requirements to be fulfilled by those desirous of validating their marriages under the Act. These are now published, and appear to call for no special comment. Simultaneously, section 21 (1) of the Regulations issued in terms of the Immigration Act of 1913 is amended by the reduction of the fee for identification certificates, issued to those desirous of obtaining them prior to leaving the Union, from £1 to haif-1-cr wn, and the alteration of the covering period from one year to three years. We understand, however, that the Durban Immigration Officer has commenced to make a demand for photographs from applicants, in addition to thumb prints, failing which he "exercises his discretion" by refusing to issue the certificate. Such a demand is purely arbitrary, for the thumb-print system was instituted because that of photographs was avowedly unsatisfactory. Only recently, a finger-impression expert of the Government, in giving evidence before the Immigration Board at Pretoria, declared on oath that the risk of two persons possessing the identical thumb-print was one in a million—or, in practice, negligible. To demand, therefore, in addition a photograph as a condition of issue is to demand more than commonsense and the law require, and we cornestly recommend those who value their selecepted to decline to accept these documents on the conditions that the local officer seeks to impose. Moreover, we would suggest to the Natal Indian Association to take urgent steps, if it have not already done so, to draw the Minister's attention to this new requirement, for it was surely never the intention of Parliament that his discretion should be exercised by him or on his b-half against an applicant save in exceptional cases, such as those that have been brought to our notice certainly are not. Listly, the system of visiting passes to individual Asiatics desirous of paying brief visits to neighbouring Provinces has been reverted to, the charge being reduced to a nominal figure, and the issue being in the hands of magistrates as well as of immigration officers. These documents should be a matter of great convenience to the travelling public and business men generally, but we wish to warn all applicants therefor to refuse to pay the unlawful charge of is. 6d., presumably the commission on the transmission of the d poot, that is now being made by the Volksrust officer. The matter is, we understand, being brought to the notice of the authorities.

THE grisly spectre of war his not crept, but rushed, upon a startled Europe, and we now may the dreadful spectacle of millions of armed men let lose upon each other like so many ravening brutes. All appeals to reason seem to have fallen upon dear ears, and at the beck and call of the few who dominate Governments, masses of men are driven against each other in sanguinary frenzy, with all the attendant horrors of carnage and miseries of armed scrife. Russia, Austria, Germany and France are at leath grips, the Bulkan Peninsula will soon be an interno once more, the neutrality of at least one small state has been

invaded, and whether Italy and Great Britain can escape from the threatening maelstrom no-one dare prophesy. The civilisation of Europe is once more in the melting-pot. What will emerge from it, God alone knows. All that is best, noblest, and most aspiring in the West is about to be submerged, if only temporarily, in the stream of blood that is even to-day flowing—for who can tell what purpose? We are told that this is a conflict between Slav and Teutonic ideals of civilisation. We wonder what conceptions of racial culture the German bauer and the Russion moujek have been allowed to develop by their rulers! The bloodiest war that Europe can wage cannot destroy Teutonic civilization or stay the advance of that of the Slavs-if either has any real hasis in fact; but Western civilisation is certainly doomed if brute-force is allowed to dominate over and crush reason and wisdom. only possible hope to-day is that the horror of the cataclysm that has befallen the Western world may even at this late hour give pause to statesmen and thinkers, or, il even this poor comfort may not be grant d, that this may be the last great organised murder of which the nations of Europe may be guilty. The brain reels at the mere thought of the outrage against religion and mankind with which they have burdened theniselves, and it behoves those who retain any control over themselves to protest with all their might and vigour against a display of criminal folly that may well cause the peoples of the East to stand aghast in shocked dismay.

Transvaal Indian Women and Mr. Gandhi

On the evening the 15th ultimo, at the Ebenezer Church Hall, Johannesburg, Mr. Gandhi addressed a meeting of the Fransvaal Indian Women's Association. Mr. and Mrs. Polak were also present. Mrs. Rama Moodaley, the President of the Association, was in the Chair. She said they had met that evening to bid tarewell to their leader, Mr. Gandhi, but she did not know whether she should call him leader. He was their Protector. He had protected them as a mother protects her children and that day, the eve of his departure, she felt as if both her arms were broken. She did not know what was in store for them in the future and she did not know how they would carry on life there without Mr. Gandhi. Before the arrival of Mr. Gundhi there had been no Indian Women's Association. He had opened their eyes, he had shown them a standard. That they must never depart from, but they must always remember the advice Mr. Gaudhi had given them all that time. Mr. Gandhi in the body would be away ir in them, but in soul would be with them, and it was their bounden duty to conduct the Indian Women's Association according to the wishes of Mr. Gandni. In conclusion, she thanked Mr. and Mrs. Gandhi for all they had done for them and prayed that they might be given long life.

Mr. Gandhi said that they had spoken of him that day as a Protector and a Guru but he felt that he was undes rving of either title, but if they would accept him as their devoted brother, it was the highest honour that he could claim from them, and he knew that it would be a precious privilege to him to think of them, wherever he might be, as his sisters. And as their co-worker and fell of Passive Resister, but with greater experience than they possessed, he could only tell them to continue the work they had commenced, and that the work they had done was noble. They should held together as one woman, and, if the call to duty came gain, they should not fail to respond and should not full to do even as Valiamma had done. They should not forget Mrs Vegl. She had done much They could still receive her assistance selfles, work. in taking sewing classes and much other work. Her companionship too was worth catering for. She was

a true woman who felt for them. She would do more if she could, and she would never fail to do all she could. They owed her a great deal, but the best honour that they could pay Mrs. Vogl was not to pile gifts upon her, but to follow her advice and receive her assistance, which she was most anxious to give in connection with classes and such other matters. In India sisters gave their blessings to their departing brothers, whether younger or older than they. He hoped that his sisters there would give him their blessing, no matter in what part of the world he might be placed.

Additional Regulations under the Immigration Act

The following Government Notice is published in the Union Gazette, signed by E. H. L. GORGES, Secretary for the Interior :-

No. 1238.]

[28th July, 1914.

His Excellency the Officer Administering the Government has been pleased, under the powers vested in him by section twenty-six of the Immigrants Regulation Act, No. 22 of 1913, to approve of the accompanying additional regulation and Seventh Annexure to the regulations issued under the said Act, published by Government Notice No. 1079 of 1913.

REGULATION No. 24A.

24A. (1) Visiting permits in the form and subject to the conditions set out in the Seventh Annexure to these regulations may be issued to Asiatics who, on reasonable grounds, to be stated to the satisfaction of the issuing officer, desire to proceed from the Province in which they are lawfully resident to another Province of the Union for a temporary purpose or visit. In respect of each such permit a fee of two shillings and sixpence shall be paid, and such person shall further be required to deposit a sum not less than ten pounds as security for the observance by him of the conditions imposed under the permit. The deposit shall only be refunded upon the fulfilment of such conditions and upon such persons returning to the Province in which they are lawfully resident within the period for which the permit is issued.

(2) No such certificate shall be issued unless there be lodged with the issuing officer a properly completed declaration in the prescribed form.

Mr. Gandhi and the Tamil Community

On the 15th ultimo, at the West End Bioscope Hall, Johannesburg, Mr. Gandhi addressed a meeting of the Tamil Community, including many ladies. Others present were-Mrs. Gandhi, Rev. Chas. Phillips, Rev. Phillips, Rev. Rodgers, Mr. Polak, Mr. Kallenbach and Miss Schlesin.

Mr. Gandhi said that he felt, in coming to meet the Tamil brothers and sisters, as if he came to meet blood relations. That was a sentiment which he had cherished now for many years, and the reason was quite simple. Of all the different sections of the Indian community, he thought that the Tamils had borne the brunt of the struggle. The largest number of deaths that Passive Resistance had taken had been from the Tamil community. They had that morning gone to the cemetery to perform the unveiling cere-mony in connection with the two memorials to a dear sister and brother. Both of these had been Tamils. There was Naryansamy whose bones lay at Delagoa Bay. He had been a Tamil. The deportees had been Tamils. The last to fight and come out of gaol had been Tamils. Those who were ruined haw-kers were all Tamils. The majority of the Passive Resisters at Tolstoy Farm had been Tamils. On every side, Tamils had shown themselves to be most typical of the best traditions of India, and by saying that he was not exaggerating in the slightest degree. The faith, the abundant faith in God, in Truth, that the Tamils had shown had been one of the most sustaining forces throughout those long-drawn years. The majority of women to go to gaol were Tamils. The sisters who defied the authorities to arrest them and had gone from door to door, from barracks to barracks at Newcastle, to ask the men to lay down their tools and strike work-who were they? Again, Tamil sisters. Who mached among the women? Tamils, of course. Who lived on a pound loaf of bread and an ounce of sugar? The majority were Tamils: though there he must give their due also to those of their countrymen who were called Calcutta men. In that last struggle they also had responded nobly, but he was not able to say quite so nobly as the Tamils; but they had certainly come out almost as well as the Tamils had, but the Tamils had sustained the struggle for the last eight years and had shown of what stuff they were made from the very beginning. Here in Johannesburg they were a handful, and yet, even numerically, they would show, he thought, the largest number who had gone to gaol again and again; also if they wanted imprisonment wholesale it came from the Tamils. So that he selt when he came to a Tamil meeting that he came to blood-relations. The Tamils had shown so much pluck, so much faith, so much devotion to duty and such noble simplicity, and yet had been so self-effacing. He did not even speak their language, much as he should like to be able to do so, and yet they had simply fought on. It had been a glorious, a rich experience, which he would treasure to the end of his life. How should he explain the settlement to them? did not even want it. But if he must he could only tell them that all that they and theirs had fought for had been obtained and obtained largely through the force of character that they had shown; and yet they did not want, they had not wanted to reap the reward, except the reward that their own consciences would offer them. They had fought for the Cape entry right for Colonial-borns. That they had got. They had fought for the just administration of the laws. That they had got. They had fought for the removal of the racial taint in the law with reference to th. Free State. That they had got. The £3 Tax was now a matter of the past. And, with reference to the marriage question, all those dear sisters who had gone to gaol could now be called the wives of their husbands, whilst but

yesterday they might have been called so out of coun tesy by a friend, but were not so in the eye of the law That was one of the things they had fought for and had got. Truth was what they had been fighting for and Truth had conquered-not he or they. They might fight to-morrow for an unrighteous thing, and as sure as fate they would be beaten and well-beaten. Truth was unconquerable, and whenever the call to duty came he hoped they would respond. There was one thing more. They had sometimes, as every other section of the community had, jealousies amongst themselves. They had petty jealousies not in connection with the struggle, but in matters which had nothing to do with the struggle. All those petty jealousies and differences he hoped would go, and they would rise higher still in the estimation of themselves and of those who at all grew to know them and the depth of character which they had. They had also, as all sections of the Indian community had, not only those jealousies but sometimes many bickerings also, and petty quarrels. He felt these also should be removed especially from their midst, because they had shown themselves so fit to give themselves to the Motherland. And here, of course, it was a Tamil who had given his four sons to be trained as servants of India. He hoped Mr. and Mrs. Naidoo knew exactly what they had done. They had surrendered all right to those children for life, and they could not possibly do anything to advance their material well-being, but had always to remain servants of India. It was no joke, and yet Mr. and Mrs. Naidoo had certainly done that. He could not appeal to them too strongly that they of all sections should rid themselves of all those bickerings, petty jealou ies and quarrels amongst themselves. He would also ask them whenever they chose a President or a Chairman to obey him, to follow him, and not always listen to the views of this or that man. If they did that their usefulness would be curtailed. And then too they should not worry if others and not they might reap the reward. Their reward would be all the greater if it was not of this earth; they were not fighting for material reward, and a true Passive Resister never thought of material reward. They should not worry about material prosperity, but always have higher things before them. Then indeed they would be like the leaven working in the community which could raise the community as one to look up to. The privilege was certainly theirs and time also was at their disposal, and if they make good use of that time it would be a splendid thing for the whole of South Africa, and would certainly be a splendid thing for them; and if he heard in India that all those little things to which he had drawn attention had also been got rid of by the Indian community he would indeed be rejoiced. One thing more. He had known something of Madras, and how sharp caste distinctions were there. He felt they would have come to South Africa in vain if they were to carry those caste prejudices with them. The caste system had its uses, but that was an abuse. If they carried caste distinctions to that fatuous extent and drew those distinctions, and called one another high and low and so on, those things would be their ruin. They should remember that they were not high caste or low caste, but all Indians, all Tamils. He said Tamils, but that was also applicable to the whole Indian community, but most to them because most was

certainly expected of them.

Mr. Kallenbach also paid a glowing tribute to the Tamil community, and referred to his experiences when he accompanied the first party of ladies to Viljoen's Drift and also at Newcastle, where most of his co-workers had been Tamils. He also urged them to adhere to their simple national customs, and not to adopt the cheap display of the West.

Mr. Phillips next spoke. He said that the community had got all it wanted under the settlement, and what was more the Passive Resistance Movement had put an end to all further repressive measures on the part of the Government. In conclusion, he said that,

if ever the community wanted assistance of any kind, they would find in himself and Mrs. Phillips ready helpers.

Mr. Polak and Mr. P. K. Naidoo also spoke.

Mr. Thambi Naidoo, the Chairman, in closing the meeting asked those present to remember Mr. Gandhi's remarks, and added that it had been said that, if the community here were ever in trouble again, Mr. Gandhi should come back to them, but they should remember also that if they ever heard that Mr. Gandhi was in trouble in India they should immediately pack up and go to India and show who were the followers of Mr. Gandhi and follow him to death.

Transvaal Gujaratis' Farewell

Oh the afternoon of the 16th ultimo, the Gujarati Hindu community met Mr. Gandhi at the West End Bioscope Hall, Johannesburg, and amongst others present were Mrs. Gandhi, the Rev. Chas. and Mrs. Phillips, Mr. Cachalia (Chairman of the British Indian Association), Mr. Thambi Naidoo (Chairman of the Tamil Benefit Society, a number of the members of the Transvaal Indian Women's Association), Mr. Dantu (Chairman of the Coloured People's Association), and Messrs. Aswat, Baroochi, Lalbahadursing, Amod, P. K. Naidoo, Moosajee, Bhikjee, Joseph Royeppen and Miss Schelsin. Mr. Gopal Patel was in the chair and delegates attended from many of the country districts. After the usual garlanding, Mr. Gindhi addressed the fleeting at length in Gujarati, other speakers being Rev. Chas Phillips, Mr. Dantii, Mr. Cachalia, Mr. Lalbahadursing, Mr. Vassanjeebhai, Mr. J. P. Patel, Mr. Shelat and Mr. Ramjue. The Germiston community and the New Clare Dhobi Sciety took the opportunity to present purses to Mr. Gandhi.

The European Committee and the Settlement

On the 14th ultimo Mr. Gandhi met the European Committee, which was established several years ago with the object of advising the passive resisters. The terms of settlement were discussed. It was decided to write a letter thanking the Government for its conciliatory attitude in regard to the passive resisters' grievances, and further, to address a letter to Mr. Gandhi congratulating him upon the settlement. The following is a copy of the letter to the Prime Minister:—Johannesburg,

16th July, 1914.

The Private Secretary,
Right Honourable General Botha, P.C.,
Preteria.

Sin—The European Committee of sympathisers with the Indian community that has met from time to time to aid in procuring a settlement of the Indian troubles out of which the Passive Resistance movement arose, desires me to convey to the Government, through the Right Honourable the Prime Migister, its sincere and grateful appreciation of the settlement that has now been reached so patriotically, and with such an earnest regard for the importance of the Imperial principles involved.

My Committee, which has on various occasions made representations on the subject of Indian grievances to the Union Government, takes this opportunity of tendering to the Government its respectful congratulations upon the removal of real and serious grievances of many years' standing, and trusts that, with the passing of the Indians' Relief Act, and the fulfilment of the Government's undertaking of administrative reforms, an era of peace will have arrived enabling the resident Indian community to take its proper place in assisting to promote the welfare of South Africa.

My Committee is confident that with the sympathetic spirit that has been created by the settlement the Government will have the most loyal co-operation of that community.

News in Brief

In reply to a cable grain of condolence sent by the British Indian Association, the Private Secretary to the Viceroy of India cables as under to Mr. Polak :— "Viceroy sends his grational thanks to Transvaul Indians for their kind message of sympathy."

Mr. Gandhi has sent the following wireless message a "May I convey on whalf of Mr. Gandhi, Mr. Kallenbach and self our occpost timels to bundreds of senders of telegrams from all pairs of S ath Africa which awaited us upon our arrival on board. These telegrams containing messages of over and sympathy will be an additional reminder to us of what South Africa has meant to us. We trust that the goodwill shown to us personally by so many European friends will be transferred to those to whose cause our lives in South Africa were dedicated."

A meeting of Irdians at Poit Shepstone, convened by Mr. Anthony D. Pillay, was held recently, with the object of establishing a school for Indian children in the district. After discussion, it was resolved to form a society called "Port Shepstone Indian Society," to undertake the management of the proposed school.

Sir Ian Hamilton's Speech

The Times, referring to Sir I an Hamilton's famous speech in New Z aland, says:—"He pictures the Pacific as 'the meeting place, not of nations, but of continents.' 'Here,' he says,' it may be decided whether Europeans or Asiatics are going to guide the destinies of the world.'

"He glances at China and sees a vast and mysterious upheavel of new forces which threaten to break the immemorial indifference of its niltions. No longer is the East prepared, in Methew arnold's phrase, to 'let the legions thunder past,' and 'plurge in thought again.' In the United States, in Canada, in South Africa, the problem of the Asimic immi finit is acute. He lives, as Sir Ian Hamilton rather but ally puts it, on rice, and monopolises business. The white trader cannot exist in competition with him. He makes 'corners' in all the merchandise of perly in flicking. He can live where the white man would state. He knows no need of recreation. His hours of work are limited only by leg-I compulsion. His whole being is one struggle to hoard infinitesimal prifics agains, his return to his own country, tree bicause he is rich.

The Nation regards Sir Lin's speech is "a blazing indiscretion."
