NOTES AND NEWS

ACIAL nots have takent place in Chicago, resulting in an deaths and 1,000 injured, many of whom, says the Reuter message, died of their wounds. 'The Times correspondent at Washington says the beginning of the trouble arose when a negrobather wandered into the area reserved for whites, who drove him back with stones. This was the spark which ignited the smouldering blaze. However, the bad feeling is due to a variety of causes. Negro soldiers complained of the different treatment they experienced in the United States compared with their treatment in France, while white Bolshevist agents tell the negroes that they should use their military training as a hint to the whites that they are not inclined, after fighting for iteedom abroad, to revert to the conditions under which they are treated in a humiliating manner. preachers and magazines are saying practically the same thing, and also uttering a warning to the whites they had better look out unless they treat coloured people

We refer to the above in our leading article; and we iso recommend our readers to observe what the Natal Advertiser has to say on the question in the leaderette which we reproduce in another column.

A mass meeting of Durban Indian waiters was held on Friday the set inst., at Rawat's Bio to discuss and socide upon the reply received from the mastern ! The Indian waiters have been organised since May last, and the beginning of the month a demand was sent to the hotel proprietors asking that the head waiters be paid £9 per month with lood and quarters, and the waiters £6 with lood and quarters or £8 without lood and quarters. In reply to this, the masters appointed a sub-committee, consisting of Messrs, W. H. Hamilton, Joel, Oliver and Allerton, 60 meet a deputation of the waiters. The meeting took place on Thursday, July 24th, and the masters offered the sum of \$5 with tood, and £6 ros. without food.

We understand that the waiters have refused the above offer but refrained from taking drastic action until after the Peace Celebrations.

In the House of Commons (says Reuter from London), Mr. Bennett (Coalition Unionist, Seven Oaks) drew attention to the protests of the Indians in South Africa against the Asiatica Trading Act, and asked if in the event of the Union Government holding the promised new inquiry, the Government of India could assist the Indians to present their case. Col. Amery (Under-Secretary for the Colonies), in teply, said he had no doubt that a full opportunity would be given to the Indians to present their case, though he had no information at present in regard to the details of the proposed arrangements. 👡 👢

Mr. Jamnadas Dwarkadas has published a lengthy statement setting forth his reasons for severing his, connection from the Satyagraba Sabha. After stating he could not agree with Mr. Gandbi on law breaking

propaganda, he declares - The circumstances which have led to the suspension of the movement have not materially altered and that its proumption is likely to create a ferment throughout the country more serious than witnessed during April and May. The cortem-plated action of Satyagraha, Sabha would, he says, not only damage India's cause but would impede the growth of Satyagraha and endarged British connection. After pointing out that the situation had become more critical since the movement was suspended he says they must take into account the mischievous elements in the country which might take advantage of the law. breaking propaganda as a fit channel to work at their nelarious designs! His opposition to the Rowlatt legislation remains and he pleads for more constitutional agitations. In conclusion he appeals to Mr. Gandhi not to resume civil disobedience.

The following is an extract from the Budget speech of the Hon. Mr. Montagu, Secretary of State for India, delivered in the House of Commons:

He could not do better, in describing, this body of men, than quote the words of a very great and distin-guished Indian, Mr. Gandhi. There was no man who offered such perplexity to a Government as Mr. Gandbig a man of the bighest motives and of the fibrat character, a man who his worst enemy, if he had any enemies, would agree was of the most disinterested ambitions that it was possible to conceive, a man who had deserved well of his country by the services he had rendered, both in India and outside it, and yet a man who his friends, and he would count himself as one of. them, would wish would exercise his great powers with a greater sense of responsibility and would realise in time that there were forces beyond his control and outside his influence who use the opportunities afforded by his name and reputation. His hon, and gallant friend (Colonel Wedgwood) would realise that Mr. Gandhi was not the only man who, despite the most laudable motives, sometimes showed a lack of political

Colonel Wedgewoon: I should be quite content if I bad Mr. Gandhi's virtues and powers.

We are glad to know that the efforts of the Durban and District Indian Educational Advisory Committee are meeting with success. Through the persistent work of this Committee a Matriculation class was established by the Education Department at the Carlisle Street School, Durban, about a year ago. The score or so of students who are preparing for the Cape Junior Certificate, are expected to sit for examination this year.

About the same number of boys, having passed the sixth standard last June, expressed the desire to proceed. with higher studies, and it has been arranged to start a second class for them. It was only to be expected; that the Provincial Executive, which controls education in the Province, would provide each year for those students who were ready, and we trust that we shall w continue to see, year by year, fresh batches of Indian. youths availing themselves of the facilities offered." $(x,y)_{i\in I}$

We understand that, as a result of an interin withing the Seretary of the above to mustave tMr. Suchin Maharaja and Mr. Cherlin Nulliah of Maritzburg had with the Acting Superintendent of Education recently, a similar class is to be opened at Maritzburg. We hope that City Indians will take the fullest advantage of the offer and follow the example of Durban by terming an Advitory Committee to encourage passents and assist the Department.

So far only male students have joined these classes, but we hope that Indian girls will also be included in the near future. We know that Indian elementary achools only teach up to Standard four, but there is at least one institution in Durban that proceeds to the sixth standard and repares girls for the Indian Teachers' examinations. So there is no reason why some of our girls should not the up higher studies.

We are straid that Noted Mercury is becoming more and more with Jam. It takes exception to General Smule views in favour of sell-government for Ir dis even in a medified form, and tells the general that he had better let such matters alone as he was not too successful in his deslings with the Indian question in this country.

We'do not quite follow the line of reasoning in the above: It sounds silly evough. But for crass stepidity we have never seen anything to beat the following sentence from our contemporarys leading article:—
"The Asiatic row demand free right of trade in the Transvaul, and this concession cannot be granted, because there is the possibility that the right would be exploited by German traders, who are already on the alect for openings for commerce."

The editor must be one of those crack-brained "vigilants" who see the bogey of a German at every time. The obsession seems to have turned his brain. Ever Sir Abe Bailey and his friends do not suggest that a German trader might secure a footing in humaness disguised as an Asiatic!

The truth, of course, is that a German will have no need to hide behind an Indian. He will walk straight in and secure his licence to trade whilst a British Indian will be treated as an "undesirable person." The Transvaal swarms with every kind of alies trader, and it is from this class that the organised opposition to Indian trade course.

We are also led to wonder why the Mescury is so apxious to save the Transvaal from these "dangerous". Indian traders. Has it lorgotten that there are a tew in Natal and even in Durban? Has the "tree right of trade" which Indians anjoy in Natal been exploited by Germans? If not, why this nonsence?

Our contemporary well known that Germans and other European aliens have always traded, do now, and will continue to trade, in the town of Durban and throughout Natal, with considerably less restriction than do loyal British Indians.

As for the Mercury's—or Lord Sydenham's—opinion that the vast majority of the Indian people "do not want to be interfered with" by the grant of self-government, we feel that our contemporary would be wises not to express opinions on matters which it knows very little about. In any case its opinion is worthless.

General Smuts on his return to South Airica, selemed in eloquent terms to the secrifices made by English and Dutch, Natives and Colouzed men, in the war. There was, he said, a great woice coming to South Africa from those thousands of graves all over the world, telling us they know no more bitterness towards

each other. There was no haired that spike from the grave. English, Dusch, coloused and bisck people everywhere had stood together and done their duty, and they all appealed to us to stand together for the future of this great country in the spirit in which they tought, and in which they struggled. "We have been comrates in srms, let us be brothers in peace—(Applaussys—for only—in that way shall we be able to realise the destiny that Providence has in store for us."

For the extension of the Durban Indian Market no fewer than rr tenders were received by the Town Council. In view of the urgent need for the proposed increased accommodation the Council decided to proceed with the work at once and the lowest tenden that of Mr. Charles Carr, Durhan, amounting to £12,600 was accepted.

A correspondent writes to the Natal Measury with reference to a paragraph which appeared in that paper concerning the question of the landing of five Mauraian waskinen. He says they were debarred from landing at Delagos Bay, and arrangements had to be made to land them at Durban, and then to convey them by rail to their destinations. He is particularly amonged at the man "having to affir 'thumb marks' to their paramits."

In view of the extremely high prices rating for rice in the last few years, many planters on the Natal court north of Durhan and on the Zululaud coast are seriously proposing (says the Natal Advertism) to grow rice for their own requirements and to devote any surplus to the general markets. In years gone by quantities were: successfuly grown in Natal, and there is an increasing belief that there is scope for making it a paying crop.

A Reuter telegram from London states that much interest centred in the march past by the Indian troops, who were not able to take part in the recent Victory Pageant. They arrived in special trains from Hampton Court, and, headed by the combined bands at the Guards Brigades, presented a striking and picturesque appearance as they marched from Waterloo Station to Buckingham Palace grounds, where they were received by the King. There were also present the Queen, the Prince of Wales, the Duke of Connaught, Field Marshall Haig, and other notable personages. The King addressed the troops, thanking them for their devotion to the throne and Empire, for their services in the war, and cheerful bearing of suffering and sacrifices.

Says the Pretoria News: The Smuts-Gandhi treaty of peace, in which our great Imperialist was so badly beaten, was tounded on one fundamental principle: "No more Indians to come in, and those here to be treated fairly and justly." Capt. Blackwell tells us that we are in danger of the menace of the Indian competition in the Transvaal. Let us consider what this competition means. If we expel the Indians how shall it profit us? All merchants belong to the passistic class. That is true. But if we expel one paramite class we merely open the door for another. If we expel the Indian we make room for the Russian and the lowest class of Greak.

If the findians were to maintain the same standard of living, pay similar sugges and salaries, in abort, spend on much as the white of m, merchant or mechanic, then a case could be made out for equal privileges, but they do not, and the fight would not be fair, (says the Natur Mercury, referring to the Johannesburg Conference resolutions).

The same journal, in its protound wisdom, solemnly declares that "we do not think visiting permits are possible." Our contemporary might with advantage atudy the Immigration Act.

THE CONVENTION

7R are glad that the Renergency Convention of the South African Indian Matiental Confer--uncer held at Johnnesburg, was well attended by delegates from every important centre in the Union. The presence at a united gathering of all sections of the Indian community is an indication that the Jadies community is abler if, necessity arises, to combine dorner against the adverse elements encayed against them. . It is, of source, true that very simulant resolutions passed at the convention are in themselves mere pious expressions of opinions or in the nature of simple requests which the Government may or may not take notice of. But the fact that they embody the consitiered espinion of the thinking pert of the Indian section of the population should be sufficient so show to the Government that they should be treated with respect and consideration. Such questions as the semoval of the provincial harriers and the grant of the municipal and political franchise to every quelified dedism in the Union are not going to be solved by the mere asking. We should evalue that our claim must be backed up by determination to achieve the objective desired. The tank and file must be educated up to the salar of the vote and those who are at present in posession of the tranchise should use it wisely and well. We "yenture to say that, when we are ready to demand, earnestly the vote, no power will be sufficient to withstand our demand. It is not enough to ask for these things. We must fight for them. We hope, therefore, us a result of this Conference, every soun and district will have its Votwar and Ratepayers' Association whose - work is will be to sester public spirit. In the Transvall, where there is not even the municipal franchise for Indians, similar bodies composed of eligible and wouldbe votess should be found with the object of pressing their claims to sitisembip and educating their brethren in the duties of busyesses and nitizens. Let the Munireignities, Propincial Administrations and the Government be made to understand that we are serious and determined in our efforts to improve our status. We are bere to stay. Our lives are cast, for good or ill, among our European fellow citizens. We feel the same pain and pleasure as they do, and we are willing to share the same responsibilities." If we claim equal legal rights it is because we accept the duties also. We admit that some of our people are not educated and are not yet gendy to anjoy full, rights of citizenship, but that could be said even on the large majority; of the peop white population of the Union. The same argument has been used to keep down theirising ambitious of every union and people un the face of the earth, . For one section of the population to say that another is not fit to exercise political rights whilst doing nothing to assest them to fit them for that position is the attitude of the stre-owner. بر او د معر

The demand for education up to the University is timely. Everything depends upon what efforts we make in that directions. We must show the Government that we really want our children educated and that we will not test untisted with anything short of equal apportunity with others. It is the duty of purents, who can afford it, to encourage their children to montinue their studies beyond the elementary stage. And it should be the privilege of wealthy Indiana to easist more parents to educate their children. We have at right to fixe educate their children, but we shall get that

in good time only by making sacrifices. We shall do well if we, as a community, determine that no child shall remain preducated through lack of means. One status depends upon education and nothing else; and that is why we lay stress upon it. Conferences may pass resolutions until doomstry but we conselves are the real masters of our destroy.

In discussing the cabled news from Chicago regarding the racial nots which have occurred there between whites and blacks, the Natal Advertuer, in a leaderette, gives expression to the same thought when it says Men-even black men-do rot fise up against the existing order unless: there is something in the existing order which has made it intolerable to them." - In other words, men in Ireland, Rgypt, India, South Africa and elsewhere do not mice their voices in solemn protest and resort, in come cases, even to violence, thereby risking their own lives, unless there is reason for it. The Negroes of America have come to realise that, whilst they are, good enough to die with on the battlefield, they are not to be allowed to live peaceably slopg with white people; in their own country. We one is icalish coording to be lieve that the similes wandering of a Negro bathet arto the area reserved for whites was in itself sufficient toarouse passions resulting in a deadly conflict with over a thousand casualties. In order, to understand anything. of the racial problem in America the mind must go back to the time when Negro men, women, and children were sontched away from their homes in Africa and sold as slayes to the cotton planters of America. It mould-need are occur of represent texts to wash away the stain of those crimer committed by a civilised people against a belpless, primitive race. But I, instead of source and repentance; we find harred and. intolerance, the sin is aggravated a hundred-fold. To quote again from the Advertiser There is no need for white men to fear the black if they treat him: justly. It they will not, however, treat him justly, it is not the provess of the black so much as the correcting sin of injustice that will finally involve our white civilisation in disaster." That is well spoker and, be it remembered, by a South African nesspaper. Flow mell such words apply to our Native and Andian probloom in it only the white population could realise a the eternal truth : " As a man soweth so shaft he also, reap," there would be change of attitude towards those who to-day are regarded as but hewers of wood and drawers of mater. Those few Europeans who have exponsed the Indian or Native cause in this country have no doubt realised this truth. They have, we believe, felt that, in helping to remove the racial bar, " they have been doing the greatest possible service to themselves and their own pation. They have looked upon every form of recislism as an evil force which south inevitably bring about dispeter to their own race if not checked in time. Swely, the warnings coming from all corners of the earth are loud and clear enough to arouse the sleeping world! Yes, the world is not get awakened to the deeper things of life. Was so no temedy for felichness and arrogance. The semedy is to be found only within the human heart. RICE PRICES PIXED BY THE GOVERNMENT

The maximum prices of rice have been fixed by the Union Government as follows:—

Allabrown rice (except Madagascar rice) 60s, per hagwholesale-5d, per lb, retail.

All white rice, 72s. per bag wholesale—6d. per lb.

Madagascar rice (white or brown), 47s. 6d. per bag

wholesale 4d per lb. retail

Bag in each case to be 164lbs. Wholesale prices to be regarded as for. Durban persons selling wholesale elsewhere than in the Borough of Durban, to be entitled to add cost of transport. In cases of dispute as to proper amount to be so added, magnificate of district to decide.

Nothing less than a bag of 164lbs to be considered a wholesale transaction, any less quantity to be consi-

dered retail."

Under sub-section (c) of (1) 2 of the Public Welfare and Moratorium Act, the Government has the power to expropriate stocks of rice, upon the terms therein laid dewn.

WHAT ARE "WESTED RIGHTS"

DR. KRAUSE MARES IT CLEAR

The following extracts from the evidence given by Dr. Krause, counsel for the Transval Indians, before the Select Committee on the Disabilities of the Indians in the Transval, puts the questions, what are "vested rights," and, what is a 2 successor," in the true light:—

The ordinary public, the people who do not think, and who do not come into touch with the Asiatic, they call every Asiatic a Coolie, no matter what ha is. One does not, however, expect that from the Legislature. Apparently that was the position in 1885. They were only acquairted with a particular class of Indian. There were a few of the better class, but they were to a very small minority. The Legislature in those days was alraid of an influx from Natal, and that was what they desired to provide against. I hold that in 1885 the word Coolie was used in order to indicate the man coming from Natal. The Indian who waded at the corner of Church Street and St. Andries Street where Mr. Hamilton's shop is now in Pretoria, was M. C. Camroodien. He is dead now. That was in 1884. It is quite true that even in those days the decent class. of trader was to a certain extent known to the peoplenithough there were very few of them; the legislation undoubtedly also applied to them, but their right to trade was never restricted. So far as I know there has never been any agitation against the Indian dealers on the part of the rural population. The rural popula-Asiatic dealer has been a friend of the rural population. I spoke of race prejudice against the Asiatios. I did not mean to convey that it was prejudice on the part of the Dutch or English race against the Asiatic-is is a prejudice against the coloured race. I do not wish to go so deeply into the matter as to say that it is a prejudice on the part of any particular section, and I do not mean to say that the prejudice comes from the rural population. It is not a general racial feeling coming from the rural population—the prejudice comes from the dealers and traders. I do not think that when General Smuts made the agreement in regard to vested is rights, he referred only to rights existing at that time.

I think General Smuts dealt in general with the rights of the Asiatic community—he dealt with the innercut rights of the Asiatic community of South Africa, their right to trade-that was their vested right. Incir right to trade was affected only in certain areas of the Transuaal, but none the less theirs was a vested right, The position is that even if they did not all exercise that right at that time, even if they were not availing themselves of that right, they could have that rightit was theirs. Say, for instance, to take another example, a man was a hawker at the time; that fact would not prevent him from becoming a wholesale, dealer later on, Surely nobody wishes to say that he should always have remained a hawker. He had the gight at the time to trade—consequently, carrying the point to its legical conclusion, he had the right to expand his trading. Many of those men were only hawkers in olden days. and have become great traders since, just as many of our present day millionaires started as hawkers in olden days. You ask me what were their rights which were not vested then-they had no right to acquire property, but the law did not interefere with them and it specially protected those who owned property at the time in 1885. They cannot acquire property yet, but they get property as companies to day. According to our Company Law the property does not belong to the individual but to the corporation. You ask if they are not just availing themselves of a loophole in the Law-but I ask, how can you abuse the law if the Law allows you to do a thing, if it does not disallow you? There is another point; that say "you tell us that we must not have property, but why not? Here in the Cape the coloured man and the Asiatic have acquired property, and they have not done any harm in naving property.

You ask the to give an explanation of the word bazzar as appearing in the Law. I should say it is a place where trade is carried on. In the Law of 1885 the word bazzar is not used at all. There are a number of other words used indicating the places where they should live, the Law speaks of streets, squares, etc., but it does not make any reference to bazzara. In regard to the use of the words vested rights and the interpretation given by Mr. Gandhi, you must not lorget that he also spenks of successors there. Say a man has a business in Johannesburg, and the successor lives in Pretoria, there is nothing to stop the man who is living in Pretoria to go over to Johannesburg. If you grant that, and I submit that you cannot get away from that, then you must also grant that the man has the unrestricted right to shift his place as often as he wishes. The successor is always a newcomer, but my contention is that the successor need not necessarily have been carrying on a business such as the man from whom he is taking over. I hold that they all have the inherent right to trade. None of the men who are here were indentured labourers in the past. I do not say that they all had capital when they came in. Some of them worked themselves up, while others came with capital.

You will find that the petition which has been presented does not really say that the agreement entered into between General Smuts and Mr. Gaudhi should be maintained. The petitioners are concerned with the sateguards and privileges which they have hitherto been allowed to enjoy. The effect of the agreement was that the question of immigration was settled and a general promise was made by the Government that in respect of the administration of the existing law, where the Indians suffered under disabilities, the law would be administered in a just manner.

I interpret the word successor to be any person, any successor in fitle, no matter how he acquires his right to succession, whether he purchases it or otherwise. That is the only way in which you can explain it. It cannot mean; as has been contended, a man's heirs, because he cannot bring any of his heirs over the age of 16 into the country. As to the place, where a successor has to come from, I do not think it necessary that a man to succeed another must live in the
