EDITORIAL

Drainage and Irrigation Schemes and planned Settlements

Provided the Secretary of State for the Colonies approves of the Schemes by Sir Gordon: Lethem Governor and Sir Frank Stockdale, Comptroller of Development and Welfare, the Colony may expect grants totalling approximately Twelve Million dollars for the improvement of Drainage and Irrigation.

These schemes are printed as Legislative Council Paper No. 1A/1945 and are briefly described for record DUTDOBER.

Scheme No. 1 that is approved and is being carried out under the Colonial Development and Welfare Act 1940 is estimated to cost \$2,089882.

coheme No. 2 which was approved under the Development Trust Fund and estimated to cost \$415,952 is being carried out.

Scheme No. 3 which embraces main Drainage and Irrigation in the Cor-entyne and East Demorars, and estimated to cost \$5,678,250 has been recommended to the Secretary of State and the financing of same is under discussion.

Scheme No. 4, East Demerara Drainage, estimated to cost \$3,500,000 is still under consideration

The details of the Schemes mentioned above make interesting reading, the farmers in the future.

In your issue of Jan. 6, 1945, you state in Leadlines "Local Government Waves Dollar a Ton Tax from Colony's Revenue," and in the course of your first paragraph, by The Watchdog;"

May I point out to you that on December 20, 1944, in Legislative Council, the Hon. Attorney General moved and the Hon. F. Dies seconded the Expiring Laws Continuance Bill, 1944. Among the Laws to be continued was the Sugar Duty Ordinance, in respect of which the Governor had explained very clearly that in view of the increased price for sugar granted by the Ministry of Food, Government would not proceed with the proposal to waive the existing duty. The motion was passed.

The Editor: Indian Opinion Dear Sir.

I am writing this letter with the object of placing on record in a public organ my impression of an important matter which concerns the welfare of the inhabitants of British Guiana. I have come to this viewpoint after reviewing a few of the most recent incidents. The matter concerns the delays and indecisions of the Local and Imperial Governments.

A classical example is the Corentyne Drainage and Irrigation Scheme. When the Caribbean area was very hard pressed for food in 1942 and rice was urgently required in the British West Indies, the Corentyne Drainage and Irrigation Scheme received attention and a plan was drawn up to place the whole area under a proper system. Since then the whole situation has been changed somewhat and there is a gradual shifting away from the problem.

In August 1944, the Governor left for England where he expected (as we were told) to have definitely settled the matter with the Secretary of State for the Colonies; but much to our

surprise when he returned nearly three months later the matter stood exactly where it was in 1942.

We the public were informed that Sir. Frank Stockdale will arrive to FINALLY FINALIZE the decision. Much to the disappointment of citizens like myself what do we find, the matter is again referred to the Secretary of State for the Colonies. I am sure work will not be started until a decision is reached and I would not be surprised if the matter will have to be referred to the co-chairman of the Angio-American Caribbean Commission for his approval and lastly the people of British Guiana would be told-the Secretary of State has given consent to the plan and the money is available but ALAS there is no machinery with which to start work and you must await the conclusion of the war. Have patience-endure your chafe. This is British Guiana,-a Crown Colony.

CHANGING ASPECT

In Europe, there were several men of stature whose aspect changed in the shifting light of events. One of these was somber, iron-willed Charles de Gaulle. For four years he had been the symbol and touchstone of French resistance to the Nazi conquer or, but he had lived in the half-light of exile, In 1944 he returned in triumph to his free but prostrate country. In the liberated countries, he was the only exile who went back to a people solidly ranked behind him, and the only manwho seemed able to control the revolutionary ferments which liberation had set estir.

Winston Churchill, Man of 1940, hat also been a symbol. In Britain's darkest and finest hour, his flaming words and dauntless courage had heartened his country to stand alone against Hitler at the crest of his Blitz-krisg power. As one of the organizers of victory, Churchill had been magnificent. Now, in the last weeks of 1944, he was facing—with his usual truculence—the heaviest criticism of his World War II career; his critics charged him with responsibility for the civil war in Greece and for selling out.

Any sovereign nation may choose to drug itself with suspicion, ownersmisolation, and history does not deny a great man his place because his aims and methods are objectionable. History, someone has said 'is a record of events which ought not to have happened.' But Joseph Scalin was not the Man of 1944.

Union policy and basic principles are being rapidly adjusted to the needs of the Post-war cituation. The latest and most Significant development is the introduction in Parliament of a

Wages Councils Bill,

This measure which involves a change in the traditional attitude of Britain's Trade Unions towards State regulation of wages, has been the subject of full and careful consideration by the General Council of the Trades Union Congress in consultation with both the Minister of Labour (Ernest Bevin) and representatives of the British Employers' Confederation, The traditional attitude of Britain's Trade Unions towards statutory regulation of wages has been hortile : a cardinal principle of Britain's Trade Union policy bitherto has been to entrust the determination of wages and conditions of employments to the voluntary machinery of collective bargaining. Even the Trade Board legislation, dating back to 1909, under which minimum wage rates were prescribed and suforced in what were called the 'sweated' trades, never commanded the wholehearted assent of the Trade Unions. But the Bill now before Parliament goes farther than the Trade Board Acts, though it might be regarded as a logical development of the Trade Board

RADICAL ALTERATION IN METHOUS à

The Bill makes radical alterations in the methods by which wages wille be determined in post-war industry.One of the main provisions continues for five years after the war the provision of the Order of 1940 governing wartime conditions of ent ployment and setting up a national Arbitration Tribunal By the extension of the life of this Order employers will remain under the obligation to observe in their establishments terms and conditions of employment not less favourable than recognised terms and conditions " in the trade or industry in the district; that is to say, wage standards and

five years after the war. By this provision the Government is meeting the problem of stabilising wages in the immediate post-war years -after World War I a temporary Act of Parliament was passed to effect this Durpose.

But the Bill also brings into existence, permanent machinery for the statutory, regulation of wages. It does this by re-enacting the Trade Board legislation with amendments which will extend the powers of the Trade Boards (benceforth to be known a 'Wages Councils') and by endowing the Minister of Labour with additional powers to set up Wages Councils in any industry or trade where it is necessary to lay the louddations of better standards of remuneration for the workers.

In the view of the Minister the Trade Boards have fulfilled sheir original purpose. Mr Bevin dislikes the association of the Trade Board Machinery with the so-called "sweated trades" a definition which no longer applies to any considerable section . of British Industry. The Prade Boards are therefore to be developed and invested with additional powers to bring them into line with the statutory Wage Boards that have been created under later legislation to some industries-for instance, the Agricultural wages Board, the statutory Wages Board for the Road Haulage industry, and the Catering Wages Commission. Mr. Gandhi's Letter And Viceroy's Reply

A Press Note issued from the Viceroy's House, New Delbi, on July 1, stated :

As the substance of Mr. Candhi's letter of June 17 to H. E, the Viceroy and of the Viceroy's reply of June 22 has already appeared in the Press, the full text of the two letters is now released for publication :

Dear Friend-But for the fact that this letter is along the lines of your preoccupation I should not have troubled you with any letter from me,

2. Though there is little cause for it, the whole country and even many from outside expect me to make some decisive contribution to the general good. I am sorry to say my con-valescence threatens to be fairly long. Even if I was quite well, I could do little or nothing unless I knew the mind of the Working Committee of the Congress. I pleaded as a prisoner for permission to see them. I plead now as a free man for such permission; If you will see me before deciding, I shall gladly go wherever you want me to, as soon as I am allowed by my medical advisers to undertake long distance travelling.

3. I have circulated among friends, for private use, copies of the correspondence the passed between the authorities and me during detention. I do feel, however, that in fairness to me Government should permit its publication in the Press.

My address will be as above till 30th instant.
