The Honourable Pandit Hirday Nath every likelihood that soon that long, awaited Kunzru arrived in British Guiana May 10. He was warmly welcomed by the Indian Community at the Town Hall, Georgetown. He was also accorded a Civic welcome in New Amsterdam, Berbice.

> Speaking at Public meetings held at Georgetown and Berbice he deplored the deterioration that had occurred in the Indian Community and stressed the urgent need for taking steps to rehabilitate their culture and languages if they were not to disappear as a people in these parts. He also urged the need for the teaching of Hindi and Urdu in the primary schools in order to make Indians to remember their National heritage, so that they may not forget their moral basis of life. Hewent on to state that they had to guard against the great and iminent danger of losing their culture as there was no other culture to take its place in British Guiana or Trinidad. The help of the Government of both' British Guiana and India would be necessary in this connection.

It would be a grave wrong to the In-dians of British Guiana and Trinidad if the Government of India neglected this vital question any longer. Their greatest duty is to take up the matter immediately and energetically.

He also referred to the question of education, and Labour and stated that the condition of the Indian workers on the sugar plantations was extremely unsatisfactory. It seemed to him that there was a surplus of labour on the sugar plantations and unless Indians were settled as independent farmers in large numbers there could be no 'hope of improvement in their present misera le condition. The wages paid were so low that the great insjority of the workers were under fed and ill clad.

The housing arrangements in the main deserved to be strongly condemned, the workers lived mostly in over-crowded barracks and the surroundings were insanitary, at least during the rainy season and thoroughly depressing.

The arrangements for the supply of pure drinking water were also unsatisfactory; be was told that in some places there was no provision for pure water supply.

Regarding education. his view was that the Indian Community had been gravely neglected. There was great overcrowding, and almost all the schools belonged to Christian Denominations, it had been authoritatively stated that in consequence of this. Non Christian Indians could not be appointed head masters in any of the schools and few could even be assistant masters, while in these schools the salaries of all teachers were paid entirely from the revenues of the Colony. Mr Kunzru then stressed the need for the appointment of an Agent of the Government of India. Without an Indian Agent there was scarcely any chance of the needs of the Indians receiving proper attention. The Indian public and the Indian Government should therefore vigorously press the British Government to permit his appointment so as to prevent further neglect and degradation of the Indian Community.

The Need For Consumers' Cooperatives

Man in his search for politico economic forms of organization for the promotion of his welfare has accepted capitalism, tascism, socialism and communism. Most of us are aware of the short-comings of political democracy with its attendant capitalism and free enterprise which has for its prime motive the acquiring of profits. We have just witnessed the fatal termination of Italian Fascism and German National Socialism, both outgrowths of a decaying capitalism. One still finds, however, in our midst native fascists and Franco lovers. Of Socialism and Communism with the philosophy of from each according to his ability, to each according to his need", most of us are sympathetic, a few perhaps a bit sceptical of the means pursued to achieve this just end, having been bombarded by adverse propoganda. Living in a colony dominated by the Colonial Office in London, we have no choice but to slowly evolve within the existing frame-work of capitalism. It is in such a situation that the cooperative move-ment, the so-called "Middle-Way" of the Scandinaviau countries finds itself as an organization for the promotion of human well-being.

A consumers cooperative society is a voluntary association of individuals organized democratically to supply their economic needs. Whereas the prevailing capitalistic philosophy of profit and self-interest places the welfare of the individual above that of the group, that of the cooperative movement recognizes that the welfare of the individual will be advanced by promoting the welfare of the group. In capitalism, the prime motive is the acquisition of profits.

The cooperative movement, starting as it usually does among the lowest income groups recognizes the practical impossibility of members of those groups ever acquiring profits. It also recognizes the exploitation of that group by those possessing the economic power to acquire profit for themselves. The prime purpose of a cooperative is to perform an economic service for its members.

The basic principles of a true cooperative are (1). Membership is voluntary and unlimited, with one vote per member. This principle has its foundation on true democracy both political and economic. It implies no compulsion or coercion, and at the same time reserves for each member one vote regardless of how much capital he may have invested. It preserves time democratic control, not allowing control to pass into the hands of the few who may possess several

(2). Owners of invested capital are paid a limited rate of return, while not surplus savings are divided on the basis of patronage. The cooperative idea is that capital is only one factor in the production of commodities and consequently shouldube paid a fixed wage. One fundamental difference with existing corporate practice is that profits shall not be distributed on the basis of number of shares held or amount of capital invested, but are to be divided among its members according to the volume of their individual purchases.

(3). Merchandise must be sold at the current price a strictly cash basis.

There are various types of cooperatives. The most common perhaps is the retail marketing of groceries and food stuffs. Cooperative retail stores of this nature would definitely pat an end to the abnoxious practice of black-marketing, and at the Bame time eliminate several middle-men whose profits add to the burden of the poor consumer. In other countries the movement has apread into the retailing of gasolene, oil, supplying of credit through credit unions, insurance, housing, health and burial associations.

The attitude to cooperatives by American Big Business may be summed up from Babson's reports of 1935. "It has something of truth and crushding quality almost like a spiritual revival potentially it has enough votes, enough money and enough economic soundness to split things wide open.....we must watch our steps if consumers ever become wise to their latent powers, and decide to become dictators in fact as they are in theory."

Conference Unanimously Passes Resolution For Indian Commissioner

WHEREAS there are many problems peculiar to the Indians in British Guiana:

AND WHEREAS for the preservation of good relation between the Indians and other races, and between the Indians and the Government of this Colony, an Indian Commissioner would be of considerable assistance in promoting that relationship.

AND WHEREAS there are appointed in this colony Consuls and in some cases vice consuls for several races resident here, and such appointments are serving a very useful purpose.

AND WHEREAS in no less a degree there is need for the appointment of an Indian Commissioner for this Colony by the Government of India, and such an appointment would not be incompatible

with the interest of the other races.

AND WHEREAS the necessity for the appointment of such a person has been conceded by the Council of State for India by a resolution passed by the Council, a few years ago, which was moved by the Hon. Pandit Hirday Nath Kunzra.

BE IT RESOLVED that this Conference Firstly, records its profound gratitude to the Hon. Pandit Hirday Nath Kunzru for his assistance in initiating and guiding the passage of a Resolution in the Council of State of India for such an appointment. Secondly, that this Conference unanimously affirms the urgent necessity for the appointment by the Government of India of an Indian Commissioner for this Colony who shall himself be an Indian, solely responsible to the Government of India with as nearly as possible similar powers and privileges or a Consul, and respectfully requests Hon. Pandit Hirday Nath Kunzru to take all steps necessary bringing about such an appointment at an early date.

WHEREAS Mr. Hammond—EJucational Adviser to Sir Frank Stockdale—Comptroller for Development and Welfare in the West Indies has examined and reported on the Education System of British Guiana.

ANDWHEREASMr. Hammondhas recommended that all new School Buildings erected in the future be controlled by Government, and existing Buildings be administered under a TRUST SCHEME until such time as Government is in a position to assume control of such buildings

REPATRIATION AND LAND SETTLEMENT.

WHEREAS there is a large number of Immigrants in the Colony entitled to Return Passages to the Port in Judia whence they came;

AND WHEREAS for economic and other reasons it would be very desirable to cencourage their remaining in the Colony;

AND-WHEREAS a strong factor in achieving this end would be the granting or transporting of land or the making of money payment to them in lieu and satisfaction of their right to Return Passage under the provision of Section 195 of the Immigration Ordinance, Chapter 208;

AND WHEREAS it is certain if suitable offers are made a fair number would avail themselves of such offers;

AND WHEREAS in view of the war having spread to the Pacific it is not possible to reputriate Immigrants at the present time, and this situation may continue for some time in the future;

BE IT RESOLVED that this Conference respectfully requests Government to offer at an early date suitable lands or money payment to all Immigrants, their wives, children, and/or dependants entitled thereto in lieu and satisfaction of their right to Return Passage in accordance with Sections 193 to 195 of the Immigration O:dinance. Chapter 208;

AND BE IT FURTHER RESOLVED that this Conference urges upon Government as an alternative measure the establishment of land settlements at suitable sites for such Immigrants when the equivalent of their Return Passages may be utilised towards the cost of the lands taken tip by them under such settlements.

ALTERNATIVELY upon refusal or failure Government be asked to afford shipping of illiteracy among the Indians particularly. facilities immediately after the cessation of War in the Pacific for transporting every Immigrant and those entitled to back passage and wishing to be repatriated,

AND BE IT FURTHER RESOLVED that this Conference respectfully ask the Hon. Pandit Hirday Nath Knazru to make full representation in respect of the above in India and anywhere else he may deem fit on behalf of the Indians in these parts.
