MASS MEETING OF TRANSVAAL INDIANS

MASS MEETING of the Transval Indians was held in Johannesburg on Sunday the 15th March to protest against the new Immigration Bill. The chairman of the meeting Mr. Cassim Adam delivered the following speech :-Gentlemen,—No doubt you have already read in INDIAN OPINION what this new Immigration Bill means. But have you understood all that it may be made to mean to us Indians of the Transvaal! At the present time the registration certificate is your "pass". If the authorities question the state of the pass". If the authorities question the right of any Indian to be in this holy land of the Transvaal, the production of the registration certificate is his best answer to that challenge. If he seeks to enter this province from abroad the production of the registration certificate is sufficient to show his prima facie right to do so. Without the production of a registration certificate he will probably be refused the issue of a trading licence even after the municipal authorities have granted him the certifi-Under the law as it stands the title of the holder of a registration certificate can of course be challenged on the ground of fraud, or an Indian may still be denied the domiciliary rights in the province because he has been absent for more than three years, in spite of his being the lawful holder of a registration certificate. In the former case, however, the burden of proving the registration certificate holder's fraud is, rightly, upon the authorities who allege it; in the latter, domicile may be re-established by a renewed stay for a continuous

The new Bill will, as our counsel has advised us, reduce the registration certificates to 'scraps of paper'; they will have had taken from them all any protective value. Every Indian will be liable to undergo an inquisition, and be made to give a satisfactory account of his original entry into the Transvaal, or. that of whoever may be responsible for his being The whole community is liable to be challenged as prohibited immigrants, and each member will be compelled to prove his right even though he was brought here as an infant, on pain of expulsion, should he fail to satisfy the inquisitors. It will be seen, therefore, that the outlook is grave. It becomes alarmingly dangerous when the object of the new Bill is grasped. That object is to accomplish what the Gentleman's Agreement has failed to do, the appreciable reduction of South Africa's Indian population. It is the old story of "hook or crook". The baited hook of assisted repatriation failed to catch the fish, hence more forceful methods have to be dynamited.

Let me recall the history of the registration certificate the better to illustrate the callous disregard of promises, pledges, con pacts, entered into by responsible Ministers before this Government took office and by which according to all the recognised canons of political decency and honesty this Government should hold itself bound. We have been told again and again that the white man's word is his bond. But history has proved not only in our Motherland but in South Africa that the white man will only observe the sacredness of his promise to

Indians and Bantu so long as it suits his convenience. The Indian community in the Transvaal has been sold by the farliament of this land, and we are faced with the same position as Mahatma Gandhi was in his days here. At the present moment there is only one method, even at this eleventh hour to appeal to the Union Government not to get the third reading of this obnoxious Bill passed, but to get this question postponed until such time as the Round Table Conference meets when this question could be fully discussed with the representatives of the Indian Government. The Indian community is not asking for any new rights, nor for any fresh privileges; but it does ask in the name of everything that is honourable, true and just, that those few remaining rights which we have secured by our sufferings and sacrifices, by the death of many of our people in the jails of this country, should be preserved to us. In the words of General Smuts the possession of the registration certificate was the Magna Charta of the Indian community of this province. Solemn promises were given by the learned General after the passive resistance struggle of 1907. Whatever may be done against the Indians, we were assured, this right of entry into the Transvaal by virtue of having registration certificates will never be taken away. To-day the wrong is about to be done by the passing of the Immigration Amendment Bill in Committee stage. I appeal to the Minister of the Interior to do the right while the Bill goes for consideration, by granting our request.

The history of the registration certificate shortly is as follows:

Shortly after the Boer War Lord Milner urged the Indian community to accept his suggestion that they enregister in order to satisfy the agitators who resented the Indians being permitted to share the new Tom Tiddler's ground just won. "Take them," new Tom Tiddler's ground just won. "Take them," urged His Lordship, "they will give you the right to be here, and to come and go". Anxious to conciliate, our people did take them; took them in the belief that in so doing they were making concessions to suspicions and prejudices that would speedily pass; took them in all good faith and trust in Lord Milner's assurances. The period 1903 to 1907 shows 4 years of ceaseless effort on the part of the then authorities to segregate us and to oust us from our businesses, of continued struggle on our part to resist the threatened attacks. Then came the 1907 Immigration and Registration Acts, under Responsible Government and the consequent Passive Resistance campain. That is 23 years ago, but the painful agony endured by those who took part in it is still remembered.

That struggle, my brothers, was not for loaves and fishes, for material gain, for worldly wealth. Men and women, your fathers and mothers, brothers and sieters, suffered imprisonment and sickness, endured to the death, sacrificed everything for their honour and your honour, so that the status and the dignity of Indians should be preserved. It was for that they resisted the differential legislation; they

TRANSVAAL INDIANS AND REGISTRATION | CERTIFICATES

R List Fri THERE exists a good deal of misapprehension concerning Indians and their Transvaal 'Registration Certificates. There is probably not an Indian in the whole Province who does not feel the sting, the indignity, of having to carry a "Pass", this certificate of his undesirability, this brand-mark of his inferiority. 'There is certainly not one who would not gladly welcome consigning the precious document to the flames, but for its protective value. It has been said that the Registration Certificate is, so to speak, hallowed for certain sentimental reasons; possesses for its holders value because of its association with the Passive Resistance struggles, Any such contention, though excusable, is somewhat misleading, "The naked truth is "that" the Registration Certificate always has been and always will be an abomination. But, while there is nothing sentimentally precious about the Certificates themselves, 'a very great deal of sentiment does attach to the events that led up to their ultimate adoption; to the martyrdom: that was suffered in the ultimately successful effort to resist the implications their imposition, it was thought, e summ a verste light conveyed."

The spirit in which the community acquiesced in the appeal made to them to fail in with the original proposal to register was all to the people's credit; an example of 'noblesse oblige." The Pro-Consul was a past master in the art of extracting the sting of seeming indignity, and refieved of the suggestion of racial interiority the certificates as such involved little more than the inconvenience of getting and retaining them. "Be it also remembered that at this stage and for long after there existed no statutory restriction upon Indian immigration on the score of race. The 1906 Ordinance, of which the Immigration Act (15 of 1907) was virtually a replica, was disallowed by the Colonial Secretary, Lord Elgis; the proposal of compulsory registration of Transvaal Indians, also advanced in 1906. was similarly rejected. Act 2 of 1907 and Act 15 of 1907 under Responsible Government, followed. Followed also the intensive Passive Resistance struggle, that probably

for the first time reminded the civilised world that there is a sincerer belief in the doctrine of the Christian Master among orientals than among many of His professed followers of the West. The struggle culminated in the passing of Act 36 of 1908, as supplementary to Act 2 of 1907. One has but to re-read the above two statutes together in conjunction with the Immigration Law, Act 15 of 1907, to perceive the startling difference, in tone and spirit, of the official attitude then and now. There has quite obviously developed a callous indifference to Indian sensitiveness side by side with a disregard of pledges and promises both expressed and implied. This is reflected in subsequent enactments and even more pronouncedly in their administration." The earlier, as well as the later, Passive Resistance struggles were primarily in defence of "amour propre", what we Indians labelled "self-respect". Indian sensitiveness on this score was appreciated by Lord Milner, was respected by General Smuts; as far as was practicable the sting of imputation of racial inferiority was withdrawn or at least concealed. In making concession to the prejudices and antagonisms the authorities felt themselves called upon to record in the form of legislation, the people were consoled with a consciousness of stooping to conquer. More than once was it said of them, and to them, that "it was their virtues not their vices that were "feared." 'Apart from sentiment, it was felt that the acceptance of the Registration Certificates would, at least, constitute a guarantee of peace and inaugurate a period of tranquility wherein the community might shew their oppments the hollowness of the fears professed in respect of them. Both the Acts of 1907 and 1908 make the production of a Registration Certificate by its lawful holder a complete answer to any challenge of his "right to be here and his right to come and go."

THE NEXT CONFERENCE

ITS GREAT IMPORTANCE
(By C. F. Andrews)

VERYTHING will now depend on the next Conference which is to be held at the close of the five years Capetown Agreement.

Many have fold me since I came to South Africa, that the Indian community had gained nothing since the time in 1927 that the Capetown Agreement was signed. But surely this is in reality taking a short-sighted view of things. Let it be clearly understood that the Agreement itself included two important factors,—(1) the complete withdrawal of the Class Areas Bill, (2) the establishment of the Agent-General and staff as an institution in South Africa in order to relieve the tension between the Union Government and the Indian community.

The Transvaal has gained no less than any other province owing to these two matters being settled by the last Agreement. Therefore I truly believe that the situation is more hopeful to-day for the Indian community in the Transvaal (as well as in Natal and in the Cape Province) that it was before owing to these two new factors. It is not too much to say, I think, that the Asiatic Land Tenure Bill would have been the law of the Transvaal long ago, if 'it had not been for the work of the Agency, both in obtaining the original postponement of the Bill hi 1936 and also in giving such admirable evidence before the Select Committee in the same year. 'Its firm stand also this present year in again urging postponement until the Conference, has been remarkably effective. I would add that a very great number of individual cases have been dealt with shore leniently and injustice has been prevented in many important personal instances owing to the presence of the Agent-General from India and his staff.

It must be remembered that we have not only had the invaluable help of the Rt. Hon. Srinivasa Sastri with his private secretary Kodanda Rao and Sir Kurma Reddi with his son Gopal Kurma Reddi, but also the equally important and effective help of Mr.

Tyson and the Hon. E. Baring and every member of the Agent's staff. I have seen now for some years past Mr. Rickett's quiet work, and while congratulating him most heartily on his marriage I would like at the same time to acknowledge, along with the whole Indian community, the debt of gratitude that is owed to him for his silent constant effort. I should not leave out also Mr. S. M. Moodley whose own quiet work in its own way has been of great importance.

Last of all, in connection with the Agency, if we review the last five years quite calmly, we shall see, I am sure, that European sympathy and interest, such as had no existence in this particular way before, has been added to our resources since the Agreement was signed. Perhaps, in this matter, the opinion of one like myself who has been away and returned after four years' absence, is of value. I can say without any hesitation, that among Europeans in South Africa the situation has immensely changed since the Agreement was signed. I have seen this on every side and, above all, it has been the presence of the Agent-General and his staff that has so entirely altered the situation,

Now we are faced with another Conference. Whether it is to be in India or in South Africa is uncertain. But one thing is certain, it must deal fundamentally with the Transvall Question and find a solution, not only of the present acute points of controversy, but also of the earlier disabilities under which the Transvall Indians have suffered ever since the days of the Boer Republic. We have to review at the Conference the whole situation and find somehow a firm foundation upon which a good and satisfactory family life can be built up in the Transval.

Other questions, affecting other provinces, will undoubtedly be brought forward and dealt with at this Conference; but since the Transvaal matters have been the main points of controversy during the past years, it is clear that they must be the first points to be brought up and settled at the Conference.

fought to save you from the stigma of being branded as Pariahs, for the preservation of their self-respect and yours. The struggle terminated in terms of Act 36 of 1908, under which registration certificates were voluntary, the production of which by the lawful holder constituted a complete answer to any challenge of the right to be here or the right to come here.

The settlement of 1908 was a "compromise" also. We were to be left in peace. The 1913-14 struggle was also based upon considerations of status and self-respect, but I am now principally concerned to point out that our trust and confidence in those who assured us that our registration certificates were to be our title-deeds to right of entry, residence and ordinary opportunities to prosper, has been betrayed

again and again.

How are we going to meet the situation if this new Immigration Bill becomes Law! Are we going to share the memory of our martyrs! To brand ourselves cowards and traitors to the Motherland presently struggling to achieve nationhood. So I appeal to my countrymen that when the time does come for united action, none of us will be failing in our duty to respond to its call in the struggle to retrieve that which has been lost. We shall get what we earn, what we deserve. Let us not forget that these are gains greater than money and fixed properties, riches and comfort.

Gentlemen, you must have noticed in the papers a notice to the effect that the scholars attending Indian schools will from the first of April be called upon to sweep and to scrub class rooms and not only that but they will be compelled to clean the lavatories of these various schools. The Provincial Council in its wisdom has made this regulation only for non-European schools. Another example of

racial legislation.

European children are free from the performance of any of such tasks. The Government up to now has been paying a certain amount for school cleaning The amount was dependent upon the purposes. size of the building. These amounts were paid to the Principal and they had to engage some person or other to do the work. Now for the sake of economy the Provincial Council has decided to withdraw these grants and to make your sons and daughters road sweepers and scavengers. Will you parents allow such a state of affairs to exist? only advice to parents is to instruct all their children to passively resist any instruction that may may be given to them by the Principals of the schools. Let them become passive resisters. Protest should be sent to the Provincial authorities, the Educational Department and all the school boards. A resolution will be submitted to you and I ask for your unanimous support.

Resolutions

The following resolutions were then passed by the meeting:—

- 1. That this mass meeting of the Transvaal Indian Congress protests against the passing of the Immigration Amendment Bill being in the opinion of the Congress a violation of all solemn promises and assurances given by the Transvaal and the Union Governments in the past. This meeting appeals to the Union Government and more especially to Dr. Malan, Minister of the Interior, to suspend all further steps to make this Bill Law until such time as the Round Table Conference between the Gevernment of India and the Union Government meets.
- 2. That this mass meeting of the Transvaal Indian Congress appeals to the Government of India and its Agent, to arge upon the Union Government to suspend the Immigration Amendment Bill until

such time as the Round Table Conference between the two Governments is held.

- 3. That this mass meeting appeals to Lord Irwin, the Viceroy of India, personally to interest himself in the removal of the proposed disabilities under the Immigration Amendment Bill, and so prevent a revival of the 1907 passive resistance movement.
- 4. That this mass meeting of the Transvaal Indian Congress appeals to the Indian National Congress and the leaders of India, and more especially to Mahatma Gandhi to urge upon the Government of India to make representations to the Union Government for the suspension of the Immigration Amendment Bill now before the Union Parliament, until such time as the Round Table Conference takes place between the representatives of the two Governments.
- 5. That this mass meeting of Indians in the Transvaal strongly protests against the degrading circular issued by the Provincial authorities to Indian schools to the effect that as from the first of April school children should sweep and scrub school floors and clean out their own lavatories. We protest against the said action of the authorities on the ground of racial discrimination and appeal to them to rescind their resolution.

Cables Sent to Mahatma Gandhi And Congress President

The following are the cables sent by the Transvaal Indian Congress to Mahatma Gandhi and to the President of the Indian National Congress:—

Mahatma Gandhi, Karachi:-

Please confirm or correct. We feel that such step by the Government justifies our returning to position we adopted in 1907. Transvaal Indian Congress humbly offers congratulations your great work and prays for its fruition."

PRESIDENT, CONGRESS, Karachi:-

"Transvaal Indian Congress offers prayers complete success Indian National Congress deliberations. May Mahatma Gandhi's goal be fully reached. Appeal to you to reserve corner for consideration destructive legislation threatening us under new Immigration Bill already before Parliament and Asiatic Tenure Bill temporarily hung up."

Third Reading Of Immigration Bill Passed

An amendment by Mr. Duncan on the third reading of the Immigration Bill, calling for the submission of the Japanese agreement to Parliament, was rejected by 55 votes to 45 after a debate that lasted all afternoon and evening. Col. Stallard attacked the Minister's power to fulfil the agreement in view of the terms of the Immigration Act, but in his reply the Minister said he had full power under the clause and regulation permitting the entry of persons of whom he had been advised through diplematic channels. He said the Government's law advisers were satisfied in every respect of the agreement.

There are some servers the magnitude of whose devotion owes to silence such as can appreciate. In regard to our devoted friend Mr. Andrews, this is very much how I feel. Into what words can we put our grateful appreciation of Dinbandoo Andrews' work for us, for India and for humanity. How can we hope to express our feelings. As his Master gave Himself for mankind, so has Mr. Andrews given himself to us and for us. We can but reverence and silently admire and perhaps envy a little. He is with us and we feel inspired and hopeful. He goes from us and we feel lost and helpless. To us he is a father and friend. His presence encourages us like unto the presence of a brave captain among his army, and like a great captain he has fought for us and again and again saved us from defeat and destruction. 'Our loving gratitude", Dinbandhoo, and "God_bless you" are perhaps the most welcome thanks I can offer you and those words I say from my heart.

Mr. L. W. Ritch paid striking tributes to Mr. Andrews' work and said that Mr. Andrews was a sever of the people. His was a labour not only of drawing together the people of India, but of uniting the people of the world, irrespective of race, creed or colour. Messrs. Pragji Desai, Sigamoney, Mooljee Patel, Mavjeebhai, Gopaldas (of Messrs. Irikamdas Bros) Thambi Naidoo, D. M. Narsoo, Tavaria and others spoke in high terms of Mr. Andrews' services.

On behalf of the Fransvaal Indian Congress Mr. Cassim Adam and on behalf of the Patidar Society Mr. Mooljeebhai Master garlanded Mr. Andrews.

Mr. Andrews in reply thanked all the friends for the kind words they had spoken about him and said how he had to leave Dr. Rabindranth Tagore in America and hurriedly had to come to South Africa to render such assistance as he could to the Transvaal Indians in their darkest hour. He said it was yet undecided whether the conference was to be held in India or in South Africa, but wherever it was to be held he would be present. "There are two reasons of my going to England at present. First of all my sister is very ill there and secondly Mahatma Gandhi will be soon going to England. I would like to go to England before Mahatma goes there and try to prepare the ground for him in England. Once again I thank you all and hope to see you back.

Lord Irwin expressed his gratitude to the members
who, disregarding the risks and reproaches, had
attended the Session and prevented a rude setback

to Indian Parliamentary progress.

After the Vicercy had shaken hands with members individually the Assembly rose and cheered him.

Viceroy's Answer To "Iron Hand" Advocates -

New Delhi, Friday.

A striking answer to the advocates of the "iron hand" policy in India was given by the Viceroy at a farewell banquet here. He said there were those who saw in the present situation merely a movement engineered by a negligible minority which a firm Government could suppress. - Lord Irwin expressed the opinion that such a diagnosis was superficial and distorted, and wholly divorced from reality.

Nobody could deny that there was sedition in India, but Britain would delude herself if she did not recognise that, beneath the distinction of com-munity, class and social circumstances, there was growing an intellectual self-consciousness closely

akin to nationalism.—Renter.

India Congress Opens

Karachi, March 30 .- Ories of "Why drag in Gandhi's name every time? Why take shelter under his 'name?" indicated the temper in which the Congress Subjects Committee received Rajgopala-chariar, a member of the Working Committee, when he moved a resolution regarding Indians in South Africa and East Africa and remarked that Gandhi approved it as it stood.

The resolution, which was ultimately adopted, expressed alarm at the trend of events in South and East Africa and declared that the contemplated legislation was a contravention of promises, and in some respects even constituted an attack on the

Indian's legal rights.

The resolution appealed to the Governments concerned to mete out to Indians the same measure of justice as they would claim for their own

nationals in the free India.

Rajgonalachariar, when he was interrupted, asked the audience to let him have his say and explained that Gandhi approved the draft resolution but was not present, as it was his "silence day."

Striking Scene

The scene at the opening of the National Congress

was a stiking one.

More than 8,000 delegates and several thousand visitors of all ages squatted in a vast open air stadium called Motilal Pandu (tent) in memory of the late Pandit Motilal Nehru.

Several spot lights were concentrated on the stadium when Vallahhai Patel rose at dusk to

deliver his address.

The speeches were magnified by means of load aneakera

Gandhi, with Vallabhai Patel, was given an ovation as he entered and sat with members of the Working Committee on a dais several yards from the rostrum. The inaugural addresses were brief and were cheered from beginning to end. Sardar Kishen Singh, the father of Bhagat Singh,

who was excuted in connection with the Lahore conspiracy case, in response to the audience's invitation to speak, urged the young men not to be carried away by mere enthusiasm, but to be guided by wisdom.

Congress reached the apex of its proceedings in a three-hour debate, as a result of which it passed a resolution confirming the Irwin-Gandhi pact, reaffirming the goal of independece and demanding complete control of the army, foreign affairs and

The resolution also appointed Gandhi as head of a Congress delegation to the further Round Table . Conference:

End Of Congress Session

Karachi, April 1.—Storms of noisy enthusiasm resounded throughout the town at midnight denoting the end of the All India Congress, whose finanal act was the unanimous adoption of a resolution consisting of an elaboration of Gandhi's famous 11 points, forming an official definition of

"Swaraj."
The resolution demanded an Indian Native Government endowed with various fundamental rights, and laid down a catalogue with detailed provisions which included:—

Abolition of the Salt Duty;

Control of the exchange and currency policy and military expenditure;

Reduction of expenditure by at least half; Fixation of wages for industrial workers:

Protection of Indian cloth by the exclusion of foreign yarn;

The Congress session was orderly, and the speakers were heard in silence.

The plenary session endorsed the resolutions adopted by the Working Committee and the Subjects Committee urging the release of all political prisoners, deploring the communal riots at Cawnpore, and appointing a committee to enquire into the causes of the riots.

Telegram From Mr. Benn

Löndon, Friday. - According to the News-Chronicle's Karachi correspondent Gandhi has received from Mr. Wedgwood Benn's telegram assuring him that in any future round-table conference the constitutional safeguards will be regarded as entirely open for discussion.

This is held to have removed Gandhi's objections to attending future conferences on the constitution, which arise from Lord Sankey's recent statement on the finality of the safeguards. Coming on the eve of the Congress meeting this telegram will ammensely strengthen Gandhi's hands against the extremists, especially as Pandit Jawarharlal Nehru has now decided not openly to oppose the Delhi truce.

Nehru admitted privately that he is not in favour it, but added: "I am a disciplined soldier and of it, but added: must therefore remain loyal to our leader Gandhi."

Gandhi And Riots

The Times correspondent at Karachi says the Campore rioting has plainly depressed Gandhi. "I feel troubled and grieved" he confessed yesterday. The unplessant reality of communal conflicts has already thrown a shadow across the deliberations of the Congress.

In a public speech last night Gandhi, with great emphasis said that, if the Hindus and Moslems continued to divide India he would retire, go on hunger strike, and starve himself to death.

Asked if in the event or the same would accept being unable to reach an agreement he would accept Asked if in the event of the Hindus and Moslems the principle of British arbitration, he answered, should feel the deepest humiliation if it were necessary to refer the greatest of India's problems to Britain."

Gandhi said he dared not prophesy what would happen if the Congress refused to ratify the Delhi pact. "I refuse to face such a tragedy until it occurs," he said, but he admitted that he would not be surprised if serious opposition appeard.

None can harm me, he said. "As long as God wills I shall serve India. Gandhism, which my young friends shouted down yesterday, will not die with me, or will its believers."

Referring to the black cloth flower presented to him on Thursday on his arrival at Malir, Mr. Gandhi said that if the youth who gave it to him "came and confessed the error of his ways, he would return it to him."

A later message from the same source states that "it appears that Mr. Gandhi is ready to stake his career on the Congress, vote."

Sitting before his spinning wheel in his hut in the Congress camp, Mr. Gandhi told a group of journalists that if the Congress rejected the settlement arrived between Lord Irwin and him at Delhi the only course open to him would be to retire temporarily from political life as the rejection would be tantamount to a vote of no confidence in himself. If the agreement was ratified, Mr. Gandhi said, he would not accept an open mandate from the Congress to the Round Tuble Conference, but would ask for a restricted mandate defining the terms of independence and sateguards."
