THE LATE MR. RANGASWAMYIYENGAR

THERE seems to be no end to India's corrows. Thousands of innocent people are behind prison bars bearing the Cross in their straiggle for independence. As though that were not enough there are a hundred and one other troubles such as communal, religious and social. Mahatma Gandhi who was wholly engaged in the political struggle has been compelled by force of circumstances to divert all his energies for the time being to eradicating the age long evil of untouchability. Ere that is being done one hears of a terrible calamity caused by an unprecedented earthquake. And now ere the tears are dried over that shocking affair and over the recent death of Mr. V.J. Patel another great soul has been taken away by the God of Death in the person of Mr. A. Rangaswamy Iyengar. Mr. Iyengar was one of the most prominent Nationaist leaders in Madras. Born in 1877, the late Mr. lyengar was educated at the Coimbatore High School and the Presidency College, Madras, where he was graduated. He was clerk in "the Chief Secretariat; practised as a spleader in Tanjore and joined The Hinds which he bought and took up the editorship of The Swadssamitran, a leading vernacular paper, and from 1928 was editor of The Hands. The late Mr. Iyengar was elected to the second and third Legislative Assembly and was the Secretary of the All India Swara Party during 1925-27 and General

Secretary of the Indian National Congress during 1925-27. Mr. Rangaswami Tyengar went to the Round Table Conference held in London during the end of 1932 with Maketman Gandki. He refused invitation to the last-Round Table. Conference-in 1932 on the ground that all important leaders of India were at the time in prison and those who were invited were not the real representatives of the people. His refusal won him very high esteem among the people. The Hinds to day is known to be the dest news paper in India which was takedy due to the greatness both of the keed and least of the late Mr. Iyengar. We in South-Africa are doubly grieved in losing him. For apart from being one of the foremost Nationalist leaders of India Mr. Iyengar was a keen follower of our cause in this country which he had always championed. Never was there a mail from which when his paper did not contain something on the South African question. The only message he could give them, said Mr. Iyengar, was, "to organise, to unite, to sink your differences by a method of give and take and somehow to achieve that unity without which you will be weaker than you will otherwise be."

To let these words sink into us and to endeavour to put them into practice would, we think, be a fitting tribute by South African Indians to the memory of that great patriot whom the Almighty has snatched away from us. It is our fervent prayer that we may be inspired to do so. Indians in South Africa join their brethren in India in mounting their great loss. May the woul of the departed rest in sternal space.

APPEAL BY BISHOP OF NATAL

Midward .VIEW RACIAL PROBLEMS IN TRUE CHRISTIAN SPIRIT

CHOICE BETWEEN CIVILISATION BASED ON MORAL PRINCIPLES AND ONE BASED ON OPPRESSION
CLOAKED IN LANGUAGE OF HYPOCRISY

N appeal to all Christian churches to "review all racial problems from the standpoint of a common welfare and a common citizenship" is made by the Bishop of Natal and the Rev. F. Oldrieve, a leading representative of the Nonconformist churches in Natal,

The Bishop of Natal is president of the Indo-European Joint Council of Maritzburg, and Mr. Oldrieve the chairman of its executive committee.

The appeal is as follows:

"Convinced that the well-being of the country is one and indivisible;
"That the economic prosperity of our

Indian and native fellow-citizens will promote that of the white population also;

"That the contentment of the non-European races is a factor of the highest political importance; "That the mentality which sees a menace in the progress and prosperity of other races will react most injuriously upon South African culture;

"That the supremacy of justice in public as in private affairs, even beyond the limits of economic vision, is the foundation of all worthy citizenship and moral character;

"That the Christian religion stands for the effective realisation of the principle of brotherhood in all social, political and interracial questions.

"That we stand to-day before a momentous choice—the choice between a future civilisation based upon moral principle and one resting upon oppression cloaked in the language of hypocrisy;

"The undersigned, on behalf of the Indo-European Joint Council of Maritzburg, call upon the Christian churchs to review al-

racial problems from the standpoint of a common welfare and a common citizenship.

"To this end it suggests the holding of parochial meetings to discuss the problem of Christian duty in all questions of race.

"It wishes to lay down the principle that before the claims of any citizens, and especially before those of Europeans, are pressed in any matter that affects the welfare of other sections of the community, those other sections shall have the opportunity to state their views, and that a genuinely fair hearing shall be given them.

"It also appeals for new members for the joint councils, which are seeking to promote friendly co-operation between the races upon a basis compatible with our daily prayer "Thy Kingdom come on earth." It hopes that the Christian congregations may supply such members.

COLONISATION COMMITTEE REPORT

FORECAST BY 'MERCURY' CORRESPONDENT

JOINT COMMITTEE RECOMMENDED

THE political correspondent of the Natal Mercury from Capetown states:—

The special Indian Colonisation Commission has finished its report and will place it in the hands of the Government in about 10 days time, when the document has been typed, translated and signed.

I understand that the Commission finds that opportunities for colonisation do exist and the appointment of a Joint Commission by the Governments of India and the Union to investigate schemes indicated in the report is unanimously recommended. The document will be transmitted to the Government of India, upon which will rest the onus of taking the next step.

FACE SAVING.

The Indian Government is bound by agreement to initiate a colonisation inquiry, but a very strong impression prevails in responsible quarters that the Indian Government is not over-anxious for domestic political reasons to proceed with the colonisation project and that the suggestion at its best was merely a face soving device by the Indian delegation which attended the last round table conference in Capetown.

The completion of the present Union preliminary colonisation report will, at all events, establish whether the Government of India means business or is simply playing for time. There will be no delay in sending the report to India.

Meanwhile, the situation in South Africa with regard to Indian affairs is far from reassuring. It is important to bear in mind that the attitude of the Union Government ever since 1921, when the first commission recommended class segregation, has been that there could be no proper solution to the Asiatic problem in Natal except by a diminution of the Indian population.

When the 1926 agreement was signed controversy ceased in Natal in order to give the repatriation scheme a chance. Repatriation fuiled, largely because of the activities of the Indian community here and in India, and a secret dispatch sent by the Union Government to India in 1929 throws a flood of light on this point:

Secret Dispatch.

The dispatch stated: "The Union Government desires respectfully to bring to the notice of the Government of India the very marked decrease in the number of Indians leaving the Union under the assisted emigration scheme. During the first six months of 1929 only 822 left, compared with 1,841 during the same period last year and 1,648 during the second six months of 1928, while during the period July to October, 1929, only 239 left compared with 932 during the same four months of last year.

"Seeing that the Capetown Agreement itself is so largely dependent for public support in South Africa upon the success of the scheme, the difficult and ever serious position created by this rapid decrease will be fully appreciated."

The underlying note of anxiety over the boycott commenced by Indian leaders is apparent in the message. In 1929 the Indian population of Natal was estimated at 151,390 and in 1930 at 166,000—an increase of about 10 per cent.—and it was quite obvious that repatriation had failed.

The activities of the Indian section while the Union has been wrestling with this difficult problem are hard to understand. Their subsequent reluctance to support measures agreed upon by the Union Government and Indian delegations had created innumerable difficulties.

Furthermore, while the European population has for the most part abided loyally by the truce signed in 1926, Indians in South Africa have never ceased to agitate and have become increasingly bold in their demands—particularly of late. The presence in South Africa of a direct representative of the Covernment of India, who has apparently been allowed to interfere in matters of a purely domestic nature has been a further complication.

The fear is entertained in many quarters that the Government is not meeting demands from the Indian community as firmly as it should do and it is recognised that weakness by Ministers at this juncture may easily prejudice the future.

Warwick Ayenue Market mot land Last Wednesday afternoon the Morning Markat in Warwick Avenue was opened by the Deputy-Mayor Councillor S. K. Elgie, Among the other Councillors process were Mesers Kinloon, J. L. Farrell, C. F. Westrate, E. D. Layers and A. E. Wormen, Mr. H. Serridge, Assistant Borough Engineer, Mr. H. M. Cannon, Assistant Town Treasurer, Mr. Whitsitt.

Ohial Constable, Mr. W. J., Westbrook, the Market Master, a few Europeans, many prominent Indians. farmers and Indian buyers and sellers were also present to witness the opening ceremony. Mr. T. M. Naicker, the president and Mr. A. B. Naidoo, the secretary, of the Farmers' Association, were responsible for this opening function. After the garlanding beremony speeches were made appropriate to the occasion, the chairman tracing the history since 1910 to the present day.

Conditions At The Market

After the opening there were hundreds of parts with produce waiting to enter and there was a hitch before they were allowed to do so. The old practice was to allow them to sell and then collect the market dues but the new rule was that they should pay before they entered, this was due to some misanderstanding, as the farmers said they were unaware of it; eventually they agreed to comply with the new rule. The market is congested and there is hardly any room to turn about; the position is, not altered from the hygiene point of view and most of them will be in a worse position as they are not protected from sun, rain and storm. There is no space prowided where they may leave the unsold produce. A lot of improvement is necessary and is nrgently required before the producers and consumers and the health authorities could be satisfied.

Victoria Street Market.

In The old market in Victoria Street and the street fiself, now, in the early hours, looks deserted. The hustle and bustle and the jostling, the fruits and the greens and the spimated scenes are no, more to be seen; the stallholders and the shorkeepers wait patiently for the hour whon the Warwick Avenue market closes, to catch the trade thereafter. The old order has changed to the new and it will take some time before they get settled to the new state of aftairs. Let us hope it is for the better.

Surblus Population General Sunts, when he returned from Europe in 1919, was presented with an address of welcome by the Durban Indian community. In reply on that opposion, he said, "South Africa has its own difficulties and as a small white community cannot withstand A great influx of Indians. India, continued the General, if she is in need of emigration for her surplus population, has the fertile fields of Mesopotamia, Euphrates, Tigris and Turkistan, which can hold 30 millions of people." India, thought our worthy General, should settle her people there and not send them to South Africa. Dealing with the Indians in South Africa, he said, "But now that the Indians are here I hold they should have fair treatment in all parts of the Uniou. We have to live side by side in condillation, and we must endeavour to understand each other's standpoint, so that we may live together and grow together. We are members of the one family and belong to the same Empire." All this, he said, just fourteen yours ago and since the doors for emigration have been closed, would it not be statesmanship to accord that "fair treat-

let live. Surely the present trend of activities is no sign of peace and contentment to the Indian members of the Empire. The Right Honourable J. C. Smuts who is the Minister of Justice in the present Coalition Government ought to remember the sacrifices the Indians made during the war and should use his great influence to prevent class legislation detrimental to the interests of Colonial-born Indians and settlers. I hope the Government would realise that in these times of depression and want, the Indian's status would be improved and not made the target of budding politicians who consider self of more importance than the Empire.

Action And Reaction

The present state of affairs certainly dues not redound to the credit of the leaders who with one eye closed are leading the community to disaster. All the patting whicht hey are getting from high offices is so much eyewash to safeguard their own position. Any amount of dinner-equality or banquets even with members of the Royal family is not going to assist the people—the mass—from their present deplorable position. The amount of energy, time and money which would be wasted soon, in some such manner, could be better epent or stored for the benefit of those who are struggling hard to eke out a living to save their children from hunger and starvation. The Natal Indian Congress during the Prince of Wales' visit boycotted all celebrations in honour of the Prince because they were not invited to the civic banquet: What they would do on this occasion, I am not in a position to say, but if principles count for anything and if the position is similar to 1925, they would cartainly adopt the same course. I also , wonder what those stalwarts are going to do who were presented to the Prince a little over a year age at the Albert Park. Are they going to be left in the cold or were they good enough only then and not now? It is presumed that the Congress leaders or the Agent will seek out these veterans of 1925 to be presented to Prince George so that they, with those who have now been selected may be lined up for presentation. It would be an apoch making day and why should they be left out. Any schoolboy knows that acts of this nature are not going to restore the Municipal franchise, nor are they going to help to wipe out the anti-Aciatic laws of this country. All actions have a reaction and this bloff and incette, I dare say, would long be remembered after H. R. H. Prince George leaves our shores.

Indian Welfare Committee To Be Formed

RS. LAURA RUXTON presided over a meeting of Indian women at the Patidar Hall, Fordsburg. The meeting discussed the formation of an Indian Welfere Committee. The Indian women present represented the Transvaal Indian Women's Association (Johannesburg branch), the the Social Centre and the Indo-European Association. Each of these organisations will hold its annual meeting early next month, and six representatives will be elected to form the Indian Welfare Ocmmitte, which will meet in the Patidar Hall at 3.30 p.m. on February 25, to outline its aims and to elect its officers. An inquiry into Indian slum conditions and the provision of a baby and anti-natal clinic for Indian mothers will be one of the most important items on the Committee's programme for this year.

Indian Earthquake Appeal

A few days ago the South African Red Cross Society appealed to the public of the Union for funds for the relief of distress caused in the recent earthquake at Bihar, India. The South African Red Cross was acting on behalf of the International Red Cross in making this national appeal. Messrs. Gant's Bombay House, Klerksdorp, in response to the appeal have sent a sent a cheque for £6/6/- to The Star with a request that this amount be forwarded to the proper quarter. The cheque has been sent on to the secretary of the South African Red Cross Society, P. O. Box 3266, Johannesburg.

Reply To Tielman Roos

Mr. Tielman Roos's speech in Pretoria and Mrs. Jansen's, wherein they advocated the boycott of Asiatic traders, have evoked a great deal of public criticism. Two interesting letters appearing in The Star, (Johannesburg) above nom-de-plumes are given hereunder:—

Sir,—Mr. Tielman Roos's latest speech is most amusing. One wonders how any one with a grain of common-sense could suggest that the Indian in a country like the Union could be made to trade with his own race only. Why not extend this privilege to the English, Greeks, Afrikaners, Germans, Natives, etc.?

Mrs. Jansen's advice to the Afrikaners not to trade with the Indian will remain ignored. The poor class of Afrikaner will continue to support the Asiatic in preference to the alien element. They look upon the Asiatic as more honest and less exacting. There are no Asiatics in the Free State and very few in the Cape, and yet where can she find greater poverty amangst the Afrikaner element than in those provinces? There being no Asiatics in those provinces, why are there no Afrikaner traders?—REX.

Sir,—Evidently Mrs. E. G. Jansen did not make an exhaustive investigation of the conditions under which the Asiatic traders conduct their dealings with farmers before addressing the Reddingsbond meeting on Jan. 20.

Does she (or Mr. Tielman Roos) realise the countless advantages the farmer gets from his business connection with the Asiatic trader? Firstly, the Asiatic, on account of his sound principles of organisation, coupled with sound economy, can supply the farmer with necessities of life at a keener price than other traders. Secondly, can either of the speakers mention cases where Asiatic traders have forced honest farmers to dispose of their properties in order to pay their debts to the Asiatics? Do they realise the immense financial losses sustained by the Asiatles as a result of their readiness to assist farmers with their requirements on terms which are, to say the least, unheard of with European traders? I know of Indian traders in a certain district who have been defrauded by thousands of pounds by farmers over a period of a few years. Thirdly, do Mrs. Jansen, Mr. Roos and others appreciate the commercial uplift the Union derives from the circulation of the capital of Indian traders? How many of the traders, wholesale or retail, in South Africa are Afrikaner? A very meagre percentage. The leaders in every sphere of business are the foreigners. To regain "economic independence," the Afrikaner will have to attempt the impossible, for without the organisation which is the mainstay of the foreigner's success the attempt would indeed be useless.

The shipy motor cars in which the well-to-do traders go about are in a way a support of South African industries, and should not be a matter for criticism.—QUESTION MARK.

Lichtenburg Asiatic, Licences

As a result of the Council's refusal to grant a general dealer's licence to an Asiatic trader, Mr. M. Moosa, (London House), two letters have been received by the town clerk from the Administrator's Office. In the first of these, dated December 28, the Administrator wanted to know whether Mr. M. Moosa's application had been refused solely on the grounds of overtrading. A subsequent letter, dated January 4, pressed the Council for a reply to the earlier communication, and also asked whether the Council had given any reasons for its refusal to issue the licence.

A motion was tabled by Mr. C. J. Grove at the monthly meeting of the Council that the Council should inform the Administrator that Mr. Moosa's application had not been refused solely on the gound of overtrading, and in reply to the second letter, that no reasons had been give by the Council for refusing the certificate. Mr. J. Conradie and Mr. P. Hnyser asked that their names should be noted

as being against the first part of the answer. Mr. Conradie said that, in his opinion, by saying that the certificate was not refused solely on the grounds of overtrading, the Council admitted that one of the reasons was overtrading. Mr. Grove's motion was passed.

A special meeting of the Council-in-Committee was to be held to discuss the General Dealer's (Control) Ordinance with the Council's legal adviser. Speaking at a meeting of the Council in favour of calling the meeting, Mr. C. B. Maartens said it was time the Council should have legal opinion regarding the ordinance, so that they should know what powers the Council possessed, on what grounds a certificate could be refused and when they were not able to refuse one. The Council should also decide their future line of action regarding this matter,

Higher Education For Indians In Transvaal

How Increased Facilities Were Granted

REV. B. L. E. SIGAMONEY writes to the Rand Daily Mail:—"Sir,—With reference to the matter of secondary education for Indians, I would like to point out that the question of higher education is troubling the minds not only of the Indian community but of the coloured community as well.

In 1931 the then officials of the Transvaal Indian Congress met Mr. Malan, the Acting Director of Education, and the deputation was introduced by that faithful and devoted friend of the non-European, Mr. J. D. Rheinallt Jones. The Acting Director not only produced a scheme which he had formulated for higher education; but was also very desirous of starting on the venture. He was, however, held up by lack of money. Mr. Malan suggested that the deputation should get in touch with the Transvaal Eurafrican Teachers' Society, as there was no possible chance of a separate high school for Indians by reason of the fact that the numbers would not justify opening such an establishment.

Mr Rheinallt Jones called a joint meeting of certain officials of the Transvaal Eurafrican Teachers' Association, the Congress officials and Indian teachers. The result was that both these bodies met Mr. Malan in the School Board offices in Johannesburg. This deputation strongly objected to the present precises, because of the environment. A small sub-committee was appointed from this deputation to inspect the Village Main Recreation Hall. The sub-committee was pleased with the building and locality, and reported accordingly.

On January 8, 1932, the following letter was sent out to all concerned by the Education Department:—

"Establishment of a Combined Junior High School and Training Centre for Coloured and Indian Pupils at the Village Main, Johannesburg."

"I am directed to inform you that the Executive Committee has approved of the transfer of the training classes at the Krause Street School to the Village Main as soon as the building is available, which is expected at an early date, but not before the opening of the first term of 1932."

It was agreed by the Director of Education that at the end of 1933 the higher primary certificate course would be taken instead of the C.P.I.

MAs a direct result of the joint representations made, Indian and coloured youths for the first time in the history of Transvaal education sat for the Transvaal Junior Certificate, and there have been ten passes. Those who want to go in for the teachers course will now take the higher primary certificate, and those who want to take the Matriculation can do so.

Education and to all those who assisted, these facts should be published. In addition, the Transvasi Indian and the Eurafrican teachers' societies have been keenly alive to this subject.

University Examination Results

Two More Graduates

HE various results of the University degree examinations .. held during t November and December, 1933, are now available. The results of the Indian candidates, who are external students of the University of South Africa, were not published in the local papers; in which recently appeared the results only of the internal students of the different constituent colleges of the University. But private communication has brought the pleasing tidings that the Indian-community may now boast of two more graduated. They are Messrs. Y: Sirkari Naidoo, B.A. and Coopan Somasundrum, B.A.: There are now four Indian arts graduates in South Africa. The first, Mr. A. D. Lazarus, B.A., obtained his degree in 1930, working at Fort Hare. In 1932 Mr. G. Singh, B.A. graduated, also at Fort Hare. Both Mr. Lazarus and Mr. Singh as well as Mr. Sirkari Naidoo are now on the staff of Sastri College. Mr. Coopan Somssundrum, however, has expressed his intention of prolonging his sojourn at Fort Hare with a view to taking the Higher Diploma in Education. . . . 1

Mr. V. Sirkari Naidoo majered in English and Roman Law; Mr. C. Somasundrum in English and Psychology. Mr. Naidoo, in particular, deserves to be congratulated in that he has obtained his degree solely through private and individual effort. Ever since he passed his Matriculation in 1927 his has been a career of ambition and determination. The following are the courses he took:—English III, Roman Dutch Law I, Roman Law II, Mathematics I, Latin I, Criminal Law I, Chemistry I, and Constitutional Law L.

The following courses were taken by Mr. C. Somasundrum:—English III, History II, Pseyhology II, Mathematics I, Chemistry I, Latin I, and Ethics I. Let Mr. Naidoo, it will be noticed, has taken five law courses for his B.A. This entitles him to an exemption from the Prel. L.L.B. To secure the latter degree he has now, therefore, to put in two years more study.

It is also learnt that Mr. Jhuria Ramfakir has passed his second year in five subjects for the B.A. while Mr. Joseph Gabriel has also secured a pass in five subjects for his first year. Mr. Gabriel has in addition to his normal degree work also secured the Fort Hare College Diploma in Education.

Mr. G. Singh, B.A. took five subjects last November for his Prel. L.L.B., and news has come that he has secured a pass in all of them. They are: Roman Law I, Roman Dutch Law I, Constitutional I, Native Law I and Criminal Law I.

Durban Indian Market

iNew By-Laws'

The official Gazette of the Province of Natal, dated 25th ultimo, contains the Indian Market Bylaws as finally passed by the Durban Town Council at a meeting held on the 22nd December, 1933: Part I., Indian Market to be operative with effect from 1st March, 1934, and Part II., early morning section with effect from 1st February, 1934.

PART I.-INDIAN MARKET.

The market will be open every day, except Sundays, and Public Holidays, during such hours as the. Town Council may from time to time determine.

The stalls and stands will be let on monthly tenancy terminable upon one month's notice on either side, and the tenant has no right to the refund of any sum which he may have paid as Bonus in respect of the tenancy, or to any compensation whatsoever.

No stall-holder may sub-let his stall or stand without the previous consent in writing of the market-master, and no stall-holder may transfer his tenancy except with the approval of the Council. The market-master may divide the market into sections for the sale of different classes of articles, and may direct that any particular articles shall be sold only in the section set aside for the sale thereof.

The market-master may enter any stall or stand for the purpose of inspecting any articles of food exposed for sale, and, if such articles are found to be diseased, unwholesome or unit for human consumption, he may seize, condemn or destroy the same without compensation to the owner.

No stallholder may construct any fixtures or make any erections without the permission of the market-master.

Every stall-holder is responsible for any breach of the By-laws committed by his servants.

The Town Council may set aside a section of the market for the exclusive use of Natives for the sale of meat and offal, and for the carrying on of such other trades as the Town Council may determine. These stalls will be let on daily tenancy and no tenant will be entitled to occupy same for more than one day.

The Council is not responsible for the loss by fire, flood or theft, or from any other cause, of any goods the property of any tenant in the market.

DEFINITIONS.

"Stallholder" means the tenant or occupier of any stand or stall in the market.

"Grower" means any person who grows agri-cultural produce on his own land or on land rented

by him,
"Speculator" means any person who buys
agricultural produce on the farm or garden on wnich it is grown or from a market outside the Borough and brings the same to the market for

"Trader" means any person who buys agri-cultural produce or other articles from a market within the Borough, or from a local dealer or agent, or imports such produce or articles from outside the Borough for sale in the market.

""Manufacturer" means any person who makes baskets, native-made furniture, implements and earthenware pots.

"Agricultural Produce" means anything grown on a farm or garden for human consumption, and includes flowers, green lucerne, green forage and such dried products as the market-master may

permit to be sold.

"Closing Hour" means 9.30 a.m. on Mondays,
Tuesdays, Wednesdays, Thursdays and Fridays,
and 10 a.m. on Saturdays.

Every standholder must vacate his stand as soon as he has sold the contents of his vehicle, crate or other receptacle, although it may not be closing time.

No person may sub-lef any stall of stand. Vehicles may not be driven or taken into the market after 3 a.m. without the express permission of the market-master.

At the closing hour a warning bell will be rung after which no further sales may take place.

Growers and speculators may deposit unsold goods in the Storage Room on payment of the prescribed fee. All articles so left are at owner's risk.

The gates of the market will be closed 15 minutes after the closing hour and no person may remain in the market after the gates are closed.

TARIFF OF CHARGES.

The following fees or charges shall be payable to the market master in respect of all goods sold or offered for sale at the Early Morning Section in the market:-

1. For Agricultural Produce (excluding Streetberries) :-

Fees payable by growers and speculators.

(a) For two-wheeled vehicles, irrespective of whether the produce is loose or is con-tained in baskets, boxes, sacks, bundles or packages, is per vehicle.

(f) For boxes, baskets, sacks, bundles or packages brought in rikshas, handcarts or in vehicles drawn by more than two animals, unloaded at the entrance and carried by hand into the market, from 2d, to 4d, per basket, hox, sack, hundles 2d. to 4d. per basket, box, sack, bundle

or package (according to size).

(g) For storage of unsold produce for the first day free; but if same produce is brought in for storage, 2d. per basket, box, sack, bundle or package.

3. For New Baskets:—
(a) Small size, 1d. per pair; (minimum 1d.).

(b) For four-wheeled vehicles, 2s. per vehicle.
(c) If carried by hand, 3d per basket.

Drama

Occidental And Oriental

(BY RAMBLER)

EISURELY turning back through the pages o history one seems instinctively to falter and perp admiringly at the ancient Greeks. The Greek era is perhaps the most romantic, the most full, that Man has hitherto traversed. Particularising, the Greeks may be accredited, for instance, with the enviable reputation of having been the pioneers in establishing drama as a definite aspect in the social life of man. Though their drama may sometimes be stigmatised as having been mythical and allegorical, there is no doubt that the genesis of the drama may be traced right back to the toga ed Greeks. With the advent of the Roman Empire, however, Greek drama fell into decadence and it was not to be revived till the beginning of the 16th century in England, when the Renaissance fervour, overflowing from the Continent and from Italy in particular, into, what may be called at that time, highly initiative England, once more made it nossible for the playwright to breathe. The whole of the Middle Ages, which are often rightly capped with the epithet, dark, seems to have stunted not only the growth of the drama but all forms of art. With the exception of the Niebelungelied, man, apparently due to shortsighted religious bigotry and oppression, was never able during medieval times, to improve his cultural lot. Thanks to the Renaissance, which brought in its trail, freedom from dogmatic conventionality and narrow ecclesiastical orthordoxy, the drama in 16th England burst forth with conserved vigour like a bird that had long been encaged. In this way, one might easily trace the gradual evolution of the drama to its present form. But such is not the object of this epistle. •

On January 6th, I had the pleasure, which is by no means unique in Durban, of witnessing "Sahishnuta" or "Tolerance" which is its English, synonym. The play was staged by the members of the Arya Woonnati Natak Mundal in Durban and though the same play was staged 10 years ago in Durban, it drew an overwhelmingly large andience. The acting, generally speaking, was commendable, N. Lalbahadur, the producer-playwright evinced more mirth from the patient audience than one thought possible. A. Dulipsingh, the stage manager, also assumed a major role in the play and with N. Lalbahadur were the leading artists; both natural historic talent; they do what all great artists do; they seem to put their souls into their parts. Master Lorrick, nimble of foot impressed with his nautch dancing and voice.

There were others in whom was discernible artistic ability but I do not wish to labour each "Artist's talents ability out I do not wish to labour each artist's talents and drawbacks. It may require a thesis. What I should like to know is: why was there such a huge galaxy of songs. Everybody sang from the villain, Govind, to the heroine, Rughunan. Excess is as bad as want but one would, in the case of drama, certainly prefer a dearth of singing than an excess of it.

The play started at 11 p.m. The final curtain fell at a.m. One begins to wonder whether seven hours, when others are ordinarily asleep, is not belabouring the point. Circumstances, perhaps, are often taken into consideration but between the Indian play I witnessed and the typical modern play there appears to be a yawning gulf. Not that I blindly advocate following the modern tendency of regarding everything occidental as ideal; but for convenience, for effect and impressiveness, the more this gulf is bridged, the more progressive and living will be the current form of Indian drama. Short plays are often very effective; they create no tedium, they liminate an excess of oratorio and when the final curtain is turned down the audience is left as frost as when the

play started. This seems to be the sine qua non of the art of acting. .

It will now be apparent why I described at the outset the gradual evolution of the drama in the Oriental forms of drama can remain essentially so without in any way impairing its colour, but if the bistory of Western drama has lessons for the playwright, let him not regard them with disdain. Shakespeare breathed life into the English stage by borrowing on the plots of the Italians and the biographies of old Latin chronologists. Shelley, Keats, Byron and Wordsworth, in like manner, drew much of their inspiration from the unorthodox free-thinking Continent. So too, if there be aspiring artists and playwrights whose genesis may be traced to the East, let them not ignore entirely the universal lessons of the West. On the universal past let us build.

Please think forgivingly of me if I injure even in the slightest degree, your tender susceptibilities. Remember: harmful are the wounds of a friend. I meant not to decry "Sahishnuta" or any other play. My point in clear. In fact, not to be hyperbolic in the slightest degree, the audience was not in any way dis-appointed; they emerged from the ordeal with tears of deep pathos for the beroine; they were satisfied it was the best they had seen; it was good; but in the light of what I have said might it not have been better? leave you to judge.
