Bihar Relief Fund

WE are happy to announce that South Africa's contribution to the Bihar earthquake relief fund in response to the appeal made by INDIAN OPINION has reached the figure of over £1216 5 6 which is a sign no doubt that our appeal has not fallen entirely on deaf ears. We will discuss this question with further details in our next week's issue.

Average Native Student Equal To European

PROF. R. W. VARDER, Dean of the Faculty of Science of the University of South Africa in the course of his address to the congregation said, speaking from his own experience as an examiner, he had found the average of the Fort Hare student at least equal to the average in European colleges and on several occasions there had been found among them students of the first rank. This he said was true in regard to scientific training as well as in the department of mathematics.

Fort Hare Cannot Be Admitted

THE Witwatersrand University had some time back proposed that the Native University at Fort Hare should be admitted to the National Union of South African students. This was recented by various other members of the Union owing to the strong prejudice against Natives sitting together with Europeans. A commission was set up for the purpose of considering the question whether Fort Hare should be invited to join the National Union of South African Students, which, we understand, has come to the conclusion that the general opinion among South African students is that it would be impracticable to admit Fort Hare to membership. Fort Hare did not stand on the same footing as the various European universities and university colleges and was therefore not eligible for membership in terms of the present constitution of the Students' Union. The replies to a questionnaire showed that only a small minority found no practicable objections to admission. Barring that it is a University for Natives we do not know in what other way it is on a different footing to the other South African Universities. It is a case of colour projudice pure and simple,

Warning To Storekeepers

Two Asiatics, a storekeeper and his asistant, were charged before Mr. J. G. van Alpen in the Magistrate's Conrt, Johannesburg, under the Foods and Drugs Act, with selling a quantity of sugar which was discoloured bad smelling and containing part of the dead body of a mouse. Both of the men were found guilty, reprimanded and discharged.

WHY WE DIFFER

VHEN Mahatma Gandhi was repeatedly requested by the writer to express his considered opinion on the controversy which has unfortunately arisen on the question of co-operating with the Colonisation Inquiry Committee appointed by the Minister of the Interior to investigate into the possibilities of a colonisation scheme for settling South African Indians in other countries and to find out to what extent Indians would participate in such a scheme, Mahatma Gandhi most emphatically said he could not express any opinion unless he was on the spot. Similarly Mr. Andrews too wrote from India that he considered it wise to be silent on the question and that Mahatma Gandhi had endorsed that view. Mr. Andrews is now in London and he seems to have changed his mind and has made a statement which we publish elsewhere in this issue. We wish Mr. Andrews would have adhered to his former resolution till his arrival. We are sorry he has decided otherwise. We have always respected the views of Mr. Andrews and we would think twice before offering any adverse criticism. But on the present issue we are sorry to have to entirely differ from him. The question is complicated and so much misrepresentation has been made that it would nigh be impossible for one who is not on the spot to thoroughly grasp it. If anyone has really understood the question thoroughly in India we think it is The Hendu of Madras whose comments we have published in previous issues.

We wholeheartedly agree with Mr. Andrews that a pledge given should be considered sacred and should be observed as such. The verse in the Psalms quoted by Mr. Andrews: "He that maketh a promise to his neighbour and disappointeth him not, even though it were to his own hindrance, whose doeth these things shall never fall," is as sacred to us as it is to Mr. Andrews. We are fully prepared to discuss this question from this high moral plane without entering into the question of expediency.

Our contention is that those who have opposed the Congress co-operating with the Colonisation Committee are not guilty of having violated any sacred pledge, for no pledge to co-operate with a committee

of this nature was ever given. It should be the least necessary for us to explain that to Mr. Andrews because he had heated debate on the very question with the writer himself in Capetown during the Round Table Conference. Mr. Andrews is fully aware of the very strong resentment there was at that time against any substitution of the Assisted Emigration Scheme or the compromising of the rights of the poor Indians for any promised concessions. Mr. Andrews will also be able to recall the fact that it was only after it was explained by the Government of India delegation in explicit terms that India was going out on a mission to seek outlets for her own teeming millions, and an invitation was extended to Indians in South Africa to co-operate in that mission and to incidentally see if there existed any good opportunities for Indians in South Africa in such outlets explored by India and precisely not on the score of Indians being deemed undesirables or that their population was to be reduced, that the Congress representatives agreed to co-operate, and, that too, with certain reservations, namely, that the Congress would withdraw their co-operation if the assisted emigration scheme was not eliminated and if any matters discussed at the Round Table Con-, ference or anything in the Agreement did not meet with their approval. On the score of these re-servations alone the Congress was fully justified in withdrawing their co-operation with India's mission to seek outlets for her own teeming millions. By what stretch of imagination, then, the appointment of a local inquiry into the possibilities of a colonisation scheme for settling South African Indians in other countries and to find out to what extent Indians could participate in such a scheme could have any bearing with what is termed bombastically by the Congress leaders as their solemn pledge is beyond our comprehension.

Mr. Andrews' statement would certainly be irrefutable if a pledge as he imagines would have ever been given but if Mr. Andrews were to examine carefully the undertaking signed by him in Capetown jointly with the Congress representatives, and recompare it with the terms of the present inquiry, he would not fail to see in the latter a distinct departure from the original understanding.

Discussing the advantages and disadvantages of "co-operation with the enquiry committee, Mr. Andrews says: ""I personally can see no hindrance coming to the Indian community.....on the contrary, distinct good coming from it instead of evil. For it ought to be possible for the Indian community, by sending a member to serve on the committee of enquiry, to prove by evidence once and for all to the Union Government, that there is clearly no place for any colonisation scheme abroad in the future; and that the Indian community in South Africa is solidly and unitedly against any such scheme." If the community is soldly and unitedly against any such scheme, as it no doubt is, we entirely fail to see what purpose is served by co-operating in investigating the possibilities of such a scheme. Again, if it is assumed that there is no place for any colonisation why could it not also be assumed that there is a place?" And what if a place is found? Can the Government of India with any show of honesty shirk their responsibility in formulating a scheme

for settling South African Indians in such a place even as they formulated the assisted emigration scheme, for after all has not this colonisation idea arisen as a result of the failure of the assisted emigration scheme? Mr. Andrews seems to assume that nothing is going to come ont of it at all; and the Government of India, according to their Agent, are not contemplating financing any colonisation scheme nor do they believe there is any available country where Indians could go. It would be pertinent to ask then, what is all this fuss about? Is it merely to delay the evil day? Discussing the question from a high moral plane is this not camouflage? Are we not trying to appear what we are not to the government and the European people of this country? Could we not win their confidence better by being true to ourselves and true to them?

Mr. Andrews who has been the father of the repatriation scheme and is regretting his action to this day would, in our humble opinion, be better serving the cause of Indians in South Atrica by exploding the idea of repatriation or colonisation altogether and devoting all his energy to bringing home to the Government and the people of South Africa their duty to treat the comparatively small Indian community in their midst, eighty per cent. of which is South African born, with justice and equality.

Sacred Concert Incident

Mayor's Letter To C.B. and S.I.A.

(FROM OUR MARITZBURG CORRESPONDENT)
Mr. K. Soobramoney, Joint Hon. Secretary of the
Colonial Born and Settlers' Indian Association (Maritzburg Branch) received the following letter from the
Mayor of Maritzburg in connection with the incident at
the Sacred Concert held at the City Hall:—

"Dear Sir, -With reference to your letter of the 8th. inst. I am directed by the City Council to express its deep regret at and to apologise for the unfortunate incident which occurred on the occasion of the Sacred Concert on the evening of Sunday, the 4th March last. The Council feels that the position was due to exceptional circumstances which arose out of the visit of His Royal Highness the Prince George, and it is satisfied that there was no intention of doing anything derogatory to the feelings of members of the non-European section of the community. In an earnest endeavour to avoid any recurrence of a most unpleasant incident, the Council hereby gives its assurance that in so far as future public Municipal functions in the City Hall are concerned, suitable provision will be made for the accommodation of non-Europeans, provided of course that such public functions are open to all sections of the community."

Mr. C. F. Andrews On Colonisation Controversy

Mr. C. F. Andrews writes from London:-

HAVE refrained hitherto from expressing any judgment of my own with regard to the controversy which has arisen in Natal, within the South African Indian community, because I was intending to come out immediately to South Africa; and therefore it seemed right to suspend my judgment till my arrival. Furthermore, I had wished on this occasion to come out for purely social and educational work, and not take part, if I could possibly help it, in political matters. I had already written to those whose judgment I valued most, both in India and South Africa, and they had cordially agreed with this proposal of mine that I should do social rather than political work.

But from various causes the time of my departure for south Africa has been delayed again and again. It was impossible to prevent this, and on each occasion I took the best advice of those friends who were nearest to me, before deciding.

During this interval of silence, I have had time to think more and more clearly concerning the controversy, and though I wish still to adhere closely to my resolution not to take part in political matters when I come out, it now seems to me only fair and reasonable that I should give frankly beforehand my considered judgment on the point which is at issue; and I am vriting this statement for Indian Opinion, with that object in view.

I feel that the Indian leaders are right, who have strictly adhered to the pledge which they gave at the time when the new Agreement was made at Capetown and ratified afterwards. That pledge is a sacred pledge, and it should be observed as such. There is a verse in the Psalms which has always appealed to me; it thus describes one of the marks of a man, of character and religion: "He that maketh a promise to his neighbour and disappointed him not, even though it were to his own hinderance,—whose doeth these things shall never fall." (Ps. 15.4).

Even therefore supposing some hinderance were to come to the Indian community from keeping the promise made by Congress to the Union Gevernment, this would not, in my opinion, settle the matter. The promise ought to be kept at whatever cost. But coming down from that high moral plane to the question of expadiency, I personally can see no hinderance cominge to the Indian community at this stage, from keeping the promise made at Capetown, but, on the contrary, distinct good coming from it instead of evil. For it ought to be possible for the Indian community, by sending a member to serve on the Committee of Enquiry, to prove by avidence once and for all to the Union Government, that there is clearly no place for any colonisation scheme abroad in the future; and that the Indian community in South Africa to-day is solidly and smiledly against any such scheme.

I am well aware how intensely in earnest South African Indian opinion is against epening the door to even the slightest compromise on this critical matter. I can also sympathise with the South African Indian community wholeheartedly in

feeling that children who have grown up in South Africa and learnt to realise that South Africa is their only home, should not be sent away, against their own wish, merely by their parents' consent. This treatment of South African-born Indian children clearly has become a serious wrong; and I deeply regret that I have not in the past more strongly objected to it, when the matter might have been brought up for settlement. But this does not make any weaker my conviction that we ought now to keep the pledge given at Capetown.

Our Indian Letter

(By CASUAL)
The 'Quake

NDIA has more than its share of human misery. Nowhere is the problem of poverty more acute. Famine is almost synonymous with India. Foreign rule with all its attendent evils is also a big feature of ours. But we had always been congratulating ourselves on the absence of serious earthquakes. Our self-satisfaction, as all your readers know, has received the rudest shock possible." We will no lenger read accounts of earthquakes in Japan and elsewhere as though they were fairy tales. We have now our own fairy tale to tell to every one who will listen with sympathy. We do not know what sort of accounts you have been receiving. But no fictitous story could possibly convey an exaggerated impression of the devastation caused by the earthquake in Bihar. All that remains of three or four big towns and scores of villages is heaps of bricks, iron and timber under which still lie buried hundreds of human bodies. The number of deaths so far ascertainable is in the neighbourhood of 6000. Both official and non-official agencies are working away at high pressure to bring relief to the sufferers. It is no easy task. It is bound to take six months if not more before we get a correct measure of the damage and the work of reconstruction to be carried out. Funds for this purpose are pouring into the hands of the well known Congress leader Babu Rajendra Prasad. It was indeed a divine merce that his release from jail on account of ill-health should have come just a day or two before the earthquake on 15th January. He is one of those who enjoy the esteem and confidence of the entire nation. The big response therefore to the appeal for funds is not a little due to the personality of Babu Rajendra Prasad. His fund now amounts to nearly 14 lakes of rupees. The kiceroy, who has also inaugurated a fund, has collected about 17 lakhs, most of his contributors being Princes or merchantprinces. But both the funds combined do not make up more than a flea-bite. Lakhs won't do where crores are wanted, excepting for the purpose of affording relief of a very temporary and urgent mature.

It does seem somewhat strange that Indians in South Africa have not so far come forward with the large donations some of them are undoubtedly capable of making. Never was there a greater need for money. It is not at all too late for them to wake up and once more fulfil the great tradition of their past.

Colourful Cricket

There are ever so many things about which one can write. There is the M.C.C. visit to India which has just concluded. It has certainly kept up keen interest and excitement. Our White visitors have been feted and garlanded all over India but unfortunately, however, they have left behind a poor impression of their sportsmanship, and their muchyaunted sense of fair-play. The last match Madras was characterised by the display of savage tactics on the part of the M.C.C. which nearly caused us a couple of lives at the wicket. We are told that it is not customary to grumble whem the ball hits you because it is meant to bit you if you can't hit it. But that only reminds us that when some years ago our fast bowler Ranji proved troublesome to a M.C.C. team in an identical way quite a hue and cry was raised against: kim. 🙉 🗓

Mr. Jardine has made matters worse by raising an eleventh hour objection to an Umpire, who is an Englishman and a veteran oricketer himself. Why a winning and a superior team should show such desperateness it is difficult to understand. But this is not the worst. The parting at Madras was more in the nature of a "Good-bye" than an "Au Revoir." The colour question crept up at Madras and the Indian team found; themselves unable to attend a dinner party at which both were invited. They complained, of gross discourtesy and an utter lack of appreciation of the extraordinary, hospitality lavished all over India on the guests. But I suppose the best thing is for people to try and forget these things until the next time. Then we can start all -over again India and the Indians can hope for better luck both on and off the field.

I cannot afford to refer to other topics, if only , because I am anxious that your readers should realise that there is no more burning topic at present than the situation with regard to the earthquake and that, all efforts have to be directed towards the alleviation of distress in Bihar.

Englishmen Up In Arms

FNERAL HERTZOG, the Prime Minister of the Union of South Africa has disturbed the horret's nest by his new draft legislation which would soon be on the anvil in a few days. His Bill first of all seeks the right to declare South Africa's neutrality if Great Britain becomes involved in a future war. Secondly, only South African nationals may become members of the Senate or Assembly and thirdly to deprive the King of his power to veto any future amendment of the South African Act, as also abolishing or reducing the powers of the Provincial Councils. This is in a nutshell what he is siming at and against which the Englishmen are up in arms.

All Tends To Republicanism

It is clear as daylight that this new move of General Hertzog backed by Dr. Malan and others is exactly what he laid down when he was thrown out of the Botha Cabinet and formed the Nationalist Party over twenty years ago. He was young then and his language was not clothed in the diplomatic garb nor was he or his party strong enough to force the Government to accept his principles. The posttion to-day is different and all the stars are in his favour and constitutionally he is in a far better posttion to carry out his life's dream. There should be no doubt that if this legislation is passed South Africa for all intents and purposes would be a republic, only, not in name. But then the next steb after making England impotent constitutionally would be simply to declare this country a Republic and legally England could not their litteriere. Did not General Herizog with some of his present cabinet members go to England on such a mission and has not the way now been nicely paved for Hitt to achieve his object without firing a shot? Are not the Englishmen in Natal and elsewhere already finding that they are beaten at their own game? These are questions to be pondered over.

Indians' Invidious Position

The Indians who are observing this battle of wits between the Dutch and the British are placed in a most unfortunate position, not being enfranchised they do not know where they are. Their staths in not declared, they are either British subjects or South African nationlds, would that their position was once for all clearly defined and that they were made to feel that this was their home and they had their responsibilities as others in the welfare of the dollartry in which they lived. I trust that the Prime Minister in his new legislation will clear this snomaly. Indians are here and most of them know no other country, their standard of living is more of the West than of the East and to leave them grobling in the dark does not redound to the credit of any civilised Government.

Telling Facts

.Mr. Philip Townshed of Mayville writes to the Natal Mercury in reply to a correspondent who had

stated that an Asiatic will never spend a penny in a European store if he can trade with an Amatic. "Out of the 10,000 Indiana," says Mr. Townshend, "who, at great expense have been repatriated, I olaim that at least balf were consumers, to some extent of South African made footwear, clothing, finery, mesliemesl, milk, sugar, tobacço, jam, liquor, stationery, and humerous, other things which divilised Indians use, To ship these customers away to another country, he continues, must surely have had a deleterious effect on local trade and industry." He then dwells on the question of "Asiatic penetration" which he respectfully submits has no meaning in view of the very large number of Asiatios born in South Africa and who, he suggests, should be considered Afrikanders like the rest of there if they pay their taxes. His letter hits the nail right on the head.

Can Never Be Beaten

The Mayor of Newcastle disappointed the Indian community during the Prince's visit when Mr. O. J. Christopher took up the task of running all the way to Johannahogia with the Powerstle, Indiana garland to present to H. R. H. the Prince George. He has now issued a statement that he has succeeded in his mission. It is presumed that had the Mayor of Newcastle known this he would have allowed the two minutes out of the thirty which was allotted to his dorp. It is rightly told that there is none to beat the Indians in showing their loyalty and Newcastle now has proved it beyond doubt. The Mayor must be saying with regret, "O, they have done it."

Nothing For Indian Charity!

It was only the other day the late. George, Shearer Armstrong of Durban died at sea and left an estate worth £101,295. The late Leon Renaud, advocate has left an estate worth £19,549. Both these gentlemen made most of their money from the Indians, one by using Indian labour in the sugar plantation. the other by having Indian clients. I do not envy their estate but what I do feel is that when they are gone they have left nothing for Indian charity? A little this way would have helped the many, poor and helpless Indians in Natal.

Work For Panchcourie De

Police officers at Sobtland Yard and also in the Union and Rhodesia are mightly puzzled over the trick whereby gold valued at £6,360, consigned from Bulawayo to a London bank, has been abstracted from a box and its place filled with cement and nails, It is stated that the seals on the box appeared. to be intact ret the gold was gone. There is a theory that the gold never left Bulawaye, but that a duplicate box was prepared and substituted for the treasure cheek. This reminds me of the great mysteries solved by that expert Mr. Panchcourie De of Calcutta. Would it be too much to suggest to Scotland Yard, Rhodesian or Union, officers of the C. I. Benjamin (representing the Natal and Maritzburg Coloured Welfare Society); Messra J. Messra, Thuin, and E. Young (representing the European residents of Ward 8); and Mesars P. Thompson, M. R. Naidoo, V. Kristy, and K. Soobra-Money, Sécretary, and the co Bake til Burneret

The Church Speaks Out

""It is hard to believe that these ladies can have been so much perturbed about the road surface and the loss of revenue to the Tramways Department that they overlooked the untold hardship such a restriction would impose upon the poor in general and their poorer sisters in particular. There are at present over 100 Indian buses in Durban, conveying literally thousands of the poorest members of the community, Natives, Indians and Coloured people, in and out of town. The termini of these bus routes are from two to two, and three-quarters not a mile beyond the tram termini. The charge for the complete journey is one ticket. If the suggestion of the National Council of Women were to be carried out and passengers brought by Indian buses to the tram termini were to be transferred to the trame, the cost of the journey would, of necessity, increase.

"The great majority of those who use the buses are too poor to afford an increase. One result would inevitably be that hundreds of poor women who now get to town by bus would be compelled to walk half the distance. They would probably travel by bus to the termini and then walk into town, carrying their heavily-laden baskets." 🧓

Many Europeans profess sympathy for the lot of the Indians but lack courage to give open expression to their feelings; for one at least to come out openly with the courage of his convictions is worthy of commendation.

"His intimate knowledge of the sufferings of the Indian unemployed and the hundreds of ill-fed and Commence of the contract of th

ill-clothed children—compassion has demanded a little sacrifice of his personal comforts to afford relief to them-probably impelled him to champion the cause of the Indian bushrivers against whom the National Council of Women is up in arms. How many of the members of the National Council of Women patronise the trams to save a loss of revenue to the Corporation? The discomfort experienced in the trams and the stigma attached to the six rear seats of the upper deck, which are invaded more often by the Europeans, drove the Indians to run buses. When they have thus voluntarily segregated themselves they are accused of being the cause of loss of revenue, and force is to be employed to bring them back to the discomforts and degradation of the trams. In certain shops the Indians who go there to help the revenue are rudely turned out and slighted, netwithstanding the representations repeatedly made by the Indian community. Would the National Council of Women intervene here and show their sense of "fairplay" by passing another resolution to remedy the wrong?"

THINGS IN GENERAL

POSTAL DIFFIGULTIES IN SYDENHAM

The Sydenham Ward Indian Ratepayers' Association in reply to representations made by them have received the following communication dated Feb. 19 from the Private Secretary to the Minister of Posts and Telegraphs :-

"Dear Sk,-I am in receipt of your letter of the 7th February. The Minister of Posts and Telegraphs has caused inquiry to be made in connection with this matter. The main cause of difficulty in delivering correspondence in Sydenham was that the streets and houses had not been named and numbered. These requirements have now been met and arrangements have been made for correspondence to be delivered twice a day by European postmen. These officers are experienced and it is reported that they man finding no difficulty in effecting deliveries. I shall be glad to hear from you as to whether you have any complaint now in regard to the delivery of letters in specific instances so that they can be investigated, by the Postmaster, Bushim. The Minister suggests that you should interview the Postmaster in connection with the matter if you are experientin any difficulty as it is within his purview to remedy mattern."

SPRINGFIELD INDIAN SCHOOL

.0

On March 17 certificates were distributed by the Rev. W. H. Stanton, manager of the above school, to the prize-winners in the arts and orafts exhibition organised by the Natal Indian Teachers Society held during the month of December, in which the Springfield Methodist Government-Aided Indian School excelled the other schools in Natal, having gained the trophy presented by Mrs. A. Christopher, for the second time in succession. The Headmaster of the school, Mr. D. P. Nundoo, in his opening speech, said that the success of the school in the recent exhibition was entirely due to two of the teachers, Mesers. S. R. Maharaj and S. Panday. He also pointed out that in the P. S. C. examination held last year, six out of ten passed, all having gained the continuation certificate. Vernacular was also taught free of charge. The Rev. Stanton appealed to the parents to take greater interest in both their children and the school. He paid tribute to the headmaster and staff. Among other speakers were Mesers, R. Ramdharie, R. Perumal and S. R. Maharaj.

Non-Europeans On Rand Mines

In the Unior House of Assembly in reply to Mr. J. D. Heyns (Nat., Middelburg), the Minister of Mines said that 47,826 Natives, 668 Coloured persons and 118 Asiatics were employed in surface work on the Witwatersrand mines as at Feb. 28, 1934. The possibility of replacing such Natives, Coloured persons and Asiatics by Europeans had been discussed from time to time with the Chamber of Mines. There were, however, many occupations which could not justifiably be undertaken by Europeans and he was of opinion that it would be undesirable to employ Europeans at other than standard wages.

PREVENTION OF MALAIMA

At a meeting of non-European land-owners of Plessislaer, Maritzburg, held at the school an interesting lecture on the "Prevention of Malaria" was given by Mr. Bayer. A voluntary committee of sprayers, comprising twenty three members who undertook to apray all Indian and native homes in and around Plessislaer was formed. With the assistance of Mr. Bayer very good results in Ante Malaria work is expected.

By a bare majority of seven votes the South African Party has regained the Greyville seat in the Natal Provincial Council, rendered vacant by the death of the Rev. A. Lemont, who was elected as a member of the Home Rule Party. The result of the by-election, which took place last week was a victory for Mr. J. L. Farrell (631 votes) over his Town Council colleague and Labour opponent, Mr. J. Fyfe (624 votes).
