### Mahatma Gandhi's Health

OME anxiety has been caused by the publication in the local daily press of a message received from Mahatma Gandhi by Mr. H. Kallenbach which reads as though Mahatma Gandhi was unwell. The word is not unwell but "am well" meaning that Mahatma Gandhi has broken his fast and is well.

### India Government On Colonisation Report

In the Legislative Assembly Mr. C. S. Ranga Iyer asked a short notice question. "Will the Government be pleased to state what action they propose to take on the South African Colonization Enquiry report?" Mr. Bajpai replied:—The Government of India have informed the Government of the Union of South Africa that they will formulate their views on the report only after Indian opinion, both in South Africa and in India has expressed itself fully. They have so far received no indication of the reaction of Indians in South Africa to the report, They also propose to consult the Standing Emigration Committee of the two Houses of the Indian Legislature, as soon as they can place before the Committee representative expressions of Indian opinion in both the countries. Communication of their own conclusions to the Government of the Union is therefore, likely to take some time.

### Roos And His Centre Party

MR. TIBLMAN ROOS is still large as life. Anyone who says that Mr. Roos is no longer going to speak about Indians and make that a plank for his political propaganda is living in a fool's paradise. On August 15 at a largely attended meeting in Brakpan Mr. Tielman Roos is reported to have enumerated the principles of his Centre Party. If there was employment, Mr. Roos said, it was the duty of the State to see that the unemployed were provided with the wherewithal to live. No part of the European population should be allowed to sink. Another important principle of the Centre Party, he said, was the dividing line should be drawn between the jobs for white and black. All skilled and semi-skilled work should be given to Europeans. A man who simployed a native chauffeur ought not to be allowed

to have a car. "We must see," added Mr. Roos, "that the Indian does not eat up the businesses of our towns. Where they exist, conditions become dirty, unpleasant and a curse. I say that there is nothing unfair in confining Indians to their own locations. The Centre Party is going to do that, and I may tell you that there is not another party which subscribes to that principle." The Centre Party was also going to take away the vote of the native in the Cape,

### "This Restless Age"

Addressing the Ben oni Rotary Club on "This Restless Age" Mr. Duncan Little is reported to have said that human greed and the desire for personal success at any price was more intense than ever before. Just as the individual was to blame, so were nations. People to-day, he said, were indulging recklessly in the pleasures of life and giving little or no thought to the ideals and fundamentals which, should form a vital part of their very existence. Young people spent their time at cinemas and at dances, and were perpetually grovelling madly after new and more thrills. In the big cities of the world he went on, thousands of pounds were squandered nightly in entertainment and champagne, while, in the same great centres, millions were living in starvation and squalor. Real art and fine thoughts were rare, he said. It was the blatant, hectic age of jazz. Occasional periods of reflection and a stronger spirit of comradeship, he said, would go far towards making the world happier and sounder.

### Another Commission

The Government has appointed a commission to inquire into and report upon the working of the law relating to trading on land in the Transvaal proclaimed as public diggings under the Precious and Base Metals Act, with power to examine witnesses. The members of the commission are Mr. Sidney Maynard Page (chairman); Mr. W. M. Edwards, Senator the Hon. Gustave Hartog, Mr. P. Richter and Mr. Wilfrid Fearnheard, with Mr. W. H. Louw as secretary. The address of the secretary to the commission is 50, New Law Courts; Johannesburg.

#### Indiana Abroad Directory 1934

THE Imperial Indian Citizenship Association, Bombay, has published the Indians Abroad Directory for the year 1934. This is the second edition and is bulkier than the first one and contains more detailed information concerning Indians settled outside India, The compilor and editor of the Directory Mr. S. A. ### OUR OWN NEEDS

DURING the last year or two especially there ; has been a heavy call on the purses of the Indian community of South Africa. In Natal the Natal Indian Congress has had two elaborate functions—one in hoppus of Prippe George and another in bonour of H.E. The Governor-General and other demonstrations, the heavy expense of which has fallen on the shoulders of the community. And yet, of course, neither the Natal Indian Congress nor the S.A.I.O. has had even the time to concentrate on the national calamity caused in Indian by the disastrous earthquake in Behar; for so far no attempt has been made by either of these bodies to collect a cent for the relief of the distressed. The response of the Transvaal Indians in this connection is worthy of praise, Excepting for the £500 from the Parses Rustomise Trust and about £750 from Mr. J. E. Gardes of Johannesburg the hulk of another sum of about £1,500 has been contributed by Indians in the Transvall. The money given in this is given in a very deserving cause and we can have nothing to say against it.

Then we have had collectors coming from India to raise funds for this, that or the other institution. Mostly it has been for education purposes and people in this country have shown their hospitality to these friends of ours and have readily given their bit. A fact to be noted in this connection is that so far the people coming from overseas have not come for funds because their institutions were starving but for the purpose of raising a capital fund in order that they may be able to maintain themselves from the interest derived therefrom.

Others again have come as preachers with the expectation of getting monetary help to enable them to go on a world tour or some such thing.

While we cannot refuse these good friends who come knocking at our door we should not forget that charity begins at home. Don't we who talk of this country as being ours by birth and by adoction owe a duty to our own poor and our own children?

What have we done for them? Are we not a community large enough and wealthy enough in this country as to be able to run our pwn national institutions? Is it necessary that we should always be dependent upon the Government or Christian Missions to supply and to look after our needs? Are we not patriotic enough to at least try to be independent? If we are not can we not justifiably be considered a burden to this country and as apply unfit to live or to enjoy the rights as citizens of this country? These are pertinent questions which every individual and every public body should ask unto themselves.

From the amount of money we have been able to give out to others outside the Union it is quite obvious that we are in a position to look after our own needs in so far as finance is concerned, and yet we have not a single institution of which we could say with pride: "this is our national institution." Health and education are the two essential things needed for any progressive community. We are lacking in both. Rich people, when they fall sick, can afford to call doctors at their homes and to have nurses to attend on them or to go to nursing homes. But how much thought have we given to our poor who fall sick and are left at the mercy of God? In the absence of any provision for them by ourselves we have, of course, to thank the Government for the secommodation provided for them at the Addington or the Deput hospitals. But to any person who has the misforithe of possessing a dark complexion both these places are like a veritable hell. Scandalous treatment is being meted out to Indian patients we understand at the Depot hospital and as a result of a stir made by the Colonial Born and Settlers Indian Association it is learnt that some improvements have heen effected. .. F . ..

Then we have also to very sincerely thank the St. Aidan's Mission for coming to our resone by providing for us one and the only hospital where, as regards treatment is concerned, we can feel quite safe. In the absence of self-help on our part and in view of the differential treatment meted out to us in Government institutions we are greatly indebted in South Africa and, we done say, in other parts too to Christian Missions for our health and education. The St. Aidan's is one such Mission and it would be the height of ingratitude on our part if we were to fail to express our profound sense of appreciation for the humanitarian services repdeced by its hospital.

through its hospital.

The St. Aidan's Mission has prepared plans to build a new hospital for Indians at a cost of £6,650 and a building fund is being raised to which the sum of £4,200 has already been subscribed and a balance of £2,450 is still required. The only practical demonstration the Indian community could give of their gratitude to the Mission is by generously subscribing to its fund which we hope they will do. But they may not allow the matter to rest at that. We can feel satisfied only when we have an Indian national hospital under Indian mapagement and similar other institutions which we may be able to call our own without having to be under the obliga-

tion of anyone. This is the first step to Swara; and unless every indian prepares himself for it he cannot expect his country to be free. Unless we have that nationalism in us the talk of internationalism is all sham and hypocricy,

This discussion leads us to ask, what is the position of the £40,000 bequeathed by the late Mr. R. K. Khan for hospitals for Indians and the £5,000 given by Mr. Andrew Weir for the same purpose. It is a fairly long time now since these two amounts have been donated and the public is entitled to know from those in charge what steps, if any, have been taken to fulfil the desire of the donors and if not why not?

### Indians And The War

N enthusiastic meeting of Indians was held on the premises of Mr. Parsee Rustomjee on the 17th inst., under the auspices of the Natal Indian Association. The hall was overcrowded, and many could not gain admittance. Among those present were Mesers. O. H. A. Jhaveri, Parsee Rustomies, Abdul Cader, Lazarus and Bryan Gabriel, V. Lawrence, V. R. B. Moodley, G. D. Hausraj, Imam Abdul Kader Bawazeer, R. Bugwan, Lutchman Panday, R. Lugenberthy, A. S. Singh, V. S. Q. Pather, S. Goolabsingh, Sorebjee and A. Christopher. A report was submitted by the secretaries of the Committee, who had already taken the initiative in collecting subscriptions from the members of the Indian community in aid of the Mayor's Relief Fund, and stated that the first instalment of the subscriptions collected had been handed to the Mayor . . At the suggestion of the Natal Indian Association, Messrs, M. Bawat and Co., proprietors of the Union Bioscope in Victoria Street, Durban, have offered to give a star programme for to-night with the object of handing over the proceeds of the night's performance to the Mayor's War Relief Fund. . . The Indian community has already contributed over £330 to the Mayor's War Relief Fund, The Chinese community in Durbail, which is only small in numbers, has contributed £55 4s. . . Arrangements are being made by the Natal Indian Association for the holding of Ambulance Classes.

From the Editor's Chair:

# Colonisation Enquiry Report

### Mr. Sastri's Views

THE Right Hon. Srinivasa Sastriar who was the first Agent-General to the Government of India in South Africa, interviewed on the South African Indian Colonisation Committee Report stated:—

"The Committee whose report has just been published, state expressly what is commonly ignored, namely, that investigation of (likely) countries is to be jointly by the Government of India and the Union Government and that the resulting scheme, if any, should be for the benefit of Indians alike from this country and from South Africa. To put it in another and perhaps clearer way, the scheme as conceived by the Round Table Conference of 1932 is for the two countries together and not for South Africa only.

The Committee likewise admit that the Indian community are in acute economic distress accentuated by the White Labour policy now in vogue in the Union. Are the Government of India now in a position to join in a large inquiry into the conditions obtaining in North Borneo, New Guines, and other countries mentioned in the report? Is it possible for them to encourage and foster the large colonisation scheme for their nationals? Is public opinion likely to fayour a novel project of this nature? Is the financial condition of the country such as to justify any considerable ontlay in this direction? None of these vital questions can be answered in the affirmative. I cannot think that the Government of India is likely to take their part in the issue of a Joint Committee of Inquiry. If so, the inquiry and the resulting scheme could be undertaken only by the Union Government acting on their own.

If they decide to pursue the matter by themselves what should the Indian community do? It is a tremendous responsibility to give advice in hypgthetical conditions. It must be remembered that when the Preliminary Committee that has just reported was first appointed, the South African Indian Congress gave its co-operation only because in decisive stages of the matter the Indian Government were also to take their full share. If, owing to the peculiar conjunction of circumstances in this country, our Government find themselves unable to fulfil their original undertaking, our countrymen there will be fully justified in completely revising their attitude. Above all, they must consider the nature of the colonisation scheme and the irreducible requirements thereof. These are adequate financial assistance to intending emigrants and the ability and willingness of their Government to look after them and their welfare in new lands which they colonise. The position is accepted in this report that the present Indian population is eighty per cent. colonial bora. If the Union Government having the interests of this community at heart promote the scheme of colonisation abroad for them, they must be prepared not only to provide intending emigrants with initial capital but to watch their progress anxiously and step in at every stage to solve their difficulties and relieve their sufferings by advice, exercise of diplomatic influence and other steps. Is it conceivable that the Union would take up this attitude of fatherly protection? If they were likely to do so in the least, they would not be anxious to get rid of them, and we should not have heard of this Committee or of its report. It does not seem to me to be probable that even if the Union Government seriously contemplated the scheme of colonisation, the Indian community would look upon it with any favour. In the result, the Union Government, baulked in this attempt, may fall back on their old policy, which has kept alive for so many years the feeling of animosity between the races. The two Governments will once more have to consult together and explore afresh whatever avenues there may be of reconciliation. The prospects are by no means bright.

Two circumstances, somewhat germane to the subject, may finally be mentioned, one favourable and the other unfavourable. Mr. Hofmeyr, the present Minister of the Interior in the Union Government, has given proof of courage and magnanimity in his treatment of the Indian question and his influence is likely to be exerted on the side of fair play. On the other hand, the present India Office, which seems to be tightening its hold on the Government of India, has not shown itself over-friendly to the Indian cause. We have not had time to forget that it has seriously proposed to deny in the new Constitution the right of retaliation to the Government of India when they find their nationals not well treated in other parts of the Empire."

### Cato-Manor School

#### Third Win In Thrift Prize

For the third year in succession the "Mahatho" Thrift Competition cup for Indian Schools was presented to the Cato Manor Indian School, Mayville, on Monday last by Kunwar Sir Maharaj Singh, Agent of the Government of India who said that two of the great qualities of the Indians, whether in India or abroad, were thrift and industry, and he congratulated the scholars and masters and organisars on their achievement in this noble quality of thrift. The Kunwarani also spoke.

The Headmanter Mr. B. Barnabas, accepted the cup on behalf of his school. Thrift, he said, was so deeprooted in the Indian that it had become second nature, There bed not been much difficulty in inducing the children from poor homes to join the savings club, but a great deal of encouragement had been necessary among the children from the better homes.

Mr. O. K. Winterton, Inspector of Schools, urged that if the Indians would keep together and support the best people among them they would get everything they wanted in education. They must not separate into factions. One of the first things that had to be done was to put all teachers on an equal footing. The teachers came first and the erection of buildings could follow. "This school deserves all that it has won," he concluded.

### Roads In Pretoria Asiatic Bazaar

To The Editor, Indian Opinion,

Sir,—During the last few months I have had terrible experiences of the roads in the Asiatic Bazaar. While driving motor vehicles, I have had about seven springs broken. Every road in the Asiatic Bazaar is really bad with big holes, stones etc., and is seldom cleared. The Municipality wants Indians to be clean and their houses and yards etc. kept clean, otherwise a notice is served very quickly.

I do not know whom to approach in this matter as there seem to be no interest taken by the Indian community of Pretoria.

A few years back there was a branch of the South African Indian Congress. The last I heard of the above branch was when an address was to be presented to H.R.H. Prince George. I may mention that when an address or a bouquet is to be given the leaders want to be in the limelight but when some spade work is to be done nobody is to be seen. I do not blame the City Council of Pretoria but I blame the Indian community for neglecting such things. It is not only the bad roads that I am complaining of but there are many other things which require the attention of our leaders. Not enly I but any respectable person will agree with me that the roads are really had. # So-Called Scientific Criticism inen. Itamas grientals Orientals to

F the various characteristics which have been escribed to the people of the Orient-many of of them designed to be on the form of criticism-the one that seems to be the most appropriate is the the lack of what is known as the scientific spirit. But in wiew of the usually admitted, fact, that prientals are in general philosophically inclined, this may sound rather paradoxical, unless the term of soientific? is proved to connote something autithetical to philosophical. If the end of science is to become philosophy, it is obviously, limpossible to nestablish any antithesis between the two-sudbut; in science is regarded as an end indiself, there may be some such possibility, and the apparent paradox of the orientals. being philosophical but unscientific may disappear.

Accepting the popular Spencerian meaning of science as partially unified knowledge, anyone may perceive its hypothetical nature from its own climitation. Scientific knowledge is rightly held as partially unified, because the collection of facts upon which knowledge is based can ubardly be regarded , as complete. Moreover, the facts that are thus collected give only a partial knowledge of them until they are studied in their relation to the whole reality. Each science builds its own little world of facts upon which it seeks to generalise. The truth of such a generalization may be established by the facts of this little world, but when one considers that these facts bear richer and fuller meaning in their relation to the facts of the yest outside one invariably finds it difficult to accept, it as really getablishedet. This is why science, leaden to, philosophy and does not appose it. But science may oppose philosophy when its little world, is all it likes to reouguize in testing, the truth, of the own, generalisation. Philosophy certainly admits the great value of scienutic studies, but it cannot understand science when the latter elaims its decision to be final, ......

n The scientific spirit as revealed in such an exorbitant claim, is chearly antithetical to any, philosophicel disposition. "This spirit is, found, sometimes, to go, go, far, as, to, make, itself, positively harmful to , , the real, cause of science, 1, 1,.........

in the case of natural science such spirit, however may not be so readily perceived, insemuch as its generalization is based upon some faces of nature,

and nature does not care as to what sort of opinion is passed upon it. Nature did not say any thing when Potlemy upheld his generalization about planets—the generalization of which had long been the gospel truthay it was equally unconcerned when Copernious proved that generalization to be false. But did not that peculiar scientific spirit reveal itself, in that astronomical generalization, which, proclaimed its certainty and despotically sought to maintain that position?

In the case of a social or rather humanistic science the so-called scientific spirit may be clearly visible. This, is specause its, generalization, affects men, and men do not aboose to be wholly indifferent to what is said about them. But science has an advantage peculiar to itself. It gives facts for its genearlization and facts are very powerful for immediate influence over one's decision. Few are prepared to see through the game. For, these facts are very often collected with a hidden purpose and manipulated in a manner so as to compel the generalization already intended. The quaint and fantastic race theories of some 'distinguished', anthropologists might have been "scientific,", because based upon physical differences, viz., skull formation, skull content, facial bones, shape of the head, colour of the skin, hair, and eyes, etc., but these have served very little of the the real cause of science, inasmuch as physical obstracteristics are the most unreliable determinants of race divisions. On the other hand, when some person of that scientific spirit notices that those theories are merely convenient devices to flatter the theorists themselves and their kinsmen and to feed their national bigotry, he may try to uphold, with the same purpose, some counter-theory by means of equally scientific data. Of the many psychological theories of race qualities the one that is much talked of is the theory that maintains levels of race intelligence. Some races are generalized as superior in intelligence to some other on bases of intelligence-quotient and statistics. When & person affected by this theory finds that the generalisation invariably includes in the former group the theorist himself, he may become equally sensitive and try to prove the contrary, to his own advantage, in the same scientific manner. The sociological theories of cultural levels, progress, and civilization have been upheld as scientific, white these may show to all reflective minds how each theorist has ingeniously collected facts to pursuade others to feed his national egotism. While he recognizes some sort of natural divisions of mankind, he does not seem to feel shy of dogmatically upholding his own likes and dislikes as the sole criteria of other people's achievements and his own standard as the only-messpring rod of all types of progress and oivilization. There, are estain fundamental athical principles which, on account of their intrinsic value, have universal application. // These are the acknowledged criteria of high moral life. So: the same solentific spirit is found to play its part in the fatuous generalisation about a whole people of race as morally depraved from some individual instances of failure to observe such principles. On the other hand, to please itself it may naively generalize about a people as highly moral from the instances of its individual

The absurdity of such, theories, of generalization does not seem to strike those, for , whom, these have some pragmatic values. On the contrary, they may try their best no upheld them neglecting, for even hiding all facts that may be advenced against such theories. Reason fails because their, will, is a determined. Only, persons of, similar, scientific spirit may make them distent to another story,—persons who may collect, in any equally glaring manner, another set of facts to justify a contrary theory. They may listen and be temporarily, silent about their own pet theories, but they would not like, to admit that their theories are wrong until and unless

they have tried all possible means to disprove the contrary: and found themselves: unsuccessful. Evidently, what is passing at present for scientific spirit is that confirmed habit of generalization upon facts without due regard to their adequacy. Science may, thus define itself as an unusual attempt to generalize and to generalize in a good many cases, with a hidden motive.

A little reflection upon the points described will show that science in this sense is a misnomer and the so-called scientific spirit is positively dangerous if not scicidal. No real scientific spirit can ever think of admitting in the laboratory the idols of Bacon.

Thus a balance of £2,450 is required to complete the good work. The hon: treasurers are Messrs. A daughter living in Durban and another in India, both married, are left £100 each and a widowed sister in India £15. Three Mosques in India are to receive £100 each. The will expressly directs that Osman Latiff Hamdany, a son in India, is to get nothing whatever.

### Babu Rajendra Prasad's Bereavement

Babu Rajendra Prasad is under a shadow of a sad bereavement, writes our Patna correspondent. Babu Mahendra Prasad, his elder brother, who was the head of the family and more than a father to him has passed away, all medical skill and attention unavailing. It was Mahendra Babu's co-operation in shouldering the burden of family affairs that made it possible for Rajendra Babu to dedicate himself entirely to national service. His demise, therefore, is not merely a personal bereavement of Rajendra Babu but loss to the entire Province of Bihar.

Mahatma Gandhi's Love For Frontier People

The Frontier Delegation led by Mr. Pir Shahan Sha, President of the Frontier Congress Committee, waited on Mahatma Gandhi and discussed the situation on the North West Frontier for about an hour. The delegation conveyed the love and respect of the Frontier people for Mahatmaji, who also reciprocated in his feeling of love for the Frontier Pathans-Mahatma Gandhi expressed his desire to visit the Frontier Province and told the delegation: "I regard "Frontier Gandhi"—Abdul Gaffar Khan, as dear to my heart as Devidas." Finally Gandhiji conveyed his message of love to the Frontier people through them and said he could never forget them in his life and their particular difficulties and troubles were ever in his mind.

### The Life Of Indian Peasants

"The most remarkable serenity and courage with which these people seem to take the tremendous calamity that has befallen them made the most profound impression on me and makes one feel the mose strongly the desire to help them," said Dr.

Pierre Ceresole, the Swiss Hugineer, International Pacifist and the organiser of the International Volunteer Service Corps, on his return to Patna recently after a visit in the devasted parts in the district of Muzafferpore in the course of a special interview to a representative of the Searchlight. Asked to give his impression of the life of the people he saw during his tour, he said, "It is something like a big blow on the head to hear of the farmer working for six pice a day. The question that arises uppermost in one's mind is, who is responsible for these good and nice people carrying on such a heavy burden in their lives. Mahatma Gandhi told us during, his visit in Switzerland that they in Europe were not conscious of the fact that part of the standard of life in the West was supported by poor people of the East. I am not enough of an economist to know whether this is true or not, but it is painful to think that possibly we of the West are responsible for this state of affairs.

### Songs from Prison"

A volume of "Songs from Prison" by Mahatma Gandhi were published in London on June 26, "The Mahatma's rough English version has been rendered in metrical form by Mr. J. S. Hoylands without the Indian names and symbolism. Mr. Gandhi is now also among the prison poets. But his "Songs from Prison" are no heart-cry from a prophet in captivity. The title is, in fact, a little misleading. They are just translations of ancient Indian religious Lyrics, writes "Peterborough" in the Daily Telegraph with which Mr. Gandhi occupied some of his time while in gaol at Poons in 1930. The poems themselves are dignified and simple.

These "medical examinanation fees" will, of course, go to the Harijan Fund.

A London firm of publishers, it is stated, has secured a contract from Mr. Subhas Chandra Bose, who has undertaken to deliver the manuscript of a book on India early in the autumn in time for simultaneous publication with the report of the Joint Parliamentary Committee on India. The publishers are arranging for the issue of separate American, French and German editions of the book.
