In accordance with A.M.R. 18 (I.), I submit herewith the Annual Report required from the Inspector-General of the Australian Military Forces.

Since the submission of my last Report I have relinquished the appointment of Inspector-General (from 10th June, 1923), and have received the appointment of Chief of the General Staff whilst continuing to exercise the duties of Inspector-General.

This change was decided upon consequent upon the appointment of Major-General Sir C. B. B. White, K.C.M.G., K.C.V.O., C.B., D.S.O., late Chief of the General Staff, to a high post in the Commonwealth Civil Service.

#### INTRODUCTION AND GENERAL REMARKS.

1. Recent events have made it desirable to again review, briefly, the problem of Australian Defence and to bring to notice some aspects of the case as they affect the Army, and its place in the general scheme.

2. It may be accepted that the Defence of Australia remains, as it has always been, primarily a naval problem.

3. The reduction of the British Navy to a one power standard, taken in conjunction with its strategical location in peace, determines that it will be unable immediately on the outbreak of war to intervene effectively in the Pacific.

4. The postponement of the project to construct a first class naval base at Singapore must inevitably add to (if it does not indefinitely prolong) the time which will elapse, after the outbreak of war, before a superior British Fleet will be able effectively to operate in the Naval Defence of Australia.

5. The duration of this period of time will depend upon the circumstances then existing (e.g., whether the Empire is engaged in war in the East and West simultaneously) and also upon certain technical naval considerations which it is not within my province to discuss.

It may be concluded, however, that this period of time would be prolonged, and that, in the meantime, an enemy possessing temporary naval ascendancy might find the way clear for military action against Australia.

6. The capacity of our own Naval and Air Forces in conjunction with such minor elements of the British Navy as are located in Eastern waters in peace (or could reasonably be expected to be transferred to these waters in the early stages of a war) to act as a deterrent against a military attack upon Australia by a power which possesses a marked local naval supremacy is a question which needs the most earnest consideration and is one with which I do not wish to deal in this Report.

7. Neither is it within my province to discuss here the Naval and Air provisions that are within the capacity of Australia, but, whatever these provisions may be, it appears reasonable to conclude that the Land Forces of this Country are a very vital element in Australian Defence and that the maintenance of at least their nucleus in a state of efficiency is now, more than ever before, essential to the safety of Australia.

8. Basing their conclusions upon premises which are not substantially dissimilar to the above, the Senior Officers' Conference, held in 1920, recommended that our Military Forces should be the maximum obtainable.

The organization of forces amounting to two Cavalry Divisions, four Divisions, three Mixed Brigades (comprising a potential fifth Division) and certain non-divisional troops was subsequently approved by the Government of the day and was proceeded with.

9. In view of the result of the Washington Conference and financial stringency, t = 0 decided by the Government in 1922 to reduce Defence measures to a nucleus basis and the period of training of the land forces to a minimum.

The aims of the Military Board in consequence have been :----

- (a) To maintain the above organization in nucleus form within the limits prescribed by parliamentary votes; to produce and train the leaders (officers and noncommissioned officers); to inculcate the elements of discipline in the annual quotas of trainees who comprise the nucleus, and to lay a foundation for more advanced training.
- (b) To procure (if possible within a fixed period of time) the requirements of the Army in arms, armament, equipment, ammunition, and other necessary stores.

10. With regard to (a). having in view the financial resources of Australia, the paramount necessity for naval expansion, and the military adaptability of our manhood as shown in two recent wars. I have nothing to say against the nucleus system, but the nucleus must be efficient. Its function is to be capable of expanding quickly into an army at War Establishment, for which it will be required to find all the leaders, staffs, and instructors.

11. The present nucleus numbers 37,655, and, in the event of war, will have to expand into an army of 140,000. Of the 37,655 some 31,000 are boys of eighteen and nineteen years, and they receive ten days' military training a year for two years. I have no desire to disparage the efforts of Commanders and other officers towards the training of these youths nor the response on the part of the trainees. Far from it, I consider that remarkable progress has been made during the year under review, but this nucleus is hardly a substantial foundation upon which to build an army.

12. The upkeep of the establishment of officers and non-commissioned officers is the most serious problem of the system, and upon this the short period of training has a very direct bearing, for it must be remembered that the effectiveness of the forces as a nucleus will depend very largely upon the capacity of the officers and non-commissioned officers to assume control of and to instruct the large influx of recuits required, on mobilization, to complete the various units to War Establishment

13. Notwithstanding the progress of which the trainee is capable, the limited period does not, and never will, enable the instruction of the rank and file to proceed beyond the elementary stages, for the reason that each year exactly half of those to be instructed are raw recuits and the remaining half little more. It fails in consequence to sustain the interest of actual officers or to create it amongst the potential officers and non-commissioned officers now serving in the ranks. A considerable number of the officers of the late A.I.F. have continued to serve and to these, in a very great measure, is due the progress already made. Under present conditions it is becoming increasingly difficult to retain their enthusiasm, and in many cases it is only their spirit of patriotism and loyalty which keeps them with their units. Except in certain technical units, there is no alacrity on the part of potential leaders to accept either commissioned or non-commissioned rank, or, if they do accept the latter, to continue to serve after their period of compulsory training has passed.

14. Further, the provision of funds for the training of officers and non-commissioned officers at courses and schools of instruction is insufficient to enable all of them, or even a substantial proportion of them, to attain the requisite standard of efficiency. On many occasions it has been found necessary, through lack of funds, to refuse the applications of many officers and non-commissioned officers to attend schools of instruction. The disheartening effect of this is obvious.

15. The nucleus Army is 700 officers short of an establishment of 2,786, and the shortage in non-commissioned officers (the potential officers of the future) is proportionately much greater.

16 In the case of technical units not only is the period of training quite inadequate to provide officers and non-commissioned officers, but also to provide the necessary specialists of every kind, from the gun-layer to the signaller.

17. With regard to the inculcation of the elements of discipline there has been a marked improvement during the year, though this improvement is much more noticeable in the technical arms and country units than in the city battalions.

18. The only solution of these difficulties which appeals to me as feasible and within our resources is as follows :---

- (a) An increase of the period of training from two to three years. This will mean the training of three annual quotas instead of two as at present, *i.e.*, those of eighteen, nineteen, and twenty years. An increase in the annual period from ten to twelve days, the extra two days being added to the continuous training
  - Concurrently with the increase in Citizen Force training to three years the Senior Cadet training might be correspondingly reduced to one year, thus
  - leaving the total period of service the same as at present. (I have discussed this matter in detail in para. 172).
- (b) The provision of sufficient funds for schools and courses to comply with the voluntary effort offering.

The adoption of this solution would involve extra expenditure to the extent of £100,000, but I am of the opinion that the results obtained would be out of all proportion to the extra cost and would render the nucleus of some real value. 19. With regard to the question of the provision of arms, equipment and ammunition, I wish to state very clearly that these essentials do not exist in this country in sufficient quantities to enable our formations to be given their war outfit when raised, on mobilization, to war establishment : and there are no reserves to replace wastage.

The position in regard to guns and gun ammunition is especially serious, and is dealt with in Part II of my Report That such a state of affairs is highly dangerous to the safety of this country is transparently evident

20. The allocation by the Government of the sum of £250,000 during the present financial year for the purchase of munitions will effect a slight improvement in this matter, but very much more is required before any substantial qualification can be made in the statement above The estimates of cost are given in Part II.

The only practical method of meeting these conditions is to make special provision of a fixed sum annually in order that the situation may be rectified within a definite period of time. Concurrently with the purchase of munitions it will be necessary to provide the requisite storage accommodation and the staff required for care and maintenance

21. It is necessary that the work of providing storage accommodation should be put in hand at least twelve months prior to the arrival of munitions, &c., in order that it may be ready in time. The situation at the moment is that, when material at present on order is received, our storage capacity will be taxed to the utmost

22. The necessity for the supporting of the Munitions Supply Board in the carrying through, with expedition, of its present programme, as well as the desirability of making Australia self supporting (so far as this is possible) in the matter of the production of munitions, is also evident

#### Organization

23. Army Head-Quarters.- In accordance with the decision of the Government, subsequent to the retirement of Major-General Sir C B B. White, K.C M G, K C.V.O, C B. D S O, from the appointment of Chief of the General Staff, the following changes in the organization of the General Staff and the Inspector-General's Department have been made :---

- (a) The Chief of the General Staff, who is responsible for the general control of all General Staff duties and in detail for that portion of General Staff duties connected with wai preparations (Operations, War Organization, and Intelligence), also continues to exercise the duties of Inspector-General of the Australian Military Forces in accordance with section 9 of the Defence Act.
- (b) A Second Chief of the General Staff has been appointed and is responsible (through the Chief of the General Staff) for all duties connected with Peace Organization, Peace Establishments, and Training, &c Pending the return from England of Brig-Genl. T. A. Blamey, C.B., C.M.G., D.S.O, who has been appointed Second Chief of the General Staff, the duties are being performed by Brig.-Genl. W. A. Coxen, C.B., C.M.G., D.S.O.

The necessary re-organization of the General Staff at Army Head-Quarters has been made.

24. The combined functions of Adjutant-General and Quartermaster-General are still being performed by one officer. In view of the radical difference in the nature of the duties of these two branches as well as the wide scope of each and the responsibilities entailed, I am of opinion that the amalgamation is unsound both in principle and practice and should not be allowed to continue

Attention is drawn to the fact that, in addition to his control of the services of maintenance and supply of all kinds, the Quartermaster-General is responsible for the care and preservation of stores to the value of over £15,000,000. It needs little argument to prove the inadvisability of placing these responsibilities upon an officer who is already charged with the duties of the administration of personnel, discipline, military law, and the other many important functions of the Adjutant-General's Branch.

25. Divisional.—The Divisional Organization continues to work satisfactorily.

26. Base.- The District Base Organization has worked satisfactorily in so far as the performance of the peace duties of maintenance is concerned. It has been found, however, that the present establishment of a District Base Headquarters is insufficient to perform properly, in addition to its work of maintenance and routine administration, the many duties connected with war preparations and plans which necessarily fall to the lot of a Base Commandant.

I am of opinion also that the status of District Base Commandants as provided for on the approved establishment (*i.e.*, Major or Lieut.-Colonel in the larger and Captain or Major in the smaller districts) is not commensurate with the onerous and responsible duties which these officers are required to perform. The remarks as to status do not apply to the two cases (in New South Wales and Queensland) where the duties have been amalgamated temporarily with those of a Formation Command, but consideration should be given to the raising of the status of District Base Commandants in the remaining Districts as well as to the provision of an extra staff officer for the work connected with war preparations and plans.

27. Reserves.—The only reserves to the Army which may be considered to be organized in such a way as to enable the members thereof to be called up for service by individual notice are the Reserve of Officers, the Engineer and Railway Staff Corps, the A A.M.C. Reserve (officers), and the Australian Army Nursing Service.

28. Steps were taken on the disbandment of the A.I.F. to enrol in the Army Reserve discharged members of the A.I.F who signified their willingness to enlist therein. Some 48,000 men were so enrolled. An army reserve of such a character ceases in a very short time to be of ,any practical value as an organization unless very close touch is maintained with the members thereof. This involves an obligation on the part of the members to notify their successive changes of address and upon the Department to maintain an elaborate system of records. It has been found impracticable on the score of expense to maintain the latter and, although the men concerned, or a substantial proportion of them, would no doubt come forward in an emergency, this Army Reserve as an organization has ceased to exist.

On the other hand, under the Defence Act, the whole man power of Australia can be called up, in the event of war, in successive categories. The position, therefore, as to the provision of reserves is not so serious a problem as the training of them when called up.

#### WAR PLANS AND MOBILIZATION.

29. War Book.—Considerable advance has been made in the preparation of an Army Head-quarters (Internal) War Book. This is a work of considerable magnitude in itself. It will contain a summary of the principal items of action to be taken by the various branches of the Staff at Army Head-quarters during a precautionary stage, which may be instituted on the occurrence of strained relations as well as on the outbreak of war. In many cases it is impracticable to embody in detail the whole of the procedure to be taken, and references have to be made to various war plans and schemes for defence and security. It is obvious, therefore, that the latter must be kept up to date if the procedure detailed in the War Book is to be effective when an emergency arises.

30 A commencement has been made by the Council of Defence in regard to the preparation of a Commonwealth War Book covering and co-ordinating the action of all Government Departments on the outbreak of war. This is a very desirable step, but the completion of the work will necessarily take a considerable time.

#### MOBILIZATION.

31. Standing Orders for Mobilization.—Revised Standing Orders for Mobilization, outlining the procedure to be adopted for the calling up of the Citizen Forces and raising them to war establishment in personnel, animals, and materiel, have been issued, and the necessary local plans in connexion therewith are now in course of preparation by Formations and District Base Commandants. These orders also contain a scheme for the application of Part IV. of the Defence Act

32. Steps are also being taken to proceed with the preparation of plans covering the provision of supplies and the purchase or requisition of remounts and transport (horsed and mechanical)

33. Places of Mobilization.—The initial steps for the acquisition of land for mobilization purposes in Tasmania have been taken. The necessary proposals for similar action in South Australia are shortly to be submitted. Both of these projects have been very much delayed by the non-provision of money on the Estimates.

34. In cases where the places of mobilization selected for fighting formations do not afford the necessary security for the various base organizations and reserves of personnel and materiel, consideration has been given to the selection of sites for the location of these latter in time of war. Certain reconnaissances to this end have been made, and the localities have been decided upon. It will be a question for consideration at a later date as to whether it is desirable or actually to install in peace any of the facilities necessary for these bases. The matter will have to stand over for the moment on account of the expenditure involved.

35. Mobilization Equipment.—The situation as regards mobilization equipment has been referred to in the introduction to this Report. Further details are given in Part II.

36. Mobilization Stores.—No improvement has been effected in the matter of mobilization stores since the submission of my last Report. The stores in the 1st, 2nd, and 3rd Military Districts are still overcrowded. It is most desirable that the necessary mobilization stores in the 4th and 6th Military Districts be erected at an early date and also at the additional place of mobilization selected in New South Wales. Extra storage accommodation is also required in the 1st, 2nd, and 3rd Military Districts. When this is provided some relief will be afforded. The 2nd and 3rd Military Districts are still holding stores intended for issue on mobilization to units raised in South Australia and Tasmania. This, apart from the congestion it causes, is a most unsound arrangement for mobilization.

It is eminently desirable that, in order to economize time, to avoid congestion and confusion, and to enable the issue of stores on mobilization to be properly organized in peace, the war equipment of units (less such articles as guns and wagons, which require separate storage) should be stored in unit compartments of the mobilization stores. This will not be practicable in all cases unless certain additions are made to the accommodation at mobilization stores.

37. It is also essential that, in the design of new mobilization stores, the factor of quick and orderly issue on mobilization should be given full consideration in addition to the mere question of storage *per se*.

The question of storage for explosives is referred to in Part II.

38. Railways.—I wish to refer again to my remarks and to those of the late Chief of the General Staff, quoted in my last Report, on the subject of the breaks of gauge in our railways. Attention is drawn, in particular, to the fact that the Trans-continental Railway, through shortage of standard gauge rolling stock, is of very limited military value. A connexion with the New South Wales system, which would allow the transfer of rolling stock, would be a distinct advantage.

39. The completion of the railway from Binnaway to Werris Creek has conferred upon our railway system definite strategical advantages. There now exists an inland lateral railway which, though still suffering from the disadvantages of breaks of gauge at the State borders, should enable military movements between Southern Queensland, New South Wales, and Victoria to be carried out in security. In this connexion it is desired to state that the proposed Sydney to Brisbane standard gauge railway via Kyogle and Richmond Gap does not, because of its proximity to the coast in certain places, confer the same strategical advantages as the standardization of the route via Wallangarra would do.

### TRAINING.

#### INSTITUTIONS.

40. The Royal Military College.—Since my Report of last year a Special Committee consisting of :--

Professor Sir T. W. Edgeworth David, K.B.E., C.M.G., D.S.O.;

Major-General Sir C. B. B. White, K.C.M.G., K.C.V.O., C.B., D.S.O.; and

Captain G. F. Hyde, Royal Australian Navy.

was appointed by the Cabinet to report upon the Royal Australian Naval and Military Colleges, with a view to ascertaining whether the cost of training our Naval and Military Cadets could be reduced.

Their Report, which was furnished to you on the 6th July, 1923, confirms in detail the remarks on the Royal Military College, Duntroon, in my Report to you of 31st May, 1923, and says, *inter alia* :---

"Adequate and efficient training is now an essential in the production of leaders. Efficient colleges are, therefore, a vital factor in national insurance, which takes the form of preparation against war."

41. In my Report of last year, para. 41, I stated that the annual intake into the College should be not less than twelve. Owing to the fact that the wastage in the Staff Corps has been greater than was expected, and to the decision that cadets for the Royal Australian Air Force should also be trained at Duntroon, this number was found to be insufficient.

Considering also the shortage in the establishment of cadets, owing to there being fewer successful candidates than were provided for during the two previous years, you gave authority for the admission of eighteen during the current year. It would appear that the annual intake should be not less than sixteen under present conditions, but, if an expansion in the Royal Australian Air Force is determined upon, as seems probable, the intake should be proportionately greater.

The present establishment of cadets under training is 41. Ten of these should graduate in December next.

42. The extensions of the functions of the College to train suitable candidates for employment in the Civil Service of mandated and other Territories appears to me to be worth serious consideration.

43. I recently inspected the College and consider that the standard established by the late Sir William Bridges is being well maintained. The only recommendations I have to make are the following :---

(a) That a qualified wireless instructor (warrant officer) be appointed.

(b) That the present civilian grooms be replaced by Remount personnel, who would be properly trained in stable management, and under military discipline. No extra expenditure should be involved if this change is decided upon.

In addition to these courses, officers and warrant officers of the Staff of the School acte as Instructors at practically all Militia Field Artillery and many of the Garrison Artillery Camp of Training throughout the Commonwealth, as well as the Divisional Artillery Staff Course hel in Victoria.

The results of the courses at the School were most satisfactory as far as officers, warrant officers, and senior non-commissioned officers were concerned, but the younger non-commissioned officers and gunners were lacking in education from a mathematical point of view.

This, I feel, is due to the fact that the low rates of pay and prospects of future advancement are not sufficiently inviting to encourage the right stamp of man to enlist in the R.A.A.

45. Small Arms School.—The work of the School during the past year has been well organized, and the standard of knowledge displayed at the end of the courses was good.

The following courses were arranged for members of the Permanent Staffs, at which 60 officers and 131 warrant and non-commissioned officers qualified :---

Two Rifle and Bayonet Qualifying.

Two Light Gun Qualifying (Lewis & Hotchkiss).

Two (Vickers) Machine Gun Qualifying.

In addition, local Small Arms Courses were carried out in five Military Districts for Citizen Force and Senior Cadet officers, and warrant and non-commissioned officers of the Citizen and Permanent Forces, at which the total attendances were 126.

46. Commencing with the First Course in the current year, the elements of grenade training are now included in the Rifle and Bayonet Qualifying Courses, following the procedure in vogue at Hythe.

47. Tests of rifles and ammunition were carried out by the Staff on behalf of the Department in connexion with supplies received from the Small Arms and Small Arms Ammunition Factories.

48. Central School of Physical Training.—Local Courses of Physical Training under the members of the Physical Training Staff have been conducted in all Districts and, in addition, special courses have been conducted in the 2nd and 3rd Military Districts for the R.A.G.A. with the most satisfactory results.

Four hundred and eighty-five officers, warrant officers and non-commissioned officers of the Penn ar ent Forces have passed through and qualified at this School since July, 1920.

A member of the Physical Training Staff has been allocated for duty at the Royal Military College with satisfactory results.

#### THE CITIZEN FORCES.

49. Introduction.—I have already referred to the general effect of the present limited period of training upon the Citizen Forces and their efficiency as the nucleus on which to build our home defence army in war.

Such training as has been possible has, however, been carried out, in accordance with a definite policy, on uniform lines. Certain valuable, though limited, results have been obtained.

There has been a definite improvement in the spirit of the Citizen Forces. Much progress in elementary training has been made; 'the results are creditable to all concerned, and it is no fault of the personnel, who are of excellent material, that their efficiency as a nucleus falls, for reasons already explained, below the desired standard.

50. The Education of Officers and Non-Commissioned Officers — Within the limits imposed by the restricted financial votes a great deal has been accomplished in the education of officers and non-commissioned officers during the year. The examinations for first appointment to commissions in the Citizen Forces and promotion therein, re-introduced last year, have had a beneficial effect. The Staffs have displayed commendable energy in holding courses and classes to prepare candidates for the various subjects; 792 candidates passed the practical tests, whilst 495 qualified in the various written papers. These numbers are somewhat below that of the previous year, but it must be borne in mind that in each successive year the numbers will decrease in proportion as the commissioned ranks become completed to establishment, and also as those who held commissions on the re-introduction of the tests qualify for promotion.

51. The issue by the General Staff at Army Head-Quarters and the Staffs of Formations of memoranda for the guidance of those preparing themselves for examination has been helpful, as also have the correspondence classes instituted for the benefit of country officers.

A satisfactory increase in the number of books issued from district libraries to Citizen Force Officers has been noted.

52. The United Service Institutions in the capital cities have displayed commendable activity in the arranging of regular series of lectures, which have been well attended and are of considerable value in the military education of officers.

53. Schools, Courses and Classes-Officers and Non-Commissioned Officers.-Some 500 officers and 1,600 non-commissioned officers have attended voluntary courses and classes of instruction extending over continuous periods up to ten days. These courses of instruction are essential for the training of officers, and it is regrettable

These courses of instruction are essential for the training of officers, and it is regrettable that further funds were not available for the inclusion of a greater number of officers and noncommissioned officers.

Improvements have been effected by the Formation Staffs in the organization and general arrangements for these courses. The standard of instruction thereat is being gradually raised. The interest shown and the progress made by those attending have been commendable.

54. Tactical courses, in accordance with section 21A of the Defence Act, have been held in the various Districts for the instruction and examination of officers for promotion to the rank of Lieut-Colonel. Successful efforts have been made to bring the instruction thereat to a high standard.

55. During the first nine months of the year approximately 2,000 all ranks attended voluntary week-end courses and bivouacs, which have proved most useful and are worthy of further encouragement.

56. Attachment of Officers to other Arms.—Attention was drawn, in my Report last year, to the desirability of attaching officers, for instruction, to arms other than their own. Efforts have been made during the year to put this proposal into practice, but the extent of these attachments has necessarily been restricted by considerations of finance.

#### TRAINING OF THE RANK AND FILE.

57. Training Instructions.—Following the procedure of last year, special instructions for the training to be carried out were issued by the General Staff to ensure adherence to a definite training policy and concentration upon essentials.

58. Training Programmes.—Acting on the principle that Commanders are responsible for the training of their own units, the preparation of the detailed programmes for training has been left in the hands of the Commanding Officers of Units, the Formation Staffs merely indicating the general lines to be followed.

Most of the time available has necessarily been devoted to individual training, but some simple collective training exercises were rightly included during the final days of camp and courses.

60. In most instances the specialists, such as Vickers, Lewis and Hotchkiss gunners, have been separated from the remainder of their units, and have been trained in their particular work by special instructors. The best results have been obtained by units which adopted this method.

#### HOME TRAINING.

61. Attendances at parades have improved generally, and particularly so in technical units.

A certain portion of the period of four days allotted to home training is necessarily consumed by matters connected with organization and administration, and this, together with the infrequency of parades, has prevented a progressive advance being made except amongst those who are willing to attend frequent voluntary parades. In some units, particularly in the technical arms, this voluntary effort has been considerable, and the results have consequently in those instances been good. But, considering the force as a whole, the attendance at voluntary parades is not general enough to ensure the primary object of home training, viz. :--to permit collective training to be commenced on the first day of camp.

62. Musketry.—One of the principal disabilities caused by the short period of home training is that it is not practicable for units to complete their annual musketry course during that period.<sup>1</sup> This is especially the case where range facilities are limited and where units are located at considerable distances from rifle ranges. An appreciable portion of camp training has consequently to be devoted to this work.

An advance has been made in the results obtained in the firing of the rifle and automatic weapon courses.

Compared with the previous year, there has been a considerable increase in the numbers who fired. In some formations as many as 95 per cent. have been partly exercised, whilst, of those who completed the whole course, over 70 per cent. have qualified.

Where satisfactory results have been obtained in the musketry training it is mainly due to voluntary effort, and is a matter for congratulation, not only to the Staffs concerned but to the trainees themselves who have thus voluntarily surrendered their time.

63. The benefits of the courses held at the Small Arms School, or those carried out in Districts by the staff of that school, are becoming evident as the increased numbers of officers, warrant officers, and non-commissioned officers, both of the Permanent and Citizen Forces, who have qualified, become available to instruct in musketry.

64. Miniature Ranges.—Existing 30x ranges have been repaired and new ranges constructed, but many more are still required.

65. Regimental Rifle Clubs.—These clubs are playing a very prominent part in raising the general standard of shooting. Not only does the participation in contests rouse the enthusiasm of units' teams, but the expert shot produced through the medium of these competitions is available to act as a coach and so assist to improve the whole shooting of a unit.

66. In New South Wales particularly is the effect of these rifle clubs to be noticed. What commenced as the 1st Division Rifle Association has had so rapid a growth as to warrant its extension into what is now the Citizen Force Rifle Association of New South Wales, which embraces all formations in that State. The number of entries for the monthly and annual competitions has been most gratifying.

67. In other districts, though the increase in Regimental Rifle Clubs has not been so marked, there has been a steady expansion. In view of the improvement produced on rifle training efficiency by means of these competitions and particularly in team competition when the corporate discipline is advanced, it is hoped that, at no distant date, the establishment of a Citizen Force Rifle Association in each State will be an accomplished fact.

Where units are scattered it has not been found feasible to form clubs, but where possible every endeavour should be made to encourage their formation.

68. His Majesty the King has approved of the grant of the King's Medal to the winner of the Army Championship of Australia. Competitors from all the Military Forces are eligible, eliminating contests being held in each Formation and District Base. This year each of these sent one representative to Melbourne to compete in the final test, which was held on 23rd and 24th May. The standard of shooting at this meeting was good and produced a very close finish. The weather conditions were, however, exceptionally unfavorable. The winner was Honorary Captain W. C. G Ruddock, Australian Instructional Corps.

69. Citizen Co-operation.—Greater attention has been given by some formations during the year to route marches through unit areas and participation in local functions, which have had a beneficial effect on *esprit de corps* and also in establishing interest in their territorial unit amongst the citizens. Much, however, yet remains to be done, and attention should be given by all formations to encourage the interests of citizens in their local unit.

### CAMP TRAINING.

70. The interest displayed in this form of training is very marked when compared with home training. With few exceptions, attendance has been very good (vide Appendix "A") and all ranks have regretted that a longer period could not be spent in camp. The exceptions as regards attendance are found in units recruited in the country, where seasons and often the weather conditions existing at the time affect the ability of the men to leave their farms to attend camp.

71. The keen spirit displayed has enabled training to be carried out on progressive lines and good results to be obtained, though, as already pointed out, this training has not adyanced beyond an elementary stage.

Except in the training of specialists, where the services of the best instructors obtainable have been employed, the training has been conducted by the leaders themselves, with the help of the Permanent Staff, who have rendered very valuable assistance and worked hard to improve the standard of training.

72. The benefits of the courses of instruction already referred to are evidenced in the increased ability of the Citizen Force leaders who have attended them to assume charge of the training. Where it has been possible to hold courses immediately prior to camps, the results have been even more marked and valuable work has resulted.

73. Morale.—It has been found that, where it has been possible to bring two or more units into camp together, it has stimulated *esprit de corps* and a healthy competition between units which has done much to raise the keenness of the troops in their work.

It is most desirable, as far as funds will permit, that brigade, rather than unit, camps should be held in the future.

74. Discipline.—Discipline, beyond a very few insignificant instances, has shown improvement. The instances referred to were caused in the first place by unforeseen administrative difficulties which were immediately rectified, and, with the cause of complaint removed, the normal routine proceeded without further trouble. It is noticeable that the undue prominence given by the press to any such incidents of breach of discipline inevitably stimulates further incidents. As pointed out in my introductory remarks, there has been a greater improvement in the discipline of the technical units and those raised in the country districts than in the city battalions.

75. Machine and Light Guns.—In units armed with these weapons the necessity of concentrating on the special training of detachments has, with few exceptions, been realized, and as a result much progress has been made. The interest displayed in their weapons and the voluntary effort made by the trainees has enabled a standard, much beyond what could be expected from the normal training periods, to be reached.

Though it is impossible to attain that precision which should become instinctive when handling these weapons, the results obtained from firing on the range have justified the time and ammunition expended by increasing the interest of the gun teams and encouraging them to further efforts.

Competitions between teams is a further means of stimulating efficiency, and has produced some excellent results.

76. Regimental Signallers.—The training of Regimental Signallers is always a very difficult problem, and is becoming still more difficult owing to the addition of wireless apparatus to the equipment.

It is a question whether Regimental Signallers should not be made part of the Brigade Signal Sections. If this were so there would be no break in the continuity of the Signal Organization, and the Officer Commanding Divisional Signals would be responsible for the training of the whole of the Signal Service and the care of the apparatus, which is becoming increasingly more plentiful, delicate and costly. Unless the methods of instruction of all Signal personnel is definitely on similar lines, difficulty is likely to be experienced when Brigade Signals endeavour to communicate with Regimental Signallers Under the present system, also, replacement of casualties would be a difficult matter, as suitable trained personnel would only be available from the Signal Service.

77. Ceremonial.—All forms of ceremonial parades stimulate esprit de corps, and this has been recognized throughout the training. Though it has not been possible to devote more than a short time to ceremonial parades, each unit has set aside a certain period to close order drill with very beneficial results The ceremony of guard mounting in camp has stimulated those taking part in the function to make a creditable display

78. Bands.—Last year the desirability of increasing the number of bands was stressed, and action has since been taken to give effect to it. The grant towards the upkeep of each band is certainly inadequate, but much has been done by local effort to make the unit band efficient. This increase in the number of bands, one per Cavalry Brigade, and one per Infantry Battalion, has been of inestimable value, particularly in camp, where they make all the difference to the contentment, discipline, and behaviour of the troops In one or two cases, however, the bands, which were composed of voluntary enlisted men, did not attend camp. In future it should be provided that if the band does not attend camp the allowance will not be paid

79. Leave of Officers from Civil Institutions to attend Camps.—It is regretted that it is again necessary to draw attention to the difficulty experienced by some officers employed by Government Departments, &c., in securing leave to attend camp. This is difficult to understand, but it may be possible that the heads of Departments, &c., concerned do not comprehend the value of the work that these officers do in the training of the youth of the country.

80. Chaplains.—It is pleasing to record the increase in the number of chaplains attending camps. Their work has been of great assistance, and an extension of their activities would be greatly appreciated.

81. Institutions.—At all camps, the Y M.C.A. and other institutions have done much to add to the comfort and entertainment of the trainees by providing reading rooms, writing facilities, and musical or pictorial entertainments.

82. Sports.—The question of devoting one afternoon in camp to sports of a military nature should be given consideration. In some instances this has been done, particularly where units have held their camps adjacent to towns. If the events are entirely of a military nature, they must undoubtedly help the training, and the competitive spirit of the trainees should go far to improve their efficiency. When they are held, the sports should be open to the citizens of the adjacent towns In some cases this has been done, with excellent results in the creation of interest in the work of the troops.

83. General —Generally it may be said that the camps have shown a distinct improvement on those of the previous year, but the results obtained will not be really satisfactory until the period and the number of quotas are increased — Many of the units are in a comparatively efficient state, but this is due in the main to the energetic efforts of Commanding Officers in establishing voluntary effort additional to the authorized training

#### TRAINING OF TECHNICAL ARMS AND SERVICES.

84. The foregoing remarks, although applicable to Light Horse and Infantry Units, refer in general terms to other arms of the service There are, however, certain features connected with the training of other arms which are stated in the following paragraphs

85. *Field Artillery.*—Practice of an elementary nature, using live shell, was carried out by all batteries, and the results obtained are considered quite creditable — The drivers handled their teams well, often through timbered country, when bringing their guns into position for action.

It would considerably assist in this class of instruction—*i.e*, "ranging of targets"—if money were made available to provide a miniature target apparatus at each of the main Field Artillery Drill Halls, for by this means a better knowledge of the subject would be obtained and greater value would accrue from the small allotment of ammunition that is at present made available for practice 86. The Staff of the Artillery Schools of Instruction was employed in instructional duties at the Camps of Training in all Military Districts with good results. This method of promulgating the latest Artillery information and ensuring uniformity of training has been of great value.

87. Some improvement has been made in equitation. In several instances batteries took their guns into camp, and returned by road. In one instance a distance of 48 miles (from Guildford to Rockingham, W.A.) was covered in a two days' trek by one battery. The return journey was made by another battery, with no casualty or injury to the horses in either case.

This is satisfactory as far it goes, but the shortage of horses in the Remount Dépôts and of personnel to look after them has caused considerable difficulty to the Field Artillery generally in regard to instruction in equitation and driving. By careful arrangement it has been found possible to give at home training a certain amount of instruction in riding, but driving drill can hardly be touched until the units go into camp.

The improvement referred to may be attributed, in the main, to the fact that the older quota of trainees had the benefit of the camp training of the previous year.

88. Artillery Ranges.—The necessity of acquiring land for use as artillery ranges becomes more obvious each year. At the present time there exists only one artillery range which is situated on Defence Department property. That is at Liverpool; New South Wales.

In all other States, practice has to be carried out over private property, and in many instances, owing to the increasing habitation in the vicinity of the camp areas, ranges are becoming difficult to find, and when found are often too circumscribed, or do not lend themselves to any manœuvre work.

The question has been referred to the various Military Districts, and recomendations regarding suitable sites, costs, &c., have been called for.

89. Garrison Artillery.—The Australian Garrison Artillery Units are still very short of officers, but improvement has been made during this year, as a certain number of suitable trainees has developed sufficiently to qualify for commissioned rank.

has developed sufficiently to qualify for commissioned rank. Three of these applied for and have been permitted to go through the four weeks' course held for the Duntroon Staff Cadets at the Artillery Schools of Instruction.

90. A lack of enthusiasm has been noticed in the home training of the Garrison Artillery. This is due very largely to the absence of training equipment at the local drill halls. In the majority of instances drill halls are too far away from the forts to enable the Citizen Force trainees to undergo instruction on their guns except on Saturday afternoons and at camp. The mounting of a gun at each Garrison Artillery drill hall would benefit the training and morale and raise the enthusiasm of this arm.

91. In the majority of cases endeavour has been made to carry out the musketry portion of the training of the Australian Garrison Artillery during the home training period, to enable the whole of the time allotted to camp to be devoted to training on their guns.

92. In all Districts the Garrison Artillery have carried out gun practice of an elementary nature with 6-in. B. L. guns, and have combined with the Royal Australian Garrison Artillery in manning the forts. Practices of Coast Artillery are considerably hampered owing to the excessive cost of providing suitable towing steamers—and when provided these are unable as a rule to tow the targets at anything like the speed that is desired for efficient training. At the present time the Defence Department launches are not permitted, owing to their size, to tow targets outside the Heads at either Sydney or Melbourne.

93. Field Engineers.—The work done by the Field Engineers has been of a useful nature, and good progress has been made.

Difficulty has been experienced in obtaining officers with the necessary technical qualifications, and the question requires careful consideration if the high standard of the past is to be kept up.

94. There is still a shortage of bridging equipment in most Engineer Dépôts, but this is gradually being made up.

95. Many of the sites for Camps of Training during the last year have not been altogether suitable. Good digging ground should be available, as too much time is wasted if the ground is too hard. Good facilities should also exist for bridging. While it may be useful experience for Field Engineers to go into camp with other units, their technical training should not be hampered by an unsuitable site.

Until combined manœuvres are contemplated better results in the technical training of Field Engineers is obtained in a separate camp at a suitable site, where some definite scheme, such as the construction of a bridge, can be carried out. 96. Signals.—In spite of the short period of training very good work has been done, largely by means of voluntary effort, and many of the units are quite efficient.

Wireless and other equipment has been coming to hand and has facilitated training. More is expected shortly. The personnel of the units are on the whole very keen on their work, and in spite of difficulties make every endeavour to make themselves efficient.

97. Army Service Corps.—Though the establishment has been increased, the work in connexion with supply of camps has been such as to prevent the necessary time being devoted to training of the personnel in other military duties.

The question of good messing arrangements for the troops has received much attention during the past year, and the general excellence of the results obtained is to a large extent due to the efficient work of the Supply Services.

It is hoped that a further increase in establishment will enable more time to be devoted to those combatant duties which now form so important a part of the training of the Army Service Corps.

98. Army Medical Corps.—There is still a difficulty in inducing medical officers to give up the necessary time for military training.

Notwithstanding the question of officers, satisfactory progress has been made in training of the Army Medical Corps personnel in technical duties in the field.

Revised training manuals for the Army Medical Service are awaited.

99. Dental and Pharmaceutical Services.—A Senior Dental Officer and Senior Pharmaceutical Officer have been appointed in each Military District.

The Senior Dental Officer examines dentally all persons applying for appointment or enlistment in the Permanent Military Forces, and advises generally on all matters connected with dental service. The Senior Pharmaceutical Officer inspects and reports on all medicines, medical materiels, and chemists' sundries for the Military Forces, and generally advises on all questions relating to Pharmaceutical Service.

100. Army Nursing Service.—A Principal Matron has been appointed in each Military District, who is taking the necessary action to place the Australian Army Nursing Service on an organized footing.

The service, when completed, will consist of (a) Volunteers, who will undergo a certain amount of training as applicable to the Military Service; and (b) a Reserve, consisting of trained nurses who are available for duty in case of a national emergency.

101. The Ordnance Services.—Militia Ordnance Sections.—The need for units which could assist in the handling and preparation of artillery ammunition in the event of emergency is very apparent, and steps are being taken to raise Militia Ordnance Sections which can form an expandable nucleus for this purpose)

102. Army Veterinary Corps.—The Veterinary Sections have shown steady progress in their training in the practical veterinary work allotted to them.

The trainees selected for transfer to the A.A.V.C. this year were of a very suitable type.

103. It is a matter for consideration whether the number of men training in each section could not with advantage be increased by the addition of six men to the present training establishment, in order to provide trained veterinary orderlies to assist Regimental Veterinary Officers in camps when there is no Mobile Veterinary Section available.

104. During the year Classes of Instruction for the training of farriers attached to Citizen Force Units have been held in the 2nd and 3rd Military Districts; these classes of ten days' duration were well attended, and very satisfactory results were obtained.

105. Australian Army Legal Department.—The Australian Army Legal Department instituted in 1922–23, has been established on a firm basis. The officers of this Department are of good standing in the legal profession, and have also had experience as commissioned officers in either the A.I.F. or Citizen Forces or in both.

They are attached to Formations and to Brigades, and carry out both consultative and instructional duties. By the former they are of practical assistance to the Permanent Staffs of Formations, while in the latter capacity the Australian Army Legal Department facilitates the study of law and procedure by officers of the Citizen Forces.

#### ADMINISTRATION.

106. General.—The administration has generally worked smoothly and satisfactorily and further progress has been made towards decentralization and simplification of methods.

The more settled policy has enabled more attention to be given to administrative details, with the result that, except in a few instances where circumstances have not permitted accumulated arrears to be overtaken, the administration of units and areas can be broadly regarded as satisfactory. In battalions there is still somewhat undue centralization, due to the want of adequate training of Militia non-commissioned officers and the shortage of accommodation for stores referred to below. Inspections during the past year have, however, disclosed the necessity for regular visits by the Staff to ensure that the work is kept up to date and that uniform methods are adhered to.

107. Store Accounts.—The question of accounting for stores is one of paramount importance, and presents in a Citizen Army difficulties which would be readily overcome in a Regular Army. Despite these difficulties, the care and accounting for stores have received increased attention from Commanding Officers and their Staffs, with a proportional decrease in losses by negligence and bad accounting. When it is appreciated that a normal Infantry Battalion Commander is responsible for over 40,000 articles, which are definitely delineated in the unit ledger under some hundreds of various headings, and which are handled at extended intervals by the personnel of the unit, it is really surprising that the losses are not greater.

108. There are, however, several pressing requirements in order that a thoroughly satisfactory position may be attained in the matter of store accounts and storage. The needs are :--(1) Provision for an annual audit of each store account, (2) ample storage accommodation in drill halls, and (3) the training of Citizen Forces personnel whose duties are connected with the receiving, issuing, and accounting for stores. To these may reasonably be added a more direct and simple method of adjusting minor discrepancies and losses.

As regards (1), the number of Ordnance Inspection Clerks is inadequate and the present system of detailing Staff Corps Officers to carry out store account examination is unsatisfactory.

As regards (2), the lack of storage accommodation at drill halls is a strong factor towards centralization of responsibilities as against the accepted principle that efficient administration demands devolution of responsibility among subordinates. Unless safe and sufficiently spacious store rooms can be provided for subordinate Commanders, it is unsound to consider them as Store Accountants.

109. I cannot leave this subject without referring to the elaborate and exhaustive, and in some cases superfluous, method of adjusting discrepancies revealed by audits or reported by units as they occur. The audit examination itself has been rendered somewhat more simple since my Report of 1922, but there appears to be undue labour and expense involved in the adjustment of minor discrepancies. For instance, a loss of stores valued at a few shillings must be reported to the Local Auditor, the report to be accompanied by stock sheets containing all information concerning the ledger balance, &c., of the article effected, and the result is that the cost of postage alone between Unit and Formation, Formation and Local Auditor and Chief Ordnance Officer sometimes exceeds the original value of the articles lost.

This might be obviated by granting increased powers to Formation Commanders in respect to the dispensing with Courts of Inquiry, and less exacting demands on the part of the Auditor-General. It is suggested that a certificate from the Formation Commander or District Finance Officer that every effort has been made to trace the responsibility for losses to individuals should be sufficient in cases where the losses in any one instance do not exceed the value of £20.

110. Works and Buildings.—The progress made during the past twelve months has been unsatisfactory. The amount provided for repairs and maintenance was insufficient. Buildings and other works are steadily deteriorating, and now require a relatively larger amount than would have been necessary had the repairs been undertaken at the proper time.

111. The construction of new works has not advanced at the rate expected owing, it is believed, to the shortage of technical assistants for preparation of plans and specifications, and the difficulty of securing suitable tenders from contractors. The latter cause is due to activity in the building trade and shortage of skilled tradesmen.

The fact remains that of the £203,000 voted by Parliament for necessary works the Works and Railways Department have only been able to spend approximately £100,000; our building programme is far behindhand and our estimate for new works for the next year is already loaded with commitments approved amounting to £150,000. The adverse effect of this is two-fold. In the first place Parliament is alarmed at the size of the estimate and in the second place it is throwing more than the yearly capacity on the Works Department, so that the delay in the programme is likely to increase rather than diminish. The immediate result will be that the provision of armament and munitions will be seriously interfered with, for it is essential that our building programme for the housing of equipment and munitions should be well in advance of our buying programme, otherwise heavy additional expense will continue to be incurred through the temporary storage of materiel in Districts other than those for which the materiel is intended and in hired store-rooms where these are procurable. In either case additional expenditure will be incurred in subsequent re-handling, in addition to losses and deterioration.

112. Clothing.—There is much need for improvement in the fitting of uniforms. and it is a question for consideration as to whether additional sizes are not required. A smarter and more distinctive jacket for warrant officers and non-commissioned officers is also very desirable.

113. There has been a general shortage of boots of the smaller sizes, and a number of men were noted in camps suffering from sore feet as a result of wearing civilian boots which were too tight or military boots which were of wrong sizes.

'114. Since my last Report mounted units have been provided with leggings instead of puttees. This has caused general satisfaction and has assisted recruiting in the Cavalry.

### CAMP ADMINISTRATION.

115. General.—During my inspection of camps throughout the current year it was palpable that Staffs and units had largely profited from the experience gained in 1922–23. The preliminary organization and preparations were again satisfactory, and the close supervision and constant assistance by Formation Staffs ensured that camp administration and routine proceeded smoothly. Committees have been formed to draw up an outline for Unit Standing Orders, which, when printed and issued, will be of good value to all ranks during camp training.

116. Camp Sites.—A considerable advance in the selection of camp sites has been made since my last Report. Unsuitable Metropolitan Rifle Ranges have been discarded and more attractive sites selected, wherever possible at or near the places of mobilization. As it is still impossible to carry out the musketry during the four days of home training, ranges have been constructed or improvised at these sites, if none already existed.

117. As, with the exception of Western Australia, the places of mobilization are suitable for annual camps, steps should be taken without further delay to repair buildings and effect improvements in drainage, sanitation, kitchens, &c., particularly at Liverpool (including Holdsworthy) and Seymour.

118. In South Australia no place of mobilization has yet been selected. In its selection, suitability as an annual camp site will be considered. In the meantime the Cavalry used the Cheltenham Racecourse, kindly placed at their disposal by the Race Club, and the Artillery and Infantry the Seacliffe site, which is a most excellent one, but which will soon be unavailable owing to its being rapidly built over.

119. In Western Australia, the place of mobilization is quite unsuited for annual camps, and Infantry camps have been held at Karrakatta and Kalgoorlie, Cavalry at Guildford, and Artillery at Rockingham. This arrangement suits very well while the training is in elementary stages, but a manœuvre area should be acquired on which more advanced training, and, later, combined training, could be undertaken.

120. Some of the camp sites in use are still strewn with the débris of buildings, &c., used for purposes in connexion with the late war. Money should be provided in order that these may be cleaned up without delay.

121. Quarters and Sanitation.—The camps and precincts have been maintained in a sanitary and healthy condition. In some Districts units have successively undergone periods of training extending over long periods, and there have been no epidemics even of a mild nature, arising from unsanitary conditions. When conducting rotation camps it is essential that after each camp a thorough overhaul and disinfection should be carried out.

122. The quarters have been maintained in a clean and tidy condition, but there is need for further improvement. The difficulty in this direction is due, apart from the youth of the trainees, to the wide scope of duties which must be attended to in camp, and with which the non-commissioned officers, on whom much depends in the matter of routine, are not familiar. These non-commissioned officers have insufficient opportunity of gaining experience during the six days to enable them to deal with such matters with confidence and without hesitation.

As it is essential that each man should regard his own appearance and the cleanliness of his quarters and kit as bearing on the credit of his unit, it follows that he should be instructed in the correct method of barrack and camp routine.

The early morning parade might reasonably be devoted to this purpose, i.e., to general fatigues and to inspection by Company Officers. If this be instituted the training will be much less interfered with than at present by the detachment of fatigues, &c., later in the day

123. Army Catering.—Great strides have been made in this branch of training during the past two years since the initiation of the new messing system. With the fuller realization and appreciation of its advantages, it is hoped to attain considerably greater efficiency. Generally a high standard of messing was attained at moderate cost. A sample menu actually used in a recent camp (vide Appendix "B") shows the great variation in diet at a cost of 1s. 4d. per man per day that can be accomplished under the new system.

124. As regards cooking, the outstanding feature was the success of the trainee cooks. The disabilities so strongly emphasized in my previous Reports, consequent upon the employment of civilian cooks, have practically been overcome.

During the past year good work has been done by holding Courses of Instruction at Army Head-Quarters and the Flinders Naval Base Cooking School for selected members of the Australian Instructional Corps. At the conclusion of these courses the candidates were available for instructional duties at local cookery courses,

125. The system, however, is still in its infancy, and much remains to be accomplished before the full benefits are derived from it. Messing Officers are as yet mostly inexperienced; and all Commanding Officers are not fully seized with the necessity for selecting officers for the duty who can and will devote the time required for the proper performance of this responsible work.

126. Details in Camp.—A tendency has been noted for the number of details employed in camp to be excessive. If the suggestion in para. 121 is adopted these should be reduced considerably.

127. Orderly Room and States.—There appears to be a vast amount of office work performed in camp which necessitates many of the Staff being in the office instead of at their proper work as Instructors.

By the many inaccurate states and returns furnished it is evident that further instruction of Orderly Room Sergeants and Pay and Orderly Room Corporals is needed. This might be afforded by Regimental Courses of the equivalent of six days, which need not be continuous but distributed to suit the personnel. To encourage these non-commissioned officers it is desirable that, on the certificate of the Commanding Officer that those attending have qualified, they receive the same pay as is allowed to successful candidates at other Courses of Instruction. Regimental Courses are suggested in the interests of economy and to allow the Adjutant who is responsible for the administration of the unit to supervise the instruction personally.

#### PERMANENT FORCES AND SERVICES.

128. Establishments.—The Staff Corps.—Since the retrenchments of 1922, conditions of service have assumed a more settled aspect, normal wastage has been replaced, and the Permanent Forces are now almost up to the reduced establishment at present authorized. During the year following the retrenchments of 1922 there was more wastage in the Staff Corps, from voluntary retirements, than was anticipated, and as the output from the Royal Military College was insufficient to complete the establishment, those who graduated in 1919, 1920 and 1921, and who were compulsorily retired in 1922, were invited to rejoin. Eight of these accepted the offer and have rejoined with their original seniority.

129. The Australian Instructional Corps.—Similarly as regards the Australian Instructional Corps, there were many resignations. These have been made good by promotion from the ranks of the Permanent Forces or by enlistment from the Militia Forces. Considering the conditions of service at present offered in the Australian Instructional Corps, it is a matter for congratulation that the position regarding the establishment of this Corps is so satisfactory, and I cannot commend too highly the loyaly and devotion to duty of all those who are now serving.

130. The Staff Corps.—Training Abroad.—The Staff College.—Within the period under review, one officer of the Staff Corps completed two years' training at the Staff College, Camberley (England), and another at Quetta (India).

Two officers at Camberley and one at Quetta completed their first year, whilst two officers commenced the Staff College Course at Camberley and one at Quetta.

Of the nine candidates who presented themselves for the Staff College Entrance Examination in February, 1923, six qualified. The Chief of the Imperial General Staff has specially commented on the high standard of the work, and those competing are to be congratulated on the thoroughness of their preparation for the examination.

Fourteen officers sat for the examination in February, 1924, but the results are not yet to hand.

Unfortunately, funds and a small establishment do not permit of more than three officers being sent to the Staff Colleges each year. This limit, however, results in keen competition and with it the necessarily increased military education of all officers studying for the examination. 131. Special Courses.—In addition to the officers of the Staff Corps at present at the Staff Colleges—one officer is in England attending a Gunnery Staff Course, another undergoing Courses of Instruction for two years in Signals and Wireless Telegraphy, and two officers are attending a Course of Training to qualify as Inspectors of Ordnance Machinery.

132. Exchange Officers.—The system which obtained prior to the Great War of the exchange of officers between Australia and other portions of the Empire was re-introduced by the exchange of two officers from Australia with one from England and one from India respectively, for a period of two years.

133. Duntroon Graduates.—The sending abroad of Duntroon graduates to learn their regimental training, upon which so much stress was laid by the late Lord Kitchener, has been resumed, and the graduates of 1921 were sent to India in November last. Though the two years' postponement is regrettable, it is not without its advantages. The graduate will now have every opportunity of becoming thoroughly versed in Australian conditions before he goes abroad (vide my Report of 1921).

As the training season in India begins in October, these graduates should in future sail in September.

134. Training in Australia.—Schools and Courses.—Schools of Instruction under section 21A of the Defence Act, to prepare officers for promotion, have been conducted by the General Staff and refresher courses for Staff Officers have been held under Divisional arrangements as far as funds have permitted.

Two officers have qualified at technical courses, and six are undergoing instruction, viz :--four at the Universities in Civil Engineering and two in the Telegraph Department.

135. Examinations.—The improvement in the results of examination for promotion, which was mentioned last year, has been maintained.

Covering a period of twelve months, 31 officers presented themselves for promotion to Captain, of whom 23 passed and eight partially qualified (i.e., failed in one subject only).

During the same period, eight candidates were examined for promotion to Major, all of whom passed.

The written portion of the examination, with the exception of part of one paper set specially for Australian conditions, is that set by the War Office for officers of the British Regular Army.

Eight officers were examined for promotion to Lieut.-Colonel, of whom seven passed.

136. With one or two exceptions there are no officers studying foreign languages, which is a matter for regret in view of the need for interpreters in the event of war. I would again draw attention to the need of offering some inducement in the form of monetary awards to officers who qualify as interpreters.

137. The Australian Instructional Corps.—The conditions of service in this branch of the Military Forces have been mentioned above, and though the establishment is practically complete, the numbers allow of no margin to cover the absence of a proportion of Instructors on special duty or Courses of Instruction. This causes depletion of units' staffs and the consequent accumulation of arrears during their absence.

138. The technical instruction of the A.I.C. personnel included-

- (i) Weapon training at the Small Arms School, Randwick, and the Artillery School of Instruction, at which 113 and 29 attended and qualified, respectively.
- (ii) Refresher courses in drill, administration, and tactical exercises at the Annual Staff Course (fourteen working days), which 308 attended.

139. Whilst it may be said that there has been a general improvement in the efficiency of the A.I.C., it is certainly not yet up to pre-war standard. The need for the re-opening of the Central Training Dépôt for refresher courses and for the training of future instructors is very apparent.

140. The necessity for educational qualification has been recognized, and the subjects for examination now embrace English, History, Geography, Arithmetic and Map Reading. During the past year, for the 1st class certificate, 23 completed and 31 partly qualified; for the 2nd class, 2 completed and 6 partly qualified; whilst for the 3rd class, 34 completed.

141. Royal Australian Field Artillery.—The section of Royal Australian Field Artillery (which is the only unit of Permanent Field Artillery in the Commonwealth) has made marked improvement during the year. This was due primarily to the fact that recruiting has been whitted and that, in consequence, the acute shortage in personnel from which the unit suffered last year has been overcome. The unit was able, by reason of its increased strength, to go into camp at Liverpool for six weeks to carry out its annual Battery Training. During this training warrant and non-commissioned officers of the R.A.G.A. were attached from other Military Districts for instruction in Field Artillery work.

142. This unit is the only training ground for the production of Field Artillery Instructors for the Citizen Forces, and it is also used as the dépôt or training hattery for the Artillery Schools of Instruction.

The constant drain upon the establishment of non-commissioned officers of this small unit, as they become qualified, to fill vacancies for Instructors to the Militia Field Artillery militates against the maintenance of that high standard of training which one would like to see in a permanent unit.

It is most desirable that, when funds permit, it should be expanded to an establishment which will enable it more effectively to perform its important functions.

143. Royal Australian Garrison Artillery.—Battery practices have been carried out at all stations except Thursday Island and in the 4th Military District. The annual trainings in most cases were made to synchronize with the Citizen Force Garrison Artillery Camps of Training, thus permitting combined practices to be carried out.

The concentration of the bulk of the Royal Australian Garrison Artillery at Sydney, Queenscliff and Fremantle was brought into force this year, and enabled a higher standard of training to be attained.

144. The efficiency of this regiment is very adversely affected by the abolition of specialists pay for men who by extra work and diligence qualify themselves as specialists in Range Finding, Gun Laying and Signalling. At the present time there is no inducement for the rank and file to attain qualifications in these important duties.

There is a great improvement in the "turn out" of this unit.

145. Royal Australian Engineers.—The work of the year has consisted, as in the previous year, in maintenance of plant and recruit training.

The reduced personnel has been barely sufficient to keep the plant in order, and very little training has been possible.

146. Recruits have been trained at a Central Training School in Victoria. While this has the advantage of uniformity of training, the ordinary work of maintenance of Coast Defence suffers very considerably owing to the absence of personnel. This could be largely obviated by training the recruits at Sydney and Queenscliff, the two stations requiring the most attention. Central training schools are not as necessary for the training of recruits as they are for the training of non-commissioned officers.

Part of the recruit training has been carried out at Seymour on the construction of a rifle range. This has afforded valuable experience for officers and men in concrete work, and also in the handling and organization of working parties.

147. Survey Section.—Steady progress has been made by the Survey Section since 31st May, 1923, and in spite of the very reduced strength, work has been maintained in the three Military Districts of Queensland, New South Wales and Victoria.

There are at present only nine topographers on the establishment, and it is very desirable that this number should be increased with a view to expediting the work, which is of great public value in addition to its military value. Moreover an increased establishment would considerably reduce the cost per square mile of surveys.

148. During the past eight months the topography of 650 square miles of country has been completed, and the trigonometrical work has made good progress.

149. During the last Pan-Pacific Scientific Congress held in Melbourne in August, 1923, advantage was taken of the presence of Sir Gerald Lennox-Conyingham, head of the British Delegation and late Director of Surveys, India, for a conference to be held on the question of a suitable grid for Australian survey maps.

150. Aerial Surveys.—Little or no advance has been made in the development of aerial surveys during the last year, and the technical difficulties outlined in the last Report have still to be overcome before practical results can be achieved. The test survey of the Geelong sheet proposed last year was not proceeded with, owing to the shortage of personnel and machines of the Royal Australian Air Force.

The Hydrographic Branch of the Navy produced a map of Western Port Bay in 1923, from aerial photographs taken by the Royal Australian Air Force and based on a ground trigonometrical survey. This map was quite a success. and depicted very useful information which could hardly have been obtained otherwise than by aerial photography. Following on this, it has been decided to extend the principle of this survey to the charting of the Great Barrier Reef, and the preliminary work is now in progress.

It is considered that this aspect of aerial surveys, the photography of coast line and groups of small islands adjacent to the coast, can be used as a valuable adjunct to the military surveys, and will record information not accessible to the topographer.

151. Printing of Maps.—Arrangements have been made for the purchase of the latest camera for map reproduction, the use of which will result in a clearer and finer map, expedite work and reduce the cost of production.

152. Army Service Corps.—The Supply and Transport work allotted to the sections of the Australian Army Service Corps (Permanent) in the various Districts has been efficiently performed during the year.

It is considered, however, that early action should be taken to replace the horsed transport now used by these sections by mechanical transport lorries. This would greatly extend the sphere of usefulness of the Australian Army Service Corps Sections, and, though an initial outlay would be involved, I am sure that an ultimate saving would result by reason of the increased transport work which could be performed by the Department, both for itself and, where possible, for other Commonwealth Departments, thus reducing the amounts now paid to contractors for cartage and haulage.

These lorries, if provided for the Permanent A.A.S.C. units, could also be allotted to the Citizen Force Divisional Trains in turn for use at their camps in connexion with their training in the handling, &c., of mechanical transport, as well as for the transport work at camps. In this connexion it must be borne in mind that the Divisional Trains of the British Army have now been mechanicalized, retaining horsed transport for use in emergencies only.

153. It is a matter for consideration whether our Divisional Trains should not be reorganized similarly, in which case the most economical method of providing for their needs in peace would be to take action on the lines indicated above.

154. The Remount Service.—In my Reports of last year and the previous year, attention was invited to the inadequacy of the personnel provided to cope efficiently with the preparation and training of the horses, more especially when heavy demands for camps are made. This to some extent has been rectified by increasing the lower ranks. Considerable difficulty, however, has been experienced in obtaining suitable recruits, as higher wages are obtainable outside the Department for work similar to that required. The increased personnel allows for approximately one man to 17 horses and one farrier to 55 horses, which is clearly insufficient to keep the horses properly shod up, quiet, and tractable for the work required.

I must urge the necessity for a sufficient increase in the personnel to ensure that these horses are sufficiently exercised to keep them quiet and tractable.

In a great many instances trainees have very little knowledge of riding or driving on joining the service, and, however willing they may be to learn, are to a large extent deprived of sufficient opportunities of doing so during the year at voluntary riding and driving classes through lack of Remount personnel to attend to the horses, and, I might also add, insufficient funds for maintenance to enable the required number of horses to be kept in stables for this purpose. The limitations which have had to be placed on the demands for horses by units such as the Artillery, Field Engineers, Signals, and A.A.S.C. owing to the foregoing. disabilities, are unduly harassing Commanding Officers in the execution of their duties, and seriously affecting the efficiency of the units referred to.

155. In addition to recommending an increase in the Remount personnel, I recommend that consideration be given to further increasing the vote for the maintenance of the horses.

156. The horses supplied have been well selected and are of suitable types, though many of them are now very old. A considerable number have been in the service for twelve years, which speaks well for the care that has been bestowed on them. The replacement of horses as they become unserviceable and are disposed of should not be lost sight of, and should be effected by buying a few each year as required.

157. The dépôts are in fair order, but in some instances fencing needs attention and ouildings require painting. The plant, such as harness, vehicles, implements, &c., have been yell cared for. Farming operations at Glenthorne Farm have been satisfactory. 158. The three thoroughbred stallions mentioned in my last Report as standing at Enoggera, Holdsworthy, and Maribyrnong respectively have been well patronized; the fees charged for the service of these horses is moderate, viz :---£3 3s., bringing them within the means of the small horse-breeders and farmers, to whom their services, as far as practicable, have been restricted. Their progeny is well spoken of. An extension of this scheme was recommended in my Report of 1921.

159. Encouragement to the farming community to breed serviceable remounts is becoming more necessary year by year. Suitable thoroughbred stallions are not available at a fee the average farmer can afford to pay. I would again invite attention to my previous remarks on the question of improving the standard of our riding horses. In addition to the means I have suggested in my previous Reports in this regard, the Quartermaster-General, Major-General V. C. M. Sellheim, has suggested that stallion premiums of sufficient value to encourage the keeping of thoroughbred stallions be provided. This suggestion is worthy of consideration.

The breeding, in the closely settled districts, of light cavalry horses has reached such a dangerously low ebb that Government assistance appears to be necessary in order to revive the industry.

160. With regard to effecting an improvement in the standard of horses bred on the large stations in New South Wales, Queensland, and Central and Western Australia, it is obvious that the Commonwealth Government cannot give any assistance at the moment other than advice. Breeders should be advised to dispose of all mares which may be for any reason unsuitable to produce good, sound stock, and to use thoroughbred stallions only that have been passed as sound in every respect by a competent veterinary surgeon and are suitable in type and conformation for begetting high-class animals.

This would, in my opinion, be the only means of restoring a market which has been allowed to weaken and almost disappear through neglect. Owing entirely to the deterioration referred to in every Report I have furnished since the recent war, the Indian Government, our greatest customer, is now looking elsewhere for Army horses.

161. The Ordnance Services.—Permanent Ordnance Corps.—A permanent Ordnance Corps, the formation of which was approved by the Government in 1918 and recommended by the Business Board and Senior Officers Conference, is essential as a part of the Mulitary Organization. Although practically little expense is involved in its formation, for various reasons the unit has not yet been raised.

162. The Civil Ordnance Staff.—Delay in filling existing vacancies on the Civilian Staff of the Ordnance Branch has been prejudicial to the work. Appreciable progress has, however, been made during the past year, but the existing personnel is quite insufficient for the proper care and maintenance of materiel and equipment.

163. Repairs to Post Bellum Equipment.—A sum of £25,000 was specially appropriated for repairs and overhaul of explosives, vehicles, saddlery and other equipment. Large sums are still necessary to prevent further loss and deterioration and to make the equipment serviceable.

164. Ordnance Workshops.—A question which has been prominent for the past four years, but with which little progress has been made owing to financial stringency, is the establishment of ordnance workshops, which must exist for the efficient upkeep of military equipment.

Great difficulty was experienced in all Military Districts in getting both men and material to carry out the repairs to the *post bellum* equipment, and the lack of proper workshops was a severe handicap. Contract work in connexion with material of this description is undesirable. It can be done much more efficiently and economically in departmental workshops At present machinery is lying idle and valuable material is deteriorating.

165. Pay.—I feel it to be my duty to again draw attention to the discontent which exists in the Permanent Forces owing to the inadequate rates of pay allowed. The soldier is, quite rightly, on grounds of discipline and public policy, debarred from taking any collective action to ensure improvement in conditions of service either by access to the Arbitration Courts or otherwise.

It follows, therefore, that, in justice, a responsibility is placed upon the authorities to ensure, on their own initiative, that the rates of pay and conditions of service are such as not only to maintain the Forces in a state of efficiency, but also to afford a reasonable recompense and standard of living to the individual. The admirable loyalty and unstinted service of these members of the Permanent Forces, in the face of the disabilities which they suffer in this respect, affirm the moral obligation of the authorities towards them rather than afford a reason to neglect their welfare. 166. With regard particularly to the Warrant Officers of the Australian Instructional Corps, I would point out that this corps is, to a great extent, the backbone of the Citizen Army. It falls to the lot of these men, under the supervision and control of the officers of the Staff Corps, to take a primary part in the training and handling of the youth of this country during the period of the performance of their obligation under the Defence Act. The trainees come under military control during the most impressionable years of their life, and on grounds of public, as distinct from purely military interests, it is essential that only the best type of man should be employed in the working of the universal training system.

These Instructors are required to possess a sound knowledge of a wide range of military subjects such as drill, the weapons of the various arms, musketry, physical training, elementary tactics, and in the technical arms, gunnery, military engineering and equitation. They further require the ability to impart their knowledge by sound methods of instruction and teaching, to ensure discipline and order, to carry out important functions of administration which bring them closely in contact with the civil population, and to stimulate interest and enthusiasm in the units to which they are attached.

There can be no doubt that the proper performance of these duties demands qualities of character, personality, tact, and general ability above the average, in addition to a sound professional knowledge. Yet in spite of this the pay of a number of these warrant officers is below the basic wage of a labourer.

167. A departmental Committee was recently appointed to consider this question. It is earnestly to be hoped that some improvement in the matter of pay will result.

168. Superannuation.—With regard to the question of superannuation it is desired again to point out that the Public Service Superannuation Act affords little benefit to the members of the Permanent Forces. In the first place, it does not apply to ranks below that of a commissioned officer. Owing to the fact that the rank and file are required under the Defence Act to be enlisted for specified periods of service the men are not regarded, legally, as permanent employees within the meaning of the Act, even though there may be no actual break in service extending over a lifetime. On account of this anomaly, the rank and file are debarred from contributing to the Superannuation Fund or receiving from it any benefits whatever.

A further disability is caused, in regard to officers who are compelled to contribute, by the fact that the retiring age of military personnel is necessarily fixed at a lower age than 65, which is the earliest age at which, under the Superannuation Act, a full pension may be granted except when retirement is caused by physical disability.

The ages for retirement of Military Officers are :---

On retirement at ages below 65, officers as from the date of their retirement are eligible only for a pension which is the actuarial equivalent of the contributions made or to be made by them and of the share of pension payable by the Commonwealth and accruing to them under the Act. This actuarial value decreases so sharply with each year short of 65 that the pensions in most cases are negligible.

169. The shortcomings of the existing Act in relation to members of the three services have been considered by a Departmental Committee, which has submitted its recommendations to the Minister. It is understood that the proposals are now receiving the attention of actuarial experts of the Department of the Commonwealth Statistician. It is earnestly hoped that action may be taken, as soon as it is possible to do so, to adjust the anomalies referred to and to provide a reasonable superannuation scheme covering all, instead of only a portion, of the members of the Permanent Forces.

#### THE SENIOR CADETS.

170. Introduction.—On the 30th June, 1924, the last of the Senior Cadet quotas who have served their full statutory term in the Senior Cadets (four years) will be allotted to the Citizen Forces. The Senior Cadets will then consist wholly of boys who commence their training in their sixteenth year and serve for two years before transfer to the Citizen Forces.

The full effect on the Senior Cadet organization of this short term of service has still to be felt.

171. The Senior Cadet training for the shortened period serves a very useful purpose from the point of view of preparing the cadet for his Citizen Force service, particularly in regard to administrative preparations such as medical examinations, issue of clothing, bringing the youths into touch with the Area Staffs, and ascertaining their qualifications for allotment to the various arms. It also serves in some measure to give the Senior Cadets instruction in the rudiments of drill, musketry, and physical training. But it is essential that the organization for the handling, control and discipline of Senior Cadets should be efficient especially as it is during his Senior Cadet training that the young soldier gains his first impression of military service. It is precisely on this latter point that the short term of service is likely to cause difficulties which will now become acute because of its effect on the production of cadet officers and non-commissioned officers. It was possible under the four years period of service to select suitable material for cadet officers and non-commissioned officers by competitive examination from amongst the older boys who had time to become proficient in their duties and were enabled on that account and by reason of their seniority in age to carry weight with the younger boys. Under present conditions this is a most difficult matter and, unless a remedy be found, it is likely to have an adverse effect upon the Senior Cadet organization.

Two possible remedies suggest themselves :---

- (a) To provide all Senior Cadet officers from the parent Citizen Force Unit and increase the establishment of the latter accordingly; or,
- (b) To provide all Senior Cadet officers from enthusiastic citizens over the training age who would volunteer for this service

In both cases it would be desirable to provide Sergeants for the Senior Cadets from the Citizen Forces and limit promotion of the Senior Cadets themselves to the rank of Corporal.

Both of these alternatives would result in some increase in the cost of the Senior Cadet organization. The first, though probably the best, method would be somewhat more costly than the second.

172. I do not advocate, at all events at present, any return to the four year period of service for Senior Cadets. In fact, in view of all the circumstances, I think that, if the Citizen Force training be increased by one year, the period of Senior Cadet service might be correspondingly reduced. Senior Cadet training would then begin in the trainee's seventeenth year, and would continue for one year only before transfer to the Citizen Forces. This would have the effect of reducing the strength of the Senior Cadet organization by one half, and would enable it to be handed by the Area Staff with a minimum of outside assistance. The one year of preparatory training in the Senior Cadets would be devoted to the establishment of touch between the trainees and their Area Staff and units, medical examinations, issue of clothing, and other administrative work, and ascertaining the suitability of the youths for allotment to the several arms of the Citizen Forces. In addition there would be time to give the Senior Cadet a limited amount of recruit drill and elementary musketry instruction designed specifically to prepare him for his Citizen Force training.

A reduction in cost would result particularly in regard to uniform which, when issued at seventeen when the youth is more developed physically, would not require to be replaced during the remainder of his service in as many instances as occur at present when the issues takes place at sixteen.

While resulting in a saving of cost, the one year of Senior Cadet training would serve all the requirements of administration and would give a reasonable though limited amount of preparatory recruit training. The cutting off of one year's training at the commencement of the trainee's service and putting it on at the end, when he is better fitted by reason of his age to be exercised fully in military work, would, I feel sure, place our whole military organization on a sounder basis.

#### TRAINING.

173. Officers.—The attendance of cadet officers at Courses of Instruction and Regimental Classes has been generally satisfactory and the inclusion of more cadet officers in these is desirable.

174. Cadets.—During the year, Senior Cadet training has made an appreciable advance, particularly in musketry. Large numbers are active members of rifle clubs, and are thus of assistance in the supervision of other cadets during the practices of their units.

Close order drill is in general as satisfactory as circumstances permit. The intervals between parades prevents the attainment of that precision which characterizes trained troops, but, nevertheless, results of appreciable value are being attained. Signalling has not made the same general progress as the other training. This is due mainl to the limited time available for instruction, but in some cases, where qualified Instructors ar available, excellent results have been attained.

175. Attendance.—The attendance at compulsory parades continues to improve. Thi is largely due to the promptitude with which Area Staffs deal with absence. and to the fact tha generally the syllabus of training is more progressive and interesting.

. 176. Registration.—Since the suspension of training for the first two years, a diminution, of the numbers registered has been noted throughout the Commonwealth. The reasons advanced, and which are borne out by facts, are the ignorance of parents and trainees of the provisions of the Defence Act in respect to registration, and their assumption that such is not now necessary until the year in which training is commenced.

It is evident that notices exhibited and advertisements in the press are insufficient to make the obligation to register universally known.

Actually, registration in January or February of the year in which a boy attains the age of fourteen years is succeeded by a period of over two years before he is medically examined and called up for training. During this period he is required to notify change of address. This is often forgotten through carelessness or lack of association with an Area Staff, or is ignored with intent to evade, the result being that the tracing of a boy who from either cause has failed to notify change of address is extremely difficult.

The means at the disposal of Area Officers are not sufficient to enable personal investigation to be undertaken in each case, and the at first careless youth often becomes a deliberate evader simply because he gains a feeling of security, believing that all trace of him has been lost.

177. Medical Examination.---From the number of undersized or otherwise unsuitable, though technically physically fit, cadets in training it is evident that the medical examination should be of a more rigorous nature. It is not yet realized that the ideal of building up the physique of the nation has had to be abandoned, owing to shortage of funds and consequent curtailment of the training, and that only those who are actually fit and suitable for military training should be passed.

178. Uniform.—Carelessness is still apparent in the fitting of uniform, and it will never be popular unless the cadet feels that he looks smart in it. There is still a tendency to wear collars and ties, which further detracts from the smartness of the uniform.

179. Provost Staff.—The work of the Provost Staff has been meritorious. The personnel of this branch, which works unobtrusively in the tracing of missing trainees, deserves commendation for the concrete results obtained.

It would greatly facilitate their work if Commanding Officers who require trainees traced would take more care in furnishing adequate and correct details of the trainee, together with any information which might help in the search.

180. Athletic and Military Competitions.—Except in the 1st and 2nd Military Districts, where very successful competitions have been held, the interest in sports competitions has waned considerably.

This loss of interest is due to the decreased activity of Citizens Encouragement Committees, which is much to be regretted. An active Encouragement Committee does much to bring the Area Staffs into close association with the parents of trainees.

The inclusion in the sports programmes of military competitions which include the Citizen Forces has been of value in stimulating training.

#### JUNIOR CADET TRAINING.

181. The scheme of Junior Cadet training in schools (which was inaugurated on 1st July, 1911) ceased, owing to enforced economy, to be an activity of the Defence Department on 30th June, 1922, after a period of eleven years' efficient work.

Since its discontinuance frequent representations have been made to the Department by the several States Education Departments urging the Commonwealth to re-introduce the scheme, and the question was listed as a subject for discussion on the Agenda Paper of the Premiers' Conference of May, 1923.

It was affirmed that the State Governments could not provide efficient uniform instruction in physical training without a co-ordinating authority, and that the national value of the work could not be over-estimated.

Following on the above representations, the subject was considered by the Cabinet on 8th November, 1923, and it was decided that, provided the State Governments were willing to meet the ordinary expenses of the scheme and provide facilities for the school teachers to obtain instruction, the Commonwealth would provide the co-ordinating authority and a competent instructional staff capable of qualifying the teachers and ensuring a measure of uniformity throughout the Commonwealth.

The State Governments have officially intimated their acceptance of the proposals.

It is proposed to re-introduce the training, with certain modified requirements, as from the commencement of the next training year.

The re-introduction of this training will be of great national value, but, as it ends when the boy leaves school, it will fall far short of the original intention, i.e., that the youth of Australia should be systematically trained physically from the age of 12 to 25 years.

## EXPEDITIONARY FORCES.

Interest is displayed in connexion with certain existing activities associated with the late Expeditionary Forces, and I am advised that the position is as follows :---

#### WAR HISTORIES.

182. National Histories of the War .-- There have been published during the past year the following volumes :--

Volume VIII.—" Australian Flying Corps," by Mr. F. M. Cutlack. Volume XII.—" The War in Photographs."

Volume IX. (Naval) is with the printer, and Volume X. (Rabaul) is about to go; Volume II. is near completion, and these will be followed by XI. (" The War Effort in Australia").

#### WAR MEMORIALS.

183. Villers Bretonneux.--The Cabinet has decided to proceed with the erection of a Memorial at Villers Bretonneux at an estimated cost of £100,000. The names of all missing are to be inscribed on the Memorial, which, however, is to be known as an "Australian Memorial" and not a "Memorial to the Missing". A competition among Australian artists is to be held for the most suitable design. Material is to be sent from Australia.

Port Said .- The competitive designs received have been considered and awards made. Arrangements have been completed with Mr. Web Gilbert for the sculptural group, and with Messrs. Stephenson & Meldrum for the pedestal, base, &c. The work will take four years to complete.

Divisional Memorials.—These have now been finally completed, with the exception of the 2nd Divisional Memorial, in connexion with which the sculptural group is now being cast in Paris.

The 5th Divisional Memorial has been taken down and re-built on foundations extended down to solid ground.

The 1st Australian Tunnelling Company Memorial has been rebuilt on a new site.

184. War Graves.—The construction of cemeteries abroad by the Imperial War Graves Commission is advancing rapidly, and various reports from the High Commissioner and others are to the effect that the appearance and maintenance are satisfactory in every way.

In Australia, where the graves are in general cemeteries, the erection of headstones is now in progress. The total number of headstones to be erected is approximately 2,000, and of these approximately 1,000 will have been completed by the 30th June next. Arrangements are being made for the maintenance of the graves.

185. War Medals.-Some 40,000 medals have been distributed during the past year, but a very large number remain unclaimed, as will be seen from the following table :---

## PART VIII.-COURTS-MARTIAL.

Power to constitute courts-martial Amended by No. 36, 1917, 5, 23.

- 86.—(1.) The Governor-General may—
  - (a) Convene courts-martial;
  - (b) Appoint officers to constitute courts-martial; and
  - (c) confirm the finding, or finding and sentence of any courtmartial, or in the case of a military court-martial send back the finding and sentence or either of them for revision;
  - (d) mitigate or remit the punishment or any part of the punishment awarded by any sentence, or commute the punishment for any less punishment to which the offender might have been sentenced by the courtmartial; and
  - (e) suspend the execution or currency of any sentence on such terms and conditions (if any) as he thinks fit.

Added by No. 36, 1917, s. 23. (2.) Nothing in this section shall affect the powers conferred by the Army Act in regard to the Military Forces or the Naval Discipline Act in regard to the Naval Forces of convening courtsmartial and confirming the findings and sentences of those courts.

96. Every person who is tried by court-martial may be assisted in his defence by counsel. And if the offence charged be punishable by death he shall be entitled to be defended by counsel assigned by and at the expense of the Crown unless on war service the authority convening the court or the Presivent thereof, by writing under his hand (which shall be conclusive) declares that military exigencies or the necessities of discipline (the nature of which exigencies or necessities shall be specified in the declaration) render it impossible or inexpedient to procure the attendance of counsel.

(2.) All regulations shall be notified in the *Gazette* and shall thereupon have the force of law.

(3.) All regulations shall be laid before both Houses of the Parliament within fourteen days after the making thereof if the Parliament be then sitting, and if not then within fourteen days. after the next meeting of the Parliament.

(4.) If either House of the Parliament passes a resolution, at any time within fifteen sitting days after any regulation is laid before it, disallowing any such regulation, that regulation shall thereupon cease to have effect.

(f) Persons whose bond fide residence is not within a distance of five miles, reckoned by the nearest practicable route, from the nearest place appointed for training:

Provided that the regulations may authorize the District Commandant to grant temporary exemption for a period not exceeding one year, renewable from time to time, to persons who reside at so great a distance from the places appointed for training that compulsory attendance would involve great hardships.
