I BEG most respectfully to submit the following statement for your Lordship's consideration.

I am a Parsee by birth, a native of Bombay, and a member of the Royal College of Surgeons of England. I came to London in June of last year with the especial object of competing for an appointment in Her Majesty's Indian Medical Service. Though I had completed a five years' course of medical studies in Bombay, I resolved to spend twelve months in study in this country to further my medical knowledge, and to qualify myself the better for an appointment in the army. About the beginning of November last it was announced that, in consequence of the amalgamation of the Indian and British forces, there would in future be only one examination for both the services, and that out of the successful candidates a certain number would be appointed to Her Majesty's Indian forces. It was also announced that the candidates would be admitted for examination under the same regulations which were applicable to home service. As one of these regulations required that all candidates should be unmarried, and as I was married, it formed an objection to my being admitted for examination. I consequently represented my case by a written application, dated 29th November 1860, to the Director General of the Army Medical Department, who submitted the same to your Lordship, and I was thereafter informed that your Lordship had decided it in my favour. To my utter disappointment, however, I learned from the Director General on the 5th ultimo, that as natives of India of native parentage are deemed by your Lordship unfit for entering into Her Majesty's general medical service on account of their supposed physical incapability to perform the active duties of medical officers in cold climates, such as Canada, I will not be allowed to offer myself for examination.

I would, however, humbly venture to hope that the consideration of the following facts will induce your Lordship to rescind the above decision in my case:---

lst. Natives of India are of various denominations, manners, and customs. They differ widely in their mode of life. Their constitutions are different, and, in some races, the power of resisting the vicissitudes of elimate is very great. I believe, however, that I am correct in stating, that of all the natives of India, none are more English in constitution, and in mode of life generally, than my own countrymen, the Parsees.

2d. The Parsees of the present day live in all parts of the world : a few are in Australia, a large number in China, many now in England, and within the last year two of them have established themselves in New York. For the last 50 years or more, the Parsees have borne the severe cold winters of Canton and Shanghai, without the least inconvenience to their health or risk to their life. Within the last six years they have established themselves in London, and later still, in Liverpool and Manchester, and are at this day here in sufficient numbers (about 45, including children of all ages) to enable a fair inference to be drawn. It is an unquestionable fact that they have borne several winters, and the last a most severe one, with perfect impunity. I am moreover able to say, that they follow their different occupations with an increased amount of mental and bodily labour, and yet enjoy better health and strength than they did in India. In my own case, I beg to state that during the past severe winter, I have, with ordinary warm clothing, been called out at all hours, during the night as well as day, to attend to medical duties, without experiencing any bad effects whatever. On the contrary, though working mentally for a longer time during the 24 hours than I used to do in India, I have actually improved in health since I arrived in this country.

I trust your Lordship will excuse the length of this communication, and most anxiously awaiting your decision,

CORRESPONDENCE relative to the general Question of admitting Natives of India Correspondent to the Army Medical Service.

WITH reference to previous correspondence on the subject of the competitive examination of candidates for appointments in Her Majesty's British and Indian Medical Services, I have the honour to solicit the instructions of the Secretary of State for War, as to whether candidates above the age of 26, who state that they have been studying with a view to enter the Indian Medical Department, on he faith of the regulations of that service admitting gentlemen up to 28 years of

age, may be allowed to compete at the next examination. I beg to add, that I make this inquiry to enable me to answer numerous applications which I have received from gentlemen, who state that they are thus circumstanced.

I HAVE laid before the Secretary of State for War your letter of the 24th instant, in which you inquire whether candidates for appointments in the Army Medical Service, who have been studying with a view to enter the Indian Medical Department, on the faith of regulations under which they could be admitted up to 28 years of age, may be allowed to compete at the next examination, though above the age of 26.

In reply I am to acquaint you, that under the circumstances, Mr. Secretary Herbert considers that the proposal is only fair and reasonable, and should be adopted.

Sir, War Office, 10 January 1861. I AM directed by the Secretary of State for War to transmit to you for the consideration of Sir Charles Wood, the enclosed copy\* of a letter from Mr. M. Beramjee, in reference to the application to natives of India of the regulation which requires that candidates for admission to the Army Medical Service shall not be married men.

This application has raised the more important question as to the rule which should be laid down in reference to the admission of natives of India to medical appointments with the army. They are clearly unsuited for general service, and ought therefore only to be allowed to compete for local appointments, and with native troops.

Mr. Herbert will be glad to be furnished with the opinion of Sir C. Wood on this subject, and at the same time to be informed whether any, and if so, what expectations have been held out to the students at the Medical College at Bombay of being admitted to the military medical service.

Sir, India Office, S.W., 19 January 1861. I HAVE laid before the Secretary of State for India in Council Lord F. Paulet's letter, No. 7644-161, dated the 10th instant, enclosing a representation from a native of India regarding his exclusion as a married man from the competitive examination to the medical service of the British Army; and, with reference to the concluding paragraph of the letter above quoted, I am directed to observe that expectations of being admitted to the medical service of the Indian armies are held out to native medical students in the clauses of the Acts of Parliament named in the margin, and that since the passing of the Act of 1853, several c. 85, sec. 86. named in the margin, and that since the passing of the Act of 1853, several 16 & 17 Vic., c. 95, natives have obtained commissions as assistant surgeons in Her Majesty's Indian service.

> I am further directed to express Sir Charles Wood's concurrence in the opinion of Lord Herbert, that natives of India of native parentage, are unsuited for general service in the British Army, and to state that he could not recommend that they should be permitted to compete for assistant surgeoncies in that armv

> The provision of suitable professional employment in India for native medical students who have qualified themselves to compete for appointments on the faith of the Acts of Parliament above quoted, will be the subject of separate and early consideration.

CIRCULAR Despatch to the Governments of India, Madras, and Bombay.

#### India Office, London, 16 February 1861.

1. THE Secretary of State for War has transmitted to me a representation from Mr. M. Beramjee, a native of Bombay, in reference to the application to natives of India of the regulation which requires that candidates for admission to the Army Medical Service shall not be married men.

2. Expectations of being admitted to the medical service of the Indian armies were held out to native medical students in the clauses of the Acts of Parliament, noted in the margin, and since the passing of those Acts, several natives have obtained commissions as assistant surgeons in Her Majesty's Indian service. Examinations for such appointments have now ceased.

3. Mr. Beramjee, who represents that he left India with the special object of qualifying himself to compete for admission into the Indian Medical Service, prays that the regulation above referred to may not be enforced in his case, and that

that he may be permitted to be examined for a medical appointment. The Corresponde Secretary of State for War considers natives of India of native parentage, unsuited for general service in the British army. In this opinion I have expressed my concurrence.

4. I am desirous that the principals of the several medical colleges in India should be informed of the decision now communicated to you.

5. The withdrawal of the privilege of competing for military medical appointments will, no doubt, cause disappointment to native medical students, who are qualifying themselves to compete for appointments on the faith of Acts of Parliament as above quoted.

I should wish the subject of the provision of other suitable professional employment in India for such students, to engage your early consideration.

I AM directed by the Secretary of State for India in Council to acknowledge the receipt of your letter, dated 18th instant,\* and to observe, with reference to the inquiry made therein, that my letter dated 19th January last, informed you that Sir Charles Wood concurred in the opinion expressed by Lord Herbert, that natives of India of native parentage are unsuited for general service in the British army

Under the late Act of the Legislature, no fresh appointments will be made of assistant surgeons to Her Majesty's Indian forces. The withdrawal of the privilege of competing for military medical appointments will, no doubt, cause disappointment to native medical students who were qualifying for such appointments; and Sir Charles Wood has impressed on the Government of India the importance of endeavouring to provide suitable employment in India for such students

I BEG to solicit the favour of your attention to my request for permission to be examined for an assistant surgeonship in the Indian army, although my qualifications are not within the rules recently laid down for the admission of candidates thereto.

I was born in India, and am 27 years of age; I was educated at the Madras Medical College, and obtained my certificate of qualification there in 1855; from that time until the beginning of this year I was employed at Rangoon. I came over to England in April last, and obtained by examination the degree of doctor in medicine at St. Andrew's University in Scotland, on the 27th of September last. I have been recently informed that candidates will not be allowed to present themselves for examination who are above 26 years of age, and who are present themselves for examination who are above 20 years of age, and who are not possessed of a double qualification. I am desirous of presenting myself for examination in February next, and should feel thankful if I might, under the circumstances, be allowed to be then examined, for otherwise my prospects of advancement in Her Majesty's service in India will be quite destroyed. In consequence of the mutinies in India I was unable to obtain leave of absence to come over here and present myself for examination, and ultimately I was obliged to purchase my resignation at a considerable sum of money. I can produce at your pleasure all my certificates in India, and also my diploma, obtained in Scotland.

Dr. . Thompson. QUALIFICATIONS and EXAMINATION of Candidates for Commissions in the Army Medical Service.

1. EVERY candidate presenting himself for admission to the competitive examination required for the Army Medical Service, must be unmarried. He must produce a birth-certificate from the district registrar, or a certificate of baptism in which the date of birth is stated; or, if neither of these can be obtained, an affidavit from one of the parents or from some other near relative who can attest the date of birth, will be accepted. The certificate or affidavit must show that the candidate is not above 26 nor under 21 years of age. He must also produce certificates of moral conduct and character, one of them from the parochial minister, if possible.

2. The candidate must make a declaration that he labours under no mental or constitu-tional disease, nor any imperfection or disability that can interfere with the most efficient discharge of the duties of a medical officer in any climate an interfere with the most entern neess to engage for general service immediately on being gazetted.

3. The candidate must possess a diploma in surgery, or a license to practise it, from the Boyal College of Surgeons of England, Scotland, or Ireland, or from the Faculty of Physicians and Surgeons of Glagow, or from some other corporate body legally entitled to grant a diploma in surgery, or a license to practise it. He must besides, and in addition to such diploma or license, possess a degree in medicine, or other legal qualification to practise medicine in Great Britain or Ireland.

4. Degrees, diplomas, licenses, and certificates of age and character must be lodged at the Army Medical Department for examination and registry, at least one week before the candidate appears for examination.

5. On producing the foregoing qualifications the candidate will be examined by the Examining Board, on the following subjects :---

Anatomy and physiology.

Surgery. Medicine, including therapeutics, the diseases of women and children, chemistry, and 'pharmacy. (The examination in medicine and surgery will be, in part, practical, and will include operations on the dead body, the application of surgical apparatus, and the examination of medical and surgical patients at the bedside.) Comparative anatomy, zoology, and botany, with especial reference to Materia

The subjects for this part of the examination will be taken from the following books :---

"Animal Kingdom," by W. S. Dallas, F.L. 8.
"Outlines of the Structure and Functions of the Animal Kingdom," by Rymer Jones; or "Cours Elémentaire d'Histoire Naturelle," par Milne Edwards.
Lindley's "School Botany," Lindley's "Medical and Economic Botany," Henfrey's "Elementary Course of Botany."

Candidates who may desire it, may be examined in the elements of physics and in physical geography. The following books are recommended for this purpose :---

(1.) "Elements of Natural Philosophy," by Golding Bird and C. Brooks.

(2.) " Physical Geography," by Mrs. Somerville.

6. The names of candidates who pass the preliminary examination of the Examining Board will be sent to the Director General, and communicated to the Professors of the Army Medical School. The names will be arranged in the following classes :---

#### Class L

Names of those who have passed a pre-emi-nently distinguished examination, arranged lence of each. Fitness for special service. in their order of merit.

#### Class II.

Statement of the topics in which each has Names of those who have passed a creditable examination, arranged in alphabetical individually excelled or fallen short. order.

#### Class III.

Names of candidates who have passed the Statement of the particular branches of minimum examination, arranged in alpha-betical order. betical order.

This information will enable the Professors of the Army Medical School to carry out their instructions with a definite aim as regards each class.

7. After

7. After passing his preliminary examination, every candidate will be required to attend one entire course of practical instruction at the army medical school, before being admitted to his examination for a commission, on,-

(1.) Hygiene.
(2.) Clinical and military medicine.
(3.) Clinical and military surgery.
(4.) Pathology of diseases and injuries incident to military service.

These courses to be of not less than four months' duration.

8. At their conclusion, the candidate will be reqr de to pass an examination on th subjects taught in the school. The examination will be conducted by the professors of the school.

The Director General, or any medical officer deputed by him, may be present and take part in the examination. If the candidate give satisfactory evidence of being qualified for the practical duties of an army medical officer, he will be eligible for a commission as assistant surgeon.

9. During the period of his residence at the Army Medical School, each candidate will receive an allowance of 5 s. per diem, with quarters; or 7 s. per diem, without quarters, to cover all costs of maintenance; and he will be required to provide himself with uniform (viz., the regulation undress uniform of an assistant surgeon, but without the sword).

10. All candidates will be required to conform to such rules of discipline as the Senate may, from time to time, enact.

#### RULES for the Examination of Assistant Surgeons previous to Promotion.

THIS examination is intended as a test for promotion, and may be taken at any time after the Assistant Surgeon has served five or more years. When Assistant Surgeons have served the requisite time, they will be examined in the

following manner :-

A series of printed questions, prepared by the Examining Board, will be sealed and sent by the Director General to the principal medical officers of stations where Assistant Surgeons may be eligible for examination. It will be the duty of the principal medical officer of the station to deliver these sealed questions to the Assistant Surgeons, and to see that they are answered without the assistance of books, notes, or communication with any that they are answered without the assistance of books, hotes, or communication with any other person. The answers are to be signed, and delivered scaled, to the principal medical officer, who is to send them, unopened, to the Director General, together with a certificate from the surgeon of the regiment, or other superior medical officer, that the Assistant Surgeon has availed himself of every opportunity of practising surgical operations on the dead body.\*

The Assistant Surgcon will also be required to transmit, together with his answers to the Director General, a medico-topographical account of the station where he may happen to be at the time, or of some other station where he may have been resident sufficiently long to enable him to collect the necessary information for such a report. Failing this, he will send a medico-statistical report of his regiment for a period of at least 12 months

If the Examining Board is satisfied with the replies to the questions, and the Director General is satisfied with the certificates and with the medico-topographical or statistical report, the Assistant Surgeon will be held qualified for promotion. The Assistant Surgeon will thus be subjected to three separate examinations within

the first for genrs of his service, each examination having a definite object. The first, to ascertain, previous to his admission into the service as a candidate, his scientific and professional education, and to test his acquirements in the various branches of professional knowledge. The second, after having passed through a course of special instruction in the Army Medical School, to test his knowledge of the special duties of an army medical officer; and the third, previous to his promotion, to ascertain that he has kept pace with the progress of medical science.

I HAVE received with surprise and mortification your letter of the 13th of April, stating that, in the opinion of a Board of Medical Officers, I was constitutionally unfit for employment in the various northern climates in which the British army is called upon to serve. I have now been more than one year in England, exposed to the severest winter almost known, and I have never been ill for a single day.

Under the most trying circumstances of a pestilential climate in Burmah I constantly preserved my health, and was never absent from hospital duties for a day; moreover, previously to my examination by the Medical Board, Dr. White, the Government examiner, had pronounced me physically eligible to compete. I respectfully beg, therefore, to ask in what way I am constitutionally unfitted to be employed in northern climates; and I must appeal against the decision of a medical opinion which I feel is not founded on fact, and I am quite willing to submit myself to examination by medical men attached to Life Insurance Offices. I cannot believe that I am to be deprived of the rights of a British subject guaranteed by Acts of Parliament, Her Majesty's gracious proclamation of August 1858, and the recent declaration of the Prime Minister in the House of Commons, because I was born in India, and with a bare shade of native blood inherited from one parent; but I have reason to fear that such is the fact, as I have seen a letter addressed by Dr. Gibson, Director General of the Army Medical Department, to Mr. W. Lyons, who was born in India, and now studying for a commission in the Army Medical Service, stating that he will only be eligible to attend the next competitive examination for appointment in the Medical Department of the Army in case both his parents are Europeans.

On the faith of existing regulations as to age and qualifications for admission into Her Majesty's Service in India, I came to England for the express purpose of competing for medical commission in Her Majesty's Indian forces.

I have qualified myself according to the hitherto existing regulations, and have for some months been anxiously preparing for the competition which I understood was likely to take place next February.

The new regulations promulgated within the last few days, without previous notice, assimilating the qualifications as to age, &c., in the hitherto distinct services, have disqualified me (for I am above the prescribed age of 26), and without any fault or neglect on my part, have utterly blighted my prospects, and reasonable expectation of attaining a position, which has long been the object of my ambition, and for which I have made such great pecuniary and other sacrifices.

WITH reference to the verbal intimation received from you yesterday, stating that natives of India were not eligible for employment in the military service, I have the honour to request that you will kindly favour me with a copy of any rules issued by order of the Government, or any Act of Parliament to that effect. The objection now stated should have been made at once when I applied last year for admission to the examination, which application, on the contrary, met the sanction of the Secretary of State for War; and you directed me to obtain a diploma in surgery, in addition to my degree in medicine, in order to render myself thoroughly eligible according to the recent rules of the service, for the accomplishment of which I have undergone considerable heavy expense, both in money and time.

2. If the Bengal mutiny has been a cause to exclude Indians from the military service, I beg to state that I am the first native from the loyal presidency of Madras, and a man of the highest order of caste, who has offered himself for a medical commission. I came to England on the faith of the advertised promises of Her Majesty's Government, thereby infringing the most revered laws of my country, rendering myself subject to excommunication from my relatives and friends, besides from native society. I am sorry to be obliged to add that if this news of my disappointment should reach India, it will create a great deal of grievance and mistrust in the faith of the British Government. Such combined grievances, chiefly relating to caste, as your Government are aware, had been the cause of the late mutiny.

3. The pecuniary remuneration which you stated that the Secretary of State for India is desirous of granting to me, will not in any way enable me to redeem my caste; and as you were the communicant on this subject from the Secretary of State, I deem that it is but right that you should be pleased to lay this my grevance before him, and procure me at least a free passa ge to Madras, and an appointment as a covenanted civil surgeon, either giving me charge of one of the civil dispensaries in the presidency division or the zillahs (collectorates) upon the same footing as those of the zillah surgeons from the Military Medical Service, with regard to pay, privileges, and status in society. There are other offices, the duties of which I am competent to fulfil; such as of an assay-master, if such appointment is vacant at the Mint; and I trust that if, from State reasons, I am deemed ineligible for the appointment for which, on the faith of the published offers of Government, I have laboured and studied both in India and in England, I may be indemnified by some such appointment, so far as the mere pecuniary loss can be satisfied.

4. I shall, however, in such case, deeply regret that I have not the opportunity of serving Her Majesty in my proper medical capacity, to insure which, I have, with great difficulty, made my way to Great Britain, have passed nearly a year in arduous study in this country, and have obtained the degree of Doctor in Medicine, and of Member of the Royal College of Surgeons.

WITH reference to the request contained in the note of your private secretary, dated 23d instant, I beg to state that my letter of the 19th submitted through the Director General of the Army Medical Department contains a full statement of my case; however, I now submit a brief account of my wishes to your favourable consideration.

In the hope of obtaining a commission in the Military Medical Service, which was the highest boon that natives of India could aspire to in Her Majesty's service, and for which ambition, in the faith of the publicly advertised promises of Her Majesty, I have laboured and studied, both in India and in this country, I made my way to Great Britain with great difficulty, infringing the most revered laws of my country, although a man of the highest caste; I have submitted to abandon this position, and have rendered myself subject to excommunication from my friends and relations. I have passed nearly a year in arduous study in Britain, and obtained the degree of Doctor in Medicine, and Member of the Royal College of Surgeons, for the accomplishment of which I have undergone considerable heavy pecuniary and other sacrifices.

Dr. Gibson has informed me that you are desirous of granting me some pscuniary renuneration and an employment in the Civil Service; I beg, there-fore, that you will be pleased to provide me with a free passage to Madras, and an appointment as a covenanted civil surgeon, either giving me the charge of one of the civil dispensaries in the presidency division, or the zillahs (collectorates), on the same footing as those of the zillah surgeons from the Military Medical Service, with regard to pay, privileges, and status in society. I beg also to bring to your notice that there is an appointment of the kind I allude to granted by the Madras Government to an appleading of Dr. J. Howard) who came-home and graduated, and who, though yet retained in the subordinate Medical Service, holds an appointment as civil surgeon of Ganjam.

My sincere wish is that my appointment should be granted by the Home Government, and instructions sent to the local Government to have my name enrolled on the list of covenanted civil medical servants, instead of having me employed as an uncovenanted sub-assistant surgeon, which is an inferior appointment, and not in any way equal to compensate my labour, pecuniary loss, and my high professional position.

I trust in conclusion that you will kindly take my case into your liberal and generous consideration, and be pleased to grant my request, and despatch me by the next mail if possible, as my detention in England only entails on me heavy additional expense which I can ill afford.

Sir, I would beg respectfully to submit the following circumstances for consideration.

I am a native of Bombay, and by birth a Parsee. I have completed a five years' course of study in medicine, and possess the diploma of the Grant Medical College of Bombay.

In May of last year I left India with the special object of qualifying myself to compete for admission into Her Majesty's Indian Medical Service, and had hoped to have presented myself for examination in June of next year, but according to the regulations, only lately issued, I find that candidates must be unmarried.

Like the great majority of, not only my own class, but of the inhabitants of India generally, I have, although only now 24 years of age, been married for several years; and I may mention that of the 50 students, or thereabouts, now attending the medical college in Bombay, certainly not more than five are unmarried.

I would, therefore, very respectfully venture to represent that, not only would the enforcement of the above-named regulation have the effect of practically nullifying Her Majesty's gracious decision, that the natives of India should be allowed to present themselves for examination along with the rest of her subjects, but that it would fall with particular severity upon myself, as on the faith of the regulations until now in force, I have undergone the expense of coming to this country solely with the before-named object.

May I, therefore, venture to hope that the regulation in question may not be enforced in my case; and on behalf of those of my countrymen, who may in future, like myself, be desirous of obtaining the high honour of an appointment in Her Majesty's Indian service, I would likewise very humbly presume to solicit that the same exemption may be applied to them.

My Lord,

I BEG most respectfully to submit the following statement for your Lordship's . consideration.

I am a Parsee by birth, a native of Bombay, and a member of the Royal College of Surgeons of England. I came to London in June of last year, with the especial object of competing for an appointment in Her Majesty's Indian Medical Service. Though I had completed a five years' course of medical studies in Bombay, I resolved to spend 12 months in study in this country to further my medical knowledge, and to qualify myself the better for an appointment in the army. About the beginning of November last, it was announced that, in consequence of the amalgamation of the Indian and British forces, there would in future, be only one examination for both the services, and that out of the successful candidates, a certain number would be appointed to Her Majesty's Indian forces. It was also announced, that the candidates would be, admitted for examination under the same regulations which were applicable to home service. As one of? these regulations required that all candidates should be unmarried, and as I was married, it formed an objection to my being admitted for examination. I consequently represented my case by a written application, dated 29th November 1860; to the Director General of the Army Medical Department, who submitted the same to your Lordship, and I was thereafter informed that your Lordship had decided it in my favour. To my utter disappointment, however, I learned from the Director General on the 5th ultimo, that as natives of India, of native parentage, are deemed by your Lordship unfit for entering into Her Majestw's general medical service on account of their supposed physical incapability to perform the active duties of medical officers in cold climates, such as Canada, I will not be allowed to offer myself for examination.

I would, however, humbly venture to hope that the consideration of the following facts will induce your Lordship to rescind the above decision in my case :

1st. Natives of India are of various denominations, manners, and customs. They differ widely in their mode of life. Their constitutions are different; and in some races, the power of resisting the vicissitudes of climate is very great." I believe, however, that I am correct in stating, that of all the natives of India, none are more English in constitution, and in mode of life generally, than my own countrymen, the Parsees.

2d. The Parsees of the present day, live in all parts of the world; a few are in ... Australia; a large number in China, many now in England, and within the lastyears two of them have established themselves in New York. For the last 50 years or more, the Parsees have borne the severe cold winters of Canton and Shanghai, without the least inconvenience to their health or risk to their life .... Within the last six years, they have established themselves in London, and lator, still, in Liverpool and Manchester, and are at this day here in sufficient numbers. I am moreover able to say, that they follow their different occupations with an increased amount of mental and bodily labour, and yet enjoy better health and strength than they did in India. In my own case, I beg to state, that during the past severe winter, I have, with ordinary warm clothing, been called out at all hours, during the night as well as day, to attend to medical duties, without experiencing any bad effects whatever. HAVING failed in obtaining definite information, I am compelled to trouble you. To be brief, I was sent from India by my father, with the express view of studying for Her Majesty's Indian forces; and though European, I was sufficiently long in that country to speak the language well. Having obtained the Edinburgh M. D., I laboured to fulfil every condition imposed by the late Indian regulations, which gave me to understand that "all natural-born subjects of Her Majesty, between 21 and 28 years of age," and of sound health, would be eligible, provided that they could produce in addition to a degree in medicine, including a surgical examination (which the Edinburgh M. D. does), certificates of extra attendance on classes, and hospitals therein specified. All these conditions have I fulfilled to the letter, necessitating, need I add, extra outlay; and now, at the "eleventh hour," after much anxiety, you may conceive my serious surprise and disappointment, on receiving from the India Office an intimation to the effect that "all candidates" at the next examination will be subject to the regulations issued by the War Office "! not only rendering past labour in conforming to the late regulations of no avail, but imposing a restriction as to age in itself sufficient to exclude me, for I am past 26 and nearer 27; thus compelling me to return to India after expenditure of time and means, without obtaining the sole object of my studies in Britain. Surely I am mistaken in supposing the new regulations to apply retrospectively, and without consideration for one, who, though qualified according to regulations but lately supplied him, and, so to speak, ready for the next examination, would thus be excluded from the only opportunity of competing, and by circumstances over which he could have no control?

In having the honour of addressing you, I beg to call your attention to the following facts :---I was a candidate for an appointment in the Medical Department of Her Majesty's General Military Service. My application as a candidate was accepted, and I received a ticket for the examinations, which commenced on the 18th current. According to request, I attended upon the Director General on the morning of the same date, when I was informed by him that he had received orders to exclude from competing at the examinations all those born in India. The reasons given for which were, that it had been found by experience that all such persons are not capable of withstanding the injurious effects of the extremes of climate which Her Majesty's army had to experience. Allow me, with all deference, to state that such a decision, made at such a moment, is extremely unjust for all whom it especially concerns; for me it is particularly so.

First. I have been for the last 10 years a student in this country, between five and six of which I devoted myself strictly to medicine, and for the last two years was a house surgeon in the Glasgow Royal Infirmary. I had always in view the military medical service.

Second. My father, Henry Goodall, is at present Surgeon Major in the 25th Madras Native Infantry, stationed at Mercara. He has served for the last 30 years. May I put the question, are Her Majesty's servants to be rewarded for their long services by their children being deprived of the rights which they themselves enjoy?

Third. I was born in Tavoy, one of Her Majesty's Tenasserim provinces, not in India at all. 1

Lastly. I have resided for above nine years in Scotland without a day's illness of consequence. In colour, habits, and religion, I am a Briton, and legally and physically I am as much a Scotchman as if I had been born and lived all my life in Scotland.

I hope, therefore, you will be pleased to give my case a further consideration.

a medical man and possessed at least so much of apprehension as to understand the meaning of a rational sentence when uttered in my hearing. But I am perfectly at a loss to comprehend how I am thus constitutionally

unfit. Do the above examiners find any symptoms of lurking disease in any organs of my body? Not if I remember aright the words of the consultation carried on in my hearing.

I was examined for upwards of an hour, during which time I had to strip my chest twice. Sir Ronald Martin and the Director General did not agree. They called in a fourth medical gentleman, who gave my chest a most thorough examination. It was his opinion, that as far as he could find, nothing abnormal existed in my chest.

But, my Lord, I no longer press my rights as a British subject to compete for an assistant surgeonship in the British army. But I hope your Lordship will see the justness of my claim, when I demand to be provided for in an equivalent way. A few strokes of the pen are only necessary to state so simple a sentence as that I am constitutionally unfit; but it becomes a most serious matter with

me. Icrave your Lordship to give attention to them for a few moments. At an early age I was sent to this country for my education; I have been 10 years in it, during which period I was put to the best education that Glasgow could afford. I was three years in the High School of that city, and six at the University. I had not been long at the medical classes, when I read in a pamphlet, the words which caused me so to qualify myself as to be able to compete for an assistant surgeonship in the British army; that pamphlet under the signature and sanction of the British Government. I applied to stand as a candidate. I am found qualified in every point, even physically; for the medical gentlemen appointed to examine the candidates as to their physical condition, after examining me, wrote the word "fit" opposite my name. A card is given me for the examination. Just on the eve of them, I receive a note from the Director General, to attend upon him at his office. When there, I am informed that I am prohibited from competing.

The reason assigned is, that being born in India, my constitution will not be able to endure the various climates Her Majesty's army has to experience.

I am found deficient in a qualification without warning, and suddenly made. and not stated in the above pamphlet, nor in any other paper; that very pamphlet at the time the Director General spoke, was hanging in the waiting room of his office. I resolved to enter the army, because it was the best thing I could do in the circumstances I was placed.

I gave up the situation of house-surgeon, which I held at the Glasgow Royal Infirmary, in order to come to London and compete, according to intimation from the Director General, and then I am most unceremoniously thrown adrift.

To set up a practice, it requires means, and to acquire any other settled appointment, influence is necessary. It becomes Her Majesty's Government now, to do me justice by supplying me with either the one or the other; and such means or such an appointment as will place me in station equivalent to that held by an assistant surgeon in the British army. Hoping, that your Lordship will perceive the justness of my claims, and awaiting the hour of a reply,

The humble Memorial of Alexander Solomon, of Calcutta, sheweth :---

THAT your memorialist went through a full course of medical study, in the medical college of Bengal, and, after passing the prescribed examinations, duly obtained the diploma or certificate of competency to practise medicine, surgery, and midwifery, which is conferred by that college, under the authority of Government.

That the said diploma has heretofore been accepted as sufficient qualification to enable a candidate to enter into the competitive examination for the commission of assistant surgeon in Her Majesty's Indian forces.

That, in full reliance on such sufficiency of qualification, your memorialist proceeded from Calcutts to London, with the view of undergoing the examination; but that since his arrival in this country he has found that in consequence of the examination for assistant surgeonships in the Indian army having recently merged in the examination conducted under the Army Medical Department, he will be required, in addition to his present qualification, to possess a " degree or license" in medicine, and a diploma or license in surgery, from two separate bodies in Great Britain or Ireland.

That your memorialist is prepared to comply with that condition before receiving a commission, and has, indeed, already taken the preliminary steps for obtaining the diploma of the Royal College of Surgeons; but the next examination for medical commissions in the army takes place on Monday, the 18th instant, within which time it is manifestly impracticable for him to fulfil the aforementioned condition, and before another army examination takes place he will be excluded altogether by being beyond the limit of age already extended in his case to 28.

Your memorialist, therefore, humbly begs that, in consideration of these cir-cumstances, your Lordship will be pleased to grant him indulgence so far as to permit him in the meantime to enter the ensuing examination on the 18th instant, in virtue of his diploma from the College of Bengal, but on the express condition that, should he be so fortunate as to be placed, he shall provide himself with the further qualifications from medical bodies in Great Britain before he receives his commission.

Your memorialist trusts he may be permitted to state as additional claims to your Lordship's favourable consideration of his case, that while a student at the Bengal College, he obtained two certificates of honour, and that during the period of the Indian Mutiny, whilst house surgeon to the Medical College Hospital at Calcutta, he did extra duty in order to permit of the accommodation of the hospital being extended to sick and wounded men of Her Majesty's European army, and that in order to render this service, he cheerfully gave up for a time a private practice of (10 him) considerable emolument.

I BEG leave respectfully to solicit your attention to the following representa- Mr. A. Solor tion.

I am a native of India and a natural born subject of Her Majesty. In 1849 I entered the medical college of Bengal, and went through a regular course of medical study in that institution, during which I obtained two certificates of honour, and, after passing the prescribed examinations, received in 1854 the usual diploma, certifying my competency to practise the several branches of medicine.

My main inducement for taking this course was to qualify myself for a medical appointment in the Indian army, which, following the example of more than one of my countrymen, I hoped to obtain through the competitive examination for such appointments.

As, however, the means of defraying the expense of a voyage to England for that purpose were not at my command, I for the next few years did duty as subassistant surgeon, and added to my resources by private practice, which I cheerfully abandoned for a time during the exigency of the Indian mutiny, in order to do extra work as a public servant.

Having at length gathered sufficient funds, I proceeded to England, and arrived in London on the 24th January last, with the view of entering the competitive examination for an assistant surgeoncy in the Indian army. I did so in full reliance that the diploma of the Bengal College, conferred under the authority of Government, would now, as invariably heretofore, be accepted as sufficient qualification to admit me to the examination.

Having, however, learnt that the examination for India medical appointments had been recently merged in that conducted under the Medical Department of the British army, I, on the 31st of January, applied to the Director General to be admitted to the examination next ensuing ; but after encountering various objections made to my medical qualification, under the new arrangement, I finally received a letter from the Director General (a copy of which is enclosed) informing me that it " has been decided that native gentlemen should not be permitted to compete for appointments in the General Medical Service." With this letter was enclosed a copy of one from Colonel Baker, dated, "India Office, 19th February," in which is the following passage : "The withdrawal of the privilege of competing for Indian medical appointments will no doubt cause disappointment to native medical students who were qualifying for such appointments, and Sir Charles Wood has impressed upon the Government of India the importance of

endeavouring to provide suitable employment in India for such students." The Director General was good enough to add, "should you wish to be employed in India, I would suggest that you apply direct to the Secretary of State for India.'

To you, Sir, I now, therefore, most respectfully apply, not to remonstrate against the infliction of a disability, grievous and humiliating though it be on myself and my fellow countrymen, nor to urge my just complaint of the frustration of a cherished purpose, to attain which I have for years laboured in India and now made the journey to England; but, seeing that I gave up the emoluments of practice, and incurred the expense of my voyage on the faith of existing regulations, and with no reason to anticipate disappointment from retrospective enact-ments, I trust your sense of justice and of the faith due to engagements, will induce you to direct that I should receive pecuniary compensation for my expenses to England, and for my stay there, as well as for my passage home, and for the loss of the emoluments of private practice during my absence.

I have further to pray that you will be pleased to furnish me with such recommendation to the Government in India as may secure for me a public medical appointment in some degree commensurate with that which has now been placed beyond my reach.

Should it for this purpose be deemed expedient to subject me to an examination, absolute or competitive, I will most cheerfully subject myself thereto.

I AM directed by the Secretary of State for India in Council to acknowledge the receipt of your letter, dated 13th instant, detailing the circumstances under which you came to England, for the purpose of competing for a commission in the Indian Medical Service, stating the disappointment to which you have been subjected in having been refused permission to compete for the Medical Department of the British army, and requesting that you may be furnished with such recommendation to the Government of India as may secure for you a public medical appointment in some degree commensurate with that which has now been placed beyond your reach.

Sir C. Wood regrets that the changes lately determined upon in the organization of the Indian armies have prevented the fulfilment of your just expectations to be allowed to compete for a commission in the Indian Mcdical Department.

He has instructed the Government of India to take into early consideration the subject of the provision of suitable professional employment for native medical gentlemen; and in consideration of the expenses which you have incurred in coming to this country, and in qualifying yourself for the competitive examination, he is prepared to grant you a sum of 100 l. on the production of a certificate from Sir J. R. Martin, examining physician, that you would have been qualified to compete at the examination for the Indian Medical Service under the old regulations, and to grant you 100 l. in addition as soon as you have taken your passage to return to India.

I AM directed by the Secretary of State for India in Council, to transmit for the information of the Secretary of State for War, the enclosed memorial addressed to Sir Charles Wood by Mr. James, A. Greene, late hospital steward in the Indian Medical Service, requesting to be permitted to compete for a commission at the examination for medical appointments, to be held in July next.

A copy of correspondence received from the Government of India, narrating the circumstances under which Mr. Greene left India in January 1860, without awaiting the announcement of the leave for one year, which had been granted to him, is also forwarded. It will be seen that on the 31st December 1859, Mr. Greene applied for furlough to England for two years, with a view to qualify himself as a candidate at the competitive examination for Her Majesty's Indian Medical Service, to be held in July 1861. The application obtained the favourable recommendation of the Director General, Medical Department, and on the 16th January 1860, a letter was addressed to Mr. Greene, to inform him that leave was granted to him for one year. Mr. Greene, however, had left Calcutta two days previously, and on the circumstances being reported to the Home Government, the Secretary of State for India informed the Government of India that Mr. Greene would not be admitted to compete for a commission in Her Majesty's Indian Medical Service, and that on his reporting himself at the India Office he would be would not be admitted to compete for a commission in Her Majesty's Indian

be directed to return forthwith to his duty, and should he fail to do so within one year, he would be struck off the strength of the subordinate Medical Department.

In reply, the Government of India, under date 8th September last, observe, "We beg to remark in favour of this subordinate medical officer, that 12 months" leave without pay was considered to have been granted to him, and that but for a reference respecting the nature of the leave, which delayed its publication, it would have been notified in General Orders previous to his leaving India."

Mr. Greene states in his memorial, that fearing he would be dismissed for leaving India before his leave had received the sanction of the Government, he tendered his resignation of the service, and having subsequently been informed that he would not be admitted to compete for a commission, he now applies for a reconsideration of his case.

As there is no longer a separate examination for the Indian Medical Service. I am desired to transmit the application for the decision and orders of Lord Herbert.

WITH due respect, I beg to solicit your attention to my very hard case, and hope it will meet with a favourable consideration.

I am the son of a warrant officer of the Honourable Company's service; of mixed parentage.

I entered the Honourable Company's subordinate medical service in 1847; served in Her Majesty's European regiments, and was, after due examination, promoted to assistant apothecary, receiving the warrant in November 1853. I studied in the Calcutta Medical College, and when qualified, in 1855, I was appointed apothecary to that institution.

In 1857, when the army medical service was open for competition, I tendered my resignation, with the view of coming to England and competing for the commissioned

missioned grade of the service. That, unfortunately, the Indian mutiny broke out, and I was obliged to join the army forming for the relief of Lucknow. My resignation was consequently returned, as the exigency of the service could not allow its acceptance. As proof of the above statements, I beg to append a few certificates.

I was attached to the army field hospital, and was present at all the enga ments with Lord Clyde, for which I receive a medal and two clasps; viz. (Relief and Siege of Lucknow). After arduous and harassing duties in the field and camp for two years, I was finally permitted to resign my appointment when the army broke up. (Vide G. O. C. C., 19th March 1859.)

I worked my way to England, with the hope of being able to compete for the Army Medical Service. I arrived in September 1860, studied at King's College, and obtained the degree of Doctor of Medicine of St. Andrews, and a diploma from the Royal College of Surgeons of England. I have completed the regulations which would make me eligible, but, to my mortification, I find that my birth and parentage renders me unfit; and, though this be humiliating to the sons of British subjects who have toiled for the British Government, and are now deprived of serving in a grade to which, by education, they aspired, all I ask for is, that my labours be rewarded. I have served Government 12 years, and am still desirous of serving them. I beg that I may be recommended for some appointment in India, equivalent to the one now closed on me. In addition, I have undergone heavy expenses, and beg that the same indulgence may be extended to me, and the pecuniary compensation awarded, which will enable me to reach India, and obtain an appointment, in consideration of my past services, and the disappointment to which I have been subjected.

I BEG leave most respectfully to solicit your attention to the following representations.

I am a native of India, and a natural born subject of Her Majesty. I studied at the Bengal Medical College for a period of four years and obtained several honours. It was the prospect of competing for an assistant surgeoncy in the Indian army that incited me to labour indefatigably, and to make many sacrifices, that induced me to quit my native shore and to prosecute my studies with still greater zeal.

On my arrival in London, I entered University College, and after two years study, I obtained the degree of Bachelor of Medicine at the University of London. Besides this, I possess the diploma of Member of the Royal College of Surgeons. I need not narrate to you the numerous difficulties I had to contend with, and the expenses I have incurred to possess these qualifications which would render me eligible to the competitive examination for the appointment of assistant surgeon in Her Majesty's Indian army.

It is indeed very mortifying to me to find, that when I have just made myself qualified to compete for the above appointment, to be considered ineligible on account of my parents not being Europeans.

I now, Sir, appeal to your sense of justice. I do not for a moment remonstrate grade of Her Majesty's army, I merely ask for an adequate return for the im-mense expenses I have incurred, to enable me to seek employment in India, and I hope that the compensation granted by Government may not be denied me.

# CORRESPONDENCE relative to Mr. G. F. Hoff.

I TAKE the liberty of presenting the following petition for your perusal and kind consideration.

I am an East Indian by birth, the son of an old servant of the late Honourable East India Company, the enclosed list of testimonials showing my father's services.

I have studied medicine for four years at the Calcutta Medical College, and passed the first examination of that college, it having been my intention at that time to have graduated and taken Government employ out in India, but the Indian Medical Service having been thrown open to competition, and several of my countrymen being successful in getting into the service, I was likewise induced to come to this country for the same purpose, with the view of bettering myself; and accordingly left the Calcutta College and came to England. On my arrival I was informed by the Secretary of the Royal College of Surgeons, London, that I needed a further attendance at some recognised college and hospital before I could be permitted to pass for my degree, without which I was not eligible to compete for a commission. I accordingly left London and proceeded to Edinburgh, where I have been attending the University and Royal Infirmary for the last two years; and now, when I have just completed all that was necessary, and am ready to go up for my degree, I find that, owing to certain new rules, all those whose parents are not purely Europeans are ineligible to compete for army appointments; this has placed me in a very awkward predicament, as the little money which I possessed, and which would have just enabled me to have accomplished the object of my visit to England, is very nearly all expended in living, paying for classes, hospital practice, &c. &c., and my father has not the means to assist me, his income being very small; further having a large family to support.

My chief object in petitioning you is, not that I have any cause of finding fault with the new Government rules, prohibiting Indians from entering the army, but merely that my hard case may receive some consideration from the Government : begging your kind support at the same time, so that I may receive some remuneration to make up for the great disappointment I have met with, and the heavy expenses I have been put to, just to enable me to finish and return back to India without further delay.

Major General James Ramsay (late Commissary General in India), and the only friend I have in London, if referred to, can certify to the above statement.

No. 16. Report of Medical Officers

--- No. 16. ---COPY of Report of Medical Board appointed to re-examine the several Applicants.

In compliance with instructions contained in War Office letter, dated 2d March 1861, that Sir Ronald Martin, Sir John Liddell, Director General, Naval Medical Department, and Dr. Gibson, Director General Army Medical Department, should report their joint opinion as to whether certain gentlemen of colour were physically qualified to stand the exposure to the various climates in which they would be called upon to serve were they admitted into the medical department

of Her Majesty's army, We have to report, that it is our deliberate opinion, founded on experience, that the native and mixed races of India and other tropical countries will never be able to sustain for any length of time the climate of our northern regions; and that they can only be employed advantageously to the public service in climates similar to those in which their race exists.

We carefully examined Messrs. Goodall and Thompson, men of colour with Asiatic features; and although we could not discover any marked bodily defect that would exclude them from employment in a tropical climate, still they are constitutionally unfit for service in the various northern climates in which the British army is called upon to serve.
