PREFACE

THE problems connected with international gold movements have received renewed attention as a result of the breakdown of the gold standard during the depression following 1929. In a world where friction is so important in the economic sphere, and where international capital is very mobile, an automatic standard is not attainable. It has not been recognized clearly enough, however, that the pre-war standard was not strictly automatic. The problems have grown quantitatively during the post-war years, but most of them were faced by the Bank of England in the pre-war era, especially after 1900. The growth of foreign balances in London, the rise of other nations as competitors of England in the export markets for manufactured goods, and the increasing friction caused by greater rigidity in the price and wage structure and the growth of high tariffs presented problems of management to the Bank of England similar to those encountered today.

Cyclical movements of gold coin from New York to the interior of the country, accompanied by imports of gold from abroad during periods of business prosperity; were encountered in the United States during the pre-war era. In depression both flows were reversed. The importance of these phenomena for problems of money and banking and international trade was pointed out by the late Professor Allyn A. Young. At his suggestion, the present study was begun to see whether the same relations between internal and external movements of gold were to be found for England.

During the period selected for study there were five clearly marked complete business cycles, and the movements of gold and currency are considered in relation to business conditions. By the beginning of the period the Bank of England had mastered the principles of action through which it endeavored to protect

its reserve and control the money market. Except for the South African conflict, the period was free from war.

I am deeply indebted to Professor Young for his advice and criticism during the preparation of this study. After his death the work was continued under the direction of Professor John H. Williams, and I wish to express my appreciation of the many helpful suggestions which he has made. I also wish to thank Professor S. E. Harris of Harvard University and Professor James W. Angell of Columbia University for their criticism of the manuscript.

BRITISH INTERNATIONAL GOLD MOVEMENTS AND BANKING POLICY, 1881–1913

CHAPTER I

INTRODUCTION

International gold movements are important in periods of disordered currencies and dislocated exchanges, but the transfers are likely to be spasmodic and they play little part in the mechanism of trade adjustment. So long as gold imports and exports may be made freely by banks, the gold standard acts as a regulator of prices and exchanges, whether or not gold coin is used, and whether or not other forms of currency are convertible into gold. Under certain conditions the use of gold coin and conversion of notes to gold or vice versa may impede, rather than aid, the working of the gold standard. The early classical explanation of the problem of trade adjustment was based upon the premises of a relatively simple economic structure, where credit and other forms of currency acted in a manner similar to what would have been expected of a pure metallic money, and a price-cost structure which was extremely sensitive to alterations in the volume of currency and credit. The price-specie flow mechanism also implied the predominence of commodity trade in the international accounts of nations, and adjustment of disequilibrium was assumed to occur almost entirely through the effects of gold shipments upon the price level and ultimately upon the volume of international trade in goods. Adjustments through forces operating within the gold points were not regarded as important.

While the views of the earlier classicists have been modified by later writers, the price-specie flow mechanism is still the core of the doctrine of adjustment of disequilibria. The importance of short-term capital movements and speculative operations in exchange are recognized, but gold flows are regarded as the important element in the restoration of equilibrium when there has been a force of considerable quantitative importance at work to upset the original condition of equilibrium. It is also recognized that under modern credit banking the response of prices to specie movements may be less sensitive than in a primitive state where

standard metal alone is used in internal circulation, since various offsetting operations by central banks or lags in the response of bank credit and prices may occur unless the banking systems are "loaned up." The narrowing of the gold points as a result of the development of international banking connections and improvement in transportation has served to increase the ease with which specie is moved, and less adjustment is possible within the gold points. The neo-classical position is strengthened as a consequence of this development. On the other hand, the concomitant growth of short-term borrowing between financial centers, and the expansion of speculation in exchange, in "international" securities and in commodities with a "world market" have reduced the volume of specie movements, and enabled greater adjustment to occur within the narrowed gold points. The question of the price-specie flow analysis may be attacked from an historical standpoint, and its validity determined upon the basis of the institutional developments which have occurred. Or the problem may be attacked from a logical viewpoint, and a different explanation of the process of adjustment worked out irrespective of the development of institutions.

The second method is illustrated by the work of writers ¹ who stress the shifting of demand schedules, rather than the mechanism of sectional price levels, as the means by which adjustment of disequilibrium is achieved. Writers on foreign exchange have also pointed the way to a different explanation by their emphasis upon discount rates as the major force behind the movement of specie. Angell's theory ² of the transfer of purchasing power via the bill market is a logical development from the position of foreign exchange specialists, although it depends in part upon the development of close international banking connections and the possibility of adjustments within the gold points.

The classical price-specie flow mechanism was designed to explain conditions which economists describe as "long-run," and

was not applied directly to the phenomenon of business cycles by the earlier writers. But adaptation of the classical doctrine to cyclical fluctuations began during the nineteenth century, and other writers have pointed out inconsistencies in the application of the price-specie flow analysis to cyclical phenomena. Many new questions are raised when gold movements are considered as a problem in connection with business cycles, and a considerable portion of the present study is concerned with the relations between specie flows and the volume of domestic credit and currency.

Attention was frequently called by Professor Allyn A. Young to a peculiar movement of gold in the United States under the National Banking System.¹ New York City was an intermediary through which demands for the rest of the country for money were transmitted to the international market. Gold imports coincided with drains of cash to the interior, and a reflux of money to New York and exports to foreign countries were concurrent phenomena. There was also a close correlation between these flows and movements of bank loans and deposits in New York and the rest of the country. A definite inverse relationship in the various items was apparent when cyclical fluctuations in New York were compared with fluctuations for the rest of the United States. And the relation of New York to the international loan market changed during the progress of the cycle.

The flow of gold during cyclical fluctuations also appeared to be at variance with what was to be expected according to the classical analysis of long-time movements. Professor Young found that during periods of prosperity gold tended to come into the United States in response to high discount rates, even though a relatively high price level should have caused gold to be exported. The question of the relative importance of discount rates as compared to commodity prices in bringing about the movement of specie is raised so far as cyclical fluctuations are concerned, and the present study attempts to evaluate the quantitative problems involved. It has been suggested that possibly creditor nations

may differ from debtor countries in the manner in which specie movements occur over the course of business cycles,¹ and the study of the British pre-war data may be useful in answering this query.

In addition to questions of gold movements, attention has been paid to the problem of banking arrangements and their effect upon the control exercised by the Bank of England. The development of branch banking exerted a profound change in the relations of the central bank to the joint stock banks and to the money market, and enabled the Bank of England to control the market adequately in general, despite growing difficulties arising from the increasing importance of other nations as trade rivals to Great Britain and the strain introduced by the growth of foreign balances in London. The slender reserves with which the Bank operated prior to 1802 would have been inadequate if foreign funds had been as large as in later periods. Central banking problems have been increased greatly by the growth of such balances. and the transfer of these funds from one market to another have been one of the chief causes for the failure of the gold standard to work in an automatic manner. It is only gradually that it is being recognized that the pre-war gold standard was not automatic in a rigid sense, and that the post-war problems are different not in kind but in degree from those encountered in the period prior to 1913. It is hoped that the present study may throw light on the working of the gold standard in this earlier period.

In Chapter II a brief summary is made of the more important doctrines with respect to the role of gold movements as the agent in bringing adjustment of disequilibria in the international balance of payments.² In the succeeding portions of the book the external and internal movements of gold are examined, followed by a survey of the London money market and the conditions of credit during the period 1881–1913. Finally an attempt is made to set forth a theory of gold movements over cyclical periods.

CHAPTER II

THE THEORY OF INTERNATIONAL GOLD MOVEMENTS

(1) A brief survey of some of the more important ideas concerning the part played by specie flows in the adjustment of international trade disequilibria is made in the present chapter.¹ The classical and neo-classical theories of Mill and Taussig are considered, followed by an examination of the expansion of the classical doctrine to problems of the business cycle made by Hawtrey and other writers.

Before turning to the classical theory of trade adjustment, one point suggested by Ricardo will be considered. Ricardo maintained that interest rates do not depend upon the level of prices,² but changes in the volume of money *would* affect interest rates temporarily.³ Clearly he means here market rates of discount, which would affect both long- and short-term security prices for the moment, and there is some implication of a distinction between the price levels of capital goods and liquid capital and of consumable goods. While Ricardo does not examine the question further, the notion is implicit that a redundancy of currency ⁴

International trade adjustment is treated in terms of redundancy, and the unilateral theory of gold flows held by Ricardo (see Angell; op. cit., pp. 56-58, 64, and 70; Jacob Viner, Canada's Balance of International Indebtedness, 1900-1913, Cambridge, Massachusetts, 1924, pp. 103 ff.; and David Ricardo, The High Price of Bullion, op. cit., pp. 4-7, 11, and 12) is illustrative of the emphasis placed upon the monetary aspects of the problem. Angel has pointed out contradictions in Ricardo's position (op. cit., p. 70), and suggests that the inconsistency in the treatment of foreign exchange premiums and the unilateral specie flow doctrine may be reconciled "by regarding that state of relative prices which brought about the deficit in the balance of payments as being itself symptomatic of a relative redundancy or deficiency in the currencies" (loc. cit.). used for purchasing consumable commodities does not necessarily imply a redundancy of currency for other purposes, particularly for short-term funds. The converse situation might also occur where short-term interest rates were relatively high in one country, even though there was no redundancy of currency used for the purchase of consumable goods.

(2) The classical bi-lateral theory of gold movements became the accepted doctrine early in the nineteenth century. It is finally found in a complete and clear form in the work of Mill, although all of the essential elements are seen earlier. Gold flows may be either the cause or the result of an unfavorable balance of trade.¹ Any important disequilibrium in the balance of trade will cause gold to flow, and the movement of specie will set in motion forces which remove the initial cause of the disturbance. Mill also held that an annihilation of credit equivalent to the subtraction of coin or notes from circulation is equally effective in altering the level of prices and correcting the disequilibrium in the balance of trade.² A slight disparity between the demand for and the supply of bills of exchange may not lead to gold flows, since the premium on exchange may bring a sufficient corrective force operating within the gold points to remedy the disequilibrium in the balance of trade.

The price-specie flow analysis depends upon the quick response of prices and costs of production to movements of specie, and a prompt alteration in the volume of international trade to correct the initial disturbance of the equilibrium in the balance of payments. Additional elements have been added by later writers,

but the neo-classical school relies upon the movement of specie to set in motion the forces which restore equilibrium whenever the departure from equilibrium is quantitatively important.

(3) The neo-classical position set forth by Taussig¹ makes allowance for the sensitivity of banking systems. When the banking systems are "loaned up," the volume of bank deposits and notes is sensitive to changes in reserves, and gold movements will dominate the level of prices.² But when the relation between reserves and the media of payments is elastic, specie flows may not exert an immediate influence upon commodity prices, and the effect of the flows will be dependent to a considerable degree upon the temper of the business community.³ Discount rates may be the proximate cause of specie movements over short periods, and gold may be drawn into a country on account of the depletion of bank reserves.⁴ Such flows may be eliminated to a considerable extent by the transfer of bankers' balances, or the exchange of international securities.⁵ The underlying forces, however, are concerned with relative price levels, and the ultimate adjustment of any important departure from equilibrium comes through price changes and alterations in the trade balance.

The effects of real changes in the positions of lending and borrowing countries are considered by Taussig,⁶ and he points out that in some cases an agreement, tacit or otherwise, is made by which the borrower employs the funds lent in purchasing goods in the lending country.⁷ The flow of goods proceeds immediately, and the relative price levels of the two countries need not change in order to induce commodity movements. Ordinarily, however, it is assumed that new foreign loans lead to specie flows, and consequent changes in relative prices, which alter commodity movements.⁸ Where the connection between bank reserves and deposits is loose, the chronological order of events in connection with

specie flows may be different from that assumed in the classical statement: an influx of specie may follow, rather than precede, an increase in the volume of the media of payments and a rise of prices.¹ This notion is applied specifically to the process of transferring an international loan, and is linked up with cyclical conditions. "If, for example," Taussig states,

the country is in the early stage of large borrowings — if a succession of loans from abroad is in course of being contracted — the proceeds of the loans will provide the means for paying for added imports. While advancing prices will tempt imports, the loans, so long as they continue, enable them to be paid for from year to year. They may even enable still more specie to flow in, and so give support to a still further advance in prices and still further imports. The process may go on *crescendo*, until at last there is a halt in the lending operations, not unlikely to be sudden, and marked by a financial and industrial crash.²

In the case of Great Britain the greatest volume of capital exports took place when the movement of prices at home was upward, and "... the export of goods apparently has taken place, not in connection with a cheapening of goods in the lending country, but in spite of the fact that its goods have seemed to be dearer at times of great capital export."³ Whether large capital exports were associated with *relative* increases in export *versus* import prices or not, the fact that they occurred principally during periods of rising prices in the lending countries is significant for the development of a theory of gold movements concerned with cyclical fluctuations.

Taussig's analysis provides such a theory, with capital movements dominating the situation. Borrowing nations would receive gold during the expansion phase of a business cycle, despite a high level of commodity prices relative to lending countries. This borrowing would enable expansion to continue until the loans ceased, generally because of a crisis. The cessation of loans would not necessarily stop the influx of gold, since the high discount rates, which are the proximate cause of the gold movements, will continue until the crisis is over.

The magnitude and duration of the flow of loans will be affected by changes in the sectional price levels, in addition to other forces. The barter terms of trade may become either more or less favorable to the lender. If import prices rise relatively to export prices (less favorable terms of trade), the transfer of the loan to the borrower is made with a minimum of friction.¹ The flow of specie necessary to maintain equilibrium in the balance of payments will be small relative to the magnitude of the loans. To the extent that the drain on the specie reserves of the lender is the limiting factor to the flow of loans, the duration and magnitude of the loan operations will be greater under the conditions above than in the case where a larger flow of specie is necessary to maintain equilibrium in the balance of payments. If the prices of import goods decline relatively to prices of export goods in the lending country (more favorable terms of trade), the flow of specie must be larger relative to the loans, since adjustment of the trade balance is impeded by an increase of exports by the borrower.² The duration of the loan movement will be shorter than in the first case, since the reserves of the lender will be drawn down more rapidly. In both cases, however, the import of specie by the borrower is associated with a greater expansion of production and a higher price level than are found in the lending nation.

In depression the borrowing country would lose gold, even though its price level was low relative to that of creditor nations. The proximate cause of the specie flow would be a relative decline of discount rates, but the underlying force would be the pressure upon the balance of payments created by the interest and amortization payments on old loans in the absence of new borrowing. Loss of specie is consistent with a price level below that of lending countries.

The theory set forth briefly here assumes that the response of prices and costs is not immediate following changes in discount or interest rates. If the price-cost structure is sensitive to fluctuations in money rates, the expansion of business and the rise of

prices in borrowing countries during the recovery and prosperity stages of the cycle could not continue long, and in depression the adjustment downward of prices would enable the borrower to transfer interest payments without large gold exports.¹

The doctrine set forth here may also be related to the internal movements of currency and credit. In the borrowing nation, a flow of funds from the central money market to the interior would be expected during the period of expansion. At the same time funds would be flowing in from abroad, and specie imports would be coupled with an expansion of deposits and currency in the interior of the country.² The two types of flow were recognized early in the nineteenth century. The two movements were sometimes regarded as concurrent, however, the drain of gold abroad occurring at the same time that notes and coin were moving to the interior of the country. The analysis of the question made by R. G. Hawtrey ³ suggests that this is the phenomenon to be expected during the expansion phase of a business cycle; but before examining this idea it is necessary to consider his general theory of money and credit.

(4) Prices are determined, in Hawtrey's view, by the expenditure of purchasing power by consumers out of their income. More specifically, price changes vary in accordance with the amount of the "unspent margin", which is the difference between the income of consumers and their outlay, plus the balances at the beginning of the period of consumers and business men. This margin can be equated to the amount of money in circulation, plus the volume of bank deposits outstanding. During a period of expanding credit he finds that the consumers' incomes rise with the increase in business. A gradual drain of money into circulation results, to be succeeded eventually by higher discount rates, and ultimately by contraction as consumers' incomes and outlays fall off.⁴ Except for the introduction of money there would be no

end to an expansion, for credit is inherently unstable. The function of the former is to supply a means of discharging a debt legally, and to stabilize the unit of value.¹

He goes on to show that in a country depending upon gold for its supply of money, the credit structure might break down because of the exhaustion of its supply of legal tender. He summarizes this concept in the following words:

The grounds for this conclusion were two fold. First, though the consumers' income is increased, the part composed of wages is not immediately increased in proportion, and even when wages do rise, the amount of cash continuing in circulation, the cash portion of the unspent margin, only grows gradually. There is thus a long interval between an increase in the quantity of credit and the corresponding increase in the circulation of money. Secondly, the increase in the consumers' outlay tends to deplete stocks of goods, orders are given for the replenishment of stocks, there supervenes an over-pressure upon the productive powers of the country and an accumulation of orders awaiting execution, and this accumulation of arrears of orders constitutes a latent demand for credit, which will only materialise when the arrears begin to be overtaken.²

Thus a credit expansion is dangerous, not only because it reduces reserves of legal tender at the moment as notes and coin are drawn into circulation, but because there are *latent* demands for credit and cash which will develop even after the contraction of new orders has diminished.

Hawtrey then turns to the international aspects of the question. As a country experiences a credit expansion its trade balance tends to become unfavorable. As a result, through a mechanism to be described later, gold flows abroad; thus to the inward drain of cash there is added an efflux abroad as well. But this gives bankers prompt warning, and they raise discount rates and curtail credit, and so prevent an undue expansion.³

But there is nothing to prevent a world-wide expansion of credit. For in that case no nation would lose gold, except momentarily. If all nations are passing through the same period of expansion of credit during the prosperity stage of a business cycle, the flow of gold means merely that they are not keeping precisely

the same pace. "One lets credit expand a little faster than the others and loses gold; another lags behind and receives gold."¹ This does not remove the danger, however, for in time the internal drain depletes the reserves of banks, and credit must be curtailed.²

As stated above, Hawtrey's analysis refers specifically to cyclical movements of business, and the events he depicts will recur from time to time. His theory of gold movements is essentially classical, and primary importance is attached to changes in the prices of commodities resulting from fluctuations in the volume of credit.³ But account is also taken of what he regards as lesser factors centering around the exchange market, and to these we shall turn presently.

He supposes an expansion of credit in one country, which thereby brings an increase in the consumers' income and the consumers' outlay. In part this will increase the import of foreign goods, and the preexisting equilibrium of the balance of payments will be disturbed. The increased demand for imports means that the country's currency is less desired abroad, and there is a *virtual* depreciation of the unit. The exchanges become unfavorable, and gold is exported to pay for the excess of imports.¹ Equilibrium can be restored by contracting credit "... till the consumers' outlay is so reduced as no longer to attract an excessive share of the world's supply of foreign trade products."²

The processes are examined further in connection with a disturbance of equilibrium arising from the failure of a harvest, or the like. Such disturbances are reared on top of the normal course of cyclical disequilibria outlined above. The first effect of such a failure is a decline in consumers' income and in their outlay. In part this means a decrease in the purchase of foreign goods, and in part a decline in buying domestic commodities. Unless imports fall off immediately to the full extent of the decreased income

(which is unlikely) the foreign exchange market will be affected and the balance of payments will become adverse. But there will also be a diminution in the consumers' outlay on domestic goods, bringing repercussions to act upon the exchange market, and in time income and outlay on domestic goods will be equated, as will the income and outlay on foreign goods. When this has been accomplished, equilibrium is restored.¹

The process is hindered by the reduction in the unspent margin, for these margins of consumers in the country experiencing the crop failure will be drawn down. Ultimately that part of the balances which is expended for foreign goods reaches the hands of foreign traders. These traders desire means of payments abroad for the increased imports (a relative increase in imports over exports is all that is essential for the analysis), and their increased demands cause the foreign exchange rates to become unfavorable. Bullion dealers take advantage of these rates to ship gold abroad, and sell drafts drawn against the foreign balances created, and in turn repay their advances secured from banks to purchase the gold. By this process the volume of outstanding credit and currency is reduced, and the unspent margin is diminished.²

The processes outlined are subject to modification from three sources. First, the fall in the prices of home-trade commodities will tend to divert demand to them from foreign goods. Second, if the disturbance is long-continued, there will be a diversion of enterprise from the production of domestic products, whose prices have fallen, to foreign trade products, whose prices do not tend to fall as rapidly. Third, capital movements will be affected. If profits fall off there will be more borrowing abroad (or a diminution of lending in the case of a creditor nation), and the severity of the impact upon goods and thence upon the exchange market is thereby lessened.³

Credit contraction will be furthered by the loss of gold, as bank reserves will be reduced, and this decline in the volume of credit will hasten the reduction of consumers' incomes and outlays, and a short cut to equilibrium is provided. To the extent that credit

contraction occurs, the pressure leading to gold export is diminished, and if the decline in the unspent margin is sufficient no specie need be sent abroad. It is probable that some gold would be lost, however, since less specie would be required for reserves because of the decline in the unspent margin.¹

The analysis of the mechanism of trade adjustment which Hawtrey presents is inherently classical. It depends upon the prompt reaction of commodity prices to changes in the volume of deposits and currency. The size of the unspent margin must be sensitive to variations in rates of discount in the central money market, and money market rates must reflect changes in Central Bank rates quickly. The trader carrying stocks of goods is the focal point in the mechanisms set up, since changes in the volume of orders placed by him are assumed to be dependent upon the cost of bank credit. Alterations in the quantity of orders placed by traders affect the incomes and outlays of consumers and the amount of the unspent margin quickly. And once the equilibrium between consumers' incomes and outlays is disturbed, the forces set to work as a consequence will change the direction of the cycle without further impetus from Bank rates.

The mechanism set up may be criticized on several grounds. Central Bank control over the money market must be complete enough to cause market rates to respond to changes in Central Bank rates. Particularly during periods of long depression there may be little connection between these rates. And the close relation required may be broken at other periods by lack of securities in the Central Bank portfolio for open-market sales, or by movements of foreign balances which offset the efforts of the Bank. The central money market must also be relatively important in the general economy of the country, so that discount rate changes may affect business conditions in general, unless the Central Bank rate is effective directly upon borrowing throughout a nation. The position of the trader must be important enough to exert significant pressure upon the volume of bank deposits, if the cycle of expansion or contraction is to be broken. And the amount of borrowing by traders must be dependent upon fluctua-

tions of money rates. Where bank borrowing is dependent principally upon the willingness of bankers to lend, rather than upon small variations in profits of business men occasioned by changes in the cost of credit, the response of deposits to changes in Bank rates will be slow.

Unless the volume of bank credit is immediately sensitive to changes in rates, a movement of short-term foreign balances may offset the action of the Central Bank. Hawtrey recognizes that the flow of foreign balances may delay a contraction of credit, but he assumes that the rise in Bank rate will be effective, and that the same underlying equilibrium which would have been reached by allowing gold to flow out will be attained eventually. If the influx of balances is precisely equal to the gold exports which would have taken place, there is no delay in the attainment of equilibrium. If, however, the rise in Bank rate attracts foreign balances to a degree which more than offsets the adverse balance of payments, the Central Bank would hesitate to keep such a high rate, and the credit contraction would be delayed. Moreover, the influx of gold would tend to make the rate ineffective, unless open market sales of securities are made.¹ But the credit contraction assumed by Hawtrey may not even occur. The influx of balances may be so large as to nullify completely the action of the Central Bank, and the net effect may be an increase in the unspent margin for short periods.² While ultimately contraction of credit may occur, the expansion phase of the cycle may continue for periods of months or possibly years before the increased cost of bank credit or the unwillingness of bankers to make further loans brings the phase to a close. Where a nation is borrowing heavily abroad short-term money market rates may exert relatively little influence, and the expansion phase of the cycle will be extended despite high rates. In periods of depression lowering Bank rate to stimulate traders

may bring such an exodus of foreign balances as to decrease the unspent margin, and thus further prolong the downward phase of the cycle.¹

(5) Writers on foreign exchange have contributed an important body of literature on the question of gold movements. Starting with an examination of the mechanisms of the exchange market, forces at work within the market itself and the foreign exchange banks have been depended upon for the adjustment of disequilibria in the balance of payments, and the price-specie flow analysis has been neglected, or, in some cases, explicitly denied. The somewhat scattered ideas of previous writers were brought together by Goschen, and a brief statement of his views is presented below. The influence of Goschen and others upon economists has been important, and gold movements are regarded by Laughlin as results of capital movements solely. On the other hand, Taussig,² Whitaker, and Young have recognized the importance of adjustments by exchange market forces where disequilibrium is not quantitatively important, but insist that where the departure from equilibrium in the balance of payments is great or protracted that the price-specie flow mechanism comes into play.

The elements which determine fluctuations in exchange rates according to Goschen are summarized by Angell as follows: "Currency disturbances apart, they are: (1) the balance of indebtedness, which, however, will cause fluctuations only within the specie points, (2) the relative rate of interest in the two countries, (3) the state of credit in each, and (4) political disturbances; or some combination of the four."³

Goschen goes on to explain that usually the balance of indebtedness on account of goods and the rate of interest are forces which work *simultaneously*, but in opposite directions:

The adverse balance of trade will, as far as its power extends, render the bills on the country which is most in debt difficult of sale, and tend to compel it to export specie; whereas the high rate of interest, which is contemporaneous with a drain, or the prospect of a drain, of specie, will revive a demand for bills on this same country, and enhance their value in other quarters; for there will be a general desire to procure the means of remitting capital to that market where it commands the highest value.¹

The analysis is completed by showing that the natural course of events would bring about a rise in the rate of interest. "The abstraction caused by the bullion shipments will of itself tend to raise the rate; and banking establishments will in their own interest (which will be identical with the interest of the public) accelerate this result as far as it lies in their power."² The action of central banks is, of course, directed powerfully toward the same end. Goschen does not, however, in his analysis explicitly suggest that the rise in interest rates precedes the drain of specie, or that such a rise may avert a threatened loss, although this possibility is implicit in his reasoning.³

it is the price of short bills, not of those which have some time to run, which determines the course of bullion shipments. Most of the primary elements of value affect long and short bills equally; but the rate of interest and the question of credit exercise an additional influence upon the former, and so modify the fluctuations in their price as to render them unreliable as indications of the currents of gold.¹

While this is undeniably true for domestic bills, the point cannot be pressed too far when dealing with the foreign exchange market under present banking conditions, for there is a strong underlying tendency for all bill and exchange rates to move together. Let us assume a condition in which England has an adverse balance, and bills on London in New York are consequently plentiful. Exchange rates would be near the gold import point in the latter center. The prospect of bullion exports would tend to bring advances in the rate of discount in London and thereby widen the spread between the prices of short and long bills. Bankers in New York would be induced to hold their long bills instead of discounting them in London as usual. They would then be unable to draw sight drafts as cheaply, since their London balances would tend to decline.² The effect would be a rise in the price of demand bills on London in New York, and a rise in the price of long bills in London.

can never be the cause of changes in the trade balance.¹ This position is inherent in his general refutation of the validity of the quantity theory of money.

His doctrines rest in part upon his propositions with regard to the function of gold in the price structure of a country. Gold can affect prices only as it becomes a part of the general media of exchange,² but he extends this notion to cover modern conditions where gold is used largely as bank reserves. An excess of reserves does not, however, necessarily bring about the issuance of more credit, for

in legitimate banking, loans are made because of satisfactory collateral or actual transfer of goods, and not merely because reserves are high. To be sure, if reserves rise, rates of interest will fall and new loans are possible; but merely because a bank can loan, it does not follow that it does loan... If gold is pouring in beyond the needs of banking safety, the banks get rid of it, just as of any other asset which does not pay a return.³

Having repudiated the classical approach to prices and international trade adjustments, he proceeds to set forth his own views. He points out that it is the movement of interest rates rather than the movement of prices of commodities which determines the flow of gold. Under modern conditions the exchange of securities, and of other services, must also be considered. The amount of gold moving under these circumstances becomes very small in comparison, and can have very little or no effect upon prices of goods. His position with regard to the significance of interest rates is so important that it merits the following full statement:

The reason why balances in favor of a country may not be paid in gold is due to the possibility of investing those balances at a higher rate of interest in a foreign country than can be obtained at home. The relative rates of interest have an influence even wider than that upon the movement of balances. It is the rate of interest upon sound international securities, as well as the rate in the loan market, which determines whether credits due, for instance, to the United States shall be left abroad or brought home in the form of goods or specie. The general accounting in foreign trade must include the operations of loans, and the movement of capital for investment from one country to another. Indeed, the rate of interest is behind the movement of securities men-

tioned above. The purchase of securities is, of course, one form of investing capital. Therefore, in determining the causes affecting prices and the movement of gold in international trade, it must be kept in mind that the relative rates of interest in the trading countries will influence the passage of loanable capital to and fro, thereby acting as a factor in adjusting merchandise credits and debits, and seriously affecting the transmission of gold. Instead of gold being the originating cause of new exports and imports, as once generally held, it is the very last thing to move; and even then merchandise balances may be entirely reversed by changes in the rates of interest in New York or foreign centres which may cause capital to flow from the creditor to the debtor country. The recognition of the force exerted by the rate of interest on the movement of loanable capital gives the final coup de grace to the old theory, which based its change of general prices upon the international movement of specie. The order of events is quite the other way: relative prices cause exports and imports of goods; and the shipment of gold is not necessarily made even to cover balances of merchandise. If gold moves, it goes not merely because of the account in goods and securities, but of the investment of international capital.¹

Laughlin also makes his position clear with respect to gold movements at a time of commercial crisis:

It might be said, however, that there could be a temporary change in the value of gold in one country, due to violent trade convulsions, which did not extend to other countries; and that the value of gold would be different for a time in that country from its world value. If so, prices would be for a period elevated or depressed, and gold would be moved to restore the equilibrium. Could there be such a temporary scarcity of gold in one country? A case in point may be cited, in the history of the panic of 1893 in the United States, when there existed what was called a "money famine," and when gold was imported.

Such a situation would, even before the event, show itself in the rate of interest, and gold could be imported within a week. Granting the temporary scarcity of gold in such an emergency, the time required for the shipment of gold could not be long enough to change the general level of prices; in truth, it would be usually found that prices had fallen before the money famine disclosed itself. This exceptionally high value set on gold, in 1803, was due to temporary business and banking conditions, and to the liquidation of obligations. In this case the sudden demand for gold was disassociated from the movement of prices; the increased estimate put on gold in the panic came after, and so could not have been the cause of, a previous fall of prices.

To be sure, a fictitious rise of prices due to abnormal credit might temporarily give to gold a lower value within a country than it possessed elsewhere in the world; but these conditions bring their own overturn in such vengeful fashion as to show that it is at variance with the natural principles of pricemaking.²

It is worth while to note at this time an article of Professor Whitaker's ¹ which subjects this analysis of Laughlin to careful and penetrating criticism. With much of this article we need not concern ourselves, but the author's view that the rate of discount acting on the movement of securities is "temporary and of strictly limited scope"² is worth attention. If the excess of imports into a country is large, or if it continues for a long period, the discount rate becomes an important influence on the flow of gold. The influence of such rates is confined largely in his view to the correction of normal season flows. Important differences between imports and exports can be settled only by the movements of gold.

Whitaker also shows that for the years 1890-1903, with the exception of 1897, net changes in the annual movement of gold produced similar changes in the excess of merchandise exports over imports for the succeeding year in the case of the United States. While he does not link this notion definitely to cyclical fluctuations, as Hawtrey does, such reasoning is possible upon the analysis which he does present.³

A classification of the various types of gold movements which is admirable in many respects is presented by Whitaker. He divides them into (1) producers, (2) commercial, and (3) financial or money market shipments.⁴ The second type are due to trade

or service balance items, while the last are due to differences in interest rates, and may arise from direct loans of gold (on collateral) or from the purchase of floating securities. The difference between commercial and financial shipments is set forth clearly: "A commercial shipment of gold always serves to discharge a previous international debt, but an initial financial shipment creates a debt and looks to a future and early return shipment of gold."¹

Whitaker maintains that adjustments through borrowing operations on floating securities are necessarily only temporary. But they serve to diminish gold flows. Professor Allyn Young also made a somewhat similar analysis.² Taking the case of a country experiencing a cyclical rise of prices, he points out that under classical analysis an export of gold would be expected. But interest rates also advance along with prices, which tends to diminish lending by the country, or increase loans to it, or both. This will tend to diminish or delay specie exports. "The delay may even continue until the balance of trade has turned in the other direction, so that gold shipments become unnecessary."³ Thus movements of capital soften the shocks attendant upon the movement of gold. And he also points out that bankers do not move gold in order to take advantage of high rates of interest, but that loans in this case merely mean that the gold reserves of other centers are put at the disposal of the borrowers.⁴ He does not show why the trade balance should be affected ultimately, although he undoubtedly had in mind the influence of high interest rates upon prices and production.

Analysis of the foreign exchange market has directed the attention of later writers to the importance of capital movements, and brought greater recognition to the role played by interest rates in the adjustment of disequilibria in the balance of payments. Refinements in the discussion of cyclical influences have resulted from the work of the foreign exchange writers. The importance

of their contribution is shown further in the following section, where certain contemporary writers are considered.

(7) The influence of the writers on foreign exchange is shown clearly in the work of Angell. Transfers of purchasing power through the bill market, and the resultant effects upon the volume of bank deposits and loans and upon the level of commodity prices, replace gold movements as the principal agent for the adjustment of disequilibria in their view. In many cases the adjustment occurs within the limits of the gold points, and even where specie is moved, the flow is regarded as a consequence of conditions in the banking systems already set up by the transfer of purchasing power.

Angell ¹ considers both short- and long-period adjustments, and he relates the problems to the fluctuations of the business cycle. The mechanisms of adjustment are illustrated by the case of the flotation of a large international loan. The lending country (designated as country A) is now under the necessity of transmitting the proceeds of the loan to the borrowing nation (country B). It must therefore increase the relative volume of remittances it has been making to foreign countries.²

He then proceeds to examine the forces relating to the holding of bills of exchange by bankers. The stock of bills is built up by discounting drafts for exporters and the volume of deposit credit is thereby increased, while the sale of bills to importers reduces the stock of bills and decreases the purchasing power of the country.³ The net effect of these two sets of forces is that while the holdings of the banks vary, they may be said "... to follow paths which we may describe as 'normal'."⁴ This "normal" would allow for seasonal and cyclical movements of business, and secular tendencies which are primarily domestic in origin.

In a later article ⁵ Angell examines the mechanisms of the bill market in more detail. The manner of financing foreign trade

XLII, no. 3 (May, 1928), pp. 388-433. transactions, the policy of commercial banks, and the actions of the foreign traders affect the volume of purchasing power. In some cases imports may bring an expansion of purchasing power in the importing country. If the imports are paid for by the purchase of a foreign currency draft from a bank, the bankers' foreign balance is drawn down.¹ But the bank gains an equivalent amount of domestic funds, and its lending position is improved thereby.² Moreover, the importers or the buyers of the goods may borrow in order to purchase their drafts, and while ultimately repayment of the loan extinguishes the volume of purchasing power created by it, the aggregate loans outstanding may increase if there is overlapping of individual loans.³ Where payment for imports is effected through the drawing of a draft upon the importer or his bank, the foreign balances of the exporter or his bank will be increased after acceptance and sale of the bill.⁴ Both the assets and the liabilities of banks in the importing nation are increased.⁵ An expansion of purchasing power may occur if banks extend additional loans during the interim between acceptance and maturity of the draft.⁶ The effect of exports upon the volume of purchasing power is also examined in detail. It is important to note that either imports or exports may increase the volume of deposits.⁷

Returning to the case of the flotation of a foreign loan, Angell states that the agents of the borrowing country will enter the exchange market to purchase bills in return for the local currency or deposits paid to them by the investors.⁸ "This new demand for bills will accelerate the rate at which the banks' holdings are depleted." 9 The average size of holdings will tend to fall as a result. This might continue until the store of bills was wiped out, but certain correctives are called into play before that will result.

First, the price of bills will rise, and exchanges will become un-

favorable. This will stimulate the export of goods and restrict imports, within the limits of the specie points, in accordance with Mill's analysis. Further, it will encourage the drawing of finance bills, and stimulate other speculative operations.¹ Secondly, there will be a flow of gold abroad, both on account of the exchange position, and because of commitments of bankers which cannot be easily met by the purchase of bills. If protracted, these exports will have far-reaching effects, but the amount is usually so small that it has little effect on the adjustment in the balance of payments.² Thirdly, any large disturbance will bring increases in the discount rate in the lending country. This will operate to check the demand for bills, and will lead to a return of gold.³

The rise of rates is due to the loss of gold, and also to the loss of purchasing power produced by the decline in bill holdings.

The decline . . . will create a demand for more bank credit to replace that part of the country's purchasing power which has (in effect) been exported. But to yield to these demands would be tantamount to inflating credit. The physical volume of business in the country has not increased, and there is hence no legitimate excuse for an expansion of loans.⁴

The above correctives are of limited duration, however. More important are the effects produced by changes in purchasing power. It will be recalled that the original purchaser of foreign securities has spent his income, and cannot, therefore, purchase domestic commodities (or more likely domestic securities). As a result there will be a decline in the purchasing power expended in the lending country, either directly or indirectly. This tend-

ency will be accelerated by the loss of gold and securities from banks, and the consequent rise of discount rates. The *absolute* effects will vary in accordance with the position of the country in the business cycle; in some cases a mere retardation of the upward movement of prices will be the result. The final adjustments will take place through changes in the commodity balance of trade, and equilibrium will be restored. More goods will be exported and fewer imported, though some minor changes may result in other items of the international accounts.¹

The conclusions may well be summed up in Angell's words:

In the first instance, the disturbance leads to a movement of the foreign exchanges. If it is small and temporary, this adjustment alone may suffice, for it will accelerate or retard the rate at which bills of exchange are currently offered in the market. If that is inadequate, gold will flow; and discount rates, especially in the gold-exporting country, will be affected. If even this fails to correct the situation, finally an alteration will take place in the underlying conditions that govern the general course of international exchange itself. The volume of purchasing power in circulation in the creditor country will be built up, in consequence of the increase in the banks' holdings of bills. In the other country it will be reduced, through the decline there in bill holdings. These changes in turn will operate upon the corresponding general price levels. The latter effect is often, though not always, strengthened by alterations in the discount rates. The movements in prices will then influence the commodity balance of trade, in ways long familiar, and will continue to do so until the change in the commodity trade has become great enough to offset and correct the original disturbance in the balance of international payments.²

He continues by pointing out that temporary disturbances are adjusted by the immediate and short-time influences, but that large and enduring disturbances can only be corrected by an alteration in the trade balance itself. He shows that the classical theory took little account of these temporary correctives, except for the limited effect of exchange rate fluctuations on commodity movements, and that their main reliance was on movement of gold, which exercised a quick and direct influence on prices. He then restates his own interpretation of the role of gold flows:

The doctrine which has been set up here, on the other hand, regards gold flows as an essentially short-run phenomenon, usually of temporary importance alone. It bases its more long-run conclusions on the effects which significant changes in the relation between the demand and supply of *bills* of exchange produce upon the total volume of purchasing power in circulation. It rejoins the classical line of analysis only at the point where general price changes begin to appear.¹

Angell is even more explicit when he considers the case of Canadian borrowing. He holds that the change in Canadian prices was brought about by an increase in bank deposits, and that gold imports or changes in the "outside reserves" were not the initial causal elements. Alterations in the "outside reserves" were due to lags in the response of international trade to fluctuations in the volume of loans, and they did not have a direct or immediate effect upon conditions in Canada.² "The correction, in the Canadian case, did not come from the effects of gold flows, or of changes in outside bank balances. It came from the effects of the original and prior increase in Canadian bank deposits."³

An additional element in the process of adjustment of disequilibrium in the balance of payments is suggested by White.⁴ The volume of international trade will be affected by shifts in demand schedules for groups of commodities. The transfer of purchasing power may be made through gold movements ⁵ or short-term capital flows, and the movement of sectional price levels may either aid or impede the subsequent adjustment. In the case of a foreign loan, it would be expected by White that the borrower would use a large portion of it in purchasing imported commodities, and there would be an increase in the demand schedules for such goods,

quite apart from any increase in the quantity taken because of the effect of the transfer of purchasing power upon sectional price levels. The loan is thus taken in the form of goods without any changes in the export-import price relation, and the classical price specie-flow mechanism is unnecessary for adjustment to occur.

(8) The chief proponents of the Currency Principle,¹ Lord Overstone, Robert Torrens, and George W. Norman, applied the unilateral Ricardian theory of gold movements to the monetary problems of the day. They held a rigid form of the quantity theory of money, and argued that a bank note currency should fluctuate in the same manner that a pure metallic currency would if equilibrium of prices was to be achieved.² Outflows of specie would bring adjustment of disequilibrium in the balance of international payments provided the note issue was contracted concurrently with gold exports.³ The Bank of England was

Later Loyd pointed out that a rise in the rate of interest by the Bank would arrest an outflow of bullion. This is not only powerful, but quick acting. He refers to such a case in April, 1847, saying that as a result of the rise in the value of money there "... was an *immediate* correction of the exchanges — the drain of bullion at once ceased — the gold actually shipped for America was relanded — policies upon further shipments were cancelled — and the bullion previously sent to the Continent of

attacked because it did not vary its issue in accordance with this principle.¹

Defenders of the Bank pointed out that it had no control over the issues of country banks, and held that these local bank notes were largely to blame for the inflation of the currency.² In emphasing the importance of deposit credit, the Banking School made an important contribution, although some of the adherents of the School were clearly erroneous in maintaining that there was an automatic "reflux" of notes issued in connection with bank loans and that the temporary expansion of the currency would not affect prices.³

Fullarton's analysis of specie flows is suggestive, even though it is confused and at times contradictory. He denied that gold movements could be brought about by excessive note issues or by a relatively high price level. Exports of specie were caused by an unfavorable balance of payments.⁴ But he admits later that "speculation and over-trading" may bring gold flows.⁵ He suggests as other causes of drains demands of foreign governments for specie for coining, demands for hoarding abroad, over-investment in foreign securities, and increased imports of goods because of a harvest failure or some similar disturbance.⁶

The level of prices is determined by the volume of bank credit and not by the quantity of currency, and the Bank cannot control specie flows by regulating the amount of the currency. Its power of control through regulation of deposits or notes is limited. In some cases the specie which is exported comes from "hoards in the hands of the banks or the public, and the movement will not affect prices at all."¹ In the case of drains due to foreign government demands or to panic conditions it is impossible to stop their progress, and it is undesirable to hinder flows which pay for imports of grain necessitated by a failure of the harvest at home. The Bank of England should, therefore, hold a sufficient stock of bullion to meet such demands, until other fortuitous circumstances arise to bring the gold back again.

Drains due to over-trading are of a different nature, and the Bank should have no compunction in dealing with them. But, in the main, it is impotent, for these come at the end of a period of speculation, when the collapse is imminent.² He shows that an influx of bullion is to be found in most cases when the circulation of notes in the country is large. He continues:

The case is nothing more than this, that the same circumstances which conduce to a rise of the exchanges and an influx of gold, denote also generally the existence of an active state of internal industry, a high scale of production and consumption, and every condition requisite to an enhanced employment and demand for money. On the other hand, when a fall of the foreign exchange and a drain of gold come in the train of a period of commercial excitement and speculation, their advent is commonly the signal of a collapse already commenced, an indication of overstocked markets, of a cessation of the foreign demand for our productions, of delayed returns, and, as the necessary sequel of all these, of commercial discredit, manufactories shut up, artisans starving, and a general stagnation of industry and enterprise.³

Fullarton employed this concept merely to show that fewer notes were needed in circulation when business was slack, and to prove that the state of the note issue did not determine gold flows. He also maintained that the Bank could be effective in con-

trolling the state of credit and currency only occasionally. For normally the country was not dependent upon the Bank.¹

By this time the nature of the internal demand for money at the time of a panic was clearly understood. Demands for coin and notes at such times were due to fear, and money was wanted for hoarding — not spending. Therefore the increased amount in "circulation" could not affect prices as it would in normal times.² And the proper procedure for the Bank of England to follow was distinctly shown. In order to stay the panic, loans were to be freely granted, according to Torrens, for the internal situation was the more precarious. But this did not excuse the Bank for failing to contract earlier when gold was being exported.³ The terms of Bagehot's thesis are evident here, although the increase in the rate of interest charged by the Bank, which is an integral part of the latter work, is not stressed until Overstone's treatises after the crisis of 1847.

Out of the controversy over the Bank Act of 1844 there emerged important contributions to theory. The Currency School theorists applied the Ricardian doctrine of specie flows to the monetary situation, and pointed out that the correct procedure for banks was to curtail note issues early in a period of expansion. Otherwise the trade balance would become unfavorable, and gold would flow out, bringing panic conditions. If action were taken early, the disequilibrium could not become large, and the loss of gold would be thereby reduced in volume. The restriction of currency would affect prices and the trade balance, and restore equilibrium in the international accounts. By the Act of 1844 the Ricardian principle was established, and the Bank was forced to act in the manner prescribed, since the amount of expansion of note issue was limited by the bullion stock at the Bank. It took many years

of agitation and criticism on the part of Bagehot¹ and others to force the Bank to recognize its responsibilities, and to take action *early* in a period of prosperity, and vary its rate of discount in accordance with the state of the Reserve.

On the other hand, the critics of the principle had pointed out that there did not exist the intimate connection between gold and prices which was presumed by the Currency School. In part this was due to the development of deposit credit, in part to the lack of control by the Bank over the business of the country, and in part to the fact that gold flows did not come from circulation but from "hoards." Moreover, it was asserted that the business of the country should not be hampered because of gold flows arising from causes other than over-trading and speculation. Therefore, bullion reserves should be elastic to some extent to allow for irregular and spasmodic gold flows traceable to causes other than relative states of price levels. While the Act itself did not admit of great latitude in that respect, the effects of such flows, as they became easily recognizable, were discounted by the market.²

supply the gold sent abroad.¹ The latter type of movement is not treated specifically in connection with cyclical fluctuations of business, and it is probable that seasonal flows only are thought of, but the analysis suggests that of Professor Young in connection with the United States.

Juglar's analysis is more complete. Like de Laveleye, he stresses the actions of the foreign exchange market. He attributes the precipitation of a crisis to an export of gold. But the concept is extended to cover other phases of the trade cycle. In the earlier stages prices tend to rise, the balance of trade tends to become unfavorable, and gold flows out. After the fall of prices facilitates the liquidation, the trade balance becomes favorable, and gold returns.² Here the Ricardian analysis is *definitely* linked to *cyclical* fluctuations. The period of rising prices and gold exports is long; while the fall of prices is rapid, and the return of gold is consummated in a relatively short time.³ And lastly, he maintains that cycles are simultaneous for England and France (with a time lag of not more than a year) and the situation is nearly the same for these two countries and the United States.⁴

Both of these theorists showed that an import of gold would raise prices immediately if spent for goods. But if advanced to entrepreneurs it would first affect interest rates, and ultimately prices, unless the stimulation given to production offset the tendency toward increased prices.⁵

It remained for Marshall to explore this process more definitely,

and to show its relationship to internal currency flows.¹ In his view a new supply of gold would first increase bank reserves. Lower discount rates would result, and more speculation would be indulged in.² As a consequence prices would rise, and then people would need more hand-to-hand circulation. The new currency drawn into circulation would support and sustain the rise of prices. Marshall qualifies the analysis by showing that the changes outlined above will occur only if "other things" remain the same.³ He examines some of these other factors, and finds that at times they will outweigh the monetary elements, and that the expected price change will not result. The other important factors are the methods of doing business — particularly the customs and practices of banking — and the amount of currency customarily carried by the people.

CHAPTER III

GOLD AND CURRENCY MOVEMENTS

(1) During the years from 1881 to the outbreak of the war in 1914, England¹ affords a peculiarly interesting and instructive field for the investigation of the influence of both international and domestic flows of specie upon banking and industrial conditions. Although there were wars in the Orient, the Balkans, and in America, and general European wars were narrowly averted on several occasions, England was at peace except for the South African war. The Boer War seriously affected industrial and financial conditions within England, and her international balance of payments was disturbed, but it was not catastrophic and there was no disruption of the monetary system or resort to forced issues of paper currency. From time to time during the period considered there were internal difficulties of an industrial nature, but these did not interrupt seriously the marked expansion of trade and production which occurred during these years.

On the financial side England was in a wholesome condition. Government finances were maintained in a satisfactory state, and under the administration of Lord Goschen an appreciable reduction of the interest on the outstanding Consol debt was achieved. Moreover, by the beginning of the period the Bank of England, following the oft-times repeated criticism of Bagehot and others, had begun to operate in a systematic and well-defined manner. While its control over the London money market was weakened by the large accumulation of liquid capital in the hands of the constituents of the outside market, it exerted a strong psychological influence upon this group and a certain amount of mechanical control over the business of the country outside of London. Its con-

See below, p. 60. trol of the local market was complete at times, and it succeeded in developing auxiliary weapons to aid its major device of the discount rate. The Bank was successful in preventing panics, and the crises of the period were far less severe than those experienced earlier in the nineteenth century.

All this was achieved in spite of the constant pressure brought upon the London bullion market — the only free market of any size — during the last two decades of the last century by the increasing relative scarcity of gold in the world, and in the years immediately preceding the Great War by the demands of the Continental nations for larger specie reserves. On the other hand, the amalgamation movement in English banking proceeded rapidly during the whole period, and the banking resources of the nation were gradually concentrated in the hands of a relatively small number of companies. While there was not always the closest sympathy between the banks and the Bank of England, relations were improved toward the end of the period, and evidences of cooperation were seen at times.

(2) In addition to an important secular growth of industry and commerce during the period, there were pronounced cyclical fluctuations in business and prices. For the present purpose it is unnecessary to distinguish between all of the phases of the trade cycles, since variations in the volume of currency and credit and movements of specie would tend to be alike in the stages of revival and prosperity and during recession and depression. The analysis of Hawtrey assumes that gold will flow from the central reserve into circulation during the period of expansion,¹ and specie may be exported if foreign countries are expanding at a slower rate. While the movement of gold may lag somewhat behind the increased volume of business and the rise of prices, losses of specie from the central bank and a reduction in the reserve ratio would accompany the revival and prosperity stages of the business cycle. In periods of recession and depression, reserves would rise as

coin and notes flowed in from the circulation, and specie imports would occur if the contraction of credit was less severe in foreign countries.

The fluctuations of business and prices attributable to cyclical or accidental forces are classified below into periods of expansion and recession:

The above classification is made from the quarterly indexes of business conditions and prices prepared by Persons, Silberling, and Berridge¹ for the period 1903 to 1914 and by Dr. Thomas² for the earlier years. The indexes are shown in Chart I and Table I. While the division of business fluctuations into periods of expansion and recession is not precisely accurate so far as the turning points are concerned, the general course of the business cycles is fairly well defined.³

In the following sections the cyclical fluctuations of business are examined in relation to the international flow of gold and the domestic movement of currency, and in the succeeding chapter variations in bank credit and discount rates are considered with respect to "secondary" expansion. In later chapters a more minute historical survey is made of the developments in the London money market and the banking system.

(3) The London gold market was preeminently important during this period. A very large amount of specie moved direct to England from the mining countries, especially South Africa and Australia, to be sold on the bullion market. Before the War most of the supplies from these regions were sold in London.¹ The presence of this market was of great value to England, for it gave her immediate access to newly arriving supplies. Not only was it profitable to the dealers in the way of commissions but a much slighter change in discount rates reacting on exchange rates was necessary to retain gold already within the country than to cause it to flow in from abroad. And the fact that at all times shipments were on the seas bound for London from the mines gave security to her reserve position.²

It was the practice for newly mined gold to be sent to the London refiners, and then to be sold through the various firms of bullion dealers. The price never fell below the Bank of England buying rate of 77s. od., but it often went considerably above it. With the exception of certain periods, whenever the slightest fraction above the Bank price was offered by agents acting for principals in foreign countries, the gold was sold to them for export. At times, however, the Bank came into the market as an active bidder for specie at a price above its usual buying rate.³ Instances of this practice will be noticed later, but for the present it is desirable merely to point out the limits to which this policy might go. Rarely did the Bank pay as much as 775. 10d., and 775. 10¹/₂d. was the upper limit.⁴ In the case of sales of gold by the Bank, the price of bullion was normally at 77s. 10¹/₂d. per ounce, but it might rise above that to the limit of the tolerance of the Mint. Beyond 77s. 11d. it was not safe to go, as coin would then be de-

manded to be melted down for export.¹ The buying and selling prices of *foreign coins* were subject to somewhat greater variation, however, depending upon the needs of the Bank.²

Statistics relating to international gold movements for England were published monthly by the Board of Trade, and movements at London weekly by the London Customs House. In addition the Bank of England reported daily the amount of bullion and coin received and withdrawn on foreign account. Specie which entered England only to be reshipped immediately after sale in the bullion market, and movements into bank reserves or the internal circulation which were offset shortly by exports from the same sources, had very little effect upon the international balance of payments.³ And movements which were cancelled by others in the opposite direction within a week could have little effect even upon the fluctuations of commodity prices and industrial production. Accordingly, only the net weekly figures of the Bank of England ⁴ and the London Customs House have been utilized here.

In order to secure series more nearly comparable with the index of business cycles, quarterly totals of the weekly net figures have been computed, and they are shown in Table II and Chart II. Four-quarter moving averages of each series have been calculated,⁵ and they are shown in Table III and Chart III. Random fluctuations have been reduced by the moving average, but seasonal variation and secular trend are evident. It has not been thought worth while to remove the seasonal and the trend in the usual manner partly because the cyclical variations are very

marked after smoothing, and partly because the series of internal movements of currency ¹ with which external movements of gold are to be compared are subject to considerable error and removal of seasonal fluctuations and trend seems unwarranted. The resemblance between the curve of gold movements reported by the London Customs House on Chart III and the curve of net gold movements shown by Dr. Silverman ² is close. The latter curve shows a series of monthly gold movements as reported by the Board of Trade after seasonal variation has been removed. The curve derived from the Bank of England returns differs from

that derived from the London Customs House data, especially from 1891 to 1894, from 1898 to 1903, and in 1905. The cyclical fluctuations in the former series are in general more pronounced, as is to be expected. The more important differences between the series are considered below.¹

(4) Internal movements of gold and currency also reveal pronounced cyclical variation. England continued to use gold sovereigns and half-sovereigns for the greater part of her internal circulation until the war, but substantial amounts of silver and bronze coins and Bank of England and country bank notes were also in use. None of the bank notes were less than £5 in denomination, however, and they were but little used in ordinary transactions. Moreover, it was necessary to endorse them in making payments, and this bother helped to make checking accounts more desirable. The requirements of the Act of 1844 prevented any large fluctuation in the Fiduciary issue of Bank of England notes. For the most part notes were used, consequently, only in payment of large salaries, for traveling expenses, and as till money for banks.² The latter use was especially important, for country banks could retain their own notes instead of metal money for reserve purposes beyond the daily coin requirements. The country bank note issues steadily declined during the period, as these banks were required to relinquish the privilege of issue upon bankruptcy or upon amalgamation with a bank maintaining

an office within sixty-five miles of London.¹ There was a steady diminution of these notes, and the growth of the Bank of England issue was accounted for largely by the replacement of the country bank notes. The Bank was permitted to increase its issue to the extent of two-thirds of the relinquished issue.²

value of coins struck and issued, and the value of coins withdrawn from circulation for recoinage are of help, however. When these figures are combined with the statistics of foreign movement of British gold coin, a series is secured which throws some light on the internal movements of coin. These figures have been plotted in Charts IV and V to show the movements of gold coin, silver coin, and bronze coin separately, and a three-year moving average has been prepared for the gold coin series to remove some of the irregularity.¹

(5) A second method of ascertaining the cyclical variation in the internal currency involves a process of deduction from certain figures contained in the weekly return of the Bank of England. From this statement it is easy to determine the amount of specie held by the Bank. In addition to gold a small amount of silver was held by the Banking Department, but it was generally believed that the sum was small; and variations in it were relatively slight in comparison with changes in the gold holdings. The difference between the specie holdings for successive weeks indicates the amount of gold which must have moved through either international or domestic channels. The Bank returns of gold received and taken for export² are then combined with the figure for

The *Economist* has taken proper account of this movement of gold in making up its figures of imports and exports in nearly all cases. And no significant changes would result in the series from the correction of minor omissions, as they were small in magnitude.

One important aspect of the seasonal drain was the demand for gold on the part of the Scotch and Irish banks of issue. Under the Acts of δlh and glh Vict., cap. 38 (1845), these banks were allowed to continue to issue notes to the extent of their average issue during the year ending May 1, 1845. Beyond that limit notes must be issued on gold and silver coin held by them. For this purpose a return was rendered weekly, and a four-weekly average was calculated to determine if the fiduciary limit had been exceeded. When larger note issues were necessary the banks in these two countries drew gold from London to bring their average for the month up to the legal requirements. In Scotland the &r note was used in general circulation in place of sovereigns.

series has been compiled from the weekly figures, and a fourquarter moving average computed.¹

Fluctuations in the outstanding issue of the Bank of England notes have also been compiled, and Table VI includes a series combining the net quarterly movements of gold and Bank of England notes. A four-quarter moving average of this composite series is also shown in Table VII and Chart VI.² Another series of

quarterly movements of gold and Bank notes beginning with the second week of each calendar quarter was calculated. It is not presented here because the cyclical fluctuations in the two series of gold and Bank notes were similar. There were minor differences between the two series on account of the "window dressing" in connection with the preparation of company statements in January and July.

(6) It is apparent from the statistics of internal and external gold movements shown in Tables II and VI that there was a large secular increase in the amount of gold available for monetary and other uses in England. In Table VIII the net foreign movements of gold reported by the Bank of England and the London Customs House are compiled into annual series, and cumulative totals of net imports calculated. In the last column of the table the differences between the cumulative net imports are calculated. During the first five years of the period considered in this study, the Bank of England reported somewhat larger specie imports, but between 1886 and 1890 the statistics of the London Customs House show somewhat greater net imports. The differences between the two series are not large during this period. Between 1801 and 1804, however, the import of gold reported by the Customs House was much greater than that reported by the Bank, and by 1894 the cumulative net imports according to the Customs House data were nearly $\pounds_{24,000,000}$ greater than those shown by the Bank of England statistics. Again between 1897 and 1902 the net imports reported by the Customs House far exceeded the imports reported by the Bank, and the cumulative net imports of the former had grown to some £62,000,000 in excess of the Bank's net imports for the period from 1881. Aside from the year 1905, there is not a wide difference between the two sets of statistics after 1002.

The increase in the specie stock of England revealed by the cumulative imports is deceptive in part, because the foreign trade

in the country bank note issue were due principally to the downward trend in the issue. The maximum variation in the outstanding issue in any quarter was £168,000 between 1881 and 1900, and by that time the total amount had declined to about £1,250,000 from approximately £3,500,000 in 1881.

figures did not take account of coin carried abroad by travelers. Sovereigns were used in the British colonies and in foreign countries such as Portgual and Brazil where the sovereign was legal tender, and the net quantity of coin carried away by travelers or immigrants to these and other countries must have been considerable. In addition, the currency of Scotland and Ireland was supplied from the imports of specie shown by the statistics above. Industrial consumption accounted for a very large portion of the net imports during the period. Part of the supply for this purpose undoubtedly came from the melting down of sovereigns or of old plate, but a very large part must have come from newly imported gold.¹ The industrial consumption very likely varied somewhat

over cyclical periods, as the demand for gold ornaments is affected by cyclical conditions of business.¹ There was a considerable increase in the volume of coin held by the banks and the public,² and the amount held by the banks is understated somewhat in the Mint estimates.³ The estimate of £110,000,000 for the gold supply of the United Kingdom in 1883 by Palgrave may have been somewhat high. It seems probable that there was an increase of nearly £25,000,000 in the gold circulation between 1881 and 1913.⁴ When the additions to the bullion stock of the Bank of England are added, a total of nearly £40,000,000 in the gold monetary stock seems probable. In addition there must have been an increase in the Irish circulation not shown by the Mint estimates.

After allowing some £40,000,000 as the increase in the monetary stock of the country, and assuming that most of the annual industrial consumption of £2,000,000 was taken care of from newly imported specie, there is a considerable volume of gold reported by the Customs House which is not accounted for. But when further allowance is made for the stocks of bullion accumulated by the joint stock banks, an increase in the Irish circulation, and the coin and bullion lost through wear or unrecorded export, the total amount of the net import for the period seems to be accounted for without any great margin of error. The chief problem

is to account for the great difference in the net imports indicated by the two sets of statistics between 1891 and 1894 and later from 1897 to 1902. The fluctuations in the outstanding issue of Bank of England notes and the large imports of gold which did not go to the Bank of England in the first of these two periods suggest that some hoarding of currency may have taken place.¹ In the second period, the accumulation of gold by the joint stock banks may be the major explanation for the differences between the statistics of the Customs House and the Bank.

The series derived from the Mint reports are subject to a wider margin of error, since no allowance is made for coin melted down for export in the form of bullion. And the gold series shows much less regular cyclical fluctuation than the silver and bronze coin

series. Even the latter are subject to errors of various kinds. For example, in 1906 and 1907 a significant change in the use of bronze was brought about by the introduction of the penny slot machine on a large scale.¹ The series derived from the Mint reports also tend to lag somewhat behind those calculated on the basis of the Bank returns. One explanation for this difference is the fact that the former are based upon annual rather than quarterly statistics. But a more important reason lies in the relation of the Bank of England to the Mint. It was the practice of the Bank to meet the cash requirements of its customers - the banks primarily from their own coin stock. Not until that ran low did they send bullion to the Mint for coinage.² Under these circumstances such a lag is not surprising.

(7) Bank notes do not exhibit any important cyclical fluctuation because of their limited use. This was pointed out by Mitchell in his study of business cycles,⁸ and it is also indicated by the annual averages of the outstanding note issue prepared by Palgrave.⁴ The quarterly averages of notes held outside the

Bank, shown in Table IX and Chart VII, reveal pronounced seasonal variation, but no regular cyclical fluctuation is apparent.¹ During the period of depression from 1891 to 1894 there was a considerable increase in the outstanding issue, although the Fiduciary Issue was increased by only £250,000 in February, 1890, and by £350,000 in January, 1894.² According to the Mint statistics shown in Tables IV and V, the public's requirements for silver coin declined after 1889, and the movement of bronze coin into circulation decreased after 1891. On the other hand, the circulation of gold coin was larger in 1891 than in 1890, and after a decline in 1892, there was an increase in the gold coin supplied to the public by the Mint. The fluctuations in gold coin and Bank of England notes suggest that hoarding of currency in large denominations was occurring from 1892 to 1894.

The Mint statistics of silver coin in circulation indicate a definite cyclical variation in the public demands for currency. During the years immediately preceding the crises of 1882-83, 1890, 1900, and 1907, and also in the period of expansion before 1913, there was a drain of silver from the Mint. In the periods of recession following each crisis the demands of the public were diminished. In 1902 and 1904 there was a reflux to the Mint on balance. The movement of bronze coin exhibited the same type of variation on a smaller scale. These two series are particularly significant in showing the increased need for currency during periods of high prices and business prosperity, and they reflect the conditions more clearly than the gold statistics because it was not profitable to melt down silver or bronze coin, nor is it probable that many of the coins were carried out of the country.

The gold coin series derived from the Mint Reports ² also reflects cyclical variation in the need for currency. In 1882 the increase in circulation was slight, but in all the other periods of expansion in business there was an important increase in the demands of the public for coin. The irregularity of the series is due

partly to the re-coinages of 1889 and 1892, since much of the coin withdrawn from circulation was not replaced.¹ The three-year moving average conforms more closely to the variations shown by the statistics of silver coin. The series of total internal movements of coin shown in Table V is dominated by the gold series, and follows the latter closely.

The two series of quarterly movements of currency derived from the Bank of England returns ² after allowance has been made for external movements of gold are in close agreement. Since gold coin constituted the most important element in the circulation, and Bank of England notes showed no cyclical fluctuation, it is obvious that the series combining gold and notes is dominated by fluctuations in gold.

(8) In Chart VIII the four-quarter moving averages of net foreign movements of gold reported by the Bank of England and internal movements of gold and Bank of England notes are compared. The striking feature of this chart is the high inverse correlation between foreign and internal movements of gold.³ During the period of prosperity prior to the recession of 1883-1886 there was a noticeable drain of currency from the Bank into circulation, and at the same time an influx of gold into England from abroad. The latter continued until 1884, accompanied by a slight reflux of currency from the country to the Bank in 1883. In 1885 and 1886 foreign exports of gold were heavy, and there was a concomitant reflux of coin to the Bank from circulation in 1886. The internal drain began again in 1887 and continued until 1891. There was little movement of gold on foreign account during 1887 and 1888, but from 1880 to 1801 inclusive the imports were large. In the recession following the Baring crisis a return flow of currency to the Bank set in, and this was accompanied by exports of gold. In 1894 and 1895, however, specie imports were large; but there was little movement into circulation, and the gold remained in the

Bank for the most part, though much of it was exported during 1896 and 1897.

In 1897 a pronounced cyclical movement of currency into circulation commenced, and it was followed by large gold imports from 1898 to 1901. The internal drain ceased during 1901, and there was some reflux to the Bank between 1902 and 1904, coupled with relatively unimportant net movements of gold on foreign account. The internal drain of gold began again in 1904 and continued until the crisis of 1907. Large gold imports accompanied this internal drain. During the depression immediately after 1907 there was a return of currency from circulation, and specie was exported from the Bank. But in 1909 the internal drain began again and continued until 1913. As in other periods of business revival large gold imports accompanied the movement of gold into circulation.

In general gold imports became important during the latter stages of the periods of business expansion, and at the same time the volume of currency in the hands of the public was expanding. In recession the flows were reversed. Thus the Bank of England acted as a channel through which gold passed from foreign countries or the mines to the British public. During the long depression from 1891 to 1896 there was an influx of gold from abroad because of the diminution of capital exports, but in other periods of depression the effect of the reduction in foreign loans was not clearly shown in specie movements.

(9) Examination of Chart IX and Table IX indicates some cyclical fluctuation in the bullion stock of the Bank of England. In the years preceding the crises of 1882-1883 and 1890 the stock declined, and the imports of gold did not remain in the Bank but went to swell the internal circulation or to provide gold for industrial purposes. The large influx of specie during 1894 and 1895 enabled the Bank to maintain a higher general level of gold, and the stock which at times before 1890 fell below £20,000,000 never averaged less than £30,000,000 after 1894. But the same cyclical variations were apparent, and in the periods of prosperity preceding the crises of 1900 and 1907 the gold stock again declined. It is

clear that the demands of the country for coin were sufficient to lower the gold stock of the Bank and to cause the importation of metal during the expansion periods. And in recession the reflux from the circulation built up the Bank's stock, and even permitted the export of gold at times without diminishing the stock appreciably. In Chart IX the annual average Reserve Ratio of the Bank of England¹ is shown in connection with the stock of bullion. It is evident that fluctuations in the ratio were similar to the variations in the bullion stock. So long as the Bank attempted to

keep its ratio within a narrow range, and its action was effective upon foreign exchange rates and gold movements, this concurrence in the variations in the bullion stock and the reserve ratio was to be expected over cyclical periods.

(10) It is evident that the length and magnitude of the business cycles were important in determining the volume of the gold and currency movements. Following the crisis of 1882 the recession was gradual, and the same was true after 1890. Commodity prices reached their peak in the latter part of 1889, but the crisis did not occur until the fourth quarter of 1890. The internal drain

of coin did not cease, however, until the late spring of 1891. On the other hand, after 1900, and particularly after 1907, the recessions were abrupt, and the internal drain stopped more quickly. In 1900 the lag was from nine months to a year, while in 1907 it was less.

Events around 1882 do not conform altogether to this classification. In that year the peak of business reached in the late fall was sharp, but throughout 1883 there was little decline from the newly established level. The internal drain, however, ceased early in the year, although no important reflux began until 1885. Movements in this period were of somewhat less magnitude than in later periods, and it is likely that some of the important fluctuations are obscured. Moreover, the crisis itself was not pronounced, as only four years had elapsed since the severe one in 1878.

On the whole the data seem to warrant the conclusion that in cases where the period of expansion was long-continued and the succeeding recession gradual, the internal drain was abated slowly. And where the business cycle was shorter and the recession abrupt the drain ceased more quickly. The evidence afforded by the experience of the United States also confirms this conclusion.¹ It may be said, then, that the more temperate the fluctuations of the business cycle, the greater is the lag of gold and currency movements. The implications of these conclusions will be discussed below in connection with banking policy.²

CHAPTER IV

BANK RESERVES AND CREDIT

(1) The ultimate banking reserves of the country were held in the Bank of England for the most part, and it is possible to ascertain the fluctuations in the reserve from the weekly returns of the Bank showing the Reserve of the Banking Department. This Reserve was composed principally of Bank of England notes, plus a small amount of specie, primarily silver coin. Changes in the total specie holding of the Bank closely paralleled changes in the Reserve, because of the manner in which the provisions of the Act of 1844 were carried out. Gold was received by the Banking Department, and deposit credit or notes given in return. The specie was transferred immediately to the Issue Department, and an equivalent amount of notes given in exchange to the Banking Department. Except in cases where an increase in the Fiduciary Issue was authorized and the public did not require a similar expansion in the Bank notes held by them, the specie stock and the Reserve fluctuated in a similar manner, so far as cyclical conditions are concerned. If there had been important cyclical variations in the volume of notes held by the public, the Reserve might have shown fluctuations not revealed by the specie stock, but the amount of notes outstanding was remarkably stable so far as cyclical movements are concerned. The quarterly averages of the bullion stock of the Bank shown in Table IX and Chart IX, consequently, afford an adequate indication of the movements of the ultimate banking reserve of the country.

The returns of the Bank show figures for "other deposits," which give some idea of the volume of reserves of other banks. Earlier in the century the balances of the joint stock banks were presented separately, but after 1878 this information was no longer given.¹ It seems probable that by 1914 the balances of

these banks constituted the larger part of the "other deposits," because of the amalgamation of private banks with the joint stock banks. The remainder of the "other deposits" consisted of balances of private bankers, London branches of foreign or overseas banks, and other financial houses operating in the London money market.

No regular cyclical variation in the amount of the "other deposits" was found by Persons, Silberling and Berridge, after the seasonal variation and secular trend had been removed from a monthly series of these deposits.¹ An examination of the quarterly averages of total deposits compiled in the Statistical Abstract for the United Kingdom showed no cyclical fluctuation. The absence of regular variations in deposits of the Bank in connection with business fluctuations tends to substantiate the contention of English bankers that changes in these deposits were associated principally with local conditions in the London money market, and had little to do with conditions of credit and prices throughout the country.

It is possible that while the "other deposits" showed little cyclical variation, the share held by joint stock and private banks may have fluctuated somewhat in accordance with business conditions, provided the portion held by other financial houses varied in an inverse manner. Information as to the constitution of the

form of the report by one of the Directors of the Bank of England, Mr. Thomson Hankey, who was also a member of the House of Commons. The apparent reason for this action at the time was that at intervals the balances of the joint stock banks exceeded the Reserve of the Bank of England. It was felt that if this situation were generally known, fear would be engendered as to the safety of general banking deposits and bank notes. How largely this was justified is an open question, since the reports were not published until some time after the situation was a thing of the past. It was stated that thereafter the "bankers' balances" did not increase, but it seems more probable that the amalgamation of private banks with joint stock banks increased the balances of the latter during the years from 1881 to 1914. "other deposits" is not available, but it seems unlikely that substantial shifts over cyclical periods occurred in the share of the deposits of the Bank held by joint stock or private banks engaged in extending loans to business. The reports of two joint stock banks gave the balance held at the Bank of England separately from the cash in the till, and these figures are shown in Table XI. and are plotted in Chart X. Some increase in the balance at the Bank of England is shown before each of the major crises in the case of the Union Bank of London.¹ To the extent that cash held by the banks and balances at the Bank of England were increased by reducing holdings of short-term bills, discounting at the Bank would be increased. Average deposits of dealers who kept accounts at the Bank would rise, presumably, as they borrowed more freely from the Bank. Such movements could not have been very important, however, or there would have been a definite cvclical variation in the total of the "other deposits." Nor does it seem probable that other financial houses having deposits at the Bank would permit them to be drawn down to any great extent during periods of business prosperity, since demands for credit by their customers would increase at the same time that loans made by joint stock and private banks were growing.

The fluctuations in the balance at the Bank of England are greater than the variations in the cash held on the premises in the case of the two banks for which data are available. But there seems to have been a tendency for the fluctuations to offset one another throughout much of the period. The two parts of the reserve were roughly equal in the case of the Union Bank, while the City Bank kept considerably more than half of its reserve in the form of a balance at the Bank of England during the years for which statistics are available. In the post-war period "cash in hand" has been somewhat greater than the balance held at the Bank of England.² It seems likely that the amalgamation of

banks brought this change, rather than an alteration in banking practice, and that the two banks considered here were not typical of the banking system. Their business was largely confined to London, and till money requirements were undoubtedly less than was the case of banks at a distance. The merging of banks would increase the till cash requirements of a London bank acquiring country branches.

The reports of other banks are of little help in the determination of reserves. The joint stock banks published annual or semiannual reports throughout the whole of the period, and in 1891 the members of the London Clearing House began to print

monthly statements. Many of the private banks, however, issued no returns whatever. Fortunately the progress of the amalgamation movement brought most of them under the fold of the joint stock banks, and by 1914 the reports of the latter cover most of the banking institutions of the country, with the exception of the London branches of foreign banks. Even where available, the statements are not of the greatest value, since there was no uniformity as to the type of information presented. In many cases the item of "cash" included money lent "at call and short notice." uncleared checks, and balances at the Bank of England, as well as till money.¹ And the last included all forms of money: Bank of England notes, country bank notes, and silver and bronze coin. in addition to gold.² Moreover, the cash item was subject to manipulation. The banks generally increased their reserves prior to the date of publication of their returns by calling in some of their short loans from the market,³ thereby increasing their balances at the Bank of England, and possibly also their cash held on the premises by withdrawing portions of their balances from the Bank in the form of notes or coin. This practice of "window dressing" was subjected to widespread criticism, and it is possible that it became somewhat less prevalent after 1900.4 Some of the joint stock bank chairmen denied that their banks indulged in the practice, and maintained that they were forced to call loans only because some of their customers demanded cash in order that company statements might reveal more liquid conditions.⁵ But un-

(2) The joint stock banks increased the currency held in their vaults considerably during the period from 1881 to 1913. The increase was due in part to the amalgamation of banks, and in part to the agitation over the question of bank reserves. The growth in currency holdings was made easier by the heavy gold flow from South Africa into England after 1893, and differences in the reports of gold movements between the Bank of England and the London Customs House are explained in part by the accumulation of coin and bullion by the joint stock banks.¹

Merging of banks brought an increase in the total reserves held. Many of the small banks kept very small reserves, and upon combination with other banks it was necessary to bring up their total to the percentage carried by the absorbing bank. It was the practice for country banks to carry a certain percentage of their deposits in cash (perhaps fifteen, though many banks kept smaller proportions). Of this 15 per cent one-third would be in the till, and two-thirds with a London agent. The latter kept only a reserve of 15 per cent against this deposit. Thus on the basis of deposits of £100,000,000 the total reserve would be only £6,500,000. When banks were merged, the London banker would still maintain a 15 per cent reserve, which necessitated £15,000,000 against the same amount of deposits. If a country bank absorbed a bank in London, it also had to keep larger re-

serves to conform to the standard of the city banks. Against this loss, it saved the fees formerly paid to the agent.¹

The second major reason for the accumulation of gold by the joint stock banks was the agitation for larger reserves of gold in England. The controversy upon this question waxed strongly at various times during the period -- chiefly during the prosperity phases of cycles. In general participants agreed that larger reserves were needed, but no one was willing to assume the expense of getting them. And the discussion waned during the periods of depression when gold reserves were large. Obviously this was the time to secure additional gold in excess of the supplies which accumulated in such periods, but no efforts were made then. Some progress was attained, however, particularly after the crisis of 1890, and again in the years immediately preceding the great war.

In the first case the joint stock banks began to hold larger "cash" reserves after the admonitions of Lord Goschen in 1891.² There is no question but that more "cash" was held, but it is difficult to say whether the banks merely increased their balances at the Bank of England,³ or actually carried more specie in their

In 1914 he announced that he had been authorized by the Board of Directors to publish the holdings of the bank,¹ and in December the statement showed $\pounds 8,000,000$ held in coin.²

The reports of the Royal Mint also indicate a great increase in the gold held by the joint stock banks. Beginning in 1907 these banks co-operated in giving to the Mint the amounts of coin held on a specified date.³ They had begun the reporting of similar statistics with regard to silver coin several years earlier. The figures for gold coin show a large increase, especially after 1910. The number of banks reporting changed somewhat, however, and a part of the growth was due unquestionably to the inclusion of more banks as time passed. But without doubt more gold was

held, and less reliance placed upon the Reserve of the Bank of England after 1907.

While there was an important increase in the gold holdings of the joint stock banks, there was no significant cyclical variation in the amounts kept on the premises. It is clear that the reserves rose generally after and not before crises. In part this seems to have been due to the return of coin from circulation during the recession phases of business cycles, and in part to the agitation for larger reserves which was most apparent in crisis years. Undoubtedly the increase in reserves made it possible for banks to expand credit during the succeeding period of prosperity; but not until after 1907 is it certain that the banks themselves held bullion or coin stores of their own beyond till money requirements, and larger bank reserves in the preceding periods of depression probably merely increased the amount of gold which it was necessary for the Bank of England to hold.

While there was some cyclical fluctuation in the Bank's stock of bullion, the fluctuations of bank credit were associated principally with variations in the reserve ratio of the Bank, since currency requirements were largely responsible for the variations in the stock. An examination of Chart IX shows that there was a considerable difference in the average ratio between periods of business expansion and contraction. The ratio declined as demands for credit and currency increased during prosperity, and rose again during depression. The gold stock of the Bank of England fluctuated somewhat with the course of the business cycle, but reserves of other banks did not vary greatly on account of cyclical movements of business, apparently. For the most part, changes in the volume of bank credit seem to have been made possible by variations in the ratio of the Bank of England, and by gold movements. Except for the international flow of gold there was little slack in the banking system, and excess reserves built up in depression periods provided little possibility for the credit or currency expansion necessary in the succeeding periods of prosperity.

(3) Data relating to the volume of bank credit outstanding are even more difficult to secure than figures for reserves. The state-

ments of all reporting banks are gathered in the semi-annual banking supplements of the *Economist*, and series of the more important items are compiled there. The monthly statements of the London clearing banks are available from 1891 on. The prime difficulty with the data is that they are not all-inclusive. Nor are the series homogeneous, since new banks were continually added to those reporting, due primarily to the progress of the amalgamation movement.

Of the various figures reported the deposit item is the most valuable on the whole. The chief defect is that it included both current and deposit accounts, i.e., checking and savings accounts. In some cases acceptance liability was also included. In the same way loans included both advances on securities and bills discounted. The total amounts of deposits and loans generally varied together, however, and deposits are considered here as a measure of the volume of bank credit. The Economist compiled a semi-annual series of deposits for all joint stock banks in England and Wales.¹ and this series is shown in Table XII and Chart XI. It has not been deemed worth while to remove the trend. since the growth is accounted for partly by the increase in business in the country, and partly by the addition of banks to the series, principally because the amalgamation movement brought banks which did not publish statements under the control of joint stock banks which made returns. Despite this defect, some cyclical fluctuation is apparent in deposits. They tended to grow at a more rapid rate during periods of prosperity and to fall off somewhat in depression. The measures of bank credit used by Professor Pigou² shown in Charts XII and XIII show the same cyclical variations, except that for the period 1896 to 1900 the 3year moving average of the annual increase in the volume of bank credit declines.

A further examination has been made of two banks for which monthly data are available. These are the London and West-

minster Bank and the National Provincial Bank. The former dealt almost entirely with London business, while the latter had important provincial connections in addition to its London clien-

tele. While both banks grew during the period through the addition of branches, neither was concerned in important amalgamations.¹ And the item of acceptances was not large in either case.

Statistics of deposits and cash reserves for the two banks are given in Table XXI and the series are plotted in Chart XIV. There is no evidence of cyclical fluctuation in the deposits of the Westminster Bank, but deposits of the National Provincial

tended to increase in periods of prosperity and to remain nearly constant during depression. Cash reserves fluctuated in the same manner as the deposits, although there was a lag in the increase of reserves behind the rise of deposits of the National Provincial Bank.

A comparison has also been made of two banks whose business was principally in London — the Westminster Bank and the London Joint Stock Bank — with a group of country banks. Since monthly statistics are not available for the latter group, semi-annual statistics of deposits have been used. They are shown in Table XIII and Chart XV. Deposits of the two London banks grew slightly between 1885 and 1889, and declined somewhat thereafter until 1893. From 1894 to 1896 they grew considerably, possibly because of the transfer of balances from country banks to London. It is not possible to determine cyclical fluctuations after 1896. Deposits of the group of country banks grew steadily throughout the period, but there was a more rapid expansion from 1887 to 1891, and again from 1894 to 1899.

Fluctuations in the volume of bank credit were very likely greater than is apparent from the crude measures used here. Shifts between current and deposit accounts were probably important over cyclical periods,¹ but accurate determination of the extent of such shifts is impossible. Variations in the rate of interest on deposits seem to indicate that time deposits increased markedly during depressions, but this evidence is not conclusive, because the deposit rate was tied in practice closely to the Bank of England rate.

Currency fluctuations appear to have been the most important forces which caused the bullion stock of the Bank of England to vary over cyclical periods, and induced gold movements on foreign account, although some variations in the volume of bank reserves occurred. Changes in the volume of bank credit undoubtedly brought some changes in the liabilities of the Bank of England, but it does not seem to have been a dominant cause of the fluctuations in the Reserve. The development of deposit banking does not seem to have brought very much slack into the monetary system, so long as the provisions of the Act of 1844 were in effect and the currency consisted largely of gold coin.

(4) Statistics of interest and discount rates are voluminous, but it is not necessary for the present purpose to make precise calcula-

tions of cyclical movements. The main fluctuations are obvious, and the half-yearly averages compiled from the *Bankers' Magazine* are sufficient.

It is evident from an examination of the data in Table XIV and Chart XVI that rates rose during the years of prosperity, and fell off in depression. There was a tendency for the spread between the market rate and the Bank rate to narrow somewhat toward the end of the period studied. And the margin between the market rate and deposit allowances tended to increase. This was due largely to the increased concentration in banking and the cooperation of the joint stock banks with the Bank of England which resulted in keeping the deposit rate low. The market rate was in close accord with the Bank rate during periods of expansion, while in depression the spread increased.

The rates are somewhat misleading, as the Bank charged more for security loans in times of crisis, and it also got a considerable share of the fine bills on such occasions, so that market rates on the average were somewhat higher than the quoted figures for bankers' fine bills, since the latter formed a smaller proportion than usual. But the important cyclical fluctuations stand out, rates being high in periods of expansion and low in depression.

While the statistical data presented are defective in many ways, they do suggest a number of important problems which will be examined later. In the following chapters certain historical material is brought together which amplifies the previous data, and the two types of information are then considered with relation to the theory of international gold flows.

CHAPTER V

THE LONDON MONEY MARKET, 1881–1891

(1) The course of events in the money market is of especial significance in the study of foreign gold movements, for the rates of discount there are one of the primary determinants of exchange rates, which in turn induce specie flows. While too much attention is often paid to such phenomena, and too little to the fundamental conditions of credit and commodity prices, they have an important influence upon cyclical fluctuations of business. Moreover, the historical treatment which follows is particularly valuable in supplementing the preceding analysis of the statistical series, from which it was possible to draw only tentative conclusions because of the inherent defects in the data.

This survey of the money market is based largely upon material appearing in the *Economist* and the *Bankers' Magazine*. Much information is also available in the speeches of the Chairmen of the joint stock banks, however, and these reports have been utilized.¹ While contemporary opinion is not always farsighted, it is helpful in the interpretation of monetary and banking statistics, and especially in the study of trends in banking policy. In somewhat the same way, the descriptions of events in Thorp's *Business Annals* supplements the Thomas index of business conditions, and both have been used in the delineation of phases of the business cycles.

(2) The index prepared by Dr. Thomas shows that the period of revival began with the first quarter of 1881, following the depres-

sion which had existed since 1873, and accentuated by the financial distress after the failure of the City of Glasgow Bank in 1878.¹ Thorp shows the same depression existing from 1874 on, but finds that the revival began as early as the latter part of 1879.² He pictures 1881 and 1882 as years of "mild prosperity," and 1883 as a year of "slow recession."³ 1884 and 1885 are characterized as years of "depression," and 1886 as "depression; slight revival." ⁴ There was nothing of a "boom" at any time, and the period of prosperity was short-lived.

To facilitate the description of conditions during this period, Chart XVII has been prepared. It shows the four-quarter moving averages of external gold movements reported by the Bank of England and the internal movements of gold and Bank of England notes derived from the Bank returns after allowance was made for external movements, the quarterly averages of the bullion stock of the Bank, semi-annual averages of the market and Bank rates of discount, and the Thomas index of business conditions from 1881 to the first quarter of 1891.

Cyclical movements of gold are not pronounced during the first period to be considered. From 1881 to the early part of 1883 there seems to have been more than the normal flow of coin and notes into internal circulation. This was especially marked during 1882, when the movement exceeded that of the preceding year by a considerable amount.⁵ At the same time, there was a net export of gold to foreign countries throughout the earlier part of this period.⁶

In the case of foreign movements, reversal of the flow began early in 1882, under the stimulus of high Bank rates. This was counteracted to some extent by exports in the spring of the following year, when the market had broken away from the control of the Bank of England; but by May the flow had ceased, and the inward movement began again. In the case of internal movements of gold and notes, the seasonal reflux into the Bank during the chief tax-gathering period from January to March, 1883, was

larger than in 1882. In the second quarter of the year the outflow was smaller than usual, but in the third quarter it was greater than in the preceding year. In the fourth quarter, however, there was a return flow to the Bank,¹ in contrast with the last quarters of 1881 and 1882, and it seems evident that the reversal of the outward cyclical flow may be placed near the end of the third quarter of 1883, or possibly somewhat earlier.

The fluctuations of the stock of specie at the Bank of England throw considerable light upon movements during this period. From a high point of £28,119,000 on March 23, 1881, the holdings steadily dwindled away until they were only £18,772,000 on February 1, 1882. The normal return flow from circulation in the spring combined with imports restored the stock to £24,083,000 at the end of the first quarter of 1882, but by November 1, it had again declined to £20,163,000. Despite the influx during the succeeding spring from internal circulation, the holdings attained a maximum of only £23,143,000 on February 28, 1883; and the withdrawals for foreign countries exceeded the accretion from the provinces so greatly that by May 16 the Bank held only £19,858,000, the minimum for the year.²

It is evident that the central cash reserve of England suffered a diminution from cyclical flows during the expansion of business from 1881 to 1883. That movements of more than usual amounts were taking place was plainly apparent to the Bank of England, and the officials made strenuous efforts to prevent undue loss. Conditions in the money market were such that control was exceedingly difficult, and it was not until the early part of 1883 that their efforts were rewarded.

Attention to the impending condition was called by the heavy

withdrawals of gold for Italy and America in August, 1881.¹ The Bank raised its rate of discount to 4 and then 5 per cent, and in October it refused to sell bars.² The exchange finally rendered shipment of sovereigns profitable, and the drain continued. In January of 1882 there was another stringency in the money market, and the Bank rate went to 6 per cent, with a 7 per cent rate for advances. But the rate was effective for only a day or two.³ A crisis in France caused a heavy sale of securities in London, followed by a fall of the exchange and large gold exports.⁴ This movement of gold was reversed shortly, as the market rates in England advanced during the normal spring pressure, and gold flowed to the Bank of England from abroad, as well as from the internal circulation. After May, however, there was little flow either way, and the loss in the bullion stock at the Bank was due primarily to the internal drain.⁵

In general the market refused to follow the Bank during 1882.⁶ At times the Bank was able to control market rates, but only at periods of seasonal pressure, and under the psychological influence

of large gold withdrawals for the Continent.¹ But in 1883 the Bank began to wield more power. In the first two months of the year there was a small inflow of gold under the influence of high Bank rates, even though market rates did not rise to the same height $(1\frac{1}{2}$ per cent under).² But in March and April under a lower rate (3 per cent) at the Bank, gold flowed abroad continuously. By this time, fortunately, the supplies of short-time capital were becoming scanty. This was true not only for the London money market, but for the provinces as well.³ And when on April 26 the Bank announced that it would revert to its old rule of lending to bill-brokers only during the six weeks preceding the end of each quarter, and that brokers were not to rely upon being able to secure loans at other times, it speedily acquired control over the market.⁴ Coin and notes began to return from circulation, and gold was induced from abroad; and the banking crisis was over.

It had been maintained during 1882 that there was no need for a high Bank rate to curb boom conditions in business, and that the only reason for it was the export of gold to foreign countries.⁵ But it has been seen that the foreign loss of gold, except for minor drains, ceased early in 1882. There was a net influx from that time on to May, 1883, despite intermittent net exports for certain weeks. This accretion to the metallic stock of England did not remain in the Bank, but went out to fill the need for currency in the pockets of people or the tills of banks.⁶ Thus the Bank acted

merely as the transmitter of specie from the rest of the world to the pockets of the people of England.¹ This phenomenon is found to a greater degree in the case of later periods of expansion. The movement was comparatively small at this time, since the total cash reserve of England was very scanty in relation to the credit structure based upon it. Relatively slight changes in the requirements of other nations, which brought demands upon the gold market in London, or on the banks, and in the need for hand-tohand currency within England, caused important changes in the gold stock, and compelled the Bank officials to take action to protect the reserves. And this they were able to do, though their control over the market was not complete by any means. Very possibly if the specie stock had been larger, the Bank's action would have occurred much later, and a greater expansion of business would have resulted before it was checked. It is pointed out later that while the Bank rate was not always effective in the London market, it did have important effects, because it was the basis upon which banks of the country made their advances; increases in overdraft rates had more effect upon industrial expansion than did changes in the money rates of the London market.²

(3) During 1884 and 1885 there was a fairly steady movement of coin into circulation, but nothing which could be deemed cyclical in nature. And the foreign flows of specie were not large on balance.⁸ The bullion stock of the Bank was increased somewhat, and the average reserve ratio also rose.

In general the money market was not active on account of the trade depression, and its fluctuations arose largely from external flows of gold. In 1884 there was a flutter when gold was taken for Australia in February.⁴ Later in the spring the panic in New York

caused a serious fall in security prices, and heavy sales to London followed.¹ The movement was so large that it raised exchange rates nearly to the English gold export point, but London discount rates rose and no important movements of specie took place. In December, however, the Bank was forced to raise its rate to 5 per cent, largely because of its failure to act sooner.² But for the most part rates were low and trade quiet during 1884.³

Rates were even lower in 1885 than in the previous year, and the banks found it very difficult to lend at times.⁴ But in the third quarter of the year there was an exceptionally large outflow of gold into the internal circulation, coupled with an external drain, and the stock of specie at the Bank fell rapidly. While the outflow was arrested by the imposition of higher Bank rates, and by borrowing in the open market on the part of the Bank,⁵ the latter found it very difficult to exert control because of the great plethora of liquid capital available.

In 1886, however, movements of gold were larger. Specie continued to move abroad on balance,⁶ but there was a marked diminution in the drain to the country, and for the year as a whole a net influx into the Bank from that source.⁷ The foreign movements were so large as to cause a net decrease in the stock at the

Bank,¹ and the maximum holdings for the year were £22,002,000 on February 24.

The Bank exerted a certain amount of effort to prevent the large exports of gold, and at times acquired some control over the market.² For much of the period, however, it was ineffective, and its policy was severely condemned by the Economist.³ But there is much to be said for the Bank. In the face of the reflux of gold from the interior, control over the market was difficult. The continued depression, with much unemployment, is probably the major explanation of the large flow of gold to the Bank, as coin would be drawn out of small hoards, and ultimately pass into the hands of the Bank of England. There was also a tendency for country banks to send some of their resources to London for investment at this time, and it is possible that coin and notes were drawn to London as a result.⁴ The spread between the average market and Bank rate widened considerably in 1886 and the early part of 1887.

In 1886 the same passage of specie through London as a channel is found as in 1882, but the flow was in the reverse direction. Much gold also passed through London from America to the Continent.5

until the third quarter of 1890.¹ The same conditions are indicated by Thorp,² who marks the end of the period of expansion as November, 1890, with respect to finance, with industry and trade slackening possibly somewhat earlier.³ The index of prices reached its peak in the last quarter of 1889.

Movements of gold were not important in 1887, but in the latter part of 1888 the internal movement of coin became greater with expanding business. It continued in greater amount during 1889 and 1890 but ceased during 1891, and a reflux began, which continued through 1894.⁴ During 1889 and 1890, there was a large net influx of gold into England from abroad. The movement to the Bank of England ceased after 1891, and not until 1894 did it become important again.⁵

In 1887 the flow from the country to the Bank ceased. The Bank was somewhat better off with respect to foreign flows than in 1886, but its specie stock declined somewhat during the year. In 1888 an important internal movement began, under the impetus of business revival. The Bank was forced to take strenuous measures, especially in the fall of the year when Bank of England *notes* were taken for Russia,⁶ and withdrawals of cash were made by country banks to strengthen their till reserves after the failure of a local bank.⁷ By the first week in December the stock of metal at the Bank had fallen to only £18,304,000, and the Bank sold some of its government securities in an attempt to induce gold imports.⁸

In 1889 the internal drain of coin continued, but large acces-

sions of gold were received from abroad.¹ At the end of the summer, the Bank secured control over the market, largely by the sale of Treasury bills and Exchequer bonds. These issues were extraordinarily large in amount, as they were needed to pay off some of the old 3 per cent Consols which were not converted under Goschen's scheme.² And the Bank was able to make higher rates effective, especially as there were small shipments of gold to South America on account of loans, and the market became frightened.³ For a time in October the release of dividends brought low market rates, and the Reserve of the Bank dropped very low; ⁴ but there was some improvement toward the end of the year, as assurance was given by financial houses that rather than allow an international war of rates which would result from advances in the Bank rate, they would go to some expense to bring gold in. Russia was the source for most of the gold finally secured, and it was believed that it was parted with because the Czarist government was desirous of paving the way for a conversion loan of £50,000,-000.⁵ In the last month of the year the market was short of funds, probably because of borrowing on the part of the Bank.⁶

(5) There was a heavy drain of gold into circulation during most of 1890, and for the most part specie was imported, especially when the plight of the Barings became known to the Bank,

and it secured a large amount from France and Russia. In the money market conditions were chaotic. Throughout a large part of the year the Bank was able to exert a considerable amount of control over the market, as funds were becoming scanty. But there were intermittent periods when bill rates fell substantially below the Bank rate, and gold exports followed.

In January the Bank put up its rate to 6 per cent, and its charge for advances to 7 per cent.¹ The bullion stock at the Bank was very low at this time, due in part to the heavy demands for cash at Christmas, and in the early part of January for the payment of dividends.² The reflux of currency to the Bank during the first quarter of 1890 was larger than in 1888 and 1889, owing to the extra heavy withdrawals in the preceding year.³

The Bank retained control during the winter quarter,⁴ despite

He an increase in the fiduciary issue on February 8th.¹ But in May and June the market broke away, and some gold was exported to the Continent.² Control was again secured in June, as the market was short of funds, and the stock exchange settlement at the end of the month was so large that it necessitated loans from the Bank at 3¹/₄ or 4 per cent.³ This 4 per cent was an unusually high rate for July, but it went even higher at the end of the month in order to acquire gold from America. The passage of the Sherman Silver Bill brought gold imports from the United States, and the Bank took advantage of the opportunity of securing some of it.⁴ Some gold was lost abroad during September, and there was a drain to the provinces, so that the stock at the Bank was reduced to only £10,137,000 on November 12, 1890. But the financial uncertainty preceding the failure of Baring Brothers had caused the Bank to take extraordinary measures to secure gold. £2,000,000 was borrowed from the Bank of France, through the good offices of the Rothschilds, and £1,500,000 was procured from Russia by the sale of bonds.⁵ By the time the condition of Baring's became known, the stock at the Bank had been augmented considerably. and the action of the banks in subscribing to the guarantee fund kept the crisis from developing into a monetary panic.⁶ The

specie stock at the Bank increased, for the most part, during the succeeding weeks. In December some withdrawals were made for America, as a partial crisis occurred there,¹ but the Bank was able to avert any serious loss, and its position remained strong.

(6) During the early months of 1801, the exports of gold were large, as it was necessary to return the loan of the Bank of France. But in the second quarter the Bank secured a large amount. While it lost some specie in the last two quarters, its stock never fell below £22,000,000, with the exception of one week; a vastly better showing than in the preceding year. The large influx in the late spring was the result of an increase in the Bank rate, and a rise in the buying price for gold at the Bank.² The Bank was affected largely by foreign movements, especially the flow from the United States in the spring, and withdrawals for Austria-Hungary, which desired gold in order to resume specie payments.³ Hence the Bank was forced to rebuild its bullion stock several times during the year. But it was able to exert control over the market much of the time. This was due primarily to the fact that the joint stock banks kept larger balances with it after Viscount Goschen's speech at Leeds in February.⁴ The effect of this in-

crease in the balances of bankers was to cut down their funds available for loans in the money market. The Bank had the use of the funds, and it could, and did, lend them in part, much to the chagrin of the banks.¹ But it could determine the rate, and thus control the activities of brokers to a greater extent than before. At one time the Bank succeeded in enlisting the support of a number of the joint stock banks in an attempt to bring up market rates, and these banks refused to lend at less than 4 per cent for a short period. It was impossible to maintain that rate in the market, and the trial was given up;² but it indicates a willingness upon the part of some of the banks to aid the Bank of England in a rather trying period.

Large movements of gold into circulation continued during the last quarter of 1890, and the seasonal reflux in the spring of 1891 closely approximated that of the preceding year in magnitude, though that had been unduly large.³ But the usual outflow of gold from the Bank during the second quarter of 1891 was only half that of 1890, and the outward movement in the third quarter was very much smaller than the flow in the previous year.⁴ In the case of gold and Bank of England notes much the same thing was

found, though here the outward flow in the second quarter was equal to that of 1890, and did not fall off until the third quarter of the year.¹ There was a noticeable increase in the notes of the Bank outstanding between 1890 and 1891,² and there was some expansion in the outstanding note issue of provincial banks. Very likely the movement of country bank notes into circulation compelled the provincial banks to substitute Bank of England notes as till money.

(7) Throughout this period of expansion from 1886 to 1890 we find the same type of gold movements that were found in the previous one from 1881 to 1883. There was a large drain of specie into internal circulation, but an almost equally large influx of gold from abroad.³ The latter commenced in 1889, very shortly after, the internal drain began. And it did not cease until the crisis had been over some time. The internal flow was abated during the second quarter of 1891; but the Bank was not subjected to any real drain after the opening of the year 1891, for it received back a normal seasonal amount of coin from January to April, and withdrawals were not heavy after that time.

The Bank again acted as the agency for procuring the necessary gold from abroad to fill the pockets of the people of England.

"The inference, of course, must be, that both amounts were absorbed in the circulation of the country, owing to the improvement of trade, and evidence from the same sources would also prove that the same process is still going on."

The lesson which is drawn is that it is futile to resort to high rates to prevent what is not likely to happen under low rates, i.e., the export of gold. For such rates are a burden on business. The real remedy is to advance the price of gold when it is needed badly. *Economist*, June 13, 1891, pp. 365-366.

It was under a greater handicap than in the early eighties, for its stock of bullion was considerably smaller at the beginning of the period of expansion. Thus it was forced to take measures to protect its stock of specie even when internal industrial conditions were not "booming" by any means. And this action was responsible undoubtedly, to a large extent, for the lack of a panic in 1890.¹

CHAPTER VI

THE LONDON MONEY MARKET DURING THE DEPRESSION OF THE NINETIES

(1) The present chapter continues the survey of conditions in the money market from the Baring Crisis to the Boer War. Movements of gold and currency, discount rates, and fluctuations in the index of business are shown in Chart XVIII. The series plotted are the same as those used for Chart XVII in the preceding chapter. Reference to the chart shows that the depression following the crisis of 1800 lasted until the second quarter of 1805. according to the Thomas index. There was a slight upturn in the index of business in the early part of 1894, but the index of prices continued to fall during that year. The revival beginning in 1805 lasted until 1900, although there was a decline in 1897 in the Thomas index.¹ Thorp dates the revival during the latter part of 1895, and classifies 1897 as prosperous, despite poor conditions in the textile industry.² For a part of 1900 the increased demand for war materials for the conflict in South Africa stimulated business. but rising prices and discount rates brought a decline in production and an increase in unemployment. The issue of large blocks of government securities was responsible to a considerable extent for the draining of funds from the market and the consequent high discount rates.⁸ The index of business conditions reached its peak in the first quarter of 1900, a year before the close of the war.

During 1892 and 1893 internal movements of gold and notes were not large, and the Bank of England gained from the public circulation on balance. Foreign movements of gold in the quarters of the two years were offset almost precisely by counter movements in other quarters, and there was no important net flow either into or out of the country, according to the Bank of England returns. During 1894 and 1895, however, the internal movement of gold and notes from the Bank became more impor-

tant, and imports of specie from abroad were very large. The internal flow subsided somewhat in 1896 and 1897, and some gold was exported on balance. From 1898 to 1900 the internal movement was greater, and gold was imported from abroad.

During the years from 1891 to 1894 the imports of gold reported by the London Customs House were much larger than those reported by the Bank of England. The Bank reported net imports of £8,500,000, while the Customs House reported net imports of £21,000,000.¹ The Bank's stock of bullion increased from £23,466,000 on December 31, 1890, to £33,091,000 on January 2, 1895. It was higher than this latter figure at intervals during the period, reaching nearly $\pounds_{40,000,000}$. The estimates of the gold circulation in the hands of banks and the public indicate an increase of £2,500,000 during the three years from 1892 to 1895.² in spite of the reflux of gold to the Bank shown by the statistics derived from the Bank returns. The increase of £10,000,000 in the Bank stock, plus an increase of £2,500,000 in circulation, leaves some £9,000,000 unaccounted for, using the Customs House figures for imports. The figure may be even larger if there was a reflux from circulation. Industrial consumption can hardly account for this sum. There was much less gold available from imports for industrial uses in the eighties, and industrial requirements might well have been less during the depression years after 1800 than in the years immediately preceding the crisis. Hoarding of gold or unreported additions of specie to the stocks of the joint stock banks may be the explanation for the large excess of imports over increases in monetary stocks for which information is available.8

(2) The years following 1890 are of peculiar interest, as the depression was very prolonged. The cheapest money rates in London seemed to have no effect in starting a revival, and rates of less than $\frac{1}{2}$ of r per cent did not stimulate trade.⁴ Of course, rates charged to most borrowers were much above these low rates, but some reduction occurred in loan rates generally.

During the spring of 1892 the Bank had little control over the market,¹ except at the end of March.² Despite the low rates, the movement of gold from England was not great. There was a tendency for the arriving parcels from mining countries to be taken for the Continent, but there were no large withdrawals.³ In the second quarter there was no need for Bank loans even at the stock exchange clearings.⁴ Despite the low discount rates at this period, gold poured in in considerable quantities,⁵ and the stock of bullion and coin at the Bank showed an increase. Later in the fall, however, there was a rise in the Bank rate, as gold was taken for Austria, and Russia began to compete for some of it.⁶ Market rates followed, and it was believed that the Bank was in position to prevent any important loss of specie.⁷

One influence operating to bring coin to the Bank after 1891 was the recall of light coin by the Mint. Under the Act of 1888 only pre-Victorian coins were called in, but now all lightweight money was subject to recoinage. The coin was sent in by banks generally during the following years, and lodged first at the Bank of England. In the case of country banks it is probable that new coin was sent very quickly to replace the shipments, but in the case of the London banks it is likely that a transfer of reserves from their tills to the Bank occurred.⁸ It was maintained that part of the loss of control over the market by the Bank was due to this increase in its gold reserve.⁹

126 BRITISH INTERNATIONAL GOLD MOVEMENTS

The year 1803 was more difficult for the Bank, for a severe crisis occurred in the United States, and the Austrian. Government was attempting to build up a reserve of some £20,000,000 in order to safeguard the adoption of the gold standard.¹ In Tanuary exports of specie to France brought about a rise in market rates for money in England. These were induced by the efforts of French banks to strengthen themselves after the Panama scandals had become public; and the supplies were secured by the sale of securities abroad. The limit of note issue at the Bank of France was quickly reached as it extended its issue, and while the limit was soon raised, the momentary stoppage of emission seems to have checked the flow of gold from England.² During the early months of the year the export of gold from America supplied most of the Continental demands, though some gold left England for South American harvest needs.³ In general the London money market was easy during the spring quarter,⁴ though in April there was somewhat of a scarcity.

The second quarter of the year was marked by large gold imports, especially in June. But there was an important influx of currency into the banks of England, particularly those outside of London, due to the fears engendered by the Australian banking crisis which began in April. The stock of bullion and coin at the Bank fell considerably, and the Reserve even more, as notes were also drawn out of the Bank.⁵ The Bank rate was advanced to 4

"There is nothing unusual in an efflux of cash into circulation between the middle of March and the middle of May; but, since the alarms which folper cent in the middle of May, and market rates on the best bills were above this rate for a time, standing at $4\frac{1}{2}$ per cent.¹ These rates were very effective in inducing imports of specie, especially as gold was flowing from the United States as more silver was injected into the circulation.² A return of coin and notes from circulation set in, and the Bank Reserve and metal stock increased greatly, this being followed by a slackening of money rates.

But this decline was ephemeral, as Continental demands set in, and the breaking of the American crisis brought heavy gold exports to the United States. Some £4,000,000 was shipped from the Bank of England during the first two weeks of August.³ "The Continent has furnished some supplementary supplies, but — as usual with a sudden drain of gold — the Bank of England has been called upon, first and most largely, to supply it." ⁴ With high money rates in England, there was a quick reflux, and by the end of September the stock at the Bank was largely restored.⁵ Moreover, by that time the American panic was over and cash was returning to New York from the interior, instead of going to banks in the West as usual in September.⁶ During the remainder of the year, the London market was quiet, and there were no important movements of specie.⁷

(3) 1894 and 1895 were marked by a most extraordinary stagnation in the money market, and by heavy gold imports. Only in the last quarter of 1894 was there a net export balance.⁸ The

Bank rate was at 2 per cent from the last of February, 1894, until September, 1896. But market rates were far below that rate, and bills were discounted at times as low as $\frac{1}{4}$ of 1 per cent. It is remarkable that such low rates did not induce specie exports; but money was almost equally cheap in foreign centers.¹ As England was lending relatively little to other countries at the time, the annual interest due her brought large payments, both in specie² and in goods. The latter contributed to the fall of prices and caused domestic producers much woe.³

During the early part of 1894 the Bank had some power over the market, but it refrained from inflicting any restrictive rates.⁴ Money rates continued to be low and the banks complained that money was almost unlendable much of the time.⁵ For the remainder of the year the Bank was out of touch with the market entirely, and at times the rates on the best short-time bills dropped below the deposit rate of the banks.⁶

Not until the latter part of 1895 was there any important change.⁷ By that time a renewed activity was taking place on the stock exchange, and the banks loaned important sums for the settlements, and also purchased more securities themselves.⁸

And the operations involved in the payment of the Chinese indemnity locked up some £13,000,000 in the Bank of England.¹ These funds were expended during the following year, but for the moment the market lost control of the amount. Toward the end of the year discount rates in foreign countries began to advance, as a result of panics on the stock exchanges, especially in Paris and Vienna, and political scares arising from eastern Europe.² While the spring of 1896 witnessed another stagnant market, conditions were not as bad and did not continue so long as in the two previous years, and the money market may be said to have passed its dullest point with the summer of 1895.

The period from 1881 to 1891 was a difficult one for the Bank on account of the slender gold reserves of the country. The stagnation in business during the early nineties brought relief, and the great increase in the holdings of the Bank during 1894 and 1895 entirely changed the situation. The stock of specie at the Bank was enlarged, and it attained a maximum of some £49,000,000 on February 26, 1896. The large London joint stock banks began to hold larger balances with the Bank, and it is possible that they acquired some stores of gold of their own beyond till money requirements. The amalgamation movement in banking had concentrated banking power in fewer hands by this time, and the problem of control by the Bank of England was simplified to some extent. The Bank was in a much stronger position in 1896 to meet the demands of the revival in business than it was a decade earlier.

Internal flows from the Bank in response to trade needs were large from 1897 to 1900, but there was a marked break in the movement following the culmination of the prosperity phase of the the cycle similar to that found in former periods of decline. In this instance there was no important reflux of gold or notes to the Bank, but the outflow was completely abated. Internal movements were not important thereafter until the beginning of the drain which preceded the crisis of 1907.¹

The heavy drain of gold to America, which has been noted above, arose largely from a remarkable change in the trade balance of the United States.² Not only was gold taken from the Bank of England, but for a period of eighteen months all the market arrivals were sold for foreign account.³ In addition to the American demand, gold was desired by Japan to serve as reserve for its new gold standard. Some of the indemnity money paid to it by China — in London — was withdrawn in the form of specie, though most of the receipts were expended on ships and other capital goods in England.⁴ Other demands for gold were made by Continental nations as usual.

Rates of discount in 1896 were little higher than in 1895, but by the end of 1897 the Bank was forced to take action. In October the rate was raised to 4 per cent. More important, however, was the action taken to make the rate effective in the market. Although the average rate of the Bank was no higher in 1897 than in 1896, market rates on the average were higher, and approached

more closely to the Bank rate.¹ This result was achieved largely by the increased discounting of bills by the Bank. There is some evidence to show that the Bank adopted a more energetic policy in this respect, not only at the head office, but at its branches as well.² It adopted two important changes in its policy in this regard. In September, 1807, it announced that it would now discount bills having a usance of 90 days.⁸ The previous limit had been 60 days. And in December the Bank relaxed its old rule of not lending for periods of less than a week, and granted three-day loans.⁴ The discounting of bills for relatively long periods brought forced ease to the market at the time of discount, but the maturing of the bills during the late fall of 1807 and the spring of 1808 helped the Bank in its efforts to control the market. In addition to its discounting policy, the Bank resorted to the older methods of borrowing for a month on Consols, and on other Government securities.5

Throughout the years from 1898 to 1900 the Bank continued to enforce its will upon the market as best it could. Its rate was advanced from time to time, and despite intermittent periods of

guided largely by the action of the Government.¹ The Bank wielded more power through its control over the large Exchequer balances, and its control was aided by the natural fear and hesitancy on the part of bill brokers and other lenders during war times.

(5) The internal drain of coin was large during 1808 and 1800. and the efflux from the Bank continued well into 1900. References to the increased use of cash in the provinces on account of the expansion of trade are to be found at this time.² And banks operating in both the country and the city of London found that the demands for advances in the interior required more of their funds, and they were forced to withdraw balances from Lombard Street as a result.³ As a consequence, the heavy imports of gold in these years made little impression on the Bank stock of gold.⁴

Not until 1901, when the internal drain had ceased, did the holdings of the Bank increase, except for the usual seasonal fluctuations.¹

It was indicated above that the height of the prosperity phase of the cycle was reached during the first quarter of 1000. The internal drain of coin continued, however, throughout the year. Not until the last quarter of the year was there a change. While the outflow did not cease at this period, there was a marked diminution as compared to 1800, and the influx in the spring of 1001 was nearly twice as great as that of the preceding year.² It is evident that the change in the direction of the cyclical flow came some nine months after the expansion of business had reached its peak. The return flow to the Bank from circulation was not marked at any time, however, and from the standpoint of central reserves it is important to notice that the normal secular increase in internal currency needs, coupled with the slow decline in business transactions, prevented any augmentation of the Reserve of the Bank of England from the circulation of the country.3

(6) One other aspect of the international situation in this period is of interest. There was a unanimity of opinion at that time that a large and important transfer of securities from Europe to the United States was taking place. The American trade balance was very favorable at this period, and it was believed that instead of taking gold in payment of the balance, securities sold in Europe previously were being repurchased in the United States.¹ In the summer of 1900 part of a British Government loan was floated in New York — a remarkable occurrence from the standpoint of British finance.² And during the fall of 1900 large amounts were temporarily loaned to England by the United States and Continental countries for a short time by the purchase of bills of exchange, or by holding bills until maturity instead of discounting them in London as usual.³

The security market in London was upset in May, 1901, by the refusal of some of the joint stock banks to lend after the collapse of the American stock market following the corner in Northern Pacific stock.¹ From the viewpoint of the London market this was only one of the minor circumstances which compelled the market to borrow at the Bank of England. CHAPTER VII

THE LONDON MONEY MARKET FROM 1902 TO 1913

(1) In the period between the Boer War and 1013, the problems encountered by the Bank of England in controlling the money market became more complex. The preeminent position of England in export markets was threatened by Germany and the United States, and the pressure exerted at times by movements of foreign balances became important. On the other hand, the position of the Bank in relation to the market was strengthened by the further progress of the amalgamation movement, and by the establishments of new relations between the Bank and the joint stock banks. The accumulation of gold stocks by some of the banks, however, placed them in a more independent position, and threatened the position of the Bank of England to some extent.

The recession beginning in 1000 continued until the middle of 1904, when a revival began which lasted until 1907.¹ The lowest point marked by the Thomas index is the third quarter of 1904, and expansion commenced thereafter, and continued steadily until the middle of 1907.² Thorp designates 1904 as "depression; revival," and sets the beginning of revival during the last quarter of the year.³ The Sauerbeck index of prices also turned upward during the same period.⁴ The crisis of 1907 came in the late summer, but the succeeding depression was short-lived. It reached its lowest ebb in the last quarter of 1008, and revival began during 1909.⁵ There was a momentary halt during 1911, occasioned chiefly by the important strikes of that year, but no real decline began until the latter part of 1913.6

During the years of expansion from 1905 to 1907 there was an important drain of gold from the Bank into circulation. During

the depression of 1908 there was a small reflux, but the heavy internal flow began again in the latter part of 1908. Except for a lull in 1012, the internal drain was heavy until 1014.¹

During 1904 and the early part of 1905 there was a marked influx of gold from abroad, and the Bank stock was large in the spring of 1905. During the summer of that year, however, a large foreign drain commenced, and the Bank was forced to take action.² For 1905 there was little net movement at the Bank, but in the two following years the flow was heavily inward. The stock of bullion, however, declined somewhat,³ and the imported gold clearly went into circulation or into the hands of banks.

(2) Considering the lack of gold imports from abroad, at least on the scale of the previous years, and the failure of coin to return in large quantities from the provinces, it was only to be expected that the Bank would attempt to retain control over the money market throughout 1901 and 1902. The heavy issues of Government securities aided, since they helped to drain the market of funds. Moreover, the new Parliamentary powers granted to the Chancellor of the Exchequer in September, 1902, enabled him to borrow in the market rather than at the Bank to meet deficiency advances if he chose.⁴ When he chose the former course the funds were taken from the market in the first place, and the control of the Bank was increased to that extent.

As a result of these various factors the Bank was able to temper the course of the market for most of these two years.⁵ It did not

attempt to abuse the power and charge high rates on advances, and there was no real stringency at any time. At the end of each quarter borrowings at the Bank were heavy, and there was considerable lending by that institution between the usual days of stress at the ends of quarters. While imports of gold were not heavy, the stock of bullion at the Bank was fairly high, and there was no need to inflict high rates of interest. Furthermore, in the interest of the Government, which was still doing much borrowing, such rates were inadvisable.

During 1903 the Bank was forced to take action to protect its bullion stock. Conditions elsewhere in the world, particularly in the United States, were calculated to bring a demand for gold from England. The Bank raised its rate several times, and endeavored to make it effective. In addition it raised its buying price for gold bars to increase its holdings when its rate did not succeed in bringing gold to it.¹ But in general it was not as successful in its control as in the years immediately preceding.²

the industrial expansion outside.¹ Despite the increased demand for funds, it was necessary for the Bank to borrow heavily in October to make its rate effective, and stop the loss of gold.² In September it had raised its rate to 4 per cent, and this was continued in force throughout the rest of the year. In December the rate on advances was raised to 5 per cent.³ The situation at the time was precarious due to the paying off of some £14,000,000 of Treasury Bonds, and market rates fell off to as low as 3 per cent for fine bills. The Bank's reserve was endangered by the consequent fall of the French exchange, and the Bank took a new departure and asked the principal clearing banks to co-operate with it by taking surplus money off the market, and increasing their deposits at the Bank thereby.⁴ This method was followed again in January, 1906,⁵ and the Bank rate was made effective, bringing up market

rates and raising the French exchange from the gold export point.¹

During 1906 the Bank reserve fell until it reached the danger point in the fall, and the Bank was forced to take drastic action.² Although the Bank had begun to raise rates during the latter part of 1905, the internal drain was so severe that it was impossible to retain a large stock of bullion and coin at the Bank. It was pointed out at the time that a rise in the Bank rate should have occurred during the late summer of 1906. The United States had been borrowing large funds in England by the drawing of finance bills,⁸ but, due to the dilatory action of the Bank, these bills were renewed in the early fall instead of being paid off.⁴ And the Bank was finally forced to act in a more severe manner than would otherwise have been the case.⁵ Its rate was advanced to 5 and then to 6 per cent in September and October, which created a

scare on the money market. Continental rates were also high at the time, and relatively little gold was secured from abroad until late in the year. It was feared that the Bank rate would be raised to 7 per cent, since little specie was acquired under the 6 per cent rate, and Continental countries, particularly France, began to release gold for export.¹ This situation continued into 1907, with America hesitant about drawing gold, knowing that it would mean a higher Bank rate.²

The English crisis was hastened by the outbreak of the severe American panic in the late fall of 1907.³ At the time the Bank of England had control over the London market,⁴ and it speedily ad-

vanced its rate to 6, and then to 7 per cent, and market rates rose with it. The situation was more difficult than in 1006, largely because few American finance bills were held in London at the time. The admonitions of the Bank of England in the fall of the preceding year kept the discounting of such paper to a minimum in 1007.¹ Consequently, no gold had been drawn to the United States earlier in the year,² and the full weight of the American demands for gold were concentrated in the weeks following the outbreak of the panic. From the standpoint of the United States this was advantageous, for the receipts from crop shipments did not have to be applied to the repayment of finance bills, and the heavy remittances necessitated brought gold from England.³ Large shipments of gold to New York during November and December occurred when the exchange in New York on London was actually above the gold export point of normal times. The high rate of exchange was due to the premium on gold in the United States,⁴ and the effective rate was below the gold import point when allowance was made for the premium.

The immediate effect of the American panic was to draw specie from England; but the advance of the Bank rate to 7 per cent brought gold to London from other countries, and England became a clearing center through which gold passed from the rest of the world to the United States. The Bank of England lost little gold as a consequence: the net export for the fourth quarter of 1907 amounted to less than one million pounds, and a net gain accrued to the Bank in the first three quarters of the year.⁵ This achievement was heralded as the acme of success of the English banking system under the Act of 1844.⁶ But in fact, the Bank rate of 7 per cent drew gold only because of the action of the Bank of France and the Reichsbank in permitting specie to be drawn from their hoards.⁷ When account is taken of the sums drawn from these two countries, the amount unearmarked from the Indian account at the Bank of England, and the newly arriving gold

from mining countries, the receipts from other countries are found to be very small.¹ In other words, the high Bank rate brought gold merely because the two Continental banks preferred to aid the Bank of England, rather than suffer higher discount rates in their own countries.² Otherwise, the English Bank rate might have had to go to untold heights to keep their Reserve up, and the trade of the country would have suffered severely.

(4) Immediately the panic in the United States was ended and cash payments renewed, the Bank rate was lowered and conditions in London became easier. Coin began to return from the provinces in 1908.³ The flow of cash into the Bank from the in-

An examination of the English statistics substantiates Lee's results in general. ternal circulation was large in the first quarter of the year, and the outflow from the Bank in the second quarter was about as usual. In the third quarter the usual efflux was reversed, and the Bank gained gold from the country circulation. The influx was shortlived, however, and the Bank showed only a small gain for the year. By 1000 the heavy flow of gold into circulation was again apparent.¹ It is probable that the joint stock banks intercepted much of the returning coin and kept it in their own vaults during this year, for they had begun to accumulate large sums irrespective of the holdings of the Bank of England.² This factor helps to explain the small gains of the Bank of England during the year. It is apparent again during the period of expansion and crisis that the Bank gained gold during prosperity from other countries, but that its new supplies were taken by the country to add to the circulation. It is also clear that the reflux to the Bank began shortly after the crisis. Due to the action of some of the joint stock banks. the Bank of England did not receive as much of the return flow as in earlier cycles, but it is significant that the reflux began more quickly than in other cases.

All during 1908, aside from the first quarter, the Bank tended to lose gold on foreign account. Much of the gold sent to the United States in the preceding fall was returned directly to Europe; but England loaned large sums to Continental countries, and it was unable to acquire the gold arriving weekly from South Africa as a consequence.³ For a period of nearly a year from April, 1908, the Bank did not purchase any bar gold in the market.⁴ This heavy movement of gold to the Continent ceased with 1909, and the position of the Bank was improved. The exports from England were made possible by the market arrivals, and by the return of coin from the country, in addition to the unearmarking of some $\pounds_{2,000,000}$ more from the Indian balances at the Bank.⁵ But the

Bank stock did not decline, and tended to increase slightly during 1908, despite the European demands.

During 1008 the American crisis showed its effects in Europe. The resulting trade depression in England affected the operations of banks, and a decline in profits was suffered, particularly by the London banks.¹ Those in the provinces were able to keep their earnings up longer, as usual, and banks operating in both sections found that business in the latter regions was of substantial aid.² The half-yearly dividend period at the end of June was passed easily, and there was much less borrowing from the Bank than in previous years.

(5) During the early part of 1000 there was a wide difference between the Bank rate and market rates of discount.³ It was necessary for the Bank to take action later in the fall as a consequence, and it raised its rate to 5 per cent in October and began to borrow in the market to make it effective. The immediate cause for the advance was the large export of specie due to very heavy lending to foreign countries, especially the United States.⁴ The Bank also raised its buying price for gold bars, but its operations were only partially successful.⁵ It fared better in the following year, however, and the imports during the third guarter of 1910 aggregated over £11,000,000. The autumnal demands took a considerable part of the new gold, and the Bank was forced to take action. The Bank was tardy in checking the fall of money rates in the first half of the year, and it was called upon to take severe action in the latter half of the year.⁶ In 1911 the Bank raised the

rate in March, which was only the second time in the history of the the Bank that the rate had risen during this month.¹ Despite intermittent losses, the Bank tended to gain gold from abroad during these years from 1909 to 1913.² Its problem was made more difficult by the large accumulations of gold which were being made by the central banks of the Continent, particularly Germany and Russia.

Nevertheless, the Bank did gain some gold for its stock, and the gain would have been great if it had not been for two internal factors. The first of these was the large withdrawal of gold into internal circulation and the arts on account of the expansion of trade and industry.³ This amount was large in all years up to the beginning of the War in 1914, and contributed greatly to the depletion of the Bank stock. The second factor was the large accumulation of gold in the vaults of the large joint stock banks.⁴ This gold was secured either from incoming supplies, which might otherwise have gone into the Bank store, or by intercepting the normal seasonal return of coin to the Bank.

One other aspect of the international situation is of interest. At several times during this period gold imports into England were induced, not by the actual rates imposed by the Bank, but by the fear of higher rates that might be imposed. It will be recalled that in the fall of 1906 and of 1907 the Bank of France began to purchase sterling bills and to pay for them in gold, for fear that the Bank of England rate would be raised to 7 and 8 per cent, respectively.⁵ The same procedure was adopted again in 1910 and in 1913. In these latter cases there appears to have been an

agreement made at the time that the bills would be repaid with gold on reaching maturity.¹ In other words, the Bank of France was willing to let gold go temporarily to avoid any disturbance in the French market, but they were not willing to lose the specie permanently. It seems clear that they were to that extent becoming the central bank for England as well as France, and were permitting the use of their bullion stock because the English system was not competent or willing to take care of seasonal and other needs.

(6) Two important developments occurred in London during the period after 1901. The first was the general agreement on the part of London joint stock banks not to loan day-to-day money at less than the deposit rate of interest.² This was an important change, for it removed some of the extreme fluctuations in the London money rates, and gave greater firmness to the money market.

The second innovation was the commencement of conferences between the joint stock banks of London and the Bank of England. It was agreed that one meeting in each quarter of the Committee of the London Clearing Bankers would be held at the Bank of England.³ This was an important development as it meant closer co-operation would be evidenced between the Bank and the important joint stock banks.

(7) During 1912 and 1913 the stringency in the London market was severe, and resort to the Bank was made throughout most of the months. The trade activity, with resultant flows of cash and of loanable funds — which would otherwise have been lent in the London market — to the provinces was the most important factor; but the accumulation of especially large Government balances in 1912 also contributed. In the latter case, the large

surplus was not expended in purchasing Consols for the Sinking Fund, but was held at the Bank on deposit.¹ The Chancellor was subjected to much criticism for his policy in this regard. The market was forced to go to the Bank for funds which would normally have been supplied by the release of Exchequer money. There was no such locking up of Government money in 1913, but by that time the political difficulties on the Continent had invoked a spirit of caution into the market, which had been lacking until late in the preceding year. The Bank had raised its rate to 5 per cent in October, 1012, and it was not changed until April of the following year.² But rates continued high in 1013 on the average. and the Bank of England had a fair amount of control taking the vear as a whole.³ The bullion stock remained at a reasonable level, however, due to imports of specie, partly through the purchase of the newly arriving gold, and partly because of receipts from South America.4

During the period from the Boer War to 1913, the increase in gold reserves of the larger joint stock banks gave them somewhat greater freedom from the Bank of England. To the extent that they held excess reserves of gold during ordinary times, they had become small central banks. But it is apparent that in periods of stress, at least, they were more willing to co-operate with the Bank of England in bringing the money market under control than they had been earlier.

The more important developments in the relations of the Bank of England to the money market and the banking system are considered in the following chapter. The changes have been mentioned in the chapters on the money market, but they are brought together for purposes of analysis.

CHAPTER VIII

RELATIONS OF THE BANK OF ENGLAND TO THE MONEY MARKET AND THE BANKING SYSTEM

(1) In the middle of the nineteenth century the Bank of England was the leader in the money market principally because it always supplied a portion of the supply of funds seeking investment. Sykes quotes the Bankers' Magazine of 1863 as follows: "Bankers merely look to the Bank of England returns, and tacitly follow in the wake of that establishment."¹ He goes on to say: "The Bank of England was then so strong that it could have absorbed all the other London banks, their capitals and their reserves, and yet its own capital would not have been exhausted."² And he calls attention to Bagehot's well-known quotation that: "At all ordinary times there is not money enough in Lombard Street to discount all the bills in London without taking some money from the Bank of England." 3 And Feavearyear maintains that at times the competition of the Bank for bills was responsible for the forcing down of market rates. Except when the Bank had to protect or add to its Reserve, Bank rate and market rate were held close together by this competition.⁴

But after 1857, and especially after 1866, the policy of the Bank with respect to discounts was gradually altered. This change came in part because of the growth of the London joint stock banks, and the increase in the capital available for lending in the hands of private banks and discount houses, and in part because of the lessons learned in the crises of 1847, 1857, and 1866, and the repeated strictures of Bagehot on the necessity of keeping adequate reserves for any emergency. In 1878 the Bank definitely accepted the new situation when it announced that it would no longer lend to bill brokers at the market rate, but would restrict

discounts at that rate to its regular customers only, when market rate was below Bank rate.¹ The Bank rate consequently became completely ineffective except for certain periods, and it no longer was the governing rate at which the best bills were discounted.²

There were generally periods within each year when the rate was effective, and occasionally the influence of the Bank was felt over longer periods. Within each year the market was normally bare of funds when there were heavy payments to be met on account of dividends, especially at the end of each quarter. This phenomenon was especially pronounced in the first quarter of the year, for at that time the collection of taxes swept large sums of cash and deposit credit into the Bank. The same situation sometimes prevailed when internal drains of coin or notes for holiday or harvest requirements were exceptionally large.³ Any large shipment of gold from the Bank to a foreign nation always brought strong psychological, as well as mechanistic, forces to bear upon the market, and was likely to cause an upward movement of mar-

ket rates.¹ Most important of all were needs resulting from the expansion of business in the periods just preceding crises.² Only in the last case was it necessary for the market to resort to the Bank for loans over any extended time.

By 1881 the Bank had learned to alter its discount rate in a systematic manner in order to control gold flows; and the state of its Reserve was the criterion upon which discount policy was based.³ It had accepted tacitly the doctrine that changes in money rates would ultimately affect commodity prices and industrial production, and readjust the international balance of trade. Moreover, it had discovered that rate increases stopped foreign drains of specie and enabled the Bank to maintain a stronger reserve position, although the full significance of this causal con-

nection was not appreciated. The primary machinery of the discount policy was supplemented later in the century only because of the altered relation of the Bank to the London money market. The price-specie flow mechanism, supplemented by use of the discount rate, was felt to be adequate for the adjustment of the exchanges, the price level, and the international balance of payments.¹

The lack of power over the market at times, however, compelled the Bank to resort to other means than the discount rate to obtain the necessary control. The policy with respect to gold also changed somewhat, due to the deficiency of the reserves. We shall turn to this latter question before examining the problems of discount rates and open-market operations.

(2) Even in the earliest years of the period studied the Bank raised its *selling* rate for bullion,² and its prices for foreign coin were also subject to change. But such changes were not so common as in later years. The first instance which I have found of a change of policy with respect to the *buying* rate for gold bars was in 1890;⁸ and during the Baring Crisis period the Bank pursued a definite policy of control in order to secure gold. But from 1892 to 1898 there does not appear to have been any increase in the

buying rate for gold bars at the Bank. In the latter year, the rate was raised above 77s. 9d.,¹ and from that time on the Bank frequently purchased bullion at prices ranging up to 77s. $10\frac{1}{2}d.^2$

The Bank instituted a policy of interest-free advances to importers of gold in 1898.³ This aid was granted very infrequently, however. The Bank also adopted the plan of paying bullion dealers in light coin — within the limits of the Mint tolerance — in order to prevent exports of specie. This device was apparently used for the first time late in the nineteenth century.

A more active policy with respect to gold clearly began in the late nineties.⁴ During periods of depression there was little need for such action, but in expansion, when gold was demanded for export, the Bank was definitely aggressive. The limits within which the Bank could determine specie movements were small, but the evidence shows that use was made of the Bank's power to supplement its discount policy.

(3) The securing of funds from the Bank by the market was achieved in two ways — by the discount of bills, and by the advance of credits against collateral security. During the period studied there was a noticeable trend toward the favoring of the former method. Rates on loans were kept above those on discounts, particularly during periods of tight money. This practice was used as early as 1881,⁵ but no consistent use of the policy was made until after 1887.⁶ Moreover, the discount of bills was favored by increasing the usance of bills acceptable for discount. Until 1894 the limit was fifteen days, but in that year it was raised

to thirty days,¹ and in 1897 to ninety days.² At any particular time the Bank might refuse to discount long bills, for its policy depended upon its own needs and the conditions existing in the money market. But it is clear that the average usance of bills held increased with the passage of time.³

The requirements of the Bank with respect to advances changed somewhat at times. In 1883 loans were granted only in the six weeks preceding the end of the quarterly periods.⁴ This rule was relaxed shortly, however. A more important change occurred in 1894, when the closing hour for loans on collateral was altered from 3.30 to 2.30 P.M. The action was taken for the convenience of the Bank, and to protect it from being called upon as the last resort for loans.⁵ On the other hand, in 1897 the Bank permitted loans for three days, and did not insist that they be taken for a full week.⁶ No evidence as to the continuance of this policy has been found, however.

The discrimination shown by the Bank in favor of discounts may have been due to a desire to divert funds from the stock market into commercial channels, but it is not possible to draw a definite conclusion. It is evident, however, that the Bank found it advantageous to "shock" the money market at times by altering its methods of lending.⁷ While such changes could not have lasting effects, they tended to disrupt the working of a highly sensitive credit organization, and gave the central bank more

More important, however, was the extended use of open-market operations. The Bank had begun the practice of selling and purchasing securities much earlier.¹ But apart from some shifting of securities during the thirties, the operations were designed only to smooth the money market over seasonal pressures. In the years following 1881 the Bank resorted more freely to such operations, and to the extent that they were carried on more frequently in the periods of business prosperity when the Reserve was falling, there was some cyclical significance in the operations. I have found no evidence of purchases of securities during depressions to ease the market.

The Bank employed three methods in open-market dealings. The use of one of them is definitely seen in 1885,² e.g., when the market was drained of funds by *borrowing* on the part of the Bank through a broker, giving Consols as collateral security.³ This was the usual practice, but the Bank also operated through the medium of the stock exchange. It borrowed from the dealers by lending Consols from one account to another, which in effect was a sale for cash and a repurchase for the next account, or a shorter time as might be arranged. This was known as borrowing on "contango."⁴ At times the Bank also sold Consols outright, but this was practiced very rarely.⁵ The use of Treasury bills in openmarket operations is primarily a post-war development, because there were rarely more than a few millions of them outstanding at any time before 1914.

In 1905 the Bank secured the co-operation of the large clearing banks of London in draining the market of funds, and this policy was utilized again in 1906. Later the Bank established closer relations with these banks, and conferences began to be held in which

both parties participated.¹ This co-operation was mutually advantageous, for the Bank gained greater control over the money market, and the banks gained through the higher rates imposed as a consequence. Bankers long had objected to the paying of deposit rates above the day-to-day rate for loans. With the concentration of control brought by the conferences with the Bank of England, the joint stock banks were able to refuse to lend at less than the rate of deposits.²

In this period from 1881 to 1914 a definite change took place in the relation of the Bank of England to the London money market. At the beginning of the period the Bank had less contact than at any time since the passing of the Act of 1844. But by the outbreak of the war in 1914 the Bank had regained most of its lost power, and was in a position generally to make its rate effective on the money market.³ The gradual reduction in the spread between the Bank rate and the market rate is evidence of this increased control.⁴

(4) The study of the structure of the English banking rates reveals another mechanism of control which was of particular significance during the earlier years of the period under examination. It is difficult to secure adequate evidence on rates, but it is apparent that the relationship of the Bank rate to deposit rates and charges for loans and advances ⁵ was very significant.

The customary rate on loans in London and in the country outside varied with the Bank rate of the day. This was particularly important for the country banks, since the proportion of earning assets in the form of loans was higher than in the case of London

banks. A high Bank rate was, therefore, regarded as an affliction by the industry dependent upon local banks.¹ Rates on deposits also varied in accordance with the Bank rate.² This practice became less prevalent in the provinces as time passed, however, as

Sykes makes much of this difference in explaining the growth of large banks. The low money rates in London during the nineties caused the London banks to seek

following the Baring Crisis; for while the purely metropolitan banks found their earnings greatly reduced, the country banks continued to earn large profits. In this respect the banks with country connections added to a City clientele were more fortunate than banks operating almost entirely in the London market.

The London banks which kept a considerable proportion of their assets in the shape of bills found that the earnings varied with the "profit margin" - the difference between the market rate for fine bills and the deposit rate.¹ When the supplies of "money" ran short, the market rate was high, and profits large. In fact, whenever the market rate was in close accord with the Bank rate the banks gained, for the deposit rate fluctuated with the Bank rate. At the beginning of the period treated the rate on deposit balances was normally fixed at 1 per cent below the rate at the Bank, but as time passed the spread became greater, averaging $1\frac{1}{2}$ per cent, and finally reached 2 per cent for the most part in 1922.² The change was due largely to the ineffectiveness of the Bank rate over considerable periods. At times the profit margin was reduced to less than nothing,³ and the banks gradually reduced their deposit allowance in consequence. Eventually they agreed not to make "floating" loans at less than the deposit rate.⁴

Country banks, on the other hand, kept their assets more largely in advances and overdrafts. Their bills, moreover, were primarily what are known as "inland" or trade bills, and these bore a higher rate than the bankers' bills discounted in London.⁵

The dividends of banks did not vary so widely, since it was the policy of many to maintain stable returns to shareholders. Large reserves were accumulated in years of prosperity to enable them to pay the same dividend in less prosperous times.

alliances with country banks in order to have alternative fields of investment. "Since money rates in the provinces were not only more remunerative but also more stable, it was natural for the London banks to seek alliances with the banks having a preponderance of such business." There were eighteen such amalgamations in the five years following 1890. *Op. cit.*, p. 48.

When the demand for accommodation from banks was large they were in a position to raise their rates. This was possible on account of the local monopoly enjoyed by many of the country banks. In view of the difference between profits of provincial and City banks, it is unlikely that rates on loans in the country varied closely with the Bank rate.¹ But it is probable that the provincial banks tended to raise their charges when the Bank rate rose appreciably. Furthermore, the application of a fixed minimum prevented local charges from falling very far in periods of low Bank rates.² On the other hand, after 1900 the country banks suffered somewhat because deposit rates did not fall far on account of the competition of local bodies.

The country banks were able to maintain local monopolies and charge high rates in periods of depression by virtue of their relationship to London banks. The provincial banks had agents in

the City, with whom balances for clearing and reserve purposes were kept. This system provided a channel through which surplus funds could be sent to London for investment in depression,

and withdrawn again when business expanded in the country.¹ The amplitude of the fluctuations of money rates in the London market was increased as a consequence of this movement of local

It would be natural for industrial companies in the country to discount their bills or to secure advances in the City, rather than pay higher charges in the provinces during depression. This movement certainly took place, especially when the depression was long-continued.¹ But banks were not easily induced to grant advances to new customers who were not regular borrowers, and the discounting of bills for other than their own customers was frowned upon.² Moreover, in depression the profit accruing to banks on bills was almost negligible, and they were disinclined to take bills from strangers, with whom the risk of loss was increased.³

The placement and withdrawal of funds in London by country bankers, then, was an easy process. But the other half of the mechanism, which would have kept country rates down, namely, the borrowing or discounting from London banks by local companies, was largely absent. It worked if given sufficient time, but even then only half-heartedly.

The amalgamation movement in banking brought important changes, however, for the larger customers of a branch of one of

Undoubtedly other banks felt the same way, for the profits to be secured on such discounts were small, and the risks involved in new customers would be greater than on their other advances or discounts.

In periods of depression the purchase of securities, or the lending of funds to stock exchange operators, was more profitable to the banks than the discount of bills. the large London banks were now in better position to demand the privileges available to London borrowers than were the same customers dealing with a purely local bank. Competition between the branches of the large banks tended to aid local industry, and the local monopolies of banks were broken down¹ to a considerable extent. This movement was particularly important in the nineties, and by 1900 banking in England was in the hands of a relatively small number of banks. During the succeeding years even larger amalgamations took place, and the number of banks was further reduced. Competition became keener throughout the country, and local monopoly rates became rare. The same movement of balances between London and the country persisted, however, but the flow was primarily an intra-bank movement.²

(5) The structure of rates in England during the earlier period of study lent itself to control by the Bank of England. In periods of expansion the advance of the Bank rate led in time to higher rates for charges, particularly in the country. Still more important was the manner in which banking funds were shifted from the country to London. As the need for funds in the country increased, balances were withdrawn, and rates in the London market tended to rise as a consequence. In depression, on the other hand, local rates remained high, thereby making production more difficult, and balances were shifted to the glutted money market. Eventually, the purchase of securities was stimulated,³ and industrial expansion induced as a consequence.

To a certain extent the control of the Bank was aided during periods of prosperity by the advance of rates on advances in con-

formity with rises in its own rate. But this was a very slow-acting mechanism. The drain of funds from London led to high rates in the City, but this too was slow. Nevertheless, the power of the Bank rate over country transactions was of value in the earlier years, when the Bank had difficulty in controlling the London market. The evolution of large banking systems brought country rates more nearly into line with those of the City, and the Bank derived little aid from the former mechanism. But this same movement also brought more scientific banking, and more responsibility as power was concentrated in the hands of a few banks.¹ When necessary the Bank could exercise a potent control over them by bringing public opinion to bear, and thus supplement its mechanistic control over the money market.

During the latter part of the nineteenth century the gold reserves of England were very scanty. Many proposals were made to increase them,² but little action was taken until the years immediately preceding the Great War, when the large joint stock banks began to accumulate stores. The main reason for the lack of action was the expense involved. Each of the chief parties involved — the Bank of England, the joint stock banks, and the Government — sought to evade the burden. Consequently, for most of the period treated, England was "trading on a very thin equity" in the matter of gold reserves.³

But positive advantages resulted from this condition. The Bank was forced to take energetic measures to control the money market when its Reserve fell. With the exception of the years

from 1804 to 1807, the Bank never had large excess reserves.¹ As a result, the Bank resorted to various devices in an attempt to keep market rates in accord with the Bank rate during periods of expansion. Especially in the earlier years of the period studied, the Bank was aided to some extent by the rise of rates in the country. Gradually the growth of large banks through combination and establishment of new branches, and the development of central banking technic, enabled the Bank to regain any power over the money market which it had lost during the period of heavy gold imports into the country. To the extent that it is desirable to curb a period of prosperity early in order to avoid a long and severe depression, scanty gold reserves were advantageous. With the growth of larger foreign balances in London, however, it became increasingly desirable to have excess specie, in order that international demands for the return of balances should not upset the local credit situation.

CHAPTER IX

GOLD MOVEMENTS AND BANKING POLICY

(1) Cyclical fluctuations in the movement of gold to and from England occurred in the pre-war era. There was a tendency for imports to increase during the prosperity stages of business cycles, and for exports to grow during depression. The same phenomena were evident in the United States from 1896 to 1913.¹ Coupled with the fluctuations in foreign movements of gold were important variations in the internal movements of currency in both countries. Domestic requirements for cash increased during prosperity, and there was a large flow of cash from the money centers in each country to the interior. In depression the flow was abated greatly or reversed.

These cyclical fluctuations in gold and currency movements might be explained in terms of the classical theory of gold movements. Commodity prices and the international movement of goods must dominate the situation if this explanation is to be adequate. Hawtrey's analysis of specie flows over cyclical periods is based upon the assumption that prices of goods will be the dominating factor. Gold flows because the price levels of one country do not rise or fall in accordance with the levels in other countries. The movement of gold forces all countries to keep the same pace through the various phases of the business cycle. If the price levels in England and the United States had been less sensitive than prices in other countries, the cyclical fluctuations in gold flows found here could be explained along the lines of the classical theory. In prosperity their price levels would have risen more slowly than prices elsewhere in the world, and specie would have flowed into the two countries. In depression the price levels would have fallen more slowly also, and gold exports to countries whose prices were falling faster would have taken place.

Undoubtedly there is some tendency for the price and wage structures of advanced industrial countries, such as England during the period studied, to be more rigid than the structure in countries which are newer in their stage of economic development. On the other hand, there is perhaps a tendency for the elasticity of demand for commodities produced for export by "older" nations to be somewhat greater on the average than the elasticity of demand for products imported by "old" countries from "newer" nations. If prices of all commodities entering into foreign trade were to rise by the same degree during the prosperity phase of a world business cycle, the total sums due by "older" nations to "young" countries would rise relatively to the amounts owing to them by the latter. Gold would then flow to the "young" countries instead of to the more developed nations. A considerable difference in the rate of price change in the two sets of countries would be necessary in order to provoke flows in the opposite direction. In depression the sums due to the "young" nations would decline greatly, and the amounts owed to "older" countries would rise relatively. Gold movements to the more developed nations would take place. If the fall of prices in the "newer" countries was relatively great, the specie movement would be even larger.

Shifts in demand for goods in a schedule sense, however, are likely to be more important than the elasticity of demand, when price and income levels are changing. Shifts in demand schedules occur not only because of price changes in general, but also because of fluctuations in the volume of foreign loans. The flotation of loans enables the borrowing nations to increase purchases of goods without suffering a loss of gold. The volume of new loans tended to increase during prosperity and to fall off in depression in the case of England.¹ There would be a tendency for gold to be lost, as a consequence, unless goods movements expanded and contracted in proportion to the loans. If the price level of England did not rise as rapidly as in the rest of the world, goods exports would increase during the periods of prosperity. But this would merely balance the increase in foreign loan flotations in

part, and gold would flow into the country because of the goods exports induced by the price differentials between England and the rest of the world. Any excess of the volume of foreign loans above the expansion in exports of commodities would tend to bring specie exports.

In less developed countries commodity imports would increase with borrowing operations. Some specie imports would occur if the proceeds of the loans were not taken wholly in the form of goods. The expenditures from the loans would tend to increase the price level in these countries relatively to levels in creditor nations. But no specie would be lost, so long as the borrowing operations continued.

There are two principal difficulties with the classical analysis in connection with cyclical gold flows. In the first place, the adjustment through the price mechanism must be very prompt. International trade must respond quickly to changes in the general level of prices. Over periods so short as the business cycle it is not certain that these adjustments will be made rapidly enough for gold movements to play the role assigned to them. Secondly, the fluctuations in foreign loans should permit relatively higher price levels in borrowing countries during the prosperity phases of the cycle, and should bring a greater fall in these levels during depression, as compared with creditor nations, if the classical explanation of adjustment in the case of foreign loans is correct. Even though the price levels were lower in lending nations than in borrowing countries, gold would flow to the latter. Again, however, the adjustment of goods movements to loan operations takes time, and it may not be perfect over so short a period as the business cycle. The chief defect with the classical explanation is that lower price levels in prosperity in the "older" nations, which are also the creditor nations, would lead to specie imports if price levels govern the situation, but would be consistent with specie exports if there was a large volume of international lending occurring. A lag of prices in these countries during the expansion and prosperity phase of the cycle should not necessarily bring specie imports. In depression a lag of prices would lead to gold exports, but this movement would be counteracted by a decline in the volume of foreign loans. Net specie exports could occur only if the price level fell much faster than in other nations. Dependence cannot then be placed upon an insensitive price structure as the explanation for the cyclical gold movements found for England.

It is obvious that foreign loans would affect debtor and creditor nations in different ways, so far as gold flows are concerned. But the cyclical movements were similar for both England and the United States in the pre-war period. The United States might have had a more sensitive price structure than England, and in that case gold exports would have occurred in prosperity, and imports would have taken place in depression. In prosperity the borrowing operations would have tended to bring in gold to offset the specie exports due to relatively high prices, while in depression the decline in loans would have prevented specie imports. It is difficult to make out an a priori case for specie movements over cyclical periods where two important forces of this type work at cross purposes. The same situation prevails for England, since the making of loans in prosperity would have led to specie exports, but the insensitive price structure would have led to imports.

(2) In one respect, however, both nations were alike in this period. The banking systems of both countries had little slack, and relatively small changes in the volume of credit tended to reduce reserves markedly. Even more important was the fact that both used standard money coin for a large proportion of the cash transactions of the public. With rising prices in prosperity the requirements of the public increased, and this drain was more important than the increase of bank credit for the depletion of reserves. The pressure upon bank reserves led to increased discount rates in the money markets, and the flow of short-term capital, induced as a consequence, may well have been the dominating factor determining the gold flows over cyclical periods. So long as rates remained above the world levels, the funds would remain in the two centers. In time the high discount rates would affect business conditions, and the rise of prices and production curtailed. But this period might be postponed for several years. In depression the return of gold from the interior would ease the money markets and bring about an outflow of balances accompanied by gold.

Hawtrey maintains that the response of prices and production to the rise of discount rates will be quick, because of the activities of traders operating on little capital of their own, and dependent principally upon bank credit. An increase in the cost of this credit would lead them to curtail orders. Some variation in the spread between buying and selling prices of goods might enable the traders to bear the added interest cost, however. And the traders must occupy a prominent place in the economic system if the mechanism is to work promptly. International conditions would be affected by traders in London, and fluctuations in the volume of their orders would tend to keep all nations at about the same stage in the business cycle, according to Hawtrey. If this were true, however, cyclical fluctuations in gold flows should not be very marked, since adjustment of disequilibria in the balance of payments would occur quickly through goods movements. The evidence found in this study points to very important cyclical variations in specie movements, and it seems probable that the frictional elements in the economic system are more important than the classical writers have admitted.

(3) If the internal currency requirements were the dominant factor in connection with "tight" banking systems causing the cyclical fluctuations in gold movements in England and the United States, it is clear that in addition to the cost of coinage and the loss of interest on the specie, standard money currencies are expensive because of their effects in upsetting the economic systems of other countries. Unless the requirements of the public for additional coin in periods of prosperity are met by withdrawals from hoards somewhere in the world, other nations will be forced to contract more rapidly than would have been the case. Even if the needs are supplied wholly from newly mined gold, other countries suffer, since they are unable to secure their usual share of the annual output of metal. In depression the flow of gold to other countries tends to upset their money markets, and to produce an easy condition which is deceptive. As in the case where balances are held in foreign centers by countries on the gold exchange standard, these nations must be ready to part with their specie when times improve.

Coin circulations consisting of standard money have been advocated on the ground that they constitute "secondary" reserves.¹ Gold coin was not available for export, however, during periods of business expansion when it was most likely to be needed, and the internal drain was likely to be heaviest at times of crises. Under long-run conditions a coin circulation may constitute a secondary reserve, because it may be assumed that commodity prices will dominate the situation. If a nation should begin to lag behind other countries in its economic development, adjustment to the altering situation would occur gradually. The fall of domestic prices brought about by gold exports would release gold from the coin circulation to supplement bank reserves. But over periods so short as the business cycle, there is no *a priori* reason to expect that the necessary adjustments will be made in this frictionless manner.

(4) Before examining further the possibility that fluctuations in discount rates and short-term capital movements are the chief explanation for the cyclical movements of gold found for England and the United States, the variations in the foreign loans made by England during the period studied will be considered. In Table XVI, capital exports, earnings from shipping, and receipts from commissions for financial services are shown.² These data are plotted in Chart XXI, together with the Thomas index of business conditions. Capital exports declined during the period from 1881 to 1883, although business conditions were improving, and there was very little expansion in foreign loans in the years from 1895 to 1900.³ In the other periods of business prosperity, 1886-

1890, 1904-1907, and 1909-1911, exports of capital increased greatly. In the periods of declining business from 1890-1895, 1900-1904, and 1907-1908, capital exports fell off. The timing of the movements is not parallel in all cases, but there is a high posi-

tive correlation between the condition of business and the volume of capital exports.¹

1891-1903, and 1904-1911, respectively. The periods were too short to insure proper handling of the years at the ends of each period. Somewhat higher correlation between capital exports and business conditions was indicated by a comparison of deviations from the trends and the cyclical fluctuations shown by the Thomas index than is shown in Chart XXI, where the original data of capital exports are compared with the index of business.

Cyclical fluctuations in earnings from shipping and commissions are evident, although the amplitude of the fluctuations is less than in the case of capital exports. Business prosperity brought increased earnings from these sources, and depression caused them to decline. The most important divergence in the curves shown in Chart XXI is in the earnings from shipping following 1901. Receipts began to increase three years prior to the improvement in business conditions.

(5) It has been pointed out by Angell that an intimate connection exists between the movements of capital and the balance of commodity trade.¹ But he denies that fluctuations in these flows can be explained in terms of the business cycle. He argues that if the cycles in the lending and borrowing nations are coincident and of roughly equal magnitude, their influence will not materially affect the situation. If the cycles are not similar, the prices of securities will fluctuate in different ways in the two countries, and a flow of capital might occur. But the prices of stocks and of fixed-yield securities will tend to move in opposite directions, and consequently there will be a cross-current of investment flows between the two nations. The latter type of security passes chiefly in international dealings, so far as new loans are concerned, however, and to the extent that fixed-yield securities are more important than stocks in international transactions, some cyclical fluctuation in investment would occur. Angell goes on to deny that the cyclical hypothesis can account for variation in other items in the international accounts, such as shipping charges, immigrants remittances, tourist expenditures, etc.

The two countries considered by Angell are presumed to be financially independent, and capital can move freely either way. In the case of the majority of long-term loans, however, this assumption cannot be made. New loans are made by nations with large volumes of accumulated capital, while the borrowers are principally newly developed countries. In a period when discount rates are rising in debtor nations, new loans will be made by creditor countries because of the higher rates, and securities of

the debtor nation which are already on the market will be more attractive to investors in the creditor country because of the fall in their prices. But direct investment in the debtor country is also profitable for foreign investors because of the business expansion occurring there. If the expansion is accompanied by a "boom" stock market, foreign speculators will be tempted to transfer funds to the country. Even if the creditor country is experiencing depression, the low price of stocks will not tempt investors or speculators in the debtor nation to invest, since opportunities for investment or speculation at home are at least equally tempting. But little flow of funds from the debtor country to the creditor nation would occur whatever the relation of the business cycles in the two countries to each other, because the volume of funds at the disposal of investors in the debtor country is relatively small. While some cross-currents of investment flows may well occur between financially independent nations, the vast bulk of the international movement of capital is accounted for by transactions between creditor and debtor countries. Cyclical fluctuation in this movement is probable, both because the volume of new loans is determined to a large extent by the conditions of business in the lending nations, and because psychological forces are of great importance. Expansion of loans in prosperity and contraction during depression is to be expected, as a consequence.

(6) Movements of short-term balances between financially independent nations, however, may be determined by relative differences in discount rates, rather than by the underlying conditions of business in the two countries. Unless the influence of discount rates upon commodity prices and the volume of production is felt immediately, there is no reason why such short-term loans should flow in the same direction as long-term loans. So long as the flow of short-term funds continues, the nation receiving the balances would not lose gold, where the movement was large, and it would be enabled to continue its business expansion until the high discount rates proved to be a deterrent to business, or, more important, the bankers became unwilling to lend.

The international movement of short-term balances is likely to

be very sensitive to changes in discount rates, but domestic business is unlikely to respond so quickly to rate changes. Central banks are placed in a position where ordinary discount policy may be ineffective. In periods of prosperity the rise of rates designed to curb business expansion may merely bring in foreign balances. and enable the country to continue its expansion to a greater extent. And in depression the fall of rates leads to an outflow of foreign funds, and money market conditions are not eased in the manner expected.¹ Unless the general price structure is very sensitive to rate changes, which is only likely to be the case when a large proportion of the bank credit made available to business is provided by the central money market, movements of foreign balances may dominate the situation over periods so short as the various phases of the business cycle. Cylical fluctuations in the movement of specie might easily be controlled by the movements of these balances. This explanation for the cyclical movements of gold found for England and the United States seems more adequate than the explanation based upon price level differences. The existence of banking systems with little slack made the flow of foreign balances very important, because the drawing down of reserves in prosperity occurred early. Internal currency movements added to the tightness of the money markets, and rising rates tended to draw gold to the countries. During depression the reflux of funds and cash from business firms and the public produced an ease in the money markets which caused the withdrawal of foreign balances.

(7) If the nations with "tight" banking systems are not to upset the world economy, they must hold large excess reserves of gold, so that specie will not have to be drawn from the rest of the world during the stages of business prosperity. But this alone is not sufficient, since any attempt by the central banks to curb domestic business may lead to an influx of foreign balances accompanied by specie imports. In the absence of sensitive price structures within the countries, central banks may have to resort to qualitative measures of control, or rationing of credit. It is

possible that a scheme of rate control might be devised where rates to banks on rediscounts outside the central money market might be raised prior to the increase of rates at the center. In the United States, rates at the Federal Reserve Banks in the interior of the country would be raised before the New York Bank acted, thus reversing present-day policy. While politically difficult to apply, such a policy would have the effect of applying pressure first upon business in the interior which is unable to borrow in the major money market. Easing of rates there in depression might be quickened, and to some extent the evil effects of ordinary bank rate stability over cyclical periods would be abated. The lag of rates in the central money market behind the rates in the interior would prevent foreign balances from exerting such a powerful effect.¹ Such a mechanism assumes that the fluidity of credit is less than is generally thought. The evidence of rates and movements of banking funds in England in the period studied suggests that a considerable proportion of business firms were not able to tap the central money market, and were forced to accept the conditions laid down by local banks. Dr. Riefler's study of rates in the United States indicates that the same type of condition prevails in this country.² Perhaps writers on banking have been influenced too much by the fluidity of funds in money markets, and have assumed tacitly that such fluidity is also true of the banking structure in general when such has not been the case.

Co-operation of central banks may remedy the situation in part, by keeping discount rates in the various money markets more nearly in line. Unless banking systems are very much alike, and business conditions similar throughout the world, however, central banks may not be able to make rate changes effective in the money markets. And these banks may well hesitate to apply a policy which is desirable from the standpoint of the world economy, but which may be disadvantageous from a national

viewpoint. Moreover, the transfer of funds for speculative use elsewhere may not be curbed by small changes in money rates. The flow of balances to New York in 1928 and 1929 for investment in brokers' loans or in securities would have been difficult to control even though central banks in Europe had raised rates to very high levels.

Keynes' suggestion that an element of doubt as to the future terms of exchange between currencies should be established, by providing for larger variations in the buying and selling prices of gold by central banks, and the establishment of forward exchange market rates under the control of the central banks,¹ appears to have great merit. In a world where internal price structures are rigid, the easiest method of curbing the unfortunate effects of movements of short-term balances is to set up conditions which make the latter more insensitive to rate changes. Unless such a mechanism is devised, the international gold standard seems likely to prove effective only over short periods, and to be subject to breakdown at frequent intervals.

APPENDIX A

GOLD MOVEMENTS AND BUSINESS CYCLES IN THE UNITED STATES, 1896-1913

Attention has been called earlier to the high inverse correlation found between foreign movements of gold at New York and the internal flow of currency over cyclical periods, and this phenomenon will be examined briefly here. There is abundant material for the study of business and banking conditions and the movement of specie in the United States, but most of the data have been subjected to analysis in other studies, and it is necessary only to bring together the important results for study in relation to the problems considered in the case of England.

The banking system of this country was admittedly a poor one in many respects prior to the adoption of the Federal Reserve System. and its defects were most clearly apparent in times of commercial crises. Any severe strain on the reserves of the important clearing banks in New York City was likely to bring a suspension of payments and general financial panic. The most important reasons lay in the inelasticity of reserves and the lack of a central banking institution. The interlocking of reserves, through the deposit of portions of the legal reserves of banks in outlying cities and towns in the banks in reserve and primarily central reserve cities, coupled with the fact that gold was the only elastic element in the ordinary hand-to-hand circulation, brought a heavy strain upon the cash of the country. Without a central bank to curtail credit operations during the latter stages of business expansion and to advance funds to meet crisis needs, the system operated in uncontrolled freedom during the expansion phase, only to break down completely under the demands of the crisis stress.

It is true that the United States used other forms of money than gold, but they were inelastic, and could not be expanded quickly in order to meet the needs of the country for circulating media.¹ And this was an ever present need, for the autumnal drain of cash necessary to move the crops was very large. The seasonal movements of credit and cash in response largely to agricultural requirements have been studied by Professor Kemmerer for the National Monetary Commis-

sion.¹ It was recognized that crises were most likely to occur in the fall of the year, since the banks in New York were then called upon to meet the heavy internal demand at the time when they were weak. The additional strain was sufficient to bring their downfall.

In addition to seasonal demands, there was a drain of currency into circulation during the expansion phase of the business cycle. Studies of the relationship between the amount of money in the hands of banks and in the pockets of the people have been made, which show this clearly.² Banking reserves were drained in prosperity and replenished in depression. The recognized value of the ratio of loans to deposits of the New York clearing banks as a barometer of business conditions is silent proof of knowledge of this fact. When the proportion approached close to 100 per cent it indicated that a crisis was imminent, for it meant that deposits were being withdrawn in cash, while loans were still increasing.³ In periods of crisis gold was drawn from abroad by the high interest rates in New York.

In the introductory chapter attention was called to the observation of Professor Young with respect to the flow of gold through New York as an entrepot. His conclusions were deduced from an examination of a chart and accompanying table in A. P. Andrew's studies for the National Monetary Commission.⁴ The table showed weekly net foreign movements of gold at New York, and net movements of currency between New York and the interior of the country, as reported by the *Commercial and Financial Chronicle*. This series has been extended in Table XVII to cover the full period from 1896 to 1913, and quarterly totals computed. In addition a four-quarter moving average has been calculated to remove some of the seasonal variation, as in the case of the similar English statistics.⁵ The two series have been plotted in Charts XXII and XXIII.⁶ Another series has been constructed

from data appearing in Professor Mitchell's *Business Cycles* (1913). This series, which is shown in Table XIX and Chart XXIV, makes allowance for gold used in industry, and for the production of new metal, but the figures are based on annual data, and do not indicate the timing of movements as well as the quarterly series. The division of

the total monetary stock among the Treasury, the banks, and the public is shown in Table XX and Chart XXV.

Foreign movements of gold were somewhat less important for the United States, because of the large domestic production. Domestic demands were supplied primarily from the newly mined supplies, and ordinarily some was exported as well. Only occasionally was it necessary to secure gold from abroad in large amounts. There was an important seasonal flow of specie, but there was also a definite cyclical

variation in the movement of gold at New York. From 1896 to 1898 there was a very heavy net import into the country, due primarily to the large agricultural exports in these years.¹ No important foreign flows aside from the usual export of newly mined gold occurred there-

after until the expansion period preceding the crisis of 1907. In 1904 there was an unusually large efflux, but the crises of 1901 and 1903 seem to have affected gold flows very slightly on the whole. Undoubt-

edly, the large imports of the late nineties enabled the country to pass through these crises without drawing upon foreign countries to any great extent.¹ In 1906 and 1907 the import of gold was very large,

while in 1908 the movement was reversed, and the specie secured during the crisis was returned to Europe.

Internal movements show a normal flow of currency into New York during depression periods, and a drain into circulation in prosperity.²

When allowance is made for the utilization of domestically produced metal, the drain preceding the crisis of 1903 becomes evident; and in the years immediately preceding the crisis of 1907 it is marked. It is clear from an examination of the chart showing the division of the

monetary stock that the proportion held by the public increased during both of these periods.

The movements of gold into and out of the Treasury also affected the amount of currency available for use by the public. It was pointed out by Andrew that the operations of the Treasury tended to lock up more gold in periods of prosperity, since taxes, especially customs duties,

were then more prolific; and the opposite was true in depression.¹ Under Secretary Gage the deposits by the Treasury in banks was greatly increased, and the idle balances of the Treasury reduced.² But with Secretary Shaw a more decided policy came into effect. He aided the banks by transfers of gold to them from the Treasury during 1903, thus adding to the gold available for reserves.³ During 1906 he aided the import of gold by permitting certain banks to anticipate arrivals by withdrawing cash immediately from the Treasury.⁴ In effect this raised the gold import point by removing the interest cost. During the crisis of 1907 the Treasury supplied the New York banks with much of the cash sent to the interior.⁵ Thus the evils indicated by Andrew were mitigated to a certain extent. But the Treasury operations introduced uncertainty as to the course which would be followed by the Secretary, and discouraged prudent preparation by bankers.⁶

In the panic period of 1907 the cash in circulation was supplemented by temporary media of various kinds.⁷ The demands of the United States during prosperity and crisis on other countries for gold were consequently less than would otherwise have been the case. On the other hand, much of the cash removed from the banks was not utilized, but was hoarded by people.

During periods of prosperity the cash reserves of New York banks tended to fall, and they were replenished during depressions.⁸ Thus these banks took up some of the slack in flows of gold from abroad to the interior circulation and bank reserves of the United States. Money rates, on the other hand, rose during expansion, and fell off in the succeeding depression.⁹ The rise of money rates was certainly the proximate cause of the foreign influx of gold in 1906. Evidence to this effect is afforded by the large issue of finance bills drawn on London in that year.¹⁰ In 1907 the major cause was the payment for agricultural exports.¹¹

The studies of Professors Young and Mitchell reveal important dif-

ferences in the cyclical movements of bank deposits in New York and in the country outside.¹ In periods of depression New York bank deposits and loans tended to increase, while in prosperity they declined. Banks outside of New York showed the opposite characteristics. The causes for this difference were the movement of idle cash in "other" banks to New York in depression and the withdrawal in expansion periods, and the shifting of bank deposits to and from "other" banks to New York.³ There was also a marked cyclical variation in the volume of investments made by both the New York banks and those outside of New York.³ In periods of depression the holding of securities increased, since surplus funds were large. But banks disposed of them "... when the demand for loans and discounts increased."⁴

The treatment of American data has been very brief, but several points stand out clearly. There was a tendency for currency to move into circulation during prosperity, and to reflow into the banks in depression. It is noticeable that the reflux occurred very quickly after the outbreak of the crisis, both in 1903–1904 and 1907–1908. Associated with this internal movement was a foreign flow of gold into the United States immediately before and during the crisis period, and a reflow from the country after the crises abated. Due to the presence of hoarded gold in the Treasury, and the large annual output from mines of the country, foreign flows were of less significance than in the case of England. Unless cyclical fluctuations of business were great, the repercussions upon international gold flows were not easily seen.
