PREFACE

THE aim of the present work is to give, in a short form, a summary of the more important regulations relating to bills of exchange and cheques which exist in European countries, together with particulars concerning the stamp duties payable thereon. It was not the intention, however, to provide a book of reference for a lawyer, but rather to collate the more important rules, so that those whose business brings them into touch with foreign bills may obtain readily some help in matters of more or less daily occurrence.
