APPENDIX I

FOOTNOTES TO TABLE NUMBER VI, CHAPTER I, P. 28

- (1) Five bond issues which were reported as in default were reinstated, viz.:
 - Yosemite Valley Railroad Company, 1st sinking fund gold 5's, 1936; interest paid about 6 months late from 1919 to 1924, at which time and after, interest was paid when due.
 - Algoma Eastern Railway (Canada), 50 year 1st mortgage 5's, 1961; interest was deferred and is being paid late.
 - Atlanta, Birmingham and Atlantic Railway Company, 6% equipment trusts, 1935; all arrears in interest are being paid and likewise payments on account of principal in accordance with agreement between receiver for road and United States Government which holds all of above notes.
 - Minneapolis and St. Louis Railway Company, 1st gold 7's, 1927; on which interest was not defaulted, but bonds were extended from June 1, 1927 to June 1, 1932, with interest at 6%.
 - Nashville Terminal Company, 1st gold 5's, 1932; on which interest
 was deferred but paid about 6 months late since 1916. Since July 1,
 1928, interest has been paid when due.
- (2) Five bond issues which were reported as in default were reinstated, viz.:
 - Houghton County Traction Company, 1st consolidated gold 5's, 1937;
 all but \$6,000 of \$660,000 outstanding are owned by Central Gas and Electric Company, and interest is being paid about 2 years late.
 - Oregon Electric Railway Company, 1st gold 5's, 1933; interest was deferred but paid late from May 1, 1923 to May 1, 1924, from which date interest has been paid when due.
 - 3. Biloxi Electric Railway and Power Company, 1st gold 6's, 1924; principal was defaulted January 1, 1924. On January 1, 1925 the Mississippi Power Company purchased the properties, assumed the bonds, and subsequently retired them with all interest accrued at 106.
 - 4. Gulfport and Mississippi Coast Traction Company, 1st gold 6's, 1935; defaulted interest October 1, 1924. On January 1, 1925, the Mississippi Power Company purchased the properties, assumed the bonds, paid arrears in interest and subsequently retired the bonds at 105.
 - Clinton Street Railway Company, 1st gold 5's, 1926; defaulted principal March 31, 1926. Interest has been paid regularly to and including October 1, 1930. No reorganization has been undertaken.
- (3) Ten bond issues which were reported as in default were reinstated, viz.:
 - Brooklyn City and Newtown Railroad, consolidated 1st gold 5's, 1939; defaulted interest July 1, 1919 to July 1, 1921, with interest at 6%, to April 15, 1922, on overdue amounts was paid and these bonds were not disturbed in the reorganization of the Brooklyn Rapid Transit Company.

- Brooklyn, Queens County and Suburban Railroad Company, 1st 5's; defaulted interest July 1, 1919. The defaulted interest was paid in cash (\$225 per \$1000 bond) and the bonds reinstated under the reorganization plan of the Brooklyn Rapid Transit Company.
- 3. Brooklyn, Queens County and Suburban Railroad Company, 1st consolidated 5's; defaulted interest Noverber 1, 1919. The defaulted interest (\$200 per \$1000 bond) was paid, \$50 in cash and \$150 in 6% preferred stock of the Brooklyn-Manhattan Transit Corporation, and the bonds were reinstated under the reorganization plan of the Brooklyn Rapid Transit Company.
- 4. Coney Island and Brooklyn Railroad, 1st consolidated mortgage 4's; defaulted interest July 1, 1919. All interest due was paid in cash (\$180 per \$1000 bond) and bonds were reinstated under the reorganization plan of the Brooklyn Rapid Transit Company.
- Jamaica and Brooklyn Railroad Company, 1st 5's; defaulted interest July 1, 1919. All arrears in interest paid in cash and bonds reinstated under Brooklyn Rapid Transit Company reorganization plan.
- Nassau Electric Railroad, 1st mortgage 5's, 1944; defaulted interest
 October 1, 1919. All arrears in interest (\$200 per \$1000 bond) was
 paid in cash and bonds were reinstated under the reorganization plan
 of Brooklyn Rapid Transit Company.
- 7. Nassau Electric Railroad, 1st consolidated 4's, 1951; defaulted interest July 1, 1919. All arrears in interest (\$180 per \$1000 bond) was paid (\$40 in cash and \$140 in 6% preferred stock of Brooklyn-Manhattan Transit Corporation) and bonds were reinstated under the reorganization plan of Brooklyn Rapid Transit Company. Both this issue and No. 5 above were assumed by the Brooklyn and Queens Transit Corporation in 1929.
- Hoosac Valley Street Railway, refunding gold 7's, 1924; defaulted interest September 1, 1919. All arrears in interest paid and in 1924 bonds were extended to 1929 and on November 2, 1929 were extended to September 1, 1939 at 6% interest.
- 9. Atlantic Avenue Railroad, improvement gold 5's, 1934; defaulted interest January 1, 1920. All arrears in interest (\$200 per \$1000 bond) was paid in cash and bonds were reinstated under the Brooklyn Rapid Transit Company reorganization. Bonds were assumed in 1929 by by the Brooklyn and Queens Transit Corporation.
- 10. United Railways Company of St. Louis, 1st general gold 4's, 1934; interest defaulted July 1, 1924. All arrears in interest were paid by receiver on order of the court and bonds were undisturbed in the reorganization of the United Railways Company of St. Louis in 1927, and were assumed by the new company—St. Louis Public Service Company.
- (4) Four bond issues reported as in default were reinstated, viz.:
 - 1. Equitable Gas Light Company (Memphis, Tenn.), 1st 5's, 1929; de-

faulted interest May 1, 1920, which was paid June 17, 1920 with interest thereon. Subsequent interest paid and bonds redeemed at par at maturity.

- 2. Pittsburgh and Allegheny Telephone Company, 1st 5's, 1949; defaulted interest June 1, 1921. In November 1922, the Bell Telephone Company of Pennsylvania purchased the assets of this company, assumed the bonds, and guaranteed them as to principal and interest, and paid the defaulted interest with interest thereon at 6% which amounted to \$106.50 per \$1000 bond on April 1, 1923.
- Western Quebec Power Company, Ltd., 1st 6½'s, 1931; defaulted interest January 1, 1924, which was paid before April, 1924, and on July 1, 1924 the bonds were called for redemption at 105 and interest.
- Albia Light and Railway Company, 1st gold 5's, 1941; defaulted interest January 1, 1925, which was paid a few weeks later and regularly thereafter to date (1929).
- (5) Six bond issues reported as in default were reinstated, viz.:
 1. Atlas Crucible Steel Company, 1st gold 8's, series A, 1931; defaulted
 - interest January 1, 1924. About 1926 arrears in interest paid and interest rate reduced to 6%, which rate was paid until early in 1929 when bonds were retired at 102 and interest.

 2. J. H. Williams and Company, 5 year sinking fund gold 7's, series A,
 - 1925; defaulted principal and interest June 15, 1925. Subsequently (December 15, 1925) the company paid 20% on the principal and issued a new series of bonds for the remaining 80% under a new indenture dated June 15, 1925, which bonds were to mature June 15, 1930. This entire issue was called for redemption December 15, 1927
 - at par and accrued interest and paid.

 3. Dominion Iron and Steel Company, Ltd., 1st gold 5's, 1929; defaulted interest July 1, 1926. The Supreme Court of Nova Scotia ordered the trustee to pay all arrears of interest on July 2, 1927, and in June, 1929, ordered the trustee to pay the principal at maturity (July 1,
 - 4. Dominion Iron and Steel Company, Ltd., consolidated 5's, 1939; defaulted interest September 1, 1926. In March, 1928, the protective committee for these bonds sold the deposited bonds for 87½% of principal plus interest unpaid from March 1, 1926 to January 31, 1928, plus a sum sufficient to cover committee expenses. Holders received \$970.83 per \$1000 bond.

5. Nova Scotia Steel and Coal Company, Ltd., 1st mortgage sinking fund gold 5's, 1959; defaulted interest July 1, 1926. On November 2, 1926, and subsequently to January 1, 1929, interest due on these bonds was deposited by British Empire Steel Corporation which controls the company, and the interest was paid. Since January 1, 1929, the interest has been paid later. Sinking fund retirement also

continuing although interest charges are not being earned by the company.

6. Nova Scotia Steel and Coal Company, Ltd., 6% perpetual debenture

- stock; defaulted interest July 1, 1926. All interest has been paid although in recent years it is being paid late.
- One bond issue which defaulted was reinstated, viz.:
 Sapulpa Refining Company, 1st sinking fund gold 8's, 1931; defaulted interest May 1, 1924, subsequently paid, and interest rate reduced to 6½% starting May 1, 1924, at which rate it was paid until November
- 1, 1929 when all the outstanding bonds were called for payment at 100 and interest.
 Two bond issues which defaulted were reinstated, viz.:
 Lincoln Mills Ltd., 1st sinking fund gold 7½'s, 1942; defaulted interest August 1, 1924. All arrears in interest were paid and interest
- is being paid currently when due.

 2. Continental Paper and Bag Mills Corporation, 1st and refunding 6½'s, series A, 1944; defaulted interest February 1, 1928. Defaulted interest was paid in March, 1928, and all subsequent coupons have been provided for on their respective dates.

 (8) Three bond issues which defaulted were reinstated, viz.:
- Flanders Apartment Hotel (Chicago), 1st mortgage 6½'s, due serially
 to 1944 inclusive; defaulted interest September 15, 1925. Hotel is
 being operated under a receiver and all interest and serial payments
 have been made; funds to make up deficiencies due bondholders for
 interest and principal are being advanced by S. W. Straus & Company, Chicago, Illinois;
 - Post Office Square Company (Boston), general and refunding gold 6½'s, 1943; defaulted interest December 1, 1926. Interest is being paid about two and one-half years late.
 Ritz Carleton Hotel Company of Montreal, Ltd., 2nd gold 6's, due
- serially to October 1, 1923, extended to 1943; defaulted interest October 1, 1926, which was paid April 1, 1927. By end of 1927 interest was paid when due and has since been paid when due.
