CENTRAL PROVINCES ACT No. I OF 1920*

THE CENTRAL PROVINCES TENANCY ACT, 1920

[Published in the "Central Provinces Gazette" of the 31st January 1920.]

An Act to consolidate and amend the law relating to agricultural tenancies and village-service [lands]† in the Central **Provinces**

WHEREAS it is expedient to consolidate and amend the law relating to agricultural tenancies and village-service [lands] in the Central Provinces;

AND WHEREAS the previous sanction of the Governor-General required by section 79;, sub-section (2), of the Government of India Act, 1915 (5 and 6 Geo. 5 ch. 61), has been obtained to the passing of this Act;

It is hereby enacted as follows:—

CHAPTER L—PRELIMINARY

- 1. (1) This Act may be called the Central Provinces Short title, extent and Tenancy Act, 1920; commencement.
 - (2) It extends to the whole of the Central Provinces; and
- (3) [It] § shall come into force on such day ¶ as the Provincial Government may, by notification, direct.
- 2. In this Act, unless there is anything repugnant in the Definition. subject or context,--
- (1) the expressions "abadi," "agricultural year," "estate," "kamil-jama," "land-revenue," "legal practitioner," "mahal," "malik-makbuza," "patti," "proprietor," "record-of-rights," "Sambalpur Territory," "sir-land," "survey-number," and "village" have the meanings assigned to them, respectively, in the Central Provinces Land Revenue Act, 1917 (II of 1917):
 - (2) "Agriculture" includes—
 - (a) the raising of annual or periodical crops and garden produce:
 - (b) horticulture:
 - (c) the planting and upkeep of orchards; and
 - (d) the reserving of land for fodder, grazing or thatching

The rest of the Act came into force on the 1st May 1920, see Central Provinces Gazette, 1920, Part I, p. 306,

- (3) "arrear" means an instalment or part of an instalment of rent which is not paid on or before the date on which it is payable:
- (4) "holding" means a parcel of land held by a tenant of a landlord under one lease or one set of conditions:
- (5) "improvement" means, with reference to a holding, any work which adds materially to the letting value of the holding which is suitable thereto and consistent with the purpose for which it is held and which, if not executed on the holding, is either executed directly for its benefit or is, after execution, made directly beneficial to it; and, subject to the foregoing provisions, includes—
 - (a) the construction of tanks, wells, water-channels, embankments and other works for storage, supply or distribution of water for agricultural purposes;
 - (b) the construction of works for the drainage of land or for the protection of land from floods, or from erosion or other damage from water;
 - (c) the reclaiming, clearing, enclosing, levelling or terracing of land;
 - (d) the erection of buildings on or in the vicinity of the holding, elsewhere than in the abadi, required for the convenient or profitable use or occupation of the holding; and
- (e) the renewal or re-construction of any of the foregoing works, or alterations therein or additions thereto; but does not include—
 - (f) temporary wells and such water-channels, embankments, levellings, enclosures or other works, or petty alterations in or repairs to such works, as are commonly made by tenants of the locality in the ordinary course of agriculture; or
 - (g) any work which substantially diminishes the value of any land, wherever situated, in the occupation of any other person, whether as proprietor or tenant.

Explanation.—A work which benefits several holdings may be deemed to be an improvement with respect to each of such holdings:

- (6) "land" means land which is let or occupied for agricultural purposes or for purposes subservient thereto, and includes the sites of buildings appurtenant to such land:
- (7) "landlord" means the person of whom a tenant holds land, and to whom the tenant is, or but for a contract would be liable to pay rent for such land:
- (8) "pay", with its grammatical variations and cognate expressions, includes, when used with reference to rent, "deliver," with its grammatical variations and cognate expressions:
- (9) "rent" means whatever is paid or payable in money or kind by a tenant on account of the use or occupation of land held by him:

- (10) "Revenue Officer", in any provision of this Act means such Revenue Officer appointed under the Central Provinces Land Revenue Act, 1917 (II of 1917), as the Provincial Government may, by notification, direct to discharge the functions of a Revenue Officer under that provision, and shall include a Settlement Officer:
- (11) "tenant" means a person who holds land of another person, and is, or but for a contract would be, liable to pay rent for such land to such other person, but does not include—

(a) a farmer, mortgagee or thekadar of proprietary rights;

or

(b) a person to whom only the right to cut grass, or to graze cattle, or to grow singhara (Trapa bispinosa), or to propagate or collect lac is granted; or

(c) a servant holding land as his remuneration and not

liable to pay any rent.

Explanation I.—An inferior proprietor is not, as such, a tenant.

Explanation II.—The holder of a survey number in a village let in farm by Government, or held by a gaontia in the Sambal-pur Territory, is a tenant of the farmer or gaontia for the time being.

3. There shall be three classes of tenants, namely—

Classes of

(1) absolute occupancy tenants;

(2) occupancy tenants; and

(3) sub-tenants.

CHAPTER II.—ABSOLUTE OCCUPANCY TENANT

4. Every person who, at the commencement of this Act, is Definition the tenant of any holding in respect of which he, or a person of "absolute whose rights he had acquired, had been recorded in any record-occupancy of-rights made before the first day of January 1884, as an "absolute occupancy raiyat," or in terms equivalent thereto, shall unless he had parted with his rights, be deemed to be an absolute occupancy tenant of such holding.

5. The interest of an absolute occupancy tenant in his Rights of holding shall on his death pass by inheritance or survivorship in succession. accordance with his personal law.

*[6. (1) An absolute occupancy tenant may transfer any Rights of right in his holding without reference to his landlord to the transfer extent and in the manner herein indicated, namely—

*[6. (1) An absolute occupancy tenant may transfer any Rights of right in his holding without without the second content of the property of the pr

(a) he may transfer any right in his holding to a co-tenant to the or to any person who, if he survived the tenant landlord. without nearer heirs, would inherit his right; or

(b) he may mortgage any right in his holding by a simple mortgage or by a mortgage by conditional sale as defined in the Transfer of Property Act, 1882 (IV of 1882); or

(c) he may sublet any right in his holding for a priod not

exceeding five years.

(2) An absolute occupancy tenant shall be competent to bequeath by will subject to his personal law any right in his holding only to a co-tenant or to any person who, if he survived the tenant without nearer heirs, would inherit his right.

Rights of transfer in other cases and landlord's right of pre-emption.

- 6-A. In respect of a transfer by an absolute occupancy tenant of any right in his holding to an extent or in a manner not provided for in sub-section (1) of section 6, or the sale or foreclosure of such right under a decree or order of a Civil Court, or the sale of such right under an order of a Revenue Officer or the sale of such right under an order made in pursuance of the provisions of the Central Provinces Co-operative Land Mortgage Banks Act, 1937 (C. P. Act I of 1937), the following provisions shall apply:—
 - (1) If the tenant intends to make a transfer to an extent or in a manner not provided for in sub-section (1) of section 6, he shall give his landlord a written notice of his intention, stating therein the particulars of the intended transfer including, if the intended transfer is by sale, the amount of the consideration for which he intends to transfer the right, and shall defer proceeding with the transfer for a period of thirty days from the date on which the notice is delivered.
 - (2) The landlord may, within fifteen days from the date on which the notice under sub-section (1) is delivered, give written notice to the tenant of his intention to purchase the right which is intended to be transferred, or to permit the transfer.
 - (3) If the landlord fails to give notice as provided for in sub-section (2), he shall be deemed to have permitted the intended transfer.
 - (4) If the landlord gives notice to the tenant of his intention to purchase the right, he shall be entitled to purchase it,—
 - (i) if the intended transfer is by sale, for the amount of the consideration stated in the notice, or
 - (ii) if the intended transfer is otherwise than by sale, for a sum equal to the value, fixed by a Revenue Officer, of the right intended to be transferred.
 - (5) If the landlord is entitled to purchase the right, and
 - (a) if the intended transfer is by sale, he may purchase the right from the tenant by private sale within thirty days from the date on which the notice under sub-section (1) is delivered or apply within that period to a Revenue Officer, in the manner hereinafter provided, or
 - (b) if the intended transfer is otherwise than by sale, he may apply, within thirty days from the date on which the notice under sub-section (1) is delivered, to a Revenue Officer, in the manner hereinafter provided

- (6) If the landlord gives notice of his intention to purchase the right, but fails to purchase it by private sale or to apply to a Revenue Officer, in the manner hereinafter provided, the tenant may proceed with the intended transfer or enforce specific performance by the landlord in the manner hereinafter provided:
- (7) If the landlord permits the intended transfer or is deemed to have permitted it, he shall be entitled by way of consent money,—
 - (i) if the transfer is by sale, to a sum equal to three per cent of the consideration stated in the sale-deed or the annual rent of the holding or part of the holding, the right in which is transferred, whichever is greater, or

(ii) if the transfer is otherwise than by sale, to a sum equal to the annual rent of the holding or part of the holding, the right in which is transferred.

- (8) If the tenant makes a transfer of any right in his holding in contravention of the foregoing provisions of this section and if the transferee temporarily or permanently obtains possession of the right, the landlord shall be entitled at his option,—
 - (a) if the transfer is by sale and the consideration for the right transferred can be determined from the sale deed, to purchase the right through a Revenue Officer, in the manner hereinafter provided, for the amount of the consideration stated in the sale deed, or to receive consent money of a sum equal to three per cent of such consideration or the annual rent of the holding or part of the holding, the right in which is transferred, whichever is greater, or
 - ever is greater, or

 (b) if the transfer is by sale and the consideration for the right transferred cannot be determined from the sale deed or if the transfer is otherwise than by sale, to purchase the right through a Revenue Officer, in the manner hereinafter provided, for a sum equal to the value, fixed by the Revenue Officer, of the right transferred, or to receive consent money of a sum equal to the annual rent of the holding or part of the holding, the right in which is transferred.
- (9) If the landlord permits the intended transfer or is deemed to have permitted it, if the transferee temporarily or permanently obtains possession of the right and if it appears that the notice given under sub-section (1) was incorrect in material particulars as compared with the deed of transfer executed by the tenant, the landlord shall be entitled at his option to purchase the right through a Revenue Officer or to receive consent money as provided for in sub-section (8):

Provided that if the transfer is by sale and the consideration for the right transferred can be determined from the sale deed, the landlord shall be entitled to purchase the right or to receive consent money on the basis of the amount of the consideration stated either in the notice or in the sale deed at his option.

(10) If any right in the holding is sold in execution of, or foreclosed under, a decree or order of a Civil Court, other than a decree obtained by the landlord, or is sold under an order of a Revenue Officer other than an order obtained by the landlord or under an order made in pursuance of the provisions of the Central Provinces Co-operative Land Mortgage Banks Act, 1937 (C. P. Act I of 1937), and if, in pursuance of such sale or foreclosure, any person, other than a person specified in clause (a) of sub-section (1) of section 6, obtains possession of such right, the landlord shall be entitled at his option,—

(a) if the right is sold and no other immovable property is sold along with it in one lot, to purchase the right through a Revenue Officer, in the manner hereinafter provided, for the amount of the purchase money, or to receive consent money of a sum equal to three per cent of such amount or the annual rent of the holding or part of the holding, the right in which is transferred, which-

ever is greater, or

(b) if the right is sold along with other immovable property in one lot, or if the right is foreclosed, to purchase the right through a Revenue Officer, in the manner hereinafter provided, for a sum equal to the value, fixed by the Revenue Officer, of the right sold or foreclosed or to receive consent money of a sum equal to the annual rent of the holding or part of the holding, the right in which is transferred.

(11) (a) If the landlord elects to purchase the right through a Revenue Officer under sub-section (5), sub-section (8), sub-section (9) or sub-section (10) and the value of the right is not required to be fixed by the Revenue Officer, the landlord shall deposit the necessary amount in the office of a Revenue Officer and apply to him to get a sale deed executed by the tenant or the transferee, as the case may be, and put him in possession of the right.

(b) If, on such application being made, the Revenue Officer is satisfied that the amount so deposited is the amount to which the tenant or the transferee, as the case may be, is entitled, he shall, subject to rules made under section 109, call upon the tenant or the transferee, as the case may be, to execute the sale deed and if the tenant or the transferee neglects or refuses to execute it, execute it on his behalf, pay the amount deposited to the tenant or the transferee, as the case may be, deliver the

sale deed to the landlord and put him in possession of the right.

- (12) (a) If the landlord elects to purchase the right through a Revenue Officer under sub-section (5) sub-section (8), sub-section (9) or sub-section (10) and the value of the right is required to be fixed by the Revenue Officer, the landlord shall apply to a Revenue Officer to fix the value of the right and the Revenue Officer shall, in accordance with rules made under section 109, fix the value thereof.
- (b) If the right is already mortgaged or charged, the Revenue Officer shall fix the value of the right as if it were not mortgaged or charged and if the landlord is put in possession under clause (d), the mortgage debt or charge shall be a charge on the purchase money in exoneration of the land.
- (c) On the value of the right being fixed by the Revenue Officer, the landlord shall, within such period, not less than one month, as may be ordered by the Revenue Officer, deposit in his office the sum so fixed.
- (d) On such deposit being made, the Revenue Officer shall, subject to rules made under section 109, call upon the tenant or the transferee, as the case may be, to execute the sale deed, and if the tenant or the transferee neglects or refuses to execute it, execute it on his behalf, deliver the sale deed to the landlord and put him in possession of the right and the sum deposited shall, subject to the rights of the mortgagee or the charge-holder under clause (b), be paid to the tenant or the transferee, as the case may be.
- (e) If the landlord fails to make the deposit within the time prescribed, he shall be deemed to have waived his claim in respect of the right.
- (13) If there are crops standing on the land of which the landlord has to be put in possession under clause (b) of sub-section (11) or clause (d) of sub-section (12), he shall be put in possession of the land after such crops have been reaped.
- (14) Any sum to which the landlord is entitled as consent money under this section shall be recoverable from the transferee as an arrear of rent of the holding or part of the holding, the right in which is transferred.
- (15) Notwithstanding anything contained in this section, if any right in the holding is sold by the tenant, the landlord shall, on the ground that the consideration is fraudulently stated in the sale deed and does not represent the actual consideration, be entitled to institute a civil suit for purchasing the right for a consideration to be determined by the Civil Court.
- (16) If the tenant elects to enforce specific performance by the landlord under sub-section (6), he shall file a duly executed sale deed in the office of a Revenue Officer and apply to the Revenue Officer to recover from the landlord and pay him the amount due to him and put the landlord in possession of the right.

• Officer is satisfied that the sale deed so filed is in accordance with the notice given under sub-section (1), he shall, subject to rules made under section 109, call upon the landlord to deposit the necessary amount together with interest at six per cent per annum on such amount from the date on which the notice under sub-section (2) was delivered to the tenant and if the landlord neglects or refuses to deposit the total amount, recover it in the same manner as an arrear of land revenue, pay it to the tenant, deliver the sale deed to the landlord and put him in possession of the right.

Explanation.—For the purpose of this section the rent of a part of a holding shall be deemed to be a sum which bears the same proportion to the rent of the whole holding as the part bears to the whole holding.]

Absolute occupancy tenants not liable to ejectment. Rent fixed for period of settlement.

- 7. Notwithstanding any contract to the contrary, an absolute occupancy tenant shall not be ejected from his holding by his landlord as such for any cause.
- 8. The rent of the holding of every absolute occupancy tenant shall be fixed by the Settlement Officer at each settlement of the area in which such holding is comprised, and the rent so fixed shall not be altered during the currency of the settlement, except under sections 56, 57, *[61-A], 62, †[63-A] or 64.

Power to declare absolute occupancy tenants as malik-makbuzas.

‡[8-A. (1) Subject to rules made under section 109, a Revenue Officer may, except in such areas as the Provincial Government may, by notification, exclude from the operation of this section, on an application made by an absolute occupancy tenant and on his depositing ten times the rent of the holding for being paid to the landlord of whom he holds the holding, declare such tenant to be a malik-makbuza of the land comprised in the holding, fix the amount of land revenue payable for such land and pay the landlord the amount deposited by the tenant:

Provided that no such application shall lie in respect of a part of a holding.

- (2) A declaration made under sub-section (1) shall take effect from the commencement of the agricultural year next following the date of such declaration.
- (3) A declaration made under sub-section (1) of an absolute occupancy tenant as a malik-makbuza of the land comprised in his holding shall not affect the rights in trees standing in such land on the date on which the declaration takes effect.]

CHAPTER III.—OCCUPANCY TENANTS

- 10. Every tenant who is not an absolute occupancy tenant Definition of or a sub-tenant is an occupancy tenant. "occupancy tenant".
- *[11. The interest of an occupancy tenant in his holding Rights of shall on his death pass by inheritance or survivorship in accord-succession. ance with his personal law.]
- †[12. (1) An occupancy tenant may transfer his holding Rights of only to the extent and in the manner herein indicated, namely:— transfer.

(a) he may sublet any right in his holding for a period not exceeding five years; or

- (b) he may transfer by sale or otherwise, except by a simple mortgage as defined in the Transfer of Property Act, 1882 (IV of 1882), any right in his holding to any co-tenant or person who, if he survived the tenant without nearer heirs, would inherit his right; or
- (c) he may transfer by sale any right in his holding to any other person.
- (2) Except in pursuance of a transfer permitted by this Act, or in pursuance of a document registered before the twenty-first day of October, 1898, no decree or order shall be passed for the sale or foreclosure of any right of an occupancy tenant in his holding, nor shall such right be attached or sold in execution of any decree or order, nor shall a receiver be appointed to manage such holding under section 51 of the Code of Civil Procedure, 1908 (V of 1908), nor shall such right vest in the Court or in a receiver under the Provincial Insolvency Act, 1920 (V of 1920).
- (3) Nothing in sub-section (2) shall apply to a decree or order for the recovery of an arrear of rent of the holding of an occupancy tenant.
- (4) Nothing in this section shall prevent an occupancy tenant from transferring any right in his holding to secure payment of, or shall affect the right of the Crown to sell such right for the recovery of, an advance made to him under the Land Improvement Loans Act, 1883 (XIX of 1883), or the Agriculturists' Loans Act, 1884 (XII of 1884).
- (5) Nothing in this section shall prevent an occupancy tenant from transferring any right in his holding to secure payment of an advance made to him by a land mortgage bank established under the Co-operative Societies Act, 1912 (II of 1912), or a land mortgage bank established by Government under any other enactment, or shall affect the right of the bank to sell such right for the recovery of such advance, notwithstanding the forfeiture or the extinction of the tenant right in any manner whatsoever, provided the bank discharges all liabilities of the tenant in respect of arrears of rent'due on account of the holding.

(6) Notwithstanding anything contained in the Indian Registration Act, 1908 (XVI of 1908), no officer empowered to register documents thereunder shall admit to registration any document which purports to contravene the provisions of this section.

Pre-emption by the landlord.

- 12-A. In respect of a sale by an occupancy tenant of any right in his holding as provided for in clause (c) of sub-section (1) of section 12 or the sale of such right in execution of a decree or order of a Civil Court or the sale of such right under an order of a Revenue Officer or the sale of such right under an order in enforcement of a transfer made under sub-section (5) of section 12, the following provisions shall apply:—
 - (1) If the tenant intends to make a sale as provided for in clause (c) of sub-section (1) of section 12, he shall give his landlord a written notice of his intention, stating therein the particulars of the intended sale including the amount of the consideration for which he intends to sell the right, and shall defer proceeding with the sale for a period of thirty days from the date on which the notice is delivered.
 - (2) The landlord may, within fifteen days from the date on which notice under sub-section (1) is delivered, give written notice to the tenant of his intention to purchase the right which is intended to be sold, or to permit the sale.
 - (3) If the landlord fails to give notice as provided for in sub-section (2), he shall be deemed to have permitted the intended sale.
 - (4) If the landlord gives notice to the tenant of his intention to purchase the right, he shall be entitled to purchase it for the amount of the consideration stated in the notice.
 - (5) If the landlord is entitled to purchase the right, he may purchase the right from the tenant by private sale within thirty days from the date on which the notice under sub-section (1) is delivered or apply within that period to a Revenue Officer, in the manner hereinafter provided.
 - (6) If the landlord gives notice of his intention to purchase the right, but fails to purchase it by private sale or to apply to a Revenue Officer, in the manner hereinafter provided, the tenant may proceed with the intended sale or enforce specific performance by the landlord in the manner hereinafter provided.
 - (7) If the landlord permits the intended sale or is deemed to have permitted it, he shall be entitled to consent money of a sum equal to five per cent of the consideration stated in the sale deed or one and a half times the annual rent of the holding or part of the holding, the right in which is sold, whichever is greater.

(8) If the tenant makes a sale of any right in his holding in contravention of the foregoing provisions of this section and if the purchaser temporarily or permanently obtains possession of the right, the land-lord shall be entitled at his option,—

(a) if the consideration for the right sold can be determined from the sale deed, to purchase the right through a Revenue Officer, in the manner hereinafter provided, for the amount of the consideration stated in the sale deed or to receive consent money of a sum equal to five per cent of the consideration or one and a half times the annual rent of the holding or part of the holding, the right in which is sold, whichever is greater, or

(b) if the consideration for the right sold cannot be determined from the sale deed, to purchase the right through a Revenue Officer, in the manner hereinafter provided, for a sum equal to the value, fixed by the Revenue Officer, of the right sold or to receive consent money of a sum equal to one and

a half times the annual rent of the holding or part of the holding, the right in which is sold.

(9) If the landlord permits the intended sale or is deemed to have permitted it, if the purchaser temporarily or permanently obtains possession of the right and if it appears that the notice given under sub-section (1) was incorrect in material particulars as compared with the sale deed, the landlord shall be entitled at his option to purchase the right through a Revenue Officer or to receive consent money as provided for in sub-section (8):

Provided that if the consideration for the right sold can be determined from the sale deed, the landlord shall be entitled to purchase the right or to receive consent money on the basis of the amount of the consideration stated either in the notice or in the sale deed at his option.

(10) If any right in the holding is sold in execution of a decree or order of a Civil Court other than a decree obtained by the landlord or under an order of a Revenue Officer other than an order obtained by the landlord or under an order in enforcement of a transfer made under sub-section (5) of section 12 and if in pursuance of such sale any person, other than a person specified in clause (b) of sub-section (1) of section 12, obtains possession of such right, the landlord shall be entitled at his option,-

(a) if the right is sold and no other immovable property is sold along with it in one lot, to purchase the right through a Revenue Officer, in the manner hereinafter provided, for the amount of the purchase money paid at the sale, or to receive consent money of a sum equal to five per cent of such amount or one and a half times the annual rent of the holding or part of the holding, the right in which is sold, whichever is greater, or

- (b) if the right is sold along with other immovable property in one lot, to purchase the right through a Revenue Officer, in the manner hereinafter provided, for a sum equal to the value, fixed by the Revenue Officer, of the right sold or to receive consent money of a sum equal to one and a half times the annual rent of the holding or part of the holding, the right in which is sold.
- (11) (a) If the landlord elects to purchase the right through a Revenue Officer under sub-section (5), sub-section (8), sub-section (9) or sub-section (10) and the value of the right is not required to be fixed by the Revenue Officer, the landlord shall deposit the necessary amount in the office of a Revenue Officer and apply to him to get a sale deed executed by the tenant or the purchaser, as the case may be, and put him in possession of the right.
- (b) If, on such application being made, the Revenue Officer is satisfied that the amount so deposited is the amount to which the tenant or the purchaser, as the case may be, is entitled, he shall, subject to rules made under section 109, call upon the tenant or the purchaser, as the case may be, to execute the sale deed, and if the tenant or the purchaser neglects or refuses to execute it, execute it on his behalf, pay the amount deposited to the tenant or the purchaser, as the case may be, deliver the sale deed to the land-lord and put him in possession of the right.
- (12) (a) If the landlord elects to purchase the right through a Revenue Officer under sub-section (5), sub-section (8), sub-section (9) or sub-section (10) and the value of the right is required to be fixed by the Revenue Officer, the landlord shall apply to a Revenue Officer to fix the value of the right and the Revenue Officer shall in accordance with rules made under section 109, fix the value thereof.
- (b) If the right is already mortgaged or charged, the Revenue Officer shall fix the value of the right as if it were not mortgaged or charged, and if the land-lord is put in possession under clause (d), the mortgage debt or charge shall be a charge on the purchase money in exoneration of the land.
- (c) On the value of the right being fixed by the Revenue Officer, the landlord shall, within such period, not less than one month, as may be ordered by the Revenue Officer, deposit in his office the sum so fixed.
- (d) On such deposit being made, the Revenue Officer shall, subject to rules made under section 109, call upon the tenant or the purchaser, as the case may be, to execute the sale deed, and if the tenant or the purchaser neglects or refuses to execute it, execute it on his behalf, deliver the sale deed to the landlord and put him in possession of the right and the

sum deposited shall, subject to the rights of the mortgagee or the charge-holder under clause (b), be paid to the tenant or the purchaser, as the case may be.

- (e) If the landlord fails to make the deposit within the time prescribed, he shall be deemed to have waived his claim in respect of the right.
- (13) If there are crops standing on the land of which the landlord has to be put in possession under clause (b) of sub-section (11) or clause (d) of sub-section (12), he shall be put in possession of the land after such crops have been reaped.
- (14) Any sum to which the landlord is entitled as consent money under this section shall be recoverable from the purchaser as an arrear of rent of the holding or part of the holding, the right in which is sold.
- (15) Notwithstanding anything contained in this section, if any right in the holding is sold by the tenant, the landlord shall, on the ground that the consideration is fraudulently stated in the sale deed and does not represent the actual consideration, be entitled to institute a civil suit for purchasing the right for a consideration to be determined by the Civil Court.
- '16) If the tenant elects to enforce specific performance by the landlord under sub-section (6), he shall file a duly executed sale deed in the office of a Revenue Officer and apply to the Revenue Officer to recover from the landlord and pay him the amount due to him and put the landlord in possession of the right.
- (17) If, on such application being made, the Revenue Officer is satisfied that the sale deed so filed is in accordance with the notice given under sub-section (1), he shall, subject to rules made under section 109, call upon the landlord to deposit the necessary amount together with interest at six per cent per annum on such amount from the date on which the notice under sub-section (2) was delivered to the tenant, and if the landlord neglects or refuses to deposit the total amount, recover it in the same manner as an arrear of land revenue, pay it to the tenant, deliver the sale deed to the landlord and put him in possession of the right.

Explanation.—For the purpose of this section the rent of a part of a holding shall be deemed to be a sum which bears the same proportion to the rent of the whole holding as the part bears to the whole holding.]

order made under any law for the time being in force, such holding is knocked down to a stranger, the following persons may claim to take it at the sum last bid in the following order:—

- (a) any co-tenant,
- (b) any person who, if he survived the tenant without nearer heirs, would inherit his right.
- (2) No such claim shall be allowed unless it is made within thirty days from the date of sale and accompanied by a deposit of twenty-five per cent of the amount of the last bid.
- (3) The amount of the balance of the last bid shall be paid by the claimant within fifteen days from the date of his claim being allowed, and if such amount is not paid, the deposit shall be forfeited to the Crown.
- (4) If a claim under sub-section (1) is allowed and the amount of the balance of the last bid is paid by the claimant, the sale shall be set aside, the auction-purchaser shall be repaid the amount of the purchase money deposited by him, the amount paid by the claimant shall be applied towards the satisfaction of the amount recoverable under the decree or order and he shall be given a certificate, specifying his name, the date of the auction sale, the amount of the pre-emption money and the property pre-empted and shall be put in possession of the property.]

13. If an occupancy tenant transfers his right in his holdtam persons ing or any portion thereof in contravention of section 12, *[any co-tenant or] any person who, if he survived the tenant without nearer heirs, would inherit the holding, or the landlord of such tenant may apply to a Revenue Officer to be placed in possession, subject, so far as the Revenue Officer may, in accordance with rules made under section 109, determine, to his acceptance of the liabilities of the tenant for arrears and for advances for necessary expenses of cultivation.

Procedure on application to set aside transfers.

- 14. (1) If an application is made under section 13, the Revenue Officer may, after such inquiry as he thinks fit, reject the application on the ground that the transfer was in accordance with section 12.
- (2) If the Revenue Officer finds that the transfer was not in accordance with section 12, he shall issue a notice to all persons who seem to him prima facie to have a right equal, or prior, to that of the applicant and shall also cause a proclamation to issue in the village in or from which the holding was cultivated, inviting all persons claiming to be heirs of the tenants to appear before him on a date fixed, and shall, after hearing all of such persons as appear and any other persons who may apply to be heard, decide who, from among such of them as desire to be placed in possession, is first entitled to be so placed, and shall determine what amount, if any, is payable on account of the liabilities of the tenant specified in section 13 and the period within which such amount shall be deposited in his office, and

shall place such person in possession on his depositing this amount within such period:

Provided that—

(i) no person who has consented to the transfer in writing shall be entitled to be placed in possession under

this section;

- (ii) if the transfer has been by sub-lease and the Revenue Officer is satisfied that the tenant is able and willing to cultivate the holding, the Revenue Officer may replace the tenant in possession of the holding on repayment to the sub-tenant of any consideration which it is proved has been paid for the sub-lease, and to the applicant of the costs incurred by him in the application.
- *[(3) As among several persons so entitled and being desirous of being placed in possession, the right to be so placed shall accrue to a co-tenant, if any, and failing any such cotenant, in the order in which persons entitled to inherit the right of the tenant in the subject of the transfer, would have inherited it, if the tenant had died, and failing any such persons, the right shall accrue to the landlord.
- (4) The Revenue Officer shall determine the proportions in which the amount deposited under sub-section (2), should be distributed between the landlord and other persons for arrears of rent or for the repayment of advances made for the necessary expenses of cultivation, and shall make payment accordingly.

- (b) on the application of the landlord, by order of a Revenue Officer, in accordance with the provisions of section 56, 62 or 63, or on the ground that—
 - (i) the rate of rent is below the rate paid by occupancy tenants for land of a similar description and with similar advantages in the same village or neighbouring villages, and that there is no sufficient reason for the tenant holding at so low a rate;
 - (ii) there has been a rise in the local prices of produce since the rent was fixed;
 - (iii) since the rent was last fixed, there has been a permanent increase in the total area in cultivation within the holding:

or any other ground declared by the Provincial Government to justify an enhancement:

Provided that-

- (1) except as provided in section 56, 62, *[63 or 63-A], the rent of any such holding shall not be enhanced—
 - (i) within ten years of such rent having been fixed at any settlement or under any provision of this Act except section 56, 62, *[63 or 63-A]; or
 - (ii) with ten years of the full enhancement of a progressive rent fixed under section 66 having become payable;
- (2) no order shall be made for the enhancement of rent which is inconsistent with any contract made after the current settlement and still in force, such contract being consistent with this Act.

Procedure on enhancement by agreement.

17. If the rent of an occupancy tenant is enhanced by agreement, such enhancement shall not take effect, notwith-standing such agreement, unless and until the landlord has given notice to the Tahsildar of such enhancement in accordance with rules made under section 109, and until the commencement of the agricultural year following the date of giving such notice.

Procedure for enhancement on application ment, to a Revenue Officer.

- 18. (1) If a landlord wishes to enhance the rent of an occupancy tenant and the tenant does not agree to such enhancement, he may apply to a Revenue Officer for an order of enhancement.
- (2) Such application may be made in respect of any number of tenants collectively:

Provided that all such tenants are tenants of the same landlord and of the same mahal or patti.

Tenant's improve-ments how to be treated in fixing rents.

19. If the land, in respect of which an application under section 18 is made, has been improved in accordance with this Act by the tenant, and such improvement was made during the term of the current settlement or the term of the settlement immediately preceding it, the quality and advantages of the

- (a) any rent which has fallen due to him in respect of the holding within the previous or current agricultural vear; and

- (2) If the Court on inquiry finds the landlord's claim to the whole or any part of the rent to be proved, it shall sell the produce or such portion thereof as it may deem necessary, and shall apply the proceeds of the sale, in the first instance, to satisfy such claim.

Ejectment for diversion.

- *[25. (1) Notwithstanding any contract to the contrary, an occupancy tenant shall not be liable to be ejected from his holding except in execution of a decree of a Civil Court in a suit for ejectment brought by the landlord on the ground of his having diverted the land to non-agricultural purposes.
- (2) A suit for the ejectment of an occupancy tenant under sub-section (1) shall not be entertained, unless the landlord has given the tenant a written notice calling upon him, if the damage caused by the diversion is capable of remedy, to remedy the same, or to pay reasonable compensation for the damage, and the tenant has failed to comply with the notice within a reasonable time.
- (3) A decree passed in a suit for ejectment under sub-section (1) may direct the ejectment of the tenant from the holding or from such portion of the holding as has been diverted to non-agricultural purposes or from that portion and such additional land as may be necessary for the reasonable enjoyment of that portion.
- (4) Such decree shall further direct that if the tenant repairs the damage or pays such compensation to the landlord as the Court thinks fit within one month from the date of the decree, or such further time as the Court may for reasons to be recorded allow, it shall not be executed.]
- 26. (1) If, in any suit for arrears against an occupancy tenant, the tenant at any time before a decree is passed pleads that his rent is excessive, the Court shall enquire into the circumstances of the rent.
- (2) If the Court finds that the rent payable by the tenant has been enhanced by contract or consent above the rent determined by a Settlement Officer at the current settlement or by a Revenue Officer under this Act, or, if not so determined, above the rent at which the holding was first taken up by the tenant, the Court may stay the proceedings and refer the case to a Revenue Officer, who shall thereupon fix a fair and equitable rent for the holding, and if the rent so fixed is equal to or more than the rent previously payable, the Court shall decree the arrears claimed and proved, or, if the rent so fixed is less than the rent previously payable, the Court shall decree against the tenant arrears on account of any year only to the extent of the amount, if any, by which his payment for that year fell short of such rent, and the tenant shall be entitled to remain in occupation at such rent from the commencement of the agricultural year next following the date of the institution of the suit.
- (3) If the Court finds that the rent, in respect of which the plea is made by the tenant, was not enhanced or determined in the manner specified in sub-section (2), but was the rent at which the tenant first took up the holding from the landlord, the Court shall pass a decree for such sum as may be due at the rent so payable, but may, before or after passing the decree, refer the case to a Revenue Officer, who shall thereupon fix a fair and equitable rent for the holding, and, if the tenant pays the amount decreed within one month from the date on which the

- (i) a tenant shall not be entitled to retain possession of any land or receive any sum in respect thereof under this section if, after the commencement of proceedings by the landlord for his ejectment, he has cultivated or prepared such land contrary to local usage;
- (ii) the rent, if any, payable to the landlord by the tenant at the time of ejectment may be set off against any sum payable to the tenant under this section.
- (2) The Court or Revenue Officer ejecting the tenant shall determine the amount, if any, payable under sub-section (1).

Right of tenant on ejectment to compensation for improvements.

If an occupancy tenant or his predecessor in interest has made an improvement in respect of his holding, he shall not be ejected until he has received compensation for such improvement, unless it was begun after the institution of the proceedings which resulted in the decree or order for ejectment, but no such compensation shall be claimable, if the tenant has made such improvement in pursuance of a contract binding him, in consideration of some substantial advantage to be obtained by him, to make the improvement without compensation, and has obtained such advantage.

Right of tenant on ejectment to remove all things attached to the earth.

- *[30-A. (1) Without prejudice to any other right under the foregoing sections, if an occupancy tenant, who, after diverting his holding to non-agricultural purposes, is ejected therefrom in execution of a decree of a Civil Court, or if such a tenant or his transferee loses possession of the holding in favour of the landlord under section 14, he shall, at any time before he is ejected or loses possession, he entitled to remove therefrom all things which he has attached to the earth: provided that he shall leave the holding in the state in which it was before the diversion.
- (2) If the holding is not left in the state in which it was before the diversion the landlord may apply to a Revenue Officer for assessment of the compensation for the damage thereby caused.

Execution of a decree for ejectment of tenant who has made improvement.

- 31. (1) If a Civil Court makes a decree for the ejectment of an occupancy tenant, it shall ascertain whether he claims to an occupancy have made any improvement, and, if so, shall refer the question of the amount of compensation due to a Revenue Officer, and shall stay the execution of the decree pending the order of the Revenue Officer.

CHAPTER IV.—SUB-TENANTS

 - (a) who holds, as a tenant, land from a malik-makbuza or from the holder of a survey number, and who is not an absolute occupancy tenant or was not recorded in the Settlement Records of the last Settlement made before this Act came into force as an occupancy tenant, or
- (b) who holds sir-land as a tenant, shall be deemed to be a sub-tenant of such land.

Tenure to be according to agreement.

38. Except as otherwise provided for in this Act, a subtenant shall hold on such terms as may be agreed upon between him and his landlord:

Provided that-

- (i) notwithstanding any contract to the contrary, a lease granted to a sub-tenant by an occupancy tenant shall not be valid for a period exceeding [five years]*;
- (ii) if, at the time of the subletting of the land, the tenant is a co-sharer in the mahal or patti in which the land lies, and does not hold the land sublet as an absolute occupancy tenant, the sub-tenant shall have the rights of an occupancy tenant.

Devolution of tenure.

CHAPTER V.—VILLAGE SERVANT

Definition of [village service land]*.

42. Land which is recorded in the papers of the current settlement as, or which may, during the currency of the settlement, be declared by order of a Revenue Officer to be held by a village-servant rent-free or on favourable terms on condition of rendering village-service is a [village-service land]*

Devolution of villageservant's rights in [his villageservice land]†. 43. If a village-servant dies, resigns or is lawfully dismissed, his right in his [village-service land]† shall pass to his successor in office.

Restrictions on transfer of villageservant's rights in [his villageservice land]‡.

- 44. (1) A transaction by which a village-servant attempts to transfer his interest in his [village-service land]! by sale, gift, mortgage, sub-lease or otherwise, except by a sub-lease for a period not exceeding one year, shall be void.
- (2) The right of a village-servant in [his village-service land]‡ shall not be attached or sold in execution of a decree, nor shall a receiver be appointed to manage [such land]‡ under section 51 of the Code of Civil Procedure, 1908 (V of 1908).

Grounds on which a villageservant may be ejected.

CHAPTER VII.—IMPROVEMENTS

Summary inquiry by Revenue Officer.

59. Date from which order fixing rent operates.

60. An order fixing, altering or commuting the rent of a holding shall take effect from the commencement of the agricultural year next following the date of application, or from any subsequent day, or, if it is made on the ground of increase, diminution or deterioration of the holding, from the date of such increase, diminution or deterioration, unless the order directs that it shall take effect from any date subsequent thereto.

Time for payment of rent.

61. Rent shall be payable in such instalments and on such dates as the Provincial Government may, by notification, prescribe, and, in the absence of such notification, according to the contract between the parties, or, where there is no such contract, according to local usage.

Power to reduce rent during currency of settlement.

- *[61-A. (1) If, at any time, during the currency of the settlement, the Provincial Government finds that, having regard to changes in general conditions subsequent to settlement, it is desirable that the rent payable by an absolute occupancy tenant or occupancy tenant should be reduced, it may reduce such rent for such period as it may deem fit.
- (2) An order made under sub-section (1) shall take effect from the commencement of the agricultural year next following the date thereof, unless the Provincial Government otherwise directs.]

Power to alter rent when holding is increased, diminished or deteriorated. 62. If the area of a holding, the rent of which is payable in money, is increased or diminished by fluvial action or otherwise, or if the soil of a holding is, without the fault of the tenant, permanently deteriorated by a deposit of sand or by any other circumstances, a Revenue Officer may, notwithstanding any contract between the parties, on the application of the landlord or of the tenant, alter the rent with reference to such increase, diminution or deterioration.

Power to alter rent in case of new assessment. 63. If a landlord grants a lease, or makes any other contract fixing the rent of any holding, and, if while such lease or contract is in force,—

(a) land revenue is for the first time made payable in res-

pect of the holding, or

(b) land-revenue having been previously payable in respect of it, the land revenue payable when such lease or contract was granted or made is increased or diminished.

a Revenue Officer may, notwithstanding any contract to the contrary, on the application of the landlord or of the tenant, alter the rent with reference to the land revenue.

Atteration of rent of holding on diversion to nonagricultural purposes. †[63-A. (1) Where a tenant has diverted the whole or any part of his holding to non-agricultural purposes, a Revenue Officer may, either on his own motion or on the application

of the landlord, alter the rent of such holding with reference to its increased value:

Provided that he shall not alter the rent of an occupancy holding on his own motion unless the landlord has failed, within two years from the date of such diversion, to institute a civil suit for the ejectment of the tenant.

- (2) Where the whole or any part of a holding has been diverted to non-agricultural purposes, and is subsequently re-converted to agricultural purposes, a Revenue Officer may, on the application of either the landlord or tenant, alter the rent of such holding with reference to its decreased value.
- (3) Where the rent of a tenant's holding is so altered, he shall have the same rights therein as he had in it before its diversion to non-agricultural purposes.
- 64. (1) If a tenant, other than a sub-tenant, pays rent for Commutaa holding either in kind, or on the estimated value of a por-tion of rent tion of the crop, or at rates varying with the crop, or in more kind. than one of these ways, the landlord or tenant may, notwithstanding anything in the record-of-rights or any contract, other than a contract whereby waste land is let for the purpose of reclamation, apply to a Revenue Officer to commute the rent to a fixed money-rent.

- (2) On receipt of such application, the officer may, after giving notice to the other party and hearing him, if he appears, fix the sum to be paid in money as rent, and such sum shall be the rent of the holding.
- 65. (1) If from any cause the payment of the whole or any Remission part of the land-revenue payable in respect of any land is remit- and suspented or suspended, a Revenue Officer may, by general or spe-sion of rent cial order, remit or suspend, as the case may be, the payment consequent of the rent of such land to an amount which would bear the ment of same proportion to the whole of the rent payable in respect land revenue. of the land as the land-revenue of which the payment has been remitted or suspended bears to the whole of the land-revenue payable in respect thereof, and may distribute the amount so remitted or suspended amongst the tenants holding such land in such manner as may seem to him to be equitable, having regard to the effect on their holdings of the cause which has led to the remission or suspension of the land-revenue:

Provided that, if the rent is taken by actual division of the produce, no portion of it shall be suspended under this section.

- (2) No Civil Court shall entertain or try any suit to recover any rent the payment of which has been remitted or suspended. and any such suit pending at the date of the order of remission or suspension under sub-section (1) shall be dismissed, and no orders regarding costs shall be made.
- (3) If the rent suspended is subsequently ordered to be recovered, the plaintiff or his successor in interest may apply for the suit to be restored, and it shall thereupon be proceeded with.

- *[(3-a) The provisions of sub-sections (2) and (3) shall apply, so far as may be, to an application under sub-section (1) of section 58-B for the recovery of an arrear of rent.]
- (4) The provisions of sub-sections (1), (2) and (3) shall apply to land of which the land-revenue has been wholly or in part released, compounded for or redeemed, in any case in which if the land-revenue in respect of the land had not been released, compounded for or redeemed, the whole or any part of it might, in the opinion of the Revenue Officer, have been remitted or suspended.
- (5) If, subsequent to the publication of an order of remission or suspension, the landlord collects any rent of which the payment has been remitted, or, before the expiry of the period of suspension, collects any rent the payment of which has been suspended, he shall be liable, by order of a Revenue Officer, to a penalty not exceeding the total amount of the revenue payable by him on account of the mahal in which such rent was recovered, or, if the revenue has been released, compounded for or redeemed, of the kamil-jama of such mahal.
- (6) Nothing in sub-section (5) shall affect the right of tenant from whom such recovery has been made to recover a penalty under section 74.

Progressive rents.

66. If a Revenue Officer in any proceeding under this Act passes an order which enhances a tenant's rent, but considers that the immediate enforcement of such order to its full extent will be attended by hardship to such tenant, he may direct that the enhancement shall be gradual, and that the rent shall be reduced in such manner and to such extent as he may, subject to rules made under section 109, think fit, for any period not exceeding fifteen years, until the full enhancement has been reached.

Procedure when a tenant holds land at rent lower than settlement.

67. If, by reason of the receipt by the landlord of any consideration whether in money or otherwise, or in pursuance of any agreement with the landlord, a tenant is holding at a rent lower than that fixed by the Settlement Officer under section 8 that fixed at or 15, the Settlement Officer may, subject to rules made under section 109, notwithstanding in this Act or any contract to the contrary, declare him to be entitled to hold at such lower rent for such term as the Settlement Officer, having regard to the circumstances, fixes as fair and equitable:

> Provided that in no case shall the tenant be entitled to hold at such lower rent for a period longer than that for which the settlement is being made.

Power to deposit rent in certain cases with Revenue Officer.

If a landlord refuses to accept any instalment of rent payable in money when tendered to him by a tenant, or if a tenant in any case is doubtful as to the person entitled to receive rent payable in money, such tenant may apply to a Revenue Officer for permission to deposit the amount of rent which he believes to be due.

- 76. (1) A tenant who makes a payment on account of rent shall be entitled to obtain forthwith from the landlord a receipt therefor.
- (2) The Provincial Government may prescribe, by rules made under section 109, a form of receipt book for the use of tenant, and the procedure to be followed in making entries therein.
- (3) If, at the time of making any payment on account of rent, the tenant produces the receipt book prescribed under subsection (2), the landlord shall give the receipt for the rent paid in that book, and shall enter the date of payment and the amount paid, and shall either state that the payment made is in full discharge of all arrears entered therein or shall specify the instalments in respect of which the payment has been accepted.
- (4) If, at the time of payment of any rent, the tenant fails to produce a receipt book, the landlord shall give a receipt for the amount paid, and shall specify therein-

(a) the name of the payer and the payee, and, if the payer is not the tenant, the name of the tenant on whose

account the payment is made;

(b) the name of the village, mahal or patti in which the holding, in respect of which the rent is paid, lies;

- (c) whether the payment has been accepted as a payment in full of all rent due by the tenant in respect of the village, mahal, or patti, or only on account;
- (d) the date on which the payment is made.

CHAPTER IX.—OTHER RIGHTS OF LANDLORD AND TENANT

Land broken up from waste.

- 87. (1) In any local area in which the Provincial Government may, by notification, declare this section to be in force, a Revenue Officer may enquire into the claim of any tenant other than a sub-tenant, to hold any land, contiguous to his holding but not previously included therein, which land he or his predecessor in interest has broken up from waste, and may subject to rules made under section 109, declare such tenant to be an occupancy tenant of such land and fix the rent payable therefor, and shall at the time of making such declaration direct that a sum not exceeding six times the rent so fixed shall be paid by the tenant to the landlord on account of compensation:
- *[Provided that no such declaration shall be made unless the land is in the same village, mahal or patti in which the holding of the tenant making the claim is situate.]
- (2) In any such local area, if it appears in any suit or proceedings in a Civil Court for the ejectment of any tenant from any land referred to in sub-section (1), that such tenant has filed an application before a Revenue Officer under sub-section (1), or if he files such application before the Court, the Court shall stay proceedings until the application has been disposed of, and shall, if the application is filed before itself, forward such application to a Revenue Officer for disposal.
- (3) No declaration shall be made under sub-section (1) unless the land has been cultivated for three years by the tenant or his predecessor in interest before the date of the application or the date of institution of the civil suit or ejectment.

Penalty for illegal distraint or interference by landlord.

- 88. (1) Any landlord of a holding who distrains or attempts to distrain the produce of such holding, or prevents or attempts to prevent any person from tending, reaping, gathering, storing, removing or otherwise dealing with any such procedure, shall be liable, by order of a Revenue Officer, to a penalty which may extend to five hundred rupees, and such sum shall be awarded to the tenant as compensation.
- (2) Nothing in this section shall affect the right of any person to recover compensation in a civil suit:

Provided that the Court in any such suit shall take into account any sum paid or recovered as compensation under subsection (1).

If in any holding, other than that of a sub-tenant, there are more persons than one having tenancy rights, any such person may apply to a Revenue Officer for a partition of his share in the holding, and the Revenue Officer may, subject to rules made under section 109, after hearing the objection of the landlord and the co-tenants, divide the holding and apportion the rent:

Provided that no such partition shall be made if any question of title is raised, until such question has been decided by a Civil Court.

Partition of a holding consisting partly of sir-land.

If a holding consists partly of sir-land, the landlord or tenant may apply to a Revenue Officer to separate the sir-land from the remainder of the holding and to declare it to be a separate holding, apportioning the rent between the two separated holdings, and, subject to rules made under section 109, Revenue Officer shall separate the holding and apportion the rent accordingly:

Inquiry into rentfree grants.

- 99. If any tenant, other than a sub-tenant, claims to hold any land rent-free or at a reduced rent, whether under an agreement entered into with the landlord or his predecessor in interest or under any order recorded at settlement or under a decree of a Civil Court, the Settlement Officer shall enquire into such claim, and notwithstanding any such agreement, order or decree, may subject to rules made under section 109, either—
 - (i) disallow the claim, or
 - (ii) determine the period for and conditions including rent, if any, on which the land shall be held.

Reinstatement of tenant illegally ejected.

100. Any tenant, other than a sub-tenant, who has been ejected from his holding, or from any portion thereof, otherwise than in accordance with this Act, may, on application to a Revenue Officer, be reinstated in possession of such holding or portion thereof:

Provided that-

- (i) no order passed under this section shall prejudice the right of the landlord to eject the tenant so reinstated, or the right of a tenant whose application for reinstatement is rejected to establish his title to his holding and to recover possession thereof by means of a suit:
- (ii) possession of a tenancy, or of any portion thereof, shall not be recoverable under section 9 of the Specific Relief Act, 1877 (I of 1877), by a tenant, other than a sub-tenant dispossessed thereof.

CHAPTER X.—MISCELLANEOUS

Exemption in case of land in reserved forest to local authority.

101. Nothing in this Act regarding the rights of an absolute occupancy tenant or an occupancy tenant shall be deemed to apply to the tenant of any land situate within the limits of any area which has been declared to be a reserved forest under or belonging the Indian Forest Act, 1878 (VII of 1878)*, or which is the property of, or is in the occupation of, a local authority.

Power to exempt company's lands from operation of the Act.

102. The Provincial Government may, by notification, exempt from the operation of any of the provisions of this Act any land which is the property of a company as defined in the Land Acquisition Act, 1894 (I of 1894):

Provided that-

- (i) such exemption shall not affect any right subsisting at the date of such notification, and
- (ii) such notification shall issue only after previous publication, to which, as far as may be, the provisions of section 22 of the Central Provinces General Clauses Act, 1914 (C. P. Act I of 1914), shall apply.

- (b) if the applicant desires to have evidence recorded, record such evidence:

Provided that no such action shall be taken by any Revenue Officer if he considers that there are no reasonable grounds for making the application, or if the subject-matter thereof is under inquiry in a Civil Court.

- (2) If any matter has been recorded under this section, the record thereof shall, notwithstanding anything contained in the Indian Evidence Act, 1872 (I of 1872), be admissible in evidence in any subsequent proceedings between the landlord and tenant, or any persons claiming under them.

Recovery of penalties.

Extent of savings.

110. All rules and assessments made, notifications and proclamations issued, authorities and powers conferred, farms and leases granted, records framed, revised or confirmed, rights acquired, liabilities incurred, times and places appointed, and other things done under any of the enactments hereby repealed shall, so far as may be, be deemed to have been respectively made, issued, conferred, granted, framed, revised, confirmed, acquired, incurred, appointed and done under this Act.

Repeals.

111. The enactments mentioned in the First Schedule are repealed to the extent specified in the fourth column thereof.

- (2) It shall come into force on such date as the Provincial Government may, by notification, appoint in this behalf.
- 2. In sub-section (1) of section 58-F of the Central Prov-Amendment of 1 of 1928, inces Tenancy Act, 1920, in the second description, the word section 58-F. "and" shall be omitted, and after the third description, the Act I of 1920. following description shall be inserted, namely:—

XII of 1864.

"fourthly, to the payment of a loan granted under the Agriculturists' Loans Act, 1884, if such holding or the part thereof which has been sold was hypothecated as security for such loan."
