MEMBERSHIP OF THE AFFILIATED ORGANISATIONS, Table A.

In 1933 and 1934 the International lost nearly 258,000 members owing to the loss of the Unions in Germany and Austria. On the other hand, the two French Unions succeeded, during 1935 and 1936, in increasing their membership by a total of 208,000. Apart from the French Unions, the Czech Chemical Workers (headquarters Prague) and the Polish Chemical Workers (headquarters Cracow) showed the biggest increases in membership.

Only four organisations showed a decrease in membership during the period under review.

So far as the percentage of women members is concerned, an appreciable increase is noticeable in the case of one organisation only, the Norwegian Chemical Workers' Union. In few other organisations there was a decrease in the female membership, in yet others it remained about the same.

UNEMPLOYMENT IN THE AFFILIATED ORGANISATIONS, Table C.

The following must be borne in mind in any closer consideration of these figures :

The Danish General Workers' Union (Denmark I) has a large number of members employed in the building materials industry.

The Norwegian General Workers' Union (Norway I) is affiliated to our International on behalf of its members employed in road-making.

A large section of the membership of the Swedish General Workers' Union (Sweden I) is employed in the building materials industry and as labourers in the building trade.

Unemployment was considerably less throughout in the case of the Paper Workers' Unions (Denmark III, Finland I, Norway III and Sweden II) than in the General and Chemical Workers' Unions. In the Danish paper industry unemployment was very low.

In appraising the figures for 1936 it must be borne in mind that in that year the Dutch currency was devaluated by about 20%, so that expressed in that currency the financial position of the unions in 1936 is flattered in comparison with that in the years 1933-1935. At the close of 1936 it was no longer the Danish but the Norwegian Paper Workers Union, which showed the highest funds per member.
