## PREFACE.

"Production in India" is a comparative study in national productivity with special reference to the prosperity or material welfare of the people. The object of the treatise is twofold: First, to help in building up the objective background of India's thinking on the question of national wealth. Second, to find out the fundamental cause of India's extreme poverty, which is an outstanding phenomenon in the modern economic world.

The treatise was begun in 1912 as a part of the report on Indian agriculture to the seminar on agricultural economics in the University of Wisconsin. In 1917, the work was resumed in its present form, but had to be given up for lack of time and means. The subject of productivity as a part of India's poverty problem had, however, occupied the mind of the author for a much longer period and it was the study of agricultural production which led him to the conclusion that national prosperity depended more upon the industrial efficiency of the people than the natural resources of the country. While this conclusion made him take up the study of the human element in production, i.e., the labor question, he had also intended to make a comparative study of national productivity with a view to determining the industrial efficiency of India.

A word may be said regarding methodology. Any treatise on production must give due consideration to the factors, namely, land, labor and capital. The amount of capital or capital goods is rather insignificant in India and it has received only a fair consideration. Land more readily lends itself to description and comparison than labor. Moreover, the latter forms the subject matter of the author's other treatises. Much more space has therefore been given to the discussion of land in the present volume.

In the study of historical growth of productivity, the year 1890-91 has, as a rule, been taken as the starting point. The statistics for previous years are neither

complete nor reliable for comparative purposes. In only a few cases, has it been possible to trace back the data beyond that year.

No attempt has been made to translate the French or international measures and weights into their English or Indian equivalents. They have been mostly used in comparison and their equivalents have been given in footnotes. Except where otherwise noted, the documents and works on which this treatise is based are given in the bibliography. The reason for omitting some of the references is that they can be easily located in the current statistical abstracts, yearbooks and almanacs. It has not been found possible to illustrate some of the statistical tables with charts and diagrams in this edition.

In presenting the treatise to the public, the author is fully conscious that it is far from being exhaustive or even complete. There are several reasons for this defect, such as lack of time and means on the part of the author, incompleteness of the data, both Indian and foreign, for comparative purposes and meagreness of statistics on production in India. The time has not yet come, especially in India for treating such a subject with any pretence to adequacy. The present volume is only an attempt to outline what seems to the author to be the main phases of the productive system which determines industrial efficiency and affects national prosperity.

In conclusion, the author takes this opportunity to express his thanks to the Bibliotheque de la Direction de la Statistique Generale de la France in Paris, where practically all the work was done, and the Commercial Library in Calcutta, where some of the old Indian statistics were consulted, for the help they have kindly rendered in the preparation of this volume.

## CHAPTER I.

### INTRODUCTION.

The wealth of a nation depends upon its productive power. Land, labor and capital are the essential factors of production, but the parts played by them are not of equal importance.

Capital is the instrument with which labor utilises land for productive purposes. The importance of capital in the modern industrial organisation cannot be minimised. Industrial evolution might be said to be synonymous with the accumulation of social capital. Capital is, however, a passive factor. Its growth is determined by the habit of thrift and foresight in saving for future production. Given a certain amount of capital to begin with, efficient labor with sufficient land can easily build up an adequate amount of social capital in a comparatively short time.

Land supplies the material basis to which immaterial mind in the form of labor can be applied for the production of wealth. Labor and capital being the same, production varies directly with the supply of land. This is the advantage which the younger nations like America have over the older ones. But population tends to reach the maximum limit of resources as determined by the known arts of production and, sooner or later, the growth of production is determined by the efficiency of labor in inventing new industrial arts. Like capital, land is also a passive factor. Theoretically, land

is limited in quantity, but practically, it lends itself to a great deal of flexibility. Land is almost the same to-day as ages ago, but the development in the art of production has increased, both in kind and quantity, the resources or those objects of nature which have been proved to be of value for productive purposes. The same Mississippi Valley which could not yield sufficient food to a few thousand Indians two centuries ago, is supplying the needs of millions of a highly civilised people to-day.

Labor is the creative principle in the productive process. It is labor which conquers nature, discovers laws, invents machinery, devices art, co-ordinates land and capital and organises industrial systems. Labor is the dynamic factor and is ever unfolding itself in both intensity and extensity. It now produces a thing in a day which formerly took a year to finish and makes the wastage of yesterday the resources of to-day. The growth of its efficiency is the most important cause of increase in productivity.

There are several ways of estimating the productivity or productive power of a nation. First, by the ratio between the actual and potential production; by the latter is meant the produce which would result from industry by the application of the most efficient labor and capital to the known resources of the country. This is not, however, a practicable method for the estimation of national productivity. Second, by the growth, both in quantity and quality, of products in proportion to the increase in resources. Third, by relative prosperity, i. e., by comparing the per capita wealth of one country with that of others. Since prosperity is the object of all production, this is one of the best methods of estimating national productivity.

What prosperity consists of is, however, hard to define. It must include all the necessaries for the maintenance of life and all the requirements for the development of individuality and for the preserva-

tion of the social standard. But habit and custom play such an important part upon consumption that it is often impossible to draw a sharp line between necessaries and luxuries. Requirements also offer a very wide range of variation according to time and place as well as individual aims and social attitudes. Moreover, mere conformity to the standard of a social class, such as the wage-earners, does not necessarily mean prosperity.

What is true of an individual is also more or less true of a nation. A prosperous nation must provide for its citizens all the necessaries and requirements and preserve national prestige or international standard. The necessaries of life, of course, vary according to climate, but since they form a more or less subordinate part of the manifold needs of modern civilised life, they may be ignored for practical purposes. The stages of social development also bring about some variation in national requirements. Although facilities for communication give rise to the same ideals and aspirations, especially among the peoples of advanced countries, there still remains a difference in the requirements of various nations.

Unlike poverty, prosperity is, moreover, a relative term. Partly due to inadequate production, but mostly to unequal distribution, the real income of individuals or classes may fall far short of the provision for necessaries. Absolute poverty is thus still one of the evils of the day. But absolute prosperity in the sense of sufficiency above requirements is scarcely possible in modern times. There is no end to human wants and the thought of providing for posterity, desire for "conspicuous consumption" and love of power and glory always make a man acquire more. Besides, in the present dynamic society, where aims and aspirations follow one another in quick succession giving rise to ever-increasing wants, it is hard to determine where

poverty ends and prosperity begins. Even a Rockefeller, determined to eradicate hookworms from the earth, or a Carnegie, anxious to provide every township with a library, finds his "wants" unsatisfied for lack of "funds". Prosperity cannot, therefore, be judged from a subjective viewpoint; nor is it possible to have a clear conception of it without comparison.

Relative prosperity may be studied either with reference to the whole world or to advanced countries. In the former case, India having 17 per cent of the world's population must have the same proportion of its wealth. But such a procedure is both impractical and useless. For, there does not exist any estimate of the world's wealth nor would its average amount mean prosperity to progressive nations. A more appropriate method of judging relative prosperity would be to take into consideration such advanced countries as the United States, Great Britain, France, Germany, Italy, Japan and Belgium, which through intellectual achievement, material progress or capitalistic imperialism control the destiny of other nations and influence the direction of social evolution.

The productivity of a nation may be determined by its wealth or income, which is generally estimated in terms of money—the common denominator for measuring all forms of wealth. But for comparative purposes, the exchange value, on which such estimate is generally made, is rather defective. National wealth thus estimated excludes many commodities which have no exchange value, such as national buildings, public parks and household work, and which are more or less variable items in different countries. Moreover, there is no uniform rate in international exchange except for a very few standard commodities. National productivity may also be computed with reference to the products of various industries, such as wheat, cotton, cattle, timber and iron and steel. The defect of such a

system is obvious. It neglects the quality and leaves out many minor and unstandardised commodities. But although somewhat inaccurate and incomplete, it is a clearer and more concrete method and offers opportunity for the study of the products of principal industries, which contribute the largest share to national wealth.

How the productivity of India has grown within recent years and how it compares at present with that of other countries and affects the prosperity of the people, form the subject-matter of this study.

## CHAPTER II.

### RESOURCES.

#### I. The Land.

India is separated from the rest of the world by two great natural barriers, namely, the Himalaya ranges and the Indian Ocean. There are three natural divisions, the Himalayas, the Indo-Gangetic Valley and the Deccan. The Himalayas extend over a distance of 1,500 miles from east to west and contains some of the highest peaks of the world. The Indo-Gangetic Valley is a vast plain and is, in most parts, well-watered by the tributaries of the Ganges, Brahmaputra and Indus. The Gangetic basin is one of the most fertile and densely populated regions on earth. The Deccan is an extensive tableland, surrounded almost on three sides by the Eastern and Western Ghats and is much variegated in topography.

Both the geographical situation and physical features make the meteorological condition of India extremely diversified. While most of the plains have tropical and sub-tropical climates, there also prevails the arctic climate in higher altitudes. The most important factor in the meteorology of India is the monsoon which divides the climate into two well-defined seasons, namely, the dry and the wet. The lowest temperature in the plains has been recorded to be 23.2 degrees at Rawalpindi and the highest, 126 degrees in Upper Sind, the normal temperature lying between these two extremes. The annual rainfall also varies from 460 inches at Cherrapunji in the Assam Hills to less than 3 inches in Upper Sind, but the average rainfall in the year amounts to 45 inches.

The flora of India are much more varied than those of any other country in the Eastern Hemisphere. This is due to several reasons: First, the country rises from the level of the sea to the height above vegetation. Second, the temperature ranges between tropical heat and arctic cold. Third, precipitation varies from almost absolute aridity to maximum humidity. Thus it has been possible for many plants from widely different neighbouring countries to migrate and thrive in India, notably the Chinese and Malayan plants on the east and south, the Oriental, European and African on the west and the Tibetan and Siberian on the north. For example, about 570 European genera and 760 species are indigenous to India. There are as many Oriental and other genera and species. It has been estimated that there are 4749 woody plants in India consisting of 2,513 trees, 1,429 shrubs and 807 climbers.

The fauna of India are as abundant and varied as her flora. Local richness and climatic difference have made the number and kind of animals inhabiting India very large, and they far surpass those found in the whole of Europe. While there does not yet exist any estimate as to the number of invertebrates that of vertebrates has been estimated to be 1229 genera and 4100 species.

Physical vastness, geographical isolation, topographical variation and climatic fluctuation have great influence upon the industrial development of India. They have made the economic life rich, although self-sufficing. What is more important, they offer opportunities for the fullest utilisation of her immense mineral, vegetable and animal resources and indicate the possibility of her industrial greatness and national prosperity.

## 2. The Area.

The total area of India is, 1,802,624 square miles with a population of 319 millions according to the

census of 1921. In area and population, India stands very high among the largest countries of the world, as shown in the following tables :

In the above table, it is seen that the Soviet Union stands at the head of the largest countries of the world with an area of 8.1 million square miles. This union is a political federation rather than a national whole. But even Siberia, one of its component parts, has an area of 4.8 million square miles and is the largest single tract of land. But most part of it is unproductive and uninhabitable, and so are parts of Canada, Brazil and Australia, which countries stand respectively third, fourth and sixth in the list. India is seventh in area among the largest countries.

From the viewpoint of population, however, India leads other countries with 318.9 million inhabitants and is closely followed by China with 318.6 million inhabitants. The United States is fifth among the countries in area and fourth in population. Of 57.2 square miles of the world's area, India occupies 1.8 million square miles or 3.3 per cent, and of 1849.5 millions of the world's population, India contains 318.9 millions or 17 per cent, according to the census of 1921. In other words, 17 per cent of the world's population is living in 3.3 per cent of its area in India.

Politically India falls under two great divisions : First, that which is directly under British rule and is called British Provinces. Second, that which is under the rule of the native princes and is called Indian States. Some of the Indian States are within the political jurisdiction of Local British Governments and Administrations, while other states have direct relations with the British Government of India. During the past fifty years, there have been great variations in the area and population of India, as shown in the table below :

The above table shows the variations in the area and population of India during the past fifty years. It is seen that the total area decreased from 1,476,000 square miles in 1871 to 1,378,000 square miles in 1881. The reduction resulted from the correction of former mistakes. It was in 1871 that the first systematic effort was made for the census, but in several provinces, the census was based mostly on estimation. In every succeeding decade, the census became more and more accurate. The increase in area in the succeeding decades has been effected mostly by annexation of new territories, such as Burma and Beluchistan.

The last column shows the variations in population. The irregularity in the increase of population is due to several causes. First, increasing accuracy in the succeeding decades. Second, annexation of new territories. Third, effect of famines and epidemics in the intervening periods. This was very clearly seen in the last census. The epidemic of influenza alone swept away 14.8 million population during the year 1918, thus raising the annual death rate from 32.72 to 62.46 per 1000(1). The increase of population fell from 7.2 per cent in the decade from 1901 to 1910 to 1.2 per cent in the last decade, i. e., from 1911 to 1920. During the same decade the population of the world rose from 1741.3 millions in 1911 to 1849.5 millions in 1921, thus showing an increase of 5.2 per cent (2)

It is seen that during the period under consideration, while the area in the whole of India increased from 1,476,000 square miles to 1,805,000 square miles i. e., 21.6 per cent, the population increased from 240.94 millions to 318.94 millions, i. e., 32 per cent. It must be remembered that while there is scarcely any possibility of increasing the land area, there remains every chance in the world for the increase of population,

Out of the total area of 1,805,000 square miles in 1921, 1,094,000 square miles or 60 per cent belonged to British Provinces and 711,000 square miles or 40 per cent to Indian States and out of the total population of 318.9 millions, 247 millions or 77.5 per cent were living in British Provinces and 71.94 millions or 22.5 per cent in Indian States. In other words, 77.5 per cent of the population were living in 60 per cent of the land in British Provinces and 22.5 per cent of the population in 40 per cent of the land in Indian States.

The most important question in connection with the area of a country is not so much the actual amount of land as the supply of it in proportion to the population, which is best shown by the density or the number of population per unit of land. Like area and population, the density has also undergone variation both in British Provinces and Indian States during the last 50 years, as shown below:

The above table shows that during the period under consideration the density of population in India rose from 210 in 1871 to 228.9 in 1891, and after remaining practically stationary for a decade, declined to 211 in 1901, to rise again to 225 in 1921. The density of population in Indian States declined

from 108·4 in 1881 to 101 in 1921, though there were some rapid fluctuations in the intervening periods. Taking India as a whole, the density of population after remaining practically stationary from 1881 to 1891, declined to 167 in 1901, but rose again to 177 in 1921. The fluctuations in density are partly due to the annexation of new territories from time to time and partly due to the correction of the data through the subsequent census. Since the country has become practically settled as far as the frontier is concerned, it may be concluded that India is becoming more and more thickly populated and the supply of land is diminishing.

In spite of the increasing population, India is not yet as densely populated as some of the countries in Western Europe or even as Japan. The density of population in India as compared with that in countries with a population of above 100 persons per square mile is shown in the table below. It is seen that the density varies from 108 per square mile in Spain to 636 per square mile in Belgium. India stands tenth in the list of the countries mentioned above and had a density of 177 persons per square mile in 1921. The people of India are better supplied with land than those of Japan, where there are 295 persons to the square mile.

In connection with the density of population, there are several essential points which must be borne in mind. First, some of the thickly populated countries such as Belgium, Holland and England, have colonies and dependencies, the resources of which augment the national wealth. Second, in these days of exchange economy, it is not mere density of population, but the state of industrial development and industrial efficiency which determine the prosperity of a people.

More important than the density of population, or mere land area per person, is the amount of land available for productive purposes. Of the total acreage of 1,152,000,000 in all India, about 659,000,000 acres belong to British Provinces and

496,000,000 acres to Indian States. Of British Provinces, there are returns for agricultural statistics only for 621,000,000 acres according to the professional survey or 618,000,000 acres according to the "village papers," i.e., papers prepared by the village accountants for the assessment and collection of land revenue; Agricultural statistics are based on the figures given by village papers. Of Indian States, statistics are available only for 132,700,000 acres according to the professional survey and 132,900,000 acres according to the village papers. The statistics for Indian States are defective for two reasons: First, additions have been made from time to time to the number of reporting States. Second, only a small number of States submit returns of agricultural statistics. In most of the comparative statements, Indian States have, therefore, been omitted, the statistics of British Provinces only being taken into consideration.

The amount and distribution of productive land in proportion to the unproductive both in British Provinces and Indian States is shown below. It is seen that of the total acreage of 751,402,000 according to the village returns of 1920-21, 165,316,000 acres, or 22 per cent, are not available for cultivation or forestry. A large part of it is hilly and deserty, and the rest is covered with buildings, roads and water and is, therefore, productive in the economic sense of the word, but unproductive in the ordinary of technical sense. 586,087,000 acres of land are suitable for farming and forestry. In short, about four-fifths of the area, for which statistics are available, are productive(1) in India.

Like the total area, the productive area has also undergone some variation. The earliest records available for productive area in British Provinces are those of 1878-79. Out of the total acreage of 513,271,000 excluding that of Bengal for which no data are available, 279,532,000 acres were productive during that period. This area increased to 416,699,000 acres in 1920-21, as shown in the table below. The increase in productive area is due to the same reasons as those in the case of the total area.

The following table shows the proportion of productive area to the unproductive in various countries. Although some of the figures relate to pre-war period, yet they do not fail to give some rough idea of the subject. It is seen that the productive area varies from 6.7 per cent in the case of Australia to 96.2 per cent in the case of Hungary.

In connection with the proportion of productive area to the unproductive in each country, two things must be remembered : First, large areas of land in several countries remain still unexplored. Nine-tenths of land in Australia, for instance, are still unknown as far as their productivity is concerned. Second, population varies in different countries. In spite of the fact that only less than half the area of the United States is productive, the land area is so vast in comparison with the population that it has a much larger area of productive land per capita than most of these countries. On the other hand, over three-fourths of the land in India are productive, but the per capita area is very meagre.

### 3. Arable Land.

The most important natural resources of a country are its arable land, upon which depends the supply of both food and raw materials. This is specially so in the case of India, where the population is very large and the question of food is the vital issue with the majority of the people.

There has been a slight increase in the area of arable land in British Provinces, for which alone early reliable statistics are available, as shown in the table below. The area was estimated at 227,027,000 acres in 1884-85. Taking the figures for 1890-91, which are more reliable, as the basis of calculation, it is seen that the area rose from 321,135,000 acres in 1890-91 to 388,854,000 acres in 1920-21, showing an increase of 20 per cent in 30 years.

In 1920-21, there were also 91,819,000 acres of arable land in Indian States, thus making the total arable land for all India 480,273,000 acres. This means an average of 1.5 acre of arable land per inhabitant. For a population depending mainly upon agriculture, this supply of arable land is very meagre—a fact which becomes clearer when compared with that in other chief agricultural countries, as shown below. It is seen that Argentine, Canada, United States and Australia have each a per capita acreage varying from 6.8 to 3.1. In 1911, there was a per capita acreage of 1.7 in the Russian Empire as against 1.5 in India. On the other hand, France—an industrially developed country—has an acreage of 1.4 per inhabitant. The United States, which is one of the leading manufacturing countries, has more than twice as much acreage as India. The arable land in the rest of the countries varies from .9 acre per head in the case of Italy to .3 acre in the case of Great Britain and Japan.

Even this limited supply of arable land is not properly utilised for productive purposes. A large part of it has not yet been brought under cultivation, while another large section is left fallow every year, as shown in the table below. It is seen that of the total arable land, the acreage sown with crops in British Provinces amounted to only 55.7

per cent in 1884-85 and 54.6 in 1920-21, showing little tendency for the appropriation of arable land for cultural purposes. Of the un-appropriated land, the acreage of fallow land varied from 8.3 per cent in 1884-85 to 15.7 per cent in 1920-21, and of the culturable waste other than fallow, from 36.0 in 1884-85 to 29.3 in 1920-21, showing a greater tendency towards the fallowing of arable land in recent years.

A similar proportion of arable land remains unappropriated in Indian States. The wastage of arable land in all India is shown below. It is seen that of 480,273,000 acres of arable land in all India in 1920-21, only 266,431,000 acres or 56.9 per cent, were utilised for cropping. Of the rest, 80,962,000 acres, or 16.8 per cent, were laid fallow<sup>1</sup> and 132,880,000 acres, or 27.6 per cent were not brought under cultivation.<sup>2</sup>

Fallowing once served a very necessary function in the economy of agriculture. But with the knowledge of crop rotation and the use of fertilizers, it has become an unnecessary waste. There is also a large area of land which is neglected or has not even been brought under cultivation. Only a part of it is utilised for raising bamboos and thatching grass, but by far the largest part of it is wasted. Taking the current fallow and culturable waste together, it is seen that over 44 per cent of arable land can be added to the actual productive area of the country.

There is still another phase to the question. Having tropical climate, India can devote most of her arable land to more than one crop a year. The total area of land which is utilised at present for this purpose amounted, in 1920-21, to 26,942,000 acres in British India and 3,064,000 acres in Indian States, i.e., a total of 30,006,000 acres in all India. This means practically an addition of 6.2 per cent of culturable area to the existing arable land of the country. With the facilities afforded by irrigation and fertilizers, there is possibility of thus augmenting the arable land of the country immensely.

#### 4. Forests.

Forests form one of the most important sources of national wealth. The importance of forests in conserving moisture, in preventing inundation and erosion, and in moderating temperature cannot be over-estimated in a country like India, which is subject to tropical heat and rainfall. The value of forests as a direct source of wealth lies, however, in the supply of timber and other building materials. The supply of fuel is equally important in India due to the fact that coal and oil resources are not

adequate and water power is still undeveloped. To this must also be added the yield of the so-called minor products, such as lac, caoutchouc and feeds. A large number of industries, such as box and paper-making, also depends upon forests for raw materials. The preservation and improvement of forests are, therefore, of prime importance to national economy.

Forests in India belong to the following chief classes: First, deciduous forests. They are most important and extend from the foot of the Himalayas throughout the country, furnishing the valuable timber of sal, ironwood, teak, red-sander, sandal, rose-wood, ebony, acacia and others. Second, evergreen forests. They are next in importance and grow in the regions of heavy rainfall, comprising *terminalia*, *cedrals*, tuna, wild mango and others, located mostly in the west coast of India and in Burma and Andaman islands. Third, dry forests. They are located in tracts where the rainfall is less than twenty inches, such as the Punjab and Central India. Fourth, Alpine forests. They are located in Northern India, Burma and Assam and comprise roughly the vegetation in the altitudes between 12,000 and 3,000 feet including such varieties as juniper, birch, spruce, fir and cedars, cypress and oak. Fifth, tidal forests. They grow on those alluvial lands which are subject to overflow of tides and are found on the coast of Burma, Bengal and Madras. They are valuable for such timber as *sundari* and for fuel. Sixth, riparian forests. They are represented in the Punjab and Burma.

Forests are more or less fixed in area. But there has been slight increase due mostly to the annexation of new territories, as seen below. Taking into consideration the figures for 1900-01, which are more complete, it is noticed that the forest area increased from 208,364 square miles to 250,473

square miles within the last twenty years. During the same time, the proportion of forests to total area increased from 21.97 per cent to 23.1 per cent, although it fell again to 22.7 per cent in 1921-22.

Thanks to the elevation and rainfall, nearly all the trees of commercial importance are represented in India. There are about 2000 species of timber trees, which are broadly classified into soft and hard wood trees. The soft wood trees are coniferous or cone-bearing and are supplied by the Alpine forests. In India they are mostly inaccessible due to their location in high altitudes. The hard wood trees are broad-leaved and are supplied largely by deciduous forests. Between the two chief classes are to be found all kinds of medium weight trees.

Out of a total area of 1,098,341 square miles in British Provinces, excluding Delhi and Manipur, 249,504 square miles or 22.7 per cent were under forests in 1921-22. This area includes unclassed state forests or "public forest land", which contains in many provinces unoccupied waste, often entirely devoid of trees. (1) The actual forest area would not amount to more than 13 per cent. (2)

There is a good deal of variation in the distribution of forest land in different provinces of the country. Most of the forests are to be found in a few sections. Burma, which is geographically outside India proper, contains about half the forests having 144,708 square miles out of the total forest area of 249,504 square miles. In India proper, Assam has the largest area of forests, i. e., 21,463 square miles and is closely followed by the Central Provinces including Berar and Madras with an area of 19,792 and 19,304 square miles respectively, as shown in the table below. It is also seen that the proportion of forests to the total area of the province varies from 10.2 per cent in the case of Bombay to 59.5 per cent in the case of Burma.

The forest area of the world excluding parts of Asia, South America and Africa, amounts to 1618 million hectares or 24 per cent of the land area. i.e., about the same proportion as that in India. But in proportion to population, the forest land in India is quite inadequate to supply the needs of modern life. This is clearly brought about by comparing the per capita forest area of India with that of other countries, as shown in the table below. It is seen that the forest area per inhabitant varies from .02 hectare in the case of the United Kingdom to 7.6 hectares in the case of Australia. Excepting the United Kingdom, Belgium and Italy, India has the smallest forest area per inhabitant, which amounted to .14 hectare in 1920-21.

### 5. Fisheries

Fisheries also form a very important source of national wealth. The function of fishes to a country are various. First, they make a very delicious and nutritious food. Second, they are the chief means of exploitation and conservation of such small plants and animals as algae and protozoa—a function which becomes all the more important in a country like India because of its tropical climate and prolonged rainy season. Third, they feed upon the eggs and larvae of such injurious insects as mosquitoes and thus render a very valuable service in the prevention and control of diseases like malaria. (1) Fourth, they supply raw material for such industries as those relating to oil, glue and manure. Fifth, fishing develops some of the best qualities of character such as courage, enterprise and ingenuity and thus helps the up-building of national life.

Like Japan, North America and most of the European countries, India possesses large fisheries, which may be divided into three classes. First, freshwater fisheries including rivers, brooks, ponds, jheels, tanks marshes and rice-fields. Second, brackish water fisheries of estuaries, creeks and lagoons. Third, marine fisheries consisting of the foreshore and deep water.

There are in India 437 genera and 1,637 species of fishes and of these, 79 genera and 361 species are fresh water fishes and the remaining inhabit either brackish or sea water. The number of migratory fishes is rather limited. There are about 53 different kinds of fishes considered to be edible in India. (2) The main varieties of inland fishes are hilsa, rohu, catla, vetki, murrel, carp, trout and cat fishes. Among the brackish water and marine fishes the following are the chief : sardins, mackerel, cat fishes, seer, sole,

mango fishes, pomfret, vontrils, shark and ray fishes. Among the other fisheries, the oyster, turtle, pearl, mussel and chank are the chief.

The most important fresh water fisheries in India are located in Bengal, Bihar and Orissa, large sections of which are occupied by rivers and their branches and tributaries. The inland water of these provinces has an area of about 8,000 square miles, which during the rainy season is more than doubled.

(1) The rivers in Madras, Sind and the Punjab are also important sources of fish-supply. In short, the inland water-fisheries of India are not excelled either in area or potentiality by any other fisheries except those of the United States. There are also large areas of brackish water fisheries, the most important of which are the Sundarbans, occupying an area of 5700 square miles. They are teeming with several species of valuable fishes which are within the easy reach of Calcutta and other lucrative markets. (2)

The richest fisheries of India are, however, the marine, including both the foreshore and deep water. Madras has a coast line of 1750 miles with a shallow water area of 40,000 square miles. An equally large or larger area extends from the coast of the Bay of Bengal to Burma and Malaya peninsula. Another important area of fishable water is the Arabian sea. The fine weather of Bombay coasts permits even small crafts to fish for more than half the year. The marine fisheries of India are practically inexhaustible.

## 6. Mines.

Another source of wealth to a country are the mines. Precious metals, such as gold and silver, satisfy the desires of a large number of people for

decoration and ornamentation. Of still more importance are the minerals, such as copper, zinc, tin, and sulphur, which form basic materials for many manufacturing industries. But the greatest value of the minerals lies in the supply of material for machinery and mechanical power. From this viewpoint, iron, coal and oil are the most important mineral products and form the motive force of modern industrial civilisation.

For the convenience of study, mineral resources may be classified as fuels, metals and non-metals. Among the most important fuels are coal, oil peat and gas, of which the first two are found in comparative abundance in India. Metals consist of such important minerals as iron, gold, silver and copper. Unlike the mineral fuels, which are "perishable" and are exhausted in a single use, metals are more or less durable and a large portion can be preserved in tact, although through wear and tear, oxidation and other chemical changes, parts of them are lost. The metallic stock of gold and silver thus increases every year. Except iron, the supply of most of the metals is rather limited in India. The non-metallic minerals consist of such structural materials as lime, sand, cement and clay; abrasive materials, such as millstone and emery; chemical materials such as arsenic, borax, gypsum, salt and sulphur; pigments such as barytes; and miscellaneous materials such as asbestos, graphite and magnesite. (1) India has considerable supply of some of these non-metallic minerals.

Coal is the most important of all minerals, both because it is a source of motive power and because it yields a large number of important by-products. The coal seams of India occur in deposits younger than those in which the principal fields

of Europe are found. Sufficient information is not yet available for estimation of the reserves beyond the depth of 4,000 feet. The total superficial area for which the estimate is made, is 3333 square miles.

In comparison with those in other countries, the coal reserves in India are rather small, as shown in the table below. It is seen that the United States with Alaska is far ahead of other countries in the possession of coal reserves, which amount to 3,500,000 million tons. Canada and China occupy the second and third places having respectively 1,361,000 and 1,100,000 million tons. India with a reserve of 87,000 million tons stands seventh in the list and leads countries like France, Russia and Japan.

Petroleum is another important fuel mineral. Like coal, it furnishes many by-products. Petroleum is found in two distant areas in India. The one is on the east including Assam, Burma and the islands of the Arakan Coast and extends to Sumatra, Java and Borneo. The other is on the west,

including the Punjab and Beluchistan and extending to Persia. Of these two areas, the eastern area is by far the more important.

The known resources of the world's petroleum amount to 45,055,000,000 barrels of 42 gallons each, as shown in the table below. It is seen that South America including Peru, Bolivia, Columbia and Brazil possesses 9,280 million barrels or 20.6 per cent. But as far as a single country is concerned, the United States stands first and possesses 9,000 million barrels or 20 per cent and is followed by Russia with 6,755 million barrels or 15 per cent. India has the resources of only 995 million barrels or 2.3 per cent of the world's total amount.

Water is still another source of power. Unlike coal and petroleum, which are perishable and exhaustible, the supply of power from water resources is permanent and practically inexhaustible, though limited.

A preliminary forecast shows that India has the following water power areas: First, nearly the whole of Burma. Second, the whole of Northern India along the Himalaya ranges, comprising Assam, Northern Bengal, the United Provinces, the Punjab and the North-western Frontiers. Third, the whole of Western Ghats in Bombay and down to Southern India. Fourth, on a smaller scale, Madras and Central Provinces. It has been estimated that the water power resources of India amount to 27,000,000 horse power.

In comparison with other countries, India stands very high in water power resources. The water power resources of the world have been estimated to be 439,000,000 horse powers and of these resources, 190,000,000 horse powers are located in Africa alone, mostly in the Congo river regions. Taking into consideration only the advanced countries, the United States with the resources of 28,000,000 horse powers stands at the head of the list and is closely followed by India with the resources of 27,000,000 horse powers, as seen in the table below. Brazil with 25,000,000 horse power resources occupies the third place. Canada and China each with 20,000,000 horse power resources compete for the fourth place. In proportion to population, some of the smaller countries, such as Norway and Sweden, are, however, better supplied with water power resources than China, India and even the United States.

In respect to the development of the water power resources, the credit lies with European countries, as shown in the same table. Switzerland and Germany, for instance, have developed respectively 76 and 74 per cent of their water power resources. Among

the other important countries, the United States has developed 33 per cent, Italy 32 per cent, France 29.7 per cent, Sweden 26.7 per cent, Norway 24.5 per cent, and Japan 16.6 per cent. The developed water power resources of India amount to only .55 per cent of the potential wealth.

Regarding the energy resources of the world, a very interesting estimate has been made by Dr. Thomas T. Read of the Federal Bureau of Mines, U.S. Government. Taking the estimates of probable and possible available coal, petroleum and water power in the principal countries of the world and reckoning them in terms of millions of horse power years, they line up, according to his estimate, as shown in the

table below. It is seen that the United States with 500,000 million horse power years of coal, 400 million horse power years of petroleum and 37 million horse power years of water, is the most powerful country in the world and is followed by China, Germany, Canada and other countries. India with 11,000 million horse power years of coal, 70 million horse power years of petroleum and 20 million horse power years of water stands ninth in the list of the powerful countries.

The most important mineral is, however, iron. Machinery and mechanical power are the two main pillars of the modern industrial organisation. While power can be supplied by water or by any of the fuel resources such as coal and oil, there is no known substitute for iron.

Metallic iron is scarcely found in a pure state. The value of iron depends upon the proportion of iron con-

tents and the nature of other composing elements. Some of the ores are known to contain as much as 72 per cent of iron, but ores with 60 per cent of iron are regarded to be of a highly desirable grade. The ores of commercial value must have at least 25 per cent of iron.

The iron ores of India have not yet been fully explored. But vast iron ore deposits have been discovered in Singhum, and in the Keonjhar, Benai and Mayurbhanj States of Orissa. These iron ores lie on the average at a distance of 125 miles of the fuel supply area and contain more than 60 per cent of iron. They are among the largest and richest resources of the world and are distributed as follows: (1)

In comparison with other countries, India occupies a very high place in the possession of iron resources, as shown in the table below. It is seen that France, as she has been constituted by the recent Versailles Treaty, possesses 5630 million tons of ores, which amount is the largest in the world. But the United States leads the world having the largest amount of metallic iron, India with 2,832 million tons of iron ores and 1,699 million tons of metallic iron stands fourth among the countries.

## CHAPTER III.

### INDUSTRIES.

#### 1. Forestry

As an industry, forestry presents some peculiarity which distinguishes it from other industries. A forest of valuable timber takes a long time to mature, generally from 50 to 100 years according to the softness or hardness of the wood. An individual can scarcely feel interested in an industry of which neither he himself nor his immediate successors can reap the benefit. Even when possessed of a natural forest, an individual is scarcely interested in preserving it for social benefit. This is clearly seen in the case of the United States. When first discovered there were 822,000,000 acres of forests, of which now only 463,000,000 acres are left. A similar thing happened in India. In the early part of British rule, forests were rapidly destroyed. The acreage of agricultural area and the construction of railways were pushed forward at the cost of forests. It was the shortage of timber to meet the demand of public works that led to the realisation of the necessity of forest service. Forestry has therefore become a public or semi-public industry in India as in other countries.

Although local efforts were made in Malabar in 1806, in Bombay in 1847, and in Madras in 1856, it was only in 1864 that an inspector-general of forests to the Government of India was appointed and a department of forestry was created. Forest

administration is a division of the Department of Revenue and Agriculture. Subject to the general supervision of the Government of India, the administration of forestry rests with Provincial Governments. The first forestry act was passed in 1865 and since then several local and national acts have been passed. The policy of the government is to develop forests and to protect them from disease, fire, grazing animals and unauthorised felling.

For administrative purposes, forests in India are divided into three classes, namely reserved, protected and unclassified, according to the degree of State control. The reserved forests are under the direct control of the Government. They are intended to be maintained permanently for the supply of timber, fuel and other products or for the protection of water supply or other similar purposes. The protected forests are those in which the control is not so strict and to which local communities have beneficial exercise of rights. The unclassified forests are those in which there is practically no restriction for the use of the public. Of the 249,504 square miles of forests in 1921-22, 103,789 square miles, or 41 per cent, were reserved, 7,550 square miles, or 3 per cent, were protected, and 138,165 square miles or 56 per cent, were unclassified. The last class of forests are mostly located in provinces where there is a scanty population, such as Burma and Assam.

The outturn of forests in India is classified under two heads, major products consisting of timber and fuel and minor products comprising bamboos, grazing and fodder grass and such other products as lac, caoutchouc, myrabalans and cardamoms. They are disposed of either by the Government directly or by purchasers and rightholders.

The outturn of forest products within the last 16 years, *i. e.*, from 1905-6 to 1921-22, is shown below. It is seen that although forests have increased very

little in the acreage, there has been some decided increase in the produce per square mile, rising from 1,054 cubic feet to 1,448 cubic feet in timber and fuel and from Rs. 27 to 55 in the value of minor products, i.e., while the area increased by 6 per cent, the outturn of timber and fuel increased by 46 per cent and that of minor products by 100 per cent.

The timber production of India is not sufficient for her large population. It has been estimated that the annual growth is about 1200 million cubic feet, of which only 361 million cubic feet or 30 per cent was cut in 1921-22. But even if the whole growth is cut, the supply of timber would be quite inadequate to the needs of the people. Some idea of India's position in timber supply may be had from the following table. It is seen that even countries like Austria-Hungary or Sweden produce more timber than India, i.e., 2,827 million cu. ft. or 950 million cu. ft. as against 361 million cu. ft.

One of the functions of forests is the supply of grazing land to domestic animals. In 1921-22, 11. 8 million animals were allowed to graze in the public forests, of which 6. 6 millions were allowed on payment of fees and 5. 2 millions were allowed free. Every year a large amount of forest products is given away free or sold at reduced price. The value of such products amounted to 85.7 lakhs of rupees in 1921-22. The importance of forests to national production is also seen in the value of their

exports, which amounted to 9.9 crores of rupees in 1921-22.<sup>1</sup> Almost the same amount in value of timber was imported during that year.

The table below shows the growth of the forest production in India for the past 16 years.<sup>2</sup> Taking the figures for 1910-11 for which complete data are available, as the basis of comparison, it is seen that the production has increased by 35 per cent.

INDUSTRIES

Unlike other industries, forestry is a public or semi-public enterprise, as noted before, and the profit is largely appropriated by the Government. The surplus from the revenue is also a fair indicator of the growth of forestry, as shown below. It is seen that in 30 years from 1890-91 to 1920-21, the amount of revenue increased from 149 lakhs to 541, the expenditure from 80 lakhs to 364, During the same time the surplus rose from 69 lakhs to 177, showing an increase of 158 per cent.

## 2. Fishing.

Fishing is one of the oldest industries of the world. It has come down from pre-historic times. A considerable number of the world's population is supported by fishing. In India alone 1.5 million population depends upon fishing for their livelihood, according to the census of 1921.



The methods of catching fish in India are still very primitive. Among the implements, the most important are the following: (1) fixed engines and nets; (2) moveable engines, nets, traps and other contrivances; (3) missile implement such as spears and arrows; (4) baited hooks, springs, rods and lines and bottom lines; (5) twisted cards and knots. The nets are of various kinds, square, round, medium and minute sized, meshed and drifting with one or two *cartamarons*. Among the fishing boats are to be mentioned *dug-outs*, *dingis* or small boats and big boats. With these primitive and obsolete implements and with illiterate and so-called lower caste fishermen, India has made very little progress in fishing industry, especially in brackish or sea water areas.

The richness of fisheries in India drew the attention of naturalists and amateurs even in the last quarter of the 18th century. They occasionally described and classified fishes until the middle of the 19th century. In 1867, Sir Arthur Cotton, an irrigation engineer, pointed out to the Secretary of State for India, the danger to the coastal fisheries of Madras arising from weirs in the rivers. The same year, the Government of India made inquiries into the general conditions of the fisheries of the country. In 1868, Colonel Strachey, the Inspector General of Irrigation Works, suggested the institution of an inquiry into the migration, spawning and other habits of edible fishes. In consequence, Surgeon Major Francis Day was appointed to investigate the question of weirs in the rivers of Madras and other provinces. The same year, he was made the Inspector General of Fisheries in India. He made several reports on fresh water and marine fish and fisheries in 1873. After his death in 1889, all the interest in the fisheries subsided.

Meanwhile Colonel Alcock made an investigation of the fisheries of the Bay of Bengal and found them

to be of inestimable value. But no work of practical importance was undertaken until 1905, when the Government of Madras initiated an enquiry into the possibilities of fishing industries, both fresh and marine water, under the supervision of Sir F. A. Nicholson. Soon after the publication of the report of this investigation, a department of fisheries was established in Madras.

The Government of Bengal started in 1906 a similar investigation under the direction of Sir (then Mr.) K. G. Gupta, who made his report in 1908, giving some very valuable suggestions. The Government of Bengal acted immediately upon the report and appointed a board and a department of fisheries, the latter being afterwards amalgamated with the Department of Agriculture.

The most important outcome of Sir K. G. Gupta's investigation was the appointment by the Government of Bengal of Dr. J. T. Jenkins, who, with the help of the trawler *Golden Crown* and the launch *Ila*, made several voyages on the Bay of Bengal and the estuaries of the Sunderban. He located and charted the fishing regions and ascertained the kind and quality of fish. He proved that sea fish could be landed in fresh condition in Calcutta from places as far distant as Akyab and that the average catches of the *Golden Crown* compared very favourably with those of the trawlers working in the White Sea, Bay of Biscay, North Sea, Irish Sea, English Channel, Iceland, Portugal and Morocco. But no practical step has yet been taken to tap these fish resources.

There does not exist any estimate as to the amount of the annual catch of fish in India. Fishing is mostly restricted to the inland water over a wide area and the products are consumed locally. Recently some data have been collected of fish supplies to the markets of Madras and Calcutta.

In the City of Madras the fish consumed in the year 1921-22 amounted to 4 million pounds in

weight and Rs. 5.6 lakhs in value. (1) A more detailed account of fish supply to Calcutta is shown in the following table. It is seen that in the year 1905-06, for which the first statistics are available, 194,000 maunds of fish were imported into Calcutta by railways and water ways. It rose to 435,000 maunds in 1922-23, showing an increase of 224 per cent, as indicated by the index number.

Fishing affords a large number of branch industries, but they are practically undeveloped. The modern methods of fish-preservation, such as canning, have not made any headway. The old-fashioned ways of preserving fish were drying in the sun or artificial heat, and dry and wet salting. The principal by-products of fish are isinglass, fins, skins, orbs, whips and manure.

From the fish supply to Calcutta and Madras, a very rough estimate may be made of the annual catch of fish for the whole country. (1) There are, however, several assumptions on which such estimation is based: First, that the per capita fish consumption in the country is the same as in a city like Calcutta or Madras. Although in the country the fish supply is more abundant during certain seasons, in the city it is more steady throughout the year. Second, that as far as the fish consumption is concerned, Calcutta is the representative of the provinces of Bengal, Bihar and Orissa and Assam, and Madras represents the provinces of Madras and Bombay and that these provinces include practically all the fish consuming regions of the country except Burma. Third, that the population of the latter provinces in 1921-22 was the same as in 1920-21 according to the census. There is a variation in population from year to year and any calculation on the basis of population requires necessary correction. But the estimation made here is too rough to need such minute correction.

In 1920-21, the total population of the provinces of Bengal, Bihar and Orissa and Assam amounted to 82.6 millions and that of the provinces of Madras and Bombay to 61.5 millions. Now it has been shown that 1.32 million people in Calcutta consumed 370, 100 maunds or 26.2 million pounds of fish in 1920-21 and that 500,000 people in the city of Madras consumed 4 million pounds of fish in 1921-22. On the basis of the assumptions laid down above, a simple calculation would give 1639 million pounds of fish for Bengal, Bihar and Orissa and Assam and 473 million pounds of fish for Madras and Bombay Presidencies or in other words, 2112 million pounds of fish for all these provinces. To this sum must be added

100 million pounds of fish which are consumed in 140 establishments on the coast of Madras. The total catch amounts to 2212 million pounds.

The importance of deep water fishing to the wealth of a country can be seen by the amount and value of the annual catch of various countries, as shown in the table below. It is seen that the value varies from 3 crores of rupees in the case of Germany to 240 crores in the case of the United States. According to the estimate made above, the annual catch of fish in India amounted to 2112 million pounds in 1921-22 valued at 29.5 crores of rupees.

### 3. Mining.

Mining and metallurgy were among the most important and highly developed industries in ancient India. Before the advent of the British, there flourished in the country such mineral industries as the manufacture of alum, alkaline compound, blue vitriol, lead, iron and steel and achieved a prominent place in the ancient metallurgical worlds. India anticipated the modern process of manufacturing steel and exported brass, borax and nitre. In the face of modern competition, the ancient industries have declined, but modern methods have not been sufficiently developed in India to raise her to the level of modern industrially advanced countries.

The mining products of India consist of such minerals as iron, coal, petroleum, salt, gold, chromite, copper, diamond, graphite, jadstone, lead, mangesite, manganese, mica, silver, saltpeter, tin, zinc and wolfram. India virtually controls the world's production of mica and manganese ore.

Coal production is the most important mining industry in India. The coal fields are not only comparatively few in number, they are also remote from sea-ports and centers of manufacture. Of the numerous coal fields of proved value in India, 18 are actually being worked, but only seven are of any considerable importance, while 89 per cent of the output is produced in the Ranigunj and Jharria fields. The output of coal in 1879-80 was only .98 million tons. It rose to 2,167 million tons in 1890 and to 19.5 million tons in 1921. The amount of coal production in India as compared with that in other countries is shown in the table below:

The above table shows that the United States raised, in 1920, 457 million tons of coal, i. e., more than the combined production of Germany and the United Kingdom, which countries raised respectively 169 and 166 million tons of coal. The coal production of other countries varies from 19 to 29 million tons. India and China both produced practically the same amount of coal and occupied the 7th place in the list of the countries mentioned above.

More rapid progress has been made in the production of petroleum than in the case of any other mineral. In 1890, there were only 4.1 gallons of oil raised and in 1920, the production rose to 293 million gallons. To the production of the world's petroleum, India's contribution was rather small. Of 769 million barrels of the world's production in 1921, the United States produced 469.6 million barrels or 61.7 per cent, Mexico 195 million barrels or 25.3 per cent, Russia 28.5 million barrels or 3.7 per cent, Dutch East Indies 18.0 million barrels or 2.3 per cent, Roumania 8.3 million barrels or 1.0 per cent and India 6.8 million barrels

or .8 per cent. The rest of the countries produced the remaining 5.2 per cent, as shown in the table below :—

Next in importance is gold mining. Small quantities of gold are washed in river gravels in various parts of the country, but it is chiefly mined from a rich reef in the Kolar field in the State of Mysore. The work began early in the eighties of the last century and is continued.

India's share in the production of the world's gold supply is shown in the table below. It is seen that the value of the world's production of gold in 1921 amounted to 95.7 crores of rupees and that of India 2.9 crores of rupees or 3 per cent of the total.

Manganese is another important mineral in which India holds the world's market, as shown in the table below. It is seen that in 1921 the world's production of manganese ore amounted to 1,140,000 tons of which India produced 679,000 tons or 59 per cent.

India also produces a considerable quantity of salt. The total production of the world amounted to 17,000,000 tons in 1921. The United States produced the largest amount, i.e., 4,447,000 tons. India stood fifth among the producing countries and raised 1,682,000 tons of salt or 9.8 per cent of the total, as shown in the table below :—

The most promising mining industry in India is, however, the production of iron ore. Earlier statistics are not available, but from the year 1916, there has been a gradual increase in its production, as shown in the table below. It is seen that the production of iron ore has increased from 411,800 tons in 1916 to 625,000 in 1922, showing an increase of 51 per cent, while in 1921 the increase amounted to 942,000 tons, i.e., 129 per cent.

In spite of the increase, the production of iron ore in India is very insignificant, in comparison with that of other important countries as shown in the table below. It is seen that the United States leads the world in the production of iron ore, mining 67,600,000 million tons in 1920, and is distantly followed by France and the United Kingdom, producing 13,800,000 and 12,700,000 tons respectively. India produced only 600,000 tons of ore in spite of its immense reserves.

Among the other important minerals might be mentioned zinc ore, saltpetre and lead. The relative

importance of different minerals in the mining industry of India may be judged from their respective values given in the table below. It is seen that in 1922, for which complete figures are available, the value of coal amounted to £9,755,300 or 40.8 per cent of the total, that of petroleum to £7,185,000 or 30 per cent of the total, and that of gold to £1,857,000 or 7.7 per cent of the total. The total value of all the minerals amounted to £23,905,000.

The growth in the value of minerals during the past 25 years is shown in the table below. It is seen that it rose from £3,450,000 in 1898, from which date complete data are available, to £ 23,905,000 in 1922, showing an increase of 591 per cent. It is also noticeable that there is a sudden rise in the value of the minerals in 1920. This was due to fluctuations in the value of the rupee which was 2 s. in 1920 as against 1 s. 8½ d in 1919 and 1 s. 4d. in 1921.

Some rough idea of the growth of the mining industry in India for the past thirty years may be had from the table below. It is seen that during the period the production of coal increased by 193 per cent, that of petroleum by 7225 per cent, that of iron ore by 1892 per cent, that of manganese by 429 per cent and that of gold by 366 per cent. The total production grew by 612 per cent, as represented by these minerals.

#### 4 Agriculture

Unlike mining, which is an extractive industry, agriculture is a genetic industry and is based on the breeding of plants and animals. The main requirements for agricultural production are fertility, moisture, livestock and implements.

##### Fertility

The most important element in the agricultural resources of a country is the fertility of soil. According to geological formation, the soils of India may be divided under the following heads :

First, the alluvial tracts, which are most extensive and agriculturally most important. They occupy the river basins of the country. The color of the surface soils varies from dark to light fawn or brown. The texture also varies from drift sands to stiff clays preventing drainage. The soil may extend unaltered in color and texture to a considerable depth, but the substrata are generally found in well-defined layers of sand, clay and loam. The amounts of nitrogen and organic matter are generally low. There is an adequate supply of potash, but phosphoric acid is rather deficient.

Second, the Deccan trap formation extends over 200,000 square miles. The soils vary in color and texture. On the slopes and uplands, the soils are thin and poor. When disintegrated, the trap furnishes a light-colored sandy or gravelly soil, which is moderately productive only in years of favourable rainfall. The lowlands have deeper color and contain black cotton soils. Black soils vary in texture and fertility, but all are highly retentive of moisture. There is a sufficient supply of potash, but the amounts of phosphoric acid, nitrogen and organic matter are generally small.

Third, outside the area of the Deccan trap and alluvial sections, crystalline tracts occupy the whole



of Peninsular India. The soils vary in color from light to red or reddish brown and in texture from thin and stony to clay-like composition. They are suited to a variety of crops, and like other soils, are deficient in phosphoric acid, nitrogen and organic matter.

Fertility is the power of soils to produce crops. Its essential factors are water, sun-light, temperature, soil bacteria and plant food. There is a good deal of plant food lying potential in soils. What is needed is proper cultivation to make it available. But no soil can supply food to plants indefinitely without being supplied with it from outside. The best source of plant food is the barnyard manure. But a good deal of it is burned in India. On the other hand, for lack of funds practically no cultivator uses any commercial fertilizers. It is one of the greatest drawbacks of the agricultural industry in India.

### Irrigation

Irrigation has been known to India from time immemorial. Although there is plenty of rainfall in some parts of the country, in others it is neither sufficient nor evenly distributed throughout the year. Irrigation has therefore been a means of supplementing the rainfall and of storing water for use in times of need. Through neglect, most of the ancient irrigation systems have undergone deterioration. In recent years, there has been a revival of irrigation works as shown in the table below :

The above table shows that the acreage of land irrigation in 1920-21 amounted to 48,957,000 in British Provinces and 8,145,000 in Indian States. They have increased from 29,220,000 to 57,102,000 acres, i.e., 95 per cent in 30 years.

Agriculture in several provinces depends largely upon irrigation. In Lower Burma, Assam, Eastern Bengal and the Malabar Coast, rainfall is generally heavy and the crops scarcely require any irrigation, but other provinces are more or less in need of irrigation. Of the total area irrigated in British India

in 1920-21, 27 per cent were in the Punjab, 23 per cent in the United Provinces, 19 per cent in Madras, 12 per cent in Bihar and Orissa, 6 per cent in Sind and the remaining 13 per cent in other provinces. (1)

The importance of irrigation to crops is shown still more clearly by the proportion of the irrigated to the total area in each of the following provinces, as shown in the table below. It is seen that it varied from 24 per cent in the case of Bihar and Orissa to 80 per cent in the case of Sind in 1920-21.

Irrigation works in India are of three different kinds, namely, lift, storage and rivers, which are represented by wells, tanks or reservoirs and canals. The wells and small tanks are often the property of private individuals, but large tanks and canals are generally built by Government.

The classification of irrigation works in British Provinces, for which alone complete statistics are available, is shown in the table below. It is seen that of the total irrigated acreage of 48 956,000 in 1920-21, only 20,078,000 acres, or 42.9 per cent, were irrigated by Government canals, 2,564,000 acres or 5.2 per cent by private canals, 7,236,000 acres or 14.8 per cent by tanks, 14,241,000 acres or 29.6 per cent by wells and 4,835,000 acres or 9.8 per cent by other sources. The table also shows the growth of irrigation works under different systems.

The Government irrigation works are grouped under two heads—major and minor works. The major works are again subdivided into productive and protective works, the former being more important. In 1920-21, for instance, of the total acreage of 20,047,000, the major productive works covered 18,319,000 acres or 91 per cent of the total and

minor works only 1,728,000 acres or 7 per cent. The productive works are built with borrowed capital in the expectation of their being self-sustaining and remunerative and protective works with public capital as insurance against famine. (1)

Irrigation has a decided effect on crop production. It often helps to raise more than one crop from the same area. But what is more important, it helps to increase the yield. It is clearly seen in the difference between the yields of crops in the irrigated and un-irrigated areas of the Punjab, where more than half the area is irrigated, as shown in the table below. It is seen that the increase in the yield of crops from irrigated areas varied from 20 per cent in the case of jawar to 71 per cent in the case of rice—a fact which proves the influence of moisture on certain crops such as rice.

## Livestock

Livestock serves an important function in national economy. It transforms straw, shrubs, grass and many otherwise useless products into matter and energy and furnishes labor, food and raw material.

The larger livestock of the country may be divided into five important groups : (1) the bovine, comprising oxen and buffaloes ; (2) the ovine or sheep ; (3) the caprine or goats ; (4) the chevaline, comprising horses, mules, donkeys and ponies ; (5) the porcine or swine. The smaller livestock consists of poultry and bees.

There is practically no livestock of the class of the porcine in India. The other larger classes are grouped under the following heads, as shown in the table below :—

The above table shows that the livestock of the class chevaline comprising horses, mules, donkeys and camels play a comparatively unimportant part in the industrial life of India. In 1920-21, there were 2,708,000 horses, 81,000 mules, 1,404,000 donkeys and 527,000 camels in all India. (1) The use of camels as beasts of burden is restricted mostly to arid regions. Mule-breeding has not found much favour in India. The number of donkeys is also small. The horses are not only small in number, but also small in size and unfit for heavy drafting. The present breeds of horses do not seem to thrive well under the climatic conditions of India and no new breed has yet been produced to suit the needs of the country.

More important than horses and camels are sheep and goats in India, which are raised for the purposes of milk, meat and wool. Goat's milk is extensively used in certain sections of the country. Both goats and sheep are used for meat by Mahomedans and a large number of Hindus. Goat's wool is generally used for the manufacture of blankets, but certain breeds of goats supply wool for the manufacture of shawl. The wool from sheep is rather coarse in comparison with that in colder regions. In 1920-21, there were 39,570,000 goats and 34,574,000 sheep in all India.

The most important domestic animals in India are the cattle, which include both oxen and buffaloes. Of 178,502,000 heads of cattle in 1920-21, there were 142,987,000 heads of oxen and 35,515,000 heads of buffaloes. The function of cattle in India is manifold. First, they are used for labor in cultivation and drafting. Thus of 105,847,000 mature oxen in 1920-21, there were 7,085,000 bulls, and 52,399,000

bullocks or working cattle, that is, half the number of the cattle was used for labor. Besides, the cows which numbered 46,363,000, are also used, at least for part of the time, for labor in the field. Second, they supply milk, butter and the limited demand for meat. Third, together with goats and sheep, they supply hides and skins and other by-products such as bones. Hides and skins form one of the largest items of India's export trade. Fourth, cattle manure is the main source of fertility in India. Buffaloes serve the same purpose as oxen. Their milk is used in several sections of the country and is much richer in butter fat than that of the cow. In swampy regions, they thrive better than oxen. In 1920-21, there were, in all India, 6,475,000 heads of buffalo bulls, 17,238,000 heads of buffalo cows, and 11,802,000 heads of young stock.

There has been an appreciable growth in the number of domestic animals in India during the last 35 years. Accurate and complete data are not available for the livestock in Indian States. The growth of livestock in British Provinces is shown in the table below. It is seen that in 1884-85, there were 22,810,000 heads of cattle, 18,556,000 heads of sheep and goats, 439,000 heads of horses and ponies and 630,000 heads of mules and donkeys. Taking the more accurate data of 1890-91 as the basis of calculation, it is seen that the cattle have grown in number from 66,478,000 heads in 1890-91 to 145,103,000 heads in 1920-21 or 118 per cent, sheep and goats from 29,346,000 heads to 46,369,000 heads or 58 per cent, horses and ponies from 957,000 heads to 1,697,000 heads or 66 per cent, mules and donkeys from 957,000 heads to 1,445,000 heads or 36 per cent.

In spite of the growth in number, cattle-raising is not a profitable business in India. There are several reasons for that : First, religion makes the killing of cattle an act of sacrilege among Hindus, who form the majority of the population. Out of respect for Hindus, many Mohammedans are also averse to the killing of cattle. The result is that most of the cattle in India grow very old and live a long life of inactivity before their natural death. For the same religious belief, the disposal of cattle by killing at the time of approaching drought or famine, becomes impossible, and men and cattle die together without offering any chance for preserving human life at the cost of cattle or even saving the best stock at the sacrifice of the poorer ones. Second, although there are several good breeds in India, the majority of cattle, for example, those of Bengal amounting to one-sixth of the whole, are very poor as far as the yield of milk and energy are concerned. Even for food purposes, they are inferior. This is partly due to the character of the breeds and partly to the lack of sufficient amount of rich and concentrated feed, which is essential for making meat flavory and juicy. Third, cattle as the source of energy are inefficient, though under present conditions in India they may be inevitable.

Of other larger domestic animals on the farm, pigs play a very important part in agricultural economy. They utilise many products and offals of the farm which cannot be done by any other means. Ham, bacon and lard are often the by-products of milk and beef industries. In the United States, pigs are used in turning its most important crop, namely, maize, into meat and fat. The same is true of other countries to a more or less degree. But due to religious belief, the raising of pigs has scarcely found any favour in India. It is untouchable to Hindus and Mohammedans alike. Only a few so called lower classes rear them for their family consumption.

The number of pigs in India is so insignificant that no statistics have yet been collected.

Among the smaller domestic animals, poultry and bees are the most important. The number of poultry, comprising ducks, geese and chickens, is unknown. In turning into food products such as meat and eggs, poultry serve a very important function in utilising the offals from kitchens, tables and barns as well as plantlets and small animals. Bee culture is another important industry in connection with agriculture. In India where every season has its new fruits and flowers, there is a great opportunity of producing honey and wax. They are produced to a limited extent in different parts of the country. But scientific method has not yet been applied to Indian apiculture for extensive production.

In the possession of livestock, India occupies a very high place among the countries of the world. She has the largest number of cattle and the second largest of sheep and goats, possessing 178 million heads of cattle as against 68 million heads of the United States and 66 million heads of sheep and goats as against 87 million heads of Australia, as shown in the table below. It is also seen that the United States has the largest number of horses, mules and donkeys, amounting to 21 million heads as against 20.9 million heads of Russia and has also the largest number of hogs numbering 73 million heads as against 14 million heads of Germany. India has only 4 million heads of the former and practically none of the latter.

In spite of a large stock of domestic animals, India falls far behind other countries as far as their number in proportion to the population is concerned. This is very clearly shown by a comparison of her stock per 100 persons with that in other countries in the table below. It is seen that as to the animals of bovine and chevaline classes, Argentine leads the countries under consideration, possessing 299 heads of cattle and 97 heads of horses including ponies, etc., per 100 persons and is followed by Australia with 236 heads of cattle and 46 heads of horses, etc. With respect to sheep, Australia is, however, far ahead of other countries and has 1,613 heads per 100 persons, Argentine with 503 heads standing distantly second. In the possession of pigs, the United States take the lead, having 68 heads per 100 persons as against 33 heads of Argentine, which has the second largest number. India with 56 heads of cattle and buffaloes and 21 heads of sheep including goats and only one head of horse, etc. per 100 persons, stands respectively fourth, eighth and last among the nine countries mentioned in the list. Moreover, like other countries, she has no pigs, as noted before.

## Implements.

Farm implements in India are comparatively few in number and simple in kind. They form a very small part of agricultural capital in comparison with that of other advanced countries. There are several reasons for this condition, such as the smallness of holdings, cheapness of labor, primitiveness of culture, lack of training and poverty of cultivators. Modern implements have scarcely found their way into Indian farms. Most of the agricultural implements in India are therefore small in size, obsolete in kind and insignificant in value.

The plough is the principal implement, which is supplemented by scarifier and seed drill in the Deccan. Bullock hoes, harrows, levellers and cold crushers are among the other implements used in different parts of the country. Of handtools, crowbar, kodali, picks, sickles and sieves are the chief.

Owing to their smallness, there scarcely exists any record as to the number of tools and implements used on farms. Carts and ploughs are the only implements which have so far been enumerated, as shown below. The statistics for years previous to 1910-11 are not complete. It is seen that the number of ploughs rose from 21,444,000 in 1910-11 to 27,571,000 in 1920-21 and that of the carts from 5,877,000 to 6,947,000, showing an increase of 28 per cent and 18 per cent respectively.

### Plantations

In connection with agriculture must also be considered the plantations which produce special commodities, such as coffee, tea and indigo. The history of plantations in India dates back to the middle of the 18th century or still earlier, when several British-settlers began to grow indigo with the help of Indian labor. In the course of time plantations for the other products grew up in different sections of the country. In 1910-11, there were 1,687 establishments employing 810,407 persons and in 1920-21, there were 2,266 establishments with 820,868 employees.

### Cultivation.

The gross area cultivated with crops amounted in 1920-21 to 239 million acres in British Provinces and 57 million acres in Indian States, or 296 million acres in all India, counting the areas sown more than once as separate areas. But the net area actually sown with crops was 212 million acres or 34 per cent of the total area in British Provinces and 54 million acres or 41 per cent of the total in Indian States. Of the gross total area sown in all India, food crops occupied 241 million acres or 81 per cent and non-food crops 55 million acres or 19 per cent. In other words, over four-fifths of the area were devoted to the production of food, as shown in the table below :

Chief among the food grains are rice, wheat, barley, jawar, bajra, ragi, maize and gram. They together with minor food grains occupy 77 per cent of the total area. The statistics for fruits and vegetables are not complete. A large amount raised in orchards and kitchen gardens is scarcely recorded. Of the non-food crops, fibres, especially cotton and jute, are the most important. They occupy about 7.6 per cent of the total area. The oil seeds chiefly consists of linseed, sesamum and rape and mustard. These together with some minor crops are cultivated on 5.6 per cent of the area. Among the fodder crops are included only those which are used exclusively as fodder in normal times. They are oats, field vetch, guinea grass, lucerne, fodder jawar and carob or locust trees. The total area under fodder amounted to 3.5 per cent of the whole area in 1920-21. Among other non-food crops, opium, coffee, tea, tobacco and other drugs and narcotics are the chief.

The relative importance of the staple crops is indicated by the respective areas devoted to their cultivation. In the last 28 years there has been a slight variation in the area, as shown in the table below. It is seen that as far as the amount of land devoted to their cultivation is concerned, rice is by far the most important crop, occupying 78 million acres, and is followed by jawar, wheat, cotton and bajra, occupying respectively 23, 20, 14 and 12 million acres.

During the last 28 years, there has been a decrease in the areas devoted to the cultivation of wheat, bajra, gram, rape and mustard, and an increase in the areas devoted to the remaining crops. The largest increase has taken place in the case of cotton amounting to 38 per cent and the largest decrease in the case of rape and mustard amounting to 37 per cent.

Both in areas devoted to cultivation and in yields, some of the crops raised in India play an important role in the world's agriculture. Of these crops, rice, wheat, cotton, barley, maize, jute, rapeseeds, linseed, tea, tobacco and wool are the chief.

India is by far the largest rice growing country in the world. Of 49.8 million hectares devoted to the cultivation of rice in 1921-22, 33 million hectares were in India producing 519.9 million quintals(1) of rice out of the world's production of 804.2 million quintals, as shown in the table below. It is seen that the area under rice in India amounted to 66 per cent of the total and the crops produced to 64 per cent of the total.

Wheat is the most important food crop in the world and to its cultivation, 87.5 million hectares of area were devoted in 1922-23 with an yield of 850.8 million quintals. In India, it covered 11.4 million hectares, i. e., 13 per cent of the total area and yielded 99.7 million quintals, that is, 11.7 per cent of the total crop. The United States cultivated 24.7 million hectares of land and produced 233 million quintals of wheat or 28 per cent of the total area and 27 per cent of the total crop and stood first in both area and yield. India was second in area and third in yield, as shown below:

Next to wheat, cotton is the most important crop. In 1922-23, it covered a total area of 23.9 million hectares in different parts of the world, which yielded 35 million quintals of crop. Of these, India cultivated 8.5 million hectares and produced 26.3 million quintals as against 13.4 million acres of area and 60.3 million quintals of crop in the United States. Both in area and yield India stood second in the world, as shown in the table below :

Barley is another important crop among the food grains of the world, and covered 23 million hectares of area and yielded 263.6 million quintals of products in 1922-23. In India, it occupied 2.9 million hectares of area and yielded 31.7 million quintals of products. Both in area and yield, India stood second as against Russia with 3 million hectares of area and the United States with 405 million quintals of crop.

Maize is another important cereal occupying a large area of the world's arable land. In 1921-22, an area of 61.1 million hectares was devoted to its cultivation and 1,070.5 million quintals of crops were produced. The United States is by far the largest maize producing country in the world, cultivating 41.9 million hectares of land or 68.5 per cent of the total area and producing 779.4 million quintals of crop or 72.8 per cent of the total crop. In India, 4 million hectares of land were cultivated and 2.2 million quintals of crop produced, as shown in the table below :

Linseed is one of the most important oil-seeds, occupying 4 million hectares of the arable land of the world in 1922-23 including Russia. The total production was 21.9 million quintals. Argentine with an area of 1.6 million hectares and production of 11.2 million quintals led the world and was followed by India with an area of 1.2 million hectares and a production of 4.4 million quintals, that is, 20 and 20 per cent of the world's total respectively, as shown in the table below :

Tobacco is also one of the most important crops of the world, the estimated production of which amounts to 4,500 million pounds a year on the average. Of these, India produces about 1,000 million pounds or 22 per cent, and is followed by China raising 500 million pounds or 11 per cent a year. ### 5. Manufacture.

In ancient times India made considerable progress in manufacture in spite of the fact that she was, and still is, pre-eminently an agricultural country. Until the middle of the 18th century, she not only supplied limited demand of her people for manufactured goods, but also had a large export trade. With the beginning of the 19th century, the industrial organisation underwent complete change under the rule of the East India Company. Manufacture declined and agriculture became the main support of the artisan classes. Within the last two generations, there has been a growing tendency in India for modern industries. The factory system has been established and domestic manufactures are again finding their place in the foreign market.

#### Handicrafts.

The handicraft system is, however, still more important than the factory system in India. The chief handicrafts are weaving, pottery-making, carpentry, smithing, oil-pressing, masonry, tailoring and shoe-making. Among the artistic crafts are to be classed such works as those in wood, clay, stone, metal and textile.

#### Industrialism.

The essential feature of modern industrialism is the factory system which has been well-established in India. Other modern industries also have made rapid progress. In 1911, there were in the whole of India 7,113 large scale industries employing 2,105,624 persons. In 1920-21, the number of industries rose to 15,600 and that of the employees to 2,601,000. But including all classes of workers, such as those in transport, the industrial population of India was 8,000,000 in 1920-21.

From the view-point of industrial population, India stands very high among modern advanced

countries, as shown in the table below. It is seen that the industrial population of India in 1921-22 amounted to 8 millions as against 13 millions of the United Kingdom and 12 millions of Germany. Taking the industrial population of the United Kingdom, which is most advanced in manufacture, as base, the index number for India as well as that for France stood at 61·5 as against 91·6 for Germany. The list excludes the United States which is a highly industrial country and also Russia for which no recent statistics are available. India can, however, claim the fifth place among the industrial nations.

In proportion to her vast population, the number of workers who find occupation in modern industries in India is, however, very insignificant, amounting to 1·5 per cent as against 27·6 per cent in the United Kingdom and 25 per cent in Switzerland. India is, therefore, still in the rudimentary stage of industrial development.

### The Joint Stock Companies.

One of the most important features of modern industrial organisation is the rise of corporate enterprise, which is represented in India by the joint stock companies. They indicate the industrial growth of the country, especially regarding factories and other large scale industries.

The Joint Stock Companies Act was passed as early as 1882 and amended in 1913. The total number of companies limited by shares and incorporated in India under the laws relating to the registration of companies was 8887 up to the year 1919-20. Of these only 3,668, or 41 per cent, were working at the end of that year with a total paid-up capital of 123 crores of rupees.



The growth of the joint stock companies within the last 30 years is shown in the table below. It is seen that they have increased in number from 1309 in 1895-96 to 4283 in 1920-21 and in the amount of paid-up capital from 24 crores in 1890-91 to 158 crores in 1920-21, showing an increase of 227 and 558 per cent respectively. It is also seen that the amount of capital for each company increased from 2.6 lakhs to 3.6 in 20 years. This is due partly to the lower purchasing power of the rupee, partly to the facilities for raising capital and partly to the need of increasingly larger capital for modern business enterprise.

Beside the above companies registered in India, there were also in 1920-21, 643 companies with a paid-up capital of 495 million pounds, which were registered abroad but did business in India.

The largest number of companies registered in India were formed for trading purposes and amounted to 1834 in number or 42.8 per cent of the total,

and had a paid up capital of 59.7 crores of rupees or 37.7 per cent of the total, as shown in the table below. The trading companies were followed by banking, loan and insurance companies, which numbered 741 or 17.3 per cent of the total and had a paid up capital of 19.5 crores of rupees or 12.3 per cent of the total. The number of companies for textile industries amounted to 469 or 10.9 per cent of the total, but had a paid capital of 40.7 crores of rupees or 25 per cent of the total. Other important joint stock companies were formed for such industries as plantation and mining.

#### Factories.

A factory in India is any premise using power-driven machinery and employing 20 persons or more according to the Factory Act of 1922. No reliable

data regarding the number of factories are available prior to the year 1892, when the first statistics were gathered, and 653 factories were found to exist in the whole country. The gradual growth in number of factories and of employees is shown below. It is seen that in 30 years from 1892 to 1921, the number of factories increased from 653 in 1892 to 3957 in 1921 and that of employees from 316,715 to 1,263, 658, i. e., 506 and 298 per cent respectively. During the same period the number of employees per factory decreased from 485 to 319. This reduction is due to the inclusion of smaller establishments within the jurisdiction of the factory Act.

The importance of India's factory system becomes evident by comparing her factories with those in other countries like Japan and the United States. In 1919, Japan had, for instance, 23,831 factories employing 1,390,941 persons(1) and the United States 290,105 modern industrial plants employing 9,096,372 persons, (2) as shown below. It is seen also that of the three countries, India had the largest number of employees per establishment or factory, that is, 369 as against Japan having 58 and the United States having 31. This is due to the fact that more small industrial plants are included within the jurisdiction of the factory law in Japan and the United States than in India.

The cotton industry is the most important of manufacturing industries in India. The spinning and weaving of cotton had been known to the people of India for centuries, but it was not until 1851 that Bombay started its cotton mills. In a decade about

a dozen mills sprang up round about the city. In 1878-79, there were 58 mills with an authorised capital of 5.62 crores of rupees and 80,000 pounds, 12,983 looms and 1,436,464 spindles. In the year 1920, the number of mills rose to 278, that of looms to 117,900 and that of spindles to 6,652,000 and the amount of authorised capital to 56.24 crores. The growth of the cotton industry from 1879-80 to 1920 is shown below. It is seen that taking the average of the quinquennium from 1879-80 to 1883-84 as base, the number of mills has increased by 341 per cent, that of looms by 713 per cent and that of spindles by 313 per cent and the amount of authorised capital by 764 per cent.

In manufacturing cotton, India occupies an important place in the world's industry, as indicated by her possession of spindles and looms and by the consumption of cotton in her mills. In the year 1920, there were 154 million spindles in the world, of which 134 millions were active. Great Britain led the manufacturing countries and possessed 56 million spindles or more than one-third of the total and was followed by the United States with 37 million spindles. In the possession of looms, Great Britain and the United States similarly took the first and second places having respectively 790,000 and 729,000 looms. India possessed 6.8 million spindles and 119,000 looms, i.e., 4.5 and 4.2 per cent of the total respectively and stood sixth and seventh among the nations. During the same year, the total consumption of cotton in the world amounted to 9,322 million bales, of which India used 945 or one-tenth of the total and stood fourth in the list, as shown in the table below :

Next in importance is the manufacture of jute, fabrics of which had long formed the rough clothing of the poor. In 1854, spinning machinery were brought from Dundee and the first jute factory was established at Serampore. The growth of the jute industry in the quinquennial averages from 1879-80 to 1918-1919 and in annual for 1920-21 is shown in the table below. Taking the quinquennial average for 1879-80 to 1883-84 as base, it is seen that in 1920-21 the number of mills increased by 257 per cent, that of looms by 654 per cent and that of spindles by 888 per cent and the amount of authorised capital by 569 per cent.

The third in the series of the textile industries is woolen manufacture, which has met with little success against foreign competition. Rugs, carpets and shawls are still made with hand looms in workshops, but their annual output is considerable. In 1905, there were 6 mills with 715 looms and 27,387 spindles. In 1919, the number of mills rose to 7, that of looms to 1,385 and that of spindles to 47,020. Only five factories made a report of their authorised capital, which rose from 46 crore of rupees in 1905 to 2.81 crores in 1909.

Next to the manufacture of textile goods is the iron and steel industry. Only two decades ago, the production of iron and steel was insignificant, but since the beginning of the Great War, it has become one of the most promising industries of the country. While several old companies have been revived, the Tata Iron and Steel company, a new organisation, has become one of the largest concerns in the world.

The production of iron and steel during the last few years is shown in the table below. It is seen that the production of pig iron rose from 244,700 tons in 1916 to 366,600 in 1922, showing an increase of 49 per cent. But at the same time, the production of steel slightly fell from 114,000 tons in 1917 to 111,500 in 1922, i. e., decreased by 2.5 per cent.

In comparison with other countries, India's production of iron and steel is almost insignificant, as shown in the table below. It is seen that the world's production of pig iron and steel amounted to 59.8 millions and 56.6 million tons respectively in 1920 and 1919. Of these, the United States alone produced 37.5 million tons of the former and 35.2 million tons of the latter, i.e., 62.7 and 62.5 per cent respectively. India produced only .31 million tons of pig iron and .12 million tons of steel, i.e., .5 and .2 per cent respectively.

### Outturn

It is hard to estimate the products of manufacturing industries in India. Most of them are produced by handicrafts and consumed locally. The most important handicraft products are the cotton goods, a rough estimate of which may be made in the way shown in the table below. It is seen that by subtracting the yarn exported or re-exported from the

total quantity of the domestic and imported yarn, we find the quantity of yarn consumed by both handlooms and mills in India. Since the quantity of the yarn consumed by the mills is known, that consumed by the handlooms is found by mere subtraction. At the rate of 4 yards of cloth per pound of yarn, the amount of cloth woven by the handlooms is calculated in the last column. It is seen that the amount of handiwork production of cotton cloth has increased from 748 million yards in 1896-97 to 1176 million yards in 1920-21.

One of the important features of the cotton industry is that the domestic products of cotton fabrics are growing more rapidly than their imports. This is clearly seen in the case of grey and bleached goods, as shown in the table below. It is seen that while the amount of the products in Indian mills rose from 319.5 million yards in 1900-01 to

871 million yards in 1915-16, i.e., from 19.3 per cent of the imported goods, to 42.8 per cent, the increase jumped into 1076.3 million yards in 1919-20, i.e., 125.8 per cent of the imported goods. This phenomenal increase is partly due to the fall of imports as the results of the general depression of business and banking in Europe arising from the after-effect of the Great War, but is also partly due to the increasing capacity of Indian mills.

Some idea of the progress of the manufacturing industries in India may be had from the increase in the products of cotton and jute industries, as shown below. It is seen that the amount of yarn grew, although not without some fluctuation, from 432 million pounds in 1895-96 to 621 million pounds in 1920-21 and that of woven goods from 83 million pounds in 1896-97 to 339 million pounds in 1920-21, showing an increase of 43 and 300 per cent respectively. The products of jute industries increased much more rapidly as shown in the volume of their exports. The number of gunny bags rose from 99 millions in 1890-91 to 534 millions in 1920-21 and



the amount of gunny cloth, from 30 million yards to 1352 million yards during the same period, showing an increase of 439 and 4466 per cent respectively. The growth of the total productivity of the manufacturing industries as represented by these four items is shown in the last two columns. Taking as base the figures for 1900-01, for which complete data are available, it is seen that the productivity increased by 178 per cent in twenty years.

## Transport.

Transportation is the key to the modern industrial organisation. The most important systems of transportation are roads, railways, tramways and waterways. To these must also be added such other means of communication as post, telegraph, telephone, radiograph and airship.

## Roads.

Road-building was a common custom with Hindu princes even before the Christian era. But it received a new impetus under Mahommedan rulers. Many trunk roads like those between Bengal and the Punjab were built during the Mahommedan period. Metalled roads for heavy draft were not, however, constructed until within recent years. In 1850, there were only a few miles of metalled roads in the whole country, and since then there has been a gradual, though slow, increase in milage of both metalled and unmetalled roads, as shown below. It is seen that metalled roads increased from 38,089 miles in 1900-01 to 55,456 miles in 1920-21 and the unmetalled roads, from 133,808 miles to 148,456 miles, thus leading to a total increase from 176,897 miles to 204,344 miles of both metalled and unmetalled roads. In 1920-21, there were also 4328 miles of bridle paths and 1911 miles of fair weather and temporary roads.

## Railways.

The work of railway construction began in India in 1853 with a capital outlay of 3.7 crores of rupees. In 1863, 2,507 miles of railways were built at the total outlay of 53 crores. They have since then steadily increased and the milage opened for traffic amounted to 37,029 miles in 1920-21. Of these, 18,195 miles were of the standard gauge (5 1/2), 15,248 miles of the metre gauge (3-3/8) and 3,586 miles of other gauges (2 1/2 and 2 ft.)

The gradual growth in the milage and the capital outlay of the railway system in India is shown in the table below. It is seen that during the last 48 years the milage increased from 5,697 miles to 37,029 and the capital outlay increased from 91.7 crores to 626.8 crores, that is to say sevenfold in each case. On the other hand, the gross earnings also increased from 7.2 crores to 91.9 crores, that is, about thirteen fold.

In spite of the increase of the milage, the Indian railways fall far short of satisfying the needs of

modern life, which depends so much upon transportation systems. This is very well seen by comparing the railways of India with those of other countries, as shown in the table below :

The above table shows that in the years between 1919 and 1922, the United States had by far the

largest railway line in the world, which amounted to 422,437 kilometres. Amongst the other large railway systems were those of the Russian Empire, Canada and India, amounting respectively to 64,902, 62,603 and 59,859 kilometres. According to area, Belgium, however, led the world, having 30 kilometres of railway per 100 square kilometres and was followed by Great Britain, Germany and France having respectively 14.2, 11.6 and 9.5 kilometres. But from the viewpoint of population, the most advanced countries were Australia, Canada and Argentine, occupying the first three places with the respective lengths of 76.4, 61.3 and 42.1 kilometres per 10,000 inhabitants. It must, however, be remembered that a new and extensive country with a sparse population and modern civilisation is likely to have a larger railway line than a densely populated country. If the population be increased two or three times in such a country, there would scarcely be a proportionate increase in the railway line. These countries should, therefore, be excluded for the purpose of comparison. Among the large and populous countries, the United States had 39.4 kilometres per 10,000 inhabitants and France, Belgium and Australia had respectively 12.9, 11.7 and 10.6 kilometres. India stood last in the list with the exception of China, and had only 1.86 kilometres of railway per 10,000 inhabitants.

The relative position of India with regard to the railway transportation becomes still more clear by a study of the traffic in the chief countries, excluding Germany for which the records are not available, as shown in the table below. It is seen that the largest number of passengers travelled on the railways of Great Britain and the United States, amounting respectively to 1591 and 1085 millions. India stood fourth in the list with 460 million passengers. But from the viewpoint of the number of times each inhabitant travelled, Australia took the

lead with a record of each passenger travelling 51 times and was followed by Great Britain with a record of 33 times. India with a record of 1.4 times stood last in the list with the exception of China and Russia. Taking into consideration the freight carried by each railway system, the United States took the lead both in the total and per capita amounts of freight which were 2,306 million tons and 22 tons respectively. The per capita amount of freight in India was only .3 ton and excepting that of China, was the lowest as compared with the countries mentioned in the list. It is worth while to remember that the railway traffic is generally supplemented by those of tramways, subways, elevated railways, steamers and motors or wagons. The addition of these traffics will make some decided change in the relative positions of these countries.

## Waterways

Waterways are still the cheapest and one of the most important means of transportation. There are several great rivers in India, but they are not evenly distributed. The rivers in western and southern India are few in number and mostly unfit for navigation. Whatever small navigation is being carried on in the Indus at present will come to an end as soon as the Punjab and Sind canals are opened for irrigation. Bengal, Assam, Bihar and Orissa are traversed by several large rivers which still form the high ways of commerce in the North-eastern India.



Besides, there are innumerable small rivers, tributaries, creeks and backwaters which are fully utilised by small crafts. Rain in summer turns the whole of lower Bengal and several other districts of India into a vast mass of water, making navigation easy and cheap.

The navigable canals in India are insignificant. In several provinces, some of the large irrigation canals are used for navigation purposes. In 1920-21, there were opened 4,471 miles of canals on which plied 204,593 vessels carrying 2,389,927 passengers and 14,499,339 tons of cargo.

The most important waterway for international trade is the sea, which surrounds India practically on three sides. But the coasts of India are low and sandy and deficient in good harbours. With the exception of river mouths, there are scarcely any openings into the land. The only chief ports of India are Karachi, Bombay, Tuticorin, Madras, Calcutta and Rangoon.

Merchant shipping is practically undeveloped in India. Indian shipping took an important part in foreign trade during ancient and medieval times, but has declined under British rule. Thus in 1922-23, including vessels of 100 tons or more, India together with Ceylon had only 230,883 tons of merchant shipping. The relative position of India in the merchant shipping of the world is shown in the table below. It is seen that in 1922-23, India and Ceylon had only .23 million tons of merchant shipping i. e., .3 per cent of the total shipping of the world as against 19.2 million tons of Great Britain and 16.9 million tons of the United States, i. e., 29 per cent and 25 per cent of the world's shipping respectively.

Owing to the inadequacy of the merchant marine, the shipping trade of India is almost entirely in the hands of foreigners, especially the British. Thus of the total volume of 15,473,221 tons of shipping including vessels entering and those clearing at the ports in 1920-21, only 190,035 tons or 1.2 per cent were native, 12,072,403 tons or 78 per cent British or British Indian and the remaining 3,210,783 tons or 20.7 per cent belonged to other European and non-European countries.

## Post Office.

One of the most important means of communication in modern times is the postal service. It is, therefore, logically connected with the transportation system. Its main business is the conveyance and delivery of letters, post cards, newspapers, parcels book packets. To these have also been added such other functions as the remittance of money, establishments and maintenance of savings banks and selling of bonds.

It was in 1837 that a public post was first established in India. The organisation of the present postal system did not begin, however, until 1854. In 1876 India became a member of the Universal Postal Union. The function of the post office has since then gradually widened.

In 1860-61, there were in British India only 889 post offices carrying 48.4 millions of articles exclusive of money orders. The progress of the postal service during the past fifty years, i.e., from 1870-71 to 1920-21, is seen in the table below. It is seen that the number of post offices increased from 2,736 to 19,496 and the milage of mail line from 52,000 to 158,000<sup>1</sup> and the amount of revenue, from 81.2 lakhs of rupees to 535.6 lakhs. In the year 1920-21, the personnel of the post office numbered 102,885, of whom 2404 were village postmen.

In spite of its progress, the post office in India is quite inadequate to serve the varied interests of modern industrial and intellectual life. This becomes clearer when the Indian postal system is compared with that in other countries, as shown in the table below. It is seen that in 1921 for every 13 square kilometres, there was one post office in Germany and Great Britain, while in Russia, there was one post office for every 1174 square kilometres. It must be remembered that large parts of Russia are uninhabited. The same is true of the United States. In India each post office had an average of 93 square kilometres within jurisdiction. As far as the number of post offices in proportion to the population is concerned, Germany stand first. There is one post office for every 1700 people. India stands last in the list with one post office for every 12,800 persons of the population. The number of letters and cards per inhabitant was also the lowest in India amounting to 5 as against 89 in the case of the United States and 79 in the case of Great Britain.

### Telegraphs

One of the quickest means of communication is telegraph, which has rapidly increased in India as in other countries. In 1851-52 there were only 82 miles of line with the same milage of wire and cable, which have steadily increased in each succeeding decade. The progress of the telegraph system during the past 50 years is shown below. It is seen that the milage of the line increased from 13,500 to 91,700 and that of the wire and cable from 22,800 to 412,000 and the amount of revenue from 12.9 lakhs to 350.50 lakhs, thus showing an advance amounting to 579, 1701 and 2613 per cent respectively.

The relative position of India in the development of the telegraph system is shown below. It is seen that in the milage of lines, the United States, Russia and Germany occupy the first three places with 245,500,153,100 and 148,100 miles respectively, India with 87,800 miles stands fifth in the list. But as far as the number of messages per person is concerned, India occupies the last place, having only 06 messages as against 3.2 of Australia and 1.7 of Canada. The details on these points are lacking in the case of Russia and China.

## Telephone.

With respect to telephone service, India is still in the infant stage of development. The telephone system is partly in the hands of the Government and partly in the hands of private companies in such important cities as Calcutta, Madras, Bombay and Ahmedabad. In 1921-22, there were 10 telephone exchanges with 23,958 connections established by private companies and 255 exchanges with 11,988 connections established by the Government. In the same year, there were 22 wireless Government stations. Only four of these were open to the public for transmission of messages.

The telephone system in India as compared with that in other countries is shown in the table below.

It is seen that the United States and Canada lead other countries in the number of telephones having respectively 13.1 and 10.2 per every 100 inhabitants. They are followed by Denmark, Sweden and other smaller countries. India had only .01 telephone for every 100 persons.

The latest means of communication, such as radiograph, which has been successfully introduced even in a backward country like China, and air service, which has been introduced in many Western countries, are practically unknown to India.

The progress of the transportation system during the past forty years is shown in the table below.



It is seen that the railway production increased by 322 per cent in the case of passengers and 235 per cent in the case of freight, and the foreign shipping increased by 106 per cent. During the same time, the postal service increased by 435 per cent in the value of the money orders issued and by 329 per cent in the number of articles carried, and the number of paid telegrams increased by 505 per cent. The total production of the transport system showed an increase of 323 per cent.

## 7. Banking.

Banks in India may be divided into three groups : general banks including industrial and mortgage banks, postal savings banks and co-operative banks.

Of the general banks, the following are the chief : First, the Imperial Bank comprising the banks of Bengal, Bombay and Madras. They were originally the Presidency Banks and were recently combined into the Imperial Bank. Their business is confined to fixed territories. Beside undertaking ordinary banking activities as regulated by banking laws, they act as banker to Government. Second, the Exchange Banks with head offices abroad. Some of them were established half a century ago. The business of these banks is twofold : transaction of exchange business between India and foreign countries and ordinary banking activities like that of the Imperial Bank. In 1920, there were 15 exchange banks in India with a number of branches. Third, Indian Joint Stock Banks, which with the exception of a few have been organised within the last two decades. They are registered under the Indian Companies Act and, unlike the exchange banks, have their head offices in India. They are subdivided into two classes : First, those with a paid up capital and reserve of Rs. 5 lakhs or more. Second, those with a paid up capital and reserve amounting to any sum between one lakh and less than 5 lakhs. Statistics are taken only of those banks which have a minimum paid up capital and reserve of one lakh of rupees. In 1919, for instance, there were altogether 95 banks and 230 branches and agencies, but in the statistics for that year were included only 47 banks and 224 branches. There is no land mortgage bank or industrial bank in India in the proper sense of the word.

The growth of general banking in India is shown in the table below. It is seen that the capital and

reserves of all classes of banks comprising Presidency Banks, exchange banks and joint-stock banks, rose from 5.9 crores of rupees in 1871 to 108.7 crores in 1920-21. But excluding the capital and reserves of the exchange banks, which are outside India, the amount inside India rose from 3.7 crores to 18.4 crores in 1920-21, showing an increase of 497 per cent in 50 years. During the same period, the amount of deposits rose from 12.4 crores of rupees to 232.9 crores and that of cash balance from 10.6 crores to 67.5 crores, showing an increase of 1768 and 537 per cent respectively.

## Postal Savings Banks.

The first government savings bank was established in Calcutta in 1833 and was followed by similar banks in other Presidency towns. In 1870, district savings banks were also instituted in connection with district treasuries. It was in 1882 that the postal savings banks were opened all over the country. The district savings banks were transferred to the postal savings banks in 1886 and the Presidency savings banks were closed in 1896. The administration of Postal Savings banks is within the jurisdiction of the Post Office Department. The Government regards the deposits as unfunded debts and there are no specific reserves against them. The postal savings banks offer an opportunity mostly to the urban population. The maximum amount receivable for deposit is Rs. 5,000 and the rate of interest is 3 per cent.

The growth of Postal Savings Banks is shown in the table below. Taking the quinquennial averages from 1882-83 to 1886-87 as base, it is seen that in 1920-21 the number of depositors increased from 196,000 to 1,78,000 or 858 per cent and the amount of deposits from 3.0 crores of rupees to 18.8 crores or 515 per cent, that of the withdrawals from 2.5 crores to 17.3 crores or 571 per cent and that of the balance of deposits from 4.3 crores to 22.8 crores or 426 per cent. It is also seen that at the outbreak of the war, the amount of withdrawals increased from 9 crores to 17.8 crores and per capita deposit fell from 141 to 91 rupees. In 1920-21, the per capita deposit was 121 rupees.

### Co-operative Credit banking.

Co-operative credit societies were instituted in India by an Act in 1904 in order to "encourage thrift, self-help and co-operation among agriculturists, artisans and persons of limited means." The underlying aim was to induce deposits from the non-agricultural population, such as money-lenders, merchants and the professional classes, to supplement the finance of the agricultural population. They are divided into two classes, namely, agricultural and non-agricultural, according as members of one class do or do not preponderate over members of the other class to the extent of four-fifths of its membership. Each society consists of ten or more members above the age of eighteen residing in the same locality, who by combining to furnish a collective guarantee, can obtain loans at a lower rate of interest than they could obtain individually. The local societies in a district are federated into central or district banks. There may be combinations in smaller areas also.

The progress of co-operative credit banks has been most rapid in the history of Indian banking, as shown below. It is seen that taking four years' average from 1906-07 to 1909-10, as base, the number of societies rose from 1,900 to 43,300 in 1920, and that of the members from 161,900 to 1,756,900, showing respectively an increase of 2178 and 983 per cent. During the same period the amount of working capital increased from '68 crores of rupees to 21.4 crores or 3047 per cent.

In recent years, the banking system in such European countries as France, Italy and Belgium, has undergone much deterioration, while in other countries, such as Austria, Germany and Russia, it has completely broken down. Accurate data for comparative study is not therefore available. It is still possible to have some rough idea of the relative banking position of some of the countries. In comparison with other countries, India is in a very low stage of development in banking business, as shown in the table below. India, for example, with a population three times as much as that of the United States, had in 1922 only 11,292 banks including branches and agencies, 1,339 million rupees, or 446.3 million dollars of capital including that of the exchange banks outside India and 2,318 million rupees or 772.6 million dollars of deposits as against the United States having 30,460 banks and branches exclusive of savings banks, 3006 million dollars of capital and 37,785 million dollars of deposits. The relative position of India's banking becomes still more striking when her capital and deposit in proportion to population are compared with those of other countries. The per capita capital and deposit in India amounted to only Rs. 4.2 or \$ 1.4 and Rs. 7.2 or \$ 2.4 respectively as against, for example, \$28.6 capital and \$35<sup>00</sup> deposits in the United States,

Some rough idea of the progress of banking business in India may be had from the growth of the capital and reserve and the deposits of all classes of banking, as shown in the table below. The capital and reserve of the exchange banks outside India have been omitted.

It is seen that the mean average of the units have grown from 12.5 in 1890 to 97.5 in 1920, showing an increase of 680 per cent in the total banking business of the country during the 30 years under consideration,

### 8. Commerce.

Exchange economy is the most important feature of the modern industrial organisation. This is very clearly seen in the growth of commerce all over the world. As in other countries, there has been in India

a gradual growth of trade, which may be conveniently grouped under four heads, namely, inland trade, coasting trade, frontier trade, and sea borne trade.

#### Inland Trade.

One of the most interesting records of Indian commerce is that relating to inland trade, giving some idea as to the extent of the movement of the staple articles of both imports and exports from one part of the country to another. It shows the final destination of imports and the original locality of exports. There is a good deal of variation from year to year in the movement of these goods as it depends upon the outturn of crops which are largely determined by climatic conditions. The first data on inland trade carried by rail and rivers were collected in 1884-85. The total imports and exports of merchandise amounted to 68 million tons in 1920-21.

#### Coasting Trade.

A considerable trade is also carried on between the ports of Indian States, French possessions, and British Provinces. The most important of such trade is that between India proper and Burma. In 1920-21, the coasting trade amounted in value to 209 crores of rupees, including 113 crores of rupees in imports and 96 crores of rupees in exports as against the pre-war average of 110 crores and the war average of 123 crores.

#### Frontier Trade.

The land frontier of India extends over 6800 miles, but the value of the trade across the frontier is on the average about five per cent of the sea-borne trade. Of the frontier countries trading with India, Nepal, Tibet and Afganistan are the chief. In 1921-22, the total trade amounted in value to 30 crores of rupees as against the pre-war average of 18.7 crores and the war average of 25 crores.

## Sea-borne Trade.

The internal domestic trade excepted, the most important trade of India is the sea-borne trade. Within the last 85 years, there has been a steady increase in the sea-borne trade varying from 27 to 134 per cent each decade, as shown in the table below. It is seen that during the period under consideration, the imports increased in value from 6.15 crores of rupees to 381.90 crores, the exports from 8.19 crores to 293.81 crores and the total trade from 14.34 crores to 675 crores, showing an increase of 47 times in the value of the total trade. This valuation, however, needs correction. Taking the value of 39 articles of export and import commodities in 1873 as base, the index of commodities rose to 23.6 in 1920-21, or in other words, the real value of the sea-borne trade rose to 286 crores as against 675.7 crores of the nominal value.

#### Balance of Trade.

One of the important features of India's foreign trade is favourable balance. For about three-fourths of a century this balance had been in her favour, varying from 2.04 crores of rupees in 1834-35 to 25.5 crores in 1914-15 and even after, as shown in the last column of the table above. In the year 1920-21, the balance was, however, reversed against her amounting to 88.09 crores of rupees. The favourable balance

was usually liquidated in England by the payment of "home charges" and interests on debts.

#### Countries trading with India.

The relative positions of the countries trading with India are to be seen in the analysis of her sea-borne trade for 1921-22, as given below. It is seen that India's three largest customers are the United Kingdom, Japan and the United States, buying respectively 20, 15 and 10 per cent of her commodities. Similarly the three most important countries from which India imports are the United Kingdom, Japan and the United States, selling respectively 56, 8, and 5 per cents in value of goods. The other important trading countries are Java, Germany, China, Belgium, Australia, Ceylon, and France,

By far the largest part of India's trade is transacted with the United Kingdom. This is partly due to difference in geographical situation and industrial development between the two countries. But the essential cause is the political domination which has given England virtual control of India's resources and industries.

There has been, however, a great deal of variation in India's trade with the United Kingdom. While both exports and imports have increased absolutely, they have decreased relatively. Thus the import trade increased from 32.2 crores of rupees in 1875-76 to 151 crores in 1921-21 and the export trade from 28 crores to 49 crores, but the percentages of the imports and exports as compared with the totals fell respectively from 83 per cent to 56 per cent and from 49 per cent to 20 per cent, as shown below.

## Nature of Trade.

Exports mainly comprise food stuffs and raw materials and imports, manufactured articles. This is clearly seen in the analysis of the sea-borne trade for the year 1921-22, as given in the table below. It is seen that the most important articles of imports are manufactured cotton goods amounting to 21 per cent of the total import trade in value and are followed by machinery amounting to 13 per cent. The other important articles are sugar, iron and steel and railway plants. The exports consist chiefly of jute and jute manufactures and cotton and cotton manufactures amounting respectively to 24 and 19 per cent of the total export trade. Hides and skins, food grains, oil seeds and tea are chief among the other articles of exports.

A still more clear conception of the nature of India's foreign trade may be had from the export and import of the merchandise classified under four heads : First, food, drink and tobacco. Second, raw material and produce mainly manufactured. Third, articles wholly or mainly manufactured. Fourth, miscellaneous and unclassified articles. The relative importance of these four classes of goods in the import and export trade of India is seen in the table below. It is seen that 71 per cent of the articles imported were wholly or mainly manufactured as against 26 per cent which were exported. At the same time India exported 48 per cent of her raw materials as against 8 per cent which she imported. The import and export of food, drink and tobacco almost balance each other.

The more significant point in the analysis of the trade of India is the relative increase in the export of manufactures and decrease in that of raw materials. In 1913-14, that is, the year before the outbreak of the war, the export of manufactured goods formed 22.4 per cent of the total exports in value and in 1921-22, it rose to 36 per cent. Similarly, the export of raw materials formed 50 per cent of the total export in 1913-14 and fell to 43.4 per cent in 1920-21.

A review of the export and import trades of important countries during the year 1921-22 would bring

out the relative commercial position of India. It must however, be remembered that the breakdown of the industrial organisation of Central Europe, of which Germany was the backbone, renders the comparison somewhat misleading. It is still possible to have some idea of the position of India in international trade.

The table below would show that in 1921-22, the United Kingdom stood first in both imports and exports, the value of which were respectively 1004 and 824 million pounds, thus having a total trade of 1828 million pounds. The United States and France stood second and third with a total trade of the 1375 and 578 million pounds respectively. India ranked fourth in import, export and total trade.

From the viewpoint of per capita trade, the Netherlands, however, leads the countries of the world having 39.7 pounds as against the United Kingdom standing second with a per capita trade of 38.6 pounds. The per capita trade of India with the exception of that of China is the lowest and amounted to only 1.7 pounds.

The amount of the trade of a people does not necessarily signify their prosperity. A small country with a large population and specialised industries, such as England and Belgium, is bound to have more per capita trade than a large country like the United States which has vast territories, diversified industries and well developed internal trade.

Some idea of the commercial progress of India may be had from the growth of the inland, coasting, and sea-borne trades within the past thirty years, as shown in the table below. It is seen that the inland trade has increased by 228 per cent, the coasting trade by 228 per cent and the sea-borne trade by 232 per cent, thus leading to a general increase of 238 per cent.

## CHAPTER IV, PRODUCTIVITY.

In the foregoing chapters have been described the chief resources of India as compared with those of other countries as well as the principal industries through which they are utilised. The products of various industries have been discussed, both absolutely and relatively and their effect on the people noted. Now it remains to summarise the results with a view to determining the productivity of the country and indicating the prosperity of the people.

As noted before, national productivity may be determined in several ways : First, the quantitative and qualitative growth of products. Second, the present condition of production in a country as compared with that in other countries. Third, the comparative thoroughness with which the resources are utilised and wastage avoided. Fourth, the relative prosperity of the people.

### I. Growth.

This is an age of rapid industrial development. Discoveries and inventions are bringing about changes in industrial art, leading to the enormous growth of production in almost all countries. How far India has kept pace with other countries in industrial progress as indicated by the quantitative and qualitative growth of products is hard to determine for lack of complete and comparable statistics.

Although it is not possible to have any accurate knowledge of relative productivity, a rough idea may be had of the absolute growth of production in India during the past 30 years from a few fragmentary data on some of the industries. It must, however, be remembered that such calculation becomes accurate



only when a large number of the products of representative industries are taken into consideration. But in the present study, the number of products being very small, the index of productivity leads only to a tentative rather than a final conclusion.

The growth of the total productivity may be estimated from the productivity of different industries discussed before. Leaving out of consideration the fishing industry, for which there exist no complete and adequate data, the products of other industries may be estimated as in the following table. Taking the mean averages of the products of several industries for 1890-91 as base, it is seen that the index number rose to 570 in 1920-21. In other words, the total productivity of all industries under consideration increased about 6 times as much in 30 years.

### 2. Condition,

In some of the commodities for which there is a world-wide demand, India occupies a very high position. The most important of these are fibre crops, food crops, oil seeds and even some minerals. In 1921-22, India produced 98.6 per cent of jute, 87.6 per cent of rape and mustard, 64 per cent of rice, 59 per cent of manganese ore, 44 per cent of tea, 26 per cent of cotton, 22 per cent of tobacco, 20 per cent of linseed, 12 per cent of wheat, 12 per cent of barley and 9.8 per cent of salt, as shown in the table below. Besides, India stood fourth in international trade in 1920-21.

India even possesses a large proportion of a few of the capital goods of the world, as shown in the table below. It is seen that in 1920-21, India had 47 per cent of each of the world's cattle and goats, 8.6 per cent of the sheep, 6 per cent of the horses and mules and ponies, 6.8 per cent of the railways, 8.3 per cent of the telegraph wires, 4.4 per cent of the spindles and 4.3 per cent of the looms,

In spite of its outstanding position in some of the world's products and even in some of the capital goods, the present status of India as regards productivity is very low. This becomes clearer when her productivity is compared with that of other countries. While it is hard to estimate the efficiency of such industries as manufacture, transport and commerce, agriculture, which is by far the most important industry of India, gives us some basis for calculation.

To the production of such crops as rice, wheat, cotton, barley, maize, jute, linseed, and rape and mustard, India devoted an average of 46.7 per cent of the world's area covered with these crops in 1922-23, but the yield amounted to 39.9 per cent of total production of the world, as shown in the table below. Taking the averages of the yields for these crops as base, it is seen that the index of productivity varied from 55 in the case of maize to 96 in the case of rice. The yield of jute amounted to 118, but it is a crop peculiar to India. The index of yield for all the crops amounted to 85, that is, 15 per cent less than the mean average yield of the world.

The low productivity of Indian agriculture becomes still more evident by comparing its yield with the average yield of crops in all the countries,

as shown in the table below. It is seen, for example, that India produces only 8.7 quintals of wheat per hectare as against an average of 9.4 quintals. The same thing is true of the other crops, except jute which was on a par. The mean average of all the crops was 8.4 quintals as against the mean average of 9.5 quintals of all the countries. In other words, India's production was only 88 per cent of the average production of the world.

In averaging the yields of different crops, all the countries have been taken into consideration, irrespective of the quality of land, and the method of culture. But when compared with the agriculture of advanced countries, the low productivity of Indian agriculture becomes still more clear. The per hectare yield of three principal crops of India as compared with those of rival countries is shown in the following table.

Rice is the most important crop, but its yield per hectare amounted to only 15.7 as against 35.2 quintals of Japan and 59.5 quintals of Spain. Similarly the per hectare yield of wheat was 8.7 quintals in India as against 9.4 in the United States and 12 quintals in Canada and that of cotton 1.1 quintals in India as against 1.6 quintals in the United States and 2.9 quintals in Egypt.

The relative inefficiency of Indian agriculture as compared with the agriculture of other countries is revealed by the index number of productivity—a method adopted by the U.S. Department of Agriculture. Six crops forming the bulk of crop production in most countries, namely, wheat, oats, rye, barley, corn and potatoes were taken into consideration. For each country, the average yields per acre for a series of years were obtained and these averages were reduced to the percentage of averages of all countries. The percentages for each country were combined, weighted in proportion to the relative average of



various crops in the country, to obtain the index number of production. The following is the result obtained, 100 representing the weighted average of all countries.

The above table shows that the index of agricultural production in India was 86 which is practically the same as found in the two previous tables, i.e., 85 and 88 or 86.5 on the average. Belgium with the index number of 221 stood highest in the list and India stood twenty-second among the countries. The efficiency of Indian agriculture is lower than that of Canada, Australia and the United States, which are new countries and where the most extensive system of cultivation prevails.

### 3. Wastage.

Beside insufficient production, wastage is another important feature of the industrial system of India. As shown before, India possesses a considerable

amount of mineral, vegetable and animal resources. But the present organisation is scarcely capable of utilising even half of these resources. A few examples will be sufficient to prove this contention.

The culturable area in 1920-21 amounted to 480 million acres. Thanks to climatic conditions, practically all this area is adaptable to two or even three crops a year. Since some part of this land may not be cultivated more than once, it may be assumed that all the arable area is fit for two crops a year on the average. The potential resources of India's arable land is, therefore, 960 million acres. The actual area cropped in 1920-21 was 296 million acres in all India counting the areas sown more than once as separate areas. In other words, out of a total potential arable area of 960 million acres, only 296 million acres or 31 per cent, were utilised for productive purposes and 664 million acres or 69 per cent, were wasted. Viewed from the standpoint of efficiency, this wastage becomes still larger, India's yield being only 85 per cent of the average yield of the principal countries of the world, the area utilised for cropping becomes 26 per cent instead of 31 per cent as above and the wastage, 74 per cent.

Forest land amounts to about 25,000 square miles or 23 per cent of the total land area. Of this area, a large part is "unclassified forests" containing unoccupied treeless waste. The actual area under forests would not amount to more than 13 per cent, as noted before. In other words, 56 per cent of the forest land is under actual forests. But the area of merchantable forests is still less, amounting to about 40 per cent. Even the merchantable forests are scarcely intensively afforested. In spite of the attempt for the last three or four decades, it has not yet been possible to allow annual cut to exceed one third of the annual growth. Nor has there yet begun any industrial use of forests products. It might be safely said that one half of the forest land is wasted in India.

The larger part of the fisheries is also wasted. As will be noted presently, only 30 per cent of the fish required for the population supplied at present. That the remaining 70 per cent can be easily supplied from the fresh water and marine fisheries with proper culture and catch cannot be doubted for a moment. Unlike metal, fish resources are perishable and 70 per cent of the fisheries must be regarded as an annual waste.

Of the mineral resources, the most important loss is that of water power. As noted before, India possesses water resources of 27 million horse power, of which only one-half of one per cent has been utilised for production up to the present time. Thus 99.5 per cent of the water power resources are annually lost to India. The production of iron of which there exists an abundant supply is so meagre that it might also be regarded as lost to India. Through inefficient mining, a large part of coal, mica and other minerals is also wasted.

Along with these main classes of resources are also wasted other resources which might be regarded as their by-products. The most important of these are as follows: First, edible plants and animals, such as mushrooms, oysters, mussels and frogs. Second, wood for the manufacture of paper, alcohol and other commodities. Third, fruits and flowers for apiculture, i.e., for the production of honey and wax. Fourth, algae and larvae, which grow in plenty under the tropical heat and rainfall and which could be transformed into food by fish and poultry. Fifth, feeds together with labor for boarding the old and useless cattle as well their meat. Speaking very conservatively, about one-sixth of the cattle, numbering 25 million heads, are nothing but "boarders," on vegetable resources and productive energy of the country. Sixth, the export of oil seeds, hides and skins and other raw materials may also be regarded as a sort of wastage of India's re-

sources. Instances like these could be multiplied. In short, India is scarcely conscious of her potential wealth and lacks the necessary efficiency for utilising it for the benefit of her people.

#### 4. Prosperity.

Consumption is the ultimate object of all production. The best method of judging national productivity is to estimate its effect on the material condition of the people, as compared with that in other countries. One of the great achievements of the advanced countries is that they have practically solved the problem of absolute poverty. It is, however, still the greatest problem of India. The majority of the people are insufficiently fed. The comparative supply of food in terms of calories is given in the table below.

The above table shows the per capita amount of food produced in different countries. The average amount of food required by an individual per year is about 1,000,000 calories. It is seen that all the countries except the last three produce food sufficient for their inhabitants as far as the caloric value is concerned. Both Argentine and Canada lead other countries, each producing 6.45 million calories

or over six times the amount required by their people. They are followed by the United States and Australia, producing 4.63 and 2.69 million calories respectively. A new country having a comparatively small population and applying the modern technique of production is in a very advantageous position to raise food stuffs and other raw materials. While these advantages cannot be enjoyed by the older and more densely populated countries, there is still a great chance for the production of more food as seen in the case of Austria-Hungary, Germany and France. Germany has the same acreage of per capita land as India, but raises more than twice the amount of food. The reason is that Germany uses more intensive cultivation and raises more food crops of higher caloric value, such as sugar, than India.

The per capita food production in India amounted to 83 million calories, that is, about one-fifth less than what is required for a person. Out of this meagre production, a large part is exported in exchange for other necessaries and for the payment of "home charges." Although some food stuffs are imported, the imports never balance the exports as far as the nutritive value is concerned. The United Kingdom, on the other hand, produces only about half of the food required for its people. She is essentially a manufacturing country and imports, in exchange of her manufactured goods food stuffs for more than six months in the year. But India is mainly an agricultural country and cannot very well import food stuffs in exchange of her manufactures which are scarcely sufficient for her own consumption.

Fish is another important food. To a rice-eating people, fish is not a luxury, but an absolute necessity. The present supply is quite inadequate. Allowing 4 oz. of fish per person a day and assuming that a person eats fish 320 days in the year, as suggested by Sir K. G. Gupta concerning the people of Bengal,

one needs about one maund of fish a year. But the fish supply to Calcutta in 1919-20 amounted to only 313,000 maunds for a fish-eating population (1) of 900,000, i.e., the supply amounted to about 14 seers or a little over one-third of the requirements.

Even the people of England and Wales, to whom fish is only a supplement to the protein diet of meat, eggs, milk and cheese, consume more fish per capita than the people of India. In 1920, for instance, the per capita consumption of fish in England and Wales was 43 lbs. as against 28 lbs. in India.

Next to food, clothing is the most important item of consumption. Owing to warm climate, the clothing used in India is mostly made of cotton. But the consumption of cotton cloth in India is far below than that in most of the countries, as shown in the table below.

Although the figures refer to the pre-war period, they do not fail to convey a clear idea of the condition. It is seen that excepting China and Russia, the consumption of cotton cloth in India was the lowest among the countries mentioned in the list and amounted to only 4 lbs. per head as against 17.7 lbs. in the United States and 10 lbs. in Belgium. When it is considered that most of the countries including China and Russia use woollen clothing in addition, the consumption of clothing in India becomes still more insignificant.

The people of India are not much better off in the consumption other material good, as shown in table below. It is seen that the per capita consumption of the following goods and services in India falls far short of the general mean averages of other countries, varying from .2 in the case of telephone to 13 in the case of letters and cards.

### 5. Conclusion

The statistical records on production in India are not complete enough to warrant any final statement on her productivity. But there exist sufficient data on some of the industries for drawing some conclusions.

The outstanding feature of the productive system of India is its inefficiency, which is shown by the great wastage of resources on the one hand and the lower productivity of the industries on the other. In spite of the growth of some products in recent years, the productive power of India is quite inadequate to supply the needs of the people including both necessities and requirements. It is this insufficient production to which is due India's poverty, both absolute and relative. The cause of this insufficiency may be traced to one or all the factors of production.

The low productivity could not be a result of the scarcity of land. The major part of the resources is, as we have seen, wasted at present or remains unexploited for productive purposes.

Capital is quite insufficient in India as compared with that in other countries. That the lack of adequate capital is partly responsible for the present low productivity cannot be denied. But capital, accumulating as it does from the savings of past industries, plays a role less important than the other two factors in the growth of national wealth. The lack of capital could not, therefore, be regarded as the fundamental cause of insufficient production in India. Moreover, there exists a good deal of savings or potential capital which could be collected and utilised for productive purposes by adequate banking and other systems of industrial organisation.

Insufficient production is the result of inefficient labor, i.e., lack of capacity on the part of the people to mobilise the physical, intellectual and moral forces of the country and to organise land and capital effectively for national production. The fundamental cause of India's poverty is, therefore, her industrial inefficiency. (1)
