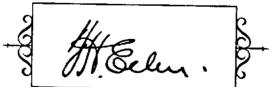

PREFACE

HIS VOLUME has been prepared in celebration of the 75th anniversary of the Metropolitan Life Insurance Company. It is fitting that this milestone in the life of a business institution which has become so widely known on this Continent, be marked by a record of events and accomplishments over the years. The country was already at war when the preparation of this history began. At such a time, one's thoughts turn naturally to a sober appraisal of the institution and of its relation to the way of life which we are fighting to maintain. It was in this spirit that the author approached his task. He was particularly fortunate in the abundant sources of information at his disposal. It was an even happier circumstance that he could also turn to a few men who not only remembered the early days, but who knew the founders of the Company and had worked beside them. Indeed, these veterans helped to lay new foundations and played a major role in the growth of the organization.

This history of the Company does not pretend to be complete. It would be impossible, in a single volume, to cover adequately the varied phases of so far-reaching a business. The author has, therefore, limited himself to a consideration of the principal characters and events in the story. He has tried to bring into focus those thoughts and policies which, over the years, have made the Metropolitan the leader that it is today. The significance of this history would have been lost without some reference to the background against which these events took place. The author has, therefore, sketched in roughly the economic and social development of the United States and Canada, and of the institution of Life Insurance which has contributed so richly to national progress.

This history has been written by one who has spent virtually his whole working life in the organization, and who is bound by many warm ties to his colleagues. Nevertheless, he has tried to be objective and to write an authentic story. He has made no attempt to gloss over the difficulties or the many problems that inevitably beset an organization over a period of 75 years. If at times the picture presented here appears too bright, it is not because it has been painted in glowing colors, but because the record of the Metropolitan is one of the most extraordinary in American business history. Its everyday operations have become an important element in the national economy, and through these activities, as well as through the extensive social services it has created and stimulated, the Company's influence has extended to homes and people in every part of the two neighboring countries. The author hopes that the reader will find this volume to be a truly human story, one that is peculiarly American, reflecting the national genius for enterprise, technical skill, and good business administration. Perhaps the volume will also serve to give the general public a clear conception of the theory and practice of modern Life Insurance.

At this time in our history, when the desire for security is greater than ever before, it is hoped that this volume will reflect what the American people have done through Life insurance to provide financial protection for themselves. They have achieved this security to a greater degree than any other people, achieved it voluntarily, and through institutions of their own making. This is in the American tradition. They have not depended upon Government subsidy, but have themselves taken the initiative. Americans apparently prefer this method, which takes into account individual needs and relies on the sense of obligation of the head of the family to look after his own.

To be sure, this effort has not reached perfection. But the record is one of constant improvement. Today fully one half the people of the United States and Canada depend in large measure upon the institution of Life Insurance for their program of family security. Nor is there any suggestion that

the saturation point for the private companies has been reached. There are still many uninsured or inadequately insured individuals in the country who are the policyholders of the future.

The author desires to make acknowledgment of his indebtedness to his many colleagues, without whose help this volume could not have been written. So many have participated in the effort that it is impossible to name them all. Indeed, the chief task of the author has been to marshall the material supplied to him and to bring it into a uniform scheme. Especially helpful have been the Actuary of the Company. Horace R. Bassford; Second Vice-Presidents Samuel Milligan and Francis M. Smith; and Dr. William A. Berridge, the Economist—who were responsible for much of the original material. Associate Actuary James R. Herman undertook the checking of every item in the book. The author's sincere thanks are due to Vice-President Charles G. Taylor, Jr., who read the entire text and made many valuable suggestions. He is particularly indebted to his associates, Jacob Baar and Herbert H. Marks, who collaborated with him throughout the course of the work. With the help of these and many others, this has been a pleasant and stimulating undertaking.
