Sir,

I have the honour to submit the Annual Administration Report on the working of the Indian Companies Act, 1913, for the year ending 31st March 1916 together with the returns prescribed by the Government of India. As usual the report deals with Societies registered under the Societies Registration Act, XXI of 1860, the Indian Life Assurance Companies Act, 1912, and the Provident Insurance Societies Act, 1912.

2. I had charge of the office of the Registrar of Companies during the whole year under review with the exception of the first 24 days in April 1915 when Mr. J. C. D'Almeida was in charge.

3. Twenty Companies were registered during the year as compared with 17 (which number included one transferred from another Presidency and one transferred from charitable societies) registered in the previous year. Of these, 19 were Companies limited by shares and the remaining one by guarantee. The classification below indicates the nature of the new undertakings in comparison with those registered in the preceding year :—

4. The above table shows that there has been a slight increase in the registration of new Companies compared with the figures for the previous year. The reasons for the small number of new flotations is, as was the case last year, mainly due to the depression in business, loss of credit and stringency of the money market owing to the war. Japanese competition also I think has contributed towards a slackness of Indian business, the Japanese business methods being extremely up to date, skilful and well organised. In any case no general improvement in this Presidency can be expected until the end of the war brings a revival of trade.

Item No. 9 contains the largest falling off in numbers which is attributable to the fact that in the previous year all the share capital Companies forwarded lists of directors and managers soon after the introduction of the new Companies Act, whereas there is no necessity to file them separately since they are included in the returns under section 32. The falling off in numbers under item 8 is partly due to the smaller number of renewals of hypothecations and pledges. The shrinkage in the number of items 3 and 4 is due chiefly to the concession under the new Act permitting Balance Sheets to be drawn up and general meetings to be held after the period of 15 months instead of 12 months. There are also still remaining on the register a number of Companies which are defunct and as to which steps are being taken to strike them off the Registers under section 247. The decreases in the numbers of resolutions in item No. 5 and also in items Nos. 10 and 12 are due to ordinary fluctuations. An increase appears under allotment returns in item No. 7, which is a new return under the Act. Those Companies which did not make allotments last year or those who failed to file returns in due course, obtained the High Court's sanction to an extension of time for filing and secured registration during the year under report. The increase under item No. 11 is partly due to the filing of Balance Sheets and other documents, which British and Foreign Companies, owing to the war, were not able to procure in time for filing last year. Item No. 13 shows the satisfactory result of persistent calls from this office for the returns. Other items of increase call for no remarks.

6. During the year under report seventy Companies ceased to carry on business and went into liquidation as compared with 43 in the previous year. As observed in my last Annual Report, some Companies of doubtful stability failed owing to various causes such as dulness of business, tightness of money, loss of confidence and inefficient management. Numerous Companies were

also removed from the Registers by constructive dissolution in accordance with the provisions of section 247.

7. Of the Companies that were in course of liquidation, on or before 31st March 1915, one was dissolved by the Court, 7 were fully wound up by the liquidators and 7 struck off the Registers in pursuance of Government Resolution, Revenue Department, No. 2713, dated 24th April 1903, and section 247 alluded to above. There are a number of Companies of which liquidation is pending, but, owing to the meagre provisions in the old Act in connection with the mode of liquidation proceedings, it is not possible to ascertain their present position. With respect to this matter the High Court of Bombay has, under the new Act, made a very elaborate and effective provision by means of the forms prescribed under section 244.

8. The total number of Companies working at the close of the year was 558 as against 608 for the year 1914-15. Of these 558, 18 were limited by guarantee with 11,586 members exclusive of unlimited numbers of members in the case of 4 Companies. The remainder were share capital Companies, the details whereof are given below in tabular form as they stood on the closing days of the years 1914-15 and 1915-16:—

It is apparent from the above that though the number of Companies and the amount of registered capital were reduced during the year, the working capital was increased.

9. During the year 121 Companies increased their capital by Rs. 23,97,000 in authorised, Rs. 1,22,00,760 in subscribed, and Rs. 2,03,80,389 in paid up capital against an increase of Rs. 63,12,500 in authorised, Rs. 2,75,58,085 in subscribed and Rs. 2,63,04,414 in paid up capital in the preceding year.

10. Twenty-seven Companies reduced their capital by Rs. 18,25,250 in authorised, Rs. 41,07,875 in subscribed and Rs. 22,31,015 in paid up capital against a reduction by Rs. 48,25,000 in authorised, Rs. 56,08,775 in subscribed and Rs. 45,02,504 in paid up capital in the previous year.

11. Fees realised on the registration, filing or recording of documents amounted to Rs. 18,995-10-0 including Rs. 30 received on the 31st March 1915 after close of treasury and not accounted for in the last year's report. The subjoined statement shows the amount of fees recovered on documents classified under different heads and compared with the figures for the year 1914-15:—

The above statement shows a decrease of Rs. 1,756-12-0 in the aggregate. It should be observed, however, that the income of the office greatly depends on the registration of new Companies and resolutions including the notices of increase in capital. Under these heads there is an increase of Rs. 2,430 and Rs. 195 respectively (in items Nos. 1 and 3). The other items of increase are of no importance. The reason for the decrease in registration of documents by Companies established outside British India and auditors' certificates is to a large extent due to the fact that the Companies which had established their offices prior to the introduction of the new Act had to register four documents last year and subsequently only one, namely Balance Sheet, if the Companies have their principal places of business in Bombay and provided that they are not private Companies, in which case they are exempt. The fees for auditors' certificates will gradually fall away since it is improbable that a large number of certificates will be granted by Government every year. The reasons for other decreases are fully set forth in paragraph 5 which deals with registration of documents.

12. The expenditure during the year amounted to Rs. 27,152-3-5 against Rs. 12,795-0-11 showing an increase of Rs. 14,357-2-6—

The increase in the salaries to the Registrars is due to the payment of arrears due to the late Registrar, Mr. Almeida, and the salary fixed for the appointment of a qualified officer. (*Vide* Government Resolution, Revenue Department, No. 6151, dated 4th June 1915.) The increase under establishment is due to the fact that the clerical staff sanctioned by Government Resolution, Financial Department, No. 7948, dated 26th August 1914, was employed after September 9th, 1914, and also to the revision of the menial establishment in accordance with Government Resolution, Financial Department, No. 3214, dated 30th August 1915. The rent is an additional item this year and was necessitated to accommodate the Registrar and his staff in new premises instead of at the High Court. The other items of increase are minor and are due to fluctuations. The main decrease is under Auditors' Council and contingent charges and can be attributed to a smaller number of meetings of the Council and to the fact that the need for new furniture, etc., was less.

13. The offices of certain Companies subject to the provisions of section 136 of the Indian Companies Act, 1913, were inspected by the Assistant Registrars in the mofussil and by the head clerk in Bombay. Statements in Form G were found hung up and the sign-boards properly exhibited.

14. No actual proceedings were instituted, although I found it necessary to threaten them in several cases. Many of the smaller Companies are still very ignorant as to the provisions of the law, but I am glad to state that in practically every instance where I have had cause to complain of the inaccuracy of returns, etc., I have found the Companies' Agents or Directors more than willing to comply with the law. Unwillingness to comply with my requirements or hostility to the Act has been entirely absent. During the year great

efforts have been made to instruct Companies' Agents and Managers as to their legal duties and very good results are already noticeable. It has, however, meant a very large amount of work for the office owing to the increase in correspondence and personal interviews.

15. Twenty-four Companies, not hitherto registered, filed their papers under section 277 and a list thereof is appended hereto as an annexure.

16. In several cases I have found the powers of investigation under section 137 of great utility and during this year I have made three reports to Government under this section resulting in the appointment of 2 inspectors under section 138 (one after the end of the year under report), while in the third case the Company in question went into liquidation, a most desirable result.

17. A year's experience as Registrar has impressed me with the great powers of the firms who act as "Secretaries, Treasurers and Managers" of Companies as contrasted with the very small powers of the usual Indian shareholders, who are, for the most part, too ignorant to know how to protect themselves.

18. An improvement is noticeable in the audit of Companies' Balance Sheets all of which are scrutinised before being accepted for registration and, where necessary, full explanations are called for from the Companies. If anything appears to be wrong with the auditors' certificates or reports, an explanation is called for from them and, where necessary, they are reported to the Auditors' Council. In connection with the audit of Companies a society called the "Society of Professional Accountants" has lately been formed in Bombay, its members being limited to the members of the exempted societies under section 144 and to the holders of certificates from Local Governments in India. The great majority of the leading Bombay auditors are members and the society shows every promise of great utility, both to its members by elevating the profession and to the public by helping to suppress malpractices, etc.; I have already found it a very useful institution.

19. The general work of the office has increased considerably owing to the more stringent scrutiny of all documents and owing to the efforts made to instruct Companies' officers in the legal requirements.

The Indian Societies Registration Act of 1860.

20. Eight Societies were formed and registered during the year as against fifteen of the previous year. The falling off is due to the fact that this Act is of little practical value. The names of the Societies registered are as under:—

The Provident Insurance Societies Act, 1912.

21. This Act has apparently not met with the approval of the public in Bombay. People here are backward in forming Societies inasmuch as it is found to be a complicated and intricate matter. The rules require a number of detailed annual returns which even Life Assurance Companies are not called upon to make. With their small funds the promoters are afraid that they will not reap benefits in proportion to the outlay. Present conditions are, in addition, not favourable. An increase is expected after the war. The audit requirements also fall heavily on small Societies. Out of the eight Societies

named in my last report the Sarvajanik Provident Fund has already been wound up; the Krishna Company, Limited, has also been wound up but no official intimation has been as yet received. The managing director of the Bharat Sarkar Company, Limited, whose offices were visited by my head clerk, is reported to have died and there is no other person to carry on the Society's management and it is practically defunct. Such also is apparently the fate of the Hindu Shadi Sahaita Fund, Limited, there being now no trace of the Society. Of the remaining four Societies three have filed their rules. The Amalgamated Society of Railway Servants of India, Burma and Ceylon has filed rules of two subsidiary Societies, namely, The Family Benefit Fund Society of the Amalgamated Society of Railway Servants of India and Burma, Limited, and the Voluntary Sick Benefit Fund Society of the Amalgamated Society of Railway Servants of India and Burma, Limited. The Deccan Mutual Provident Fund has not yet filed its rules, final approval not having been obtained until after the end of the year. This fund was allowed extra time owing to recrudescence of plague and unrest which delayed meetings.

The Indian Life Assurance Companies Act, 1912.

22. During the year there was no addition to or removal from the list of Companies.
