SUBJECT :—*Annual Report on the working of the Indian Companies Act, 1913,
in the Bombay Presidency for the year 1930-31.*

SIR,

I have the honour to submit the Annual Report on the working of the Joint Stock Companies for the year ending 31st March 1931. The ten statistical statements prescribed by the Government of India are attached to the Report. A list of Private Companies has been appended to this Report and marked "A". The Report also deals with the Provident Insurance Societies Act, V of 1912, the Indian Life Assurance Companies Act, VI of 1912, and the Societies Registration Act, XXI of 1860.

2. I held the charge of the Office of the Registrar of Companies throughout the year under review.

The Indian Companies Act, VII of 1913.

3. The number of new Companies registered during the year was 108 as against 107 in the preceding year. Of these, 103 were limited by shares and 5 limited by guarantee. Out of the said 103 Companies limited by shares, 29 were Public and 74 Private. The number of Companies in operation limited by shares at the close of the year was 959 as compared with 913 in the year preceding, being a net increase of 46.

*It includes one Company omitted from the list last year. It may be noted that the increase is rather in Companies of the nature of Provident Insurance, Motor-Traction Dealing and Manufacturing and General Merchants than in Manufacturing Concerns.

The aggregate Authorised, Subscribed and Paid up Capitals of the Companies have gone down during the year by about 10 crores, 11 crores and 5 crores respectively. The decrease is chiefly due to the voluntary winding up of six Companies of the Petit group and one Company named the Trustees Corporation (India), Limited.

Auditors.

5. The total number of persons holding Auditors Certificates under Section 144 of the Act was 119 as against 113 in the year preceding. One person holding Restricted Certificate died during the year and 7 others were granted Unrestricted Certificates. Four persons holding Temporary Restricted Certificates applied for renewal of their Certificates during the year and Government extended the period of Certificate for five years in the case of one and up to 31st March 1932 in the case of three others.

Compliance with the provisions of Section 136.

6. The reports of the Assistant Registrars of Joint Stock Companies who were requested to make enquiries in the matter show that the provisions of Section 136 of the Act were complied with during the year by the limited, banking and other Companies working in their Districts to which the provisions of the Section apply.

Foreign Companies.

7. During the year, 11 Companies incorporated outside British India established their places of business in this Presidency as against 9 in the previous year and filed documents under Section 277 of the Act. A list of these Companies is given in Appendix "B".

Societies Registration Act, XXI of 1860.

10. The number of Societies registered under this Act during the year was 40 as compared with 36 in the year preceding. A list of these Societies is appended to the Report and marked "C". One Society named "The Bombay Seamen's Society" changed its name to "The Royal Bombay Seamen's Society" with the approval of Government.

Provident Insurance Societies Act, V of 1912.

11. The Teachers Family Benefit Fund registered its rules under the Act. 21 Companies (registered under the Ludian Companies Act, 1913) also registered their rules under this Act during the year. A list of these Societies is hereto appended and marked "D".

Indian Life Assurance Companies Act, VI of 1912.

12. During the year under report, the following Companies complied with the provisions of the Act :—

13. There was no prosecution during the year. A few defaults under Section 32 of the Indian Companies Act by Private Companies were noticed but the Companies were cautioned and their returns accepted late without prosecution.
