# ANNUAL POLICE ADMINISTRATION REPORT OF THE BOMBAY PRESIDENCY INCLUDING THE RAILWAYS FOR THE YEAR 1936.

I was in charge of the office of the Inspector General of Police Charge. throughout the year.

The Deputy Inspectors General of Police were :---

#### In the Northern Range.

Mr. A. S. Holland was in charge for the whole year.

#### In the Southern Range.

Mr. A. C. J. Bailey, C.I.E., was in charge from the beginning of the year till the 12th March 1936 when he proceeded on leave, handing over on the 13th idem to Mr. H. M. Haslehust, M.B.E., who continued to hold charge till the end of the year.

#### In the Criminal Investigation Department.

Mr. F. E. Sharp. officiated as Deputy Inspector General from the beginning of the year till the 4th November 1936; he handed over on the 5th idem to Mr. A. C. J. Bailey, C.I.E., who continued in that office till the end of the year.

**Total reported crime**cognizable and noncognizable. • 2. (a) The total number of cognizable and noncognizable offences reported during the year was 142,925 as against 143,789 in 1935—a net decrease of 864 cases under all classes.

(b) The total number of cognizable cases dealt with by the Police suo motu during the year was 26,059 while those dealt with by Magistrates direct amounted to 10,823 giving a total of 36,882 as against a total of 37,825 in 1935—a decrease of 943 cases.

(c) The total non-cognizable crime numbered 106,043 as against 105,964 in 1935—an increase of 79 cases.

(d) The attached graph shows the variations in reported crime under these three categories during the last ten years.

(e) Cognizable crime reported to the Police has remained stationary, there being a nominal increase of 1 case only viz., from 26,058 in 1935 to 26,059 in the year under report. These figures cannot however be accepted without some comment. Last year the economic conditions due to the failure of the rains were not satisfactory in several districts. One would have therefore expected an increase of "economic" crime: in some districts there was such a rise but it was counterbalanced by decreases in others: this then has brought out the result reported above.

(f) Direct cognizable complaints to Magistrates have declined considerably viz., from 11,767 in 1935 to 10,823 in 1936—a decrease of 944 cases.

(g) Non-cognizable complaints, as remarked previously, increased by 79 cases, a negligible rise in proportion to the total. These variations are discussed in the following paragraphs under the respective headings.

3. (a) Statement "A" has been split up into two statements "A" Statements "A" and and "AA" with effect from this report under the "AA"—Part I— Total cognizable orders of the Government of India communicated under the Bombay Government Resolution in the cases reported to the Police. Home Department No. 7381/3, dated the 8th February 1936. According to these orders, the former statement is to contain offences under the Indian Penal Code (classes I to V) and the latter the remaining offences included in class VI. These orders have further been slightly amended so as to exclude from class VI and include in class I the offences against religion-sections 295-297, Indian Penal Code-(vide Government Resolution, Home Department, No. 7381/3, dated 21st December 1936). For the purposes of an accurate comparison, therefore, the figures under the Indian Penal Code (classes I to V) and under class VI for the year 1935 have been quoted after suitable alteration wherever they have been compared with the corresponding figures for 1936 in the following paragraphs of this report.

(b) Accordingly, cognizable crime reported to the Police under the Indian Penal Code (classes I to V) for the year under report and for the preceding year was as under :—

(d) The totals for the year under report (under all classes) and for the previous year practically tally. Analysing the figures under classes I to V and those under class VI separately, the crime reported shows a decrease of 190 under the Indian Penal Code (classes I to V) counterbalanced by an increase of 191 under class VI. The decrease under the Indian Penal Code was shared by eleven districts and the increase under class VI by eight districts and one Railway. (e) Districts showing a marked decrease in reported crime under the Indian Penal Code are Dharwar (211), Thana (149), Poona (110), Satara (106) and Ahmedabad (99). Types of offences affected were chiefly house-breakings and thefts, simple thefts including cattle thefts and rash and negligent acts. Revised method of patrolling was adopted in Dharwar District since the beginning of 1936, to which among other preventive methods the District Superintendent of Police attributes the large drop in house-breakings and thefts. In the other districts, the decreases are reported to be the result of greater attention by the Police to preventive measures; a decrease under rash and negligent acts noticeable in the Ahmedabad City Sub-Division is attributed to better traffic regulations, stricter supervision and deterrent punishments to offenders.

(f) On the other hand, marked increases occurred in Kaira (209), East Khandesh (88) and on the G. I. P. and M. & S. M. Railways (81). In Kaira, offences of robbery, house-breaking and theft are mainly responsible for the rise while in East Khandesh it is contributed to by dacoities, house-breakings and thefts. In Kaira, it is attributed to the failure of the rains for a major portion of the season whilst in East Khandesh the reason is almost the same viz., drought in the middle of the year and poor economic conditions. On the G. I. P. and M. & S. M. Railways, the increase was mainly under class V—Minor offences against property under Victoria Terminus. The Superintendent of Police does not, however, ascribe this to any specific reason, but reports that the rise is only apparent when compared to the figure for 1935, but it is not abnormal when compared to the figures for a few years prior to 1935. Last year's decrease was unusual. The increase does not therefore necessitate any further comment.

(g) Taken by Ranges, the Northern Range showed an increase of 201 cases, as against a decrease of 391 cases in the Southern Range. The resultant net decrease for the Presidency as a whole therefore amounted to 190 cases and can be considered as satisfactory.

(h) In respect of cases under class VI the increase was contributed by eight districts and one Railway, prominent increases being in Ahmedabad (255), Sholapur (163), Nasik (132) and Bijapur and G. I. P. and M. & S. M. Railways (98 each). On the other hand, marked decreases were noticed only in Surat (220), Dharŵar (189) and Poona (113). The result was an increase of 191 cases over the Presidency figures for the preceding year. This increase was mainly contributed to by a large number of offences in connection with Public Conveyances and Motor Vehicles. In Ahmedabad, it is attributed to better traffic regulations, stricter supervision and deterrent punishments to offenders in the City Sub-Division. The District Magistrate, Ahmedabad, in this connection observes :—

"The population seems to be entirely undeveloped as far as traffic sense goes and the increase of cases under class VI is a welcome sign that the Police are now able to give more attention to real traffic control."

In Nasik, Sholapur and Bijapur also, it is indicative of stricter action on an increased scale on the part of the Police. In addition, greater activity under the Abkari and Gambling Acts has also tended to swell the figures for Nasik whilst on the G. I. P. and M. & S. M. Railways, the increase is the result of prosecutions under the Indian Railways Act and the Public Conveyances Act.

(i) The decline in the three districts of Surat, Dharwar and Poona mentioned above is also mainly noticeable under the Public Conveyances Act. More vigorous action under this Act was taken in the past in the first two of these districts which, it is reported, has led to greater respect for traffic rules and regulations during the year under report. With the gradual replacement of tongas and bullock carts by motor vehicles, a decrease of cases under this Act may not be unexpected.

(j) The increase of 191 cases for the Presidency may be commendable, as indicating increased vigilance on the part of the Police, but one has to admit there are many offences committed by Public Motor Vehicles which go undetected through shortage of Police to cope with this traffic and all its problems.

(b) A net.decrease of 50 cases is noticed in the total for 1936 when compared with that for 1935, though small increases have occurred under some of the categories. Murders and attempts as well as culpable homicides are, however, offences which admit of little control by the Police; increased prosecution of receivers of stolen property is a welcome indication of extended activity by the Police. The increase under dacoities is too small to require comment whilst the drop under the remaining heads of offences against property, though not great, is to be appreciated. With the adverse economic conditions prevalent in several districts one would not have been surprised at serious increases under dacoities, robberies and thefts.

Incidence of (a) cognizable and (b) serious crime per thousand of population. 5. (a) The latest figures from other Presidencies and Provinces available for comparison under these heads are those of 1935. They are given below and compared with the figures of this Presidency. (g) The incidence of total crime under the Indian Penal Code for the Presidency, including Railways, works out to 1.09 in 1936, a very slight reduction compared to the preceding three years viz., 1.10; serious crime in 1936 has remained stationary at 78 as in the year before.

(h) Bombay Suburban and Ratnagiri retain their reputation of being respectively the most and least criminal districts in the Presidency, their respective incidences of crime for 1936 being 3.98 and .27 per 1,000 of population.

(b) The number of cases in which the Police refused investigation under Section 157 (1) (b), Criminal Procedure Code, was 1,097 as against 1,070 in 1935, leaving 29,155 cases for investigation against 29,379 in the year before. The percentage of cases dealt with under Section 157 (1) (b), Criminal Procedure Code, to total cases for disposal rose slightly from 3.51 in 1935 to 3.62 in the year under review.

(c) Of the 3,860 cases excluded during 1936, 760 were compounded as against 817 in 1935 giving a percentage of 19.69 against 19.72 in 1935. These figures under the two categories were as under :---

There is practically no variation. Of the total number of cases compounded, 462 were of hurt or grievous hurt. The position in 1936 in respect of the number and proportion of compounded cases was almost constant as compared with the year 1935. It is at least satisfactory to note that there is no tendency for these cases to increase which may be taken to indicate that the orders of Government on the Police Administration Report for 1931 (paragraph 5 of Government Resolution, Home Department, No. P. 132-1, dated the 30th September 1932) in respect of discouraging litigation by checking compromise as much as possible are not being overlooked by the Magistracy. Continued attention to these orders on a wider scale is desirable in the future to obtain improved results and to eliminate waste of time and conserve the energy of the Police for other duties.

8. (a) Of the 3,654 excluded cases under the Indian Penal Code Maliciously false referred to in the preceding paragraph, 538 cases were classed as maliciously false as against 598 in 1935—a decrease of 60 cases. The percentage of such cases to the total number of cases for disposal under the Indian Penal Code also declined from 2.68 in 1935 to 2.45 in 1936.

(b) Prosecutions were ordered in 182 cases during the year under report against 165 in the year before. Of these 182 cases, 89 ended in conviction and 66 were pending at the close of the year. The percentage of prosecutions undertaken to the total number of maliciously false cases was 33.82 against 27.59 in 1935 and 27.95 in 1934.

The increase was of 68 under Indian Penal Code and of 47 under class VI. These increases, shared both by the Southern and Northern Ranges, are, however, small. The increase pertained to the number of cases pending with the Magistracy viz., from 3,072 in 1935 to 3,196 in the year under report, whilst those pending with the Police dropped very slightly from 812 to 803.

The District Magistrate, Ahmedabad, considers that a full time Magistrate at Viramgam is necessary and attributes the trouble partly to the abnormal amount of leave required by Honorary Magistrates. He is taking necessary steps to effect an improvement. An increase in the Prosecuting staff is also suggested by him. The District Magistrate, East Khandesh, attributes the increase to the absence of First Class Magistrates for several months at Yawal, Rawer, Jamner and Jalgaon Talukas, and is impressing on the Subordinate Magistrates the necessity of quicker disposal.

(c) There was no marked increase in Satara, but the District Superintendent of Police complains of the large number of cases of protracted trials which were 77 in which the trial lasted over three months and 20 in which it lasted over six months. Though the figures for the preceding three years show a gradual improvement in this tendency, the District Magistrate suggests the need of a third Police Prosecutor to improve the situation. In Belgaum the number of pending cases has dropped: still the District Magistrate suggests the need for increase in the Prosecuting staff. He observes :---

"Magistrates who are also Revenue officers have several multifarious duties to attend to and on that account I am not quite optimistic about the improvement, in the speedy disposal of cases in future envisaged by the District Superintendent of Police. There are several other matters connected with this question, one of them being the question raised by me last year about the paucity of Police Prosecutors."

(d) I have since the close of 1936 submitted a scheme for the increase of Police Prosecutors. In support of this scheme I would invite attention to the above complaints and remarks.

10. (a) Eliminating cases excluded and those pending at the close of the year, real cognizable crime disposed of during

Even if the Indian Penal Code cases are considered separately, the percentage of undetected cases has also dropped slightly from 39.77 in 1935 to 38.72 in the year under report. The improvement on the whole, though not marked, is welcome. The highest percentage of 55.36 was recorded by Nasik, the lowest being 23.10 by Ratnagiri.

12. (a) Out of 15,231 cases decided by trial, 14,423 ended in conviction as against 14,308 out of 15,108 cases tried in 1935. The percentage of cases convicted to those tried was 94.69 as against 94.70 in 1935 under all

13. Cases committed to the Sessions Courts, together with those pending from the previous year, numbered 779 as against 747 in 1935. Out of the 605 cases tried, 461 ended in conviction and 144 in acquittal or discharge as compared with 572, 430 and 142 respectively in the previous year. The percentage of cases ending in conviction to cases tried was 76.19 in 1936 as against 75.17 in 1935. Out of the remaining cases, five were withdrawn, and in one the accused died and 168 were pending at the close of the year 1936. The highest percentage was again returned by the Bombay Suburban District (100 per cent.) and the same was also recorded by the B. B. & C. I. Railway whilst the lowest was in Ratnagiri (55 per cent.).

14. (a) Including pending cases, offences under special and local laws dealt with by the Police numbered 8,124 in 1936 as against 7,971 in the year before, returning an increase of 153 cases. Analysing the figures by districts, Ahmedabad returned the highest increase (280), followed by Sholapur (158) and Nasik (128). The resultant increase for the Presidency has already been dealt with in paragraph 3 of this report. 15. (a) The number of true cases dealt with by Magistrates in 1936 without the intervention of the Police under all classes was 10,823 against 11,767 in 1935 (vide graph—paragraph 2), the number convicted being 6,387 against 7,301 in 1935.

(b) Out of the above the true cases under the Indian Penal Code numbered 5,138 (classes I to V) against 5,350 in the year before. Of these 1,296 ended in conviction as against 1,438 in 1935, giving a percentage of  $25 \cdot 22$  in respect of convictions to cases tried against  $26 \cdot 87$  in the year before. Corresponding percentages under all classes were  $59 \cdot 01$  against  $62 \cdot 04$  in the year before. The variation is small and needs no comment.

16. The total number of persons arrested by the Police suo motu

Statements "A" and "AA", Part II— Persons in Police Cases.

was 26,747 as compared with 25,925 in the previous year. Inclusive of the persons concerned in cases pending from the previous year, the total number of persons for disposal was 32,180 as against 31,617 in 1935. Persons released without being brought

to trial under the Indian Penal Code (classes I to V) numbered 646 as against 607 in 1935, giving a percentage of 3.60 of the total arrested as against 3.49 in the preceding year. Of the 32,180 persons for disposal, those under the Indian Penal Code numbered 22,675 of whom 16,548 were tried during the year and 10,908 were convicted, giving a percentage of 65.91 of the total tried against 64.97 in 1935. The number of persons awaiting trial or investigation under the Indian Penal Code at the end of the year was 5,224 as against 4,639 in 1935.

17. (a) Reported non-cognizable crime rose from 105,964 in 1935 to 106,043 in the year under report—an increase Statement "B", Part I—Non-cognizable Crime. 1935 regarding the continuous increase in reported non-cognizable crime during the preceding ten years still hold good. For the reasons stated last year, I do not think this rise need be looked upon with any alarm.

(b) The total number of cases for disposal including those pending from the previous year was 111,375 as against 111,417 in 1935. Of the former, 88,793 were tried and 77,305 ended in conviction against 88,556 and 77,305 cases respectively in the year before, giving a percentage of 87.06 of cases convicted to cases tried, as against 87.48in 1935. The percentage of convictions to the cases for disposal also was almost the same as in 1935 viz., 69.40 against 69.53 in the year before. 18. 150,057 persons concerned in non-cognizable cases appeared before the Courts in 1936 as against 150,446 in the previous year. Persons discharged after appearance without trial numbered 8,717 as against 9,151 in

1935; of the 117,861 persons tried, 84,316 were convicted and 33,545 discharged or acquitted, as against 116,553, 84,497 and 32,056 respectively in the year before. The percentage of persons convicted to those tried slightly declined from  $72 \cdot 49$  in 1935 to  $71 \cdot 53$ during the year under report. The percentage of persons convicted to those who appeared before the Courts, however, was almost the same as in 1935 viz., 56 · 19 against 56 · 16 respectively.

19. The value of property stolen in 1936 in connection with cogstatement "C"--property stolen and recovered. in 1935, the corresponding figures of the value of property recovered being respectively Rs. 2,48,759 and Rs. 2,27,035. The percentage of property recovered to property stolen, based on the percentage of property recovered in individual cases, was 44.10 in 1936 against 52.19 in 1935. The highest percentage of recovery was returned by Dharwar (67.22), followed by Bijapur (61.50), Ratnagiri (59.96) and Sholapur (59.29) all in the Southern Range while the majority of the districts in the Northern Range recorded poor results, which contributed largely to the drop in the percentage for the Presidency. This is amplified by a comparison of the lowest percentage of 39.58 of Kanara in the Southern Range with the lowest of 18.48 of Ahmednagar in the Northern Range. No particular reason can be given for these poor figures in the Northern Range : they are in consonance with the other poor results in the same Range with an increase in crime, an increase in serious offences and a deterioration of conviction results.

20. (a) The details of persons proceeded against under Chapter VIII,

#### Preventive Action.

Criminal Procedure Code and Regulation XII of 1827 will be found in Appendix "C" to this report.

The total number of persons proceeded against under the preventive sections dropped by 84 from 1,881 in 1935 to 1,797 in the year under report. Comparing the figures for the two Ranges separately, the Northern Range was characterised by an increase of 172 persons, which merged in the larger decrease of 256 persons in the Southern Range. The marked decreases were Satara (114), Kolaba (83) and Sholapur (58), whilst the marked increases were Thana (91) and Ahmedabad (80). The percentage of persons from whom security was demanded to those proceeded against (excluding persons in pending cases) practically remained stationary in 1936 as in 1935, viz., 74.70 and 74.59 respectively. (b) There is still a tendency for the proceedings in these cases to be unduly prolonged about which reference was made last year. Kolaba District has again rather given evidence of such dilatory proceedings. The Commissioner had to remark on the question during the year, while at the end of the year a case under section 107, Criminal Procedure Code, against some 18 persons had been pending for six months. Such delays merely stultify Police action and may give rise to further trouble despite action taken by the Police.

21. During the year under report, 3,231 out of 19,178 persons convicted Were identified as having been previously convicted, and 752 were classed as "Habitual offenders" against 2,667, 19,130 and 711 respectively in 1935. The highest number of "Habitual offenders" was returned by Ahmedabad (124), followed by East Khandesh (107) and Poona (83).

22. (a) During the year under report, only one gang case was taken up which ended in conviction. In the previous Gang Cases: G.R., J.D., No. 557, dated 25th January 1916. Year no case was investigated. There were no persons pending trial at the beginning of the year. All the seven persons arrested in 1936 in the case were tried, of whom 6 were convicted and one discharged. The percentage of cases convicted to tried was 100.00 in 1936 against 50.00 in the year before. The percentage of convictions to the persons tried was 85.71 in the year under report against 66.66 in the preceding year.

(b) I am not an advocate of such gang cases as a general rule. In running a gang case there are so many issues involved that the chances of conviction are not great. When and where possible I prefer to see individuals prosecuted in such separate cases as may be possible : this ensures these individuals being put out of the way for various periods. On the conclusion of such separate cases, then the question of a gang case against all may be considered when the convictions in the separate cases may provide very good evidence of association or other circumstances. If the gang case then breaks down, we still have the members convicted in the separate cases. It is merely advocating the principle of safety first in such intricate cases.

23. Important and interesting offences investigated by the Police Important cases dealt with in Districts and on Railways. in the districts and on the Railways of the Presidency during the year under report are narrated below with brief details :--

#### (1) Armed dacoity at Vanz, Chorasi Taluka, Surat District.

About 7-30 p.m. on the 21st March 1936, when a rich individual was sitting with his clerk in the front room of his house in the village of Vanz, several men armed with guns, sticks, etc., arrived and demanded the keys of the safe. On non-compliance the owner was beaten and forced to open the safe when property consisting of jewellery, ornaments, Government currency notes, cash and a silver bar, valued at over Rs. 9,000 was removed. While the house was being ransacked three or four dacoits who remained outside fired gunshots to scare off neighbours who consequently did not attempt a rescue. Vigorous enquiries by the Police resulted in suspicion falling on a gang of ten or twelve Bhils headed by a Kunbi of Baroda State. Seven members of the gang were traced at different places in Broach District as well as in Baroda State limits with identifiable stolen property valued at over Rs. 2,000. The ringleader and his two associates were absconding. They were eventually traced and arrested at Benares where they had changed their names and carried on business as cotton brokers and jewellers. As a result of information given by the ringleader, a bundle containing one double-barrel gun, one six-chambered revolver, two daggers and ammunition was recovered from a well in Segwa village in Baroda State. The investigation of this case extended over a period of seven months and involved great patience, tact and labour on the part of the Police; a huge mass of evidence had to be collected from various places mostly lying in Baroda State limits which made the task all the more difficult. The case ended in conviction.

#### (2) A gang of dacoits, East Khandesh District.

A gang of dacoits carried on depredations in East Khandesh District during the years 1919 to 1922 and committed numerous offences of dacoities, dacoities with murder, house-breakings and thefts. The gang was traced in 1922 and 52 of its members were sentenced in 1923 to various terms of imprisonment by the specially appointed Sessions Court : . the leader of the gang who posed as a respectable cotton merchant in Yawal however was untraced. Information was fortunately received through the medium of an anonymous application at the end of 1935 that the absconding leader was working as a watchmaker in Bombay. Voluminous files of the old gang case had to be examined. With the assistance of the Criminal Investigation Department, the leader's arrest . was effected on 12th February 1936. His trial lasted for two months, as numerous witnesses had to be examined. He was convicted and sentenced to ten years' Rigorous Imprisonment under section 400, Indian Penal Code. He was also separately sentenced to rigorous imprisonment for two years under the Arms Act in connection with the ammunition, etc., which had been found in the search of his house over fourteen years back. This conviction finally finished up the case.

#### (3) Rounding up of a gang of house-breakers, Bijapur District.

A series of house-breakings and thefts committed in the Bijapur city in February 1936 remained undetected for about a month. From the modus operandi resorted to in all these cases, the local. Sub-Inspectorsuspected the offences to be the work of some Criminal Tribesmen: on this assumption enquiries were vigorously started resulting in the Haran Shikaries of Panduzari in the Jath State being discovered as the responsible culprits. A special Police party under the Sub-Inspector started on the track of the gang, which was reported to be moving from place to place. Ultimately the gang was raided and captured in the jungle of Morabagi on 20th March 1936. Property pertaining to eleven offences valued at over Rs. 800 was discovered with the gang: the property concerned in three undetected cases of 1933 valued at over Rs. 1,200 was also found with the gang. In all, therefore, fourteen offences were detected and the cases sent up against the gang.

The capture of this gang considerably reduced the number of housebreakings and thefts in Bijapur District.

#### (4) Human sacrifice at Dhumwad, Kalghatgi Taluka, Dharwar District.

On the evening of 16th March 1936, a Mahomedan woman committed her baby aged six months to the care of her eldest son, as she went inside to do some cooking, but on coming out later she found her son without the baby. On being questioned, the son pointed out the baby's dead body near by with its neck severed and explained that he had offered the baby to the Pir. Soon after, the accused was found to be mentally deranged and is under treatment in the Dharwar Mental Hospital. The case is mentioned as being a curious and rare instance of human sacrifice and that too by a close relative of the yictim.

Criminal Investigation Department: Bombay Presidency. 24. (a) The sanctioned strength of the Criminal Investigation Department underwent the following changes during the year under report :---

(c) During the year under report the Investigation Branch enquired into twelve criminal cases as compared with fourteen in 1935. Of these five were pending from the previous year. Most of the cases were of a difficult and protracted nature.' Their result was as under :--

27 persons (including seven from the previous year) were dealt with, of whom seven were convicted, four were acquitted and charge sheets were submitted against fourteen who were pending trial. The remaining two are pending extradition.

.

(d) In addition to the above, one Police Inspector was deputed to assist the Poona District Police in an enquiry into the Serious Communal disturbance in the Poona City arising out of playing music before the Sonya Maruti Temple. He assisted the prosecuting officers in that investigation from the beginning and was throughout present in the trial and appeal Courts. The cases in all numbered nine in which 65 Mahomedans and 47 Hindus were sent up with the result that 63 Mahomedans and 27 Hindus were convicted in the lower Courts. In appeal the convictions of 56 Mahomedans and 18 Hindus were upheld.

(e) Requests for the assistance of the Investigation Branch officers were refused in two cases during the year. In the case of one the grounds were that the case was very simple and could conveniently be dealt with by the local Police, while in the other, there was no suitable officer available at the time.

#### Intelligence Branch.

(f) The Intelligence Branch carried out satisfactorily its numerous and important duties throughout the year. The officers attached to this Branch made a number of confidential enquiries and attended many political meetings and conferences. The Shorthand staff consisting of nine Sub-Inspectors supplemented by several Sub-Inspectors who know Shorthand belonging to districts, reported a large number of political speeches. In this connection, it may be mentioned that two prosecutions were launched on the strength of shorthand reports both of which ended in conviction.

(g) The usual figures with regard to enquiries and meetings are not given this year as the compilation of these gives no real indication of the activities of the staff or supplies a useful basis for comparison with other years. It will suffice to say that the out-door work of the staff was greater than in the previous year largely on account of the political activity consequent on the Faizpur Congress Sessions and the approaching elections for the Provincial Legislation.

(h) As previously remarked the staff of the Intelligence Branch was reorganized during the year under report. Experience gained so far indicates that the re-organization was planned on sound lines and that the innovation by which Sub-Inspectors and Sergeants were entrusted with the ministerial work has amply justified itself.

(i) The office work of the Branch is both heavy and important and an immense amount of information has to be collected, recorded and distributed. In connection with this work the new system of filing has proved most helpful and Mr. N. P. A. Smith and the special temporary staff who completed their labours early in the year, can congratulate themselves, on having removed the chaotic state of affairs which existed previously and on providing the Criminal Investigation Department with a simple but comprehensive system of recording information which will add greatly to its general efficiency. The proper working of the system entails a considerable amount of labour and it has been found necessary to add a Steno-typist as the number sanctioned viz., two has proved to be insufficient and the employment of a third Steno-typist for a period of five years from 1st April 1937 has recently been sanctioned by Government.

(j) The most outstanding event of the year so far as the Intelligence Branch is concerned was the Congress Session at Faizpur. The Bombay Presidency Criminal Investigation Department was entrusted with the task of reporting the proceedings not only to the Bombay Government but also to the Director of the Intelligence Bureau and all the other Provincial Criminal Investigation Departments in India. The task involved sustained and arduous effort for over ten days and the officers of the Criminal Investigation Department and those of other Presidencies who assisted are deserving of much credit for the manner in which they performed their duties.

#### Crime Branch.

(k) (i) During the year, 12 Crime Records of Inter-Provincial and Inter-District Criminals (cheats) were prepared and published in the *Bombay Police Gazette* as compared with 38 in 1935, 56 in 1934 and 34 in 1933. The total of all such records published up to the end of 1936 amounts to 442.

(*iii*) The number of Crime Records prepared and published during the year under report is small because in accordance with the policy mentioned in last year's Annual Administration Report, records of only professional poisoners and cheats were prepared.

(iv) The crime records already published were kept up-to-date by the publication of 33 addenda containing details of further criminal tendencies or convictions.

(v) As in previous years district crime reviews and the diaries of Sub-Divisional Officers were closely examined. This enables the Criminal Investigation Department to keep a general watch on serious crime throughout the Presidency and to give assistance and information to District Superintendents of Police in cases where the co-ordination of investigation is necessary.

(vi) Crime graphs have been maintained up-to-date and show the monthly variations of more important forms of crime in the Presidency.

## (1) CRIMINAL TRIBES ACT.

#### A. REGISTRATION.

(i) The total number of registered members at the end of the year belonging to all tribes and mixed gangs declared as Crimial Tribes was 8,165 as compared with 8,318 at the end of 1935. The decrease is due to a smaller number of registrations as compared with the previous year.

Statements I, I-A, II and II-A give a complete synopsis of the working of this Act throughout the year in all its phases.

(ii) 3,277 registered members are subject to the provisions of Section 10 of the Act and 4,888 are restricted under Section 11, as compared with 3,674 and 4,644 respectively in 1935. 317 registered members were absconding and 338 were in jail at the end of the year as against 403 and 370 respectively in the previous year.

# Changes during the year owing to additions to, and removals from, the register.

(*iii*) During the year, 1,255 members of different tribes and gangs were registered. 22 were received under Section 10 (3), 103 died and 1,170 were removed from the register owing to improvement in character or other reasons. Two Berads and one Pardhi were again brought on the register in Sholapur District for having reverted to crime.

#### B. CONVICTIONS AND PROSECUTIONS.

(i) The details of convictions of Criminal Tribesmen both registered and unregistered are shown separately in Statements II and II-A according to Tribes and Districts.

(ii) Instances of the wrong application of sub-sections of section 22 are still common. Out of the 25 persons liable to enhanced punishment under Section 23, 12 actually received enhanced punishments.

(*iii*) Eight registered members were convicted under section 224, Indian Penal Code, as against 8 in 1935 and 6 in 1934.

#### C. NEW APPLICATIONS OR MODIFICATIONS OF THE ACT.

(i) During the year a mixed gang consisting of 41 members residing in Ahmedabd District was brought under the operation of the Act, *vide* Government Resolution, Home Department, No. 7809/3, dated the 18th May 1936.

(ii) Notifications under Section 11 in respect of the Berad and Waddar tribes of this Presidency were cancelled and section 10 (1) (a) and (b) was made applicable to all registered Berads and Waddars as had been already done in the case of Lamanis.

(*iii*) A proposal for the application of the Act to a mixed gang of 23 persons received from Poona District was examined and proposals to notify this gang under Section 3 are under preparation for submission to Government.

(iv) The question of the gangs of Kanjar Bhats and others emanating from the Madras Presidency which was under the consideration of Bombay and Madras Governments as mentioned in last year's report still remains undecided.

During the year 1936, 25 Kanjar Bhat Gangs consisting of 158 members including males, females and children migrated into Dharwar District. Five of these Kanjar Bhats were convicted for offence of house-breaking and thefts.

The present state of affairs is very unsatisfactory and cases continue to occur in which it is alleged that pressure is brought on Kanjar Bhats to return to this Presidency from Madras. An early settlement of this problem is desirable.

#### **D.** INTERNMENTS AND TRANSFERS.

112 registered members of different tribes were sent to Settlements under Section 16. No registered member was restricted in his movement to another Province under Section 13 or was deported to any Indian State under Section 28.

### E. ABSCONDERS.

317 registered members were absconding at the end of the year while 121 were apprehended during the year. 490 were prosecuted under Section 22 of the Act, usually after having been first arrested in respect of some major offence.

#### F. WANDERING GANGS.

(i) During the year 383 wandering gangs came to notice in the Presidency as against 304 last year. The increase is due mainly to the arrival of many gangs of Kanjar Bhats from the Madras Presidency.

(*ii*) 273 of the gangs belonged to notified Criminal Tribes, 26 to classes considered as non-criminal, and the remaining 84 were Iranis.

(*iii*) The question of registering wandering gaugs under the Criminal Tribes Act is under consideration and will be taken up during the current year.

#### M. GENERAL.

(i) The Criminal Tribes Branch of the Criminal Investigation Department continued to exercise close supervision over the working of the Criminal Tribes Act and gave constant advice and instruction in the administration of the Act throughout the Presidency.

(*ii*) With the help of the Finger Print Bureau many absconders were traced and brought back either for prosecution or for registration under the Act.

#### N. INSPECTIONS.

During the year the Criminal Tribes records of East Khandesh, West Khandesh, Bijapur and Belgaum Districts were inspected and lectures on the Act and the Rules made thereunder were given.

#### O. CONCLUSION.

(i) During the year, 1,464 members of Criminal Tribes were convicted of cognizable offences and under Chapter VIII of the Criminal Procedure Code as against 1,655 during the year before. Of these 928 members were convicted for offences against property as against 1,017 last year.

(ii) The decrease in offences against property and other cognizable offences committed by both registered and unregistered members is indicative of a gradual departure of the tribes from their traditional criminal propensities.

(*iii*) The new Criminal Tribes Manual has been approved by Government and has been sent to the Press. It is hoped it will be published during the year 1937.

(b) From the above it will be seen that there was a considerable increase in the circulation of counterfeit coins on the Railways as compared with 1935. An officer of the Criminal Investigation Department was specially deputed to make enquiries on the M. & S. M. Railway with the assistance of the Railway Police and the co-operation of the bordering Indian States. As a result the Railway Stations on which the enquiry was concentrated showed a marked decrease of counterfeit coins in their collections in subsequent months. The Criminal Investigation Department officer was incidentally successful in arresting in Sangli State limits a gang of three Salat Waghris with nickel counterfeit coins and materials for manufacturing the same. The case was taken up by the Sangli State Police and is now sub-judice. (c) Reports received from the districts show greater activity on the part of the District Police in tracing and prosecuting counterfeiters and utterers, 25 prosecutions involving 57 arrests for counterfeiting and possession of counterfeiting implements having been undertaken as compared with 11 prosecutions and 15 arrests in the previous year. Of the 57 persons arrested, 12 were convicted and 45 were awaiting trial at the end of the year. A majority of those arrested were Marwar Bauriahs or Salat Waghris of Ahmedabad and the neighbouring States. They were arrested in Ahmedabad, Bombay Suburban, Nasik, Poona, Satara and Belgaum Districts.

. (d) No sweated Sovereigns came to notice during the year.

(e) The steady increase in the circulation of spurious coins merits more than passing attention. This has now developed almost into an industry, and is no longer a "crime" committed by professional coiners like Chapparbands. Economic pressure has no doubt encouraged this industry : gold and silver-smiths no longer find such work : there are skilled die engravers to be found in most places : silver can be freely purchased : it is thus no more difficult to turn out coins than to make jewellery and trinkets. Then in adjacent States that coining is going on is no secret. In some places miniature mints have been discovered. With resultant financial loss to Government and the tendency to discredit Indian currency, this question assumes very serious importance. It is moreover not one affecting only this Presidency: one has read about it as being quite as serious elsewhere. What the solution should be to cope effectively with this problem one cannot definitely say. It is, I fear, getting beyond the control of the Police and certainly merits even more serious attention from the Currency Authorities.

(b) At the commencement of the year there were on record 124,341 slips. During the year under report 10,503 fresh finger impression slips were recorded and 5,986 eliminated thus leaving 128,918 slips on record at the end of the year.

(c) The number of finger impression slips received for search of previous convictions was 31,910 as against 31,436 in 1935. Of these 4,283 were traced as against 3,979 in 1935.

(e) The number of finger impression slips of Criminal Tribes absconders recorded in the Bureau was 431 and the slips traced out of those recorded during the year was 297. Intimations in respect of other absconders were received in 389 cases, the number of absconders traced being 552.

(f) Intimations regarding Inter-District and Inter-Provincial criminals were sent to the Criminal Intelligence Branch in respect of 203 cases.

(g) In 92 cases (64 Civil and 28 Criminal) written opinions on finger prints were furnished and the fees collected on account of the Civil cases amounted to Rs. 685 as compared with Rs. 795 in 1935. On 48 occasions Experts were deputed to give evidence in Courts as against 46 in 1935. The amount of fees collected for expert evidence in Civil cases was Rs. 45 the same as in the previous year.

(h) Ten Policemen were trained as Chief Operators as against nine in the previous year.

(i) Experts were called on in sixteen cases to visit scenes of crime in Poona City as against thirty in the preceding year.

In eleven cases articles bearing chance prints suspected to be of the culprits were sent to the Finger Print Bureau for examination. Thus the Experts handled 27 cases during the year. Out of these two successes were registered.

(j) In Poona Civil Lines Police Station C. R. Nos. 2 and 6 a chance print left on a silver kettle by the culprit was identified as that of an ex-convict whose finger impression slip was on record in the Finger Print Bureau. The name of the culprit was intimated to the Police who arrested him and recovered the stolen property. During the course of investigation into these cases it transpired that the accused was also concerned in four other cases in the same locality. He was charged in all the cases and subsequently convicted and sentenced to be detained in the Dharwar Borstal School for four years.

(k) In the other case photo prints of chance impressions found by the Bombay Bureau Experts in a series of housebreaking and theft cases in the jurisdiction of the Ville-Parle and Bandra Police Stations were sent to the Poona Bureau for search in the general record after an unsuccessful search in the Bombay Single Digit record. While search was being carried on in the general record a watch was also kept on all finger

impression slips received for search of previous convictions. After a lapse of about four months the photo prints were identified to be those of an individual whose finger impressions were received from the Chief Operator, Santa Cruz, for search of antecedents. The Bombay Bureau and the Bandra Police were immediately informed that the individual who had been arrested on suspicion of being a bad character was the culprit responsible for the series of cases in question. He was subsequently charged and sentenced to a long term of imprisonment. This case was also detected in the Bombay Bureau on the same day from the duplicate finger impression slip of the suspect received for search from the Chief Operator, Santa Cruz.

#### Bombay Bureau.

(1) The number of finger impression slips on record at the beginning of the year was 34,987. 3,666 fresh finger impression slips were recorded during the year while 1,972 finger impression slips were eliminated thus leaving 36,681 slips on record at the end of the year.

(m) The finger impression slips searched for previous convictions numbered 21,756 as against 22,090 in 1935. Of these, 4,619 slips were traced as against 4,675 in 1935.

(n) Written opinions on finger prints were furnished in 57 cases as against 46 in 1935 and the amount of fees recovered was Rs. 560 as against Rs. 470 in the previous year. Experts attended courts for giving evidence in 89 cases as against 83 in 1935.

(o) 41 Policemen as against 24 in the previous year were trained as Operators during the year under report.

(p) Visits to scenes of crime rose from 211 in 1935 to 252 in 1936. In 48 cases articles were also sent in for examination of chance prints. In all therefore 300 cases received the attention of the Experts as against 248 in the previous year. The number of crimes detected by this method was the same as in the preceding year, viz., 31. This Single Digit System still continues to be of great assistance to the Bombay City Police in the investigation of crime against property.

(q) The following tabular statement shows the progress made in this kind of work since the introduction of the Single Digit System in 1933 :----

(r) At the commencement of the year there were 800 sets of Single Finger Print Cards or 8,000 single prints of burglars and thieves on the record. To these 275 sets were added during the year bringing the total to 1,075 sets or 10,750 single prints. The supplementary or skeleton record started in 1935 has now 250 sets of cards on record as against 100 in the previous year.

#### Handwriting Bureau.

(s) The work of the Handwriting Expert in the Criminal Investigation Department has continued to develop rapidly.

(t) The following tables give an idea of the work done and the progress made :—

It will thus be seen that the amount received by Government for the Experts' services rose from Rs. 605 in 1935 to Rs. 905 in the year under report.

(u) The decrease in the amount of photographic bills in paid cases is due to the introduction of the practice of photographing on the same plate instead of on separate plates the several different writings in the same case. This saves money to the parties concerned so is a step in the right direction; but with increasing work this revenue will also continue to increase.

(v) During the year the Expert was required to give evidence before various Courts in the Presidency in 35 cases. 25 of these cases ended in conviction and 10 in acquittal. In the 10 cases ending in acquittal

the Experts' opinion was not challenged. The results of his work are very creditable and are a testimony to the high opinion which is held by the Courts of his reliability as an Expert.

(w) The provision of a laboratory for the Expert with up-to-date apparatus such as the following will also have to be considered :---

- (I) Ultra-violet lump for deciphering erased writings, additions, etc.
- (II) Photo-micrographic apparatus for demonstrating before Courts the writing features seen through the microscope.
- (III) Spencer's Comparator for presenting evidence in Court in a scientific manner.
   (IV) Transmitted-Light apparatus for examining documents through transmitted light.

(x) The question of placing this Handwriting Expert on a regular basis is under consideration: so far his work has been rather of an experimental nature to test the real need for such an officer as well as to test his own efficiency. The facts recorded above prove sufficiently the success of the experiment.

27. (a) In addition to their usual duties in connection with the

Miscellaneous duties performed. in districts plus 744 on the Railways and 490 suspicious or sudden deaths; six Military deserters were also apprehended by the Police.

(b) There has been a decrease of over 21,000 in the number of summonses and warrants served by the Police, viz., 224,286 in 1935 and 202,579 in the year under report. The decrease is clearly due to the system introduced in several districts of having summonses in criminal cases served through the agency of Police Patels instead of by the Police.

28. (a) The statistical information regarding motor vehicles as required by Government letter No. O/9-E, dated the 21st January 1930, will be found in Appendix "D" of this report.

(b) A temporary staff sanctioned by Government for work in connection with the administration of the Bombay Motor Vehicles Tax Act, 1935, with effect from 1st April 1936, was employed. Its continuance up to 31st August 1937 has recently been sanctioned by Government. The question as to whether it is adequate or not for the actual performance of the work is under consideration and necessary proposals will be submitted to Government in due course.

(c) For want of a special staff sanctioned for the purpose in the past, increasing motor traffic has been throwing considerable additional work on the Police whose energies are consequently over-taxed with the result that a large number of men are of necessity withdrawn from their normal duties (to the consequent detriment thereof) for utilization in connection with motor traffic. I have already represented to Government that our present position as regards control over motor traffic is far from satisfactory. I appreciate too there are at present difficulties in the way of further developments, so I am content to urge once more that, as soon as it is possible to develop our organization, immediate. steps should be taken to do so.

(d) From the reports of accidents due to rash driving, mechanical defects, etc., received from the districts it is noticed that during the year under report 155 persons were killed or died of injuries, while 1,696 persons received injuries in motor accidents, as against 141 and 1.399 respectively in 1935. The number of accidents has also increased from 1,450 in 1935 to 1,532 during the year under report. One cannot express any surprise about these figures: one may even be prepared for an increase of accidents next year unless very radical steps can be taken to control motor traffic over the length and breadth of the Presidency. In the past I have pleaded—and I still do so—for some definite road policy in the interests of the Public, the Motor Owners and the Police, and incidentally for the benefit of Government's coffers and of our roads. Until some policy is laid down and carried out, we must be prepared for increasing numbers of accidents, economic suicide by bus owners, and unsatisfactory services for the Public with inadequate control by the Police.

(e) The District Superintendent of Police, Poona, remarks that, due to the introduction of speed governors, the number of serious accidents has decreased. He recommends, and in this is supported by the District Magistrate and the Commissioner, that the fitting of speed governors to Public Vehicles should be made compulsory in other districts. It is however, observed that the total number of accidents in which Public Motors in Poona District were involved, increased during the year under review. The efficiency of speed governors in preventing accidents therefore appears indeed very questionable. Whether an accident is serious or not is purely a matter of chance. The proper basis for assessing the value of speed governors should be the total number of accidents and as remarked above the number increased during the year. My own opinion, for what it is worth, is that speed governors are neither satisfactory nor are they a practical solution of our traffic problems. These governors can be tampered with very easily and rendered ineffective : their adjustment and keeping in order require technical skill not available in every District Head Quarters. Then there is the danger of lorries-particularly goods lorries-failing to climb some of our ghats owing to the reduction of their power by these governors. With a definite road policy in force, such governors would be unnecessary and the danger from their use would be also eliminated. These governors may be a palliative but not a cure for our troubles : personally I place them in the category of the broken reed on which one may never rely.

29. (a) Out of 750 cases of serious crime reported, the scenes of 693

(a) Personal visitation of serious crime.

(b) Personal investigation of important crime by Assistant and Deputy Superintendents of Police (not in independent charge of a District). were visited by Superintendents and Sub-Divisional Officers. The percentage of scenes visited to serious crime reported has improved from 90.02 in 1935 to 92.40 in the year under report, both the Ranges having shared in the improvement. This duty of superior officers is very important and indispensable in the interests of efficient and straightforward investigation of Crime: it is creditable to note that this duty was, on the whole, satisfactorily

performed during the year. The cases in which scenes of offences were not visited numbered 57 as against 76 out of a total of 762 in the year before. This is a welcome decrease. The causes which were responsible for non-visitation were, on the whole, found to be justifiable and beyond the officer's control.

(b) The duty of personal investigation of a minimum of six important crimes a year by Assistant and Deputy Superintendents of Police (not in independent charge of a district), who are direct recruits in the Service was also, on the whole, adequately performed in accordance with Rule 1075 (4) of the Police Manual, Volume III. In cases in which the provisions of the rule were not fully complied with, reasons for non-compliance were inquired into and where not found to be satisfactory, the officer has been warned. This work, which is calculated to give excellent practical experience, cannot be allowed to be avoided.

30. (a) Though Sind has been created as a separate Province from 1st Statement "D"— Strength of Police. April 1936, the Indian Police cadre continues to be treated jointly for both Bombay and Sind. The variations in its sanctioned strength have been explained at the foot of statement "D" annexed to this report. Imperial and Provincial Police officers, of and above the rank of Assistant or Deputy Superintendent of Police, actually on duty on the 31st December 1936 in the Presidency numbered 54. The sanctioned strength of (a) officers below the rank of Deputy Superintendent of Police and (b) men, stood at (a) 725 and (b) 17,508 respectively, as against (a) 717 and (b) 17,576 in the year before. The increase of eight in the strength of officers below the rank of Deputy Superintendent of Police was due to the following reasons:—

- (1) Creation of one permanent post of Sub-Inspector, (Reader to the District Superintendent of Police, Bombay Suburban District.)
- (2) Creation of seven posts, viz.,
  - 1 Inspector,
  - 4 Sub-Inspectors,

2 Sergeants,

for the Intelligence Branch of the Criminal Investigation Department.

The decrease of 68 in the strength of the Constabulary was due to :— ,

- (a) --57 Unarmed Constables reduced in consequence of the transfer of the duty of service of summonses in criminal cases in certain districts from the District Police to the Village Police.
- (b) -1 Unarmed Constable-orderly to the Police Prosecutor, Bombay Suburban District, reduced.

- (c) -3 Head Constables and 9 Constables armed forming the escorts to the District Magistrate and District Deputy Collectors, Kaira, reduced.
- (d) -2 Head Constables and 6 Constables—armed—of the Treasury Guard, Dhulia, reduced.
- (e) -3 Armed Constables-orderlies to one Sub-Divisional Officer, Satara District-
- (f) -7 Armed Constables reduced due to conversion of Karwar District Prison into a Sub-Jail.
- - (g) +4 Armed Constables sanctioned permanently for personal orderlies to the District Superintendent of Police, Bombay Suburban District.
  - (h) + 3 Armed Constables added to Poona District strength on account of personal orderlies to the second Assistant to the Deputy Inspector General of Police, Criminal Investigation Department.
  - (i) +2 Head Constables and 7 Constables—armed—sanctioned for the Dharwar Sub-Jail Guard.
  - (j) +2 Unarmed Constables sanctioned as addition to the G. I. P. and M. & S. M. Railways Police Force on account of the transfer of a portion of the Hyderabad Godavery Valley Railway line to the Government Railway Police.
  - (k) +2 Head Constables, armed, sanctioned as an addition to the Police Training School strength for Head Constables' Training Class.

Total +20 Posts of Head Constables and Constables.

Net result : -88 and +20 = -68 posts

(b) Temporary Police consisting of 73 officers and men were entertained during the year as against 16 in 1935. The increase was mainly due to the entertainment of temporary staff for work in connection with the administration of the Motor Vehicles Tax Act, 1935.

31. (a) The cost of the Police, including the Railway Police and the clerical establishment, for the financial year 1936-37 in the Presidency was Rs. 98,51,195 as against Rs. 99,09,849 in 1935-36—a net decrease of Rs. 58,654. The average cost per Policeman (exclusive of the clerical establishment) in the Presidency also slightly decreased from Rs. 515-13-11 in 1935-36 to Rs. 514-14-1 in the year 1936-37. The decrease is mainly due to reduction in the permanent sanctioned strength as mentioned in the previous paragraph, economy in expenditure under Contingencies and allowances, and other minor administrative economies.

(b) The average cost per Policeman in other Presidencies and Provinces compared with ours in 1935-36 is given below :---

In 1934-35, Bombay stood ninth among ten Provinces, whilst in 1935-36, it has changed its positior to eighth even among eleven Provinces (including Sind which has now been added as it has become a separate Province from 1st April 1936), on account of the decrease in cost for North-West Frontier Province and Central Provinces which was more than that for Bombay in 1934-35. The figure of average cost per head of the Police in the Counties and Boroughs of England and Wales for the year ending September 1936 was Rs. 4,627-13-4.

32. I the year under report the proportion of Police to area, population and cognizable crime investigated, was one Policeman to 4.51 square miles, 2.30 Railway miles, 920 persons and 1.37 cognizable crime investigated, as against 4.49 square miles, 2.19 Railway miles, 917 persons and 1.38 cognizable

crime investigated in the previous year. The above statistics are based on the permanent sanctioned strength of the Police Force. In England and Wales the proportion for the year ending September 1936 was one Policeman to 1.48 square miles and 818 persons.

33. (a) Out of 349 Police Stations and 372 Outposts in the Presidency Inspection of Police Stations and Outposts. Deputy Superintendents of Police. The abolition of one Outpost and the opening of four Outposts account for the excess of three Outposts over the number of 369 obtaining in 1935. The reasons for non-inspection of the remaining one Police Station and ten Outposts among three districts are acceptable and need no comments.

(b) In addition to inspection work done by district officers, the Range Deputy Inspectors General of Police inspected the following offices during the year :--

(c) During the year under report, I visited the following places for inspection and other duties :--

Phillaur; Delhi; Simla; Mount'Abu; a tour in Sind embracing Karachi, Hyderabad (Sind), Larkana, Sukkur, Dadu and Jacobabad; Kaira with Nadiad and Mehmedabad; Godhra; Ahmedabad; Broach; Surat; Thana with Bhivandi and Kalyan; Bandra (Bombay Suburban District); Bombay; Alibag with Panvel and Pen; Nasik (including the Police Training School).

Statement "E"— 34. (a) There was no change in the armament Armament. of the Police Force during the year under report.

(b) Judging by the inspections carried out in our districts by the Chief Civil Master Armourer one cannot assert that our arms are satisfactory. The .410 musket is, I fear, not capable of doing all that was expected of it : one reason for this is probably that it is much too old a weapon before its conversion: if it were originally made as a .410 weapon or if a new  $\cdot$  303 rifle were converted, then we should have a better weapon. Our .303 rifles come in for similar condemnation on rather the same grounds: as pointed out later in paragraph 46, the future use of high velocity ammunition will lead to a further examination of the capabilities of these Police Rifles. Whatever may be said about neglect in looking after the arms in our possession, one cannot overlook the important fact that all our weapons are second-hand and some were found faulty soon after issue. It is perhaps fortunate that in the Police we do not have to use our weapons to any great extent, otherwise their weakness would perhaps be even more marked. Our musketry results as given in paragraph 46 are naturally affected by these weapons.

(c) I have also suggested to Government that our officers should be armed with a smaller weapon than the Webley & Scott 450 Service Revolver. Experience has shown that this weapon is too bulky for general use, while some officers are rather apprehensive about using it. One result has been that many officers have provided themselves with weapons of smaller calibres, as indeed has been recommended to our Assistant Superintendents on joining the Service. The question is at present under consideration.

35. (a) The total number of officers and men punished departmentally Punishments. and judicially was 376 against 347 in 1935. The percentage of punishments to the actual strength of the Force was 2.09 during the year as against 1.93 in 1935. Of the total punishments inflicted, 354 were departmental and 22 judicial as against 330 and 17 respectively in the year before. In the Northern Range, the total number of punishments inflicted was 212 while in the Southern Range it was 164. The district of Sholapur recorded the highest percentage of punishments viz., 5.42 whilst Ratnagiri returned the lowest percentage, viz., .17. (b) Extra drill was awarded in 1,279 cases for minor breaches of discipline as against 1,079 in 1935. These punishments are not included in Statement E.

(b) The number of cases in which good work was recognised by rewards, Good Service Tickets, or special promotion was 9,301 as against 9,074 in 1935.

(c) The total sum spent in rewards in the Presidency during 1936-37 was Rs. 31,650 as against Rs. 34,959 in 1935-36.

37. (a) Out of the total strength of 658 officers and 17,329 men Education. (excluding officers of and above the rank of Deputy Superintendent of Police) the number of literate officers and men was 658 and 13,131 respectively against 653 and 12,932 in 1935. The percentage of literate officers and men to actual strength further rose from 75.50 in 1935 to 76.66 in the year under report. This increase of literacy in the Force is the natural result of the general progress of education throughout the Presidency. While we stillmaintain the Fourth Standard vernacular as the minimum for the Unarmed Branch, in practice we endeavour to take no recruit with less than the Sixth Standard : in many districts this is not impossible. In addition we endeavour to get recruits with three or four standards of English because with this additional education they are the more useful with the present general tendency of increase in English correspondence. I have had however to stop the recruitment of Matriculates and men of higher education in the Constabulary. Experience proved that the mental outfit of Matriculates was not satisfactory for Constabulary duties : such Matriculate recruits were often found not to be on the best of terms with the hard and rough work which falls often to the lot of a Constable.

(b) The primary schools established for the education of the children of the Policemen and run departmentally at Kaira, Godhra, Thana, Poona and Ratnagiri continued in their satisfactory working. These schools are appreciated and very well attended. In some places the question of enlargement has been raised owing to the increasing numbers of pupils. Any such enlargements must be governed mainly by financial considerations.

38. During the year under report there was a further drop of 19 in Resignations. 117 in 1935 to 98. The figures of resignations during the quinquennium were :---

39. (a) The number of vacancies declined from 300 in 1935 to 246 in vacancies and the year under report. The largest number of recruiting. vacancies was 27 in the Dharwar District followed by 24 in East Khandesh and 22 in Panch Mahals District.

(b) There were 861 enlistments during the year under report as against 971 in 1935. The number of casualties in the Force inclusive of deaths dropped from 887 in 1935 to 847 in the year under report. Of these, 502 or a percentage of 59.26 of the total casualties retired on pension or gratuity against 547 or a percentage of 61.66 in 1935.

(c) In accordance with the orders contained in Government Resolution, Home Department, No. L. C. 919, dated 11th April 1931, 24 men of the depressed classes were enlisted during the year under report.

(d) One is justified in stating that the present economic conditions are in no small measure responsible for the decrease in resignations (mentioned in the previous paragraph) as well as the steady supply of good recruits. The Police Service may have its drawbacks in the way of discipline and hard work, but it has also its definite advantages of steady employment and regular promotion. Superintendents have had it impressed on them to take recruits at as young an age as possible as this is all for the good of the Force. We want young recruits because

they are more easily trained and disciplined before acquiring lazy and other undesirable habits as the result of unemployment. We want recruits too whose primary desire is to join the Police, and not those who have hawked themselves round in many other places of employment, failure in all of which induces them to try the Police. Then the younger a recruit joins, the younger he is on promotion to Head Constable and also on completion of his pensionable service : we should not then have old and decrepit men in the Force who are fit only for pension but cannot retire owing to lack of sufficient service. For the Police at any rate I cannot accept the principle of differentiation in ages for various communities for enlistment. It stands to reason that if a youth of any community-advanced, intermediate or backward-aged 19-20 has not passed our minimum educational standard, then obviously he has not been gifted with sufficient brains and intelligence for the Police : on those grounds alone he is not worth recruiting. The above principles were put forward and approved by Government in the case of our Sub-Inspector recruits whose recruitment age. is now 19 to 22 instead of previously 22 to 25. This policy of younger recruitment will not perhaps have any immediate effects as one must allow a period of 15 to. 20 years before the realization of any practical results. One can however foresee in the future a younger and more alert Force with no more financial burden to Government, but with definite greater advantages to the Public in general.

40. (a) The health statistics for the year under report when compared with those for 1935 show that there was Health. improvement in thirteen districts and deterioration in the remaining nine districts. The increase of sickness was most marked in the Thana and Kanara districts, where the proportions of sick Policemen (admissions and readmissions to hospitals) to strength had risen from 154.23 and 305.16 in 1935 to 188.05 and 321.48 respectively in the year under report, whilst Kaira shows a marked decrease from 89.71 in 1935 to 18.37 in 1936, followed by Ratnagiri in which the percentage has dropped from 88.23 in 1935 to 23.02 in 1936. Belgaum also shows an improvement to 60.71 from 70.46 in the year before. Kanara continues to show the highest percentage of sickness viz., 321.48, followed by Sholapur (189.44), Thana (188.05), Kolaba (134.06), Dharwar (96.01) and G. I. P. and M. & S. M. Railways (78.48).

(b) While the weather prevailing at various seasons of the year may have some bearing on this incidence of sickness, one cannot overlook the very important fact that men cannot be expected to be fit unless provided with suitable and healthy quarters with such natural amenities as a good water supply. I shall be referring later to the question of Police quarters: I am here content to draw attention to the fact that the incidence of sickness in Thana has risen from 154 per cent. to 188 per cent. Thana has recently loomed rather large in connection with Police quarters. 35

41. (a) During the year under report, 53 persons escaped from custody, 13 from jails and lock-ups, 22 from Police Escapes and Recaptures. pared to the 38 escapes from Police custody in 1935, the decrease in the number of escapes from Police custody during the year under report is welcome. Of the 53 persons who escaped, 49 were recaptured and the remaining 4 were at large at the end of the year. There is very little doubt that most of such escapes are due to carelessness on the part of the Police : this fact is being more and more impressed on all ranks.

(b) In this connection it may be of interest to mention that orders were issued during the year reducing by half the arms carried by an escorting party : the Head Constable in charge and half the Constables carry no arms, while the rest of the Constables are armed. The basis for this order is simply that the security of prisoners is governed, by the manner and care in which the prisoners are handcuffed and roped : if this be done properly, the chances of escape are practically nil. Then there is the important legal issue regarding when and how arms may be used against escaping prisoners. A moment's consideration of this issue alone forces one to the conclusion that prevention of escapes by the use of handcuffs and ropes is much preferable to the use of the musket and ammunition on the occurrence of an escape. A few arms with an escort are necessary for moral effect as well as to cope with any organized rescues of prisoners or other accidents of a similar nature. Then in actual practice a musket is really a hinderance to the escorting Constable : if he has to tie or untie a rope or do anything requiring the use of his hands, he must divest himself of his weapon, so contravene an elementary rule that on duty a Constable should never part with his weapon. Experience may require modifications of the orders in minor details, but the principle appears to admit of no change.

42. A sum of Rs. 2,04,087 was spent during the financial year 1936-37 Supply. on the purchase of arms, accoutrements, clothing and other supplies for the Police in the Presidency as against Rs. 2,12,167 in the previous year, a decrease of Rs. 8,080.

43. During the year under report, out of a total of 272 shops licensed Inspection of shops dealing in (1) arms and Ammunition and (2) Explosives. during the year under report, 1,110 were inspected by Gazetted Police Officers.

44. (a) The total number of cases conducted by Police Prosecutors (exclusive of cases compounded, withdrawn or pending) was 3,889 against 3,559 in 1935, an increase of, 330 cases. Convictions were obtained in 3,269 cases as against 2,782 in the year before giving a percentage of 84.05 against 78.16 in 1935. The percentages of convictions during the quinquennium were :--

(b) Head Constables also conducted a larger number of cases than in 1935 viz., 7,511 against 7,419 in 1935 and secured convictions in 6,688 cases or 89.04 per cent. against 6,636 or 89.44 per cent. in the previous year. The highest percentage of conviction viz., 96.58 was secured by the Ahmednagar district, the lowest being only 78.43 in Bijapur.

(c) The necessity of additional prosecuting staff has been suggested in certain districts, but the question depends largely on funds being available.

(d) The percentage of convictions does not redound solely to the credit of Prosecutors, as much depends on the care with which a case has been investigated: Prosecutors and investigating officers must share alike the credit for the above results. In this connection Ahmednagar again retains its premier position with a conviction percentage of 92.85 followed by the B. B. & C. I. Railway 92.52, Kolaba 89.61, Panch Mahals 89.47, Poona 89.25 and Bombay Suburban District 87.50.

(e) I would here invite special attention to the large number of cases handled in Courts by Head Constables, approximately twice the number in which Prosecutors appeared. I cannot agree that this is satisfactory even allowing for a large percentage of such cases being under Minor Acts in which convictions are assured without much trouble.

(f) In connection with this subject of prosecuting work I would also invite attention to some remarks in paragraph 9 regarding the inadequacy of our Police Prosecuting Staff. These figures and remarks all go to support the proposals recently put forward by me for an increased number of Prosecutors. As this scheme is under consideration I need not again enlarge on it.

45. The reports of both the Range Deputy Inspectors General indicate

Drill. that a high standard of drill—in all its branches was maintained throughout with the exception of Kaira, Broach and Kanara Head Quarters where there is room for improvement. From my own inspections I would support the above remarks.

46. (a) Of the 371 men armed with · 303 rifles (including 47 Mounted

Musketry.

Police) all were put through the Musketry course : 367 completed all seven classification practices prescribed for competition shooting; of these 178

qualified as marksmen, as compared with the figures—371, 360 and 194  $\cdot$  respectively in 1935. The percentage of marksmen this year was 47.97 as against 52.29 in 1935. The results in Poona, Kaira and Ratnagiri improved slightly, while a slight falling off was noticed in the case of

other districts. It does not however appear that the smaller number of marksmen is the result of any inattention to their musketry instruction. Better results are not possible with the existing rather inaccurate weapon. The stock of low velocity ammunition has been exhausted and further supplies will not be available in future. The present rifle ( $\cdot$ 303) will have to be replaced or modifications effected for the use of high velocity ammunition.

(b) A Brevet Jamadar and a Constable of Ahmedabad District and a Head Constable of Sholapur District were the best shots in the Presidency each securing 143 points out of a maximum of 155 and won the prizes of Rs. 15 and a gold badge each.

(c) Of the 6,989 Armed Police with  $\cdot$ 410 muskets put through the Musketry course, 6,543 completed the full course and 3,860 qualified as marksmen, as against the figures 6,989, 6,624 and 4,016 respectively in 1935. The percentage of marksmen this year was 55.22 as against 57.46 in 1935. Though these results are not as good as those of the last year, the percentage is higher than that of 1934 and the results may, on the whole, be regarded as satisfactory, as weather conditions probably account for minor variations in many cases.

(d) A Brevet Jamadar of Ahmednagar district and two Head Constables—one each of Poona and Dharwar—were the best shots among the Armed Police, having scored 117 points out of a maximum of 120 and won prizes of Rs. 10 and a gold badge each.

(e) In the Presidency, of the 655 officers armed with revolvers, 590 completed the full course of practices, 161 qualifying as marksmen. The corresponding figures for the previous year were 653, 593 and 144 respectively. In the year under review, seven officers scored the maximum of 120 points and were awarded prizes of Rs. 20 each.

(f) The percentage of revolver marksmen rose from 22.05 in 1935 to 24.58 in the year under report, which is a satisfactory improvement, though the low percentage recorded from year to year is regrettable. I have recently recommended a smaller weapon for our officers as mentioned in paragraph 34 (c). These results rather go to support my case that we should have more marksmen and officers with more confidence in their weapons than we have at present with these large weapons.

47. $(a)$ During	the financial year 1936-37, the following allotments

A completion report in regard to the work at Sholapur is awaited. Regarding the work at Thana, while the Lines were under construction, I noticed several defects and inconveniences in the design and brought them to the notice of Government. As a result, Government have recently ordered revised plans and estimates to be prepared with a view to making these Lines more suitable for the housing of the Police. Further developments are awaited.

(b) The discretionary grant for "Minor Works" was Rs. 54,600 as against Rs. 44,460 in the year 1935-36. The discretionary grant for "Petty construction and Repairs" was Rs. 25,000 as against the same amount in the previous year.

(c) I had occasion recently to bring to the notice of Government the present very uneconomical arrangements for housing Police officers and men particularly in urban areas. We are paying rents as high as 50 per cent. and 75 per cent. of average pay. In view of the fact that such heavy charges fall on the Police Budget so give an exaggerated cost of the Police Force, I have to urge once more that more economical methods be adopted for housing our personnel, methods too that will make for much more contentment among all ranks: an officer on transfer from A to B will not have the trouble of house-hunting but can walk straight into the Government quarters.

(d) The question of type designs has been already unduly delayed. We cannot make any progress with several schemes for lack of such designs. As previously intimated I do not ask for luxurious quarters, but. I do urge that they should be reasonable as regards accommodation and completely dry during the worst monsoon months. I hope next year to be able to report some further progress in the housing of our Force.

(e) I need not detail here the places where buildings of various kinds are urgently required as such details are already with Government. Suffice it to mention that primary consideration should be given to our urban areas.

48. (a) Special assistance was rendered by the Village Police in 452 Village Police. cases during the year as against 353 in 1935. 381 village Police Police Police Police Police Police Police Police Police and Good Service Tickets and the remainder by money to the extent of Rs. 2,046. On the other hand 424 Village Police were reported for neglect of duty of whom 409 were punished departmentally as against 447 and 422 respectively in 1935. 67 Village Police concerned in the commission of cognizable crime were prosecuted and 27 of them were convicted.

(b) With effect from the 1st April 1936, the scheme of serving Magisterial summonses and Police orders in criminal cases through the agency of the Village Police has been introduced in certain districts. Under this system the Village Police are remunerated at Annas 4 for each summons or order served. This system may have its advantages, but it deprives the regular Police of greater movement among the villages : • when a Constable was sent out to serve summonses or notices, he had the opportunity also of visiting villages to enquire about crime or other conditions. 49. (a) The School, as usual, re-opened after the December vacation on the 4th January 1936. Mr. H. G. Lang, O.B.E.,

the who was the Principal of the School from the **Central Police Training** beginning of the year unfortunately died very suddenly on the 17th June 1936. By his death the

Service lost an able and experienced officer. The charge of the Principal's office was held temporarily by Mr. P. M. Stewart, from the 18th June 1936 to the 24th September 1936 and afterwards from 25th September 1936 by Mr. C. H. de V. Moss who continued in that office till the end of the year.

(b) During the year the following Probationary Assistant Superintendents of Police joined the School on the dates shown against them :--

(1) Mr. B. R. E. LaBouchardiere	22nd January 1936.
(2) Mr. H. S. McGuigan	24th November 1936.
(3) Mr. W. G. Lang	24th November 1936.

Mr. Mahbub Hussain Sayad who joined the School on the 1st December 1935 as a directly appointed Deputy Superintendent of Police for Sind was discharged on the 16th June 1936.

(c) No direct recruit for the Provincial Police Service was admitted to the School during the year.

(d) Twenty-two students were admitted to the School for the Sub-Inspector's Course in January 1936 and 32 for the course in July 1936.

(e) In the final examination at the end of May, 24 out of 26 students passed successfully (14 with honours). All 21 students who appeared at the final examination in November passed successfully (8 with honours).

(f) A special feature of this year was the inauguration of a course for Head Constables which was commenced in January. Fifty Head Constables were admitted, of whom 49 passed successfully in the final examination at the end of a five months' course in May, the remaining student having been invalided during the term. Fifty Head Constables were admitted to the next course in July of whom 47 passed out successfully.

(g) A further experiment was inaugurated in connection with this Head Constables' Course by sending recruits in our Sergeant's cadre to be put through this course. Hitherto our Sergeant recruits received no training at all : they picked up their work in the rough and ready school of experience. They now receive practical training in Law and Procedure as well as on the parade ground so should be better able to perform their duties.

(h) The general health of the School was good throughout the year, except for some persistent malaria cases during the second term.

(i) The discipline and general conduct of the students throughout the year were satisfactory.

(j) I visited and inspected the School at the end of each of the two terms of the year and distributed prizes to the successful students on each occasion.

50. (1) The Session of the Indian National Congress.—The 50th Session of the Indian National Congress was held in Incidents of Note. December 1936 at Faizpur in East Khandesh District, the last Session held in this Presidency being at Belgaum in December 1924. Several other conferences such as the All India Socialist Party Conference, Kisan Conference, Village Industries Exhibition, etc., were also held at Faizpur. The people assembled numbered about a lakh and a half. A great strain was thrown on the Police of the District to assist whom Police from other districts had to be sent. The Police arrangements proved very satisfactory, and fortunately there was no contretemps like the outbreak of some epidemics.

(2) Hindu-Muslim Riot, Poona City.-A few years ago there was a certain amount of friction over the playing of music before the Sonya Maruti Temple, situated near a Masjid known as the Tamboli Masjid in Raviwar Peth, Poona City. This year the District Magistrate, Poona, gave permission for soft music to be played only on 24th April 1936 between 8 a.m. and 12 noon and from 9-30 p.m. onwards. This was resented by the Muhammadans and at 9-15 a.m. when music was being played, a fracas took place near the Temple. The situation became worse in the afternoon and pitched battles occurred between the two communi-Temples and Muslim shrines were desecrated, murderous assaults ties. with knives, and cases of arson were frequent. In view of the paucity of Police available, and as the situation was definitely serious, Military assistance was requisitioned. Detachments of troops were posted at strategic points. As a result order was quickly restored and though an atmosphere of tension prevailed for some days longer, no further rioting occurred. Additional Police were drafted to Poona from outside districts and remained there for some days. The casualties were 3 killed, 151 injured. Eleven cases arising out of this riot were registered of which 7 ended in conviction, 2 in acquittal and 2 were classed "A"; out of the 112 accused sent up for trial, 90 were convicted and the rest were acquitted.

(3) Labour Strikes.—Strikes in mills and factories occurred at several places in the Presidency, but only the following were of any importance and lasted for considerable periods :—

(a) The Gendalal Mill strike at Jalgaon, East Khandesh District-

The strike was at first engineered by some jobbers in order to satisfy private grudges against some of their colleagues, but later it developed into one for higher wages. This was taken advantage of by some Communists who preached their doctrine of "Down with Capitalism and Imperialism". The strike put a great strain on the Police especially in its latter stage when the strikers resorted to petty acts of violence in out of the way places in the city limits on the loyal workers and the petty officials of the mills.

#### (b) Strike in the Western India Match Factory at Ambernath, District Thana.

The strikers were incited to acts of violence by extremist agitators and other mischief mongers. An armed Police Force had to be posted at Ambernath under a Sub-Inspector and action with a heavy hand had to be taken against the agitators, e.g., instituting security proceedings, banning meetings, processions, etc. This resulted in the strike being called off and the unconditional resumption of duties by the strikers, at the end of November 1936.

#### (c) Strike in Gokak Mills, Gokak, District Belgaum.

A short strike commenced on the 9th July 1936 owing to disagreement between the Management and the workers regarding various matters but it ended on the 24th July 1936, when the strikers arrived at an amicable settlement and returned to work. A Union was formed afterwards under the influence of outside agitators. After the formation of the Union, the internal working of the Mills began to suffer and the Manager was assaulted in the open street in the beginning of December 1936 by a few workers. The Manager therefore closed the Mills for a week : when it was again opened, all the workers refused to return to work and have since then continued on strike. At the time of compiling this' report, the strike has nominally ended by the publication of the Labour Commissioner's arbitration award, but several important steps have yet to be taken to implement the award so as to settle down the situation generally. Some 35 Armed Police from Belgaum have been continuously on duty at Gokak to guard the Mills. Several outside agitators have taken a hand in fomenting the strike. The situation has remained quiet. Picketting in various forms is continuing. No further trouble has occurred so far.

(4) Deputation of District Police to Bombay in connection with the communal riots in Bombay City.—During the period from October to December 1936, large reinforcements of Armed Police as well as Sergeants had to be sent to Bombay from several districts in the Presidency in order to help the Bombay City Police to maintain Law and Order. All

these Police officers and men were on duty for an extended period, under very trying circumstances. Their work received the appreciation of the Commissioner of Police and of Government.

(5) Journeys of Their Excellencies the Viceroy and the Countess of Willingdon.—On their journeys from Calcutta to Rajkot via Baroda and from Rajkot to Bhawnagar and Palitana to Palanpur, Their Excellencies the Viceroy and the Countess of Willingdon passed through this Presidency over the B. B. & C. I. Railway line on the 5th and 6th January 1936 and 14th to 17th January 1936. The outgoing and incoming Viceroys passed through this Presidency over the B. B. and C. I. Railway line on the 15th and 16th April 1936. The usual Police arrangements were made on the above occasions.

51. Administrative and other changes effected during the year Administrative changes. were :--

(1) Abolition of the Outpost at Sopara in Thana District.

(2) Opening of the following four Outposts :---

- (a) At Gholwad in Thana District.
- (b) At Agashi in Thana District.
- (c) At Waghera in Nasik District.

(d) At Belapur Road Station in Ahmednagar District.

(3) Transfer of the Head Quarters of the Sub-Divisional Inspector from Jambusar to Broach and extension of his jurisdiction to the whole district with the exception of Broach Town and Head Quarters.

(4) Reorganization of the Intelligence Branch in the Criminal Investigation Department.

(5) Opening of a class at the Police Training School, Nasik, for the training of Sergeants and Head Constables.

(6) Introduction of the Motor Vehicles Tax Act, 1935.

(7) Introduction of a system of serving summonses in criminal cases through the agency of the Village Police, instead of the District Police in certain districts.

(8) Substitution of the post of a Police Prosecutor in the Bombay Suburban District by a similar appointment on a non-pensionable basis.

(9) Transfer of the appointment of a Deputy Superintendent of Police from Satara to Poona District as a Home Deputy Superintendent of Police.

(10) Transfer of the control over a portion of 27 miles of His Exalted Highness the Nizam's State Railway between Manmad and Hyderabad to the Superintendent of Police, G. I. P. and M. & S. M. Railways.

(11) Addition of 26.62 Railway Miles to the B. B. and C. I. Railway, Police jurisdiction on account of the Wasad Kathana Railway.

(12) Transfer of 8<sup>3</sup>/<sub>4</sub> Railway miles from the B. B. and C. I. Railway Police jurisdiction to the Rewa Kantha Agency Police.

52. (a) During the year under report, pecuniary assistance amounting to Rs. 2,817 was afforded to 46 families Miscellaneous. of deceased members of the Constabulary from the "Widows Fund for the Constabulary" as against Rs. 4,058 to 53 families in the previous year.

(b) 493 officers and men and three clerks joined the General Provident Fund, and 309 officers and men took out Post Office Life Insurance Policies. 585 Policemen were sued for indebtedness in Civil Courts as against 563 in 1935.

(c) In connection with my remarks last year about the rank and file being compelled to join the General Provident Fund or some Life Insurance Society, I have submitted a recommendation to this effect to Government: the question is still under consideration. That the men should be compelled to make provision for their dependants is forcibly brought to notice by the frequent cases which occur of assistance being demanded as the deceased had made no provision at all.

(d) We have in several districts Co-operative Societies which I regret to say only aggravate the impecunious conditions of the men and certainly do not encourage thrift. In most districts these Societies are little better than money-lending affairs, where men can readily obtain money without necessarily being in serious need thereof. While the administration of these Societies has had to be tightened up, I am by no means convinced that they are really necessary and they are certainly not worth the labour and trouble expended on their management. Their closing down would save us a lot of trouble while the thrifty members of the Force would lose nothing. These Societies at present militate against any benefits which the men may or should receive from the Provident Fund or Insurance schemes.

(e) For many years past there have been complaints that sufficient funds were not available in the districts to supply adequate facilities for sports and recreation for all ranks. We had Sports' Funds which were dependent mainly on voluntary and uncertain contributions: some districts were better off than others. I have recently inaugurated in each district a Sports Fund to which all ranks contribute on a very modest scale, viz.:—

The amount collected in each district depends naturally on the sanctioned strength, but it has been calculated that the sums thus raised will provide sufficient money to run modest District Sports as well as provide facilities for various games for the men and their children not only in District Head Quarters but also it is hoped in several Taluka Towns. The scheme has been actually inaugurated from the commencement of 1937, so its success or difficulties cannot yet be gauged : but reports indicate that so far the scheme has been welcomed as a move in the right direction. This scheme is but a measure in consonance with Government's own uplift policy. I am hoping it will be a veritable success for the general benefit of the men and their children.

53. (a) In considering the various needs of the Department, one has to be not unreasonable bearing in mind the strain needs of the in recent years on the finances of Government. In this connection some changes have been made in our internal organization to deal with new conditions of work without any additional cost to Government, but there are other measures which definitely require additional expenditure.

(b) The first and foremost of our needs is the proper housing of the Force generally. I have for some time been bringing this question to the notice of Government and have had occasion to refer to our present rather uneconomic arrangements in several districts. For several years we have been able to make practically no progress for lack of type designs of various quarters: this question is now, I understand, receiving attention.

(c) In connection with the heavy development of motor traffic, the District Police are gradually being overburdened with this work with the result that normal work is suffering or else there is inadequate control over this motor traffic. This question has also been the subject of more than one reference to Government. It is unnecessary to enlarge on it here again, but the sooner the Police are relieved of this work the better it will be for their more normal duties.

(d) Proposals were made some years ago for the division of Ahmedabad and Poona Districts into two charges. Nothing has yet materialised though both places are expanding in several directions. At the moment I have on hand a modified scheme for Ahmedabad which may be submitted in due course to Government.

(e) The opening of regular schools at each District Head Quarters for the training of the Constabulary merits very early consideration. With the recruitment of a better personnel it is but meet to impart better training so raise in the process of time the general tone and efficiency of the Force. A scheme in this connection has already been submitted with others to Government.

(f) The ever increasing work in Superintendents' offices mainly in connection with motor traffic work has necessitated the employment of educated Constables to do clerical work. This is rather a retrograde step as the executive Branch can ill afford these men. It is at the same time impossible to formulate any proposals for an increase till we know what is to be the future administrative machinery of all Transport and Motor Vehicles work.

(g) The establishment of a Detective School at Nasik has been under consideration for some years, but it must await the advent of better financial times as the measures enumerated above merit prior consideration.

54. (a) The year has been normal throughout : we have been spared salient Features. the anxieties resulting from serious political movements or industrial strife. We have however had comparatively minor instances of both as mentioned in paragraph 50. The failure of the monsoon in several districts perhaps caused more apprehension than anything else, but the late rains eased the situation a little in some districts.

(b) As regards crime generally, it has been already mentioned that cognizable crime reported during 1936 tallied with the figures of 1935, being thus lower than in previous years. There was a decrease in serious crime as also in the number of cases pending with the Police. Whatever effect economic conditions may have on our crime figures, I feel that the control and restraint which can be exercised by the Criminal Tribes Act are factors not to be ignored. During the last few years the working of this Act has received considerable scrutiny and revision. In some instances we have radically changed our methods in dealing with various Tribes : the yoke has been sometimes completely removed, while in other cases it has been considerably eased. The co-operation and better understanding between the Police and the Backward Class Officer's staff have also produced mutually beneficial results.

55. (a) During the year under report there were six casualties in the Imperial Service : Mr. E. E. Turner, C.S.I., died Concluding Remarks. while on leave preparatory to pension while Mr. H. G. Lang, O.B.E., died very suddenly in Nasik : Messrs. M. T. O'Gorman, O.B.E., J. L. Collins, Khan Bahadur Zia-ud-din Ahmed and Khan Bahadur Zamanshah Mahbubshah retired from the Service. In the Provincial Service there was but one casualty when Mr. M. V. Nabar retired on 14th April.<sup>6</sup>

(b) We had three recruits appointed to the Imperial Service, and no direct recruit to the Provincial Service.

"It is a matter of gratification that the Police Administration of this Division during the year under review was carried out most efficiently and crime was kept under control in spite of the circumstances arising out of the scarcity of rains in parts of Gujarath "—is the summing up of the Commissioner, Northern Division : the Commissioners of the other two Divisions have expressed similar opinions. I concur with the Commissioners that Police efficiency has been fully maintained throughout the year.




