





REPORT ON THE ADMINISTRATION OF CRIMINAL JUSTICE IN THE PRESIDENCY OF BOMBAY FOR THE YEAR 1887.

This report relates to the administration of justice by the Criminal Courts in the Regulation Provinces of the Presidency and in the Province of Sind, as well as the Courts of the Presidency Magistrates, and represents the work done by those Courts.

2. The area and population of the abovementioned provinces are as follows, according to the census of 1881:--

4. The Judges mentioned above are all paid. During the year under report there were 62 Honorary Magistrates in the Presidency proper, but none in Sind.

5. Of the Judges of the High Court 6 were Europeans, and one a Native. Of the Sessions Judges, Joint Sessions Judges and Assistant Sessions Judges, including those in Sind, all were Europeans except 4 who were Natives. Eightysix of the First Class Magistrates were Europeans and 91 Natives. Of the Second and Third Class Magistrates all were Natives except 4 and 5 respectively.

6. The total number of offences reported during the year was 133,299, of which 110,325 were returned as true. The corresponding numbers for the preceding year were 138,208 and 116,170 respectively. The proportion of offences returned as true has thus fallen from 84.2 to 85.1 per cent.

7. The following table shows the classification of offences returned as true according to the headings given in Statement No. 2, for the year 1557 as compared with those for the previous two years :—

8. There are not such large variations as compared with the preceding year as were exhibited by the figures for 1886. Cases under Chapter XIV of the Indian Penal Code have diminished in number from 1,079 to 955, cases of

criminal breach of trust from 799 to 689, cases of criminal intimidation &c. from 4,263 to 3,962, and offences under special and local laws from 61,900 to 54,323. The most marked increase is noticeable in the case of hurt (1,949), criminal force and assault (512), and receiving stolen property (95). There were no offences against the State.

9. Of the 311 offences affecting human life, 170 were murders as compared with 166 in 1886. The following table shows the classification of such offences with regard to the motives for which they were committed as compared with the preceding year:---

18. The proportion of acquittals is highest in the cases of hurt, criminal force, rape &c., extortion, cheating, mischief, offences relating to marriage, defamation, criminal intimidation, &c. The number of convictions ranges highest in the cases of offences relating to the public health, safety and convenience & c., and offences under special and local laws. The remarks made in previous reports with regard to the variation of the ratio in different classes of offences hold good as applied to the results of the year under report and need not be repeated here.

19. During the year under report 743 cases involving 762 European British subjects were brought to trial, of which one case involving 1 person remained undisposed of at the end of the year. The offences were principally hurt, criminal force and assault, and offences under special and local laws, the number of cases under the last-named heading being 620 or 83.45 per cent. of the whole number. Of the 762 persons tried 652 were convicted and 107 acquitted and discharged, the ratio of the number acquitted and discharged to the number convicted being 14.86 as compared with 13.87 in 1886.

20. The number of miscellaneous cases before the Criminal Courts during the year under report was 1,585, involving 2,033 persons of whom 3 remained "under trial at the close of the year. Of these, 920 persons were discharged and 1,110 convicted. In the year 1886 there were 1,907 cases in which 2,411 persons were involved, the number of discharges and convictions being respectively 768 and 1,436. These cases comprise proceedings under Chapter VIII of the Criminal Procedure Code for taking security for keeping the peace, and for good behaviour, as also proceedings for the forfeiture of bail or recognizance, maintenance and local nuisance cases, and orders with regard to frivolous or vexatious complaints under Section 250 of the Criminal Procedure Code.

21. Of the 1,74,122 persons who were brought to trial during the year 3,615 were placed before village officers, 3,320 before Special Magistrates, 7,246 before Honorary Magistrates sitting singly, 1,25,908 before Stipendiary Magistrates other than District and Sub-divisional Magistrates, and 1,037 before Benches of Magistrates. There were 308 referred to District and Divisional Magistrates under sections 347 and 349 of the Criminal Procedure Code, and 32,789 came before the District and Divisional Magistrates directly. There were 1,294 under trial in the Courts of Session and 75 before the High Court and the Sadar Court in Sind. As persons committed or referred are reckoned twice over, it follows that the total of the several details given above, viz. 1,75,592, does not tally with the total number of persons actually brought to trial before the various Courts.

22. The High Court during the year disposed of 32 cases, in which 41 persons were involved. Of these 29 were convicted and 12 acquitted. The number of persons tried in 1886 in 39 cases was 46, of whom 12 were acquitted and 34 convicted.

23. On the Appellate Side of the High Court 14 cases involving 17 persons were received for confirmation of sentence of death, and 5 cases involving 7 persons were referred to the High Court by Sessions Judges under Section 307, Criminal Procedure Code. Of these, 4 persons were acquitted and 17 were convicted, the sentence of death being comfirmed in the case of 6 persons; and 3 cases involving 3 persons remained pending at the end of the year.

24. The Sadar Court in Sind as a Court of reference disposed of 10 cases, involving 10 persons, referred to it for confirmation of sentence of death. In 7 cases the sentence was confirmed, in 1 it was commuted to transportation, and in 2 cases reversed.

25. In the Courts of Session 1,271 persons (exclusive of the 23 whose cases were referred to the High Court and the Sadar Court in Sind) were under trial during the year, as compared with 1,399 in 1886. Of that number 2 escaped, 606 were acquitted, 584 convicted, and 79 remained under trial at the end of the year. The ratio of acquittals to convictions is 51.49 as compared with 48.54 in 1886.

26. Exclusive of 1,447 whose cases were committed or referred to superior Courts, the Magistrates of the various classes had before them during the years the numbers shown in the following table which also gives the numbers for the preceding two years :—

The ratio of the number of persons acquitted and discharged to that of those convicted was 56.21 as against 51.92 in 1886.

27. The police patils had before them 3,615 persons against 3,825 in 1886. In the year under report 1,460 persons were acquitted and discharged and 2,154 were convicted, one person remaining under trial at the end of the year.

28. The duration of trials before Special, Stipendiary and District and Divisional Magistrates as well as before the Courts of Session and the High Court, and Sadar Court in Sind respectively is shown in the following table:—

There is an improvement noticeable with regard to all the Courts named above except the Sadar Court in Sind.

29. The total number of witnesses examined by all the Criminal Courts was 4,02,447 as compared with 3,52,668 in 1886. Of these 4,240 were examined before police pátils; 3,92,139 before Magistrates; 5,866 before Courts of Session, and 202 before the High Court and Sadar Court in Sind. The Magistrates' Courts are thus responsible for the increase in the number of witnesses examined as compared with the preceding year.

30. The High Court on its Original Side passed one sentence of death. On its Appellate Side the High Court confirmed six sentences of death and the Sadar Court in Sind confirmed seven sentences of death. In 1886 there were 23 sentences of death confirmed, 22 by the High Court and 6 by the Sadar Court in Sind, no sentence of death being passed by the High Court on its Original Side.

31. In the year under report 158 persons were sentenced to transportation as against 188 in 1886.

32. No sentence of penal servitude was passed.

33. There were 14,410 persons sentenced to imprisonment, as compared with 15,496 in 1886.

34. No sentence of forfeiture of property was passed in 1887 as in the preceding three years.

35. There were 57,434 persons sentenced to fine as compared with 63,623 in 1886. The aggregate amount of fines imposed and realized and the total amount paid as compensation in the years 1886 and 1887 respectively are shown in the following table :---

36. 556 persons were sentenced to be whipped during the year under report as against 573 in 1886.

37. Of the sentences of whipping referred to in the last paragraph, 371 were passed under Sections 2 and 3 of Act VI of 1864 in lieu of other punishments, 50 under Sections 3 and 4 in addition to other punishments, and 135 on juvenile offenders under Section 5 of the Act for offences not punishable with whipping under Sections 2, 3 and 4.

The total number of appellants and applicants for, revision before the Courts during the year (exclusive of 168 persons whose cases were referred for revision to the High Court) was 6,757, and 59 applications involving 191 accused persons were made by complainants for revision. Of these persons one died; 1,634 had their appeals or applications rejected; 2,915 had their sentences confirmed and 46 had their sentences enhanced; the sentences of 521 were reduced or otherwise modified and of 1,365 reversed; in the case of 52 persons the proceedings were quashed and in the case of 175 a new trial or further enquiry was ordered and the cases of 239 persons remained undisposed of at the end of the year.

41. As a Court of Appeal the High Court had to deal with appeals of 249 persons from convictions by the Courts of Session. In 122 cases the appeal was summarily rejected, in 57 the sentence was confirmed, in 18 modified and in 23 reversed, new trials being ordered in the cases of 3 persons. The appeals of 26 persons were pending at the end of the year. No appellant died or escaped. In 1886 there were appeals of 416 persons before the High Court. 59. The results of the administration of criminal justice during the year under report as compared with the preceding year may thus be summarised:

There was a decrease of 4,909 in the number of cases reported and of 5,345 in the number of cases returned as true. The number of cases brought to trial during 1886 exceeded the number for the year under report by 5,312 and involved 1,303 more persons. There was a considerable increase in the number of cases of hurt and a decrease of upwards of 6,500 in the number of offences under special and local laws. There was no very appreciable variation in the number of effences of other classes.

60. The ratio of discharges and acquittals to convictions has risen from $51^{\circ}57$ to $55^{\circ}82$ since the preceding year. The number of appellants during the year under report was 6,925 as compared with 6,658 in 1886. The largest number of appeals to the High Court came from the Ahmedabad District which includes the Collectorates of Kaira and Panch Maháls. 970 cases were reviewed by the inferior Courts, but in 80.41 per cent, of those cases they did not interfere. The number of reviews by the High Court has increased by 36, and the number of reviews by the Sadar Court in Sind has also increased by 33. On the whole the working of the Criminal Courts during the year under report has been satisfactory and calls for no special remark.

61. Dr. Pollen's remarks on the working of the system of trial by jury in the Belgaum District have already been communicated to Government under my letter No. 1188 of the 6th July 1888.

62. Mr. Hammick is of opinion that the tendency of juries is too often to acquit. He further notices that in all the jury cases (29 in number) tried by him since he went to Surat, the verdict has been unanimous. From this he infers that there is little or no independence of opinion among the jurors. He observes that in cases in which the Judge was not disposed to agree with the verdict of the jury, he would be much strengthened in case he determined to refer to the High Court by the knowledge that a substantial minority shared his opinion. He considers that to remedy this defect it would be preferable that instead of allowing the jury to retire to consider their verdict each juror should be asked his opinion separately in open Court.

63. To adopt these proposals would be to strike at the root of the trial by jury altogether. If the jurors are not allowed an opportunity of retiring and discussing the evidence together and of returning a common verdict, there is no reason why more weight should be attached to their verdict, than to the opinions of individual assessors in a case tried with the aid of assessors. There would in fact be only an assemblage of jurors, but no jury. Considerable alterations in the Code of Criminal Procedure would also be necessary and the proposed change in the system would not be likely to meet with approval unless at least a very much stronger case were made out for its necessity or expediency.

The subject of this report is the administration of justice by all the Civil Courts in the Bombay Presidency, including the Province of Sind, with the exception of the Courts at Aden. The Court of Small Causes at Bombay was included for the first time in 1886. From Aden and Zanzibar no information is received by the High Court regarding the constitution or working of the Courts.

2. The territories to which the report relates are the Regulation Provinces within the original or appellate jurisdiction of the High Court, and the Province of Sind. A map of the Presidency is annexed in which the position of the Courts of the several Subordinate Judges is marked with a single red line, a double line being used to indicate the head-quarter stations at which are located the Courts of District Judges or of Assistant Judges exercising the powers of a District Judge.

P. at Broach, and 6 Assistant Judges. The average number of Assistant Judges working during the year was however only 4.

8. The number of Jághirdárs and Inámdárs exercising the powers of Subordinate Judges of the Second Class under Regulation XIII of 1830 was 5. The decrease of 1 since last year is due to the death in August 1887 of the Jághirdár of Jávli. The Cantonment Magistrates of Poona, Belgaum and Ahmednagar are entered in the returns as having performed the functions of Civil Courts under Act III of 1859. The Mámlatdárs of the various tálukas, 184 in all (including Mahálkaris), disposed of possessory suits under Bombay Act III of 1876.

9. At the close of the year there were 90 Village Munsiffs and 228 Conciliators appointed under the Deccan Agriculturists' Relief Act as against 95 of the former and 236 of the latter at the close of 1886.

10. In Sind the constitution of the Civil Courts was the same as in the preceding year.

11. The following statement shows the numbers and designations of the regular Civil Courts which come within the scope of this report. The Courts of Cantonment Magistrates and Mámlatdárs are not included, as the discharge by them of the civil functions referred to above in paragraph 8, occupies only a small portion of their time.

8. The number of Jághirdárs and Inámdárs exercising the powers of Subordinate Judges of the Second Class under Regulation XIII of 1830 was 5. The decrease of 1 since last year is due to the death in August 1887 of the Jághirdár of Jávli. The Cantonment Magistrates of Poona, Belgaum and Ahmednagar are entered in the returns as having performed the functions of Civil Courts under Act III of 1859. The Mámlatdárs of the various tálukas, 184 in all (including Mahálkaris), disposed of possessory suits under Bombay Act III of 1876.

9. At the close of the year there were 90 Village Munsiffs and 228 Conciliators appointed under the Deccan Agriculturists' Relief Act as against 95 of the former and 236 of the latter at the close of 1886.

10. In Sind the constitution of the Civil Courts was the same as in the preceding year.

43. There is a considerable increase in the number of second appeals in Sind. The number of appeals instituted in the Mofussil (including Sind) has increased by 150. The greatest increase is seen in the districts of Khándesh, Násik and Sholápur-Bijápur, the most marked decrease being in Poona.

45. In the High Court there were 67 appeals from decrees of Judges sitting on the Original Side, and eight references from the Bombay Court of Small Causes. Of these 9 appeals were dismissed, in 18 cases the decrees were confirmed, in 5 modified and in 11 reversed. There were 32 such appeals and references pending at the close of the year.

The number of such appeals disposed of in 1886 was 198.

52. The High Court on its Appellate Side also disposed of 202 applications under its extraordinary jurisdiction, 34 references under Section 617 of the Civil Civil Procedure Code, 9 references under the Stamp Act I of 1879, 3 for transfer of suits to other Courts and 2 for confirmation of decrees for dissolution of marriage. The numbers of such cases left pending at the end of the year were respectively 50 and 15.

Execution of Decrees.

53. The total number of applications for execution of decrees before all the Civil Courts during the year was 296,915 as against 286,134 in the preceding year. These applications were dealt with as follows :—

In 37,983 cases satisfaction was obtained in full;

, 50,209 ditto ditto in part ;

151,666 applications were wholly infructuous;

573 applications were transferred to other provinces for disposal;

54,195 applications were pending at the close of the year.

54. Judgment-debtors were arrested without being imprisoned in 3,902 cases, and were actually imprisoned in 3,326 cases. In the preceding year the corresponding figures were 4,292 and 3,250 respectively.

55. The total amount recovered by all the Courts in execution proceedings was Rs. 45,65,023, as compared with Rs. 38,06,106 in 1886.

56. The number of applications under Chapter XX of the Civil Procedure Code was 622 in the mofussil, as compared with 561 in the preceding year. The number of such applications made in the four districts subject to the operation of the Dekkhan Agriculturists' Relief Act was 99, as compared with 100 in 1886.

57. In the Insolvency Court in Bombay constituted under 11 and 12 Vic. cap. XXI, there were 698 applications received, as compared with 619 in 1886.

58. The number of civil cases tried with the aid of assessors was 15, all under the Land Acquisition Act (X of 1870). There were 4 cases disposed of in the District Pársi Matrimonial Court, and 2 in the Chief Pársi Matrimonial Court.

59. A tabular statement is appended to this report, showing the amount of work done during the year in the several Courts in each district subordinate to the High Court.

60. In this Presidency the records of suits disposed of by Subordinate Judges are deposited in the District Courts. This system provides a safeguard against their being tampered with, and the rules framed by the High Court in June 1882 are sufficient to secure parties against unnecessary expense or delay in obtaining copies of documents recorded. The records are reported by the District Judges generally to be in good order though in some places more accommodation is required in the record-rooms. The destruction of old records in accordance with the rules framed by the High Court is carried on from year to year.

61. During the year under report 6 District Judges and 1 Assistant Judge inspected 17 of the Courts subordinate to them. The general results of these inspections, as reported to the High Court, were satisfactory. Such of the work of the Subordinate Judges as came before the High Court in the hearing of civil appeals has satisfied it as to the intelligence, industry and ability of those officers as a class. In many of the subordinate Courts the work is exceedingly heavy, and cannot be kept in hand by a single Judge, work as hard as he will.

62. The District Judge of Ratnágiri calls attention to the continual growth of arrears of original civil suits in most of the Courts of that district as a matter of serious moment. The aggregate increase during the year under report was 83.

63. He also points out that the increase of the arrears of civil appeals in the District Court was due to the fact that an Assistant Judge was stationed there for only 41 months during the year.

64. The District Judge of Belgaum calls attention to the inequality of the amount of work falling to the several Subordinate Judges in his district. A proposal for remedying this by a revision of the territorial jurisdictions of the

Chikodi and Athni Courts has lately been sanctioned by Government in its Resolution in the Judicial Department, No. 5530 of 8th October 1888.

65. The decrease in the number of suits disposed of by the Courts in the Poona District (5,048, as compared with 6,288 in 1886) is attributed to the fact that one Subordinate Judge has been removed from the district since May 1887.

66. The increase (1,767) in the number of original civil suits filed in the Ahmedabad District is attributed by the Acting District Judge to a favourable harvest, which encouraged creditors to resort to the Courts for the recovery of debts due to them.

67. The results of the administration of civil justice in the Presidency are briefly as follows :---

There were 4,141 more suits filed during the year than in 1886. The number of suits disposed of by all the Courts during the year has increased by 8,258, resulting in a diminution of the arrears by 448. The number of appeals disposed of was 5,043 against 4,765 in 1886, showing an increase of 278. The arrears of appeals in all Courts have increased by 261.

SIR,

I have the honour herewith to forward the report and annual statements as to civil and criminal justice in this Province for the year 1887. Mr. l'arsons in last year's report stated that delay was occasioned by the fact that several returns had to be amended or in part to be prepared afresh to comply with the instructions contained in Government Resolution No. 2852 of the 16th May 1887. Notwithstanding the instructions already issued delay has been occasioned this year by the discovery that some statements had been very incorrectly drawn up, which had to be returned for correction. I regret that in the returns now forwarded there are still apparently a few mistakes, but the delay in correcting these would be so great that I prefer to send them on as they are. I may add that the last returns, as corrected, have only been received by me since the end of August, so that it was impossible sooner to prepare the consolidated returns.

Bombay.

2. In a former report I referred to the difficulty of securing the correctness of these returns. A revising officer drawing up returns procured from several districts or sub-divisions may of necessity be ignorant of various errors to be discovered only (if at all) on examining the original reports, of each subordinate officer. Even in an original report, errors of different kinds may neutralize each other, and again totals in a report for a whole district may conceal errors which exist in the subordinate reports from which it is prepared. The number of figures dealt with also tends to confusion, for it is very wearisome to the eye correctly to follow large numbers of figures in different columns, so as to ensure correctness. I trust the general principles on which the statements are to be filled up are now usually understood by the heads of the respective offices, and I have found great care taken in correcting some errors pointed ont. But there is too much reason to believe that due care is not always taken to see that clerks &c., entrusted with the preparation of the returns, always thoroughly understand the principles on which they are to be drawn up.

3. Apart from this while the instructions issued from time to time remove difficulties and ensure more uniformity, this makes it impossible to compare with any accuracy some of the returns for different years. For instance, Statement No. 2 was misunderstood for a while and what are called "undetected offences" were freely entered in it, which has now been forbidden, but notwithstanding this I' found some undetected offences entered in this year's returns. Again, a person tried at one time for several offences connected with each other was often entered separately for each offence and appeared two or three times in the return, which is against the rules. I could clearly trace this error as to some offences

and could get it corected, but it is impossible for an officer dealing with totals to say that such errors do not exist. A return may, at first sight, appear incorrect which is really correct. In number 2, for instance, in some columns offences are recorded which are not brought to trial in the year under report, while on the other hand the results are shown of trials for offences 'reported' in a previous This makes a return which may be correct appear incorrect, and a person year. who did not bear this in mind would at once proceed to add figures so as to make the return appear correct. I mention this because at least one return which is really correct seems incorrect owing to this fact, while I fear others might be found incorrect from its not being borne in mind, if the details could all be gone Again, one return shows all the cases finally decided, while another shows into. those disposed of, so far as each Court was concerned, which had to deal with it at any stage. This leads to apparent discrepancies and officers not bearing this in mind sent in incorrect statements which had to be returned for correction. Statement No. 6 as to revisional work in Criminal Courts contains a great stumbling. block. The column headed "Total number of applicants for revision" excludes all cases taken up on a complainant's petition, though he may well be called an applicant, but includes the cases of persons who have never applied, but on account of whom a superior Court itself sends for the papers on learning of the All these have to be accounted for in the columns giving details and case. naturally, but wrongly, the clerk gives the exact total in column 2. I mention these things as specimens of causes leading to error or confusion, and consequent delay in forwarding the returns and report..

4. The constitution of the Courts in Sind is in most respects the same as it was last year. There are five Magisterial Districts, of which two are under Deputy Commissioners, while there are three Sessions Divisions. In one district (the Thar and Párkar) included in the Sessions Division of Hyderabad, the Deputy Commissioner has the powers of a District Judge, and the Mukhtyarkars (or Mámlatdárs) and their Head Munshis (or Kárkúns) along with the Deputy Collector are for civil work . . . Courts of first instance, there being no regular Subordinate Judges in that district. The Upper Sind Frontier District forms part of the Shikárpur Sessions Division, but the civil work is done partly by the Subordinate Judge of Shikárpur, and partly by the Deputy Collector of Jacobabad, who is also called a Subordinate Judge, but is not classed as such.

The three District and Sessions Judges, and the five District Magistrates in 5. .1887 were all Europeans, while 1 Native and 7 European Sub-Divisional Magistrates exercised original and criminal appellate powers. There were 11 European and 7 Native Magistrates, First Class, exercising original but not appellate criminal powers, besides 108 Native Magistrates of the 2nd and 3rd Classes. 'The above figures include three City Magistrates, First Class, and three Cantonment Ma- $egin{smallmatrix}$ gistrates, First Class. All the Subordinate Judges were Natives of India. There is one Honorary Magistrate of the 2nd Class in Karáchi, and there is no bench of Magistrates in Sind. The Cantonment Magistrate of Jacobabad used to exercise civil power as Superintendent of Bazárs, but ceased to do so in April 1887, while in the same month a Small Cause Court was established for the Cantonment of Karáchi under the Cantonment Magistrate who is now a military officer. I should also refer to the fact that the Sind Frontier Regulations of 1872 and 1883 are in force in part of Sind by which special cases are referred to the decision of a Court of Elders according to Beluch or other tribe custom-a Court which I believe exists in no other part of the Presidency. The punishments inflicted by such Courts are fines, payment of which may be enforced by imprisonment of the offender by the Collector and District Magistrate. These Courts take cognizance of offences, such as murder, as to which the evidence would not suffice for conviction in a regular Court.

6. The receipts and expenditure of the several Courts are shown in the following table. The charges must vary from time to time owing to what may be called accidental causes, such as the absence of an officer on full pay or on half pay or on deputation. The salary of the Judge of the Small Cause Court was also reduced from Rs. 1,000 to Rs. 800. The Deputy Commissioner of Thar and Párkar is a Political officer, and his salary is all debited to that Department, but in this return half is taken as debited to criminal and civil justice :--

This gives as the total of receipts for 1887 Rs. 2,76,816 against Rs. 2,76,187 in 1886, while the expenditure was Rs. 4,89,913 against Rs. 5,52,495 in 1886. In other words the expenditure in 1887 exceeded the receipts by Rs. 2,13,097, and in 1886 did so by Rs. 2,76,308. The cost was least in the case of the Small Cause Court, while naturally it was most in those of Magistrates, where there are not the same Court-fee receipts on account of plaints and appeals.

The salary &c. of the Judge of the Small Cause Court for the Cantonment and his establishment was altogether debited to criminal justice, as he was paid formerly as Cantonment Magistrate and is also Secretary to the Cantonment Committee &c. It was only in this year that Government declared his establishment as such was to be that of the Judge of Small Causes for the Cantonment, so that the whole sum was charged against him as Magistrate.

Criminal Justice.

7. As said above, Statement No. 2 for 1886 was prepared in some districts on erroneous principles, so that as to cases and offenders reported it cannot be taken as a safe basis of comparison with that for 1887. But taking the figures as they stand, the number of offences reported in 1887 was 21,221 with 45,437 offenders against 20,241 cases with 42,732 offenders reported in 1886. This would give an increase in 1887 of 980 cases with 2,705 offenders. Complaints of hurt in 1887 exceeded those for 1886 by 1,059 cases with an increase of 3,186 offenders, while complaints of insult &c. fell off by 392 with a decrease of 1,065 persons. The total number of cases and offenders reported as true in 1886 were 15,915 cases with 31,459 offenders against 16,612 cases with 33,809 persons for 1887, giving an increase of 697 cases and 2,350 offenders.

8. There is as to some offences a great similarity between the numbers for the two years, e. q. 2 cases with 6 offenders complained of as to fraudulent deeds against 2 cases with 5 persons similarly reported in 1886. In neither year was there a conviction under this head. Again, in 1886 there were 53 complaints of defamation against 164 persons (giving above 3 persons for each case), while in 1887 there were 52 cases against 102 persons or only 2 per case on an average. The convictions were respectively 1 in 1886 and 3 in 1887. It will however be better at once to give tables as to the results.

9. The following table shows the numbers of persons under trial in 1857 and 1886 respectively with the results :—

10. It is strange that in 1886 and 1837 the same numbers of persons were acquitted by Sessions Courts and District Magistrates. The average duration has fallen considerably before Stipendiary Subordinate Magistrates and Magistrates disposing of referred cases and in Sessions Courts. It has risen from 9 to 14 before District Magistrates. In the Sadar Court it has risen by a fraction, and has fallen by a fraction in the Special Magistrate's Court.

11. I now consider the details, as to some offences and districts, of cases under special heads as reported, tried and disposed of. Taking the different offences in Statement 2 for which above 1,000 persons were under trial, we find 185 cases in 1886 against almost the same number (183) in 1887 for offences against the public tranquillity, but the persons tried in 1887 are 1,405 against 1,362 in 1886. The convictions in 1887 were 344 against 313 in 1886. More than half of these cases came from Shikárpur, viz. 166, involving 1,299 persons, but only 89 cases with 658 offenders were reported true. The convictions in Shikárpur were 100, whereas in Hyderabad with only 40 reported cases against 439 persons there were 104 convictions.

12. Next comes hurt of which there were 5,086 complaints with 14,481. • offenders, and as to which 4,146 cases were brought to trial, while 11,430 persons were under trial during 1887. I have already stated how the complaints of hurt in 1887 exceeded those for 1886. There were 11,430 persons (or an increase of 2,603) under trial, and the convictions—712—show an increase of 136 over 1886. There were in Karáchi 1,384 cases reported with 4,023 offenders. Shikárpur comes next with 1,574 cases and 4,335 persons, while Hyderabad supplies 1,769 cases and 5,230 persons. The convictions, however, in these 3 districts were very nearly alike, 214 in Hyderabad, 205 in Karáchi and 198 in Shikárpur. Thar and Párkar with only 184 cases gave 75 convictions, while the Upper Sind Frontier with nearly as many cases (175) gave only 20 convictions.

13. As to insult there were 1,822 cases with 3,902 offenders, of which Karáchi gave 813 cases and 1,375 persons, while Hyderabad gave more offenders (1,401) for far fewer cases -495. Shikárpur with 392 cases gives 902 offenders. The convictions were very nearly the same for these districts -33 for Karáchi, 26 for Shikárpur and 20 for Hyderabad, while Thar and Párkar with only 108 cases gave 30 convictions. In the Upper Sind Frontier there was only 1 conviction. I have had to point out often that many Magistrates took up defamation cases under the name of cases of insult. This is being stopped. In 1886 there were 147 persons convictions.

14. The return as to criminal force shows 3,231 persons under trial, of whom only 337 were convicted, giving an increase of 232 persons under trial and a decrease of 9 convictions as compared with 1886. The figures as to such offences show how little real information as to the existence of crime can be got from a table in which compromised cases are shown along with other acquittals and discharges.

15. As to theft, there were 3,549 cases reported with 5,137 persons, compared with 3,707 cases and 5,378 offenders reported in 1886, giving a decrease of 158 cases and 191 offenders. Of these only 2,673 cases with 3,816 offenders were reported true, and 3,836 persons were tried as to this offence, of whom 2,336 were convicted. In 1886, there were 3,597 persons under trial of whom 2,219 were convicted. This gives an increase of 239 persons tried and of 117 convicted in 1887.

Taking the different districts, Karáchi gave 953 cases with 1,200 offenders of which about two-thirds were reported true. Hyderabad with 1,062 cases gives far more offenders—1,714—while Shikárpur with 1,129 cases gives 1,694 offenders as reported: The numbers of offenders reported as true for these two districts were nearly the same, viz. 1,269 and 1,205. Thar and Párkar and Jacobabad gave respectively as offenders reported true 277 and 231 out of 310 and 269 offenders reported in 221 and 184 cases. The convictions were, for Hyderabad 830, for Shikárpur 719, for Karáchi 483, for Thar and Párkar 160, and for the Upper Sind Frontier 144. In every district the convictions as to theft exceeded the acquittals and discharges.

16. Offences classed as mischief show 271 persons convicted out of 1,368 under trial against 262 convicted out of 1,174 tried in 1886. For criminal trespass in 1887 there were 514 persons convicted out of 1,223 tried, showing an increase of 72 persons under trial and of 25 convicted.

. 17. There were 951 cases of offences relating to marriage involving 2,729 persons compared with 903 cases and 2,428 offenders in 1886. There were 60 convictions in 1887, and 81 in 1886.

18. The offences as to which convictions exceeded acquittals and discharges come under the heads of theft, offences against public justice, and as to coinage and against public health and decency, extortion, attempts against life, and offences against local and special laws.

19. Offences against local and special laws vary much in different districts The largest number of convictions was under this head --3,498 out of 4,996 personatried, while 4,965 out of 5,261 offenders were reported true. Karáchi gives nearly half of the whole of the cases reported --1,713 out of 3,702, and had almost as many convictions—1,691—out of a total of 3,498. These 1,713 cases involved 2,295 persons, of whom 2,167 were reported as true offenders. Then comes Shikárpur with 930 cases and 1,349 offenders and 841 convictions. Hyderabad supplies 721 cases and 998 offenders, of whom 954 were reported true, the convictions being 574. Thar and Párkar gives 101 cases and 176 offenders with 76 convictions. The Upper Sind Frontier, however, with only 237 offences, gives 316 convictions, the true offenders being 433 out of 443.

Some offences, such as those against Salt and Opium laws, are more prevalent in some districts than in others owing to their geographical position, while in other districts offences against Police and Municipal laws are more prevalent. This depends a good deal on local circumstances and on the greater or less care exercised as to cleanliness &c. For instance, Karáchi out of a total of 1,713 cases has more than a third—654—as offences against municipal rules, and convictions under this head amount to 705 out of 786 persons tried, while all such cases from the rest of Sind amounted to 276 with 246 convictions. I may note that Thar and Párkar gives 2 cases against 2 persons both of whom were convicted, while the Upper Sind Frontier gives 57 cases involving 58 persons of whom 57 were convicted. Under the Cattle Trespass Act, Karáchi gave 123 cases, Hyderabad 106, while Shikárpur comes between them with 115. Thar and Párkar gives 21 cases and 25 convictions under the Opium Act, while the rest of Sind gave only 14 cases and 9 convictions. There was no such case in the Upper Sind Frontier, and only one in Shikárpur involving one person who was convicted. There used to be considerably more opium cases, especially in Thar and Párkar. The Upper Sind Frontier gives 57 cases against the Salt laws with 52 convictions, while Shikárpur follows with 42 cases and 38 convictions. Next comes Karáchi with 28 cases and 31 convictions, while Hyderabad gives only 12 cases and 17 convictions, and there was no such case in Thar and Parkar during 1887.

20. The different districts give very similar figures as to offences against the Arms Act, Karáchi giving 14 cases with 16 convictions, Shikárpur 12 cases and 12 convictions, Hyderabad 10 cases and 8 convictions, while each of the other districts had 9 cases, but the Upper Sind Frontier had 10 convictions against 8 in Thar and Párkar. As to special and local laws in 1886 there were 3,173 persons convicted out of 4,593 persons tried in 3,333 cases, giving an increase in 1887 of 325 persons convicted and of 403 persons tried. I have not however details as to all the offences coming under the head of 'local and special laws' for 1886, so as to allow of detailed comparison for the respective years.

21. It will be observed that several Courts forgot that section 651 of the Civil Procedure Code had been repealed, and convicted persons under it instead of under the Penal Code. As however the return shows the trials as really conducted, I do not alter it as to these offences.

22. Coming to more serious offences there were 72 cases involving 129 offenders reported for offences affecting life in 1887, of which nearly all, namely 64, involving 115 persons, were reported as true. In 1886 the number of cases was less, namely 59, but they involved nearly as many persons, namely 113. The cases and offenders reported as true were 52 and 98 respectively. In 1887, 60 cases were brought to trial and 43 persons were convicted against 47 acquitted, giving a total of 90 whose cases were disposed of. In 1886 the total was the same, but 24 were convicted and 66 acquitted. For attempts at such offences in 1887 there were 10 persons convicted against 11 in 1886, but in the latter year 6 persons were acquitted, and only 2 in 1887.

23. Ten cases involving 10 persons were referred to the Sadar Court for confirmation of the sentence of death, of whom 8 were convicted and 2 were acquitted. Seven persons out of the 8 were sentenced to be hanged, and one was transported. But two sentences of death were passed on persons convicted by the Sadar Court on appeal against acquittals, so that the real number sentenced to death was 9. Both these appeals were from the district of Shikárpur. In 1886 the Sadar Court sentenced 6 persons to death, and 3 to transportation, but no one was acquitted in that year.

24. The following table shows that in Upper Sind (Shikárpur and the Upper Sind Frontier) 25 true murders were reported against 17 in Lower Sind and Thar and Párkar. Shikárpur is responsible for 16 murders (chiefly connected with jealousy), while Jacobabad, Hyderabad and Karáchi respectively account for 9 and 8 and 7 murders. Two were committed in Thar and Párkar. Murder in this sense, however, includes what technically comes to be "culpable homicide" in cases where persons cause death under grave and sudden provocation. In common language, however, they are murders. The numbers and motives reported from each district are shown below:—

25. Six persons were tried for offences as to birth, of whom 2 were convicted. There was only one such case (ending in acquittal) in 1886. There was almost the same number of persons tried for rape in 1886 and 1887. In 1886 five persons were convicted and 15 were acquitted, while in 1887 the numbers were 2 convicted and 21 acquitted. In neither year was any one convicted of an attempt at rape. There was also a decided decrease in the number of convictions for unnatural offences, only 1 out of 10 persons tried being convicted, while in 1886 out of 11 whose cases were disposed of 5 were convicted of this offence.

26. There was a considerable increase in the number of convictions for robbery and dacoity, 41 being convicted in 1887 against 26 in 1886. The numbers acquitted in the two years were respectively 48 and 50. I have already referred to cases of theft &c. I may add, however, a few coincidences as to a few offences. In 1887 and 1886 the persons tried for criminal breach of trust were respectively 112 and 113, while the acquittals were 75 and 77. The same decrease of one person is found as to receiving stolen property, the figures being 569 and 570, and as to offences against religion the figures being 9 and 10.

There were no convictions of offences as to religion or as to fraudulent deeds or as to documents and trade-marks. The three cases as to offences against religion (involving 9 persons) were from Karáchi, Hyderabad and Shikárpur, each district supplying one case.

27. The proportion of convictions to acquittals was highest in the Upper Sind Frontier District, where 680 were convicted against 960 acquitted, followed by Thar and Párkar with 530 against 857 acquittals. Karáchi gives 2,899 convictions against 6,005 acquittals, Shikárpur gives 2,570 against 7,855, and Hyderabad comes last with 2,471 convictions and 8,135 acquittals. Hyderabad, however, shows 4,046 acquittals as to hurt including many compounded offences, while Shikárpur gives 3,341 acquittals for hurt, so that these figures as formerly said are apt to mislead.

24. I now glance at a few matters affecting particular districts, but as to which there are not materials for general comparisons. Karáchi had more persons under trial and more acquittals and more convictions than it had last year, and the convictions in it are said to have been 65 per cent. of the population, while 1 offence was reported as true in every 279 square miles. In that district there was an increase of offences returned as true under each main head against the person and against property and against local and special laws, but as to other offences against the Penal Code there was the very small decrease of 3.

Hyderabad reports more acquittals and fewer convictions than in 1886. This is so far owing (1) to the fact that Magistrates used to try cases of insult &c. which really were not cognizable by them, and (2) to increase in complaints of compoundable offences. The ease with which complaints of such offences can be made and withdrawn is commented on by several Magistrates. This district shows 8 murders reported true in 1887, 4 owing to motives as to women and 4 owing to 'other motives,' whereas in 1886 there were 7 owing to "other motives." There were 13 persons involved in the 8 murders against 10 persons in the 7 murders of 1886.

Shikarpur shows a slight increase of 95 in offences reported against the person, but in all other main heads a decrease is shown. The murders reported were 18 compared with 20 in 1886.

The Upper Sind Frontier shows both more acquittals and more convictions than there were in 1886. The murders reported for 1887 and 1886 were the same. I may add that while greater care directed to offences against the Police and Municipal Acts accounts at times for the report and punishment of an increased number of offenders, this very care also tends to cause greater caution and thus ultimately fewer offences. A similar observation applies to offences against the Opium and Abkári Acts.

29. I now consider the punishments inflicted by the various Courts, and they are shown in the following table contrasted with those for 1886 :---

• Including the two capital sentences passed on appeals against acquittals which are not shown in Statement 5, but in comparing important sentences like those of death, the omission of 2 out of 9 makes such a difference that I have shown them here. The Sadar Court also passed sentences of imprisonment on one person who had been acquitted.

30. The amount of fines imposed in 1887 was Rs. 91,996, while that realized was Rs. 66,607 of which Rs. 7,412 was paid as compensation. The amount of fines imposed and realized in 1886 was nearly the same, Rs. 89,096 and Rs. 64,573. The amount paid in compensation in 1886 was Rs. 5,043.

31. In 1887, 108 persons were flogged compared with 113 in 1886. Of the 108 persons flogged 69 were so in lieu of other punishment, and 24 in addition to other punishment, while 15 were juveniles. In 1886 the corresponding figures were 72, 33, and 8. Of the 108 persons flogged 25 received 10 stripes or under, 65 got stripes not exceeding 20, and 18 received between 20 and 30 stripes.

Karáchi returns 42 cases of whipping, the same number as in 1826. In Hyderabad the number has fallen from 39 to 22, while in Shikárpur it has risen from 29 to 39. Jacobabad gives no case of whipping and Thar and Párkar gives 5. I have not, however, the figures for these districts for 1886.

The figures for Return 5A (Part 4) have been wrongly calculated. I calculate the figures for the consolidated return as follows. I take the total number of punishments and subtract double punishments, and also the number of persons simply ordered to give security, which does not seem a 'punishment' to be entered in the return in question. Taking the balance as the number of persons actually punished I subtract those whipped and take the balance as the 'other punishments.'

This shows 108 whipped against 8,762 who were sentenced to other punishments.

32. There were 31 cases involving 37 European British subjects before the Courts of Sind, only 1 being committed for trial, namely, to the Court of Session of Karáchi, where he was acquitted. Of the 36 tried by Magistrates 17 were convicted and 19 acquitted. None claimed to be tried by a mixed jury or by a mixed number of assessors.

33. I now come to miscellaneous cases (Return No. 3) of which 531 cases were disposed of involving 635 persons, of whom 230 were discharged and 408 were convicted or bound over by an order. Of these the cases of 6 persons were referred to the Court of Session, the period of imprisonment awarded on failure to give security being above one year. Of these 633 persons, the cases of 386 are included in Return No. 2. Of the remaining 252, 23 were involved in cases as to - local nuisances and possession of immoveable property, while 56 were summarily fined for frivolous complaints, 1 for non-attendance as a juror or assessor, 3 for contempt of Court, 38 for non-observance of the conditions of a bond, and 5 were ordered to pay maintenance. In 116 cases the application for maintenance was rejected.

34. The total number of persons ordered to give security in 1887 was 287, very nearly the same as the number in 1886, namely 288, while the numbers discharged in the two years were 94 and 90 respectively. In neither year was there any proceeding against a witness under Chapter VI-C and section 485. In each year there was one case with one conviction against a juror or assessor for non-attendance. In 1886, 37 persons were ordered to pay maintenance against 5 in 1887, while the number of bonds forfeited in 1887 shows a decrease of 4.

As to Return No. 3, I may add that as no column is given for persons under trial at the end of the year, I have considered this return to apply only to decided cases, so that it differs from the figures as to the sub-heads 2, 3 and 8 in Return No. 2. This is in accordance with the Return No. 3 for the whole Presidency for 1886, but in that for 1887 the numbers pending are also included as to two sub-heads. In case it is desired to show these persons in the return, the cases as to "Proceedings for good behaviour" should be shown as 292 instead of 278, and the persons concerned as 304 instead of 288, the corresponding corrections , being made as to the totals.

35. Coming now to appellate and revisional matters, there were 1,738 appellants before the Courts in 1887, the cases of 44 of whom were pending at the end of the year. Nearly a third of the appeals were summarily rejected, namely, 553, while in 739 cases the convictions and sentences were confirmed after the cases had been heard. The sentences of 262 were reversed, while those of 120 were modified and in the cases of 20 persons new trials were ordered. No proceedings were quashed. The following table shows the results as to each class of Courts :—

There was an increase of 254 appellants in 1887, while the persons whose cases were pending at the end of the year were 41 contrasted with 40 in 1886. In 1887 there were 1,447 appeal cases disposed of, while the number for 1886 was 1,330. The number of appellants whose sentences were altered or reversed in the two years were 382 and 361 respectively. The proportion altered by the Sadar and Sessions Courts was about 1 in 4, while in Magistrates' Courts it was about 1 in 5.

36. Taking the respective districts, far the greatest number of appeals was in the Shikárpur District, which contributed 715 out of 1,653 appeals to Magistrates and Sessions Courts. Of these 568 were to Magistrates' and 147 to the Sessions Court. Only 4 were pending at the enl of the year. Then comes Karáchi with 438 appellants, Hyderabad with 266, the Upper Sind Frontier with 157, and Thar and Párkar with 77. The District Magistrate, Thar and Párkar, confirmed the decisions against 52 out of 57 appellants, the largest proportion to be found. But from that district only 7 out of 77 appellants were released, 3 by the District Magistrate and 4 by the Sessions Judge, while only 2 had their sentences modified by the District Magistrate. In Karáchi Magistrates reversed 27 out of 250 sentences of appellants whose cases were disposed of, while in $\pm 863-10$ Hyderabad 43 were similarly reversed out of 147, but in the latter district only 4 were modified by Magistrates against 34 modified in Karáchi. The Sessions Court for Hyderabad interfered in 31 out of 107 appeals, and that of Karachi did so in 38 out of 138. In the Upper Sind Frontier the District Magistrate and the Sessions Judge reversed 17 sentences each, and the Sessions Judge also modified 8 sentences. The duration of appeals before Magistrates was least in the Upper Sind Frontier with 6 days, and exceeded 17 days both in Karáchi and Thar and Párkar. The duration in the Sessions Court of Hyderabad for Thar and Párkar was 20 days; in the other districts it varied between 12 and 16 days. Before the Sadar Court it was 15 days. That Court had 85 appeals, or 6 less than in 1886; the other Courts show an increase. The Sadar Court appeals include 5 against acquittals (to three of which I have already referred), 2 from Shikárpur, and 3 from Hyderabad. One was pending as notice could not be served on accused, while one person who had been convicted under section 411 and acquitted under section 379 was found guilty under section 379.

37. As to revisional matters the cases of 814 persons were before the Courts in addition to those of 127 persons against whom complainants made applications. In 1886 there were 100 accused against whom complainants made petitions, exclusive of whom the cases of 873 were before the Courts. Adding such cases there were 941 persons before the Courts in 1887 and 973 in 1886. Magistrates had (383+9) 392, and Sessions Courts had (52+19) 71, all of whose cases were disposed of except 7. Magistrates quashed the proceedings against 20 persons, and further enquiry was ordered by them and Sessions Judges in 21 cases, while the cases of 62 persons were referred to the Sadar Court. I have already referred to the misleading nature of the heading of column 2 of this return (No. 6) as to revisional matters. According to it there were 311 applicants for revision before the Sadar Court besides 68 whose cases had been referred for revision (including those pending from 1886). But the cases of 99 other persons were before the Court on complainants' applications. In 11 cases the sentences. were enhanced, in 29 they were altered and in 131 they were reversed, while 53 persons were ordered to be re-tried. The cases of 26 persons were pending at the end of the year, and in the decisions as to the rest no change was made. In 1886 the number of enhancements was 20, while sentences were reversed in 72 cases and modified in 32, a new enquiry being ordered in 16. In 1887 the average duration of a revisional case before a Magistrate was 13 days, before a Sessions Judge 19, and before the Sadar Court was 10 days. The revisional cases disposed of by Magistrates were 218, by Sessions Judges 30, and by the Sadar Court 288.

Jurors and Assessors.

³⁸ 38. The return as to these comes after the returns as to civil work, but as there were no jurors and assessors in civil cases, I more appropriately consider the matter here. The more serious cases tried in the town of Karáchi in the Sessions Court were so by jury. There were 17 such cases and in all of them the Judge approved of the verdict. The number of jurors in each case is 5. There were two cases in the same Court tried with the aid of assessors with whom in both cases the Judge agreed. Out of 75 tried by him with the aid of assessors the Sessions Judge of Hyderabad agreed with the assessors in 55 cases, while the Sessions Judge of Shikárpur agreed with them in 44 out of 52 cases. In 11 cases the Sessions Judges of Hyderabad and Shikárpur differed from both assessors and in 17 they differed from one. These 146 cases exclude 15 in which the hassessors' opinions were not asked as in 5 cases prisoners pleaded guilty and the charge was withdrawn in 4 cases, while 6 cases disposed of by the Sessions Judge of Hyderabad were so under section 123, Criminal Procedure Code.

39. Taking the population of Sind as 24,13,823 and the area as 48,014 square miles, one offence was reported for a little above every 2 square miles and for above every 100 of the population, the figures being 44 per square mile and 57 per hundred of the population. The rate of convictions was 37 per hundred of population and 19 per square mile, so that roughly speaking there was one conviction to every five square miles of area and to every 270 persons of the population.

Taking the number of civil suits instituted in all Courts, which will presently be shown as 21,749, there was a civil dispute (involving at least two persons) for a little above every 100 of the population and for about every two square miles, the arithmetical figures being '9 per hun led of the population and '45 per square mile. The numbers of offences reported and of suits instituted were not far dissimilar, namely 21,221 and 21,749. In other words, almost every two square miles and almost every 100 of the population gave an offence reported and a civil suit.

Civil Justice.

40. I now take up the subject of the administration of civil justice. The total number of suits filed in all the Civil Courts in Sind was 21,749 of the estimated value (so far as it could be calculated) of Rs. 18,79,763, which compared with the figures for 1886 gives an increase of 2,169 in suits and a decrease of Rs. 1,20,855 in their value. The cases disposed of in 1887 were 21,721 against 19,108 in 1886, giving an increase of 2,613.

41. There were 2 suits in the Court of the Judicial Commissioner in 1886, while there was none in 1887. This Court only takes up suits under the Indian Divorce Act of 1869, and for purposes of general comparison as to civil work this Court and those of Mamlatdirs may be left out of view. The Revenue (Mamlatdars') Courts I shall consider separately. The following table shows the cases with their value which were instituted and also those disposed of in these two years in the Courts in Sind usually engaged in disposing of civil disputes. I would here mention that I fear a number of suits were undervalued, as I have had to point out several instances before Subordinate Courts in which the Courtfee was taken as ten rupees when a considerably larger duty was payable :--

The returns are satisfactory as showing an increase in the number of suital instituted and disposed of.

42. Owing to orders to enforce the utmost economy, in 1886-87 the Subordinate Courts' circuits were discontinued, which temporarily affected the number of suits filed in 1836. A considerable decrease in the number of suits instituted in that year was reported and I may here give some numbers for 1885 which correspond to a great extent with those for 1887. In that year 21,246 suits or much more nearly the number for 1887 were filed, but the estimated value was Rs. 18,72,433 or nearly half a lákh of rupees above that for 1887. As a rule no better explanation can be given of the increases and decreases in the value of suits than that in one year there may be suits for exceptionally large amounts. The decrease was not by any means uniformly spread over all the Courts. For instance, in the Karáchi District there was a slight decrease as to Subordinate Courts, but the District Court shows an increase of about Rs. 75,000. Against this has to be placed a large decrease of about 21 lákhs in the Shikárpur Courts.

43. The following table shows the classes of Courts in which the decreases and increases respectively were found, and at first sight it is strange that while the District Courts and Subordinate Courts show an increase, the Small Cause Court shows a decided decrease. The civil jurisdiction of the Cantonment Court was abolished in April 1887, so that no comparison can be made as to it with the figures for former years. As already said the Small Cause Court for the Cantonment of Karáchi was constituted in 1887, with jurisdiction only up to Rs. 209 instead of Rs. 500. I believe the result has been some confusion as to the Court having jurisdiction over suits valued at sums between Rs. 200 and Rs. 500 in the Cantonment which will now be rectified. I take the two Small Cause Courts as representing the one Small Cause Court in 1886, which for statistical purposes will be correct. It is strange that the number of suits instituted in the new Small Cause Court exactly corresponds with that of suits in the Cantonment Magistrate's Court abolished in April--47 in each case :--

44. On referring to Statement No. 7 it will be seen that the chief increase in the Subordinate Courts are under the heads of "Contract in writing," "Account stated" and "Goods sold," the increase as to which exceed 2,200, while the Small Cause Court shows a decrease of above 460 under the first two of these heads. The figures in the District Courts under the several heads for the two years show very little difference and under some heads are exactly the same. Taking the districts as a whole Shikárpur heads the list with 8,370 suits valued (so far as could be estimated) at about Rs. 8,22,000 (including the Cantonment Court of Jacobabad), while Hyderabad follows with 7,354 suits valued at Rs. 4,69,550, while Karáchi (including the Small Cause Courts) gives a total of 5,041 suits valued at Rs. 4,93,154. The value of the Small Cause Court suits was slightly above Rs. 1,00,000, but it is to be recollected that all of them were capable of valuation.

45. As stated in a former report, owing to the non-existence in Sind of Subordinate Judges corresponding with the First Class Subordinate Judges under the High Court, the District Courts in Sind try many original suits which would come before Subordinate Judges in Bombay. Also in part of the district of Karáchi (including the city of Karáchi) there is no Subordinate Judge, so that all cases from it have to go either to one of the Small Cause Courts, or the District Court. The effect is marked. In Hyderabad 5 original suits, 3 of which were valued at Rs. 20,824, were filed in the District Court, while in Karáchi there were 116, of which 97 were valued at Rs. 2,10,600. Shikárpur, by far the hardest worked district, comes between the two with 32 original suits of which 26 were valued at Rs. 2,68,993. As to appeals the reverse is the case, Karáchi giving only 21 new ones, while Hyderabad gives 55, and Shikárpur has nearly double both these, or 142. There were no suits in what may be called the District Court of Thar and Párkar.

46. The decrease before the Small Cause Court is ascribed to the fact that greater strictness has been shown by the present Judge of that Court in enforcing provisions of the Civil Procedure Code applying to the Small Cause Court and the Limitation Act. The stricter application of the laws has caused a temporary decrease in the number of suits. A slight decrease in a Subordinate Court in the Karachi District is attributed to the fact that for part of the year the work of two Courts was carried on by one Subordinate Judge. I can quite understand that some suits were temporarily kept back on that account, but the number of suits disposed of in both those Subordinate Courts shows a considerable increase instead of a decrease which might have been expected in at least one of them.

47. On comparing the figures in Return No. 8 with those for last year it is found that more than half the increase in suits is in those the value of which does not exceed Rs. 10. There is also a large increase in those not exceeding Rs. 50 in value, while in suits exceeding Rs. 1,000 there was only an increase of 5 suits. The number of suits in 1887 and 1886, of which the values are reported as incapable of being estimated in money, are very nearly the same, namely, 181 and 184 respectively.

48. The suits before these Courts during the year and the numbers disposed of are thus contrasted for 1886 and 1887 :---

There was an error of 1 in the number of pending suits shown last year for 1886, as the total is now said to have been 1,616 instead of 1,615. But as the error is so slight and I have not the detailed reports for last year before me, I leave the figures for 1886 in the above table as they were given in last year's returns. Of the 1,785 pending at the end of the year under report 499 had been so for above three months.

49. I may mention the Thar and Párkar District in which there were only 578 suits before the Courts out of which 526 were disposed of. Only 23 cases are shown as contested, and in those plaintiff was successful in only 14 cases. In that district the cases are disposed of by the revenue officers who cannot try • them during the circuit season so regularly as is done in the other districts, as they have to dispose of their regular criminal and revenue work. The average duration, however, is smaller than would at first sight be expected, 31 and 45 days respectively, showing that the plaintiffs file their cases usually when they can without much delay be disposed of. The Deputy Collector, Jacobabad, is Subordinate Judge for Thul and Kashmor, but he has to dispose of civil work during the circuit time, because in the intensely hot weather of Upper Sind he is for some months chiefly at Jacobabad, which is outside of his civil jurisdiction.

. 50. Taking the chief heads under which they fall as contested, uncontested &c., the cases decided may be thus contrasted for 1886 and 1887:—

This shows an increase in 1887 under all heads except that of contested.

Above a third of the cases decided were never brought to trial and a still greater number of claims were admitted or compromised. Out of the 21,276 cases disposed of only 2,603 or little below an eighth were contested ones, excluding 387 referred to arbitration. Out of these the plaintiff was more or less successful in 2,139 cases and the defendant was wholly so in 464, showing above 4 out of 5 contested decisions partly in plaintiff's favour. In 1886 plaintiffs were similarly successful in 2,330 out of 2,820 contested cases. Claims awarded *ex-parte* were not much in excess of the above numbers, plaintiffs in *ex-parte* suits obtaining decrees in 2,705 cases but being unsuccessful in only 96. Last year the corresponding figures were 2,412 and 109. Naturally the proportion of cases decided *ex-parte* is far largest in the Small Cause Court, where nearly one-third of the total cases decided were 20 *ex-parte* in plaintiff's favour, only 14 being dis-

missed ex-parte. Leaving out the Small Cause Court, plaintiffs in all Courts were successful in 1,941 out of 2,344 contested cases and in 2,056 out of 2,138 ex-parte cases. Only 96 suits were dismissed ex-parte for all Sind, being 36 from all Courts in the Karáchi District, and 29 and 31 respectively for those in the Hyderabad and Shikárpur Districts. No suit was so disposed of by a District Court, or by the Cantonment Small Cause Court, in which the decisions for plaintiffs were the same in ex-parte suits and in contested ones, namely 13. It is to be remembered that many contested cases in Sind are only nominally so, the only dispute being whether payment is to be made by instalments or not. On the contrary, cases shown as compromised are at times suits for large sums, which have been fought out nearly to the end, when from fear of losing the case or from intervention of friends the parties mutually agree to make a private settlement. This accounts in part for the long duration of many cases shown as 'uncontested ' in the returns.

The number of cases decided by arbitration was 387 against 347 in 51. Almost all of these were decided in the Subordinate Courts and in plain-1886. tiff's favour, the District Courts only disposing of 28 by arbitration, all of which were decided for the plaintiffs. In the Karáchi District Court 18 were thus disposed of, while 8 were so in Shikárpur, the balance being 2 for Hyderabad. Of the arbitration suits decided in Subordinate Courts most were so in the Districts of Shikárpur and Hyderabad, the figures being 163 and 149 respectively, leaving only 34 for the Subordinate Courts in Karáchi (of which 30 were before the Schwan Court) and 6 for Thar and Párkar. The numbers for Shikárpur and Ilyderabad of cases thus decided for defendants were strangely alike, being 10 and 8 respectively. Especially in Shikárpur delay before arbitrators used to cause great delay in disposing of some suits. It used to be thought that if a case · was referred to arbitration any number of postponements would be granted, and the Court was trifled with till at last some references had to be cancelled. Of late arbitrators have learned that if they undertake the duty, they are expected to perform it within a reasonable time, while parties are learning that they must attend before arbitrators when required to do so, and are not at liberty to attend or not at pleasure or entitled to obtain adjournments whenever they choose to ask for them.

52. The average time occupied by suits in the respective classes of Courts is shown below, the time being expressed in days, and fractions above half a day being taken as a whole day. I regret that the figures as to District and Subordinate Courts given in last year's report as to this matter are erroneous, as I find their averages were wrongly calculated. I had formerly given special instructions as to this matter but these had been forgotten. No useful comparison can be given with last year's reported figures. The figures especially as to District Courts are considerably less than they would be if calculated on 'last year's system. I have been enabled to give the proper averages for 1886 from notes kept in my office which I give instead of those in last year's report :—

53. It is strange that the result as to Subordinate Courts shows' exactly the same average as that for 1886. The Small Cause Courts show an increase and the District Courts give a very decided increase. It is to be remembered that when there are few suits decided in a Court, of which suits one or two have been pending for long, the general average is much affected. In fact, the year in which most energy is displayed and most work is cleared off may in consequence show a very high average duration of cases. A matter greatly affecting Subordinate Courts is that in Sind many people wander about from village to village and from district to district according to the nature of the season. In a dry season many go to a distance where there is water for their cattle, so that there is often much difficulty in finding where defendants and witnesses are. This so far affects other Courts as parties go to foreign countries.

54. Naturally the Cantonment Magistrate's Court gives the lowest average, 14 day for uncontested cases and 27 for contested ones. The average for uncontested cases was too small, but I need not dwell on this as the Court now does no civil work. The Small Cause Courts with 28 and 46 days come next, the Cantonment one gives 15 and 19. The Subordinate Courts in Thar and Párkar and in Karáchi are very much alike as to contested cases, the figures being 45 and 46 respectively, but uncontested cases in these Courts in Karáchi occupied 26 against 31 days. Hyderabad follows with 30 and 54 days, while Shikarpur shows the maximum of 37 and 80. The District Courts vary much, Karachi showing an average duration of 98 and 140, while Hyderabad has 96 and 210, and Shikarpur required 376 days for uncontested suits and no less than 1.057 for contested ones. The explanations formerly given as to arbitrators' delays and the settlement of cases after they have been fought out for long applies chiefly to Shikarpur. I may add that in the present year the District Judge of Hyderabad as Joint Judge spent a considerable time at Shikarpur, so that better returns may be expected next year. Last year the Judge of Hyderabad was for a while in charge of both the Hyderabad and Shikarpur Districts, which so far increased the rates of both these districts.

55. I now come to the Revenue Courts which had 461 cases before them in 1857, of which 443 were instituted in that year, and of which 445 were disposed of, leaving a balance of 16 pending at the end of the year. The value of the suits instituted so far as it could be calculated was Rs. 55,445. Taking the figures reported for last year 430 were instituted valued at Rs. 41,856 and of 437 before the Courts, 419 were disposed of, leaving a balance of 18 at the end of 1886. The average duration in 1897 is given as 17 and 31 respectively against 18 and 23 in 1886. This shows an increase in suits instituted and their value and in the number disposed of.

56. It is noteworthy that Shikárpur gives exactly as many suits instituted in these Courts—189—as were instituted in Karáchi and Hyderabad together, while 191 were disposed of in Shikárpur against 190 in these two districts. Two cases were pending at the end of 1837 in each of three districts—Hyderabad, Thar and Párkar, and the Upper Sind Frontier. Out of 445 cases disposed of 213 were contested, only 58 being decided *ex-parte*, of which 49 were dismissed, while 114 were admitted or compromised, and 29 were disposed of without trial. One was referred to arbitration.

The average durations varied much, Karáchi being lowest with 7 and 14 days for uncontested and contested cases respectively. Shikárpur gives 9 and 12 respectively. Hyderabad gives 44 and 85, while the Upper Sind Frontier gives 49 for uncontested cases against 19 for contested ones.

These Courts had no miscellaneous cases before them.

57. There were 983 miscellaneous cases before all the Civil Courts, of which 793 were before the Subordinate Courts, 44 before the (City) Small Cause Court of Karáchi, and 151 before the District Courts. Out of the 955 for trial 859 were disposed of, leaving 129 pending. The corresponding figures for 1886 were 910 cases, of which 778 were disposed of, leaving 132 pending. Of those contested in 1887, 161 were decided for plaintiff and 183 for the defendant. This is chiefly owing to Subordinate Courts in Shikárpur which decided 131 out of 191 contested cases in defendant's favour. In 1886 the proportion was the reverse, 241 contested cases being decided in plaintiff's favour against 89 for defendants. Two were referred to arbitration in 1887, of which one was decided for plaintiff and one for defendant. Of 126 cases decided ex-parte, 83 were for plaintiff and 43 for defendant. About two-thirds of all these cases were in the Shikárpur District, which contributed 623 out of the 953 for disposal. None

were from Thar and Párkar. The following table shows a few details as to them.

The Shikárpur District Court, which has such a large duration for regular civil cases, shows for miscellaneous cases 58 and 91 days, the uncontested cases taking considerably longer than the contested. It disposed of 36 contested cases contrasting with 7 and 13 in the Hyderabad and Karáchi District Courts. The Shikárpur Court had no *ex-parte* cases, while the Hyderabad and Karáchi Courts had 15 and 24, all decreed for plaintiff. The uncontested cases before the Hyderabad District Court also lasted considerably longer than the contested ones. This anomaly is partly accounted for by the fact that summonses have to be served at a great distance and partly by the fact that such uncontested cases are often conducted by the parties in person to whom more indulgence is shown than would be shown to pleaders.

58. I now come to the Appellate Courts. Including 165 pending from the previous year, there were 393 appeals before the District Judges of which 267 were disposed of. I have already pointed out how the number of appeals varies in different districts. Passing over Thar and Párkar with only 5 appeals, the District Court of Karáchi had the fewest 23, while that of Shikárpur had 276 or more than double the appeals in all the other districts.

The following table gives the most important details as to the appeals before each District Court and a comparison of the totals for 1887 and 1886 :----

This shows that in 82 of the 210 appeals heard by the Courts after issuing notice to the respondents the decision of the Subordinate Court was considered unsatisfactory and the order was reversed or modified or the case was remanded or further trial. In 1886 this was the case with 72 appeals out of 167 which came fully before the District Courts for formal decision. The proportions for the various districts of cases in which decisions were confirmed under section 551 or after trial were nearly the same, decisions being confirmed in 11 out of 22 cases decided in Karáchi, in 33 out of 59 in Hyderabad, in 97 out of 183 in Shikárpur, and in 2 out of 3 in Thar and Párkar.

59. In the Sadar Court there were 20 first appeals of which 15 were decided, leaving 5 pending. In the 15 appeals decided 4 decisions were confirmed, 5 modified, and 6 reversed; none of these was heard *ex-parte*. The average duration was 51 days. There were 52 second appeals, in 13 of which the decisions were confirmed under section 551, and 2 were dismissed for default. In all, 49 out of the 52 were disposed of, 16 decisions being contirmed after formal hearing besides the 13 above referred to, 2 being modified and 16 reversed. The average duration was 62 days, giving a total average of 60 days for appeals before the Sadar Court. No appeal was remanded by that Court in 1887. Taking all the appeals before the Sadar Court 29 decisions out of 64 were reversed or modified.

There was a considerable increase in the appeals to the Sadar Court in 1887, the number in 1886 having been only 38 of which 34 were disposed of in that year, leaving 4 to be heard in 1887. In that year 17 out of 34 were altered with an average duration of 181 days.

60. There was one miscellaneous appeal before the District Court of Karáchi, which was disposed of under section 551 on the day it was presented. Including 1 pending from 1886, there were before the District Court of Hyderabad 7 miscellaneous appeals all of which were decided with an average duration of 95 days, 1 decision being confirmed and 6 reversed. The District Court of Shikárpur had 19 such appeals, of which 16 were disposed of, leaving 3 pending. In the 16 decided, 5 decisions were confirmed, 3 modified and 7 reversed (all after contest), and in 1 the decision was confirmed under section 551. This gives a total of 16 decisions more or less altered by District Courts out of 24 cases disposed of. The average duration of those appeals was 77 days. The Sadar Court had 14 miscellaneous first appeals, 10 of which were decided leaving a balance of 4 at the close of the year. In these 10, 2 decisions were confirmed, 2 modified and 5 (or exactly one-half) reversed, and in 1 the decision was confirmed under section 551. 7 out of 10 decisions were thus altered more or less. The following table will show how these miscellaneous appeals in all Sind were diposed ot :--

61. In addition to the appellate work before it the Sadar Court disposed of 44 applications under section 622, 2 under section 623, and 1 under section 617 of the Code of Civil Procedure, and a very large number of cases were examined by it on circuit.

It is noteworthy that the numbers of regular civil and criminal appeals disposed of by this Court in 1857 were exactly the same-64.

62. I now come to the proceedings taken to execute decrees for which purpose 13,258 applications were before the District Courts, Small Cause Courts and Subordinate Courts. Out of that number 12,185 were disposed of, but as to 9,686 applications there was no result obtained, except perhaps that of keeping the decree alive. Satisfaction was obtained in full as to 1,735 and partly as to less than half that number, namely 758 applications, while 6 were transferred. There were 1,073 pending at the close of the year, out of which 195 had been so for more than three months.

The result of issuing processes was the payment of Rs. 2,31,494, the imprisonment of 345 debtors, the sale of moveable property in 192 instances and of immoveable in 201, and the delivery of property to the judgment-creditor in 50 cases, while partition was effected in 7 instances and specific performance enforced in 3, and special arrangements as to realizing the sums due were sanctioned in 1 case. Execution was otherwise effected in 108 cases. Out of all the judgmentcreditors arrested, 555 persons were released without being imprisoned. Without any recourse to the Court's aid, a sum of Rs. 58,255 was realized for judgmentcreditors through the Court.

63. The following table shows how the execution work was distributed among the Courts in 1886 and 1887 :---

64. It is very satisfactory to find that though fewer persons were imprisoned and property was sold in fewer cases in 1887, yet Rs. 83,651 more were realized through the Courts than in 1886. There was however a decrease of Rs. 69,563 in 1887 in the amount realized without the aid of the Court.

Out of the 345 cases of imprisonment Hyderabad is responsible for 161, next comes the Small Cause Court with 90, Shikárpur with 77, Thar and Párkar with 9, and Karáchi with only 8. Only 3 persons were imprisoned by order of a District Court—that of Karáchi.

In the Cantonment Small Cause Court no one was arrested, and only 3 processes for sale of moveable property were issued, which was released from attachment while Rs. 62 were realized. It is worthy of notice that in the other Small Cause Court the number of persons imprisoned (90) was almost equal to that of persons arrested but not imprisoned (92). In Hyderabad too the figures were nearly the same, 161 imprisoned, to 154 released. In Shikár-pur 193 were released. In Thar and Párkar and Karáchi the numbers imprisoned were 9 and 8 respectively, but persons arrested and released numbered 70 and 46 respectively.

65. Immoveable property was sold in 89 cases in Hyderabad and in Shikarpur in 87 cases, while this was done in only 25 cases in Karáchi. Moveable property was sold in 75 cases in Shikárpur, while in the rest of Sind (excepting the Small Cause Courts) this was done in only 74 cases. The number of applications in Shikárpur and Hyderabad were nearly the same, 5,117 and 4,666, while that for all the Courts in the Karáchi District was 3,310, namely 1,904 for the Small Cause Courts and 1,436 for the District and Subordinate Courts. The balance of 135 was provided by Thar and Párkar.

66. Of the total sum realized by process (Rs. 2,31,494), the Shikárpur District Court provided nearly half or Rs. 1,07,944, being three times the amount realized through the Subordinate Courts in that district. The Karáchi District Court follows with Rs. 36,995 against Rs. 21,878 provided by the Subordinate Courts and Small Cause Courts in that district. The Hyderabad Subordinate Courts give Rs. 27,806 or nearly as much as the Shikárpur Subordinate Courts, but in that district the District Court collected nothing by the issue of process. In Thar and Párkar the total thus realized was Rs. 4,037.

67. As to sums paid voluntarily Shikárpur again comes first with Rs. 36,204 (of which above two-thirds were paid to the Subordinate Courts) followed by Hyderabad with Rs. 15,677 (of which less than a tenth was through the District Court) and Karáchi with Rs. 5,505, the Small Cause Court and Thar and Párkar showing only Rs. 571 and Rs. 296 respectively under this head.

68. Mukhtyárkars had 38 applications for execution, only 1 of which was infructuous, while in 36 full satisfaction was obtained and 1 was pending at the end of the year. At the end of the previous year likewise only 1 application was pending, but in that year the total applications before these Courts were only 6 of which 5 were satisfied in full. A sum of Rs. 70 was realized after the issue of process and Rs. 29 without the issue of process in the District of Hyderabad.

I now consider the return as to insolvency matters. There were 59 69. applications or 28 less than in the year 1886. Of these 45 were before the Hyderabad and Shikárpur Subordinate Courts, 8 before the Small Cause Court and 6 before the Karáchi and Shikárpur District Courts. No such applications were before the District Court of Hyderabad or the Subordinate Courts of Karáchi or the Courts in Thar and Parkar or in the Cantonment Small Cause Court. Seventeen applications were not proceeded with, leaving 42 for orders. Out of this number 16 were rejected and 13 granted; while 13 were pending at the end of the year. In 5 of the 13 applications granted a receiver was appointed. No penal steps were taken against any one in 14 applications, but sentence of imprisonment was passed by the District Court of Karachi in 2 cases. In 1886, 30 were rejected and 19 granted; but no penal steps were taken against any applicant. In 1887, 12 insolvents received discharges and proceedings as to 3 estates in receiver's hands were finally closed; the corresponding figures for 1586 being 9 insolvents discharged while proceedings as to 5 estates in receiver's hands were finally closed.

70. In 1886 Rs. 4,115 were shown as realized, while only Rs. 1,212 were disbursed, leaving a considerable sum for disbursement in 1837, in which year Rs. 4,208 were realized (chiefly in Shikárpur), but Rs. 5,621 were disbursed. Except Rs. 2 in Hyderabad and Rs. 20 in the Small Cause Court, all the disbursements were in the Shikárpur Courts. Creditors' claims were admitted for Rs. 5,519 in the District Court of Karáchi, and for Rs. 6,311 in the Small Cause Court and for Rs. 6,217 in the District Court of Shikárpur and for Rs. 805 in Sabordinate Court in Hyderabad. The only entry of creditors' claims as satisfied is for Rs. 1,151 in the District Court, Karáchi.

71. Generally speaking the records and books of the various Courts are reported to be in good condition, though the ravages of white ants have to be guarded against. The reports from the various districts are appended, but you will observe that the figures in them are often very different from those in the statements. Several reports were returned once for correction, and were corrected or re-written, but some statements had to be sent back over and over again, so that it was useless to think of correcting the reports. When they differ from the statements, the figures in the latter should be taken as correct. As already stated you will probably find some errors even in these, but they do not effect the general totals much, and the time taken to correct them would be considerable. As there could be no materials for a comparison with former years' figures no report is sent from the new Court of Small Causes for the Karáchi Cantonment.
