INTRODUCTION

I. LIVE-STOCK

The well-being of our country is intimately linked up in numerous ways with the prosperity, in numbers and quality, of our live-stock. They provide some of the most essential constituents of human diet in forms best suited for human consumption; their performance on the field is an important determinant of the standard of farm husbandry in this country; scientific utilisation of the farm-yard manure yielded by them would easily figure as one of the most essential steps in any rational scheme for better care of the fertility of our soils while mixed farming provides the most easily available opportunity to the farmer to fill in some at least of his spare time with remunerative work. In the agricultural sector especially, the quality of our live-stock and the standards of their management, therefore, greatly influence the productivity of our lands, the standards of cultivation, the quality of human diets as also the opportunities for employment of our vast labour resources. It is, therefore, in the fitness of things that the schemes like the Key Village Scheme aiming at the preservation and improvement of our cattle wealth now form an integral part of our over-all plan for the consolidation and enlargement of the economic welfare of the rural masses. In the present publication are presented the main legal enactments on live-stock which provide legal sanctions for some of the measures being taken by the State in India to improve the quality of our live-stock and to prevent wastages through the spread of disease or through indiscriminate slaughter. The major problems arising in the sphere of live-stock management in this country are indicated in the next few paras which precede a general resume of the present state of legislation on live-stock.

2. Of the various types of live-stock in the country, bovine animals are the most numerous and also the most important from the cultivator's point of view. According to the 1951 Live-stock Census, the total number of live-stock in the country stood at 292.2 millions, the number of cattle being 155.1 millions or 53.1% of the total. Buffaloes account for another 14.9% of the total live-stock population, sheep and goats for 30.1%, horses and ponies for about 0.5% and the other types viz., mules, donkeys, etc. for the remaining 1.4%. The census figures reveal the following classification of the total cattle and buffalo population in the country:—

- 3. These figures illustrate the well-known fact of the relatively greater importance of the males among cattle and the females among buffaloes. While cows above three years form only 32°1% of the total cattle population, corresponding percentage among buffaloes is 50°4. The male buffaloes tend to be neglected while the working bullocks are valued for the labour they supply for the various farm and offarm operations. The figures of working bullocks seem to indicate that in the country taken as a whole, a yoke of bullocks cultivates about 10 acres of land, though there would be wide variations in this respect from area to area because of differences in nature of soils, the lengths of the periods available for main agricultural operations, the cropping patterns and the extent of irrigation from wells, etc. It is not known as to how far the recent extension of canal irrigation and tractor cultivation can have reduced the need for working bullocks but the effect so far must have been negligible. However, when all the projects now in hand for canal and tube-well construction are completed, they cannot but reduce the demand for working bullocks, especially in areas where they replace well irrigation. A better management of farms and live-stock may strengthen the trend in that direction. This may partly relieve the difficulty being felt at present in the replacement of working bullocks by the growing youngstock.
- 4. The Royal Commission on Agriculture, while commenting on the relative numbers of the cows and youngstock in India, remarked that they showed a very deplorable state of stock management in India. We had, even in 1951, a total of 46·3 million cows (in milk and dry and not calved) as against 43·5 million youngstock below three years of age. Even keeping in view the high mortality among youngstock in India, these figures would roughly suggest a calving period of about 2 to 2 1/2 years. To the Royal Commission, this indicated a very unsatisfactory feature in cattle management in general and a neglect of the cow, when dry, in particular, for that Commission felt that Indian cows, if properly fed and managed, might be expected to calve about once a year, as do the cows of Europe. These figures also confirm the general complaint about the shortage of breeding bulls. The breeding problem, however, is not a problem of numbers alone; it has another aspect, namely, that of deficiencies and defects in the bulls used for breeding in many areas. This, according to many experts on animal husbandry, is one of the principal causes of the deterioration of the quality of our live-stock. This latter aspect can, however, be clearly linked up with the former as it is the shortage of stud and improved bulls in relation to their requirement that has led to deficient bulls sometimes suffering from contagious diseases being used for breeding purposes. This problem, along with many others connected with live-stock improvement, is now sought to be solved through the implementation of the Key Village Scheme under the Five Year Plan. The legislative sanction for certain parts of this programme like castration of defective bulls is provided by the Live-stock Improvement Acts already in force in a number of States. In view of the shortage of stud bulls in the country, the technique of artificial insemination is also utilised at the Key Village Centres set up under this Scheme.
- 5. Attempts at improvement of live-stock through breeding alone cannot, however, yield lasting results unless they are accompanied by equally vigorous efforts at improving the position in regard to the feeding of the live-stock and control of live-stock diseases. Improved breeds deteriorate rapidly if not fed properly and adequately. Also high cattle mortality compels many of the poorer cultivators to keep inferior and cheaper breeds and adversely affects their attitudes towards live-stock management. The problems relating to cattle feeding and control of cattle diseases need, therefore, as much attention as those relating to cattle breeding.
- 6. The present deficiencies in the feeding of live-stock in this country are indicated in the following table reproduced from a memorandum on "Human

Nutrition vis-a-vis Animal Nutrition in India" prepared jointly by the Indian Council of Medical Research and the Indian Council of Agricultural Research:—

Though the Agricultural Departments are alive to the situation and some improvement has been effected through the development and propagation of suitable fodder crops, only the fringe of the problem seems as yet to have been touched. The Planning Commission have recommended that action for improving livestock feeding may first be attempted in Community Projects and Key Village Areas so that the benefits of improved breeding and improved feeding may be simultaneously available to the live-stock of these areas. Obviously, even at best, legislative measures can have a minor role to play in the improvement of live-stock feeding. It is through the creation of proper environments by propaganda, arranging supplies, etc., that the State can help in the solution of this problem, beginning with such areas where other development work is at present concentrated and people are psychologically prepared for the adoption—individually and collectively—of improvements suggested to them. For example, the Royal Commission on Agriculture recommended a regulated use of the common grazing lands with a view to increasing their productivity. It is for the village panchayats to frame and implement such programmes of regulation and most State Panchayat Acts confer powers on the Panchayats for this purpose.

7. Prevalence of cattle diseases presents one of the most serious obstacles to the improvement of cattle. Its direct effects on the economy of small cultivating units where live-stock is responsible for a very large proportion of the working capital of such units can be very easily imagined. One of the important causes of the indebtedness of many cultivators is considered to be the loss of live-stock through disease. The Royal Commission on Agriculture analysed the figures relating to loans granted by co-operative credit societies in the four Provinces of U. P., Punjab, Madras and Bihar (and Orissa) during 1924-25 and 1925-26 and found that in U.P. the percentage of total loans given by the societies for purchase of cattle came to 37.7 and 36.7 respectively in those two years. The corresponding figures for Punjab were 20.75 and 20.5; for Madras, 7.5 and 7.0 and for Bihar (and Orissa),

13.0 and 11.0. They also found from still more detailed analysis of the figures relating to one of these provinces that borrowing for cattle-purchase was mainly due to losses caused by disease and not to the desire just to buy additional cattle or to replace worn-out bullocks. Such conditions obviously have a very great depressing effect on the standards of cultivation. The indirect effects of a high mortality among cattle may be even more harmful, for it affects the entire attitude of cultivators towards questions of stock improvement. Many small cultivators are tempted to rear inefficiently more cattle than they require in order to maintain reserves against losses by disease. On the other hand, the more affluent among the cultivators who could, with benefit to themselves as well as others in the industry, engage in cattle breeding are deterred from that course by a high mortality among live-stock. These attitudes affect the entire live-stock economy of the country. Programmes for control of disease are, therefore, very vital to any programme of cattle improvement. Such programmes would consist of provision of adequate medical assistance at suitably situated veterinary dispensaries through qualified veterinary staff, adequate arrangements for inoculation, segregation of affected animals, special measures during any outbreak of infectious diseases, etc. The Royal Commission on Agriculture, which made detailed recommendations in regard to arrangements for research on cattle disease and organisation of a veterinary service for the country, also recommended that the State Governments must acquire powers to enforce veterinary police measures for controlling the spread of infection and suggested that a comprehensive Contagious Disease of Animals Act should be passed for the whole of British India in order to legalise all powers needed for dealing with any cattle disease. While before this Commission reported, the Madras Cattle Disease Act, 1866, applicable to Madras, was the only legislative measure on the subject adopted in any part of India, a number of such Acts are, however, now in force in various States and their provisions generally conform to the suggestions made by the Royal Commission on the subject.

- 8. While live-stock improvement and control of live-stock diseases are the most important subjects covered by live-stock legislation in India, legislative measures for the preservation of cattle and prevention of cruelty to animals are also in force in many States. The measures relating to preservation of cattle aim at prevention of any wanton slaughter of such cattle as can be useful for breeding, dairying or agricultural purposes and those for prevention of cruelty to animals provide for the proper care and treatment of animals suffering from injuries, mal-treatment, etc. The entire legislation on live-stock can thus be grouped under five subjects, viz.:—
 - (a) Live-stock Improvement;
 - (b) Prevention of Cattle Diseases;
 - (c) Preservation of Cattle;
 - (d) Prevention of Cruelty to Animals; and
 - (e) Cattle Trespass.

A brief resume of the legislative enactments passed in the various States on each of these subjects is given below.

(a) Live-stock Improvement

Legislation aiming at an upgrading of the live-stock through improved breeding has been passed in the States of Bombay, Madhya Pradesh, Madras, Punjab, Jammu and Kashmir, Mysore, PEPSU, Rajasthan, Travancore-Cochin, and Cocrg. There is a very large measure of uniformity in the provisions of these State enactments and, with very minor differences in procedural details, they seek the elimination of defective bulls from use for breeding purposes through compulsory castration of all bulls which are not fit or are not meant for breeding on the one hand and licensing or supply of approved bulls for breeding purposes on the other.

As explained above, in most areas there is a shortage of quality breeding bulls in relation to their total requirements. In order, therefore, to ensure that the restrictive powers assumed by the State Governments under these Acts in regard to the use of bulls for breeding are used only in such areas where an adequate supply of quality bulls can be arranged, most of these Acts (or parts thereof) come into operation in any area only when the State Government issues a notification to that effect. Thus, in some States like Madras, Jammu and Kashmir, Madhya Pradesh, Mysore and Travancore-Gochin, the authorities may, by notification, apply any or all of the provisions of their relevant Live-stock Improvement Acts to any specified area and for specified periods. In the case of Bombay, the Act applies to the whole of the former State of Kutch, but for other areas one or more provisions of the Act can be enforced on notification. In Rajasthan (except the Sambhar Shamlat area), PEPSU and Coorg, the relevant Acts came into force simultaneously in all parts of the States.

Most of the Acts lay down that unless the owner of a bull that has attained a specified age (or stage in its development) applies for a licence for keeping the bull for breeding purposes, the Licensing or the Live-stock Officer appointed under the Acts can order such a bull to be castrated. The owner is given the option to make his own arrangements for castration, if he so desires. In Rajasthan, such castration can be ordered only after consultation with the Village Mukhia. In cases of stray bulls when the ownership cannot be traced, the bull may be seized by the Live-stock Officer and if, in the opinion of the Live-stock Officer, the animal has attained the prescribed age and is suffering from some disease or is otherwise unsuitable for breeding purposes, he may get it castrated and give it a prescribed mark. The animal can then be auctioned off or kept in a pinjrapole. When the owner has been traced out, he will be paid the sum realised through the auction if the bull was auctioned off or, if the bull was sent to a pinjrapole, it would be returned to the owner.

In the notified areas of Bombay, Madras, Mysore, Rajasthan, Travancore-Cochin, Coorg and Kutch, the owner of a bull which is to be kept for breeding purposes has to make an application for licence for the purpose to the Live-stock Officer or, in certain cases, to the Licensing Officer appointed for the purpose. On receipt of the application, the Live-stock or the Licensing Officer will examine the bull for which the licence is required. If on examination the bull is considered to be fit for purposes of breeding, the licence is to be granted gratis on stipulation of specified terms, conditions and restrictions under which the animal is to be kept. The Live-stock or the Licensing Officer may refuse to issue the licence if, in his opinion,

- (i) the bull appears to be of defective or inferior conformation and is likely to beget defective or inferior progeny;
- (ii) the animal is permanently affected with contagious or infectious disease; and
- (iii) the animal is permanently affected with any disease rendering the bull unsuitable for breeding purposes.

In Madras, the Live-stock Officer may also refuse to grant the licence if, in his opinion, the bull belongs to a breed which is underirable to propagate in the district or part of the district in which it is kept. In the case of Rajasthan, the Live-stock Officer while rejecting the application for grant of a licence, is required to consult the Village Mukhia. In Bombay, as in most other States, the Live-stock Officer may revoke the licence if any breach of the stipulations, terms and restrictions, etc. made therein is brought to his notice. In the States other than Bombay, the licence can also be revoked by the Officer if in his opinion it was granted under circumstances of which he was not aware at the time of its issue. The owner of a

licensed breeding bull must produce the licence when asked to do so by the Livestock or the Licensing Officer, as the case may be. The licence so granted will have to be surrendered when its tenure expires or is revoked or when the bull dies or when the animal is castrated.

In PEPSU, the legislation is somewhat different from that in other States. Thus, under the PEPSU Branded Bulls Act applicable to the whole of the State, no person is allowed to set free any bull without the previous sanction in writing of the Tehsildar of the Tehsil in which the person resides. While granting permission to release the bull, the Tehsildar is required to take into consideration the age, breed, utility and need of the animal and may refuse the permission applied for. The bull, if released, will be given a prescribed mark and used for breeding purposes only. The Act prohibits the use of these bulls for such purposes as yoking, loading, etc. Maiming, poisoning, castrating or killing of the released bulls is prohibited under the Act.

In Jammu and Kashmir, the authorities may direct the civil veterinary departments to issue approved bulls in any locality. The bulls are given either free of charge on premium or on hire to approved agents who are required to keep, maintain and use the bulls in accordance with the rules under this Act.

In Rajasthan, the authorities are empowered to regulate the dedication* of bulls. Thus, no person is allowed to dedicate a bull unless it has been certified by the Live-stock Officer as being fit for breeding purposes. The dedicated bulls which are found to be unfit for breeding purposes are liable to be disposed of in such manner as the authorities may consider fit.

For an efficient implementation of the various provisions of the Acts, the Acts in practically all the States provide for a suitable machinery for the purpose. Thus, State employees of certain departments like Revenue, Agriculture, Veterinary and Animal Husbandry, Village Officers, Village Servants, etc. residing within the notified areas are required to be vigilant about the enforcement of the Acts. Officers are expected to(i) give immediate information to the Live-stock or Licensing Officer about the commission of an offence or intention or preparation to commit an offence which may come to their notice; (ii) use their power to prevent the commission of offence and (iii) assist the Live-stock or Licensing Officer in the enforcement of the provisions of the Act.

(b) Prevention of Cattle Diseases

Legislative measures for the prevention of out-break and spread of contagious or infectious diseases among animals have been passed in the States of Assam, Bembay, Madhya Pradesh, Madras, Orissa, Punjab, West Bengal, Jammu and Kashmir, Mysore, Rajasthan, Coorg and Vindhya Pradesh. The Madras Cattle Disease Act, 1866 was the first enactment passed or the subject and it is rather surprising to find that from 1866 right up to the time the Royal Commission reported in 1928, no other province or State had passed any similar legislation. The Royal Commission commented favourably on the contents of the Madras legislation and suggested that all the Provincial Governments should arm themselves with similar powers in order to be able to deal effectively with any out-break or threat of an out-break of contagicus or infectious cattle disease.

The Cattle Diseases Acts in force in various States are very similar to one another except that the Madras Act mentioned above is not so comprehensive as those enacted more recently. The Madras Rinderpest Act, 1940, on the other hand, follows the lines of these recent Acts, to which the analysis given below generally

applies. These various Cattle Diseases Acts are enabling legislations empowering the State Governments to take certain steps which can broadly be classified into three categories, viz.,

- (i) Regulation of entry and movement of cattle;
- (ii) Isolation of infected areas and infective animals; and
- (iii) Supplementary.
- (i) Regulation of entry and movement of cattle into specified areas.—In order to be able to check the entry either of such animals as may carry infection into the State or any specified area or of uninoculated animals into areas where they would be exposed to the danger of getting infected with disease, the State Governments have the powers under all these Acts to specify the times or routes by which animals may be imported into the State or the specified area and to establish quarantine stations at suitable places along these routes for the inspection of animals and their inoculation, if considered necessary. Such animals can proceed beyond a quarantine station only after grant of a permit for this purpose by the officer-in-charge of the quarantine station.
- (ii) Isolation of infected areas and infective animals.—All the Acts make it incumbent upon the owner or the veterinary practitioner attending upon any infected animal to inform the Inspector concerned about that matter. According to the procedure laid down in the rules, the State Governments can declare an area in which an animal infected with any of the diseases specified in the Schedules to be an infected area. In regard to these infected areas, the Governments are empowered to take special measures. Movements into or out of an infected area of any animal or animal product, fodder, harness or bedding, etc., are prohibited. Animal markets or fairs are banned in infected areas. The State Governments can take measures for compulsory inoculation or vaccination of healthy animals and for compulsory segregation and treatment of infected animals.

Besides these provisions for dealing with infected areas, the Acts contain other provisions for the segregation and treatment of infected animals and certain articles required for the feeding of such animals or otherwise coming in contact with such animals. An officer authorised by the State Government in this behalf can direct any animal suspected of suffering from an infectious disease to be taken to any specified place of segregation. The animal can, after examination by a veterinary surgeon, be destroyed if found to be really suffering from an infectious disease. In such cases of the destruction of animals, compensation is to be paid to the owners. Further, the Acts provide for penalties against any person taking any infective animal to any animal market or fair. While most of the State Acts confine themselves to the provisions mentioned above, some of the Acts like Bombay and Punjab are more comprehensive and lay down some further requirements in regard to regulation of traffic of infected animals, cleansing and disinfection of vessels and vehicles, etc. The Bombay Act also prohibits grazing of any infected animal on any unenclosed land to which other persons have a right of access for grazing their animals.

(iii) Supplementary.—Supplementary provisions generally relate to the powers given under the Acts to the State Officers, viz., the Inspectors and the Veterinary Surgeons charged with the responsibility for the implementation of the Acts and laying down certain requirements on the owners and private veterinary practitioners for rendering assistance to these State Officers. Penalties are laid down for breach of any of the provisions in the Acts or the Rules framed thereunder.

(c) Cattle Preservation

The Cattle (or Animal) Preservation Acts enacted in the States of Assam, Bombay, Madhya Pradesh, West Bengal, Hyderabad, Mysore and Ajmer aim at the prevention of any wanton slaughter of cattle which are or can become useful. These

Acts lay down that an animal belonging to any of the classes specified in their respective schedules can be slaughtered only after a certificate has been obtained about the fitness of that animal for such a slaughter from the specified authority. The classes of animals usually included in the schedules and to which the Acts apply are cows, bulls, bullocks, calves, male and female buffaloes and buffalo calves.

The certifying authority in most cases is either a Veterinary Officer acting alone as in Bombay or a Government, Municipal or District Board Officer acting in conjunction with a Veterinary Officer as in Assam, Madhya Pradesh, etc. Most of the Acts either specify the circumstances under which a certificate can be issued or the grounds on which a request for such a certificate can be refused. The Assam, Madhya Pradesh and West Bengal Acts prohibit the issue of a certificate for the slaughter of an animal below fourteen years in age. The Hyderabad (Slaughter of Animals) Act, on the other hand, bans the slaughter of the cattle below three years in age. The other grounds on which a request for a certificate can be refused generally are—

- (i) that the animal is useful for the purpose of draught or any kind of agricultural operations;
- (ii) the animal, if male, is useful for the purpose of breeding;
- (iii) the animal, if female, is useful for the purpose of yielding milk or bearing offspring.

Under the Madhya Pradesh Act, the slaughter of a cow is banned under all circumstances. In other cases, the State Governments may exempt from the operation of these Acts the slaughter of animals for any religious, medicinal or research purposes.

The Mysore Prevention of Cow Slaughter Act, 1948 is a type in itself in that it totally bans the slaughter of a cow, bull, bullock, buffalo or calf except when it has been certified to be suffering from rabies. Even the export of such cattle for slaughter outside Mysore is prohibited. Further, the State Government can establish or direct any local authority or private individual to establish institutions for taking care of cows sent there and the State Government can levy taxes to maintain such institutions.

(d) Prevention of Cruelty to Animals

The Central Prevention of Cruelty to Animals Act, 1890 is a simple permissive measure generally empowering the State Governments, through extension of this Act to any area, to render commission of specified offences against animals punishable under the law. The Act provides for penalties against a number of specified acts of cruelty, the more important among which are:—

- (i) Over-driving, heating, binding, etc. of animals;
- (ii) Abandoning any animal in circumstances which render it likely that it will suffer pain;
- (iii) Overloading an animal;
- (iv) Practising 'phooka' or 'doom-dev';
- (v) Killing animals with unnecessary cruelty;
- (m) Employing in any labour any animal unfit for that type of labour;
- (vii) Baiting or inciting animals to fight unless such fighting is not likely to cause injury or suffering;
- (viii) Permitting diseased animals to go at large in public places.

The Act also prohibits the offer for sale of (a) any animal suffering from pain due to mutilation, starvation, etc. and (b) the dead part(s) of any animal which has been killed in an unnecessarily cruel manner.

The State Governments may establish infirmaries for the treatment and care of animals against which any offence is committed. The other provisions relate to consequential matters like the destruction of mortally injured animals, recovery of expenses on animals treated in infirmaries, etc.

(e) Cattle Trespass

The Central Cattle Trespass Act, 1871, which in its application to certain States like West Bengal, Assam, Bombay and Orissa has been amended in some of its details, is a permissive legislation generally empowering State Governments to take certain steps for checking the damage caused by stray animals to crops, public roads, canals, embankments, etc. The Act provides for the establishment of a pound for each village, the appointment of a pound-keeper, the seizure of stray cattle found damaging crops and their deposit at the pound, management, delivery or sale of impounded cattle, etc. and lays down directions in respect of other procedural and consequential matters.

Any cattle found damaging any land or crop grown thereon can be seized by any individual interested in such land or crop and handed over to the keeper of the pound for the locality. Persons in charge of public roads, embankments, etc. can take similar action in respect of cattle found damaging such public property. The keeper of the pound is to feed and water the cattle till such time when they leave the pound. In case the owner of the cattle does not claim it within seven days of its being impounded, it can be sold off after a proclamation to that effect has been made according to the procedure laid down in the Act. Details regarding procedure for realisation of fines and charges for feeding, etc. and disposal of the sale proceeds in case some cattle is sold out are laid down in the Act.

II. FISHERIES

In view of the vast scope for the development of fisheries in India, it is difficult to over-emphasise its importance in improving the standard of Indian diets on the one hand and for enlarging the opportunities for employment available to our rural population on the other. Fish is rich in those very constituents of food, like proteins, mineral substances and assimilable fats, in which Indian diets are known to be specially deficient. On the other hand, the per capita consumption of fish in India, which has been estimated to be about 3.4 lbs. per annum, compares very unfavourably with the estimated consumption in certain other Asian countries like Burma (70 lbs.), Ceylon (16 lbs.) and Japan (90 lbs.). This indicates roughly how great is the scope for the expansion of demand for fish even in a country where certain sections of the population are averse to including it in their diet. The scope for increasing the supplies is also equally large, for, till recently only very little attention was paid to the development or even conservation of fisheries. As stated by the Planning Commission in their First Five Year Plan, "only a small portion of the resources is being exploited at present".

The fisheries development programme under the First Five Year Plan aims at raising the production of fish in the country from the pre-Plan figure of 1 o million tons to 1 5 million tons. The programme embraces both inland and marine fisheries and lays down priorities for dealing with their various problems of conservation and development. For inland fisheries, the Planning Commission have suggested a rapid survey to determine the culturable waters and simultaneously to determine fish seed resources for undertaking large-scale stocking. Prevention

of overfishing, conservation of fisheries and fish-seed sources, research aiming at evolving suitable methods for inducing artificial spawning of certain species of fish, destruction of water hyacinth, reclamation of swamps, improvement of tanks and acquisition of necessary powers for development of private waters are some of the other aspects of the programme relating to inland fisheries. Suggestions regarding development of marine fisheries relate to: mechanisation of country craft and introduction of new mechanised boats; introduction of mothership operations, charting for deep sea fishing and development of the located fishing grounds; provision of training facilities; creating adequate ground organisation; supply of fishery requisites to fishermen; facilities for provision of ice and cold storage and efficient marketing.

For the implementation of this programme, modifications in the legal framework governing this industry have probably a very small role to play. The Planning Commission themselves have made only one suggestion in this regard, namely, the acquisition by the State Governments of fishery rights in such private waters whose owners fail to carry out the suggestions made by the State Fisheries Department. This is in line with the similar recommendation of the Planning Commission in regard to large individual holdings which are not efficiently managed.

But though legislation does not occupy a very important place in the present programmes for the development of fisheries, the importance of the State acquiring powers for the conservation of fisheries has been realised ever since 1873 when Dr. F. Dey, the then Inspector-General of Fisheries, published his two reports on "Fresh-water Fish and Fisheries of India and Burma" and "Sea Fish and Fisheries of India". In these reports, Dr. Dey directed attention to the need for adopting, inter alia, legislative measures to counter the deleterious effects on our fisheries, of irrigation works on the one hand and indiscriminate fishing on the other. After a lengthy correspondence on this subject of fisheries legislation between the Central and the Provincial Governments, the first legislative enactment on fisheries, namely, 'The Indian Fisheries Act', was passed in 1897. This was a purely protective measure firstly, prohibiting the use of any explosive or poisonous material for catching or destroying fish (except when permitted by a Provincial Government through a notification to that effect) and secondly, empowering the Provincial Government to make rules for certain purposes and apply them to any specified waters in which no person had any exclusive right of fishery. In case of private waters, these rules could be made applicable only with the consent of persons having exclusive rights of fishery therein. Through such rules, the Provincial Governments could regulate:

- (i) the erection and use of fixed engines;
- (ii) the construction of weirs; and
- (iii) the dimension and kind of the nets to be used and the modes of using them.

Further, the Provincial Governments could prohibit all fishing in any specified water for a period not exceeding two years.

Most of the larger States have adapted this Indian Fisheries Act (1897) for their own areas with slight extensions. Only the States of Orissa, Ajmer, and PEPSU do not have any legislation on fisheries in force in their areas. As most of the Acts follow a uniform pattern, some of the Acts e. g., those in force in Rajasthan, Hyderabad and Jammu & Kashmir have not been reproduced in the body of book.

Prohibition of fishing except under a licence is an important measure for the preservation and conservation of fish resources. In order to be able to prevent depletion of any fisheries, most State Governments have assumed powers to prescribe various measures for this purpose such as closed season, mesh of nets, minimum size for certain species of fish and modes of fishing operations.

The above account of the nature of Fisheries Acts in force in most States shows that they generally provide an adequate sanction for the measures needed for the conservation and protection of all fisheries except the private ones. Action in respect of private waters on the lines recommended by the Planning Commission has been taken in West Bengal, while it is under consideration in certain other States.

The major problem in regard to fisheries, however, is the problem of development and that, as stated above, is being tackled under a well-defined programme whose scope, it is hoped, will be adequately expanded in the Second Five Year Plan.

II. ACTS ON LIVE-STOCK

A. Live-stock Improvement

THE BOMBAY LIVE-STOCK IMPROVEMENT ACT, 1933

BOMBAY ACT XXII OF 19331

An Act to provide for the improvement of live-stock

Whereas it is expedient to provide for the improvement of live-stock in the manner herein provided;

AND WHEREAS the previous sanction of the Governor General required under sub-section (3) of section 80-A and the previous sanction of the Governor required under section 80-C of the Government of India Act, have been obtained for the passing of this Act;

IT is hereby enacted as follows:---

- 1. This Act may be called the Bombay Live-stock Im- Short title, provement Act, 1933.
- 2. (a) Section 1 and this section extend to the whole Extent. of the Presidency of Bombay.
 - (b) On a written application made-
 - (i) by the district local board with the previous concurrence of the Director of Agriculture, or
 - (ii) by the Director of Agriculture with the previous concurrence of the district local board

the ²[State] Government may, by notification in the ³[Official Gazette], direct that the remaining provisions of this Act shall extend to any village in respect of which the application has been made.

- (6) "Rules" means rules made under section 23;
- (7) "Village" means a village as defined in the Bombay Bom. V of Land Revenue Code, 1879; and
- (8) "A person is said to keep a bull" if such person owns the bull or has the bull in his possession or custody.

Refusal to grant or revocation of li-

- 7. (1) Subject to rules, the Live-stock Officer authorised to grant the licence may refuse to grant or may revoke a licence, if in the opinion of such authority, the bull appears to be—
 - (a) of defective or inferior conformation and likely to beget defective or inferior progeny; or
 - (b) permanently affected with any contagious or infectious disease; or
 - (c) permanently affected with any other disease rendering the bull, unsuitable for breeding purposes.
- (2) The Live-stock Officer granting a licence may also revoke a licence if in the opinion of such officer there be any breach of any of the terms or conditions of the licence.
- (3) No person shall be entitled to any compensation for the revocation of a licence under sub-section (1) or (2).
- (4) If a licence is revoked under sub-section (1) or (2), the Live-stock Officer revoking the licence shall give notice to that effect to the owner or the person stated therein to be the owner of the bull and any such notice given in respect of a licence shall state the grounds for the revocation.

 - (h) under section 17, prescribing the manner and form in which a bull shall be marked and the manner in which a Live-stock Officer shall enter any premises or other place.
- (3) Rules made under this section shall be subject to the condition of previous publication in the ²[Official Gazette].
- (4) Rules made under this section shall be laid ³[before each of the ¹[Houses] of the ¹[State] Legislature] at the session ⁴[thereof] next following and shall be liable to be modified or rescinded by a resolution ⁵[in which both the Chambers

THE Bombay Live-stock Improvement Act, 1933, is extended to Kutch by Notification dated September 8, 1952 subject to the following modifications:—

- (1) Throughout the Act for the words "Presidency of Bombay" the words "State of Kutch" shall be substituted.
- (2) For the words "State Government" wherever they occur, the words "Chief Commissioner" shall be substituted.
- (3) For clause (b) of section 2, the following clause shall be substituted, namely:—
 - "(b) On a written application made by (i) the District Local Board, a Municipal Borough, or a Gram Panchayat with the previous concurrence of the Collector, or (ii) the Collector, the Chief Commissioner may, by notification in the Official Gazette, direct that the remaining provisions of this Act shall extend to any village in respect of which the application has been made."
- (4) Sub-section 4 of section 23 shall be omitted.

MADHYA PRADESH LIVE-STOCK IMPROVEMENT ACT, 1950

ACT XX OF 1950

An Act to provide for the improvement of live-stock in Madhya Pradesh

Preamble.

WHEREAS it is expedient to provide for the improvement of live-stock in Madhya Pradesh;

It is hereby enacted as follows:-

Short title and extent.

- 1. (1) This Act may be cited as Madhya Pradesh Livestock Improvement Act, 1950.
 - (2) It extends to the whole of Madhya Pradesh.

Definitions.

 - (a) "approved bull" means a bull certified as such under section 7 or supplied by Government in a local area for breeding purpose;
 - (b) "bull" means a male calf above such age as the State Government may, by notification, prescribe for any local area;
 - (c) "Director" means Director of Veterinary Services, Madhya Pradesh;
 - (d) "Live-stock Officer" means the Director and includes any officer authorised by him to exercise all or any of the powers under the Act;
 - (e) "prescribed" means prescribed by rules made under this Act.

Power to specify area.

- 3. (1) The State Government may, by notification, declare any part of the State to be a specified area for the purposes of this Act and thereupon the provisions of sections 4 to 20 shall come into operation in such area.
- (2) No such notification shall be issued unless the State Government is satisfied that the number of bulls in the specified area which are fit to be certified as approved under section 7 together with such number of bulls as may be supplied by State Government, in any local area for breeding purpose will be adequate to maintain the rate of propagation of the species.
- (3) The State Government may, after recording reasons for doing so, cancel at any time a notification issued under sub-section (1).
- (4) The validity of any notification issued under sub-section (1) or (3) shall not be called into question in any proceeding before any court or authority.

- (2) Such castration shall be performed or caused to be performed by the Live-stock Officer free of charge, unless the owner or other person keeping the bull desires to make his own arrangements for complying with the order.
- (3) If the keeper of the bull fails to comply with the order within the time allowed under sub-section (1), then without prejudice to any action that may be taken under section 17 the Live-stock Officer shall get the bull castrated free of charge.

(4) The Live-stock Officer shall cause every bull so castrated to be branded with the appropriate mark.

THE MADRAS LIVE-STOCK IMPROVEMENT ACT, 1940

Act XV of 1940

An Act to provide for the improvement of live-stock in the province of Madras

Whereas it is expedient to provide for the improvement of live-stock in the province of Madras;

AND WHEREAS the Governor of Madras has, by a Proclamation under section 93 of the Government of India Act, 1935, assumed to himself all powers vested by or under the said Act in the Provincial Legislature.

Now, therefore, in exercise of the powers so assumed to 26 Geo. 5. himself, the Governor is pleased to enact as follows:— Ch. 2.

Short title, extent and commence-ment.

- 1. (1) This Act may be called the Madras Live-stock Improvement Act, 1940.
 - (2) It extends to the whole of the ¹[State] of Madras.
- (3) This section shall come into force at once, and the ¹[State] Government may from time to time by notification in the Fort St. George Gazette apply all or any cf the remaining provisions of this Act to the whole or any portion of the ¹[State] of Madras from such date and for such period, if any, as may be specified in the notification, and may cancel or modify any such notification.

Definitions.

- 2. In this Act, unless there is anything repugnant in the subject or context—
 - (a) "bull" includes 2 buffalo-bull;
 - (b) "cow" includes a buffalo-cow and a heifer;
 - (c) "Director" means the officer appointed by the ¹[State] Government as the Director of Veterinary Services for the ¹[State] of Madras and includes any other person on whom the powers or duties of the Director under this Act have been conferred or imposed under section 3;
 - (d) "licence" means a licence granted under section 4;
 - (e) "licensing officer" means the Director or any other officer or person authorized to grant licences under section 4;
 - (f) "prescribed" means prescribed by rules made under this Act;
 - (g) a person is said to "keep a bull" if he owns the bull or has the bull in his possession or custody; and
 - (h) a bull is said to be "castrated" if it is rendered incapable of propagating its species.

No fee shall be charged for the grant of the licence.

- (4) The power to make rules conferred by this section shall be subject to the condition of the rules being made after previous publication.
- (5) All rules made under this section shall be published in the Fort St. George Gazette and upon such publication shall have effect as if enacted in this Act.
- 21. Nothing contained in this Act shall apply to a bull Saving. dedicated in good faith to a religious purpose in accordance with any religious usage or custom, provided that notice of the dedication is given in the prescribed manner to the licensing officer.

 - (a) all matters required to be prescribed under this Act;
 - (b) the powers and duties to be exercised and performed by officers or persons acting under this Act and the procedure to be adopted by them in so acting; and
 - (c) the approved age of a bull for purposes of breeding in any local area.
- (3) All rules shall be subject to the conditions of previous publication.

THE JAMMU AND KASHMIR LIVE-STOCK IMPROVEMENT ACT, SAMVAT 1996

ACT XXIII OF SAMVAT 1996

An Act to provide for improvement of live-stock

Preamble. Whereas it is expedient to provide for the improvement of the live-stock in the Jammu and Kashmir State;

It is hereby enacted as follows:-

Short title.

r. This Act may be called the Jammu and Kashmir Live-stock Improvement Act, Samvat 1996.

Extent.

It shall extend to such places in the Jammu and Kashmir State as may from time to time be notified in the Jammu and Kashmir Government Gazette by the Government in this behalf.

Definitions.

- 2. In this Act, unless there is anything repugnant in the subject or context—
 - (a) "Live-stock" includes bull, bullock, cow, heifer, calf and buffalo;
 - (b) "Live-stock Officer" means an officer or person appointed or invested with power under section 3;
 - (c) "Prescribed" means prescribed by rules made under this Act;
 - (d) "Keeper" means the person who keeps any live-stock as owner or hirer or as an approved agent under section 9;
 - (e) "Improvement" includes castration of males unfit for breeding work and distribution of improved sires for breeding purposes;
 - (f) "Premium Bulls" means bulls issued by the Government for breeding purposes;
 - (g) "Licence" means a licence granted under section 5.

Live-stock Officer. 3. The Government may, by general or special order published in the Jammu and Kashmir Government Gazette, invest an officer or officers of the Civil Veterinary Department with powers to function as Live-stock Officer or Officers.

Prohibition for keeping a bull for breeding purposes.

4. No keeper will keep a bull for breeding purposes; except under and in accordance with terms, conditions and restrictions of a licence granted under section 5.

Grant, refusal to grant purposes shall be granted in the prescribed form by the Liver of a licence. Stock Officer.

(2) No see shall be levied for the grant of such licence.

The Jammu and Kashmir Live-stock Improvement Act, Samvat 1996

- (3) The Live-stock Officer may refuse to grant, or may revoke, a licence, if in the opinion of such officer, the bull
 - (i) of defective or inferior conformation and likely to beget defective or inferior progeny; or
 - (ii) permanently affected with any contagious or infectious disease; or
 - (iii) permanently incapacitated rendering the bull unsuitable for breeding purposes.
- (4) The Live-stock Officer may revoke a licence after giving 30 days' notice to the licence-holder if in the opinion of such officer, the terms and conditions under which it was issued have not been complied with or fulfilled.
- (5) No person shall be entitled to any compensation for the revocation of a licence under sub-clause (3) or (4).
- 6. A licence granted under section 5 shall remain in Duration of force-
 - (i) for the period specified therein; or
 - (ii) until it is revoked under this Act;
 - (iii) until the bull dies or is castrated.
- 7. The Live-stock Officer may, when he is satisfied that a Grant of licence granted under section 5 has been lost or destroyed, duplicate issue to the holder a duplicate of the licence on the applicant licence. paying a fee of eight annas, and thereupon all the provisions of this Act shall apply to the duplicate as if it were the original licence.

- 8. (1) If the Live-stock Officer is satisfied that a bull Castration, whether in possession of a keeper or not is unfit for breeding purposes, he shall pass a provisional order for its castration and notify such order in the locality in the prescribed manner.
- (2) The keeper or owner of such bull may within 30 days of such notification appear before the Live-stock Officer to show cause against such order and the Live-stock Officer may withdraw, either make the order absolute or suspend it.
- (3) If no cause is shown against the order within 30 days of such notification, the order shall be made absolute and carried into effect.
- 9. (a) Government may direct that bulls be issued by Premium the Civil Veterinary Department to approved agents in any bulls. locality either free of charge on premium, or on hire for breeding purposes.
- (b) Such bulls shall be kept, maintained and used for covering purposes by the agents in accordance with the rules made under this Act.
- 10. (1) Every keeper, shall, when so required by the Inspection of Live-stock Officer or any other officer of the Veterinary De-bulls. partment, produce any bull in his possession for the inspection of such officer at such reasonable time and place may be notified by such officer and shall render all reasonable assistance for the purpose of such inspection.

- (2) It shall be the duty of every person holding a licence issued to him under section 5 for keeping a bull to produce such licence on demand by-
 - (i) the Live-stock Officer or any other officer of the Veterinary Department at the place where the bull is for the time being kept; or
 - (ii) the keeper of a cow before such cow is covered by such bull,

Penalty.

II. Any person, who

- (a) keeps a bull for covering purposes without licence or in contravention of the terms of a licence issued to him under this Act; or
- does not produce the bull or bulls as required by
- section 10 (1);
 (c) does not render reasonable assistance in conducting the inspection; or
- (d) does not produce the licence as required by section
- 10 (2); obstruct the castration of bulls declared unfit for breeding purposes; or
- (f) in any other manner contravenes this Act or any rules or orders made under this Act;

shall be served with a notice by that Live-stock Officer to comply with the requirements of this Act or rules or orders as the case may be and if the keeper in spite of such notice fails so to comply within 30 days from the date of the receipt of such notice he shall be deemed to have committed an offence under this Act and shall be punishable on conviction before a magistrate with a fine which may extend to Rs. 50 for each such offence.

Cognisance.

- 12. (a) Information as to commission of an offence under this Act may be given to the officers of the Civil Veterinary Department and Revenue Department who shall convey the same to the Live-stock Officer.
- (b) No court shall take cognisance of any offence under this Act, except on a complaint presented by a Live-stock Officer in that behalf.

from other Departments.

13. All village officials and all officers of the departments of Revenue, Agriculture and Co-operative shall, when called upon to do, render all reasonable assistance to the Live-stock Officer in carrying out the provisions of this Act.

Live-stock Officer a public servant.

14. Every Live-stock Officer shall be deemed to be a public servant within the meaning of section 21 of the Ranbir Penal Code.

Protection.

15. No suit or prosecution or other legal proceeding shall lie against the Live-stock Officer for anything done or intended to be done in good faith, under this Act or of the rules made thereunder.

Powers to frame rules.

- 16. (a) Government may make rules for carrying into effect the provisions of this Act.
- (b) All rules made under this Act shall be subject to the condition of previous publication in the Government Gazette.

THE **MYSORE** LIVE-STOCK **IMPROVEMENT** ACT, 1951

Mysore Act XIX of 1951

An Act to provide for the improvement of live-stock in the State of Mysore

Whereas it is expedient to provide for the improvement of live-stock in the State of Mysore;

It is hereby enacted as follows:-

Short title, extent and commence

- 1. (1) This Act may be called the Mysore Live-stock Improvement Act, 1951.
 - (2) It extends to the whole of the State of Mysore.
- (3) This section shall come into force at once, and the State Government may, from time to time, by notification in the Mysore Gazette, apply all or any of the remaining provisions of this Act to the whole or any portion of the State from such date and for such period, if any, as may be specified in the notification, and may cancel or modify any such notification.

Definitions.

- 2. In this Act, unless there is anything repugnant in the subject or context,-
 - (a) "Director" means the officer appointed by the State Government as the Director of Animal Husbandry Services in Mysore and includes any other person on whom the powers or duties of the Director under this Act have been conferred or imposed under section 3;
 (b) "licence" means a licence granted under section 4;

 - (c) "licensing officer" means the Director or any other officer or person authorised to grant licences under section 4;
 - (d) "prescribed" means prescribed by rules made under this Act;
 - (e) a person is said to "keep a bull" if he owns the bull or has the bull in his possession or custody; and
 - (f) a bull is said to be "castrated" if it is rendered incapable of propagating its species.

Conferment 3. The State Government may, by general or special of powers or order, confer or impose on any person all or any of the powers Director.

Or duties of the Director under this Act.

Bulls which 4. (1) No person shall keep a bull which has attained the age corresponding to the eruption of the two central incisor teeth for the purpose of serving cows except under and in accordance with the terms, conditions and restriction of a licence granted under this section.

Explanation.—Where a person keeps more than one bull he shall obtain a separate licence in respect of each bull.

- (2) Every licence under this section shall be granted by the Director or any officer or person not below the rank of Veterinary Inspector authorised by him by general or special order. It shall be in such form, for such period, and subject to such terms, conditions and restrictions as may be prescribed. No fee shall be charged for the grant of the licence.
- 5. (1) Subject to such rules as may be prescribed, the Refusal and licensing officer may refuse to grant or may revoke a licence revocation of in respect of any bull if in his opinion the bull appears to be—licences.

- (a) of defective or inferior conformation and consequently likely to beget defective or inferior progeny,
- (b) suffering from an incurable, contagious or infectious disease or from any other disease rendering the bull unsuitable for breeding purposes, or
- (c) of a breed which is undesirable to propagate in the district or part of the district in which it is kept.
- (2) The licensing officer may also revoke a licence granted in respect of any bull kept within his jurisdiction (whether such licence was granted by himself or by any other officer) if in his opinion-
 - (a) the licence was granted under circumstances of which the licensing officer was not aware at the time of granting the licence; or
 - (b) there has been a breach of any of the terms, conditions or restrictions of the licence.
- (3) If a licence is revoked under this section, the officer revoking the licence shall give notice thereof to the person keeping the bull or to the person stated in the licence to be the owner of the bull. The notice shall set out the grounds for the revocation.
- (4) Where the officer or person refusing to grant or revoking a licence under sub-clause (1) or sub-clause (2) is not the Director, an appeal shall lie against such order to the Director.
- (5) No person shall be entitled to any compensation for the refusal or revocation of any licence under this section.
- - (a) the period specified in the licence expires, or
 - (b) the licence is revoked under this Act, or
 - (c) the bull dies or is certified by the prescribed officer to have been effectively castrated by a method and in a manner approved by the Director.
- 7. If the licensing officer is satisfied that the licence Grant of granted under section 4 has been lost or destroyed, such duplicate officer may, subject to such conditions and payment of licence.

such fees, as may be prescribed, issue to the holder of the licence a duplicate thereof, and all the provisions of this Act with respect to the licence so lost or destroyed shall apply to the duplicate as if it were the original licence.

Inspection of bulls.

8. The licensing officer may by order require any person keeping a bull to submit it for inspection by himself or by any officer or person deputed by him for the purpose, at any reasonable time, at the place where the bull is kept for the time being and thereupon it shall be the duty of the person keeping the bull to submit it for inspection accordingly, and render all reasonable assistance in connection with such inspection to the officer concerned.

Power to

- (1) The licensing officer may, by order, require any order castraperson keeping a bull required to be licensed under section 4
 and in respect of which no licence is for the time being in force under this Act, to have it effectively castrated, within three months from the date of service of the order.
 - (2) Such castration shall be performed or caused to be performed by the licensing officer free of charge, unless the owner or other person keeping the bull desires to make his own arrangements for complying with the order.

Production of licence.

- 10. It shall be the duty of any person who for the time being keeps a bull in respect of which a licence has been obtained and is in force, to produce such licence:
 - (a) within a reasonable time, at any place where the bull is for the time being, on demand made by a licensing officer or any officer of the Animal Husbandry Department not below the rank of Veterinary Inspector, or
 - (b) before a cow is served by the bull, on demand made by the person in charge of the cow.

Penalties.

- 11. Whoever-
 - (a) keeps a bull, in contravention of the provisions of this Act or of any rule or order made thereunder, or of any terms, conditions or restrictions of a licence;
 - (b) neglects or fails to submit a bull for inspection when required to do so under section 8; or
 - (c) neglects or fails to comply with an order served under section 9; or
 - (d) neglects or fails to produce a licence when required to do so under section 11;

shall be punishable with fine which may extend to fifty rupees and in case of a second or any subsequent offence, with fine which may extend to one hundred rupees.

Power licensing officer to

12. (1) If a person who keeps a bull neglects or fails to have it castrated when required to do so under section 9, castrate bulls, the licensing officer may direct that the bull shall be castrated by a method and in a manner approved by the Director and marked with a prescribed mark in the prescribed manner, free of charge.

- (2) (a) If it is not known in whose ownership, possession or custody a bull is for the time being, and the fact cannot be ascertained after an enquiry in the prescribed manner, the licensing officer may seize the bull or cause it to be seized, and if he is of opinion that the bull has attained the age specified in section 4 and is unsuitable for breeding purposes on any of the grounds specified in sub-section (1) of section 5, may direct that the bull be castrated by a method and in a manner approved by the Director and marked with a prescribed mark in the prescribed manner, free of charge.
- (b) Every bull seized under clause (a) shall, after it has been castrated and marked as aforesaid where necessary, be sold by public auction or sent to a pinjrapole or infirmary, recognised by the State Government in this behalf.
- (c) In case the owner of any bull seized under clause (a) appears before the licensing officer within such time as may be prescribed in this behalf and proves to the satisfaction of such officer that the bull is owned by him:
 - (i) in case the bull has been sold by public auction, the proceeds of ruch sale shall be paid to the owner after deducting therefrom the costs, charges and expenses incurred for the maintenance and sale of the bull; and
 - (ii) in any other case, the bull shall be delivered to the owner on payment of the costs, charges and expenses incurred for its maintenance.
- (d) The costs, charges and expenses referred to in subclauses (i) and (ii) of clause (c) shall be determined in the prescribed manner.
- 13. For the purposes of this Act, a licensing officer or Power of any officer or person authorised by him in this behalfshall have licensing officer, etc., to inspect or mark bulls

The State Government may, at any time, either suo moto or on application, call for and examine the record of any order passed by, or any proceedings recorded by any officer or person under this Act, for the purpose of satisfying themselves as to the legality or propriety of such order or as to the regularity of such proceedings, and may pass such orders in reference thereto as they think fit.

Nothing contained in this section shall apply to the orders or proceedings of any Court or Magistrate.

- 20. (1) The State Government may make rules to carry out the purposes of this Act.
- (2) In particular and without prejudice to the generality of the foregoing power, such rules may provide for—
 - (a) all matters expressly required or allowed by this Act to be prescribed;
 - (b) the circumstances in which duplicates of licences may be granted, the fees which may be charged for the grant of such duplicates, and the conditions, restrictions and limitations subject to which they may be granted;
 - (c) the powers to be exercised and the duties to be performed by officers appointed under this Act, and the procedure of such officers; and
 - (d) the service of notices and orders issued under this Act.

- (3) In making a rule under sub-section (1) or sub-section (2), the State Government may provide that a person guilty of a breach thereof shall be punishable with fine which may extend to fifty rupees.
- (4) The power to make rules conferred by this section shall be subject to the condition of the rules being made after previous publication.
- (5) All rules made under this section shall be published in the Mysore Gazette and upon such publication shall have effect as if enacted in this Act.
- 21. (1) Save as provided in sub-section (2), nothing Saving. contained in this Act shall apply to a bull dedicated in good faith to a religious purpose in accordance with any religious usage or custom, provided that notice of the dedication is given in the prescribed manner to the licensing officer.
- (2) If the licensing officer is of opinion that any such bull as is referred to in sub-section (1) is of the description set out in sub-clause (a), or sub-clause (b), or sub-clause (c) of sub-section (1) of section 5, he may cause such bull to be effectively castrated by a method and in a manner approved by the Director or cause such bull to be removed to a prescribed place.

THE PATIALA BRANDED BULLS ACT, SAMVAT 1994

ACT VI OF SAMVAT 1994

An Act to regulate the release and to prohibit the unauthorised use of branded bulls

Preamble.

Whereas it is expedient to provide for the breeding of bulls and to regulate the release and to prohibit the unauthorised use of branded bulls;

IT is hereby enacted as follows:-

Short title, extent and commencement.

- r. (i) This Act may be called the Patiala Branded Bulls Act, Samvat 1994.
 - (ii) It extends to the whole of Patiala State.
- (iii) It shall come into force a week after its publication in the Patiala Government Gazette.

Definition.

2. The "Bull" includes he-buffalo.

Frevious sanction.

- 3. No one shall release or set free any bull without the previous sanction in writing of the Tehsildar of the Tehsil in which such person resides.
- Things to be 4. (1) The Tehsildar shall in granting sanction applied considered in for under section 3 take into consideration the age, the breed, the utility and necessity of each such animal and may for sufficient reasons refuse the sanction applied for.

Appeal.

(2) An appeal against Tehsildar's order refusing sanction shall lie to the District Magistrate concerned whose order shall in this respect be final.

Maintenance of register.

5. (1) The Tehsildar shall maintain a register of all the bulls released under his sanction giving the serial No. and date of release, particulars of the bull as to age and breed and the name and full address of the person releasing the bull.

Brand Marks (2) The bull whose release has been sanctioned under the foregoing section, shall before it is set free, be branded on the right buttock with the following mark:—

(3) Under the District mark shall be branded the serial number of the bull released with capital letter of the Tehsili concerned.

Illustration.—A bull released in Tehsil Rajpura of Patiala District and registered at number 25 shall be marked as PP/25R.

- (4) The size of the letters and figures used for branding shall be at least 2½" long and ½" thick.

- (b) Every bull seized under clause (a) shall, after it has been castrated and marked as aforesaid where necessary, be sold by public auction or sent to a pinjrapole or infirmary recognized by the Government in this behalf.
- (c) In case the owner of any bull seized under clause (a) appears before the licensing officer within such time as may be prescribed in this behalf and proves to the satisfaction of such officer that the bull is owned by him—
 - (i) in case the bull has been sold by public auction, the proceeds of such sale shall be paid to the owner after deducting therefrom the costs, charges and expenses incurred for the maintenance and sale of the bull; and
 - (ii) in any other case, the bull shall be delivered to the owner on payment of the costs, charges and expenses incurred for its maintenance.
- (d) The costs, charges and expenses referred to in sub-clauses (i) and (ii) of clause (c) shall be determined in the prescribed manner.

- Bar of cer. 17. (1) No suit, prosecution or other proceeding shall tain proceed-lie against any officer or servant of the ¹[State] Government for any act done or purporting to be done under this Act without the previous sanction of the ¹[State] Government.
 - (2) No officer or servant of the [State] Government shall be liable in respect of any such act in any civil or criminal proceeding if the act was done in good faith in the course of the execution of duties or the discharge of functions imposed by or under this Act.

The Chief Commissioner may, at any time either suo motu or on application, call for and examine the record of any order passed by, or any proceedings recorded by, any officer or person under this Act, for the purpose of satisfying himself as to the legality or propriety of such order or as to the regularity of such proceedings, and may pass such order in reference thereto as he thinks fit.

B. Prevention of Cattle Diseases

THE DOURINE ACT, 1910

Аст V ог 1910¹

An Act to provide for the prevention of the spread of Dourine

WHEREAS it is expedient to provide for the prevention of the spread of dourine;

It is hereby enacted as follows:-

1. (1) This Act may be called the Dourine Act, 1910.

Short title and extent.

- (2) This section extends to ²[the whole of India except Part B States]: the rest of this Act extends only to such areas as the ²[State] Government may, by notification³ in the ⁴[Official Gazette], direct.
- 2. (1) In this Act, the expressions "inspector" and Definitions. "veterinary practitioner" mean, respectively, the officers appointed as such under this Act, acting within the local limits for which they are so appointed.

(2) The provisions of this Act in so far as they relate to entire horses shall, if the ²[State] Government, by notification as aforesaid, so directs, apply also to entire asses used for mule-breeding purposes.

- 3. The ²[State] Government may, by notification as Registration aforesaid, make such orders as it thinks fit directing and of horses. regulating the registration of entire horses maintained for breeding purposes.
- 4. (1) The ²[State] Government may, by notification Appointment as aforesaid appoint any persons it thinks fit to be inspectors, of inspectors and any qualified veterinary surgeons to be veterinary and veterinary practitioners, under this Act, and to exercise and perform, tioners. within any area prescribed by the notification, the powers conferred and duties imposed by this Act upon such officers respectively.

(2) Every person so appointed shall be deemed to be a **XLV of 1860.** public servant within the meaning of the Indian Penal Code.

Powers of 5. An inspector, may, subject to such rules as the ¹[State] inspector. Government may make in this behalf,—

- (a) enter and search any building, field or other place for the purpose of ascertaining whether there is therein any horse which is affected with dourine²;
- (b) prohibit, by order in writing, the owner or keeper of any horse, which in his opinion is affected with dourine, from using such horse for breeding purposes, pending examination by the veterinary practitioner;
- ³[(c) direct, by order in writing, the owner or keeper of any horse which, in the opinion of the Inspectors, is affected with dourine to remove it or permit it to be removed for the purpose of segregation to a place specified in the order, and such direction shall be sufficient authority for the detention of the horse in that place for that purpose.]

Duties of 6. An inspector issuing an order under section 5, 4[* *] shall forthwith forward a copy of such order to the veterinary practitioner.

Inspection of horses.

7. A veterinary practitioner receiving a copy of an order forwarded under section 6 shall, as soon as possible after receipt of such copy, examine the horse mentioned therein, and may for such purpose enter any building, field or other place.

Powers of veterinary practitioner.

- 8. A veterinary practitioner may—
 - (a) cancel any order issued under section 5 4[* *]; or
 - (b) if on microscopical examination for by other scientific test] he finds that any horse is affected with dourine—
 - (i) in the case of an entire horse, cause it to be castrated,
 - ⁶[(ii) in the case of a mare, with the previous sanction of such authority as the ¹[State] Government may appoint in this behalf, or if so empowered by the ¹[State] Government, without such sanction, cause it to be destroyed.]

An Act to make better provision for the regulation of the importation of live-stock

Whereas it is expedient to make better provision for the regulation of the importation of live-stock which is liable to be affected by infectious or contagious disorders;

IT is hereby enacted as follows:-

- 1. (1) This Act may be called the Live-stock Importa-Short tion Act, 1898. local and extent.

THE ASSAM CATTLE DISEASES ACT, 1948

Assam Act XXVI of 1948

An Act to provide for the prevention of the spread of contagious diseases among cattle in the Province of Assam

Whereas it is expedient to take measures to prevent the Preamble. spread of contagious diseases among cattle in the Province of Assam;

It is hereby enacted as follows:-

1. (1) This Act may be called the Assam Cattle Diseases Short title, Act, 1948.

(2) This Act, except sections 3 to 8, extends to the whole ment. of the ¹[State] of Assam and shall come into force at once. Sections 3 to 8 shall extend to such areas and come into force on such dates as the ¹[State] Government may, by notification, direct.

2. In this Act, unless there is anything repugnant in the Definitions. subject or context,—

- "Cattle" means cows, bull, bullocks, buffaloes, sheep and goats and the young ones of these species of both sexes and such other domesticated animals as may be prescribed;
- (ii) "Contagious disease" means a disease specified in the Schedule to this Act and any other disease which the ¹[State] Government may, by notification in the official Gazette, declare to be a contagious disease;
- (iii) "infected area" means an area in respect of which a notification under section 10 is in force;
- (iv) "infective" used with reference to an animal means affected by a contagious disease or having recently been in contact with or proximity to an animal so affected;
- (v) "Inoculation" means inoculation with any protective serum or vaccine or with both;
- (vi) "Owner" in relation to any animal includes a person having charge of such animal;
- (vii) "Prescribed" means prescribed by rules made under this Act;
- (viii) "Veterinary Officer" means any officer of the Civil Veterinary Department not below the rank of Veterinary Assistant Surgeon.

 - (a) the number of cattle seized and sold,
 - (b) the time during which they had been in custody,
 - (c) the proceeds of sale, and
 - (d) the manner in which those proceeds have been disposed of.

- (3) For the purpose of inoculation of any such animal, a Veterinary Officer may, by notice in writing, call upon the owner of the animal to produce it for inoculation at the time and place specified in such notice and such owner shall give that officer reasonable facility and assistance in carrying out the inoculation.
- **16.** For the purpose of identification, the Veterinary Marking Officer may mark the inoculated animal by branding or animals. tattooing with letters or numerals, or with both.
- 17. When inoculation has been carried out under sec-Certificate of tion 13, 14, or 15 the Veterinary Officer shall, if requested inoculation. by the owner of the inoculated animal, issue a certificate in the prescribed form showing that the animal has been inoculated against the disease shown in such certificate.

- (2) A Veterinary Officer may, when he has reason to believe that any animal had died of any contagious disease, issue a notice to the owner to bury such animal in the manner provided under sub-section (1).
- (3) No person shall disinter or otherwise remove the carcass of any animal buried in compliance with the provisions of sub-section (1) or (2).

Penalty.

22. Whoever contravenes any of the provisions of this Act, or of any rule or order made thereunder shall, on conviction, be punishable with fine not exceeding fifty rupees, or in default with simple imprisonment for a term not exceed-ing one month.

Bar of legal 23. No suit, prosecution or other legal proceedings shall proceedings lie against any person for anything in good faith done or intended to be done in pursuance of this Act.

Rules.

- (1) The ¹[State] Government may make rules for carrying out the purposes of this Act.
- (2) In particular and without prejudice to the generality of the foregoing provisions, the ¹[State] Government may make rules-
 - (a) prescribing the manner in which an area may be declared to be an infected area or a compulsory inoculation area;
 - (b) prescribing the form of notice issued under subsection (2) of section 13, section 14 and sub-section (3) of section 15;
 - (c) prescribing the form of certificate granted under section 16;
 - (d) providing for the custody of animals detained under this Act and for their feeding and watering while under detention and prescribing the charges to be levied for feeding and watering such animals and for their production by the Police before the Veterinary Officer;
 - (e) regulating the sale of animals liable to be sold under section 20;
 - (f) providing for the disinfection of buildings where infective animals are kept in infected areas;
 - (g) prescribing the manner of disposal of carcasses of infective animals under section 21;
 - (h) prescribing the fee for vaccination and marking under section 6.
- (3) All rules made under this Act shall be laid before the Assam Legislative Assembly, as soon as possible after they are made, and shall be subject to such modifications or amendments as may be made by the said Assembly.

THE BOMBAY ANIMAL CONTAGIOUS DISEASES (CONTROL) ACT, 1948

BOMBAY ACT LIX OF 1948 1

An Act to provide for the prevention and control of contagious diseases affecting animals

Whereas it is expedient to provide for the prevention and control of contagious diseases affecting animals;

It is hereby enacted as follows:-

PART I

PRELIMINARY

- 1. This Act may be called the Bombay Animal Conta-Short title, gious Diseases (Control) Act, 1948.
- 2. (1) This Act extends to the whole of the ²[State] of Extent and commencement.
- (2) This section shall come into force at once. The ²[State] Government may, from time to time, by notification in the Official Gazette, direct that all or any of the remaining provisions of this Act shall come into force in such area in respect of such scheduled disease and on such date as may be specified in the notification and may by similar notification direct that such provisions shall cease to be in force in any area from such date as may be specified therein.
- 3. In this Act unless there is anything repugnant in the Definitions. subject or context,—
 - (a) "animal" means any domesticated animal or bird, or any animal or bird kept in confinement;
 - (b) "export" means to take out of the ²[State] otherwise than across a customs frontier as defined by the *Dominion** Government;
 - (c) "import" means to bring into the *[State] otherwise than across a customs frontier as defined by the Dominion* Government;
 - (d) "infective animal" means an animal which is affected with a scheduled disease or has recently been in contact with or in close proximity to an animal so affected;
 - (e) "Inspector" means an Inspector appointed under section 4;

- (f) "prescribed" means prescribed by rules made under section 36;
- (g) "rules" means rules made under section 36;
- (h) "scheduled disease" means any disease specified in the Schedule to this Act;
- (i) "transport" means to remove to one place from another place within the '[State];
- (j) "Veterinary Surgeon" means a Veterinary Surgeon appointed under section 4.

- Appointment 4. (1) The '[State] Government may, by notification of Veterinary Surgeons and Inspectors.

PART II

PREVENTION AND CONTROL OF SCHEDULED DISEASES

Power to prohibit or regulate regulate import, export or transport of, holding of markets, fairs, etc. of, and traffic in, infective animals, etc.

- **6.** (1) The ¹[State] Government may, for the purpose of preventing the outbreak or spread of any scheduled disease by notification in the Official Gazette, prohibit, control or regulate in such manner and to such extent as it may think
 - (a) the import, export or transport of any animals, or the carcasses thereof, or of any part of animals or carcasses thereof or of any fodder, bedding or other thing used in connection with animals, which may, in the opinion of the '[State] Government, carry infection or infection, or
 - (b) the holding of animal markets, animal fairs, animal exhibitions or other concentration of animals in any specified area, or
 - (c) the sale or other dealings in, infective animals or the carcasses of animals, which at the time of their death were infective, or any fodder, bedding or

other thing used in connection with such animals which may, in the opinion of the 1[State] Government, carry infection.

- (2) The ¹[State] Government may, by notification in the Official Gazette, specify the season or seasons during which and the route or routes by which animals may be imported into the [State] and no person shall import animals into the [State] otherwise than during the season and by the route so appointed.
- (1) The ¹[State] Government may establish quaran- Establish tine stations for the inspection and detention of animals ment of along the route appointed under sub-section (2) of section 6 along the route appointed under sub-section (2) of section 6. quarant stations.

- (2) All animals inspected or detained at a quarantine station shall be liable-
 - (a) to be vaccinated against any scheduled disease if in the opinion of the officer in charge of such station it is necessary to do so; and
 - (b) to be marked in the prescribed manner.
- (3) The period of detention of animals at a quarantine station for the purpose of inspection, vaccination and marking shall be such as may be prescribed.
- (4) The animals detained at a quarantine station shall remain under the care of the person in charge who shall be responsible for their feeding and upkeep and for the payment of such fee for their vaccination and marking as may be prescribed.
- (5) The officer in charge of the quarantine station shall, at the time of release of an animal from the station, grant in such form as may be prescribed a permit to the person in charge of the animal and such person shall, while in charge of the animal, produce it whenever required to do so by an Inspector or a Police Officer.
- 8. (1) Where an Inspector has reason to believe that Power to any animal is infective he may, by order in writing, direct infective the owner or person in charge of such animal to keep it where animals and it is for the time being or to remove it or allow it to be re-their examimoved to such place of isolation or segregation as may be nation. specified in the order:

Provided that where there is no person in charge of the animal and the owner is unknown, or where the order cannot be communicated to the owner of the animal without undue delay or where the person in charge of the animal refuses to comply with the order under this sub-section, the Inspector may seize the animal and remove it to a place of isolation or segregation.

(2) The Inspector shall forthwith report to the Veterinary Surgeon every order or seizure under sub-section (1).

Power of Veterinary Surgeons to examine animals.

- 9. (1) On receipt of a report under sub-section (2) of section 8 the Veterinary Surgeon shall, as soon as practicable examine the animal and all animals with which it has been in contact or to which it has been in close proximity, and for this purpose may submit any animal to any prescribed test.
 - (2) If after such examination the Veterinary Surgeon-
 - (a) is of opinion that any animal is not infective, the Inspector shall forthwith return it to the person who, in his opinion, is entitled to its possession:

 Provided that where such person cannot, in the opinion of the Inspector, be found after reasonable inquiry, he shall send the animal to the nearest cattle pound or deal with it in such other manner as may be prescribed,
 - (b) certifies in writing that any animal is affected with a scheduled disease, the Inspector, shall destroy the animal, or deal with it in such other manner as may be prescribed, or
 - (c) certifies in writing that any animal is infective, though not diseased the animal shall be dealt with in such manner as may be prescribed.
- (3) The decision of the Veterinary Surgeon whether any animal has been in contact with or in close proximity to an animal suspected to be affected with a scheduled disease shall be final.

Compensation for animals destroyed. **xo.** (1) The owner of an animal destroyed under subsection (2) of section 9 may be paid such compensation as shall be determined in the manner prescribed:

Provided that no compensation shall be paid-

- (i) to any person convicted of any offence punishable under this act committed in respect of such animal; or
- (ii) in respect of any animal which, when it was imported, was affected with a scheduled disease on account of which it was destroyed.
- (2) The decision under sub-section (1) regarding the right of a person to be paid any compensation or the amount of such compensation shall be final.

Declaration of private infected places and examination of such places by Veterinary Surgeon. II. (1) If an Inspector has reason to believe that an infective animal is kept on any land, or in any building or other place he shall, forthwith, by order in writing, declare such land, building or place to be an infected place. The Inspector shall deliver a copy of the order to the owner, occupier or person in charge of the infected place and report his action to the Veterinary Surgeon.

Nothing in this sub-section shall apply to any place which is owned by or is under the control or management of, any local authority or a railway administration and in which animals are kept temporarily for purposes of sale or exhibition or while in transit.

- (2) On receipt of a report under sub-section (1), the Veterinary Surgeon shall, as soon as practicable, examine the infected place and the animals kept therein. After such examination, he shall either confirm or cancel the order passed by the Inspector.
- (3) If the Veterinary Surgeon confirms the order passed by the Inspector, he may declare all places in which animals are kept, temporarily or otherwise, within a radius not exceeding one mile from the infected place, to be infected places. The Veterinary Surgeon shall give a written notice of such declaration to the owners, occupiers or persons in charge of such places. The Veterinary Surgeon shall thereafter report the action taken by him under this section to the prescribed authority.
- (4) If the Veterinary Surgeon cancels the order passed by the Inspector, the place specified in such order shall cease to be an infected place and the Inspector shall give notice accordingly to the owner, occupier or person in charge of such place.
- 12. (1) Where the Veterinary Surgeon has reason to Declaration believe that an infective animal is or has been kept in any of public infected place which is owned by or is under the control or management of any local authority or railway administration or a port authority and in which animals are kept temporarily for purposes of sale, or exhibition, or while in transit, he may, by order in writing, declare such place to be an infected place.

(2) The Veterinary Surgeon shall-

- (a) cause a copy of the order passed by him under sub-section (1) to be exhibited prominently in the infected place in the regional language of the locality:
- (b) cause a copy of such order to be delivered at the office of the local authority or to the station master of the nearest railway station or to the Officer in charge of the port or in charge of a shipping office at such port, as the case may be;
- (c) cause a copy of the order to be sent to the nearest police station; and
- (d) forthwith report the action taken by him to the prescribed authority.
- 13. (1) On receipt of the report of the Veterinary Sur-Power of geon under sub-section (3) of section 11 or sub-section (2) [State] of section 12, the prescribed authority shall, after making to declare such further inquiry as it this set, submit such report with infected his remarks thereon, to the ¹[State] Government.

- (2) The ¹[State] Government on receipt of the report from the prescribed authority may-
 - (a) confirm the declaration under sub-section (1) or (3) of section 11 or sub-section (1) of section 12 either with or without modification; or
 - (b) cancel any such declaration.

- (3) Where the ¹[State] Government confirms any such declaration, either with or without modification, a notification, shall be published in the Official Gazette, defining the limits of the area to which the declaration, with the modifications, if any, made therein shall apply and declaring such area to be an infected area.
- (4) The ¹[State] Government may by notification in the Official Gazette add to, amend, vary or rescind any notifica-tion published under sub-section (3) either on its own motion or on a further report of the Veterinary Surgeon submitted to it through the prescribed authority.
- (5) On publication of a notification under sub-section (3) or (4) any place declared by the Inspector or the Veterinary Surgeon to be an infected place and not included in the infected area as defined in such notification shall cease to be an infected place and the Inspector shall give notice accordingly to the owner, occupier or person in charge of such place.
- (6) The Inspector shall cause to be exhibited, in some prominent place in the infected area and in the regional language thereof a copy of the notification issued under sub-section (3) or (4).
- (7) Where the ¹[State] Government cancels any declaration referred to in sub-section (2), any place specified in such declaration shall cease to be an infected place and Inspector shall give notice accordingly to all persons to whom copies of such declaration were delivered or on whom notices of such declaration were served.

- Removal of 14. (1) Where any area or place has been declared to animals and be an infected area or place under the foregoing provisions, from infected no person shall, while such a declaration remains in force, area or place remove any infected animal, alive or dead, or any part of prohibited an animal or any food, bedding or other thing well in nection without an animal or any food, bedding or other thing used in connection with an animal, save in accordance with the conditions of a licence granted by the Inspector.
 - (2) Nothing contained in sub-section (1) shall apply to the carriage by railway of any animal or thing referred to in that sub-section through an infected area or place:

Provided that where any such animal or thing while in transit through an infected area or place is unloaded therein, it shall not be removed therefrom save in accordance with the provisions of sub-section (1).

Provided that nothing in this section shall affect the powers of an Inspector under section 8 to deal with infective animals.

- (1) Every vessel or vehicle used by a common carrier Cleaning for the transport of animals shall be cleansed and disinfected and dis-by him at such periods and in such manner as may be vessels and vehicles.
- (2) The person in charge of every such vessel or vehicle shall, when required to do so by an Inspector, cause the vessel or vehicle to be taken to such place as the Inspector may direct and to stop and remain stationary for so long as may reasonably be necessary for the purpose of enabling the Inspector to inspect such vessel or vehicle. Powers of entry and inspection.

24. Subject to such rules as may be prescribed, an Inspector may enter upon and inspect any land, building or other place or any vessel or vehicle for the purpose of exercising the powers and performing the duties conferred or imposed on him by or under this Act.

Enforcement of orders and recovery of expenses.

- 25. (1) Where by any notice, requisition, or order made under this Act or under any rule or notification issued thereunder, any person is required to take any measures or to do anything in respect of any property owned or occupied by him or in his charge, a reasonable time shall be specified in such notice, requisition or order within which such measures shall be taken or such things shall be done, as the case may be
- (2) If such measures are not taken or such thing is not done within the time so specified, the authority issuing the notice, requisition or order may cause the measures to be taken or the thing to be done at the cost of the person concerned.
- (3) The cost of any measures taken or thing done under sub-section (2) shall be recoverable from the person concerned in the manner provided by the Code of Criminal Procedure, 1898, for the recovery of fines imposed by a Court as V of 1898. if such costs were a fine imposed by a Court.

Power of Inspector to decide whether or not animal is infective, **26.** If any question arises under this Act whether or not an animal is an infective animal, the question shall be decided by the Veterinary Surgeon and his decision shall be final.

Penalties.

27. Whoever-

- (i) fails to carry out any direction specified in, or contravenes the terms of, any notification issued under section 6 or imports any animal in contravention of the provisions of sub-section (2) thereof, or
- (ii) fails to feed or look after the upkeep of the animal under sub-section (4) of section 7 or fails to produce the permit under sub-section (5) thereof, or
- (iii) fails to comply with an order made by an Inspector under sub-section (1) of section 8, or
- (iv) removes any animal or thing from an infected area or place in contravention of the provisions of section 14, or
- (v) fails to comply with any direction given by an Inspector or a Police Officer under section 15, or

- (vi) fails to cleanse or disinfect any vessel, or vehicle used for removing animals in the manner pres-cribed as required under sub-section (1), or fails to cause any vessel or vehicle to stop and remain stationary when required to do so under sub-section (2) of section 16, or
- (vii) fails to comply with an order made by a Veterinary Surgeon under section 17, or
- (viii) fails to report that an animal is infective as required by section 19, or
 - (ix) keeps or grazes any animal which he knows to be infective in contravention of the provisions of section 20, or
 - (x) brings or attempts to bring any animal which he knows to be infective in contravention of the provisions of section 21, or
 - (xi) disinters or causes to be disinterred the carcass or any part of the carcass of any animal which at the time of its death was infective or was destroyed on account of its being infective or suspected to be infective in contravention of the provisions of section 23,

shall, on conviction, be punished with fine which may extend in the case of a first conviction to one hundred rupees, and in the case of a second or subsequent conviction whether under the same or any other clause of this section to five hundred rupees.

28. - (2) No prosecution under this section shall be instituted after the expiry of three months from the date on which the offence has been committed.

No person shall except as provided for in section 10 be entitled to any compensation on account of the destruction of any animal or thing under provisions of this Act or of any loss, injury or inconvenience caused to him by reason of anything lawfully done under this Act.

- (iv) the authority to be prescribed for the purposes of sections 11, 12 and 13;
- (v) the periods at which and the manner in which the vessels and vehicles shall be cleansed and disinfected under section 16;
- (vi) for disinfecting land, building or other place or vessel or vehicle under section 17;
- (vii) the making of post-mortem examinations under section 18;
- (viii) the distance from the shore within which carcasses shall not be placed under section 22;
- (ix) for regulating the powers of an Inspector under section 24.
- (3) In making a rule under sub-section (1) or sub-section (2), the ¹[State] Government may provide that a breach thereof shall be punishable with fine which may extend in the case of a first conviction to Rs. 50 and in the case of a second or subsequent conviction to Rs. 100.
- (4) The rules made under this section shall, subject to the condition of previous publication, be published in the Official Gazette.

THE Bombay Animal Contagious Diseases (Control) Act, 1948 is extended to Kutch by Notification dated September 8, 1952 subject to the following modifications:—

- (1) Throughout the Act for the words "Province of Bombay" the words "State of Kutch" shall be substituted.
- (2) Throughout the Act for the words "State Government" the words "Chief Commissioner" shall be substituted.
- (3) Throughout the Act for the word "Dominion" the word "Union" shall be substituted.
- (4) In section 32, the words "a Presidency Magistrate" shall be omitted.

THE [MADHYA PRADESH] CATTLE DISEASES ACT. 1934

CENTRAL PROVINCES ACT XVI of 1934

An Act to provide for the prevention of the spread of contagious diseases among cattle in the Central Provinces

WHEREAS it is expedient to provide for the prevention of Preamble. the spread of contagious diseases among cattle;

And whereas the previous sanction of the Governor General required by sub-section (3) of section 80-A of the Government of India Act has been obtained to the passing of this Act;

It is hereby enacted as follows:-

- I. (1) This Act may be called the [Madhya Pradesh] Short title, Cattle Diseases Act, 1934. extent and commence-
- (2) This Act, except sections 3 to 9, extends to the whole ment. of the Central Provinces and shall come into force at once. ³[Sections 3 to 8 and section 9] shall extend to such areas and come into force on such dates as the ⁸[State] Government may, by notification, direct.
- 2. In this Act, unless there is anything repugnant in the Definitions. subject or context,-
 - (a) "cattle" means such domesticated animals as may be prescribed;
 - (b) "contagious disease" means rinderpest and such other disease as may be prescribed; and
 - ⁴[(b-1) "Infective" means affected by a contagious disease or having recently been in contact with or proximity to a Cattle so affected, or residing in an area declared to be infected area];
 - (c) "prescribed" means prescribed by rule made under this Act.

(2) The 1[State] Government may establish quarantine stations for the inspection and detention of such cattle along the routes appointed under sub-section (1),

Vaccination and marking be liable-of cattle.

- (1) All cattle on arrival at a quarantine station shall
 - (a) to be vaccinated against contagious disease, unless the veterinary officer of the station is satisfied that they have been vaccinated against such disease within 18 months immediately preceding their arrival or within such longer period so preceding as may be prescribed; and
 - (b) to be marked in the prescribed manner.

Period of detention of cattle at quarantine station.

(2) The period of detention of cattle at a quarantine station for the purpose of inspection and vaccination shall be such as may be prescribed.

Assistance to Veterinary (3) Every person in charge of cattle shall give reasonable assistance to the Veterinary Officer of the station and his subordinates for the inspection, vaccination and marking inspection, subordinates fo etc., of cattle, of such cattle.

Feeding and upkeep of detained cattle.

5. (1) The cattle so detained shall remain, under the care of the person in charge who shall be responsible for their feeding and upkeep.

Fodder depots and watering arrangements at quarantine stations.

(2) The ¹[State] Government shall establish fodder depots through the agency of the Forest Department at quarantine stations for the supply of fodder on payment to persons in charge of cattle so detained or provide facilities for the grazing of such cattle on payment in any adjoining Government forest. The [State] Government shall, likewise, make watering arrangements at every such station, unless there is a natural supply of water close thereto, and persons in charge of cattle shall be entitled to water free of charge.

Precautions (3) Every person in charge of cattle snau, during the policy against stray of their detention, take reasonable precautions against their straying from the limits of the quarantine station or from

Liability to pay vaccina-tion and marking fee.

- 6. (1) The person in charge of cattle shall be liable to pay the prescribed fee for their vaccination and marking under section 4.
- (2) If such fee is not paid, the Veterinary Officer of the station may seize as many cattle as will, in his opinion, suffice to defray the fee leviable under sub-section (1) and forthwith report the fact to the Deputy Commissioner or such other officer as may have been appointed by the Deputy Commissioner in this behalf.
- (3) The Deputy Commissioner or other officer so appointmay, if satisfied that such fee has not been paid, such notice or proclamation as may be prescribed, and cause

 - (d) the manner in which those proceeds have been disposed of.
- 7. Complaint of seizure by being diseased, may presen a complaint against the seizure, at any time within ten days from the date thereof, to any

complaint.

The complaint may be either verbal, ir which case the substance of it shall be taken down in writing by the Magistrate, or written upon plain paper, and shall be preferred by the complainant in person, or by an agent personally acquainted with the circumstances.

Procedure thereon.

If on examination of the complainant or his agent, the Magistrate shall see reason to believe the complaint to be well founded, he shall summon the party complained against, and shall proceed to make a summary inquiry into the case.

If the seizure be adjudged illegal, the Magistrate shall award to the complainant such damages as he may deem to be a reasonable compensation for any loss or injury sustained from the unlawful seizure, together with all expenses tained from the unlawful seizure, together with all expenses of the incurred by the complainant in procuring the release of the animals; or, if the animals have not been released, the Magistrate, in addition to the award of damages, shall make an order for their release, and shall direct that the expenses leviable under this Act shall be paid by the party who made the seizure.

The amount of all damages and expenses so awarded shall be recoverable according to the process prescribed in Act No. V of 1865 (Madras), for the recovery of forfeitures or penalties imposed under the authority of Act No. XXIV of 1859.

Fees and fines to be credited to the cattlepound.

17. All fines levied under this Act shall be credited to the cattle-pound fund established under the provisions of Act No. III of 1857, which fund shall be available for payment of all expenses incurred under the provisions of this Act :

In any district or part of a district in which the provisions of the Madras Cattle Disease Act, 1866, are put in force, whenever any animal dies of any contagious or infectious disease, its owner, or the person in charge of it, shall give immediate notice of the occurrence to the keeper of the hospital-pound provided for the village or township in which the animal died, and shall see that the carcass is not skinned. The keeper of the hospital-pound shall, as soon as possible, examine the carcass and if he should be of opinion that the animal died of a contagious or infectious disease, he shall require the owner or the person in charge to have the carcass either burnt, or buried without skinning at least six feet below the surface of the ground and well covered with quicklime.

THE MADRAS RINDERPEST ACT, 1940

Act XIX of 1940

An Act to provide for the prevention and control of rinderpest in the Province of Madras

Whereas it is expedient to provide for the prevention and control of rinderpest in the Province of Madras;

AND WHEREAS the Governor of Madras has, by a Procla-26 Geo. 5 mation under section 93 of the Government of India Act, Ch. 2. 1935, assumed to himself all powers vested by or under the said Act in the Provincial Legislature;

Now, THEREFORE, in exercise of the powers so assumed to himself, the Governor is pleased to enact as follows:—

Short title, extent and commence-

- 1. (1) This Act may be called the Madras Rinderpest Act, 1940.
 - (2) It extends to the whole of the ¹[State] of Madras.
- (3) This section shall come into force at once, and the (3) This section shall come into force at once, and the ¹[State] Government may from time to time by notification in the Fort St. George Gazette apply all or any of the remaining provisions of this Act to the whole or any portion of the ¹[State] of Madras from such date and for such period, if any, as may be specified in the notification, and may cancel or modify any such notification.

- (f) removes any animal or thing from any infected area or place in contravention of section 14,

shall be punished with fine which may extend to fifty rupees in the case of a first conviction and to one hundred rupees in the case of a second or subsequent conviction whether under the same or any other clause of this section.

Penalty for keeping or grazing in-fective ani-mal in un-enclosed land.

20. Whoever keeps or grazes in or on any forest, open field, roadside, or other unenclosed land, to which other persons have a right of access for their animals, any animal which he knows to be infective, shall be punished with fine which may extend in the case of a first conviction to fifty rupees and in the case a second or subsequent conviction to one hundred rupees.

Penalty for bringing infective animal to mar-

21. Whoever brings or attempts to bring into any market, fair, exhibition or other concentration of animals, any animal which he knows to be infective shall be punished with fine which may extend in the case of a first conviction to fifty rupees and in the case of a second or subsequent conviction to one hundred rupees.

Penalty for placing car-cass of in-fective ani-mal in river.

22. Whoever places, or causes or permits to be placed, in any river, canal, or other water, or in the sea within such distance from the shore as may be prescribed the carcass or part of the carcass of any animal which at the time of its death was infective or which was destroyed as being infective or suspected of being infective, shall be punished in the case of a first conviction with imprisonment for a term which may extend to six months or with fine which may extend to one hundred rupees or with both and in the case of a second or subsequent conviction with imprisonment for a term which may extend to six months or with fine which may extend to five hundred rupees or with both.

Penalty for disinterring carcass of diseased ani-mal.

23. Whoever, without lawful authority, disinters or causes to be disinterred the carcass or part of the carcass of any animal which at the time of its death was infective or which was destroyed as being infective or suspected of being infective, shall be punished with fine which may extend in the case of a first conviction to fifty rupees and in the case of a second or subsequent conviction to a second or subsequent conviction to a second or subsequent conviction. second or subsequent conviction to one hundred rupees.

24.  - (d) the disinfection of vessels or vehicles used by common carriers, the cleansing and disinfection of buildings, yards and other places used for animals, and the destruction of infected matter or things found therein or near thereto;

- (e) the circumstances under which licences may be granted by an Inspector under section 14, and the form and conditions of such licences;

- (h) the powers and functions and the procedure of Inspectors and Veterinary Surgeons;

An Act to provide for the prevention and control of contagious diseases affecting animals

Whereas it is expedient to provide for the prevention and control of contagious diseases affecting animals;

IT is hereby enacted as follows:-

CHAPTER I

PRELIMINARY

r. (1) This Act may be called the Orissa Animal Con-Short title, extent and commencetagious Diseases Act, 1949.

 - (c) "prescribed" means prescribed by rules or regulations made under this Act;
 - (d) "scheduled disease" means any disease for the time being included in the Schedule in Appendix I.
- The diseases specified in the Schedule in Appendix Scheduled I shall in the first instance be scheduled diseases for the pur-diseases. pose of this Act, but the ¹[State] Government may by notification—
 - (a) delete any entry from the schedule, or
 - (b) include in the Schedule any communicable disease of animals to which it is expedient in their opinion that the provisions of this Act should apply.

- 5. (1) The ¹[State] Government may appoint any graduate of a recognised Veterinary College, whom they think fit to be a Veterinary Surgeon for the purposes of this Act, and may define the area within which he shall exercise the powers and perform the duties of a Veterinary Surgeon under this Act.
- (2) A Veterinary Surgeon shall have all the powers of an Inspector under this Act, and may exercise such powers concurrently with his powers as Veterinary Surgeon.

Inspectors.

6. The '[State] Government may appoint any person they think fit to be an Inspector for any or all of the purposes of this Act, and may define the area within which he shall exercise the powers and perform the duties incidental to such purposes,

Status of Veterinary Surgeons and Inspectors.

7. Any person appointed under section 5 or section 6 shall be deemed to be a public servant within the meaning of the XLV 1860.

Powers of Inspector.

8. An Inspector may, subject to any rules made in this behalf by the ¹[State] Government, enter and inspect any land or building or other place, or any vessel or vehicle, for the purpose of exercising the powers or performing the duties conferred and imposed on him by or under this Act.

- (2) The ¹[State] Government may appoint places where an Inspector may detain and inspect any such vessel or vehicle, and, if it is not in a sanitary condition, require it to be cleansed and disinfected in the prescribed manner within such time as the Inspector may appoint.
- (3) If such vessel or vehicle is not so cleansed and disinfectwithin the appointed time the Inspector may cause it to be cleansed and disinfected at the expense of its owner.
- (4) This section shall not apply to the rolling stock of any railway.

Provided that where there is no person in charge of the animal, and the owner is unknown or the order cannot be communicated to him without undue delay or the person in charge of the animal refuses to do as ordered above, the Inspector may seize the animal and remove it to a place of isolation or segregation.

(2) The Inspector shall forthwith report every order of seizure under this section to the Veterinary Surgeon.

Examination by the Veterinary Surgeon. 16. On receipt of a report under sub-section (2) of section 15 the Veterinary Surgeon shall examine the animal as soon as possible and may also examine all animals which it has been in contact with or in close proximity to and for this purpose may submit any animal to any test which the ¹[State] Government may, by regulations, prescribe in this behalf.

Action after examination by Veterinary Surgeon.

17. (1) If after such examination the Veterinary Surgeon is of opinion that any animal is not infective the Inspector shall forthwith return it to the person from whom it was recovered:

Provided that where such person cannot, without undue inconvenience, be found, the Inspector shall send the animal to the nearest cattle-pound, or deal with it in such other manner as the ¹[State] Government may, by rules, prescribe in this behalf.

- (2) If after such examination the Veterinary Surgeon certifies in writing that any animal is affected with a scheduled disease, the Inspector shall destroy the animal or deal with it in such other manner as the ¹[State] Government may, by rules, prescribe in this behalf.
- (3) If after such examination the Veterinary Surgeon certifies that the animal is infective though not diseased, the animal shall be dealt with in such manner as the ¹[State] Government may, by rules, prescribe in this behalf.

Compensation for animals destroyed.

18. Compensation may be paid to the owner of an animal destroyed under section 17 and such compensation shall be determined in accordance with rules to be prescribed in this behalf:

Provided that-

- (i) no compensation shall be paid to any person convicted of any offence punishable under this Act committed in respect of such animal;
- (ii) no compensation shall be paid in respect of any animal which, when it was brought into the ¹[State] of Orissa, was affected with the disease on account of which it was destroyed.

Power to require disinfection of infected premises, vessels or vehicles. 19. (1) Subject to the rules to be prescribed in this behalf the Veterinary Surgeon may, by order in writing, require the owner, occupier or person in charge of any building, yard, vessel or vehicle in which there has been an infective animal, to have such building, yard, vessel or vehicle

disinfected and the internal fitting thereof and other things found therein or near thereto be disinfected or destroyed, in such manner and to such extent as may be specified in the order.

- (2) Subject as aforesaid, if such owner, occupier or person fails to comply with the requirements of such order a reasonable time the Inspector may cause such building, yard, vessel or vehicle to be disinfected, and the internal fittings and other things to be disinfected or destroyed, at the expense of the owner.
- 20. (1) If the Inspector has reason to believe that there is Declaration an infective animal in any field, yard or building in which of private animals are kept, temporarily or otherwise, he shall at once by infected order in writing declare the place to be an infected place and shall deliver a copy of the order to the owner, occupier or person in charge of the place and arrange for the immediate disinfection thereof and report his action to the Veterinary Surgeon. Surgeon.
- (2) This section shall not apply to any place owned by or under the control or management of any local authority or railway administration where animals are temporarily kept for sale, exhibition or in transit.
- 21. (1) The Veterinary Surgeon shall, as soon as possible, Examination examine the infected place and the animals kept therein, of infected and may cancel or confirm the order of the Inspector.

- (2) If he confirms the order he may cause notice to be Surgeon. served on the owners, occupiers or persons in charge of all places in which animals are kept temporarily or otherwise, within a radius not exceeding one mile from the infected place, declaring such places to be infected places.
- (3) The Veterinary Surgeon shall forthwith report his action under sub-section (2) to the authority prescribed in this behalf.
- 22. (1) Where the Veterinary Surgeon has reason to Declaration believe that infective animals are or have been in any place of public owned, controlled or managed by any local authority or infected railway administration, where animals are temporarily places. kept for purposes of sale, transit or exhibition, he may, by order in writing, declare such place to be an infected place.

- (2) the Veterinary Surgeon shall cause a copy of such order in the vernacular of the locality to be exhibited prominently in the infected place, and he shall deliver copies at the office of the local authority, or to the nearest station master of the railway administration, as the case may be, and shall also send a copy to the nearest police-station; and he shall report his action forthwith to the authority to be prescribed in this behalf.
- 23. (1) On receipt of the report of the Veterinary Surgeon Declaration under sub-section (2) of section 21 or under sub-section (2) of infected of section 22 and after such further inquiry, if any, as they areas by the most think fit the [State] Government— [State] may think fit, the ¹[State] Government-

(a) may cancel any declaration made under section 21 or 22; or

- (b) may confirm such declaration either with or without modifications.
- (2) Where the ¹[State] Government cancels any declaration, the Inspector shall give notice of the cancellation to all persons to whom copies of such declaration were delivered or on whom notices of such declarations were served.
- (3) Where the ¹[State] Government confirm such declaration either with or without modifications they shall, by notification defining the limits of the area to which the notification shall apply, declare such area to be an infected area.
- (4) On the issue of such notification any place declared by the Inspector or Veterinary Surgeon to be an infected place and not included in the infected area so defined shall cease to be an infected place, and the Inspector shall give notice accordingly to the owner, occupier or person in charge of such place.
- (5) The Inspector shall cause to be exhibited in some prominent place in the infected area and in the vernacular of the area, a copy of the notification under sub-section (3), and shall also cause to be so exhibited a copy of any subsequent notification adding to, amending, varying or rescinding such notification.

Removal of animals and other things from infected areas or places.

- 24. (1) No person shall remove from any infected area or place any animal, dead or alive, or any part of an animal or any fodder, bedding or other thing used in connection with animals, save in accordance with the conditions of a licence granted by the Inspector in the prescribed form.
- (2) Nothing in this section shall prevent the transit by railway through an infected area or place of any animal or thing:

Provided that where any animal or other thing referred to in sub-section (1) while in transit through an infected area or place is unloaded therein, it shall not be removed therefrom save in accordance with sub-section (1).

Power to return animals, etc., to infected areas. 25. Where any animal or thing is removed from an infected area or place otherwise than in accordance with a licence granted under section 24, any Inspector or police officer may require the owner or person in charge of such animal or thing to return it to such area or place, and if the owner or person in charge fails to do so within a reasonable time, may cause it to be returned at the expense of the owner without further delay:

Provided that nothing in this section shall affect the powers of an Inspector under section 15 to deal with infective animals.

Time for complying with and enforcement of orders. 26. Where by any notice, requisition, or order under this Act or under any notification or rule issued there under any person is required to take any measures or to do anything in respect of any property owned or occupied by him or in his

- (g) fails to comply with an order made by an Inspector under sub-section (1) of section 15;
- (h) fails to comply with an order made by the Veterinary Surgeon under sub-section (1) of section 19;
- (i) removes any animal or thing from any infected place or area in contravention of section 24;

shall be punishable with fine which may extend, in the case of a first conviction to one hundred rupees, and in the case of second or subsequent conviction, to five hundred rupees.

Penalty for keeping or grazing infective animal in unenclosed land. 29. Whoever keeps or grazes, in or on any forest, open field, roadside, or other unenclosed land, to which other persons have a right of access for their animals, any animal which he knows to be infective, shall be punishable with fine which may extend in the case of a first conviction to one hundred rupees and in the case of second or subsequent conviction to five hundred rupees.

Penalty for bringing infective animal to market. 30. Whoever brings or attempts to bring into any market, fair, exhibition or other concentration of animals any animal which he knows to be affected with a scheduled disease shall be punishable with fine which may extend in the case of a first conviction to one hundred rupees and in the case of a second or subsequent conviction to five hundred rupees.

Penalty for placing carcass of infective animal in river. ar. Whoever places, or causes or permits to be placed, in any river, canal, or other water, or in the sea within ten miles of the shore, the carcass or part of the carcass of any animal which at the time of its death was infective or which has been destroyed as being infective or suspected of being infective shall be punishable with imprisonment for a term which may extend to six months or with fine which may extend in the case of a first conviction to one hundred rupees and in the case of a second or subsequent conviction to five hundred rupees or with both.

Penalty for disinterring carcass of diseased animal. 32. Whoever, without lawful authority, disinters or causes to be disinterred the carcass or part of the carcass of any animal which at the time of its death was infective or which has been destroyed as being infective or suspected of being infective, shall be punishable with fine which may extend in the case of a first conviction to one hundred rupees and in the case of a second or subsequent conviction to five hundred rupees.

Penalty for malicious and vexatious entry or seizure by inspector.

- 33. (1) Whoever being an Inspector, maliciously and vexatiously enters or inspects any land or building or other place or any vessel or vehicle or seizes or detains any animal, shall be punishable with imprisonment for a term which may extend to six months, or with fine which may extend to five hundred rupees or with both.
- (2) No prosecution under this section shall be instituted after the expiry of six months from the date on which the offence has been committed.

Arrest without order or warrant. 34. Any police officer, not being below the rank of Sub-Inspector of police, may, without an order from a Magistrate and without a warrant, arrest any person who has been concerned in an offence against any of the provisions of this Act relating to infected places or infected animals.

Institution of 35. No prosecution under this Act shall be instituted except proceedings. by or under the authority of the Veterinary Surgeon.

Jurisdiction of Magis36. No Magistrate shall try any offence under this Act unless he is a Presidency Magistrate, a Magistrate of the first class or a Magistrate of the second class.

37. No person shall be entitled to any compensation in Bar of claim respect of the destruction of any animal and thing or in to compenrespect of any other loss, injury, detriment or inconvenience sation. caused to him by reason of anything done under this Act in good faith excepting that provided for in section 18.

- 38. (1) The ¹[State] Government may make rules or Power of regulations for carrying out the purposes of this Act. (2) In particular and without prejudice to the generality to make regulations and of the foregoing power such rules or regulations may be made rules.

- (d) to prohibit or limit the sale of or other traffic in infective animals under section 11;
- (e) to prescribe the manner of periodical cleansing and disinfection under sub-section (1) and to appoint places for the disinfection of vessels or vehicles under sub-section (2) of section 12 and for the isolation or segregation of animals under section
- (f) to prescribe the test under section 16;
- (g) to regulate post mortem examination of animals under section 14 and the disposal of animals under sub-sections (1), (2) and (3) of section 17;
- (h) to provide for the determination of the compensation payable under section 18;
- (i) to regulate the exercise of the powers of the Veterinary Surgeon and Inspector under section 19;
- (i) to prescribe the authority referred to in sub-section (3) of section 21 and sub-section (2) of section 22;
- (k) to prescribe the form and contents of the licences to he granted by an Inspector under section 24 and the circumstances under which they may be granted;
- (1) to prescribe scales of charges to be followed in preparing certificates under section 27 for expenses incurred on behalf of an owner;
- (m) to regulate the isolation, detention, treatment (including sterilization and inoculation) and disposal of animals which are infective or suspected of

- (n) to regulate the duties and powers of Inspectors;
- (θ) to prescribe the manner in which any report or notice under this Act shall be made or given;
- (p) to prohibit or regulate the entry into the '[State] of Orissa or any specified part or place thereof and the movement from one place to another in the ¹[State] of Orissa of animals, alive or dead, or parts of animals or fodder, bedding or other things;
- (q) to prohibit or limit sale or traffic in infective animals or carcasses of infective animals;
- (r) to regulate the disinfection of vessels or vehicles used by common carriers, the cleansing and disinfection of buildings, yards and other places used for animals and the destruction of infected matter or things found therein or near thereto;
- (s) to prescribe the tests to be applied to animals suspected of being infective;
- (t) to prescribe the manner in which animals shall be destroyed and the manner in which carcasses or parts of carcasses, bedding or other things seized under the Act shall be disposed of; and
- (u) to prescribe the period of detention and the amount fee for vaccination and marking at the inter-¹[State] quarantine stations.
- (3) In making a rule or regulation under this section the ¹[State] Government may direct that a breach of it shall be punishable with fine which may extend in the case of a first conviction to fifty rupees and in the case of a second or subsequent conviction to two hundred rupees.

THE EAST PUNJAB ANIMAL CONTAGIOUS DISEASES ACT, 1948

EAST PUNJAB ACT XLVII OF 1948

An Act to provide for the prevention and control of contagious diseases affecting animals

Whereas it is expedient to provide for the prevention and control of contagious diseases affecting animals;

IT is hereby enacted as follows:-

CHAPTER I

PRELIMINARY

Short title extent and ment.

- 1. (1) This Act may be called the East Punjab Animal Contagious Diseases Act, 1948.
 - (2) It extends to the whole of the ¹[State] of ¹[Punjab].
- (3) This section shall come into force at once and the ¹[State] Government may by notification bring the rest of the Act, or any part of it, into force in the ¹[State] or in any area in the ¹[State] on such date and for such period as may be specified in the notification.

Power to exempt areas from the provisions of this Act.

2. Notwithstanding anything contained in section 1, the ¹[State] Government may by notification exempt any visions of this Act, or direct that any provision of this Act shall apply to any area with such modifications as may be specified.

Definitions.

- 3. In this Act, unless there is anything repugnant in the subject or context,-
 - (a) "animal" means any domesticated animal or bird, or any animal or bird kept in confinement;
 - "an infective animal" is one which is affected with a Scheduled disease or has recently been in contact with or in close proximity to an animal so affected,
 - (e) "prescribed" means prescribed by regulations or rules made under this Act;
 - (d) "scheduled disease" means any disease for the time being included in the schedule in Appendix I.

Scheduled

- 4. The diseases specified in the Schedule in Appendix I shall in the first instance be scheduled diseases for the purpose of this Act, but the ¹[State] Government may, purpose of this by notification-
 - (a) delete any entry from the Schedule, or
 - (b) include in the Schedule any communicable disease of animals to which it is expedient in their opinion that the provisions of this Act should apply.

- 5. (1) The ¹[State] Government may either by name Veterinary or designation appoint any person holding the office of Surgeons. Veterinary Assistant or Veterinary Assistant Surgeon, or any graduate of a recognised veterinary college whom they think fit to be a Veterinary Surgeon for the purposes of this Act, and may define the area within which he shall exercise the powers and perform the duties of a Veterinary Surgeon under this Act.
- (2) A Veterinary Surgeon shall have all the powers of an Inspector under this Act, and may exercise such powers concurrently with his powers as Veterinary Surgeon.
- 6. The [State] Government may either by name or Inspectors. designation appoint any person it thinks fit to be an Inspector for any or all of the purposes of this Act, and may define the area within which he shall exercise the powers and perform the duties incidental to such purposes.

(i) no compensation shall be paid to any person convicted of any offence punishable under this Act, committed in respect of such animal;

(ii) no compensation shall be paid in respect of any animal which, when it was brought into the ¹[State] of ¹[Punjab] was affected with the disease on ac-count of which it was destroyed.

Power to require dis-infection of infected premises, vessels or vehicles.

- 19. (1) Subject to rules to be made in this behalf by the ¹[State] Government, the Veterinary Surgeon may, by order in writing, require the owner, occupier or person in charge of any building, yard, vessel or vehicle in which there has been an infective animal to have such building, yard, vessel or writing the subject of the subject yard, vessel or vehicle disinfected, and the internal fittings thereof and other things found therein or near thereto be disinfected or destroyed in such manner and to such extent as may be specified in the order.
- (2) Subject as aforesaid, if such owner, occupier or person fails to comply with the requirements of such order within a reasonable time, the Inspector may cause such building, yard, vessel or vehicle to be disinfected, and the internal fittings and other things to be disinfected or destroyed at the expense of the owner.

Declaration

- 20. (1) If the Inspector has reason to believe that there Declaration of private inis an infective animal in any field, yard or building in which
 feeted places. animals are kept, temporarily or otherwise, he shall at once
 by order in writing, declare the place to be an infected
 place and shall deliver a copy of the order to the owner,
 occupier or person in charge of the place and report his
 action to the Veterinary Surgeon.
 - (2) This section shall not apply to any place owned by or under the control or management of any local authority or railway administration or to any airfield where animals are temporarily kept for sale, exhibition or in transit.

Examination of infected place by Veterinary

- 21. (1) The Veterinary Surgeon shail, as soon as possible, examine the infected place and the animals kept therein, and may cancel or confirm the order of the Inspector.
- (2) If he confirms the order he may cause notice to be served on the owners, occupiers or persons in charge of all places in which animals are kept temporarily or otherwise, within a radius not exceeding one mile from the infected place, declaring such places to be infected places.

The Veterinary Surgeon shall forthwith report his action under this sub-section to the authority prescribed by the ¹[State] Government in this behalf.

Declaration of public infected. places.

22. (1) Where the Veterinary Surgeon has reason to believe that infective animals are or have been in any place owned, controlled or managed by any local authority, or rail-way administration or aircraft company where animals are temporarily kept for purposes of sale, transit or exhibition, he may, by order in writing, declare such place to be an infected place.

- (2) The Veterinary Surgeon shall cause a copy of such order, in the vernacular of the locality, to be exhibited prominently in the infected place, and he shall deliver copies at the office of the local authority or to the nearest station master of the railway administration, or to the officer-in-charge of the airfield as the case may be and shall also send a copy to the nearest police station; and he shall report his action forthwith to the authority prescribed by the ¹[State] Government in this behalf.
- 23. (1) On receipt of the report of the Veterinary Sur-Declaration geon under sub-section (2) of section 21 or under sub-section of infected

- (a) may cancel any declaration made under sections 20, 21 or 22; or
- (b) may confirm such declaration either with or without modifications.
- (2) Where the ¹[State] Government cancels any declaration, the Inspector shall give notice of the cancellation to all persons to whom copies of such declaration were delivered or on whom notices of such declaration were served.
- (3) Where the [State] Government confirms such declaration either with or without modifications the ¹[State] Government shall, by notification defining the limits of the area to which the notification shall apply, declare such area to be an infeated order. to be an infected area.
- (4) On the issue of such notification any place declared by the Inspector or Veterinary Surgeon to be an infected place and not included in the infected area so defined shall cease to be an infected place, and the Inspector shall give notice accordingly to the owner, occupier or person in charge of such place.
- (5) The Inspector shall cause to be exhibited in some prominent place in the infected area and in the vernacular of the area, a copy of the notification under sub-section (3), and shall also cause to be so exhibited a copy of any subsequent notification adding to, amending, varying or rescinding such notification.
- 24. (1) No person shall remove from any infected area Removal of or place, any animal, dead or alive, or any part of an animal, animals and or any fodder, bedding or other thing used in connection from infected with animals, save in accordance with the conditions of a areas or licence granted by the Inspector.
- (2) Nothing in this section shall prevent the transit by railway through an infected area or place of any animal or thing:

Provided that where any animal or other thing described in sub-section (1) while in transit through an infected area or place is unloaded therein, it shall not be removed therefrom save in accordance with sub-section (1).

Power

25. Where any animal or thing is removed from an inreturn ani fected area or place otherwise than in accordance with a mals, etc., to licence granted under section 24, any Inspector or police infected officer may require the owner or person in charge of such animal or thing to return it to such area or place, and if the owner or person in charge fails to do so within a reasonable time, may cause it to be returned at the expense of the owner without further delay:

> Provided that nothing in this section shall affect the powers of an Inspector under section 15 to deal with infective animals.

Time complying

26. Where by any notice, requisition, or order under this complying Act or under any notification or rule issued thereunder any of person is required to take any measures or to do anything in respect of any property owned or occupied by him or in his charge, a reasonable time shall be specified in such notice, requisition or order within which such measures shall be taken or such thing shall be done, as the case may be.

Recovery expenses incurred under this Act.

27. Where any action may be taken under this Chapter in respect of any property to the expense of the owner there-of, the officer taking such action may frame a certificate stating the amount of the expense incurred and the person from whom such amount is recoverable, and any Magistrate to whom such certificate is presented may, after such inquiry as he may think fit, recover such amount as if it were a fine imposed by him on such person.

CHAPTER III

PENALTIES AND PROCEDURE

Penalties for contraven-tions of Acts, Regulations and Rules.

28. Whoever-

- (a) removes from any part of the ¹[State] of the ¹[Punjab] any animal, alive or dead or any part of an animal, or any fodder, bedding or other thing in contravention of a notification issued under section 9, or imports animals in contravention of sub-section (2) of that section;
- (b) holds or promotes or takes part in any market, fair, exhibition or other concentration of animals in contravention of a notification issued under section 10;
- (c) sells or otherwise traffics in, or attempts to sell or traffic in, an infective animal, or in anything mentioned in section 11 which may carry infection, or the carcass of an animal which at the time of its death was infective in contravention of section 11;
- (d) being a common carrier fails to cleanse or disinfect any vessel or vehicle used for the transport of animals in such manner as may be required under

- sub-section (1) of section 12 or as may be required by the Inspector under sub-section (2) of that section;
- (e) fails in contravention of section 13, to report that an animal is infective;
- (f) fails to comply with an order made by an Inspector under sub-section (1) of section 15;
- (g) fails to comply with an order made by the Veterinary Surgeon under sub-section (1) of section 19;
- (h) removes any animal or thing from any infected place in contravention of section 24;

shall be punishable with fine which may extend, in the case of a first conviction, to one hundred rupees and, in the case of a second or subsequent conviction, to five hundred rupees.

- 29. Whoever keeps or grazes in or on any forest, open Penalty for field, roadside, or other unenclosed land to which other keeping or persons have a right of access for their animals, any animal grazing which he knows to be infective shall be punishable with fine mal in unenwhich may extend in the case of a first conviction to one closed land. hundred rupees or in the case of a second or subsequent conviction to five hundred rupees.
- 30. Whoever brings or attempts to bring into any Penalty for market, fair, exhibition or other concentration of animals bringing any animals which he knows to be infective shall be punishable with fine which may extend in the case of a first market. conviction to one hundred rupees or in the case of a second or subsequent conviction to five hundred rupees.
- 31. Whoever places, or causes or permits to be placed, Penalty in any river, canal or other water, the carcass or part of the placing carcass of any animal which at the time of its death was infective infective or which has been destroyed as being infective or animal suspected of being infective shall be punishable with imprisonment for a term which may extend to six months or with fine which may extend in the case of a first conviction to one hundred rupees or in the case of a second or subsequent conviction to five hundred rupees or with both imprisonment and fine.
- 32. Whoever, without lawful authority, disinters or causes Penalty for to be disinterred the carcass or part of the carcass of any disinterring animal which at the time of its death was infective or which carcass of has been destroyed as being infective or suspected of being diseased infective shall be punishable with fine which may extend in the case of a first conviction to one hundred rupees or in the case of a second or subsequent conviction to five hundred rupees.
- 33. (1) Whoever being an inspector, maliciously and Penalty for vexatiously enters or inspects any land or building or other malicious and place or any vessel or vehicle or seizes or detains any animal, entry seizure by

shall be punishable with imprisonment for a term which may extend to six months or with fine which may extend to five hundred rupees, or with both.

(2) No prosecution under this section shall be instituted after the expiry of one month from the date on which the offence is alleged to have been committed.

Arrest without order or warrant.

34. Any police officer not below the rank of Sub-Inspector of Police may without an order from magistrate and without a warrant arrest any person who has been concerned in an offence against sections 9, 10, 24 and 31 of this Act.

Institution of proceedings. 35. No prosecution under this Act except under section 33 shall be instituted except by or under the authority of the Veterinary Surgeon.

Jurisdiction

36. No Magistrate shall try any offence under this Act of magistra-unless he is a magistrate of the first class, or a magistrate of the second class specially empowered in this behalf by the ¹[State] Government.

- (c) to appoint places for the disinfection of vessels or vehicles under sub-section (2) of section 12, and for the isolation or segregation of animals under section 15:
- (d) to regulate post mortem examination of animals under section 14, and the disposal of animals under sub-sections (1), (2) and (3) of section 17;
- (e) to provide for the determination of the compensation payable under section 18;
- (f) to regulate the exercise of the powers of the Veterinary Surgeon and Inspector under section 19;
- (g) to prescribe the authority referred to in sub-section (2) of section 21 and sub-section (2) of section 22;
- (h) to prescribe the form and contents of the licences to be granted by an Inspector under section 24 and the circumstances under which they may be granted;

- (i) to prescribe scales of charges to be followed in certificates under section 27 for expenses incurred on behalf of an owner;
- (j) to regulate the isolation, detention, treatment (including sterilization and inoculation), and disposal of animals which are infective or suspected of being infective, and the disposal of carcasses and parts of carcasses;
- (k) to regulate the duties and powers of Inspectors and prescribe their qualifications;
- (1) to prescribe the manner in which any report or notice under the Act shall be made or given;
- (m) to prohibit or regulate the entry into the ¹[State] of ¹[Punjab] or any specified part or place thereof, and the movement from one place to another, in the ¹[State] of ¹[Punjab] of animals, alive or dead, or parts of animals or fodder, bedding or other things;
- (n) to prohibit or limit sale or traffic in infective animals or carcasses of infective animals;
- (o) to regulate the disinfection of vessels or vehicles used by common carriers, the cleansing and dis-infection of buildings, yards and other places used for animals, and the destruction of infected matter or things found therein or near thereto;
- (p) to prescribe the tests to be applied to animals suspected of being infective;
- (q) to prescribe the manner in which animals shall be destroyed, and the manner in which carcasses or parts of carcasses, fodder, bedding or other things seized under the Act shall be disposed of;
- (r) to prescribe the period of detention and the amount of fee for vaccination and marking at the inter-¹[State] quarantine stations.
- (2) In making a rule under this section the ¹[State] Government may direct that a breach of it shall be punishable with fine which may extend in the case of a first conviction to one hundred rupees or in the case of a second or subsequent conviction to five hundred rupees.

THE BENGAL DISEASES OF ANIMALS ACT, 1944

BENGAL ACT VI OF 1944

An Act to provide for the prevention of the spread of contagious diseases amongst animals in Bengal

WHEREAS it is expedient to provide for the prevention of the spread of contagious diseases amongst animals in Bengal;

IT is hereby enacted as follows:-

1. (1) This Act may be called the Bengal Diseases of and extent.

Animals Act, 1944.

(2) It extends to the whole of Bengal.

Definitions.

2. In this Act unless there is anything repugnant in the subject or context,—

- (1) "animals" means bulls, bullocks, cows, oxen, heifers, calves, buffaloes, sheep, goats, and all other ruminating animals, dogs, swine and includes such other domesticated animals excepting horses, camels, asses and mules as may be specified in this behalf by the '[State] Government by notification in the Official Gazette;
- (2) "contagious disease" means rinderpest (that is to say, the disease commonly known as cattle plague), anthrax, naemorrhagic septicaemia, footand-mouth disease, rabies and includes such other diseases as may be declared by the '[State] Government by notification in the Official Gazette to be contagious diseases for the purposes of this Act;
- (3) "infected area" means an area in respect of which a notification under section 5 is in force;
- (4) "infective" used with reference to an animal means affected by a contagious disease or having recently been in contact with or proximity to an animal so affected;
- (5) "prescribed" means prescribed by rules made under this Act;
- (6) "Veterinary Assistant" means a Veterinary Assistant of the Bengal Civil Veterinary Department acting within the local limits of his jurisdiction and in the absence of the said Veterinary Assistant from his jurisdiction, includes any officer of the said department who in the opinion of the '[State] Government possesses suitable qualifications in veterinary medicines and who is authorised by the '[State] Government to carry on the duties of the Veterinary Assistant under this Act in such absence.

Report contagious disease.

- 3. (1) Every owner or person in charge or having control of an animal, and every veterinary practitioner attending any animal in the course of his veterinary practice or otherwise, who has reason to believe that such animal is infective shall forthwith report and any other person who has reason to believe that an animal is infective may report the fact to the President of the union board within the area of which such animal is for the time being kept.
- (2) The President of the union board on receiving any report under sub-section (1) shall without delay communicate such report to the Sub-divisional Magistrate who shall, unless for reasons to be recorded in writing he considers that the report is unfounded in fact, instruct the Veterinary Assistant to proceed to the place where the animal is for the time being kept and examine the animal and inquire into the circumstances of the case, and on receiving such instructions the Veterinary Assistant shall without delay comply therewith.
- (3) Whenever a Veterinary Assistant has reason to behese that any animal within his jurisdiction is infective he shall proceed as soon as possible to the place where the animal is and examine it and inquire into the circumstances of the case naturithstanding that he report under subsection the case, notwithstanding that no report under sub-section (2) in respect of such animal has been received by him.
- (4) If after the examination and inquiry referred to in sub-section (2) or sub-section (3) the Veterinary Assistant is of the opinion that the animal is infective, he shall report the matter in the manner prescribed to the ¹[State] Government or to such officer of the Bengal Civil Veterinary Department as the ¹[State] Government may appoint in this behalf and the Veterinary Assistant shall also take such further action under the provisions of this Act as may be necessary or expedient and at the same time shall send a copy of such report to the Sub-divisional Magistrate. a copy of such report to the Sub-divisional Magistrate.

(1) In all cases in which preventive vaccination or Preventive inoculation is possible and practicable against the contagious vaccination disease in respect of which an area has been declared to be in infected area, the Vaccinary Assigns shall vaccinate area. an infected area, the Veterinary Assisant shall vaccinate areas. or inoculate, as the case may be, such kinds or classes of animals in that area as may be prescribed in respect of such disease and the average area. disease and the owner or person in charge or having control of every such animal shall render every facility and assistance to him in carrying out such vaccination or inoculation.

(1) Where by any requisition or order under this Act or under any notification or rule issued thereunder, any person is required to take any measures or to do anything in respect of any property owned or occupied by him or in his charge, a reasonable time shall be specified in such a requisition or order within which such measures shall be taken or such thing shall be done, as the case may be.
 - (2) If such measures are not taken or such things are not done within the time specified in accordance with the provisions of sub-section (1), the authority issuing the requisition or order may cause the measures to be taken or the thing to be done and the cost thereof shall be recoverable from the person who was required to take such measures or to do such thing as if it were an arrear of land revenue.

22. No person shall be entitled to any compensation in respect of the destruction of any animal or thing or of any other loss, injury, detriment or inconvenience caused him by reason of anything done under this Act in good faith,

Indemnity.

23. No suit, prosecution or other legal proceedings shall lie against any servant of the ¹[Government] for anything which is in good faith done or intended to be done under this Act or any rule made thereunder.

JAMMU AND KASHMIR ACT XV OF SAMVAT 2006

An Act to provide for the prevention and control of contagious diseases affecting Animals

Whereas it is expedient to provide for the prevention and control of contagious diseases affecting animals; now, therefore, in exercise of the power reserved under section 5 of the Jammu and Kashmir Constitution Act, 1996, read with the Proclamation issued by His Highness and published in extraordinary issue of the Government Gazette dated 7th Har, 2006, Yuvraj Shree Karan Singh Ji Bahadur is pleased to enact as follows:—

PART I

PRELIMINARY

Short title.

1. This Act may be called the Jammu and Kashmir Animal Contagious Diseases (Control) Act, 2006.

Extent and 2. (1) This Act extends to the whole of the Jammu and Commencement.

(2) This section shall come into force at once. The Government may, from time to time, by notification in Government Gazette direct that all or any of the remaining provisions of this Act shall come into force in such area in respect of such scheduled disease and on such date as may be specified in the notification and may by similar notification direct that such provisions shall cease to be in force in any area from such date as may be specified therein.

Definitions.

- 3. In this Act, unless there is anything repugnant in the subject or context,—
 - (a) "animal" means any domesticated animal or bird, or any animal or bird kept in confinement;
 - (b) "infective animal" means an animal which is affected with a scheduled disease or has recently been in contact with or in close proximity to an animal so affected;
 - (c) "inspector" means an Inspector appointed under section 4;
 - (d) "prescribed" means prescribed by rules made under section 36;
 - (e) "rules" means rules made under section 36;
 - (f) "scheduled diseases" means any disease specified in the schedule to this Act;
 - (g) "Veterinary Surgeon" means a Veterinary Surgeon appointed under section 4.

- 4. (1) The Government may, by notification in the Appointment Government Gazette, appoint a person to be a Veterinary Surgeon and Surgeon for the purposes of this Act for such local area as Inspectors, may be specified in the notification and may specify the area within which he shall exercise the powers and perform the duties of a Veterinary Surgeon under this Act.
- (2) The Government may, by a similar notification in the Jammu and Kashmir Government Gazette, appoint a person to be an Inspector for all or any of the purposes of this Act and specify the area within which he shall exercise the powers and perform the duties of an Inspector under this Act.
- (3) A Veterinary Surgeon shall, within the area for which he is appointed, exercise all the powers which an Inspector may exercise under this Act and may exercise such powers in addition to his powers as Veterinary Surgeon.

Establishment of quarantine stations.

- 7. (1) The Government may establish quarantine stations for the inspection and detention of animals along the route appointed under sub-section (2) of section 6.
- (2) All animals inspected or detained at a quarantine station shall be liable-
 - (a) to be vaccinated against any scheduled disease if in the opinion of the officer-in-charge of such station it is necessary to do so; and
 - (b) to be marked in the prescribed manner.
- (3) The period of detention of animals at a quarantine station for the purpose of inspection, vaccination and marking shall be such as may be prescribed.
- (4) The animals detained at a quarantine station shall remain under the care of the person in charge who shall be responsible for their feeding and upkerp and for the payment of such fee for their vaccination and marking as may be prescribed.
- (5) The officer-in-charge of the quarantine station shall at the time of release of an animal from the station, grant in such form as may be prescribed a permit to the person in charge of the animals and such person shall, while in charge of the animal, produce it whenever required to do so by an Inspector or a Police Officer.

Power to solute infective animal is infective, he may, by order in writing, direct the animals and their examples owner or person in charge of such animal to keep it where it mination.

Solution of isolation or segregation as may be specified in the order:

> Provided that where there is no person in charge of the animal and the owner is unknown, or where the order cannot be communicated to the owner of the animal without undue delay or where the person in charge of the animal refuses to comply with the order under this sub-section, the Inspector may seize the animal and remove it to a place of isolation or segregation.

> (2) The Inspector shall forthwith report to the Veterinary Surgeon every order or seizure under sub-section (1).

- g. (1) On receipt of a report under sub-section (2) of section 8 the Veterinary Surgeon shall, as soon as practicable, examine the animal and all animals with which it has been in contact or to which it has been in close proximity and for this purpose may submit any animal to any prescribed

 - (a) is of opinion that any animal is not infective, the Inspector shall forthwith return it to the person who, in his opinion, is entitled to its possession:

Provided that where such person cannot, in the opinion of the Inspector, be found after reasonable inquiry, he shall send the animal to the nearest cattle-pound or deal with it in such other manner as may be prescribed;

(b) certifies in writing that any animal is affected with a scheduled disease, the Inspector may destroy the animal, or deal with it in such other manner as may be prescribed:

Provided that nothing herein contained shall authorise the Inspector to destroy an animal the killing of which constitutes an offence under any law for the time being in force in the State; or

- (c) certifies in writing that any animal infective, though not diseased the animal shall be dealt with in such manner as may be prescribed.
- (3) The decision of the Veterinary Surgeon whether any animal has been in contact with or in close proximity to an animal suspected to be affected with a scheduled disease shall be final.

- (3) If the Veterinary Surgeon confirms the order passed by the Inspector he may declare all places in which animals are kept temporarily or otherwise within a radius not exceeding one mile from the infected place to be infected places. The Veterinary Surgeon shall give a written notice of such declaration to the owners, occupiers or persons in charge of such places. The Veterinary Surgeon shall—thereafter report the action taken by him under this section to the prescribed authority.
- (4) If the Veterinary Surgeon cancels the order passed by the Inspector the place specified in such order shall cease to be an infected place and the Inspector shall give notice accordingly to the owner, occupier or person in charge of such place.

Declaration of public infected places.

- ta. (1) Where the Veterinary Surgeon has reason to believe that an infective animal is or has been kept in a place which is owned by or is under the control or management of any local authority or administration and in which animals are kept temporarily for purposes of sale or exhibition or while in transit, he may, by order in writing, declare such place to be an infected place.
 - (2) The Veterinary Surgeon shall-
 - (a) cause a copy of the order passed by him under sub-section (1) to be exhibited prominently in the infected place in the court language of the locality;
 - (b) cause a copy of such order to be delivered at the office of the local authority;
 - (c) cause a copy of the order to be sent to the nearest police station; and
 - (d) forthwith report the action taken by him to the prescribed authority.

Power of Government to declare infected areas.

- 13. (1) On receipt of the report of the Veterinary Surgeon under sub-section (3) of section 11 or sub-section (2) of section 12, the prescribed authority shall, after making such further inquiry as it thinks fit, submit such report with his remarks thereon to the Government.
- (2) The Government on receipt of the report for the prescribed authority may—
 - (a) confirm the declaration under sub-section (1) or (3) of section 11 or sub-section (1) of section 12 either with or without modification; or
 - (b) cancel such declaration.

- (5) On publication of a notification under sub-section (3) or (4) any place declared by the Inspector or Veterinary Surgeon to be an infected place and not included in the infected area as defined in such notification shall cease to be an infected place and the Inspector shall give notice accordingly to the owner, occupier or person in charge of such place.
- (6) The Inspector shall cause to be exhibited in some prominent place in the infected area and in the court language thereof a copy of the notification issued under sub-section (3) or (4).

Power to require disinfection of infected premises, boats or vehicles. 17. Subject to such rules as may be prescribed, the Veterinary Surgeon, by order in writing, require the owner, occupier or person in charge of any land, building, or other, place or of any boat or vehicle in which an infective animal has been kept to have such land, building, place, boat or vehicle disinfected and the internal fittings thereof and other things found therein or near thereto to be disinfected or destroyed, in such manner and to such extent as may be specified in the order.

Power of Veterinary Surgeon to hold post mortem. 18. Subject to such rules as may be prescribed the Veterinary Surgeon may make or cause to be made a post morten examination of any animal which at the time of its death was infective or suspected to have been infective, and for this purpose he may have the carcass of such animal to be exhumed.

Duty of certain persons to report scheduled diseases. 19. Every owner or person in charge of, and every Veterinary Practitioner who has been called to treat an animal which he has reason to believe to be affected with a scheduled disease shall forthwith report the fact to the Inspector having jurisdiction in the area.

Keeping or grazing infective animal prohibited. 20. No person shall keep or graze in open or unenclosed land to which other persons have a right of access for their animals, any animal which he knows to be infective.

Bringing of infective animal in market, etc., prohibited. 21. No person shall bring or attempt to bring into any market, fair, exhibition or other concentration of animals, any animal which he knows to be infective.

Placing of carcass of infective animals in river etc. prohibited.

22. No person shall place or cause or permit to be placed in any river, lake, canal or other water within such distance from the shore, as may be prescribed, any carcass or any part of the carcass of any animal which at the time of its death was infective or which was destroyed on account of its being infective or suspected to be infective.

Disinterring without lawful authority carcass of animal prohibited.

23. No person shall without lawful authority disinter or cause to be disinterred the carcass or any part of the carcass of any animal which at the time of its death was infective or which was destroyed on account of its being infective or suspected to be infective.

THE MYSORE DISEASES OF ANIMALS ACT, 1949

Mysore Act XXI of 1949

An Act to provide for the prevention of the spread of contagious or infectious diseases amongst animals in Mysore State

Whereas it is expedient to provide for the prevention of the spread of contagious or infectious diseases amongst animals in Mysore State;

IT is hereby enacted as follows:--

- 1. (1) This Act may be called the Mysore Diseases of Short title Animals Act, 1949.
 - (2) It extends to the whole of Mysore.
- 2. In this Act unless there is anything repugnant in the Definitions. subject or context,—
 - (1) "animals" means bulls, bullocks, cows, oxen, heifers, calves, buffaloes, sheep, goats and all other ruminating animals, dogs, swine, horses, camels, asses, mules, fowls, and includes such other domesticated animals as may be specified in this behalf by the Government by notification in the official Gazette;
 - (2) "contagious or infectious diseases" means rinderpest, anthrax, haemorrhagic septicaemia, rabies, glanders and farcy, epizootic lymphangitis, surra, equine influenza or pink eye, sheep-pox, ranikhet disease and includes such other diseases as may be declared by the Government in the official Gazette to be contagious or infectious diseases for the purposes of this Act;
 - (3) "infected area" means an area in respect of which a notification under section 5 is in force;
 - (4) "infective" used with reference to an animal means affected by a contagious or infectious disease or having recently been in contact with or proximity to an animal so affected;
 - (5) "prescribed" means prescribed by rules made under this Act;
 - (6) "veterinary officer" means an officer of the Mysore Veterinary and Live-stock Department, not below the rank of a veterinary inspector acting within the local limits of his jurisdiction and in the absence of the said veterinary inspector from his jurisdiction; includes any officer of the said Department who in the opinion of the Government possesses suitable qualifications in veterinary medicine and

who is authorised by the Government to carry on the duties of the veterinary inspector under this Act in such absence.

Report of contagious diseases.

- 3. (1) Every owner or person in charge or having control of an animal, and every veterinary practitioner attending to any animal in the course of his veterinary practice or otherwise, who has reason to believe that such an animal is infective, shall forthwith report and any other person, who has reason to believe, that an animal is infective may report the fact to the local patel or, where there is no patel, to the chairman of the village panchayat or the president of the municipality within the area of which such animal is for the time being kept.
- (2) The patel or the chairman of the village panchayat or the president of the municipality on receiving any report under sub-section (1) or on any other information shall, unless for reasons to be recorded in writing he considers that the report is unfounded in fact, communicate without delay such report to the veterinary officer for the area and send copies thereof to the Superintendent, Veterinary and Live-stock Department in Mysore, Bangalore, the District Veterinary and Live-stock Officer of the District and the Amildar of the taluk to which the place belongs. The Veterinary Officer shall, on receiving such a communication, proceed without delay to the place where the animal is for the time being kept and examine the animal and inquire into the circumstances of the case.
- (3) Whenever a veterinary officer has reason to believe that any animal within his jurisdiction is infective, he shall proceed as soon as possible to the place where the animal is and examine it and inquire into the circumstances of the case, notwithstanding that no report under sub-section (2) in respect of such animal has been received.
- (4) If after the examination and inquiry referred to in sub-section (2) or sub-section (3), the Veterinary Officer is of the opinion that the animal is infective, he shall report the matter in the manner prescribed to such officer or officers of the Mysore Veterinary and Live-stock Department as the Government may appoint in this behalf and the Veterinary Officer shall also take such further action under the provisions of this Act as may be necessary or expedient.

Duty to segregate infective animals. 4. Every owner or person in charge or having control of an animal who has reasons to believe that such animal is infective shall, as far as may be possible in the circumstances, segregate such animal in a place apart from all other animals which are not infective and shall take all possible steps to prevent any animal which is not infective from coming into contact with or approaching near such animal.

Declaration of infected areas.

5. (1) The District Magistrate or such officer as the Government may authorise in this behalf may, by notification published in the manner prescribed, declare any area in which any contagious disease has broken out, or any area within which in the opinion of the District Veterinary

and Live-stock Officer, or such officer as the Government may authorise, there is a danger of the spread of any such disease, to be an infected area.

- (2) Every notification under sub-section (1) shall specify the limits of the area which is declared to be an infected area and shall also specify the contagious or infectious disease in respect of which the area is declared to be an infected area.
- 6. (1) Save in accordance with the conditions of a licence Prohibition granted by a veterinary officer— of movement

(2) Nothing in sub-section (1) shall prevent the carriage by railway or by any mechanically propelled vessel of a type approved by the Government of any animal or thing referred to in that sub-section through an infected area:

Provided that if such animal or thing at any stage during its carriage by railway or such vessel through an infected area is unloaded therein, it shall not be removed therefrom save in accordance with the provisions of sub-section (1).

7. Provided that on the release of the animal the owner or his authorised agent, as the case may be, shall comply with any order which the Veterinary Officer may see fit to issue under sub-section (1).

ACT XIX OF 1947

An Act to provide for the prevention and control of certain diseases affecting Animals

WHEREAS it is expedient to provide for the prevention and control of contagious and infectious diseases affecting animals;

It is hereby enacted as follows:-

Short title, extent and commence-

- 1. (1) This Act may be called the Marwar Animal Contagious and Infectious Diseases Act, 1947.
- (2) It extends to the whole of Marwar except the Sambhar Shamlat Area.
- (3) It shall come into force from the date of its publication in the Jodhpur Government Gazette.

Definitions.

- 2. In this Act unless there is anything repugnant in the subject or context,—
 - (1) "Animal" means any domestic animal or any animal or bird kept in confinement.
 - (2) "Director" means the Director of Animal Husbandry Department, Jodhpur.
 - (3) "Infected animal" means an animal which is affected with a scheduled disease or has recently been in contact with or in close proximity to, an animal so affected.
 - (4) "Owner" means a person in whose charge the animal is and includes any person who feeds and looks after the animal or takes certain work from that animal
 - (5) "Scheduled Disease" means any disease for the time being included in the Schedule to this Act.
 - (6) "Stable" means the dwelling place, whether permanent or temporary, where the animal rests or is being kept in a state of health or sickness.
 - (7) "Veterinary Officer" means a qualified veterinary surgeon serving in the Animal Husbandry Department and includes a person not below the rank of a stockman, on whom the powers or duties of the Veterinary Officer have been conferred by the Director under this Act.
 - (8) "Village headman" means a Jagirdar or his representative, a Hawaldar or Kanwaria, village chowdhari, Sarpanch or any other person or persons who may for the time being be in charge of the village.

THE VINDHYA PRADESH CATTLE DISEASES ACT 1952

ACT II OF 1952

An Act to provide for the prevention of the spread of contagious diseases among cattle in the Vindhya Pradesh

BE it enacted by the Vindhya Pradesh Legislative Assembly as follows:—

- L. (1) This Act may be called the Vindhya Pradesh Short title, Cattle Diseases Act, 1952.

 Cattle Diseases Act, 1952.
- (2) This Act, except sections 3 to 8, and 9 extends to the ment. whole of the Vindhya Pradesh and shall come into force at once. Sections 3 to 8 and section 9 shall extend to such areas and come into force on such dates as the State Government may, by notification, direct.
- 2. In this Act, unless there is anything repugnant in the Definitions. subject or context,—
 - (a) "cattle" means such domesticated animals as may be prescribed;
 - (b) "contagious disease" means rinderpest and such other diseases as may be prescribed;
 - (c) "infective" means affected by a contagious disease, or having recently been in contact with or proximity to a cattle so affected, or residing in an area declared to be infected area; and
 - (d) "prescribed" means prescribed by rules made under this Act.

CHAPTER I

REGULATION OF ENTRY AND MOVEMENT OF CATTLE IN A LOCAL AREA

- 3. (1) When [Sections 3 to 8]¹ have been extended to Seasons and any area, the State Government may, by notification, aproutes for point the season or seasons during which and the route or importation routes by which cattle may be imported into such area and no person shall import cattle into such area otherwise than during the season and by the route so appointed.
- '(2) The State Government may establish quarantine Quarantine stations for the inspection and detention of such cattle along stations. the routes appointed under sub-section (1).

Vaccination 4. (1) All cattle on arrival at a quarantine station shall of cattle.

Period of detention of cattle at quarantine station.

(2) The period of detention of cattle at a quarantine station for the purpose of inspection and vaccination shall be such as may be prescribed.

Assistance to (3) Every person in charge of cattle shall give reasonable Veterinary Officer for assistance to the veterinary officer of the station and his subordinates for the inspection, vaccination and marking inspection, subordinates for etc., of cattle, of such cattle.

Feeding and 5. (1) The cattle so detained shall remain under the upkeep of detained cattle.

5. (1) The cattle so detained shall remain under the care of the person in charge who shall be responsible for their feeding and upkeep.

Fodder

(2) The State Government shall establish fodder depots depots and through the agency of the Forest Department at quarantine watering arrangements stations for the supply of fodder on payment to persons in charge of cattle so detained or provide facilities for the grazing through the agency of the Forest Department at quarantine arrangements at quarantine stations. of such cattle so detained or provide facilities for the grazing charge of cattle so detained or provide facilities for the grazing of such cattle on payment in any adjoining Government forest. The State Government shall, likewise, make watering arrangements at every such station, unless there is a natural close thereto, and persons in charge of cattle supply of water close thereto, and persons in charge of cattle shall be entitled to water free of charge.

Precautions against straying of cattle.

(3) Every person in charge of cattle shall, during the period of their detention, take reasonable precautions against their straying from the limit of the quarantine station or from the place allotted for their halt.

 - (2) If such fee is not paid, the Veterinary Officer of the station may seize as many cattle as will, in his opinion, suffice, to defray the fee leviable under sub-section (1) and forthwith report the fact to the Deputy Commissioner or such other Officer as may have been appointed by the Deputy Commissioner in this behalf.
 - (3) The Deputy Commissioner or other officer so appointed may, if satisfied that such fee has not been paid, issue such notice or proclamation as may be prescribed, and cause the cattle so seized to be sold by auction and the proceeds of the sale applied to the payment of-
 - (a) the amount due on account of the fee leviable under sub-section (1), and
 - (b) the charges in connection with the seizure, custody, feeding and upkeep of the cattle and the proceedings of the sale.

- (4) The balance of the purchase money, if any, shall be delivered to the person who was in charge of the cattle when they were seized or their owner, together with an account showing—
 - (a) the number of cattle seized,
 - (b) the time during which they had been in custody,
 - (c) the proceeds of sale, and
 - (d) the manner in which those proceeds have been disposed of.

Explanation.—For the purpose of this section the expression "Veterinary Officer" means any officer of the Civil Veterinary Department not below the rank of ¹[a Veterinary Assistant Surgeon].

Declaration of the infected areas.

- 12. (1) The State Government or such officer as it may authorise in this behalf may, by notification published in the manner prescribed, declare any area in which any contagious disease has broken out, or any area within which in the opinion of the State Government, or such officer, there is a danger of the spread of any such disease, to be an infected area.
- (2) Every notification, under sub-section (1) shall specify the limits of the area which is declared to be an infected area and shall also specify the contagious disease in respect of which the area is declared to be an infected area.

Power to take special measures and make rules as to contagious diseases.

- 13. (1) On the issue of a notification under section 12 the State Government, or the Officer authorised under the said section may take, or require or empower any person or Gram Panchayat to take such measures and enforce such rules to be observed by the public or by any person or class of persons as the State Government or such officer deems necessary to prevent the outbreak of a contagious disease or the spread thereof, and may determine in what manner and by whom any expenses incurred (including compensation, if any) shall be defrayed.
- (2) In particular and without prejudice to the generality of the foregoing provision the State Government may take measures and make rules for—
 - (a) Prohibition of movement of cattle, cattle carcasses, or articles appertaining to them into or out of infected areas;
 - (b) Preventive vaccination or inoculation of cattle in infected areas and marking of cattle for purposes of identification.
 - (c) Compulsory segregation and treatment of cattle in infected areas.

Power of State Govt. to disperse, prohibit or regulate the holding of cattle-market, cattlefair, cattleexhibition, etc. 14. - (4) The [State] Government may also at any time for the purpose of satisfying itself as to the legality or propriety of any order passed by a Veterinary Officer under subsection (1) call for and examine the records of the case and may pass such order in reference thereto as it thinks fit.
- (5) A certificate under this section shall be granted in such form and on payment of such fee as may be prescribed.

IT is hereby enacted as follows:---

I. (1) This Act may be called the Hyderabad (Slaughter Short extent of Animals) Act, 1950. title, and commence-

(2) It extends to all Municipal and Town areas in the Hyderabad State and shall come into force in each such area from such date as Government may by notification in the *Jarida* appoint in respect of the area.

- 2. In this Act unless there is anything repugnant in the Definitions, subject or context,—
 - (1) "Animal" includes such animals only as Government may by notification in the Jarida declare to be animals for the purposes of this Act;
 - (2) "Municipal area" means an area which is for the time being a Municipality for the purposes of the Hyderabad Municipal and Town Committees "A" in IV of 1352F.;
 - (3) "Prescribed" means prescribed by rules made under this Act;
 - (4) "Town area" means an area which is for the time being a small Town for the purposes of the Hyderabad Municipal and Town Committees "A" in IV of 1352F. or which Government has by notifications in the Jarida declared to be a town area for the purposes of this Act;
 - (5) "Veterinary Officer" means an officer or person appointed under section 3.
- 3. Government may by notification in the Jarida appoint Appointment any officer or person to be the Veterinary Officer for an area of Veterinary in which this Act is for the time being in force.
- 4. In an area in which this Act is for the time being in Restriction force, no person shall slaughter, or procure the slaughter of, on slaughter any animal for human consumption otherwise than—

 (1) on the authority of a certificate granted by the

 - (2) in a slaughterhouse licensed for the slaughter of animals for human consumption.

- (4) The certificate referred to in clause (1) of section 4 shall be granted in such form and on payment of such fee as may be prescribed.

 - (d) prescribing the purposes to which fines realised under this Act may be applied, including such purposes as the maintenance of infirmaries, pinjrapoles, and veterinary hospitals;

 - (f) requiring persons carrying on the business of a farrier to be licensed and registered;

THE CATTLE TRESPASS ACT, 1871

ACT I OF 18711

An Act to consolidate and amend the law relating to Trespasses by Cattle

Whereas it is expedient to consolidate and amend the law relating to trespasses by cattle;

It is hereby enacted as follows:---

CHAPTER I

PRELIMINARY

²[1. (1) This Act may be called the Cattle-trespass Act, Title 1871.

(2) It extends to 3[the whole of India except Part B States]4 and the Presidency towns and such local areas as the ⁵[State Government] by notification in the official Gazette, may from time to time exclude from its operation.

An Act to provide for the protection, conservation and development of fisheries in the Central Provinces and Berar

Preamble.

WHEREAS it is expedient to provide for the protection, conservation and development of fisheries in the Central Provinces and Berar;

IT is hereby enacted as follows:-

Short title, extent and commencement.

- title, T. (1) This Act may be cited as the Central Provinces and and Berar Fisheries Act, 1948.
 - (2) It extends to the whole of 1 [Madhya Pradesh].
 - (3) It shall come into force on such date as the ¹[State] Government may by notification appoint in this behalf.

Definition.

- 2. In this Act unless there is anything repugnant in the subject or context,--
 - (i) "fish" includes shell-fish, and fish in all stages in its life history;
 - (ii) "Fishery Officer" means such officer as the ¹[State] Government may appoint for the purpose of this Act and includes any efficer or class of officers empowered by the ¹[State] Government to act as Fishery Officer:

Provided that no Police Officer below the rank of Sub-Inspector shall be so empowered;

- (iii) "Fixed engine" means any net, cage, trap or other contrivance for taking fish, fixed on the soil or made stationary in any other way;(iv) "private water" means water—
- - (a) which is the exclusive property of any person,
 - (b) in which any person has for the time being an exclusive right of fishery whether as owner, lessee or in any other capacity, but does not include any river, canal, stream, jhil, or any piece of water which ordinarily had direct communication with any river, canal, stream or jhil.

Explanation.—Water shall not cease to be "Private water" within the meaning of this definition by reason only of the fact that persons other than the owners may have by custom a right of fishery therein.

- (v) "Prescribed" means prescribed by rules made under this act.

- (2) The ¹[State] Government may, by notification, apply such rules or any of them to any private waters with the consent in writing of the owner thereof and of all persons having for the time being any exclusive right of fishery therein.
 - (3) Such rules may :--
 - (a) prohibit or regulate all or any of the following matters, that is to say—
 - (i) the erection and use of fixed engines;
 - (ii) the construction, temporary or permanent, of weirs, dams and bunds;
 - (iii) the dimension, size of mesh and kind of nets to be used and the mode of using them;
 - (iv) the use of more than one method of catching fish at one time;
 - (b) prohibit the destruction of, or any attempt to destroy, fishes by explosives, gun, bow, arrow or the like in inland waters;
 - (c) prohibit the destruction of, or any attempt to destroy, fishes by using a chemical or any other substance likely to cause pollution of water;
 - (d) prohibit the throwing into any water of any solid or liquid which may be harmful to fishes in such water;
 - (e) prohibit fishing except under a licence and regulate the grant of such licences, the fees payable therefor and the conditions to be inserted therein;
 - (f) prescribe the seasons during which the killing, catching or sale of fishes of any prescribed species shall be prohibited; and
 - (g) prescribe a minimum size or weight below which no fish of any prescribed species shall be sold.
- (4) Such rules may also prohibit all fishing in any specified waters for a specified period.
- (5) In making any rule under this section the ¹[State] Government may provide for:—
 - (a) the seizure, removal and forfeiture of any fixed engine or apparatus erected or used for fishing in contravention of the rules, and
 - (b) the forfeiture of any fishes taken by means of any such fixed engine or apparatus.

The ¹[State] Government may by notification prohibit in any specified areas the offering or exposing for sale or barter of any fish capture of which has been made unlawful by any rule made under section 3 of this Act although caught outside ¹[Maduhya Pradesh] and although their capture might be legal at the place where caught ture might be legal at the place where caught.

Penalties.

5. If any person contravenes any of the provisions of this Act or rules made thereunder, he shall on conviction be punishable with imprisonment for a term which may extend to three months or with fine which extend to five hundred rupees or with both.

Arrest with-out warrant for offence under this Act.

Provided that no person so arrested shall be detained longer than may be necessary for bringing him before a Magistrate except under an order of the Magistrate for his detention according to the Provisions of the Code of Criminal Procedure, Act of 1898.

(3) All Fishery Officers shall have the same powers of search and investigation in respect of an offence under this Act as a Police Officer of the rank of a Sub-Inspector has under the provisions of the Code of Criminal Procedure, Act of 1898.

 - (v) "private waters" means waters which are the exclusive property of any person or religious body or institution or in which any person or religious body or institution has for the time being an exclusive right of fishery, whether as owner, lessee or in any other capacity, and includes tanks, ponds, artificial lakes, etc., excavated at the expense of the owner which have no communication in the rainy season with natural waters, such as rivers, canals, streams and jhils.

Explanation.—Waters shall not cease to be "private waters" within the meaning of this definition if any other person has by usage or custom a right of fishery therein.

 - (d) prohibit fishing except under licence or regulate the granting of such licences, the charges of fees therefor and the conditions to be inserted therein;
 - (e) prescribe seasons in which the killing or catching or sale of any spawn, young or adult fish, of any prescribed species shall be prohibited; and

- (f) prescribe a minimum size or weight below which no fish of any prescribed species shall be killed or sold;
- (g) prohibit fishing in any specified water for specified period;
- (h) regulate the export of fish outside any area or areas and price at which fish may be bought or sold in specified markets of all or any specified species;
- (i) require the owner, mortgagee with possession or lessee of any tank or jhil for the stocking of such tanks or jhil with any class or classes of fish;
- (j) prescribe the formation of association or societies and the collection of funds for the uplift of fishermen and promotion of the fishing industry.
- (4) In making any rules under this section the ¹[State] Government may provide for—
 - (a) the seizure, removal and forfeiture of any apparatus erected or used for fishing in contravention of the rules;
 - (b) the forfeiture of any fish taken by means of any such apparatus, and
 - (c) the confiscation of any consignment of fish held or transported in contravention of the rules.
- (5) The power to make rules under this section shall be subject to the condition of the rules being made after previous publication.

BENGAL ACT 2 OF 1889

An Act for the protection of the right of fishing in private waters

Preamble.

WHEREAS it is expedient to provide for the protection of private rights of fishery;

It is hereby enacted as follows:-

Short title.

1. This Act may be called the Private Fisheries Protection Act, 1889.

Interpretation clause. "Fish." 2. In this Act-

"fish" includes shell-fish and turtles;

"fixed engine" means any net, cage, trap or other contrivance for taking fish fixed in the soil or made stationary in any other way;

"Private waters."

"Fixed engine."

"private waters" means waters-

- (a) which are the exclusive property of any person; or
- (b) in which any person has an exclusive right of fishery, and in which fish are not confined but have means of ingress or egress.

Penalties.

- 3. Any person who-
 - (a) fishes in any private waters, not having a right to fish therein,
 - (b) erects, places, maintains or uses any fixed engine in private waters, or puts, or knowingly permits to be put, therein any matter for the purpose of catching or destroying fish without the permission of the person to whom the right of fishery therein belongs;

shall be guilty of an offence, and shall be punished for a first offence with a fine not exceeding fifty rupees;

An Act to provide for the protection, conservation, auctioning and development of fisheries in the United State of Gwalior, Indore and Malwa (Madhya Bharat)

Whereas it is expedient to provide for the protection, conservation, auctioning and development of fisheries in the United State of Gwalior, Indore and Malwa (Madhya Bharat);

Mysore Act II of 1901

An Act to prevent the indiscriminate destruction of Wild Animals and Birds, and to provide for the protection of Game and Fish in Mysore

Preamble.

Whereas it is expedient to prevent the indiscriminate destruction of wild animals and birds, and to provide generally for the protection of game and fish in Mysore, Her Highness the Maharani-Regent is pleased to enact as follows :-

Short title.

1. (1) This Act may be called the "Mysore Game and Fish Preservation Act, 1901".

Extent and commencement.

- (2) It shall extend to such local areas as may from time to time be specified by Government by notification in the Official Gazette.
- (3) And it shall come into force at the end of six months from the date of its publication in the Official Gazette.1

'Game' defined.

2. In this Act "Game" means antelope, ibex, jungle-sheep, sambhar and all other descriptions of deer, bison, hares, jungle-fowl, spur-fowl, pea-owl, partridge, grouse, quail, wood-cock, bustare, florican, duck and teal, and shall include such other animals and birds as the Government of Mysore may by notification in the Official Gazette, declare to be game.

Absolute protection of by notification in the Official Gazette, prohibit absolutely particular classes other than "Game".

3. The Government of Mysore may, from time to time, protection of by notification in the Official Gazette, prohibit absolutely the killing or capture of any specified kinds of animals or birds, the killing or capture of which the Government may consider unsportsmanlike or otherwise inexpedient, provided that such animals or birds do not come under the definition of "Game" for the time being in force.

Whereas it is expedient to make provisions for matters Preamble. relating to Fisheries in the State of Travancore-Cochin;

IT is hereby enacted as follows:-

- I. (1) This Act may be called the Travancore-Cochin Short title. Fisheries Act, 1950.
- (2) It extends to the whole of the State of Travancore-Extent. Cochin.
 - (3) It shall come into force at once.

Commence-

2. In this Act, unless there is anything repugnant in the Definitions. subject or context,—

"Fish" includes shell-fish;

"Fixed engine" means any net, cage, trap or other contrivance for taking fish, fixed in the soil or made stationary in any other way; and

"Private water" means water which is the exclusive property of any person or in which any person has for the time being an exclusive right of fishery, whether as owner, lessee or in any other capacity.

Explanation.—Water shall not cease to be "private water" within the meaning of this definition by reason only that other persons may have by custom a right of fishery therein.

- 3. (1) The Government may, by a notification in the Close time. Gazette, declare the whole year or any part thereof to be a close time in any area for any kind of fish.
- (2) Subject to the provisions hereinafter contained it shall be unlawful except under a licence, and in the manner and to the extent permitted thereby to capture any fish during such close time.
- 4. (1) The Government may make rules for the purposes Protection of hereinafter in this section mentioned and may, by a notification in selection in the Gazette, apply all or any of such rules to such ed waters by waters, not being private waters, as the Government may by Governspecify in the said notification.
- (2) The Government may also, by a like notification, apply such rules or any of them to any private water with the consent in writing of the owner thereof and of all persons having for the time being any exclusive right of fishery therein.
- (3) Such rules may prohibit all fishing in any specified water except under a licence granted by the Government and in accordance with such terms and conditions as may be specified therein.

- (4) Such rules may also prohibit or regulate either permanently, or for a time or for specified seasons only, all or any of the following matters, that is to say:—
 - (a) the erection and use of fixed engines;
 - (b) the construction of weirs;
 - (c) the dimension and kind of the contrivances to be used for taking fish generally, or any specified kind of fish and the modes of using such contrivances;
 - (d) the minimum size or weight below which no fish of any prescribed species shall be killed;
 - (e) the variety, description or power of lights used for fishing; and
 - (f) the destruction of fish or depletion of fisheries by pollution by trade or industrial effluents.
- (5) Notwithstanding anything contained in sub-section (1) (2), (3) or (4), the Government may for the purpose of preserving or protecting fish in any area, make rules restricting, regulating or otherwise controlling fishing in private waters generally, and they may by notification in the Gazette apply all or any of such rules to such private waters as they may specify in the said notification after giving notice to the owners thereof and to all persons having or believed to have an exclusive right of fishing therein and after hearing their objections, if any.
- (6) In making any rule under this section the Government may provide for—
 - (a) the seizure, forfeiture, and removal of any fixed engines erected or used or nets or other contrivances used for fishing in contravention of the rules, and
 - (b) the forfeiture of any fish taken by means of any such fixed engine or nets or other contrivances.

Penalty.

6. The breach of any notification under Section 3 or of any rules made under Section 4, or of any notification under Section 5, shall be punishable with fine which may extend to one hundred rupees:

Provided that the Superintendent of Fisheries or any officer not below the rank of a Fishery Inspector specially authorised by Government in that behalf may accept from any person reasonably suspected of having committed an offence against the rules made under sub-section (3) of Section 4 by way of compensation for the offence which may have been committed, and where any property has been seized as liable to forfeiture may release the same on payment of the value thereof as estimated by him.

- 7. (1) If any person uses any dynamite or other explosive Destruction substances in any water with intent thereby to catch or of fish by ex-destroy any of the fish that may be therein, he shall be punish-land waters able with imprisonment for a term which may extend to two and on coasts. months, or with fine which may extend to two hundred rupees, or with both.
- (2) In sub-section (1) the word "water" includes the sea within a distance of one marine league of the sea coast; and an offence committed under that sub-section in such sea may be tried, punished and in all respects dealt with as if it had been committed on the land abutting on such coast.
- 8. (1) If any person puts any poison, lime or noxious ma- Destruction terial into any water with intent thereby to catch or destroy of fish by any fish, he shall be punishable with imprisonment for a poisoning term which may extend to two months or with fine which waters. term which may extend to two months or with fine which may extend to two hundred rupees, or with both.
- (2) The Government may, by notification in the Gazette, suspend the operation of this section in any specified area and may in like manner, modify or cancel any such notification.

- 10. Subject to any rule made in this behalf by the Govern-Cancellation ment, any licence may be cancelled or suspended by the of licence. authority competent to issue the licence-

Provided further that the provisions of this section shall not apply to fishing stakes and China nets.

13. Whoever, having been already convicted of an offence under this Act, is again convicted thereunder, shall, on every subsequent conviction, be punished with imprisonment for a term which may extend to six months or with fine which may extend to five hundred rupees, or with both.

Confiscation.

14. When any person is convicted of an offence punishable under this Act the convicting Magistrate may direct that any fish in respect of which the offence has been committed or the flesh or any part of such fish, together with the instru-ments, if any, with which the offence was committed, shall be confiscated.

Presumption of commission of certain offences, sume that he has captured or killed such fish with such instrument.

Duty of Court as regards can-cellation of licence.

16. When the holder of a licence granted under this Act has been convicted of an offence thereunder, the convicting Court shall send a copy of its judgment together with the licence (if before the Court) to the nearest authority empowered to cancel the licence under this Act, for such action as such authority may deem fit.

(1) Whenever it appears that adequate arrangements have been made by any club or association to receiving non-indigenous variety ing certain of fish psech water within such limits and for such period, and fish in such water within such limits and for such period and subject to such conditions as the Government may deem fit.
 - (2) Any club or association to which such right has been conceded may, subject to the approval of the Government, make rules for the protection and preservation of the fish to which the concession applies, and for regulating the manner in which they may be taken. Such rules when approved by the Government shall be published in the Gazette.

- (3) In particular, and without prejudice to the generality of the power conferred by the last preceding sub-section, such rules may-
 - (a) provide for the issue of licences by the club or association (either in addition to or in substitution for the licences prescribed by Section 9) enabling the licencees to fish for and take the fish to which the concession applies subject to the rules of the club er association;
 - (b) prescribe the fees chargeable on the issue of such licences;
 - (c) provide for the application of such fees; and
 - (d) prescribe a close season for the fish with regard to which the concession was given.
- 20. Any person who fishes or takes, or attempts to take Fishing with-any fish for the taking of which a licence is required by rules out licence in made under Section 19 without such licence, or during the conceded close season prescribed by such rules, or in contravention of waters. any of such rules, shall be liable to the punishment prescribed by Section 6.
- 21. Any Police Officer or other person specially empowered by the Government in this behalf may, without a warrant, arrest any person committing in his view a breach of any of the provisions of this Act or of any rule made thereunder, if the name and address of such person be unknown to him and if such person declines to give his name and address or if the Police Officer or any person empowered as aforesaid shall have reason to doubt the accuracy of such purposers and shall have reason to doubt the accuracy of such name or address, if given, such person may, subject to the Code of Criminal Procedure for the time being in force, be detained at the Station-house until his name and address shall be correctly ascertained.

22. (4) Fee at such rates as may be fixed by the Government by rules made under sub-section (3) shall be paid in respect of every licence issued under sub-section (1):

Provided that the fee payable for any such licence shall not exceed a sum calculated at rupees five per acre of the private waters into which prawns are attracted or caused or allowed to migrate.

(5) The breach of any rule made under sub-section (3) or of the conditions of any licence issued under sub-section(1), shall be punishable with fine which may extend to one hundred rupees.

23. The Government may, by notification in the Gazette, apply the provisions of this Act to shells of fish, if, in their opinion, it is desirable to prohibit or regulate the collection of the same from the same from the collection of the collection opinion, it is desirable to prohibit or regulate the collection of the same from any water.

Explanation.—For the purposes of this section, the word "water" includes the sea within a distance of one marine league of the sea coast.

Repeal.

24. The Travancore Fisheries Act, XI of year 1097 and the Cochin Fisheries Act, III of 1092 are hereby repealed:

Provided that all licences granted under the said Acts shall continue in force for the periods for which the same have been granted subject to the provisions of the said Acts.

THE STATE OF BHOPAL FISHERIES ACT, 1952

Act V of 1953

An Act to provide for the protection, conservation, auctioning and development of Fisheries in the State of Bhopal

Whereas it is expedient to provide for the protection, conservation, auctioning and development of Fisheries in the State of Bhopal;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the State of Bhopal Fish-Title, extent and commencement. cries Act, 1952.
 - (2) It extends to the whole of the State of Bhopal.
- (3) It shall come into force on such date as the Chief Commissioner may, by notification in the official Gazette, declare in this behalf.
- 2. In this Act unless there is anything repugnant in the Definitions. subject or context,-
 - (i) "Fish" includes shell-fish.
 - (ii) "Fisheries Development Officer" means such officer as the Government may appoint for the purpose of this Act and includes any officer empowered by the Government to act as Fisheries Development Officer.
 - (iii) "Fixed engine" means any net, cage, trap or other contrivance for taking fish fixed in the soil or made stationary in any other way.
 - (iv) "Private Water" means water which is the exclusive property of any person or in which any person has for the time being an exclusive right of fishery whether as owner, lessee or in any other capacity.

Explanation.—Water shall not cease to be "Private Water" within the meaning of this definition by reason only of the fact that persons other than the owners may have by customs a right of fishery therein.

- (v) "Prescribed" means prescribed by rules made under this Act.
- 3. (1) The Government after previous publication in the Protection of official Gazette may make rules for the purpose hereinafter making making in this section mentioned and shall in such rules, declare Rules. the waters, not being private waters to which all or any of them shall apply.

(2) The Government may, by notification in the official Gazette, apply such rules or any of them to any private waters with the consent in writing of the owner thereof and of all persons having for the time being any exclusive right of fisheries therein.

- (3) Such rules may-
 - (a) prohibit or regulate all or any of the following matters, that is to say-
 - (i) the erection and use of fixed engines;
 - (ii) the construction of temporary or permanent weirs, dams and bunds;
 - (iii) the dimensions, size of mesh and kind of nets to be used and the mode of using them;
 - (iv) the use of more than one method of catching fish at one time;
 - (b) prohibit the destruction of or any attempt to destroy fishes by explosive, gun, bow, arrow or the like in inland waters;
 - (c) prohibit the destruction of or any attempt to destroy fishes by using a chemical or any other substance likely to cause pollution of water;
 - (d) prohibit the throwing into any water of any solid or liquid or gas which may be harmful to fishes in such waters;
 - (e) prohibit fishing except under a licence and regulate the grant of such licences, the fees payable therefor and the conditions to be inserted therein;
 - (f) prescribe the seasons during which the killing, catching or sale of fishes of any prescribed species shall be prohibited;
 - (g) prescribe a minimum size or weight below which no fish of any prescribed species shall be sold;
 - (h) prescribe any procedure regarding sale or auctioning of fishes; and
 - (i) require an owner of a private water to undertake fish-culture in his waters.
- (4) Such rules may also prohibit all fishes in any specified water for a specified period.
- (5) In making any rules under this section the Government may provide for-
 - (a) the seizure, removal and forfeiture of any fixed engine or apparatus erected or used for fishing in contravention of the rules, and
 - (b) the forfeiture of any fishes taken by means of any such fixed engine or apparatus.

4. The Government may, by notification in the official sale Gazette, prohibit in any specified areas the offering or exprohibit of fish, posing for sale or barter of any fish the capture of which has been made unlawful by any rule made under section 3 of this Act, irrespective of the place where it has been caught.

Power to

- 5. If any person contravenes any of the provisions of this Penalties. Act or rules made thereunder, he shall on conviction be punishable with imprisonment for a term which may extend to two months or with fine which may extend to two hundred rupees or with both.
- 6. (1) Any Sub-Inspector of police or other person specially Arrest withempowered and notified in the official Gazette by the Govern-out warrant
 ment in this behalf may, without warrant, arrest any person committing or attempting to commit a breach of any Act.

A person arrested under this section may be detained until his name and address have been correctly ascertained:

Provided that no person so arrested shall be detained longer than may be necessary for bringing him before a Magistrate except under an order of the Magistrate for his detention according to the provisions of the Code of Criminal Procedure, 1898.

(3) All officers empowered by the Fisheries Development Officer in this behalf shall have the same powers to seize, search and investigate in respect of an offence under this Act as a Police Officer of the rank of a Sub-Inspector has under the provisions of the Code of Criminal Procedure, 1898.

7. (1) No court inferior to that of a Magistrate of the Jurisdiction second class shall try any offence under this Act.

- (2) No court shall take cognizance of any offence under II class exthis Act except on a report in writing of the facts constitut-cluded. ing such offence made by the Fisheries Development Officer or a Police Officer not below the rank of Sub-Inspector or any other officer specially authorised by Fisheries Development Officer in this behalf.
- 8. (1) Any offence specified in the schedule may be Offences to be compounded by the Fisheries Development Officer or compounded, any other person specially empowered by the Government in this behalf by acceptance of a sum not exceeding one hundred rupees along with the value of the property seized, as estimated by such officer.
- (2) On composition of an offence, the accused shall be discharged and property seized from his possession shall be released.
- 9. All persons empowered to exercise powers and perform Officers duties under this Act shall be deemed to be public servants be de within the meaning of section 21 of the Indian Penal Code, vants. 186o.

THE SCHEDULE

Offences compoundable under section 8

- 1. Fishing with a net having a smaller mesh than that prescribed under the rules made under this Act.
- 2. Fishing without a licence.
- 3. Selling or attempting to sell fish of a size or weight less than the standard prescribed under this Act.
- 4. Killing or catching or selling or attempting to kill, to catch or sell any fish of a prohibited species during a close season.
- 5. Fishing or attempting to fish with any gear or method other than the prescribed gear or method.
