INTRODUCTION

This volume contains all the twenty-three Reviews of Administration of the Bombay Presidency compiled individually under the instructions of His Excellency the Governor, Sir Frederick Sykes, in consonance with his intention of having the whole administrative machinery of Government examined and ensuring efficient working in accordance with present and future economic and progressive requirements. Each review includes all the important changes effected during the last five years, including a summary of reforms, developments, economies carried out and proposals which Government have considered and rejected. The position disclosed has been examined by the Reorganisation Committee, and the subject matter, including the recommendations of that committee, brought up-to-date for future reference and assistance. This volume has been paged consecutively, but each review is prefaced by a table of contents.

Remarks.—In the year 1918–19, the receipts swelled in consequence of the supply of timber and other forest produce to the Munitions Board and the high prices prevailing in the market. The increased demand necessitated enhancement of the cost of exploitation. The main reasons for the fall of receipts in the year 1930–31 were acute depression in the timber trade, the Congress campaign of boycott and picketing, and the




