INTRODUCTION

India has attained her freedom and is now at liberty to develop herself according to her genius. But she can fully develop only when some of the evil legacies that the British have left behind them, are swept off. One of such legacies is the irrational formation of provinces without an eye to the real development of the land and its people. The mischief has been partially undone by the formation of Bihar, Orissa and Sind as separate provinces. But much remains to be done in this direction, especially in the south.

The Constituent Assembly of India is framing a new constitution for this great country. A new constitution means a new order of things, the provision of a new framework for working out the objectives near and dear to a nation and its people. The dawn of a real democracy based on adult franchise is near at hand. It is in this context that this small brochure seeks to state the case for the redistribution of provinces on linguistic and cultural basis and especially the case for the formation of a united Karnatak province.

The people of Karnatak lie scattered in different administrations and have been suffering the evils of this disintegra. They have been agitating for the last thirty years for a united Karnatak. The Indian National Congress formed linguistic provinces and among them Karnatak in 1920 for its own administration and activities. Karnatak has realised the advantages of such a unification and since then her political and many cultural activities have been directed on the basis of a single province. But this is not enough and the seal of real unification can be set only by the formation of a single administrative province. Though as a first step it is proposed to form a province consisting of the non-States areas only, the grant of responsible government in Mysore has opened a new vista. This book has gone into that whole question; but has stated the case as well as the ways and means primarily for a province consisting of those territories of Karnatak which lie outside the States.

The members of the Drafting Committee which prepared this statement felt it necessary to state the case at this juncture as briefly as possible and place it into the hands of the public. The Karnatak Provincial Congress Committee and the Karnatak Unification League have been the bodies that have been working for the last quarter of a century for unification. We are publishing this booklet in the hope that every citizen will give due consideration to the subject and support the formation of linguistic provinces and thereby help Karnatak to come to her own. Karnatak will then be able to develop to her full stature and contribute her humble mite to make India far greater than what she is today.

CHAPTER I

NEED FOR LINGUISTIC PROVINCES

Units in a Federation

The present distribution of provinces is based on no rational basis. The provincial boundaries were artificially drawn as a result of British conquest and rule. As the authors of the Montford Report admitted, "the present map of British India was shaped by a military, political or administrative exigencies or conveniences of the moment with small regard to the actual affinities or wishes of the people". The Simon Commission also pointed out this fact. The Nehru Committee appointed by the All-Parties Conference in 1928 discussed the question of the redistribution of provinces and held the view that there was a strong case for a distribution of provinces on linguistic lines. The report pointed out that the existing provinces had little to do with geographical or historical or economic or linguistic reasons and that, even from the purely administrative point of view, they were not a success.

It would be unwise to postpone this question any longer in view of the approaching formation of a federation for the Indian Union. The nature of units in a federation is a matter of vital importance. To treat the existing provinces as the federating units would, as rightly pointed out by Prof. D. R. Gadgil, Director of Gokhale Institute of Politics and Economics, "not only be meaningless but also positively harmful. A large number of these units are so composite in character as to be potential federations in themselves, and in a number of instances, there is no homogeneity of sentiment or interest between all their parts. If the federal structure is to be raised on a basis that is durable, the sertling of Provincial constitutions......must be done by units which are homogeneous, which have a feeling of distinct identity among themselves and which represent a common way of thinking."†

Since language is the most important factor indicating a distinct culture, common traditions and a common way of thinking, a linguistic area would be the most appropriate unit in a federation. In India the people having a common language and literature have already developed such a strong feeling of oneness that they should be considered as a distinct regional group. It would be really wrong to consider the Indian people as a whole as forming one homogeneous mass of population. As a matter of fact, the Indian nation is made up of several sub-national groups each speaking a well developed language of its own.

That the people in India speaking a distinct language form a separate sub-nationality can be well illustrated by way of a comparison with conditions in Europe. The difference between a Punjabi and a Tamil in respect of language, traditions culture, etc., is at least as wide as that between an Englishman and a Frenchman. Similar comparisons between different sub-nationalities in India and those on the European continent would show that India has many distinct subnationalities. But unlike European peoples, a sub-stratum of common history, traditions and cultural ties for many centuries has developed among the Indians a strong con. ciousness of being one people belonging to one nation. These various sub-nationalities in India may not seek to break away from one another. On the contrary, they may aspire to form a united Indian nation, but this should not mislead us into thinking that the Indian people as a whole do not even constitute different sub-nationalities. Once it is admitted that India is made up of various sub-nationalities, no further argument is necessary for the redistribution of provinces on linguistic basis. In short, in the comprehensive nationhood of India which we are building, the individualities of the Bengalee, the Maratha the Tamil, the Andhra, the Kannadiga and other groups must each find their proper place as distinct groups like those of the English, Scotch and Welsh in the United Kingdom, and like those of the British and French in Canada. As pointed out, the existing administrative provinces in India have been formed haphazardly by somewhat fortuitous circumstances. The present provincial boundaries are largely mere accidents of history; they do not form any geographical, racial or linguistic principles, nor have they proved to have been administratively convenient and successful.

The East India Company originally acquired certain possessions on the eastern and western coasts as also in the old province of Bengal. These were named the three presidencies of Madras, Bombay and Bengal. New acquisitions. as they were made, were added to one of these presidencies, When they became unwieldy, new administrative units called Lieutenant Governerships or Commissionerships were created without any reference to the community or harmony of interests. All these units came subsequently to be called 'Provinces'. Of these provinces, Madras, Bombay, C.P. and Bengal were multi-lingual areas. The Bengal Presidency was once made up of Bengal, Bihar and Orissa. The Central Province consists of Hindustani and Marathi areas. consists of four different regions, namely (1) Andhra or Telugu. (2) Tamil. (3) Malayalam and (4) Karnatak. The province of Bombay has three linguistic areas belonging to Gujarat, Maharashtra and Karnatak, After 1911, Bihar and Orissa were separated from Bengal and in 1936 Orissa was formed into a separate unit. Separate administrative provinces on linguistic basis have got to be formed for Maharashtra, Gujarat, Karnatak, Andhra, Tamilnadu and Kerala or Malayalam. This would naturally result in the logical redistribution of the present unwisely and heterogeneous provinces of C.P. Bombay and Madras. Karnatak has suffered most by this unsystematic arrangement of administrative units.

Size of Provinces

The existence of large provinces such as Madras and Bombay is a definite disadvantage from the administrative point of view. These large provinces have become so unwieldy that serious inconvenience is caused to the people, particularly to those who are in the border districts. In a country like India, where people are generally poor, care should be taken to see

that no part of the province is far away from the provincial head-quarters. In fact, the people should have easy access to the headquarters of the province. Moreover, the functioning of democracy becomes difficult in a province where the people are far removed from the place where the legislature preets.

That the existing provinces are of an unwieldy size was recognised as early as 1918 by the authors of the Montagu-Chelmsford Report on Indian Constitutional Reforms. "We cannot doubt," stated the Montagu-Chelmsford Commission, "that the business of Government would be simplified if administrative units were both smaller and more homogeneous; and when we bear in mind the prospect of the immense burdens of government in India being transferred to comparatively inexperienced hands, such considerations acquire additional weight"."

The Simon Commission, which reported in 1930, also held the same view. The Commission stated: "Most of them (provinces) are too populous and extensive, having regard to the cultural level and economic conditions of their inhabitants, to allow of the easy working of the machinery of representative government on a reasonably extensive franchise".† Thus the Commission thought that even under the restricted franchise which they proposed, the size of the provinces was too large for the easy working of the representative government. This means that an efficient functioning of the administrative machinery would become much more difficult under universal adult franchise, which is now guaranteed by the Constituent Assembly, unless the size of the provinces is greatly reduced.

That the existing provinces are too extensive and populous can be seen from a few comparisons. The provinces of Madras and Bombay are each of them bigger than Italy. The United Provinces and the Central Provinces each exceed Great Britain in size; and Orissa, one of the smallest in area in the Indian Dominion, is of almost the size of Portugal. If we turn from areas to population, the scale of things is not less significant.

The provinces of Madras and United Provinces have each of them more inhabitants than Great Britain. Even Assam (excluding Sylhet), which is the smallest in population in the Indian Dominion, has more inhabitants than Portugal.

No lederation in the world contains units so large as the existing provinces in India. In the Soviet Union, the units of the Federation based on linguistic, ethnic and cultural affinity, are much smaller in population when compared to the provinces in India. Out of the 16 Soviet Republics, only three have a population exceeding one crore each, whereas in the Indian Dominion, only two provinces have a population of less than one crore each. As many as 11 republics out of 16 in the Soviet Union have a population of less than 36 lakhs each. In fact, only two have a population of more than 60 lakhs each, while as many as seven have a population of less than 20 lakhs each. The smallest of them has a population which is less than five lakhs. In the United States of America, the average population of a State which is analogous to our province is about 30 lakhs. The average population of a Canadian province is still less. Considered in the light of these comparisons. the creation of linguistic provinces in India for groups like Maharashtrians, Gujaratis, Andhras, Kannadigas, Tamils, and Malavalees will not result in provinces of an unduly small size.

The size of the proposed province of Karnatak would be neither too small nor too big. The area of the new province would be about 34,000 square miles with a total population of over 75 lakhs even excluding the area in the adjoining Mysore State. The principles of a 'model' constitution for the provinces of the Indian Union, as enunciated by the Constituent Assembly, recognise the possibility of the creation of provinces which would be even smaller in population the proposed province of Karnatak. Clause 19 of this 'Model' Constitution says:—"The representation of the different territorial constituencies in the Legislative Assembly shall be on a scale of not more than one representative for every lakh of the population, subject to a minimum of 60 for any province and a maximum of 300". The laying down of this minimum of 60 for a province clearly shows that there is a

possibility of provinces being created with a population which would be less than 60 lakhs. It is important to note that to-day no province in the Dominion of India has less than 60 lakhs of population. Even Assam, the smallest of the existing provinces, has a population of over 71 lakhs. Knowing that no existing province has a population which is less than 60 lakhs, the Constituent Assembly thought it proper to lay down this limit of 60 members, thereby recognising the possible need for the creation of smaller provinces.

Harmonious Relations

It is often argued that the creation of linguistic provinces would lead to provincial rivalries and will thereby weaken the solidarity of the Indian people as a whole. The truth is that only the formation of provinces on linguistic and cultural basis would eliminate provincial jealousies and rivalries. It is common knowledge that there is a feeling of mutual rivalry and even distrust amongst the people comprising different linguistic and cultural regions when they happen to be grouped in multilingual provinces such as Madras and Bombay. For instance, this feeling exists in the province of Bombay between Maharashtrians and Gajaratis on the one hand and the Maharashtrians and the Karnatakis on the Similarly, in the Madras province, the feeling of distrust between the Andhras and Tamils has assumed such serious proportions that unless a division is effected between them by the creation of separate provinces a stable and efficient administration for the province of Madras will be very difficult of realisation.

That the provincial rivalries will cease to exist as a result of the creation of linguistic provinces, is evident from the fact that today there is no ill-feeling whatsoever between the various sub-nationalities when they are not grouped in one province. For instance, such feeling does not exist between the Maharashtrians and the Andhras in spite of the fact that they are neighbours. Similarly, the ill-feeling that existed between the Oriyas and the Andhras before the creation of the separate province of Orissa has now practically ceased to exist.

It is thus clear that the only remedy for the elimination of such ill-feeling and rivalries between various linguistic subnationalities is to form linguistic provinces. Recent history has shown that the creation of linguistically homogeneous units greatly helps in developing initiative and a feeling of oneness amongst the people comprised within these units. In our opinion, the national movement in India would not have acquired the strength it did, if the Indian National Congress had ignored the factor of language in framing its constitution. The creation of linguistic provinces for the purpose of carrying on the work of the Indian National Congress was one of the fundamental factors in evoking the loyalty of the people to the central organisation and also in developing a sense of patriotism amongst the people. It will be a great misfortune if this lesson of history is ignored by the framers of India's new constitution. In fact, the existing units in the Indian Union will fail to give that sense of stability and administrative efficiency which are so essential for the successful working of a federal government. It is, therefore, essential that the units in the federation should be linguistically homogeneous.

Functioning of Democracy

The existence of bi-lingual or multi-lingual provinces would make democratic government extremely difficult and unreal. A variety of languages in a province would mean that the members of a provincial legislature will have to speak in different languages, if each one of them desires to speak in his own language. As each and every member of a multi-lingual province cannot reasonably be expected to know all the regional languages of his province, the result would be that a member speaking his own language may not be understood by a large section of the house. The Simon Commission did not fail to take note of this anomalous position when they wrote that "in Madras Legislative Council, Tamil-speaking members will be understood only by a minority; Telugu and Kanarese are in the same case; and English provides the greatest common measure."

This anomalous position may often lead to absurdities as it actually did in the Bombay Legislative Assembly very recently. On September 11, 1947, the Speaker of the Bombay Legislative Assembly told the members that they could speak in any recognised provincial language, bearing in mind that what they spoke was not meant for their own satisfaction, but to make themselves understood by others. The result of this so-called 'freedom of language' led to several undesirable incidents almost within a week itself. A Minister piloted a Bill in Marathi and a Parliamentary Secretary made a speech in Gujarati, thereby depriving several members of their right to know what a Government representative speaks in the legislature. A member put certain questions in a language which the Minister concerned could not understand. Another member spoke in Kannada which could not be understood by more than 80 per cent of the members of the Assembly. All this happened for the simple reason that the province of Bombay is a multilingual area, its inhabitants speaking three different languages, viz., Marathi, Gujarathi and Kannada. English, with the disappearance of the British rule, cannot remain in India as the language of administration. In the legislatures, we are having members not conversant with English.

Only the formation of linguistic provinces can eliminate the possibility of absurd situations like those described above. That democracy cannot function efficiently under such conditions is hard to deny. The use of provincial languages in politics is essential for the successful working of democracy. The provinces should be so designed as to make it possible for public business to be discussed in a language which all the legislators can speak with ease and which the electors can understand. Only then the common people, who cannot be expected to conduct debates in English, are rendered available for being members of the legislature. In short, the hope of a democratic government lies in the language of the people.

The fact that the existence of bi-lingual or multilingual provinces in India is a great obstacle in the successful working of responsible or representative government is recognised by many constitutional experts. The Montford Commission reporting in 1918 stated:

It is also a strong argument in favour of linguistic or racial units of government that, by making it possible to colduct the business of legislation in the vernacular, they would contribute to draw into the arena of public affairs men who were not acquainted with English. We believe emphatically that redistribution of provincial areas cannot be imposed upon the people by official action: and that such a process ought in any case to follow and to precede nor accompany, constitutional reform. But we are bound to indicate our own clear opinion that wherever such redistributions are necessary and can be effected by process of consent, the attempt to do so should be made; and therefore, we desire that it should be recognised as one of the earliest duties incumbent upon all the reformed provincial Governments to test provincial opinion upon schemes directed to this end".*

In 1928, the Nehru Committee Report discussed this question at great length. The views of the Nehru Committee on this subject are so instructive that we make no apology for quoting them in full. They stated:

"It is well recognised that rapid progress in education as well as in general culture and in most departments of life depends on language. If a foreign language is the medium of instruction, business and affairs and the life of the country must necessarily be stunted. No democracy can exist where a foreign language is used for these purposes. A democracy must be well informed and must be able to understand and follow public affairs in order to take an effective part in them. It is inconceivable that a democracy can do this if a foreign language is largely used. It becomes essential therefore to conduct the business and politics of a country in a language which is understood by the masses. So far as the provinces are concerned this must be the provincial language. We

are certainly not against the use of English. Indeed from, the necessities of the situation we feel that English must. as at present, continue for some time to come to be the most convenient medium for debate in the central legis. lature. We also believe that a foreign language, and this is likely to be English, is essential for us to develop contacts with the thought and science and life of other countries. We are however strongly of opinion that every effort should be made to make Hindustani the common language of the whole of India, as it is to-day of half of it. But, granting all this, provincial languages will have to be encouraged and, if we wish the province to make rapid progress, we shall have to get it to do its work in its own language. If a province has to educate itself and do its daily work through the medium of its own language, it must necessarily be a linguistic area. If it happens to be a polyglot area difficulties will continually arise and the media of instruction and work will be in two or even more languages. Hence it becomes most desirable for provinces to be regrouped on a linguistic basis. Language as a rule corresponds with a special variety of culture, of traditions and literature. In a linguistic area all these factors will help in the general progress of the province".*

The conclusion is that it is practically impossible for India to develop a democratic form of government or to lachieve a genuine nationhood on the basis of a map inherited from the British and fashioned to suit the needs of an autocratic administration. The formation of linguistic provinces alone will create the necessary machinery for the successful functioning of democracy. As the late Rt. Hon'ble Mr. Srinivasa Sastri once declared: 'The idea of a compact area with a homogeneous population dwelling in it is certainly the most propitious condition that we can imagine for the success of representative government'.

CHAPTER II

MOVEMENT FOR LINGUISTIC PROVINCES

Beginnings of the Movement

The hardships and injustice suffered by the people of those linguistic areas who were inconveniently grouped in different administrative units naturally gave rise to the movement for linguistic unity and for the formation of linguistic provinces. The beginnings of this movement can be traced to the last quarter of the 19th century. The fact that the people could strongly feel the desire for linguistic unity at a time when even the Indian National Congress was not born clearly shows the depth of the feeling amoung the people on this question.

As early as 1874 when the district of Sylhet was transfersed from Bengal to the Chief Commissionership of Assam, the inhabitants of that district strongly protested against the transfer. Ever since the people of Sylhet, both Hindus and Muslims, had been demanding their reunion with Bengal on the ground that they formed a part and parcel of the Bengalispeaking sub-nationality.

Two years later, i.e. in 1876 Raja Baikunth Nath De of Balasore and Bichitranand Patnaik submitted a memorial to the Government pleading for a single administration for all the scattered Oriya-speaking tracts. This is how the movement for a linguistic province of Orissa began in those early days. Since then the demand of the Oriyas steadily gained ground; and in 1895 it attracted the attention of Mr. Cooke Commissioner for Orissa, who officially supported the demand and recommended that the Oriya people should be united under a single administrative unit.

18%, the Biharis under the leadership of Mr. Mahesh Narayan started the movement for a separate province of Bihar on the ground that the Hindi-speaking people of Bihar formed a distinct group in the Presidency of Bengal which then comprised within its boundaries most of the territories which are at present included within the provinces of East and West Bengal, Bihar and Orissa-

When this feeling for a separate existence was gaining ground in Bihar, the movement in Orissa took a definite shape. In 1902 a memorial signed by hundreds of Oriyas was presented to Lord Curzon, the then Governor-General, asking for the linguistic unity of the Oriyas under one administration. In 1903, an association called the Utkal Union conference was formed with a view to systematically carrying on the agitation for a united Orissa.

The Partition of Bengal in 1905 gave a great fillip to the movement for linguistic unity in various parts of the country. It is very significant to note that in 1908 the late Lokmanya Bal Gangadhar Tilak, giving evidence before the Royal Commission upon Decentralization in India, advocated "a rearrangement of provinces on considerations of linguistic and ethnological affinities and a federation thereof under a central authority". The agitation in various parts of the country for the creation of linguistic provinces and the evidence of Lokmanya Tilak seem to have made an impression upon the Commission. Although the Commission was not called upon to deal with the question of provincial boundaries, it could not fail to point out the fact that "the various provinces contain diverse nationalities with different languages, traditions, and interests, and are often on separate planes of development".t

The agitation against the partition of Bengal assumed such serious proportions that the British Government was forced to cancel the partition in 1911. The famous Hardinge Dispatch of 1911 proposing the cancellation of the partition of Bengal and the new re-arrangement of the territories concerned was a great victory for the principle underlying the formation of linguistic provinces. The Dispatch clearly recognised that injustice might be done to a people speaking a distinct language by their being placed in a position of permanent minority in a province. Speaking on this point with

regard to Bihar, the Dispatch stated that "it is in the highest degree desirable to give the Hindi-speaking people, now included within the province of Bengal, a separate administration. These people have hitherto been unequally yoked with the Bengalis, and have never, therefore, had a fair opportunity for development".

Thus the agitation started by the Biharis in 1896 had its effect; and the Hardinge Dispatch had to recognise the soundness of the claim put forward by them. The fact that the Government of India was practically forced to this conclusion is evident from the following remarks of the Hardinge Dispatch. It stated: "The cry of Bihar for Biharis has frequently been raised......There has, moreover, been a very marked awakening in Bihar in recent years, and a strong feeling has grown up among Biharis that Bihar will never develop until it is dissociated from Bengal. That belief will, unless a remedy be found, give rise to agitation in the near future, and the present is an admirable opportunity to carry out on our own initiative a thoroughly sound and much deserved change."

The result was the creation of the province of Bihar and Orissa. The Hardinge Despatch, although admitted the fact that the Oriyas, like the Biharis, had little common with the Bengalis, did not recommend the formation of a separate province for Orissa. This failure on the part of the British Government to fulfil the natural aspirations of the Oriyas and many other nationalities not only kept the movement alive in Orissa, but also gave birth to similar movements in other areas.

Spread of the Movement

The new areas in which this movement become more pronounced was Andhra, the Telugu-speaking country, and Karnataka, the Kannada-speaking country. Since 1913 the Andhras had been holding conferences at almost regular intervals, at which resolutions demanding a separate province for Andhra were adopted. The Kannadigas, who were also feeling the desire to unite under one administrative unit, formed in 1916 an association known as the "Karnataka Sabha"

with the aim of unifying Karnatak. This Sabha, which was later on re-named as the Karnataka Unification Sabha, has been ever since holding conferences and passing resolutions demanding unification. In 1917 when Mr. Montagu and Lord Chemsford were touring India before submitting, their proposals to the British Government on Indian Constitutional Reforms, the Oriyas, the Andhras and the Kannadigas presented them with representations demanding the creation of separate provinces for Orissa, Andhra and Karnatak.

At about the same time, Mr. Lionel Curtis, a close student of constitutional questions, fully realising the soundness of the peoples' demand for linguistic provinces, very ably advocated their cause both before the Montford Commission and the public. The views he held on this question were so sound and rational that they have not lost their force even today. Since Mr. Curtis played an important part in educating public opinion on this question, particularly in influential quarters, it would be usefull to know the arguments he put forward in advocating the cause. While speaking of the provinces, as irrationally created, he says:

"They are for the most part the artificial creations of a paterenal and highly centralised government which has its mainspring in England. They were designed as the satraples of a vast oriental dependency.... The internal peace of India generations hence, will depend upon the wisdom and foresight with which the areas of provincial self-government are planned in the initial stages of the new departure". Next when writing about the principle of redistribution, he says: 'Where possible historic areas like Sind should be taken. But unity of language, race and religion are also important factors, and language is the most important of all', While speaking of the application of the principle, he further says: 'If this experience is held in mind, can we really look forward to a United States of India within the British Common-wealth, under which Sind and the Kanarese speaking people are tied and bound into the same self-governing unit as the Marathas?

Are not the Marathas themselves entitled to a state such as will perpetuate the traditions of that famous community? Are the Tamil and Telugu peoples of Madras to be given no separate institution of their own? Are the Ooriyas to be left dispersed amongst three provinces, the larger section being left under the permanent domination of the people of Bihar? To base responsible government on such units is not only to ignore the experience af the other dominions, but to violate the principles for which we are fighting in this war. You cannot base responsible government on units evolved on principles which are the antithesis of that system. You cannot graft figs on thorns or grapes on thistles'.*

The Motague Chemsford Commission, after pointing out that provinces were distributed having "small regard to the natural affinities or wishes of the people", remarked that "the point is of supreme importance when we have to consider the future development of India". In paragraph 246 of their Report, they made the definite recommendation that the qustion "should be recognised as one of the earliest duties encumbent upon all the reformed provincial Governments to test provincial opinion upon schemes directed to this end" This recommendation marked a further stage in the movement in the sense that Governments were definitely asked not to ignore the question but to recognise it as resonable and to test public opinion on it.

After the publication of the Montford Report, the advocates of linguistic provinces were not satisfied by merely holding public conferences, passing resolutions and by presenting memorials to officials. The method of making use of the legislatures for the abvocacy of their cause was now felt necessary. As a result, the question of redistribution of provinces was brought before the legislature several times both in the form of resolutions and questions.

On February 16, 1948, Rao Bahadur B. N. Sarma moved a resolution in the old Indian Legislative Council, recommending the redistribution of provincial areas, and the constitution

of provinces, where necessary, to secure complete means for self-governing institution; and the rearrangement of provincial areas on a language basis, wherever and to the extent possible, especially where the people speaking a distinct language and sufficiently large in numbers, desired such a change. Although the resolution was not opposed by any member on grounds of principles, it did not secure the approval of the house mainly on grounds of expediency.

In 1920 the Indian National Congress recognised the principle of formation of linguistic provinces and since then, so far as the Congress machinery is concerned, India has been divided into linguistic provinces. Thus the soundness of the principle, for which the people in different parts of the country stood and fought, received the approval of the nation! movement, thereby demonstrating that the creation of linguistic provinces would foster the feeling of oneness among the Indian people as a whole instead of hampering it as apprehended by some.

Ie 1921, Mr. A. B. Lathe moved a resolution in the newly constituted Indian Legislative Assembly, recommending the reconstitution of provinces with a view to facilitate the constitutional development of the provinces. In moving his resolution, Mr. Lathe pointed out how the people of Orissa, Karnatak and Maharashtra were divided under different administrations. He also made a reference to the disabilities of the people of Sind. Although the resolution was formally defeated, it secured the support of the majority of the elected members of the Assembly, thereby showing that the real representatives of the people were in favour of his resolution.

In 1922, Mr. Ramayya, Pantalu moved a resolution in the Indian Legislative Assembly, recommending that the Telugu-speaking districts of the Madras Presidency be constituted into a separate province. Though the resolution was confined to Andhra, the mover in his speech advocated the general principle of linguistic provinces. As the object of the mover was only to elicit the sympathy of the Government towards the cause, the resolution was not pressed to vote.

In 1926, Dr. U. Rama Rao moved a resolution in the Council of State, recommending the appointment of a Committee to suggest ways and means for the formation of a separate Karnatak province. During the same session of the Council of State, Sir Sankaran Nair moved a resolution recommending the constitution of a separate province for the Tamil-speaking districts of the Madras province. In 1927, Mr. V. Ramadas Pantulu moved a resolution in the Council of State, recommending that steps be taken to constitute all the Telugu-speaking districts of Madras province into a separate province. All these resolutions were defeated. It could not be otherwise due to the reactionary composition of the Council of State which contained a large element of nominated members.

Nehru Committee and After

In 1928, the question of formation of linguistic provinces was considered by the famous Nehru Committee appointed by the All Parties Conference to consider and determine the principles of a Constitution for India. The Nehru Committee discussed this question at great length in a separate chapter in their Report. They expressed their view in favour of formation of linguistic provinces wherever possible, and pointed out that demands had been made from time to time for the creation of new provinces for Andhra, Orissa, Karnatak, Kerala, Sind and the Hindi-speaking areas of the Central Provinces. The acceptance of the principle of linguistic units by the Nehru Committee marked an important stage in the history of the movement.

During 1928 and 1929 when the Simon Commission was touring India, the advocates of linguistic provinces submitted representations to the Commission pleading for their cause. Weighty representations from Orissa, Andhra, Karnatak and Sind were submitted and deputations waited upon the Commission. The Commission in their Report, which was published in 1930, admitted that there was "a considerable body of opinion in India" which called for readjustment of boundaries and redistribution of areas on linguistic lines and supported the

principle underlying the peoples' damand. After pointing out that "Federation schemes usually start with a number of clearly defined states each already possessed of individuality and consciousness" and observing that no one of the Indian provinces had been "deliberately formed with a view to its suitability as a self-governing unit within a federated whole." the Simon Commission made a "definite recommendation for reviewing, and if possible resettling, the provincial boundaries of India at as early a date as possible," For the purpose of giving effect to this recommendation, the Commission suzzested that the Government of India should set up, as a matter of urgent importance, a Boundaries Commission with a neutral Chairman, to investigate the main cases in which provincial readjustment seemed called for. The Commission gave special consideration to the claims put forward by the Orivas and the Sindhis.

The Government of India, in their Dispatch on the proposals of the Simon Commission, while suggesting that two independent Boundaries Commissions should be set up to examine the cases of Orissa and Sind separately, held the view that "other possible readjustment of provincial boundaries" should be held over "until opinion has more clearly expressed itself". They concluded by saying that "It would be for the new administrations themselves to take up such cases as they arise". Though the Government of India admitted the "other possible readjustment of provincial boundaries", they did not want to adjust these boundaries except in the case of Orissa and Sind. The result was the creation of the two new provinces of Orissa and Sind in 1936. Although the formation of these two provinces marked a very important stage in the history of the movement for linguistic provinces, it was only a partial success in the sense that other groups like the Kannad 22s, Andhras, Tamils, Maharashtrians and the Malayalis had to carry on their agitation unabated.

The movement grew in strength particularly in Andhra and Karnarak. In 1938, the Madras provincial legislature

adopted a resolution recommending the creation of linguistic provinces. A similar resolution about Karnatak was adopted in the Bombay provincial legislature in the same year. The passing of these resolutions clearly indicated that the people concerned were in favour of linguistic provinces. The movement became so strong that the Working Committee of the Indian National Congress felt it necessary to pass the following resolution in 1938.

"Having heard the views of the deputation of the Andhra P. C. C., the Andhra Mahasabha, the Karnatak Unification Cmmittee, the Karnatak P. C. C. and the Kerala P. C. C. on the question of the redistribution of provinces in India on a linguistic basis for administrative purposes, this Committee declares that the resolutions of the Madras legislature on linguistic provinces and of the Bombay legislature on the separation of the Karnatak province, were passed with the previous sanction of the Parliamentary Sub-Committee and the full approval of this Committee. This Committee desires to assure the people of the areas concerned that the solution of this question would be undertaken as a part of the future scheme of the Government of India, as soon as the Congress has the power to do so, and calls upon the people of these areas to desist from any further agitation in this behalf, which may direct the attention from the main issue now before the country".

In pursuance of this resolution calling upon the people to desist from further agitation, which might direct attention from the main issue of winning the political freedom for the country, the movement lay dormant till the end of the war in 1945. With the cessation of the war and with the decision of the Indian National Congress to fight the general elections, the movement for linguistic provinces once again began to agitate the minds of the people. The Congress, therefore, felt it necessary to re-iterate its views on the question by inserting them in the Election Manifesto of 1945 and also that of 1946. Recognising the need for the formation of linguistic provinces, the Election Manifesto stated that the Congress "has stood for full opportunities for the people as a whole to grow and

develop according to their own wishes and genius; it has also stood for the freedom of each group and territorial area within the nation to develop its own life and culture within the larger framework, and for this purpose such territorial areas or provinces should be constituted, as far as possible, on a linguistic and cultural basis".

By this time, the movement assumed a much wider significance than before and spread even to those areas where the demand for linguistic provinces was not hitherto so pronounced. The latest instance in point is the demand of the Marathi-speaking people for a separate province. The formation of the United Maharashtra League in 1946 is meant to achieve this end in view.

India being now free from foreign domination and the Indian National Congress, which stands for linguistic provinces, being in power both at the centre and all the provinces, it is to be expected that the question of linguistic provinces will be satisfactorily solved, and the various units forming the new federation will be homogeneous and unilingual in character.

CHAFTER III

KARNATAK UNIFICATION MOVEMENT Birth of the Movement

Although some references have been incidentally made to the Karnatak unification movement, a brief outline of the movement seems to be necessary as we are here mainly concerned with the problem of Karnatak. This we propose to do in this Chapter. It will be seen from what has been already narrated that the movement in Karnatak was very similar to that started by several other sub-national groups. In fact, the Karnatak unification movement forms only one section of a much wider movement for the creation of linguistic provinces in different parts of the country.

The movement in Karnatak was born out of a natural desire on the part of the Kannada-speaking people to break down the main obstacle that came in their way of cultural development and economic progress. The pioneers of the movement rightly realised that the division of Karnatak under several Governments lay at the root cause of all the troubles of the Kannada people. The educated class, who had absorbed the new spirit and the new outlook generated by the great national movement, clearly saw that only a united Karnatak can play its proper role in the great national task of building a renovated India.

By the end of the last century associations were formed to revive Kannada literature and art and to develop the language. Books in Kannada on modern lines came to be written, old Kannada inscriptions were edited, and Kannada journalism had its successful beginning. As Prof. B. M. Srikantia, the father of Kannada Renaissance, writes: "By the turn of the century and within its first decade, all these forces played on the public and set up a ferment in men's hearts and roused a Kannada patriotism which could hold its own with the neighbouring provinces of Maharashtra, Andhra, Tamilnad and Kerala. The new national spirit, the ideals of social reform and economic progress, the Congress

Organised Efforts

The foundation in 1915 of the Karnataka Sahitya Parishat marks out as the culmination of the early efforts and aspirations of the Kannada people striving for unity. The Parishat was an all-Karnatak body embracing all the Kannada speaking tracts lying in different administrative areas. For 32 years now this academy of Kannada letters has worked for an all-Karnatak vision. Resolutions demanding the creation of a linguistic province of Karnatak have been adopted by this body from time to time.

The growing consciousness in the people took a more pronounced turn in the year 1916 when the Karnatak Sabha was started in Dharwar with the definite object of achieving the goal of a United Karnatak. This association, which was later on renamed as the Karnatak Unification Sabha. has been ceaselessly working for the attainment of its objective since its foundation. The Sabha in its early days held meetings in various places and created public opinion in favour of unification. Mr. Kadapa Raghavandra Rao, one of its founders, visited even the remotest corners of Karnatak with this object. The result was that memorials were sent from different districts to the Secretary of State for India, Mr. Montagu, who was touring India. The memorandum submitted to Mr. Montagu was to the following effect: "We sincerely pray that the provinces in India should be redistributed on the linguistic basis and the Kanarese parts of the Bombay and Madras presidencies together with Coorg should

form a separate administrative unit. We respectfully submit that the present provinces are not the natural divisions of India".

In 1918, the Sabha turned its attention to the Indian National Congress and the delegates from Karnatak submitted a statement whererin they asserted their desire to secure the reorganisation of Congress Circles on linguistic basis. statement added that the Kannada-speaking tracts in the provinces of Bombay and Madras and Coorg should be given a separate circle. As this request was not then granted by the Congress. agitation was started all over Karnatak. As a result of this agitation, as many as 800 delegates from Karnatak mustered strong at the Nagpur session of the Indian National Congress and demanded a separate administrative unit for Karnatak for Congress purposes. The demand received due consideration and the Congress accepted the principle of linguistic provinces and divided the country into 21 linguistic Congress Since then Karnatak, which was a part of the jurisdiction of the Bombay Provincial Congress Committee, has been functioning independently.

It was creditable to the leaders of the movement that they did not stop short with making representations to others, but were all along doing what constructive work they could to march onwards to their destined goal. In 1920, even before the Congress granted a separate circle for Karnatak, they held the first Karnatak Conference at Dharwar under the presidentship of Sir V. P. Madhav Rao. The Conference was attended by representatives from every part of the province. This Conference passed, without a single dissentient voice, the resolution demanding the formation of a separate Karnatak Province.

The year 1921-1924 were the years of non-cooperation and the Karnatak leaders had little time to devote to the unification movement as such. But real and solid work was done during those days in so far as the scattered parts of Karnatak worked as one man and felt and suffered as one man. The efforts of all the Kannadigas for combining

together in national work, inspite of their being divided under numerous administrations, may be said to have culminated in the grand success of the Indian National Congress session held at Belgaum in 1924. In the same year, the first Karnatak Unification Conference was held. Since then the Karnatak Unification Sabha has been organising similar conferences from time to time.

In 1927 due to the efforts of the Sabha, the A. I. C. C. which met in Bombay passed a resolution which said that the "readjustment of provinces be immediately taken in hand and that any province which demands such reconstitution on linguistic basis be dealt with accordingly......The Committee is further of opinion that a beginning may be made by constituting Andhra, Sind and Karnatak into separate provinces."

In 1928, a joint representation by the Karnatak Unification Sabha and the Karnatak Provincial Congress Committee was made to the Committee appointed by the All-Parties Conference held at Delhi. This Committee, which was presided over by the late Pandit Motilal Nehru, is popularly known as the Nehru Committee. Mr. R. R. Diwakar, on behalf of the Sabha and the K. P. C. C., presented the case of Karnatak before this Committee at its meetings held at Allahabad. The Nehru Committee in its Report discussed at some length the case of Karnatak and recommended that a separate province should be created out of the Kannada-speaking areas in the provinces of Bombay and Madras and the small province of Coorg.

Dealing with Karnatak, the Nehru Committee wrote "The case for the Karnataka was placed before us by a representative of the Karnataka Unification Sangh and the Karnataka Provincial Congress Committee. It has been ably prepared with a wealth of information, historical, cultural and statistical. All our questions were answered satisfactorily and in our opinion a strong prima facie case for unification and the formation of Karnataka as a separate province was made", Referring to the financial position, they stated: "Financially

the position of Karnataka was very strong and even at present there was a considerable surplus in the British part of the Karnatak'. The All-Parties Conference, which was held at Lucknow in 1928, endorsed the recommendation of the Nehru Committee relating to Karnatak.

As stated in the last chapter, the case for Karnatak was placed before the Simon Commission when it was touring India in 1928-29. The Commission which accepted the principle of linguistic provinces, made a reference to the Kannada people and recognised that they possessed a distinct culture of their own. The inhabitants of Bombay Karnatak, wrote the Simon Commission, "are racially allied to peoples further south, and particularly to those who speak the same language of Kanarese........ the Kanarese-speaking people have memories of the ancient Hindu Kingdom of Vijayanagar and the Kanarese dynasties which preceded it, and take a jealous pride in their distinctive culture".1

Movement since 1930

Since 1930 the cry for a united Karnatak has become universal all over the Kannada country including the States. The movement has spread even to the remotest corners of the Karnatak territory. The demand for unification is voiced not only in Unification Conferences which are called specially for this purpose, but also in other conferences such as literary, cultural or political. The Karnataka Sahitya Parishat goes up and down the country every year with a missionary zeal to advance the cause of the Kannada movement. "The Annual Conference of the Parishat meets in some big centre, usually near the border where enthuasm has to be roused, the dying flame of Kannada has to be fanned, tract swallowed up or about to be swallowed up has to be reclaimed, and the feeling of a United Karnataka has to be planted never to be rooted out again."

Numerous Kannada Sanghas which have sprung up in various parts of the country are daily spreading the gospel of unification and are holding before the people the vision of a Festivities like Naduhabba (national united Karnatak. festival of Dasara), anniversaries and other functions are affording further opportunities to voice the feeling of the people for a united existence. Almost every journal in Karnatak stands for unification. In fact, the movement has become so strong and universal that Mahatma Gandhi admitted ten years ago that "the creation of Karnatak as a separate province cannot be resisted". As recently as January 1946 Sardar Vallabhbhai Patel had to give an assurance to the Kannada people saying that they "will not have to wait long to see a United Karnatak rising out of the scattered Kannada speaking areas with a provincial government, a University and a proud provincial life of its own". He concluded by saying that one of the first acts of free India will be to remove the handicaps of disintegration which the British have imposed upon linguistic areas in this country".

In August 1946, the Karnataka Unification Sabha and the Karnatak Provincial Congress Committee jointly called an All-Karnatak Convention at Davanagere in! Mysore State The Convention was inaugurated by Mr. K. R. Karanth, the then Revenue Minister in the Government of Madras, and was presided over by Mr. M. P. Patil, Minister of Forests and Agriculture in the Government of Bombay. The Convention, which was fully representative of the Kannada people as a whole, was attended by the Karnatak members of the provincial legislatures of Bombay, Madras, Coorg, Mysore and smaller states; by office-bearers of states peoples' organisations; representatives of literary and cultural and local self-government institutions; and by representatives of various political parties and communities. The Convention adopted, with one voice, a resolution urging the Indian Constituent Assembly to take up the important question of the formation of provinces on linguistic basis and to take immediate steps to constitute Karnatak into a separate province.

In April 1947, a resolution moved in the Bombay Legislative Assembly by Mr. A. J. Doddameti, recommending the immediate formation of Karnatak into a separate province, was adopted. A similar resolution was also accepted by the Madras Legislative Assembly about the same time.

CHAPTER IV

PLIGHT OF THE KANNADA PEOPLE

Inroads on the Language

The Kannada country had been cut into as many as 19 fragments till March 1948 when the merger of the Deccan states took place. Even excluding States, Karantak has been divided into three administrative units, namely, Bombay, Madras and Coorg. The districts of Bijapur, Belgaum, Dharwar and North Kanara with portions of Sholapur and Satara districts form the tail-end of the Bombay province. Similarly, the district of Bellary with the adjoining Kannada tract in Anantpur forms the north-west tail-end of Madras province, while the districts of South Kanara and Nilgiris with the adjoining Kannada portions of Coimbatore and Selam and the Wainad taluka in Malabar from another tail end of the same province. Thus, the two Kannada-speaking areas in the province of Madras are not only non-contiguous but are separated from each other, as the Mysore state intervenes between the two. In other words, there exists separation within separation. Again, Coord with a separate administration, is struggling hard with the semblance of a provincial government. The Mysore State and the districts of Raichur, Gulburga and parts of Bidar in Hyderabad State form most of the Kannada territory lying within the States. The States of Kolhapur and Sandur account for the remaining portions of Karnatak. While Sandur is wholly Kannada, Kolhapur is partly Kannada and partly Marathi in its composition. This dismemberment of the Kannada country has resulted into great hardahips and gross injustice to the Kannada people in every field of human activity.

When people speaking a different language are in a small minority in an administrative unit such as a district, division or even a province, they are likely to lose in course of time their mother tougue unless special efforts are made to prevent this process. A typical example of this is cited by the Orissa Committe which was appointed by the Government of India in 1931. Referring to the district of

Midnapur in Bengal, the Committee stated that "it is inevitable that the schools and the law courts and long association with Bengal should affect the speech of the Oriya element and that the mixed dialect described be Dr. Grierson should become progressively Bengalised. Bengali is now not only the dominent language of the district as a whole; in all areas the language of the majority is either Bengali or a dialect which is or is rapidly becoming more Bengali than Oriya".

As a result of a similar process that has been going on in the border regions of Karnatak, Kannada is losing ground to the neighbouring languages which have acquired a dominant position. In the northern border regions of Karnatak, particularly in Satara and Sholapur districts and in Kolhapur and Sangli States, Kannada has been replaced by Marathi to a very considerable extent. This was long ago noticed by Dr. Eleet who wrote as follows in 1882: "In the present day, the people and the language of the British districts are Kanarese; and the Kanarese people and language have been displaced to a certain extent, by the Marathi people and language in the Native States, only because those States were established by the agressions of Marathas from the north, whose local influence proved to be greater than that of the native rulers whom they dispossessed."

The position on the southern frontier of Karnatak, where it meets Tamil, is equally distressing. The Salem District Gazetteer, referring to Hosur Taluk, admits this fact when it says that the "British occupation, in the course of the century, has had the effect of advancing the Tamil at the expense of the Kanarese." Speaking about Dharmapuri Taluk, the Gazetteer records: "Donnakuttahalli itself is a settlement of Vakkaligas, an interesting remnant of a Kanarese population which, if place-names have any significance, appears at one time to have permeated the whole of Dharmapuri Taluk and southern Uttankarai as well." The Kannada tracts in Coimbatore district have suffered in the same way as those in

Salem. The Taluk of Kollegal, which is a wholly compact Kannada area in Coimbatore district, has been even now admirably holding its own and is even recognised officially as a Kannada tract in the midst of overpowering Tamil influence on three sides out of four. The proximity of the Kannada state of Mysore on its west has been its only saving grace. But the worst sufferer is the district of the Nilgiris where Tamil has made serious inroads on Kannada and its dialect Badaga. What is true of the northern and southern borders of Karnatak is equally true of its eastern border where the Kannada-speaking tracts, isolated as they remain, are losing around to Telugu.

Administrative Inefficiency

Kannada being a small minority language in the provinces of both Madras and Bombay and consequently most of the high officials being non-Kannadigas, Kannada people are at a great disadvantage in the matter of administration. As it is not possible for a provincial government to give adequate importance to a language which is spoken by a small minority of its population, the efficiency of the administration is bound to suffer; and the people speaking the minority language are the worst sufferers. Attention was drawn to this unsatisfactory position as early as 1903 by no less a person than Mr. H. H. Risley, the Secretary to the Government of India in the Home Department. Referring to the Presidency of Madras, he wrote: "The Goveanment of Madras have repeatedly complained of the anxieties inposed upon their administration, of the great diversity of languages Oriya, Tamil, Telugu, Malayalam, and Canarese with which Madras civilians are called upon to cope and which render the transfer of officers from one part of the presidency to another a matter in any case of great difficulty and often of positive detriment to the public interest. These disadvantages exercise an injurious effect not only upon the administration, but still more upon the people. Where the population speaking a distinct language and the area over which it is spoken are too small to constitute a substantial portion of a province, the foreign unit is of necessity neglected. Under ordinary circumstances, the Government is unable to

retain in it a superior staff who have become acquainted with the language, and with the local customs which invariably accompany it. It is often impossible to officer the subordinate staff from local sources, and foreigners have to be brought in who are ignorant alike of the people, their language, and their ways. The Government may order that the vernacular shall be the language of the Government offices and courts, but since officers nor clerks know this vernacular properly, compliance with the order is often impracticable and almost always incomplete Hence in dealing with a question of this kind, it may be that the true criterion of territorial redistribution should be sought not in race but in language".

Denial of Self-Government

The Kannada people have been unequally yoked with the Maharashtrians and Gujaratis in Bombay, and with the Telugus and Tamilians in Madras. In Bombay province they are less than 20 per cent of the total population, while in Madras they from only obout six per cent. Consequently, in the legislatures of both these provinces they find themselves in a small minority. In the Bombay Legislative Assembly consisting of 175 members, representatives from the Karnatak number 28: while in the Madras Legislative Assembly they are only twelve in a house of 215. As matters now stand, the Kannada people can never exercise in either province that influence to which they rightly consider themselves entitled to by reason of their distinct culture, glorious traditions and economic importance. This grievance will be all the more keenly felt hereafter when a more democratic form of government based on adult franchise and fully responsible to the people comes into existence. Unless Karnatak is constituted into a separate province, self. Government for the Kannadigas will be difficult of realisation.

Confining ourself to areas outside the Indian States, we find that no other people in India are placed in such a bad plight as the Kannadigas. The Maharashtrians, though

divided under two administrations, do not form a small minority in either of the privinces. On the contrary, they constitute a majority in Bombay province, while in the C. P. and Berar they are nearly forty per cent of the total population. The Andhras are not at all divided and form nearly one-half of the total population in Madras province. The Tamilians are in a very similar position. The Gujaratis and the Malayalees, though they form a minority in the retpective provinces of Bombay and Madras, are not divided under differ. ent administrations. These comparisons clearly show that the Kannadigas are the worst sufferers under the existing arrange. ment of territorial distribution. Another significant fact to be noted regarding Kannadigas, which makes their position still worse, is that those among them who are in Bombay province are grouped with people speaking Indo-Aryan languages which are basically different from Kannada which is a Dravidian tongue. This is an additional disadvantage.

A Neglected People

As the Kannada districts form the tail-ends of the provinces of Bombay and Madras, they are neglected in almost every respect. In the first place, they are inconveniently situated at great distances from the respective provincial headquarters. Thus the distance between Bombay and the district headquarter towns of Bajapur, Belgaum, Dharwar and Karwar is 350 miles, 359 miles, 440 miles and 555 miles respectively. Similarly, the distance between Madras and the district headquarter towns of Bellary, Ootacamund and Mangalore is 306, 355 and 551 miles raspectively. There are no proper transport or communication facilities between various parts of Karnatak itself. Thus, for instance, the distance by rail between Mangalore and Bellary is 814 miles. although both these towns are in the same province of Madras This is due to the absence of a direct railway line between these towns through the intervening Mysore State which forms a part of the Kannada country itself. A direct line would have shortened the distance by more than 500 miles. The existing railway route between Mangalore and Bellary takes a round of nearly three-fourths of the Mysore State

frontier through the Tamilnad and Andhra Desha. A more absurd situation than this cannot be imagined. A glance at the railway map would show that the various parts of Karnatak, lying as they are in different administrative units, are left unconnected with one another although linking them up would not involve great distances.

Even inter-district transport and communication facilities within the boundaries of the same province are greatly lacking. As the Bombay Economic and Industrial Survey Committee observes: "While Gujarat and the Deccan are more or less well served with railways, Karnatak is not equally fortunate." Referring to North Kanara, the Committee says: "The injurious effects of inadequate transport facilities can find no better illustration than the district of North Kanara, which inspite of resources of raw materials and of power, remains a backward area with a declining population." Similarly, the the district of South Kanara and Coorg are notoriously lacking in proper transport facilities.

The development of natural resources of Karnatak and the growth of its industry are all checked by the existing order of things. To cite only one instance, there are only three textile mills in the whole of Bombay Karnatak inspite of the fact that the Kannada districts grow as much as one-third of the total quantity of cotton in Bombay province. The situation becomes clearer when it is remembered that there are more than 200 textile mills in the Bombay province; and the injustic to Karnatak becomes more glaring when it can be pointed out that Karnatak grows some of the best types of cotton in the whole of India.

The Karnatak districts in Bombay province are also neglected in the matter of irrigation. Not a single canal irrigation work has been undertaken by Government for the benefit of Bijapur district, inspite of the fact that four big rivers, namely, the Bhima, the Krishna, the Ghataprabha and the Malaprabha, flow through the district. Considerable portions of the non-Kannada districts of Sholapur and Ahmednagar, which are liable to famine like Bajapur, have been brought under canal

irrigation, while Bijapur has been neglected all along. That Karnatak has been neglected in respect of irrigation was admitted by the Irrigation Inquiry Committee appointed by the Government of Bombay in 1939. Referring to Karnatak, the Committee wrote; "Cultivators in this Division also consider themselves to have been neglected in regard to irrigation projects although the physical features of the tract are more favourable for irrigation schemes than those in the North Division" (Gujerath).

The Karnatak districts are also neglected in the matter of education. In the words of the Bombay Economic and Industrial Survey Committee, "the Southern Division of the Province is the poorest in the matter of schools imparting vocational training". The position is equally unsatisfactory with regard to professional colleges or institutions. Figures of literacy also indicate the backwardness of the Kannada districts. In the field of social services provided by the State, Karnatak does not receive its proper share. For instance, the provision for medical facilities, sanitation and drainage is very inadequate in Karnatak in comparison with other parts of the Bombay province.

We need not stretch the point further by citing more instances to show how the Kannada people have suffered by the division of their country. What has been stated above is sufficient to indicate that the Kannadigas are labouring under a real sense of injustice. In addition to economic and social disadvantages, the Kannada people stand the greatest danger of losing their very individuality as a sub-national group. The formation of Karnatak into a separate province alone will avert this calamity and afford them fullest opportunities for growth and self-expression.

CHAPTER V

THE PROPOSED PROVINCE OF KARNATAK Karnatak Country and the Proposed Province

Before we indicate the exact boundaries, the extent and population of the proposed province of Karnatak, it is necessary to give an idea of the Kannada country as a whole including those tracts which lie within the States. A glance at the map of India would show that the land of Karnatak, where Kannada with its dialects is the predominant language, covers the western half of the central portion of the Peningular India. Its greatest length north to south is about 480 miles and that from east to west is about 250 miles. It covers an area of about 75,000 square miles. The northern boundary runs through the Marathi-speaking district of Satara and through Sholapur city in Bombay province and through the Bidar and Osmanabad districts in the Nizam's dominions. A little curved line starting from Bidar district and running southwards almost in a straight line, then crossing the Madras territory on the east of Bellary and running along the eastern border of Mysore State almost upto the Kaveri river, forms the eastern boundary The southern boundary runs through the districts of Salem and Coimbatore along the mountain range which eventually merges in the Nilgiris. The western boundary is the Arabian Sea, the Karnatak sea-coast extending from Goa in the north to Malabar in the south for a distance of about 200 miles.

The Kannada territory lying within the boundaries described above is politically divided into the provinces of Bombay, Madras and Coorg; and till recently, when the merger of the Decean States took place, it was divided into as many as 16 States including Mysore and Hyderabad. In Bombay province, it includes the districts of Bijapur, Belgaum, Dharwar and North Kanara, with a small portion of Sholapur and a few villages of Satara. In Madras, it comprises the districts of Bellary, South Kanara and the Nilgiris, with considerable portions of Salem, Coimbatore and Anantpur and portions of Wainad area in Malabar. The Mysore State and the districts

of Raichur, Gulburga and parts of Bidar in Hyderabad form most of the Kannada territory lying with the States. The States of Kolhapur and Sandur account for the remaining portions of Karnatak. While Kolhapur is partly Kannada and partly Marathi in the composition of its population, Sandur is wholly Kannada.

The total population of the Kannada country is about 177 lakhs which is distributed as follows:—(1) The areas in the provinces of Bombay (including the recently merged Deccan States), Madras and Coorg contain about 75 lakhs; (2) the Mysore State has a population of about 73 lakhs; (3) the Hyderabad Karnatak accounts for nearly 26 lakhs; and (4) the States of Kolhapur and Sandur together make up the balance of 3 lakhs. It is significant that over 50 per cent of the total population of Karnatak belongs to the States.

Linguistically, the Kannada country is bounded on the north by Marathi, on the north-west by Konkani (Goa), on the east by Telugu and on the south by Tamil and Malayalam. Thus except in the north and the north-west it is surrounded by people speaking one or the other of the Dravidian languages to which group Kannada also belongs. The dialects of Kannada are Tulu which is spoken in South Kanara, Kodagu which is prevalent in Coorg, and Badaga which prevails in the Nilziris.

Karnatak divides itself into three natural regions each of which has well-marked and distinct features. Starting from west to east, first comes the west coast region, then comes the central forest belt and finally the eastern plateau which by far forms the greater portion of the Kannada country. The coastal region is known as 'Karāvali', the central forest belt as 'Malnād' and the eastern plateau as 'Bailuseeme' or 'Maidān'.

The west coast region is the narrow strip between the crests of the Western Ghats and the Arabian Sea. This strip is very narrow, particularly in North Kanara district. The region is indented by numerous creeks and bays formed by the estuaries of rivers. The flat alluvial land forms the most important part of the west coast region. The banks of the

lagoons are often lined with coconut plantations. Here also lie the numerous villages, and every possible piece of land is sown with paddy, interrupted at intervals by groves of coconuts and areca nuts. Rice is the staple food of the people in this region which is densely populated.

The central forest region is confined to the tracts bordering or resting on the Western Ghats. "It is a land of magnificent hill and forest, presenting alterations of the most diversified and charming scenery. A fertile soil and perennial streams clothe the valleys with verdant cultivation. The shelterd hillsides are beautiful with waving woods which give shade to numerous plantations of coffee," The rainfall is heavy often exceeding 150 inches. In addition to rich coffee plantations, betel-nuts, pepper and cardamons are the main money crops. Rice which forms the staple food of the people is the principal cereal grown. The region is very rich in forest wealth, the most valuable timber being teak. The tract is very sparsely populated.

The estern plateau region, which contains alluvial black soil, as in the north, grows cotton, wheat, jowar and oil-seeds. In the south, the black soil is replaced by red soil where ragi is grown instead of jowar and wheat. In the south and west of this region, paddy and sugarcane also form important crops. Numerous tanks, varying in size and forming small ponds to extensive lakes, are found dispersed throughout this region. In some parts the lands under tanks are planted with coconut and areca palms.

There are two water-sheds in Karnatak, namely, the Western Ghats and the hills of Nandidroog in Mysore. All the big rivers which rise from the Western Ghats find their way to the Bay of Bengal. They are the Krishna, the Kaveri, the Bhima, and the Tungabhadra. The Krishna which rises near Mahabaleshwar enters Karnatak near Sangli. It is the biggest river in the Karnatak. It receives during its course the Malaprabha, the Ghataprabha and the Bhima and finally the Tungabhadra. Three other rivers, namely, the North Pennar, the South Pennar and Palar rise in the high grounds near

Nandidroog. All of them enter the Bay of Bengal. The Kaveri, which rises in Coorg, flows south-east across Mysore. A large number of comparatively small rivers, which flow into the Arabian sea, rise in the Western Ghats. The more important, of these are the Kali, the Gangavali, the Aghanashini and the Sheravati in North Kanara; and the Gangoli, the Suvarnanadi, the Netravati and the Chandragiri in South Kanara.

Proposed Province and the States

How the formation of the proposed province of Karnatak will help the solution of the States problem, may be indicated here. It is no doubt true that the ultimate aim of the unification movement, as expressed in the Davanagere Resolution, is to unify all the parts of Karnatak, including those in States, into one administrative unit. But the immediate objective of the movement is the formation of a Karnatak province comprising only those tracts which are outside the States. This point should be particularly noted in order to avoid confusion. The formation of a Karnatak province on the proposed lines will greatly facilitate the solution of the States problem as well. In fact, it constitutes the first concrete step in the attainment of the final objective of an All-Karnatak province.

A regards Mysore, it is suggested that, with the recent establishment of full responsible government in Mysore, a scheme may be drawn up immediately under which the Mysore State and the Karnatak province to be newly formed may be enabled to merge themselves into one another and thus together constitute a greater administrative unit. The formation of a Karnatak province will bring the possibility of such a merger within the range of practical politics.

The problem of Nizam Karnatak is, however, complicated. This is mainly due to the fact that the Hyderabad State is in a position to continue its existence as an independent unit in the Indian Federation. The problem will be further complicated if the Nizam finally decides not to join the Indian Union. In fact, the problem of Hyderabad, which consists of

three linguistic areas of Telugu, Marathi and Kannada, is an all-India issue. Not much useful purpose will, therefore, be served by discussing it here on a provincial plane.

Size of the Proposed Province

Having shown how the movement for the unification of Karnatak originated and developed during the last 30 years, how the Kannada people have suffered due to the dismemberment of their province, and how the creation of the new province will help the solution of the Karnatak problem, including that of the States, we now propose to acquaint the reader with the size and population of the proposed province and also other vital matters pertaining to it.

The proposed province of Karnatak will contain the following seven districts, the small province of Coorg and also the Kannada-speaking areas of the recently merged Deccan States:

The first four districts are from Bombay province and the next three are from Madras.

It may be necessary from the linguistic point of view to have a few adjustments made in the boundaries of some of the districts. Starting from the north, the Bijapur district will have to be extended by the inclusion of the South Sholapur Taluka and some villages in North Sholapur and Songola talukas, while the Belgaum district will gain a few villages from the Tasgaon Taluka of Satara district. Again, the remaining areas of the recently merged Deccan States will have to be incorporated in the adjoining disticts, after carving out a new district out of the most of the areas merged. In the case of Bellary, if that district at all loses to the Andhras a few eastern villages of Adoni. Alur and Rayadurg talukas, this loss will be more than compensated for by the inclusion of the Madakasira taluka and the western portions of Kalyandurg and Hindupur talukas from the Anantpur district. The district of the Nilgiris will be more than twice its present size and population by the inclusion of the adjoining Kannada-speaking tracts. including Kollegal and Hosur talukas from the Coimbatore and Salem districts, and also the Wainad area which are contiguous to the Nilgiris. By these adjustments the proposed province may slightly gain both in area and population. We shall deal with this question at some length in the next chapter when considering the details of each of the districts. It is sufficient to note here that the total population of the proposed province will be in the neighbourhood of 75 lakhs if not a little more. and the area will be more than 33,000 square miles. We have not attempted to draw up exact boundaries in this report. This matter will have to be finally considered by the Bound. aries Commission that will have to be set up.

Thus the Karnatak province will be a little bigger, both in size and population, than Mysore State which has an area of 29,458 square miles with a population of 73 lakhs. The Karnatak province will have more population than either Sind or N. W. F. Province. The population of Sind is 45 lakhs, while that of N. W. F. Province is only 30 lakhs. Assam, after the recent adjustment of its boundaries, has a population which is less than that of the proposed Karnatak province, In area, Karnatak is about the size of Orissa and is more than double the size of the N. W. F. Province.

A comparison with some countries in Asia may be found more interesting and instructive. The Karnatak province will be much larger, both in area and population, in comparison with Ceylon. It will be more extensive in area and more than treble in population when compared to the Federated Malay States. Again, its population will be more than double that of Syria, and will exceed that of Nepal by nearly 20 lakhs.

A few comparisons with European countries may also be useful. Karnatak province will be almost the size of Portugal both in area and population, and will be equal to Greece in population. Denmark is about half the size of the proposed Karnatak province both in area and population. The population of the Irish Free State is less than half of that of Karnatak province, while in area also Karnatak is much bigger. Norway is in the same position as Ireland in so far as population is concerned. Sweden and Finland have each much less population than the Karnatak province. These comparisons would show that the proposed province will not be inadequately small either in area or population.

The Karnatak province will also form a compact area. All the districts which are proposed to be included in it are contiguous to one another. The proposed province will be much more compact than the Bombay province. It may be noted that the territory comprising the Gujrat districts, except the southern and eastern parts of Surat, are not contiguous to the rest of the Bombay province. Again, the talukas of Jhalod and Dohad in Panch Mahals, the taluka of Jamkhed in Ahmednagar and the taluka of Barsi in Sholapur are separated from the Bombay province by the intervening States territories. Similarly, the Sambalpur district and the Angul tract in Orissa are not contiguous to the rest of the province. In West Bengal, the districts of Darjeeling and Jalpaiguri are similarly separated from the rest of the province. These comparisons, along with a glance at the map of India, would show that the proposed province of Karnatak will be much more compact than some of the existing provinces.

As shown in the table, the Karnatak province will have 6,762 villages and 64 towns, excluding those from the recently merged States. It is remarkable that, inspite of poor transport facilities and other drawbacks, the proportion of urban to the total population is comparatively high in the districts of the proposed province. Thus, this proportion is 32 per cent in the Nilgiris, 25.5, per cent in Dharwar, 17.2, per cent in Bellary, 16.5 per cent in North Kanara, 12.6 per cent in Bijapur, 11, 8, per cent in Belgaum, 9.1 per cent is South Kanara and 6, 2 per cent in Coorg. The proportion for the whole of India is 11.5 per cent. Thus, as many as six districts exceed the all-India average. In fact, figures show that the Karnatak province is more urbanised than Assam-Orissa, Bengal, the N. W. F. Province, C. P. and Berar, and Bihar. Although urbanisation is not to be confused with industrialisation, it generally indicates the economic position of the region concerned. A proper balance between town and country facilitates the growth of industry and economic progress. Considered from this point of view, the position of the proposed province is quite satisfactory.

CHAPTER VI

DISTRICTS OF THE PROPOSED PROVINCE The Plateau Districts

The four districts of Bijapur, Belgaum, Dharwar and Bellary lie in the plateau region which by far forms the greater portion of the proposed province.

Bijapur District: This district, which will cover the northeastern portion of the province, will be the largest district in area. The taluka of South Sholapur, which is predominantly Kannada and which is contiguous, should be added to this district. A Settlement Report written as recently as 1943 admits the fact that the language of this taluaka is Kannada. The southern portions of the talukas of North Sholapur and Singola, where Kannada is spoken, will have also to be added to the Bijapur district,

No other district in the Bombay province has as large an area under crops as Bijapur. The main products are jowar. bajri and wheat, while the principal money crops are cotton, ground nuts and other oil seeds. The acreage under jowar. bajri and wheat is about 13.25,000 acres, 5.75,000 acres and 2,00,000 acres respectively. In point of acreage under jowar. Bijapur stands first, while its acreage under wheat is the third largest in the Bombay province. It stands second in the Bombay province in point of acreage both under cotton and oil seeds, the area under these crops being about 3,60,000 acres and 2,30,000 acres respectively. Handloom industry is extensively carried on, the district having as many as 18,000 looms, a figure which is not exceeded by any other district in the Bombay province. If the resources of this district are developed and large-scale irrigation works are carried out, Bijapur dist. rict will be a great asset to the new province.

Belgaum District: This district will form the northwestern part of the proposed province. The few Kannadaspeaking villages in Tasgaon taluka of the Sarara district should be added to Belgaum. These villages are predominantly Kannada. The Linguistic Survey of India by Dr. Grierson admits this fact.

The district has a large cultivated area of about 20 lakhs of acres. The principal food crops are jowar, wheat, rice and ragi. Pulses are also largely grown. The important commercial crops are cotton, tobacco and groundnuts. The area under tobacco is about 57,000 acres. More than one-third of the total area under tobacco cultivation in the Bombay province is in this one district. To quote from an official report, Nipani in Belgaum district "is one of the most important tobacco markets in India". The district contains some very good grazing grounds. Handloom weaving is an important industry, the total number of looms in the district being 7,500.

Dharwar District: This district will cover the central portion of the proposed province. This is a very important district in various respects. It will be the most urbanised district of the Karnatak province. The main foodcrops are jowar. wheat, rice and pulses and the principal commercial crops are cotton, chillies and groundnuts. Its area under wheat, which is about 2 lakhs acres, is the second largest in Bombay province, while its acreage under cotton amounting to nearly 5,65,000 acres exceeds that of any other district in Bombay. The district is famous for its superior quality cotton. As the Imperial Gazetteer says, it "stands first in the Presidency for its cotton, which is highly esteemed." The area under chillies is about 75,000 acres. Nearly half of the total area in Bombay province under chillies is to be found in this one district. The district is remarkable for its irrigation tanks and wells. These tanks are about 3,000 in number, nearly two-thirds of which are in the south-west portion of the district. These ancient tanks irrigate a total area of nearly a lakh of acres. Handloom weaving is the most important cottage industry in the district. In the number of looms the district stands second in Bombay province. There are as many as 16,500 looms in the district.

Bellary District: This will cover the eastern portion of the central part of Karnatak. The claim of the Andhras that the eastern talukas of Adoni, Alur and Rayadurg are Telugu cannot be maintained. If it is found on complete and impartial enquiry that some eastern villages in these talukas are predominantly Telugu, they may be left out. However, this matter will have to be considered by the Boundaries Commission.

The western villages of Kalyandurg and Hindupur talukas and the whole of Madakasira in Anantapur district will have to be added to the Bellary district, as the language of this tract is Kannada. This fact is admitted by various official publications such as the Gazetteers and Census Reports

Geographically also, the talukas of Madakasira and Hindupur form parts of the Mysore plateau. 'As the District Gazetteer says: "Both these talukas are a part of the Mysore plateau and share its higher elevation and cooler climate"*. We may add by saying that linguistically also most of this tract forms a part of the Kannada country which includes the Mysore plateau. It may be incidentally mentioned that the inclusion of Madakasira taluka in the Bellary district will be a great gain to Karnatak, as this taluka is the most favoured by nature in the whole of Anantapur district. To quote from the District Gazetteer, "the taluka is more favoured by nature than the rest of the district, lying at a higher elevation, receiving an ampler rainfall, possessing thicker vegetation. having a soil of superior fertility, containing a wider irrigated area, being less sparsely populated, and maintaining a higher rate of increase in its population than its northern neighbours. It has been called "the garden of the district." According to 1941 census, the population of this taluka is 1.07, 166 and the area is 446 square miles.

In Bellary district, jowar is the most important foodcrop which occupies more than seven lakhs of acres. In fact, no other district in Madras province has such a large area under this crop. The millet "korra" comes next, occupying an area of more

than five lakhs of acres. Again, no other district in Madras contains such a large area under this millet. It may also be noted that Ballary stands first in Madras province in having the largest area under cereals. Sugarcane is an important money crop, occupying more than 10,000 acres. But the most important commercial crop is cotton. In cotton acreage, Bellary again stands first in Madras province, the total area under this crop being more than five lakhs.

Coastal Districts

North Kanara, which is in Bombay province and South Kanara which is in Madras province, together form the coastal region of Karnatak. This coast is popularly known as the Kanara coast.

North Kanara District: This is a remarkable district in many respecs. It contains the famous spice gardens yielding betel-nuts, pepper and cardamons. In fact, North Kanara holds a monopoly of these crops in so far as Bombay province is concerned. Its forest wealth is richer both in quantity. quality and variety than that of ony other district in Bomby province. In fact, it is essentially a forest district, more than two million acres being under forests. The most important forest produce is timber. Teak and sisum are the common varieties of wood from which timber is prepared. A press note issued by the Bombay Government in 1942 says that "Kanara teak is superior to all other teak in India". Soft woods suitable for manufacturing matches, plywood etc., are also available. Bamboos can be had in large quantities. According to the figures given in the Tariff Board Report on paper and paper-pulp industries. North Kanara is the richest district in bamboo production in the whole of India. As an official report says, "Of all the districts in this Province (Bombay), Kanara is extraordinarily rich in all kinds of forest produce."

The district is also rich in marine fisheries. North Kanara contributes about 16 per cent of the total annual catch of fish

in Bombay province. The district has immense possibilities for producing hydro-electric power on a large scale. A preliminary survey recently made by the Bombay Government shows that nearly 700,000 Kw. of power can be produced from the Kali river. This is only one of the several schemes that may be undertaken. The district possesses the fine natural harbours of Karwar and Bhatkal. If properly developed, North Kanara would be a great asset to the new province.

South Kanara District: This district is similar to North Kanara in many respects. Its forest wealth is very considerable, the total area under reserved forests being more than half a million scres. The gardens of areca, pepper and cardamons are to be found mostly in Puttur taluk. The district has a large area under nuts and fruits. South Kanara produces more cashew nuts than any other district in the whole of India. Its annual production is estimated at 2.50,000 maunds which is equal to about 40 per cent of the total production in Madras province. The district has nearly 50,000 acres under coconut cultivation. This area is exceeded only by two other districts in Madras province, namely. Malabar and East Godavari. It may also be noted that South Kanara has 45,000 acres undes mangoes. No other district in Madras has such a large acreage, the next district in importance being East Godavari with 3L000 acres. Sugarcane is also an important money crop occupying more than 6.000 acres.

South Kanara is rich in marine fisheries and annually produces about nine per cent of the total production of seafish in India. The district is famous for its tiles known as Mangalore tiles. Handloom weaving is also an important industry. Development of hydro-electric power, for which there are considerable possibilities, will greatly help the industrialisation of the district.

Coorg and the Nilgiris.

While Coorg, which is situated on the eastern slopes of the Western Ghats, is essentially a malnad region, the Nilgiris is a class by itself.

Coorg is rich in agricultural and forest wealth. It is one of the important coffee producing regions in India. Nearly 25 per cent of the total acreage under coffee in India is in Coorg. It may be mentioned here that about 95 per cent of the total coffee in India is grown in the Kannada country, these coffee regions being distributed over the Mysore State, the Nilgiris and Coorg.

Coorg growns more rice than it can consume. The land being fertile, the average production per acre is high. To quote from an official report: "It will be observed that the reported average yield per acre is much greater in Coorg than in any other part of India". Oranges form an important money crop of Coorg. About 10,000 acres are under this crop. Thus Coorg has about 8 per cent of the total area under oranges in India. Pepper and cardamons are also important commercial crops. The forest wealth of Coorg is very considerable. Hydro-electric power could be produced on a large scale and utilised for the development of industries allied to forestry and agriculture.

The Nilgiris: This beautiful district, which is situated at an elevation of about 6.500 feet, will be the most southerly district of the Karnatak province. The area of this district can be greatly extended by the inclusion of the Kannada speaking tracts of Coimbatore and Salem districts and also the Wainad area in Malalar. Thus, the taluka of Kollegal and portions of Gopichettipalayam, Avanashi and Bhavani in Coimbatore, the taluka of Hosur and portions of Dharmapuri and Krishnagiri in Salem will have to be added to the Nilgiris district. The whole of this tract is contiguous. Geographically also, this tract including Wainad forms a part of Karnatak. It is, in fact, a continuation of the Mysore plateau. The following observations from the Salem District Gazetteer will be found interesting: "Tamil is understood throughout the District," says the Gazetteer, "except in certain parts of the Balaghat where Kanarese predominates".* The Gazetteer further says that nine-tenths of the Dharmapuri records and three-fourths of the accounts in Hosur taluka are in Kannada.t

Although it is not possible to give here the exact population and area of this tract, it may be said that the area of the tract will be more than 2,000 square miles, while the population will be more than five lakhs. The Kollegal taluk has a population of 1, 18,000 and extends over 1,000 square miles. The Hosur taluk, which has an area of 1,180 square miles, supports a population of 2,24,000. With the addition of this tract, the Nilgiris district will have a decent size and population and also many economic advantages. Kollegal and Hosur, which together monopolise the sericulture industry of the Madras province, will considerably add to the economic wealth of the new province. The extent of land under mulberry cultivation in this tract is about 15,000 acres.

The main commercial crops of the Nilgiris are tea, coffee hand cinchona. The Nilgiris "is the home of some of the k best types of coffee in the world" as pointed out in an official a report. The potato crop is equally important. Out of 15,000

acres under potatoes in Madras province, the Nilgiris alone account for as much as 14,000 acres. The Nilgiris produce the best type of potatoes, both for seed and consumption purposes, in the whole of India. The manufacture of eucalyptus oil is carried on extensively in the Nilgiris. As the demand for eucalyptus oil is great, there are possibilities of developing this industry on monern lines.

CHAPTER VII

INDUSTRIAL POSSIBILITIES OF KARNATAK

Government and Industry

The Karnatak districts are industrially backward as compared to many other parts of India. This backwardness is not, however, due to the absence of adequate economic resources as we shall presently see. The Mysore State, which is more or less similarly situated as the rest of Karnatak in economic resources, has already made very considerable progress industrially. The main reason why this happened in the case of Mysore lies in the fact that Mysore had a separate administration properly to look after its interest in the industrial field. In the case of other parts of Karnatak this was not so. As the Kannada districts outside Mysore were divided into different provinces and formed their neglected tail-ends, the region remained backward.

As there are few capitalists in Karnatak, the industrial development of the region on an adequate scale may not be possible unless the administration itself, following in the footsteps of the Mysore Government, starts industries with its own capital at least in the earlier stages. In Mysore, some of the ndustries are entirely Government-owned; in some the Government own shares: and to others Government have afforded ctive assistance. Nearly twenty crores of rupees have been invested by the Mysore Government on various industries and hey annually yield a substantial revenue which accrues to the hencht of the general tax-payer. Again, the pioneer work in helds of industrial enterprise and the risk involved in it may por induce private capitalists to undertake such ventures a such cases, the Government themselves should start the new tidustry with their own capital. This is what the Government Mysore does. Among the industrial plants owned by the novernment of Mysore, in addition to the hydro-electric porks, are the Bhadravati Iron and Steel works, a silk weaving sectory, a sandalwood oil factory, a cement plant, an implements

factory, porcelain factory, a lac and paints works, a soap factory, a chromite factory and a paper manufacturing plant. A similar industrial policy will have to be followed in the case of Karnatak also. In order to make this possible, the Kannada people should have their own provincial administration run by themselves.

Agriculture and Industry

Having shown how the formation of the new province is extremely desirable for the industrial progress of Karnatak, let us proceed to examine in brief the economic resources of the region. In the absence of a complete geological survey and of full enquiries and investigations in various fields, it is not possible to have a complete picture of our natural resources. Even then, the information that is already available tends to show that the resources of Karnatak are rich and varied,

We may take up agriculture first. Industry and agriculture are inter-dependent. Besides supplying the industrial population with food, agriculture can feed industry by providing such industrial crops as cotton, oil-seeds, tobacco and sugarcane. Karnatak province will be self-sufficient in food. The total area under cereals, including millets, is about 7 million acres, with an estimated annual yield of over 12,50,000 tons of grain. This gives an average of 430 pounds of cereals per adult per year, after making provision for seed. This average is higher than the all-India average which works out at less than 361 pounds per adult per year. The position with regard to pulses is equally satisfactory. The total area under pulses is about a million acres which amounts to one-seventh of the acreage under cereals.

Expansion of irrigation will greatly increase our food supply. There are immense possibilities for large-scale river-irrigation in Karnatak. Apart from the fact that the investigations on this subject are not complete, certain surveys already undertaken prove this. The famous Daddi project on the Ghataprabha, for instance, will command more than a million acres in Belgaum and Bijapur districts and the adjoining States. To quote Mr. Beale who conducted the survey:

"The land commanded is very much subject to famine, and hence the project with its super-abundant water-supply is one of the most important in the Deccan. These two canals, the Gokak Canal on the Left Bank commanding 497,000 acres and the Right Bank Canal commanding over 8,25,000 acres together command an area of 13,22,000 acres, or probable cultivable area of over a million acres. The water supply available in normal years is over 100,000 million (cubic feet) and is more than sufficient to irrigate the whole cultivable area with cereal crops. The system is the greatest in the Deccan." Again, the Asoga project on the Malaprabha in Belgaum district is estimated to irrigate about 1,15,480 acres. The famous Tungabhadra project, which is being jointly operated by the Governments of Madras and Hyderabad, will irrigate a large area in Bellary district.

There is also considerable scope for lift-irrigation by means of electrically driven power pumps. It is estimated that the lift-irrigation schemes on the Krishna and the Bhima will irrigate about two lakhs of acres in Bijapur district. The power for pumping out the water can be supplied by the Koyana hydro-electric project.

Besides irrigating cereal and leguminous crops, these projects are expected to grow sugarcane in large areas covering more than 70,000 acres. This will make Karnatak more than self-sufficient in gur and sugar. Assuming that the average production per acre is four tons, the total annual production of sugar will be 280,000 tons. This will bring in a sugar excise duty of 168 lakhs of rupees at the present rate of Rs. 60/- per ton. It has been found that irrigation will not have any deleterious effects on the black cotton soils of the Karnatak districts. Dry crops like jowar and bajri, cotton and groundnut yield when irrigated three to four times the quantity obtained when unirrigated. The areas commanded by these irrigation projects will also be saved permanently from famine. It may be noted here that the areas to be benefited by these projects in Bijapur, Belgaum and Bellary districts are now liable to famine frequently. Irrigation alone will banish famine from these tracts once for all.

Raw Materials for Industry

It is necessary to give a very brief account of raw materials that are available in Karnatak. Taking agricultural products first, we find that the new province will be particularly rich ia cotton. The total area under this crop would come to more than 2.1 million acres. The execution of the irrigation projects already referred to will not only increase cotton production. but will also make it possible to grow long staple cotton. With occasional irrigation, long staple cotton will yield 1,000 lbs per acre. The existing large area under cotton, coupled with the increased production after irrigation, will enable Karnatak to develop textile industry on a large scale. As observed by the Bombay Economic and Industrial Survey Committee, "the central position which Dharwar and Hubli occupy, make them ideal centres for supplying cloth to the whole of the Karnatak." The availability of oil-seeds, which are grown over a large area of 1.3 million acres, will help the establishment of oil-mills on modern lines. As pointed out earlier, the irrigation projects will bring under sugarcane cultivation about 70,000 acres. Even now the Karnatak districts possess 37,000 acres under this crop. Thus there will be sufficient sugarcane to establish sugar factories in considerable numbers.

The rich forests of both the Kanaras, Coorg and the Nilgiris can provide a variety of raw materials in large quantities for the development of forest industries. The Karnatak province will have more than 4.5 million acres under reserved forests an area which will be exceeded only by the provinces of C. P. and Midras. In the forests of Kanara and the Nilgiris, "the trees often grow to enormous size, with straight clean poles of 80 feet to the first branch and with a total height of 200 feet and more." In the absence of a comprehensive economic survey of the forest products and due to inadequate research, we are not in a positiou to give a complete picture of the forest industries. However, we may mention that there is scope for profitable establishments like plywood and match factories. Of the average annual extraction of bamboos in Bombay province amounting to 2,733,300 culms, no less than 2,045,300 culms

are claimed by the Karnatak districts. It is estimated that nearly 2,00,000 tons of bamboos per year are available in the northern portion of North Kanara district alone. This would be sufficient to feed several pulp-producing factories. It is said that bobins, which are at present imported from Sweden, can be manufactured from bamboo woods. With the vast forest resources, we should have large varieties of indigenous medicinal herbs and seeds for establishing a drugs industry. In short, as Mr. E. A. Smythies remarks: "There are great possibilities of development in the near future in the forests of Kanara, by means of increased and improved communications."*

Karantak province will have a coast line of about 200 miles. The sea fisheries resources can be exploited to the full by using modern methods of fishing and fish curing. The resulting increase in the supplies of fish will become the basis of industries like the manufacture of fish manure, fish guano, fish meal, fish oil, fish maws, etc.

Although Karnatak cannot boast of certain basic minerals like coal, the geological surveys so far carried out show that it contains some useful minerals like manganese, bauxite, ironores, limestone. China clay and building stones of various types. Manganese is found in large quantities in the western talukas of Belgaum and the up-shat talukas of North Kanara and also in Dharwar district. The China clay found in Khanapur taluka in Belgaum is said to be of high quality. The Bijapur district, owing to the variety of its strata, makes the region "rank high in mineral wealth". The district is rich in iron ore in the sense that the ore is found in various parts of the district. In fact, the smelting of iron ore and the making of agricultural implements from the same were followed as subsidiary occupation by some rural artisans. The district is particularly rich in building stones of various types and colours and also in those materials needed for the manufacture of cement Clay slate is also found. In Honavar taluka in North Kanara, sand which is useful for the preparation of glass can be had. China clay is available in Bellary, North Kanara and

Belgaum districts. Corundum is found at a number of localities in South Kanara, while ochres are available in Bellary and Dharwar. Soapstone can be had in south Kanara and Bellary.

A comprehensive geological survey of all parts of the proposed province from an industrial point of view is necessary. It is stated that some regions contain useful minerals in large quantities. For instance, the Supa petha, as pointed out by an official report, "is believed to be rich in different kinds of minerals though no geological survey of the tract has yet been undertaken."

Power and Transport

Although Karnatak has no coal deposits, this deficiency can be made up by developing hydro-electric power and thus producing "the white coal". Fortunately for us, there are immense possibilities in this direction. The irrigation projects already mentioned may also be made to produce electric power. This is particularly so in the case of the Daddi and the Tungabhadra schemes. In addition, there are a number of sites, particularly in Kanara and Coorg, which may be utilized for developing hydro-electric energy. Unfortunately, no comprehensive hydro-electric survey has yet been carried out. Even then, whatever investigations have been so far made indicate that Karnatak is rich in hydro-electric resources,

The hydro-electric survey of India mentions the following sites; (1) Kalinadi River:—Site near Kheda village in Supa petha of the North Kanra District, (2) Bedli River:—site near. Magod in Yellapur taluka in N. Kanara. (3) Benne Nala:—On the Sirsi-Kumta Road in N. Kanara. (4) Kuneri River:—Site about ten miles from Kumbharwada in North Kanara. (5) Hiranyakshi River:—Site about 38 miles from Belgaum; (6) Muhadeo River.—Site at 17 miles from Khanapur in the Belgaum district.

A similar list can be made indicating sites in the Madras portion of Karnatak. The 1931 Census Report of Madras mentions four such sites in South Kanara, four in the Nilgiris and seven in Coorg. The extent to which some of these sites

are capable of development can be seen from the fact that a preliminary survey recently undertaken by the Bombay Government of the Kalinadi valley has shown that the full development of the basin could provide a total installation of about 700,000 Kw. of electric power. The recent progress that has been made in the development of hydro-electric methods of generating and distributing electric power-has opened out new prospects. Making use of water-power is the cheapest method of supplying energy to industrial establishments. With the full utilization of water power, the new province of Karnatak can take a big stride in the industrial field. Water-power can also be utilized for electro-chemical industries, such as the extraction of aluminium from bauxite and the manufacture of nitrogen compounds from the air.

The economic aspects of forestry in relation to the fuel supply has not received sufficient attention so far. Wood distillation as a method of obtaining charcoal gas has been neglected. There is ample scope for the production of charcoal gas in Karnatak. A well-developed sugar industry in Karnatak, to which we have already referred, will also produce power alcohol from molasses which is obtained as a by-product in sugar factories. In all progressive countries, where indigenous petrol is not available in sufficient quantities, it has been considered desirable to develop alcohol as motor fuel.

Without adequate transport facilities, industrial development is not possible beyond a very limited extent. We have indicated in Chapter IV how Karnatak has suffered on account of inadequate transport. Karnatak has certain advantages in the matter of developing its transport and communication systems. The Kanara coast possesses some of the best natural harbours such as Karwar and Bhatkal in North Kanara and Malpi and Mangalore in South Kanara.

Karwar has been long recognised to be one of the finest ports on the West Coast, though it is sadly neglected. An expert like Sir Arthur Cotton, Commandant of Engineers. once wrote about Karwar as follows: "Upon the whole I think we may safely say there is scarcely a harbour in the world

that has a more remarkable collection of advantages than this would have, considering its position in respect of the sea and the country, its security, its accessibility by sea, its improvability, its climate, its connection with internal communications, its sanatorium on the neighbouring hill and its freedom from any drawback. That such a harbour should be placed opposite to such an opening in the Ghats leading to such a country with facilities for internal communications is most remarkable and it would seem to be madness to neglect such great advantages."

Bhatkal, the development of which is worth considering. is also a fine harbour. It can be easily connected with the Mysore Railway which is within a distance of 25 miles. Malpe, which is in south Kanara, is another fine natural harbour which can be developed with great advantage. The development of harbours on the Kanara Coast, coupled with a network of railway lines connecting the main centres of commercial and industrial importance. greatly facilitate the industrialisation of the new province. Some of the important railway lines which require early construction may be mentioned: (1) Line connecting Bhatkal with the Mysore Railway. (2) Line connecting Shimoga with Byadgi. (3) Line connecting Karwar with Hubli. (4) Lines connecting Mangalore with Mysore via Mercara and also with Kadur and Shimoga, (5) Line connecting Hosur with Bangalore, (6) Line connecting Kottur with Davanagere, (7) Line connecting Bijapur with Miraj.

Cottage Industries

The purpose of this section is not to take a survey of the cottage industries of Karnatak. What is sought to be done is to inducate very briefly the possibilities of developing some rural industries which need urgent attention. The handloom industry has always occupied a premier position among the rural industries in Karnatak. The Fact Finding Committee (1941) estimated the number of looms in the districts of

future Karnatak province at 59,000. The establishment of textile spinning mills in Karnatak will greatly assist the handloom industry. Yarn which is now imported from outside Karnatak can be manufactured in the province itself and supplied to looms at cheaper rates.

There are great possibilities for developing the sericulture industry in Karnatak. The talukas of Belgaum, Gokak, Khanapur, Hukeri, Chikodi, Sampgaon and Parasgad in Belgaum district: and the talukas of Dharwar, Kalghatii, Hangal, Kod, Bankapur, Hubli and Karajgi in Dharwar District are very well suited for introducing sericulture. This tract has a moderate rainfall, temperate climate and a favourable soil retentive of moisture. These climatic conditions are ideal for siik-worm rearings. Mulberry plants and trees grow here luxuriantly. The Sericulturist to the Government of Mysore, who was invited in 1939 by the Bombay Government to investigate the possibilities of introducing scriculture in Bombay province, reported that the tract referred to was "well fitted to take up the industry and to capture the silk market." He recommended that a sericulture farm should be established at Belgaum which "has all the advantages to be an ideal research and experimental station guiding the various branches of the silk industry in the Province." † In accordance with this recommendation, mulberry cultivation has been already started on a large scale.

Another important rural industry which has a bright future is bee-keeping. The whole of Kanara, both north and south, Coorg, the Nilgiris and the western parts of Dharwar and Belgaum districts are eminently suited for the development of this industry which has already made a good beginning in North Kanara. "While the industry, says an official monograph, "does not make a heavy call on the bee-keeper's time and involves only little labour and capital, the income derived from

the industry is greater than the income from several other cottage industries".!

The vast groves of coconut trees on the Kanara coast should make possible the establishment of a good coir industry. The total area under coconut palm in Kanara is about 60,000 acres. It may be noted that the coconuts of Kanara are bigger than those of Malabar and have, therefore, a longer fibre.

This brief note on the industrial possibilities of the future province of Karnatak should not be considered as exhaustive. The list of industries mentioned is by no means complete. But what has been stated is sufficient to indicate that there are vast possibilities for the industrial and economic advancement of the region. "Just as Governments should recognise," wrote the Famine Inquiry Commission (1945), "their responsibility to provide food for all, so also they should recognise the responsibility of developing economic resources to the fullest extent". The Government of India, who, in our opinion, recognise this responsibility, would do well immediately to form Karnatak into a separate province, so that it may develop industrially under the fostering care of a Government which will be run by the people of the region themselves.

CHAPTER VIII

FINANCIAL POSITION OF THE PROPOSED PROVINCE

The case for the immediate formation of the new province of Karnatak has been stated so far and is, in our opinion, irressistible. Here it is proposed to indicate its financial position also. As all relevant facts and figures are to be found only in Government records and as complete separate figures for different districts on all heads are not available even in Government records, we have to be satisfied with what figures we have at hand.

Roughly speaking we might say that the new province consisting of Union Karnatak territory will be as big and populous as the Mysore State today. Since this territory is as rich, if not more, in resources, it would not be far wrong to say that the revenues of this province when developed would be as big as those of Mysore itself. Three decades ago when Mysore was as undeveloped as these parts, its revenues did not exceed Rs. 3 crores. Today Mysore has a revenue of about Rs. 11 crores.

Recent developments regarding states have been very favourable to Karnatak. All the Deccan States except Kolhapur have merged into the Union territory. That has added a population of about 6 lakhs and a territory of about 3000 square miles to Union Karnatak area and the approximate revenue that would accrue to the new province would be a decent sum.

For the purposes of revenue and expenditure of Karnatak, we have to rely on the available Government figures. Here we shall calculate only the revenues of the four Kannada districts of the Bombay province, the two districts of the Madras province and shall mention about the small province of Coorg.

The financial position of the new province would be as reasonably satisfactory as is necessary for a new province which has so far been neglected. This fact was recognised by the

Nehru Committee as far back as 1928 when they wrote: "Financially the position of Karnataka was very strong and even at present there was a considerable surplus in the British part of the Karnataka". The position still continues to be the same substantially.

We shall not take into consideration here the central heads of revenue or the allocations usually made therefrom to the provinces. Thereby we shall be on the safer side in our calculations. We shall restrict ourselves to the provincial heads of revenue and expenditure and see if there is any serious handicap from which this young province would suffer. We shall find on examination that there is not only no serious impediment but that the province of Karnatak is likely to start functioning under far better auspices than Sindh or Orissa when they were first formed in 1936.

In applying any financial test to a new province, the following two factors may be born in mind, namely: (1) The absolute financial position of the province as indicated by the relation between its revenue and its expenditure; and (2) The financial position of the new province in comparison with the financial position of other new provinces.

Let us take the first test. The total receipts under the provincial heads for the four Karnatak districts of the Bombay province for the year 1946-47, as indicated in the Budget papers, are Rs. 357 lakhs. But the figures do not include the proceeds of the Sales Tax for the year which is estimated at Rs. 15 lakhs per year and Rs. 15 lakhs of land revenue which had to be remitted on account of extra-ordinary circumstances. That means that the normal annual revenue of Bombay Karnatak would be Rs. 337 lakhs. The receipts under provincial heads for the two districts of Madras province (for the year 1945-46) would be Rs 252 lakhs (Figure for 1946-47 were not available). Thus, the total income of only six districts excluding Coorg and the newly merged Karnatak states or Kannada portions of the states, would be Rs. 639 lakhs.

Now let us examine the total expenditure on provincial heads for the same period and for the same six districts. We find that expenditure for Bombay Karnatak under provincial heads for the year 1946-47 is Rs. 484 lakhs. But the figure includes an abnormal expenditure of Rs. 56 lakhs on bunding operations as part of the post-war development scheme. Therefore it is not a part of the normal expenditure. The normal expenditure therefore would be Rs. 428 lakhs. The expenditure for Karnatak districts in Madras for 1945-46 is Rs. 177 lakhs.

Summing up, the revenues of one year for the six districts come to Rs 639 lakhs, while the expenditure would be Rs 605 lakhs. There will thus be a small surplus of Rs 34 lakhs. It is out of this surplus that a provinicial administration will have to be run.

Now a provincial administration consisting of a Governor. a Secretariat, a Legislature and other establishment may cost about Rs. 45 lakhs which would mean a small deficit of about Rs. 11 lakhs. This is too small a deficit for a new province to be deterred in any way and the people of Karnatak would even welcome additional taxation to wipe out the deficit if thereby they have the liberty to administer their own province and find full scope to develop their resources.

The above is certainly not an unsatisfactory position for a new province. There should, therefore, be no objection whatsoever on financial account to the creation of the Karnatak province. On the contrary, the financial picture is such that it makes practicable the administrative realisation of the linguistic and cultural ideals that underlie the demand of the Kannada people for a new province.

Applying the second test, the following statement compares the position of the Karnatak with that of Assam and Orissa,

The figures for Assam would be even smaller when we take into account the separation of Sylhet from that province. It will be seen that Karnatak, in spite of its having a population of about the same order of magnitude as the other two provinces mentioned above, has a much larger revenue. Inspite of the fact that the other two provinces mentioned in the table are getting a central subvention of Rs. 30 lakhs and Rs. 40 lakhs respectively, Karnatak does not show a considerable deficit. If however, subvention is given on the lines similar to those granted to several other new provinces, it can be stated confidently that the financial position of the Karnatak is distinctly superior to that of either Assam of Orissa.

Apart from what has been stated above, we may refer with advantage to three more important considerations here. first consideration is regarding Coorg. The financial position of Coorg is entriely satisfactory. The total income for 1945-46 was Rs. 32 lakhs and the total expenditure Rs. 18 lakhs, leaving a surplus of Rs. 14 lakhs. The second condideration is the merger of the Deccan States. As indicated above, the approximate total revenue of the Karnatak areas would be Rs. 30 The expenditure including privy purses concerned would not be more than Rs. 11 lakhs. So there too we shall have a surplus of Rs. 19 lakhs. When all these territories are consolidated into the new province, as they now have been informally done, the financial position of the Union Karnatak would be sounder than ever. The thid consideration is that of contributions from the Central Revenues. Percentages, however small of the income-tax, excise etc. are usually paid as subsidies to the provinces. When the estate duty comes to be levied, a substantial portion of it may be allocated to the provincial revenues. But we have deliberately left them out of our calculations in order to prove that the financial position of the province even without these contributions is sound enough.

Moreover, there is a possibility in the near future of Union Karanatak and Mysore uniting to form a single unit under the Indian Union. The formation of the present province is perhaps only a preamble to the logical consolidation of all

Karnatak areas including the outlying portions such as the Nilgiris, Kollegal, Madakasira under a single provincial administration. When that happens-and it is bound to happen sooner than later-the province would be the envy of all with a territory of about 75,000 square miles and a little less than two crores of population.

But apart from that, even assuming for the sake of argument that Karnatak will not be financially self-supporting. the demand for unification cannot be resisted on this ground if the people concerned are willing to bear the burden of additional taxation. As the Nehru Committee declared. "a denial of the right to self-determination on purely financial grounds...... is bound to lead to great dissatisfaction." The Nehru Committee clinched the whole issue in the following words: "We who talk of self-determinatson on a larger scale cannot in reason deny it to a smaller area, provided of course this does not conflict with any other important principle or vital question. The mere fact that the people living in a part. icular area feel that they are a unit and desire to develop their culture is an important consideration even though there may be no sufficient historical or cultural justification for their demand. Sentiment in such matters is often more important than fact". We may observe that the demand of the Kannada people has more than sufficient justification not only on historical or cultural considerations, but also on financial grounds. It is not merely sentiment but solid facts of historical, cultural and economic importance that fully justify their claim for a united existence.

CHAPTER IX

SUMMARY AND CONCLUSIONS

The question of the redistribution of provinces in India has come up before the public very prominently in recent months. The attainment of full freedom by India in August 1947 and the work of constitution making that is proceeding apace have lent reality to a demand that is long-standing and urgent.

India is a single State and ought to continue to be one and indivisible. But it is inevitable that there should be provinces big and small in such a vast country and there they are. The formation of some provinces has been haphazard, irrational and unscientific for historical reasons. Since the constitution of India is being newly framed, this is the time when the problem of re-formation of provinces on a basis which would be conducive to the growth of homogeneous linguistic and cultural groups, can be tackled most unobtrusively and effectively.

Such a demand for redistribution is not recent. In fact it is there right from the begining of the formation of the province of Bengal by the British. They never took into consideration the language, history, culture and traditions of the local people. The people of Orissa and Bihar who were clubbed together with the Bengalees were the first sufferers. Therefore they were the pioneers of this linguistic movement. The success of the Biharis and later on of Oriyas and Sindhis, in getting separate provinces gave encouragement to others who were similarly situated. The movement for linguistic provinces had already spread to Andhra, and Karnatak by 1920 And now Maharashtra, Kerala, Tamilnad and others have fallen in line.

The Indian National Congress readily grasped the importance of the principle as early as 1920, and formed linguistic provinces for carrying on its activities. Those who have worked in that organization know it well enough that but for the formation of linguistic provinces, the national movement in India, would not have gained the strength it

did. This is an important lesson of history which should not be ignored. It is in recognition of this that the Congress Working Committee resolved in 1938 that as soon as it assumed power at the centre it would take up the question of the formation of linguistic provinces. The Congress has now achieved its political objective. It in in power at the centre. The time has therefore come for implementing its solemn assurances to those who actively co-operated with it in the struggle. We know that there are some other very important issues before the country. But no one can justify the postponement of such a constructive piece of work as the formation of linguistic and cultural provinces. In our opinion immediate formation of such provinces would render it easier for carrying out vast schemes of national reconstruction and for real democratic representative government to function.

The plea for the formation of a Karnatak province consisting of the Kannada areas is but a part of the larger question of the redistribution of provinces. The Kannada people who are more than one crore and a half in number today lie scattered in different administrations and would like to be in a single province. Though the grant of full responsible government in Mysore has opened a new vista for a United Karnatak including the Mysore State, one need not postpone the immediate formation of a Karnatak province consisting of the Kannada areas lying outside the states.

Though the claim was first registered during the course of the first Kannada Sahitya Sammelana in 1915, a practical plan of the province was prepared only in 1927 and submitted to the Nehru Committee. The case was so ably presented that the Committee at once accepted the claim and said that there was a prima facie case for a Karnatak province.

The proposed province is big enough to be a self-supporting autonomous unit. It will cover a compact area of about 32,000 sq. miles inhabited by nearly 75 lakhs of people and consisting of eight districts, together with the merged states, viz., Bijapur, Belgaum, Dharwar, North Kanara, South Kanara,

Bellary, Nilgiris and Coorg. It is far bigger than Sind or N.W.F. Province in population and is in no way smaller than Assam or Orissa. It is bigger than many of the independent European countries like Switzerland, Denmark or the Irish Free State. It would be far bigger than most of the Republics of the U.S.S.R. and the states constituting the United States of America. In fact, no federation in the world has such big units as in India and it would be healthier to have maller units if only we can make them more homogeneous.

In short, we must shed the illusion that the map inherited by us from the British is in any way conducive to the real development of various people inhabiting this vast country. Composite provinces are definitely disadvantageous; and the day to day business of democratic governments can certainly be better carried out if the unit is both small and homogeneous, Multilingual provinces give rise to distrust, jealousy and avoidable rivalries. Thus the most natural and logical thing would be to follow the Congress in this matter and to form linguistic and cultural provinces simultaneously with the ushering of the new Constitution.
