Sale of Redeemable Securities of Investment Company at Net Asset Value as Part of Plan of Reorganization.

There a registered open-end company proposes to sell its redeemable securities at net asset value to a registered closed-end company in consideration of the transfer of all the assets of the closed-end company at market value and where the redeemable securities received by the closed-end company will then be distributed as a liquidating dividend to its shareholders, held, that the open-end company be granted an exemption pursuant to Section 6 (c) of the Investment Company Act of 1940 from the provisions of Section 22 (d) of the Act.

General Capital Corporation (hereinafter referred to as "General"), a registered open-end investment company, has filed an application pursuant to Section 5 (c) of the Investment Company Act of 1940 for an order exempting it from the provisions of Section 22 (d) of the Act to permit the sale of its shares at net asset value without the imposition of a sales load to Old Colony Investment Trust (hereinafter referred to as "Old Colony"), a non-affiliated refistered closed-end investment company, in connection with a plan of reorganization which, in effect, will result in a combination of the two companies.

After appropriate notice, a public hearing was held. The Commission, having considered the record, makes the following findings:

General, incorporated under the laws of the State of Delaware in 1929, is a diversified investment company. It had outstanding 187,195 shares of common stock as of June 30, 1943 with an aggregate net asset value of \$5,986,927. It is currently engaged in the sale of its stock for cash on the basis of net asset value plus a sales load of 7% of the public offering price or 7.527% of the asset value per share of stock. The stock is redeemable at the option of the holder at its liquidating value determined at the close of business on the Tuesday or Friday next following receipt of a request for redemption on the basis of net asset value less an amount estimated to represent the expense of liquidating sufficient assets on a pro rata basis to pay for the redeemed shares but in no event more than 1% of the liquidating value per share.

Old Colony is a common law trust organized pursuant to a Declaration of Trust, dated January 14, 1927, under the laws of the State of Massachusetts. It is registered under the Investment Company Act as a diversified, closed-end company. It has presently outstanding 4-1/2% Debentures, Series B, due December 15, 1952 in the principal amount of \$782,900 and 300,000 common shares of no par value. As at August 2, 1943, the aggregate net asset value of the common shares, after deducting the debentures at par, amounted to \$4,262,853.

General and Old Colony propose to effectuate a plan of reorganization which will result in a merger of Old Colony into General. Under the terms of the proposed plan of reorganization, Old Colony is to redeem all its outstanding debentures on December 15, 1943 and is to pay or provide for the payment or satisfaction in full of all its debts, obligations and liabilities other than obligations to its shareholders as such. Thereafter, all of Old Colony's remaining assets (except a cash reserve) is proposed to be transferred to General in exchange for shares of common stock of General which, taken at net asset value, will equal the market value of the assets transferred. Old Colony will then distribute the stock of General to its shareholders. Payments in lieu of fractional shares will be made from the cash reserve to be retained by Old Colony.

Under the terms of the plan, the trustees of Old Colony will terminate the trust prior to the transfer of assets. The Declaration of Trust specifically provides that upon termination of the trust, the trustees may convey the trust property to new trustees or to a corporation and may distribute the net proceeds in kind at valuations fixed by the trustees among the shareholders ratably or may in their discretion turn such proceeds received into money for the purpose of such distribution, or may distribute part in kind and part in money. It appears that the consent of shareholders to such termination and liquidation of the trust is not required by the trust instrument.

Notice of the proposed transactions, however, is intended to be given to them.

Section 22 (d) of the Investment Company Act of 1940 provides in part, with certain exceptions not pertinent here, that no registered investment company shall sell any redeemable security issued by it except at a current public offering price described in the prospectus. Since the transfer of shares of General to Old Colony is proposed on the basis of respective net asset values of the two companies without the addition of the regular sales load included in the current public offering price of the stock of General as described in its prospectus, it would not meet the requirements of Section 22 (d)

literally applied. But there appears to be no reason in a transaction of this nature for the sale of the stock of General at a price equal to the current public offering price. On the contrary, the imposition of a sales load would disturb the relative net asset value basis of exchange, which the plan seeks to achieve, and consequently might introduce an element of unfairness.

In view of the facts and circumstances of this case, it is our opinion that the exemption requested from the provisions of Section 22 (d) of the Act is appropriate in the public interest and consistent with the protection of investors and the purposes fairly intended by the policy and provisions of the Act.

An appropriate order will issue.

Proposed transactions between: affiliated registered investment companies; a registered investment company and its affiliated persons; and, a registered investment company and affiliated persons of its affiliated persons, held, in view of all the circumstances, to meet the standards of Section 17 (b) of the Investment Company Act of 1040.

Change in Business so as to Cease to be an Investment Company

Where an application by a registered investment company pursuant to Section 8 (f) of the Investment Company Act of 1940 is predicated upon consummation of a series of proposed transactions with affiliated persons exempted from the prohibitions of Section 17 (a) by order pursuant to Section 17 (b) of the Act, the Commission will retain jurisdiction over the registrant and will hold in abeyance its order pursuant to Section 8 (f) of the Act until such time as the registrant has filed formal proof in the proceedings that it has ceased to be an investment company.

Setay Company, Incorporated ("Setay") has filed an application pursuant to Sections 6 (c) and 17 (b) of the Investment Company Act of 1940 for an order exempting the proposed transactions hereinafter set forth from the prohibitions of Section 17 (a) of the Act and for an order pursuant to Section 8 (f) of the Act, after consummation of certain of the proposed transactions, declaring that Setay has ceased to be an investment company within the purview of said Act

After appropriate notice a public hearing was held before a Trial Examiner. The Commission having considered the record makes the following findings:

. I. THE PRINCIPALS AND THEIR AFFILIATIONS

Setay was incorporated under the laws of the state of New York in 1927. It is registered under the Investment Company Act of 1940 as a closed-end nondiversified investment company, and has assets consisting principally of the securities of four other companies. Metropolitan Royalty Corporation ("Metropolitan") was incorporated in Delaware in 1928 and is registered under the Act as a closed-end management investment company. Its assets are principally oil royalty interests but it also owns 6,000 shares of Republic Pictures Corporation. Consolidated Film Industries, Inc. ("Consolidated") was incorporated in 1928 in Delaware and, with its subsidiaries, is engaged in processing was motion picture films, manufacturing motion picture advertising accessories, producing and distributing motion pictures, and manufacturing plastic molded product materials. Republic Pictures Corporation ("Republic") was incorporated in Delaware in 1937 and, with its subsidiaries, is engaged in producing and distributing motion pictures. Cajo Company, Inc. was incorporated in New York in 1934 and its only asset is 225,000 shares of Republic. Associated Motion Picture Industries, Inc. ("Associated") was incorporated in New York in 1943 for the purpose of acquiring all the assets of Setay except certain securities of Republic, and will upon conclusion of the transactions be a closedend, non-diversified investment company, he are the second and the

Setay owns approximately 95% of the outstanding voting securities of Metropolitan, 20% of the outstanding voting securities of Consolidated, 50% of the outstanding voting securities of Republic. The record indicates that associated and Setay have the same persons as officers and directors and that the two companies are under common control. 1/

^{1/} Samuel A. Adamson, Vice President of Associated and of Setay, testified at the hearing in this proceeding that Associated and Setay were under common control.

Setay proposes transactions with the other companies named above, and with four individuals who are directors of companies within the group. Frederick R. Fyan is a director of Setay and Republic; Hertert J. Yates, Jr. is a director of Consolidated; Walter W. Vincent is a director of Consolidated and Republic; and Forris Goodman is a director of Republic.

Fecause of the foregoing facts, each of the persons with whom Setay proposes to deal as a principal is either an affiliated person 2/ or an affiliated person of an affiliated person of Setay. Therefore the proposed transactions involving purchases and sales are prohibited by Section 17 (a) of the Act. 3/

2/ Section 2 (a) (3) reads as follows:

"'Affiliated person' of another person means (A) any person directly or indirectly owning, controlling, or holding with power to vote, 5 per centum or more of the outstanding voting securities of such other person; (B) any person 5 per centum or more of whose outstanding voting securities are directly or indirectly owned, controlled, or held with power to vote, by such other person; (C) any person directly or indirectly controlling, controlled by, or under common control with, such other person; (D) any officer, director, partner, copartner, or employee of such other person; (E) if such other person is an investment company, any investment advisor thereof or any member of any advisory board thereof; and (F) if such other person is an unincorporated investment company not having a board of directors, the depositor thereof."

3/ Section 17 (a) reads as follows:

"It shall be unlawful for any affiliated person or promoter of or principal underwriter for a registered investment company (other than a company of the character described in Section 12 (d) (3) (A) and (B), or any affiliated person of such a person, promoter, or principal underwriter, acting as principal —

- (1) knowingly to sell any security or other property to such registered company or to any company controlled by such registered company, unless such sale involves solely (A) securities of which the buyer is the issuer, (2) securities of which the seller is the issuer and which are part of a general offering to the holders of a class of its securities, or (C) securities deposited with the trustee of a unit investment trust or periodic payment plan by the depositor thereof:
- (2) knowingly to purchase from such registered company, or from any company controlled by such registered company, any security or other property (except securities of which the seller is the issuer); or
- (3) to borrow money or other property from such registered company or from any company controlled by such registered company (unless the borrower is controlled by the lender) except as permitted in Section 21 (b).

NOIE:

The exceptions to paragraphs 1 and 2 and the provisions of paragraph 3 of Section 17 (a) are not pertinent with respect to the proposed transactions.

At a meeting of stockholders on September 2, 1943 Setay, by a vote of a majority of its outstanding voting securities, was authorized: (1) to increase its authorized capital stock from 100,000 to 500,000 shares of common stock of \$1 par value; (2) to change the nature of its business so as to cease to be an investment company 4/; (3) to consummate a series of transactions designed to effect a voluntary reorganization of Setay, place it primarily in the business of producing motion pictures, and change the nature of its business so it will cease to be an investment company; and, (4) to file an application for an order declaring that Setay has ceased to be an investment company.

> III. THE PROPOSED TRANSACTIONS AND SETAY'S REQUEST FOR AN ORDER DECLARING THAT IT HAS CEASED TO BE AN INVESTMENT COMPANY

The proposed transactions which were approved by the stockholders of Setay and which are before us in this application are as follows;

- (1) The purchase by Setay and the sale by Metropolitan of 6,000 shares of stock of Republic for \$30,000:
- (2) The transfer by Setay to Associated of all assets, property and rights of Setay, except 90,085 shares of Republic, 150 shares of Cajo, some secured notes receivable in the amount of \$200,000 and the 6,000 shares of Republic which Setay proposes to acquire from Metropolitan, in consideration of Associated issuing to Setay 94,735.8 shares of capital stock of Associated and assuming all obligations and liabilities of Setay except some notes payable in the amount of \$200,000;
- (3) The issuance by Setay to Consolidated of 195,442 shares of Setay in exchange for 317,800 shares of Republic and 150 shares of Cajo;
- (4) The acquisition by Setay of an aggregate of 750 shares of Republic from Frederick R. Ryan, Herbert J. Yates, Jr., Walter W. Vincent and Morris Goodman on the tasis of an exchange of .4542 share of Setay for each share of Republic: and

^{4/} Section 13 (a) (4) prohibits a registered investment company from changing the nature of its business so as to cease to be an investment company unless it is so authorized by a vote of a majority of its outstanding voting securities.

(5) The receipt of 225,000 shares of Republic by Setay through the liquidation of Cajo.

Setay proposes to consummate the proposed transactions in the order in which they are listed above and requests that its application pursuant to Section 8 (f) of the Act, for an order declaring that it has ceased to be an investment company within the purview of the Act, be granted after consummation of the transaction with Associated or, at the latest, after consummation of the transaction with Consolidated.

IV. THE STANDARDS OF SECTION 17 (b) OF THE ACT

Even though proposed transactions may be prohibited by Section 17 (a), we are required under the provisions of Section 17 (b) of the Act to exempt transactions from the prohibitions of Section 17 (a) provided the evidence establishes that: (1) the terms of the proposed transactions, including the consideration to be paid and received, are reasonable and fair and do not involve overreaching on the part of any person concerned; (2) the proposed transactions are consistent with the investment policy of each investment company concerned as stated in its registration statement and reports filed under the Act; and, (3) the proposed transactions are consistent with the general purpose of the Act. We will now consider the proposed transactions in the light of these standards.

- A. Fairness of the Terms of Each Transaction
- 1. The Setay Metropolitan Transaction

Setay proposes to purchase 6,000 shares of Republic from Metropolitan for \$30,000.

A determination that the terms of this transaction are fair and reasonable necessarily involves a finding that the purchase price of \$5 per share to be paid for the stock of Republic is reasonable and fair. Therefore, various factors which have a bearing on the value of the stock will be considered.

As of September 3, 1943, Republic's outstanding capital stock consisted of 642,239 shares of common of a par value of \$1 per share. As of the same date the stock had a book value of approximately \$3.10 per share of which approximately \$1.95 represents the value assigned to good-will, residual value of amortized productions and other intangible assets.

Republic earned \$765,256.71 in the fiscal year ended April 30, 1943 and its earnings from May 1 to September 3, 1943 amounted to \$287.385.90. Its per share earnings in its fiscal years ending April 30, 1939, 1940, 1941, 1942 and 1943 were \$.09, .06, .27. .025 (loss), and \$1.25. The per share earnings in the period from May 1 to September 3, 1943, amounting to approximately \$.45, indicates an annual rate of approximately \$1.28 per share. Thus, the average indicated earnings on the stock in the fiscal years 1939 through 1944 would be approximately \$.45 per share. A comparison of the indicated average earnings with the proposed selling price of \$5 per share results in a price-earnings ratio of 10.2. A similar comparison, using per share earnings at the indicated annual rate for the fiscal year ending April 30, 1944 results in a price-earnings ratio of 3.9.

However, it is noted that Republic lacks adequate working capital, that its current liabilities exceed its current assets and that substantially all of its assets are pledged or mortgaged.

The production and distribution of the motion pictures released by Republic are financed by means of relatively short term loans under agreements which provide, among other things, for the pledge of all motion pictures produced and to be produced, together with stories, copyrights, exhibition and distribution rights and all other rights incidental thereto, as security for the payment of principal of, and interest on, such loans. Under such agreements all cash receipts derived by, due and to become due to Republic from the distribution or other disposition of its motion pictures are pledged and are applied weekly, through the medium of trusteed bank accounts, in reduction of the loans and payment of interest thereon, and on accounts payable for prints, film laboratory work, material and certain accessories. Since Republic lacks adequate working capital and its income is pledged for the payment of loans and current accounts payable, it is necessary to obtain new secured loans to finance its current productions.

In effect, the money for Republic's continued operation is provided by means of a revolving fund of short term loans obtained under the above-mentioned agreements. Assuming that the future growth of Republic will not require an increase over the current sum of the secured loans obtained under these agreements, it would require approximately six years before the earnings of Republic, at the rate experienced in its fiscal year ended April 30, 1943, would equal the sum of these secured loans and current secured accounts payable. While this condition exists, or at least until the loans have been substantially reduced, it is not probable that dividends may be paid on the Republic stock.

Republic's stock is not listed on a stock exchange nor is it traded on an over-the-counter market. Metropolitan purchased its holdings of Republic stock from Republic in 1938 at a price of \$5 per whare and it carries this stock on its books at such value. Setay also values its holdings of 90,085 shares of Republic stock at \$5 per share. Cara opposition, and Februar Condi

Since the equity represented by a share of Setay both prior to and after the consummation of the foregoing proposed transactions remains the same, we find that the terms of the proposed transactions, including the consideration to be paid and received, are reasonable and fair and do not involve overreaching on the part of any person concerned.

5. The Setay-Cajo Transaction

Setay will have acquired all of the outstanding capital stock of Cajo as a result of the consummation of the proposed transaction with Consolidated. As previously indicated, the sole asset of Cajo consists of 225,000 shares of Republic and it has no liabilities. Setay proposes to acquire direct ownership of the 225,000 shares of Republic by the receipt of such shares as the proceeds of liquidation of Cajo.

Paragraphs (1) and (2) of Section 17 (a) of the Act, subject to certain exceptions therein contained, prohibit any transaction between Setay and Cajo involving a purchase or sale of securities or other property. $\frac{7}{2}$ However, the receipt by Setay of the 225,000 shares of Republic as the proceeds of liquidation of Cajo will not involve a purchase or sale of the Republic shares. Therefore, the receipt by Setay of these shares does not come within the purview of Section 17 (a) and an order of exemption pursuant to Section 17 (b) of the Act, as requested by Setay, is unnecessary. Our findings on this point are limited to the particular circumstances of the instant transaction.

B. Consistency of the Proposed Transactions with the Policies of Setay and Metropolitan and with the Purposes of the Investment Company Act of 1940.

The proposed transactions are consistent with the policies of Setay and Metropolitan as recited in their respective registration statements filed pursuant to Section 8 (b) of the Act. Setay there states that it is a non-diversified investment company and that its policy with respect to investments places no limitation on the types of securities in which it may invest or upon the proportion of its assets it may invest in each type of security. Moreover, Setay has been authorized, by a vote of a majority of its outstanding securities, to consummate the entire series of transactions and to change the nature of its business so as to cease to be an investment company 6/. Metropolitan states that it is its policy to invest in securities of all types without restriction or limitation as to the proportion of its assets which it invests in any type of security. We also find that the proposed transactions are consistent with the general purposes of the Act 7/.

However, it is pointed out that the entire series of transactions are part of a plan for the voluntary reorganization of Setay and were designed as a whole to effect the change in the nature of its business so that Setay would cease to be an investment company. Therefore, we shall retain jurisdiction under the Act over Setay until the entire series of transactions are completed and shall hold in abeyance our order pursuant to Section 8 (f) of the Act 12/until such time as Setay has filed in this proceeding formal proof, including financial statements, that it has ceased to be an investment company.

Setay Company, Incorporated ("Setay"), a registered investment company, has filed an application pursuant to Sections 6 (c) and 17 (b) of the Investment Company Act of 1940 for an order exempting from the provisions of Section 17 (a) of said Act the proposed transactions hereinafter set forth and for an order pursuant to Section 8 (f), after consummation of certain of the proposed transactions, declaring that Setay has ceased to be an investment company within the meaning of said Act.

The transactions for which Setay seeks exemption are: (1) the purchase by Setay and the sale by Metropolitan Royalty Corporation, a registered investment company, of 6,000 shares of Republic Pictures Corporation ("Republic") for \$30,000:

- (2) the transfer by Setay to Associated Motion Picture Industries, Inc. ("Associated") of all assets, property and rights of Setay, except 90,085 shares of Republic, 150 shares of Cajo Company, Inc. ("Cajo"), some secured notes receivable in the amount of \$200,000 and the 6,000 shares of Republic to be acquired from Metropolitan Royalty Corporation, in consideration of Associated issuing to Setay 94,735.8 shares of the total authorized and unissued capital stock of Associated and assuming all obligations and liabilities of Setay except some notes payable in the amount of \$200,000;
- (3) the issuance by Setay to Consolidated Film Industries, Inc., an affiliated person of Setay, of 195,442 shares of its authorized and unissued stock in exchange for 317,800 shares of Republic and 150 shares of Cajo (the latter shares are the equivalent of a one-half interest in 225,000 shares of Republic):

- (4) the purchase by Setay of an aggregate of 750 shares of Republic from Frederick R. Ryan, Herbert J. Yates, Jr., Walter W. Vincent and Morris Goodman on the basis of an exchange of .4542 share of the authorized and unissued stock of Setay for each share of Republic; and
- (5) upon consummation of the transaction in (3) above, Setay, as the sole stockholder of Cajo, proposes to acquire 225,000 shares of Republic as the proceeds of liquidation of Cajo.

Setay plans to consummate the proposed transactions in the order in which they are set forth above.

A public hearing having been held on such application after appropriate notice and the hearing having been closed with respect to Sections 6 (c) and 17 (b) and continued subject to call by the Trial Examiner with respect to Section 8 (f); the Commission having examined the record and having this day issued its Findings and Opinion in the matter;

IT IS ORDERED on the basis of such Findings and Opinion that each of the aforesaid transactions involving a sale or purchase of securities or other property be and hereby is exempted from the provisions of Section 17 (a) of the Investment Company Act of 1940.

The applicant, a New York corporation, is the successor by consolidation of two securities companies organized and formerly sponsored by Liberty Bank of Buffalo. One of these predecessors, Liberty Share Corporation, was formed in April 1929 and operated for several years as the Bank's securities department. The other predecessor, Western New York Securities Corporation, was organized in September 1929 and operated as a subsidiary of Liberty Share until the consolidation which took place in 1941. The two securities companies were under common management, predominantly composed of officers of Liberty Bank until the Banking Act of 1933 required the separation of the securties business from commercial banking. Leon G. Ruth, president of the applicant, was president of the two predecessor companies for several years and before that was a vice president of Liberty Bank. 3/

The applicant has an authorized capital of \$350,000 consisting of common stock of the par value of \$1 per share. In connection with the 1941 consolidation 237,860 shares were issued or subject to issuance in exchange for the stock of the predecessors. As of December 31, 1942, 202,421 shares were outstanding or subject to issuance in such exchange, and the applicant had about 6,000 shareholders. Its officers and directors beneficially owned an aggregate of 11,384 shares (5.6% of the total) as of that date, and Liberty Eank teneficially owned 17,535 shares (8.66%). 3a/

The stock is not listed on any exchange and it does not appear to be active in the over-the-counter market. In recent years the company has been practically the sole bidder for its stock, having maintained a customary bid of \$1. 4/ Before the adoption of our present Rule N-23C-1 the applicant, during the period June 4, 1941, to December 11, 1942, purchased 35,439 shares of its own stock.5/ With the exception of a few fractional interests (for which payment at the rate of \$1.50 per share was made) applicant reacquired its stock at prices ranging from \$1 to \$1.10. 6/ During the period in which purchases were made the net asset coverage per share varied from \$2.30 to \$2.84. At December 31, 1942 it was \$2.72; at May 31, 1943, \$3.44.

It is admitted that no dividends have been declared or paid for the years 1941 or 1942, so that the purchase program does not meet the requirements of paragraph (a) (2) of Rule N-23C-1. Applicant nevertheless seeks permission to continue its program of purchasing. We cannot grant the application unless we can find the existence of circumstances "to insure that such purchases are made in a manner or on a basis which does not unfairly discriminate against any holders of the class ... of securities to be purchased."

The applicant's further reasons are irrelevant to the issue of whether its purchase would discriminate. It points to the fact that by keeping an open bid it provides a market; and one of the benefits claimed to result from the existence of this market is that it enables stockholders "to establish a tax loss" which "is or may be of more value to the holder than the stock itself."

The applicant's vice president admitted that the purchase price of \$1 was not selected as a result of any method, but that it was arrived at in "an arbitrary way." Arbitrariness was justified on the ground that there is "any number of stocks selling on the big board and many other places that have a book value considerably in excess of market value." But in this case it cannot be fairly said that there is a "market value" for the stock. In past transactions the applicant has been practically the only buyer.

The fact that stockholders have been willing to sell out to the applicant at a sacrifice is directly traceable to the management's policy of not paying dividends despite the availability of earnings and cash for the purpose. The management does not contend here that the company is unable to declare or pay dividends. Apart from a desire to build up asset values, its chief reason for not paying dividends seems to be the expense which it says would be incurred in making such payment. We do not pass on the validity of these reasons. The point is that if the management adheres to such policy, the natural result will be to discourage a considerable body of stockholders as to their prospects, and tend to induce them to sell to the applicant at a sacrifice. 10/
The applicant cannot be permitted to take advantage of its own policies to acquire its stock at prices well below asset value for the benefit of those stockholders who are able and willing to outlast the others, in an endurance contest wholly lacking in rules of fair play.

^{10/} Letters to the company from some of its stockholders evidence the kind of attitude which leads to sales at depressed prices brought about by management policies. One stockholder wished to know -- "Does Western New York stock ever pay any dividends? Is there any market for these stocks and if so what price." Another stockholder, who had been advised by a broker to sell, stated -- "I am taking a loss on these shares but wish to dispose of them as I do not believe we will ever receive our original investment as so much of the earnings of this Corporation are paid out in high salaries at the present time." Another noted that even though officers' salaries "absorb over 41% of total income" the board of directors voted to "compensate Mr. Ruth [president of the company] by the differential existing between the salary he would have received with the corporation and his remuneration [as a major] . . . in the army." Another, after noting the salaries paid, asked "Is this a milking machine, or is it run on a legitimate basis?" Another stated: "The Fund is now and has been for a long time past but a custodian account and it should not be burdened with unnecessary salaries, directors' fees and office expenses; it should be immediately liquidated for the benefit of its stockholders or turned over to a custodian."

FINDINGS AND ORDER

The Guardian Investment Trust has filed an application pursuant to Section 6 (c) of the Investment Company Act of 1940 for an order exempting it from the provisions of Section 30 (d) of the said Act and Rule N-30D-1 pronulgated thereunder in so far as the said Section and Rule require the transmittal of semi-annual reports to shareholders.

A public hearing having been duly held after appropriate notice, the Commission having considered the record in the matter, finds:

- 1. The Guardian Investment Trust is a common law trust organized under the laws of the State of Connecticut pursuant to a declaration of trust dated June 15, 1927. It has registered under the Investment Company Act of 1940 as a closed-end, diversified, management company.
- 2. The applicant was originally sponsored by F. E. Kingston and Company, investment dealers and brokers of Hartford, Connecticut. In 1931, members of that firm were criminally prosecuted. While the prosecution was pending, an application for the appointment of a receiver of the applicant was filed in the Superior Court for Hartford County. The receivership action was settled by agreement of all parties and with the informal approval of the court. Under the terms of the settlement, the original trustees resigned and four of the present five trustees were appointed.
- 3. The policy of the trustees since taking office in 1931 has been to effect over a period of years a gradual liquidation of the trust by the repurchase and retirement of its preferred shares. The applicant has not offered its securities since 1931, and no further public offering is intended. In accordance with the recitals of policy contained in its registration statement,

the applicant will not borrow money, will not act as underwriter, will not concentrate its investments in any particular fridustry, will not engage in the purchase and sale of real estate, will not engage in the purchase and sale of commodities or commodity contracts, and will not loan money to any person.

- 4. As of May 31, 1943, the applicant had total assets of \$1,174.186 and had outstanding 35,330 preferred shares and 270,472 common shares. At that date, the preferred shares were entitled in liquidation to \$30 per share plus \$7.27 in accrued dividends in preference to the common shares, or a total liquidating preference of \$1,352,901. Neither the preferred shares nor the common shares are a voting security.
- 5. The applicant has approximately 4,500 shareholders of whom by far the greater majority are holders of common shares. The cost of semi-annual reports and the expense of transmitting the same to its shareholders are estimated by the applicant at \$2,000 as compared to a total annual compensation of \$2,500 to its five trustees. TO THE TANK OF STATES
- 6. It is appropriate in the public interest and consistent with the protection of investors and the purposes fairly intended by the policies and provisions of the Act to grant the applicant the exemptive relief hereinafter set forth.

WHEREFORE IT IS ORDERED that the applicant be granted an exemption from the requirement of transmitting reports to its shareholders semiannually as prescribed by Section 30 (d) of the said Act and Rule N-300-1 thereunder, provided that the applicant transmit to its shareholders, at least annually, the reports prescribed by that Section and Rule; and further provided that this order may be revoked, suspended or modified after notice and opportunity for hearthg. 28421 A alem navlej censa serec . is anterior, flader

Applications having been filed by employees' securities companies pursuant to Section 6 (b) of the Investment Company act of 1940 for exemptions from certain provisions of that Act; upon appropriate findings the exemptions granted.

Executives Investment Trusts and Elfun Trusts filed applications under the provisions of Section \acute{o} (b) of the Investment Company Act of 1940 for orders exempting them from all of the provisions of the Act. Section \acute{o} (t) 1/ provides, among other things, that this Commission, upon the application of

"Upon application by an employees' security company, the Commission shall by order exempt such company from the provisions of this title and of the rules and regulations thereunder, if and to the extent that such exemption is consistent with the protection of investors. In determining the provisions to which such an order of exemption shall apply, the Commission shall give due weight, among other things, to the form of organization and the capital structure of such company, the persons by whom its voting securities, evidences of indebtedness, and other securities are owned and controlled, the prices at which securities issued by such company are sold and the sales load thereon, the disposition of the proceeds of such sales, the character of the securities in which such proceeds are invested, and any relationship between such company and the issuer of any such security."

¹/ The language of Section 6 (t) is as follows:

an employees' securities company, 2/ shall exempt such a company from the provisions of the Act and from the rules and regulations under it, to the extent that such exemption is consistent with the protection of investors. The applications were consolidated for hearing and after appropriate notice a hearing was held. Thereafter the applicants filed amendments to their respective applications limiting their requests nunc pro tunc to exemptions from certain specified provisions hereinafter discussed.

Both of the applicants fall within the scope of Rule N-6C-3 (b), subsequently superseded by Rule N-6B-1, and accordingly have been exempt from the provisions of the Act pending the final disposition of the applications. 3/

Executive Investment Trusts is an inter vivos common law trust created under a trust agreement dated December 20, 1928. The purpose of its organization was to provide to certain employees of General Electric Company 4/ and its affiliated companies an investment vehicle which would continue in existence until each individual participant would revoke his interest therein. The question of whether this applicant is an investment company for the purposes of the Act is not in issue. It operates as a form of diversified, open-end, management, common law trust. 5/

"Any employees' securities company which files an application for an order of exemption under Section 6 (b) of the Act shall be exempt, pending final determination of such application by the Commission, from all provisions of the Act applicable to investment companies as such."

^{2/} An employees' securities company is defined in Section 2 (a) (13), as follows: "'Employees' securities company' means any investment company or similar issuer all of the outstanding securities of which (other than short-term paper) are beneficially owned (A) by the employees or persons on retainer of a single employer or of two or more employers each of which is an affiliated company of the other, (B) by former employees of such employer or employers, (C) by members of the immediate family of such employees, persons on retainer, or former employees, (D) by any two or more of the foregoing classes of persons, or (E) by such employer or employers together with any one or more of the foregoing classes of persons."

^{3/} Rule N-6B-1 provides as follows:

^{4/} The Trust Agreement (paragraph 38) specifically provides as follows: "It is hereby expressly declared that General Electric Company is not a party to this instrument and shall have no responsibility whatever for the administration of the trust funds."

^{5/} Section 5 (t) (1) of the Act provides: "'Diversified company' means a management company which meets the following requirements: At least 75 per centum of the value of its total assets is represented by cash and cash items (including receivables), Government securities, securities of other investment companies, and other securities for the purposes of this calculation limited in respect of any one issuer to an amount not greater in value than 5 per centum of the value of the total assets of such management company and to not more than 10 per centum of the outstanding voting securities of such issuer."

Fankers Trust Company, as trustee, holds and conducts all transactions in the assets of the trust but a committee of persons associated with General Electric Company and its affiliated companies in fact manages the fund. The trustee may resign or be removed by a majority of the committee and a successor trustee shall be designated by a majority of the committee. The committee is self perpetuating.

The committee has the power under the trust agreement of Executives Investment Trusts to determine who may invest in the securities (designated as Parts and all being of the same class) of the trust and may at any time direct a participant to surrender all or a part of his certificates for redemption. Such certificates are non-transferable although the right of a holder to redeem, for the value of his share of the under-lying assets of the trust less 1%, is assignable and passes by inheritance. No sales load or under-writing commission was paid with respect to the issuance of the securities of this applicant and no such securities have been issued since the effective date of the Securities Act of 1933. 6/ The 1% redemption fee is retained by the trust.

All of the outstanding securities of the Executive Investment Trust are benefically owned by employees or persons on retainer (or members of the immediate families of any such group) of the General Electric Company or its affiliated companies. It is therefore an "employees' securities company" as defined in Section 2 (a) (13) of the Act and thus entitled to apply for exemption pursuant to Section 6 (b).

Executives Investment Trusts had net assets on September 30, 1943, having a value of \$5,909,826.47 of which \$5,472,078.75 represented securities at market value. 7/ Common and preferred stocks of industrial companies (with some emphasis upon utility issues) predominate in the portfolio. 8/ Expenses of administration, including compensation for services performed, are paid out of the trust funds. The trust agreement provides that the committee shall, within a reasonable time after the completion of each annual audit, render a statement to the participants showing the actual value of each Part as of the preceding December 31st.

Section 5 (a) (1) of the Act provides: "'Open-end company' means a management company which is offering for sale or has outstanding any redeemable security of which it is the issuer."

Section 4 (3) of the Act provides: "'Management company' means any investment company other than a face-amount certificate company or a unit investment trust."

- 6/ It is asserted in the application (p.5) that Executives Investment Trusts is "virtually on a liquidating basis."
- 7/ These securities were carried at a cost of \$9,969,288.08.
- 8/ As of September 30, 1943 Executive Investment Trusts possessed 6,000 shares of General Electric Company common stock representing 3.93% of applicant's net assets at market and .021% of the outstanding common stock of General Electric Company. It owned no other securities issued by Central Electric Company or its affiliated companies.

Elfun Trusts was created under a trust agreement dated May 27, 1935 to continue the program of Executives Investment Trusts which had ceased offering its securities after the effective date of the Securities Act of 1933. All and on June 17, 1935, Elfun Trusts filed its first registration statement under the Securities Act of 1933. The organization of Elfun Trusts is similar to that of Executives Investment Trusts hereinbefore discussed. The principal organic differences between the two trusts are, (1) the functions undertaken by the Committee of Executives Investment Trusts are more or less assigned in Elfun Trusts to a like group designated as Trustees, and (2) the functions of the corporate trustee of Executives Investment Trusts are more or less assigned to Bankers Trust Company as Agent. Like Executives Invest ment Trusts , Elfun Trusts is an "employees' securities company" and is also entitled to apply for exemption pursuant to Section 6 (b) of the Investment to securous control of and security and securous control of the securous security and the securous security of the security of Company Act of 1940. desirys and many Contract to the second

Unlike Executives Investment Trusts, however, Elfun Trusts, currently issues securities. These securities, which are registered under the Securities Act of 1933, are sold under a prospectus which must meet the requirements of Section 10 of that Act; and annual reports are filed by this applicant pursuant to its undertaking under Section 15 (d) of the Securities Exchange Act of 1934. 9/ No sales load or underwriting commission is charged with respect to the issuance of the securities of this applicant and the 1% redemption fee is retained by the trust. The trust agreement provides that the trustees shall mail a copy of the annual report of the auditor, as well as quarterly reports showing the actual value of each "Unit", to each particlpant in the trust. In all other respects the characteristics and purposes of Executives Investment Trusts and Elfun Trusts are essentially the same.

** * J. On September 30, 1943, Elfun Trusts had net assets having a value of \$6,632,658.33, of which \$5,982,480,75 represented diversified securities at market values. 10/ Its investment policy appears to have been the same as that of Executives Investment Trusts and it may also be classified as a " diversified, open-end, management, common law trust. 11/

The amended applications limit the requests for exemptions as follows:

Both applicants request exemptions from Section 8 (b) (except with respect to the "Policy" Items of Form N-88-1), Section 20 (a), Section 22 (f), Section 30 (b) (1) and Section 32 (a) of the Act.

Executives Investment Trusts also requests exemption from Section 30 (a) (except with respect to the "Policy" items of Form N-30A-1). Section 30 (d) (to the extent that reports are required to be sent to participants more than once a year), and Section 32 (b) of the Act.

Form N-30A-1 which is prescribed by Rule N-30A-2 for reports by such companies pursuant to Section 30 (a) of the Investment Company Act of 1940, is also prescribed by Rule X-15D-2 for reports by such companies pursuant to Section 15 (d) of the Securities Exchange Act of 1934.

^{10/} These securities were carried at a cost of \$5,342,222.83.

^{11/} As of September 30, 1943, Elfun Trusts possessed 2,000 shares of General Electric Company common stock representing 1.17% of applicant's net assets at market and .007% of the outstanding common stock of General Electric Company. It owned no other securities issued by General Electric Company effiliated companies.

Elfun Trusts also requests exemption from Section 16 (b) of the Act.

Applicants are employees' securities companies, a peculiar type of company which Section 6 (b) requires to be exempted from the provisions of the Act if and to the extent that such exemption if consistent with the protection of investors. 12/ Section 6 (b) also contains certain standards to be considered by the Commission in determining the provisions of the Act to which its order of exemption shall apply.

It appears that the protection of the rights and interests of investors will not be prejudiced by the granting of the exemptions sought. Furthermore, the nature and activities of these trusts have been tested against the standards contained in Section 6 (b) of the Act and the exemptions sought appear to be justified thereby. Accordingly, on the basis of the existing record we find it consistent with the protection of investors and the standards of Section 6 (b) of the Act to grant to the applicants the exemptions requested as above set forth.

An order will issue in accordance with this opinion.
