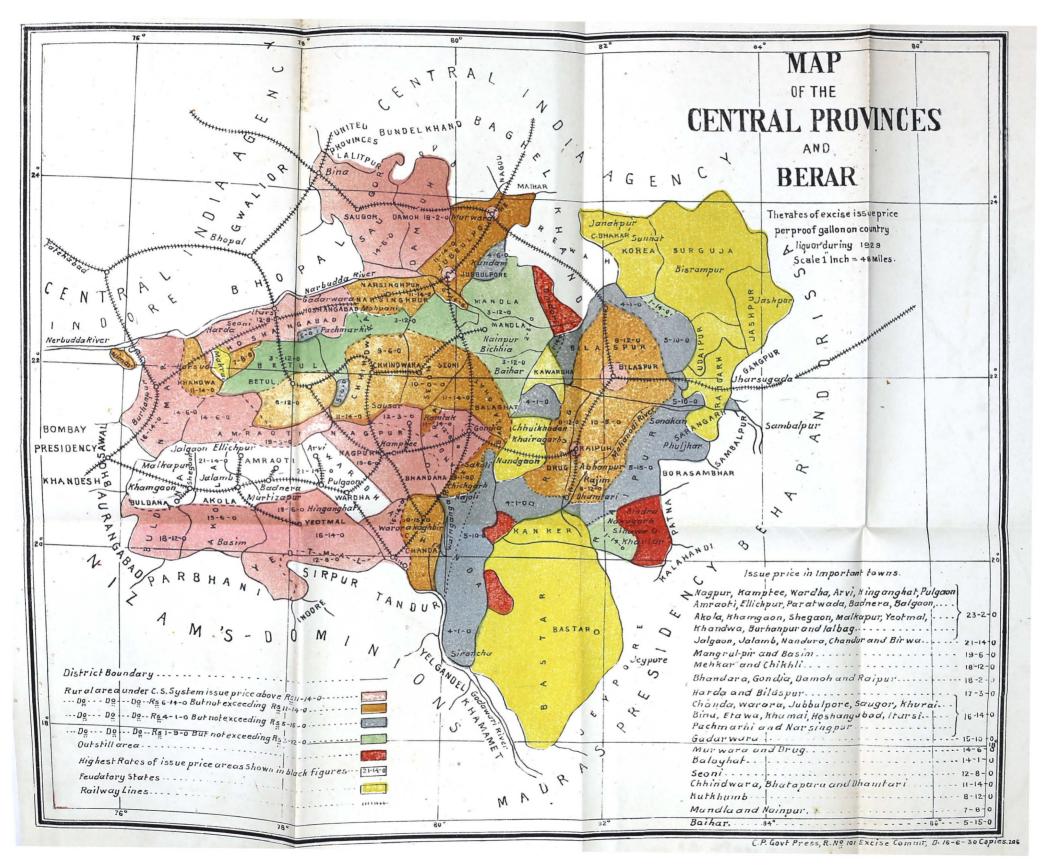

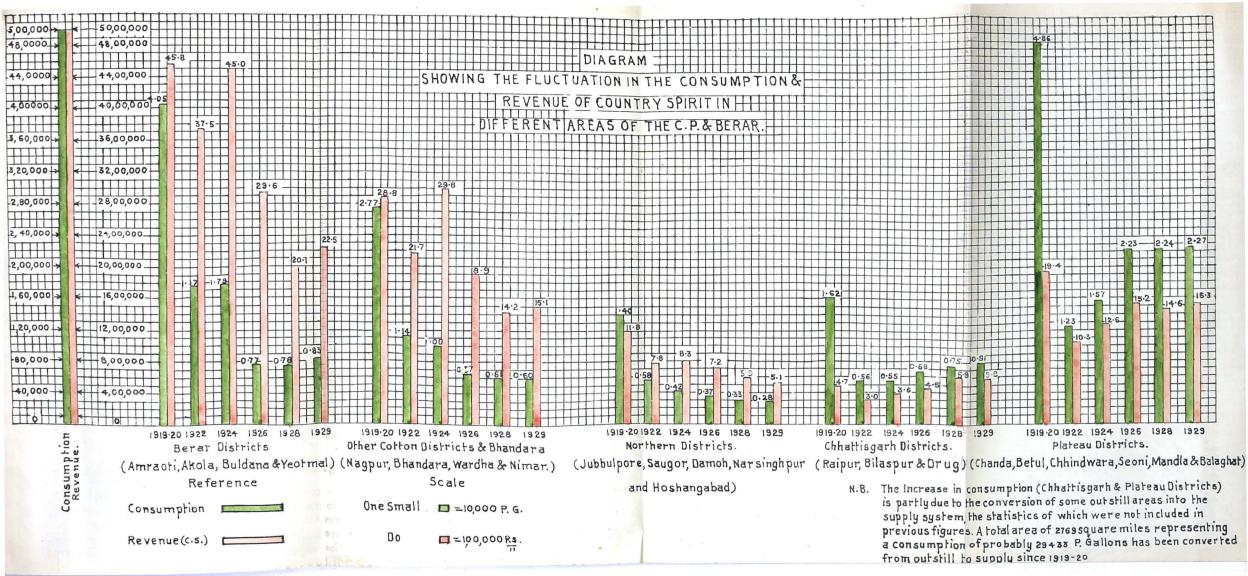

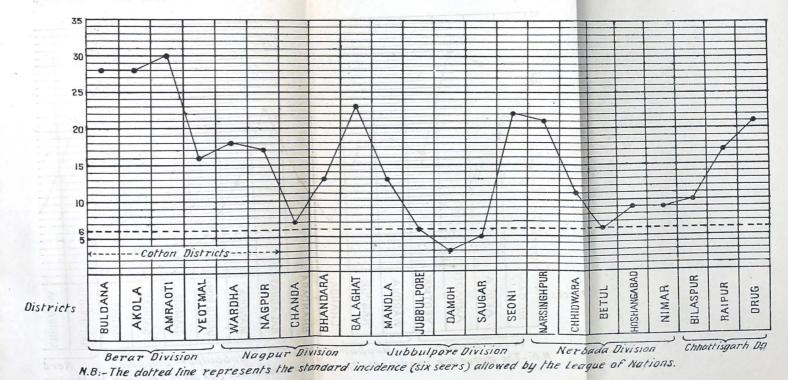

RESOLUTION.

The series of bad rabi crops in the northern districts continued in 1929 and, although the cotton crop was above normal, prices ruled low and the economic condition of the agricultural and labouring classes was not as satisfactory as it might be. There was moreover severe depression in the mining industry. A substantial fall in consumption of liquor and in excise revenue might therefore have been expected and would undoubtedly have occurred had it not been for the passing of the Child Marriage Restraint Act which was to come into force from 1st April 1930 which resulted in a much larger number of marriages and consequent demand for liquor. The net result was that the gross excise revenue rose from 122 lakhs in 1928 to 125 lakhs in 1929.

- 2. The total consumption of country spirit rose from 470,970 to 479,020 proof gallons but out of this 10,433 proof gallons were sold in the area newly brought under the contract supply system at the beginning of the year and, leaving this out of account, there was actually a small fall in consumption. There was also a satisfactory fall in the sales of opium and ganja of 1,455 and 3,201 seers respectively, which indicates that the high price of liquor is not driving people to take drugs in its place.
- 3. In pursuance of the restrictive policy of Government, 47 shops of country liquor, 16 of tari and 9 of foreign liquor were closed during the year and the issue

price of country spirit was further enhanced in 14 districts. The tari tree-tax was also raised from Rs. 6 to Rs. 7 in 4 out of the 7 districts in which it is in force. The price of both opium and ganja was enhanced by Rs. 5 per seer, and the number of retail vend shops reduced by 23 and 29 respectively. The working hours of opium and hemp drug shops which were from sunrise to 9 p.m. were curtailed to 10 a.m. to 9 p.m. in municipal areas and 10 a.m. to 8 p.m. in rural areas.

It is to be remembered, however, that as the measures taken by Government become more effective and the disparity between the cost of illicit production and that of the controlled articles becomes wider, the temptation to evade law increases while detection hecomes more difficult. Thus cases of illicit distillation rose from 1.455 to 1.676 or nearly four times the figure of 1919-20 and 15 per cent above that of 1928. Offences relating to opium and hemp drugs also rose by 7 per cent to 2,162. The large figure of fines imposed for these offences (Rs. 97,000) shows that the magistracy is alive to the necessity for dealing adequately with excise crime and the rapid increase in crime in spite of punishment indicates that coercion alone will not solve the problem unless it is supported by a strong temperance movement. Government expects the co-operation interested in the welfare of the province in promota genuine temperance movement and hopes that advantage will be taken of the offer of financial assistance to bona fide temperance associations. Government observes with regret that no attempt has yet been made in this direction and no temperance association has been formed although the scheme has been in force for over a year. A temperance movement to be effective must be directed against both licit and illicit liquor as well as drugs and can obviously be best promoted by close co-operation between Government and social workers operating in harmony for the common cause. The advocacy of prohibition or temperance undertaken as a political measure and directed mainly against licit liquor and not against illicit liquor and drugs also, however well intentioned, must fail in its object and any attempts to achieve prohibition by compulsion, whether such compulsion is applied by Government or by public organizations, are bound to be unsuccessful in the end. The policy followed by Government has undoubtedly made liquor and drugs more expensive and less accessible but much more rapid progress would be made towards the goal of prohibition if social reformers were to direct their energies to a proper organization of the temperance movement especially in the backward tracts of the province.

5. Mr. G. P. Burton was the Excise Commissioner up to the 12th January and Mr. G. C. F. Ramsden held the post from that date till the 20th October 1929 when Mr. C. F. Waterfall succeeded him and remained in charge till the end of the year under review. Government (Ministry of Excise) feels thankful to all these officers for their efficient administration of the department during the year. Government's appreciation is also due to Mr. McClenaghan for his interesting report.
