PREFACE.

The present fifth edition of the Bombay Code is based partly on the last edition edited and published by the Legislative Department of the Government of India and partly on the last edition of the supplementary volumes (containing Bombay Acts from 1923–1934), edited and published by the Legal Department of the Government of Bombay. It contains, with some exceptions, the unrepealed Bombay Regulations, the Local Acts of the Governor General in Council in force in the Province of Bombay, the Acts passed by the Governor of Bombay in Council, the Bombay Legislative Council and the Bombay Legislature.

- 2. The exceptions referred to above are—
- (a) certain enactments which are now only in force within narrow limits and which were excluded from the last edition of the Code;
- (b) the following Acts, which are of a purely personal character:—

3. This edition of the Code consists of six volumes, and like the earlier edition is divided into parts according to the class of enactments in each part. Volume I contains Part I, which reproduces unrepealed Bombay Regulations published in the last edition; and Part II which consists of unrepealed Local Acts of the Governor General in Council, now in force in the Province of Bombay. The other five volumes contain Parts III and IV which reproduce the Acts passed by the

local Council and the Bombay Legislature, respectively, from 1862 onwards. Volume II consists of the Acts passed during the years 1862 to 1887, Volume III those passed from 1888 to 1897, Volume IV those passed from 1898 to 1922, Volume V those passed from 1923 to 1930 and Volume VI those passed from 1931 to 1937.

- 4. Since its last publication in 1922 a large number of amending acts and new enactments have been passed by the Bombay Legislative Council. The Government of India (Adaptation of Indian Laws) Order, 1937, passed under section 293 of the Government of India Act, 1935, has made considerable changes in almost all the Acts and Regulations enacted prior to 1st April 1937. In publishing this edition, all Acts purely of an amending nature modifying the main Bombay Acts have been omitted except those which have modified the Acts of the Central Government.
- 5. In order to facilitate ready reference to all the changes carried out in any Act, a table has been inserted at the commencement of each Act setting out the number and years of all amending and repealing Acts. A chronological table of Acts and a short index are also appended to each of the volumes. The changes made by the Government of India (Adaptation of Indian Laws) Order, 1937, are referred to in the foot-notes as being made by the Adaptation of Indian Laws Order in Council.

All Acts are printed as modified up to 31st December 1937.

BOMBAY ACT No. I OF 1898.1

[3rd June, 1898]

An Act to supplement the provisions of the City of Bombay Municipal Act, 1888, with respect to the Investment of Sinking Funds and Surplus Moneys, and to validate certain Debentures.

Whereas it is expedient to supplement the provisions of the ² City of Bom. III Bombay Municipal Act, 1888, with respect to the investment in public of 1888. securities of sinking funds and surplus moneys of the Municipal Corporation of the City of Bombay; and whereas it is also expedient to remove doubts which have arisen with respect to the validity of certain debentures of the Corporation in which portions of their sinking funds and surplus moneys purport to have been heretofore invested, and to obviate the extinction of such debentures of the Corporation as have been, or may hereafter be, issued in or transferred to the name of the Corporation or to the name of the Municipal Commissioner for the City of Bombay on behalf of the Corporation in respect of any such investments;

It is hereby enacted as follows:-

- 1. This Act may be cited as the City of Bombay Municipal Investments Act, 1898.

- 4. All the several debentures of the Corporation heretofore issued, transferred, assigned or endorsed in the name of the Corporation or in the name of the Municipal Commissioner on behalf of the Corporation as specified in Schedule A, and all debentures heretofore issued by way of renewal, consolidation or sub-division of any of the said debentures shall be deemed to be and to have always been valid and negotiable in all respects and in the same manner as if the same had been issued against moneys borrowed from the Secretary of State or any other person.
- 5. The signature of the person for the time being holding the office of the Municipal Commissioner for the City of Bombay to a transfer of any debenture standing in the name of the Corporation or of the Municipal Commissioner on behalf of the Corporation shall be valid and sufficient, notwithstanding that such person may not have held the said office at the time when such debenture was issued, transferred, assigned or endorsed to the name of the Corporation or the Municipal Commissioner as aforesaid.

An Act for the better management of municipal affairs in mofussil towns and cities.

WHEREAS it is expedient to consolidate and amend the law relating to the management of municipal affairs in cities and towns in the Bombay Presidency other than the City of Bombay; It is enacted as follows:—

CHAPTER I.

PRELIMINARY.

Short title.

1. (1) This Act may be cited as the Bombay District Municipal Act, 1901.

Local extent.

(2) It extends to the whole of the Presidency of Bombay, except the ¹City of Bombay.

Commencement. (3) It shall come into force on the first day of April, 1901.

Repeal.

2. (1) The Bombay District Municipal Acts of 1873 and 1884 are Bom. hereby repealed:

Provided that-

Saving clause.

- (a) the said repeal shall not affect the validity or invalidity of anything already done under either of the said enactments;
- (b) all municipalities constituted, municipal commissioners appointed or elected, committees established, limits defined, appointments, rules, orders and by-laws made, notifications and notices issued, taxes and rates imposed, contracts entered into, and suits and other proceedings instituted, under the said Acts or under any enactments thereby repealed, shall, so far as may be, be deemed to have been respectively constituted, appointed, elected, established, defined, made, issued, imposed, entered into and instituted under this Act;
- (c) any enactment of the Governor of Bombay in Council, or document referring to any such repealed enactment, shall, so far as may be, be construed to refer to this Act or to the corresponding portion thereof.

 - (1) "City Municipality" shall mean any Municipality which

(a) is one of those specified in Schedule E, or

- (b) has been declared under sub-section (1) of section 181
- a City Municipality, and which has not ceased, under sub-section (2) of section 181, to be a City Municipality.
- (2) "Councillor" shall mean any person legally a member of a Municipality constituted under this Act.

or for any religious or charitable purposes, or who would so receive the rent if such land or building were let to a tenant: Provided that no person receiving the rent of any land or building as agent or trustee for another person, shall be liable to do anything by this Act required to be done by the owner of such land or building which may involve expenditure on the part of such owner, unless he have funds of, or due to, the owner sufficient to pay for the same; nor shall he be subject to any penalty for omitting to do such act, if he can prove that the default was occasioned by reason of his not having funds of, or due to, the owner sufficient to defray the expense of doing the act required.

- (9) "Salaried ¹[servant of the Crown]" shall not include a retired ¹[servant of the Crown] in receipt of a pension, or a person in receipt of a salary ²[from the Crown] who is not a full-time ¹[servant of the Crown].
- (10) "Official year" shall mean the year commencing on the first day of April.
- (11) "Annual letting value" shall mean the annual rent for which any building or land, exclusive of furniture or machinery contained or situated therein or thereon, might reasonably be expected to let from year to year.
- (12) "Street" shall mean any road, footway, square, court, alley, or passage, accessible whether permanently or temporarily to the public, whether a thoroughfare or not;

and shall include every vacant space, notwithstanding that it may be private property, and partly or wholly obstructed by any gate, post, chain or other barrier, if houses, shops or other buildings abut thereon, and if it is used by any persons as a means of access to or from any public place or thoroughfare, whether such persons be occupiers of such buildings or not, but shall not include any part of such space which the occupier of any such building has a right at all hours to prevent all other persons from using as aforesaid.

- (13) "Public street" shall mean any street-
 - (a) over which the public have a right of way, or
- (b) heretofore levelled, paved, metalled, channelled, sewered or repaired, out of municipal or other public funds, or
- (c) which under the provisions of section 90 is declared by the Municipality to be, or under any other provisions of this Act becomes a public street.

- (14) "Tax" shall include any toll, rate, cess, fee or other impost leviable under this Act.

- (16) "Dangerous disease" shall mean cholera, plague, small-pox, and any endemic, epidemic or infectious disease by which the life of man is endangered.

time to time, by a like notification, extend, contract or otherwise alter the limits of any municipal district, or declare that any local area shall, from a date to be specified in the notification, cease to be a municipal district.

Limits to be specified in notification. (2) Every such notification constituting a new municipal district, or altering the limits of an existing municipal district, shall clearly set forth the local limits of the area to be included in or excluded from such municipal district, as the case may be.

Erection and maintenance of boundarymarks. (3) It shall be the duty of the Municipality in every municipal district already existing, and of every Municipality newly constituted under this Act, and of every Municipality whose local limits are altered as aforesaid, to cause, at their own cost, to be erected or set up, if and when so required by the Collector, and thereafter to maintain, at their own cost, substantial boundary marks of such description and in such positions as shall be approved by the Collector, defining the limits or the altered limits of the municipal district subject to its authority, as set forth in the notification.

Property and rights of Municipality which has ceased to exist to vest in His Majesty. (4) When any local area ceases to be a Municipal district, the Municipality constituted therein shall cease to exist, and the property and rights vested in any such Municipality shall, subject to all charges and liabilities affecting the same, vest in His Majesty, and the proceeds thereof, if any, shall be expended under the orders of the ¹[Provincial Government] for the benefit of the local areas in which such Municipality had jurisdiction.

Municipal districts to be periodical or permanent. 5. Municipal districts constituted under section 4 may be either periodical or permanent.

What local 'areas may be declared to be periodical municipal districts.

6. Any local area in which a periodical fair is held or which is visited periodically by pilgrims, together with any neighbouring local area to which the people attending such fair or the pilgrims resort whilst such fair or pilgrimage lasts, may be declared a periodical municipal district at and throughout certain specified recurring seasons.

What local areas may be declared to be permanent municipal districts.

- 7. (1) Any local area which comprises—
- (a) a city, town or station, or two or more neighbouring cities, towns and stations, with or without any village, suburb, or land adjoining thereto, or
- (b) a village or suburb or two or more neighbouring villages and suburbs,

may be declared a permanent municipal district: Provided that, except—

(a) in the case of hill-stations, or

- (ii) to constitute any municipal district in any area of which the population is less than two thousand.

(1) Not less than two months before the publication of any Permanent notification declaring any local area a permanent municipal district, or municipal altering the limits of any such district, or declaring that any local area shall cease to be a municipal district, the 1[Provincial Government] shall cause to be published in the 2[Official Gazette], in English, and in at least one of the local newspapers, if any, in the language of the district in which such local area is situated, and to be posted up in conspicuous spots in the said local area in the language of the said district, a ³proclamation announcing that it is proposed to constitute such local area a municipal district, or to alter the limits of the municipal district in a certain manner, or to declare that such local area shall cease to be a municipal district, as the case may be, and requiring all persons who entertain any objection to the said proposal to submit the same, with the reasons therefor, in writing to the Collector within two months from the date of the said proclamation, and whenever it is proposed to add to or exclude from a municipal district any inhabited area, it shall be the duty of the Municipality also to cause a copy of such proclamation to be posted up in conspicuous places in such area.

- (2) The Collector shall, with all reasonable despatch, forward every objection so submitted to 'the Provincial Government'.

Constitution ation of Municipalities.

9. In every municipal district there shall be a Municipality, and every and incorpor- such Municipality shall be a body corporate by the name of "The Municipality of—", and shall have perpetual succession and a common seal, and may sue and be sued in their corporate name.

Municipalities to consist of elected and nominated councillors.

- 10. (1) Except as is hereinafter otherwise provided, every such Municipality shall consist of—
 - (a) elected councillors;
 - (b) nominated councillors, if any, that is to say, such persons, as from time to time,
 - (i) are by name appointed in this behalf by, or
 - (ii) are executing the functions of any office from time to time notified in this behalf by the Commissioner:

In specified proportions.

Provided that the number of elected councillors shall be not less than one-half of the whole number, inclusive of the president, and that not more than one-half of the nominated councillors shall be salaried ¹[servants of the Crown].

Failure to elect.

(2) Any vacancies due to failure to elect the full number of elected councillors which under this section might be elected, may, notwithstanding anything in this Act contained, be filled up by nomination by the Commissioner.

The Provincial Governe ment may determine number of councillors: fix proportion ο£ elected and nominated councillors and make rules for regulating elections. -

(2) every person who for the like period has paid the qualifying tax, shall be qualified to be entered in the list of voters for such district; and he shall also be qualified as a candidate if he has been resident for the like period in such district or within seven miles of the limits thereof.

Explanation 1.—For the purposes of this section a person shall be deemed to be resident in or within seven miles of the limits of a municipal district if he ordinarily resides or has his principal place of residence in or within seven miles of the limits of such district.

Explanation 2.—For the purposes of this section 'the qualifying tax' means a tax, other than octroi, toll and the tax on vehicles and animals plying for hire or kept for the purpose of being let for hire, imposed in a municipal district, of an amount not less than such minimum as shall for the time being be fixed for such district by the '[Provincial Government] in the case of City Municipalities and by the Commissioner in other cases.]

Operation of lists.

13. (1) When, in accordance with rules framed under sub-clauses (iii) and (iv) of clause (c) ²[of sub-section (1)] of section 11, a list of voters has been prepared or, upon a general revision, completed, a copy thereof signed by such person as may be designated in this behalf in the rules aforesaid, shall be the Municipal Election Roll. A new Election Roll shall be published in each year on such date as may be prescribed by the rules, and shall continue in operation for a period of twelve months from that day:

Provided that if a new Election Roll is not published in any year before the date prescribed, the roll then in operation shall continue in operation until the new roll is published.

(2) At every election of councillors every person enrolled in the Municipal Election Roll as for the time being in operation under sub-section (1) shall be deemed to be entitled to vote, and every person not so enrolled shall be deemed to be not entitled to vote.

Powers of Judge holding inquiry.

- (2) ¹[An inquiry shall thereupon be held by a Judge, not below the grade of an Assistant Judge, appointed by the ²[Provincial Government] either specially for the case or for such cases generally, and such Judge] may, after such inquiry as he deems necessary, and subject to the provisions of sub-section (3), pass an order confirming or amending the declared result of the election, or setting the election aside. For the purposes of the said inquiry the said Judge may summon and enforce the attendance of witnesses, and compel them to give evidence as if he were a Civil Court, and he may also direct by whom the whole or any part of the costs of any such inquiry shall be paid, and such costs shall be recoverable as if they had been awarded in a suit under the Code of Civil Procedure. The decision or order shall be conclusive. If he sets aside an election, a date shall forthwith be fixed and the necessary steps taken for holding a fresh one.

Corrupt practices: criminal offences and procedure.

(1) (a) Whoever in any election under this Act, directly or indirectly, by himself or by any other person on his behalf, shall, with a view to inducing any voter to give or to refrain from giving a vote in favour of any candidate, offer or give any money or valuable consideration or hold out any promise of individual profit or hold out any threat of injury to any person, and
- (b) whoever shall give, procure, or abet the giving of a vote in the name of a voter, who is not the person giving such vote,

shall be liable to a fine not exceeding two hundred rupees for every such offence.

(2) Whoever, being qualified to vote at any election under this Act or claiming to be so qualified, accepts or obtains or agrees to accept or attempts to obtain for himself or for any other person any money or valuable consideration or any individual profit as a motive or reward for giving or forbearing to give his vote in any such election shall be liable to a fine not exceeding one hundred rupees for every such offence.

Explanation.—In sub-section (1) and sub-section (2) "individual profit" includes a benefit accruing to the person himself or to any one in whom he is interested. It does not include a promise to vote for or against any measure which may come before a Municipality for consideration.

- (3) Every person convicted under sub-section (1) or sub-section (2) shall; for such period not exceeding seven years from the date of the conviction as the Court may direct, be disqualified from voting at any municipal election or at any election to a local board constituted under the ³Bombay Local Boards Act, 1884, and from being a councillor in any Bom municipal district or a member of any such local board.

- (b) watch over the financial and executive administration of the Municipality, and, subject to the rules of the Municipality at the time being in force, to perform such executive functions as may be performed by or on behalf of the Municipality over which he presides;
- (c) exercise supervision and control over the acts and proceedings of all officers and servants of the Municipality in matters of executive administration and in matters concerning the accounts and records of the Municipality; and, subject to the rules of the Municipality at the time being in force, to dispose of all questions relating to the service of the said officers and servants, and their pay, privileges and allowances;
- (d) furnish to the Collector, or to such other officer as the Collector shall from time to time nominate in this behalf, a copy of every resolution passed at any meeting of the Municipality and any extract from the minutes of the proceedings of the Municipality or of any committee or other document or thing which the Collector from time to time calls for under section 173:

CHAPTER III.

CONDUCT OF BUSINESS.

- (1) Municipal meetings.
- 26. The following provisions shall be observed with respect to the Provisions in regard to meetings of a Municipality:meetings of a Munici-
 - (1) Except in periodical Municipalities and in Municipalities at Ordinary hill-stations, there shall be held four ordinary general meetings in each ings. year for the disposal of general business, on or about the tenth day of the months of January, April, July and October, respectively, and such other ordinary general meetings as the president may find necessary. In Municipalities at hill-stations there shall be held one ordinary general meeting on or about the tenth day of April, and not less than one other ordinary general meeting for the purpose aforesaid, in each year. In every periodical Municipality there shall be such and so many ordinary general meetings, as the president thereof shall from time to time determine. It shall be the duty of the president to fix the dates for all ordinary general meetings,

- (2) The president may, whenever he thinks fit, and shall, upon Special genethe written request of not less than one-fourth of the councillors, ral meetings. call a special general meeting.
- (3) Seven clear days' notice of an ordinary general meeting, and Notice to be three clear days' notice of a special general meeting, specifying the given of meetings. time and place at which such meeting is to be held and the business to be transacted thereat shall be circulated to the councillors, and posted up at the municipal office or the local kacheri or some other public building in the municipal district. The said notice shall include any motion or proposition which a councillor shall have given written notice not less than ten days previous to the meeting of his intention to bring forward thereat, and, in the case of a special general meeting, any motion or proposition mentioned in any written request made for such meeting.

Municipal meetings to be held at municipal office. (4) Every meeting of a Municipality shall, except for reasons to be specified in the notice convening the meeting, be held in the building used as a municipal office by such Municipality.

Every meeting how presided over in the absence of the president and the vice-president.

Meeting must ordinarily be open to the public.

- (5) Every meeting shall, in the absence of both the president and vice-president, be presided over by such one of the councillors present as may be chosen by the meeting to be chairman for the occasion, and such chairman shall exercise thereat the powers vested in the president by clause (a) of sub-section (I) of section 24.
- (6) Every meeting shall be open to the public unless the presiding authority deems any inquiry or deliberation pending before the Municipality such as should be held in private, and provided that the said authority may at any time cause any person to be removed who interrupts the proceedings.

Number of councillors required to form a quorum.

(7) If in a City Municipality less than one-third, and in any other Municipality less than one-half, of the whole number of councillors be present at a meeting at any time from the beginning to the end thereof, the presiding authority shall adjourn the meeting to such hour on the following or some other future day as he may reasonably fix, and a notice of such adjournment shall be fixed up in the municipal office, and the business which would have been brought before the original meeting, had there been a quorum thereat, shall be brought before the adjourned meeting and may be disposed of at such meeting or at any subsequent adjournment thereof whether there be a quorum present or not.

What business to be transacted at meetings and order of business how to be settled.

(8) Except with the permission of the presiding authority, which permission shall not be given in the case of a motion or proposition to modify or cancel any resolution within three months after the passing thereof, no business shall be transacted and no proposition shall be discussed at any general meeting unless it has been mentioned in the notice convening such meeting or, in the case of a special general meeting, in the written request for such meeting. The order in which any business that may be transacted or any proposition that may be discussed at any meeting in accordance with this sub-section, shall be brought forward at such meeting, shall be determined by the presiding authority, who in case it is proposed by any member to give priority to any particular item of such business, or to any particular proposition shall put the proposal to the meeting and be guided by the majority of votes given for or against the proposal.

Minutes of proceedings to be kept.

(9) In every City Municipality there shall be kept in English, and, if the Municipality so resolve, in the vernacular language also, and in every other Municipality there shall be kept in the vernacular language, and if the Municipality so resolve in English, either in lieu of or in addition to the vernacular, minutes of the names of the

councillors and of the ¹[servants of the Crown], if any, present under the provisions of sub-section (14), and of the proceedings at each general meeting, in a book to be provided for this purpose, which shall be signed, as soon as practicable, by the presiding authority of such meeting, and shall at all reasonable times be open to inspection by any inhabitant of the municipal district.

(b) If it shall appear to a Municipality that the presence of the Executive Engineer, Educational Inspector, Deputy Sanitary Commissioner or Civil Surgeon of or in the district, is desirable for the purpose aforesaid at any future meeting of such Municipality, it shall be competent to such Municipality, by letter addressed to such officer not less than fifteen days previous to the intended meeting, to require his presence thereat; and the said officer unless prevented by sickness, or other reasonable cause, shall be bound to attend such meeting:

(7) The provisions of sections 170, 171 and 172 shall, so far as may be, apply to the Pilgrim Fund Account and the Pilgrim Committee shall, with respect to the preparation and submission to the municipality of its annual budget, follow the following procedure, namely:—

- "The Pilgrim Committee shall in sufficient time submit its annual budget and all alterations therein to the municipality for consideration, and, if the municipality agree to it, for its incorporation in the general municipal budget. If the municipality do not agree to the budget as framed by the Pilgrim Committee, they shall return it to the Pilgrim Committee, for reconsideration, either in whole or in part, together with any alterations which they may recommend, and if the Pilgrim Committee agrees to these alterations, the budget so altered shall be incorporated in the general municipal budget. If the municipality and the Pilgrim Committee fail to reach an agreement, the budget with a statement of the points in dispute shall be referred by the municipality to the Commissioner, whose decision on such points shall be final."
- (8) The provisions of sections 173, 174, 175, 178 and 179 shall apply to a Pilgrim Committee, and in their application to a Pilgrim Committee the said sections shall be construed, so far as may be, as if for the word 'municipality' occurring in the said sections the words 'Pilgrim Committee' were substituted, and as if the words "other than a city municipality in such taluka" occurring in sub-section (2) of section 173 were omitted.]

School committees.

28. The Municipality may appoint, subject to such limitations as are prescribed by the rules for the time being in force under section 46 and subject also to the proviso contained in ¹[section 58], a committee consisting of such councillors as they think fit, for managing all or any primary or other schools vested in or maintained by the Municipality, or for conducting the business of the Municipality in respect of any educational institutions aided by the Municipality.

Other executive committees. 29. Subject to the limitations prescribed by the rules aforesaid, the Municipality may appoint, for a period not exceeding one year, any such committee or such or so many committees consisting of such councillors as they think fit for any purpose or respectively for any of the purposes, other than those specified in section 28, for which a managing committee may, under section 27, exercise the powers of a Municipality, and may invest each committee so appointed with such of the said powers as may be necessary or expedient for the fulfilment of the purpose for which it is appointed ²[not being, where a Pilgrim Committee is appointed, powers or duties referred to in section 27A];

Notwithstanding anything contained in this Act, it shall be lawful When perfor the Municipality from time to time, by a resolution supported by sons other than counnot less than one-half of the whole number of councillors, to appoint, as cillors may members of any committee under section 28, 29 or 30, any persons of serve on either sex, who are not councillors, but who may in the opinion of such Municipality possess special qualifications for serving on such committee: provided that the number of persons so appointed on any committee shall not exceed one-third of the total number of the members of such committee.

(1) Notwithstanding anything contained in the preceding section the chairman of the committee, whenever it appears to him unnecessary to convene a meeting, may, instead of so doing, circulate a written proposition of his own, or of any other member of the committee, or of any executive officer of the Municipality, for the observations and votes of the members of the committee.

(1) No disqualification of, or defect in the election or appointment of, any person acting as councillor, or as the president or presiding authority of a general meeting or as chairman of a committee appointed under this Act, shall be deemed to vitiate any act or proceeding of the Municipality or of any such committee, as the case may be, in which cations, etc., such person has taken part, whenever the majority of persons, parties to such act or proceeding, were entitled to act.

Proceedings of meetings to be good and valid, until the contrary is proved.

(2) Until the contrary is proved, every meeting of the Municipality, or of a committee appointed under this Act, in respect of the proceedings whereof a minute has been made and signed in accordance with this Act, shall be deemed to have been duly convened and held, and all the members of the meeting shall be deemed to have been duly qualified; and where the proceedings are the proceedings of a committee, such committee shall be deemed to have been duly constituted and to have had the power to deal with the matters referred to in the minute.

Vacancy not to affect Municipality's proceedings.

(3) During any vacancy in a Municipality or committee the continuing councillors or members may act as if no vacancy had occurred.

(5) Joint transactions with other bodies.

Joint committees of two or more Municipalities or other local bodies.

39. A Municipality may from time to time—

Discretionary power to make rules.

¹[46-A. Power to suspend, reduce or abolish any existing tax. 47. Subject to the requirements of clause (a) of the proviso to section 46, every Municipality may, except as otherwise provided in clause (b) of the proviso to section 74, at any time for any sufficient reason, suspend, reduce or abolish any existing tax by suspending, altering or rescinding any rule prescribing such tax under the provisions of clause (i) and of the first clause of the proviso to section 46.

Power to make by-laws:

48. (1) Every Municipality may from time to time, with the previous sanction, in the case of City Municipalities, of the ³[Provincial Government] or in other cases of the Commissioner, make, alter or rescind by-laws, but not so as to render them inconsistent with this act,

for markets and slaughterhouses, etc., etc.; (a) for the regulation and inspection of markets and slaughter-houses and all places used by or for animals which are for sale or hire, or the produce of which is sold, and for the proper and cleanly conduct of business therein; and for fixing the rents and other charges to be levied, for the use of any of them which belong to the Municipality;

- (b) prescribing the conditions on or subject to which, and the circumstances in which, and the areas or localities in respect of which, licenses may be granted, refused, suspended or withdrawn for the use of any place not belonging to the Municipality,
 - (i) as a slaughter-house,
 - (ii) as a market or shop for the sale of animals intended for human food, or of meat, or of fish, or as a market for the sale of fruit or vegetables,
 - (iii) for any of the purposes mentioned in sub-section (1) of section 151,

and providing for the inspection and regulation of the conduct of business in any place used as aforesaid, so as to secure cleanliness therein or to minimise any injurious, offensive or dangerous effect arising or likely to arise therefrom;

- (h) for enforcing the supply of information as to any cases of dangerous disease, and carrying out the provisions of sections 144 and 145;
- (i) for enforcing the supply of such information by inhabitants of the municipal district as may be necessary to ascertain their respective liabilities to any tax imposed therein;

octroi bylaws ; (j) fixing octroi limits and stations; providing for the exhibition of tables of octroi; regulating, subject to any general or special orders which the ¹[Provincial Government] may make in this behalf, the system under which refunds are to be made on account thereof when the animals or goods on which the octroi has been paid, or articles manufactured wholly or in part from such animals or goods, are again exported, and the custody or storage of animals or goods declared not to be intended for use or consumption within the municipal district; and prescribing a period of limitation after which no claim for refund of octroi shall be entertained, and the minimum amount for which any claim to refund may be made;

(k) for conserving and preventing injury to sources and means of water-supply and appliances for the distribution of water, whether within or without the limits of the municipal district; and regulating all matters and things connected with the supply and use of water and the turning on or turning off and preventing the waste of water, and the construction, maintenance and control of municipal water-works, and of pipes and fittings in connection therewith, whether the property of the Municipality or not;

regulating public baths, etc., (1) regulating the use of public bathing and washing places within municipal limits;

for conservancy. (m) regulating sanitation and conservancy and the disposal of carcasses of dead animals;

regulating structures and buildings; (n) regulating the conditions on which permission may be given for the temporary occupation of, or the erection of temporary structures on, public streets or for projections over public streets and regulating the structure and dimensions of plinths, walls, foundations, roofs and chimneys of new buildings for the purpose of securing stability and the prevention of fires, and for purposes of health;

Publication of drafts of proposed by-laws.

(2) Every Municipality shall, before making any by-law under this section, publish in such manner as shall in their opinion be sufficient, for the information of the persons likely to be affected thereby, a draft of the proposed by-law, together with a notice specifying a date on or after which the draft will be taken into consideration, and shall, before making the by-law receive and consider any objection or suggestion with respect to the draft which may be made in writing by any person before the date so specified.

Objections and suggestions to be submitted to Central Government, Provincial Government or Commissioner as the case may be.

(3) When any by-law made by a Municipality is submitted to the ²[Central Government], ³[Provincial Government] or Commissioner for sanction, a copy of the notice published as aforesaid, and of every objection or suggestion so made, shall be submitted for the information of the ²[Central Government], ³[Provincial Government] or Commissioner along with the said by-law.

Rules and by-laws to be printed and sold.

49. The rules and by-laws for the time being in force shall be kept open for public inspection at the municipal office at all reasonable times, and printed copies thereof and of this Act in the vernacular language of the district, and in City Municipalities in English as well as in the vernacular, shall be kept on sale at cost price.

CHAPTER V.

MUNICIPAL PROPERTY AND FUND.

Power to acquire and hold property. 50. (1) Every Municipality may acquire and hold property both moveable and immoveable, whether within or without the limits of the municipal district.

Property vested in the Municipality. (2) All property of the nature hereinafter in this section specified, and not being specially reserved by the ³[Provincial Government] shall be vested in and belong to the Municipality, and shall, together with all other property, of what nature or kind soever, not being specially reserved by the ³[Provincial Government], which may become vested in the

Municipality, be under their direction, management and control, and shall be held and applied by them as trustees, subject to the provisions and for the purposes of this Act; that is to say-

- (a) All public town-walls, gates, markets, slaughter-houses, manure and night-soil depots, and public buildings of every description.
- (b) All public streams, tanks, reservoirs, cisterns, wells, springs aqueducts, conduits, tunnels, pipes, pumps and other water-works, and all bridges, buildings, engines, works, materials and things connected therewith or appertaining thereto, and also any adjacent land (not being private property) appertaining to any public tank
- (c) All public sewers and drains, and all sewers, drains, tunnels, culverts, gutters and water-courses in, alongside or under any streets. and all works, materials and things appertaining thereto, as also all dust, dirt, dung, ashes, refuse, animal matter, or filth, or rubbish of any kind collected by the Municipality from the streets, houses, privies, sewers, cesspools or elsewhere.
- (d) All public lamps, lamp-posts, and apparatus connected therewith, or appertaining thereto.
- (e) All lands transferred to them by the [Crown], or by gift or otherwise, for local public purposes.
- (f) All public streets, and the pavements, stones and other materials thereof, and also all trees, erections, materials, implements and things provided for such streets.

51. All moneys received by or on behalf of the Municipality by virtue of this or any other Act; all taxes, tolls and other imposts, fines, fees. penalties paid to or levied by them under this Act 3 other than fines imposed by a Court]; all proceeds of land or other property sold by the Municipality, and all rents accruing from their land or property; as also all interest, profits and other moneys accruing by gifts or transfers from the 4[Crown] or private individuals or otherwise, shall constitute the municipal fund, and shall be held and dealt with in a similar manner to the property mentioned in ⁵[section 50]:

Provided that—

Provision as to special trusts.

(a) nothing in this section, or in ⁵[section 50], shall in any way affect any obligations accepted by or imposed upon any Municipality by any declarations of trust executed by or on behalf of such Munici-VI of pality, or by any scheme settled under the 6Charitable Endowments 1890. When special trusts may be created.

(b) a Municipality may, subject to the condition that reasonable provision shall be made for the performance of all obligations imposed or that may be imposed on them by section 54, 55 or by or under section 61, or 72, or Chapter XII, credit to a separate heading in the municipal accounts any portion of the municipal fund received by them specially for, or devoted by them to, the purposes of schools or dispensaries or of water-works or fire-brigades, or other such purposes as the Commissioner in this behalf approves, and, provided that there shall be credited to such special heading such sums only as expressly relate to the object for which the fund designated by such heading was created, the Municipality may apply the sums so credited exclusively to the respective objects to which they are so credited.

- ¹(c) (I) Every municipality in a municipal district in which a tax on pilgrims resorting periodically to a shrine within the limits of the municipal district is levied shall, subject to the condition that reasonable provision shall be made for the purposes specified in clause (2), credit the proceeds of the said tax to a separate heading in the municipal account, to be called the 'Pilgrim Fund Account'.

- (b) to make a contribution towards expenditure incurred by any other Municipality, or in any area subject to the authority of a local board or cantonment authority, or Sanitary Board or Committee, or of a Committee appointed under section 188 for an area notified under section 187, or incurred out of any public funds for measures affecting the health, instruction or convenience of the public and calculated to benefit the residents within the limits of the contributing Municipality; or
- (c) to create scholarships tenable outside the limits of the municipal district:

Provided, further, that nothing in this section, or in any other provision of this Act, shall be deemed to make it unlawful for a Municipality when with such sanction as aforesaid they have constructed works beyond the limits of the said district for the supply of water or for drainage as aforesaid,

- (a) to supply or extend to, or for the benefit of, any person or buildings or lands in any place 1* * * *, whether such place is or is not within the limits of the said district, any quantity of water not required for the purposes of this Act within the said district, or the advantages afforded by the system of such drainage-works, on such terms and conditions, with regard to payment and to the continuance of such supply or advantages, as shall be settled by agreement between the Municipality and such person or the occupier or owner of such buildings or lands, or
- (b) to incur any expenditure, on such terms with regard to payment as may be settled as aforesaid, for the construction, maintenance, repair or alteration of any connection pipes, or other works necessary for the purpose of such supply or for the extension of such advantages.
- 53. (1) It shall be lawful for the Municipality to deposit ^{2*} ** with the ³[Imperial Bank of India], or such other bank as may hereafter be appointed to conduct the business of His Majesty's Treasury at Bombay, or with the sanction of the ⁴ [Provincial Government] in any bank in the Presidency of Bombay, any surplus funds in their hands which may not be required for current charges, and to invest such funds in public securities in the name of the Municipality, and from time to time to dispose of such securities as may be necessary.

CHAPTER VI.

OBLIGATORY AND DISCRETIONAL FUNCTIONS OF MUNICIPALITIES.

- 54. It shall be the duty of every Municipality to make reasonable Duties of Municipaprovision, lities.
 - (1) for the following matters within the municipal district under their authority, namely:
 - (a) lighting public streets, places and buildings;
 - (b) watering public streets and places;
 - (c) cleansing public streets, places and sewers, and all spaces not being private property, which are open to the enjoyment of the public, whether such spaces are vested in the Municipality or not; removing noxious vegetation; and abating all public nuisances;
 - (d) extinguishing fires, and protecting life and property when fires occur;
 - (e) regulating or abating offensive or dangerous trades or practices;
 - (f) removing obstructions and projections in public streets or places, and in spaces not being private property, which are open to the enjoyment of the public, whether such spaces are vested in the Municipality or belong to His Majesty;
 - (g) securing or removing dangerous buildings or places, and reclaiming unhealthy localities;
 - (h) acquiring and maintaining, changing and regulating places for the disposal of the dead;
 - (i) constructing, altering and maintaining public streets, culverts, municipal boundary-marks, markets, slaughter-houses, latrines, privies, urinals, drains, sewers, drainage-works, sewerage works, baths, washing places, drinking fountains, tanks, wells, dams and the like;
 - (j) obtaining a supply or an additional supply of water, proper and sufficient for preventing danger to the health of the inhabitants from the insufficiency or unwholesomeness of the existing supply when such supply or additional supply can be obtained at a reasonable cost;

- (k) naming streets and numbering houses;
- (1) registering births and deaths;
- (m) public vaccination;
- (n) suitable accommodation for any calves, cows or buffaloes required within the municipal district for the supply of animal lymph;
- (o) establishing and maintaining public hospitals and dispensaries and providing public medical relief;
- (p) establishing and maintaining primary schools;
- (q) printing such annual reports on the municipal administration of the district as the '[Provincial Government] by general or special orders requires the Municipality to submit;
- (r) paying the salary and the contingent expenditure on account of such police or guards as may be required by the Municipality for the purposes of this Act or for the protection of any municipal property ^{2**},

and subject to such reasonable provision as aforesaid,

- (2) for the following special matters, namely:
- (a) providing special medical aid and accommodation for the sick in time of dangerous disease; and taking such measures as may be required to prevent the outbreak of, or to suppress and prevent the recurrence of the disease;
- (b) giving relief and establishing and maintaining relief works in time of famine or scarcity to or for destitute persons within the limits of the municipal district.

Provision for lunatics and lepers.

- 55. Every Municipality shall also, out of the municipal property and fund, make payments at such rates as the ¹[Provincial Government] from time to time by general or special orders prescribes, for the maintenance and treatment either in the municipal district or at any asylum, hospital or house, whether within or without such district, which the ¹[Provincial Government] declares by notification to be suitable for such purpose,

²[Provided that where an application is made to the High Court or a District Court under the provisions of section 88 of the Indian Lunacy IV of Act, 1912, no order for the payment of the cost of maintenance of the lunatic by a municipality shall be made without an opportunity being given to such municipality to show that the lunatic has an estate applicable to his maintenance or that there is a person legally bound, and having the means, to maintain him:

- (b) constructing, establishing or maintaining public parks, gardens, libraries, museums, lunatic asylums, halls, offices, dharamshalas, rest-houses and other public buildings;
- (c) furthering educational objects other than those set forth in subclause (ν) of ³[section 54];
 - (d) planting and maintaining roadside and other trees;
- (e) taking a census, and granting rewards for information which may tend to secure the correct registration of vital statistics;
 - (f) making a survey;
- (g) the salaries and allowances, rent and other charges incidental to the maintenance of the Court of any stipendiary or Honorary Magistrate, or any portion of any such charges;

(h) arrangements for the destruction or the detention and preservation of such dogs within the municipal district as may be dealt with Bom. under section 49 of the Bombay District Police Act, 1890:

1890.

- (i) securing or assisting to secure suitable places for the carrying on of the offensive trades mentioned in sub-section (1) of section 151:
- (i) supplying, constructing and maintaining, in accordance with a general system approved by the Sanitary Board, receptacles, fittings, pipes and other appliances whatsoever, on or for the use of private premises, for receiving and conducting the sewage thereof into sewers under the control of the Municipality:
- (k) establishing and maintaining a farm or factory for the disposal of sewage;
- (1) any other measure not specified in section 54 likely to promote the public safety, health, convenience or education; and
- (m) with the previous concurrence 1* * * of the Collector, any public reception, ceremony, entertainment or exhibition within the municipal district.

Arrangement purporting to be binding permanently or for a term of years.

57. When a Municipality have entered into any arrangement or made any promise, purporting to bind themselves or their successors, for a term of years or for an unlimited period, to continue to any educational or charitable institution a yearly contribution from the municipal property or fund, it shall be lawful for the Municipality or their successors, with the sanction in the case of a City Municipality of the 2[Provincial Government], and in the case of any other Municipality of the Commissioner, to cancel such arrangement or promise, or to discontinue or to diminish such yearly contribution, provided that they shall have given at least twelve months' notice of their intention so to do to the manager or managers of such institution.

Management of public institutions maintained by Municipalities to vest in them.

58. The management, control and administration of every public institution exclusively maintained out of municipal property and funds shall vest in the Municipality by which it is maintained:

Provided that the extent of the independent authority of any Municipality in respect of public education and their relations with the ³[Educa; tional Department of the Provincial Government] shall from time to time be prescribed by the '[Provincial Government].

CHAPTER VII.

MUNICIPAL TAXATION.

(1) Imposition of Taxes.

- 59. Subject to any general or special orders which the ¹[Provincial Taxes Government] may make in this behalf, any Municipality which may be imposed.
 - (a) after observing the preliminary procedure required by ²[section 60] and
 - (b) with the sanction of the ¹[Provincial Government] in the case of City Municipalities, and in other cases of the Commissioner, and subject to such modifications or conditions as under section 61 the ¹[Provincial Government] or the Commissioner, respectively, in according such sanction, deems fit,

may impose, for the purposes of this Act, any of the following taxes: that is to say,

- (i) a rate on buildings or lands or both, situate within the municipal district;
- (ii) a tax on all or any vehicles, boats, or animals used for riding, draught or burden, kept for use within the said district;
- (iii) a toll on vehicles, ³[(other than motor vehicles or trailers save as provided in section 14 of the Bombay Motor Vehicles Tax Act, 1935)] and animals used as aforesaid, entering the said district, but not liable to taxation under the clause last preceding;
 - (iv) an octroi on animals or goods, or both, brought within the octroi limits for consumption or use therein;
 - (v) a tax on dogs kept within the said district;
 - (vi) a special sanitary cess upon private latrines, premises or compounds cleansed by municipal agency, after notice given as hereinafter required;

- (vii) a general sanitary cess for the construction or maintenance, or both construction and maintenance, of public latrines, and for the removal and disposal of refuse;
- (viii) a water-rate or water-rates, for water supplied by the Municipality, which may be imposed in the form of a rate assessed on buildings and lands, or in any other form, including that of charges for such supply, fixed in such mode or modes as shall be best adapted to the varying circumstances of any class of ¹[cases] or of any individual case;
 - (ix) a lighting tax;
- (x) a tax on pilgrims resorting periodically to a shrine within the limits of the municipal district;

Provided that

- (a) no tax imposed as aforesaid, other than a special sanitary cess or a water-rate, shall, without the express consent of ⁴[the Provincial Government], be leviable in respect of any building or part of any building, or of any vehicle, animal or other property, belonging to His Majesty and used solely for public purposes, and not used or intended to be used for purposes of profit, and no toll shall be leviable for the passage of troops or the conveyance of ⁵[Crown stores] or of any other ⁶[Crown property], or for the passage of Military or Police-officers on duty, or the passage or conveyance of any person or property in their custody;

- (ii) issued either severally to the persons to be charged, or generally to the inhabitants of the district or part of the district to be charged, with such cess, one month's notice of the intention of the Municipality to perform such cleansing and to levy such cess;
- (c) the Municipality in lieu of imposing separately any two or more of the taxes described in clauses (i), (vii), (viii) and (ix) 1* * may impose a consolidated tax assessed as a rate on buildings or lands, or both situate within the municipal district.
- ²(2) Nothing in this section shall authorise the imposition of any tax which the Provincial Legislature has no power to impose in the Province under the Government of India Act, 1935:

Provided that a municipality which immediately before the commencement of Part III of the said Act was lawfully levying any such tax under this section as then in force, may continue to levy that tax until provision to the contrary is made by the Central Legislature.]

- 60. Every Municipality before imposing a tax shall observe the Procedure following preliminary procedure: of Municipality
 - (a) They shall, by resolution passed at a general meeting,

preliminary to imposing (i) select for the purpose one or other of the taxes specified in tax.

- section 59;
- (ii) prepare rules for the purposes of clause (i) of section 46 prescribing the tax selected;
- and shall by such resolution and in such rules specify
- (iii) the class or classes of persons or of property, or of both. which the Municipality desire to make liable, and any exemptions which they desire to make;
- (iv) the amount for which, or the rate at which, it is desired to make such classes liable;
- (v) all other matters, which the 3[Provincial Government] may so require to be specified.
- (b) When such resolution has been passed, the Municipality shall publish the form of rules so prepared with a notice in the form of Schedule A prefixed thereto.
- (c) Any inhabitant of the municipal district objecting to the imposition of the said tax, or to the amount or rate proposed, or to the

class of persons or property to be made liable hereto, or to any exemptions proposed, may within one month from the publication of the said notice send his objection in writing to the Municipality, and the Municipality shall take all such objections into consideration, or shall authorize a committee to consider the same and report thereon, and, unless they decide to abandon or to modify the proposed tax in accordance with such objections, shall submit the same with their opinion thereon, together with the notice and rules aforesaid, in the case of a City Municipality, to the '[Provincial Government] and in the case of any other Municipality to the Commissioner.

Power to sanction, modify and impose conditions.

- 61. The ¹[Provincial Government], or the Commissioner, as the case may be, may either refuse to sanction the rules submitted, or may return them to the Municipality for further consideration; or if no objection, or no objection which is in ²[its or his] opinion sufficient, was made to the proposed tax within one month from the publication of the said notice, may sanction the said rules either—
 - (a) without modification, or
 - (b) subject
 - (i) to such modifications not involving an increase of the amount to be imposed, or
 - (ii) to such conditions as to the application within the municipal district to any purpose or purposes of this Act specified in such conditions, of the whole or any part of the proceeds of such tax,
- as 3[it or he] deems fit.

Publication of sanctioned rules with notice. 62. All rules sanctioned under section 61 with all modifications subject to which the sanction is given, shall be published by the Municipality in the district for which they are prescribed together with a notice reciting the sanction and the date and serial number thereof, and the tax as prescribed by the rules so published shall, from a date which shall be specified in such notice and which shall not be less than one month from the publication of such notice, be imposed accordingly, and the proceeds thereof shall be applied by the Municipality in accordance with all conditions, if any, subject to which under section 61 the sanction was given:

Provided that

(a) a tax leviable by the year

(i) shall not come into force except on one of the following dates, viz., the first day of April—the first day of July—the first day of October—the first day of January—⁴[in any year], and

- (ii) if it comes into force on any day other than the first of April, it shall be leviable by the quarter, till the first day of April then next ensuing;
- (b) on or before the day on which a notice is issued under this section, the Municipality shall publish such further detailed rules as may be required, and as may have been approved by the ¹[Provincial Government] or by the Commissioner, as the case may be, under the first clause of the proviso to section 46, prescribing the mode of levying and recovering the tax therein specified, and the dates on which it or the instalments, if any, thereof, shall be payable;
- (c) if the levy of a tax, or of a special portion of a tax, has been sanctioned, for a fixed period only, the levy shall cease at the conclusion of that period, except so far as regards unpaid arrears which may have become due during that period.

(2) Assessment of and liability to rates.

- 63. (1) When a rate on buildings or lands or both is imposed, the Preparation Municipality shall cause an assessment-list of all buildings, or lands, or assessment-buildings and lands in the municipal district to be prepared containing list.
 - (a) the name of the street or division in which the property is situated;
 - (b) the designation of the property, either by name or by number, sufficient for identification;
 - (c) the names of the owner and occupier, if known;
 - (d) the annual letting value or other valuation on which the property is assessed; and
 - (e) the amount of the tax assessed thereon.
- (2) For the purpose of making such assessment on property as aforesaid, Power to the Municipality may from time to time appoint any person or persons, whether councillors or not, and whether remunerated or not; and any person or persons so appointed may for such purpose make an inspection of any such property:

(3) On the requisition of the Municipality or of such person ³[or of the Returns to Municipal Commissioner, as the case may be,] the owner or occupier of be furnished, any such building or land shall, within such reasonable period as shall be

specified in the requisition, be bound to furnish a true return to the best of his knowledge or belief and subscribed with his signature—

- (a) as to the name and place of abode of the owner or occupier or of both;
- (b) as to the dimensions of such building or land and the annual letting value or other valuation thereof.

Publication of notice of assessmentlist. 64. When the assessment-list has been completed the Municipality shall give public notice thereof, and of the place where the list or a copy thereof may be inspected: and every person claiming to be either owner or occupier of property included in the list, and any agent of such person, shall be at liberty to inspect the list and to make extracts therefrom without charge.

Public notice of time fixed for revising assessmentlist. 65. (1) The Municipality shall at the time of the publication of such assessment-list give public notice of a time, not less than one month thereafter, when they will proceed to revise the valuation and assessment: and in all cases in which any property is for the first time assessed or the assessment is increased, they shall also give notice thereof to the owner or occupier of the property, if known.

Objections how to be made.

(2) All objections to the valuation and assessment shall be made to the Municipality, before the time fixed in the notice, by application in writing, stating the grounds on which the valuation and assessment are disputed, and all applications so made shall be registered in a book to be kept by the Municipality for the purpose.

Hearing of objections.

- (3) ¹[In a municipal district for which there is a Municipal Commissioner, such Municipal Commissioner, and elsewhere] the managing committee, or any committee or committees to which the Municipality delegate the powers and functions of the managing committee in this behalf, or any ²[servant of the Crown] to whom, with the permission of the Commissioner, the municipality delegate, and they are hereby empowered so to delegate, the powers and functions of the managing committee in this behalf, shall, after allowing the applicant an opportunity of being heard in person or by agent,
 - (a) investigate and dispose of the objections,
 - (b) cause the result thereof to be noted in the book kept under subsection (2) and
 - (c) cause any amendment necessary in accordance with such result to be made in the assessment-list.

- (5) The list so authenticated shall be deposited in the municipal office, Custody and and shall there be open for inspection during office hours to all owners and inspection of occupiers of property specified therein, or to the agents of such persons, list. and a notice that it is so open shall be forthwith published.

(1) The Municipality may at any time alter the said list by insert- Amendment ing the name of any person whose name ought to have been inserted, or by of assessment-list. inserting any property which ought to have been inserted, or by altering the valuation of or assessment on any property which has been erroneously valued or assessed through fraud, accident or mistake, after giving notice to any person interested in the alteration, of a time, not less than one month from the date of service of such notice, at which the alteration is to be made.

(2) Every objection made by any persons interested in any such altera-Objections tion, before the time fixed in the notice, and in the manner provided by how dealt sub-section (2) of the last preceding section, shall be dealt with in all respects as if it were an application under the said section.

(1) When any license is granted by the Municipality under this Municipality Act, or when permission is given by them for making any temporary may charge erection or for putting up any projection, or for the temporary fees for occupation of any public street or other land vested in the Municipality, licenses. the Municipality may charge a fee for such license or permission.
- (2) The Municipality may also charge such fees as may be fixed by Market and by-laws under clause (a) of sub-section (1) of section 48 for the use of any other fees. such places mentioned in that sub-section as belong to the Municipality.

(4) Special provisions relating to certain taxes.

Fixed charges and agreements for payment in lieu of taxes for water supplied.

- 71. (1) The Municipality may, instead of imposing a water-rate or, in individual cases, of levying a rate imposed in respect of the supply of water belonging to the Municipality to, or for use in connection with, any private lands or buildings,
 - (a) fix at rates not exceeding such as shall be specified in the rules in force under section 46, charges for such supply according to the quantity used, as ascertained by measurement,
 - (b) arrange with any person, on his application, to supply on payment, periodical or otherwise, water belonging to the Municipality in such quantities or for such purposes, whether domestic, ornamental, or irrigational or for trade, manufacture or otherwise, on such terms and subject to such conditions as they shall fix by agreement with such person:

Provided that-

- (a) the meters, connection-pipes and all other works necessary for and incidental to such supplies, and all future repairs, extensions and alterations of such works shall be under the control of the Municipality, and the expense thereof shall, so far as is not inconsistent with the rules or by-laws of the Municipality, be defrayed by the persons liable in respect of such supplies, and
- (b) all such supplies of water shall be, and shall be deemed to have been granted, subject to all such conditions as to the limit or stoppage thereof, and as to the prevention of waste or misuse, as are prescribed in the by-laws for the time being in force under section 48.

Power to fix a special rate in lieu of special sanitary cess.

- (2) When the Municipality have made provision for the cleansing of any factory, hotel, club or group of buildings or lands used for any one purpose and under one management, they may, instead of levying in respect thereof any special sanitary cess imposed under this chapter, fix a special rate and the dates and other conditions for periodical payments thereof, which shall be determined either,
 - (i) in accordance with the rules for the time being in force under section 46, or
 - (ii) by written agreement with the person who would have been otherwise hable for the cess, provided that, in fixing the amount, proper regard be had to the probable cost to the Municipality of the service to be rendered.

Power to compound tax on vehicles or animals.

(3) When the Municipality have imposed a tax on vehicles or animals kept for use within the municipal district they may compound with the keeper of any livery-stable or of horses or vehicles kept for sale and hire, for the payment of a lump sum, for any period not exceeding one year at a time, in lieu of any amount which such keeper would otherwise have been liable to pay on account of the tax imposed as aforesaid.

(4) Every sum claimed by the Municipality as due under sub-section Recovery (1) as a charge fixed by agreement or otherwise on account of claimed water-supply, or as expenses to be defrayed such as are referred to in under this that sub-section, or as a special rate under sub-section (2) or as a lump section. sum payable under sub-section (3), shall for the purposes of Chapter VIII be deemed to be, and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under the said chapter:

Provided that nothing in this section shall affect the right or power of the Municipality to contract with any person to supply for use beyond the limits of the municipal district, at such rates and on such conditions as the Municipality may think fit, any quantity of water belonging to the Municipality but not required for the purposes of this Act.

72. If any tax imposed under this Act is a tax on pilgrims resorting Taxes on periodically to a shrine within the limits of a municipal district, the pilgrims Commissioner may require the Municipality of such district to assign assigned in and pay to the district local board, or to the taluka local board having part to local authority in the taluka in which such municipal district is situate, or boards. partly to the said district local board and partly to the said taluka local board, such portion of the total collections on account of such tax as he shall deem fit; and the portion so assigned shall be expended by the said board or boards, within the areas respectively under their authority. on works conducive to the health, convenience and safety of the said pilgrims.

73. If it shall at any time appear to the [Provincial Government], on Power of complaint made or otherwise, that any tax, leviable by a Municipality, is Government unfair in its incidence, or that the levy thereof, or of any part thereof, is to suspend obnoxious to the interest of the general public, 2[it] may require the said levy of Municipality, within such period as 2[it] shall fix in this behalf, to take taxes. measures for removing any objection which appears to 3[it] to exist to the said tax, and if, within the period so fixed, such requirement shall not be carried into effect to the satisfaction of the ¹[Provincial Government], ²[it] may, by notification in the '[Official Gazette], suspend the levy of such tax, or of such part thereof, until such time as the objection thereto shall be removed.

The [Provincial Government] may at any time, by a like notification, rescind any such suspension.

Power of Provincial Government to require municipalities to impose taxes.

74. Whenever it appears to the [Provincial Government] that the balance of the municipal fund of any Municipality is insufficient for meeting the expenditure incurred under section 175 or for the performance of any duties in respect of which they shall have been declared under section 178 to have committed default, the [Provincial Government] may by notification require the Municipality to impose, within the municipal district, any such tax specified in the notification as may be imposed under section 59 if no such tax is at the time imposed therein, or to enhance any existing tax in such manner or to such extent as the 1[Provincial Government] considers fit, and the Municipality shall forthwith proceed to impose or enhance in accordance with the requisition such tax under the provisions of this chapter, as if a resolution of the Municipality had been passed for the purpose under section 60;

Provided that-

- (a) the '[Provincial Government] shall take into consideration any objection which the Municipality or any inhabitant of the municipal district may make against the imposition or enhancement of such
- (b) it shall not be lawful for the Municipality to abandon or modify or to abolish such tax when imposed, and
- (c) the [Provincial Government] may at any time cancel or modify any requisition made by 2[it] under this 3[section], and the levy of the tax or the enhancement, except as to arrears theretofore accrued due, shall thereupon cease or be modified accordingly.

(5) Octroi and Tolls.

Octroi bylaws to be submitted for imposition of octroi.

Every Municipality, when submitting for sanction a proposal for the imposition of octroi, shall submit therewith for sanction a draft of with proposal by-laws for the purposes of clause (j) of section 48, after observing the requirements of sub-sections (2) and (3) of that section.

Power to examine to octroi.

- (1) Every person bringing into, or receiving from beyond, the articles liable octroi limits of a municipal district any article on which octroi is payable shall, when required by an officer authorized in this behalf by the Municipality, and so far as may be necessary for ascertaining the amount of tax chargeable,
 - (a) permit that officer to inspect, examine and weigh, and otherwise deal with the article; and

- (b) communicate to that officer any information and exhibit to him any bill, invoice or document of a like nature, which he may possess relating to the article.
- (2) If any person bringing into, or receiving from beyond, the octroi Power to limits of a municipal district in which octroi is leviable any conveyance or search where package shall refuse, on the demand of an officer authorized by the octroi is Municipality in this behalf, to permit the officer to inspect the contents of the conveyance or package for the purpose of ascertaining whether it contains any articles in respect of which octroi is payable, the officer may cause the conveyance or package to be taken without unnecessary delay before a Magistrate or such officer of the Municipality as the ¹[Provincial Government] appoints in this behalf by name or office, who shall cause the inspection to be made in his presence.
- ²77. (1) Every officer demanding octroi by the authority of the Muni- Presentation cipality shall tender to every person introducing or receiving any article of bills for on which the tax is claimed, a bill specifying the article taxable, the ^{octroi} amount claimed, and the rate at which the tax is calculated.
- (2) If goods passing into a municipal district are liable to the payment Penalty of of octroi, then every person who, with the intention to defraud the evasion of other Municipality, causes or abets the introduction of, or himself introduces or attempts to introduce within the octroi limits of the said district, any such goods upon which payment of the octroi due on such introduction has neither been made nor tendered, shall be punishable with fine which may extend to ten times the value of such octroi or to fifty rupees, whichever may be greater.
- 78. Every Municipality imposing any toll under this Act shall cause to Tables of be kept, at each place where such toll is to be collected, a table in the tolls to be vernacular language of the district, showing the amounts leviable in all shown on cases provided for in the rules, including the terms, if any, on which the liability to pay such tolls may be compounded by periodical payments, and it shall be the duty of every person authorized to demand payment of a toll to show such table on the request of any person on whom such demand is made.
- ¹79. (1) In the case of non-payment on demand of any octroi or of any Power to toll leviable by a Municipality, the person appointed to collect such octroi seize vehicle or toll may seize any article on which the octroi is chargeable or any vehicle or animal on which the toll is chargeable, or any part of its burden, of octroi or which is of sufficient value to satisfy the demand, and may detain the toll. same. He shall thereupon give the person in possession of the vehicle, animal or article seized, a list of the property together with a written notice in the form of Schedule D that the said property will be sold as shall be specified in such notice.

Power to sell property seized at once.

(2) When any article seized is subject to speedy and natural decay, or when the expense of keeping it together with the amount of the octroi or toll chargeable is likely to exceed its value, the person seizing such article may inform the person in whose possession it was that it will be sold at once, and shall sell it or cause it to be sold accordingly unless the amount of octroi or toll demanded be forthwith paid.

Release of property on payment.

(3) If at any time before the sale has begun, the person whose property has been so seized tenders at the municipal office the amount of all expenses incurred, and of the octroi or toll payable, the Municipality shall forthwith release the property seized.

Sale.

(4) If no such tender is made, the property may be sold, and the proceeds of such sale shall be applied in payment of such octroi or toll and the expenses incidental to the seizure, detention and sale.

Surplus how dealt with.

(5) If surplus, if any, of the sale-proceeds shall be credited to the municipal fund, and may, on application made to the Municipality in writing within six months next after the sale, be paid to the person in whose possession the property was when seized, and, if no such application is made, shall be the property of the Municipality.

Power to current with firm or public body in lieu of levying octroi on introduction of goods.

180. The Municipality, if they think fit, instead of requiring keep account- payment of octroi, due from any mercantile firm or public body, to be made at the time when the articles in respect of which it is leviable are introduced within the octroi limits of the municipal district, may at any time direct that an account-current shall be kept on behalf of the Municipality of the octroi so due from any such firm or body as the Municipality specify in this behalf. Every such account shall be settled at intervals not exceeding one month, and such firm or public body shall make such deposit or furnish such security as the Municipality or any committee or officer authorized by them in this behalf shall consider sufficient to cover the amount which may at any time be due from such firm or body in respect of such dues. Every amount so due that the expiry of any such interval shall, for the purposes of Chapter VIII, be deemed to be, and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under the said chapter.

Collection of octroi by one public body on behalf of others.

81. When any agreement such as is referred to in clause (b) of section 39 has been entered into, such one of the bodies entering into the agreement as by the terms thereof shall be specified in this behalf, shall have the same power to establish such octroi limits and octroi stations as that body may deem necessary, for the entire area in which the octroi is to be collected, and shall have the same power of collecting octroi on animals or goods or both brought within the limits so established, and the provisions of ²[the Act under which that body is constituted] relating

to octroi shall apply in the same way as if the limits so established were wholly comprised within the area subject to the control of ¹[that body], and the collections made and the costs thereby incurred shall, subject to the provisions of section 39, be divided between the funds respectively subject to the control of the bodies so entering into the agreement, in such proportions as shall have been determined in the said agreement.

²[81A. (1) It shall be lawful for the Municipality to lease the levy Farming of any tell that may be imposed under this Act by public auction or ^{of tolls}. private contract:

Provided that the lessee shall give security for the due fulfilment of the conditions of the lease.

(2) Where any toll has been leased under this section any person Person employed by the lessee to collect such toll shall, subject to the conditions employed of the lease, have the powers referred to in sub-sections (1) and (2) of of toll section 79:

Provided that no article distrained may be sold except under the soizure. orders of the Municipality.]

CHAPTER VIII.

RECOVERY OF MUNICIPAL CLAIMS.

82. (1) When any amount,

Presentation e of bill for

- (a) which, by or under any provisions of this Act, is declared to be of bill for recoverable in the manner provided by this chapter, or
- (b) which, not being leviable under sub-section (1) of section 79, or payable on demand on account of an octroi or a toll, is claimable as an amount or instalment on account of any other tax which now is imposed or hereafter may be imposed in any municipal district,

shall have become due, the Municipality shall, with the least practicable delay, cause to be presented to the person liable for the payment thereof a bill for the sum claimed as due.

(2) Every such bill shall specify—

Contents of bill.

- (a) the period for which, and
- (b) the property, occupation or thing in respect of which, the sum is claimed, and shall also give notice of—
 - (i) the liability incurred in default of payment, and of

(ii) the time within which an appeal may be preferred as hereinafter provided against such claim.

If bill not paid within fifteen days, notice of demand to issue. (3) If the sum for which any bill has been presented as aforesaid is not paid into the municipal office, or to a person authorized by any rule in that behalf to receive such payments, within fifteen days from the presentation thereof, the Municipality may cause to be served upon the person liable for the payment of the said sum a notice of demand in the form of Schedule B, or to the like effect.

In what cases warrant may issue.

- 83. (1) If the person liable for the payment of the said sum does not, within fifteen days from the service of such notice of demand, either—
 - (a) pay the sum demanded in the notice, or
 - (b) show cause to the satisfaction of the Municipality, or ¹[of] such officer as the Municipality by rule may appoint in this behalf, or in a City Municipality ¹[of] the chief officer, if any, why he should not pay the same, or
 - (c) prefer an appeal in accordance with the provisions of section 86 against the demand,

such sum with all costs of the recovery may be levied under a warrant caused to be issued by the Municipality in the form of Schedule C or to the like effect by distress and sale of the moveable property of the defaulter.

Warrant by whom to be signed.

(2) Every warrant issued under this section shall be signed by the president of the Municipality causing the same to be issued, ²[or by the Municipal Commissioner, if any,] or in the case of a City Municipality by the chairman of the managing committee, or by an officer to whom the Municipality have delegated their powers under section 37 or by the chief officer, if any.

To whom warrant should be addressed.

³[(2A) Where the property is in the Municipal district the warrant shall be addressed to an officer of the Municipality. Where the property is in another municipal district or is not in a municipal district the warrant shall be addressed to the vice-president of the Municipality in such other municipal district or to a ⁴[servant of the Crown] not lower in rank than a Mahalkari as the case may be: Provided that such vice-president or ⁴[servant of the Crown] may endorse such warrant to a subordinate officer. be addressed to the ¹[Registrar of the Court of Small Causes of Bombay:] ²[provided that the Registrar may endorse such warrant to a subordinate officer]]

- (3) It shall be lawful for ³[any office⁷] to whom a warrant issued under Power of sub-section (2) is addressed, if the warrant contains a special order entry under authorizing him in this behalt, but not otherwise, to break open, at any time between sunrise and sunset, any outer or inner door or window of a building, in order to make the distress directed in the warrant, if he has reasonable grounds for believing that such building contains property which is liable to seizure under the warrant, and if after notifying his authority and purpose and duly demanding admittance, he cannot otherwise obtain admittance: Provided that such officer shall not enter or break open the door of any apartment appropriated for women, until he has given three hours' notice of his intention and has given such women an opportunity to remove.
- (4) It shall also be lawful for such officer to distrain, wherever it may Warrant how be found, any moveable property of the person therein named as default- to be er, subject to the following conditions, exceptions and exemptions, executed namely:
 - (a) The following property shall not be distrained:—
 - (i) the necessary wearing apparel and bedding of the defaulter, his wife and children,
 - (ii) the tools of artizans,
 - (iii) when the defaulter is an agriculturist, his implements of husbandry, seed-grain, and such cattle as may be necessary to enable the defaulter to earn his livelihood.
 - (b) The distress shall not be excessive, that is to say, the property distrained shall be as nearly as possible proportionate in value to the amount recoverable under the warrant, and if any articles have been distrained which, in the opinion of a person authorized by or under sub-section (2) to sign a warrant, should not have been so distrained they shall forthwith be returned.
 - (c) The officer shall on seizing the property forthwith make an inventory thereof, and shall before removing the same give to the person in possession thereof at the time of seizure a written notice in the form of Schedule D that the said property will be sold as shall be specified in such notice.

Sale of goods distrained.

84. (1) When the property seized is subject to speedy and natural , decay, or when the expense of keeping it in custody together with the amount to be levied is likely to exceed its value, the president or chairman or officer by whom the warrant was signed shall at once give notice to the person in whose possession the property was when seized to the effect that it will be sold at once, and shall sell it accordingly unless the amount named in the warrant be forthwith paid.

Application of proceeds of sale.

(2) If not sold at once under sub-section (1), the property seized or a sufficient portion thereof may, unless the warrant is suspended by the person who signed it, or the sum due by the defaulter together with all costs incidental to the notice, warrant, and distress and detention of the property, is paid, be, on the expiry of the time specified in the notice served by the officer executing the warrant, sold by public auction under the orders of the Municipality, and the proceeds, or such part thereof as shall be requisite, shall be applied in discharge of the sum due and of all such incidental costs as aforesaid.

Surplus, if any, how dealt with. (3) The surplus, if any, shall be forthwith credited to the municipal fund, notice of such credit being given at the same time to the person from whose possession the property was taken, but if the same be claimed by written application to the municipality within one year from the date of the '[notice] a refund thereof shall be made to such person. Any sum not claimed within one year from the '[date] of such notice shall be the property of the municipality.

Distraint and sale outside the district.

³[84A. Where the warrant is addressed outside the municipal district the authority issuing the warrant may by endorsement direct the officer ⁴[or Registrar of the Court of Small Causes of Bombay] to whom the warrant is addressed to sell the property distrained and in such case it shall be lawful for such officer ⁴[or Registrar] to sell the property and to do all things incidental to the sale and the foregoing provisions shall be modified accordingly. ⁵[Such officer or Registrar shall, after deducting all costs of recovery incurred by him, remit the amount recovered under the warrant to the authority by whom it was issued].]

Fees and costs chargeable.

- 85: Fees for--
 - (a) every notice issued under sub-section (3) of section 82,
- ⁶(b) every warrant issued under sub-section (1) of section 83 or distress made under sub-section (4) of the said section, and

- (c) the costs of maintaining any live stock seized under ¹[subsection (4) of section 83],
- shall be chargeable at the rates respectively specified in such behalf in the rules of the Municipality, and shall be included in the costs of recovery to be levied under ²[section 83].
- 86. Appeals against any notice of demand issued under sub-section (3) Appeals to of section 82 may be made to any Magistrate or Bench of Magistrates by whom under the directions of the ³[Provincial Government], or of the District Magistrate, such class of cases is to be tried.

But no such appeal shall be heard and determined unless-

- (a) the appeal is brought within fifteen days next after service of the notice of demand complained of; and
- (b) an application in writing, stating the ground on which the claim of the Municipality is disputed, has been made to the Municipality as follows, that is to say:
 - (i) in the case of a rate on buildings or lands, within the time fixed in the notice given under section 65 or 66 of the assessment or alteration thereof, according to which the bill is prepared,
 - (ii) in the case of any other claim for which a bill has been presented under sub-section (1) of section 82 within fifteen days next after the presentation of such bill; and
- (c) the amount claimed from the appellant has been deposited by him in the municipal office.
- 87. All sums due on account of any tax imposed in the form of a rate on Liability lands or buildings or on both, mentioned in section 68, shall, subject of land, to prior payment of land-revenue, if any, due to 4[His Majesty] there-etc., for upon, be a first charge upon the building or land, in respect of which such rates. tax is leviable, and upon the moveable property, if any, found within or upon such building or land, and belonging to the person liable for such tax or taxes:

Provided that no arrears of any such tax shall be recovered from any occupier who is not the owner, if it has been due for more than one year or for a period during which such occupier was not in occupation.

Suspension of power to recover by distress and sale. 88. The ¹[Provincial Government may at any time by notification suspend the operation of sections 83 and 84 in any municipal district, in which there is not a City Municipality, and from such date as shall be fixed in this behalf in the notification, every amount due on account of any tax theretofore recoverable under the said sections, shall be recoverable on application to a Magistrate, in the manner provided in sub-section (2) of section 161 for the recovery of such fines as are therein referred to, and not otherwise.

Receipts to be given for all payments.

89. For all sums paid on account of any tax under this Act, a receipt stating the amount, and the tax on account of which it has been paid, shall be tendered by the person receiving the same.

CHAPTER IX.

MUNICIPAL POWERS AND OFFENCES.

(1) Powers in respect of streets.

Power regarding streets, etc.

- 90. (1) It shall be lawful for the Municipality to lay out and make new public streets, and to construct tunnels and other works subsidiary to the same, and to widen, open, enlarge or otherwise improve any such streets, and to turn, divert, discontinue or stop up any such streets, and, subject to the provisions of sub-section (2) of section 40 ²[to lease or sell] any such land, theretofore used or acquired by the Municipality for the purposes of such streets as may not be required for any public street or for any other purposes of this Act.
- (2) In laying out or making or in turning, diverting, widening, opening enlarging, or otherwise improving any public street, in addition to the land required for the carriage-way and footways and drains thereof, the Municipality may purchase the land necessary for the houses and buildings to form the said street, and, subject to the provision contained in sub-section (2) of section 40, may sell and dispose of the same in perpetuity or on lease for a term of years, with such stipulations as to the class and description of houses or buildings to be erected thereon as they may think fit.

Power to require repair of streets, (3) When the Municipality consider that in any street, not being a public street, or in any part of such street, within the municipal district, it is necessary for the public health, convenience or safety that any work should be done for the levelling, paving, metalling, flagging, channeling, draining, lighting or cleaning thereof, the Municipality may by written notice require the respective owners of the lands or buildings fronting, adjoining or abutting upon such street or part thereof, to carry out such work in a manner and within a time to be specified in such notice.

and to declare such streets public.

(4) After such work has been carried out by such owners or, as provided in section 156, by the Municipality at the expense of such owners, the street or part thereof in which such work has been done may, and on the

then the street may be laid out and made, in such manner as may have been specified in the notice, and as is not inconsistent with any provision of this Act or of any by-law for the time being in force thereunder.

(4) Whoever lays out, makes or builds upon any such street, either Penalty. without giving the notice required by sub-section (1), or, except in accordance with the provisions of sub-section (3) without awaiting, or otherwise than in accordance with, the instructions issued by the Municipality, or in any manner contrary to the provisions of this Act or of any by-law in force thereunder shall be punished with fine which may extend to two hundred and fifty rupees, and the Municipality may cause

any street so laid out or made to be altered, and any building erected in such street contrary to their directions to be altered or removed, and the expense thereby incurred shall be paid to them by the offender, and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VIII.

The regular line of a public street. ¹[91A. (1) It shall be the duty of every ²[city municipality and of such other municipality as may be notified by ³[the Provincial Government] in this behalf] to prescribe a line on each side of every public street within the municipal district and the Municipality may from time to time prescribe a fresh line in substitution for any line so prescribed, or for any part thereof:

Provided that-

- (a) at least one month previous to prescribing such line or such fresh line, as the case may be, the Municipality shall give public notice of the proposal and they shall put up special notice thereof in the street or part of the street for which such line or such fresh line is proposed to be prescribed, and
- (b) the Municipality shall consider any written objection or suggestion in regard to such proposal delivered at the office of the Municipality within such time as they may specify in such public or special notice.
- (2) The line for the time being so prescribed shall be called the regular line of the public street.
- ⁴[(3) (a) Except under the provisions of section 113, no person shall construct or reconstruct any portion of any building within the regular line of the public street without the permission of the municipality under section 96.

Roofs and not to be made of inflammable materials.

94. (1) The external roofs and walls of buildings erected or renewed external walls after the coming into force of this Act, shall not be made of grass, wood, cloth, canvas, leaves, mats or other inflammable materials except with the written consent of the Municipality, which may be given either specially in individual cases, or generally in respect of any area specified therein.

Power to require removal of if inflammable.

(2) The Municipality may at any time by written notice require the owner of any building which has an external roof or wall made of any roof and wall such material as aforesaid, to remove such roof or wall within such reasonable time as shall be specified in the notice, whether such roof or wall was or was not made before the time at which this Act came into force, and whether it was made with or without the consent of the Municipality.

Penalty.

(3) Whoever without such consent as is required by sub-section (1) makes, or causes to be made, or in disobedience to the requirements of a notice given under sub-section (2) suffers to remain, any roof or wall of such material as aforesaid, shall be punished with a fine which may extend to twenty-five rupees, and with a further fine which may extend to ten rupees for every day on which the offence is continued, after the date of the first conviction.

Level of buildings.

95. No building shall hereafter be built upon a lower level than will allow of the drainage thereof being led into some public sewer or drain either then existing or projected by the Municipality, or into some stream or river, or into the sea, or some cesspool, or other suitable place which may be approved of by the Municipality.

Notice of new buildings.

- 96. (1) Before beginning to erect any building, or to alter externally or add to any existing building, or to '[construct or] reconstruct any projecting portion of a building in respect of which the Municipality is empowered by section 92 to enforce a removal or set-back, ²[or is empowered by section 91A to give permission to [construct or] reconstruct it,] the person intending so to build, alter, 3[add or reconstruct] shall give to the Municipality notice thereof in writing, and shall furnish to them, at the same time if required by a by-law or by special order to do so,
 - (a) the sanad, if any, in force relating to the site of such proposed building, issued under section 10 of 4Bombay Act IV of 1868 or received under section 133 of the Bombay Land Revenue Bom Code, 1879, or other enactment relating to the survey of vot 1879. lands in towns and cities, and
 - (b) a plan showing the levels, at which the foundation and lowest floor of such building are proposed to be laid, by reference to some level known to the Municipality, and all information

(6) The Municipality or any officer deputed by them may at any time inspect the erection of any building without giving notice of their or his intention to do so, and 1* * at any time during the erection of a building or the execution of any such work as aforesaid, or at any time not later than one month after being informed in writing by the person responsible for giving a notice under sub-section (1) that the erection of the building, or the execution of any such work as aforesaid, has been completed, may by written notice specify any matter in respect of which the erection of such building, or the execution of such work, may be in contravention of any provision of this Act or of any by-law made under this Act at the time in force, and require the person erecting or executing, or who has erected or executed, such building or work, or, if the person who has erected or executed such building or work is not at the time of notice the owner thereof, then the owner of such building or work, to cause anything done contrary to any such provision or by-law to be amended or to do anything which by any such provision or by-law he may be required to do but which has been omitted.

Explanation.—The expression "to erect a building" throughout this chapter includes—

- (a) any material alteration, enlargement or reconstruction of any building ²[or of any wall, verandah, fixed platform, plinth, doorstep or the like, whether constituting part of a building or not],
- (b) the conversion into a place for human habitation of any building not originally constructed for human habitation,
- (c) the conversion into more than one place for human habitation of a building originally constructed as one such place,
- (d) the conversion of two or more places of human habitation into a greater number of such places,
- (e) such alterations of the internal arrangements of a building as affect its drainage, ventilation or other sanitary arrangements, or its security, or stability, and
- (f) the addition of any rooms, buildings or other structures to any building,

and a building so altered, enlarged, reconstructed, converted, or added to, is, throughout this chapter, included under the expression "a new building".

Regulation of huts.

97. It shall not be lawful for any person to erect any hut or shed or range or block of huts or sheds, or to add any hut or shed to any range or block of huts or sheds already existing when this Act comes into operation, without giving previous notice to the Municipality; and the Municipality may require such huts or sheds to be built so that they may stand in regular lines, with a free passage or way in front of and between every two lines of such width as the Municipality may think proper for ventilation and to facilitate scavenging, and at such a level as will admit of sufficient drainage, and may require such huts to be provided with such number of privies and such means of drainage as to them may seem necessary. If any hut or shed or range or block be built without giving such notice to the Municipality, or otherwise than as required by the Municipality, the Municipality may give written notice to the owner or builder thereof, or to the owner or occupier of the land on which the same is erected, or is being erected, requiring him within such reasonable time as shall be specified in the notice to take down and remove the same, or to make such alterations therein or additions thereto as having regard to sanitary considerations the Municipality may think fit.

Improvement of huts.

- 98. (1) Whenever the Municipality are of opinion that any huts or sheds, whether used as dwellings or stables or for any other purposes, and whether existing at the time when this Act comes into operation or subsequently erected, are by reason
 - (a) of insufficient ventilation or of the manner in which such huts or sheds are crowded together, or
 - (b) of the want of a plinth or of a sufficient plinth or of sufficient drainage, or
 - (c) of the impracticability of scavenging,

attended with risk of disease to the inhabitants or the neighbourhood, they shall cause a notice to be affixed to some conspicuous part of each such hut or shed, requiring the owner or occupier thereof, or the owner of the land on which such hut or shed is built, within such reasonable time as may be fixed by the Municipality for that purpose, to take down and remove such hut or shed, or to execute such operations as the Municipality may deem necessary for the avoidance of such risk.

- (2) In case any such owner or occupier shall refuse or neglect to take down and remove such huts or sheds, or to execute such operations within the time appointed, the Municipality may cause the said huts or sheds to be taken down, or such operations to be performed in respect of such huts or sheds as they may deem necessary to prevent such risk.
- (3) If such huts or sheds be pulled down by the Municipality, the Municipality shall cause the materials of each hut or shed to be sold separately, if such sale can be effected, and the proceeds, after deducting all expenses, shall be paid to the owner of the hut or shed, or if the owner

be unknown or the title disputed, shall be held in deposit by the Municipality until the person interested therein shall obtain the order of a competent Court for the payment of the same:

Provided always that in case any huts or sheds, existing at the time when the land on which they are situated first became part of a municipal district, should be pulled down under this section by order of the Municipality, or in pursuance of their notice, compensation shall further be made to the owner or owners thereof, and the amount thereof, in case of dispute, shall be ascertained and determined in the manner provided in section 160.

- (3) Powers connected with drainage, etc.
- 99. (1) All sewers, drains, privies, water-closets, house-gullies and Municipal cesspools within the municipal district shall be under the survey and control over control of the Municipality.
- (2) All covered sewers and drains, and all cesspools, whether public or private, shall be provided by the Municipality or other persons to whom they severally belong, with proper traps, or other coverings or means of ventilation and the Municipality may by written notice call upon the owner of any such covered sewers, drains or cesspools to make provision accordingly.
- 100. (1) In order to carry out any drainage scheme it shall be lawful Powers for for a Municipality to carry any drain, sewer, conduit, tunnel, culvert, making drains. pipe or water-course through, across or under any street, or any place laid out as or intended for a street, or under any cellar or vault which may be under any street, and after giving reasonable notice in writing to the owner or occupier, into, through or under any land whatsoever within the municipal district.

- (2) The Municipality, or any officer appointed by them for such purpose, may enter upon and construct any new drain in the place of an existing drain in any land wherein any drain vested in the Municipality has been already constructed, or may repair or alter any drain vested in the Municipality.
- (3) In the exercise of any power under this section no unnecessary damage shall be done, and compensation, which shall, in case of dispute, be ascertained and determined in the manner provided in section 160, shall be paid by the Municipality to any person who sustains damage by the exercise of such power.
- 101. (1) If any building or land be at any time undrained, or not Sufficient drained to the satisfaction of the Municipality, the Municipality may by drainage of written notice call upon the owner to construct or lay from such building or land a drain or pipe of such size and materials, at such level, and with such fall as they think necessary for the drainage of such building or land into
 - (a) some drain or sewer, if there be a suitable drain or sewer within fifty feet of any part of such building or land, or

(b) a covered cesspool to be provided by such owner.

New (2) It shall not be lawful newly to erect any building or to re-build any buildings not building, or to occupy any building newly erected or re-built, unless and without until-drains.

- (a) a drain be constructed of such size, materials and description, at such level, and with such fall, as shall appear to the Municipality to be necessary for the effectual drainage of such building;
- (b) there have been provided for and set up in such building and in the land appurtenant thereto, all such appliances and fittings as may appear to the Municipality to be necessary for the purposes of gathering and receiving the drainage from, and conveying the same off, the said building and the said land and of effectually flushing the drain of the said building and every fixture connected therewith.
- (3) The drain to be constructed as aforesaid shall empty into a municipal drain, or into some place legally set apart for the discharge of drainage situated at a distance not exceeding fifty feet from such building; but if there is no such drain or place within that distance, then such drain shall empty into such cesspool as the Municipality direct.

Powers of owners and occupiers of buildings or lands to drain into Municipal drains.

The owner or occupier of any building or land within the municipal district shall be entitled to cause his drains to empty into the sewers of the Municipality, provided that he first obtains the written permission of the Municipality, and that he complies with such conditions as the Municipality prescribe as to the mode in which and the superintendence under which the communications are to be made between drains not vested in the Municipality and drains which are so vested.

How right to carry drain may be obtained.

Such right how and on what conditions to be authorized by Municipality.

- 103. (1) If the owner or occupier of any building or land desires to connect the same with any municipal drain, by means of a drain, to be through land constructed through land, or to be connected with a drain, belonging to or belonging to occupied by or in the use of some other person, he may make a written other persons application in that behalf to the Municipality.
 - (2) The municipality thereupon, after giving to such other person a reasonable opportunity of stating any objection to such application, may, if no objection is raised or if any objection which is raised is in their opinion insufficient, by an order in writing authorize the applicant to carry his drain into, through, or under the said land, or into the said drain, as the case may be, in such manner and on such conditions as to the payment of rent or compensation, and as to the respective responsibilities of the parties for maintaining, repairing, flushing, cleaning and emptying the said drains as may appear to them to be adequate and equitable.

(3) Every such order shall be a complete authority to the person in Written whose favour it is made, or to any agent or other person employed by order of him for this purpose, after giving or tendering to the owner or occupier authority for of the said land or drain the compensation or rent, if any, specified in execution of the said order, and otherwise fulfilling as far as possible the conditions necessary of the said order, and after giving to the said owner or occupier reasonable notice in writing, to enter upon the land specified in the said order with assistants and workmen at any time between sunrise and sunset and, subject to all provisions of this Act, to do all such work as may be necessary-

- (a) for the construction or connection of the drain, as may be authorized by the said order,
- (b) for renewing, repairing or altering the same, as may be necessary from time to time, or
- (c) for discharging any responsibility attaching to him under the terms of the order as to maintaining, repairing, flushing, cleaning or emptying the said drain or any part thereof.
- 104. In executing any work under section 103, as little damage as Work how possible shall be done, and the owner or occupier of the buildings or to be carried lands for the benefit of which the work is done, shall
 - (a) cause the work to be executed with the least practicable delay:
 - (b) fill in, reinstate and make good at his own cost and with the least practicable delay the ground or any portion of any building or other construction opened, broken up or removed for the purpose of executing the said work; and
 - (c) pay compensation to any person who sustains damage by the execution of the said work.
- 105. - 106. (1) In case the Municipality shall be of opinion that any privy Provision of or cesspool, or additional privies, or cesspools, should be provided in privies, etc. or on any building or land, or, in any municipal district in which, with the approval of the sanitary board, a water-closet system has been introduced, that water-closets should be substituted for the existing privies in or on any building or land, or that additional water-closets should be provided therein or thereon, the Municipality may by written notice call upon the owner of such building or land to provide such privies, cesspools or water-closets as the Municipality may deem proper.

- (2) The Municipality may by written notice require any person or persons employing workmen or labourers exceeding twenty in number, or owning or managing any market, school or theatre or other place of public resort, to provide such latrines and urinals as the Municipality may direct, and to cause the same to be kept in proper order, and to be daily cleaned.
- (3) The Municipality may by written notice require the owner or occupier of any land upon which there is a privy, to have such privy shut out, by a sufficient roof and a wall or fence, from the view of persons passing by or resident in the neighbourhood, or to alter as they may direct any privy door or trap door which opens on to any street, and which they deem to be a nuisance.

Cost of altering, repairing and keep. order privies, etc.

- 107. (1) All sewers, drains, privies, water-closets, house-gullies and cesspools within municipal district shall, unless constructed at the cost ing in proper of the Municipality, be altered, repaired, and kept in proper order at the cost and charges of the owners of the land and buildings to which the same belong, or for the use of which they are constructed or continued, and the Municipality may by written notice require such owner to alter, repair, and put the same in good order in such manner as they think fit.
 - (2) The Municipality may by written notice [require the owner to] demolish or close any privy or cesspool, whether constructed before or after the coming into operation of this Act, which in the opinion of the Municipality is a nuisance, or is so constructed as to be inaccessible for the purpose of scavenging or incapable of being properly cleaned or kept in good order.

Power to close existing private drains.

108. When any building or land within the municipal district has a drain communicating with any cesspool or sewer, the Municipality, if they consider that such drain, though it may be sufficient for the drainage of such building or land, and though it may be otherwise unobjectionable is not adapted to the general sewerage of the district, may close such drain, and such cesspool or sewer, whether it is or is not on land vested in the Municipality, on providing a drain or drains equally effectual for the drainage of such building or land, and the Municipality may do any work necessary for the purpose.

Power in respect of sewers, etc., unauthorizedly constructed. rebuilt or unstopped.

- 109. The Municipality may by written notice require that any such sewer, drain, privy, water-closet, house-gully or cesspool on any land within municipal limits constructed, rebuilt or unstopped-
 - (a) after such land became part of a municipal district, and
 - (b) either without the consent or contrary to the orders, directions or general regulations or by-laws of the Municipality, or contrary to the provisions of any enactment in force at the time when it was so constructed, rebuilt or unstopped.

shall be demolished, amended or altered, as they may deem fit, by the person by whom it was so constructed, rebuilt or unstopped and every person so constructing, rebuilding or unstopping any such sewer, drain, privy, water-closet, house-gully or cesspool, whether he does or does not receive such notice or does or does not comply therewith shall, in addition to any penalty to which he may be liable on account of such noncompliance, be punished with fine which may extend to twenty-five rupees.

110. (1) Whoever, without the written consent of the Municipality Encroachfirst obtained, makes or causes to be made any drain into or out from any ments on of the sewers or drains vested in the Municipality, shall be punished drains. with fine which may extend to twenty-five rupees, and the Municipality may by written notice require such person to demolish, alter, remake, or otherwise deal with such drain as they may think fit.

- (2) No building shall be newly erected or rebuilt over any sewer, drain, culvert or gutter vested in the Municipality, without the written consent of the Municipality, and the Municipality may by written notice require the person who may have erected or rebuilt such building to pull down or otherwise deal with the same as they may think fit.
- 111. (1) The Municipality or any officer appointed by them for such Inspection purposes may, subject to the restrictions of this Act, inspect any sewer, of drains, drain, privy, water-closet, house-gully or cesspool, and for that purpose, etc. at any time between sunrise and sunset, may enter upon any lands or buildings with assistants and workmen, and cause the ground to be opened where he or they may think fit, doing as little damage as may be.

(2) The expense of such inspection, and of causing the ground to be Expense of closed and made good as before shall be borne by the Municipality, unless inspection the sewer, drain, privy, water-closet, house-gully or cesspool is found when to be borne by the to be in bad order or condition, or was constructed in contravention of Municipality. the provisions of any enactment, or of any by-laws of the Municipality in force at the time, in which case such expenses shall be paid by the. owner of such sewer, drain, privy, water-closet, house-gully or cesspool and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VIII.

112. (1) The Municipality may, if they think fit, cause any work of Municipality the nature to which this sub-chapter applies to be executed by municipal pality may or other agency under their own orders, without first of all giving the execute person by whom the same would otherwise have to be executed the works option of doing the same.

Expenses in such cases by whom to be paid.

- (2) The expenses of any work so done shall be paid by the person aforesaid, unless the Municipality shall, by a general or special order or resolution, sanction, as they are hereby empowered to sanction, the execution of such work at the charge of the municipal fund.
- (3) Any pipes, fittings, receptacles, or other appliances for or connected with the drainage of private buildings or lands shall, if supplied, constructed or erected at the expense of the Municipality, be deemed to be municipal property, unless the Municipality shall have transferred their interest therein to the owner of such buildings or lands.

(4) Powers regarding external structures, etc.

Permission necessary for certain projections.

- 113. (1) The Municipality may give written permission to the owners or occupiers of buildings in public streets to put up open verandahs, balconies or rooms, to project from any upper storey thereof, at such height from the surface of the street as the Municipality may fix by by-laws from time to time, and to an extent not exceeding four feet beyond the line of the plinth or basement wall, and may prescribe the extent to which and the conditions under which, roofs, leaves, weather-boards, ¹[shop-boards] and the like may be allowed to project over such streets.
- ²(2) (a) Any such owner or occupier putting up any such projections as aforesaid without such permission or in contravention of such orders, shall be punished with fine which may extend to twenty-five rupees, and if any such owner or occupier fails to remove any such projection as aforesaid in respect of which he has been convicted under this section, he shall be punished with further fine which may extend to five rupees for each day on which such failure or neglect continues.
- ³(b) Notwithstanding any proceedings which may be taken under clause (a) of this sub-section, the Municipality may, by written notice, require the owner or occupier of any such building to remove or alter any such projection which has been constructed either without, or contrary in any manner to, the permission of the Municipality.

Removal of projections.

- (3) The Municipality may by written notice require the owner or occupier of any building to remove or alter any projection, encroachment or obstruction which, whether erected before or after the site of such building became part of a municipal district, shall have been erected or placed against or in front of such building, and which
 - (a) overhangs or juts into, or in any way projects or encroaches upon, any public street, so as to be an obstruction to safe and convenient passage along such street, or which

(b) projects and encroaches into or upon any uncovered aqueduct, drain or sewer in such street, so as to obstruct or interfere with such aqueduct, drain or sewer, or the proper working thereof:

Provided always that the Municipality shall, if such projection, encroachment, or obstruction shall have been made in any place before the date on which such place became part of a municipal district, or after such date with the written permission of the Municipality, make reasonable compensation to every person who suffers damage by such removal or alteration; and if any dispute shall arise touching the amount of such compensation, the same shall be ascertained and determined in the manner provided in section 160.

- 114. The Municipality may by written notice require the owner of Troughs every building in any street to put up and keep in good condition proper and pipes troughs and pipes for catching and carrying the water from the roof and water. other parts of such building, and for discharging the same, in such manner as they may think fit, so that it shall not fall upon the persons passing along the street.
- 115. The Municipality may erect or fix to the outside of any building Fixing of brackets for lamps to be lighted with oil or gas, or subject to the provi-brackets. sions of the ¹Indian Electricity Act, 1887, for lamps to be lighted with to houses. electricity or otherwise, or subject to the provisions of the 2 Indian Telegraph Act, 1885, as amended by subsequent enactments, for telegraph wires or telephonic wires, or for the conduct of electricity for locomotive purposes or such pipes as they may deem necessary for the proper ventilation of sewers and water-works, and such brackets and pipes shall be erected so as not to occasion any inconvenience or nuisance to the said building or any others in the neighbourhood.

116. (1) The Municipality may from time to time cause to be put up Naming or painted on a conspicuous part of any building at or near each end, streets and corner or entrance to every street, the name by which such street is to be houses. known, and may from time to time fix a number in a conspicuous place on the outer side of any building, or at the entrance of the enclosure thereof fronting the street.

- (2) Any person who destroys, pulls down or defaces any such name or number, or puts any name or number different from that put up by the Municipality, and any owner or occupier of any building who shall not at his own expense keep such number in good order after it has been put up thereon, shall be punished with fine which may extend to twenty-five rupees.
 - 117. Any person
 - (a) who without the consent of the owner or occupier affixes any Penalty for posting bill, placard or other paper or means of advertise-defacing ment against or upon any building, wall, board, fence or pale, etc.

(b) who without such consent as aforesaid writes upon, soils, defaces or marks any such building, wall, board, fence or pale with chalk or paint or in and other way whatsoever, shall be punished with fine which may extend to twenty-rupees.

Removal and trimming of hedges, tree, etc.

- 118. The Municipality may by written notice require the owner or occupier of any land so to trim or prune the hedges thereof bordering any public street that the said hedges may not exceed the height of four feet from the level of the street, and width of four feet, and to cut down, lop, or trim all trees or shrubs which in any way overhang, endanger or obstruct, or which they deem likely to overhang, endanger, or obstruct any public street or to cause damage thereto, or which so overhang any public tank, well, or other provision for water-supply as to pollute, or be likely to pollute, the water thereof.
 - (5) Powers for promotion of public health, safety and convenience.

Ruinous or dangerous buildings. 119. (1) If any building, or anything affixed thereon, be deemed by the Municipality to be in a ruinous state or likely to fall or in any other way dangerous to any inhabitant of such building or of any neighbouring building or to any occupier thereof, or to passengers, the Municipality shall immediately, if it appears to them to be necessary, cause a proper hoard or fence to be put up for the protection of passengers; all expenses incurred by the Municipality under this sub-section shall be paid by the owner or occupier of such building and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VIII.

Action to be taken on default by owner or occupier. (2) The Municipality shall also cause notice in writing to be given to the owner or occupier, requiring such owner or occupier forthwith to take down, secure, or repair such building, or thing affixed thereon, as the case shall require, and if such owner or occupier do not begin to repair, take down, or secure such building or thing within three days after the service of such notice, and complete such work with due diligence, the Municipality shall cause all or so much of such building or thing, as they shall think necessary, to be taken down, repaired or otherwise secured:

Proviso if danger is not imminent.

Provided always that if the danger be not of hourly imminence, it shall be at the discretion of the Municipality, instead of themselves causing a hoard or fence to be put up, to issue in the first instance notice in writing to the owner or occupier to put up a proper hoard or fence, and in the event of the owner or occupier failing to put up within two days from the service of such notice a hoard or fence which the Municipality consider sufficient in the circumstances of the case, Municipality shall at once cause such hoard or fence to be put up and thereafter proceed as provided in sub-sections (1) and (2).

- 120. (1) The Municipality may at any time by written notice require Powers that the owner of, or any person who has the control over, any well, and duties stream, channel, tank or other source of water-supply, shall, whether it with is private property or not,
 - dangerous, stagnant tary sources of water-

supply.

- (a) keep and maintain any such source of water-supply, other than or insania stream, in good repair, or
- (b) within a reasonable time to be specified in the notice, cleanse any such source of water-supply from silt, refuse and decaying vegetation, or
- (c) in such manner as the Municipality prescribe, protect any such source of water-supply from pollution by surface drainage, or
- (d) within twenty-four hours of such notice, repair, protect or enclose in such manner as the Municipality approve, any such source of water-supply other than a stream in its natural flow, if for want of sufficient repair, protection or enclosure, such source of water-supply is in the opinion of the Municipality dangerous to the health or safety of the public or of any persons having occasion to use or to pass or approach the same, or shall
- (e) desist from using and from permitting others to use for drinking purposes any such source of water-supply which not being a stream in its natural flow, is proved to the satisfaction of the Municipality to be unfit for drinking; or
- (f) if notwithstanding any such notice under clause (e) such use continues and cannot in the opinion of the Municipality be otherwise prevented, close, either temporarily or permanently, or fill up or enclose or fence in such manner as the Municipality consider sufficient to prevent such use, such source of water-supply as aforesaid;
- (q) drain off or otherwise remove from any such source of watersupply, or from any land or premises or receptacle or reservoir attached or adjacent thereto, any stagnant water which the Municipality consider is injurious to health or offensive to the neighbourhood.
- (2) If the owner or person having control as aforesaid, fails or neglects Remedy on to comply with any such requisition within the time required by or under non-compli-the provisions of sub-section (1) the Municipality, may, and if in their ance with the provisions of sub-section (1), the Municipality may, and if in their directions opinion immediate action is necessary to protect the health or safety of issued. any person, shall at once proceed to execute the work required by such notice, and all the expenses incurred therein by the Municipality shall be paid by the owner of, or person having control over, such water-supply. and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VIII;

Provided that in the case of any well or private stream or of any private channel, tank or other source of water-supply, the water of which is used by the public or by any section of the public as of right, the expenses incurred by the Municipality or necessarily incurred by such owner or person having such control, may, if the Municipality so direct, be paid from the municipal fund.

Displacing pavements, etc.

121. (1) Whoever displaces, takes up or makes any alteration in the pavement, gutter, flags or other materials, of any public street, or the fences, walls, or posts thereof, or any municipal lamp, lamp-post, bracket, water-post, hydrant, or other such municipal property therein, without the written consent of the Municipality, or other lawful authority, shall be punished with fine which may extend to one hundred rupees.

Penalty for failure to replace after notice.

(2) Any person who, having displaced, taken up or made alteration in any such pavement, gutter, flags, or other materials, or in the fences. walls, posts, municipal lamps, lamp-posts, brackets, water-posts, hydrants, or other municipal property of any public street, shall fail to replace or restore the same to the satisfaction of the Municipality after notice to do so, shall be punished with fine which may extend to fifty rupees, and shall pay any expense which may be incurred in restoring the street, and such expense shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VIII.

Obstructions ments upon public streets and open spaces.

- 122. (1) Whoever in any place after it has become a municipal and encroach- district, shall have built or set up, or shall build or set up, any wall or any fence, rail, post, stall, verandah, platform, plinth, step or any projecting structure or thing, or other encroachment or obstruction, in any public street, or shall deposit or cause to be placed or deposited any box, bale, package or merchandise, or any other thing in such street, or in or over or upon, any open drain, gutter, sewer or aqueduct in such street, shall be punished with fine which may extend to twenty-five rupees 1 and with further fine which may extend to five rupees for every day on which such projection, encroachment, obstruction or deposit continues after the date of first conviction for such offence.
 - (2) The Municipality shall have power to remove any such obstruction or encroachment, and shall have the like power to remove any unauthorized obstruction or encroachment of the like nature in any open space not being private property, whether such space is vested in the Municipality or not, provided that if the space be vested in His Majesty the permission of the Collector shall have first been obtained, and the expense of such removal shall be paid by the person who has caused the said obstruction or encroachment, and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VIII.

- (3) Whoever, not being duly authorised, in that behalf, removes earth, sand or other material from, or makes any encroachment in or upon, any open space which is not private property, shall be punished with fine which may extend to fifty rupees, and, in the case of an encroachment, with further fine which may extend to ten rupees for every day on which the encroachment continues after the date of first conviction for such offence.
- (4) Nothing contained in the section shall prevent the Municipality from allowing any temporary occupation of or erections in any public street on occasions of festivals and ceremonies, or the piling of fuel in by-streets and spaces for not more than four days, and in such manner as not to inconvenience the public or any individual.
- ¹ [(5) Nothing contained in this section shall apply to any projection duly authorized under sub-section (1) of section 113, or in any case where permission has been given under sub-section (4).]
- 123. (1) Every person intending to build or take down any building, hoards to be set up or to alter or repair the outward part of any building, in such a position during or in such circumstances as the work is likely to cause or may cause repairs, obstruction, danger or inconvenience in any street, shall before beginning etc. such work.

- (a) first obtain a license in writing from the Municipality so to do.
- (b) cause sufficient hoards or fences to be put up in order to separate the building where such works are being carried on from the street and shall maintain such hoard or fence standing and in good condition to the satisfaction of the Municipality during such time as the public safety or convenience requires. and shall cause the same to be sufficiently lighted during the night, and shall remove the same when directed by the Municipality.
- (2) Whoever contravenes any of the provisions of this section shall be punished with fine which may extend to fifty rupees, and with further fine which may extend to ten rupees for every day or night, as the case may be, on which such contravention continues, after the date of the first conviction.
- 124. (1) The Municipality shall, during the construction or repair Fencing of any of the streets, sewers, drains or other premises vested in them, lighting take proper precaution for guarding against accident, by shoring up during and protecting the adjoining buildings and shall cause such bars, chains repairs, or posts, to be fixed across or in any of the streets to prevent the passage etc. of carriages, carts, or other vehicles, or of cattle or horses, while such works are carried on, as to them shall seem proper; and the Municipality shall cause any sewer or drain or other works in streets, during the construction or repair thereof, to be lighted with a sufficient light and guarded during the night.

(2) Whoever takes down, alters or removes any of the said bars, chains or posts, or removes or extinguishes any such light, without the authority or consent of the Municipality, shall be punished with fine which may extend to fifty rupees.

Timber not to be deposited in a street without permission.

- 125. (1) No person shall, without the written permission of the Municipality or otherwise than in accordance with such conditions as or hole made may therein be prescribed, make a hole in any street or erect or deposit thereon, any timber, stone, brick, earth or other material that has been. or is intended to be, used for building; and such permission shall be terminable at the discretion of the Municipality; and when such permission is granted to any person, he shall, at his own expense, cause such materials or such hole to be sufficiently fenced and enclosed until the materials are removed, or the hole is filled up or otherwise made secure, to the satisfaction of the Municipality, and shall cause the same to be sufficiently lighted during the night.
 - (2) Whoever contravenes any of the provisions of sub-section (1) shall be punished with fine which may extend to twenty-five rupees, and with further fine which may extend to ten rupees for every day or night, as the case may be, on which such contravention continues, after the date of the first conviction.

Dangerous quarrying.

126. 1* If in the opinion of the Municipality the working of any quarry or the removal of stone, earth or other material from the soil in any place, is dangerous to persons residing in or having legal access to the neighbourhood thereof, or creates or is likely to create a nuisance, the Municipality may, by written notice, require the owner of the said quarry or place, or the person responsible for such working or removal, not to continue or permit the working of such quarry or the removing of such material, or to take such order with such quarry or place as the Municipality shall direct for the purpose of preventing danger or of abating the nuisance arising or likely to arise therefrom:

Provided that if such quarry or place is vested in His Majesty, or if such working thereof or removal therefrom as aforesaid is being carried on by or on behalf of ² [any Government], or any person acting with the permission or under the authority of 2[any Government] or of any Iservant of the Crown acting as such, the Municipality shall not take such action unless and until the Collector has consented to their so doing:

Provided further that the Municipality shall immediately cause a proper hoard or fence to be put up for the protection of passengers near such quarry or place, if in any case referred to in this 4[section] it appears

to them to be necessary in order to prevent imminent danger, and any expense incurred by the Municipality in taking action under this section shall be paid by such owner or other person as aforesaid, and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VIII.

(6) Powers for the prevention of nuisances.

- 127. (1) Whoever deposits, or causes or suffers any member of his Depositing family or household to deposit any dust, dirt, dung, ashes, garden, dust, etc. kitchen or stable refuse, or filth of any kind, or any animal matter, or any broken glass or earthen-ware or other rubbish, or any other thing that is or may be a nuisance, in any street or in any arch under a street, or in any drain beside a street or on any open space or on any quay, jetty or landing-place, or on any part of the sea-shore or the bank of a tidal river, whether above or below highwater mark, or on the bank of any river, water-course or nullah, except at such places, in such manner, and at such hours as shall be fixed by the Municipality, and whoever commits, or suffers any member of his family or household to commit, nuisance in any such place as aforesaid, shall be punished with fine which may extend to twenty-five rupees.
- (2) Whoever throws or puts, or causes or suffers any member of his household to throw or put, any of the matter above described, or, except with the permission of the Municipality, any night-soil into any sewer, drain, culvert, tunnel, gutter or water-course, and whoever commits nuisance, or suffers any member of his family to commit nuisance, in any such drain, culvert, tunnel or water-course, or in such close proximity thereto as to pollute the same, shall be punished with fine which may extend to twenty-five rupees.
- 128. Whoever causes or allows the water of any sink or sewer, or any Dischargother liquid or other matter which is, or which is likely to become ing sewage, offensive from any building or land under his control, to run, drain, or be etc. thrown or put upon any street or open space, or to soak through any external wall, or causes or allows any offensive matter from any sewer or privy to run, drain or be thrown into a surface drain in any street, without the permission in writing of the Municipality, or who fails to comply with any condition prescribed in such permission, shall be punished with fine which may extend to twenty-five rupees.
- 129. Whoever, being the owner or occupier of any building or land, Non-keeps or allows to be kept for more than twenty-four hours, or otherwise removal than in some proper receptacle, any dirt, dung, bones, ashes, night-soil, of filth, etc. filth or any noxious or offensive matter, in or upon such building or land, or suffers such receptacle to be in a filthy or noxious state, or neglects to employ proper means to remove the filth from, and to cleanse and purify, such receptacle, or keeps or allows to be kept in or upon such

building or land any animal in such a way as to cause a nuisance, shall be punished with fine which may extend to twenty-five rupees, and with further fine which may extend to five rupees, for every day on which such offence is continued, after the date of the first conviction.

Removal of night-soil.

- 130. (1) The Municipality may from time to time fix the hours within which only it shall be lawful to remove any night-soil or other such offensive matter.
 - (2) Whoever,
 - (a) when the Municipality have fixed such hours, and given public notice thereof by beat of drum, removes, or causes to be removed, along any street any such offensive matter at any time except within the hours so fixed, or
 - (b) at any time, whether such hours have been fixed by the Municipality or not,
 - (i) uses for any such purpose any cart, carriage, receptacle or vessel not having a covering proper for preventing the escape of the contents thereof, and of the stench therefrom, or
 - (ii) wilfully or negligently slops or spills any such offensive matter in the removal thereof, or
 - (iii) does not carefully sweep and clean every place in which any such offensive matter has been slopped or spilled, or
 - (iv) places or sets down in any public place any vessel containing such offensive matter, or
 - (v) drives or takes or causes to be driven or taken any cart, carriage, receptacle or vessel used for any such purpose as aforesaid, through any street or by any route, other than such as shall from time to time be appointed for that purpose by the Municipality by public notice,

shall be punished with fine which may extend to twenty-five rupees.

Filthy buildings, etc.

- 131. (1) Whoever, being the owner or occupier of any building or land, whether tenantable or otherwise, suffers the same to be in a filthy and unwholesome state, or in the opinion of the Municipality a nuisance to persons residing in the neighbourhood, or overgrown with prickly-pear or rank and noisome vegetation, and who shall not, within a reasonable time after notice in writing by the Municipality to cleanse, clear or otherwise put the same in a proper state have complied with the requisition contained in such notice, shall be punished with fine which may extend to twenty-five rupees, and with further fine which may extend to five rupees for every day on which the failure to comply with the said notice is continued, after the date of the first conviction.
- (2) Should the state of the building be such as in the judgment of the Municipality to render it unfit for human habitation, they may further by written notice prohibit the using thereof for that purpose until it is so rendered fit.

- (3) If any building, by reason of dilapidation, neglect, abandonment, Deserted and disuse or disputed ownership, or of its remaining untenanted and thereby, offensive

 - (a) becoming a resort of idle and disorderly persons, or of persons who have no ostensible means of subsistence, or who cannot give a satisfactory account of themselves, or
 - (b) coming into use for any insanitary or immoral purpose, or
 - (c) affording a shelter to snakes, rats or other dangerous or offensive

is open to the objection that it is a nuisance, or so unwholesome or unsightly as to be a source of discomfort, inconvenience or annoyance to the neighbourhood or to persons passing by such building, the Municipality, if they consider such objection cannot under any other provision of this Act be otherwise removed, may, if there is any person known or resident within the municipal district who claims to be the owner of such building, by written notice directed to such person, require such person, or in any other case by written notice fixed on the door or any other conspicuous part of the building, require all persons claiming to be interested in such building, within a period which shall be specified in the notice and shall not be less than seven days from the date of such notice, to cause such building to be taken down and the materials thereof to be removed, and in the event of non-compliance with such requirement, the Municipality, on the expiration of the period specified as aforesaid, may forthwith cause the building to be taken down and the materials to be removed, and may sell such materials and apply the proceeds to defray any expenses incurred by them in so doing, and all such expenses not thereby defrayed shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VIII.

132. It shall be lawful for the president, vice-president, or any Power to councillor or officer authorized by the Municipality in this behalf, at enter and inspect, etc., any time between sunrise and sunset, on giving such notice as hereinafter buildings. provided, to enter into and inspect all buildings and lands, and by written notice to direct all or any part thereof to be forthwith internally and externally lime-washed or otherwise cleansed for sanitary reasons.

- 133. (1) The Municipality may set apart sufficient public places, or Bathing any part of the sea-shore, not being private property, for the purpose places. of being used as bathing places, and may also provide or set apart a sufficient number of convenient tanks or runs of water for the inhabitants to bathe in; and may also set apart tanks or reservoirs or runs of water for washing animals or clothes, and for all purposes connected with the health, cleanliness and comfort of the inhabitants, and may prohibit the use, for any purpose mentioned in this section, of any or all other public places within the municipal district.
- (2) Copies of all orders passed and notices issued by the Municipality and for the time being in force under this section, shall be kept at the municipal office and shall be open for inspection by the public at all reasonable times.

Regulation of washing of clothes by washermen.

¹ [133A. (1) The Municipality may, by public notice, prohibit the washing of clothes by washermen in the exercise of their calling, except at such places as it shall appoint for this purpose; and when any such prohibition has been made, no person who is, by calling, a washerman shall wash clothes at any place not appointed for this purpose by the Municipality, except for such person himself or for the owner or occupier of such place.

Washing place to be provided by the Municipality for washermen.

- (2) The Municipality shall provide suitable places for the exercise by washermen of their calling and may require payment of such fees for the use of any such place as shall from time to time be determined by it.
- (3) The Municipality shall, before issuing any public notice under subsection (1), publish in such manner as shall in its opinion be sufficient, for the information of persons likely to be affected thereby, a list of washing places proposed to be provided under sub-section (2), together with a notice specifying a date on or after which the list will be taken into consideration; and shall, before finally fixing the said places, receive and consider any objection or suggestion in respect thereto which may be made in writing by any person before the date so specified.]

Fouling water.

- 134. (a) Whoever, in disobedience of any order of the Municipality under section 133, or of any by-laws, bathes in any stream, pool, tank, reservoir, well, eistern, conduit or aqueduct belonging to the Municipality, or washes, or causes to be washed therein, any animal or anything whatever, or throws, puts or easts or causes to enter therein any animal or anything, or causes or suffers to run, drain or be brought thereinto anything that is, or may become, a nuisance, or does anything whatsoever whereby any water therein shall be in any degree fouled or corrupted, and
- (b) whoever without permission of the Municipality, steeps in any tank, stream, or ditch within, or on the boundary of, the municipal district any animal, vegetable or mineral matter likely to render the water of such tank, stream or ditch offensive or a nuisance,

shall be punished with fine which may extend to fifty rupees.

Abatement of nuisances. 135. When any pool, ditch, tank, pond, well, whole or any waste or stagnant water, or any channel or receptacle of foul water or other offensive or injurious matter, whether the same be within any private enclosure or otherwise, shall appear to the Municipality to be likely to prove injurious to the health of the inhabitants or offensive to the neighbourhood, the Municipality may by written notice require the owner of the same to cleanse, fill up, drain off or remove the same, or to take such measures as shall, in their opinion, be necessary to abate or remove the nuisance.

Using offensive manure 136. Whoever, except with the written permission of the Municipality, and in the way, if any, enjoined in such permission, stores or uses nightsoil or other manure or substance emitting an offensive smell, shall be punished with fine which may extend to twenty-five rupees.

- 137. Whoever tethers cattle or other animals, or causes or suffers Tethering them to be tethered by any member of his family or household, in any cattle, etc. public street or place so as to obstruct or endanger the public traffic therein, or to cause a nuisance, or who causes or suffers such animals to stray about without a keeper, shall be punished with fine which may extend to twenty-five rupees.
- ¹[137A. Whoever feeds any animal which is kept for dairy purposes Feeding or is intended for human food on excrementitious matter, stable-refuse, animals filth or other offensive matter, or permits such animal to feed or to be on filth. fed on such matter, shall be punished with fine which may extend to fifty rupees.]
- 138. (1) It shall be lawful for the Municipality to direct by public Consumption notice that every furnace employed, or to be employed, in any works or of smoke. buildings used for the purpose of any trade or manufacture whatsoever within the limits of the municipal district, whether a steam-engine be or be not used or employed therein, shall in all cases be constructed, supplemented or altered so as to consume or burn, or reduce as far as may be practicable, the smoke arising from such furnace.
- (2) If any person shall after such direction use, or permit to be used, any such furnace not so constructed, supplemented, or altered, or shall so negligently use, or permit to be used, any such furnace as that the smoke arising therefrom shall not be effectually consumed or burnt as far as may be practicable, every person so offending, being the owner or occupier of the said works or buildings, or being an agent or other person employed by such owner or occupier for managing the same, shall be punished with fine which may extend to fifty rupees, and upon any subsequent conviction to five hundred rupees:

Provided that nothing in this section shall be held to apply to locomotive engines used for the purpose of traffic upon any railway or for the repair of roads.

(7) Regulation of markets, sale of food, etc.

139. (1) It shall be lawful for the Municipality to direct that no place Licensing shall be used as a market for the sale of animals, meat, fish, fruit or markets and vegetables intended for human food, or as a slaughter-house, excepting slaughter-houses, the public markets or slaughter-houses constructed or opened by the Municipality, or such other markets or slaughter-houses as may have been licensed in writing by the Municipality, who may, at their discretion from time to time, grant, suspend, withhold or withdraw such licenses. either generally or in individual instances.

(2) No person shall, in any municipal district in which by-laws are in force prescribing the conditions on and subject to which, and the circumstances in which, licenses for shops for the sale of such commodities may be granted, refused, suspended or withdrawn, use without a license from the Municipality granted in accordance with by-laws made under clause

- (b) of sub-section (1) of section 48 any place as a shop for the sale of animals, meat or fish, intended for human food, except in a municipal or licensed market.
- (3) Whoever, contrary to such direction or without the license required as aforesaid, or otherwise than in accordance with the conditions on or subject to which such license was granted, sells or exposes for sale any such animals or commodities, or uses or permits the use of a place as a shop for the sale thereof or uses any place as a slaughter-house, shall be punished with fine which may extend to twenty-five rupees.
- (4) Upon a conviction being obtained in respect of any place which has, without, or during the suspension or after the withdrawal of, a license, been used or permitted to be used as a shop for such sale as aforesaid, the Magistrate shall, on the application of the Municipality, but not otherwise, order such place to be closed, and thereupon appoint persons, or take other steps, to prevent such place being so used, and every person, who so uses or permits the use of a place after it has been so ordered to be closed, shall be punished with a fine which may extend to five rupees for each day during which he continues so to use, or permit such use of, the place after it has been so ordered to be closed.
- (5) Nothing contained in this section shall apply to the use of any hotel or eating house for the sale of food served for consumption on the premises.
- 140. (1) The Municipality may from time to time open or close any public market or slaughter-house. They may also either take stallage or other rents or fees for the use by any person of any such market or slaughter-house, or from time to time sell by public auction or otherwise the privilege of occupying any stall or space in, or of otherwise using, any such market or slaughter-house.
- (2) Any person who, without the permission or license of the Municipality, shall sell or expose for sale any article in the said markets or use the said slaughter-houses, shall be punished with fine which may extend to twenty-five rupees.

141. It shall be lawful for the Municipality, with the sanction of the Commissioner or, if authorized by him, of the Collector, to establish slaughter-houses or places for the disposal of carcasses of animals, beyond the limits of the municipal district, and all provisions of this Act and of by-laws in force thereunder relating to such places within municipal limits, shall have full force therein, as if such places were within the municipal limits.

- 142. (1) The president, vice-president or any councillor or officer authorized by the Municipality in this behalf—
 - (a) may at all reasonable times enter into any place for the purpose of inspecting, and may inspect, any animals, carcasses, meat, poultry, game, flesh, fish, fruit, vegetables, com, bread, flour, milk, ghee, butter or other articles intended for human food or drink or for medicine, whether exposed or hawked about for sale, or deposited in, or brought to, any place for the purpose of sale or of preparation for sale, or may

Opening, closing and letting of markets and slaughterhouses.

Slaughterhouses, etc., beyond municipal limits.

Search for and inspection of unwholesome articles. enter into and inspect any place used as a slaughter-house, and may examine anything which may be therein; and

(b) in case any such animals, carcasses, or other articles before mentioned appear to be diseased or unsound or unwholesome or unfit for human food or drink or medicine may seize the same.

Any article which is of a perishable nature may, under the orders of the president, vice-president or chairman of the managing committee or of a committee appointed under section 29 to exercise all or any of the powers vested in the Municipality under this sub-chapter ¹[or of the Municipal Commissioner, if any,] if in his opinion it is diseased, unsound, unwholesome or unfit for food, drink and medicine, forthwith be destroyed.

Every animal and every article which is not of a perishable nature, if seized as aforesaid, shall be taken before a Magistrate.

If it appear to the Magistrate upon sufficient evidence that any such article is diseased or unsound or unwholesome or unfit for human food, drink or medicine, the owner or person in whose possession it was found, not being merely bailee or carrier thereof, shall, if in such case the provitive sions of section 273 of the ²Indian Penal Code do not apply, be punished with fine which may extend to one hundred rupees, and the Magistrate shall cause such article to be destroyed or to be so disposed of as to prevent its being exposed for sale or used for food or drink or medicine.

³(2) In every municipal district in which this sub-section is, by virtue Adulterated of a notification ⁴[issued] under the Bombay Prevention of Adulteration articles for food or I of Act, 1899, ⁵[as if the sub-section were part of section 5 of that Act,] drink. ⁴[899, for the time being in force, and applicable to food of all kinds or of any

specified kind,

if any article to which this sub-section is applicable as aforesaid, is intended for food or drink, and is in any place mentioned in sub-section (I), the president, vice-president or officer authorized as aforesaid, in case such article appears not to be what it is represented to be, may seize the same, and if it appears to a Magistrate upon sufficient evidence that such article is not what it is represented to be, such Magistrate may order the same to be destroyed or to be so disposed of as to prevent its being exposed for sale or used for food or drink, and the owner thereof or the person in whose possession the same was found, not being merely carrier or bailee thereof, shall, if in such case the provisions of section 273 of the ²Indian Penal Code do not apply, be punished with fine which may extend to one hundred rupees.

Explanation.—If such article having been exposed or stored in, or brought to any place mentioned in sub-section (1) for sale as ghee,

contains any substance not exclusively derived from milk, it shall be deemed to be, for the purposes of this sub-section, an article which is not what it is represented to be:

Protection to persons acting in good faith.

Provided that when any article of food referred to in this sub-section appears to the Magistrate not to be what it is represented to be, solely by reason of the fact that there has been added to it some substance not injurious to health, no offence shall be deemed to have been committed by the owner of the article or the person in whose possession the same is found, if such owner or person proves to the satisfaction of the Magistrate—

- (a) that such substance has been added to the article of food. because the same is required for the production or preparation thereof, as an article of commerce, in a state fit for carriage or consumption, and not fraudulently to increase the bulk, weight, or measure of the food or conceal the inferior quality thereof, or
- (b) that in the process of production, preparation or conveyance of such article of food, the extraneous substance has u avoidably become intermixed therewith, or
- (c) that, by a label distinctly and legibly written or printed on or with the said article of food or by other means of public description, he has given sufficient notice that such substance has been so added, or
- - (i) the said article was purchased by him with a written warranty that it was of a certain nature, substance and quality,
 - (ii) he had no reason to believe that it was not of such nature, substance and quality as aforesaid, and
 - (iii) it was not exposed, hawked about, or brought for sale by him otherwise than as an article of the nature, substance and quality specified in the written warranty, and was in the same state in which he purchased it.
- (3) In all prosecutions under this section the Magistrate shall refuse to issue a summons for the attendance of any person accused of an offence against its provisions unless the summons is applied for within a reasonable time from the alleged date of the offence of which such person is
- 1143. The president, vice-president, or any councillor or officer authorized by the Municipality in this behalf, may at all reasonable times enter into any place used for the sale of articles used for human food, and inspect the weights and measures in use, and if the person in charge be found in possession of any false or defective weights or measures, or of weights and measures by the use of which the public may be defrauded, he shall be punished with fine which may extend to two hundred and fifty rupees.

False weights and measures.

(8) Prevention of dangerous diseases.

144. (1) The ¹[Provincial Government] ²[in the case of City Munici-Powers palities, and the Commissioner in other cases,] may at any time confer which by notification on any Municipality designated therein, all or any of the any time be powers specified in sub-section (2), and such Municipality shall, subject conferred. to all such limitations, restrictions, and conditions, if any, as the ¹[Provincial Government] ²[or the Commissioner, as the case may be,] in the same or in any subsequent notification may prescribe in such behalf, exercise within the municipal district every power so conferred on them, for such period as may be specified in this behalf in any such notification, or if no period is so specified then until such power is withdrawn.

- (2) The powers, all or any of which may be conferred under the preceding sub-section, are :-
 - (a) power by orders, which may be either of special or general application, to direct that every medical practitioner, who knows or may have reason to believe that any person whom he has visited in his professional capacity in any dwelling not being a hospital, or that every manager of any factory or educational institution, or every head of a household, who knows or has reason to believe that any person who resides in any dwelling under the management or control of any such manager or head of a household, is suffering from any illness which may reasonably be supposed to be a dangerous disease, shall give information of the same with the least practicable delay to such person as may be designated by the Municipality in that behalf;
 - (b) power to direct or authorize the inspection, without notice. or with such notice as to the person directed or authorized to inspect, appears reasonable, any place in which any dangerous disease is reported or suspected to exist, and the taking of measures to prevent the spread of the disease beyond such place;
 - (c) power to prohibit the removal of water for the purpose of drinking from any well, tank or other place which may appear to the Municipality, on the advice of a medical officer, likely to engender or cause the spread of any dangerous disease;

- (d) power to direct or cause the removal, on a certificate signed by any duly qualified medical practitioner authorized by the Municipality in this behalf, of any person who is without proper lodging or accommodation, or who is lodged in a room or set of apartments occupied by more than one family, and who is suffering from a dangerous disease, to any hospital or place at which persons suffering from the said disease are received for medical treatment;
- (e) power to require by written notice the owner or occupier of any building or part of a building, or a person owning or in charge of any article therein, to cleanse or disinfect such building or part thereof or article, either at his own expense, or in case of poverty, or for other cause which the Municipality in the circumstances of the case consider reasonable, at the expense of the Municipality;
- (f) power to provide the means, and to prescribe places, for disinfecting or washing bedding or other articles which have been exposed to infection from any dangerous disease, and to direct the destruction thereof;
- (g) power-
 - (i) to provide and maintain suitable conveyances for the free carriage of persons suffering from any dangerous disease, and
 - (ii) when such provision is made, to prohibit the conveyance of such persons in all or any public conveyances, and
 - (iii) to direct that any conveyances that may at any time be used for conveying any such person shall be immediately disinfected;
- (h) power to prohibit-
 - (i) any person suffering from any dangerous disease from wilfully exposing himself, without proper precautions against spreading the said disease, in any street or in any school or factory, or in any inn, dharamshala, theatre, market or other place of public resort, or
 - (ii) any person in charge of any person so suffering from so exposing such sufferer;
- (i) power to prohibit any person from removing to another place, or transferring to another person, except for the purpose of disinfection, any article which the person prohibited knows, or has reason to believe, has been exposed to infection of any kind whatsoever from any dangerous disease;

- (j) power to prohibit the letting of or the providing of accommodation in any hotel, inn, dharamshala or serai, in which a person has, or in which there is reason to believe that a person has, been suffering from a dangerous disease, unless and until the person desiring so to let or provide accommodation shall have had the building, or part thereof, and any article therein likely to retain infection, disinfected to the satisfaction of the Municipality or of such officer as the Municipality appoint in this behalf:
- (k) power, with the previous permission in each case of a Magistrate exercising not less than second class powers, to destroy any insanitary huts or sheds in which there is reason to believe that persons have been suffering from dangerous disease.
- (3) The Municipality may, in their discretion, give compensation to any person who sustains substantial loss by the destruction of any property under this section, but, except as allowed by the Municipality. no claim for compensation shall lie for any loss or damage caused by any exercise of the powers specified therein.
- (4) Any person who in a municipal district disobeys any order which Penalties for is for the time being in force therein, and which has been passed by the disobedience to an order Municipality in exercise of any power conferred on such Municipality passed in under this section, or obstructs any officer of the Municipality or other exercise of person acting under the authority of the Municipality in carrying out such powers. executively any such order, shall be punished with fine which may extend to two hundred rupees.

145. (1) In the event of the municipal district or any part thereof Duties of being at any time threatened or visited with an outbreak of any dangerous on threatened disease the Municipality shall take all such measures as they deem or actual necessary for the purpose of preventing, meeting, mitigating or sup-outbreak of pressing such outbreak.

dangerous

(2) In such event as aforesaid the [Provincial Government] [2] in the case of City Municipalities, and the Commissioner in other cases], may by special notification, declaring that such municipal district is threatened or visited with an outbreak of a dangerous disease, confer on the Municipality all or any of the additional powers specified in the following sub-section, and such Municipality shall, subject to such limitations. restrictions and conditions, if any, as the [Provincial Government] ²[or the Commissioner, as the case may be] in the same or in any subsequent notification may prescribe, exercise every such power so conferred on them until the same is withdrawn by means of a like notification.

- (3) The powers all or any of which may be conferred under the preceding sub-section are—
 - (a) power to order, subject to the conditions,
 - (i) that the permission of a Magistrate exercising not less than second class powers shall be in each case first obtained, and
 - (ii) that accommodation for all persons to whom the order refers is available, or shall be provided, elsewhere,
 - the evacuation of an infected building used as a dwelling, or of any part thereof, or of any building so used adjacent to such building, by the person or persons residing, whether habitually or temporarily, therein;
 - (b) power to direct the examination by a medical officer of persons, and if necessary, the disinfection of the clothing, bedding or other suspicious articles belonging to persons, either arriving from places outside the municipal district, or residing in any building adjacent to any infected building, and to direct that any such person shall give his address and present himself daily for medical examination at such time and places as may be prescribed, for a period not exceeding ten days;
 - (c) power to prohibit either generally, or by special order in any individual case, assemblages consisting of any number of persons exceeding fifty, in any place whether public or private, or in any circumstances, or for any purpose, if in the opinion, recorded in writing, of the Civil Surgeon of the district or other medical officer appointed by the ¹[Provincial Government] on this behalf, such assemblages in such place, in such circumstances or for such purpose, would be likely to become a means of spreading the disease or of rendering it more virulent.
- (4) The Municipality may in their discretion give compensation to any person who sustains substantial loss by the destruction of any property under this section; but except as allowed by the Municipality, no claim for compensation shall lie for any loss or damage caused by any exercise of the powers specified therein.

Penal clauses. (5) If in any municipal district in which such declaration under subsection (2) as aforesaid is for the time being in force, any person—

- (a) knowingly disobeys any order which for the time being is in force in such district and which has been passed by the Municipality in exercise of any power conferred on them under section 144 or under this section, or
- (b) obstructs any officer of the Municipality or other person acting under the authority of the Municipality in carrying out executively any such order,

such person shall be punished with fine which may extend to one thousand rupees.

(b) cancel or modify any limitation, restriction or condition prescribed in respect of any such powers, or

(c) cancel any order passed by a Municipality in exercise of any

such power.

- (2) Every order passed by a Municipality in exercise of any such power as aforesaid shall, on the withdrawal of such power, cease to be in force in the municipal district.
- 147. If in any municipal district any infectious disease amongst Duties of cattle, sheep or goats breaks out, or if the introduction of any such Municipality disease appears to be likely, the Municipality shall take all such in respect of measures as they deem necessary for the purpose of preventing, meeting, among cattle, mitigating or suppressing the disease or the outbreak or introduction sheep or thereof.
- 148. (1) Whenever the Municipality consider the interior of Proceedings a building is so overcrowded as to be, or to be likely to become, to abate the dangerous or prejudicial to the health of the inhabitants of that or of overcrowding any neighbouring building, the Municipality may cause proceedings to interiors of be taken before a Magistrate of the first class for the purpose of obtain-buildings. ing an order to prevent such overcrowding.
- (2) Such Magistrate may, on the production of a certificate by Procedure of a medical officer stating his opinion that the overcrowding complained Magistrate. of is likely to cause disease, or risk of disease, and after such further inquiry, if any, as may appear to such Magistrate necessary, require the owner of the building within a reasonable time, not being more than six weeks or less than ten days, to abate the number of lodgers, tenants or other inmates of the said building to such extent as he shall deem necessary to prescribe, or may pass such other order as he shall deem just and proper.

(3) If the owner of the said building shall have sublet the same, the landlord of the lodgers, tenants, or other actual inmates of the same shall for the purposes of this 3[section] be deemed to be the owner of the

building.

(4) It shall be incumbent on any owner, to whom a requisition is issued under sub-section (2), forthwith to give to so many of the lodgers. tenants or other actual inmates of the said building as may be necessary to fulfil the conditions prescribed thereby, written notice to vacate the said building within the period specified in such requisition, and any such lodgers, tenants or inmates receiving such notice shall be bound to comply therewith.

(5) Any owner who after the date specified in any requisition issued under sub-section (2) permits the overcrowding of any building in contravention of such requisition, and any person who omits to vacate any such building in accordance with notice given to him under sub-section (4), shall be punished with fine which may extend to ten rupees for each day subsequent to the date specified in such requisition during which such overcrowding, or such omission to vacate, continues.

Special powers which may be conferred by the Provincial Government in respect of over-crowded areas notified by the Provincial Government.

- 149. (1) If the ¹[Provincial Government] is of opinion that risk of disease has arisen or is likely to arise, either to any occupier in, or to any inhabitants in the neighbourhood of, any area by reason of any of the following defects, namely—
 - (a) the manner in which either buildings, or blocks of buildings, already existing or projected therein, are, or are likely to become crowded together; or
 - (b) the impracticability of cleansing any such buildings or blocks of buildings, already existing or projected; or
 - (c) the want of drainage or scavenging, or the difficulty of arranging therein for the drainage or scavenging of any such buildings or blocks or area as aforesaid; or
 - (d) the narrowness, closeness, bad arrangement or bad condition of the streets or buildings or groups of buildings;

²[it] may by notification confer on the Municipality, to which such area is subject, all or any of the powers specified in sub-section (2), and may, if ²[it] deem necessary, at any time make rules prescribing any limitations, restrictions, modifications, conditions or regulations, subject to which the Municipality shall exercise within that area all powers so conferred, unless and until those powers are withdrawn by a subsequent notification of the ¹[Provincial Government].

- (2) The powers all or any of which may be conferred on a Municipality under sub-section (1) are as follows:—
 - (a) power, when any building or block already existing or in course of erection, by reason of any defect specified in sub-section (1), has given or is in the opinion of the Municipality likely to give rise to such risk as aforesaid, to require by a written notice, to be fixed upon some conspicuous part of such building or block, and addressed as the Municipality deem fit either to the owners thereof, or to the owners of the land on which such building or block is erected or is in course of erection, that the persons so addressed shall, within a reasonable time as shall be specified in the notice, either pull down or remove the said building or block, or execute

such works or take such action in connection therewith as the Municipality deem necessary to prevent all such risk of disease:

- (b) power by municipal or other agency, to pull down or remove the said building or block, or to execute such works or take such action, if the persons addressed in the said notice neglect so to do within the time specified therein;
- (c) power, subject to a right of appeal to the Commissioner, whose decision shall be conclusive, to prohibit by written notice addressed to the owner and occupier of any such site or space, and by general notice published in the manner provided in sub-section (3) of section 154, the erection of any building of or any building exceeding such dimensions as may be specified,
 - (i) on the site of any building which has, in whole or in part, in exercise of the power specified in clause (a), been pulled down, or
- (ii) on any space not occupied by buildings, whether such space is private property or not and whether it is enclosed or not, if the Municipality consider that in order to prevent such risk as aforesaid, such site or space should not be built upon, and either
 - (a) to acquire such site or space, or
 - (b) to prescribe such conditions as may be deemed necessary as to the use which the owner or occupier may make or permit to be made thereof:

Provided that in every case compensation, the amount of which shall, in case of dispute, be ascertained and determined in the manner provided in section 160, shall be paid to any person whose rights are affected by such prohibition.

- (3) When, in pursuance of any notice under sub-section (2), any building has been pulled down, the Municipality shall, unless it has been crected contrary to any provision of this Act or of any by-law in force thereunder, pay to such owner or occupier as may have sustained damage thereby reasonable compensation, the amount of which shall, in case of dispute, be ascertained or determined in the manner provided in section 160.
- (4) In making any rule under sub-section (1) the ¹[Provincial Government] may prescribe a fine not exceeding five hundred rupees for every breach, and a further fine not exceeding twenty rupees a day for every continuing breach of any order made or conditions imposed by the Municipality in exercise of the powers conferred upon them under this section or in pursuance of such rules.

Closing of places for disposal of the dead.

- 150. (1) If the Municipality be of opinion that any place used for the disposal of the dead is in such a state as to be, or to be likely to become, injurious to health, they may submit their opinion with the reasons therefor to the '[Commissioner] and the '[Commissioner] thereupon, after such further inquiry, if any, as he shall deem fit to cause to be made, may by notification direct that such place shall cease to be so used from such date as may be specified on that behalf in the said notification.
- (2) A copy of the said notification together with a translation thereof in the vernacular of the district shall be published in the local newspapers, if any, and shall be posted up at the municipal office and in one or more conspicuous spots on or near the place to which the same relates.
- (3) Any person who buries or otherwise disposes of any corpse in any such place, after the date specified in the said notification for closure of the same, shall be punished with fine which may extend to one hundred rupees.
 - (9) Nuisances from certain trades and occupations.

Regulation of certain trades.

- 151. (1) If it be shown to the satisfaction of the Municipality that any building or place used or intended by any person to be used,
 - (a) for boiling or storing offal, blood, bones or rags;
 - (b) for salting, curing and storing fish;
 - (c) for storing hides, horns or skins;
 - (d) for tanning;
 - (e) for the manufacture of leather or leather goods;
 - (f) for dyeing;
 - (g) for melting tallow or sulphur;
 - (h) for washing or drying wool or hair;
 - (i) as a brick, pottery or lime kiln;
 - (j) for soap-making;
 - (k) for oil-boiling;
 - (l) as a manufactory of sago;
 - (m) as a distillery;
 - (n) for storing hay, straw, fodder, wood, coal or other combustible material;
 - (o) as a manufactory or place of business of any other kind, from which offensive or unwholesome smells arise, or which may involve risk of fire,

is, or is likely by reason of such use and of its situation to become, a nuisance to the neighbourhood, or is so used or is so situated as to be likely to be dangerous to life, health or property, the Municipality may by written notice require the owner or occupier—

- (i) at once to discontinue the use of, or at once to desist from carrying out, or allowing to be carried out, the intention so to use, such place, or
- (ii) to use it in such manner, or after such structural alterations, as the Municipality in such notice prescribes, so that it may not become, or may be no longer, a nuisance or dangerous.
- (2) Whoever, after notice has been given under sub-section (1), uses Liability any place or permits it to be used in such a manner as to be a nuisance to penalty to the neighbourhood or dangerous to life, health or property, shall after notice be punished with fine which may extend to two hundred rupees, and with further fine which may extend to forty rupees for every day on which such use or permission of use is continued after the date of the first conviction.
- (3) Upon a conviction being obtained under this section the Magistrate shall, on the application of the Municipality but not otherwise, order such place to be closed, and thereupon appoint persons or take other steps to prevent such place being used for any purpose mentioned in sub-section (1).
- (4) Whoever uses without a license, or during the suspension or after Penalty for the withdrawal of a license, any place for any purpose mentioned in unlicensed sub-section (I) in any municipal district in which by-laws are for the district in time being in force prescribing the conditions on ¹[or] subject to which, which by-the circumstances in which, and the areas ¹[or] localities in respect laws under of which, licenses for such use may be granted, refused, suspended ¹[or] (I) (b) (iii) withdrawn, shall be punished with fine which may extend to fifty rupees are in force, and with further fine which may extend to ten rupees for every day on which such use is continued after the date of first conviction.

(3) Whoever uses or employs any such whistle or trumpet as aforesaid without, or in contravention of any of the conditions of, or after the withdrawal of, such license shall be punished with fine which may extend to fifty rupees.]

Loitering or importuning for purposes of prostitution. ¹[152. Whoever in any street or public place within the limits of a municipal district loiters for the purpose of prostitution, or importunes any person to the commission of sexual immorality, shall be punished with fine which may extend to fifty rupees:

Provided that no Court shall take cognizance of an offence under this section except on the complaint of the person importuned, or of a Police officer not below the rank of an officer in charge of a police-station and specially authorized in this behalf by the District Magistrate or by the Municipality.]

- (b) if such person is not found, by leaving the notice or bill at his last known place of abode, if within the municipal limits, or by giving or tendering the notice or bill to some adult male member or servant of his family; or
- (c) if such person does not reside within the municipal limits, and his address elsewhere is known to the president or other person directing the issue of the notice or bill, then by forwarding the notice or bill to such person by registered post, under cover bearing the said address; or
- (d) if none of the means aforesaid be available, then by causing the bill or notice to be affixed on some conspicuous part of the building or land, if any, to which the bill or notice
- (2) When any notice under this Act is required or permitted by or service of under this Act to be served upon an owner or occupier of any building notices on or land, it shall not be necessary to name the owner or occupier therein, "occupiers and the service thereof, in cases not otherwise specially provided for of buildings in this Act, shall be effected either
 - (a) by giving or tendering the notice to the owner or occupier, or if there be more owners or occupiers than one, to any one of them; or

(6) In the event of non-compliance with the terms of the notice it shall be lawful for the Municipality to take such action or such steps as may be necessary for the completion of the act thereby required to be done, and all the expenses therein incurred by the Municipality shall be paid by the person or persons upon whom the notice was served, and shall be recoverable in the manner provided in [section 160A].

Punishment for disobedience to orders and notices not punishable under any other section.

155. Whoever disobeys or fails to comply with any lawful direction given by any written notice issued by a Municipality under any power conferred by this chapter, or fails to comply with the conditions subject to which any permission was given to him by the Municipality under any power so conferred, shall, if the disobedience or failure is not an offence punishable under any other section, be punished with fine which may extend to fifty rupees, and with further fine which may extend to five rupees for every day on which the said disobedience or failure continues after the date of the first conviction:

Provided that when the notice fixes a time within which a certain act is to be done, and no time is specified in this Act, it shall rest with the Magistrate to determine whether the time so fixed was a reasonable time within the meaning of this Act.

Municipality in default of owner or occupier may execute works and recover expenses. 156. (1) Whenever, under the provisions of this Act, any work is required to be executed by the owner or occupier of any building or land, and default is made in the execution of such work, the Municipality, whether any penalty is or is not provided for such default, may cause such work to be executed; and the expenses thereby incurred shall, unless otherwise expressly provided in this Act, be paid to them by the person by whom such work ought to have been executed, and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VIII either in one sum or by instalments as to the Municipality may seem fit:

Provided that—

Agreement for construction of drainage and water connections, (a) whenever any drainage scheme or water-works scheme has been commenced by any Municipality, it shall be lawful for the Municipality, without prejudice to their powers under sub-section (1) or section 101 or any other provision of this Act, to make a special agreement with the owner of any building or land as to the manner in which the drainage or water-connection thereof shall be carried out, and the pecuniary or other assistance, if any, which the Municipality shall render, and any payment agreed upon by the owner shall be recovered in accordance with the terms of such agreement, or, in default, in the manner described in sub-sections (2) and (3):

Provided that nothing herein contained shall be taken to affect any special contract made between any such occupier and the owner respecting the payment of the expense of any such works as aforesaid.

Occupiers, in default of owner, may execute works and deduct expenses

157. Whenever default is made by the owner of any building or land in the execution of any work required to be executed by him, the occupier of such building or land may, with the approval of the Municipality, cause such work to be executed, and the expense thereof shall be paid to him by the owner, or the amount may be deducted out of the rent from from his rent. time to time becoming due from him to such owner.

Proceedings if any occupier opposes the execution of the Act.

158. If the occupier of any building or land prevent the owner thereof from carrying into effect, in respect of such building or land, any of the provisions of this Act, after notice of his intention so to carry them into effect has been given by the owner to such occupier, any Magistrate upon proof thereof, and upon application of the owner, may make an order in writing requiring such occupier to permit the owner to execute all such works, with respect to such building or land, as may be necessary for carrying into effect the provisions of this Act, and may also, if he think fit, order the occupier to pay to the owner the costs relating to such application or order; and if, after the expiration of eight days from the date of the order, such occupier continue to refuse to permit such owner to execute such work, such occupier shall, for every day during which he so continues to refuse, be punished with a fine which may extend to fifty rupees; and every such owner during the continuance of such refusal, shall be discharged from any penalties to which he might otherwise have become liable by reason of his default in executing such works.

Entry for purposes of the Act.

159. It shall be lawful for the president or vice-president, or any councillor or officer authorized by the Municipality for such purposes, to enter for the purposes of this Act, between sunrise and sunset, into and upon any building or land, as well for the purpose of making any survey or inspection they may be entitled to make as for the purpose of executing any work authorized by this Act to be executed by them:

Provided that, except when herein otherwise provided, no building or land which may be occupied at the time shall be entered unless with the consent of the occupier thereof, without twenty-four hours' written notice thereof having been given to the said occupier:

Provided also that in the case of buildings used as human dwellings, due regard shall be paid to the social and religious customs of the occupiers.

Arbitration in cases of compensation, etc.

160. (1) If a dispute arises with respect to any 1 [compensation or damages] which are by this Act directed to be paid, the amount, and if necessary the apportionment of the same, shall be ascertained and determined by a panchayat of five persons, of whom two shall be appointed

by the Municipality, two by the party ¹[to or from whom such ²[compensation or damages] may be payable or recoverable] and one, who shall be sir-panch, shall be selected by the members already appointed as above.

- (2) If either party or both parties fail to appoint members, or if the members fail to select a sir-panch within one month from the date of either party receiving written notice from the other of claim to such ²[compensation or damages], such members as may be necessary to constitute the panchayat shall be appointed, at the instance of either party, by the District Judge.
- (3) In the event of the panchayat not giving a decision within one month from the date of the selection of the sir-panch or of the appointment by the District Court of such members as may be necessary to constitute the panchayat, the matter shall, on application by either party, be determined by the District Court which shall, in cases in which the compensation is claimed in respect of land, follow as far as may be the procedure provided by the ³Land Acquisition Act, 1894, for proceedings in matters referred for the determination of the Court;

Provided that—

- (a) no application to the Collector for a reference shall be necessary, and
- (b) the Court shall have full power to give and apportion the costs of all proceedings in any manner it thinks fit.

CHAPTER X.

PROSECUTIONS, SUITS AND POWERS OF POLICE.

161. (1) The Municipality ⁵[and, in the case of offences against any Municipality of the provisions of this Act mentioned in section 183 (d), the chief officer] may prosemay direct any prosecution for any public nuisance whatever, and may cute.

order proceedings to be taken for the recovery of any penalties, and for the punishment of any persons offending against the provisions of this Act, or of any by-law thereunder, and may order the expenses of such prosecutions or other proceedings to be paid out of the municipal fund:

Provided that no prosecution for an offence under this Act shall be instituted except within six months next after the commission of such offence.

Jurisdiction of Magistrate. (2) Any prosecution under this Act or under any by-laws thereunder may, save as therein otherwise provided, be instituted before any Magistrate and every fine or penalty imposed under or by virtue of this Act or any by-law thereunder, and also all claims to compensation or other expenses for the recovery of which no special provision is otherwise made in this Act, may be recovered on application to such Magistrate, by the distress and sale of any moveable property within the limits of his jurisdiction belonging to the person from whom the money is claimable.

Distress lawful though defective in form. 162. No distress levied by virtue of this Act shall be deemed unlawful nor shall any party making the same be deemed a trespasser, on account of any defect or want of form in any summons, conviction or warrant of distress or other proceeding relating thereto, nor shall such party be deemed a trespasser ab initio on account of any irregularity afterwards committed by him; but all persons aggrieved by such irregularity may recover full satisfaction for the special damage in any Court of competent jurisdiction.

Damage to municipal property how made good... 163. If through any act, neglect or default, on account whereof any person shall have incurred any penalty imposed by or under this Act, any damage to the property of the Municipality shall have been committed by such person, he shall be liable to make good such damage as well as to pay such penalty, and the amount of damage shall, in case of dispute, be determined by the Magistrate by whom the person incurring such penalty is convicted, and on non-payment of such damage on demand the same shall be levied by distress, and such Magistrate shall issue his warrant accordingly.

Alternative procedure by suit. 164. In lieu of proceeding by distress and sale, or in case of failure to realise by so proceeding the whole or any part of any amount recoverable under the provisions of Chapter VIII, or of any compensation, expenses, charges or damages awarded under this Act, it shall be lawful for the Municipality to sue in any Court of competent jurisdiction the person liable to pay the same, as also any other person who may have in any other way caused, or may appear likely to cause, any injury to any property, rights or privileges of the Municipality.

165. (1) The Municipality may compound or compromise in respect Power to of any suit instituted by or against them, or, in respect of any claim comproor demand arising out of any contract entered into by them under this Act, for such sum of money or other compensation as they shall deem sufficient:

Provided that, if any sanction in the making of any contract is required by this Act, the like previous sanction shall be obtained for compounding or compromising any claim or demand arising out of such contract.

- (2) The Municipality may make compensation out of the municipal fund to any person sustaining any damage by reason of the exercise of any of the powers vested in them, their officers and servants under this Act.

and in the case of any such suit for damages, if tender of sufficient amends shall have been made before the action was brought, the plaintiff shall not recover more than the amount so tendered, and shall pay all costs incurred by the defendant after such tender.

168. (1) Any Police officer may arrest any person committing in Powers of his view any offence against any of the provisions of this Act or of any Police by-law thereunder, if the name and address of such person be unknown officers. to him, and if he decline to give his name and address, or if the Police

officer have reason to doubt the accuracy of such name and address if given, and such person may be detained at the station-house until his name and address shall be correctly ascertained;

Provided that no person arrested shall be detained without the order of a Magistrate longer than shall be necessary for bringing him before a Magistrate, or than twenfy-four hours at the utmost.

(2) It shall also be the duty of all Police officers to give immediate information to the Municipality of the commission of any offence against the provisions of this Act or of any by-law thereunder, and to assist all municipal officers and servants in the exercise of their lawful authority.

CHAPTER XI.

MUNICIPAL ACCOUNTS.

Presentation of accounts.

169. (1) Every Municipality shall have prepared and laid before them, at their periodical general meetings, complete accounts of the receipts and expenditure of the Municipality since the 1st day of April last preceding, and at a general meeting which shall, if possible, be held on such day between the 10th January and the 1st of March as may be fixed in this behalf by the rules of the Municipality, a complete account of the actual and expected receipt and expenditure for the financial year ending on the 31st March next following, together with a budget estimate of the income and expenditure of the Municipality for the financial year to commence on the 1st April next following.

Budget Estimates.

- (2) The Municipality shall thereupon decide upon the appropriations, and the ways and means contained in the budget of the year to commence on the 1st April next following. The budget so sanctioned may be varied or altered from time to time, as circumstances may render desirable, at a special general meeting called for the purpose.
- (3) The Municipality shall at the general meeting in April, or after audit of the past year's accounts, if such audit has not before that general meeting taken place, pass the accounts of the past year.

Audit of accounts.

170. ¹[(1) Independently of the audit provided for under the provisions of the Bombay Local Fund Audit Act, 1930, the municipal accounts Bom. may be audited at such intervals and by such agency as may be prescribed XXV in the rules of the municipality.]

- (2) The auditor, or auditors, shall, for the purposes of their office, have access to all the accounts and other records of the Municipality.
- (3) The Municipality shall pay from the Municipal fund such charges for the audit as may be agreed upon.1 2*
- 171. The Municipality shall as soon as the annual accounts have Transmission been finally passed by them, transmit to the 3[Provincial Government] of accounts or any officer duly authorized by '[it,] in this behalf, a copy thereof, or an Government. account in such form as the 3[Provincial Government] may prescribe, and shall furnish such details and vouchers relating to the same as the ³[Provincial Government] or such officer may from time to time direct.
- 172. The quarterly and annual accounts of receipts and expenditure, Publication and the budget when sanctioned, shall be open to public inspection, and of accounts. shall be published in the vernacular language of the district in such manner as the Municipality may prescribe in this behalf.

CHAPTER XII.

CONTROL.

173. (1) The Collector shall have power-

(a) to enter on and inspect, or cause to be entered on and inspected, Collector's any immoveable property occupied by any Municipality, or any work powers of in progress under them or under their direction;

and supervision.

- (b) to call for any extract from the proceedings of any Municipality or of any committee or for any book, or document in the possession of or under the control of a Municipality, and any return, statement, account, or report which he may think fit to require such Municipality to furnish;
- (c) to require a Municipality to take into their consideration any objection which appears to him to exist to the doing of anything which is about to be done or is being done by such Municipality, or any information which he is able to furnish and which appears to him to necessitate the doing of a certain thing by the Municipality, and to make a written reply to him within a reasonable time stating their reasons for not desisting from doing, or for not doing, such thing.
- (2) All or any of the powers given to the Collector by this section may be delegated by him to the Assistant or Deputy Collector in charge of a taluka in so far as concerns any Municipality other than a City Municipality in such taluka.

Collector's powers of suspending execution of orders, etc., of Municipalities.

174. (1) If, in the opinion of the Collector, the execution of any order or resolution of a Municipality, or the doing of anything which is about to be done or is being done by or on behalf of a Municipality, is causing or is likely to cause injury or annoyance to the public, or to lead to a breach of the peace, or ^{1*} is unlawful, he may, by order in writing under his signature, suspend the execution or prohibit the doing thereof.

Collector's order to be reported to Commissioner, who may confirm or modify it.

(2) When a Collector makes any order under this section, he shall forthwith forward to the Commissioner and to the Municipality affected thereby a copy of the order, with a statement of the reasons for making it; and it shall be in the discretion of the Commissioner to rescind the order, or to direct that it continue in force with or without modification, permanently or for such period as he thinks fit.

Every case under this section to be reported to Provincial Government for their final orders.

(3) The Commissioner shall forthwith submit to the ²[Provincial Government] a report of every case occurring under this section, and the ²[Provincial Government] may revise or modify any order made therein, and make in respect thereof any other order which the Commissioner could have made.

final order: Extraordinary powers of Collector in case of emergency.

- 175. (1) In cases of emergency the Collector may provide for the execution of any work, or the doing of any act, which a Municipality are empowered to execute or do, and the immediate execution or doing of which is, in his opinion, necessary for the health or safety of the public, and may direct that the expense of executing the work or doing the act, with a reasonable remuneration to the person appointed to execute or do it, shall be forthwith paid by the Municipality.
- (2) If the expense and remuneration are not so paid, the Collector may make an order directing any person, who for the time being has custody of any moneys on behalf of the Municipality, to pay such expense and remuneration from such moneys as he may have in his hands or may from time to time receive, and such person shall be bound to obey such order.
- (3) The provisions of sub-sections (2) and (3) of section 174 shall apply, so far as may be, to any order made under this section.

Power of Commissioner to prevent extravagance in the employment of establishment. 176. If in the opinion of the Commissioner the number of persons who are employed by a Municipality as officers or servants, or whom a Municipality propose to employ, or the remuneration assigned by the Municipality to those persons, or to any particular person, is excessive, the Municipality shall, on the requirement of the Commissioner, reduce the number of the said persons or the remuneration of the said person or persons:

- (iv) to require that all or any of the powers referred to in section 144 or in section 145 (if the conditions under which that section comes into operation exist) shall be delegated by any such Municipality, whether there be a chief officer or not, to the president, vicepresident or any such councillor as the [Provincial Government] may deem fit.
- (2) Any requisition issued to the Municipality under clause (i), (iii) or (iv) of sub-section (1) above shall be complied with within such time as the [Provincial Government] may in each case prescribe in that behalf.
- 178. (1) When the [Provincial Government] is informed, on complaint Power of made or otherwise, that a Municipality have made default in performing Provincial any duty imposed on them by or under this Act, or by or under any Government enactment for the time being in force, the [Provincial Government], if performance satisfied after due inquiry that the Municipality have been guilty of the of duties in alleged default, may direct the Commissioner to fix a period for the default of Municipality. performance of that duty.
- (2) If that duty is not performed within the period so fixed, the Commissioner may appoint some person to perform it, and may direct that the expense of performing it, with a reasonable remuneration to the person appointed to perform it, shall be forthwith paid by the Municipality.

1(3) If the expense and remuneration are not so paid, the Commissioner may make an order directing the bank in which any moneys of the municipality are deposited or the person in charge of the 2 Provincial Government] Treasury or of any other place of security in which the moneys of the municipality are deposited to pay such expense and remuneration from such moneys as may be standing to the credit of the municipality in such bank or may be in the hands of such person or as may from time to time be received from or on behalf of the municipality by way of deposit by such bank or person; and such bank or person shall be bound to obey such order. Every payment made pursuant to such order shall be a sufficient discharge to such bank or person from all liability to the municipality in respect of any sum or sums so paid by it or him out of the moneys of the municipality so deposited with such bank or person.

Power of Provincial Government to supersede Municipality in case of incompetency, default or abuse of \ powers.

- 179. (1) If, in the opinion of the ³[Provincial Government], any Municipality are not competent to perform, or persistently make default in the performance of, the duties imposed on them by or under this Act, or otherwise by law, or exceed or abuse their powers, the ³[Provincial Government may, by an order published, with the reasons for making it, in the 4[Official Gazette] declare the Municipality to be incompetent or in default, or to have exceeded or abused their powers, as the case may be, and ⁵ [may dissolve such municipality or] supersede them for a period to be specified in the order.
- ⁶[(2) On the dissolution of a Municipality under sub-section (1) the term of office of the councillors of such municipality shall terminate and elections of councillors shall be held under the provisions of this Act or rules made thereunder applicable thereto, on or before a date to be specified by 7[the Provincial Government] in this behalf in the aforesaid order.]

Consequences of supersession.

- (2) No such officer shall, save with the previous sanction of the ¹[Provincial Government], be removable from office unless by the votes of at least three-fourths of the whole number of councillors.

Powers of chief officer,

(b) for any other municipal district on the application of the Municipality in this behalf, provided that such application has been previously supported by not less than two-thirds of the whole number of councillors.

Population how ascertained. (2) The population of a municipal district shall be deemed to be the population as ascertained in the latest census taken in such municipal district, unless the ¹[Provincial Government] thinks fit to direct that a special census may be taken in such municipal district for the purpose of ascertaining the population, whereupon the population shall be deemed to be the population as ascertained in such special census.

Subsequent reduction of population.

(3) When the appointment of a Municipal Commissioner has been once made for a municipal district which contained at that time a population of not less than one hundred thousand inhabitants as ascertained in sub-section (2), such appointment shall not cease by reason only of the fact that the population of such municipal district has fallen short of one hundred thousand inhabitants.

Appointment of chief officer to cease on appointment of a Municipal Commissioner. (4) On the appointment of a Municipal Commissioner the appointment of a chief officer, whether made under section 177 or section 182, shall forthwith terminate: provided that the appointment of a Municipal Commissioner shall not be made until such notice has been given to the chief officer, if any, as the terms of his appointment entitle him to receive and until the expiry of the period specified in such notice.

Discontinuance of appointment. (5) The ¹[Provincial Government] may at any time discontinue the appointment of a Municipal Commissioner for any municipal district for which such appointment has been made.

Term of office.

186B. (1) A Municipal Commissioner shall hold office for a period of three years, in the first instance, and thereafter for such further period as the ¹[Provincial Government] may in each case determine.

Removal from office.

- (2) A Municipal Commissioner may be removed from office at any time by the ¹[Provincial Government] if it shall appear to the ¹[Provincial Government] that he is incapable of performing the duties of his office or has been guilty of any misconduct or neglect which renders his removal expedient.
- (3) A Municipal Commissioner shall be forthwith removed from office by the ¹[Provincial Government] on the application of the Municipality in this behalf, provided that such application has been previously supported by not less than three-fourths of the whole number of councillors.

Salary of Municipal Commissioner. 186C. (1) A Municipal Commissioner shall receive from the municipal fund such monthly salary as the Municipality shall, subject to the approval of the ¹[Provincial Government], from time to time determine.

- 186F. (1) The Municipality may require the Municipal Commissioner to furnish them with—
 - (a) any return, statement, estimate, statistics or other information regarding any matter appertaining to the administration of this Act or to the municipal government of the municipal district;
 - (b) a report on any such matter;
 - (c) a copy of any document in his charge.
- (2) The Municipal Commissioner shall comply with every such requisition without unreasonable delay.

Powers of Municipal Commissioner and limitations thereon.

 - (c) no contract for the purchase, sale, lease, mortgage or other transfer of immoveable property shall be entered into by the Municipal Commissioner except with the approval or sanction of the Municipality;
 - (d) no contract which will involve an expenditure exceeding five hundred rupees shall be made by the Municipal Commissioner except with the approval or sanction of the Municipality;
 - (e) every contract made by the Municipal Commissioner involving an expenditure exceeding two hundred and fifty rupees and not exceeding five hundred rupees shall be reported by him, within fifteen days after the same has been made, to the Municipality;
 - (f) the foregoing provisions of this section shall apply to every variation or discharge of a contract as to an original contract.

Mode of executing contracts.

1860. (1) Notwithstanding anything contained in sub-sections (6) and (7) of section 40, every contract entered into by a Municipal Commissioner on behalf of a Municipality shall be entered into in such manner and form as would bind such Municipal Commissioner if such contract were on his own behalf, and may in the like manner and form be varied or discharged:

Provided that—

- (a) Where any such contract, if entered into by a Municipal Commissioner, would require to be under seal, the same shall be sealed with the common seal of the Municipality, and
- (b) every contract for the execution of any work or the supply of any materials or goods which will involve an expenditure exceeding five hundred rupees shall be in writing and shall be sealed with the common seal of the Municipality and shall specify the work to be done or the materials or goods to be supplied, as the case may be, the price to be paid for such work, materials or goods and, in the case of a contract for work, the time or times within which the same or specified portions thereof shall be completed.
- (2) The common seal of the Municipality shall not be affixed to any contract, or other instrument, except in the presence of two members of the Managing Committee, who shall attach their signatures to the contract or instrument in token that the same was sealed in their presence. The signatures of the said members shall be distinct from the signatures of any witnesses to the execution of any such contract or instrument.
- (3) No contract not executed in the manner provided in this section shall be binding on the Municipality.
- 186P. (1) Except as is otherwise provided in sub-section (3), Tenders to be a Municipal Commissioner shall, at least seven days before entering into invited for any contract for the execution of any work or the supply of any materials involving or goods which will involve an expenditure exceeding one thousand expenditure rupees, give notice by advertisement in the local newspapers, inviting exceeding Rs. 1,000. tenders for such contract.

- (2) A Municipal Commissioner shall not be bound to accept any tender which may be made in pursuance of such notice, but may accept, subject to the provisions of clause (d) of section 186N, any of the tenders so made which appears to him, upon a view of all the circumstances. to be the most advantageous or may reject all the tenders submitted to him.

(3) Where any property and rights vest in His Majesty under subsection (1), the proceeds thereof shall, after satisfying all charges and liabilities affecting the same, be applied for the benefit of the inhabitants of the said area in such manner as '[the Provincial Government] may think fit."

Whereas it is expedient to amend and consolidate the law relating to Preamble. the Police in the City of Bombay;

AND WHEREAS the previous sanction of His Excellency the Governor 55 and General, required by section 5 of the Indian Councils Act, 1892, has 56 been obtained for the passing of this Act; c. 14.

It is enacted as follows :-

CHAPTER I.

PRELIMINARY.

Short title.

1. (1) This Act may be cited as the City of Bombay Police Act, 1902.

Local extent.

- (2) Sections 27, 1* 62, 68, 97, 99, 101, ²[102, ³and 110-A] extend to the whole of the Presidency of Bombay.
 - (3) The rest of the Act extends only to the City of Bombay.

Repeal of enactments.

- 2. (1) The enactments mentioned in Schedule A are repealed to the extent specified in the fourth column of the said Schedule.
- (2) All references made in any enactment of the Governor of Bombay in Council to any enactment hereby repealed shall be read as if made to the corresponding provisions of this Act.

Saving of Appointments, etc. (3) All rules prescribed, appointments made, powers conferred and orders and certificates issued under any enactment hereby repealed shall, so far as they are consistent with this Act, be deemed to have been respectively prescribed, made, conferred and issued thereunder.

Definitions.

- 3. In this Act, unless there is something repugnant in the subject or context,—
 - (a) the phrases "complaint," "investigation," "offence," "cognizable offence," "non-cognizable offence," "bailable offence" and "non-bailable offence" shall respectively have the meanings assigned thereto by the Code of Criminal Procedure;

- (b) "Police officer" shall mean any member of the Police force for the City of Bombay appointed under this Act, and shall include the Commissioner of Police, a Deputy or Assistant Commissioner of Police, and subject to the provisions of sub-section (2) of sections 9 and 10, an additional or special Police officer;
- (c) "officer in charge of a section" shall include, when the Inspector in charge of the section is absent or unable from illness or other cause to perform his duties, the next senior Police officer in the section, or such other officer as the Superintendent of the Division may, subject to the sanction of the Commissioner of Police, appoint in that behalf;

- (d) 1" cattle" shall, besides horned cattle, include elephants, camels, horses, mares, geldings, ponies, colts, fillies, asses, mules, sheep, lambs, rams, ewes, goats, kids and swine;
- (e) "prescribed" shall mean prescribed by any rules made under this Act;
- (f) "sign" shall, with reference to a person who is unable to write his name, include "mark";
- (g) "place of public amusement" shall mean any place, enclosure, building, tent, booth or other erection, whether permanent or temporary, where music, singing, dancing or any diversion or game, or the means of carrying on the same, is provided, and to which the public are admitted either on payment of money, or with the intention that money may be collected from those admitted 2* * * and shall include a race-course, circus, theatre, music hall, billiard-room, bagatelle-room, gymnasium or fencing school;
- (h) "place of public entertainment" shall mean any place, whether enclosed or open, to which the public are admitted, and where any kind of food or drink is supplied for consumption on the premises for the profit or gain of any person owning or having an interest in or managing such place;
- and shall include a refreshment-room, eating-house, coffee-house, liquor-house, boarding-house, lodging-house, hotel, tavern or wine, beer, spirit, arrack, toddy, ganja, bhang, or opium shop;
- (i) "street" shall mean any road, footway, square, court, alley or passage, whether a thoroughfare or not, to which the public have permanently or temporarily a right of access;
- (j) "public place" shall include the foreshore, the precincts of every public building or monument, and all places accessible to the public for drawing water, washing or bathing, or for purposes of recreation;
- (k) "vehicle" shall mean any carriage, cart, van, dray, truck, hand-cart or other wheeled conveyance of any description capable of being used on the streets of the City; and shall include a bicycle, tricycle or automotor car;
- ³(l) the expressions "appointment" and "removal", with their respective grammatical variations used in relation to an office shall, when also used with reference to any member of the Indian Police, be construed to mean respectively, appointment to, and transfer from, the said office:
- '[(m) "subordinate ranks" shall mean any ranks below that of Deputy Superintendent.]

CHAPTER II.

OF THE POLICE FORCE, AND ADDITIONAL AND SPECIAL POLICE.

Constitution of Police Force.

- 4. For the City of Bombay there shall be a Police force, the strength and constitution of which shall be as may¹ * * * * from time to time be ordered by the ²[Provincial Government].

Appointment of Deputies and Assistants to the Commissioner of Police. Powers of Deputy and Assistant Commissioners and Sup-

erintendents.

- 6. (1) The ²[Provincial Government] may from time to time appoint one or more Deputy Commissioners of Police and one or more Assistants to the Commissioner of Police. 4* * * *
- (2) Every such Deputy Commissioner shall be competent to exercise and perform, under the orders of the Commissioner of Police, any of the powers conferred upon and duties assigned to the Commissioner of Police by or under this Act or any other enactment: and every such Assistant Commissioner ⁵[and a Superintendent appointed under section 7 (1)] shall exercise such powers and perform such duties as may from time to time be delegated or assigned to him by the Commissioner of Police:

Provided that the powers conferred upon the Commissioner of Police by sections 22 and 56 shall not be exercisable by a Deputy or Assistant Commissioner ⁵[or Superintendent] under this sub-section.

7. ⁶(1) [Power to appoint and promote.]

Power to dismiss, discharge, reduce, suspend, fine and confine in a police station. (2) The Commissioner of Police may, subject to such rules and in accordance with such procedure as the ²[Provincial Government] may from time to time prescribe in this behalf, at any time—

(a) dismiss, discharge, reduce, suspend, or to the extent of half a month's pay fine, any member 7 of the subordinate ranks of

the Police force] for neglect or violation of duty, or for any breach of any rules or orders issued by him under this Act, or for gross misconduct while on leave; or

(b) punish by confinement in a police station for a period not exceeding three days any member of the Police force below the rank of Havaldar who is in his presence grossly insubordinate or insolent:

- (3) Nothing in sub-section (2) shall affect any Police officer's liability Saving to a criminal prosecution for any offence with which he may be clause. charged.
- (2) Every certificate shall become null and void whenever the person force named therein ceases, for any reason, to belong to the Police force.
- (3) The powers, functions and privileges vested in a Police officer shall Effect of be temporarily suspended whilst such Police officer is suspended from of Police office. Such Police officer shall not, by reason of such suspension, cease officer. to be a Police officer, but shall continue subject to the same responsibilities and disabilities, and subject to the same authorities, as if no such suspension had taken place.
- 9. (1) The ³[Provincial Government] may ^{4***} appoint, for such power to time and on such pay, and of such rank or grade, as ⁵[it] shall think fit, appoint additional Police officers to keep the peace or preserve order at any place, ditional Police or to enforce any of the provisions of this or any other Act in respect of officers. any particular class or classes of offences,—
 - (a) on the application of any person, at the charge of such person, or
 - (b) without such application, at the charge of any person for whose profit or benefit any large work, or any public amusement, likely to impede traffic or attract a large concourse of people, is being carried on.

- (2) Every additional Police officer so appointed shall, on appointment,—
 - (a) receive a certificate in the prescribed form;
 - (b) be vested with all or such of the powers, privileges and duties of a Police officer as are specially mentioned in the certificate; and
 - (c) be subject to the orders of the Commissioner of Police.

Notice to be given for discontinuance. (3) In any case in which such Police officers are appointed on the application of any person, such person may, by giving notice in writing, require that on the expiry of one month from the receipt by the Commissioner of Police of such notice or on the expiry of such shorter period as the Commissioner of Police may fix, the appointment of such Police officers shall cease.

Payments to be accounted for. (4) All moneys received by the Commissioner of Police for the payment of any such additional Police officers shall be accounted for by him.

Disputes as to payment of cost. (5) In the event of any dispute in any case under this section the decision of the Chief Presidency Magistrate shall be conclusive as to the amount to be paid, and as to the person by whom it is to be paid, and the sum so ascertained may, on the requisition of the Commissioner of Police; be recovered by the Collector from such person as an arrear of land revenue.

Appointment of special Police officers.

- 10. (1) The Commissioner of Police, of his own authority, may at any time appoint any able-bodied male person between the ages of 18 and 55 to be a special Police officer to assist the Police force on any occasion when he has reason to apprehend the occurrence of any riot or grave disturbance of the peace and he is of opinion that the ordinary Police force is not sufficient for the protection of the inhabitants and for the security of property.
 - (2) Every special Police officer so appointed shall, on appointment,-
 - (a) receive a certificate in the prescribed form;
 - (b) have the same powers, privileges and protection as a Police officer;
 - (c) perform all such duties as may be assigned to him by the Commissioner of Police; and
 - (d) be subject to the orders of the Commissioner of Police.

Refusal to serve or perform duties. (3) Any person who having been appointed a special Police officer under this section shall, without sufficient excuse, neglect or refuse to serve as such or to obey any lawful order or direction that may be given to him for the performance of his duties, shall be punished with fine which may extend to fifty rupees.

- (c) vexatiously and unnecessarily detains, searches or arrests any person,
- (d) vexatiously and unnecessarily delays forwarding any person arrested to a Magistrate or to any other authority to whom he is legally bound to forward such person,
- (e) offers any unnecessary personal violence to any person in his custody, or
- (f) holds out any threat or promise not warranted by law to an accused person,

shall for every such offence be punished with imprisonment for a term which may extend to six months, or with fine which may extend to five hundred rupees, or with both.

False statement to obtain employment. 20. Any person who knowingly makes a false statement or uses a false document for the purpose of obtaining for himself or any other person employment or release from employment as a Police officer, shall be punished with imprisonment for a term which may extend to three months, or with fine which may extend to one hundred rupees, or with both.

Saving in regard to District and Railway Police.

21. Subject to the provisions of the ¹Police Act, 1888, and save in so II far as the operation of this section may be temporarily suspended by the ¹⁸ special order of the ²[Provincial Government], nothing in this Chapter shall be deemed to affect any officers of the District or Railway Police employed within the limits of the City of Bombay on Police functions connected with the administration of any district or railway, as the case may be, and any such Police officer shall in the discharge of such functions be vested with the powers and privileges, and be subject to the liabilities, of a Police officer of the establishment to which he belongs.

CHAPTER III.

Police Regulations.

Rules for preservation of order.

- 22. (1) [In the case of rules under 2[clauses (b) and (c)], subject to Power to the control of the ³[Provincial Government], and in other cases] with make rules for regulathe previous sanction of the ³[Provincial Government], the Commissioner tion of traffic of Police may from time to time make, alter or rescind rules not and for inconsistent with this Act.—

 - (a) for licensing and controlling persons offering themselves for in public employment at quays, wharves and landing-places, and outside places, etc. Railway stations, for the carriage of passengers' baggage, and fixing and providing for the enforcement of a scale of charges for the labour of such persons so employed;
 - (b) regulating traffic of all kinds in streets and public places, and the use of streets and public places by persons riding, driving, cycling, walking or leading or accompanying cattle, so as to prevent danger, obstruction or inconvenience to the public;
 - (c) regulating the conditions under which vehicles may remain standing in streets and public places, and the use of streets as halting places for vehicles or cattle;
 - (d) prescribing the number and position of lights to be used on vehicles in streets and public places, and regulating and controlling the manner and mode of conveying timber, scaffold poles, ladders, iron girders, beams or bars, boilers or other unwieldy articles through the streets, and the route and hours for such conveyance;
- (e) prescribing, subject to any notice issued by the Municipal Bom. III of Commissioner under clause (c) of section 441 of the City of Bombay 1888. Municipal Act, 1888, the roads along which, and the hours during which, corpses may, or may not, be carried;
 - (f) for licensing, controlling or, in order to prevent the obstruction. inconvenience, annoyance, risk, danger or damage of the residents or passengers in the vicinity, prohibiting,-
 - (i) the keeping of places of public amusement or entertainment,
 - (ii) the playing of music in streets and public places.
 - (iii) the illumination of streets and public places and the exteriors of buildings abutting thereon by persons other than 4[servants of the Crown or Municipal officers] duly authorized in that behalf,
 - (iv) the carrying in streets and public places of gunpowder or any other explosive substance, and
 - (v) the blasting of rocks:

- (g) regulating the means of entrance and exit at places of public amusement, entertainment and assembly, and providing for the maintenance of public safety and the prevention of disturbance therein; and
- (h) prescribing the procedure in accordance with which any license or permission sought to be obtained or required under this Act should be applied for, and fixing the fees to be charged for any such license or permission;

Saving of provisions of Bombay Abkari Act and other enactments. Provided, firstly, that nothing in this section and no license granted under any rule made thereunder shall authorize any person to import, export, transport, manufacture, sell or possess any liquor or intoxicating drug, in respect of which a license, permit or pass is required under the Bombay Abkari Act, 1878, or under any other law for the time being in Bom. force relating to the Abkari revenue, or shall affect the liability of any 1878. person under any such law, or shall in any way affect the provisions of XI of the ¹Arms Act, 1878, or of the ¹Explosives Act, 1884, or of any rules 1878. made under either of those enactments, or the liability of any person 1884, thereunder:

Saving in regard to licensing places of public entertainment. Provided, secondly, that no rule under clause (f) shall contain any regulation requiring a license for any place of public entertainment unless spirituous liquor, toddy or any intoxicating drug, as defined in the Bombay Abkari Act, 1878, or opium, as defined in the ¹Opium Act, Bom. 1878, is sold in such place, or unless such place is kept open for customers V of 1878. between the hours of nine at night and five in the morning.

Provisions as to publication of rules.

(2) The power of making, altering or rescinding rules under sub-section (1) shall be subject to the condition of the rules being made, altered or rescinded after previous publication in the manner specified in section 23 x of of the ¹General Clauses Act, 1897, and every rule made, or alteration or ¹⁸⁹⁷. rescission of a rule made, under the said sub-section and sanctioned by the ²[Provincial Government], shall be published in the ³[Official Gazette] and in the manner specified in section 137.

Power of Commissioner of Police to prohibit keeping of place of public amusement or entertainment. (3) Notwithstanding anything hereinbefore contained in this section or which may be contained in any rule made thereunder, it shall always be lawful for the Commissioner of Police to refuse a license for, or to prohibit, the keeping of any place of public amusement or entertainment by a person of notoriously bad character.

Special Orders.

23. (1) The Commissioner of Police and, subject to the orders of the Powers of Commissioner of Police, every Police officer not inferior in rank to an Commis-Inspector may, from time to time as occasion may require, but not so as Police and of to contravene any rule under the preceding section, give all such orders other officers either orally or in writing as may be necessary to-

to give directions to the public.

- (a) direct the conduct of, and behaviour or action of persons constituting, processions and assemblies in streets;
- (b) prescribe the routes by which and the times at which any such processions may, or may not, pass;
- (c) prevent obstructions on the occasion of all processions and assemblies and in the neighbourhood of all places of worship during the time of public worship, and in all cases when any street or public place or place of public resort may be throughd or liable to be obstructed;
- (d) keep order on and in all streets, quays, wharves, landing-places and all other public places or places of public resort;
- (e) regulate and control music or singing in any street or public place, and the beating of drums, tom-toms and other instruments and the blowing or sounding of horns or other noisy instruments, in or near any street or public place; or
- (f) prevent, upon complaint made in writing by any person to the Commissioner of Police, the continuance of music or other such sounds as aforesaid in any place, if the Commissioner of Police be satisfied that the same is a nuisance and ought to be summarily stopped either on account of the serious illness of, or because it seriously interferes with the reasonable occupations of, any person resident or lawfully engaged in the neighbourhood:

Provided that in any case where the continuance of music or other sounds as aforesaid is so prevented, it shall be lawful for a Magistrate, upon the complaint of any person aggrieved, and if satisfied that the order complained of is unreasonable under the circumstances, to alter or reverse such order as he deems fit, and the Commissioner of Police shall give effect to any such alteration or reversal.

- (2) The Commissioner of Police may also, whenever and for such time Power to give as he shall consider necessary for the preservation of the public peace or prohibitions as he shall consider necessary for the preservation of the public peace of to for preven-public safety by a notification publicly promulgated or addressed to for preven-tion of disindividuals, prohibit
 - order.
 - (a) the carrying of swords, spears, bludgeons, guns, or other offensive weapons, in any public place:
 - (b) the carrying, collection and preparation of stones or other missiles or instruments or means of casting or impelling missiles;

- (c) the exhibition of persons or of corpses, or figures or effigies, in any public place;
- (d) the public utterance of cries, singing of songs, playing of music; and
- (e) the delivery of harangues, the use of gestures or mimetic representations, and the preparation, exhibition or dissemination of pictures, symbols, placards, or of any other object or thing, which may be of a nature to outrage morality or decency, or which, in the opinion of the Commissioner of Police, may probably inflame religious animosity or hostility between different classes, or incite to the commission of an offence, to a disturbance of the public peace or to resistance to or contempt of the law or of a lawful authority.

Power to prohibit assembly or procession.

(3) The Commissioner of Police may also by order in writing prohibit any assembly or procession whenever and for so long as he considers such prohibition to be necessary for the preservation of the public peace or public safety:

Provided that no such prohibition shall remain in force for more than seven days without the sanction of the 1[Provincial Government].

Power to reserve street or public place for public purpose.

(4) The Commissioner of Police may also, 2* * by public notice, temporarily reserve for any public purpose any street or public place, and prohibit persons from entering the area so reserved, save under such conditions as may be prescribed by the Commissioner of Police.

Issue of orders by Commissioner of Police for prevention of riot, etc.

24. (1) In order to prevent or suppress any riot or grave disturbance of the peace, the Commissioner of Police may temporarily close or take possession of any building or place, and may exclude all or any persons therefrom, or may allow access thereto to such persons only and on such terms as he shall deem expedient. All persons concerned shall be bound to conduct themselves in accordance with such orders as the Commissioner of Police may make and notify in the exercise of the authority hereby vested in him.

Compensaoccupier of building or session of by Commissioner of Police.

(2) If the lawful occupier of such building or place suffers substantial tion to lawful loss or injury by reason of the action of the Commissioner of Police under this section, he shall be entitled, on application made to the Commisplace closed sioner within one month from the date of such action, to receive or taken pos- reasonable compensation for such loss or injury, unless such action was in the opinion of the Commissioner of Police rendered necessary either by the use to which such building or place was put or intended to be put or by the misconduct of persons having access thereto.

25. (1) In any case of an actual or intended religious or ceremonial Issue of or corporate display or exhibition or organised assemblage in any street orders for or public place, as to which or the conduct of or participation in which of order at it shall appear to the Commissioner of Police that a dispute or contention religious exists which is likely to lead to grave disturbance of the peace, the Com-ceremonials, missioner of Police may give such orders as to the conduct of the persons concerned towards each other and towards the public as he shall deem necessary and reasonable under the circumstances, regard being had to the apparent legal rights and to any established practice of the parties and of the persons interested. Every such order shall be published in the section or place wherein it is to operate, and all persons concerned shall be bound to conform to the same.

(2) Any order under sub-section (1) shall be subject to a decree, Orders to be injunction or order made by a Court having jurisdiction, and shall be subject to recalled or altered on its being made to appear to the Commissioner of of Courts. Police that it is inconsistent with a judgment, decree, injunction or order of such Court, on the complaint, suit or application of any person interested, as to the rights and duties of any persons affected by the order aforesaid.

26. (1) For the purpose of preventing serious disorder or breach of Police to the law or manifest and imminent danger to the persons assembled at prevent disany place of public amusement or at any assembly or meeting to which places of the public are invited or which is open to the public, the Police officer of public amusehighest rank, superior to that of Havaldar, present 1[at] such place of ment, etc. public amusement 2* * or such assembly or meeting 3* * * may, subject to such rules and orders as may have been lawfully made, give such reasonable directions, as to the mode of admission of the public to, and for securing the peaceful and lawful conduct of persons attending 4[and the maintenance of the public safety] at, such place or such assembly or meeting, as he thinks necessary; and all persons shall be bound to conform to every such reasonable direction.

(2) The Police shall have free access to every such place of public Police to amusement, assembly or meeting, for the purpose of giving effect have free to the provisions of sub-section (1) and to any direction made to. thereunder.

Dispersal of gangs and bodies of persons.

27. (1) Whenever it shall appear to the Commissioner of Police that the movements or encampment of any gang or body of persons in the City of Bombay are or is causing or calculated to cause danger or alarm. or a reasonable suspicion that unlawful designs are entertained by such gang or body or by any member or members thereof, or that an outbreak of epidemic disease is likely to result from the continued residence in the city of large numbers of pauper immigrants, the Commissioner of Police * * may, by beat of drum or otherwise as he thinks fit, direct the members of such gang or body or such immigrants, so to conduct themselves as shall seem necessary in order to prevent violence and alarm or the outbreak or spread of such disease or to disperse and remove themselves to such place or places, by such route or routes, and within such time, as the Commissioner of Police shall prescribe.

Removal of convicted beggars.

(2) It shall also be competent to the Commissioner of Police to direct the removal in like manner of any person who has been twice convicted of an offence under section 121 2 or of any person who has been thrice convicted within a period of three years of an offence punishable either under section 4 or section 12A of the Bombay Prevention of Gambling Bom. Act, 1887].

Removal of persons convicted of certain offences.

³[(2A) It shall be further competent to the Commissioner of Police to direct any person who, not having been born in the City of Bombay or the Bombay Suburban District, has been convicted more than twice of offences punishable under Chapter XII, XVI or XVII of the Indian XLV Penal Code, to remove himself in like manner from the City of Bombay of 1860. and not to enter the said City or the Bombay Suburban District.

Provided that if in the opinion of the Veterinary Practitioner the animal can be removed from the place where it is found without causing it great suffering, and, if the owner or person in charge of the animal, or in their absence any other person on the spot is willing and offers to remove the animal to a Veterinary Hospital or Pinjrapole within suchtime as the Veterinary Practitioner considers reasonable, the Veterinary Practitioner shall allow the animal to be removed by such owner, person in charge or other person. If the owner or person in charge of the animal or such other person is unwilling or fails so to remove the animal, the Veterinary Practitioner may direct the Police officer to remove the animal before it is destroyed from the place where it is found to such other place as he may think fit:

Provided further that when the animal is destroyed in any street or public place it shall, as far as possible, be screened from the public gaze while it is being destroyed.

Power to appoint Veterinary Practitioners. (2) The ¹[Provincial Government] may appoint such persons as ²[it] thinks fit to be Veterinary Practitioners and may declare the areas of which they shall be in charge for the purposes of this Act.]

CHAPTER IV.

EXECUTIVE POWERS AND DUTIES OF POLICE.

Duties of Police Officers.

Arrest to prevent cognizable offences.

30. A Police officer knowing of a design to commit any cognizable offence may arrest, without orders from a Magistrate and without a warrant, the person so designing, if it appears to such officer that the commission of the offence cannot be otherwise prevented.

Prevention of injury to public property.

31. A Police officer may, of his own authority, interpose to prevent any injury attempted to be committed in his view to any public property, moveable or immoveable, or the removal or injury of any public landmark, or buoy or other mark used for navigation.

Duties of a Police officer.

- 32. (1) It shall be the duty of every Police officer-
- (a) promptly to serve every summons and obey and execute every warrant or other order lawfully issued to him by competent authority, and to endeavour by all lawful means to give effect to the lawful commands of his superior;

- (b) to the best of his ability to obtain intelligence concerning the commission of cognizable offences or designs to commit such offences, and to lay such information and to take such other steps, consistent with law and with the orders of his superiors, as shall be best calculated to bring offenders to justice or to prevent the commission of cognizable, and within his view of non-cognizable, offences;
- (c) to prevent to the best of his ability the commission of public nuisances;
- (d) to apprehend all persons whom he is legally authorised to apprehend and for whose apprehension there is sufficient reason;
- (e) to aid another Police officer when called on by him or in case of need in the discharge of his duty, in such ways as would be lawful and reasonable on the part of the officer aided;
- (f) to discharge such duties as are imposed upon him by any law for the time being in force;
- (g) to afford every assistance within his power to disabled or helpless persons in the streets, and to take charge of intoxicated persons and of lunatics at large who appear dangerous or incapable of taking care of themselves;
- (h) to take prompt measures to procure necessary help for any person under arrest or in custody who is wounded or sick, and, whilst guarding or conducting any such person, to have due regard to his condition;
- (i) to arrange for the proper sustenance and shelter of every person who is under arrest or in custody;
- (j) in conducting searches to refrain from needless rudeness and the causing of unnecessary annoyance;
- (k) in dealing with women and children to act with strict regard to decency and with reasonable gentleness;
 - (1) to use his best endeavours-
 - (i) to prevent any loss or damage by fire, and
 - (ii) to avert any accident or danger to the public;
- (m) to regulate and control the traffic in the streets, to prevent obstructions therein, and to the best of his ability to prevent the infraction of any rule or order made under this Act or under any other law for the time being in force for observance by the public in or near the streets;

- (n) to keep order in the streets, and at and within public bathing, washing and landing places, fairs and all other places of public resort, and in the neighbourhood of places of public worship during the time of public worship;
- (o) to regulate resort to public bathing, washing and landing places, to prevent overcrowding thereat and in public ferry boats, and to the best of his ability to prevent the infraction of any rule or order lawfully made for observance by the public at any such place or on any such boat; and
- (p) to perform all duties imposed on him by the rules for the time being in force under sections 13 and 22 in the manner and subject to the conditions therein prescribed.

Persons bound to conform to reasonable orders of Police.

(2) All persons shall be bound to conform to the reasonable directions of a Police officer given in fulfilment of any of the said duties.

Police officers may restrain or remove contumacious person.

(3) A Police officer may restrain or remove any person resisting or refusing or omitting to conform to any such direction as aforesaid.

Powers with regard to offences under Act XI of 1890.

or other marks of injury as may be found on the body of the animal:

Provided that in cases falling under clause (b) or (d), the Police officer may direct that the animal shall be sent for detention in a dispensary or any suitable place approved by [[the Provincial Government] by general or special order and be there detained until its production before a Presidency Magistrate;

Provided further that an animal so detained shall be produced before a Presidency Magistrate with the least possible delay and within a period not exceeding three days from the date on which it was sent for detention and shall be handed over to its owner unless the Presidency Magistrate passes an order for its further detention in an infirmary.

- (2) When an animal is brought before a Presidency Magistrate under clause (a) of sub-section (1), such Magistrate may direct the animal to be returned to the person from whose possession it was taken on such person giving security to the satisfaction of the Magistrate, binding himself to produce the animal when required, or, may direct that the animal shall be sent for treatment and care to an infirmary and be there detained as provided in sub-section (3) of section 6 of the said Act, or may make such order as he thinks fit regarding the disposal or custody and production of the animal.
- (3) The veterinary officer before whom an animal is brought under clause (b) of sub-section (1) shall, with all convenient speed, examine the same and draw up a report of such examination. A copy of the report shall be delivered free of charge to the accused person if he applies for it.
- (4) When under sub-section (1) a Police officer directs that an animal shall be sent for detention in a dispensary or any suitable place before its production before a Presidency Magistrate, or under sub-section (2) a Presidency Magistrate directs that an animal shall be sent for treatment and care to an infirmary and be detained therein, the provisions of subsections (5), (6), (7) and (8) of section 6 of the said Act shall, so far as may be, apply.
- (5) When a Police officer in good faith suspects that any animal being employed in any work or labour is, by reason of any sore, unfit to be so employed, he may require the person in charge of such animal to unsaddle or unload it for the purpose of ascertaining whether any sore exists and, if such person refuses to do so, may himself unsaddle or unload the animal or may cause the same to be unsaddled or unloaded.

Powers of Police Officers to arrest without warrant.

When Police may arrest without warrant.

- 33. Any Police officer may, without an order from a Magistrate and without a warrant, arrest—
 - (a) any person who has been concerned in any cognizable offence, or against whom a reasonable complaint has been made, or credible information has been received, or a reasonable suspicion exists, of his having been so concerned;
 - (b) any person having in his possession without lawful excuse, the burden of proving which excuse shall lie on such person, any implement of house-breaking;
 - (c) any person who has been proclaimed as an offender either under the Code of Criminal Procedure or by order of ¹[the Provincial Govern- V of ment];
 - (d) any person who is found having in his possession or conveying anything which may reasonably be suspected to be stolen property, or who may reasonably be suspected of having committed an offence with reference to such thing;
 - (e) any person who obstructs a Police officer while in the execution of his duty, or who has escaped, or attempts to escape, from lawful custody;
- (f) any person reasonably suspected of being a deserter from His Majesty's Army or Navy, or of belonging to ² [the Royal Indian Navy] and being illegally absent from that service ³[or of having committed an offence punishable under clause (c) of section 18];
- (g) any person who has been concerned in, or against whom a reasonable complaint has been made, or credible information has been received, or reasonable suspicion exists, of his having been concerned in, any act committed at any place out of British India, which, if committed in British India, would have been punishable as an offence, 44 an and for which he is under any law relating to extradition or under the 45, 45 Fugitive Offenders Act, 1881, or otherwise liable to be apprehended Vict., or detained in custody in British India;
- (h) any released convict committing a breach of any rule made under sub-section (3) of section 565 of the Code of Criminal V of Procedure;

Person arrested to be forwarded to Magistrate.

(3) Should the true name and residence of such person not be ascertained within twenty-four hours from the time of arrest, or should he fail to execute the bond, or, if so required, to furnish sureties, he shall, subject to the provision of sub-section (2) of section 87, forthwith be forwarded to the Presidency Magistrate having jurisdiction.

Other powers of arrest.

- 35. ¹[(1) Any Police officer empowered in this behalf by the Commissioner of Police may arrest without warrant for any offence specified in section 120.]
- (2) Any Police officer may, on the information of any person in possession or charge of any dwelling house, private premises, or land or ground attached thereto, arrest without warrant any person alleged to have committed therein or thereon an offence punishable under section 111.

Arrest of vagabonds, habitual robbers, etc.

- 36. Any officer in charge of a section may, without an order from a Magistrate and without a warrant, arrest or cause to be arrested—
 - (a) any person found within his section taking precautions to conceal his presence within the City of Bombay, under circumstances which afford reason to believe that he is taking such precautions with a view to committing a cognizable offence;
 - (b) any person within his section who has no ostensible means of subsistence, or who cannot give a satisfactory account of himself;
 - (c) any person who is by repute an habitual robber, house-breaker or thief, or an habitual receiver of stolen property knowing it to be stolen, or who by repute habitually commits extortion or in order to the committing of extortion habitually puts or attempts to put persons in fear of injury.

Powers to seize property suspected to be stolen. 37. (1) It shall be lawful for any Police officer to seize any property or thing which may be alleged or suspected to have been stolen, or which may be found under circumstances which create suspicion of the commission of any offence.

Orders of Commissioner of Police to be taken. (2) Every such seizure shall be forthwith reported to the Commissioner of Police, who shall thereupon make such order respecting the custody or production of the property or thing as he shall think proper.

Enforcement of orders issued under section 23, 24 or 25.

38. Whenever a notification, order in writing or public notice has been duly issued under sub-section (2), (3), or (4) of section 23, or an order has been made under section 24 or 25, it shall be lawful for any Magistrate or Police officer to require any person acting or about to act contrary thereto to desist or to abstain from so doing, and, in case of refusal or disobedience, to arrest such person. Such Magistrate or Police officer may also seize any

Unlawful Assemblies.

- 40. (1) Any '[Magistrate or] officer in charge of a section may com-Assembly mand any unlawful assembly or any assembly of five or more persons on command likely to cause a disturbance of the public peace to disperse; and it shall of Magistrate thereupon be the duty of the members of such assembly to disperse or Police officer.
- (2) If, upon being so commanded, any such assembly does not disperse, Use of civil or if, without being so commanded, it conducts itself in such a manner disperse, as to show a determination not to disperse, any Magistrate or officer in charge of a section may proceed to disperse such assembly by force, and may require the assistance of any male person, not being an officer or soldier or sailor in His Majesty's Army or Navy, or 2[the Royal Indian Navy], or a Volunteer enrolled under the 3Indian Volunteers Act, 1869, and acting as such for the purpose of dispersing such assembly, and, if necessary, arresting and confining the persons who form it, in order to disperse such assembly or that they may be punished according to law.
- 41. If on any emergency the available Police force is not sufficient to Requisition disperse an unlawful assembly or to quell a riot or other serious disturbance of the public peace, the Commissioner of Police, or Magistrate of the highest rank who is present, may apply to the officer of highest rank on the spot for military or naval aid for such purpose.
- 42. (1) When the Commissioner of Police or a Magistrate determines Duty of to disperse any unlawful assembly by military or naval force, he may manding require any commissioned or non-commissioned officer in command of military or any soldiers or sailors in His Majesty's Army or Navy, or '[the Royal naval force required to Indian Navy], or of any Volunteers enrolled under the Indian Volunteers disperse Act, 1869, to disperse such assembly by military or naval force, as the assembly.

case may be, and to arrest and confine such persons forming part of it as the Commissioner of Police or Magistrate may direct, or as it may be necessary to arrest and confine in order to disperse the assembly or to have them punished according to law.

(2) Every such officer shall obey such requisition in such manner as he thinks fit, but in so doing shall use as little force, and do as little injury to person and property, as may be consistent with dispersing the assembly and arresting and detaining such persons.

Power of commissioned military or naval officers to disperse assembly.

43. When the public security is manifestly endangered by any such assembly, and when neither the Commissioner of Police nor a Magistrate can be communicated with, any commissioned officer of His Majesty's Army or Navy, or 1[the Royal Indian Navy], may disperse such assembly by military or naval force, as the case may be, and may arrest and confine any persons forming part of it, in order to disperse such assembly or that they may be punished according to law; but if, while he is acting under this section, it becomes practicable for him to communicate with the Commissioner of Police or a Magistrate, he shall do so, and shall thenceforward obey the instructions of the Commissioner of Police or Magistrate as to whether he shall or shall not continue such action.

Protection against prosecution for acts done under section 40, 41, 42 or 43.

- (2) Property of which the Police have taken charge under sub-section (I) shall be handed over to the Commissioner of Police.

Intestate property under two hundred rupees in value.

48. (1) If the said property appears to have been left by a person who has died intestate, and not to be under two hundred rupees in value, the Commissioner of Police shall communicate with the Administrator General, with a view to its being dealt with under the provisions of the ¹Administrator General's Act, 1874, or other law for the time being in force.

Proclamation to be issued by Commissioner of Police.

(2) In any other case the Commissioner of Police shall issue a proclamation specifying the articles of which such property consists, and requiring any person who may have a claim thereto to appear before himself or some other officer whom he appoints in this behalf and establish his claim within six months from the date of such proclamation.

Power to sell perishable property at once.

(3) If the property, or any part thereof, is subject to speedy and natural decay, or consists of live-stock, or if the property appears to be of less value than five rupees, it may be forthwith sold by auction under the orders of the Commissioner of Police, and the net proceeds of such sale shall be dealt with in the same manner as is hereinafter provided for the disposal of the said property.

Delivery of property to person entitled.

49. (1) The Commissioner of Police shall, on being satisfied of the title of any claimant to the possession or administration of such property, order the same to be delivered to him, after deduction or payment of the expenses properly incurred by the Police in the seizure and detention thereof.

Power to

(2) The Commissioner of Police may, at his discretion, before making take security, any order under sub-section (1), take such security as he may think proper from the person to whom the said property is to be delivered, and nothing hereinbefore contained shall affect the right of any person to recover the whole or any part of the same from the person to whom it may have been delivered pursuant to such order.

Proceedings not to be called in question. (2) No proceeding of a Police officer in any such case shall at any stage be called in question on the ground that the case was one which such officer was not empowered under this section to investigate.

Procedure where cognizable offence suspected.

60. If, from information received or otherwise, an officer in charge of a section has reason to suspect the commission of an offence which he is empowered under section 59 to investigate, he shall forthwith proceed in person, or shall depute one of his subordinate officers to proceed, to the spot to investigate the facts and circumstances of the case, and to take such measures as may be necessary for the discovery and arrest of the offender:

Provided that, if the information is given against any person by name, and the offence is not of a serious nature, or if it appears to the officer in charge of a section that there is no sufficient ground for entering on an investigation, he need not proceed in person, or depute a subordinate officer, to make an investigation on the spot; but he shall in every such case record his reasons for not making, or causing to be made, such an investigation.

Police officer's power to require attendance of witnesses.

- 61. Any Police officer making an investigation under this Act
 - (a) by order in writing, require the attendance before himself of any person being within the limits of the City of Bombay, who from the information given or otherwise appears to be acquainted with the facts or circumstances of the case, and such person shall attend if so required; and
 - (b) examine orally any person supposed to be acquainted with the facts and circumstances of the case, and may reduce into writing any statement made by the person so examined, and such person shall be bound to answer all questions relating to such case put to him by such officer, other than questions the answers to which would have a tendency to expose him to a criminal charge or to a penalty or forfeiture.

Special powers of Commissioner of Police to require attendance and obtain statements of witnesses.

62. (1) If in the course of an investigation the Commissioner of Police has reason to believe that a cognizable offence has been committed, he may by order in writing require the attendance before himself or any officer serving under him who is investigating a cognizable offence, of any person then being within the limits of the City of Bombay or within thirty miles of such limits, who from the information given or otherwise appears to be acquainted with the facts or circumstances of the case, and such person shall attend as so required. The provisions of clause (b) of the last preceding section shall apply to the person so attending.

- (2) In any case the Commissioner of Police may forward to the Superintendent of Police of the district in which any person from whom any information is required relating to the facts or circumstances of the case under investigation, is believed to be, such questions and such statement as may be necessary for the purpose of obtaining the information desired, and on receipt thereof such Superintendent of Police shall cause such person to be examined orally and his statement to be reduced into writing in the same manner and subject to the same provisions as if an investigation were being made into such offence in such district, and shall forward the statement reduced into writing to the Commissioner of Police.
- 63. (1) No statement made by any person to a Police officer in the Statements course of an investigation under this Act shall, if taken down in writing, to Police not be signed by the person making it nor shall such writing be used as or admitted evidence:

Provided that, when any witness is called for the prosecution whose statement has been taken down in writing as aforesaid, the Court shall, on the request of the accused, refer to such writing and may then, if the Court thinks it expedient in the interests of justice, direct that the accused be furnished with a copy thereof; and such statement may be used to impeach the credit of such witness in manner provided by the ¹Indian Evidence Act, 1872.

- (2) Nothing in this section shall be deemed to apply to any statement falling within the provisions of section 32, clause (1), of the ¹Indian Evidence Act, 1872.
- 64. (1) No Police officer shall offer or make, or cause to be offered or No inducemade, any such inducement, threat or promise as is mentioned in section ment to be offered. 24 of the ¹Indian Evidence Act, 1872.
 - (2) But no Police officer or other person shall prevent, by any caution or otherwise, any person from making in the course of any investigation under this Act any statement which he may be disposed to make of his own free will.
 - 65. (1) Whenever an officer in charge of a section considers that the Summons production of any document or other thing is necessary or desirable for the document or purposes of any investigation under this Chapter, he may issue a summons other thing, or written order to any person resident in the City of Bombay in whose possession or power such document or thing is believed to be, requiring him to attend and produce it, at such time and place as may be specified therein.
 - (2) Any person required under this section merely to produce a document or other thing shall be deemed to have complied with the requisition if he cause such document or thing to be produced instead of attending personally to produce the same.

Search by

- 66. (1) Whenever an officer making an investigation under this Police officer. Chapter considers that the production of any document or other thing is necessary to the conduct of an investigation into any offence which he is authorized to investigate, and
 - (a) there is reason to believe that the person in whose possession or power such document or thing is believed to be, will not voluntarily produce the same on being requested so to do by a Police officer, or in compliance with a summons or written order which has been or might be issued under section 65, or
 - (b) such document or other thing is not known to be in the possession of any person,

such officer may search, or cause search to be made, for the same in any place within the limits of the City of Bombay.

- (2) Such officer shall, if practicable, conduct the search in person.
- (3) If he is unable to conduct the search in person and there is no other person competent to make the search, present at the time, he may require any officer subordinate to him to make the search, and he shall deliver to such subordinate officer an order in writing, specifying the document or other thing for which search is to be made and the place to be searched, and such subordinate officer may thereupon search for such thing in such place.
- (4) The provisions of sections 103 and 104 shall, so far as may be, apply to a search made under this section.

Official records and communications, etc. protected.

67. Nothing in sections 65 and 66 shall be deemed to apply to, or to authorize the issue of a summons to produce or warrant to search for, documents or communications of the nature specified in sections 123 and 124 of the ¹ Indian Evidence Act, 1872, or any letter, post-card, telegram ^I of 1872. or other document, parcel or thing in the custody of the Postal or Telegraph authorities.

When Police officer may require ansearch.

- 68. (1) An officer in charge of a section may require an officer in charge of another section, and the Commissioner of Police may require an officer other to make in charge of a police station in any part of the Presidency of Bombay beyond the City of Bombay, to cause a search to be made in any place, in any case in which such officer in charge of a section or the Commissioner might cause such search to be made within the City of Bombay.
 - (2) Such officer, on being so required, shall proceed in accordance with the provisions of section 66 of this Act or section 165 of the Code of V of Criminal Procedure, as the case may be, and shall forward the document 1898. or thing found, if any, to the officer at whose request the search was made.

69. If the Commissioner of Police has reason to believe that any person Power to is confined 1[or detained] under such circumstances that the confinement search for I or detention amounts to an offence, he may issue a search warrant; wrongfully and the person to whom such warrant is directed may search for the confined. person indicated in such warrant, in accordance with such directions as may be given therein, and the person, if found, shall be immediately taken before a Presidency Magistrate, who shall make such order as in the circumstances of the case seems proper.

70. (1) Whenever—

Procedure when inves-

- (a) it appears that any investigation under this Act cannot be tigation cannot be completed within the period of twenty-four hours fixed by section 87, completed.
 - (b) there are grounds for believing that the accusation is well founded,

the officer in charge of a section shall, subject to the provisions of sub-section (2) of section 87, forthwith forward the person accused to a Presidency Magistrate, together with a report setting forth the substance of the information received and of the evidence adducible in the case.

(2) The Presidency Magistrate to whom an accused person is forwarded Order for under sub-section (1) may, after considering any information reduced into detention in writing as hereinbefore provided, and examining any witnesses that he custody. may consider necessary, from time to time authorize the detention, in such custody as he thinks fit, of the person accused, for a period not exceeding fifteen days at a time, and shall, if he does so, record his reasons for so doing.

71. (1) When any officer subordinate to an officer in charge of a section Report of has made an investigation under this Act, he shall report either orally or by subordiin writing the result of his investigation to the officer in charge of the nate Police section.

- (2) The substance of such report shall be entered in a book which shall be kept, in manner prescribed, by the officer to whom it is made.
- 72. Every investigation under this Act shall be completed without Investigation unnecessary delay, and as soon as it is completed the officer in charge to be promptof the section shall prepare a report in the prescribed form setting and report forth-

to be prepared and submitted.

Release of accused when evidence deficient.

- 73. (1) If it appears to the officer preparing such report that there is not sufficient or reasonable ground of suspicion to justify the forwarding of any person therein mentioned as accused to a Magistrate, such officer shall—
 - (a) if such person is in custody, release him on his executing a bond, with or without sureties as such officer may direct, to appear if and when so required before a Magistrate empowered to take cognizance of the offence, and shall
 - (b) forward the report prepared as aforesaid to the Commissioner of Police together with any weapon or other article which it may be necessary to produce before him.

Further investigation may be ordered.

(2) The Commissioner of Police may in any case direct the officer in charge of the case to make further investigation, or may make such further order as he deems fit.

Order for discharge of bond, when made.

(3) Whenever it appears from a report forwarded under this section that the accused has been released on his bond, the Commissioner of Police shall make such order for the discharge of such bond or otherwise as he shall think fit.

Case to be sent to Magistrate when evidence sufficient.

- 74. If the officer in charge as aforesaid considers that there is sufficient evidence or reasonable ground of suspicion to justify him in so doing, he shall-
 - (a) forward the accused person to the Presidency Magistrate having jurisdiction, or
 - (b) if the offence is bailable and the accused is able to give security, shall take security from the accused for his appearance before such Magistrate on a day fixed and for his attendance from day to day before such Magistrate until otherwise directed, and
 - (c) shall also send to such Magistrate the report prepared under section 72, and any weapon or other article which it may be necessary to produce before him.

Bond to secure atten

75. (1) The officer in charge as aforesaid shall also require the complainant, if any, and so many of the persons who appear to such complainant officer to be acquainted with the circumstances of the case as he may think

Provided that if any complainant or witness refuses to attend or to execute a bond as directed in sub-section (1) of section 75, the officer in charge of the section may forward him under custody to the Magistrate, who may detain him in custody until he executes such bond or until the hearing of the case is completed.

CHAPTER VI.

PROCEDURE.

Arrest.

- 77. (1) In making an arrest the Police officer or other person making Arrest how the same shall actually touch or confine the body of the person to be made. arrested unless there be a submission to the custody by word or action.
- (2) If such person forcibly resists the endeavour to arrest him, or Resisting attempts to evade the arrest, such Police officer or other person may use all endeavour means necessary to effect the arrest.
- (3) Nothing in this section gives a right to cause the death of any Limit of person who is not accused of an offence punishable with death or with right of Police offitransportation for life.
- 78. (1) If any person acting under a warrant of arrest, or any Police Search of officer having authority to arrest, has reason to believe that the person to place enterbe arrested has entered into or is within any place, the person residing in or ed by person being in charge of such place shall, on demand of such person acting as arrested, aforesaid, or of such Police officer, allow him free ingress thereto and afford all reasonable facilities for a search therein.

Procedure when ingress not obtainable.

- (2) If ingress to such place cannot be obtained under sub-section (1), it shall be lawful for a person acting under a warrant in any case, and for a Police officer in any case in which a warrant may issue but cannot be obtained without affording the person to be arrested an opportunity of escape,
 - (a) to enter such place and search therein, and
 - (b) in order to effect an entrance into such place to break open any outer or inner door or window of any house or place, whether that of the person to be arrested or of any other person, if after duly stating his authority and purpose and demanding admittance he cannot otherwise obtain admittance:

Breaking open zenana.

Provided that if any such place is an apartment in the actual occupancy of a woman (not being the person to be arrested) who, according to custom, does not appear in public, such person or Police officer shall, before entering such apartment, give notice to such woman that she is at liberty to withdraw, and shall afford her every reasonable facility for withdrawing, and may then break open the apartment and enter it.

Power to break open doors and windows for purposes of liberation. 79. Any Police officer or other person authorized to make an arrest may break open any outer or inner door or window of any house or place in order to liberate himself or any other person who, having lawfully entered for the purpose of making an arrest, is detained therein.

No unnecessary restraint. 80. The person arrested shall not be subjected to more restraint than is necessary to prevent his escape.

Search of arrested persons.

- 81. (1) (a) Whenever a person is arrested by a Police officer,
- (i) under a warrant which does not provide for the taking of bail, or
- (ii) under a warrant which provides for the taking of bail, but the person arrested cannot furnish bail,

and

- (b) whenever a person is arrested-
 - (i) without a warrant, or
- (ii) by a private person under a warrant, and cannot be legally admitted to bail or is unable to furnish bail,

the Police officer making the arrest, or when the arrest is made by a private person the Police officer to whom he makes over the person arrested, may search such person and place in safe custody all articles other than necessary wearing apparel found upon him.

Mode of searching women. (2) Whenever it is necessary to cause a woman to be searched, the search shall be made by another woman and with strict regard to decency.

82. Every Police officer or other person making an arrest may take Power to from the person arrested any offensive weapons which he has about his seize offenperson, and shall deliver all weapons so taken to the Court or officer sive weapons. before which or whom the officer making the arrest is required to produce the person arrested.

83. Any private person may arrest any person who, in his view, Arrest by commits a non-bailable and cognizable offence, or who has been private proclaimed as an offender, and shall, without unnecessary delay, make procedure over any person so arrested to a Police officer and shall accompany, or thereon. in the absence of a Police officer take, such person to the nearest station.

84. Every person arrested, and every person on requisition under sub- Procedure section (1) of section 34, accompanying a Police officer, shall forthwith after arrest. be brought before the officer in charge of the section in which the offence alleged against such person appears to have been committed, and the person or officer who made the arrest or the requisition shall inform the said officer in charge of the nature of the offence alleged to have been committed, and of any grounds that may exist for believing it to have been committed.

85. The officer in charge of the section, if he finds-

Person arrested when

- (a) that there are no sufficient reasons for believing that the person discharged, brought before him has committed any offence, shall record his reasons etc. and forthwith discharge such person;
- (b) that there are reasonable grounds for suspecting that such person has committed an offence, but not for suspecting that he has committed a cognizable offence, shall forthwith submit a report containing his reasons to the Commissioner of Police and shall thereafter proceed as that officer directs;
- (c) that there are reasonable grounds for suspecting that the person so brought before him has committed a cognizable offence, shall, if such person was arrested under section 83, re-arrest him and shall either himself investigate, or direct some officer subordinate to him to investigate, the facts and circumstances of the case.
- 86. An officer in charge of a section making an arrest without warrant Person aror detaining in custody or re-arresting a person under section 85, shall, rested to be without unnecessary delay and subject to the provisions of sections 88 Magistrate. and 130 and to any other provisions of this Act as to bail, take or send the person arrested before the Presidency Magistrate having jurisdiction in the case.

87. (1) No Police officer shall detain in custody any person arrested Limit to without a warrant for a longer period than under all the circumstances of power of the case is reasonable and necessary and, subject to the provisions of detention. sub-section (2), in no case for a period exceeding twenty-four hours except under the special orders of a Presidency Magistrate.

Holidays and time when Court is closed to be excluded. (2) If the aforesaid period expires on a holiday or at night or any other time when the Court of the Presidency Magistrate having jurisdiction in the case is closed, it shall extend to such further time as will permit of the person arrested being brought before such Magistrate when the Court is next open.

Discharge of person arrested.

- 88. Save as provided in clause (a) of section 85, no person who has been arrested by, or who has on requisition under sub-section (I) of section 34 accompanied, a Police officer shall be discharged except—
 - (a) on his own bond, or
 - (b) on bail, or
 - (c) under the special order of the Commissioner of Police or of a Magistrate.

Summons.

Summons how served.

- 89. (1) Every summons shall, if practicable, be served personally on the person summoned by delivering or tendering to him one of the duplicates of the summons.
- Signature (2) Every person on whom a summons is so served shall, if so required by the serving officer, sign a receipt therefor on the back of the other duplicate.

Service of summons on Company. (3) Service of a summons on an incorporated Company or other body corporate may be effected by serving it on the secretary, local manager or other principal officer of the corporation.

Service when person summoned cannot be found. 90. Where the person summoned cannot by the exercise of duediligence be found, the summons may be served by leaving one of the duplicates for him with some adult male member of his family, or with his servant residing with him; and the person with whom the summons is soleft shall, if so required by the serving officer, sign a receipt therefor on the back of the other duplicate.

Procedure when receipt cannot be obtained. 91. If service in the manner mentioned in sections 89 and 90 cannot, by the exercise of due diligence, be effected, the serving officer shall affix one of the duplicates of the summons to some conspicuous part of the house or homestead in which the person summoned ordinarily resides; and thereupon the summons shall be deemed to have been duly served.

Warrant.

Continuance 92. (1) Every warrant of arrest issued by a Court shall remain in of warrant of force until it is cancelled by the Court which issued it or until it is arrest. executed.

(2) If the Court issuing a warrant for the arrest of any person has Security to endorsed thereon any directions for taking security, the officer to whom be taken if directed in the warrant is directed shall comply with such directions, and if such warrant. security be given shall release such person from custody, and forward the bond to the Court.

93. (1) When a warrant is directed to more Police officers than one Direction. it may be executed by all or by any one or more of them.

Procedure of Magistrate or Commissioner of Police.

(1) Such Magistrate or Commissioner shall, if the person arrested appears to be the person intended by the Court which issued the warrant, direct his removal in custody to such Court:

When bail to be taken.

Provided that if the offence is bailable, and such person is ready and willing to give bail to the satisfaction of such Magistrate or Commissioner, or if such person is ready and willing to give security in pursuance of any direction endorsed on the warrant by the Court which issued the same, such Magistrate or Commissioner shall take such bail or security, as the . case may be, and forward the bond to the Court which issued the warrant.

(2) Nothing in this section shall be deemed to prevent a Police officer from taking security under sub-section (2) of section 92.

Search Warrants.

Execution of search warrant.

100. Any person to whom a search warrant is directed by a Court may make a search or inspection in accordance with such directions as may be given therein and with the provisions hereinafter contained.

Disposal of things found on search warrant issued by Court outside Bombay.

101. When in the execution of a search warrant issued by a Court outside the City of Bombay any of the things for which search is made are found in the City of Bombay, such things together with the list of the same prepared as hereinafter provided shall be taken to the Presidency Magistrate having jurisdiction at the place where they were so found or to the Commissioner of Police, and, unless there be good reason to the contrary, such Magistrate or Commissioner shall make an order authorizing them to be taken to such Court.

Procedure as in case of warrants.

The provisions of sections 92, 93, 94, 96 and 97 shall, so far as may be, apply to all search warrants issued to a Police officer under this V of Act or under the Code of Criminal Procedure.

1898.

Person in charge of closed place to allow search.

103. (1) Whenever any place liable to search or inspection under this Act is closed, any person residing in, or being in charge of, such place shall, on demand of the officer or other person executing the warrant and on production of the warrant, allow him free ingress thereto, and afford all reasonable facilities for a search therein.

Ingress how to be obtained.

(2) If ingress into such place cannot be so obtained, the officer or other person executing the warrant may proceed in manner provided by subsection (2) of section 78.

Search for articles concealed on person.

(3) When any person in or about such place is reasonably suspected of concealing about his person any article for which search should be made, such person may be searched, subject to the provisions of sub-section (2) of section 81 if such person be a woman.

- (4) When any person is searched under sub-section (3), a list of all Copy of list things taken possession of shall be prepared, and a copy thereof shall be to be given to person to person, if he so require.
- 104. (I) Before making a search under this Act, the officer about to Search to make it shall call upon two or more respectable inhabitants of the locality be made in in which the place to be searched is situate to attend and witness witnesses. the search.
- (2) The search shall be made in their presence, and a list of all things List of seized in the course of such search and of the places in which they are things seized respectively found shall be prepared by such officer and signed by such witnesses; but no person witnessing a search under this section shall be required to attend the Court as a witness of the search unless specially summoned by it.
- (3) The occupant of the place searched, or some person in his behalf, Occupant to shall, in every instance, be permitted to attend during the search, and be present, a copy of the list prepared under this section, signed by the said copy of witnesses, shall be delivered to such occupant or person at his list if request.
- 105. The Commissioner of Police may, if he thinks fit, retain in safe Documents, custody any document or thing found or produced before him which etc., may be relates to a matter under investigation or in respect of which there is safe custody. a reasonable suspicion of the commission of an offence.

Bail.

106. When any person, other than a person accused of a non-bailable Bail to be offence, is arrested or detained without warrant by an officer in charge of taken in case a section and is prepared at any time while in custody of such officer to offence. give bail, such person shall be released on bail:

Provided that such officer, if he thinks fit, may, instead of taking bail from such person, discharge him on his executing a bond without sureties for his appearance as hereinafter provided.

- 107. (1) When any person accused of any non-bailable offence is When bail arrested or detained without a warrant, by an officer in charge of a section, may be taken he may be released on bail, but he shall not be so released if there appear non-bailable reasonable grounds for believing that he has been guilty of the offence of offence, which he is accused.
- (2) If it appears to such officer at any stage of the investigation that there are not reasonable grounds for believing that the accused has committed such offence, but that there are sufficient grounds for further inquiry into his guilt the accused shall, pending such inquiry, be released on bail, or, at the discretion of such officer, on the execution by him of a bond without sureties for his appearance as hereinafter provided.

Bond of accused and his sureties.

108. Before any person is released under section 106 or 107, a bond for such sum of money as the Police officer thinks sufficient shall be executed by such person, and if he is released on bail, by one or more sufficient sureties, conditioned that such person shall attend at the time and place mentioned in the bond and shall continue so to attend until otherwise directed by the Police officer or by a Magistrate.

Discharge from custody.

109. (1) As soon as the bond has been executed, the person for whose appearance it has been executed shall be released.

Liability to be detained for other offence.

(2) Nothing in this section or in section 106 or 107 shall be deemed to require the release of any person liable to be detained for some matter other than that in respect of which the bond was executed.

Amount of hail not to

110. The amount of every bond executed under this Chapter shall be be excessive. fixed with due regard to the circumstances of the case, and shall not be excessive, and the High Court may in any case direct that any person be admitted to bail, or that the bail required by a Police officer be reduced.

Procedure on forfeiture of bond.

- ¹[110A. (1) Whenever it is proved to the satisfaction of the Court of a Presidency Magistrate that a bond taken under this Act has been forfeited, the Court shall record the grounds of such proof, and may call upon any person bound by such bond to pay the penalty thereof, or to show cause why it should not be paid.
- (2) If sufficient cause is not shown and the penalty is not paid, the Court may proceed to recover the same by issuing a warrant for the attachment and sale of the moveable property belonging to such person or his estate if he be dead.
- (3) Such warrant may be executed within the City of Bombay; and it shall authorize the distress and sale of any moveable property belonging to such person without the City of Bombay, when endorsed by the District Magistrate or Chief Presidency Magistrate within the local limits of whose jurisdiction such property is found.
- (4) If such penalty is not paid and cannot be recovered by such attachment and sale, the person so bound shall be liable, by order of the Court which issued the warrant, to imprisonment in the civil jail for a term which may extend to six months.
- (5) The Court may, at its discretion, remit any portion of the penalty mentioned and enforce payment in part only.

(6) Where a surety to a bond dies before the bond is forfeited, his estate shall be discharged from all liability in respect of the bond, but the party who gave the bond may be required to find a new surety.]

CHAPTER VII.

OFFENCES AND PUNISHMENTS.

- 111. Whoever without satisfactory excuse wilfully enters or remains Wilful in or upon any dwelling-house or premises or any land or ground attached trespass. thereto, or on any ground, building, monument or structure belonging to ¹[the Crown] or appropriated to public purposes, or on any boat or vessel, shall, whether he causes any actual damage or not, be punished with fine which may extend to twenty rupees.
- ²[111A. Whoever knowingly gives or causes to be given a false alarm False alarm of fire to the fire brigade of the municipal corporation of the City of damage to Bombay or to any officer or fireman thereof whether by means of a street fire-slarm. fire-alarm, statement, message or otherwise, or, with intent to give such false alarm, wilfully breaks the glass of, or otherwise damages, a street. fire-alarm, shall be punished with imprisonment of either description for a term which may extend to three months or with fine which may extend to one hundred rupees or with both.]

CHAPTER VIII.

Miscellaneous.

132. All fees paid for licenses or written permissions issued under this Disposal of fees, rewards, Act, and all sums paid for the service of processes by Police officers, and etc. all rewards, forfeitures and penalties or shares thereof which are by law payable to Police officers as informers, shall, save in so far as any such fees or sums belong under the provisions of any enactment in force tothe Municipality, be credited to If the Provincial Government]:

> Provided that, with the sanction of the [Provincial Government], or under any rule made by the 2[Provincial Government] in that behalf, the whole or any portion of any such reward, forfeiture or penalty may, for special services, be paid to a Police officer, or be divided amongsttwo or more Police officers.

Method of proving orders and notifications.

Prosecutions or suits for acts done under colour of duty barred after three months.

(3) In any case of an alleged offence by a Magistrate, Police officer or other person or of a wrong alleged to have been done by such Magistrate, Police officer or other person, by any act done under colour or in excess of any such duty or authority as aforesaid, or wherein it shall appear to the Court that the offence or wrong, if committed or done, was of the character aforesaid the prosecution or suit shall not be entertained, or shall be dismissed, if instituted more than three months after the date of the act complained of.

Suits in certain cases to be dismissed.

(4) The plaint in any such suit shall be rejected if it does not expressly allege that the act complained of was done maliciously and without reasonable or probable cause; and any such suit shall be dismissed if, in the case of an action for damages, tender of sufficient amends shall have been made before the suit was brought, or a sufficient sum of money is paid into Court, with costs, by or on behalf of the defendant, after the institution of the suit.

An Act for further thortening the language used in Bombay Acts, and for other purposes.

WHEREAS it is expedient further to shorten the language used in Bombay Acts, and to make certain other provisions relating to those Acts; It is hereby enacted as follows:—

Preliminary.

- 1. This Act may be called the Bombay General Clauses Act, 1904. Short title.
- 2. The Bombay Acts mentioned in the Schedule are repealed to the Repeal extent specified in the fourth column thereof.

General Definitions.

- 3. In this Act, and in all Bombay Acts made after the commencement Definitions of this Act, unless there is anything repugnant in the subject or context,—

 - (3) "affidavit" shall include affirmation and declaration in the case "Affidavit." of persons by law allowed to affirm or declare instead of swearing;
 - (4) "barrister" shall mean a barrister of England or Ireland, or "Parrister" a member of the Faculty of Advocates in Scotland;
 - (5) "Bombay Act" shall mean an Act made by the Governor of "Bombay Bombay in Council under the "Indian Councils Act, 1861, or the Act." Indian Councils Acts, 1861 and 1892 for the Indian Councils Acts, 1861 to 1909, or the Government of India Act, 1915, or made by the local Legislature, or the Governor of the Presidency of Bombay under

Provision as to offences punishable under two or more enactments.

27. Where an act or omission constitutes an offence under two or more enactments, then the offender shall be liable to be prosecuted and punished under either or any of those enactments, but shall not be liable to be punished twice for the same offence.

Meaning of service by post.

28. Where any Bombay Act made after the commencement of this Act authorizes or requires any document to be served by post, whether the expression "serve" or either of the expressions "give" or "send" or any other expression is used, then, unless a different intention appears, the service shall be deemed to be effected by properly addressing, prepaying and posting by registered post, a letter containing the document, and, unless the contrary is proved, to have been effected at the time at which the letter would be delivered in the ordinary course of post.

Citation of enactments.

- 29. (1) In any Bombay Act, and in any rule, by-law, instrument or document made under, or with reference to, any Bombay Act, any enactment may be cited by reference to the title or short title (if any) conferred thereon or by reference to the number and year thereof, and any provision in an enactment may be cited by reference to the section or sub-section of the enactment in which the provision is contained.
- (2) In this Act, and in any Bombay Act made after the commencement of this Act, a description or citation of a portion of another enactment shall, unless a different intention appears, be construed as including the word, section or other part mentioned or referred to as forming the beginning and as forming the end of the portion comprised in the description or citation.

Saving for previous Acts, rules and by-laws. 30. Where any Act, rule or by-law made after the commencement of this Act continues or amends any Acts, rules or by-laws made before the commencement of this Act, the foregoing sections of this Act shall not by reason merely of such continuance or amendment affect the construction of such Acts, rules or by-laws.

An Act to establish a Court of Wards in the Bombay Presidency.

WHEREAS it is expedient to establish a Court of Wards in the Bombay P amble. Presidency;

AND WHEREAS the previous sanction of the Governor General required by section 5 of the ²Indian Councils Act, 1892, has been obtained for the passing of this Act;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Bombay Court of Wards Act, Short title. 1905.
- (2) It shall extend to the whole of the Bombay Presidency, except Extent. the City of Bombay3 * *.
- 2. In this Act, unless there is anything repugnant in the subject or Definitions. context-
 - (a) "Government ward" shall mean any person of whose property, or of whose person and property, the Court of Wards may, for the time being, have the superintendence under this Act:

(b) "land-holder" shall mean,

- (i) in the case of minors and persons adjudged by a competent Civil Court to be of unsound mind and incapable of managing their affairs, a holder as defined in the Bombay Land Revenue Code, 1879; and
- ⁵[(ii) in all other cases, a zamindar, jagirdar, saranjamdar, inamdar, talukdar, malek and a khot, and any person not hereinbefore specified who is interested in land and whom the [Provincial Government] has declared on account of the extent and value of his interests to be a land-holder for the purposes of this Act]:

provided that no person who permanently resides, or carries on business, or personally works for gain, in the City of Bombay shall be deemed or declared to be a land-holder for the purposes of this Act;

- (a) appoint a special officer to be the Court of Wards for a division in lieu of the Commissioner; or
- (b) constitute a Board consisting of the Commissioner and any other officer or officers to be the Court of Wards for a division; or
- (c) appoint any other officer or officers to be a Court of Wards for any part of the Bombay Presidency, and direct that such part shall thereupon be excluded from the jurisdiction of the Court of Wards of any division in which it lies wholly or partly.

(1) Any land-holder ⁶[or pension-holder] may apply in writing to the ⁷[Provincial Government] to have his property placed under the superintendence of the Court of Wards, and the ⁷[Provincial Government] may on such application, where ⁸[it] is of opinion that it is expedient in the public interests to preserve the property of such land-holder ⁶[or pension-holder] for the benefit of his family and that the said property is of such value that economical management by the Court of Wards is practicable, order the Court of Wards to assume the superintendence of the property.

- ¹[(1A) Any co-sharer of property, other than a co-sharer in a family undivided according to Hindu law, may make an application under subsection (1) in respect of his own share in such property.]
- (2) ²[In every case where property is held by co-sharers, whether as co-shares in a family undivided according to Hindu law or otherwise] an application signed by co-sharers holding an aggregate interest of not less than three-fourths of the whole property shall, for the purposes of sub-section (1), be deemed to be an application by a land-holder ³[or pension-holder] in respect of ⁴[the whole property]:

Provided, firstly, that no order shall be made ⁵[on any such application] under sub-section (I) where it appears to the ⁶[Provincial Government] doubtful whether the aggregate interest of the co-sharers signing ⁷[the] application amounts to not less than three-fourths of the whole property; and

Provided, secondly, that nothing in this Act shall be deemed to prevent any co-sharer other than those signing any such application from obtaining partition of his share, whether by suit or otherwise.

- (3) An order made under sub-section (1) shall be sufficient to authorize the Court of Wards to assume the superintendence of the property referred to therein, and no such order shall be called in question in any Court.
- 10. (1) Whenever the Collector receives information that any land-Provisions holder ³[or pension-holder] is, or should be, disqualified under sub-section for tempo(1) of section 5, or that any land-holder ³[or pension-holder] has died of heirs and and that his heir is, or should be, so disqualified, he may apply to protection District Court and the District Court may authorise the Court of Wards of property to
 - (a) take such steps and make such order for the temporary custody and protection of the property as the Court of Wards thinks fit; and
 - (b) where the land-holder ³[or pension-holder] or heir is a minor, direct that the person (if any) having the custody of the minor shall produce him or cause him to be produced at

such place and time and before such person as the Court of Wards may appoint, and make such order for the temporary custody and protection of the minor as the Court of Wards thinks fit:

Provided that, where the minor is a female and belongs to a class the females of which do not usually appear in public, her production shall be required only in accordance with the manners and customs of the country.

- (2) Whenever the Court of Wards is authorized to proceed under subsection (1) it shall forthwith report its action for the information of the ¹[Provincial Government].
- (3) No appeal shall lie from any order of authorization under subsection (1), except in the case of a land-holder ²[or pension-holder] disqualified under section 5, sub-section (1), clause (a).

Assumption of superintendence by Court of Wards of person of disqualified land-holder or pension-holder in certain cases.

11. Where the Court of Wards assumes the superintendence of the property of any land-holder ²[or pension-holder] disqualified under clause (a) or (d) of section 5, sub-section (1), it may, with the previous sanction of the ¹[Provincial Government], assume the superintendence of his person also:

Provided that nothing in this section shall authorize the Court of Wards to assume the superintendence of the person of a female who is married and is in the custody of her husband.

Assumption of superintendence by Court of Wards where land-holder or pension-holder holds land in more than one jurisdiction.

12. Where a disqualified land-holder ²[or pension-holder] or a land-holder ²[or pension-holder] who has been made a Government ward in pursuance of an order under section 9, sub-section (I), holds land ³[or receives a pension] within the territorial jurisdiction of two or more Courts of Wards such one only of the Courts of Wards as the ¹[Provincial Government] may determine in this behalf shall assume the superintendence of the property, or of the person and property, of the land-holder ²[or pension-holder].

Assumption of superintendence to be notified and to extend to whole of Government ward's property.

13. (1) Whenever the Court of Wards assumes the superintendence of the property of any land-holder ²[or pension-holder] under this Act, the fact of such assumption, and the date on which it was sanctioned by the

- (2) On and with effect from the date of such sanction, the whole of the property, moveable and immoveable, of such land-holder 3[or pension-holder], whether the existence of any such property is known to the Court of Wards or not, shall be deemed to be under the superintendence of the Court of Wards.
- (3) Any property which the Government ward may inherit or acquire by succession subsequently to the date of such sanction shall also be deemed to be under the superintendence of the Court of Wards.
- (4) The Court of Wards may, in its discretion, assume, or refrain from assuming, the superintendence of any property which the Government ward may acquire otherwise than by inheritance or succession subsequently to the date of such notification.
- 14. (1) On the issue of a notification under section 13, sub-section (1), Publication the Court of Wards shall publish in the 2[Official Gazette], and in such of notice to other manner as the [Provincial Government] may, by general or special claimants order, direct, a notice, in English and also in the vernacular, calling Government upon all persons having claims against the Government ward or his ward. property to submit the same in writing to it within six months from the date of the publication of the notice.
- (2) Where the Court of Wards is satisfied that any claimant was unable to comply with the notice. published under sub-section (1), it may allow his claim to be submitted at any time after the date of the expiry of the period fixed therein; but any such claim shall, notwithstanding any law, contract, decree or award to the contrary, cease to carry interest from the date of the expiry of such period until submission.
- (3) Every claim against the Government ward or his property (other than a claim *[on the part of the Crown]) not submitted to the Court of Wards in compliance with the notice published under sub-section (1), or allowed to be submitted under sub-section (2), shall, save in the cases provided for by section 18, sub-section (2), clause (c), and by sections 7 and 13 of the Indian Limitation Act, 1877, be deemed for all purposes and on all occasions, whether during the continuance of the

superintendence or afterwards, to have been duly discharged, unless, in any suit or proceeding instituted by the claimant, or by any person claiming under him, in respect of any such claim, it is proved to the satisfaction of the Court that he was unable to comply with the notice published under sub-section (1).

Power to require claimants to furnish full particulars and documents.

15. (1) The Court of Wards may by written order require that any claimant submitting his claim shall, within such reasonable time as it may prescribe in such order, furnish full particulars thereof, and produce all documents (including entries in books of account) on which he relies to support his claim, together with a true copy of every such document:

Provided that, where the claim relates to an amount secured by a decree or award, it shall be sufficient for the claimant to produce before the Court of Wards, a certified copy of the decree and a certificate from the Court which passed or is executing the same declaring the amount recoverable thereunder, or a true copy of the award and statement of the sum recoverable thereunder, as the case may be; and where the claim is pending adjudication in any Court or has been referred to arbitration, it shall be sufficient for the claimant to produce a certified copy of the plaint, or a true copy of the reference to arbitration, as the case may be.

- (2) The Court of Wards shall, after marking, for the purpose of identification, every original document so produced and verifying the correctness of the copy, retain the copy and return the original to the claimant.
- (3) Where any document, which is in the possession or under the control of a claimant, is not produced by him in accordance with an order under sub-section (1), the document shall not be admissible in evidence against the Government ward, whether during the continuance of the superintendence or afterwards, in any suit brought by such claimant, or by any person claiming under him, in respect of any claim to which such document relates, unless it is proved to the satisfaction of the Court that he was unable to produce such document as required by such order.

Investigation of claims.

- 16. (1) On receipt of all claims submitted in compliance with the and decision provisions of sections 14 and 15, the Court of Wards shall proceed to investigate such claims and shall decide, subject to the provisions of sub-section (3), which of them are to be wholly or partly admitted or wholly or partly rejected, as the case may be, and shall communicate its decision in writing to each claimant concerned.
 - (2) Where the Court of Wards has admitted any claim under subsection (1), it may make to the claimant a proposal in writing for the reduction of the claim, or of the rate of interest to be paid in future, or of both; and if such proposal, or any modification of it, is accepted by the claimant, and his acceptance is finally recorded and attested by the Court of Wards or by any Revenue-officer not below the rank of an

Assistant or Deputy Collector whom the 1[Provincial Government] may, by general or special order, appoint in this behalf, it shall be conclusively binding upon the claimant:

Provided that if, when the superintendence of the property by the Court of Wards is withdrawn, any portion of the claim reduced as aforesaid is still unsatisfied, the claimant shall be entitled to recover a sum bearing the same proportion to the original claim admitted under subsection (1) as the unsatisfied portion bears to the reduced claim.

(3) Subject to the provisions of sub-section (2), nothing in this section shall be construed to bar the institution of a suit in a Civil Court for the recovery of a claim against a Government ward or his property which has been duly submitted to the Court of Wards:

Provided that no decision of the Court of Wards under this section shall be proved in any such suit as against the defendant.

- 17. (1) On the publication of a notice under section 14, sub-section Execution (1), no proceeding in execution of any decree against the Government of decrees to be stayed ward or his property shall be instituted or continued until the decree-till certiholder files a certificate from the Court of Wards that the decree-claim ficate filed. has been duly submitted, or until the expiration of one month from the date of receipt by the Court of Wards of a written application for such certificate, accompanied by a certified copy of a decree.
- (2) Any person holding a decree against the Government ward or his property shall be entitled to receive from the Court of Wards, free of cost, the certificate required by sub-section (1).
- (3) In computing the period of limitation prescribed by the 2Indian Limitation Act, 1877, or by section 230 of the ³Code of Civil Procedure. for any application for the execution of a decree, proceedings in which have been stayed or temporarily barred by reason of the claim not having been duly submitted, the time from the date of the notice published under section 14, sub-section (1) or of the decree if it was passed subsequently to the publication of the notice, to the date of due submission shall be excluded.
- 18. (1) When all claims have been investigated under section 16, the Report to Court of Wards shall submit to the '[Provincial Government] a schedule Provincial of the debts and liabilities of the Government ward, and the [Provincial Government] may, where the property appears to be involved beyond all hope of extrication, or for any other sufficient reason, by order

published in the '[Official Gazette], direct that, on a date to be fixed by the order, the superintendence of the property, or of the person and property, of the Government ward by the Court of Wards shall be withdrawn.

- (2) On the date so fixed.
 - (a) the superintendence shall terminate;
 - (b) the owner of the property under superintendence shall be restored to the possession thereof, subject to any contracts entered into by the Court of Wards for the preservation or benefit of such property; and
 - (c) the claims referred to in section 14, sub-section (3), shall revive.
- (3) In calculating the periods of limitation applicable to suits to recover and enforce claims revived under sub-section (2), clause (c), the time during which such superintendence has continued shall be excluded.

Delegation of powers by Court of Wards.

- 19. (1) With the general or special sanction of the ²[Provincial Government], the Court of Wards may, from time to time, delegate all or any of its powers to the Collector of any district in which any part of the property of a Government ward is situated, or to any other officer not below the rank of an Assistant or Deputy Collector whom it may appoint in this behalf, and may, at any time, with the like sanction, revoke such delegation.
- (2) Subject to any general or special orders of the ²[Provincial Government], the Court of Wards may exercise all or any of the powers conferred on it by this Act through the Collector of any district in which any part of the property of a Government ward is situated, or through any other officer not below the rank of an Assistant or Deputy Collector whom it may appoint in this behalf, and, subject to the like orders, any such Collector or Assistant or Deputy Collector may exercise all or any of the powers delegated to him under this Act through any Revenue-officer subordinate to him not below the rank of a Mahalkari.

Duties of Court of Wards or manager. 26. The Court of Wards, or the manager (if any) appointed by it under this Act, shall manage the property of every Government ward under its superintendence or under his management diligently and faithfully for the benefit of the Government ward, and shall in every respect act to the best of its or his judgment for the Government ward's interest as if the property were its or his own.

Power of Court of Wards as to property of Government wards. ¹[27. The Court of Wards may sell, exchange, mortgage, charge or let the property of a Government ward, and may do all such things as it may judge to be best for the benefit of the property and the advantage of the Government ward: Provided that—

- (a) the previous sanction of the ²[Provincial Government] shall be required to any sale, exchange or mortgage of, or charge on, immoveable property and to any lease of such property for a term exceeding ten years, and
- (b) where one-fourth of the immoveable property of a Government ward has been sold or exchanged no further sale or exchange shall be made.]

Power of Court of Wards to evict. 28. The Court of Wards may summarily evict in the manner specified in section 202 of the Bombay Land Revenue Code, 1879, any person Bom. occupying, or in possession of, any immoveable property under its V of 1879 superintendence, to the use and occupation of which he has ceased to be entitled under any of the provisions of that Code, or which he uses or occupies in contravention of any of the provisions of this Act.

Recovery of arrears of rent as arrears of land-revenue.

Payment of costs.

33. Where, in any suit brought by or against a Government ward, any Civil Court decrees any costs against the Government ward's next friend or guardian for the suit, the Court of Wards shall cause the costs to be paid out of any property of the Government ward which may, for the time being, be in its hands.

Processes against Government ward to be served on next friend or guardian. 34. Every process which may be issued out of any Civil or Revenue Court against any Government ward shall be served on the Government ward's next friend or guardian for the suit.

Authority of Court of Wards required in case of suits brought on behalf of Government wards. 35. No suit shall be brought, and no appeal in any suit shall be preferred, by any guardian or manager appointed by the Court of Wards on behalf of any Government ward unless it is authorised by an order in writing of the Court of Wards:

Provided that a manager may authorize a plaint or a memorandum of appeal to be filed in order to prevent a suit or appeal from being barred by the law of limitation, but the suit or appeal shall not afterwards be proceeded with except with the sanction of the Court of Wards.

Adjudication of civil disputes between two or more Government wards. 36. (1) Where any question arises as between two or more Government wards of such a nature that an adjudication upon it by a Civil Court is expedient, it shall be lawful for the Court of Wards, acting through the Collector of the district in which a case might have been stated for the opinion of the Civil Court with regard to such matter under section 527 of the ¹ Code of Civil Procedure, to file in the Civil Court having jurisdiction a statement containing the point or points for determination.

- (2) When such statement has been filed, the Court shall appoint a guardian for the suit for each ward having a separate interest, and such guardians shall thereupon conduct the case subject to the general control of the Court of Wards.
- (3) The Court may, if it thinks fit, amend the case so stated and shall then proceed to hear and dispose of the case in the manner provided in Chapter XXXVIII of the 'Code of Civil Procedure for the hearing and disposal of cases stated for opinion under that Chapter.

Withdrawal of superintendence of Court of Wards.

- 40. (1) Where superintendence has been assumed in pursuance of an order under section 9, sub-section (1), the Court of Wards shall withdraw such superintendence as soon as, in the opinion of the ¹[Provincial Government], the property is free from embarrassment.
- (2) The Court of Wards may, with the sanction of the ¹[Provincial Government], at any time withdraw its superintendence from the person or property, or both, of a Government ward, and shall withdraw its superintendence as soon as, in the opinion of the District Court, certified to the Court of Wards,
 - (a) in the case of a person disqualified under clause (a) of sub-section(1) of section 5, he attains or has attained his majority;
 - (b) in the case of a female disqualified under clause (b) of the same sub-section, she is fit to manage her own property;
 - (c) in the case of a person disqualified under clause (c) of the same sub-section, he is fit to manage his own property;
 - (d) in the case of a person disqualified under clause (d) of the same sub-section, he ceases to be of unsound mind and incapable of managing his affairs; and
 - (e) where it was assumed under section 4, sub-section (1), in the case of a family which was undivided according to Hindu law, any co-sharer ceases to be disqualified under sub-section (1) of section 5:

Provided, firstly, that

- (i) where a Government ward dies or ceases to be disqualified and his property is still encumbered with debts and liabilities, the Court of Wards may, with the sanction of the ¹[Provincial Government] retain the said property under its superintendence until such debts and liabilities have been discharged; and
- (ii) in the case of land-holders ²[or pension-holders], ³[who are co-sharers in a family which is undivided according to Hindu law] where one or more of the proprietors of a property remain disqualified although another or others have ceased to be disqualified, the Court of Wards may, with the sanction of the ¹[Provincial Government], retain the whole of the property under its superintendence, paying any proprietor who has ceased to be disqualified ⁴[from surplus income such portion as shall be proportionate to his interest in the estate]:

No suit shall be brought in any Civil Court in respect of the exercise of any discretion conferred by this Act, or against the Court of Wards or any public servant or person duly appointed or authorized under this Act in respect of anything in good faith done or purporting to be done under the provisions thereof or the rules made thereunder:

Provided, firstly, that any person evicted under section 28 may sue for restitution; and

Provided, secondly, that any tenant from whom an arrear of rent has been recovered under section 29 may sue for recovery of the amount, or any part thereof, so recovered.

Power of Provincial Government to make rules.

- 46. (1) The ²[Provincial Government] may, by notification published in the ⁶[Official Gazette] make rules to carry out the purposes and objects of this Act.
- (2) In particular and without prejudice to the generality of the foregoing power, such rules may
 - (a) prescribe the matters to which regard should be had in appointing or removing guardians and managers, and in fixing their remuneration;

- (b) regulate the form, conditions and amount of security, and the number of sureties (if any), to be given by managers;
- (c) prescribe the cases in which proposals or arrangements connected with the administration of the properties of Government wards shall be reported for the sanction of the ¹[Provincial Government];
- (d) prescribe the accounts and other returns, and the form and other particulars thereof, which shall be rendered to the Court of Wards and by the Court of Wards to the ¹[Provincial Government];
- (e) regulate the custody of securities and title-deeds belonging to the estate or property of a Government ward;
- (f) regulate the procedure in inquiries by, and in appeals from orders of the Court of Wards;
- (g) prescribe the mode in which powers delegated to managers are to be notified for the information of persons concerned;
- (h) prescribe the mode in which any expenses incurred by the Court of Wards or the Collector under any power conferred by this Act may be recovered; and
- (i) generally prescribe the manner in which the powers and duties of the Court of Wards under this Act shall be exercised and performed.

An Act to consolidate and amend the law relating to the powers and procedure of Mamlatdars' Courts.

WHEREAS it is expedient to consolidate and amend the law relating to preamble, the powers and procedure of Mamlatdars' Courts; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Mamlatdars' Courts Act, 1906. Short title.
- (2) It shall extend to the whole of the Bombay Presidency, except the Local extent. City of Bombay.
 - 2. The Mamlatdars' Courts Act, 1876, is hereby repealed.

Repeal of Bom. Act III

3. In this Act, unless there is anything repugnant in the subject of 1876.

Interpretation.

- (a) the word "Mamlatdar" shall include any Revenue-officer exercising for the time being the powers of a Mamlatdar, of a Mukhtyarkar, or of a Mahalkari, and any other person who may be specially authorized by the [Provincial Government] to exercise the powers of a Mamlatdar under this Act; and
- (b) the words "plaintiff" and "defendant "shall include—
 - (i) a pleader duly appointed to act on behalf of such plaintiff or defendant, and
 - (ii) the recognized agent of a plaintiff or defendant as defined in section 37 of the *Code of Civil Procedure.

Power to appoint Joint Mamlatdar. 4. •(1) The ¹[Provincial Government] may, by notification in the ²[Official Gazette], appoint in any taluka a Joint Mamlatdar under this Act who shall be invested with co-extensive powers and a concurrent jurisdiction with the Mamlatdar, except that he shall dispose of such suits only as he may receive from the Mamlatdar.

Power of Mamlatdar to transfer suits to the Joint Mamlatdar. (2) The Mamlatdar is hereby empowered to transfer to the Joint Mamlatdar for disposal any suit under this Act the plaint in which has been presented to the Mamlatdar under section 7, and to re-transfer to his own file any such suit, of which the Joint Mamlatdar is, owing to death, sickness or any other cause, unable to dispose.

Delegation of powers to Commissioner. (3) The ¹[Provincial Government] may delegate ³[its] powers under sub-section (1) to the Commissioner.

Powers of Mamlatdars' Courts. 5. (1) Every Mamlatdar shall preside over a Court, which shall be called a Mamlatdar's Court, and which shall, subject to the provisions of sections 6 and 26, have power, within such territorial limits as may from time to time be fixed by the '[Provincial Government], to give immediate possession of any lands or premises used for agriculture or grazing, or trees, or crops, or fisheries, or to restore the use of water from any well, tank, canal or water-course, whether natural or artificial, used for agricultural purposes to any person who has been dispossessed or deprived thereof otherwise than by due course of law, or who has become entitled to the possession or restoration thereof by reason of the determination of any tenancy or other right of any other person, not being a person who has been a former owner or part-owner within a period of twelve years before the institution of the suit of the property or use claimed, or who is the legal representative of such former owner or part-owner:

Provided that, if in any case the Mamlatdar considers it inequitable or unduly harsh to give possession of any such property or to restore any such use to a person who has become entitled thereto merely by reason of the determination of any such tenancy or other right, or if it appears to him that such case can be more suitably dealt with by a Civil Court, he may in his discretion refuse to exercise the power aforesaid, but shall record in writing his reasons for such refusal.

- (2) The said Court shall also, subject to the same provisions, have Power to power within the said limits, when any person is otherwise than by due issue course of law disturbed or obstructed, or when an attempt has been made so to disturb or obstruct any person, in the possession of any lands or premises used for agriculture or grazing, or trees, or crops, or fisheries, or in the use of water from any well, tank, canal or water-course, whether natural or artificial, used for agricultural purposes, or in the use of roads or customary ways thereto, to issue an injunction to the person causing, or who has attempted to cause, such disturbance or obstruction, requiring him to refrain from causing or attempting to cause any further such disturbance or obstruction.
- (3) No suit shall be entertained by a Mamlatdar's Court unless it is Suits to be brought within six months from the date on which the cause of action filed within arose.
- (4) The cause of action shall be deemed to have arisen on the date on Cause of which the dispossession, deprivation, or determination, of tenancy or action. other right occurred; or on which the disturbance or obstruction, or the attempted disturbance or obstruction, first commenced.

Explanation.—The exercise by a joint owner of any right which he has over the joint property is not a dispossession, or disturbance of possession of the other joint owner or owners within the meaning of this section.

Illustration I.

A lets B his field to cultivate for a specific period one or more years. B refuses to resign possession after the expiration of that period. A can sue for possession in the Mamlatdar's Court at any time within 6 months from the date of the expiration of the said period, unless B is a person who has been a former owner or part-owner within a period of twelve years before the institution of the suit of the property, or who is the legal representative of such former owner or part-owner.

Illustration II.

B is a yearly tenant of A, who gives him a notice to vacate, as he is bound to do under section 84 of the Bombay Land Revenue Code, 1879, at least three months before the end of the then current year of tenancy. At the commencement of the next year B refuses to vacate. A can sue B in the Mamlatdar's Court at any time within six months from the commencement of that year, unless B is a person who has been a former owner or part-owner within a period of twelve years before the institution of the suit of the property, or who is the legal representative of such former owner or part-owner.

Bom. V of

Illustration III.

A allows B the use of water from his well, or from his water-course, for a specific period, at the expiration of which B continues to take water from the well or water-course without A's consent. A may sue B in the Mamlatdar's Court at any time within six months from the expiration of the said period to obtain an injunction to stop B from taking the water, unless B is a person who has been a former owner or part-owner within a period of twelve years before the institution of the suit of the use of the water, or who is the legal representative of such former owner or part-owner.

Illustration IV.

A and B hold lands adjacent to a \P Z or \P H, or similar artificial water-course, which has hitherto been exclusively used by B. A draws water therefrom. B may sue in the Mamlatdar's Court, at any time within six months from the date on which A commences to take the water, for an injunction to prevent A from so doing.

Power of Collector to transfer suits. 6. The Collector may, after due notice to the parties, by order in writing transfer any suit from any Mamlatdar's Court in his district to any other Mamlatdar's Court in his district, and the Mamlatdar's Court to which the suit is so transferred shall thereupon exercise jurisdiction in such suit; but any order issued to village-officers under section 21 shall be issued by the Mamlatdar to whom such village-officers are subordinate.

Suits commenced by plaint. Contents of plaint.

- 7. All suits under this Act shall be commenced by a plaint, which shall be presented to the Mamlatdar in open Court by the plaintiff, and which shall contain the following particulars:—
 - (a) the name, age, religion, caste, profession and place of abode of the plaintiff;
 - (b) the name, age, religion, caste, profession and place of abode of the defendant;
 - (c) the nature and situation of the property of which possession or use is sought, or the nature of the injunction to be granted, as the case may be; .
 - (d) the date on which the cause of action arose;
 - (e) the circumstances out of which the cause of action arose; and
 - (f) a list of the plaintiff's documents if any, and of his witnesses, if any, shewing what evidence is required from each witness, and whether such witnesses are to be summoned to attend, or whether the plaintiff will produce them on the day and at the place to be fixed under section 14,

8. Where a petition not in the form of a plaint is presented to the Informal Mamlatdar and the subject matter thereof appears to fall within the petitions to be treated scope of section 5, the Mamlatdar shall explain to the person presenting as plaints. the petition the nature of the reliefs afforded by this Act and shall inquire whether the petitioner desires to obtain relief thereby. If the petitioner expresses a desire so to obtain relief, the Mamlatdar shall endorse the desire on the petition which shall thereupon be deemed to be a plaint presented under section 7.

9. Where the plaint does not contain the particulars specified in Examination section 7 or is unnecessarily prolix, the Mamlatdar shall forthwith of plaintiff on oath. examine the plaintiff upon oath and ascertain from him such of the particulars specified in section 7 as are not clearly and correctly stated in the plaint and shall reduce the examination to writing in the form of an endorsement on or annexure to the plaint which shall thereupon be deemed to be part of the plaint. Where the plaintiff requires time to obtain any of the particulars specified in section 7, the Mamlatdar shall grant him such time as may under all the circumstances appear reasonable.

- 10. When the plaint is presented, and has, if necessary, been treated Plaint to be in the manner specified in section 9, the Mamlatdar shall require the subscribed plaintiff to subscribe and verify the plaint in his presence, in open Court, and verified. in the manner following, or to the like effect:-
 - "I, A.B., the plaintiff, do declare that what is stated in this plaint is true to the best of my information and belief."
- 11. (1) The Mamlatdar shall endorse the plaint to the effect that it was Endorsement by Mamlatduly subscribed and verified.
- (2) Where the plaintiff cannot write, the verification may be written Procedure for him in open Court and he shall affix his mark to his name in token plaintiff canof the authenticity of the verification, and the Mamlatdar shall, in such not write. case, record that the verification was made in his presence at the request of the plaintiff, and that his mark was so affixed.

12. The Mamlatdar shall reject the plaint

Rejection of plaint.

- (a) where the plaintiff declines to make a statement on oath under section 9; or
- (b) where the plaintiff is willing to make or has made a statement on oath under section 9, but fails to furnish the particulars specified in section 7 within the time fixed under section 9 or altogether; or
- (c) where it appears upon the face of the plaint,
 - (i) that the property or use claimed is not one of the kind specified in section 5, or

- (ii) that the cause of action arose more than six months before the plaint was presented; or
- (d) where the plaintiff declines to subscribe or verify the plaint as required by sections 10 and 11.

Return of plaint.

, 13. Where it appears to the Mamlatdar that the subject of the plaint is not within his jurisdiction, he shall return the plaint to be presented in the proper Court.

Procedure where plaint admissible.

- 14. (1) Where a plaint is admissible, the Mamlatdar shall receive and file it. He shall then fix a convenient day and place for the trial of the case, and shall issue, at the expense of the plaintiff, notice in the form of Schedule A to the defendant. He shall then require the plaintiff to appear with his documents, if any, and witnesses, if any, on the day and at the place fixed.
- (2) The date to be fixed for the trial of the case shall not be earlier than ten days, nor later than fifteen days, from the day on which the notice is issued, except for sufficient reason to be recorded in writing by the Mamlatdar with his own hand.
- (3) The place to be fixed for the trial of the case may be in the Mamlatdar's office, or at or near the scene of dispute, or at any other spot that the Mamlatdar considers convenient to the parties.

Attendance of witnesses.

- 15. (1) Where either party requires any witness to be summoned to appear on the day and at the place fixed, the Mamlatdar shall issue a summons for that purpose.
- (2) The Mamlatdar may issue, after recording his reasons in writing, a warrant for the arrest of any such witness if at such time he fails to appear and the summons is proved to have been duly served in time to admit of his appearing in accordance therewith and no reasonable excuse is offered for such failure.
- (3) The payment of the cost incurred in thus procuring the attendance of witnesses shall be regulated in accordance with the rules that may from time to time be in force in regard to the attendance of witnesses in Subordinate Civil Courts.

Where plaintiff makes default, plaint to be rejected with costs.

16. (1) Where the plaintiff fails to attend, or to produce his documents, if any, or to adopt measures to procure the attendance of his witnesses, if any, on the day and at the place fixed, the Mamlatdar shall reject the plaint with costs, whether the defendant appears or not, unless the defendant admits the claim.

(2) Where the plaintiff attends as required by section 14, sub-section Where defen-(1), but the defendant fails to attend, and the Mamlatdar is satisfied dant does not appear, from the evidence before him that the notice has been duly served on case to be the defendant and in sufficient time to enable the defendant to appear heard ex and answer on the day fixed in the notice, he shall proceed to hear and parte. decide the plaint ex parte:

Provided, firstly, that if either party satisfies the Mamlatdar at any But case may time within thirty days from the date of the rejection of a plaint under be reheard on sufficient sub-section (1), or of an ex parte decision under sub-section (2), that cause being he was prevented by some unavoidable circumstance from attending, shown or from producing his documents or from adopting measures to procure the attendance of his witnesses, as the case may be, it shall be lawful for the Mamlatdar to issue a notice in the form of Schedule B at the expense of the applicant to the opposite party and, if still satisfied after hearing the opposite party that the applicant was prevented as alleged, to re-hear the case at such time and place as he may then fix:

Provided, secondly, that nothing in the foregoing provisions shall or plaintiff prevent the plaintiff from withdrawing his suit on payment of the draw his suit, defendant's costs.

17. (1) Where, in the case mentioned in sub-section (2) of section 16, When prothe Mamlatdar is not satisfied from the evidence before him that the ceedings notice has been duly served on the defendant, and in sufficient time may be adjourned. to enable the defendant to appear and answer on the day fixed in the notice, he shall adjourn the trial of the case and issue a fresh notice under section 14, sub-section (1), to the defendant.

- (2) Where any witness who has been duly summoned, or for whose arrest a warrant has been issued under sub-section (2) of section 15, fails to attend on the day and at the place fixed, the Mamlatdar may, if he considers there is sufficient reason, after taking the evidence of those present, adjourn the hearing of the suit from time to time till the attendance of such witness can be enforced.
- (3) The Mamlatdar may, for any other sufficient reason to be recorded in writing, adjourn the trial of the case for such time as he thinks fit, but not ordinarily exceeding ten days.
- (4) The provisions of sections 15 and 16 shall apply in respect of any day to which the trial of the case may be adjourned under this section, as if such day were the day originally fixed for the trial.
- 18. (1) A minor may sue or be sued, if he is represented by a natural Minor may be a party. or duly appointed guardian.

Power to add parties. (2) The Mamlatdar may, at any stage of the proceedings, order that the name of any person to whom possession or enjoyment of the property or use claimed, or of any part thereof, may have been transferred, or the addition of whom as a party appears necessary in order to enable the Court effectually and completely to adjudicate upon the issues, be added as a plaintiff or defendant, as the circumstances of the case may require:

Provided that no person shall be added as a plaintiff without his consent:

Provided also that in respect of any person so added, not being a transferee pending the suit, the suit shall for the purposes of section 5, sub-section (3), be deemed to have been instituted on the day when his name was so added.

Procedure in case of death of party.

- (3) In case of the death of any party while the suit is pending,
 - (i) if application is made within one month of such death, the Mamlatdar shall determine summarily who is the legal representative of the deceased party and shall enter on the record the name of such representative;
 - (ii) if no such application is made, the suit shall abate.
- (4) Where the Mamlatdar orders the name of any person to be added as a defendant or enters on the record the name of any person as the legal representative of a deceased defendant, the Mamlatdar shall issue to such person a notice as provided in section 14; and the trial shall proceed on the date fixed in such notice.

Points to be decided by Mamlatdar at hearing.

- 19. (1) On the day fixed, or on any day to which the proceedings may have been adjourned, the Mamlatdar shall, subject to the provisions of section 16, proceed to hear all the evidence that is then and there before him, and to try the following issues, namely:—
 - (a) If the plaintiff avers that he has been unlawfully dispossessed of any property or deprived of any use—
 - (1) whether the plaintiff or any person on his behalf or through whom he claims was in possession or enjoyment of the property or use claimed up to any time within six months before the suit was filed;
 - (2) whether the defendant is in possession at the time of the suit, and, if so, whether he obtained possession otherwise than by due course of law;
 - (b) if the plaintiff avers that he is entitled to possession of any property or restoration of any use by reason of the

- determination of any tenure or other right of the defendant in respect thereof-
- (1) whether the defendant is in possession of the property or in the enjoyment of the use by a right derived from the plaintiff or from any person through whom he claims;
- (2) whether such right has determined at any time within six months before the suit was filed:
- (3) whether the defendant is other than a person who has been a former owner or part-owner within a period of twelve years before the institution of the suit of the property or use claimed, and other than the legal representative of such former owner or part-owner;
- (c) if the plaintiff avers that he is still in possession of the property or in the enjoyment of the use, but that the defendant disturbs or obstructs, or has attempted to disturb or obstruct, him in his possession or use—
 - (1) whether the plaintiff or any person in his behalf is actually in possession or enjoyment of the property or use claimed;
 - (2) whether the defendant is disturbing or obstructing, or has attempted to disturb or obstruct, him in such possession or enjoyment;
 - (3) whether such disturbance or obstruction, or such attempted disturbance or obstruction, first commenced within six months before the suit was filed.
- (2) The Mamlatdar may, after due notice to, and in the presence of, Power of the parties, summon and examine as a witness any person who has Mamlatdar not been summoned or produced, and may call for and cause to be proved to examine other witany document which has not been applied for or produced, by either nesses and of the parties, where he considers it expedient in the interests of justice inspect proso to do, and may, if he thinks fit, make a personal inspection of the dispute. property in dispute in the presence of, or after due notice to, the parties. ¹[He shall without unnecessary delay record a memorandum after hearing the parties on the spot, if present, of any relevant facts observed at such inspect on. The memorandum shall form part of the record of the case.]

(3) The Mamlatdar shall with his own hand make or sign Record of a memorandum of the substance of the evidence of each witness as proceedings the examination of the witness proceeds, and briefly record his reasons lates. for his finding.

Orders to be passed by Mamlatdar upon decisions in favour of plaintiff and defendant. (4) Where the Manilatdar's finding upon the issues is in favour of the plaintiff, he shall make such order, not being in excess of the powers vested in him by section 5; as the circumstances of the case appear to him to require; and where his finding is in favour of the defendant, he shall dismiss the suit. In either case the costs of the suit, including the costs of execution, shall follow the decision.

Mam'atdar's order to be endorsed on plaint and read out in open Court.

20. Every order of the Mamlatdar, whether for rejecting or returning a plaint or whether for allowing or disallowing a claim, shall be endorsed by the Mamlatdar on the plaint and shall be read out by him in open Court, either at once or on some future day of which due notice shall be given to the parties or their pleaders, and brief reasons for the order shall be placed by him on record.

Mamlatdar's decision how executed.

21. (1) Where the Mamlatdar's decision is for awarding possession or restoring a use, he shall give effect thereto by issuing such orders to the village-officers, or to any subordinate under his control or otherwise, as he thinks fit:

Proviso as to growing crops. Provided that, notwithstanding anything contained in this Act, where, at the time when a decision is recorded by the Mamlatdar for awarding possession of any land, there is a crop on such land which has been sown by, or at the expense of, the defendant, and the Mamlatdar is satisfied that it has been so sown in good faith, the Mamlatdar may, and if the defendant makes an application for the purpose and furnishes sufficient security, or deposits in Court a sufficient sum, for the payment of the costs of the suit, shall pass an order staying delivery of possession of such land to the plaintiff seeking possession thereof, either

- (a) until the plaintiff agrees to take the crop at a valuation, to be made under the orders of the Mamlatdar, according to the value of the crop at such time, including any instalments of the Government assessment which the defendant may have paid for the current year; or
- (b) where the plaintiff is unwilling to take the crop at such valuation until after the expiration of sufficient time for the crop to be gathered by the defendant.

The amount of any valuation made under clause (a) of the proviso to this sub-section shall be paid to the defendant through the Mamlatdar, and shall be recoverable from the plaintiff as an arrear of land-revenue.

Mode of serving injunction. (2) Where the Mamlatdar's decision is for granting an injunction, he shall cause the same to be prepared in the form of Schedule C, and shall deliver or tender the same then and there to the defendant, if present, or if the defendant is not present, shall send it to the village-officers, or to any subordinate under his control, to be served upon the defendant.

- (3) Where the Mamlatdar awards costs, such costs, together with the Recovery of costs of execution, shall be recoverable from the party ordered to pay awarded, them as an arrear of land-revenue.
- XLV (4) Any person disobeying an injunction granted under sub-section (2) Disobedience to an injunction how punishable.

Subject to the provisions of section 23, sub-section (2) and section Possession 24 the party to whom the Mamlatdar gives possession, or restores a use, or in whose favour an injunction is granted, shall continue in possession or use until ousted by a decree or order of a competent Civil rights of Court:

Any plaintiff subscribing and verifying any plaint under this Punishment XLV Act which he either knows or believes to be false, or does not believe for verification to be true, in any material point, shall be deemed to have committed plaint, an offence punishable under section 193 of the ¹Indian Penal Code.

Bar of certain suits.

- 26. No suit shall lie under this Act
 - (a) *[against the Crown or against any servant of the Crown] in respect of any act done or purporting to be done by any such officer in his official capacity, except where acting as a manager or guardian duly constituted under any law for the time being in force; or
 - (b) in respect of any dispossession, recovery of possession or disturbance of possession, that has been the subject of previous proceedings, to which the plaintiff or his predecessor in interest was a party, under this Act, or in a Civil Court, or v of under Chapter XII of the Code of Criminal Procedure, 1898. 1898.

BOMBAY ACT No. III OF 1909,1

[THE PRINCE OF WALES MUSEUM ACT, 1909.]

[19th August, 1909]

Adapted and modified by the Adaptation of Indian Laws Order in Council.

An Act to provide for the erection and management of the Prince of Wales Museum of Western India.

WHEREAS it is intended to erect and maintain at Bombay a Museum as a memorial of the visit in the year 1905 of His Royal Highness the Prince of Wales to Bombay;

AND whereas certain land has been set apart and large sums of money have been and are being subscribed for these purposes;

AND whereas three Trustees have been provisionally appointed to take the custody of the said moneys;

AND whereas it is expedient to make provision for the erection, maintenance and management of the Museum and for the vesting and management of the said land and moneys and for the appointment of a permanent Board of Trustees;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Prince of Wales Museum Act, Short title and commencement.
 - (2) It shall come into force at once.
- 2. All the estate, right, title and interest of His Majesty together Property with all other estates, rights, titles and interests in and to the land vested in the specified in the schedule to this Act and all moneys now in the custody of the three Trustees provisionally appointed to take the custody of the moneys subscribed for the purposes of erecting or maintaining at Bombay a Museum as a memorial of the visit in the year 1905 of His Royal Highness the Prince of Wales to Bombay and all the other

property, whether immoveable or moveable, which has been or may hereafter be given, devised, bequeathed, transferred or otherwise acquired for the said purposes shall vest in the permanent Board of Trustees constituted by this Act on trust for the erection on the land specified in the said schedule of a Museum to be called "The Prince of Wales Museum of Western India," and for the maintenance and management of the said land and Museum.

Constitution and powers of the Board.

3. (1) There shall be constituted for the purposes of this Act a permanent Board of Trustees to be called "The Trustees of the Prince of Wales Museum of Western India" and such Board (hereinafter called "the Board") shall be a body corporate, with perpetual succession and a common seal, and in the name of "The Trustees of the Prince of Wales Museum of Western India" shall sue and be sued, and shall have power to 'acquire and hold immoveable or moveable property, to let on hire, lease or mortgage any immoveable property vesting in them] to enter into contracts, and to do all acts necessary for and consistent with the purposes of this Act:

²[Provided that the Board shall not have power to mortgage any land specified in the schedule which is included within lines drawn parallel to, and at a distance of twenty feet from, above the plinths of the front corner towers of the present Museum building and extending from the Rampart Row boundary to the Esplanade Road boundary which area_contains by admeasurement 14,606 square yards, be the same a little more or less, and is for greater clearness delineated on the plan referred to in section 2 of the Prince of Wales Museum (Amending) Bom. Act, 1913, or any building thereon.]

- (2) The Board shall consist of the following members, namely:—
 - ³[(a) the Director of Industries for the Presidency of Bombay;]
 - (b) the Collector of Bombay;
 - (c) the Principal of the Sir Jamsetjee Jeejeebhoy School of Art;
 - (d) the Superintendent, Archæological Survey, Western Circle;
 - (e) such two members of the Municipal Corporation of the City of Bombay as shall from time to time be elected by the said Corporation in accordance with such regulations as may from time to time be made in this behalf by the said Corporation: provided that the election shall be by 4[ballot];
 - ³[(f) three other persons be nominated by the ⁵[Provincial Government];]

- 2[(hh) one other person elected at a joint meeting of the Trustees of the Sir Dorabji Tata Trust constituted by a trust deed dated the eleventh day of March 1932 and of the Trustees of the Sir Ratan Tata Charities constituted by the will and codicil of Eir Ratan Tata dated the twenty-first day of March 1913 and the twenty-ninth day of February 1916 respectively, by a majority of votes of the Trustees present and voting at such meeting, the Chairman of such meeting having a casting vote in the case of an equality of votes;]
 - (i) one other person to be nominated by the Syndicate of the University of Bombay; and
 - (j) four other persons to be nominated by the Board, if the Board so desire, for such period as the Board may consider desirable.
- (3) In the case of ex-officio members the person for the time being performing the duties of any of the offices mentioned in sub-section (2) shall act as a member.
- (4) All acts done by a majority of the members present and voting at a meeting of the Board shall be deemed to be acts of the Board.
- (5) No act of the Board shall be deemed to be invalid merely by reason of any vacancy in, or defect in the constitution of, the Board.
 - (6) The Board may appoint a person to act as their Secretary.
- (7) Orders for the payment of money on behalf of the Board shall be deemed to be sufficiently authenticated if signed by two members and countersigned by the Secretary.

- (c) leaves the Presidency of Bombay with the intention of being absent therefrom for more than six consecutive months, or
- (d) desires to be discharged, or
- (e) refuses to act or becomes incapable of acting,

Power of Board to lend, exchange, sell or destroy articles in collections.

 - (c) for the form of accounts to be kept by the Board, and for the audit and publication of such accounts; and
 - (f) for the application to the officers and servants employed by the Board of the rules which apply to the civil servants of the Crown, or to any class of such civil servants;
 - ²[(y) for the payment of contributions at such rates and subject to such conditions as may from time to time be prescribed by the Board to any provident fund which may be established by the Board for the benefit of the officers and servants employed by it.]
- 3[6. The Board may from time to time borrow or reborrow and Power to take up at interest from 4[the Central or the Provincial Government] borrow from or with the previous sanction of the 4[Provincial Government] from Provincial any person any sum necessary for the purpose of defraying any costs, Government charges or expenses incurred or to be incurred by them to carry out or person, the purposes of this Act, or for the purpose of repaying either in whole or part any sums hereafter borrowed or owing by the Board.

Mortgage of immoveable property, or revenues.

- 17. (1) The Board may borrow or reborrow any such sum as aforesaid from any person on the security of any immoveable property vesting in them other than the property mentioned in the proviso to section 3 or of their revenues or of both of these securities.
- (2) For the purpose of securing the repayment of any sum so borrowed with interest thereon they may mortgage to the person by or on behalf of whom such sum is advanced any such immoveable property or revenues of both of these securities.]

Provisions as to sinking funds.

- ¹[8. (1) In respect of every loan raised by the Board for a term exceeding one year, the Board shall either pay off the money borrowed by equal yearly or half-yearly instalments of principal or of principal and interest, or they shall in every year set apart as a sinking fund and accumulate in the way of compound interest by investing the same in the purchase of public securities or in such other securities as the ²[Provincial Government] may approve in this behalf such sum or sums as will, with accumulations in the way of compound interest, be sufficient after payment of all expenses to pay off the moneys so borrowed 3[within such period not exceeding sixty years from the date of the raising of the loan as the ²[Provincial Government] may in each case direct.]
- (2) The Board may at any time apply the whole or any part of a sinking fund set apart under this section in or towards the discharge of the moneys for the repayment of which the fund has been established: Provided that they pay into the fund each time that interest would have been received by the Board in respect of the sinking fund or the part of the sinking fund so applied, and accumulate, until the whole of the moneys borrowed are discharged, a sum equivalent to the interest which would have been so received.]

Annual of sinking fund.

19. The sinking fund established for the liquidation of any loan examination shall be subject to annual examination by the Accountant General, Bombay, who shall ascertain whether the cash and the value of the securities at the credit of the fund are actually equal to the amount which would have been accumulated, had investments been regularly made, and had the rate of interest as originally estimated been obtained thereon. The Board shall pay forthwith into the sinking fund any amount which the Accountant General may certify to be deficient, unless the 2[Provincial Government] specially sanction a gradual re-adjustment.]

- (3) The purchase by, or the transfer, assignment or endorsement to, the Board of any debenture issued by the Board shall not operate to extinguish or cancel any such debenture, but the same shall be valid and negotiable in the same manner and to the same extent as if held by, or transferred, assigned or endorsed to, any other person.]
- 1[11. (1) When money is raised by the Board on debentures the Form of debentures shall be in such form as the Board, with the previous debentures. sanction of the ²[Provincial Government], shall from time to time determine.
- (2) The holder of any debenture in any form duly authorised under this section may obtain in exchange therefor, upon such terms as the Board shall from time to time determine, a debenture in any other form authorised by the Board.
- (3) Every debenture issued by the Board shall be transferable by endorsement.
- (4) The right to payment of the moneys secured by any such debentures and to sue in respect thereof shall vest in the respective holders thereof for the time being without any preference by reason of some of such debentures being prior in date to others.]

- (g) the proof to be produced by persons applying for duplicate debentures and stock certificates;
- (h) the circumstances and manner in which duplicate debentures and stock certificates may be issued in case of debentures and stock certificates alleged to have been wholly or partly lost or destroyed and the period after which interest may be paid or a duplicate be issued in case of such debentures and stock certificates and the fees to be levied in respect of the issue of duplicate debentures and stock certificates;

- (2) (a) No rule, or alteration or revocation of a rule, shall have effect until the same shall have been approved by the ¹[Provincial Government], and such approval shall have been published in the ²[Official Gazette]; and no rule, or alteration or revocation of a rule, shall be approved by the ¹[Provincial Government] until the same shall have been published for three weeks successively in the said Gazette.
- (b) It shall be lawful for the ¹[Provincial Government] at any time by notification in the said Gazette to cancel any rule published under the provisions of this section.]

XXI WHEREAS it is expedient to amend the Societies Registration Act, of 1860, in manner hereinafter appearing;

AND WHEREAS the previous sanction of the Governor-General required by section 5 of the ²Indian Councils Act, 1892, has been obtained for the passing of this Act; It is hereby enacted as follows:—

1. Notwithstanding anything contained in section 14 of the Amendment XXI Societies Registration Act, 1860, hereinafter called "the said Act," of section of section 1860, it shall be lawful for the members of any society dissolved under 14. section 13 of the said Act to determine by a majority of the votes of the members present personally or by proxy at the time of dissolution of such society that any property whatsoever remaining after the satisfaction of all its debts and liabilities shall be given to Government to be utilised for any of the purposes referred to in section 1 of the said Act.

An Act to provide for the licensing of race-courses in the Bombay Presidency.

WHEREAS it is expedient to make provision for the regulation of horse-racing in the Bombay Presidency; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Race-courses Licensing Short title Act, 1912.

- (2) This section extends to the whole of the Bombay Presidency. The rest of the Act extends only to such areas as the *[Provincial Government] may by notification in the *[Official Gazette] direct.

Definitions.

- (a) "horse-race" means any race in which any horse, mare or gelding runs or is made to run in competition with any other horse, mare or gelding for any prize of what nature or kind soever, or for any bet or wager made or to be made in respect of any such horse, mare or gelding or the riders thereof, and at which more than twenty persons shall be present;
- (b) "race-course" means any ground on which a horse-race can be held.
- 3. (1) No horse-race shall be held save on a race-course for which Prohibition a license for horse-racing granted in accordance with the provisions of against horse-racing this Act is in force.

Application for license for horseracing.

4. (1) The owner, lessee or occupier of any race-course may apply to the ¹[Provincial Government] for a license for horse-racing on such race-course,

Grant of license for horseracing.

- (2) The '[Provincial Government] may withhold such license or grant it subject to such conditions and for such period as '[it] may think fit.
- ³[(3) The ¹[Provincial Government] may by such licence authorize the licensee to grant, subject to such conditions as shall be specified by the ¹[Provincial Government] in such licence, a licence or permit to any bookmaker for such period not exceeding the period of the licence granted to the licensee as the licensee may think fit; and]

Cancellation of license. *(4) The ¹[Provincial Government] may at any time cancel any license granted under this section in the event of any breach of the conditions subject to which it was granted.

Penalty for taking part in horserace on unlicensed race-course. 5. Whoever takes part in any horse-race on any race-course for which a license granted in accordance with the provisions of section 4 is not in force shall be punishable with fine which may amount to two hundred rupees.

Penalty for owner, etc., allowing racing in unlicensed place. 6. If any horse-race is held on any race-course for which a license granted in accordance with the provisions of section 4 is not in force, any person being the owner, lessee or occupier of such race-course shall be punishable with fine which may amount to one thousand rupees.

Penalty for contravening conditions of license.

- 57. (1) If any person to whom a license has been granted in accordance with the provisions of section 4 contravenes any of the conditions subject to which such license was granted, such person shall be punishable with fine which may amount to one thousand rupees.
- *[(2) If any person to whom a licence or permit has been granted by a licensee in pursuance of the provisions of sub-section (3) of section 4 contravenes any of the conditions subject to which such licence or permit was granted he shall be punishable with fine which may extend to one thousand rupees.]

Cognizance of offences under this Act.

8. No Court inferior to that of a Presidency Magistrate or of a Magistrate of the First Class shall try an offence under this Act.

9. The ¹[Provincial Government] may from time to time by general or particular order published in the ⁷[Official Gazette] exempt any horse-race from the operation of this Act.

An Act for the registration of medical practitioners.

Whereas it is expedient to provide for the registration of medical practitioners in the Presidency of Bombay; And whereas the previous sanction of the Governor-General required by section 5 of the Indian Councils Act, 1892, has been obtained for the passing of this Act; It is hereby enacted as follows:—

1. (1) This Act may be called the Bombay Medical Act, 1912.

Short title, extent and definition.

- (2) It extends to the whole of the Bombay Presidency.
- (3) In this Act the expression "the Medical Acts" means the Medical Act, 1858, and any Acts amending the same.
- ³[2. (1) A Council, herein referred to as "the Medical Council", Bombay Which shall be called "the Bombay Medical Council", shall be established Council for the Presidency of Bombay.
- (2) The Medical Council shall consist of thirteen members registered under this Act who shall be appointed in the following manner, namely:—
 - (a) a President nominated by the 4[Provincial Government];
 - (b) six members nominated by the '[Provincial Government];
 - (c) four members elected by the Doctors, Bachelors and Licentiates of Medicine, and the Masters, Bachelors and Licentiates of Surgery of the University of Bombay who are registered under this Act;

- (d) two members elected by the medical practitioners who are registered under this Act, and who are not Graduates in Medicine or Surgery or Licentiates in Medicine or Licentiates in Medicine and Surgery of the University of Bombay.
- (3) Elections of members shall be held at such time and place and in such manner as the Medical Council shall direct by rules or regulations made from time to time in this behalf.]

Tenure of office.

- 3. (1) The members of the Medical Council shall hold office for a term of five years, and shall be capable of re-appointment.
- (2) Any member may at any time resign his appointment by letter addressed to the President of the Medical Council.
- (3) Upon the death or resignation of any member of the Medical Council, some other person shall be appointed a member of the Medical Council in his place by nomination or election, as the case may be, in accordance with the provisions of sub-section (2) of section 2, and such person shall hold office for the remainder of the period for which the member in whose place he is appointed was nominated or elected.
- (4) (a) Leave of absence from India may be granted by the Medical Council to any member thereof for a period not exceeding six months.
- (b) If any member of the Medical Council leaves India without the leave of the Medical Council, or does not return to India within the period of the leave granted by the Medical Council, the Medical Council may forthwith declare his seat vacant and such declaration shall have the same effect as resignation of his seat by the member concerned.
- (c) In any case not provided for in clauses (a) and (b) if any member of the Medical Council shall absent himself from three consecutive meetings of the Medical Council, the Medical Council may forthwith declare his seat vacant and such declaration shall have the same effect as resignation of his seat by the member concerned.

Time and place of meeting of Council. 4. The Medical Council 1*** shall make such rules and regulations as may be necessary with respect to the times and places of the meeting of the Medical Council, and the mode of summoning the same. In the absence of any rule or regulation as to the summoning of a meeting of the Medical Council, it shall be lawful for the President to summon a meeting at such time and place as to him shall seem expedient, by letter addressed to each member; and at every meeting, in the absence of the President, some other member, to be chosen from the members

present, shall act as President; and all acts of the Medical Council shall be decided by the votes of the majority of the members present at any meeting, the whole number present not being less than eight, and at all such meetings the President for the time being shall, in addition to his vote as a member of the Medical Council, have a casting vote in case of any equality of votes.

5. (1) The Medical Council shall appoint a Registrar, and may Registrar from time to time grant leave to the Registrar and appoint a person and to act in his place. Any order of the Medical Council appointing, granting leave to or dismissing a Registrar or appointing a person to act as Registrar shall be subject to the previous approval of the [Provincial Government]. The Registrar and any person appointed to act as Registrar shall be paid by the Medical Council such salary and allowances as they may from time to time determine. Any person duly appointed to act as Registrar shall be deemed to be Registrar for all the purposes of this Act.

- (2) The Medical Council with the previous approval of the ¹[Provincial Government] may appoint such other officers or clerks as may be necessary for the purposes of this Act.
- (3) The Registrar and any other officer or clerk appointed under this XLV section shall be deemed to be a public servant within the meaning of of section 21 of the 2Indian Penal Code. 1860.
 - 6. The Registrar shall keep a register of medical practitioners in Register. accordance with the provisions of this Act. The register shall be kept in such form as the [Provincial Government] from time to time directs. The name, residence and qualifications of every person who is registered under this Act shall be entered in the register with the date on which each qualification was granted. It shall be the duty of the Registrar under the orders of the Medical Council to keep the register correct and from time to time to enter any necessary alterations in the addresses of persons registered, and to enter any additional qualifications which any registered person may have obtained subsequent to his registration. and to erase the names of all registered persons who have died; provided that the '[Provincial Government] may prescribe a fee for the entry of any additional qualification. To enable the Registrar duly to fulfil the duties imposed upon him it shall be lawful for him to write a letter to any registered person according to his address on the register to enquire whether he has ceased to practise or has changed his residence. and if no answer is returned to such letter within a period of six months from the sending of the letter, it shall be lawful to erase the name of such person from the register: provided that the same may be restored by direction of the Medical Council if they think fit to make an order to that effect.

Central Acts.

Persons entitled to be registered.

- ¹[7. (1) Every person for the time being registered under the Medical Acts shall be entitled to be registered under this Act free of charge on informing the Registrar of the date of his registration under the Medical Acts and giving a correct description of his qualifications with the dates on which they were granted.
- ²[(1-a) Every person for the time being registered under any Act for the registration of medical practitioners in force in any other province in India with the Medical Council of such province shall, if reciprocity of registration has been arranged with such Council, be entitled, on production of his registration certificate, to have registered under this Act, free of charge, such qualifications entered in the said certificate as are registrable under this Act.]
- (2) Every person who is possessed of any of the qualifications described in the Schedule to this Act (subject to the provisions of section 20) shall be entitled to be registered under this Act on payment of a fee of fifteen rupees, and on giving evidence to the satisfaction of the Registrar of his possession of a qualification fitting him for registration.
- (3) The ³[Provincial Government] may, after consulting the Medical Council, permit the registration of any person who was actually practising medicine in the Bombay Presidency before the 25th day of June, 1912.
- (4) The Medical Council may refuse to permit the registration of any person who has been convicted of a cognizable offence as defined in V of the ⁴Code of Criminal Procedure, 1898, or who, being or having been 1898 subject to military law, has been convicted under the ⁵Army Act or 44 & under the ⁴Indian Army Act, 1911, of an offence which is also a cognizable Vict offence as so defined, or who after due enquiry has been held guilty by VIII the Medical Council of infamous conduct in any professional 1911 respect.]

Appeals and erasure of incorrect entries.

- 8. (1) Any appeal against the decision of the Registrar respecting a first registration or any subsequent alteration shall be heard and determined by the Medical Council under regulations which shall be made by the Medical Council in this behalf.
- (2) Any entry in the register which shall be proved to the satisfaction of the Medical Council to have been fraudulently or incorrectly made may be erased from the register under the orders of the Medical Council.

Medical Council authorised to call for information and attend examinations.

- 13. The Medical Council shall have authority to call on the governing body or authorities of any Medical College or School and on any examining body included in or desirous of being included in the Schedule—
 - (a) to furnish such particulars as the Medical Council shall require of any course of study prescribed or examination held by such body or authority or in such School or College with reference to the grant of any medical or surgical qualification, and
 - (b) to permit any member of the Medical Council deputed by the Medical Council in this behalf to attend and be present at any such examination.

Exemption from serving on inquests.

14. Notwithstanding anything in any other law for the time being in force, every person who shall be registered under this Act shall be exempt, if he so desires, from serving on any inquest.

Fees payable to members. 15. There shall be paid to the members of the Medical Council such fees for attendance and such reasonable travelling expenses as shall from time to time be allowed by the Medical Council and approved by the ¹[Provincial Government].

Disposal of fees.

16. All monies received by the Medical Council as fees under this Act shall be applied for the purposes of this Act in accordance with such rules as may be made in this behalf by the ¹[Provincial Government].

Annual Medical List. 17. The Registrar shall in every year on or before a date to be fixed by the Medical Council cause to be printed and published a correct list of the names and qualifications of all persons for the time being entered in the register, and the dates when such qualifications were granted, in alphabetical order according to the surnames of the persons registered. Every Court shall presume that any person entered in such list is duly registered under this Act, and that any person who is not so entered is not registered.

Penalties.

18. Whoever falsely pretends to be registered under this Act or not being registered under this Act uses in connection with his name or title any words or letters representing that he is so registered shall, whether any person is actually deceived by such pretence or representation or not, be punished on conviction by a Presidency Magistrate or a Magistrate of the first class with fine that may extend to three hundred rupees.

Rules and regulations. 19. (1) Subject to the provisions of this Act, the Medical Council may from time to time make rules and regulations generally to carry out the provisions of this Act:

Provided that no rules or regulations made by the Medical Council whether under this or under any of the foregoing sections of this Act

shall have any force or effect unless the same shall have received the previous approval of the '[Provincial Government].

- (3) It shall be lawful for the ¹[Provincial Government], by notification in the ²[Official Gazette], to cancel any rule or regulation made under this Act.

If it shall appear to the 1[Provincial Government], on the report Alteration of the Medical Council or otherwise, that the course of study and in list of examinations prescribed by any of the Colleges or bodies conferring mentioned in the qualifications described in the Schedule are not such as to secure the Schedule. the possession by persons obtaining such qualification of the requisite knowledge and skill for the efficient practice of their profession, or if it shall appear to the ¹[Provincial Government], on the report of the Medical Council or otherwise, that the course of study and examinations prescribed by any College or body conferring a qualification not entered in the Schedule are such as to secure the possession by persons obtaining such qualification of the requisite knowledge and skill for the efficient practice of their profession, it shall be lawful for the '[Provincial Government] from time to time by notification in the 2[Official Gazette] to direct that the possession of any qualification entered in the Schedule shall not entitle any person to registration under this Act, or to direct that the possession of any qualification not entered in the Schedule shall, subject to the provisions of this Act, entitle a person to be so registered, as the case may be, and the Schedule shall thereupon be deemed for all purposes to be altered accordingly.
- 21. If at any time it shall appear to the ¹[Provincial Government] control. that the Medical Council has failed to exercise or has exceeded or abused any power conferred upon it under this Act or has failed to perform any duty imposed upon it by this Act, the ¹[Provincial Government] may notify the particulars of such default, excess or abuse to the Medical Council; and if the Medical Council fails to remedy such default, excess or abuse within such time as may be fixed by the ¹[Provincial Government] in this behalf, the ¹[Provincial Government] may for the purpose of remedying such default, excess or abuse cause any of the powers and duties of the Medical Council to be exercised and performed by such agency and for such period as ³[it] may think fit.

An Act for the abatement of nuisances arising from the smoke of furnaces in the Town and Island of Bombay and to provide for the extension thereof to other areas in the Bombay Presidency.

Whereas it is expedient to enact a law for the abatement of nuisances arising from the smoke of furnaces in the Town and Island of Bombay and to provide for the extension thereof to other areas in the Bombay Presidency; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Smoke-nuisances Act, Short title 1912.
- (2) It extends in the first instance to the Town and Island of Bombay.
- 2. (1) ²[The Provincial Government] may, by notification published Power in the ³[Official Gazette] and in such other manner as ²[the Provincial further Government] may determine, declare its intention to extend this Act Act. to any specified area in the Bombay Presidency other than the Town and Island of Bombay:

Provided that, if a military cantonment is situated within any area to which it is proposed to extend this Act, no notification shall be published under this sub-section in respect of such area without the previous sanction of the 4[Central Government].

(2) Any inhabitant of an area to which it is proposed to extend this Act may, if he objects to such extension, submit his objection in writing to ²[the Provincial Government] within a period of three months from the publication of the said notification in the ³[Official Gazette].

(3) At any time after the expiration of the said period, and after considering the objections, if any, submitted under sub-section (2), ¹[the Provincial Government] may, by notification in the ²[Official Gazette], extend this Act to the said area.

Definitions.

- 3. In this Act-
- (1) "furnace" means any furnace or fire-place used-
 - (a) for working engines by steam, or
 - (b) for any other purpose whatsoever:

Provided that no furnace or fire-place-

- (i) used for the burning of the dead;
- (ii) used in a private house for domestic purposes other than the purpose specified in clause (a);

shall be deemed to be a furnace or fire-place within the meaning of this Act.

- 4[(1A) "Flue" or "chimney" means any "flue" or "chimney" joined to, connected with or forming part of a furnace.]
- (2) "Inspector" means a Chief Inspector of Smoke-nuisances, or an Assistant Inspector of Smoke-nuisances, appointed under this Act;
- (3) "the Commission" means the Bombay Smoke-nuisances Commission constituted under this Act;
- (4) "occupier" means any person for the time being paying, or liable to pay, to the owner the rent or any portion of the rent of the land or building in respect of which the word is used;
 - (5) "owner" --
 - (a) when used in reference to a furnace ⁵[flue or chimney], includes any agent or lessee using the furnace ⁵[flue or chimney], and any foreman or other person superintending the working of the furnace ⁵[flue or chimney];
 - (b) when used in reference to any premises, has the meaning Bom. assigned to it in section 3 of the City of Bombay Municipal III o Act, 1888; and

(6) "Magistrate" means a Presidency Magistrate, a Magistrate of the first class, or a Bench of Magistrates exercising first class powers under the Code of Criminal Procedure, 1898.

- 4. (1) ¹[The Provincial Government] shall, by notification in the Constitution ²[Official Gazette], constitute a Commission, to be called the Bombay of Commission, Smoke-nuisances Commission, to supervise and control the working of this Act.
- (2) The said Commission shall consist of a President nominated by '[the Provincial Government] and so many other members as '[the Provincial Government] may determine.
- (3) One-half of the members (exclusive of the President) shall be nominated by ¹[the Provincial Government]; and the remainder shall be elected, in such manner and for such period, as ¹[the Provincial Government] may direct, by bodies or associations whose interests are likely to be affected by this Act; and the appointment of all members, whether nominated or elected, shall be notified in the ²[Official Gazette].
- (4) Where a casual vacancy occurs in the case of a nominated member ¹[the Provincial Government] shall make a fresh nomination, and where a casual vacancy occurs in the case of an elected member the election shall be made by the same body or association as that which elected, the member whose place is to be filled; and a member so nominated or elected shall hold office so long as the member whose place he fills would have been entitled to hold office had the vacancy not occurred.
- (5) No act done by the Commission shall be questioned on the ground merely of the existence of any vacancy in or any defect in the constitution of the Commission.
- 5. (1) ¹[The Provincial Government] may, by notification in the Appointment ²[Official Gazette], appoint a Chief Inspector of Smoke-nuisances and so of Inspectors. many Assistant Inspectors of Smoke-nuisances as they may think fit.
- (2) Every Assistant Inspector appointed under sub-section (1) shall be subordinate to the Chief Inspector, and all Inspectors shall be subordinate to, and subject to the control of, the Commission.
- 6. Every Inspector appointed under this Act shall, for the purposes Inspectors
 (LV) of this Act, be deemed to be a public servant within the meaning of the servants.

 - 7. (1) ¹[The Provincial Government] may, by notification in the Power to prohibit within any specified area—

prohibit the erection of kilns or furnaces, or the manuf facture of coke, in specified areas: and to inflict

- (c) the manufacture of coke in ovens or with special appliances, or
- (d) the making of coke without ovens or special appliances:

Provided that where, prior to the issue of such notification, a license has been granted by the Municipal Commissioner under the provisions of section 394 of the City of Bombay Municipal Act, 1888, for the Bom erection of a furnace to be used for any of the purposes mentioned in 1888. clauses (a) and (b), such notification shall not affect such furnace or kiln.

- (2) If any furnace or kiln be erected in contravention of any notification issued under sub-section (1), clause (a) or (b), the owner thereof shall be liable to fine which may extend to two hundred and fifty rupees.
- (3) If any person manufactures coke in contravention of any notification issued under sub-section (1), clause (c), he shall be liable to fine which may extend on first conviction to two hundred and fifty rupees, and on any subsequent conviction to five hundred rupees.

If any person makes coke in contravention of any notification issued under sub-section (1), clause (d), he shall be liable to fine which may extend on first conviction to twenty-five rupees, and on any subsequent conviction to fifty rupees.

- (5) If any coke is made in any building or place in contravention of a notification issued under sub-section (1), clause (d), the owner or occupier of such building or place shall be liable to fine which may extend on first conviction to twenty-five rupees, and on any subsequent conviction to fifty rupees.
- (6) Where any coal is in process of being made or has been made into coke in contravention of a notification issued under sub-section (1), clause (d), an Inspector may seize such coal or coke, and report the seizure to a Magistrate who may, after such enquiry as he thinks necessary, order such coke or coal to be confiscated, and to be sold in accordance with rules to be made by ¹[the Provincial Government] in this behalf under section 11.

Power to order demolition of kilns or furnaces unlawfully erected.

- 8. (1) A Magistrate imposing a fine on any person under sub-section (2) of section 7 may by order direct such person to demolish the kiln or furnace within a period to be specified in the order.
- (2) Any such person failing to demolish any kiln or furnace within the period prescribed in any such order, or within such longer period as the Magistrate may, for reasons to be stated, allow, shall be liable to fine which may extend to twenty rupees for every day thereafter during which such failure continues.

(1) If smoke be emitted from any furnace in greater density, Penalty for or at a lower altitude, or for a longer time, than is permitted by rules excessive emission of made under this Act, the owner of the furnace shall be liable to fine smoke. which may extend on first conviction to fifty rupees, on second conviction to one hundred rupees, and on any subsequent conviction to two hundred rupees.

- (2) Sub-section (1) shall not apply to any furnace which is used—
 - (a) in connection with a brick, tile or lime kiln, or
 - (b) for the purpose mentioned in clause (d) of sub-section (1) of section 7.

- (2) If any furnace, flue or chimney is erected, altered, added to or re-erected in contravention of the provisions of sub-section (1), the owner of such furnace, flue or chimney shall be liable to fine which may extend to one hundred rupees; and, if any such furnace, flue or chimney is used without the permission of the Commission, to a further fine not exceeding twenty rupees for every day during which such use continues.]

 - (a) enter and inspect, during working hours, any building or place which contains a furnace, 2[flue or chimney], and inspect such furnace, 2[flue or chimney];
 - (b) under the written authority of the Commission, use and test any appliance used for preventing the emission of smoke from such furnace, 2[flue or chimney]; and
 - (c) under the written authority of the Commission, direct that any such furnace, 2[flue or chimney] be worked 3* * experimentally, during his visit to such building or place, in any manner

which he may consider suitable for preventing or reducing the emission of smoke, but not so as to interfere with the business carried on in such building or place further than is necessary for the purposes of the experiment.

(2) If any owner of a furnace, '[flue or chimney] in respect of which a direction is given under clause (c) of sub-section (I) fails to secure compliance with such direction, he shall be liable to fine which may extend to one hundred rupees:

Provided that where any Inspector has reason to believe that any offence under sub-sections (2), (3) or (4) of section 7 has been or is being committed on any premises it shall be lawful for him to enter on such premises without previous notice and without written authority from the Commission.

Rules.

- 11. (1) ²[The Provincial Government] may, ^{3*} * * after-previous publication, make rules to carry out the objects of this Act.
- (2) In particular, and without prejudice to the generality of sub-section (1), such rules may—

(a) regulate the transaction of business by the Commission;

- (b) prescribe the powers and duties to be exercised and performed by the Commission and by Inspectors, respectively, and regulate the exercise and performance of those powers and duties;
- (c) prescribe a scale for the purpose of determining the density of smoke:
- (d) prescribe the degree of density of smoke that may be emitted from a furnace;
- (e) prescribe the time during which smoke of such density may be emitted from a furnace;
- (f) prescribe the altitude below which smoke may not be emitted from a furnace;

- (h) prescribe a procedure for the giving of warning to offenders before instituting a prosecution under this Act, and declare the minimum period which should be allowed to elapse in different classes of cases between the giving of such warning and the institution of a prosecution;
- ⁵[(hh) prescribe the procedure regarding the submission and approval of plans under sub-section (1) of section 9A.]
 - (i) fix the amount of fee payable to each or any member of the Commission attending a meeting of the Commission; and

- (3) The date to be specified in accordance with clause (c) of section 24

 - 12. A Magistrate may take cognizance of an offence against this Cognizance Act only—
 - (a) upon a complaint made by, ¹[an inspector with the previous sanction of the Commission or of a sub-committee appointed by the Commission], and
 - (b) within a period of two months from the date of the commission of the offence.

X of WHEREAS it is expedient to amend the Indian Limitation Act, 908. 1908, in the manner hereinafter appearing:

AND WHEREAS the previous sanction of the Governor General required by section 5 of the ⁸Indian Councils Act, 1892, has been obtained for the passing of this Act; It is hereby enacted as follows:—

- 1. This Act may be called the Indian Limitation (Amendment) Short title. Act, 1912.
- 2. (3) The provisions of sections 2, 3 and 4 shall apply to any case restored under either of the foregoing sub-sections.

[THE PRINCE OF WALES MUSEUM (AMENDING) ACT, 1913.]

[4th October, 1913]

An Act to amend the Prince of Wales Museum Act, 1909.

Bom. Whereas it is expedient to amend the ²Prince of Wales Museum III of Act, 1909, in the manner hereinafter appearing; It is hereby enacted as follows:—

- 1. This Act may be called the Prince of Wales Museum (Amending) Short title. Act, 1913.
- 2. From the area comprised in the schedule to the Prince of Wales Amendment Museum Act, 1909 (hereinafter referred to as "the said Act"), the of schedule following area shall be excluded, namely:—

All that piece or parcel of land containing by admeasurement 359.52 square yards, be the same a little more or less, of which 275.57 square yards are contained between the outer side of the curve at the North-East angle of the boundary of the site of the Prince of Wales Museum of Western India and lines tangential to the extremeties of the said curve, and the remaining area amounting to 83.95 square yards is contained in an irregular figure projecting outwards from the tangential line of the said curve which runs more or less parallel to Apollo Street, the whole of the said piece or parcel of land with the boundaries thereof being delineated for greater clearness on a plan signed by the Executive Engineer, Presidency District, and a majority of the Trustees of the Prince of Wales Museum of Western India and deposited with the Secretary to Government in the General Department.

3. All the estate, right, title and interest of the Trustces of the Property Prince of Wales Museum of Western India in and to the area excluded from the schedule to the said Act by the last preceding section shall schedule to revest in His Majesty.

An Act to provide for the making and execution of town-planning schemes.

Whereas it is expedient that the development of certain areas should be regulated with the general object of securing proper sanitary conditions, amenity and convenience to the persons living in such areas and in neighbouring areas;

AND WHEREAS the previous sanction of the Governor General required by section 5 of the ²Indian Councils Act, 1892, has been obtained for the passing of this Act; It is hereby enacted as follows:—

CHAPTER I.

PRELIMINARY.

- 1. (1) This Act may be called the Bombay Town Planning Act, Short title 1915.
- (2) It shall extend in the first instance to the Island of Salsette, but the ³[Provincial Government] may by notification in the ⁴[Official Gazette] direct that it shall extend in whole or in part to any part of the Bombay Presidency:

Provided that this Act shall not be extended in whole or in part to the City of Bombay or any part thereof except on the previous application of the Municipal Corporation of the City of Bombay in this behalf to the ³[Provincial Government], such application having been previously assented to by a majority of the whole of the Municipal Corporation.

- 2. In this Act, unless there is anything repugnant in the subject Interpretaor context:—
 - (a) "local authority" means a Municipality or, where there is no Municipality, a committee appointed for a notified area under the provisions of Chapter XIV of the Bombay District Municipal Act, 1901, as modified by this Act;

- (b) "prescribed" means prescribed by rules made under this Act;
- (c) "owner" includes an owner in severalty, in common or joint; and includes also an occupant as defined in clause (16) of Bom. section 3 of the Bombay Land Revenue Code, 1879;

- (d) "plot" means a continuous portion of land held in one ownership, other than land used, allotted or reserved for any public or municipal purpose;
- (e) "reconstituted plot" means a plot which is in any way altered by the making of a town-planning scheme otherwise than by the severance of land used, allotted or reserved for any public or municipal purpose.

Explanation.—" Altered " includes alteration of ownership.

(f) "scheme" includes a plan relating to a town-planning scheme.

Contents of planning scheme.

- 3. A town-planning scheme may make provision for any of the following matters:-
 - (a) the construction, diversion, alteration and stopping up of streets, roads and communications;
 - (b) the construction, alteration, and removal of buildings, bridges and other structures;
 - (c) the plotting out of land as building-sites whether such land is intended to be used for building purposes in the immediate future or not:
 - (d) the allotment or reservation of land for roads, open spaces, gardens, recreation grounds, schools, markets and public purposes of all kinds;
 - (e) drainage inclusive of sewerage and of surface drainage and sewage disposal;
 - (f) lighting;
 - (q) water supply;
 - (h) the preservation of objects of historical interest or natural beauty and of buildings actually used for religious purposes or regarded by the public with special religious veneration;
 - (i) the imposition of conditions and restrictions in regard to the open space to be maintained about buildings, the number, height and character of buildings allowed in specified areas and the purposes to which buildings or specified areas may or may not be appropriated;
 - (j) the suspension, so far as may be necessary for the proper carrying out of the scheme, of any rule having the force of law, bye-law, Act, or other provision 1* * * which is in force in the area included in the scheme:

- (k) such other matter not inconsistent with the objects of this Act as may be prescribed.
- 4. (1) Where there is a disputed claim as to the ownership of any Disputed piece of land included in an area in respect of which any of the provisions ownership. of this Act are to be applied and any entry in the record-of-rights or mutation register relevant to such disputed claim is inaccurate or inconclusive, an enquiry may be held by such officer as the 3[Provincial Government] in the City of Bombay or the Commissioner elsewhere may appoint for the purpose of deciding who shall be deemed to be the owner for the purposes of this Act.
- (2) Such decision shall not be subject to appeal but it shall not operate as a bar to a regular suit.
- (3) Such decision shall, in the event of a Civil Court passing a decree which is inconsistent therewith, be corrected, modified or rescinded in accordance with such decree as soon as practicable after such decree has been brought to the notice of the local authority either by the Civil Court or by some person affected by such decree.
- 5. For the purpose of the preparation, making, or execution of any Right of town-planning scheme any person authorized by the local authority entry. or any public servant or person duly appointed or authorised under this Act may, after giving such notice as may be prescribed to the owner, occupier or other person interested in any land, enter upon, survey and mark out such land and do all acts necessary for such purpose.
- 6. (1) A local authority as defined in this Act shall be deemed to Powers of IX of be a local authority as defined in the 4Local Authorities Loans Act, suthority to 1914, for the purpose of borrowing money under that Act, and the borrow making and execution of a town-planning scheme shall be deemed money and to be a work which such local authority is legally authorized to make and execute carry out.
- - (2) Any expenses incurred by a local authority under this Act or scheme, any town-planning scheme made thereunder may be defrayed out of its funds.
- 7. Notwithstanding anything contained in sub-section (3) of Notified section 187 of the Bombay District Municipal Act, 1901, the 3[Provincial areas. III of Government] may declare any specified area, for which it is proposed 1901. to make a town-planning scheme, to be a notified area.

CHAPTER II.

DECLARATION OF INTENTION TO MAKE A SCHEME, AND PREPARATION OF DRAFT SCHEME.

Land in respect of which a townplanning scheme may be made.

- 8. (1) A town-planning scheme may be made in accordance with the provisions of this Act in respect of any land which is in course of development or is likely to be used for building purposes.
- (2) Where it appears to the ¹[Provincial Government] that a piece of land already built upon, or a piece of land not likely to be used for building purposes is so situated with respect to any land which is in course of development or likely to be used for building purposes that it ought to be included in any town-planning scheme intended to be made with respect to the last-mentioned land, the ¹[Provincial Government] may sanction the making of a scheme including such piece of land as aforesaid, and providing for the demolition or alteration of any buildings thereon so far as may be necessary for carrying the scheme into effect.
- (3) The expression "land likely to be used for building purposes" shall include any land likely to be used as, or for the purpose of providing, open spaces, roads, streets, parks, pleasure or recreation grounds, or for the purpose of executing any work upon or under the land incidental to a town-planning scheme, whether in the nature of a building work or not, and the decision of the ¹[Provincial Government] as to whether land is likely to be used for building purposes or not shall be final.

Powers of a local authority to resolve on a declaration of intention to make a scheme and of the Provincial Government to sanction such declaration.

- 9. (1) The local authority having jurisdiction over any such land as is referred to in section 8 may by resolution declare its intention to make a town-planning scheme in respect of the whole or any part of such land and of any land which is in the vicinity of such land but which is not included in any other municipal or notified area, provided that for the making of such scheme the sanction of the ¹[Provincial Government] shall be necessary.
- (2) Within twenty-one days from the date of such declaration (hereinafter referred to as a declaration of intention to make a scheme), the local authority shall despatch a copy thereof for publication in the ²[Official Gazette] and shall publish it in the prescribed manner and shall apply to the ¹[Provincial Government] for sanction for the making of such scheme.
- (3) With its application for such sanction the local authority shall send to the '[Provincial Government] a plan showing the area which it proposes to include in the town-planning scheme and the surrounding lands.

(4) A copy of such plan shall be open to the inspection of the public at all reasonable hours at the head office of the local authority.

(5) If within one month from the date of such publication in the 1[Official Gazette] any person likely to be affected by such scheme communicates in writing to the 2[Provincial Government] any objection or suggestion relating to such scheme the ²[Provincial Government] shall consider such objection or suggestion.

(6) After receiving such application and after making such inquiry as ³[it] may think fit, the ²[Provincial Government] may, by notification in the '[Official Gazette], either sanction the making of such scheme with or without modifications and subject to such conditions as ³[it] may think fit to impose, or ³[it] may by a similar notification refuse to

give sanction.

10. (1) Within twelve months from the date of the notification Preparation sanctioning the making of a town-planning scheme the local authority and shall in consultation with the owners prepare, and publish in the of draft prescribed manner, a draft scheme for the area in respect of which scheme. sanction has been given.

(2) If such publication is not made by the local authority within twelve months from the date of such notification, the 2[Provincial Government] in the City of Bombay or the Commissioner elsewhere may in consultation with the owners prepare, and publish in the prescribed manner, a draft scheme for the area in respect of which

sanction has been given within a further period of nine months.

(3) If such publication is not made by the 2[Provincial Government] Lapsing of or the Commissioner, as the case may be, within the further period sanction. specified in sub-section (2), the sanction of the ²[Provincial Government] for the making of such town-planning scheme shall lapse, and until a period of three years has elapsed from the date of such sanction it shall not be competent to the local authority to apply for fresh sanction for the making of any town-planning scheme for the same area or for any part of it.

11. The draft scheme shall contain the following particulars:—

Contents of draft scheme.

- (a) the area, ownership and tenure of each original plot;
- (b) the land allotted or reserved under clause (d) of section 3, with a general indication of the uses to which such land is to be put;
- (c) the extent to which it is proposed to alter the boundaries of original plots;
- (d) an estimate of the net cost of the scheme to be borne by the local authority;
- (e) a full description of all details of the scheme under such clauses of section 3 as may be applicable; and
- (f) any other prescribed particulars.

Reconstituted plots.

- 12. (1) In the draft scheme the size and shape of every reconstituted plot shall be so determined as to render it, so far as may be, suitable for building purposes.
- (2) In order to render original plots more suitable for building purposes the draft scheme may contain proposals—
 - (a) to form a reconstituted plot by the alteration of the boundaries of an original plot,
 - (b) to provide with the consent of the owners that two or more original plots each of which is held in ownership in severalty or in joint ownership shall hereafter, with or without alteration of boundaries, be held in ownership in common as a reconstituted plot,
 - (c) to allot a plot to any owner dispossessed of land in furtherance of the scheme, and
 - (d) to transfer the ownership of a plot from one person to another.

Objections to the draft scheme to be considered. 13. If within one month from the date of publication of the draft scheme any person affected by such scheme communicates in writing to the local authority any objection relating to such scheme the local authority shall consider such objection and may, at any time before submitting the draft scheme to the [Provincial Government] as hereinafter provided, modify such scheme as it thinks fit.

Power of the Provincial Government to sanction a draft scheme.

- 14. (1) The local authority shall then submit the draft scheme with any modifications which it may have made therein together with the objections which may have been communicated to it to the ¹[Provincial Government] and shall at the same time apply for ²[its] sanction.
- (2) After receiving such application and after making such inquiry as ³[it] may think fit, the ¹[Provincial Government] may, by notification in the ⁴[Official Gazette] either sanction such scheme with or without modifications and subject to such conditions as ³[it] may think fit to impose, or ³[it] may by a similar notification refuse to give sanction.
- (3) If the ¹[Provincial Government] sanctions such scheme, ³[it] shall in such notification state at what place and time the draft scheme shall be open to the inspection of the public.

Restrictions after declaration.

- 15. (1) When a local authority has published a declaration of intention to make a scheme—
 - (a) no person shall within the area included in the scheme erect or proceed with any building or work ⁵[or remove, pull down

- or alter any building or part of a building or remove any earth, stone or material] unless such person has applied for and obtained the necessary permission which shall be contained in a commencement certificate granted by the local authority in the form prescribed;
- (b) the local authority on receipt of such application shall at once furnish the applicant with a written acknowledgment of its receipt, and after enquiry may either grant or refuse such certificate or grant it subject to such conditions as may be consistent with the scheme; but if the local authority communicates no decision to the applicant within three months from the date of such acknowledgment he shall be deemed to have been granted such certificate;
- (c) if in the opinion of the local authority any person contravenes the provisions contained in clause (a) or clause (b), the local authority after making enquiry in the prescribed manner may by notice in writing direct such person to stop any work in progress;
- (d) any expenses incurred by the local authority under clause (c) shall be a sum due to the local authority under this Act from the person in default;
- ¹[(r) any diminution in the value of an original plot occasioned by any contravention of clause (a) or clause (b) shall, notwith-standing anything contained in section 16, 17 or 19, be taken into account in fixing the market value of such plot.]
- (2) No person shall be entitled to compensation in respect of any damage, loss or injury resulting from any action taken by the local authority under the provisions of this section or of section 43, except in respect of a building or work begun or a contract entered into before the date on which the local authority published a declaration of intention to make a scheme, and only in so far as such building or work has proceeded at the time of the publication of the declaration of intention to make a scheme.
- (3) The restrictions imposed by this section shall cease to operate in the event of the ²[Provincial Government] refusing to sanction the making of a town-planning scheme, or in the event of the sanction of the ²[Provincial Government] for the making of such scheme lapsing, or in the event of the ²[Provincial Government] refusing to sanction the draft scheme.

CHAPTER III.

Costs of the scheme.

- 16. (1) The costs of a town-planning scheme shall include—
 - (a) all sums payable by the local authority under the provisions of this Act which are not specifically excluded from the costs of the scheme:
 - (b) all sums spent or estimated to be spent by the local authority in the making and in the execution of the scheme;
 - (c) all legal expenses of the local authority incurred in the making and in the execution of the scheme; and
 - (d) any amount by which the total of the values of the original plots exceeds the total of the values of the plots included in the final scheme, each of such plots being estimated at its market value at the date of the declaration of intention to make a scheme with all the buildings and works thereon at that date and without reference to improvements contemplated in the scheme other than improvements due to the alteration of its boundaries.
- (2) If in any case the total of the values of the plots included in the final scheme exceeds the total of the values of the original plots, each of such plots being estimated in the manner provided in clause (d) of sub-section (1), then the amount of such excess shall be deducted in arriving at the costs of the scheme, as defined in sub-section (1).

Calculation

17. ¹[For the purposes of this Act the increment shall be deemed to of increment, be the amount by which at the date of the declaration of intention to make a scheme the market value of a plot included in the final scheme estimated on the assumption that the scheme has been completed would exceed at the same date the market value of the same plot estimated without reference to improvements contemplated in the scheme:

> provided that in estimating such values the value of buildings or other works erected or in the course of erection on such plot shall not be taken into consideration.

Contribution towards the costs of the scheme.

18. (1) The costs of the scheme shall be met wholly or in part by a contribution to be levied by the local authority on each plot included in the final scheme calculated in proportion to the increment which is estimated to accrue in respect of such plot by the Tribunal of Arbitration:

provided that—

(i) no such contribution shall exceed half the increment estimated by the Tribunal of Arbitration to accrue in respect of such plot; and

- (ii) where a plot is subject to a mortgage with possession or to a lease, the Tribunal of Arbitration shall determine in what proportion the mortgagee or lessee on the one hand and the mortgagor or lessor on the other hand shall pay such contribution.

Provided that an agricultural lease shall not be transferred from an original plot to a reconstituted plot without the consent of all the parties to such lease.

21. The owner of any property or right which is injuriously affected Compenby the making of a town-planning scheme shall, if he makes a claim sation in respect of before the arbitrator within the prescribed time, be entitled to obtain property compensation in respect thereof from the local authority or from any or right person benefited or partly from the local authority and partly from such injuriously affected person, as the Tribunal of Arbitration may in each case determine:

Provided that the value of such property or right shall be held to be its market value at the date of the declaration of intention to make a scheme without reference to improvements contemplated in the scheme.

- 22. (1) Where property or a private right of any sort is alleged to be Exclusion or injuriously affected by reason of any provisions contained in a town-limitation of planning scheme, no compensation shall be paid in respect thereof in certain if or in so far as the provisions are such as would have been enforceable cases without compensation under any rule having the force of law, by-law or Act in force at the time.
- (2) Property or a private right of any sort shall not be deemed to be injuriously affected by reason of any provisions inserted in a townplanning scheme, which, with a view to securing the amenity of the area included in such scheme or any part thereof, impose any conditions and restrictions in regard to any of the matters specified in clause (i) of section 3.

Provision for case in which amount payable to owner exceeds amount due from him. 23. If the owner of an original plot is not provided with a plot in the final scheme, or if the contribution to be levied from him under section 18 is less than the total amount to be deducted therefrom under any of the provisions of this Act, the net amount of his loss shall be payable to him by the local authority in cash, or in such other way as may be agreed upon by the parties.

Provision for case in which value of developed plot is less than amount payable by owner.

- 24. (1) If from any cause the total amount which would be due to the local authority under the provisions of this Act from the owner of a plot to be included in the final scheme exceeds the value of such plot estimated on the assumption that the scheme has been completed, the arbitrator shall, at the request of the local authority, direct the owner of such plot to make payment to the local authority of the amount of such excess.
- (2) If such owner fails to make such payment within the prescribed period, the arbitrator shall, if the local authority so requests, acquire the original plot of such defaulter and apportion the compensation among the owner and other persons interested in the plot on payment by the local authority of the value of such plot estimated at its market value at the date of the declaration of intention to make a scheme and without reference to improvements contemplated in the scheme; and thereupon the plot included in the final scheme shall vest absolutely in the local authority, free from all encumbrances but subject to the provisions of this Act:

provided that the payment made by the local authority on account of the value of the original plot shall not be included in the costs of the scheme.

Payment by adjustment of account.

25. All payments due to be made to any person by the local authority under this Act shall, as far as possible, be made by an adjustment in such person's account with the local authority in respect of the plot concerned or of any other plot in which he has an interest and failing such adjustment shall be paid in cash or in such other way as may be agreed upon by the parties.

Payment of net amount due to local authority.

- 26. (1) The net amount payable under the provisions of this Act by the owner of a plot included in the final scheme may at the option of the contributor be paid in one sum or in such instalments including charges for interest as shall be fixed by the local authority with the sanction of the ¹[Provincial Government] in the City of Bombay or the Commissioner elsewhere.
- (2) Where more than one plot included in the final scheme is in the same ownership the net amount payable by such owner under the provisions of this Act shall be distributed over his several plots in proportion to the increment which is estimated to accrue in respect of each plot unless the owner and the local authority agree to a different method of distribution.

- 27. (1) A local authority shall be competent to make any agreement Power of with any person in respect of any matter which is to be provided for local in a town-planning scheme, subject to the power of the ¹[Provincial to make Government] to modify or disallow such agreement and, unless it is sgreements. otherwise expressly provided therein, such agreement shall take effect on and after the day on which the town-planning scheme comes into force.
- (2) Such agreement shall not in any way affect the duties of the arbitrator or of the Tribunal of Arbitration as described in Chapter IV or the rights of third parties, but it shall be binding on the parties to the agreement notwithstanding any decision that may be passed by the arbitrator or by the Tribunal of Arbitration:

provided that if the agreement be modified by Government, either party shall have the option of avoiding it if he so elects.

CHAPTER IV.

THE ARBITRATOR AND THE TRIBUNAL OF ARBITRATION.

- 29. After a draft scheme has been sanctioned the '[Provincial Appointment Government] shall appoint an arbitrator with sufficient establishment of arbitrator, whose duties shall be as hereinafter provided.
- 30. In accordance with the prescribed procedure the arbitrator Duties shall—

 - (4) estimate the increment to accrue in respect of each plot included in the final scheme, in accordance with the provisions contained in section 17;
 - (5) calculate the proportion in which the increment of the plots included in the final scheme shall be liable to contribution to the costs of the scheme, in accordance with the provisions contained in section 18;

- (6) calculate the contribution to be levied on each plot included in the final scheme;
- (7) determine the amount to be deducted from or added to, as the case may be, the contributions leviable from a person, in accordance with the provisions contained in section 19;
- (8) provide for the total or partial transfer of any right in an original plot to a reconstituted plot or provide for the extinction of any right in an original plot, in accordance with the provisions contained in section 20;
- (9) estimate in reference to claims made before him, after notice given by him in the prescribed manner, the compensation to be paid to the owner of any property or right injuriously affected by the making of a town-planning scheme, in accordance with the provisions contained in section 21 and subject to the provisions contained in section 22;
- (10) draw up in the prescribed form the final scheme in accordance with the draft scheme:
 provided that—
 - (i) he may make variations from the draft scheme;
 - (ii) any variation estimated by him to involve an increase of ten per centum in the costs of the scheme as described in section 16 shall require the sanction of the ¹[Provincial Government]:
 - provided further that he shall make no substantial variation without the consent of the local authority and without hearing any objections that may be raised by the owners concerned; and that in the case of any substantial variation made by him the owners concerned shall have the right of appeal to the ¹[Provincial Government].

Certain decisions of the arbitrator shall be final. 31. Except in matters arising out of clauses (4), (5), (6) and (9) of section 30, and subject to the provisos contained in clause (10) of section 30, every decision of the arbitrator shall be final and conclusive and binding on all persons.

Arbitrator shall make proposals in certain matters. 32. In matters arising out of clauses (4), (5), (6) and (9) of section 30, the arbitrator shall estimate or calculate what is required by such clauses to be estimated or calculated and shall forthwith make proposals on all such matters to the President of the Tribunal of Arbitration for the decision of such Tribunal.

Constitution of the Tribunal of Arbitration.

- 33. (1) The Tribunal of Arbitration shall consist of a President and two Assessors.
- (2) The President shall, in the City of Bombay, be a person who holds or has held office as a Judge of the High Court of Judicature, to be appointed by the Chief Justice, in the district of Karachi, be such Additional Judicial Commissioner as may be appointed by the Judicial Commissioner, and elsewhere the District Judge.

- (6) The ¹[Provincial Government] may, if ²[it] thinks fit, remove for inability or misconduct or any other good and sufficient reason the Assessor appointed under sub-section (3) or the Arbitrator.
- (7) If any member of the Tribunal of Arbitration is removed or dies or refuses or neglects to act or becomes incapable of acting, the authority who appointed such member shall appoint forthwith a fit person to take the place of such member.

(2) The salary of an arbitrator, a President of the Tribunal of Arbitration or an Assessor who is a salaried ¹[servant of the Crown], and any remuneration payable under sub-section (I) and all expenses incidental to the working of the Tribunal of Arbitration shall, unless the ²[Provincial Government] otherwise determines, be defrayed out of the funds of the local authority and shall be added to the costs of the scheme.

Final scheme.

- 40. (1) After the Tribunal of Arbitration has decided all matters arising out of clauses (4), (5), (6) and (9) of section 30, the arbitrator shall forward the final scheme through the local authority to the ²[Provincial Government], ³[which], on sanctioning the same, shall publish a notification relating thereto in the ⁴[Official Gazette] and in any other way which may be prescribed.
- (2) In such notification it shall be stated where the final scheme is open to the inspection of the public and the price at which copies may be obtained, and a date not earlier than one month after the publication of such notification shall be fixed as the date on which all liabilities created by the scheme shall take effect and the final scheme shall come into force.
- (3) On and after the date fixed in such notification a town-planning scheme shall have effect as if it were enacted in this Act.

Effect of final scheme.

- 41. On the day on which the final scheme comes into force—
 - (a) all lands required by the local authority shall, unless it is otherwise determined in such scheme, vest absolutely in the local authority free from all encumbrances;
 - (b) all rights in original plots which have been reconstituted shall determine and the reconstituted plots shall become subject to the rights settled by the arbitrator.
- 42. On and after the day on which the final scheme comes into force any person continuing to occupy any land which he is not entitled to occupy under the final scheme may, in accordance with the prescribed procedure; be summarily evicted by the local authority.

- (b) execute any work which it is the duty of any person to execute under the scheme in any case where it appears to the local authority that delay in the execution of the work would prejudice the efficient operation of the scheme.
- (2) Any expenses incurred by a local authority under this section may be recovered from the persons in default in the manner hereinbefore provided for the recovery of sums due to the local authority under the provisions of this Act.
- (3) If any question arises as to whether any building or work contravenes a town-planning scheme, or whether any provision of a town-planning scheme is not complied with in the erection or carrying out of any such building or work, that question shall be referred to the '[Provincial Government] in the City of Bombay or the Commissioner elsewhere, and '[its or his] decision shall be final and conclusive and binding on all persons.
- 44. For the purposes of this Act an officer appointed under sub-Power to section (1) of section 4, an arbitrator or a Tribunal of Arbitration compel attendmay summon and enforce the attendance of witnesses including the ance of parties interested or any of them and compel them to give evidence witnesses and compel the production of documents by the same means and, as far as possible, in the same manner as is provided in the case of a Civil Court by the Code of Civil Procedure, 1908.

CHAPTER V.

MISCELLANEOUS.

- 45. (1) When two or more local authorities are of opinion that the Joint town-interests of contiguous areas within their respective jurisdictions can planning best be served by the making of a joint town-planning scheme, and the schemes. ¹[Provincial Government] agrees with such opinion, a joint Town Planning Board shall be constituted.
- (2) Such Board shall consist of representatives of each of the several local authorities and of persons nominated by the '[Provincial Government] in such proportion as may be prescribed.
- (3) The representatives of the several local authorities shall be elected in the prescribed manner on dates appointed by the ¹[Provincial Government] in the City of Bombay and by the Commissioner elsewhere.
- (4) Such Board, when duly constituted, shall make a declaration of intention to make a joint town-planning scheme in respect of the contiguous areas in the manner provided in section 9 and thereafter the procedure shall follow all the provisions of this Act and such Board shall have all the powers and be liable to all the duties of a local authority under the provisions of this Act.
- (5) The draft joint town-planning scheme shall specify the parts of the scheme to be executed by the several local authorities in the

47. If at any time after the day on which the final scheme has come into force such scheme is varied or revoked, any person who has incurred expenditure for the purpose of complying with such scheme shall be entitled to receive compensation from the local authority, in so far as any such expenditure is rendered abortive by reason of the variation or revocation of such scheme.

WHEREAS it is expedient to decentralize and otherwise to facilitate the administration of certain enactments in force in the Presidency of Bombay;

AND WHEREAS the previous sanction of the Governor General required by section 5 of the ²Indian Councils Act, 1892, has been obtained for the passing of this Act; It is hereby enacted as follows:—

- 1. This Act may be called the Eombay Decentralization Act, Short title. 1915.
- 2. The enactments specified in the third columns of the Schedules I Amendments and II are hereby amended to the extent and in the manner specified of certain in the fourth columns thereof.
- 3. Any appointment, notification, order, scheme, rule, form or Saving of bye-law made or issued by an authority for the making or issuing of orders etc., which a new authority is substituted by or under this Act shall, unless previous inconsistent with this Act, be deemed to have been made or issued by authorities. such new authority unless and until superseded by an appointment, notification, scheme, rule, form or bye-law made or issued by such new authority.

(2) The Assistant Superintendents shall exercise such powers as may be delegated to them by the Superintendent.

4. The Superintendent or any other officer employed in the survey ent may enter may enter, between the hours of sunrise and sunset, upon any land within the local limits aforesaid, without being liable to any legal proceedings whatsoever on account of such entry or of anything done on such land in pursuance of this Act:

> Provided that no such entry shall be made unless a notice of the intention to make such entry has been posted at least twenty-four hours previously in some conspicuous manner on the land.

Notice to be served on holders to attend.

5. Before entering on any land for the purposes of survey, the Superintendent may cause a notice in writing under his hand to be served on the holder or occupier of the land about to be surveyed and on the holders or occupiers of conterminous lands, calling upon them to attend either personally or by agent on such land before him or before such officer as may be authorized by him in that behalf, within a specified time (which shall not be less than three days after the service of such notice), for the purpose of pointing out boundaries and of affording such information as may be needed for the purposes of this Act, and intimating that in the event of their failing to attend he or such officer will proceed with the survey in their absence.

After service of notices Superintendent may proceed with survey.

6. After due service of notice under section 5, the Superintendent, or such officer as may be authorized by him, may proceed with the survey whether the persons upon whom notices have been served are present or not.

Survey map and register.

- 7. (1) The Superintendent shall prepare a map and a register of all lands which have been surveyed under this Act.
- (2) To every piece of land separately shown on the map and entered in the register an indicative number shall be assigned, and the name of the person appearing to be the holder thereof at the time of the survey shall be entered in the register.
- (3) Nothing contained in such map or register shall affect the rights of any person.

8. The Superintendent may at any time cause to be erected, on ent may erect any land which is to be, or has been, surveyed under this Act, temporary or permanent boundary marks of such materials and in such number and manner as he may determine to be sufficient for the purpose of the survey:

> Provided that no permanent boundary mark shall be erected when the boundary is defined by a permanent building, wall or fence.

Maintenance of temporary boundary marks.

9. (1) When any temporary boundary mark has been erected under section 8, the Superintendent may cause a notice in writing under his hand to be served on the holder of the land whereon, or adjoining which, such boundary mark is situate, requiring him to maintain such boundary mark till the survey has been completed.

(2) Should such holder not comply with such notice, the Superintendent may repair the boundary mark and expenses shall be recoverable from such holder as an arrear of land revenue under the provisions of the Bombay City Land-revenue Act, 1876.

> 10. (1) The holder of any land surveyed under this Act shall be Survey fee liable to the payment of a survey-fee assessed on the area and rateable may be charged. value of such land:

Provided that the aggregate amount of the survey-fees assessed under this section shall not be greater than one-half of the total cost of the survey.

(2) The amount of the survey-fee payable under sub-section (1) shall be regulated by the Collector in accordance with rules made by the '[Provincial Government] under section 18:

Provided that—

(a) no survey-fee shall be payable by 2[the Crown] or by the Municipal Corporation of the City of Bombay or by the Trustees for the Improvement of the City of Bombay or by the Trustees of the Port of Bombay;

(b) the holder of any land of which the area and rateable value do not exceed such limit as may be prescribed by rule made by the ¹[Provincial Government] under section 18 shall be exempt from the payment of any survey-fee in respect of that

land:

(c) no survey-fee shall be payable in respect of buildings and lands exclusively occupied for public worship or for charitable purposes which under the City of Bombay Municipal Act, 1888, are exempt from the levy of the general tax.

(3) Any survey-fee assessed in accordance with sub-sections (1) and (2) shall be payable within three months from the date of a notice to be served by the Collector upon the person liable therefor after the completion of the survey of the Town and Island of Bombay, and such survey-fee shall be leviable as an arrear of land revenue under the provisions of the Bombay City Land-revenue Act, 1876.

(3) During such period the Collector may, if necessary and without prejudice to the rights of any of the parties concerned, cause the map or the register prepared under section 7 to be corrected free of charge.

Maintenance of survey map and register.

12. (1) The map and register prepared under section 7 shall be maintained by the Collector, who shall cause the map to be revised and the entries in the register to be corrected from time to time as may be necessary, without prejudice to the rights of any person:

Provided that no person shall for the purposes of this Act be required to give notice of the acquisition of any interest in land.

(2) The Collector may assess the cost of the revision of any part of the map and all contingent expenses on the land to which such part relates, and such cost shall be payable by the holder of such land, subject to the same exemption as is provided in section 10, subsection (2), proviso (a), with reference to the payment of survey-fees and shall be leviable as an arrear of land revenue under the provisions Bom of the Bombay City Land-revenue Act, 1876.

Revision of maps.

13. Subject to rules made in this behalf by the ¹[Provincial Government] under section 18, any officer acting under the orders of the Collector of Bombay may, for the purpose of revising any map prepared under this Act, exercise any of the powers of a Superintendent under this Act.

How notices may be served.

- 14. Every notice required by this Act to be served on any person may be served-
 - (a) by delivering the same to such person, or when such person cannot be found, by posting the same on some conspicuous part of the house in which such person usually resides or holds his office or carries on his business, or by delivering the same to an agent or servant of such person, or to a male adult member of his family, and, in the case of a notice served under section 5 or section 9, by fixing a copy in some conspicuous manner on the land to which it relates; or
 - (b) by sending a registered cover through the post office containing such notice addressed to such person at the place where he resides.

Privilege of title-deeds.

15. No person shall for the purposes of this Act be compelled to produce his title-deeds to any land or to disclose their contents.

An Act to disqualify certain aliens from being members, and from voting at elections of members, of certain local authorities in the presidency of Bombay.

Whereas it is expedient that certain aliens should be disqualified from being members, and from voting at elections of members, of certain local authorities in the presidency of Bombay; It is hereby enacted as follows:—

- 1. This Act may be called the Bombay Disqualification of Aliens Short title. Act, 1918.
- 2. In this Act, unless there is anything repugnant in the subject Definitions: or context,—
 - ²[(a) "alien" means—
 - (i) a person who is neither a British subject nor a subject of ³[an Indian State], or
 - (ii) a person who, whether he is himself within the foregoing definition or not, represents an alien firm as defined in clause (aa) for the purpose of voting at an election of a member of any of the local authorities specified in the schedule or for the purpose of membership of any of the said authorities;
 - (aa) "alien firm" means any firm, company, association or body of individuals (whether incorporated or not), a majority of the members of which are aliens as defined in sub-clause (i) of clause (a), or the business of which is carried on under the control or mainly for the benefit of aliens as so defined;]
 - (b) " * * * *
 - (c) "member" includes a municipal councillor and a member of a body of trustees.

Disqualification of aliens. 3. Save as hereinafter otherwise provided, no alien shall be qualified to be a member of any of the local authorities specified in the schedule or to vote at any election of a member of any of the said authorities.

Effect of subsequent disqualification.

- 4. (1) If any person having become a member of any of the local authorities specified in the schedule, subsequently becomes an alien, his seat shall thereupon become vacant.
- (2) Section 18 of the ¹City of Bombay Municipal Act, 1888, shall be Bom. read and construed as if, after the word "aforesaid", the words "or III of under the Bombay Disqualification of Aliens Act, 1918", were ¹⁸⁸⁸. inserted.
- (3) Section 15, sub-section (3) of the ²Bombay District Municipal Bom. Act, 1901, shall be read and construed as if, after the word "section" III of the words "or under the Bombay Disqualification of Aliens Act, 1918", ¹⁹⁰¹, were inserted.

Exemption.

5. The ³[Provincial Government] ^{4*} * * may, by notification in the ⁵[Official Gazette], exempt any person or class of persons from the operation of this Act.

Modification of Schedule.

6. The ³[Provincial Government] may, by notification in the ⁵[Official Gazette], direct that the name of any of the local authorities specified in the schedule shall be omitted therefrom, or that the name of any other local authority shall be entered therein, and such direction shall have effect accordingly.

An Act to amend the Law relating to the regulation of public conveyances.

WHEREAS it is expedient to amend the law relating to the regulation of public conveyances; And whereas the previous sanction of the Governor General required by sub-section (2) of section 79 of the 5 and 6 Government of India Act, 1915, has been obtained for the passing of this Goo. 5. Act; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Public Conveyances Act, Short title 1920.
- (2) This section and sections 36, 38 and 39 extend to the whole of the Presidency of Bombay. The rest of the Act extends, subject to the provisions of section 36, only to the City of Bombay.
- 2. In this Act, unless there is anything repugnant in the subject Definitions. or context—
 - (a) "Commissioner of Police" means the Commissioner of Police for the City of Bombay and includes any person authorised by him to exercise or perform any power or duty imposed or conferred on the Commissioner of Police by this Act;
 - (b) "public conveyance" means a wheeled vehicle, drawn by one or more horses or other animals or by hand, which is used for the purpose of plying for hire for the conveyance of persons or goods;
 - 2(c) "licensing year" means the year commencing on such date as the Commissioner of Police shall, subject to the condition of previous publication, fix for the purpose of licenses granted under this Act.
 - (d) "driver" includes a conductor, attendant or other person in charge of a public conveyance;
 - (e) "licensee" means the holder of a license granted under this Act for a public conveyance or a horse or a driver of a public conveyance.

Licensing of Public Conveyances.

Public conveyances to be licensed.

- 3. (1) No person shall keep or let for hire any public conveyance without a license granted by the Commissioner of Police in this behalf.
 - (2) On every public conveyance—
 - (a) the number of the conveyance as entered in the license granted for the same, and
 - (b) where the conveyance is licensed to carry passengers, the number of passengers which it is licensed to carry,

shall be clearly inscribed in such manner as the Commissioner of Police may direct.

Licenses for public conveyances.

- 4. (1) Such licenses shall remain in force for the licensing year, unless sooner determined under the provisions of this Act, and shall be renewable.
- (2) Such licenses shall contain the following and such other particulars and conditions as the Commissioner of Police may prescribe:—
 - (a) the full name and address of the licensee;
 - (b) the date on which the license was granted and the date on which it will expire by efflux of time;
 - (c) the local area for which the license is granted;
 - (d) the number and class of the conveyance;
 - (e) the number of horses or other animals (if any) by which it is to be drawn;
 - (f) the number of passengers (if any) which it may carry.
- (3) Such licenses shall not be transferred by the licensee to any other person without the sanction of the Commissioner of Police and if transferred without such sanction shall thereupon become void. Such sanction when granted shall be endorsed on the license.

Grounds on which license may be refused or cancelled.

- 5. (1) The Commissioner of Police may refuse to grant a license for a public conveyance if in his opinion the conveyance is insufficiently found or is otherwise unfit for the purpose for which it is intended.
- (2) The Commissioner of Police may refuse to renew, and may at any time suspend or cancel, a license for a public conveyance on either of the foregoing grounds, or if in his opinion—
 - (i) the licensee has committed a breach of any provision of this Act or of a rule made under this Act or of a condition of the license, or
 - (ii) a conveyance licensed for carrying goods has been used for carrying passengers.
- (3) When refusing to renew, or suspending or cancelling a license for a public conveyance, the Commissioner of Police may erase the inscription made thereon in accordance with this Act.

- 6. (1) When granting or renewing a license for a public conveyance, Number, and at other times when necessary, the Commissioner of Police shall inscribed on cause the particulars required by clauses (a) and (b) of sub-section (2) conveyance. of section 3 to be painted or otherwise clearly inscribed upon the conveyance.
- (2) No fee shall be charged for any inscription made under the foregoing sub-section when it is made at the time when the license is granted or at the annual renewal of the license, but when such inscription is made at any other time '[the licensee shall pay such sum towards the cost of such inscription as the Commissioner of Police shall by rules direct].
- 7. (1) For the grant of a license for a public conveyance a fee shall Fees for public conveyance at such rate as the Commissioner of Police shall prescribe.

 public conveyance licenses.
- (2) For the renewal of such license a fee at one-half of the rate chargeable under the foregoing sub-section shall be charged.

Licensing of horses.

- 8. (1) No horse shall be used for drawing a public conveyance Licensing except under a license granted by the Commissioner of Police in respect of horses. of such horse.
- (2) Such licenses shall remain in force for the licensing year unless sooner determined under this Act, and shall be renewable.
- (3) Such licenses shall contain the following and such other particulars and conditions as the Commissioner of Police may prescribe:
 - (a) the full name and address of the licensee;
 - (b) the date on which the license was granted and the date on which it will expire by efflux of time;
 - (c) the local area for which the license is granted;
 - (d) a description of the horse for which the license is granted and the marks of identification of the same;
 - (e) the class of conveyance to draw which the horse may be used.
- (4) Such licenses may not be transferred by the licensee to any person without the sanction of the Commissioner of Police and if transferred without such sanction shall thereupon become void. Such sanction shall be endorsed on the license.

Branding of horses.

9. When granting a license for a horse the Commissioner of Police ¹[may, if he thinks it necessary] brand such horse on the hoof in such manner that it may be easily identified.

Grounds on which license for horse may be refused or cancelled and examination by a veterinary practitioner.

- 10. (1) The Commissioner of Police may refuse to grant or renew, and may at any time suspend, a license for a horse if in his opinion such horse is in any way unfit for use in a public conveyance.
- (2) In case of such refusal or suspension the owner of the horse or licensee, as the case may be, may require that such horse be examined by a veterinary practitioner of the Government or of a local authority, and, if in the opinion of such practitioner the horse is fit for use in a public conveyance, the Commissioner of Police shall grant or renew the license or cancel the order of suspension.

Licensing of Drivers.

Drivers to be 11. (1) No person shall act as driver of a public conveyance without a license granted by the Commissioner of Police in this behalf.

- (2) Such licenses shall remain in force for the licensing year unless sooner determined under this Act, and shall be renewable.
- (3) Such licenses shall contain the following and such other particulars and conditions as the Commissioner of Police may prescribe:
 - (a) the full name and address of the licensee;
 - (b) the date on which the license was granted and the date on which it will expire by efflux of time;
 - (c) the local area for which the license is granted;
 - (d) the class of public conveyance which the licensee is licensed to drive.

Grounds on which driver's license may be refused or cancelled.

- 12. (1) The Commissioner of Police may refuse to grant a license to a driver if in his opinion such driver ²[is not competent and careful or] is unfit on account of youth, infirmity, bad character or any other reason to pursue the occupation of driver of a public conveyance.
- (2) The Commissioner of Police may refuse to renew, and may at any time suspend or cancel, a driver's license on the foregoing grounds or if the holder has committed a breach of any provision of this Act or of a rule made under this Act or of a condition of the license.

Drivers' badges.

- 13. (1) When granting a license to a driver the Commissioner of Police shall provide him with a metal badge bearing the number of the license.
- (2) Every driver who has received such badge shall wear the same on a conspicuous part of his dress at all times when pursuing his occupation as driver.

- (3) No driver who has received such badge shall permit any other person to wear the same: provided that any person, other than the driver to whom a badge has been given by the Commissioner of Police, who shall wear such badge shall be presumed, until the contrary is proved, to wear it with such driver's permission.
- 14. (1) For the grant of a license to a driver a fee shall be charged drivers' at such rate as the Commissioner of Police shall prescribe.

- 20. (1) Every driver of a public conveyance shall have with him when pursuing his occupation as driver the license granted to him under section 11 of this Act and a clean and legible list, in English and such vernacular language or languages as the Commissioner of Police may direct, bearing the name in full of the licensee of the conveyance and showing the rates of fares fixed for the time being for the hire of the conveyance, with an abstract of the law relating to public conveyances.
- (2) Every such driver shall on demand by a police officer produce for inspection such license and list.
- (3) Every such driver shall on demand produce such list for the information of any hirer of, or passenger travelling in, the conveyance.

Book of fares to be issued,

21. Lists of the fares fixed for public conveyances, as for the time being in force, together with the abstract referred to in the preceding section, shall be prepared by the Commissioner of Police and sold to the public at a reasonable price.

Offences and punishments.

Keeping public conveyance without license.

- Any person who shall—
 - (a) keep or let for hire any public conveyance without a license granted by the Commissioner of Police in this behalf and for the time being in force, or
 - (b) who shall keep or let for hire any public conveyance on which the number and other particulars required by section 3 are not clearly inscribed in such manner as the Commissioner of Police directs.

shall be punishable with fine which may extend to one hundred rupees.

Failure to cause public conveyance to ply when so required by the police.

23. Any licensee of a public conveyance who shall without sufficient reason fail to cause such conveyance to ply for hire when required to do so by a police officer and any driver of a public conveyance who shall without sufficient reason fail duly to pursue his occupation when required to do so by a police officer, shall be punishable with fine which may extend to fifty rupees.

Licensee of public conveyance permitting unlicensed driver to use the same the same to be drawn by unlicensed horse.

24. Any licensee of a public conveyance who shall, when the same is used for the purpose of a public conveyance, permit any person to act as driver thereof other than a driver duly licensed under this Act, or who shall, when such conveyance is used for the purpose aforesaid, permit the same to be drawn by a horse other than a horse for which or permitting a license is in force under this Act, shall be punishable with fine which may extend to fifty rupees.

 - (f) fail to produce, on demand by a hirer of, or passenger travelling in, a public conveyance a list of the legal rates of fares for such conveyance as required by this Act;
 - (g) refuse or neglect to give way, if he conveniently can, to any private conveyance, or obstruct or hinder the driver of any other public conveyance in taking up or setting down any person into or from such other public conveyance;
 - (h) be intoxicated at any time while pursuing his occupation as driver:
 - (i) make use of insulting or abusive language or gesture;
 - (j) refuse to obey the reasonable orders of any person hiring a public conveyance of which he is in charge;
 - (k) when acting as driver, permit the inside of a public conveyance of which he is in charge to be dirty; or

- (l) when in charge of a public conveyance other than a cart used for conveyance of goods,—
 - (i) demand prepayment of his fare, or
 - (ii) refuse without reasonable cause to carry any person desiring to hire the conveyance, or
 - (iii) refuse or delay to proceed with reasonable expedition, or
 - (iv) demand for the hire of the conveyance more than the legal fare, or
 - (v) stand to ply for hire at any place other than a stand or place appointed under this Act or loiter for the purpose of being hired in or upon any public street, road or place,

shall be punishable with fine which may extend to fifty rupees.

Failure to return license or to notify address.

27. Any licensee

- (a) who shall fail to return a license which has been suspended or cancelled to the Commissioner of Police within twenty-four hours after the suspension or cancellation thereof, or
- (b) who, after changing his residence, shall fail to give notice thereof in writing signed by himself to the Commissioner of Police within one week after such change has taken place, or
- ¹[(bb) who, before leaving the City of Bombay for a period exceeding fifteen days shall fail to give notice thereof in writing signed by himself to the Commissioner of Police, or]
- (c) who shall contravene any condition of his license, shall be punishable with fine which may extend to twenty rupees.

Injury to public conveyance.

28. Any person using a public conveyance who shall wilfully or negligently injure the same shall be punishable with fine whichmay extend to twenty rupees, and shall also pay the owner of such conveyance such compensation as the Magistrate may direct, and such compensation shall be leviable as a fine.

Compensation payable by driver causing damage. 29. The driver of any public conveyance who shall by negligence or misconduct, cause any hurt or damage shall, in addition to any punishment to which he may be liable by law, pay the complainant such reasonable compensation as the Magistrate may direct, and such compensation shall be leviable as a fine.

Procedure.

Arrest by police.

30. Any police officer may arrest without warrant any person who has committed any offence under this Act, and may seize and detain any conveyance or horse in relation to which such offence has been committed.

31. (1) In case of any dispute between the hirer and driver of a public Procedure conveyance, either party may require the other to proceed forthwith dispute. to the nearest Magistrate's Court, where the dispute shall be determined in a summary manner by the Magistrate then sitting.

- (2) If no Magistrate is then sitting, either party may require the other to proceed to the '[officer in charge of the nearest police station] who shall, if necessary, arrange for the hearing of the case at the next sitting of the Court.
- (3) On failure of either party to appear before the Magistrate in pursuance of a requisition under sub-section (1) or sub-section (2), or to attend the Court at any subsequent sitting to which the case may be adjourned, the Magistrate may decide the case ex parte and his decision shall be binding on both parties.
- (4) Provided that, if the hirer is about to leave the City of Bombay, a police officer to whom reference has been made under sub-section (2) may, after hearing both parties, require the hirer to deposit such sum, if any, as appears to be due by him, and, if any compensation appears to be due under section 28, an additional sum of ten rupees, and the hirer shall not be required to attend the Magistrate's Court. The police officer shall report the dispute to the Magistrate and the Magistrate may award the driver such sum, if any, not being in excess of the amount deposited by the hirer, as he considers just, and if any offence appears to have been committed, shall inquire into the same according to law. In either case where any surplus remains of the deposit made by the hirer, the Magistrate shall give notice hereof to the hirer and return it to him on demand.
- (5) Where the Magistrate is satisfied that one party had no reasonable ground for requiring the other party to proceed to his Court or to the nearest police officer, he may direct the former party to pay to the latter such compensation not exceeding fifty rupees as he thinks fit, and such compensation shall be leviable as a fine.
- 32. (1) When a complaint is made before a Magistrate against a driver Licensee of a public conveyance under this Act, the Magistrate may, if the driver may be fails to appear, summon the licensee of such conveyance to appear and required to produce the driver.
- (2) If the licensee after being duly summoned fails without reasonable penalty. excuse to appear or to produce the driver he shall be punishable with. fine not exceeding fifty rupees.

Disposal of property: penalty.

- (2) The Commissioner of Police shall cause such property to be returned to such person as shall prove to his satisfaction that he is entitled to the same, on payment by such person of all expenses reasonably incurred and of such compensation to the driver of the public conveyance as the Commissioner of Police may consider just.
- (3) Any licensee or driver failing to deposit any property as required by sub-section (1) shall be punishable with fine which may extend to fifty rupees.

Rules.

- 35. ¹(1) The Commissioner of Police, subject to the condition of previous publication, may make rules not inconsistent with this Act,—
 - (a) fixing the sum to be paid towards the cost of an inscription under sub-section (2) of section 6;

[THE CITY OF BOMBAY PRIMARY EDUCATION ACT, 1920.]

[13th December, 1920]

Adapted and modified by the Adaptation of Indian Laws Order in Council.

An Act to provide for the extension of primary education in the City of Bombay.

Whereas it is expedient to provide for the extension of primary education in the City of Bombay; It is hereby enacted as follows:—

- 1. (1) This Act may be called the City of Bombay Primary Education Short title, extent and construction.
 - (2) It extends only to the City of Bombay.

- (3) It shall be construed as part of and supplementary to the City of Bombay Municipal Act, 1888, hereinafter called "the principal Act".
- 2. In this Act, unless there is anything repugnant in the subject Definitions. or context—
- (1) to "attend" a recognized primary school means to be present for instruction at such school on such days and at such time or times on each day as may be required by the Schools' Committee with the approval of the prescribed educational authority;
- (2) "child" means a child whose age is not less than six and not more than eleven years;
- (3) "parent" includes a guardian and any person who has the actual custody of a child;
- (4) "prescribed" means prescribed by rules made by the 2[Provincial Government] under this Act;
- (5) "primary education" means such education as is for the time being recognized as such by the ²[Provincial Government].
- (6) "recognized primary school" means a school (or a department of a school) in which instruction in primary education is given and which is for the time being recognized by the prescribed educational authority;
- (7) "Schools' Committee" means a committee appointed under section 39 of the principal Act.

Issue of notification making primary education compulsory.

- 3. (1) The Corporation may with the previous sanction of the ¹[Provincial Government] declare by notification that the primary education of boys or of girls or of children of both sexes shall be compulsory in the City of Bombay or in any ward or part of a ward thereof from a date to be mentioned in the notification; provided that, where a notification has been issued under this section with reference to children of one sex only, the Corporation may with the like sanction issue a subsequent notification with reference to children of the other sex.
- (2) A notification under this section shall be published in the ²[Official Gazette] and shall be posted at the municipal office and at such other places, if any, as the Corporation shall deem necessary.

Corporation to make provision for primary education.

4. A notification shall not be issued under section 3 unless the Corporation satisfy the ¹[Provincial Government] that they are in a position to make and will make adequate provision in municipal or other recognized schools for free and compulsory primary education.

Resolution to be passed before issue of notification, 5. A notification shall not be issued under section 3 unless the Corporation have so determined by resolution passed at a general meeting specially called in this behalf, and unless such resolution has been supported by at least two-thirds of the councillors present at the meeting and by at least one-half of the whole number of councillors.

Duty of Schools' Committee. 6. Where a notification has been issued under section 3 for any ward or part of a ward, it shall be the duty of the Schools' Committee, subject to the provisions of this Act and the principal Act, to enforce the provisions of this Act respecting the attendance of children at school and the employment of children.

Duty of parents to cause children to attend school.

7. Where a notification under section 3 is in force in any ward or part of a ward, the parent of every child to which such notification applies shall, in the absence of a reasonable excuse as hereinafter provided, and if such parent and child ordinarily reside in such ward or part of a ward, cause such child to attend a recognized primary school therein.

Meaning of reasonable excuse,

- 8. A parent shall be deemed to have a reasonable excuse for failure to cause a child to attend a recognized primary school in any of the following cases:—
 - (a) where the child is prevented from attending school by sickness, infirmity or other unavoidable cause;
 - (b) where the child is receiving, otherwise than in a recognized primary school, instruction which in the opinion of the Schools' Committee is efficient, or has already completed his primary education;
 - (c) where there is no recognized primary school within one mile, measured according to the nearest road, from the residence of the child.

- (2) No court shall take cognizance of an offence under this section except on the complaint of the Schools' Committee.
- 11. - (2) No court shall take cognizance of an offence under this section except on the complaint of the Schools' Committee, and before making any complaint under this section against any person, the Schools' Committee shall, unless such person has previously been convicted under this section in respect of the same child, cause a warning to be given to such person.

An Act to consolidate and amend the Law relating to pleaders in the Presidency of Bombay.

WHEREAS it is expedient to consolidate and amend the law relating to pleaders in the presidency of Bombay; and whereas the previous sanction of the Governor General required by section 79, sub-section (2), of the Government of India Act, 1915, has been obtained for the passing of this Act; It is hereby enacted as follows:—

1. (1) This Act may be called the Bombay Pleaders Act, 1920.

Short title and extent.

- (2) It extends to the whole of the presidency of Bombay except Sind 2* *.
- 2. In this Act, unless there is anything repugnant in the subject or Definitions. context,—
- (1) "the High Court" means the High Court of Judicature at Bombay;
- (2) "court subordinate to the High Court" means any court, tribunal, or person whose decree, order, decision or award is, or may hereafter be, subject to the appellate or revisional jurisdiction of the High Court;
- (3) "pleader" means a pleader admitted under this or any previous Act, and includes an attorney of the High Court appearing, leading or acting for a client elsewhere than in the City of Bombay, but nothing in sections 3, 4, 5, 6, 11, 12, 13, 24, 25, 27, or 30 shall apply to an attorney of the High Court;
- (4) "district" means the local limits of the jurisdiction of a principal civil court of original jurisdiction other than the High Court;

- (5) "the Letters Patent" means the Amended Letters Patent of the High Court of Judicature for the presidency of Bombay, dated the 28th December 1865, subject to any amendments thereto and alterations therein made or hereinafter to be made pursuant to clause 44 thereof or section 106 (1A) of the Government of India Act;
 - (6) "prescribed" means prescribed by rules made under this Act.

Classes of pleaders.

3. Pleaders admitted by the High Court under this Act shall be of two classes, namely, vakils of the High Court and district pleaders.

Sanads.

- 4. (1) The High Court shall issue to every pleader on his admission a sanad in form A or form B in Schedule II, as the case may be, or in such other form as the High Court may prescribe.
- (2) In the case of the sanad of a district pleader, the name of the district ¹[or districts] for which the sanad is available shall be specified therein.

Extent and transfer of sanads.

BOMBAY ACT No. II OF 1921.1

[THE BOMBAY SHORT TITLES ACT, 1921.]

[21st June, 1921]

An Act to facilitate the citation of certain Acts in force in the Presidency of Bombay.

Whereas it is expedient to facilitate the citation of certain Acts in force in the Presidency of Bombay; And whereas the previous sanction of the Governor General required by clause (e) of sub-section (3) Gio. 5, of section 80A of the Government of India Act has been obtained for c. 61. the passing of this Act; It is hereby enacted as follows:—

1. This Act may be called the Bombay Short Titles Act, 1921.

Short title.

Bom. WHEREAS it is expedient to repeal the Bombay Cotton Contracts I of Control (War Provisions) Act, 1919; It is hereby enacted as follows:—

1. This Act may be called the Bombay Cotton Contracts Control Short title. (War Provisions) Repeal Act, 1922.

- 2. The Bombay Cotton Contracts Control (War Provisions) Act, Repeal of 1919, hereinafter called "the said Act," is, with effect from 1st June Bom. I of 1922 and except to the extent mentioned in section 3, hereby repealed.

The said Act and the rules and bye-laws made thereunder shall Provision continue in force thereafter only for the purpose of settling contracts settlement and disputes in relation thereto, for the purchase and sale of cotton of certain to be delivered on or before 31st May 1922, and the Bombay Cotton contracts Contracts Board shall deal with such contracts and disputes and the disputes powers and functions of the Board in relation thereto shall as regards after repeal such contracts and disputes remain in full force and effect, provided that the application for the exercise of the powers and functions of the Board under its rules and bye-laws is made not later than 15th July 1922.

[THE MAHUL CREEK (EXTINGUISHMENT OF RIGHTS) ACT, 1922.]

[20th May, 1922]

Amended by Bom. Act 16 of 1927.

WHEREAS it is expedient to facilitate the laying by the Trustees of the Port of Bombay of a new oil pipe line to the oil pier at Trombay;

And whereas for the proper laying and protection of the said pipe line it is necessary to keep the drawbridge now maintained by the Port Trust Railway over the Mahul Creek permanently closed and thus to cut off from access to the sea a portion of the said creek;

And whereas it is therefore necessary to extinguish all 2*. * * rights of navigation in the said creek over and above the site of the said bridge;

And whereas the previous sanction of the Governor-General required 56 by clauses (e) and (f) of sub-section (3) of section 80A of the Governor-5, ment of India Act has been obtained for the passing of this Act; It is hereby enacted as follows:—

- 1. This Act may be called the Mahul Creek (Extinguishment of Short title. Rights) Act, 1922.
- 2. From the first day of June 1922 all ^{2*} * rights of navigation Extinguishin that part of the Mahul Creek which lies over and above or to the ment of north of the drawbridge now to be kept permanently closed by the Trustees of the Port of Bombay, and spanning the said creek at a point specified in the Schedule hereto, shall be extinguished.
- 3. (1) On the passing of this Act, the Collector of Bombay shall Compensation to take order for the award of compensation for any loss or sation to be awarded damage caused to any person by the extinction of such rights, in the for loss or same manner, as nearly as may be, as if he had been directed under damage caused by section 7 of the Land Acquisition Act, 1894, to take order for the extinction acquisition of land.
- (2) Compensation shall be determined and awarded in accordance, as nearly as may be, with the provisions of the Land Acquisition Act, 1894, by the said Collector, or, if his award is not accepted, by the Court.

[The Prevention of Cruelty to Animals (Bombay Amendment) Act, 1922.]

[28th December, 1922]

Adapted and modified by the Adaptation of Indian Laws Order in Council.

An Act further to amend the Prevention of Cruelty to Animals Act, 1890.

WHEREAS it is expedient further to amend the Prevention of Cruelty XI of to Animals Act, 1890, in its application to the Presidency of Bombay 1890. in manner hereinafter appearing; It is hereby enacted as follows:—

- 1. This Act may be called the Prevention of Cruelty to Animals Short title. (Bombay Amendment) Act, 1922.
- 2. In section 3 of the Prevention of Cruelty to Animals Act, 1890, Amendment of section 3 of XI of 1890
 - (a) the words "in any street or in any other place, whether open or closed, to which the public have access, or within sight of any person in any street or in any such other place" shall be repealed, and
 - (b) after clause (c) the following two clauses shall be added, namely:—
 - "or (d) in any area to which this clause is by special notification as aforesaid extended, without sufficient excuse neglects to supply any animal under his control with sufficient food or drink; or
 - (r) in any area to which this clause is by special notification as aforesaid extended, without sufficient excuse abandons or turns loose any animal without making due provision for its sustenance."
- 3. For section 6 of the said Act the following section shall be Amendment substituted namely:—

 of section 6 of XI of
- "6. (1) If any person employs in any work or labour any animal Penalty for which by reason of any disease, infirmity, wound, sore or other cause is employing unfit to be so employed, or permits any such unfit animal in his possession animal unfit for or under his control to be so employed, he shall be punished with fine labour. which may extend to one hundred rupees.

- (2) The ¹[Provincial Government] may, by general or special order, appoint places to be infirmaries for the treatment and care of animals in respect of which offences against sub-section (1) have been committed.
- (3) The Magistrate before whom a prosecution for such an offence has been instituted may direct that the animal in respect of which the offence is alleged or proved to have been committed shall be sent for treatment and care to an infirmary and be there detained until, except as provided for in sub-section (4), it is in his opinion or in the opinion of some other Magistrate, again fit for the work or labour on which it has been ordinarily employed. If however the Magistrate decides that the animal will never again be fit he may direct that it shall be destroyed or sent to a pinjrapole.
- (4) Within any specified area the ¹[Provincial Government] may, when any animal has been sent to an infirmary under sub-section (3), authorize any veterinary officer to issue a certificate that in his opinion such animal is fit for the work or labour on which it has been ordinarily employed and such animal shall not be released from detention unless and until such certificate shall have been issued or the Magistrate directs that it shall be destroyed or sent to a pinjrapole.
- (5) The cost of the transport to the infirmary and the treatment, feeding and watering of the animal in the infirmary shall be payable by the owner of the animal according to such scale of rates as the District Magistrate or, in the case of an infirmary in a Presidency town, the Commissioner of Police may from time to time prescribe.
- (6) If the owner refuses or neglects to pay such cost and to remove the animal within such time as a Magistrate may prescribe, the Magistrate may direct that the animal be sold and that the proceeds of the sale be applied to the payment of such cost.
- (7) The surplus, if any, of the proceeds of the sale shall, on application made by the owner within two months after the date of the sale, be paid to him.
- (8) If the cost incurred under sub-section (5) shall exceed the proceeds of the sale, the excess to such extent as shall seem reasonable shall be recoverable from the owner as a fine on the order of the Magistrate, provided that no such order shall be made without the owner being given a reasonable opportunity of urging his objections, if any, before the Magistrate.
