PREFACE

Preface to the First Supplement of 1938 to the Bombay Code, 5th Edition, 1938.

The fifth edition of the Bombay Code contains local Acts applicable to the Province of Bombay as modified up to the 31st December 1937.

This supplement contains all the Acts passed by the Bombay Legislature during the year 1938. In editing it the system adopted in the original Code has been adhered to. In order to facilitate ready reference a chronological table has been inserted at the commencement of this volume giving references where necessary to Acts that have been amended. A table of contents has been inserted before each Act except in the case of those which merely amend local Acts. Another feature of this supplement is that in the case of Acts amending local Acts footnotes have been given indicating references to the amended Acts published in volumes of the Code. For Statement of Objects and Reasons and Reports of the Select Committee, references to the Bombay Government Gazette and to the Bombay Legislative Assembly and Council Debates have also been given in these footnotes.

BOMBAY ACT No. I OF 1938.1

[THE BOMBAY LOCAL BOARDS (AMENDMENT) ACT, 1938.]

[28th January, 1938]

An Act to amend the Bombay Local Boards Act, 1923.2

WHEREAS it is expedient to amend the Bombay Local Boards Act, 1923, for the purposes hereinafter appearing; It is hereby enacted as follows:—

- 1. This Act may be called the Bombay Local Boards (Amendment) Short title. Act, 1938.
- 2. In section 3 of the Bombay Local Boards Act, 1923, hereinafter Amendment called "the said Act", after clause (c), the following shall be inserted, of section 3 of Bom. VI of 1923.
 - "(cc) 'Backward tribe' means a tribe specified in Part II of the Thirteenth Schedule to the Government of India (Provincial Legislative Assemblies) Order, 1936.
 - (dd) 'Harijan' means a person belonging to any of the Scheduled Castes as defined in the Government of India (Scheduled Castes) Order, 1936."
 - 3. In section 5 of the said Act,
 - (1) for sub-section (1), the following shall be substituted, namely:— Amendment "(1) Every district and taluka local board shall, subject to the of Bom. VI provisions of sub-section (5), consist of elective members." of 1923.
 - (2) sub-sections (2), (3) and (4) shall be deleted.
- 4. For section 6 of the said Act, the following section shall be Amendment substituted, namely:—

 of section 6 of Bom. VI of 1923.
 - "6. (1) The elective members of local boards shall be elected by Elective general and Muhammadan constituencies. The number and extent members of of such constituencies, the number of members to be elected by each local boards by whom to constituency, and the number of seats to be reserved in general be elected. constituencies for the representation of women or of any caste,

community or tribe shall be as prescribed by orders made by the Provincial Government under clause (a) of section 133:

Provided that no seat shall be reserved for the representatives of any caste, community or tribe,

- (a) other than-
 - (i) Harijans,
 - (ii) a backward tribe, or
 - (iii) any community the members of which are, under the Fifth Schedule to the Government of India Act, 1935, entitled to reparate constituencies for electing representatives to the Bombay Legislative Assembly, and
- (b) unless the Provincial Government is of opinion that the reservation of such seats is necessary having regard to the population of such caste, community or tribe in the local board area.
- (2) Notwithstanding anything contained in sub-section (1), the Muhammadans in the area constituting a Muhammadan constituency who are qualified voters may either unanimously or by majority declare in the manner prescribed under clause (a) of section 133 that the said Muhammadan constituency be abolished.
- (3) On such declaration, the Provincial Government shall direct that the said Muhammadan constituency be abolished from such date as may be specified in the notification in the Official Gazette and may make orders under clause (22) of section 133 for the purpose of securing representation in general constituencies of the Muhammadans in the area constituting the said Muhammadan constituency."

Insertion of new section 15A in Bom, VI of 1923. 5. After section 15 of the said Act, the following section shall be inserted, namely:—

Provisions of section 15 (3), clauses (a) and (b) to cease to be in force.

- "15A. From the date specified in the notification under subsection (3) of section 6 the provisions of clauses (a) and (b) of subsection (3) of section 15 shall cease to be in force and for the purpose of any election of persons to fill the places of persons whose term of office has expired under section 28 and for all subsequent elections, lists for constituencies shall be prepared and finally published as if the said provisions have not been in force."
- Amendment 6. In section 130 of the said Act, the words "by such nominations of section 130 and elections as may be necessary" shall be deleted.

Amendment of section 133 of Bom. VI of 1923.

- 7. In section 133 of the said Act,-
- (1) in clause (a) for the words beginning with the words "the proportion" and ending with the words "each constituency" the

words and figure "the number of members to be elected by each constituency and the reservation of seats in general constituencies for women or for any caste, community or tribe specified in section 6" shall be substituted;

- (2) after clause (a) the following clauses shall be inserted, namely:—
 - "(a1) prescribing the manner in which the Muhammadan voters in any area for which a Muhammadan constituency is constituted may declare that the said constituency be absolished;
 - (a^2) determining the mode in which the representation of the Muhammadans in the area for which a Muhammadan constitutency is abolished under section 6 shall be secured."
- 8. (1) Notwithstanding anything contained in this Act or the rules Provision or orders thereunder, in the case of a local board—

 for increase of reserved.
 - (a) of a district which includes a partially excluded area, or in seasts for respect of which the Provincial Government is of opinion that the backward population of the members of backward tribes residing therein is tribes in sufficiently large to justify reservation of seats being made for the tricts. purpose of giving them representation, and
 - (b) which is constituted on a date next following the commencement of this Act, the Provincial Government may, at any time during the term of office of such board, direct by notification in the Official Gazette, that the total number of members of such board prescribed by rules or orders under section 133 of the said Act shall be increased to such number as it deems necessary for the purpose of providing seats for the members of backward tribes or adding to the number of seats already reserved for such members under the said rules or orders:
- (2) On the publication of such notification elections shall, for the purpose of filling the number of seats so increased, be held in the manner specified in the said Act or the rules or orders thereunder subject to such modification as the Provincial Government may direct.
- (3) The period for which the members elected to fill the said seats shall hold office shall be coterminous with the term of office of such board under section 28 of the said Act.
- (4) Nothing herein contained shall affect the constitution of any committee which may have been constituted or the election or appointment of any officers who may have been elected or appointed, before the election of the additional members under sub-section (2).

Explanation.—For the purpose of this section, a partially excluded area shall be any of the areas in the Province of Bombay specified in the Schedule to the Government of India (Excluded and Partially Excluded Areas) Order, 1936.

- 9. (1) Nothing in this Act shall affect the local boards constituted immediately before the commencement of this Act and no appointment, notification, notice, tax, order, scheme, licence, permission, rule, by-law or form made, issued or imposed by or in respect of such local board shall be deemed to be invalid by reason only of the fact that this Act has come into force.
- (2) Notwithstanding anything contained in this Act, any casual vacancy in a local board constituted immediately before the commencement of this Act shall, subject to the provisions of section 33, be filled in the manner provided by the said Act, as if this Act had not been passed.

BOMBAY ACT No. II OF 1938.1

[THE CITY OF BOMBAY MUNICIPAL (AMENDMENT) ACT, 1938.]

[2nd February, 1938]

An Act to amend the City of Bombay Municipal Act, 1888.2

Whereas it is expedient to amend the City of Bombay Municipal Bom. Act, 1888, for the purpose hereinafter appearing; It is hereby enacted III of as follows:—

- 1. (1) This Act may be called the City of Bombay Municipal Short title and commencement, Act, 1938.
- (2) It shall come into force on such date as the Provincial Government may by notification in the Official Gazette appoint.
- Bom. 2. Sub-section (8A) of section 39 of the City of Bombay Municipal Amendment III of Act, 1888, hereinafter referred to as the said Act shall be repealed.

 - 3. After section 78 of the said Act, the following heading and Insertion of new heading and new sections shall be inserted, namely:—

 and Insertion of new heading and new sections 78A and 78B in Bom, III of 1888.

" Municipal Chief Auditor.

- 78A. (1) The Corporation shall from time to time appoint a fit Appointment person to be Municipal Chief Auditor, who shall chief auditor.
 - (a) perform such duties as he is directed by this Act to perform and such other duties with regard to the audit of the accounts of the Corporation as shall be required of him by the Corporation or by the standing committee;
 - (b) devote his whole time and attention to the duties of his office;
 - (c) receive such monthly salary not exceeding rupees one thousand as the Corporation shall from time to time determine;
 - (d) be removeable at any time from office for misconduct or for neglect of, or incapacity for the duties of his office on the votes of not less than two-thirds of the members present at a meeting of the Corporation.

(2) The municipal chief auditor shall not be eligible for further office under the Corporation after he has ceased to hold his office.

Appointment, salaries, fees, allowances and duties of assistant auditors. clerks and servants subordinate to the municipal chief auditor.

- 78B. (1) The standing committee may from time to time—
- (a) appoint such assistant auditors, clerks and servants to be immediately subordinate to the municipal chief auditor as they think
- (b) determine the nature and amount of the salaries, fees and allowances to be paid to the said assistant auditors, clerks and servants respectively;
- (c) prescribe or delegate to the municipal chief auditor the power of prescribing the duties of the said assistant auditors, clerks and

Control, etc., of the said assistant auditors. clerks and servants.

(2) Subject to the orders of the standing committee, the municipal chief auditor shall exercise supervision and control over the acts and proceedings of the said assistant auditors, clerks and servants, and the standing committee, subject to the regulations at the time being in force under section 81, shall dispose of all questions relating to the service of the said assistant auditors, clerks and servants and their pay, privileges and allowances."

Amendment of section 80 of Bom, III of 1888.

4. In section 80 of the said Act, for the word and figures "or 78" the figures, letters and word "78, 78A or 78B" shall be substituted.

Amendment of section 83 of Bom. III of 1888.

5. In sub-section (2) of section 83 of the said Act in clause (b) for the word and figures "or 77" the figures, word and letter "77 or 78A" and in clause (c) for the word and figures "or 77" the figures, word and letter "77 or 78A" shall be substituted.

Amendment of section 84 of Bom. III of 1888.

- 6. In section 84 of the said Act,—
- (1) in sub-section (1) after the words "municipal secretary" the words "or the municipal chief auditor" shall be inserted; and
- (2) in clause (a) of sub-section (2) after the figures "78" the words, figures and letter "or to any assistant auditor, clerk or servant appointed under section 78B" shall be inserted.

Weekly scrutiny of accounts by municipal chief auditor and scrutiny of accounts by the standing committee.

"135. (1) The municipal chief auditor shall conduct a weekly examination and audit of the municipal accounts and shall report thereon to the standing committee who shall publish weekly an abstract of the receipts and expenditure of the week last preceding, signed by not less than two members of the said committee and by the municipal chief auditor. The standing committee may also from time to time and for such period as they think fit conduct independently an examination and audit of the municipal accounts.

- (2) For these purposes the standing committee and the municipal chief auditor shall have access to all the municipal accounts and to all records and correspondence relating thereto, and the Commissioner shall forthwith furnish to the standing committee or the municipal chief auditor any explanation concerning receipts and disbursements which they may call for.
- 136. The municipal chief auditor in addition to any other duties Duties and or powers imposed or conferred upon him under this Act shall perform powers of the duties and may exercise the powers specified in Schedule EE. chief auditor.

137. (1) The municipal chief auditor shall

Report by the municipal chief auditor.

- (a) report to the standing committee any material impropriety or irregularity which he may at any time observe in the expenditure or in the recovery of moneys due to the Corporation or in the municipal accounts;
- (b) furnish to the standing committee such information as the said committee shall from time to time require concerning the progress of the audit.
- (2) The standing committee shall cause to be laid before the Corporation every report made by the municipal chief auditor to the standing committee and every statement of the views of the municipal chief auditor on any matter affecting the pursuance and exercise of the duties and powers assigned to him under this Act which the municipal chief auditor may require the standing committee to place before the Corporation, together with a report stating what orders have been passed by the standing committee upon such report or statement, and the Corporation may take such action in regard to the matters aforesaid as the Corporation may deem necessary.
- (3) As soon as may be after the commencement of each official year the municipal chief auditor shall deliver to the standing committee a report upon the whole of the municipal accounts for the previous official year.
- (4) The Commissioner shall cause the said report to be printed and forward a printed copy thereof along with the printed copy of the Administration Report and Statement of Accounts which he is required by sub-section (3) of section 124 to forward to each councillor."
- 8. In sub-section (2) of section 138 of the said Act for the words Amendment "an auditor appointed by the Corporation" the words "the municipal of section 138 of Bom. III of 1888.

"SCHEDULE EE.

(See section 136.)

Duties and Powers of the Municipal Chief Auditor.

- 1. (1) The municipal chief auditor shall audit the accounts of the Corporation, as hereinafter provided, with the assistance of the assistant auditors, clerks and servants appointed under section 78B of this Act.
- (2) In the discharge of his functions under this article the municipal chief auditor shall—
 - (i) audit the accounts of all expenditure from the revenue of the Corporation, all expenditure on account of loan works and all expenditure incurred out of special funds and shall ascertain whether moneys shown therein as having been disbursed were legally available for, and applicable to, the service or purpose to which they have been applied or charged, and whether the expenditure conforms to the authority which governs it;
 - (ii) audit the accounts of all debt, deposit, sinking funds, advances, suspense and remittance transactions of the Corporation and report upon those accounts and upon the results of verification of the balances relating thereto.
- (3) The municipal chief auditor shall examine and audit the statements of accounts relating to the commercial services conducted in any department of the Corporation, including the trading, manufacturing and profit and loss accounts, and the balance sheets where such accounts are maintained under the orders of the Corporation or the standing committee; and shall certify and report upon these accounts.
- (4) The municipal chief auditor shall, in consultation with the standing committee, and subject to any directions given by the Corporation, determine the form and manner in which his reports on the accounts of the Corporation shall be prepared and shall have authority to call upon any officer of the Corporation to provide any information necessary for the preparation of these reports.
- 2. (1) The municipal chief auditor may make such queries and observations in relation to any of the accounts of the Corporation which he is required to audit and call for such vouchers, statements, returns and explanations in relation to such accounts as he may think fit.

- (2) Every such query or observation as aforesaid shall be promptly taken into consideration by the officer or authority to whom it may be addressed and returned without delay with the necessary vouchers, documents or explanation to the chief auditor.
- (3) The powers of the municipal chief auditor with regard to disapproval of, and the procedure with regard to settlement of objections to expenditure from the revenues of the Corporation shall be such as may be prescribed by rules or orders made by the standing committee in consultation with the chief auditor and sanctioned by the Corporation.
- 3. If the municipal chief auditor considers it desirable that the whole or any part of the audit applied to any accounts which he is required to audit shall be conducted in the offices in which these accounts originate, he may require that these accounts, together with all books and documents having relation thereto, shall at all convenient times be made available in the said offices for inspection.
- 4. The municipal chief auditor shall have power to require that any books or other documents relating to the accounts he is required to audit shall be sent for inspection by him:

Provided that if the documents are confidential he shall be responsible for preventing disclosure of their contents,

- 5. The municipal chief auditor shall have authority to frame rules and to give directions on all matters relating to audit, particularly in respect of the method and the extent of audit to be applied and the raising and pursuing of objections.
- 6. Sanctions to expenditure accorded by the municipal chief auditor shall be audited by an officer to be nominated by the Corporation."

An Act to provide for the extension of the term of office of the members of the Bombay Municipal Corporation.

WHEREAS it is expedient to provide for the extension of the term of office of the members of the Municipal Corporation of the City of Bombay; It is hereby enacted as follows:—

- 1. (1) This Act may be called the City of Bombay Municipal Short title Corporation (Extension of Term) Act, 1938.
- (2) It shall remain in force up to and inclusive of the first day of April 1939.
- 2. (1) Notwithstanding anything contained in section 7 or 9 of Extension

shall retire from office at noon on the first day of April 1938 and their seats shall be filled by election or by appointment, as the case may be, in accordance with the provisions of the said Act.

[THE BOMBAY PROVISIONAL COLLECTION OF TAXES ACT, 1938.]

[3rd February, 1938]

An Act to provide for immediate effect being given for a limited period to provisions in Bills relating to the imposition or increase of taxes.

WHEREAS it is expedient to provide for immediate effect being given for a limited period to provisions in Bills relating to the imposition or increase of taxes; It is hereby enacted as follows:—

- This Act may be called the Bombay Provisional Collection of Short title.
 Taxes Act, 1938.
 - 2. In this Act-

Definitions.

- (1) a "declared provision" means a provision in a Bill in respect of which a declaration has been made under section 3;
- (2) "tax" includes any rate, cess, duty, fee, toll or other impost, whether general or local or special.
- 3. Where a Bill to be introduced in the Bombay Legislative Power to Assembly on behalf of the Provincial Government provides for the makedeclaration position or increase of a tax, the Provincial Government may cause this Act. to be inserted in the Bill a declaration that it is expedient in the public interest that any provision of the Bill relating to such imposition or increase shall have immediate effect under this Act.

- (b) when the Provincial Government, in pursuance of a motion passed by the Bombay Legislative Assembly, directs, by notification in the Official Gazette, that it shall cease to have the force of law, or

Certain refunds to be made when declarations cease to have effect.

5. (1) Where a declared provision comes into operation as an enactment in an amended form before the expiry of the sixtieth day after the day on which such provision has the force of law under sub-section (1) of section 4, refunds shall be made of all taxes collected which would not have been collected if the provision adopted in the enactment had been the declared provision:

Provided that the rate at which refunds of any tax may be made under this sub-section shall not exceed the difference between the rate of such tax proposed in the declared provision and the rate in force immediately prior to the day on which the declared provision has the force of law under sub-section (1) of section 4.

(2) Where a declared provision ceases to have the force of law under clause (b) or clause (c) of sub-section (2) of section 4, refunds shall be made of all taxes collected which would not have been collected if the declaration in respect of it had not been made.

[THE CITY OF BOMBAY MUNICIPAL (SECOND AMENDMENT) ACT, 1938.]

[16th February, 1938]

An Act to amend the City of Bombay Municipal Act, 1888.2

WHEREAS it is expedient to amend the City of Bombay Municipal Bom. Act, 1888, for the purposes hereinafter appearing; It is hereby enacted H11 of as follows:—

- 1. (1) This Act may be called the City of Bombay Municipal Short title. ([Second³] Amendment) Act, 1938.
- (2) Save as provided for in sub-section (3), this Act shall come into force at once.
- (3) Sections 18, 19 and 20 shall come into force on the first day of April 1939.
- 2. After clause (kk) in section 3 of the City of Bombay Municipal Amendment Bom. Act, 1888, hereinafter called "the said Act", the following new clause of section 3 of Bom. III shall be added, namely:—

 - "(ll) 'Market' includes any place where persons assemble for the sale of, or for the purpose of exposing for sale, meat, fish, fruit, vegetables, animals intended for human food or any other articles of human food whatsoever, with or without the consent of the owner of such place, notwithstanding that there may be no common regulation of the concourse of buyers and sellers and whether or not any control is exercised over the business of or the persons frequenting the market by the owner of the place or any other person."
 - 3. In section 15 of the said Act, hereinafter called the said Act, Amendment for the words "he resides in the city", the following shall be substituted, of section 15 of Bom. III namely:—

Explanation.—For the purposes of this sub-section the expression "final decision" means a decision which is not appealable or a decision which is appealable but against which no appeal has been filed within the period of limitation allowed by law.

- (2) For the purposes of the inquiry referred to in sub-section (1) the Commissioner may himself record, or may request the District Magistrate to record or to have recorded, the whole or any part of such evidence as the parties may produce. [31st March, 1938]

An Act to provide for the temporary relief of small holders in the Province of Bombay.

WHEREAS it is expedient to provide for the temporary relief of small holders in the Province of Bombay and for certain other purposes specified herein; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Small Holders Relief Act, Short title, extent and duration.
 - (2) It shall extend* to the whole of the Province of Bombay.
- (3) It shall remain in force up to and inclusive of the 31st March 1939.
- 2. In this Act, unless there is anything repugnant in the subject or Definitions. context,—
 - (1) "Person" includes an undivided Hindu family.
 - (2) "Small holder" means—
 - (a) an individual-
 - (i) who holds land not exceeding six acres of irrigated land or eighteen acres of other land, or who holds land of whatever description, the total annual agricultural assessment of which does not exceed Rs. 30, and
 - (ii) who cultivates land himself or is an inferior village servant;

Provided that such proceedings shall not be stayed, if the Collector for reasons to be recorded in writing is of opinion on the application by the decree-holder that such stay will cause substantial loss to such decree-holder.

- (3) If the Collector, on the application of the decree-holder, is of opinion that any rights of such decree-holder to the land referred to in sub-section (1) or to the proceeds of the sale of such land are likely to be prejudiced by reason of any other proceedings taken under any law for the time being in force relating to any land belonging to the small holder, the Collector may direct that the proceedings in execution stayed under sub-section (1) shall continue.

- (b) (i) that substantial loss will be caused to such small holder if such transfer of such land or interest therein is not sanctioned, and
- (ii) that such transfer does not adversely affect the interests of any creditor of the small holder.

Collector's or Court's decision to be final.

8. If in any proceedings under this Act a question arises whether a person is a small holder such question shall be decided by the Collector in a proceeding under section 3 or 4 and by the Court in a proceeding under section 6 and the decision of the Collector or the Court, as the case may be, shall, notwithstanding anything contained in any law for the time being in force, be final.

Bar against eviction of tenant.

- 9. (1) Notwithstanding any law for the time being in force or any contract between the parties, no tenant who has been in possession of land used for the purpose of agriculture uninterruptedly from the first day of January 1932 shall, in pursuance of any decree or order of any Court, be evicted from such land, if such tenant tenders subject to the provisions of section 10, to the landlord or any person acting on his behalf before the 15th day of May 1938 rent due in respect of the land for the year ending with the 30th day of June 1938, and is willing to hold the land thereafter as a tenant on the same terms and conditions on which he was holding the same at the date when the cause of action arose to the landlord for the purpose of evicting him.
- (2) If any such land is alienated land or land held on Khoti or talukdari tenure, the tenant who is in occupation of a dwelling house as a tenant of such landlord shall not be evicted from such dwelling house (including the site thereof and the land immediately appurtenant thereto and necessary for its enjoyment), if the requirements of sub-section (1) are complied with by such tenant. .

Interest or be paid or reduced in cases in which land revenue is suspended wholly or partially.

- 10. (1) In the case of any land in respect of which, on account of rent not to famine, drought, scarcity or other causes, the collection of land revenue for the current year is wholly suspended at any time during the period for which this Act remains in force under the general or special orders of the Provincial Government, a small holder to whom such land belongs shall not under section 3, or a tenant who is in possession of such land shall not under section 9, be liable to pay any interest or rent, as the case may be.
 - (2) If in the case of such land the collection of such land revenue is partially suspended, the amount of interest or rent payable by him under section 3 or section 9 shall be reduced in the same proportion.

Revival of rights, liabilities and obligations after the expiry of the Act.

11. Any right, privilege, obligation or liability acquired, accrued or incurred under any enactment, decree or order of any Court, or any contract between the parties immediately before the commencement of this Act or which may be acquired, accrued or incurred, during the period for which this Act remains in force, but the enforcement of which has been stayed by the provisions of this Act, shall immediately on the expiration of this Act, revive and be enforceable as if this Act has not been passed.

In computing the period of limitation for the enforcement of any such sight, privilege, obligation or liability, the period during which the proceedings in respect thereof are stayed under this Act shall be excluded, notwithstanding anything contained in any law for the time being in force.

- 12. All powers exercisable by the Collector under this Act may be Delegation exercised by the Assistant or Deputy Collector or by such officer as of powers of may be empowered by the Provincial Government by general or special order in this behalf.
- 13. The Provincial Government may, by notification in the Official Rules. Gazette, make rules to carry out the purposes and objects of this Act.

[THE BOMBAY DISTRICT MUNICIPAL AND MUNICIPAL BOROUGHS (AMENDMENT) ACT, 1938.]

[12th May, 1938]

An Act to amend the Bombay District Municipal Act, 1901,² and the Bombay Municipal Boroughs Act, 1925,³ for certain purposes.

WHEREAS it is expedient to amend the Bombay District Municipal Act, 1901, and the Bombay Municipal Boroughs Act, 1925, for certain purposes; It is hereby enacted as follows:—

- 1. (I) This Act may be called the Bombay District Municipal and Short title and communicipal Boroughs (Amendment) Act, 1938.
- (2) It shall come into force* on such date as the Provincial Government may by notification in the Official Gazette appoint.
- Bom. 2. In the Bombay District Municipal Act, 1901, hereinafter called the Amendment III of District Act, clause (b) of sub-section (I) of section 10 and the proviso to of Bom. III of 1901. the said sub-section shall be deleted.
 - 3. In section 11 of the District Act, clause (b) in sub-section (1) shall Amendment of section 11 of Bom. III of 1901.
 - 4. - (3) for the explanation to the sub-section, the following explanations shall be substituted:—
 - "Explanation.—For the purpose of this section—
 - (I) A Harijan shall mean a member of a scheduled caste as defined in the Government of India (Scheduled Castes) Order, 1936:

- (2) A backward tribe shall mean a tribe specified in Part II of the Thirteenth Schedule to the Government of India (Provincial Legislative Assemblies) Order, 1936."
- (4) After sub-section (1), the following sub-section shall be inserted, namely:---
 - "(1A) If at any time the Muhammadans in any municipal borough who are qualified voters declare either unanimously or by majority in the manner prescribed by rules made under sub-section (1) that all the wards constituted for their community in such municipal borough be abolished, the Provincial Government shall abolish all such wards and may also make rules prescribing the manner in which the representation of the said community shall be secured in such municipal borough:

Provided that notwithstanding anything contained in the proviso to sub-section (1) the rules so made shall provide for reservation for the representatives of the Muhammadan community of such number of seats in such wards in the municipal borough as is, in the opinion of the Provincial Government, necessary having regard to their population in such municipal borough."

8. In sub-section (1) of section 37A of the Boroughs Act for the words, Amendment figures, letter and brackets beginning with the words "of three councillors" of section 37A and ending with the word "Crown", the words, figures, letter and of Bom. brackets "of four councillors of whom one shall be the President of 1925. the municipality and the other three shall be elected in accordance with rules made under clause (a) of section 58 and of two persons appointed by the Provincial Government, both of whom may be salaried servants of the Crown" shall be substituted.

- 9. (1) Nothing in this Act shall affect any municipality constituted Saving. under the District Act or the Boroughs Act or any committee of such municipality constituted immediately before the commencement of this Act, and no appointment, notification, notice, tax, order, scheme, licence, permission, rule, by-law or form made, issued or imposed by or in respect of such municipality or committee shall be deemed to be invalid by reason only of the fact that this Act has come into force.
- (2) Notwithstanding anything contained in this Act, any casual vacancy in such municipality or any committee thereof shall, in the case of a municipality constituted under the District Act subject to section 17 of the said Act and in the case of a municipality constituted under the Boroughs Act subject to section 25 of the said Act, be filled in the manner provided by either of the said Acts, as the case may be, as if this Act had not course into force.

An Act to amend the Bombay Race-courses Licensing Act, 1912.2

BOMBAY ACT No. XI OF 1938.1

[The Bombay Harijan Temple Worship (Removal of Disabilities) Act, 1938.]

[27th May, 1938]

An Act to remove disabilities of Harijans in regard to worship in temples.

WHEREAS it is expedient to provide for the removal of disabilities of Harijans in regard to worship in temples; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Harijan Temple Worship Short title, (Removal of Disabilities) Act, 1938.

 CONTROL Act may be called the Bombay Harijan Temple Worship Short title, extent and commence-
- (2) This Act extends to the whole of the Province of Bombay and shall me come into force on the 1st day of April 1938.
- 2. In this Act, unless there is anything repugnant in the subject or Definitions. context,—
 - (1) "Court" means the Court of the District Judge and includes the High Court in the exercise of its ordinary original civil jurisdiction;

- (2) "District" means a district constituted under section 3 of the Bombay Civil Courts Act, 1869, and includes the City of Bombay;
- (3) "Harijan" means a member of a caste, race or tribe deemed to be a Scheduled Caste under the Government of India (Scheduled Castes) Order, 1936;
 - (4) "Hindu Community" includes Jains;
- (5) "Person having interest" means a person who is entitled to enter or attend for the purpose of the performance of worship in a temple or who is in the habit of entering or attending for such purpose or of receiving any share in the gifts thereto;

- (6) "Prescribed" means prescribed by rules made under section 9;
- (7) "Temple" means a place by whatever designation known used as a place of public religious worship and dedicated to or for the benefit of or used as of right by, the Hindu Community or any section thereof, as a place of religious worship;
- (8) "Trustee" means a person by whatever description known in whom the administration of a temple is vested by any law for the time being in force or the terms of the instrument of the trust, or the terms of a decree or order of a competent Court, relating to such temple, or if there is no such person, any person who has administered the temple for a period of one year immediately prior to the date of the declaration made under section 3 and who is liable as if he were a trustee;
- (9) "Worship" includes attendance at a temple for the purpose of darshan of a deity or deities installed in or within the precincts thereof.

Declaration by trustees opening the temple to Harijans. 3. (1) A trustee, or if there are more than one trustee, the majority of the trustees, of a temple which, by anything contained in the terms of instrument of trust, the terms of dedication or a decree or order of a competent Court relating to such temple or by any custom, usage or law for the time being in force, is not open for the performance of worship to any Harijan may, of his or their own motion or on the requisition of any person having interest in such temple, notwithstanding anything contained in the terms of such instrument, the terms of the dedication, the decree or order, custom, usage or law, declare in writing that such temple shall be open to the Harijans to whom such temple was not open, for the performance of worship, subject to such conditions and the observance of such ceremonies as may be specified in the declaration:

Provided that the conditions imposed as aforesaid shall not be made applicable to Harijans only.

- (2) The declaration shall be in such ferm and shall contain such particulars as may be prescribed.
- (3) The declaration shall be forwarded to the Court within the local limits of whose jurisdiction the temple is situate.
- (4) The declaration forwarded to the Court shall be accompanied by an affidavit made by the trustee or the majority of the trustees, as the case may be, that he is the trustee or they are the majority of the trustees of the temple in respect of which the declaration is made and also in the case of a temple which is a public trust to which the provisions of the Bembay Public Trusts Registration Act, 1935, apply, by a certified Bomcopy of an entry in the Register of Public Trusts maintained under of section 7 of the said Act relating to the names and addresses of the 1935, trustees of such public trust.

4. (1) On receipt of such declaration, the Court shall, if it is satisfied The publicathat the conditions specified in the declaration do not contravene the tion of declaration. requirements of the proviso to sub-section (1) of section 3, cause public notice to be given at convenient places on or near the temple in respect of which the declaration has been made and shall cause the declaration to be published in the Official Gazette and in a newspaper published in the principal vernacular of and circulating in the district. The declaration so published shall subject to the provisions of section 6 be irrevocable and the publication of the declaration in the Official Gazette shall be conclusive evidence that the temple is open to the performance of worship to the Harijans to whom it was not so open and the instrument of the trust, the terms of dedication, the decree or order, custom, usage or law relating to the temple shall be deemed to have been amended accordingly.

- (2) Any of the conditions specified in the declaration published Alteration under section 4 may, on the application of the trustee or if there are of conditions in declaramore than one trustee of the majority of the trustees of the temple be tion. altered, added to or omitted with the previous sanction of the Court.
- 5. (1) Any person interested in the temple in respect of which a Application declaration has been published under section 4 may, within three months to Court to from the date of such publication, make an application to the Court declaration. which has caused the declaration to be published for the following reliefs only :—
 - (a) that the person or any of the persons purporting to act as trustee was not entitled to act as such at the time the declaration was made, or
 - (b) that the trustees making the declaration did not form a majority of trustees of the said temple at the time the declaration was made.
- (2) On receipt of such application, the Court shall cause notice to be served on the person or persons who made the declaration and upon any other person to whom in its opinion notice of the application should be given, specifying the date on which the application is to be heard.
- (3) On the date so specified, or on any subsequent date to which the hearing may be adjourned, the Court shall proceed to hear the applicant and the persons making the declaration, if any of them appears and any other person who, it considers, ought to be heard, and shall hold an inquiry.
- (4) Such inquiry shall be held in the manner provided by rules made, if any, by the High Court in this behalf with the previous sanction of the Provincial Government.

Save as provided by such rules, the provisions of the Code of Civil Procedure, 1908, shall, so far as may be, apply to such inquiry.

- (5) If the Court is satisfied—
 - (a) that the applicant is a person interested in the temple, and
- (b) that person or persons purporting to act as the sole trustee or the majority of trustees was or were not entitled to act as such at the time the declaration was made, or the trustees who made the declaration did not form the majority of trustees entitled to act as such at such time,

it shall set aside the declaration. If the Court is not so satisfied, it shall dismiss the application.

- (6) In deciding such application the Court may make such order as to costs as it thinks reasonable. The provisions of the Code of Civil Procedure, 1908, relating to the execution of decrees shall, so far as they are applicable, apply to the execution and order as to costs.
- (7) The decision of the Court under sub-section (5) shall be final and conclusive for the purposes of this Act.

Exclusion of Jurisdiction of other Courts. 6. Save as provided in this Act, no civil Court shall entertain any suit or proceeding or shall pass an order or decree or execute wholly or partially any order or decree, if the claim involved in such suit or proceeding or if the passing of such order or decree or if such execution would in any way affect or be inconsistent with the declaration published under section 4 unless it is set aside by the Court under section 5.

Date on which declaration to take effect.

7. The declaration published under section 4 shall take effect on the expiry of 3 months from the date of its publication, provided that, if an application to set aside the declaration is made under section 5, the declaration shall, if not set aside, take effect from the date of the decision of the Court on such application.

Penalty.

8. Whoever obstructs or causes or tends to cause obstruction to any Harijan from the performance of worship in a temple in contravention of the declaration made under section 4, shall, on conviction, be punishable with fine which may extend to Rs. 200 and in the case of a continuing offence, with an additional fine which may extend to Rs. 20 for every day after the first during which he has persisted in the offence.

Power of the Provincial Government to make rules.

- 9. (1) Save in regard to matters for which the High Court is empowered to make rules under section 5, the Provincial Government may make rules for the purpose of carrying out the provisions of this Act.
- (2) Rules made under this section shall be subject to the condition of previous publication.

BOMBAY ACT No. XII OF 1938.1

[THE BOMBAY PRIMARY EDUCATION (AMENDMENT) ACT, 1938.]

[27th May, 1938]

An Act to amend the Bombay Primary Education Act, 1923.2

Whereas it is expedient to amend the Bombay Primary Education Bom. Act, 1923, for the purposes hereinafter appearing; It is hereby enacted as 1923. follows:—

- 1. (1) This Act may be called the Bombay Primary Education Short title. (Amendment) Act, 1938.
- (2) It shall come into force on such date as the Provincial Government may by notification in the Official Gazette appoint.
- Bom. 2. In the Bombay Primary Education Act, 1923, hereinafter called Amendment of preamble IV of the said Act for the preamble the following shall be substituted:—to Bom. IV of 1923.
 - "Whereas it is the duty of Government to secure the development and expansion of primary education: and whereas it is the declared policy of the Government that universal, free and compulsory primary education should be reached by a definite programme of progressive expansion and whereas it is expedient to make better provision for the development, expansion, management and control of primary education in the Province of Bombay; It is hereby enacted as follows:—"
 - 3. For section 2 of the said Act the following shall be substituted, Amendment of section 2 of Bom. IV of 1923.
 - "2. In this Act, unless there is anything repugnant in the subject Definitions. or context,—
 - (1) 'Administrative Officer' means the officer appointed under section 9;

- (2) 'Approved school' means a school or part of a school which is for the time being approved for the purposes of this Act by the school board or by the Provincial Government on appeal from a decision of the school board refusing approval;
- (3) 'Area of compulsion' means the area in which elementary or primary education as the case may be, is compulsory;
- (4) 'To attend an approved school' means to be present for instruction at such school on such days and at such time and for such periods on each day as may be required by the school board with the approval of the Provincial Government;
- (5) 'Provincial Board of Primary Education' means the Board constituted under section 2A;
- (6) 'Child' means a child whose age at the beginning of the school year is not less than six and whose age is, with reference to 'Elementary education' not more than eleven and with reference to 'Primary education' not more than fourteen years;
- (7) 'Director' means the Director of Public Instruction for the Province of Bombay;
- (8) 'Elementary education' means the education from time to time imparted in infant classes and vernacular standards I to IV inclusive as prescribed or sanctioned under section 17;
- (9) 'Local authority' means (1) a district local board, or (2) a municipality which is authorised by the Provincial Government to manage its own schools;
- (10) 'Parent' includes a guardian or any person who has the custody of a child;
- (11) 'Prescribed' means prescribed by rules made by the Provincial Government for the purposes of this Act;
- (12) 'Primary education' means the education from time to time imparted in infant classes and vernacular standards I to VII inclusive as prescribed or sanctioned under section 17;
- (13) 'Primary Education Fund' means the fund maintained under section 8A; and
 - (14) 'School Board' means a board constituted under section 3."
- 4. After section 2 of the said Act the following new section shall be inserted, namely:—

Insertion of a new section 2A in Bom. IV of 1923.

Provincial Board of Primary Education. 2A. (1) There shall be a Provincial Board of Primary Education, consisting of twelve members, of whom six shall be elected by the school distribution of the manner prescribed. The remaining six, out of whom not

more than three shall be Government officers, shall be appointed by the Provincial Government. The members of the said Board shall hold office for a period of three years.

- (2) The elected members of the said Board shall be persons having any of the following qualifications :-
 - (a) a graduate of seven years' standing of any recognised University,
 - (b) a professor who has served for a period of five years in a recognised college in the Province of Bombay,
 - (c) a head master who has served as such for 10 years in any recognised secondary school in the Province of Bombay.

Explanation.—For the purpose of this sub-section, the expression 'recognised' shall mean recognised by the Provincial Government in this behalf.

- (3) The said Board shall elect its president from amongst its own members and his term of office shall be co-extensive with that of the Board. Out of the members appointed by the Provincial Government one member selected by the Provincial Government and belonging to the Educational Department shall act as Secretary to the Board.
- (4) The powers and duties of the said Board shall be as follows, namely:-
 - (a) to examine and recommend schemes for the organization, coordination and expansion of primary education and for the correlation of primary education with the system of education as a whole in the Province;
 - (b) to make recommendations and to advise the Provincial Government with regard to matters specified in sub-section (3) of section 27;
 - (c) to advise the Provincial Government generally on all matters connected with primary education;
 - (d) to exercise such other powers as may be conferred on it and to perform such other duties as may be prescribed by rules or by any other law for the time being in force."
- (5) Casual vacancies during the term of a Provincial Board shall be filled for the remaining period by election or appointment as the case mav be.

- (5) Except as otherwise provided in this Act, the term of office of the members of a school board shall cease on the expiry of the term of the local authority for which it was constituted:

Provided that the term of office of such members shall not be deemed to expire by reason only of the fact that the local authority is dissolved or superseded;

Provided further that notwithstanding the expiry of the term of office of such members, the said members shall continue in office, until the members of a new school board are elected or appointed, as the case may be.

(6) If the term of office of the members of a school board expires during the period of supersession of a local authority for which it was constituted, a new school board shall from time to time be constituted as provided in sub-section (2), until the local authority is re-established,

and a corrupt practice shall be deemed to have been committed by a candidate, if it has been committed with his knowledge and consent, or by a person who is acting under the general or special authority of such candidate with reference to the election.

Explanation.—The expression "a promise of individual profit"

- (i) does not include a premise to vote for or against any particular measure which may come before a school board for consideration, but

- (3) If the expense and remuneration are not so paid, the Provincial Government may make an order directing the officer in charge of the treasury or bank or society in which the Primary Education Fund is

kept, or the whole or portion thereof is deposited, or lent at interest, to pay such expense and remuneration from such moneys as may be standing to the credit of the school board in such treasury or bank or society or as may, from time to time be received from or on behalf of the school board by way of deposit by such treasury or bank or society; and such officer or bank or society shall be bound to obey such order. Every payment made in pursuance to such order shall be a sufficient discharge to such officer, bank or society from all liability to the school board in respect of any sum or sums so paid by him or it out of the moneys so received or standing to the credit of the school board in such treasury, bank or society.

Inquiry into affairs of school board.

- 26B. (1) The Provincial Government may, from time to time, cause inquiry to be made by any of its officers in regard to any local authority or school board on matters connected with primary education concerning them or any matters with respect to which the sanction, approval, consent or order of the Provincial Government is required by or under this Act.
- (2) The officer holding such inquiry shall have the powers of a court under the Code of Civil Procedure, 1908, to take evidence and to V of compel the attendance of witnesses and the production of documents 1908 for the purposes of the inquiry.
- (3) The Provincial Government may make orders as to the costs of any inquiries made under sub-section (1) and as to the parties by whom and the funds out of which they shall be paid, and such order may, on the application of the Provincial Government or of any person named therein, be executed as if it were a decree of a civil court.

Power of Provincial Government to dissolve or supersede school board in certain circumstances.

- 26C. (1) If in the opinion of the Provincial Government, a school board is not competent to perform or is not properly performing the duties imposed on it by or under this Act or any other law for the time being in force, or exceeds or abuses its powers, or is acting or has acted contrary to the provisions of this Act or the rules or regulations made thereunder, it may, by an order published with the reasons for making it. in the Official Gazette, either—
 - (a) dissolve the school board, or
 - (b) supersede it for a period to be specified in the order.
- (2) When a school board is dissolved or superseded the following consequences shall ensue:—
 - (a) all members of the school board shall, in the case of supersession as from the date of the order of supersession, and in the case of dissolution as from the date specified in the order of dissolution, vacate their offices as such members;
 - (b) all powers and duties of the school board, shall, during the period of dissolution or supersession, be exercised and performed by such persons as the Provincal Government may from time to time appoint in this behalf;

- (c) the persons appointed under clause (b) may delegate their powers and duties to any individual or committee or sub-committee.
- (3) On the issue of an order of dissolution under sub-section (1) election of members shall be held under the provisions of this Act or of the rules made thereunder on or before the date to be specified by the Provincial Government and the school board shall be re-established by the election of members under the aforesaid provisions on such date as may be specified by the Provincial Government.
- (4) If, after enquiry made, the Provincial Government so directs, the period of supersession with all the consequences aforesaid shall, from time to time, be continued by an order published as aforesaid until such date as may be fixed by the Provincial Government for the re-establishment of the school board.
- (5) After the school board is superseded it shall be re-established by the election of members under the provisions of this Act or the rules made thereunder applicable thereto—

[THE CITY OF BOMBAY POLICE (AMENDMENT) ACT, 1938.]

[10th June, 1938]

An Act to amend the City of Bombay Police Act, 1902.2

Bom. Whereas it is expedient to amend the City of Bombay Police Act, IV of 1902. 1902, for the purposes of dealing with persons who are a danger to the City of Bombay and for preventing disturbance of public peace or tranquillity by reason of conflict between communities or sections there of of gangs or factions and for other purposes hereinafter appearing; It is hereby enacted as follows:—

1. This Act may be called the City of Bombay Police (Amendment) Short title. Act, 1938.

 - "(a) that the movements or acts of any person in the City of Removal of Bombay are causing or calculated to cause alarm, danger or harm persons from to person or property, or that there are reasonable grounds for believing that such person is engaged or is about to be engaged in the commission of an offence involving force or violence, or an offence punishable under Chapter XII, XVI or XVII of the Indian Penal Code, or in the abetment of any such offence, and when in the opinion of the Commissioner witnesses are not willing to come forward to give evidence in public against such person by reason of apprehension on their part as regards the safety of their person or property; or

(b) that an outbreak of epidemic disease is likely to result from the continued residence in the city of an immigrant.";

- (ii) for the words "the members of such gang or body or such immigrants" the words "such person or immigrant" shall be substituted;
- (iii) for the word "themselves" wherever it occurs, the word "himself" shall be substituted;
- (iv) between the words "by" and "beat of drum or otherwise" the words "an order in writing duly served on him or "shall be inserted;
 - (v) the words "disperse and" shall be deleted.
- (2) After sub-section (2B) the following shall be inserted, namely:—

Proclamation of Emergency.

- "(2C). (i) The Provincial Government may, if satisfied that the public peace or tranquillity in the City of Bombay or in any part thereof is disturbed or is likely to be disturbed in consequence of a conflict between different communities or sections thereof or gangs or factions, declare, by a proclamation (hereinafter referred to as 'the proclamation of emergency') in the Official Gazette that an emergency exists.
 - (ii) A proclamation of emergency—
 - (a) may at any time be revoked by a subsequent proclamation and
 - (b) shall cease to operate at the expiration of one month, unless before the expiration of that period it has been renewed.
 - (iii) After the Provincial Government has issued under clause (i) a proclamation of emergency, the Commissioner of Police, whenever it appears to him that the presence, movements or acts of any person in the City of Bombay is or are causing or calculated to cause danger or alarm, or that a reasonable, suspicion exists that designs, calculated to disturb public peace or tranquillity are entertained by such person, may by an order in writing duly served on him or beat of drum or otherwise, as he thinks fit, direct such person so to conduct himself as he shall deem necessary in order to prevent the disturbance of the peace or remove himself to such place or places, by such route or routes, and within such time, as the Commissioner of Police shall prescribe.
 - (iv) Any person aggrieved by an order made by the Commissioner of Police under clause (iii) may appeal to the Provincial Government within ten days from the date of such order.
 - (r) Subject to the appeal under clause (iv), an order made by the Commissioner of Police under clause (iii) shall be final.

- (vi) Nothing hereinbefore contained in this section shall require any police officer to disclose to the person against whom an order is made under clause (iii) or to the Court the sources of his information or any fact the communication of which, might, in the opinion of the Commissioner of Police, lead to the disclosure of the identity or name of any informant.
- (vii) Any order passed by the Commissioner of Police under clause (iii) or by the Provincial Government under clause (iv) shall not have any effect after the proclamation of emergency has ceased to operate."

- (3) In sub-section (3) for the words, brackets, figure and letter "or (2A)", the following shall be substituted, namely:—
 - " (2A) or (2C)."
- (4) After sub-section (3), the following new sub-sections shall be inserted, namely:—
- "(4) Before an order under sub-section (1), (2) or (2A) is passed against any person, the Commissioner of Police or any officer authorised by him not below the rank of a Superintendent shall inform such person in writing of the general nature of the material allegations against him and give him a reasonable opportunity of explaining those allegations. If such person makes an application for the examination of any witness produced by him, the Commissioner of Police or such officer shall grant such application and examine such witness, unless for reasons to be recorded in writing, he is of opinion that such application is made for the purpose of vexation or delay. Any written statement put in by such person shall be filed with the record. Such person shall be entitled to appear before the Commissioner of Police or the said officer by an advocate or attorney for the purpose of explaining the allegations against him and for the purpose of examination of witnesses produced by him.
- (5) The Commissioner of Police or the officer authorised under sub-section (4) may, for the purpose of securing the attendance of any person against whom an order is proposed to be made under sub-section (1), (2) or (2A), exercise all or any of the powers of a Court under sections 75 to 77 of the Code of Criminal Procedure, 1898. After such person is brought before the Commissioner of Police, the Commissioner may release him on bail with or without sureties or may from time to time authorise his detention in such custody as he thinks fit for a period not exceeding 15 days at a time.

- (6) Any person aggrieved by an order made by the Commissioner of Police under sub-section (1), (2) or (2A) may appeal to the Provincial Government within thirty days from the date of such order.
- (7) An order passed by the Commissioner of Police under subsection (1), (2) or (2A) or by the Provincial Government under sub-section (6) shall not be called in question in any Court except on the ground that the Commissioner of Police or the officer authorized by him under sub-section (4) had not followed the procedure laid down in the said sub-section or that there was no material before the Commissioner of Police upon which he could have based his order or on the ground that the Commissioner of Police was not of opinion that witnesses were unwilling to come forward to give evidence in the public against the person in respect of whom an order was made under sub-section (1).
- (8) Nothing hereinbefore contained in this section shall require any Police officer to disclose to the person against whom an order is made under sub-section (I), (2) or (2A) or to the Court the sources of his information or any fact the communication of which might, in the opinion of the Commissioner of Police, lead to the disclosure of the identity of any person or property."

(1) When any relative or friend of a lunatic detained in Temporary any asylum under the provisions of section 7, 10, 14, 15 or 17 is release of desirous that such lunatic shall be temporarily released and delivered lunatics, over to his care and custody, he may make an application to the person in charge of the asylum, who shall make an order for the temporary release of such lunatic for a period not exceeding sixty days, unless for any reason he considers that such release is undesirable and such lunatic shall, thereupon, be so released.
 - (2) No order under sub-section (1) for the temporary release of a lunatic detained under section 7 or 10 shall be passed except on an application of the petitioner on whose petition such lunatic was detained or without the consent in writing of such petitioner:

Provided that, if in any such case, it appears to the person in charge of the asylum that such petitioner refuses, without sufficient reasons, to accord such consent, he shall refer the application made to him under sub-section (1), to the magistrate who would have juri-diction to detain such lunatic under section 7 or 10 and such magistrate may, after making such enquiry as he thinks fit, order the temporary release of such lunatic for the period specified in sub-section (1).

- (3) Any order made for the release of a lunatic under sub-section (1) may, on the application of any relative or friend, at any time during the period of his release, be set aside or varied by the magistrate who would have jurisdiction to detain such lunatic in an asylum under section 7, 10, 14, 15 or 17 on any ground other than that the lunatic was not in a state of mind fit to be released at the time the order for his release was made under sub-section (1). If the order of release is so set aside, the lunatic shall be re-admitted and detained in the asylum.
- (4) If a lunatic released under sub-section (1) or (2) is, at any time during the period of his release, found to be unmanageable or dangerous and unfit to be at large, the person who applied for his release may take the lunatic to the asylum, and such lunatic shall thereupon be readmitted and detained in the asylum.
- (5) If a lunatic released under sub-section (1) or (2) does not return to the asylum at the expiration of the period for which he was released and if no order for his discharge has been passed under section 31 or section 33 or if he is, at any time during the period of his release, found to be unmanageable or dangerous or unfit to be at large and the person who applied for his release states by a written application to the person in charge of the asylum that he is unable to bring him to the asylum such lunatic shall be deemed to have escaped from the asylum and may at any time within one month after the expiration of the said period be re-taken to and detained in the asylum in the manner provided in section 36:

Provided that such a person shall be deemed to be discharged if on or before the expiry of the period for which he was released, the Board of Visitors is satisfied either (a) as a result of investigations conducted by the person in charge of the asylum concerned or (b) on receipt of a certificate signed by a medical practitioner that the person may with safety be discharged."

BOMBAY ACT No. XIX OF 1938.1

[The Bombay Probation of Offenders Act, 1938.]

[28th October, 1938]

An Act to provide for the release on probation of offenders.

Whereas it is expedient to provide for the release on probation of offenders in certain cases and for other matters incidental thereto; It is hereby enacted as follows:-

- 1. (1) This Act may be called the Bombay Probation of Offenders Short title, extent and Act. 1938. commencement.
 - (2) It extends to the whole of the Province of Bombay.
- (3) This Act shall come into force in such area and on such date as the Provincial Government may, by notification in the Official Gazette, direct.
- 2. In this Act, unless there is anything repugnant in the subject or Definitions. context.-

V of 1898.

- (a) the "Code" means the Code of Criminal Procedure, 1898;
- (b) "Court" means a Court empowered to exercise powers under this Act;
- (c) "Probation order" means an order made under sub-section (1) of section 5:
- (d) "recognised society" means a society recognised by the Provincial Government for the purposes of section 10;
- (e) "supervision order" means an order made under sub-section (2) of section 5; and
- (f) words and expressions used but not defined in this Act shall have the meanings assigned to them in the Code.
- 3. (1) The following courts are hereby empowered to exercise powers Courts emunder this Act, namely :-
 - (a) the High Court,
 - (b) a Court of Session,
 - (c) a District Magistrate,
 - (d) a Sub-Divisional Magistrate,
 - (e) a salaried Presidency Magistrate,
 - (f) a Magistrate of the first class,
 - (q) any other Magistrate specially empowered in this behalf.

- (2) The powers conferred under sub-section (1) may be exercised by such Courts, whether the case comes before them originally or on appeal or in revision.
- (3) Where any offender is convicted by a magistrate not empowered to exercise powers under this Act, and such magistrate is of opinion that the powers conferred by section 4 or 5 should be exercised, he shall record his opinion to that effect and submit the proceedings to a Magistrate of the first class or Sub-Divisional Magistrate forwarding the offender to, or taking bail for this appearance before, such Magistrate, who shall dispose of the case in the manner provided by section 380 of the Code.

Power of Court to tion.

- 4. Notwithstanding anything contained in any enactments for the time being in force in any case in which a person is convicted of any resease certain convicted offence punishable with not more than two years' imprisonment or fine or both and no previous conviction is proved against him, the Court by after admoni- which he is so convicted, may, if it thinks fit having regard-
 - (a) to the age, character, antecedents or physical or mental condition of the offender, and
 - (b) to the nature of the offence or any extenuating circumstances under which the offence was committed

for reasons to be recorded in writing instead of sentencing him to any punishment, release him after due admonition.

Power of Court to release certain convicted offenders on probation of good conduct.

- 5. (1) Notwithstanding anything contained in any enactment for the time being in force, when-
 - (a) any male person is convicted of an offence not punishable with death or transportation for life, or
 - (b) any woman is convicted of an offence of any kind,

if it appears to the Court by which the offender is convicted, that regard being had to the age, character, antecedents or physical or mental condition of the offender, or to the circumstances in which the offence was committed, it is expedient that the offender should be released on probatior of good conduct, the Court may, for reasons to be recorded in writing instead of sentencing him at once to any punishment, direct that he be released on his entering into a bond, with or without sureties, to appear and receive sentence when called upon during such period not being less than one year and not exceeding three years as the Court may direct, and in the meantime to keep the peace and be of good behaviour:

Provided that the Court shall not pass a probation order under this section unless it is satisfied that the offender or one of his sureties (if any) has a fixed place of abode or regular occupation and is likely to continue to have such place of abode or such occupation, within the local limits of its jurisdiction during the period of the bond.

(2) Where the offender appears to the Court to be under the age of twenty-five years, the Court may for reasons to be recorded in writing make an order, hereinafter called a supervision order, directing that the bond to be entered into under sub-section (1) shall contain a condition that the offender shall be under the supervision of a probation officer named in the order during the period specified therein and such other conditions as in the opinion of the Court may be necessary for securing such supervision:

Provided that the period so specified shall not extend beyond the the date on which, in the opinion of the Court, the offender shall attain the age of twenty-six years.

- (3) While making a supervision order the Court may also direct that the bond shall contain such additional conditions with respect to residence, abstention from intoxicants and any other matters which the Court may, having regard to the particular circumstances of the case, consider necessary for preventing a repetition of the same offence or a commission of other offences by the offender.
- (1) A Court making a supervision order shall turnish the offender with a written statement of the conditions which he is required to observe.
- 6. (1) A Court directing the release of an offender under section 4 Power of or section 5 may order the offender to pay such compensation for loss Court to or injury caused to any person by the offence and such costs of the released proceedings as the Court thinks reasonable:

- (2) At the time of awarding compensation in any subsequent civil suit relating to the same matter, the Court shall take into account any sum paid or recovered as compensation under sub-section (1).
- (3) The amount ordered to be paid under this section may be recovered as a fine in accordance with the provisions of sections 386 and 387 of the Code.
- 7. (1) Notwithstanding anything contained in the Code except in Appeal and cases in which the offender has pleaded guilty, or where the order powers of is passed by the High Court, an appeal shall lie from an order of court in conviction in every case in which an order is passed under section 4 or 5 revision. to the Court to which appeals ordinarily lie under the Code.
- (2) The Appellate Court or the High Court in the exercise of its powers of revision may pass any such order as it could have passed under the Code, or may set aside an order under section 4 or 5 and in lieu thereof pass sentence on such offender according to law:

Provided that the Appellate Court or the High Court in revision shall not inflict a greater punishment than might have been inflicted by the Court by which the offender was convicted.

Provision in case of offender failing to observe condition of release.

- 8. (1) If the Court before which an offender is bound by his bond under section 5 to appear and receive sentence when called upon, or any Court which could have dealt with the offender in respect of his original offence, has reason to believe that the offender has failed to observe any of the conditions of his bond, it may issue a warrant for his arrest or may, if it thinks fit, issue a summons to the offender and his sureties, if any, requiring him or them to attend before it at such time as may be specified in the summons.
- (2) The Court before which an offender is brought or appears under sub-section (1) may either remand him to custody until the case is heard or admit him to bail, with or without sureties, to appear on the date of hearing.
- (3) If the Court, after hearing the case, is satisfied that the offender has failed to observe any of the conditions of his bond, including any conditions which may have been imposed under sub-section (2) or subsection (3) of section 5, it may forthwith—
 - (a) sentence him for the original offence, or
 - (b) without prejudice to the continuance in force of the bond, impose upon him a fine not exceeding one hundred rupees.

Provided that the Court passing a sentence of fine under clause (a) or (b) shall take into account the amount of compensation ordered to be paid under section 6.

(4) If a fine imposed under clause (b) of sub-section (3) is not paid within such period as the Court may fix, the Court may sentence the offender for the original offence.

Provisions as to bonds.

9. The provisions of sections 122, 126A, 406A, 514, 514B and 515 of the Code, shall, so far as may be, apply in the case of sureties V of given under this Act.

Appointment of probation officers.

- 10. (1) A probation officer named in a supervision order may be-
- (a) any person appointed to be a probation officer by the Provincial Government, or
- (b) any person nominated for this purpose with the previous approval of the Provincial Government by a recognised society, or
- (c) any other person who, in the opinion of the Court, is a fit person to act as a probation officer in the special circumstances of the case
- (2) A probation officer named under sub-section (1) shall be a person who shall possess such qualifications as may be prescribed by rules made in this behalf.
- (3) A probation officer, in the exercise of his duties under any supervision order, shall be subject to the control of the District Magistrate of the district in which the offender for the time being resides.
- (4) The Court before which an offender is bound by his bond under section 5 to appear and receive sentence when called upon, may at any

time appoint another probation officer in place of the person named in the supervision order.

Explanation.—In this section, in a presidency town "District Magistrate" means the Chief Presidency Magistrate, and "district" means the presidency town.

- 11. A probation officer shall, subject to the provisions of section 10 Duties of probation and rules made under this Actofficers.
 - (a) visit or receive visits from the offender at such reasonable intervals as may be specified in the supervision order or, subject thereto, as the probation officer may think fit;
 - (b) see that the offender observes the conditions of the bond;
 - (c) report to the Court as to the behaviour of the offender;
 - (d) advise, assist and befriend the offender, and, when necessary, endeavour to find him suitable employment; and
 - (e) perform any other duty which may be prescribed by rules made under this Act.
- 12. (1) The Court before which any person is bound by a bond under variation of section 5 to appear and receive sentence may at any time upon the conditions of application of the probation officer or of its own motion, if it thinks probation on application that it is expedient that the terms or conditions of the bond should by probation be varied, summon the offender to appear before it, and, if he fails to officer. show cause why such variation should not be made, vary the terms of the bond by extending or diminishing the duration thereof or by altering any of the conditions thereof or by inserting additional conditions therein:

Provided that, in no case, shall the duration of the bond be less than one year or more than three years from the date of the original order and where a supervision order has been made under sub-section (2) of section 5, the duration of the period of supervision extend beyond the date on which, in the opinion of the Court, the offender shall attain the age of 26 years:

Provided further that in the case of a bond with a surety or sureties, no such variations shall be made without the consent thereto of such surety or sureties and that in the absence of such consent the Court shall in all such cases require the offender to enter into a new bond with or without sureties.

- (2) Such Court may also, on the application made by the probation officer or of its own motion, on being satisfied that the conduct of the offender has been such as to make it unnecessary that he should be kept any longer under supervision, discharge the bond.
- 13. (1) The Provincial Government may make rules for the purpose Power to of carrying into effect the provisions of this Act. make rules.
- (2) In particular and without prejudice to the generality of the foregoing power, the Provincial Government may make rules-
 - (a) regulating the appointment, resignation and removal of probation officers and prescribing the qualifications of such officers;

BOMBAY ACT No. XXII OF 1938.1

[The Bombay Forfeited Lands Restoration Act, 1938.]

[29th November, 1938]

An Act to provide for the restoration of lands forfeited during the Civil Disobedience Movement for the non-payment of land revenue and other sums due to Government.

Whereas certain lands were forfeited as a result of the Civil Disobedience Movement for the non-payment of land revenue and other sums due to Government; And whereas the said lands were disposed of to certain persons for inadequate consideration; And whereas it is just and expedient to acquire them with a view to restore them to the original holders thereof; It is hereby enacted as follows:-

- 1. (1) This Act may be called the Bombay Forfeited Lands Short title, Restoration Act, 1938. ment and extent.
 - (2) It extends to the whole of the Province of Bombay.
- (3) It shall come into force on such date as the Provincial Government may, by notification in the Official Gazette, direct.
- 2. In this Act, unless there is anything repugnant in the subject Definitions. or context-
 - (1) "Forfeited land" means any of the lands forfeited to the Crown during the Civil Disobedience Movement in any of the years 1930 to 1934 for non-payment of land revenue or other sums due to Government and specified in the notification published in the Official Gazette by the Provincial Government within six months from the date on which this Act comes into force. The expression "Forfeiture of lands" shall be construed accordingly.
 - (2) "Original holder" in relation to any forfeited land means a person who owned the land at the time of its forfeiture and includes his heirs.
 - (3) "Prescribed" means prescribed by rules.
 - (4) "Tribunal" means the Tribunal constituted under section 3.
 - (5) "Rules" means rules made under section 14.
- (6) Words and expressions not defined in this Act but defined in the Land Acquisition Act, 1894, shall have the meanings assigned to them in that Act.

Constitution of Tribunal.

3. For the purposes of this Act, the Provincial Government shall constitute a Tribunal consisting of such member or members as the Provincial Government may appoint. If the Tribunal consists of one member, such member, and if it consists of more than one member, the President, shall be a person who is or has been a Judge of a High Court.

Declaration that land is needed for restoration.

- 4. (1) The Provincial Government, if it is satisfied that any of the forfeited lands is needed for a public purpose and should, therefore, in public interest be acquired and restored to the original holder, may make a declaration that the said land is needed for such purpose.
- (2) The declaration shall be published in the Official Gazette and shall state all the material particulars in regard to the said land.
- (3) Such declaration shall be conclusive evidence that the said land is needed for such purpose.

Notice to persons interested.

- 5. (1) On the publication of the declaration under section 4, the Tribunal shall cause public notice to be given at convenient places at or near the land to be acquired stating that the Provincial Government intends to acquire the said land.
- (2) Such notice shall also state the particulars of the said land and shall require all persons interested in the said land to appear personally or by agent before the Tribunal at the time and place therein mentioned (such time not being earlier than one month after the date of publication of the notice) and to state the nature of their respective interests in the said land and the amount and particulars of their claims to compensation for such interest.
- (3) The Tribunal shall also serve notice by registered post to the same effect on the occupier, if any, of such land and on all persons known or believed to be interested therein.
- (4) The original holder of the land and the Collector shall also be served with a notice by registered post intimating to them the time and place of the enquiry by the Tribunal and shall be entitled to appear in such enquiry either personally or by agent.

Power to require and enforce the making of statements, etc.

- 6. (1) The Tribunal may also by notice in writing require any person interested in the land to make or deliver to it at the time and place mentioned (such time not being earlier than one month from the date of such notice) a statement containing, so far as may be practicable, the name of any other person interested in the land or any part thereof as co-proprietor, sub-proprietor, mortgagee, tenant or otherwise, and particulars regarding the nature of such interest and the rents and profits, if any, received or receivable on account thereof.
- (2) Every person required to make or deliver a statement under this section or under section 5 shall be deemed to be legally bound XL▼ to do so within the meaning of sections 175 and 176 of the Indian of Penal Code. .

- 7. (1) On the day fixed in the notice given by the Tribunal under Inquiry by section 5 or any other day to which the inquiry may be adjourned, the Tribunal and Award.

 Tribunal shall proceed to enquire regarding—
 - (i) the amount of compensation to be awarded for the land; and
 - (ii) the respective interests of the persons claiming compensation.
- (2) The Tribunal shall then make an award stating the amount of compensation which in its opinion should be awarded for the land. Such award shall be in writing and where there are several persons interested in the land, the award shall also state the amount of compensation to be awarded to each.
- 8. Save as otherwise provided by or under this Act, the provisions Procedure of the Code of Civil Procedure, 1908, shall, so far as may be, apply to before any enquiry before the Tribunal under this Act.
- 9. (1) Subject to the provisions of sub-sections (3), (4) and (5), the Amount of amount of compensation to be awarded for the land shall, after making compendeductions in respect of matters specified in sub-section (2), be—

 - (a) the amount paid to the Provincial Government as occupancy price for the land,
 - (b) the amount of expenditure incurred in making improvements on the land after its disposal by the Provincial Government until the date of the declaration under section 4,
 - (c) the amount of land revenue paid in respect of the land after its disposal by the Provincial Government until the date of the award, and
 - (d) interest at the rate of 4 per cent. per annum on the amounts mentioned in (a), (b) and (c) until the date of the award.
- (2) In determining the amount of the compensation to be awarded, the Tribunal shall make deductions in respect of the following matters, namely:—
 - (a) the profits, if any, received by the holder for the time being from the land during the period mentioned in clause (c) of sub-section (1), and
 - (b) any damage resulting from any act, permanently injurious or destructive to the land, committed by the holder for the time being or any person acting on his behalf during the period mentioned in clause (c) of sub-section (1):

Provided that the amount of compensation to be awarded under sub-section (1) shall not in any case be less than the total of the amount mentioned in clauses (a) and (b) of the said sub-section.

(3) If the holder for the time being, within 15 days from the date of the publication of the notice under section 5, intimates in writing to the Collector that he is willing to receive as compensation a sum equal to the amounts mentioned in clauses (a) and (b) of sub-section (1) together with the interest thereon at the rate and for the period mentioned in clause (d) of the said sub-section; the amount of compensation to be

awarded for the land shall be the said sum without making any deductions therefrom in respect of any of the matters mentioned in sub-section (2).

- (4) In cases where the holder for the time being is not the person to whom the land was disposed of by the Provincial Government but has purchased the land in good faith and for consideration before the first day of April 1938, the amount of compensation to be awarded shall be—
 - (a) the amount paid by such holder as price for the land, and
 - (b) the amount of expenditure incurred by such holder in making improvements on the land until the date of the declaration under section 4.
- (5) In cases where the land is subject to any mortgage or charge which has been made or created in favour of a person who has advanced money in good faith, the amount of compensation to be awarded to such person shall be—
 - (a) the unpaid balance of the principal advanced, and
 - (b) if such person is not in possession of the land, the unpaid amount of interest payable on the principal at such rate as may have been specified in the instrument of mortgage or charge but not exceeding 7½ per cent. per annum.

Nothing in this sub-section shall bar the right of such person to enforce his rights against the mortgagor or the person who created the charge in respect of the balance due to him.

(6) In addition to the amount of compensation awarded under subsections (1), (3), (4) or (5), as the case may be, the Tribunal shall in every case award a sum of 15 per cent. on the said amount.

Explanation.—For the purposes of this section "holder for the time being" means the person who is the owner of the land on the date of the declaration under section 4.

Payment of smount awarded.

- 10. (1) After the award is made, the Collector shall tender payment of the amount awarded to the persons entitled thereto according to the award and shall pay it to them unless prevented by any of the contingencies mentioned in sub-section (2).
- (2) If such persons do not consent to receive it or if any of them is under any legal disability and there is no person competent to receive it on his behalf, the amount awarded or part thereof, as the case may be, shall remain in deposit with the Collector for a period of three years from the date of the deposit or from the date when the person entitled to receive it ceases to be under a legal disability, as the case may be. After the expiry of the said period, such amount, if not paid, shall lapse and shall be credited to the revenues of the Province.

Arrangement instead of money compensation. 11. Notwithstanding anything contained in this Act, the Tribunal may, with the sanction of the Provincial Government, instead of awarding money compensation in respect of any land, make any arrangement with the person having interest in such land either by grant of another land in exchange or in such other way as may be equitable.

- (4) Such land shall, on its possession being taken by the Collector under sub-section (1), vest absolutely in the Provincial Government free from all encumbrances and the Provincial Government may restore it to the original holder thereof on such terms and conditions as it thinks fit.

(2) If any person bringing into or receiving from beyond the octroi limits of a district local board in which octroi is leviable, any conveyance or package, shall refuse on the demand of an officer authorised by the board in this behalf, to permit the officer to inspect the contents of the conveyance or package for the purpose of ascertaining whether it contains anything in respect of which octroi is payable, the officer may cause the conveyance or package to be taken without unnecessary delay before a Magistrate or such officer of the board as the Provincial Government appoints in this behalf by name or office, who shall cause the inspection to be made in his presence.

Presentation of bills for octroi.

115-B. An officer demanding octroi by the authority of the district local board shall tender to every person introducing or receiving anything on which the tax is claimed, a bill specifying the animal or goods taxable, the amount claimed, and the rate at which the tax is calculated.

Penalty for evasion of octroi.

115-C. Where any animal or goods passing into the octroi limits of a a district local board are liable to the payment of octroi, any person, who, with the intention of defrauding the board, causes or abets the introduction of or himself introduces or attempts to introduce within the octroi limits of the said board any such animal or goods upon which payment of the octroi due on such introduction has neither been made nor tendered, shall be punishable with fine which may extend to ten times the amount of such octroi or to fifty rupees whichever may be greater."

An Act to amend the Indian Registration Act, 1908,2 in its application to the Province of Bombay.

WHEREAS it is expedient to amend the Indian Registration Act, XVI 1908, in its application to the Province of Bombay for the purposes οf 1908. hereinafter appearing; It is hereby enacted as follows:—

- 1. This Act may be called the Indian Registration (Bombay Amend-Short title. ment) Act, 1938.

BOMBAY ACT No. XXV OF 1938.1

[THE BOMBAY INDUSTRIAL DISPUTES ACT, 1938.]

[24th February, 1939]

An Act to make provision for the promotion of peaceful and amicable settlement of industrial disputes by conciliation and arbitration and for certain other purposes.

Whereas it is expedient to make provision for the promotion of peaceful and amicable settlement of industrial disputes by conciliation and arbitration and for certain other purposes hereinafter provided: It is hereby enacted as follows:—

CHAPTER I.

PRELIMINARY.

- 1. This Act may be called the Bombay Industrial Disputes Act, Short title. 1938.
- 2. (1) Section I and this section extend to the whole of the Province Extent, of Bombay. The Provincial Government may, by notification in the commence-official Gazette, extend all or any of the remaining provisions of the Act application. to such area as may be specified in the notification.
- (2) Section 1 and this section shall come into force at once. The Provincial Government may, by notification in the Official Gazette, direct that all or any of the remaining provisions of this Act shall come into force in any area to which the said provisions extend or may have been extended under sub-section (I) on such date as may be specified in the notification.
- (3) The Provincial Government may, by notification in the Official Gazette, direct that all or any of the provisions of this Act shall apply to such industry as may be specified in the notification.

Definitions.

- 3. In this Act unless there is anything repugnant in the subject or context-
 - (1) "Arbitration proceeding" means any proceeding under this Act before an arbitrator or where a dispute has been referred to the Industrial Court for arbitration the proceedings before such Court in respect of such dispute.
 - (2) "Arbitrator" means an arbitrator to whom a dispute is referred for arbitration under the provisions of this Act and includes an umpire.
 - (3) Association of "employers" means any combination employers, whether incorporated or not, which has for one of its objects the regulation of conditions of employment in the industry conducted or carried on by its members, and which is recognized by the Provincial Government under section 74.
 - (4) "Award" means any interim or final determination in an arbitration proceeding of any industrial dispute or of any question relating thereto and includes any award made by the Industrial Court under clause (5) or (6) of section 53.
 - (5) "Board" means the Board of Conciliation appointed under section 23.
 - (6) "Change" means a change in any industrial matter.
 - (7) "Commissioner of Labour" means an officer appointed by the Provincial Government for the time being to be the Commissioner of Labour.
 - (8) "Conciliation proceeding" means any proceeding held by a Conciliator or the Board under this Act.
 - (9) "Conciliator" means any Conciliator appointed under this Act and includes the Chief Conciliator or a Special Conciliator.
 - (10) "Employee" means any person employed to do any skilled or unskilled manual or clerical work for hire or reward in any industry and includes an employee discharged on account of any dispute relating to a change in respect of which a notice is given under section 28 whether before or after the discharge.
 - (11) "Employer" includes-
 - (a) an association or a group of employers; " .
 - (b) any agent of an employer;
 - (c) where an industry is conjected of carried on by a department of the Provincial Government, the authority prescribed in that behalf, and where no such authority has been prescribed, the head of such department;

- (d) where an industry is conducted or carried on by or on behalf of a local authority, the Chief Executive Officer of such authority; or
- (e) where the owner of any industry in the course of or for the purpose of conducting such industry contracts with any other person for the execution by or under the contractor of the whole or any part of any work which is ordinarily part of the said industry, the owner of such industry.
- (12) "Industrial Court" means the Court of Industrial Arbitration appointed under section 24.
- (13) "Industrial dispute" means any dispute or difference between an employer and employee or between employers and employees or between employees and employees and which is connected with any industrial matter.
- (14) "Industrial matter" means any matter relating to work, pay, wages, reward, hours, privileges, rights or duties of employers or employees, or the mode, terms and conditions of employment or non-employment and includes—
 - (a) all matters pertaining to the relationship between employers and employees, or to the dismissal or non-employment of any person;
 - (b) all matters as to the demarcation of functions of any employees or classes of employees;
 - (c) all matters pertaining to any right or claim under or in respect of or concerning an agreement, submission or award made under this Act; and
 - (d) all questions of what is fair and right in relation to any industrial matter having regard to the interest of the person immediately concerned and of the community as a whole.
- (15) "Industrial union" means a union the members of which belong to any industry generally and which is not an occupational union.
 - (16) "Industry" includes—
 - (a) any business, trade, manufacture or undertaking or calling of employers;
 - (b) cay calling, service, en loyment, handicraft, or industrial occupation or avocation of imployees; and
 - (c) any branch or section of industry recignised by the Registrar for the purposes of this Act on a group of industries.

- (17) "Labour Officer" means an officer appointed to perform the duties of a Labour Officer under this Act.
- (18) "Local area" means any area notified as such by the Provincial Government.
- (19) "Lock-out" means the closing of a place or part of a place of employment or the total or partial suspension of work by an employer or the total or partial refusal by an employer to continue to employ persons employed by him, where such closing, suspension or refusal occurs in consequence of an industrial dispute and is intended for the purpose of compelling those persons or of aiding another employer in compelling persons employed by him to accept any term or condition of or affecting employment.
- (20) "Member" means a person who is an ordinary member of a union and who has been paying a subscription of not less than one anna per month and the term "membership" shall be construed accordingly.
- (21) "Occupation" means any section of an industry recognised to be an occupation under section 5.
- (22) "Occupational union" means a union the membership of which is confined to employees employed in a particular occupation or group of occupations in any industry.
 - (23) "Prescribed" means prescribed by rules made under this Act.
- (24) "Qualified union" means any union declared to be a qualified union under section 11.
- (25) "Recognised union" means a union which has been recognised in the prescribed manner by an employer or by an association of the employers in any industry.
- (26) "Registered agreement" means an agreement registered under section 30 or 33.
- (27) "Registered union" means a union registered under this Act.
- (28) "Registrar" means the Registrar of Unions appointed under this Act.
 - (29) "Representative of employees" means—
 - (i) where the majority of employees directly affected if a change are members of a registered union, such registered union; or
 - (ii) where some of the employees directly affected by the change belong to a representative union, that representative union; or

- (iii) in other cases such representatives not being more than five as may be elected in the manner prescribed by employees directly affected by the change from among themselves; or
- (iv) in cases where representatives are not elected under clause (iii), and in all other cases not falling under any of these clauses the Labour Officer.
- (30) "Representative union" means a registered union declared to be a representative union under section 12.
 - (31) "Schedule" means schedule appended to this Act.
- (32) "Settlement" means a settlement arrived at during the course of a conciliation proceeding.
- (33) "Strike" means a total or partial cessation of work by employees employed in an industry acting in combination or a concerted refusal or a refusal under a common understanding of employees to continue to work or to accept work where such cessation or refusal is in consequence of an industrial dispute in any industry.
- (34) "Union" means a Trade Union (other than a union formed for the purpose of regulating the relations between employers and employers) registered under the Indian Trade Unions Act, 1926.

CHAPTER II.

REGISTRATION OF UNIONS.

- 4. (1) The Provincial Government shall, by notification in the Appointment Official Gazette, appoint a person to be the Registrar of Unions for the powers and duties of Registrars and Assistant
- (2) The Provincial Government may, by a similar notification, appoint Registrars. a person to be the Assistant Registrar of Unions for any local area and may, by a general or special order, confer on such person all or any of the powers of the Registrar of Unions under this Act.
- 5. The Registrar may after making such enquiry as he deems fit Recognition recognise any section of an industry to be an occupation for the purposes of section of industry as occupation.
- 6. It shall be the duty, of the Registrar to maintain a register of Maintenance registered and representative unions in such forms as may be prescribed, of registered and representative unions.

Application for registration. 7. Any recognised union, which has for the whole of the period of six months next preceding the date of the application under this section a membership of not less than five per cent., or any other union which has for the said period a membership of twenty-five per cent. of the total number of employees employed in any industry or occupation, as the case may be, in the local area may apply in the prescribed form to the Registrar for registration under this Act.

Registration of a union.

8. On receipt of an application from a union for registration under section 7 and on payment of the fee prescribed, the Registrar shall hold such enquiry as he thinks fit and if he is satisfied that such union fulfils the conditions necessary for registration specified in section 7 and is not disqualified from registration under this Act, he shall enter the name of such union in the register maintained under section 6 and shall issue a certificate of registration in such form as may be prescribed:

Provided that—

- (a) in any local area the Registrar shall not register more than one industrial union in respect of any industry and one occupational union in respect of each occupation in such industry;
- (b) where two or more industrial or two or more occupational unions fulfilling the conditions necessary for registration specified in section 7 apply for registration, the union which has the largest membership of the employees employed in the industry or occupation, as the case may be, shall alone be registered;
- (c) if an industrial union has been registered in any local area no occupational union in respect of the same industry in such local area shall be registered unless such union has more than twenty-five per cent. of the total number of employees employed in that occupation in such local area;
- (d) the Registrar shall not register a union as an industrial or an occupational union, as the case may be, if there is a qualified union in existence in respect of the same industry or occupation and if the union applying for registration has not for the whole of the period of six months next preceding the date of application, a membership exceeding that of such qualified union; and
- (e) the Registrar shall not register any union, if he is satisfied that the application for registration is not made bona fide in the interests of employees but is made in the interests of the employer.
- 9. The Registrar shall cancel the registration of a union-

(i) if, on an application made to him by any employer or any union concerned with the industry or occupation in which the members of the union, the registration of which is sought to be cancelled, are

Cancellation of registration of a union. employed and after holding such enquiry as he deems fit, he is satisfied --

- (a) that such union had not fulfilled the necessary conditions for registration under section 7 at the time of its registration or that it was registered under a mistake, misrepresentation or fraud :
- (b) that at the date of the application made under this section the union failed to satisfy the condition regarding the minimum membership necessary for registration specified in section 7;
 - (c) that its recognition by the employer had been withdrawn:

Provided that the registration of such union shall not be cancelled on this ground if its membership is more than twenty-five per cent. of the total number of employees employed in the industry or occupation, as the case may be;

(d) that in the case of an occupational union in any industry in any local area, an industrial union in respect of such industry is registered in such local area:

Provided that the registration of such occupational union shall not be cancelled if its membership is more than twenty-five per cent. of the total number of employees employed in the occupation in such local area; or

- (e) that the union is not being conducted bona fide in the interests of employees but is being conducted in the interests of the employer;
- (ii) if the Industrial Court directs that the registration of such union shall be cancelled.
- 10. (1) If at any time any union (hereinafter referred to in this section Registration as "applicant union") applies to the Registrar stating that it has a of another larger membership of employees employed in any industry or occupation union in in any local area than the one already registered (hereinafter referred to existing in this section as a "registered union") for such industry or occupation, registered as the case may be, for that local area, and that the registration of the union. registered union should be cancelled or that it should be registered in place of the registered union, the Registrar shall call upon the registered union by a notice in writing to show cause within one month of the receipt of such notice why its registration should not be cancelled or why the applicant union should not be registered in its place. An application made under this sub-section shall be accompanied by such fee as may be prescribed.

(2) The Registrar shall forward to the Labour Officer a copy of the said application and notice.

(3) If, on the expiry of the period of notice under sub-section (1) and after holding such enquiry as he deems fit, the Registrar is satisfied that the membership of the applicant union was during the whole of the period of six months immediately preceding the date of the application under this section larger than the membership of the registered union, he shall cancel the registration of such union and if the applicant union satisfies the conditions necessary for registration specified in section 7, he shall register the applicant union.

Qualified

- 11. (1) The Registrar shall maintain a list of qualified unions in such form as may be prescribed.
- (2) If in any local area there is no registered union in respect of any industry or occupation, a union which has for a period of six months next preceding the application a membership of not less than five per cent. of the total number of employees employed in the industry or occupation, as the case may be, may on application and on payment of the fee prescribed be declared by the Registrar as a qualified union.
- (3) The Registrar shall cancel the declaration of any such union as a qualified union as soon as any union in respect of the industry or occupation, as the case may be, is registered under section 8.
- (4) The Registrar shall also cancel the declaration of a union as a qualified union—
 - (i) if, on an aplication made to him by an employer or any union concerned with the industry or occupation in which the members of the union, the declaration of which as a qualified union is sought to be cancelled, are employed and after making such enquiry as he thinks fit, he is satisfied—
 - (a) that such union had not at the time when it was declared a qualified union fulfilled the necessary conditions for its being so declared or that such declaration was made under a mistake, misrepresentation or fraud,
 - (b) that at the date of the application made under this subsection the membership of such union fell below five per cent. of the employees employed in the industry or occupation, as the case may be, in the local area;
 - (ii) if the Industrial Court directs that the declaration of such union as a qualified union shall be cancelled.

Representative unions.

- 12. (1) Any registered union in a local area, which has for the whole of the period of six months next preceding the date of application under this section a membership of not less than twenty-five per cent. of the total number of employees employed in the industry or occupation, as the case may be, in such local area, may apply to the Registrar for being declared a representative union.
- (2) If the Registrar is satisfied, on making such enquiry as he thinks fit, that the union fulfils the conditions specified in sub-section (1) he

shall declare such union to be a representative union, and shall issue a certificate in such form as may be prescribed.

- (3) The Registrar shall cancel the declaration of a union as a representative union—
 - (i) if, on application made to him by an employer or any union concerned with the industry or occupation in which the members of the union, the declaration of which as a representative union is sought to be cancelled, are employed and after making such enquiry as he thinks fit, he is satisfied—
 - (a) that such union had not at the time when it was declared a representative union fulfilled the necessary conditions for its being so declared or that such declaration was made under a mistake, misrepresentation or fraud;
 - (b) that at the date of the application made under this subsection the membership of such union fell below twenty-five per cent. of the employees employed in the industry or occupation as case may be, in the local area;
 - (c) that the registration of such union has been cancelled;
 - (ii) if the Industrial Court directs that the declaration of such union as a representative union shall be cancelled.
- 13. (1) Any union the registration of which has been cancelled by Application the Registrar or by the Industrial Court on the ground that it was for fresh registered under a mistake, or on any of the grounds specified in clause or declaration (b) or (c) of sub-section (i) of section 9 or any union the declaration tion. of which as a qualified union or as a representative union has been cancelled on the ground that such declaration was made under a mistake, or under clause (i) (b) of sub-section (1) of section 11 or under clause (i) (b) of sub-section (3) of section 12, as the case may be, may at any time, after six months from the date of such cancellation, apply again for registration or declaration, as the case may be. Such application shall be disposed of in the manner laid down in section 8, 11 or 12, as the case may be.
- (2) A union the registration of which or a union the declaration of which as a qualified union or as a representative union has been cancelled on any other ground shall not be entitled to apply again for registration or declaration.
- 14. Notwithstanding anything contained in any law, the cancellation Liability of of registration of a registered union or the cancellation of the declaration a union or of a union as a qualified union or as a representative union shall not relieved by relieve the union or any member thereof from any penalty or liability cancellation, incurred under this Act prior to such cancellation.

Periodical

15. Every registered union and every qualified union shall submit to the Registrar periodical returns of its membership at such times, the Registrar, on such dates and in such manner as may be prescribed.

Powers of Registrar to nesses, etc.

- 16. For the purpose of holding enquiry vnder summon wit. Chapter,-
 - (i) the Registrar shall have the same powers as are vested in Courts V of in respect of the following matters under the Code of Civil Procedure, 1908. 1908, in trying a suit, namely :-
 - (a) proof of facts by affidavits;
 - (b) summoning and enforcing the attendance of any person and examining him on oath; and
 - (c) compelling the production of documents;
 - (ii) the Registrar shall have also such other powers as may be prescribed.

Appearance before Registrar.

17. Every employer in the industry concerned and every representative of employees whose interests may be affected shall be entitled to appear at any enquiry made by the Registrar under this Chapter.

Appeal to Industrial Court from orders of the Registrar cancelling registration of unions.

- 18. (1) Any person entitled to appear before the Registrar may appeal to the Industrial Court against any order passed by the Registrar under this Chapter within 30 days from the date of such order.
- (2) The Industrial Court in appeal may confirm, modify or rescind any order passed by the Registrar and may pass such consequential orders as it may deem fit. A copy of the orders passed by the Industrial Court shall be sent to the Registrar.

Reference to Industrial Court and any order of Registrar to be in accordance with such decision.

19. The Registrar may refer any matter arising before him in any proceedings under this Act to the Industrial Court for its decision and any order passed by the Registrar in such proceeding shall be in accordance with such decision.

Publication of application and orders of cancellation m Official Gazette.

- 20. (1) Every application made under section 10 shall be published in the Official Gazette not less than a fortnight before the application is heard.
- (2) Every order passed under section 8, 9, 10, 11 or 12 and every order passed in appeal against such order shall be published in the Official Gazette.

CHAPTER III.

AUTHORITIES TO BE CONSTITUTED OR APPOINTED UNDER THIS ACT.

- 21. (1) The Commissioner of Labour shall be ex-officio Chief Conciliator. Conciliators. His jurisdiction shall extend throughout the Province.
- (2) The Provincial Government may, by notification in the Official Gazette, appoint any person to be a Conciliator, for such local area as may be specified in the notification.
- (3) The Provincial Government may, by notification in the Official Gazette, appoint any person to be a Special Conciliator for such local area or such industry in any local area or for such industrial dispute or class of disputes as may be specified in the notification.
- 22. The Provincial Government may, by notification in the Official Labour Gazette, appoint any person to be a Labour Officer for such local area Officer. or such industry as may be specified in the notification.
- 23. (1) When an industrial dispute arises the Provincial Government Board of may, by notification in the Official Gazette, constitute a Board of Concilia-Conciliation tion for promoting a settlement of such dispute.
- (2) The Board shall consist of a Chairman and an equal number of members selected by the Provincial Government from panels representing the interests of the employers and employees respectively. Such panels shall be constituted in the manner prescribed. The Chairman and members of the Board shall be independent persons.

Explanation.—For the purposes of this section a person shall be deemed to be independent if he is unconnected with the dispute with reference to which the Board is constituted and the industry directly affected by the dispute.

- (3) If any vacancy in the membership of the Board arises before the Board has completed its work, such vacancy shall be filled up in the manner prescribed and the proceedings shall be continued before the Board so reconstituted from the stage at which they were when the vacancy occurred.
- 24. (1) The Provincial Government may constitute a Court of Court of Industrial Arbitration for determining industrial disputes and for dealing Industrial with other matters under the provisions of this Act and the rules made Arbitration. thereunder.
- (2) The Industrial Court shall consist of two or more members, one of whom shall be its President. Every member of the Industrial Court shall be a person—
 - (a) who is not connected with any industry, and,

- (b) who is or has been a Judge of a High Court or is eligible for being appointed a Judge of such Court.
- (3) The Industrial Court may make rules providing for the formation of Benches consisting of one or more of its members and for the exercise by each such Bench of the jurisdiction and powers vested in the Industrial Court.
- (4) The Industrial Court may hold its sittings at such place or places as the President may direct.

CHAPTER IV.

Powers and Duties of the Labour Officer.

Powers and duties of Labour Officer.

- 25. (1) A Labour Officer shall exercise the powers conferred and perform the duties imposed on him by or under this Act.
- (2) For the purpose of exercising such powers and performing such duties a Labour Officer may, after giving reasonable notice, enter any place used for the purpose of any industry or as the office of any union and shall be entitled to call for and inspect all relevant documents which are necessary for the due discharge of his duties and powers under this Act. A Labour Officer may for the same purpose enter, after giving reasonable notice, any premises provided by an employer for the purpose of residence of his employees.
- (3) All particulars contained in or information obtained from any document inspected or called for under sub-section (2) shall, if the person in whose possession the document was so required, be treated as confidential.
- (4) A Labour Officer shall be entitled to appear in any proceeding under this Act.

CHAPTER V.

CHANGES.

Standing orders regarding industrial matters and change in such standing orders

26. (1) Every employer in respect of any industry or occupation to which this section has been made applicable shall within two months from the date of such application submit to the Commissioner of Labour for approval in such manner as may be prescribed standing orders regulating the relations between him and his employees with regard to sall industrial matters mentioned in Schedule I.

- (2) On receipt of such standing orders the Commissioner of Labour shall, after making such enquiry as he deems fit and after consulting all interests concerned in the industry, settle the said standing orders.
- (3) The Commissioner of Labour shall forward a copy of the standing orders so settled to the Registrar who shall record them in the register to be kept for the purpose. The standing orders so settled and recorded in the register shall come into operation from the date of their record in the register or after 10 days from the decision of the Commissioner of Labour whichever is later.
- (4) Any person aggrieved by any of the standing orders so settled and recorded by the Commissioner of Labour may within 15 days from the date on which such standing orders come into operation under subsection (3) appeal to the Industrial Court.
- (5) On an appeal being filed, the Industrial Court may on the application of any party to such appeal stay the operation of the standing orders objected to until the appeal is decided on such conditions as it may think fit.
- (6) The Industrial Court in appeal may confirm, modify or rescind any standing order settled by the Commissioner of Labour under sub-section (2) and may pass such consequential orders as it may deem fit. A copy of the orders passed by the Industrial Court shall be sent to the Registrar who shall record them in the register referred to in sub-section (3).
- (7) The Industrial Court may also fix the date on which the standing orders as revised or confirmed by it shall come into operation.
- (8) The standing orders settled by the Commissioner of Labour under sub-section (2) or by the Industrial Court under sub-section (6) shall be determinative of the relations between the employer and his employees in the industry or occupation concerned in regard to all industrial matters mentioned in Schedule I and shall not be liable to be altered for a period of six months from the date on which they come into operation except on a review by the Industrial Court under section 27.
- 27. (1) Any person aggrieved by the decision of the Industrial Court Review. under section 26 may apply to the Industrial Court for a review of the said decision.
- (2) The Industrial Court shall not grant such application unless it is satisfied that there has been a discovery of new and important matter or evidence which after the exercise of due diligence was not within the knowledge of the party making the application or could not be produced by him at the time when its decision was made, or that there has been some mistake or error apparent on the face of the record or that there is any other sufficient reason for granting such application.
- (3) The provisions of sub-sections (6), (7) and (8) of section 26 shall apply to the proceedings under this section.

Employers or employees desiring change in standing orders and other industrial matters to give notice.

- 28. (1) Any employer intending to effect any change in any standing order settled under section 26 or 27 or in respect of an industrial matter mentioned in Schedule II shall give notice of such intention in the prescribed form to the representative of the employees. He shall send a copy of such notice to the Commissioner of Labour, the Chief Conciliator, the Registrar, the Labour Officer and to such other person as may be prescribed. He shall also affix a copy of such notice at a conspicuous place in the premises where the employees affected by the change are employed for work and at such other place as may be directed by the Chief Conciliator in any case.
- (2) An employee desiring a change in any such standing order or in respect of any other industrial matter shall give notice in the form prescribed to the employer through the representative of the employees who shall also forward a copy of the notice to the Commissioner of Labour, the Chief Conciliator, the Registrar, the Labour Officer and to such other person as may be prescribed.
- (3) After conciliation proceedings in regard to any industrial dispute arising out of a notice relating to any change given under sub-section (1) or (2) have been completed, no notice with regard to the same change shall be given before the expiry of two months from the date of such completion. If, at any time after the expiry of the said period of two months, any employer or employee again desires the same change, he shall give fresh notice in the manner provided in sub-section (1) or (2), as the case may be.

Notice of change when to be deemed general notice.

- 29. (1) Where an employer gives notice of a proposed change under sub-section (1) of section 28 and such change affects only some of the employees engaged in an industry or occupation, the registered or qualified union in respect of such industry or occupation in that local area, as the case may be, may, within seven days from the date of service of such notice, intimate in writing to other employers or an association of employers engaged in such industry or occupation that the employees employed in such industry or occupation by such employers and mentioned in such intimation are affected by such change.
- (2) Where an employee gives notice of a proposed change under subsection (2) of section 28 and such change affects only one employer or some of the employers engaged in an industry or occupation, the other employers or an association of employers engaged in such industry or occupation in that local area, as the case may be, may within seven days from the date of service of such notice, intimate in writing to the representative of the employees, engaged in such industry or occupation, that the other employers engaged in such industry or occupation and mentioned in such intimation are affected by such change.
- (3) A copy of an intimation under sub-sections (1) and (2) shall be sent to the Commissioner of Labour, the Chief Conciliator, the Registrar, the Labour Officer and such other person as may be prescribed and shall also be affixed at a conspicuous place in the premises where the employees

concerned are employed for work and at such other places as may be prescribed.

- (4) On an intimation being given under sub-section (1) or (2), the other employees or employers, as the case may be, mentioned in such intimation, shall also, for the purposes of this Act, be deemed to be affected by such change.
- 30. (1) If during fifteen days from the date of service of the notice Agreement under section 28 or within 7 days from the date of intimation given change. under section 29 to the representative of employees or the employer or the employers, as the case may be, an agreement is arrived at in regard to the proposed change between the employer or the employers and the representative of the employees, a memorandum of such agreement signed by the employer or the employers as well as by the representative of the employees shall be forwarded by them to the Commissioner of Labour, the Registrar and the Labour Officer.

- (2) On receipt of such memorandum of agreement the Registrar shall enter the same in a register maintained for the purpose unless on enquiry he is satisfied that the agreement was the result of mistake, misrepresentation, fraud, undue influence, coercion or threat.
- (3) The agreement so recorded by the Registrar shall be called a registered agreement.
- 31. In any case where the Labour Officer is a representative of the Labour employees, the Labour Officer shall, before entering into any agreement Officer to put with the employer, place the terms of such agreement before a meeting to the meetof the employees concerned. Such meeting shall be convened by the ing of Labour Officer in the manner prescribed and the terms of the agreement employees. so placed before such meeting shall be deemed to have been accepted if the majority of the employees present at such meeting accept them. If the majority of the employees present at the meeting do not accept the terms of the agreement placed before them, the Labour Officer shall not enter into such agreement with the employer.

- 32. If an agreement is arrived at and registered under section 30 Agreement the changes referred to in the agreement shall come into operation from come into the date stated in the agreement or if no date is stated therein from the force. date on which it is recorded by the Registrar.
- 33. The Registrar may, on an application made within 6 months Agreement from the date of the coming into force of this section by an employer arrived at before comor a registered union, and with the consent of the other party, register ing into force any agreement relating to any industrial matter arrived at before the Act. coming into force of this section, unless on enquiries he is satisfied that such agreement was the result of mistake, misrepresentation, fraud. undue influence, coercion or threat.

CHAPTER VI.

CONCILIATION PROCEEDINGS.

Report of industrial dispute to be sent to Registrar, Chief Conciliator and the Conciliator. 34. If any change in respect of which notice is given under section 28, or an intimation is given under section 29 is objected to by the employer or the employee, as the case may be, the party who gave such notice or intimation shall, if he still desires that the change should be effected, forward to the Registrar, the Chief Conciliator and the Conciliator of the local area a full statement of the case in the prescribed form within twenty-one days from the date of service of such notice or intimation to the other party.

Explanation.—For the purpose of this section the change shall be deemed to be objected to by the employer or employee, as the case may be, if within fifteen days from the date of service of such notice or intimation a memorandum of agreement has not been forwarded to the Registrar under sub-section (1) of section 30.

Commencement of conciliation proceeding. 35. On receipt of the statement of the case under section 34 the Conciliator shall enter the industrial dispute in the prescribed register and the conciliation proceedings shall be deemed to have commenced from the date of such receipt.

Conciliation proceedings.

- **36.** (1) The Conciliator shall then hold the conciliation proceedings in the prescribed manner.
- (2) It shall be the duty of the Conciliator to endeavour to bring about a settlement of the industrial dispute and for this purpose the Conciliator shall enquire into the dispute and all matters affecting the merits thereof and may do all such things as he thinks fit for the purpose of inducing the parties to come to a fair and amicable settlement of the dispute and may adjourn the conciliation proceeding for any period sufficient in his opinion to allow the parties to arrive at a settlement.

Power of Chief Conciliator to intervene. 37. It shall be lawful for the Chief Conciliator to intervene or to direct a Special Conciliator to intervene at any stage in any conciliation proceedings held by another Conciliator, and thereafter the Chief Conciliator or the Special Conciliator so directed shall hold the conciliation proceedings with or without the assistance of the Conciliator who was previously holding the same.

Settlement and Report. 38. (1) If a settlement of an industrial dispute is arrived at in a conciliation proceeding, a memorandum of such settlement shall be drawn up in the prescribed form by the Conciliator and signed by the employer and the representative of employees. The Conciliator shall send a report of the proceedings along with a copy of the memorandum of settlement to the Registrar and the Chief Conciliator. The Registrar shall record such settlement in the register of agreements and shall then

publish it in such manner as may be prescribed. The change, if any, agreed to by such settlement shall come into operation from the date agreed upon in such settlement and where no such date is agreed upon from the date on which it is recorded in the register.

- (2) If no such settlement is arrived at, the Conciliator shall, as soon as possible, after the close of the proceedings before him, send a full report to the Chief Conciliator or if the conciliation proceedings are held by the Chief Conciliator, the Chief Conciliator shall send such report to the Provincial Government. Such report shall set forth the steps taken by the Conciliator or the Chief Conciliator, as the case may be, for the purpose of ascertaining the facts and circumstances relating to the dispute and the reasons on account of which, in his opinion, a settlement could not be arrived at.
- (3) The Chief Conciliator shall forward the reports submitted to him under sub-sections (1) and (2) to the Provincial Government with such remarks as he deems fit.
- (4) The Provincial Government shall publish the report of the Conciliator submitted to it under sub-section (2) or forwarded to it under sub-section (3) except in cases in which the dispute is referred to the Board of Conciliation.
- (5) In any case where the Labour Officer is a representative of the employees and where a settlement of an industrial dispute is arrived at in any conciliation proceeding, the Labour Officer shall convene a meeting of the employees concerned as laid down in section 31 and place the terms of the settlement before such meeting. The Labour Officer shall not sign the memorandum of such settlement under subsection (I) unless a majority of the employees present at such meeting accept the terms of such settlement.
- 39. (1) During the pendency of any proceedings before the Reference Conciliator under the foregoing provisions the Provincial Government to Board. may, and if both the parties agree either prior to the commencement of such proceedings or after the failure of the Conciliator to bring about a settlement shall refer the dispute to a Board of Conciliation.
- (2) On such reference being made, the Board shall give notice in the prescribed manner to the parties to the dispute to appear before it at such time and place as may be specified in the notice. A copy of such notice shall be sent to the Labour Officer.
- (3) On the date specified in the notice or on such other date as may be fixed by the Board, the Board shall hold the conciliation proceedings. It shall be the duty of the Board to endeavour to bring about a settlement of the industrial dispute and the provisions of sections 35 and 36 shall, so far as may be, apply to the proceedings before the Board.

(4) On the conclusion of the proceedings before the Board, the Board shall, whether a settlement is arrived at or not, send a report of the proceedings to the Provincial Government. The Provincial Government shall then publish such report.

Procedure and powers of Concilistor and the Board.

- 40. (1) A Conciliator or the Board, as the case may be, shall, subject to the provisions of this Act, follow in a conciliation proceeding such procedure as may be prescribed.
 - (2) For the purpose of holding a conciliation proceeding,—
 - (i) a Conciliator or the Board shall have the same powers as are vested in Courts under the Code of Civil Procedure, 1908, in respect V of of the following matters when trying a suit:—
 - (a) summoning and enforcing the attendance of any person and examining him on oath;
 - (b) compelling the production of documents;
 - (c) issuing commissions for the examination of witnesses;
 - (d) proof of facts by affidavits;
 - (ii) the Conciliator or the Board shall have such further powers as may be prescribed.
- (3) The proceedings before a Conciliator shall be held in camera and the proceedings before the Board in public;

Provided that the Board may at any stage direct that any particular witness be examined or its proceeding be held in camera.

(4) If a party to an industrial dispute giving any information or producing any document in a conciliation proceeding makes a request in writing to the Conciliator or the Board, as the case may be, that such information or the contents of such document may be treated as confidential, the Conciliator or the Board shall direct that such information or document be treated as confidential:

Provided that the Conciliator or the Board may permit the information or contents of the document in respect of which a request has been made under this sub-section to be disclosed to the other party.

- (5) Save as provided in sub-section (4), the Conciliator or any member of the Board or any person present at or concerned in the conciliation proceeding shall not disclose any information or the contents of any document in respect of which a request has been made under section (4) without the consent in writing of the party making the request under the said sub-section.
- (6) Nothing in this section shall apply to disclosufe of any information or the contents of any document for the purpose of a prosecution under this Act or under any other law for the time being in force.

41. (1) The Provincial Government shall by a general or special The limit order fix a time limit for each stage of the conciliation proceedings for stages in provided for under this Chapter:

proceedings.

Provided that the total period of time limit fixed for all stages of the conciliation proceedings shall not exceed two months from the date on which the dispute is entered by the Conciliator in the register under section 35:

Provided further that the Provincial Government may extend the said period of two months by a further period of a fortnight at a time not exceeding, in any case, two months in the aggregate.

- (2) Notwithstanding anything contained in sub-section (1), the parties to any industrial dispute may, in any case by mutual agreement, agree to extend the period of time limit fixed for any stage of a conciliation proceeding by any further period and such further period shall be excluded in computing the period of time limit referred to in the said sub-section.
- 42. The conciliation proceedings shall be deemed to have been com- Completion pleted when a settlement arrived at in such proceedings is registered or of conciliaif no settlement is arrived at, when the report of the Conciliator or the tion proceedings. Board of Conciliation is published by the Provincial Government or when the time limit fixed for the completion of such proceedings under section 41 has expired.

CHAPTER VII.

Arbitration.

- 43. (1) Any employer and a registered union may, by a written Submission. agreement, agree to submit any present or future industrial dispute or any classes of such disputes to arbitration of any person whether such arbitrator is named in such agreement or not. Such agreement shall be called a submission.
- (2) Any such agreement arrived at before the coming into force of this Chapter between an employer and a union shall also be deemed to be a submission.
- (J) Such submission may provide that the dispute shall be referred to arbitration of the Industrial Court.
- (4) A copy of every such submission shall be sent to the Registrar who shall register it in the register to be maintained for the purpose and shall publish it in the Official Gazette.

Submission when to be revocable. 44. In the absence of an agreement to the contrary, every submission shall be irrevocable:

Provided that the submission to refer future disputes to arbitration may at any time be revoked by any of the parties to such submission by giving the other party six months' notice in writing:

Provided further that before the expiry of the said period of six months the parties may agree to continue the submission for such further period as may be agreed upon between them.

Proceedings in arbitration.

45. The proceedings in arbitration under this Chapter shall be in accordance with the provisions of Schedule II in the Code of Civil Pro-V of cedure, 1908, in so far as they are applicable and the powers which are exercisable by a civil court under the said provisions shall be exercisable by the Industrial Court.

No conciliation where arbitration is provided.

- 46. No conciliation proceedings shall be commenced in respect of any dispute if—
 - (a) the majority of the employees directly affected by such dispute are members of a registered union which is a party to a submission relating to such dispute, or
 - (b) some of the employees directly affected by such dispute are members of a representative union which is a party to such submission.

Special case to be stated to Industrial Court.

47. The arbitrator may refer any matter in which a decision on any question of law is required to the Industrial Court for its decision. Any award made by the arbitrator shall be in accordance with such decision.

Award by the Arbitrator. 48. The Arbitrator shall, after hearing the parties concerned, make an award which shall be signed by him.

Dispute to be referred to Industrial Court, if no Arbitrator is appointed, etc. 49. Notwithstanding anything contained in this Chapter if no provision has been made in any submission for the appointment of an Arbitrator or where by reason of the act of parties or any circumstances, the appointment of an Arbitrator or an umpire is not possible, such dispute shall be referred to the arbitration of the Industrial Court.

Notice of award to parties.

- 50. (1) The arbitrator or the Industrial Court shall give notice of the award made by him or it to the parties and forward a copy of the award to the Registrar and the Labour Officer.
- (2) On receipt of such award, the Registrar shall enter it in a register kept for the purpose and shall publish it in the Official Gazette.

Date on which the award shall come into operation. 51. The award shall come into operation on the date stated in the award or where no such date is stated therein on the date on which it is registered under section 50.

Completion of arbitration proceedings. 52. The arbitration proceedings shall be deemed to have been completed when the award is published under section 50.

CHAPTER VIII.

COURT OF INDUSTRIAL ARBITRATION.

53. It shall be the duty of the Industrial Court-

Duties of Industrial

- (1) to decide appeals from the orders passed by the Registrar Court. under this Act;
- (2) to decide all matters which may be referred to it by the Registrar under section 19 or by an arbitrator under section 47;
- (3) to decide appeals from the decision of the Commissioner of Labour under section 26 regarding standing orders;
 - (4) to decide all applications for review made to it under section 27;
- (5) to decide industrial disputes referred to it in accordance with submissions registered under section 43 and which provide for such reference to the Industrial Court;
 - (6) to decide industrial disputes referred to it under section 49;
 - (7) to decide matters referred to it under section 56;
- (8) to decide whether a strike or lock-out or a change is illegal under the provisions of this Act; and
- (9) to decide such other matters as may be referred to it under this Act or the rules.
- 54. If in any proceeding, the Industrial Court finds that the registra- Cancellation tion of any union or the declaration of any union as a qualified union or as of registraa representative union was obtained under a mistake, misrepresentation declaration or fraud or that such union has contravened any of the provisions of this of any Act the Industrial Court may direct that the registration of such union or union as a qualified union or as a representative or as a union shall be cancelled.

55. The Industrial Court may, on the application of any employer or Industrial employee concerned or a representative of the employees concerned or Court to the Labour Officer, decide whether any strike or lock-out or any change whether made is illegal.

56. A Civil Court may refer any matter or any issue in any suit or Civil Court proceeding before it relating to an industrial dispute to the Industrial may refer any matter Court for its decision. Any order passed by the Civil Court in such suit relating to an or proceeding shall be in accordance with such decision.

Procedure before an Industrial Court.

- 57. (1) The Industrial Court shall, subject to the provisions of this Act. follow such procedure as may be prescribed.
- (2) (i) The Industrial Court shall have the same powers as are vested in Courts under the Code of Civil Procedure, 1908, in respect of the V of following matters when trying a suit:—
 - (a) summoning and enforcing the attendance of any person and examining him on oath;
 - (b) compelling the production of documents;
 - (c) issuing commissions for the examination of witnesses;
 - (d) proof of facts by affidavits.
- (ii) The Industrial Court shall have such further powers as may be prescribed.
- (3) Every proceeding before the Industrial Court shall be deemed to be a judicial proceeding within the meaning of sections 192, 193 and 228 of XLV of the Indian Penal Code.
- (4) The Industrial Court shall have power to direct by whom the whole or any part of costs of any proceeding before it shall be paid:

Provided that no such costs shall be directed to be paid for the services of any legal adviser engaged by any party.

Execution of order as to costs.

58. An order made by the Industrial Court regarding the costs of a proceeding may be produced before the principal civil court of original jurisdiction within the local limits of whose jurisdiction any person directed by such order to pay any sum of money has a place of residence or business or where such place is within the local limits of the ordinary civil jurisdiction of the High Court before the Court of Small Causes of Bombay and such court shall execute such order in the same manner and by the same procedure as if it were a decree for the payment of money made by itself in a suit.

The parties on whom order of Industrial Court will be binding.

- 59. The order of the Industrial Court shall be binding on-
- (a) all parties to the industrial dispute who appeared or were represented before such Court;
- (b) all parties who were summoned to appear as parties to the dispute whether they appeared or not, unless the Industrial Court is of opinion that they were improperly made parties;
- (c) in the case of an employer who is a party to the proceedings before such Court in respect of the undertaking to which the dispute relates, his successors, heirs or assigns in respect of the undertaking to which the dispute relates; and
- (d) in the case of a union which is a party to the proceedings before such Court, all persons who were members of such union on the date of the dispute or who become members of the union thereafter.

60. No order passed by the Industrial Court shall be called in The order question in any civil or criminal court.

of Industrial Court not liable to appeal or review.

61. The Provincial Government may direct the Advocate General Provincial or any other officer to appear in any proceeding before the Industrial Government Court by giving notice to such Court and on such notice being given the Advocate Advocate General or such officer shall be entitled to appear in such General or proceeding.

Officer to appear in any proceeding before Industrial Court.

CHAPTER IX.

ILLEGAL STRIKES AND LOCK-OUTS.

62. (1) A strike shall be illegal if it is commenced or continued— Illegal

(a) in cases where it relates to any industrial matter mentioned in Schedule I, before the standing orders relating to such matter and submitted to the Commissioner of Labour under section 26 are settled by him or by the Industrial Court, as the case may be, or before the expiry of six months from the date on which such standing orders come into operation under section 26;

(b) without giving notice in accordance with the provisions of

section 28;

(c) only for the reason that the employer has not carried out the provisions of any standing order or has made an illegal change;

(d) in cases where notice of the change is given in accordance with the provisions of section 28 and where no agreement in regard to such change is arrived at, before the statement of the case referred to in section 34 is received by the Registrar;

(e) in cases where conciliation proceedings in regard to the industrial dispute to which the strike relates have commenced, before the

completion of such proceedings;

(f) in cases where a submission relating to such dispute or such kinds of dispute is registered under section 43, until such submission is lawfully revoked; or

- (g) in contravention of the terms of a registered agreement, settlement or award.
- (2) In cases where conciliation proceedings in regard to any industrial dispute have been completed, a strike relating to such dispute shall be illegal if it is commenced at any time after the expiry of two months after the completion of such proceedings.

Illegal lock-outs.

- 63. (1) A lock-out shall be illegal if it is declared, commenced or continued—
 - (a) in cases where it relates to any industrial matter mentioned in Schedule I, before the standing orders relating to such matter and submitted to the Commissioner of Labour under section 26 are settled by him or by the Industrial Court, as the case may be, or before the expiry of one year from the date on which such standing orders come into operation under section 26;
 - (b) without giving notice in accordance with the provisions of section 28;
 - (c) in cases where notice of the change is given in accordance with the provisions of section 28 and where no agreement in regard to such change is arrived at, before the statement of the case referred to in section 34 is received by the Registrar;
 - (d) in cases where conciliation proceedings in regard to the industrial dispute to which the lock-out relates have commenced, before the completion of such proceedings;
 - (e) in cases where a submission relating to such dispute or such kinds of dispute is registered under section 43, until such submission is lawfully revoked; or
 - (f) in contravention of the terms of a registered agreement, settlement or award.
- (2) In cases where conciliation proceedings in regard to any industrial dispute have been completed, a lock-out relating to such dispute shall be illegal if it is commenced at any time after the expiry of two months after the completion of such proceedings.

CHAPTER X.

PENALTIES.

Employer not to dismiss, reduce or punish an employee.

- 64. (1) No employer shall dismiss or reduce any employee or punish him in any other manner by reason of the circumstances that the employee—
 - (a) is an officer or member of a registered union or of a qualified union or of a union which has applied for being registered or declared as a qualified union under this Act; or
 - (b) is entitled to the benefit of a registered agreement, submission or award; or
 - (c) has appeared or intends to appear as a witness or has given any evidence or intends to give evidence in a proceeding under this Act; or

- (d) is an officer or member of an organisation the object of which is to secure better industrial conditions; or
- (e) is an officer or member of an organisation which is not declared unlawful; or
 - (f) is a representative of employees; or
- (g) has gone on or joined a strike which is not illegal under the provisions of this Act.
- (2) Whoever contravenes the provisions of sub-section (1) shall, on conviction, be punishable with fine which may extend to Rs. 1,000.
- (3) The Court trying any offence under this section may direct that out of the fine recovered, such amount as it deems fit shall be paid to the employee concerned as compensation.
- 65. Any employer who has declared a lock-out which has been held Penalty for by the Industrial Court to be illegal shall, on conviction, be punishable illegal with fine which may extend to Rs. 2,500 and, in the case of the lock-out lock-out. being continued after such conviction, with an additional fine which may extend to Rs. 200 for every day during which such lock-out continues after such conviction.
- 66. Any employee who has gone on strike or who joins a strike which Penalty for has been held by the Industrial Court to be illegal shall, on conviction, declaring or commencing be punishable with fine which may extend to Rs. 25 and in the case an illegal of a continuing offence with an additional fine which may extend to Re. 1 strike. per day for every day during which the offence continues after his last conviction for such offence, subject to a maximum of Rs. 50.
- 67. If any person instigates or incites others to take part in, or other. Penalty for wise acts in furtherance of, a strike or lock-out which has been held to instigating, etc., illegal be illegal by the Industrial Court, whether such strike or lock-out has strikes and commenced or not, he shall, on conviction, be punishable with imprison-lock-outs. ment of either description for a term which may extend to three months, or with fine or with both.

Explanation.—For the purposes of this section, a person who contributes, collects or solicits funds for the purposes of any such strike or lock-out shall be deemed to act in furtherance thereof.

- 68. If a Conciliator or a member of the Board or any person present Penalty for at or concerned in any conciliation proceeding wilfully discloses any disclosing information or the contents of any document in contravention of this information. Act he shall, on a complaint made by the party who gave the information or produced the document in such proceeding and on conviction, be punishable with fine which may extend to Rs. 1,000.
- 69. (1) Any employer who makes any illegal change shall, on conviction, be punishable with fine which may extend to Rs. 5,000 and in the illegal case of a continuing offence with an additional fine which may extend changes to Rs. 200 per day for every day during which the offence continues after his last conviction for such offence.

(2) An employer who acts in contravention of a standing order settled under section 26 shall, on conviction, be punishable with fine which may extend to Rs. 100 and in the case of a continuing contravention of such standing order, with an additional fine which may extend to Rs. 25 per day for every day during which such contravention continues after his last conviction for such contravention.

Penalty for obstructing any person from carrying out duties imposed under this Act.

70. Any person who wilfully refuses entry to a Labour Officer to any place which he is entitled to enter under section 25 or who fails to produce any document which he is required to produce, or who fails to comply with any requisition or order issued to him by or under the provisions of this Act shall, on conviction, be punishable with fine which may extend to Rs. 500.

Penalties for offences not provided for elsewhere. 71. Whoever contravenes any of the provisions of this Act or of any rule made thereunder shall, on conviction, if no other penalty is elsewhere provided by or under this Act for such contravention, be punishable with fine which may extend to Rs. 100 and, in the event of such person having been previously convicted of an offence under this Act or any rule made thereunder with fine which may extend to Rs. 200.

CHAPTER XI.

MISCELLANEOUS.

Modifications in Schedules.

72. The Provincial Government may, by notification in the Official Gazette, at any time, make any additions to or alterations in the industrial matters specified in Schedule I or II or may delete therefrom any such matter:

Provided that before making any such addition, alteration or deletion a draft of such addition, alteration or deletion shall be published for the information of all persons likely to be affected thereby and the Provincial Government shall consider any objection or suggestion that may be received by it from any person with respect thereto.

Illegal changes.

- 73. (1) No employer shall make any change in any industrial matter in regard to which a standing order has been settled under section 26 or which is mentioned in Schedule II before the agreement referred to in sub-section (1) of section 30 is arrived at or where no such agreement is arrived at before the conciliation proceedings are completed or in cases where there is a registered submission before the arbitration proceedings are completed or in cases where any dispute relating to such industrial matter has been referred to the Industrial Court for its decision before such decision is given.
- (2) No employer shall make any such change in contravention of the terms of a registered agreement, a settlement or an award.

- (3) Any change made in contravention of the provisions of sub-section (1) or (2) shall be illegal.
- 74. (1) The Provincial Government may from time to time by noti-Association of fication in the Official Gazette recognise any combination of employers as Employers may an association of employers for the purposes of this Act or may revoke represent any such recognition.

- (2) In any proceeding under this Act, an association of employers shall be entitled to represent any employer who is a member of the association.
- 75. (1) Save with the permission of the authority holding any pro-Representaceedings under this Act, no employee shall be allowed to appear in such tion of proceedings except through the representative of employees.

- (2) Notwithstanding anything contained in sub-section (1), if in any conciliation or arbitration proceedings or in any proceedings before the Industrial Court the majority of employees directly concerned in or affected by such proceedings are members of a qualified union, such qualified union shall also be entitled to appear in such proceedings.
- 76. (1) A registered agreement, a settlement, a submission or an Agreement, etc., on whom award shall be binding upon all persons who are parties thereto: binding.

Provided that—

- (a) in the case of an employer, who is a party to such agreement, settlement, submission or award, his successors, heirs or assigns in respect of the undertaking as regards which the agreement, settlement, submission or award is made;
- (b) in the case of a union which is a party to such agreement, settlement, submission or award, all persons who were members of such union at the date of such agreement, settlement, submission or award or who become members of the union thereafter,

shall be bound by such agreement, settlement, submission or award.

(2) In cases in which a representative union is a party to any agreement, settlement, submission or award, the Provincial Government may, after giving the parties affected an opportunity of being heard by notification in the Official Gazette, direct that such agreement, settlement, submission or award shall be binding upon such other employers and employees in such industry or occupation in that local area as may be specified in the notification:

Provided that before giving a direction under this section the Provincial Government may in such cases as it deems fit, make in the prescribed manuer a reference to the Industrial Court for its opinion.

Period for which agreement. etc., to remain in force.

- 77. (1) A registered agreement, settlement or award shall cease to have effect on the date specified therein or if no such date is specified therein, on the expiry of the period of six months from the date on which notice in writing to terminate such agreement, rettlement or award, as the case may be, is given by any of the parties thereto to the other party.
- (2) Nothing in this section shall prevent the terms of a registered agreement being changed or modified by mutual consent of the parties affected thereby.
- (3) Notwithstanding anything contained in sub-section (1) or (2), if a registered agreement provides that it shall remain in force for a period exceeding two years, such agreement may after the expiry of eighteen months from the date of commencement of such agreement be terminated by either party thereto by giving six months' notice.
- (4) The party giving notice under sub-section (1) or (3) shall send a copy of it to the Registrar and the Labour Officer of the local area concerned.

Liability of of a union.

78. Where anything is required to be done by any union by or under the executive any provision of this Act, the person authorised in this behalf by the executive of the union or if no person is so authorised every member of the executive of the union shall be bound to do the same and shall be personally liable if default is made in the doing of any such thing.

> Explanation.—For the purposes of this section, executive of a union means the body by whatever name called to which the management of the affairs of the union is entrusted.

Jurisdiction of Courts.

79. No Court inferior to that of a Presidency Magistrate or a Magistrate of the first class shall try an offence under this Act.

Conciliator and Labour Officer to be public servants.

80. A Registrar, an Assistant Registrar, a Conciliator, a Labour Officer, an Arbitrator, a member of the Board, a member of the Industrial Court and its staff shall be deemed to be public servants within the XLV meaning of section 21 of the Indian Penal Code. of 1860.

Persons acting in good faith not to be oued.

81. No suit or proceeding shall lie against any person for anything which is in good faith done or intended to be done under this Act.

Provisions of Act VII of 1929 not to be affected.

82. Nothing in this Act shall affect any of the provisions of the Trade VII of Disputes Act, 1929, and no conciliation or arbitration proceeding shall be held under this Act relating to any matter or trade dispute which has been referred to and is pending before a Court of Enquiry of Board of Conciliation under the said Act.

- Bom. 83. The Bombay Trade Disputes Conciliation Act, 1934, shall cease Repeal of IX of to apply to any area in which the provisions of Chapters II, III, IV, V Bom. IX and VI of this Act have been brought into force.
 - 84. (1) The Provincial Government may make rules to carry out the Rules. purposes of this Act.
 - (2) In particular and without prejudice to the generality of the foregoing power such rules may be made for all or any of the following matters, namely:—
 - (a) the manner in which an employer or an association of employers may recognise any union under clause (25) of section 3;
 - (b) the manner in which the representatives of employees are to be elected under sub-clause (iii) of clause (29) of section 3;
 - (c) the forms of register of registered and representative unions to be maintained under section 6;
 - (d) the form in which an application may be made under section 7;
 - (e) the form in which a certificate of registration may be issued under section 8;
 - (f) the form in which a list of qualified unions is to be maintained under section 11:
 - (g) the fee to be paid on applications made under section 8, 10 or 11;
 - (h) the form in which a certificate may be granted to a representative union under section 12:
 - (i) the time, date and manner of submitting periodical returns under section 15:
 - (j) the manner in which the total number of employees is to be computed for the purposes of this Act;
 - (k) the other powers of the Registrar under section 16;
 - (1) the manner in which the panels representing the interests of employers and employees shall be constituted under section 23;
 - (m) the manner in which vacancies in the Board of Conciliation shall be filled up under section 23;
 - (n) the manner in which standing orders may be submitted under section 26;
 - (a) the form in which notice of change is to be given and the persons to whom copies of such notice are to be sent under section 28;

- (p) the other places at which the copy of the intimation shall be affixed under sub-section (3) of section 29;
 - (q) the manner of convening meetings under section 31;
 - (r) the form in which a statement of the case is to be forwarded under section 34;
 - (s) the register in which industrial disputes are to be entered under section 35;
- (t) the manner of holding conciliation proceedings under section 36;
- (u) the form in which the memorandum of settlement shall be drawn up and the manner in which it shall be published by the Registrar under section 38;
 - (v) the manner of giving notice under section 39;
- (w) the procedure to be followed by a Conciliator or the Board and the further powers of the Conciliator or the Board under section 40;
- (x) the procedure to be followed by the Industrial Court and the further powers of such Industrial Court under section 57.
- (3) The Provincial Government may also prescribe a fine not exceeding five hundred rupees for a breach of any such rule.
- (4) The rules made under this section shall be subject to the condition of previous publication in the Official Gazette.

BOMBAY ACT No. XXVI OF 1938.1

[THE BOMBAY MEDICAL PRACTITIONERS' ACT, 1938.]

[1st March, 1938]

An Act to regulate the qualifications and to provide for the registration of practitioners of Indian systems of medicine with a view to encourage the study and spread of such systems and to amend the law relating to medical practitioners generally in the Province of Bombay.

Whereas it is expedient to regulate the qualifications and to provide for the registration of practitioners of the Indian systems of medicine with a view to encourage the study and spread of such systems and to amend the law relating to medical practitioners generally; It is hereby enacted as follows:—

PART I.

PRELIMINARY.

1. (1) This Act shall be called the Bombay Medical Practitionrs' Short title, extent and commence.

(2) It extends to the whole of the Province of Bombay.

extent and commencement.

(3) Parts I and II of this Act shall come into force on such date as the Provincial Government may be notification in the Official Gazette appoint. Part III shall come into force in all municipal, cantonment and notified areas in the province on the expiry of two years and in all other areas on the expiry of five years from the date on which Parts I and II come into force in the respective areas.

PART II.

INDIAN SYSTEMS OF MEDICINE.

- 2. In this Part of the Act, unless there is anything inconsistent in Definitions, the subject or context,—
 - (1) "Board" means the Board of Indian systems of medicine, Bombay, established and constituted under section 3.

- (2) "Indian systems of medicine" means the Ayurvedic (including the Siddha) and the Unani Tibbi systems of medicine, whether supplemented or not by such modern advances as the Board may from time to time have determined.
- (3) "Inspector" means an Inspector appointed by the Board under section 22.
 - (4) "Part" means a Part of this Act.
- (5) "Practitioner" means a practitioner of the Indian system of medicine.
 - (6) "President" means the President of the Board.
- (7) "Qualifying Examination" means the examination held for the purpose of granting a diploma conferring the right of registration under this Act.
- (8) "Register" means the Register of practitioners maintained under section 15.
- (9) "Registered practitioner" means a practitioner whose name is for the time being entered in the Register.
 - (10) "Registrar" means the Registrar appointed under section 14.
 - (11) "Regulations" means regulations made under section 30.
 - (12) "Rules" means rules made under section 29.
- Establishment, constitution and incorporation of the Board.

 3. (1) Subject to the provisions of section 31, the Provincial Government shall be notification in the Official Gazette establish a Board to be called "the Board of Indian Systems of Medicine, Bombay", for the purpose of carrying out the provisions of this Part. Such Board shall be a body corporate and have perpetual succession and a common seal and may by the said name sue and be sued.
 - (2) The Board shall consist of thirteen members, who shall be appointed in the following manner, namely:—
 - (i) A President elected by the members of the Board from amongst themselves.
 - (ii) Six members nominated by the Provincial Government, out of whom
 - (a) one shall be a person residing in this Province and connected with an institution established for the purpose of giving instruction in the Avurvedic (including Siddha) system of medicine; and
 - (b) one shall be a person residing in this Province and connected with an institution established for the purpose of giving instruction in the Unani Tibbi System.
 - (iii) Seven members elected by the registered practitioners from amongst themselves:

Provided that for the first and second terms of the Board the President shall be a person nominated by the Provincial Government and the number of members elected by the registered practitioners shall be six.

(3) The seats of members elected under clause (iii) of sub-section (2) shall be so divided amongst the Ayurvedic and Unani registered practitioners as to be in the proportion of their numbers on the Register on the date of the election:

Provided that in determining the said proportion a fraction of one-half and less shall be neglected and a fraction of more than one-half shall be counted as one:

Provided further that the number of members representing registered practitioners of either system shall not at any time be less than two.

(4) Notwithstanding anything contained in sub-section (3), in the case of the first constitution of the Board, the Provincial Government shall nominate the Ayurvedic and Unani practitioners in such proportion as they may deem fit from among the practitioners who may be eligible to be entered in the Register and such members shall be deemed to have been duly elected under clause (iii) of sub-section (2).

Explanation.—The term of a Board shall mean the period for which the members are entitled to hold office under section 6.

- 4. If any of the members is not elected under clause (iii) of sub-Nomina on section (2) of section 3, the Provincial Government may, notwithstand- of members in default of anything contained in sub-section (2) of the said section, nominate election. such registered practitioners as they deem fit and the practitioners so nominated shall for the purposes of this Part be deemed to have been duly elected under clause (iii) of sub-section (2) of section 3.
- 5. The election of practitioners entitled to be the members of Election of the Board under clause (iii) of sub-section (2) of section 3, shall be members. held at such time and place and in such manner as may be prescribed by rules.
- 6. (1) Save as otherwise provided by this Part, the term of office Term of of elected and nominated members shall be for a period of five years office. commencing from the date on which the first meeting of the Board is held after the members are elected under sub-section (2) of section 3:
- , Provided that the term of office of members appointed to the Board constituted immediately after this Part comes into force shall be for a period of three years from the date on which the first meeting of such Board is held.
 - (2) An outgoing member shall continue in office until the election or nomination of his successor as the case may be.

(3) The outgoing member shall be eligible for renomination or re-election.

. Vacancies.

7. If a vacancy occurs in the office of a member of the Board through death, resignation, removal or disability of such member or otherwise, previous to the expiry of the period of his office, the vacancy shall be filled in the manner prescribed by rules. Any person nominated or elected to fill the vacancy shall, notwithstanding anything contained in section 6, hold office only so long as the member in whose place he is nominated or . elected would have held office if the vacancy had not occurred.

Resignation of a member.

8. Any member may at any time resign his office by letter addressed to the President. Such resignation shall take effect from the date on which it is received by the President.

Disabilities for continuing as member.

- 9. If any member, during the period for which he has been nominated or elected,-
 - (a) absents himself without such reasons as may in the opinion of the Board, be sufficient, from three consecutive ordinary meetings of the Board, or
 - (b) becomes subject to any of the disqualifications mentioned in section 10.

the Board shall declare his office to be vacant.

Disqualifications.

- 10. No person shall stand as a candidate for election as a member of the Board or shall be a member of the Board-
 - (a) who is an undischarged insolvent,
 - (b) who has been adjudicated by a competent Court to be of unsound mind. or
 - (c) whose name has been removed from the Register.

Validity of

11. No disqualification of or defect in the election or nomination proceedings. of any person acting as a member of the Board or as the President or presiding authority of a meeting shall be deemed to vitiate any act or proceeding of the Board, in which such person has taken part.

Time and place of meeting of Board.

The Board shall meet at such time and place and every meeting of the Board shall be summoned in such manner as may be prescribed by regulations :

Provided that until such regulations are made, it shall be lawful for the President to summon a meeting of the Board at such time and place as he may deem expedient by letter addressed to each member.

Procedure at meetings of Board.

- 13. (1) The President shall preside at every meeting of the Board In the absence of the President the members present shall elect one them to preside.
 - (2) All questions at a meeting of the Board shall be decided by the votes of the majority of the members present at the meeting. Eight members shall form a quorum. No quorum shall be necessary for a meeting adjourned for want of a quorum.

- (3) At every meeting of the Board, the President for the time being shall, in addition to his vote as a member of the Board, have a second or easting vote in case of an equality of votes.
- 14. (1) The Board shall, with the previous approval of Government, Registrar appoint a Registrar. The Registrar shall receive such salary and allowances as may be prescribed by rules. The Board may from time to time grant him leave and may appoint a person to act in his place. Any person duly appointed to act as Registrar shall be deemed to be the Registrar for all the purposes of this Act.
- (2) Any order of the Board appointing, punishing or removing a Registrar from office shall not be passed without the previous approval of the Provincial Government.
- (3) The Board may appoint such other officers and servants as may be necessary for the purposes of this Act:

Provided that the number and designations of such officers and servants, their salaries and allowances shall be subject to the previous approval of the Provincial Government.

- (4) The Registrar and any other officer or servant appointed under this section shall be deemed to be a public servant within the meaning of section 21 of the Indian Penal Code.
 - 15. (1) Subject to the provisions of this Part and subject to any Duties of general or special orders of the Board, it shall be the duty of the Registrar Registrar to keep the Register.
 - (2) The Register shall be in such form as may be prescribed by rules. The Register shall be divided into two parts:—
 - (i) that containing the names of practitioners qualified to practice The Ayurvedic system; and
 - (ii) that containing the names of practitioners qualified to practise the Unani system.

The Register shall contain the names, residence and qualifications of every practitioner registered together with the date on which such qualification was acquired.

- (3) The Registrar shall keep the Register correct as far as possible and may from time to time enter therein any material alteration in the address or qualifications of the practitioners. The names of registered fractitioners who die or whose names are directed to be removed from the Register under sub-section (3) of section 16 shall be removed from the Register.
- (1) The Provincial Government may direct that any alteration in the entries as respects additional qualification shall not be made unless on payment of such fee as may be prescribed by rules.

(5) For the purpose of this section the Registrar may write by registered post to any registered practitioner at the address which is entered in the Register to inquire whether he has ceased to practise or has changed his residence and if no answer is received to the said letter within six months, the Registrar may remove the name of the said practitioner from the Register:

Provided that the Board may, if it is satisfied that the said practitioner has not ceased to practise, on the application of the said practitioner, direct that his name be re-entered in the Register.

Registration.

- 16. (1) Every person who passes a qualifying examination shall on payment of a fee of Rs. 10 be entitled to have his name entered in the Register.
- (2) Notwithstanding anything contained in sub-tection (1), every person who, within the period of two years from the date on which this Part comes into force, proves to the satisfaction of the Registrar that he has been in regular practice as a practitioner for a period of not less than ten years preceding the date on which he makes the application for being registered as a practitioner under this Part shall be entitled to have his name entered in the Register on payment of a fee of Rs. 10:

Provided that every person who has not been in practice as a practitioner for a period of ten years preceding the aforesaid date but has worked as an apprentice under a practitioner or has received training in an institution or has passed an examination shall, if such apprenticeship or training or examination is, in the opinion of the Board, sufficient to qualify him to practise as a practitioner, be entitled to have his name entered in the Register on payment of a fee of Rs. 10.

(3) The Board may direct that the name of any practitioner who has been convicted of a cognizable offence as defined in the Code of Criminal Procedure, 1898, which discloses such defect of moral character as is, in V of the opinion of the Board, sufficient to make him unfit to practise his ¹⁸⁹⁸ profession or who, after due inquiry, has been found guilty of conduct, which is in the opinion of the Board infamous in any professional respect, shall be removed from the Register. The Board may, on sufficient cause being shown, also direct that the name of the practitioner so removed shall be re-entered in the Register.

Appeal to Board from the decision of Registrar.

- 17. (1) Any person aggrieved by the decision of the Registrar regarding the registration of any person or any entry in the Register may appeal to the Board.
- (2) Such appeal shall be filed and shall be heard and decided by the Board in the manner prescribed by the rules.
- (3) The Board may on its own motion or on the application of any person, after due and proper enquiries and after giving an opportunity to the person concerned of being heard, cancel or alter any entry in the Register, if, in the opinion of the Board, such entry was fraudulently or incorrectly made.

18. (a) The Registrar shall also prepare and keep a list called "a list Maintenance of persons in practice on the 10th March 1938".

(b) Every person not being a person qualified for registration under 10th March Bon. this Act or under the Bombay Medical Act, 1912, who, within a period of 1938. V1 of two years from the date from which this Part comes into force, proves to the satisfaction of the Registrar that he has been in regular practice in this province, on the 10th March 1938, of any system of medicine or surgery or midwifery or any of their branches shall be entitled to have his name entered in the aforesaid list on payment of Rs. 10:

Provided, however, that any person whose name has been removed Bom from the Register kept under the Bombay Medical Act, 1912, or the VI of Register kept under an Act of a Provincial Legislature in British India or from the register of any country where he was formerly practising, for infamous conduct in a professional respect, shall not be entitled to have have his name entered in the list.

- (c) The provisions of sub-sections (3) and (5) of section 15, sub-section (3) of section 16, and section 17 shall mutatis mutandis apply to this list.
- 19. Notwithstanding anything in any law for the time being Qualified practitioners' in forcecertificates.
 - (1) The expression "legally qualified medical practitioner" or "duly qualified medical practitioner" or any word importing a person recognised by law as a medical practitioner or member of medical profession shall in all Acts of Legislature in the Province of Bombay and in all Acts of the Central Legislature (in their application to the Province of Bombay) in so far as such Acts relate to any of the matters specified in List II or List III in the Seventh Schedule to the Government of India Act, 1935, include a registered practitioner.

(2) A certificate required by any Act from any medical practitioner or medical officer shall be valid, if such certificate has been signed by a registered practitioner.

- (3) A registered practitioner shall be eligible to hold any appointment as a Physician, Surgeon or other medical officer in any Ayurvedic or Unani dispensary, hospital, infirmary or lying-inhospital supported by or receiving a grant from the Provincial Government and treating patients according to the Indian systems of medicine or in any public establishment, body or institution dealing with such systems of medicine.
- 20. Every Registrar of Deaths on receiving notice of the death of a Notice of registered practitioner shall forthwith transmit by post to the Registrar death. a certificate under his own hand of such death with the particulars of time and place of death and may charge the cost of such certificates and transmission as an expense of his office.

21. Notwithstanding anything contained in section 16 on and after the expiry of two years from the date from which this Act comes into force a person shall not be entered in the Register as a registered practitioner, unless he has passed a qualifying examination.

Qualifying examination.

- 22. (1) The Board shall by regulations prescribe the course of training and qualifying examinations including the course of training and examinations prior to qualifying examinations. Such regulations shall provide that instruction and examinations shall, as far as possible, be given or held in any of the Indian languages spoken in the Province.
- (2) A qualifying examination shall be an examination in the Indian systems of medicine including the subjects of medicine, surgery and midwifery held for the purpose of granting a diploma conferring the right of registration under this Part, by any of the institutions which on the recommendation of the Board may be specified by the Provincial Government by a notification in the Official Gazette as being authorised to hold a qualifying examination.
- (3) It shall be the duty of the Board to secure the maintenance of an adequate standard of proficiency for the practice of the Indian systems of medicine including the subjects of medicine, surgery and midwifery. For the purpose of securing such standard, the Board shall have authority to call on the governing body or authorities of any institution giving instruction in the Indian systems of medicine and on any examining body authorised by or desirous of being authorised under sub-section (2)—
 - (a) to furnish such particulars as the Board shall require of any course of study prescribed by regulations or examination held by such body or authority or in such school or college with reference to the grant of any qualification; and
 - (b) to permit Inspectors appointed by the Board from among the Registered practitioners in this behalf to attend and be present at all or any of the qualifying or prior examinations.
- (4) The Inspectors shall not interfere with the conduct of any examination, but it shall be their duty to report to the Board their opinion as to the sufficiency or insufficiency of every examination which they attend and any other matters in relation to such examinations on which the Board may require them to report.
- (5) Every qualifying examination and every prior examination leading up to it held by the bodies or institutions authorised under this section shall be inspected by the Inspectors at least once in three years and more frequently if the Board so directs.
- (6) The Board shall forward a copy of every such report to the body which held the examination in respect of which the said report was made and shall also forward a copy of such report, together with any observations thereon made by the said body, to the Provincial Government.

- (7) An Inspector shall receive such remuneration to be paid as part of the expenses of the Board, as the Board, with the previous sanction of the Provincial Government, may determine.
- 23. If it shall appear to the Provincial Government on the report of Removal of the Board that the course of study and examinations prescribed by any of institutions the institutions specified in the notification under section 22 are not such to hold as to secure the maintenance of an adequate standard of proficiency for qualifying the practice of the Indian systems of medicine including the subject of examinations. medicine, surgery or midwifery, as the case may be, it shall be lawful for the Provincial Government from time to time by notification in the Official Gazette to direct that the said institution shall be removed from the said notification and shall not be authorised to hold a qualifying examination:

Provided that before any direction for the removal of an institution from the said notification is made under this section, the Board shall require the institution to take steps within such time as it thinks fit to provide that the course of study and examinations prescribed by the institution are of an adequate standard.

24. Notwithstanding anything in any other law for the time being in Exemption force, every registered practioner shall be exempt, if he so desires, from from serving serving on any inquest or as a juror or assessor under the Code of Criminal Procedure, 1898. 1898.

- 25. There shall be paid to the members of the Board such fees and Fees payable allowances for attendance and such reasonable travelling allowances as to members of Board. shall from time to time be prescribed by rules.
- 26. All moneys received by the Board as fees under this Part shall be Fees received applied for the purposes of this Part in accordance with the rules.
- 27. (1) The Registrar shall in every year, on or before a date to be Annual List fixed by the Board, cause to be printed and published a correct list of of practithe names and qualifications of all practitioners for the time being entered in the Register and the dates when such qualifications were acquired.

- (2) In any proceeding it shall be presumed that every person entered in such list is a registered practitioner and that any person not so entered is not a registered practitioner.
- 28. Whosoever voluntarily and falsely assumes or uses any title or False description or any addition to his name implying that he holds a degree, assumption diploma, licence, or certificate, conferred, granted or issued by any of the diploma to be institutioned and in the public of the diploma to be institutions specified in the notification under section 22 or that he is an offence. qualified to practise the Indian systems of medicine or that he is a registered practitioner shall, on conviction, be punishable with fine which may extend to Rs. 250 for the first offence under this section and to fine which may extend to Rs. 500 for every subsequent offence.

Rules.

- 29. (1) The Provincial Government may, after previous publication, make rules to carry out all or any of the purposes of this Part.
- (2) In particular and without prejudice to the generality of the foregoing power, the Provincial Government may make rules for any of the following matters:—
 - (a) The time at which and the place and manner in which election shall be held under section 5.
 - (b) The manner in which vacancies shall be filled under section 7.
 - (c) The manner in which the meetings of the Board shall be convened and held.
 - (d) The salary, allowances and other conditions of service of the Registrar under section 14.
 - (e) The form of the Register and the particulars to be entered therein under section 15.
 - (f) Fees chargeable for the alteration of entries in the Register.
 - (g) The manner in which appeals against the decision of the Registrar shall be heard by the Board under section 17.
 - (h) The application of fees.
 - (i) Fees and other allowances payable to members of the Board under section 25.
 - (j) The furtherance of any of the objects of the Board.

Regulations.

- 30. (1) The Board may, with the previous sanction of the Provincial Government make regulations not inconsistent with this Part or the rules for any of the following matters, namely:—
 - (a) The time and place at which the Board shall hold its meetings under section 12.
 - (b) The salary, allowances and other conditions of service of officers and servants of the Board other than the Registrar, under section 14.
 - (c) The course of study for training and qualifying examinations.
 - (d) The language, in which the examinations shall be conducted and instruction shall be given.
 - (e) The admission of students to the bodies or institutions authorised under section 22.
 - (f) The conditions under which students shall be admitted to the degrees, diploma, licence or certificate course and to the qualifying and prior examinations.
 - (g) The conditions of appointment of examiners and the conduct of examinations.
 - (h) All other matters which may be necessary for the purposes of carrying out the objects of this Part.

- (2) All regulations shall be published in the Official Gazette.
- (3) The Provincial Government may by notification in the Official Gazette cancel any regulation:

Provided that in submitting regulations under clauses (c) to (q) for sanction of the Provincial Government under this section, the Board shall send a copy of its proceedings relating to the passing of such regulations and shall state the number of its members representing either system of Indian medicine who have voted for or against such regulations or not voted in respect of such regulations:

Provided further that in sanctioning the said regulations due consideration shall be given to the opinion of the members of either system of Indian medicine as expressed in the said proceedings.

31. If at any time it shall appear to the Provincial Government Control of that the Board has failed to exercise or has exceeded or abused any of Provincial Government. the powers conferred upon it by or under this Part or has failed to perform any of the duties conferred upon it by or under this Part, the Provincial Government may, if it considers such failure, excess or abuse to be of a serious character, notify the particulars thereof to the Board, and if the Board fails to remedy such default, excess or abuse, within such time as the Provincial Government may fix on this behalf, the Provincial Government may dissolve the Board and cause all or any of the powers and duties of the Board to be exercised and performed by such person and for such period not exceeding two years as it may think fit.

PART III.

MEDICAL PRACTITIONERS GENERALLY.

32. No person other than (i) a practitioner registered under Part II Medical Bom. of this Act or (ii) a medical practitioner registered under the Bombay practitioners VI of Medical Act, 1912, or (iii) a person whose name is entered in the list under this mentioned in section 18 shall practise or hold himself out, whether Act or under directly or by implication, as practising for personal gain any system Bom. on any matter relating to medicine, surgery or midwifery.

Penalty.

34. Any person who acts in contravention of the provisions of section 32 shall, on conviction, be punishable with fine which may extend to ${f Rs.~100}$ for the first offence and to ${f Rs.~500}$ for every subsequent offence after his conviction for such first offence.

Conferring, granting or issuing colourable imitations of degrees, diplomas or licences to

- (1) No person other than a body or institution authorised under VII of section 22 of this Act or under the Indian Medical Degrees Act, 1916, or 1916. under the Bombay Medical Act, 1912, shall confer, grant or issue or hold VI of himself out as entitled to confer, grant or issue any degree, diploma or 1912. licence which is identical with or is a colourable imitation of any degree, VII of diploma or licence granted by a body or institution authorised under this 1916. be an offence. Act or under the Indian Medical Degrees Act, 1916, or under the Bombay Bom. Medical Act, 1912, as the case may be.
 - (2) Whoever contravens the provisions of this section shall, on conviction, be punishable with fine which may extend to Rs. 1,000 and if the person so contravening is an association every member of such association who knowingly or wilfully authorises or permits the contravention shall, on conviction, be punishable with fine which may extend to Rs. 1,000.

Saving.

- 36. Nothing in sections 32 and 34 shall apply to any person—
 - (a) who limits his practice to the art of dentistry, or
- (b) who being a nurse, midwife or health visitor registered under the Bom. Bombay Nurses, Midwives and Health Visitors Registration Act, VII of 1935, or a Dai attends on a case of labour, or
- (c) who is entitled to registration under section 16 (1) of this Act or Bom. VI of section 7 of the Bombay Medical Act, 1912, or 1912.
- (d) who is a British subject domiciled in the United Kingdom or India who, by virtue of a medical diploma granted to him in the United Kingdom, or a British subject domiciled in Burma who, by virtue of a medical diploma granted to him in Burma or the United Kingdom is, or is entitled to be registered in the United Kingdom as a qualified medical practitioner; or
 - (e) who practises homoeopathy, provided that such person—
 - (i) has undergone a course of training in homocopathy for such period and in such institutions as may be prescribed by the Provincial Government and has passed an examination as may be prescribed by the Provincial Government; and
 - (ii) does not hold a degree, diploma or licence which is a colourable, imitation of a degree, diploma or licence entitling any person to practise Western medical science under the Indian Medical Degrees VII of Act, 1916, or any Indian system of medicine under this Act.

- 37. Notwithstanding anything contained in this Part, a person may Liberty to practise practise medicine in any rural areain rural
 - areas.

- (i) if he has commenced practice in any village in the said area prior to a date on which a practitioner registered under Part II of this Act or under the Bombay Medical Act, 1912, has commenced and is in regular practice of medicine in the said village, and
- (ii) so long as he continues to practise in the said village as his principal place of practice.

Explanation .- For the purposes of this section, "rural area" means an area which is not within the limit of a municipality, cantonment or notified area committee.

- 38. (1) No Court other than the Court of a Presidency Magistrate or Court comof a Magistrate of the First Class shall take cognizance of or try an offence petent to try offences under this Act. under this Act and cognizance of offences.
- (2) No Court shall take cognizance of any offence under this Act except on a complaint in writing of an officer empowered by the Provincial Government in this behalf.
- 39. No suit, prosecution or other legal proceeding shall be instituted Indemnity against any person for anything which is in good faith done or intended to persons to be done under this Act, rules or regulations. the Act.
