[THE BOMEAY WEIGHTS AND MEASURES (AMENDMENT) ACT, 1939.]

[15th March 1939.]

An Act to amend the Bombay Weights and Measures Act, 1932.2

WHEREAS it is expedient to amend the Bombay Weights and from Measures Act, 1932, for the purpose hereinafter appearing: It is hereby NV of enacted as follows:—

- 1. This Act may be called the Bombay Weights and Measures Short title. (Amendment) Act, 1939.
- Bon. 2. In section 34, of the Bombay Weights and Measures Act, 1932, Amendment of section 34 of Bom. XV of hereinafter called the said Act—

 - (i) after the word "verified" the words "or reverified" shall be of 1932, inserted; and
 - (ii) to the said section the following explanation shall be added, namely:—
 - "Explanation.—When any such weight or measure or weighing or measuring instrument is found in the pessession of any trader or of any employee or agent of such trader, such trader shall be presumed, until the contrary is proved, to have had it in his possession for use for trade."
 - 3. Section 36 of the said Act shall be deleted.

Bom. IV of 1890, for the purpose hereinafter appearing; It is hereby enacted as follows:—

- 1. This Act may be called the Bombay District Police (Amendment) Short title. Act, 1939.

BOMBAY ACT No. IV OF 1939.1

[THE BOMBAY FINANCE (AMENDMENT) ACT, 1939.]

[30th March 1939.]

An Act to amend the Bombay Finance Act, 1932.2

WHEREAS it is expedient to amend the Bombay Finance Act, 1932, for the purposes hereinafter appearing; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Finance (Amendment) Short title and commencement.
 - (2) It shall come into force on the 31st March 1939.

Bom. 2. For sub-section (3) of section 2 of the Bombay Finance Act, 1932² Amendment of section 2 (hereinafter called "the said Act"), the following shall be substituted, of Bom. II namely:—

"(3) This Act shall remain in operation for eight years from the date on which it comes into force:

Provided that the expiration of this Act shall not revive the provisions nom. of the Indian Stamp (Bombay Amendment) Act, 1926, hereby repealed."

- (4) In section 8 for the words "of licensees" the words and figure "kept under section 7" shall be substituted;
- (5) In section 9 for the words, figures and brackets commencing with the words "at the option of Government" and ending with the words "land revenue" the following shall be substituted, namely :-
 - "either through a civil court or as an arrear of land revenue—
 - (a) if the sum was payable under sub-section (1) of section 6. either from the consumer, or, subject to the proviso to the said sub-section from the licensee, at the option of the Provincial Government, and
 - (b) if the sum was payable under sub-section (4) of section 6 from the person who generates energy for his own use ";
 - (6) In the First Schedule—
 - (i) for clause (a) substitute the following:—

Extent of Part VI.

- 20. This Part extends to-
 - (i) the City of Bombay,
- (ii) the limits of the municipal boroughs of Thana, Kurla, Bandra and Ahmedabad,

- (iii) the limits of the municipal districts of Ville Parle, Ghatkopar-Kirol and Juhu in the Bombay Suburban District,
- (ir) the notified areas of Malad, Kandivali, Borivali, Chembur and Mulund in the Bombay Suburban District, Bhayandar in the District of Thana and Sabarmati in the District of Ahmedabad, and
 - (v) the limits of the Cantonment of Ahmedabad.
- 21. Unless there is anything repugnant in the subject or context,— Definitions
 - (1) "Annual letting value" means-
 - (a) in the City of Bombay, the rateable value of buildings or lands as determined in accordance with the provisions of the City of Bombay Municipal Act, 1888;

 - (c) in the area of the Cantonment of Ahmedabad, the annual value as defined by section 64 of the Cantonments Act, 1924:

Provided that if in any case the property tax is assessed on any building or land on its capital value, such percentage of the capital value as may be determined by the Provincial Government shall be deemed to be the annual letting value.

- (2) "Buildings" and "lands" have the same meanings as they have in the City of Bombay Municipal Act, 1888, the Bombay Municipal Boroughs Act, 1925, the Bombay District Municipal Act, 1901, or the Cantonments Act, 1924, as the case may be;
- (3) "Urban Immoveable Property tax" means a tax leviable under the provisions of section 22;
 - (4) "Municipality" includes a Notified Area Committee;
- (5) "Municipal area" means an area within the limits of a municipality;
 - (6) "Prescribed" means prescribed by rules;
- (7) "Property tax" means in the City of Bombay the general tax levied under section 143 of the City of Bombay Municipal Act, 1888, and in other Municipal areas and in the area of the Cantonment of Ahmedabad, a tax or rate on buildings or lands, or a tax or rate in the form of such tax or rate on buildings or lands levied under the Bombay Municipal Boroughs Act, 1925, or the Bombay District municipal Act, 1901, or the Cantonments Act, 1924, as the case may be; and
 - (8) "Rules" means rules made under section 29,

- (b) in other areas on the buildings and lands the annual letting value of which does not exceed such amount as the Provincial Government may, by notification in the Official Gazette, declare.

Provided further that if any building consists of more than one tenement and such tenements are separately assessed to the property tax, the urban immoveable property tax shall be assessed on the annual letting value of the building as a whole.

Exemption of certain buildings and lands from the levy of Urban Immoveable Property tax.

23. The Urban Immoveable Property tax shall not be leviable in respect of the following:—

(a) buildings and lands or portions thereof exclusively occupied for public worship or for charitable purposes;

- (b) buildings and lands vesting in His Majesty for purposes of the Central Government;
- (c) buildings and lands vesting in His Majesty for purposes of the Provincial Government or belonging to a Municipality or a local board or a Cantonment Board and used solely for public purposes and not used or intended to be used for purposes of profit; and
- (d) (i) buildings and lands vesting in the trustees of the Port of Bombay and not used or intended to be used for purposes of profit; and
- (ii) wharves, docks, piers, Railways and light-houses (as defined in the Bombay Port Trust Act, 1879) vesting in the Trustees of the Bom. Port of Bombay, and used as such and such other properties vesting VI of in the said Trustees as the Provincial Government may notify in this ¹⁸⁷⁹, behalf.

Explanation .- For the purposes of this section-

- (1) the following buildings and lands or portions thereof shall not be deemed to be exclusively occupied for public worship for for charitable purposes, namely:—
 - (a) those in which trade or business is carried on; and
 - (b) those in respect of which rent is derived, whether rent is or is not applied exclusively to religious or charitable purposes;
- (2) where any portion of any building or land is exempt from the Urban Immoveable Property tax by reason of its being exclusively occupied for public worship or for charitable purposes, such portion shall be deemed to be a separate property.

- 24. (1) The Urban Immoveable Property tax shall be levied and Authorities competent to levy and
 - (a) in the areas within the limits of a municipality to which this collect Urban Immoveable Property tax
 - (b) in the area of the Cantonment of Ahmedabad, by the Collector and the of Ahmedabad.

Provided that if in any area within the limits of a municipality no property tax is levied by the municipality concerned, the Urban Immoveable Property tax shall be levied and collected in such manner as may be prescribed.

- 25. A Municipality required to levy and collect the Urban Municipality Immoveable Property tax under this Part shall be entitled for its entitled to rebate for cost of collection to such rebate as may be prescribed.

 Urban Municipality Translated to rebate for cost of collection.
- 26. (I) The Urban Immoveable Property tax shall be leviable Primary primarily on the actual occupier of the buildings or lands upon which responsibility for the said tax is assessed, if he is the owner of the buildings or lands, or Urban holds them on a building or other lease granted by or on behalf of Immoveable Government, or on a building or other lease from any person or local Property tax. authority.
- (2) In other cases the Urban Immoveable Property tax shall be primarily leviable as follows:—
 - (a) if the property is let, upon the lessor;
 - (b) if the property is sublet, upon the superior lessor;
 - (c) if the property is unlet, upon the person in whom the right to let vests.
- (3) On failure to recover any sum due on account of the Urban Immoveable Property tax from the person primarily liable, there may be recovered from the occupier of any part of the buildings or lands in respect of which the tax is due such portion of the sum due as bears to the whole amount due the same ratio which the rent annually payable by such occupier bears to the aggregate amount of the annual letting value thereof.
- (4) An occupier who makes any payment for which he is not primarily liable under this section shall be entitled to be reimbursed by the person primarily liable for the payment and may deduct the amount so paid

from the amount of any rent from time to time becoming due from him to such person.

Remission and refund.

- 27. (1) Where any building or land assessed to Urban Immoveable Property tax—
 - (a) has been vacant and unproductive of rent for any period of not less than sixty consecutive days;
 - (b) consists of separate tenements, one or more of which has or have been vacant and unproductive of rent for any such period as aforesaid:
 - (c) is wholly or in great part demolished or destroyed by fire or otherwise deprived of value, the municipality concerned or the Collector of Ahmedabad, as the case may be, shall remit or refund such portion of the Urban Immoveable Property tax as may be prescribed.

Explanation.—For the purpose of this section a building or land shall be deemed to be productive of rent if let to a lessee who has a continuing right of occupation thereof, whether it is actually occupied by such lessee or not.

(2) The burden of proving facts entitling any person to claim relief under this section shall be upon him.

Default of municipality.

- 28. (1) If any municipality makes default in the levy, collection or payment to the Provincial Government of any sum due in respect of the Urban Immoveable Property tax, the Provincial Government may, after holding such inquiry as it thinks fit, fix a period for the levy, collection or payment of such sum.
- (2) If the levy, collection or payment of such amount is not made within the period so fixed, the Provincial Government may direct any bank in which any moneys of the municipality are deposited or the person in charge of the Government treasury or of any other place of security in which the moneys of the municipality are deposited to pay such sum from such moneys as may be standing to the credit of the municipality in such bank or as may be in the hands of such person or as may from time to time be received from or on behalf of the municipality by way of deposit by such bank or person; and such bank or person shall be bound to obey such order.
- (3) Every payment made pursuant to an order under sub-section (2) shall be a sufficient discharge to such bank or person from all liability to the municipality in respect of any sum so paid by it or him out of the moneys of the municipality so deposited with such bank or person.

En les. 29. (1) The Provincial Government may make rules for carrying out the purposes of this Part.

- (2) Without prejudice to the generality of the foregoing provision such rules shall provide for the following matters:—
 - (a) the manner in which the Urban Immoveable Property tax shall be levied and collected in any municipal area in which no property tax is levied;
 - (b) the amount of rebate to which a municipality or other authority would be entitled under section 25 for the cost of collection of the Urban Immoveable Property tax;
 - (c) the time at and the manner in which the amount of the Urban Immoveable Property tax collected shall be paid to the Provincial Government;
 - (d) the portion of the Urban Immoveable Property tax which shall be refunded or remitted, and the manner in which, and the conditions subject to which, such remission or refund shall be granted;
 - (e) such other matters which in the opinion of the Provincial Government are required to be prescribed by rules.
- (3) The rules made under this section shall be subject to the condition of previous publication.'

BOMBAY ACT No. V OF 1939.1

[THE BOMBAY SALES TAX ACT, 1939.]

[14th April 1939.]

An Act to provide for the levy of a tax on sales of certain goods.

WHEREAS it is expedient to provide for the levy of a tax on sales of certain goods; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Sales Tax Act, 1939.
- Short extent commment-
- (2) It shall extend to the whole of the Province of Bombay.
- (3) This section shall come into force at once. The Provincial Government may, by notification in the Official Gazette, direct that all or any of the remaining provisions of this Act in respect of all or any of the items in the Schedule shall come into force on such date as may be specified in the notification.
- 2. In this Act unless there is anything repugnant in the subject or Definit context.—
 - (1) "Consumer" means a person who purchases goods for the purpose of consumption and not for resale.
 - (2) "Importer" means a person who carries on the trade of importing goods into the Province.
 - (3) "Licence" means a licence granted or renewed under this Act.
 - (4) "Prescribed" means prescribed by rules made under this Act.
 - (5) "Retail Sale" means a sale of goods for the purpose of consumption by the person by whom or on whose behalf such goods are or may be purchased.
 - (6) "Retail trader" means a trader who sells goods for the purpose of consumption by the person by whom or on whose behalf they are or may be purchased.
 - (7) "Schedule" means the schedule appended to this Act.

- (8) "Trader" means a person who carries on any business of buying or selling for the purpose of gain or profit and includes—
 - (a) a manufacturer,
 - (b) a producer, or
 - (c) an importer,

who carries on such business, and

(d) a broker or commission agent working in connection with such business

The words "trade "or "trading "shall be construed accordingly.

(9) "Wholesale trader" means a person who carries on trade for the purpose of resale of any goods and not for consumption.

Levy of tax.

3. (1) There shall be levied and collected a tax on the sale of any kind of goods specified in the Schedule, at such stage between their manufacture, production or import, as the case may be, and their consumption, as may be prescribed:

Provided that such tax shall not be levied on the sale of any goods at more than one such stage:

Provided further that such tax shall not be levied on the sale of any goods by a manufacturer, producer or importer except on retail sale of such goods.

- (2) Subject to the provisions of section 4, the tax under sub-section (1) shall be levied by the Collector at the prescribed time, in the prescribed manner and at a prescribed rate not exceeding 64 per cent. on the value of the sale of such goods.
- (3) If any tax payable under sub-section (1) is not paid within the prescribed time, the Collector may, in lieu thereof, recover any sum not exceeding double the amount of the tax so unpaid or any smaller sum above the amount of the tax which the Collector may think it reasonable to recover.

Explanation.—For the purposes of this section, a sale of goods by any trader who has purchased them from another trader shall be deemed to be a sale of such goods although such goods may have been subjected to any manufacturing or other process before such sale provided such process does not in substance alter the form of such goods.

Assessment of the tax.

- 4. (1) In cases where accounts are kept and maintained and statements submitted in the manner and at the period prescribed under section 10, the tax leviable under section 3 shall be assessed by the Collector on the value of sales as disclessed in such accounts and statements.
- (2) In cases where no such accounts are kept and maintained or where no such statements are submitted, or where such accounts or statements are in the opinion of the Collector false or incorrect, the Collector shall make the assessment to the best of his judgment.

- 5. Where any goods, on the sale of which to a wholesale trader the Government tax is levied and collected under section 3, are exported outside the may grant refund of Province, the wholesale trader concerned shall, subject to such conditions tax in ceras may be prescribed and upon an application made in this behalf, be tain cases. entitled to a refund of the tax levied and collected in respect of such goods.
- 6. (1) Every trader carrying on business in the sale or purchase of Traders to any kind of goods specified in the Schedule, shall, within two months of take out licence. the date on which this section comes into force or of his starting business in respect of such goods after such date obtain a licence from the Collector for carrying on such trade.

- (2) Where a trader has more than one shop or place of business whether in the same town or village or in different towns or villages, he shall obtain a separate licence in respect of each shop or place of business.
- (3) Notwithstanding anything contained in this section, a hawker shall be liable to obtain one licence, whatever may be the area of his operation.
- (4) Every trader shall get his licence renewed before the date on which it expires.
- 7. (1) Every licence shall be in such form and subject to such condi-Expuy and tions as may be prescribed and shall expire on the last day of the year for renewal of licence. which it was granted, but may be renewed from year to year:

Provided that in case of any licence given to a manufacturer, producer or importer the conditions of such licence may provide that the holder of the licence shall not sell the kind of goods for trading in which the licence is given, except to a wholesale trader or a consumer.

(2) The Collector may impose for the grant or renewal of every licence such fee not exceeding Rs. 2 as may be prescribed.

Explanation.—In this section "year" means the financial year.

If any trader liable under section 10 to keep accounts or to submit statements fails to keep or submit the same in the manner and at the period prescribed, he shall on conviction, be punishable with fine which may extend to Rs. 500 and in the case of a continuing failure with an additional fine which may extend to Rs. 50 for every day during which such failure continues after conviction for the first such failure.

Power of chicers to enter places where any trade is carried on, etc.

- 12. Any officer empowered by the Provincial Government in this behalf may, for the purposes of this Act at all reasonable times,—
 - (a) require any trader carrying on business in the sale or purchase of any kind of goods specified in the Schedule to produce before him accounts or other documents or to furnish any other information; or
 - (b) inspect the accounts of any such trader.

Suspension or cancellation of Loence.

- 13. Subject to such conditions as may be prescribed, the Collector may suspend or cancel a licence given under section 6—
 - (a) if any tax payable under section 3 is not duly paid by the holder of such licence; or
 - (b) if there is any breach of any of the conditions subject to which the licence is granted; or
 - (c) if the holder of such licence contravenes any of the provisions of section 10.

Power of entry and search.

14. Any officer specially empowered by the Provincial Government in this behalf may enter and search, at any time, by day or by night any building, vessel, vehicle or place in which he has reason to believe that any kind of goods specified in the Schedule is kept for the purposes of sale.

Searches how made. 15. All searches made under section 14 shall be made in accordance with the provisions of the Code of Criminal Procedure, 1898.

Power of investigation. 16. (I) Every officer not below such rank as may be prescribed shall, within the area for which he is appointed, have power to investigate all offences punishable under this Act.

(2) Every such officer shall, in the conduct of such investigation exercise the powers conferred by the Code of Criminal Procedure, 1898, upon V of an officer in charge of a police station for the investigation of a cognizable 1891 offence.

Offences to be hallable.

- 17. All offences punishable under this Act shall be bailable.
- Power to compound offences.
- 18. (1) The Collector may accept from any person who has committed an offence punishable under this Act or the rules thereunder, by way of composition of such offence, a sum of money not exceeding five

hundred rupees or a sum double the amount of the tax payable under section 3 in respect of any sales conducted by such person, whichever is greater.

- (2) On the payment of such sum of money to the Collector the accused person shall be discharged, and no further proceedings shall be taken against such person in respect of such offence.
- 19. No Magistrate, below the rank of a Presidency Magistrate Jurisdiction or a Magistrate of the Second Class, shall try an offence under this Act.
- 20. Subject to the general or special orders of the Provincial Govern-The Collector ment the Collector may delegate any of the powers conferred upon him to delegate by or under this Act to any officer not below the rank of a Mamlatdar or Mahalkari.

- (2) The owner of goods shall, if so required by an officer conducting the search, take the goods to a place appointed by the Commissioner for the purpose of examination and deposit.

IX-B.—Prohibition of certain advertisements.

Prohibition of certain advertisements.

- 42-E. (1) No person shall print or publish in any newspaper, book, leaflet, booklet or any other single or periodical publication or otherwise display or distribute any advertisement or other matter—
 - (a) which commends, solicits the use of or offers any intoxicant;
 - (b) which is calculated to encourage or incite any individual or class of individuals or the public generally to commit an offence under this Act, or to commit a breach of or to evade the provisions of any rule or order made thereunder, or the conditions of any licence, permit or pass obtained thereunder.
- (2) Save as otherwise provided in sub-section (3) nothing in this section shall apply to—
 - (a) catalogues or price lists which may be generally or specially approved by the Commissioner in this behalf;
 - (b) any advertisement or other matter contained in any newspaper, book, leaflet, booklet or other publication printed and published outside the Province of Bombay;
 - (c) any advertisement or other matter contained in any newspaper printed and published in the Province of Bombay before such date as the Provincial Government may by notification in the Official Gazette specify; and
 - (d) any other advertisement or matter which the Provincial Government may by notification in the Official Gazette generally or specially exempt from the operation of this section.
- (3) Notwithstanding anything contained in sub-section (2), the Provincial Government may, by notification in the Official Gazette, prohibit within the Province of Bombay the circulation, distribution or sale of any newspaper, book, leaflet, booklet or other publication printed and published outside the Province which contains any advertisement or matter—
 - (a) which commends, solicits the use of or offers any intoxicant; or
 - (b) which is calculated to encourage or in the any individual or class of individuals or the public generally to commit an offence under this Act, or to commit a breach of or to evade the provisions of any rule or

order made thereunder, or the conditions of any licence, permit or pass obtained thereunder.

(4) Where any newspaper, book, leaflet, booklet or other publication wherever printed or published appears to the Provincial Government to contain any advertisement or matter commending, soliciting the use of, or offering any intoxicant, the Provincial Government may, by notification in the Official Gazette, declare every copy of the issue of the newspaper, and every copy of such book, leaflet, booklet or other publication to be forfeited to His Majesty, and thereupon any police officer may seize the same wherever found in the Province of Bombay, and any Magistrate may by warrant authorise any police officer not below the rank of Sub-Inspector to enter upon and search for the same in any premises where any copy of such issue or any such book, leaflet booklet, or other publication may be or may be reasonably suspected to be. Every warrant issued under this section shall be executed in the manner provided for the execution of search warrants under the Code of Criminal Procedure, 1898."

Whoever prints, publishes, displays or distributes any Penalty for advertisement or other matter which commends, solicits the use of or publishing, offers any intoxicant, or which is calculated to encourage or incite any etc., adverindividual or class of individuals or the public generally to commit a breach of or to evade the provisions of any rule or order made thereunder, or the conditions of any licence, permit or pass obtained thereunder in contravention of the provisions of sub-section (1) or circulates, distributes or sells any newspaper, book, leaflet, booklet or other publication, in contravention of the provisions of sub-section (3) of section 42E shall, on conviction, be punishable with fine which may extend to Rs. 1,000."

[THE BOMBAY GAS SUPPLY ACT, 1939.]

[17th May 1939.]

An Act to provide for the regulation of the prices for supply of gas in the Province of Bombay.

WHEREAS it is expedient to provide for the regulation of prices for the supply of gas in the Province of Bombay and for certain other matters; It, is hereby enacted as follows:—

1. (1) This Act may be called the Bombay Gas Supply Act, 1939.

Short title, extent and commencement.

- (2) It shall extend to the whole of the Province of Bombay.
- (3) It shall come into force on such date as the Provincial Government may by notification in the Official Gazette appoint.
- 2. In this Act unless there is anything repugnant in the subject or Definitions. context,—

Bow. V of 1863.

- (1) "company" means the Bombay Gas Company, Limited, governed by the Gas Companies Act. 1863, or any other person to whom the provisions of this Act may, for the time being, be extended under section 10 and includes the successors and assigns of such company or person;
- (2) "consumer" means any person who is supplied with gas by the company;
 - (3) "prescribed" means prescribed by rules made under this Act.
- 3. (1) The company shall prepare and render to the Provincial Company to Government or to such officer as the Provincial Government may prepare and appoint in this behalf, on or before the prescribed date in each year, a accounts statement of accounts of its undertaking for such period, made up to such annually. date, in such form and containing such particulars, as may be prescribed in this behalf.
- (2) The company shall keep copies of such statement of accounts at its office and sell the same to any applicant at a price not exceeding that which may be prescribed.

Audit of

- 4. (1) The Provincial Government may direct that the statement of accounts of the undertaking shall, before being rendered under section 3, be examined and audited by such person as the Provincial Government may appoint or approve in this behalf.
- (2) The remuneration of the auditor shall be such as the Provincial Government may direct and his remuneration and all expenses incurred by him in or about the execution of his duties, to such an amount as the Provincial Government shall approve, shall be paid by the company on demand.
- (3) The company shall afford to the auditor, his clerks and assistants, access to all such books and documents relating to the undertaking as are necessary for the purposes of the audit, and shall, when required, furnish him and them all vouchers and information requisite for that purpose, and afford to him and them all facilities for the proper execution of his and their duty.
- (4) The audit shall be made and conducted in such manner as the Provincial Government may direct.
- (5) If the company fails to pay the amount of the auditor's remuneration and the expenses incurred by him within the time fixed by the Provincial Government in this behalf, the same may be recovered from it as an arrear of land revenue.

Advisory Committee.

- 5. (1) The Provincial Government may by notification in the Official Gazette constitute an Advisory Committee.
- (2) The Advisory Committee shall consist of a Chairman and not less than two other members.
 - (3) The Provincial Government may by general or special order,-
 - (i) define the powers, and duties and regulate the procedure of the committee,
 - (ii) determine the tenure of office of the members of the committee, and
 - (iii) give directions as to the payment of fees to, and the travelling expenses incurred by, any of the members of the committee in the execution of his duty.

Rules to prescribe limits of prices. 6. The Provincial Government may, from time to time in accordance with the recommendations of the Advisory Committee, make rules prescribing the limits of prices which the company may charge for the supply of gas to any consumer or class of consumers, in the whole of the province or in any specified area.

Price in excess of limit not to be charged or recovered. 7. Notwithstanding any contract or law, the company shall not, at any time, charge or recover from any consumer price for supply of gas to him in excess of the limit prescribed in this behalf by rules made under section 6.

- 8. Whoever contravenes any of the provisions of this Act shall on Penalty. conviction be liable to a fine which may extend to one thousand rupees.
- 9. Where anything is required to be done by the company by or The principal under any provision of this Act, the principal officer of the company in the for shall be bound to do the same and shall be personally liable if default is default made by the company.

Explanation.—For the purposes of this section, the principal officer of the company shall mean the director, secretary, treasurer, manager or agent of the company.

- 10. The Provincial Government may, by notification in the Official Extension of Gazette, extend the provisions of this Act to any person who manu-persons factures or supplies gas in any area within the Province of manufacturing or supplying
- 11. (1) The Provincial Government may, by notification in the Rules. Official Gazette, make rules for carrying out the purposes of this Act.
- (2) In particular and without prejudice to the generality of the foregoing provision such rules may be made for all or any of the following matters:—
 - (a) the date on or before which the statement of accounts of its undertaking shall be rendered by the company to the Provincial Government under sub-section (1) of section 3; the date up to which such statement shall be made and the particulars which it shall contain; and
 - (b) the maximum price at which copies of statement of accounts shall be sold, under sub-section (2) of section 3.

BOMBAY ACT No. X OF 1939.1

[THE BOMBAY LIFTS ACT, 1939.]

[17th May 1939.]

An Act to provide for the regulation of the construction, maintenance and safe working of certain classes of lifts and all machinery and apparatus pertaining thereto in the Province of Bombay.

WHEREAS it is expedient to provide for the regulation of the construction, maintenance and safe working of certain classes of lifts and all machinery and apparatus pertaining thereto in the Province of Bombay in manner hereinafter appearing; It is hereby enacted as follows:—

1. This Act may be called the Bombay Lifts Act, 1939.

Short title.

- 2. (1) This Act shall extend to the whole of the Province of Bombay. Extent and
- (2) It shall come into force on such date as the Provincial Government ment. may, by notification in the Official Gazette, appoint.
- 3. In this Act, unless there is anything repugnant in the subject or Definitions, context,—
 - (a) "Inspector of Lifts" means an officer appointed as such by the Provincial Government.
 - (b) "License" means a license granted under section $\tilde{\mathbf{a}}$.
 - (c) "Lift" means a hoisting mechanism equipped with a cage which moves in a substantially vertical direction, is worked by power and is designed or is actually used to carry passengers.

Explanation.—For the purposes of this clause a lift operator shall not be deemed to be a passenger.

- (d) "Lift cage" means the car or cage of a lift used for the conveyance of passengers.
- (e) "Lift installation" includes the lift cage, the lift way, the lift way enclosure, and the operating mechanism of the lift and all ropes, cables, wires and plant directly connected with the operation of the lift.

- (f) "Lift way" means the shaft in which the lift cage travels.
- (g) "Lift way enclosure" includes any permanent substantial structure surrounding or enclosing the lift way.
- (h) "Power" means any form of energy which is not generated by human or animal agency.
 - (i) "Prescribed" means prescribed by rules.
 - (j) "Rules" means rules made under section 12.

Permission to erect a lift.

- 4. Every owner of a place intending to install a lift in such place after the commencement of this Act, shall make an application to such officer as the Provincial Government may authorize in this behalf for permission to erect such lift. Such application shall be in writing and in such form as may be prescribed. Such application shall specify—
 - (1) the type of the lift.
 - (2) the rated maximum speed of the lift,
 - (3) the maker's or designer's rated capacity in weight,
 - (4) the maximum number of passengers in addition to the lift operator which the lift can carry,
 - (5) the total weight of the lift cage carrying the maximum load,
 - (6) the weight of the counterweight,
 - (7) the number, description, weight and size of the supporting cables.
 - (8) the depth of the pit from the lowest part of the cage when at the lowest floor,
 - (9) such details of the construction of the overhead arrangement with the weight and sizes of the beams as may be prescribed, and
 - (10) such other particulars as may be prescribed.

On receipt of such application the officer authorised under this section shall, after making such enquiry and requiring the applicant to furnish such information as may be necessary, forward the application with his remarks to the Provincial Government. The Provincial Government may thereupon either grant or refuse the permission. Such permission shall be valid only for a period of six months from the date on which it is granted.

Licence to use a lift.

- 5. (1) Every owner of a place who is permitted to install a lift under section 4, shall, within one month after the completion of the erection of such lift deliver or send or cause to be delivered or sent to such Officer as the Provincial Government may authorise in this behalf notice in writing of such completion and shall make an application to him for a licence for working the lift.
- (2) An application for a licence made under sub-section (1) shall be in such form as may be prescribed.

- (3) On receipt of such application such officer as may be authorised in this behalf by the Provincial Government after making such enquiry as may be necessary forward the application with his remarks to the Provincial Government. The Provincial Government may, thereupon, either grant or refuse the licence.
 - (4) A fee of Rs. 20 shall be paid along with such application.
- 6. (1) Notwithstanding anything contained in sections 4 and 5 every Applications owner of a place in which a lift has been installed before the date of the case of existcommencement of this Act, shall within two months from such date ing lifts. apply for a licence for the working of such lift.
- (2) The provisions of sub-sections (2) to (4) of section 5 shall, so far as may be, apply to such application.
- 7. Subject to such rules as may be made in this behalf no lift shall be Lift not to worked except under and in conformity with the terms of the licence be operated without a granted in respect of the same: licence.

Provided that nothing in this section shall apply to a lift installed at the date of the commencement of this Act, for a period of two months from such date or if an application for license is made within that period in accordance with the provisions of section 6, until such application is finally disposed of under the said section.

8. (1) An officer authorized in this behalf by the Provincial Govern-Right to ment may at any time after giving reasonable notice to the occupant enter any building for enter upon any building in which a lift is installed or is being installed or inspection of in connection with which an application for a license has been received, lifts and lift for the purpose of inspecting the lift or the lift installation or the site installation. thereof.

(1) Where any accident occurs in the operation of any lift Report of resulting in injury to any person the owner of the building in which the accidents. lift is working or if such owner has appointed an agent and has communicated his name to the Inspector of Lifts under sub-section (3), such agent shall as soon as may be after such accident give notice with full details of the accident to the Inspector of Lifts and also in the City of Bombay to the Commissioner of Police and elsewhere to the District Magistrate and the working of such lift shall not be resumed except with

the written permission of the officer authorised in this behalf by the Provincial Government.

- (2) For the purposes of sub-section (1), the owner of every building in which a lift has been installed may and if such owner does not reside in such building, shall appoint an agent who shall be a resident in the town or village in which the building is situate to give notice of any accident occurring in the operation of the lift.
- (3) The name of every agent appointed under sub-section (2) shall be communicated to the Inspector of Lifts.

Delegation of the powers of Government. 10. The Provincial Government may delegate any of the powers conferred on it by or under this Act to such officer as it thinks fit.

Inspection of lifts.

11. Every lift shall be inspected at least once in six months by an officer authorised in this behalf by the Provincial Government. An annual fee of Rs. 15 shall be charged for such inspection and such fee shall include the charges for the inspection of the motor.

Power to make rules,

- 12. (1) The Provincial Government may, from time to time by notification in the Official Gazette, make rules to carry out the purposes of this Act.
- (2) In particular and without prejudice to the generality of the foregoing provision, such rules may be made for the following matters, namely:—
 - (a) specifications for lifts,
 - (b) the manner in which erection plans of lifts shall be submitted,
 - (c) the manner in which the lifts may be tested,
 - (d) the form of application for the erection of a lift or a licence for working the same,
 - (e) the terms and conditions subject to which and the form in which the licenses may be granted for the working of a lift under section 7,
 - (f) the manner in which and the terms subject to which the lifts shall be worked under section 7,
 - (g) the manner in which notice of accidents shall be given and the form of such notice, and
 - (h) the form of notice to be given under section 8.

Penalty.

13. Whoever contravenes any of the provisions of this Act, rules or conditions of a license or a direction given by the Inspector of Lifts under this Act or the rules shall, on conviction, be punishable with a fine which may extend to five hundred rupees and, in the case of a continuing contravention with an additional fine which may extend to fifty rupees for every day during which such contravention continues after conviction for the first such contravention.

Savings.

14. Nothing contained in this Act shall affect the provisions of the IX of Indian Electricity Act, 1910, or any rules made thereunder.

BOMBAY ACT No. XI OF 1939.1

[THE BOMBAY PRIZE COMPETITION TAX ACT, 1939.]

[26th May 1939.]

An Act to regulate and levy a tax on prize competitions in the Province of Bombay.

WHEREAS it is expedient to regulate and levy a tax on prize Competitions in the Province of Bombay; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Prize Competition Tax Short title Act, 1939.
 - (2) It extends to the whole of the Province of Bombay.
- 2. In this Act, unless there is anything repugnant in the subject Definitions. or context,—
 - (1) "Coupon" in relation to a prize competition includes any document in which the solution to the competition is submitted by any person.
 - (2) "Prize competition" includes—
 - (a) crossword prize competition, missing words competition, picture prize competition, number prize competition, or any other competition, for which the solution is prepared beforehand by the promoters of the competition or for which the solution is determined by lot;
 - (b) any competition in which prizes are offered for forecarts of the results either of a future event or of a past event the result of which is not yet ascertained or not yet generally known; an!
 - (c) any other competition success in which does rat depend to a substantial degree upon the exercise of skill,

but does not include a prize competition contained in a newspaper or periodical printed and published outside the Province of Bombay.

(3) "Promoter" means the person having the control or directing the conduct of a prize competition and in the case of a prize competition

conducted by or through a newspaper or periodical includes the publisher of such newspaper or periodical and the expressions "promote" and "promoting" shall be construed accordingly.

- (4) "Quarter" means a period of three months beginning from 1st January to 31st March, from 1st April to 30th June, from 1st July to 30th September and from 1st October to 31st December in each year.
 - (5) "Year" means the financial year.

Levy of tax on prize competitions.

- 3. (1) There shall be levied in respect of every prize competition a tax at the rate of 12½ per cent. of the total sum received in respect of such competition. The tax shall be collected from the promoter of such competition.
- (2) The amount of tax to be levied in respect of a prize competition under sub-section (1) shall be calculated by the Collector on the total sum received in respect of the prize competition as disclosed in the accounts maintained and statements submitted by him under section 7.
- (3) In cases where no such accounts are maintained or where no such statements are submitted or where such accounts or statements are in the opinion of the Collector false or incorrect the Collector shall make the calculation to the best of his judgment.
- (1) The tax leviable under sub-section (1) shall be paid within 30 days of the end of each quarter.
- (5) If any tax payable under sub-section (1) is in arrear the Collector may in lieu thereof, recover any sum not exceeding double the amount of the tax so unpaid or any smaller sum above the amount of the tax which the Collector may think it reasonable to recover.
- (6) Notwithstanding anything contained in sub-section (1), the Provincial Government may, by notification in the Official Gazette, direct that the tax to be levied in respect of a prize competition shall be at such rate not exceeding 25 per cent. of the total sum received in respect of such competition as may be specified in the notification.

Licence for promotion of of such corprise competitions. Collector:

4. No prize competition shall be conducted unless a licence in respect of such competition has been obtained by the promoter thereof from the Collector:

Provided that a licence may be granted for more than one such competition conducted by the same person.

Expiry and renowal of license.

- 5. (1) Every licence shall be in such form and subject to such conditions as may be prescribed and shall expire on the last day of the year for which it was granted and may be renewed from year to year.
- (2) The Collector may impose for the grant or renewal of every such licence such fee not exceeding Rs. 10 as may be prescribed.

- 6. Whoever contravenes the provisions of section 4 shall, on Penalty for conviction, be punishable with imprisonment of either description which contravention of section 4. may extend to 3 months or with fine or with both.
- 7. Every person promoting a prize competition of any kind shall keep Promoters of and maintain accounts relating to such competitions and shall submit prize competito the Collector statements in such form and at such period as may be and maintain prescribed.
- 8. If any promoter of a prize competition liable under section 7 to penalty for keep accounts or to submit statements fails to keep the accounts or to failure to submit the statements in the manner and at the period prescribed, accounts, he shall, on conviction, be punishable with fine which may extend to Rs. 500.
- 9. The Collector may, for the purposes of this Act, at all reasonable Power of Collector to require
 - (i) require any promoter of prize competitions to produce before production of him accounts or other documents or to furnish any other information; accounts or to inspect accounts.
 - (ii) inspect the accounts of any such promoter.
- 10. The Collector may suspend or cancel a licence given under Suspension or section 4;

 cancellation of licence.
 - (1) if any tax payable under section 3 is not duly paid by the promoter of the prize competition; or
 - (2) if there is any breach of any of the conditions subject to which the licence is granted; or
 - (3) if the holder of such licence contravenes any of the provisions of section 7; or
 - (4) for any other reason for which the suspension or cancellation of the licence is, in the opinion of the Provincial Government, necessary in the public interest.
- 11. Any officer specially empowered by the Provincial Government Power of in this behalf may enter and search at any time, by day or by night, any entry and building, vessel, vehicle or place in which he has reason to believe that search, any operation in connection with a prize competition is carried on by a promoter or on his behalf.
- 12. All searches made under section 11 shall be made in accordance Searches how with the provisions of the Code of Criminal Procedure, 1898.

 - 13. (1) Every officer not below the rank of sub-inspector of Power of police shall have power to investigate all offences punishable under investigation. this Act.
 - (2) Every such officer shall, in the conduct of such investigation, exercise the powers (except the power to arrest, without warrant)

conferred by the Code of Criminal Procedure, 1898, upon an officer in V of charge of a police station for the investigation of a cognizable 1898, offence.

Offences to be bailable.

14. All offences punishable under this Act shall be bailable.

Jurisdiction to try offences. 15. No Magistrate, below the rank of a Presidency Magistrate or a Magistrate of the Second Class, shall try an offence under this Act.

Government may authorise certain officer to perform functions of Collector.

16. The Provincial Government may, by general or special order, authorise any officer to perform the functions to be performed by the Collector under any of the provisions of this Act.

Officers to be public servants. 17. All officers acting under this Act shall be deemed to be public servants within the meaning of section 21 of the Indian Penal of 1860.

Protection of persons acting in good faith and limitation of suits and prosecutions.

- 18. (1) No suit, prosecution or other legal proceedings shall be instituted against any officer of the Crown for anything which is in good faith done or intended to be done under this Act or the rules made thereunder.
- (2) No suit shall be instituted against the Province and no prosecution or suit shall be instituted against any officer of the Crown in respect of anything done or intended to be done, under this Act, unless the suit or prosecution has been instituted within six months from the date of the act complained of.

License fee and other dues to be recoverable as arrears of land revenue.

19. All sums payable as taxes or fees under sections 3 and 5 shall be recoverable as arrears of land revenue.

Appeal and revision.

- 20. (1) Any person aggrieved by any order under this Act may appeal to the Commissioner or to such officer as the Provincial Covernment may appoint in this behalf from any order passed by the Collector under this Act.
- (2) Every order passed in appeal under this section shall, subject to the powers of revision conferred by sub-section (3), be final.
- (3) The Provincial Government may, at any time, call for and examine the record of any order of, or the proceedings recorded by, any officer or person for the purpose of satisfying itself as to the legality or propriety of such order passed by, or as to the regularity of such proceedings of, such officer or person and may pass such order in reference thereto as it thinks fit.

Exemption.

21. The Provincial Government may exempt from all or any of the provisions of this Act any prize competition the net proceeds of which are to be devoted to schargable purpose.

- 22. (1) The Provincial Government may, by notification in the Rules. Official Gazette make rules for the purposes of carrying out the provisions of this Act.
- (2) In particular and without prejudice to the generality of the foregoing provision the Provincial Government may make rules for the following matters:—
 - (i) the form of the licence and the conditions subject to which, it will be granted and the fees which will be imposed for its grant and renewal under section 5;
 - (ii) the manner in which the accounts shall be kept and maintained and the form in which, and the period at which, the statements of accounts are to be submitted under section 7.
- (3) Any rule made under this section may provide that any person contravening any such rule shall, on conviction, be liable to fine which may extend to Rs. 50.
- (4) Rules made under this section shall be subject to the condition of previous publication.

WHEREAS it is expedient to provide for the constitution of a Revenue Tribunal for the Province of Bombay by an Act of the Provincial Legislature; It is hereby enacted as follows:—

CHAPTER I.

PRELIMINARY.

- 1. (1) This Act may be called the Bombay Revenue Tribunal Act, Shart title, extent and commencement.
 - (2) It extends to the whole of the Province of Bombay.
- (3) It shall come into force on such date as the Provincial Government may, by notification in the Official Gazette, appoint.

 - (1) "Commissioner" includes a Commissioner appointed as such under the Bombay Abkari Act, 1878, for the purposes of that Act.
 - (2) "Prescribed" means prescribed by rules made under this Act.

CHAPTER II.

CONSTITUTION, POWERS AND FUNCTIONS OF THE BOMBAY REVENUE TRIBUNAL.

3. (1) The Provincial Government shall constitute a tribunal to be Constitution called the Bombay Revenue Tribunal. The Tribunal shall consist of of Tribunal such number of members, possessing such qualifications, as may be prescribed.

(2) Any vacancy in the membership of the Tribunal shall be filled up in the manner prescribed.

Powers and functions of

- 4. (1) The Tribunal shall exercise such jurisdiction to entertain the Tribunal, appeals and revise decisions in revenue cases as was vested in the Provincial Government immediately before the first day of April 1937 under any law for the time being in force.
 - (2) In particular and without prejudice to the generality of the foregoing provision the Tribunal shall have jurisdiction to entertain appeals and revise decisions-
 - (a) in all revenue cases, arising under the provisions of the enactments specified in the Schedule in which such jurisdiction was vested in the Provincial Government immediately before the first day of April 1937, and
 - (b) in all cases specified in section 9.
 - (3) Save as expressly provided in any enactment for the time being in force, the Provincial Government may, by notification in the Official Gazette, direct by general or special order that the Tribunal shall also have jurisdiction to entertain and decide appeals and applications for revision in any case in which the Provincial Government may have jurisdiction to entertain and decide such appeals and applications. The Provincial Government may, at any time, by like notification cancel any direction issued by it under this sub-section.

The Tribunal to exercise all powers which Provincial Covernment could have exercised.

5. In the exercise of the jurisdiction conferred upon it under section 4 in any case, the Tribunal shall have and may exercise all the powers which the Provincial Government had or could have exercised in such case.

No appeal to lie.

6. No appeal shall lie against any order passed by the Tribunal in the exercise of its powers of appeal or revision under section 4.

Review of the orders of the Tribunal.

7. (1) The Tribunal may, either on its own motion or on the application of any party interested, review its own decision or order in any case and pass in reference thereto such order as it thinks fit:

Provided that no such application made by any party shall be entertained unless the Tribunal is satisfied that there has been a discovery of new and important matter or evidence which after the exercise of due · diligence was not within the knowledge of such party or could not be produced by him at the time when its decision was made or that there has been some mistake or error apparent on the face of the record or for any other sufficient reason:

Provided further that no such decision or order shall be varied or revised unless notice has been given to the parties interested to appear and be heard in support of such order.

(2) An application for review under sub-section (1) by any party shall be made within 90 days from the date of the decision or order of the Tribunal:

Provided that in computing the period of limitation, the provisions of IX of the Indian Limitation Act, 1908, applicable to applications for review of 1908. a judgment or order of a civil court shall, so far as may be, apply to applications for review under this section.

- 8. Notwithstanding anything to the contrary contained in any law Appeal and for the time being in force, no appeal or application for revision shall lie for revision to the Commissioner in any case in which an appeal or application in cases for revision lies to the Tribunal under this Act.

- 9. Such regulations may provide for the disposal of any case or class of cases by one or more of its members.

[THE BOMBAY RENT RESTRICTION ACT, 1939.]

[19th June 1939.]

An Act to restrict the increase of rents of certain premises in consequence of the levy of the urban immoveable property tax in the Province of Bombay.

WHEREAS it is expedient to restrict the increase of rents of certain premises in consequence of the levy of the urban immoveable property tax in the Province of Bombay; It is hereby enacted as follows :--

- 1. (1) This Act may be called the Bombay Rent Restriction Act, 1939. Short title, extent and operation.
- (2) It shall extend to—
 - (i) the City of Bombay,
- (ii) the limits of the municipal boroughs of Thana, Kurla, Bandra and Ahmedabad,
- (iii) the limits of the municipal districts of Ville Parle, Ghatkopar-Kirol and Juhu in the Bombay Suburban District,
- (iv) the notified areas of Malad, Kandivali, Borivali, Chembur and Mulund in the Bombay Suburban District, Bhayandar in the District of Thana and Sabarmati in the District of Ahmedabad, and
 - (v) the limits of the Cantonment of Ahmedabad.
- (3) It shall remain in force up to and inclusive of the 31st day of March 1940:

Provided that the expiration of this Act shall not render recoverable any rent which during the continuance thereof was irrecoverable or affect the right of a tenant to recover any sum which during the continuance thereof was under this Act recoverable by him.

It includes a tenant who sub-lets any premises and every person from time to time deriving title under a landlord.
 - (2) The expression "premises" means—
 - (a) any building or part of a building let separately for any purpose whatever, including any land let therewith, or
- (b) any land let separately for the purpose of being usedprincipally for business or trade,

but does not include a room in a hotel or a boarding house.

- (3) The expression "standard rent" in relation to any premises means—
 - (a) the rent at which the premises were let on the first day of January 1939; or
 - (b) where they were not let on the first day of January 1939 the rent at which they were last let before that date; or
 - (c) where they were or shall be first let after the first day of January 1939, the rent at which they were or shall be first let; or
 - (d) in any of the cases specified in section 15 the rent fixed by the Court.
- (4) The expression "tenant" means any person by whom or on whose account rent is payable for any premises, and includes every person from time to time deriving title under a tenant.

5. (1) Subject to the provisions of this Act, where the rent of any Restriction premises has been or is hereafter during the continuance of this Act, on raising increased above the standard rent, the amount by which the rent payable exceeds the amount which would have been payable had the increase not been made shall, notwithstanding any agreement to the contrary, be irrecoverable:

Provided that nothing in this section shall apply—

- (a) to any rent which accrued due before the first day of January 1939,
- (b) to any periodical increment of rent accruing due under any agreement entered into before the first day of January 1939, or
- (c) to rent payable under any lease entered into before the first day of January 1939, which has not expired on the said date.
- (2) For the purposes of this section the rent shall be deemed to have accrued from day to day.
- 6. Where the landlord has since the first day of January 1939, Increase of incurred, or during the continuance of this Act incurs expenditure on rent on any improvement or structural alterations of any premises, (not including improveexpenditure on decoration or ordinary repairs) an increase of rent at ments a rate not exceeding 6 per centum per annum on the amount so expended excepted. shall not be deemed to be an increase for the purposes of section 5.
- 7. (1) Where, as the result of any alteration in the terms of the Cases where tenancy, the terms on which any premises are held are on the whole rent to be less favourable to the tenant than the previous terms, the rent shall be deemed and not to be deemed to be increased for the purposes of this Act, whether the sum deemed to be increased. payable as rent is increased or not.
- (2) Where, as the result of any alteration of the terms of the tenancy. the terms on which any premises are held are not on the whole less favourable to the tenant than the previous terms, the rent shall not be deemed to be increased for the purposes of this Act, whether the sum payable as rent is increased or not.
- 8. Where a landlord pays any municipal rate, cess, or tax in respect Increase of of any premises, any increase of the rent thereof shall not be deemed rent on to be an increase for the purposes of section 5, if the amount of the account of payment of increase does not exceed any increase in the amount for the time being rates payable by the landlord in respect of such rate, cess or tax over the excepted. amount paid in the period of assessment which included the first day of January 1939.
- 9. Notwithstanding anything contained in section 8 or any law for Rent not to the time being in force, or any contract, no landlord shall recover from be increased his tenant the amount of the urban immoveable property tax or any of payment portion thereof levied under section 22 of the Bombay Finance Act, of urban 1932, in respect of any premises occupied by such tenant by any increase immoveable 232 in the amount of the rent payable or otherwise.

- 10. (1) It shall not be lawful for any person, in consideration of the grant, renewal or continuance of a tenancy of any premises, to require the payment of any fine, premium or any other like sum in addition to the rent.
- (2) Where any such payment has been made after the first day of January 1939, the amount shall be recoverable by the tenant by whom it was made from the landlord, and may without prejudice to any other method of recovery be deducted from any rent payable by him to the landlord.
- (3) Nothing in this section shall apply to any payment under any agreement entered into before the first day of January 1939.

No order for ejectment ordinarily to be made if rent paid at allowable rate. 11. (1) No order for the recovery of possession of any premises shall be made so long as the tenant pays or is ready and willing to pay rent to the full extent allowable by this Act and performs the other conditions of the tenancy:

[THE CITY OF BOMBAY MUNICIPAL (THIRD AMENDMENT) ACT, 1939.]

[1st November 1939.]

An Act to amend the City of Bombay Municipal Act, 1888.2

BOMBAY ACT No. XXII OF 1939.1

[The Bombay Agricultural Produce Markets Act, 1939.]

[2nd November 1939.]

An Act to provide for the better regulation of buying and selling of agricultural produce and the establishment of markets for agricultural produce in the Province of Bombay.

WHEREAS it is expedient to provide for the better regulation of buying and selling of agricultural produce in the Province of Bombay and establishment of markets for agricultural produce; It is hereby enacted as follows:—

CHAPTER I.

PRELIMINARY.

- 1. (1) This Act may be called the Bombay Agricultural Produce Short title Markets Act, 1939.
 - (2) It extends to the whole of the Province of Bombay.
- 2. (1) In this Act unless there is anything repugnant in the subject Definitions. or context,—
 - (i) "Agricultural Produce" includes all produce of agriculture, horticulture and animal husbandry specified in the Schedule;
 - (ii) "Agriculturist" means a person who ordinarily by himself or who by his tenants or hired labour or otherwise is engaged in the production or growth of agricultural produce, but does not include a dealer or broker in agricultural produce although such dealer or broker may also be engaged in the production or growth of agricultural produce;
 - (iii) "Bye-laws" means bye-laws made under section 27;
 - (iv) "Director" means the Director of Rural Development for the Province of Bombay;
 - (v) "Market" means a market established for the purposes of this Act;
 - (vi) "Market Area" means any area declared to be a market area under section 4

- (vii) "Market committee" means a committee established under section 5;
 - (viii) "Municipality" includes a notified area committee;
- (ix) "Prescribed" means prescribed by rules made under section 26;
 - (x) "Rules" means rules made under section 26;
 - (xi) "Schedule" means Schedule to this Act.
- (2) If a question arises whether any person is or is not an agriculturist for the purpose of this Act the decision of the Provincial Government on such question shall be final.

CHAPTER II.

CONSTITUTION OF MARKETS AND MARKET COMMITTEES.

- Notification of intention of exercising control over purchase and sale of agricultural produce in specified area.
- 3. (1) The Provincial Government may, by notification in the Official Gazette, declare its intention of regulating the purchase and sale of such agricultural produce and in such area, as may be specified in the notification. Such notification may also be published in the regional languages of the area and in such other manner as the Provincial Government may deem fit.
- (2) A Notification under sub-section (1) shall state that any objection or suggestion which may be received by the Provincial Government within a period of not less than one month to be specified in the notification shall be considered by the Provincial Government.
- Declaration of market areas.
- 4. (1) After the expiry of the period specified in the notification issued under section 3 and, after considering such objections and suggestions as may be received before such expiry and after holding such inquiry as may be necessary, the Provincial Government may, by notification in the Official Gazette, declare the area specified in the notification under section 3 or any portion thereof to be a market area for the purposes of this Act in respect of all or any of the kinds of agricultural produce specified in the said notification. A notification under this section may also be published in the regional languages of the area in a newspaper circulated in the said area and may also be published in such other manner as the Provincial Government may deem fit.
- (2) On and after the date of the notification issued under sub-section (1) or such later date as may be specified therein, no local authority notwithstanding anything contained in any law and no other person shall, within the market area or within a distance thereof to be notified in the Official Gazette in this behalf in each case by the Provincial Government, set up, establish, or continue or allow to be set up, established or continued any place for the purchase or sale of any agricultural produce so notified, except under a license granted by the Provincial Government and except in accordance with the provisions of this Act, rules and bye-laws and of the conditions specified in the license.

Explanation.—A local authority or any other person shall not be deemed to set up, establish, or continue or allow to be set up, established or continued a place as a place for the purchase and sale of agricultural produce within the meaning of this section if the seller is himself the producer of the agricultural produce offered for sale at such place or any person employed by such producer to transport the same and the buyer is a person who purchases such produce for his own private use.

- (3) The Provincial Government may, on the report of the Director or the Collector or of the market committee or an officer appointed by the Provincial Government in this behalf and after such inquiry as it deems fit to make, suspend or cancel any license granted under sub-section (2).
- (4) Subject to the provisions of section 3, the Provincial Government may at any time by notification in the Official Gazette exclude from a market area any area or any agricultural produce comprised therein or include in any market area any area or any agricultural produce included in a notification issued under section 3.
- 5. The Provincial Government shall establish a market committee Establish for every market area in respect of the agricultural produce for which ment of the said area is declared to be a market area under section 4. It shall market committees. be the duty of the market committee to enforce the provisions of this Act, the conditions of a license granted under sub-section (2) of section 4 and the rules and bye-laws made under this Act in such market area and within the distance thereof notified under sub-section (2) of section 4 and when so required by the Provincial Government to establish a market therein providing for such facilities as the Provincial Government may from time to time direct, in connection with the purchase and sale of the agricultural produce concerned.

- 6. (1) Every market committee shall be constituted as prescribed Constitution and shall consist of not less than 12 and not more than 15 members, of market committees. Of these-
 - (i) not less than one-third shall be persons elected by such organizations of agriculturists in the area for which it is established, as the Provincial Government may prescribe and where no such organisations exist, by the agriculturists residing in the said area in the manner prescribed:
 - (ii) not less than one-third shall be persons elected by the persons licensed under sub-section (2) of section 4 and by the traders approved by the Market committee in the manner prescribed;
 - (iii) one shall be a person elected-
 - (a) by the councillors of a municipality from among themselves, in case the market area is wholly within the limits of such municipality, or
 - (b) by the members of a district local board from among themselves, in case the market area is wholly within the limits of the said district local board but not of a village panchayat, or

(c) by the members of a village panchayat from among themselves, in case the market area is wholly within the limits of the said village panchayat:

Provided that a person to whom a license has been granted under sub-section (2) of section 4 shall not be eligible for being elected under this clause.

Provided further that if the market area is within the limits of more than one local authority, the member shall be elected by the local authorities concerned in the manner prescribed;

(iv) the remaining members shall be persons nominated by the Provincial Government:

Provided that the Provincial Government may, at any time, reduce the number of nominated members for any market area and increase the number of members elected under clauses (i) and (ii) in equal proportion.

- (2) Notwithstanding anything contained in sub-section (1)—
- (a) On the failure of any organisation, person or authority to elect a member under sub-section (1) within a period of six months from the date of the occurrence of the vacancy, the Provincial Government shall give notice in writing to the organisation, person or authority concerned to elect a member within a month from the date of such notice and on the failure of the organisation, person or authority again to elect a member within the said period, the Provincial Government shall nominate a person on behalf of such organisation, person or authority as a member of the market committee; and
- (b) Subject to the provisions of section 31, when a market committee is constituted for the first time all the members of the market committee shall be persons nominated by the Provincial Government.
- (3) Every member of a market committee elected or nominated when it is first constituted shall hold office for a term of two years and every such member elected or nominated thereafter shall hold office for a term of three years:

Provided that a member elected under clause (iii) of sub-section (1) shall cease to hold office as such member if he ceases to be a member of the electorate by which he was elected or if he is granted a license under sub-section (2) of section 4.

- (4) If at any time a vacancy occurs through the non-acceptance of office by a person elected or nominated or through the death, disqualification or resignation of a member before the expiry of his term of office, the vacancy shall be filled up by the election or nomination, as the case may be, of a person thereto in the manner specified above. Every such person shall hold office so long only as the member in whose place he is elected or nominated would have held it if the vacancy had not occurred.
- (5) Every market committee shall elect one of its members to be its chairman.

CHAPTER III.

INCORPORATION OF MARKET COMMITTEE: ITS POWERS AND DUTIES.

- 7. Every market committee shall be a body corporate by such name Incorporation as the Provincial Government may specify by notification in the Official of market committee. Gazette. It shall have perpetual succession and a common seal, may sue and be sued in its corporate name and shall be competent to acquire and hold, lease, sell or otherwise transfer any property and to contract and to do all other things necessary for the purposes for which it is established.
- 8. The market committee may appoint one or more of its members Appointment to be a sub-committee or to be a joint committee for the conduct of of sub-committees any work or to report on any matter or matters and may delegate to such and jointcommittee or any one or more of its members such of its powers or committees: duties as it may think fit. of powers.
- 9. (1) The market committee may employ such officers and servants Appointas may be necessary for the management of the market and may pay ment and salaries of such officers and servants such salaries as the market committee thinks servants of fit. The market committee shall, in the case of any officer or servant the market committee. of Government whom it employs, pay such pension contribution, gratuity or leave allowance as may be required by the conditions of his service under the Crown for the time being in force.

- (2) The market committee may also, in the case of any of its officers and servants, provide for the payment to them of such leave allowances, pensions or gratuities as it deems proper, and may contribute to any provident fund which may be established for the benefit of such officers and servants.
- (3) The powers conferred by this section on the market committee shall be exercised subject to any rules which may be made in this behalf by the Provincial Government.
- 10. (1) Every contract entered into by the market committee shall Execution of be in writing and shall be signed on behalf of the market committee by contracts. its chairman, and two other members of the committee.
- (2) No contract other than a contract executed as provided in sub-section (1) shall be binding on the market committee.
- 11. The market committee may subject to the provisions of rules Power to and subject to such maxima as may be prescribed levy fees on the levy fees. agricultural produce bought and sold by licensees in the market area.

Certain differences regarding construction of rules, etc., about weights and measures to be decided by market committee.

- 12. (1) Notwithstanding anything contained in the Bombay Weights and Measures Act, 1932, if any difference arises between an inspector Bom. appointed under section 19 of the said Act and any person interested NV of as to the meaning or construction of any rule or regulation or as to the method of verifying, adjusting or stamping any weight or measure or weighing or measuring instrument in any market area such difference may at the request of the person interested or by the inspector of his own accord be referred to the market committee and the decision of the market committee shall, subject to the provisions of sub-section (2), Bom. be final and shall be deemed to have been given under section 25 of the XV of Bombay Weights and Measures Act, 1932.
- (2) An appeal shall lie within the time prescribed from the decision under sub-section (1) to the Provincial Government or such officer as the Provincial Government may appoint in this behalf. The decision of the Provincial Government or such officer shall be final.

: Market - Committee - Fund.

- 13. (1) All monies received by a market committee shall be paid into a fund to be called "the market committee fund" and all expenditure incurred by the market committee under or for the purposes of this Act shall be defrayed out of the said fund. Any surplus remaining with the market committee after such expenditure has been met shall be invested as may be prescribed in this behalf.
- (2) Every market committee shall pay to the Provincial Government the cost of any additional or special staff employed by the Provincial Government in consultation with such market committee for giving effect to the provisions of this Act in the market area for which such market committee is established.
- (3) The Provincial Government shall determine the cost of such additional or special staff and shall, when the staff is employed for the purposes of more than one market committee apportion such cost among the committees concerned in such manner as it thinks fit. The decision of the Provincial Government determining the amount payable by any market committee shall be final.

Purposes for which the fund shall—be expended.

- 14. Subject to the provisions of section 13, the market committee fund shall be expended for the following purposes, namely:—
 - (1) The acquisition of a site or sites for the market;
 - (2) the maintenance and improvement of the market;
- (3) the construction and repair of buildings necessary for the purposes of such market and for the health, convenience and safety of the person using it;
 - (4) the provision and maintenance of standard weights and measures;
- (5) the pay, pensions, leave allowances, gratuities, compensations for injuries resulting from accidents, compassionate allowances and contributions towards leave allowances, pensions or provident fund of the officers and servants employed by it;
 - (6) the expenses of and incidental to elections;

- (7) the payment of interest on the loans that may be raised for the purposes of the market and the provision of sinking fund in respect of such loans;
- (8) the collection and dissemination of information regarding matters relating to crop statistics and marketing in respect of the agricultural produce notified under section 4;
- (9) payments of the cost referred to in sub-sections (2) and (3) of section 13; and
 - (10) propaganda in favour of agricultural improvement.
- 15. (I) A market committee may, with the previous sanction of the Power to Provincial Government, raise money required for carrying out the borrow. purposes for which it is established on the security of any property vested in it and of any fees leviable by it under this Act.
- (2) The market committee may, for the purpose of meeting the initial expenditure on lands, buildings and equipment required for establishing the market, obtain a loan from the Provincial Government.
- (3) The conditions subject to which such money or loan shall raised or obtained and the time within which the same shall be repayable shall be subject to the previous sanction of the Provincial Government.
- 16. When any land is required for the purposes of this Act, the Acquisition Provincial Government may, on the request of the market committee of land for requiring it, proceed to acquire it under the provisions of the Land the market committee. Acquisition Act, 1894, or other law for the time being in force, and, on payment by the market committee of the compensation awarded under that Act or other law, as the case may be, and of all other charges incurred by the Provincial Government on account of the acquisition, the land shall vest in the market committee.

CHAPTER IV.

TRADE ALLOWANCES.

17. No person shall make or recover any trade allowance, other than No trade an allowance prescribed by rules or bye-laws made under this Act, in allowance any market area in any transaction in respect of the agricultural produce permissible except as concerned and no civil court shall, in any suit or proceeding arising out prescribed. of any such transaction, have regard to or recognise any trade allowance not so prescribed.

Explanation.—Every deduction other than a deduction on account of deviation from sample when the purchase is made by sample or on account of deviation from standard when the purchase is made by reference to a known standard or on account of difference between the actual weight of the container and the standard weight or on account of the admixture of foreign matter, shall be regarded as a trade allowance for the purposes of this section.

CHAPTER V.

MISCELLANEOUS.

Liability of members of market committee to removal from office. 18. (1) The Provincial Government may, if it thinks fit, on the recommendation of the market committee supported by at least two-thirds of the whole number of members, remove any member of the market committee elected or nominated under this Act, if such member has, in the opinion of the Provincial Government, been guilty of neglect or misconduct in the discharge of his duties, or of any disgraceful conduct or has become incapable of performing his duties as a member:

Provided that no resolution recommending the removal of any member shall be passed by the market committee unless the member to whom it relates has been given a reasonable opportunity of showing cause why such recommendation should not be made.

(2) The decision of the Provincial Government under sub-section (1) shall be final.

Supersession of market committee.

19. (1) If, in the opinion of the Provincial Government, a market committee is not competent to perform or persistently makes default in performing the duties imposed on it by or under this Act, or abuses its powers, the Provincial Government may, by notification in the Official Gazette, supersede such market committee:

Provided that before issuing a notification under this sub-section, the Provincial Government shall give a reasonable opportunity to the market committee for showing cause why it should not be superseded and shall consider the explanations and objections, if any, of the market committee.

- (2) Upon the publication of a notification under sub-section (1) superseding a market committee the following consequences shall ensue:—
 - (i) all the members as well as the chairman of the market committee shall as from the date of such publication be deemed to have vacated their offices;
 - (ii) the Provincial Government may, at their discretion, by order, either constitute a new market committee under section 6 or make such arrangements for the carrying out of the functions of the market committee, as it may think fit; and
 - (iii) all the assets vesting in the market committee shall, subject to all its liabilities vest in the Crown for purposes of the Province.
- (3) If the Provincial Government makes an order under clause (ii) of sub-section (2), it shall transfer the assets and liabilities of the market committee, as on the date of such transfer, to the new market committee constituted under section 6 or to the person or persons, if any, appointed for carrying out the functions of the market committee, as the case may be.

- (4) If the Provincial Government does not make such an order, it shall transfer all the assets of the market committee which remain after the satisfaction of all its liabilities, to the local authority within whose jurisdiction the market committee is situated or if there are more than one such authorities to each of such authorities any such portion of the assets as the Provincial Government may determine.
- (5) A local authority to which the assets of a market committee have been transferred under sub-section (4) shall utilise such assets for such object in the area within its jurisdiction as the Provincial Government considers to be for the benefit of the agriculturists in that area.
- 20. Whoever contravenes the provisions of section 4 shall, on Penalty for conviction, be punishable with fine which may extend to five hundred contravention rupees, and in the case of a continuing contravention with a further of section 4. fine which may extend to one hundred rupees for every day during which the contravention is continued after first conviction.
- 21. Whoever, in contravention of the provisions of section 17, Penalty for makes or recovers any trade allowance other than an allowance making or prescribed by rules or bye-laws made under this Act shall, on conviction, trade allowbe punishable with fine which may extend to Rs. 200.

22. (1) No suit shall be instituted against any market committee Bar of suit or any member, officer or servant thereof or any person acting under in absence the direction of any such market committee, member, officer or servant of notice. for anything done or purporting to be done, in good faith as such member, officer or servant under this Act, until the expiration of two months next after notice in writing, stating the cause of action, the name and place of abode of the intending plaintiff and the relief which he claims, has been, in the case of a market committee, delivered or left at its office, and in the case of any such member, officer, servant or person as aforesaid, delivered to him or left at his office or usual place of abode, and the plaint shall contain a statement that such notice has been so delivered or left.

- (2) Every such suit shall be dismissed unless it is instituted within six months from the date of the accrual of the alleged cause of action.
- (3) Nothing in this section shall be deemed to apply to any suit I of instituted under section 54 of the Specific Relief Act, 1877.
 - 23. (1) No offence under this Act, or any rule or bye-law there-Trial of under shall be tried by a Court other than that of a Presidency offences. Magistrate or a Magistrate of the First Class or a Magistrate of the Second Class specially empowered in this behalf.

(2) Prosecutions under this Act may be instituted by any person duly authorised in writing by the market committee in this behalf.

Recovery of sums due to Government from market committee.

24. Every sum due from a market committee to the Provincial Government shall be recoverable as an arrear of land revenue.

Power of the Provincial Government to delegate its powers. 25. The Provincial Government may delegate to any officer any of the powers conferred on it by or under this Act.

Rules.

- 26. (1) The Provincial Government may, either generally or specially for any market area or market areas, make rules for the purposes of carrying out the provisions of this Act.
- (2) In particular and without prejudice to the generality of the foregoing provision, such rules may provide for or regulate:—
 - (a) the election and nomination of members of the market committee, the manner of election, the preparation and revision of lists of voters from time to time and the payment of all expenditure in connection with or incidental to such election;
 - (b) the powers to be exercised by the market committee;
 - (c) the election of the chairman of the market committee and his term of office;
 - (d) the filling of casual vacancies in the office of chairman or member of the market committee;
 - (e) the maximum fees which may be levied by the market committee in respect of licenses granted to traders and on the agricultural produce bought and sold in the market area and the recovery of such fees;
 - (f) the issue of licenses to brokers, weighmen, measurers and surveyors, the form in which, and the conditions subject to which such licenses shall be issued or renewed and the conditions subject to which the licensees shall carry on their business and the fees to be charged therefor;
 - (g) the kind and description of the weights and measures and the weighing and measuring instruments which alone shall be used in transactions in the agricultural produce in a market area;
 - (h) the periodical inspection of all weights and measures and weighing and measuring instruments in use in a market area;
 - (i) the manner of control and supervision to be exercised by the market committee over inspectors appointed under section 19 of the Bombav Weights and Measures Act, 1932;
 - (j) the time within which an appeal shall lie to the Provincial 1932. Government or the Officer appointed by it in that behalf under subsection (2) of section 12;

- (k) the trade allowance which may be made or received by any person in any transaction in the agricultural produce in a market area;
- (1) the provision of facilities for the settlement of any dispute between a buyer and seller of agricultural produce or their agents including disputes regarding the quality or weight of the article, the allowances for wrappings, containers, dirt or impurities or deductions from any cause;
- (m) the prohibition of brokers from acting in any transaction on behalf of both the buyer and seller of agricultural produce or as a buyer or seller;
- (n) the provision of accommodation for storing any agricultural produce brought into the market;
- (o) the preparation of plans and estimates for works proposed to be constructed partly or wholly at the expense of the market committee, and the grant of sanction to such plans and estimates;
- (p) the form in which the accounts of a market committee shall be kept, the audit and publication of such accounts and the charges, if any, to be made for such audit;
- (y) the preparation and submission for sanction of the annual budget and the report and returns to be furnished by a market committee:
- (r) the investment and disposal of the surplus funds of a market committee;
- (s) the regulation of advances, if any, given to agriculturists by brokers or dalals;
 - (t) the prevention of adulteration of the agricultural produce;
 - (u) the grading and standardisation of the agricultural produce;
- (v) the keeping of a list of prices of agricultural produce in respect of which the market is established.
- (3) Any rule made under this Act may provide that any contravention thereof or of any of the conditions of any license issued or renewed thereunder shall, on conviction, be punishable with fine which may extend to Rs. 200.
- (4) The power to make rules conferred by this section is subject to the condition of the rules being made after previous publication.
- (5) Rules made under this section shall be laid before each of the Chambers of the Provincial Legislature at the session thereof next following and shall be liable to be modified or rescinded by a resolution in which both Chambers concur and such rule shall, after notification in the Official Gazette, be deemed to have been modified or rescinded accordingly:

Provided that when, in the opinion of the Provincial Government, such modification or rescission is likely to defeat or frustrate any of the Mo-I Bk H 1038—94

purposes of this Act, the Provincial Government may, by notification in the Official Gazette, declare that the modification or rescission shall have no effect and thereupon the rule shall remain in force as if it had not been modified or rescinded.

Bye-laws.

- 27. (1) Subject to any rules made by the Provincial Government under section 26 and with the previous sanction of the Director or any other officer specially empowered in this behalf by the Provincial Government, the market committee may in respect of the market area under its management make bye-laws for the regulation of the business and the conditions of trading therein.
- (2) Any bye-law made under this section may provide that any contravention thereof shall, on conviction, be punishable with fine which may extend to Rs. 50.

Power of Provincial Government to call for proceedings of market committee and to pass orders thereon.

Power of Provincial Government to amend the schedule.

- 28. The Provincial Government may at any time call for and examine the proceedings of any market committee for the purpose of satisfying itself as to the legality or propriety of any decision or order passed by the market committees under the rules. If in any case, it appears to the Provincial Government that any decision or order or proceedings so called for should be modified, annulled or reversed, the Provincial Government may pass such order thereon as it thinks fit.
- 29. The Provincial Government may, by notification in the Official Gazette add to, amend or cancel any of the items of agricultural produce specified in the schedule.

Savings.

30. Nothing contained in the Markets and Fairs Act, 1862, or in any law for the time being in force relating to the establishment, maintenance regulation of a market shall apply to any market area or affect in any 1862. way the powers of a market committee or the rights of a holder of a license granted under sub-section (2) of section 4 to set up, establish or continue or to allow to be set up, established or continued, any place for the purchase or sale of any agricultural produce notified under sub-section (1) of section 4 in such area.

Repeal of Bom. XVII of 1927. 31. The Bombay Cotton Markets Act, 1927, is hereby repealed:

Provided that, notwithstanding anything contained in section 6, any local area declared to be a cotton market under section 4 of the Bombay Cotton Markets Act, 1927, shall be deemed to be a market area Bom. under this Act and the market committee constituted for the said XVII market under section 5 of the said Act and holding office immediately 1927. prior to the date on which this Act comes into force shall be deemed to be the market committee under this Act for the said market area. All the members of such committee shall be deemed to be members nominated by the Provincial Government under sub-section (2) of section 6.

BOMBAY ACT No. XXIII OF 1939.1

[THE BOMBAY LOCAL BOARDS (AMENDMENT) ACT, 1939.]

[2nd November 1939.]

An Act to amend the Bombay Local Boards Act, 1923.2

Bom. WHEREAS it is expedient to amend the Bombay Local Boards VI of Act, 1923, for the purposes hereinafter appearing; It is hereby enacted as follows:—

- 1. This Act may be called the Bombay Local Boards (Amendment) Short title. Act, 1939.
- Bom. 2. (1) Section 13 of the Bombay Local Boards Act, 1923, hereinafter Amendment VI of called the said Act, shall be renumbered as sub-section (1) of that section of section 13 of Bom. VI of 1923. and in the sub-section (1) so renumbered
 - (i) after the words "entry in the list, or" the words, figures and brackets "subject to the provisions of sub-sections (2) to (6)" shall be inserted;
 - (ii) and the words "The Collector's decision shall be final and conclusive." shall be omitted; and
 - (2) after the sub-section so renumbered, the following sub-sections shall be added, namely:—
 - "(2) Before inserting in the list aforesaid the name of any person, the Collector shall publish a notice calling upon persons entered in the list to lodge within seven days from the publication of such notice any objection which they may have to the insertion of such name.
 - (3) Such objection shall be made in writing and shall specify the grounds on which the right of any person to be entered in the list is objected to, the evidence which the objector intends to lead, the address of the objector and his number, if any, in the list, and the area in the district in which his name is entered.
 - (4) An objection which is not lodged within the time specified in sub-section (2) or which is lodged by a person not entitled to lodge the same shall be rejected.
 - (5) The Collector shall, on receipt of an objection lodged, fix a date and place for the hearing of the same and shall give notice of such date and place to the claimant.

- (6) The Collector, after hearing the evidence, if any, adduced, on behalf of the parties, and after such further enquiry as he may deem necessary, shall pass an order on the objection.
- (7) The Collector's decision under this section shall be final and conclusive."

- "(2) Every person whose name is in the revised list last published before the date of any election for any constituency shall be qualified to vote and every person whose name is not in such list shall not be qualified to vote at the election of a member for the constituency for which such list has been prepared.
- (3) Every person whose name is in the revised list last published before the date of any election for any of the constituencies of any local board shall be qualified to be elected and every person whose name is not in any such list shall not be qualified to be elected at the election for any constituency of such local board.

[THE BOMBAY SHOPS AND ESTABLISHMENTS ACT, 1939.]

[2nd November 1939.]

An Act to make provision for the regulation of hours of work in shops, commercial establishments, restaurants, eating houses, theatres

and other establishments.

WHEREAS it is expedient to make provision for the regulation of hours of work in shops, commercial establishments, restaurants, eating houses, theatres and other establishments and for certain other purposes hereinafter specified; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Shops and Establish-Short title, ments Act, 1939.

 extent and operation.
 - (2) It extends to the whole of the Province of Bombay.
- (3) It shall come into force in the first instance only in the City of Bombay, the Ahmedabad Municipal Borough and Cantonment, the Poona City and Suburban Municipal Borough, the Poona Cantonment, the Sholapur Municipal Borough and the Hubli Municipal Borough; but the Provincial Government may by notification in the Official Gazette direct that all or any of the provisions of this Act shall come into force in any other area on such date as may be specified in such notification.

CHAPTER I.

PRELIMINARY.

- 2. In this Act unless there is anything repugnant in the subject Definitions. or context—
 - (I) "Child" means a person who has not completed his twelfth year.

Provided that in any area for which a scheme of compulsory primary education has been sanctioned under the Bombay Primary Education Act, 1923, the expression "child" shall have the same meaning as it has in the said Act with reference to primary education.

(2) "Closed" means not open for the service of any customer.

- (3) "Commercial Establishment" means an establishment which is not a shop but which does the business of advertising, commission, forwarding or commercial agency, or which is a clerical Department of a factory or of any industrial or commercial undertaking or which is an insurance company, joint stock company, bank, brokers' office, exchange or such other class of establishments as the Provincial Government may by notification in the Official Gazette declare to be a Commercial Establishment for the purposes of this Act.
- (4) "Day" means the period of twenty-four hours beginning at midnight:

Provided that in the case of a person employed whose hours of work extend beyond midnight, day means the period of twenty-four hours beginning when such employment commences irrespective of midnight.

- (5) "Employer" means a person having charge of or owning the business of an establishment to which this Act applies and includes the manager, agent or any other person acting in the general management or control of such shop, restaurant, theatre or establishment.
- (6) "Establishment to which this Act applies" means a shop, commercial establishment, restaurant, eating house, theatre or any other place of public amusement or entertainment or any other establishment in respect of which a declaration is made under section 18.
- (7) "Factory" means any premises which is a factory within the meaning of clause (j) of section 2 of the Factories Act, 1934, or XXV which is declared to be a factory under section 5 of the said Act. of 1934.
 - (8) "Inspector" means an inspector apponted under section 25.
- (9) "Local authority" means a Municipality constituted under Bom. the City of Bombay Municipal Act, 1888, the Bombay District III of 1888. Municipal Act, 1901, or the Bombay Municipal Boroughs Act, 1925, Bom. or a local board constituted under the Bombay Local Boards III of 1901. Act, 1923.

1888. Bom. HI of 1901. Bom. XVIII of 1925. Bom. VI of 1923.

- (10) "Member of family of an employer" means the husband, wife or children, father or mother, brother or sister of an employer who lives with and is dependent on such employer.
 - (11) "Opened" means opened for the service of any customer.
- (12) "Periods of work" means the time during which a person employed is at the disposal of the employer.

- (13) "Person employed" means—
- (i) in the case of a shop, a person wholly or principally employed in the shop in connection with the business of the shop;
- (ii) in the case of a factory, a member of the clerical staff employed in such factory;
- (iii) in the case of a commercial establishment other than a factory, a person wholly or principally employed in connection with the business of the establishment and includes a peon;
- (iv) in the case of a restaurant or eating house, a person wholly or principally employed in the preparation or the serving of food or drink or in attendance upon a customer or in cleaning any part of the premises or utensils used on such premises or as a clerk or cashier; and
- (v) in the case of a theatre or other establishment of public entertainment, a person employed as an operator, clerk, door-keeper, usher or in similar other capacity;

but does not include the employer or a member of his family.

- (14) "Prescribed" means prescribed by rules made under this Act.
- (15) "Residential Hotel" means any premises in which a bona fide business is carried on for the supply of dwelling accommodation and means on payment of a sum of money to a traveller or any other member of the public or class of the public.
- (16) "Restaurant or Eating House" means any pemises in which is carried on wholly or principally the business of the supply of means or refreshments to the public or a class of the public for consumption on the premises but does not include a restaurant attached to a theatre.
- (17) "Shop" means any premises where goods are sold either by retail or wholesale or both or where services are rendered to customers and includes offices, store rooms, godowns or ware-houses, whether in the same premises or otherwise, used in connection with such trade or business but does not include a restaurant, eating house or a commercial establishment.
- (18) "Theatre" includes any place intended principally or wholly for the representation of moving pictures or for dramatic performances.

- (19) "Week" means the period of seven days beginning at midnight of Saturday.
- (20) "Young person" means a person who is not a child and has not completed his seventeenth year.

References to time day.

3. References to the time of day in this Act are references to Indian of standard time which is five and a half hours ahead of Greenwich mean time.

Act not applicable to certain persons and establishments.

- 4. (1) Nothing in this Act shall apply to-
- (a) persons occupying positions of management or employed in a confidential capacity;
- (b) persons whose work is inherently intermittent such as a traveller, a canvasser, a watchman or a caretaker;
- (c) persons exclusively engaged in preparatory or complementary work, such as clearing or forwarding clerks responsible for the despatch of goods by rail or other means of communication and for customs formalities or messengers;
- (d) persons exclusively employed in the collection, delivery or conveyance of goods;
 - (e) Government offices and offices of local authorities;
- (f) establishments for the treatment or the care of the sick, infirm, destitute or mentally unfit;
- (g) persons employed in such chemist's or druggist's shops as are approved by the Provincial Government by a general or special order in this behalf;
 - (h) clubs and residential hotels;
- (i) stalls and refreshment rooms at railway stations, docks and wharves;
- (j) bazaars or fairs for the sale of work for charitable or other purposes from which no profit is derived; and
- (k) any other establishment or class of establishments or person or class of persons which the Provincial Government may, by notification in the Official Gazette, exempt from the operation of this Act.
- (2) Notwithstanding anything contained in sub-section (1) the Provincial Government may by notification in the Official Gazette direct that any of the persons or establishments specified therein shall not be exempt from the operation of this Act.

CHAPTER II.

SHOPS.

- 5. (1) Save as provided by or under any other enactment for the Opening and time being in force, no shop shall on any day—

 - (a) be opened earlier than such hour as may be fixed by the Provincial Government by a general or special order in this behalf, and
 - (b) be closed later than 9 p.m. or such other earlier hour as may be fixed by the Provincial Government by a general or special order in this behalf:

Provided that any customer who was being served or was waiting to be served at such closing hour in any shop may be served in such shop during the quarter of an hour immediately following such hour.

- (2) An order under sub-section (1) shall be passed by the Provincial Government after making an enquiry in the prescribed manner.
- 6. Save as otherwise provided in this Act or by or under any other Hawking enactment, no person shall after the closing hour fixed under sections prohibited after closing carry on in or adjacent to a street or a public place the sale of any hour. goods:

Provided that nothing in this section shall apply to the sale of newspapers.

7. (1) Subject to the provisions of sub-section (2), no person Daily hours employed in any shop shall be required or allowed to work in such shop of work in for more than nine and a half hours in any day.

Provided that any such person may be allowed to work in such shop for any period in excess of the limit fixed under sub-section (1), if such period does not exceed in aggregate one hundred and twenty hours in any calendar year.

(2) No person employed in any shop shall be required or allowed to work in such shop for more than seven hours in any day unless he has had an interval for rest of at least one hour:

Provided that no person so employed shall be required or allowed to work in such shop for more than five hours in any day unless he has had an interval of rest for at least half an hour.

8. The periods of work and intervals of rest of a person employed in Spread over a shop shall be so arranged that they shall not be together spread over of periods more than twelve hours in any day:

Provided that in cases where any shop is on any day entirely closed for a continuous period of not less than three hours between the opening

and the closing time the periods of work and intervals of rest may be spread over fourteen hours in that day.

Holidays in a week.

9. (1) Every person employed in a shop shall be given at least one day in a week as a holiday:

Provided that nothing in this sub-section shall apply to any person whose total period of employment is less than six days.

(2) No deduction shall be made from the wages of any person nployed in a shop on account of any holiday given to him under b-secton (I).

CHAPTER III.

COMMERCIAL ESTABLISHMENTS.

Opening and of commercial establishments.

- 10. (1) Save as provided by or under any other enactment for the closing hours, time being in force, no commercial establishment shall, on any day, be opened earlier than and closed later than such hour as may be fixed by a general or special order of the Provincial Government made under subsection (2).
 - (2) The Provincial Government may by general or special order fix the time at which any commercial establishment or any class of such establishments shall be opened or closed in any local area. Such order shall be passed after making an inquiry in the prescribed manner.

Monthly and daily hours of work in a commercial establishment.

11. (1) Subject to the provisions of sub-section (2), no person employed in any commercial establishment shall be required or allowed to work in such establishment for more than two hundred and eight hours in a month:

Provided that any such person may be allowed to work in such establishment for more than two hundred and eight hours in any month during stock-taking, making of accounts, settlement or other prescribed occasions:

Provided further that the total number of hours for which such person is allowed to work in excess of the maximum number of hours prescribed for every month under this section does not exceed one hundred and twenty in any calendar year.

(2) No person employed in any commercial establishment shall be required or allowed to work in such establishment for more than seven hours in any day unless he has had an interval for rest of at least one hour:

Provided that no person so employed shall be required or allowed to work in such establishment for more than four and a half hours in any day unless he has had an interval for rest of at least half an hour.

12. The periods of work and intervals of rest of a person employed Spread over in a commercial establishment shall be so arranged that they shall not of periods of work. together be spread over more than twelve hours in a day:

Provided that the Provincial Government may by rules made in this behalf fix, on not more than six days in a calendar year, any period in excess of the period prescribed under this section for which on account of stock-taking, making of accounts, settlements or other prescribed occasions the person employed may be required to work.

*13. (1) Every person employed in a commercial establishment shall Holiday in be given at least one day in a week as a holiday:

Provided that nothing in this sub-section shall apply to any person whose total period of employment is less than six days.

(2) No deduction shall be made from the wages of any person employed in a commercial establishment on account of any holiday given to him, under sub-section (1).

CHAPTER IV.

RESTAURANTS, EATING HOUSES, THEATRES OR OTHER PLACES OF PUBLIC AMUSEMENT AND ENTERTAINMENT.

Provided that no person so employed shall be so required or allowed to work in such restaurant, eating house or theatre or place of public amusement or entertainment for more than six hours in any day unless he has had an interval for rest of at least half an hour.

16. The periods of work and intervals of rest of a person employed Spread over in a restaurant, eating house, theatre or any other place of public of periods of amusement or entertainment shall be so arranged that they shall not work. together be spread over more than fourteen hours in any day.

Holiday in a week.

17. (1) Every person employed in a restaurant, eating house, theatre or any other place of public amusement or entertainment shall be given at least one day in a week as a holiday:

Provided that nothing in this sub-section shall apply to any person whose total period of employment is less than six days.

(2) No deduction shall be made from the wages of any person employed in a restaurant, eating house, theatre or a place of public amusement or entertainment on account of any holiday given to him under sub-section (1).

CHAPTER V.

OTHER ESTABLISHMENTS.

(1) If any local authority makes default in the performance of Power of any duty imposed by or under this Act, the Provincial Government may Provincial Government appoint some person to perform it and may direct that the expense of to provide for performing it with a reasonable remuneration to the person appointed performance to perform it shall be paid forthwith by the local authority.
 - of duties on default by local authority.
- (2) If the expense and remuneration are not so paid, the Provincial Government may notwithstanding anything contained in any law relating to the municipal fund or local fund or any other law for the time being in force, make an order directing the bank in which any moneys of the local authority are deposited or the person in charge of the local Government Treasury or of any other place of security in which the moneys of the local authority are deposited to pay such expense and remuneration from such moneys as may be standing to the credit of the local authority in such bank or may be in the hands of such person or as may from time to time be received from or on behalf of the local authority by way of deposit by such bank or person; and such bank or person shall be bound to obey such order. Every payment made pursuant to such order shall be a sufficient discharge to such bank or person from all liability to the local authority in respect of any sum or sums so paid by it or him out of the moneys of the local authority so deposited with such bank or person.
- 24. Notwithstanding anything contained in any enactment in regard Expenses to any municipal or local fund, all expenses incurred by a municipality of local or a local board under and for the purposes of this Act shall be paid out to be paid of the municipal or local fund, as the case may be.
- 25. (1) Every local authority shall appoint a sufficient number of Appointpersons with the prescribed qualifications as Inspectors for the area ment of Inspectors. subject to its jurisdiction as it may deem fit for the purpose of carrying out the provisions of this Act.
- (2) In areas which are not subject to the jurisdiction of any local authority, the Provincial Government shall appoint Inspectors with the prescribed qualifications.

Powers and duties of . Inspectors.

26. Any Inspector appointed under section 25 may at all reasonable times enter into any place which is or which he has reason to believe is an establishment to which this Act applies with such assistants being persons in the service of the Crown or of the local authority, as the case may be. and make such examination of the premises and of the prescribed registers, records and notices, as may be prescribed.

Inspectors to be public servants.

27. Every Inspector appointed under section 25 shall be deemed to be a public servant within the meaning of section 21 of the Indian Penal XLV Code.

1860.

Penalty for obstructing Inspector, etc.

28. Any person who wilfully obstructs an Inspector in the exercise of any power conferred on him under this Act or who fails to comply with a lawful direction made by an Inspector shall, on conviction, be punishable with fine which may extend to Rs. 250.

Maintenance of registers and records and display of notices.

29. Subject to the general or special orders of the Provincial Government, an employer shall maintain such registers and records and display such notices as may be prescribed for carrying out the provisions of this Act.

Penalties for offences.

- 30. (1) Any employer who contravenes the provisions of sections 5. and 7 to 21 (both inclusive) shall, on conviction, be punishable with fine which may extend to Rs. 25 for the first offence and to Rs. 250 for every subsequent offence after his conviction for the first offence.
- (2) Whoever contravenes the provisions of section 6 shall, on conviction, be punishable with fine which may extend to Rs. 10 for the first offence and to Rs. 100 for any subsequent offence after his conviction for the first offence.

CHAPTER VIII.

Miscellaneous.

Exemption.

31. The Provincial Government may, by notification in the Official Gazette, suspend the operation of all or any of the provisions of this Act for such period and subject to such conditions as it deems fit on account of any prescribed holidays or occasion.

Wages for over-time work.

32. Where any person employed in any establishment to which this Act applies is required to work in excess of the limit of hours of work he shall be entitled in respect of the over-time work to wages, at the rate of 11 times his ordinary rate of wages.

Explanation.—For the purposes of this section—

- (1) the expression "limit of hours of work" shall mean-
- (a) in case of persons employed in a shop nine and a half hours in each day;

- (b) in case of persons employed in a commercial establishment two hundred and eight hours in a month;
- (c) in case of persons employed in a restaurant, eating house, theatre or any other place of public amusement or entertainment ten hours in each day; and
- (d) in case of persons employed in any other establishment such hours as may be prescribed; and
- (2) the expression "ordinary rate of wages" shall mean such rate of wages as may be calcuated in the manner prescribed.
- 33. (1) The Provincial Government may make rules to carry out the Rules. purposes of this Act.
- (2) In particular and without prejudice to the generality of the fore-going provision such rules may be made for all or any of the following matters, namely:—
 - (i) the manner of making inquiry under sub-section (2) of section 5;
 - (ii) the manner of making inquiry under sub-section (2) of section 10;
 - (iii) the occasions on which the hours of work may exceed 208 in a month under section 11;
 - (iv) fixing excess period for work under section 12;
 - (r) the supervision which the Provincial Government shall exercise over local authority under section 22;
 - (vi) the qualifications of Inspectors under section 25;
 - (vii) the examination to be made of premises and of prescribed registers, records and notices under section 26;
 - (viii) the registers and records to be maintained and the notices to be displayed under section 29;
 - (ix) the period for which, the conditions subject to which and the holidays and occasions on which, the operation of the provisions of this Act may be suspended under section 31; and
 - (x) the limit of hours of work under clause (1) (d) and the manner of calculating the ordinary rate of wages under clause (2) of the Explanation to section 32.
- (3) The rules made shall be subject to the condition of previous publication and when so made shall be deemed to be part of this Act.
- (1) The rules may provide that any contravention thereof shall, on conviction, be punishable with fine which may extend to Rs. 50.
- 34. Save in regard to the matters for which provision is made for Byelaws. rules under section 33, a local authority may, subject to the previous

sanction of the Provincial Government, make bye-laws not inconsistent with this Act or rules thereunder for the purpose of carrying out the provisions of this Act.

Rights and privileges under other law, etc., not affected.

35. Nothing in this Act shall affect any rights or privileges which any person employed in any establishment to which this Act applies is entitled to at the date this Act comes into force under any other law, contract, custom or usage applicable to such establishment, if such rights or privileges are more favourable to him than those to which he would be entitled under this Act.

[THE BOMBAY OPTIONS IN COTTON PROHIBITION ACT, 1939.]

[11th December 1939.]

An Act to provide for the prohibition of options in cotton and for certain other purposes in the Province of Bombay.

WHEREAS it is expedient to prohibit options in cotton and to provide for certain other purposes hereinafter appearing;

AND WHEREAS the Governor of Bombay has assumed to himself under the Proclamation dated the 4th November 1939 issued by him under section 93 of the Government of India Act, 1935, all powers vested by or under the said Act in the Provincial Legislature;

Now, therefore, in exercise of the said powers, the Governor of Bombay is pleased to make the following Act:---

- 1. (1) This Act may be called the Bombay Options in Cotton Short title Prohibition Act, 1939.
 - (2) It shall extend to the whole of the Province of Bombay.
- 2. In this Act, words and expressions defined in the Bombay Cotton Definitions. Bom. Contracts Act, 1932, shall have the meanings assigned to them in that 1v of Act. 1932.
- 3. (1) Notwithstanding anything contained in section 6 of the Power of Bom. Bombay Cotton Contracts Act, 1932 (hereinafter called "the said Provincial IV of Act"), the Provincial Government may, at any time, make for any to make recognised cotton association, any by-laws in respect of any of the by-laws for matters specified in section 6 of the said Act except those specified in recognised cotton clauses (a) and (l) of sub-section (2) of the said section and may also association. add to, very or rescind any by-laws made by the Board of Directors of such association in regard to the said matters.
 - (2) The by-laws or any addition, variation or rescission made under sub-section (1) shall be published in the Official Gazette and shall be subject to the condition of previous publication:

Provided that if the Provincial Government is of opinion that in the interest of trade, it is necessary to make or rescind any by-law or to make any addition to or variation in any by-law forthwith, the Provincial Government may dispense with the conditions of previous publication.

Options in cotton void.

4. Notwithstanding anything contained in the said Act or in any other law for the time being in force, all options in cotton entered into after the date on which this Act comes into force shall be void.

Savings.

- 5. Nothing in this Act shall affect or be deemed to affect—
- (a) the terms and incidents of any option in cotton made or effected before the date on which this Act comes into force;
- (b) the validity, invalidity, effect or consequence of anything already done or suffered before the aforesaid date in regard to such options in cotton;
- (c) any right, title, obligation or liability acquired, accrued or incurred in regard to such options in cotton before the aforesaid date;
- (d) any remedy or proceeding in respect of such right, title, obligation or liability;
- (e) anything done in the course of any proceeding pending in any court on the aforesaid date relating to such options in cotton

and any such remedy or proceeding may be enforced, instituted or continued, as the case may be, as if this Act had not been passed.

[THE BOMBAY FODDER AND GRAIN CONTROL ACT, 1939.]

[12th December 1939.]

An Act to provide for the control and regulation of supply and distribution of fodder and grain including regulation of prices thereof in the Province of Bombay on occasions of famine or scarcity.

WHEREAS it is expedient to provide for the control and regulation of supply and distribution of fodder and grain including regulation of prices thereof in the Province of Bombay on occasions of famine or scarcity; It is hereby enacted as follows:—

- 1. (I) This Act may be called the Bombay Fodder and Grain Control Short title.

 Act, 1939.

 Commencement.
 - (2) It shall extend to the whole of the Province of Bombay.
- (3) It shall come into force with effect from such date as the Provincial Government may by notification in the Official Gazette appoint.
- 2. In this Act, unless there is anything repugnant in the subject or Definitions. context,—
 - (1) "Famine area" means any area declared to be a famine area under section 3:
 - (2) "Scarcity area" means any area declared to be a scarcity area under section 3;
 - (3) "Standard price" means the maximum price fixed for sale of fodder or grain under section 3.
- 3. (1) The Provincial Government may, from time to time, by Power to notification in the Official Gazette, declare that a state of famine or declare scarcity prevails in any local area in the Province; and thereupon the scarcity said area shall be deemed to be a famine area or a scarcity area, as the areas and case may be, for the purposes of this Act for such period as the to fix standard Provincial Government may direct.

- (2) On a declaration being made under sub-section (1), the Provincial Government may also by like notification declare that all contracts for the sale of fodder or grain of any kind entered into on or after the date specified in the notification shall be subject to the provisions of this Act.
- (3) The Provincial Government may, by notification in the Official Gazette, fix a standard price for the sale of fodder or grain in any famine area or scarcity area or in such other area as may be specified in the notification.

Sum in excess of the standard price not to be recovered: 4. (1) No person shall recover on account of sale of fodder or grain of any kind in any area for which a standard price has been fixed under sub-section (3) of section 3 any sum in excess of the standard price.

Vendor to give receipt to purchaser. (2) Every vendor of grain or fodder or any person acting on his behalf selling fodder or grain in any area referred to in sub-section (1) shall give to the purchaser a receipt showing the sum received as the consideration for the sale, the quantity and the quality of fodder or grain sold.

Prohibition against removal of fodder or grain from any local area.

- 5. (1) After the Provincial Government has made a declaration under sub-section (1) of section 3 that a state of famine or scarcity prevails in any local area and during the period for which such declaration is in force, the Provincial Government may, at any time, on being satisfied that it is necessary for the relief of poor persons or for the protection of agriculture or for the preservation of public health in such famine area or scarcity area that the removal of fodder or grain of any kind from such famine area or scarcity area or from any other local area should be restricted, direct, by notification in the Official Gazette, that no person shall remove from the local area mentioned in the notification such fodder or grain without permission in writing of the Collector or such other officer as may be authorised by him in this behalf.
- (2) On such direction being issued no person shall remove from the local area mentioned in the notification any such fodder or grain without permission in the manner provided in sub-section (1).

Sums in excess of standard price not to be recoverable.

- 6. (1) Any sum agreed to be paid as consideration for the sale of fodder or grain of any kind in excess of the standard price shall be irrecoverable.
- (2) If any such sum has been paid, it shall be recoverable by the person paying the same from the person to whom it was paid.

Penalty for contravention of section 4 or 5. 7. Whoever contravenes any of the provisions of section 4 or 5 shall, on conviction, be punishable with imprisonment for a term which may extend to two years or with fine which may extend to Rs. 1,000 or with both.

Rules.

8. The Provincial Government may by notification in the Official Gazette make rules for carrying out the provisions of this Act.

Insertion of new sections 20A, 20B, 20C, 20D and 20E in Bom. VIII of 1924.

Special provisions till properties, funds etc. producing an annual income of Rs. 98,000 are not assigned to the Corporation.

4. After section 20 of the said Act the following new sections shall be inserted, namely:—

- "20A. Notwithstanding anything contained in the foregoing provisions of this Act, on and after the passing of the Sir Chinubhai Madhavlal Ranchhodlal Baronetcy (Amendment) Act, 1939, so long as stocks, funds or securities referred to in section 4 of the nominal value in the aggregate of about rupees twenty-eight lacs or such sum as may produce an annual income of not less than rupees ninety-eight thouand are either not assigned and transferred by the Baronet for the time being or the person who as the heir male of his body has for the time being succeeded to and is in the enjoyment of the title of the Baronet into the name of the Corporation or are not acquired by purchase or otherwise from the income or proceeds of sale of any of the hereditaments or pemises specified in the Third Schedule;
 - (a) the Corporation shall not be required to pay, as provided in section 4, the whole of the balance of the annual income of the Trust Funds and of the hereditaments and premises specified in Schedules I and III to the present Baronet or to the person, who as heir male of his body shall for the time being have succeeded to and be in the enjoyment of the title of Baronet conferred by the said Letters Patent as aforesaid and shall be of full age or during his minority to his duly appointed guardian but shall pay to the said Baronet or the said person only such sum, not being less than rupees three thousand a month, as the Corporation may in its absolute discretion

deem fit to fix from time to time and may appropriate any part of the annual income in excess of the sum so fixed towards making up the said stocks, funds or securities of the nominal value in the aggregate of about rupees twenty-eight lacs or such sum as may produce an annual income of not less than rupees ninety-eight thousand;

- (b) the Corporation shall not, as provided in section 5, pay over, transfer and assign to the Baronet on his attaining majority the whole of the investments and accumulations of the residue of the annual income invested during his minority but shall appropriate the same towards the purpose of acquiring and holding stocks, funds or securities as will make up the stocks, funds or securities of the nominal value in the aggregate of about rupées twenty-eight lacs or such sum as may produce an annual income of not less than rupées ninety-eight thousand;
- (c) subject to the provisions of section 7, the actual management of all hereditaments and premises for the time being vested in the Corporation including the collection of rent and carrying out repairs shall be in the hands of the person in the actual enjoyment for the time being of the title of Baronet conferred by the said Letters Patent being of full age orduring his minority of his duly appointed guardian, subject nevertheless, notwithstanding anything contained in section 19, to the control, direction and supervision of the Corporation:

Provided always-

- (i) that such management shall be carried on in such manner as the Provincial Government may from time to time direct;
 - (ii) that the person so in actual management shall submit to the Provincial Government as well as to the Corporation such information and returns and accounts as to the management as the Provincial Government or Corporation may call for or require from time to time:

And provided further that on failure of the person so in actual management to carry out any direction or order of the Provincial Government or the Corporation, as the case may be, or on his failure to furnish such information or returns as may be called for from him by the Provincial Government or the Corporation, as the case may be, or on his failure, to manage the property as carefully as in the opinion of the Provincial Government a man of ordinary prudence would manage it as if the property were his own, the Provincial Government or, with the previous approval of the Provincial Government the Corporation, shall be entitled to and may forthwith take over and assume the actual management for such period as the Provincial Government or the Corporation may deem proper till the stocks, funds or securities referred to in section 4 are made up of the nominal value in the aggregatete of about MO-II Bk H 1638--11

rupees twenty-eight lacs or such sum as may produce an annual income of not less than rupees ninety-eight thousand.

Provincial Government to be Trustees of property under management. 20B. When the Provincial Government takes over and assumes the actual management of the property under the second proviso to section 20A the property shall vest in the Provincial Government as Trustees for executing all the powers and purposes of this Act conferred on and executable by the Corporation under this Act and all the provisions of this Act which apply to the Corporation shall, so far as may be, apply to the Provincial Government.

Reimbursement of expenses of Provincial Government and Corporation. 20C. On the Provincial Government or the Corporation taking over and assuming the actual management of the hereditaments under the second proviso to section 20A and so long as the Provincial Government or the Corporation is in actual management of the said hereditaments it shall be lawful for the Provincial Government or the Corporation out of any moneys which shall come to its hands by virtue of the trusts and provisions of this Act to retain and reimburse to them all damages, costs and expenses which they shall or may sustain, expend or disburse in or about the execution of the trusts, powers and provisions herein contained or in relation thereto.

Devesting of property specified in Third Schedule on amount of stocks, funds or securities totalling about Rs. 28,00,000.

20D. As soon as the stocks, funds or securities referred to in section 4 are made up of the nominal value in the aggregate of about rupees twenty-eight lacs or such sum as may produce an annual income of not less than rupees ninety-eight thousand, such of the lands, buildings, hereditaments and premises particularly described in the Third Schedule hereunder as may be vesting in the Corporation at the said date shall be devested of the Corporation or of the Provincial Government, as the case may be, and they shall then be vested in the person in the actual enjoyment for the time being of the title of the Baronet, such of them as shall be of freehold tenure absolutely and such of them as are of a leasehold tenure for all the residue then unexpired of the several terms for which the same may be demised by the respective leases relating to them for his own use and benefit.

BOMBAY ACT No. XXVIII OF 1939.1

[THE BOMBAY AGRICULTURAL DEBTORS RELIEF ACT, 1939.]

[30th January 1940.]

An Act to provide for the Relief of Agricultural Debtors in the Province of Bombay.

WHEREAS it is expedient to provide for the relief of agricultural debtors in the Province of Bombay and for certain other purposes specified herein; It is hereby enacted as follows:-

CHAPTER I.

PRELIMINARY.

- 1. (1) This Act may be called the Bombay Agricultural Debtors Short title, extent and Relief Act. 1939. commencement.
- (2) This section and sections 17, 23, 32, 37 and 73 extend to the whole of the Province of Bombay and the rest of the Act shall extend to the whole of the Province of Bombay except the town and island of Bombay.
- (3) It shall come into force on such date as the Provincial Government may, by notification in the Official Gazette, appoint in this behalf.
- 2. In this Act, unless there is anything repugnant in the subject or Definitions. context-
 - (1) "Award" means an award made by the Board under section 24, 54 or 55 or as confirmed or modified by the Court under section 9.
 - (2) "Board" means a Debt Adjustment Board established under section 4.

(3) "Co-operative Society" means a society registered or deemed to be registered under the provisions of the Bombay Co-operative Societies Act, 1925.

- (4) "Court" means--
- (a) in sections 13, 14, 17, 61, sub-section (I) of section 62, 63, 66, 75 and 83 a District Court or a Court of the First Class Subordinate Judge to which an appeal lies against the award of a Board under section 9; and
- (b) in the remaining provisions wherever the expression occurs, the Civil Court of competent jurisdiction.
- (5) "Debt" means any liability in cash or kind, whether secured or unsecured, due from a debtor whether payable under a decree or order of any civil court or otherwise but does not include arrears of wages payable in respect of agricultural or manual labour.
 - (6) "Debtor" means-
 - (a) an individual—
 - (i) who is indebted;
 - (ii) who holds land used for agricultural purposes;
 - (iii) who has been cultivating such land personally from a date prior to 1st April 1937; and
 - (iv) whose annual income from sources other than agriculture and manual labour does not ordinarily exceed 20 per cent. of his total annual income or does not exceed rupees 300, whichever is greater;
 - (b) an undivided Hindu family-
 - (i) which is indebted;
 - (ii) which holds land used for agricultural purposes;
 - (iii) which has been cultivating such land personally from a date prior to 1st April 1937; and
 - (iv) the annual income of which from sources other than agriculture and manual labour does not ordinarily exceed 20 per cent, of its total annual income or does not exceed Rs. 500, whichever is greater.

Explanation I.—For the purposes of this clause "Agriculture" includes horticulture, the raising of crops or garden produce, dairy farming, poultry farming, stock breeding and grazing, but does not include leasing of land or cutting only of grass or wood.

Explanation II.—For the purposes of this clause, a person who personally cultivated land used for agricultural purposes on 1st April 1937, but who has been evicted from such land at any time thereafter, shall be deemed to have been cultivating such land personally, if at the date of the application under section 17 or 23 he is cultivating land personally.

- (7) "Financing of crops" means advancing of loans for the raising of crops during the ploughing season or later for ploughing, sowing, harrowing, weeding, harvesting, purchase of seeds, manure or for such other purposes as may be prescribed, such loans being repayable during the season when the crops for which the loans were advanced are harvested.
- (8) "Holder" means a holder as defined in section 3 (11) of the Bom. Bombay Land Revenue Code, 1879, and includes a holder of land held for the performance of services useful to Government or village community, which service is actually being performed but does not include—
 - (a) a holder of any other alienated land which cannot be alienated without the sanction of Government, and
 - (b) a holder of any land held on behalf of a religious or charitable institution.

and the expression "to hold land" shall be construed accordingly.

- (9) "Prescribed" means prescribed by rules.
- (10) "Resource Society" shall have the same meaning as it has in the Bombay Co-operative Societies Act, 1925.
 - (11) "Rules" means rules made under section 83.
 - (12) "Secured debt" means a debt due to a creditor from his debtor for which the creditor holds the property of the debtor or any part thereof as security.
 - (13) "To cultivate personally" means to cultivate by one's own labour or by the labour of any member of one's family or by servants or hired labour under one's personal supervision or the personal supervision of any member of one's family.

Explanation I.—If a person who was cultivating personally dies leaving as his heir a widow or a minor or a person who is subject to physical or mental disability, such heir shall be deemed to cultivate the land personally notwithstanding the fact that the land is cultivated on behalf of such heir by servants or bired labour or by tenants.

Explanation II.—In the case of an undivided Hindu family, the land shall be deemed to have been cultivated personally if it is cultivated by any member of such family. If there are no adult co-parceners in such family capable of cultivating the land personally, such family shall be deemed to be cultivating the land personally if the land is cultivated on behalf of such family by servants or hired labour or by tenants.

(11) "Unsecured debt" means a debt which is not a secured debt.

- (15) The expressions "District Judge", "Joint Judge", "First Class Subordinate Judge" and "Special jurisdiction" have the same meanings as are assigned to them in the Bombay Civil Courts Act, XIV 1869. 1869.
- (16) The words and expressions used in this Act, but not defined. have the meanings assigned to them in the Code of Civil Procedure, y of 1908, or the Bombay Land Revenue Code, 1879, as the case may be.

Savings.

- 3. Save as otherwise expressly provided in this Act, nothing in 1879. sections 17, 31, 32, 33, 34, 38, 39, 40, 41, 42, 43, 44, 45, 52, 53 and 54 shall affect the debts and liabilities of a debtor falling under the following heads, namely:—
 - (i) any revenue or tax payable to Government or any other sum due to it by way of loan or otherwise, .
 - (ii) any tax parable to a local authority or any other sum payable to such authority by way of loan or otherwise,
 - (iii) any liability in respect of any sum due to any co-operative society,
 - (iv) any liability in respect of any sum advanced after 1st January 1939 solely for the purpose of financing of crops, and
 - (v) any liability under a decree or order for maintenance passed by a competent Court.

Explanation.—" Tax" means any toll, rate, cess, fee or other impost leviable by Government or any local authority.

CHAPTER II.

CONSTITUTION AND POWERS OF A DEBT ADJUSTMENT BOARD AND THE POWERS OF THE COURT IN APPEAL.

- Constitution
- 4. (1) The Provincial Government may, by notification in the Official of the Board. Gazette, establish a Debt Adjustment Board. Such Board may be established for any local area, or for any class of debtors in any local
 - (2) A notification under sub-section (1) shall also be published in the local area concerned in the regional language of that area and in such other manner as may be prescribed.
 - (3) (i) The Board shall consist of-
 - (a) one person who holds or has held office under the Crown in India, or
 - (b) a body or association of persons, or
 - (c) persons not less than three and not more than five in number.

- (ii) Where the Board consists of more than one person, one of such persons shall be a chairman and another a vice-chairman.
- (iii) Persons constituting a Board shall have such qualifications as may be prescribed and shall be appointed by the Provincial Government.
- (4) Where the Board consists of five members, the quorum shall be three, and where the Board consists of four or three members, the quorum shall be two.
- (5) Where the chairman and other members of the Board are unable to come to a unanimous agreement, the opinion of the majority shall prevail. Where the Board is equally divided, the chairman shall have a casting vote.
- (6) During the absence of the chairman from any meeting of the Board, the vice-chairman shall act as chairman. During the absence of both the chairman and vice-Chairman from any meeting of the Board, any member elected by the members present shall act as chairman. The First Class Subordinate Judge, within the local limits of whose special jurisdiction the Board is established, shall also nominate one of the members of the Board to act as chairman in the absence of both the chairman and the vice-chairman and on the failure of the members to elect a chairman. The vice-chairman or the member who is so elected or nominated as chairman shall, while so acting, have the same powers as the chairman.
- (7) When the Board consists of only one officer or individual, the Provincial Government may appoint, in the manner prescribed, such number of assessors not exceeding four as it thinks fit, to assist the Board in any proceeding before it under this Act. In making the award the Board shall take into consideration the opinions of such assessors.
- (8) No member of the Board who has directly or indirectly, by himself or his partner, any share or interest in any transaction in any proceedings before the Board shall act as a member of the Board in respect of such proceedings.
- 5. (1) Notwithstanding anything contained in section 4, the Removal of Provincial Government may, after due enquiry at any time, by Board or notification in the Official Gazette—
 - (a) dissolve any Board and establish in its place a fresh Board; or
 - (b) remove all or any of the members of a Board and appoint in their place new members.
- (2) The dissolution of a Board or the occurrence of any vacancy on the board through death, resignation or removal of its members under sub-section (1) shall not in any way affect the validity of any proceedings pending before the Board and the said proceedings shall be

continued before the said Board or before any other Board established in place of the said Board, as the case may be, as if there has been no dissolution of the Board or the occurrence of any such vacancy.

(3) Save as otherwise provided in this Act, the proceedings pending before any Board which has been dissolved under sub-section (1) and in . place of which no other Board has been established shall be deemed to be civil proceedings within the meaning of section 14 of the Indian Limitation Act, 1908, and the provisions of the said section shall, so for IX of as may be, apply to the computation of the period of limitation in regard 1908. to any suit or application which may be instituted in any civil court to enforce any claim which was the subject matter of the proceedings pending before the Board so dissolved.

Power of Board to. decide all questions arising on adjustment of debts.

- \checkmark 6. (1) Subject to the provisions of this Act, the Board shall have full power to decide all questions, whether of title or priority or of any nature whatsoever, and whether involving matters of law or fact, which may arise in any case within the cognizance of the Board or which the Board may deem it expedient or necessary to decide for the purpose of doing complete justice or making a complete adjustment of debts in any such case.
- (2) Subject to the provisions of this Act and notwithstanding anything contained in any other law for the time being in force, every such decision shall be final and binding for all purposes on all the parties and all other persons claiming through or under such persons who are parties to the proceedings in which such decision is given.

Procedure before Board.

- 7. (1) Subject to the provisions of this Act and any rules, the Board shall have the same powers as are vested in civil courts under the Code V of of Civil Procedure, 1908, when trying a suit and in particular in respect 1908. of the following matters:-
 - (a) joining any necessary or proper parties;
 - (b) summoning and enforcing the attendance of any person and examining him on oath;
 - (c) compelling the production of documents;
 - (d) issuing commissions for the examination of witnesses; and
 - (e) proof of facts by affidavits.
- (2) Subject to the provisions of this Act and any rules, the Board may direct any of its members to inspect any site, or to examine any witnesses on commission. On the inspection of such site by the members and the examination of witnesses on commission, a report shall be made to the Board.

Proceedings judicial proceedings.

8. All proceedings under this Act before the Board shall be deemed deemed to be to be judicial proceedings for the purposes of sections 193 and 228 of the XLV Indian Penal Code.

- 9. (1) Every award except an award made in terms of a settlement Appeal to under sub-section (4) of section 23 or under section 24 or under section Courts. 55 shall, at the instance of any party, be subject to appeal—
 - (a) to the District Court within the local limits of whose jurisdiction the Board may have been established, if the total amount of debts payable by the debtor under the award exceeds Rs. 5,000, and

(b) to the Court of the First Class Subordinate Judge within the local limits of whose special jurisdiction the Board may have been established, if the total amount of such debts does not exceed Rs. 5,000.

- (2) Every decision of the Board under sub-section (3) of section 23 or dismissing an application under sub-section (2) of section 35 shall at the instance of any party be subject to appeal to the Court of the Subordinate Judge of the First Class within the local limits of whose special jurisdiction the Board may have been established.
- 10. An appeal against a decision or award of the Board shall be filed Limitation within 60 days from the date of such decision or award:

Provided that in computing the period of limitation, the provisions IX of the Indian Limitation Act, 1908, applicable to appeals shall, so far as 1908. may be, apply to appeals under this Act.

 - (a) in an appeal against the decision of the Board under sub-section (3) of section 23 or under sub-section (2) of section 35—a court fee of Rs. 2.
- (b) in an appeal against an award—on the amount in dispute at the rate payable on a memorandum of appeal presented to a civil court under item 1 of Schedule I of the Court-fees Act, 1870, as if the award was a decree of a subordinate civil court.
 - 12. No decision or award of the Board shall be modified or set aside Grounds of in appeal, except on any of the following grounds:—
 - (a) such decision or award was improperly procured,
 - (b) corruption or misconduct of the Board or any member thereof, in the conduct of the proceedings relating to such decision or award,
 - (c) any illegality or irregularity in the proceedings relating to such decision or award, which has occasioned failure of justice,
 - (d) any error of law or erroneous appreciation of evidence which has occasioned failure of justice.
- 13. In the hearing of appeals made under this Act, the Court shall Procedure in follow the procedure provided in the Code of Civil Procedure, 1908, for appeals. The hearing of appeals from original decrees so far as may be applicable.
 - 14. Notwithstanding anything contained it any other law, no further Court's appeal shall lie against a decision or order of the Court under this Act. decision order to be final.
 - 15. (1) A Board shall in all proceedings under this Act be subject to Control over the control of the Court of the First Class Subordinate Judge within the Board. local limits of whose special jurisdiction it is established.

(2) The First Class Subordinate Judge or any person authorised by him may inspect or cause to be inspected any property, books or documents in possession of or under the control of the Board and require the Board to furnish such statements, accounts, reports, copies of documents or such other information relating to the proceedings and duties of the Board and may pass such orders thereon as he thinks fit.

Power of Board to enlarge time.

16. Where any period is fixed or granted by the Board for the doing of any act prescribed or allowed by this Act, the Board may, in its discretion, from time to time, enlarge such period, even though the period originally fixed or granted may have expired.

CHAPTER III.

PROCEDURE FOR ADJUSTMENT OF DEBTS.

Application for adjustment of debts.

- 17. (1) Within eighteen months from the date on which a Board is established under section 4, any debtor may make an application to the Board for the adjustment of his debts under this Act as hereinafter provided.
- (2) Unless the debtor has already made an application under subsection (1), his creditor may make an application to the Board for the adjustment of his debts within the period specified in sub-section (1).
- (3) An application under this section shall be made to the Board established for any local area if the debtor or any of the debtors who is a party to the application ordinarily resides in such area, or to the Board established for the class of debtors, if the debtor or any of the debtors who is a party to the application belongs to the said class.
- (4) When more than one application has been made to the same or different Boards by or in respect of the same debtor or one or more of the joint debtors,
 - (a) if the Boards are established within the local limits of one Court, that Court, and
 - (b) if the Boards are established within the local limits of more than one Court a District Judge or a Joint Judge appointed in this behalf by the Provincial Government,

shall after holding such enquiry as it or he thinks fit, direct that all such applications shall be dealt with by any one of such Boards as may be specified in the direction:

Provided that the Board so specified shall be one of the Boards referred to in sub-section (3).

(5) No objection as to the place of presentation of the application shall be allowed by the Board or the Court, unless such objection was taken at the earliest opportunity before the Board to which the application was made and unless there has been a consequent failure of justice.

- 18. (1) Every application made under section 17 shall be in writing Form and in the prescribed form and shall be signed and verified in the prescribed of application manner.
- (2) It shall be accompanied with such court fee as may be payable under the Court-fees Act, 1870, as if the application was a plaint in a suit for accounts.
 - 19. (1) After the coming into force of this Act, but notwithstanding Every the fact that any application has not been filed under section 17— creditor and debtor to file
 - (a) every creditor, on being required to do so by a notice in writing a true and by any of his debtors, shall, within one month from the date of the ment before receipt of such notice, file before the Board referred to in sub-section Board.

 (3) of section 17 a true and correct statement of all his claims against such debtor, and shall at the same time send a copy thereof to such debtor, and
 - (b) every debtor, on being required to do so by a notice in writing by any of his creditors, shall, within two months from the date of the receipt of such notice file before the Board referred to in sub-section (3) of section 17 a true and correct statement—
 - (i) of all the debts owed by such debtor;
 - (ii) whether he holds any land used for agricultural purposes and whether he has been cultivating land personally;
 - (iii) of his income from agriculture and from sources other than agriculture in the year preceding the date of the notice.

The debtor shall at the same time send a copy of such statement to such creditor.

- (2) Every debtor or creditor giving a notice under sub-section (1) shall at the same time send a copy thereof to the Board.
- (3) In awarding the costs of any proceeding in respect of any application made under section 17 the Board may, on being satisfied that the statement required to be filled under sub-section (1) was, without sufficient cause, not filed within the time specified therein, direct the party in default to bear the whole or any portion of the costs of such proceeding.
- 20. If the payment of a debt due by a debtor is guaranteed by a Application surety or if a debtor is otherwise jointly and severally liable for any by debtor debt along with any other person and if the surety or such other person severally is not a debtor, the debtor may make an application under sub-section (1) liable. of section 17 for relief in respect of such debt and the Board may after consideration of the facts and circumstances of the case proceed with the adjustment of debts under this Act so far as such applicant is concerned.

Assignees from nondebtor not entitled to benefit of this Act. 21. No application shall lie under section 17 for adjustment of any debt due from a debtor to whom such debt has been transferred or assigned after 1st January 1938 if such debt was originally incurred by any person who is not himself a debtor.

Statement of debts to be included in application.

- 22. (1) An application made by a debtor under sub-section (1) of section 17 shall contain a statement of debts, in the prescribed form, which shall include the following:—
 - (a) the name of the place where he ordinarily resides;
 - (b) the names and addresses of his creditors, the total amount claimed by each creditor to be owing to him in respect of each debt, so far as it is known to the debtor, and a note whether each such claim is admitted by the debtor;
 - (c) the history of each such debt with particulars of the original principal and the rate of interest chargeable;
 - (d) details of any debts for which the debtor is liable as a surety or is liable with other persons as a joint debtor or joint surety, together with the names and addresses of all such persons;
 - (e) particulars of all the debtor's property, both movable and immovable, including the property situate outside the Province and claims, if any, due to the debtor, a specification of its value and of the places where it may be found and details of any attachment, mortgage, lien or charge subsisting thereon, together with the names and addresses of the co-sharers, if any, of the debtor;
 - (f) particulars of any property as in clause (e) which has been transferred by the debtor together with the name and address of the transferee; and
 - (g) a declaration that all his debts and all his properties have been included in the statement.
- (2) An application made by a creditor under sub-section (2) of section 17 shall contain a statement of debts, in the prescribed form, which shall include the following:—
 - (a) the name of the place where the debtor ordinarily resides;
 - (b) the total amount of every debt claimed by the creditor to be owing to him from the debtor;
 - (c) the history of each such debt and the particulars of the original principal and the rate of interest chargeable;
 - (d) the names and addresses of the other creditors so far as they are known to the creditor; and
 - (e) particulars, so far as they are known to the creditor, of the debtor's property including the property situate outside the Province.
- (3) Notwithstanding anything contained in section 3 a statement filed under this section shall contain the amount and particulars of all debts specified in that section due by the debtor.

- (4) The Board may return for amendment any application if it is not complete and in proper form.
- 23. (1) If any debtor and any or all of his creditors arrive at Application a settlement in respect of any debt due by the debtor to the creditor, the settlement. debtor or any of the creditors may, within thirty days from the date of such settlement make an application for recording such settlement to the Board to which an application under section 17 lies.

- (2) Every such application shall be in the prescribed form, and shall be signed and verified in the prescribed manner. It shall be accompanied with a court fee of Re. 1.
- (3) On receipt of such application the Board shall after giving a notice in the prescribed manner to the creditor or the debtor, as the case may be, and after making such enquiry as it thinks fit, if it is satisfied that the settlement arrived at is bona fide and is not made with intent to defeat or delay any of the creditors of the debtor, and is in the interest of the debtor and that the debtor is a person who fulfils the conditions referred to in clauses (a) and (b) of sub-section (1) of section 35 record such settlement and certify the same. Every such settlement so recorded and certified shall be binding and shall not be re-opened.
- (4) After the Board has recorded and certified a settlement under sub-section (3), the Board shall call upon the debtor to make a declaration whether there are any other debts due by the debtor which are not included in the settlement. If the debtor makes a declaration that there are no such debts, the Board shall make an award under section 54 in terms of the settlement.
- (5) If the Board is satisfied, after recording such settlement, that there are other debts due from the debtor which are not included in the settlement, the Board shall treat the application made under subsection (1) as an application for adjustment of debts made to it under section 17.
- 24. Notwithstanding anything contained in the preceding sections, Settlement if during the pendency of proceedings before a Board a settlement is during the arrived at between a debtor and all his creditors and if the Board is pendency of satisfied that the settlement has been made by the debtor voluntarily before the and is for his benefit, the Board may make an award in terms of such Board. settlement. The court fee payable on such award shall be Re. 1 and shall be payable on it before it is transmitted to the court under section 61.

25. Any settlement of a debt due from a debtor to any creditor, Settlement arrived at after the establishment of a Board under section 4 for the to be void. local area in which he ordinarily resides or for the class of debtors to which he belongs shall be void and shall not be recognised by any Board or Court either as an acknowledgment or otherwise unless it is certified

by the Board under section 23 or unless an award has been made in terms thereof under section 24.

Application under section 17 or 23 to be made only by a debtor whose debts are not more than Rs. 15,000.

26. No application under section 17 or section 23 shall be entertained by the Board on behalf of or in respect of any debtor, unless the total amount of debts claimed as being due from him on 1st January 1939 is not more than Rs. 15,000.

Withdrawal of application.

27. An application for adjustment of debts under section 17 or an application for recording a settlement under section 23 shall not be withdrawn without the leave of the Board.

Consolidation of applications.

28. Where two or more applications for adjustment of debts under section 17 are presented by or against the same debtor or where such separate applications are presented against joint debtors, all such applications shall be consolidated.

Power of transfer.

29. Notwithstanding anything contained in section 17, a Subordinate Judge of the First Class or a District or Joint Judge appointed to exercise the powers under sub-section (4) (b) of that section for any local area may on the application of any person or on his own motion transfer at any stage of the proceedings any application for the adjustment of debts pending before any Board established within the local limits of such Judge to another Board within such limits.

Continuation of proceedof party.

30. If any party to the proceedings before the Board dies, ings on death the proceedings shall, unless the Board otherwise directs, be continued after the legal representatives of such deceased party are brought on the record.

Service of notice on creditors to submit statement of debts.

- On receipt of an application for adjustment of debts the Board shall in the prescribed manner—
 - (a) give a notice to the debtor (unless the debtor is himself an applicant) and to every creditor (other than the creditor who is himself an applicant) whose name and address are given in the application, and
 - (b) publish a general notice,

requiring the debtor and all creditors to submit a statement in the prescribed form within one month from the date of the service of the notice or the publication of the general notice, whichever is later:

Provided that if the Board is satisfied that the debtor or any creditor is for good and sufficient cause unable to comply with the notice within the time specified therein, it may extend the period for the submission of the statement.

- 32. (1) Every debt due from a debtor who ordinarily resides within Debts in the local area for which a Board is established under section 4 or who respect of belongs to a class of debtors for which a Board is established under the application said section, in respect of which no application has been made under for adjustsection 17 within the period specified in sub-section (1) of the said section ment or settlement is 17, or in respect of which no application for recording a settlement made to is made under section 23 within the period specified in the said section 23 be void. or in respect of which an application made to the Board is withdrawn under section 27, and every debt due from such debtor in respect of which a statement is not submitted to the Board by the creditor in compliance with the provisions of section 31 shall be deemed to have been duly discharged, unless the Board is satisfied that for good and sufficient cause the creditor did not make an application under section 17 or was unable to comply with the provisions of section 31.
- (2) Nothing in this section shall apply to any debt due from any person who has by his declaration, act or omission intentionally caused or permitted his creditor to believe that he is not a debtor for the purposes of this Act and that no application under section 17 can be entertained by any Board in respect of any debt owed by such person to such creditor by reason of the provisions of section 26.
- 33. (1) Every debtor by or against whom an application is made Duties of under section 17 or who is a party to an application made under debtor to section 23 shall produce all books of accounts and shall give such inventories of his property and such lists of his creditors and debtors and of the debts due to and from him, submit to such examination in respect of his property or his creditors, attend at such time before the Board, and generally do all such things in relation to his property as may be required by the Board or as may be prescribed.
- (2) It shall also be the duty of every creditor to produce such books of accounts, to submit to such examination and to supply such information in respect of the debt due to him by the debtor, as may be required by the Board or as may be prescribed.
- 34. (1) The Board may also on the application of the debtor or The Board any creditor summon before it in the manner prescribed any other person may summon any other known or suspected to have in his possession any property belonging person. to the debtor, or supposed to be indebted to the debtor, or any person whom the Board may deem capable of gving information in respect of the debtor, his dealings or property; and the Board may require any such person to produce any documents in his custody or power relating to the debtor, his dealings or property.
- (2) If any person so summoned refuses to come before the Board at the time appointed, or refuses to produce any document, having no lawful impediment made known to the Board and allowed by it, the Board may, by warrant, cause him to be apprehended and brought up for examination.

(3) The Board may examine any person so brought before it concerning the debtor and his dealings and property.

Preliminary issues.

- 35. (1) On the date fixed for the hearing of an application made under section 17, the Board shall decide the following points as preliminary issues :--
 - (a) whether the person for the adjustment of whose debts the application has been made is a debtor;
 - (b) whether the total amount of debts claimed as being due from such person on 1st January 1939 does not exceed Rs. 15,000.
- (2) If the Board finds that such person is not a debtor or that the total amount of his debts claimed as being due from such person on 1st January 1939 is more than Rs. 15,000 the Board shall diamiss the application forthwith:

. Provided that before the application is so dismissed the creditors or any of them may remit any specific portion of their claim so as to reduce the total amount of the debts of all the creditors claimed as being due from them on 1st January 1939 to a sum not exceeding Rs. 15,000. In such case the Board shall not dismiss the application but shall proceed further with the same.

- (3) The debts in respect of which such portion of the claim is remitted under sub-section (2) shall for all purposes be deemed to be extinguished.
- (4) The finding of the Board on the preliminary issue that the total amount of the debts due by such person on 1st January 1939 does not exceed Rs. 15,000 shall not, subject to the proviso to sub-section (2), affect the power of the Board to make an award under section 24 or 54 for any sum exceeding Rs. 15,000.

Court fee to be refunded to creditor.

36. If an application made by a creditor under sub-section (2) of section 17 is dismissed under section 35 on the ground that the total amount of the debts claimed from a debtor as being due on 1st January 1939 is more than Rs. 15,000, the Board shall direct the amount of the court fee paid by the creditor making the application to be refunded to the creditor.

Transfer of and applications to Board.

37. All pending suits and applications for execution before any pending suits civil court in which the question involved is the recovery of any debt from a person who is a debtor under this Act and all proceedings arising in or out of such suits or applications, if such person ordinarily resides in any local area for which a Board is established under section 4 or belongs to a class of debtors for which a Board is established under the said section shall, if the total amount of debts due from such debtor is not more than Rs. 15,000 be transferred to the Board to which an application for adjustment of debts of such person under section 17 lies. The decision of the Court on the points whether such person is a debtor under this Act, and whether such amount of his debts is not more than Rs. 15,000 shall be final.

No such transfer shall be made unless notice is given to all the parties to such suit or applications.

- 38. If the Board finds the person making the application under Taking of sub-section (1) of section 17 or the person against whom an application accounts is made under sub-section (2) of section 17 to be a person—
 - (a) who is a debtor, and
 - (b) the total amount of debts claimed as being due from whom on 1st January 1939 is not more than Rs. 15,000,

the Board shall proceed to take accounts in the manner hereinafter provided and determine the amount due to each of the creditors at the date of the application made under section 17 for the adjustment of debts.

- 39. In an application for the adjustment of debts if the amount Examination of the creditor's claim is disputed, the Board shall, when taking accounts, of creditor examine both the creditor and the debtor as witnesses, unless for reasons or debtor. to be recorded by it in writing, it deems it unnecessary so to do.
- 40. The Board shall inquire into the history and merits of the case Board to from the commencement of the transactions between the parties and inquire into the persons (if any) through whom they claim, out of which the claim history and has arisen:

Provided that where transactions between the parties have commenced more than 20 years before the coming into force of this Act, any settlement of accounts which has been last arrived at between the parties before the said 20 years and which is in writing and bears the signature of the debtor or the person through whom the liability is derived shall be accepted as binding between the parties and no inquiry into the history and merits of the case shall be made prior to the date of such settlement.

- 41. When the amount of the claim is admitted by the debtor and Board not the Board, for reasons to be recorded by it in writing, believes that bound to such admission is true and made voluntarily, the Board shall not be inquire, if the claim is bound to inquire in the manner provided in section 40 but may do so admitted. if it thinks fit. In other cases, the Board shall be bound to inquire as aforesaid.
- 42. (1) When the Board inquires into the history and merits of Mode of a case under section 40, it shall, notwithstanding any agreement between taking the parties or the persons (if any) through whom they claim, as to accounts allowing compound interest or setting off the profits of mortgaged property without an account in lieu of interest, or otherwise determining the manner of taking the account, and notwithstanding any statement

or settlement of account, or any contract purporting to close previous dealings and create a new obligation, open and take the account between the parties from the commencement of the transactions.

- (2) The Board shall take the account under sub-section (1) according to the following rules, namely:—
 - (a) Separate accounts of principal and interest shall be taken;
 - (b) In the account of principal there shall be debited to the debtor such money as may from time to time have been actually received by him or on his account from the creditor, and the price of goods, if any, sold to him by the creditor, as part of the transactions;
 - (c) In the account of principal there shall not be debited to the debtor any sum in excess of a sum due or to accrue due under a decree which the debtor may have agreed directly or indirectly to pay in pursuance of any agreement relating to the satisfaction of the said decree;
 - (d) In the account of principal there shall not be debited to the debtor any accumulated interest which has been converted into principal at any statement or settlement of account or by any contract made in the course of the transactions;
 - (e) (i) In the case of transactions which were commenced before the 1st January 1931, the Board shall take accounts in accordance with the provisions of this sections up to 1st January 1931, provided that in the account of interest there shall be debited to the debtor yearly interest on the balance of the principal for the time being at 12 per cent. per annum or at the agreed rate whichever is lower. On taking such accounts, the amounts found due on 1st January 1931 in respect of the principal as well as in respect of the interest shall, each separately, be reduced by 40 per cent. Notwithstanding that a decree or order of a civil court has been passed in respect of any such amount or portion thereof, provided that if such transactions had commenced after 1st January 1930, the reduction in both the amount of the principal and interest found due shall be by 30 per cent. The amount so reduced shall be taken to represent the amount due in respect of the principal and interest on 1st January 1931. Separate accounts shall thereafter be taken of the principal and interest up to the date of the application provided that the interest shall be calculated at the rate agreed to between the parties or 9 per cent. per annum whichever is lower;
 - (ii) in the case of transactions which commenced on or after 1st January 1931 in the account of the interest there shall be debited to the debtor yearly interest on the balance of principal for the time being outstanding at 9 per cent. per annum or at the agreed rate whichever is lower;

(iii) if under any decree passed between the parties the rate of interest allowed on the amount of the principal found due under paragraph (i) or (ii) above is lower than that allowable under this clause, interest on such amount shall be debited at the rate allowed by such decree;

(iv) In taking accounts under this clause interest to be calculated.

shall be simple interest;

(f) All money paid by or on account of the debtor to the creditor or on his account, and all profits, service or other advantages of every description, received by the creditor in the course of the transactions (estimated, if necessary, at such money-value as the Board in its discretion may determine) shall be credited first in the account of interest, and when any payment is more than sufficient to discharge the balance of interest due at the rate specified in clause (e), the residue of such payment shall be credited to the debtor in the account of principal;

(g) The accounts of principal and interest shall be made up to the date of the institution of the application, and the aggregate of the balance (if any) appearing due on both such accounts against the debtor on that date shall be deemed to be the amount due at that date, except when the balance appearing due on the interest-account exceeds that appearing due on the principal-account, in which case double the latter balance shall be deemed to be the amount then due.

- 43. When in the course of any proceedings under this Act the Board When books finds that there are reasonable grounds to believe that a creditor has are not in his possession or under his control any books of account or any other produced document which is material to any transaction in any proceedings before Court to the Board and such books or document is not produced by such creditor they are before the Board in such proceedings, the Board shall presume that such unfavourable books or document if produced would be prejudicial to the interest to creditor.
- 44. Where the mortgaged property is in the possession of the mort- In certain gagee or his tenants other than the mortgagor, and the Board is unable cases rent to determine what profits have been actually received, it may fix a fair charged in rent for such property and charge to the mortgagee such rent as profits lieu of profits, for the purpose of section 42:

45. (1) Notwithstanding anything contained in any law, custom or Board to contract, whenever it is alleged during the course of the hearing of an declare transaction made under section 17 that any transaction purporting to purporting to be a sale of land belonging to a debtor was a transaction in the nature to be in the of a mortgage, the Board shall declare the transaction to be so, if the mortgage.

Board is satisfied that the circumstances connected with that sale-deed showed it to be in the nature of a mortgage.

- (2) Nothing in this section shall apply to-
 - (i) any transaction entered into before 1st January 1927;
- (ii) any transaction which has been adjudged to be a sale by a decree of a court of competent jurisdiction; and
- (iii) any property belonging to a debtor and purchased by a third person from the transferee of a debtor on or before the 15th day of February 1939.

Decretal debts how far binding.

- 46. (1) Subject to the provisions of sub-sections (2) and (3), if any decree or order is passed by a competent court in respect of any debt, the amount due under such decree in respect of both the principal and interest shall, in taking accounts under section 42, be deemed to be binding between the parties.
- (2) In so far as such decree or order is in respect of transactions entered into before 1st January 1931, the amount of principal and interest found due on 1st January 1931 shall be reduced by 40 per cent. as provided in paragraph (ii) and the rate of interest shall be modified as provided in paragraph (iii) of clause (e) of sub-section (2) of section 42, provided that if the said transactions commenced after 1st January 1930 the reduction shall be by 30 per cent.
- (3) In so far as such decree or order is in respect of any transactions entered into on or after 1st January 1931 the rate of interest awarded by such decree or order shall be modified as provided in paragraph (ii) and paragraph (iii) of clause (e) of sub-section (2) of section 42.

Notice to Collector, co-operative societies, Registrar and local authorities.

- 47. (1) On the receipt of an application for the adjustment of debts the Board shall give a notice to the Collector requiring him to state to the Board within the time prescribed the amount of the debt due by the debtor to Government.
- (2) The Board shall also give a similar notice to any, co-operative society or any local authority to which or to whom any debt may be due by the debtor and also to any person who is entitled to maintenance from the debtor, under a decree or order passed by a competent court. In the case of any debt due to a co-operative society the Board shall also give notice to the Registrar of Co-operative Societies or to such officer as the Registrar may nominate in this behalf.
- (3) On the receipt of such notice the Collector, the co-operative society or the local authority, or the person entitled to maintenance, as the case may be, shall, for the purposes of enabling the Board to determine the paying capacity of the debtor under section 51, within the time prescribed, intimate to the Board the total amount of the debt due by

the debtor as also any recurring liability against such debtor in respect of such debt.

- (4) The Collector and the co-operative society shall intimate to the Board the amount of remission which the Provincial Government or the co-operative society, as the case may be, is willing to give in respect of the debt.
- (5) It shall not be lawful to the Provincial Government or the co-operative society to reduce the amount of remission intimated to the Board under sub-section (4).
- 48. The Board shall in \mathbf{the} hereinafter provided Board's duty manner determine-
 - (1) the particulars of the property belonging to the debtor,

to determine the particulars, value, etc., of the property.

- (2) the value of the said property,
- (3) the particulars of any alienations of or incumbrances on the said property,
 - (4) the paying capacity of the debtor.
- 49. Any alienation of property made or any incumbrance created Fraudulent thereon by a debtor with intent to defeat or delay any of his creditors alienations shall be void for the purposes of this Act and shall be declared to be so or incumbrances. by the Board.

Nothing in this section shall impair the rights of an alienee or the holder of an incumbrance in good faith and for consideration.

50. The value of the property and other assets of the debtor shall for Value of the purpose of ascertaining the paying capacity of a debtor under section property of 51 be determined by the Board as follows:

(1) In determining the value of the property or assets of a debtor, in prescribed the property or assets which are exempt from attachment in execution manner. of a decree of a civil court under the Code of Civil Procedure, 1908, shall not be taken into account.

- (2) In determining the value of the immovable property of a debtor which is subject to the liability of recured debts, deduction shall be made from such value in respect of the amount of the debte due to Government and to local authorities which, under any law for the time being in force, are a charge on such immovable property or are recoverable from the debtor as dues of the current year's land revenue.
- (3) In determining the value of the property which is not subject to the liability of secured debts the amount of the debts mentioned in section 3 except debts due to Government and to local authorities referred to in paragraph 2 above shall be deducted.



(4) In the case of lands to which section 73A of the Bombay Land Bom. Revenue Code, 1879, applies the market value of such lands shall be V of calculated as if the restriction on the transfer of such lands provided ¹⁸⁷⁹, by the said section was not in operation:

Provided that nothing in this paragraph shall be deemed to provide that such lands shall be transferable without the permission of the Collector under the said section.

(5) Subject to the provisions of the above paragraphs the Provincial Government may by rules prescribe the manner in which the market value of the property and assets of the debtor shall be determined.

Paving capacity.

- 51. The paying capacity of the debtor, if any, shall, for the purposes of this Act, be deemed to be the aggregate amount consisting of the following items:—
 - (a) if the amount of the secured debts of a debtor found due on taking account under this Act is less than 80 per cent. of the value of his immovable property as determined under section 50, but such debts are secured, the difference between the amount of such debts and 80 per cent. of the value of such property;
 - (b) eighty per cent, of the value of the immovable property of the debtor which is not subject to the liability of secured debts as determined under section 50;
 - (c) eighty per cent. of the value of other assets:

Provided that when any portion of such assets yields income but the market value of such portion cannot be determined, the value of such portion shall be the amount of the income capitalised at six per cent. per annum.

Petts payable by debtors to be scaled down.

- 52. (1) Notwithstanding any law, custom, contract or decree of a court to the contrary, all debts payable by a debtor at the commencement of this Act shall be scaled down in the manner hereinafter provided.
- (2) If all the debts due by a debtor are unsecured, such debts as are found due on taking accounts under this Act shall be scaled down pro rate to the value of the paying capacity of the debtor.
- (3) If all the debts due by a debtor are secured debts, and the total amount of such debts found due on taking accounts under this Act is more than eighty per cent. of the value of the property belonging to the debtor, such debts shall be scaled down pro rata to eighty per cent. of the value of such property.
- (4) If the debts due by a debtor are both secured and unsecured, and if the total amount of the secured debts found due on taking accounts under this Act is more than eighty per cent. of the value of

the property on which such debts are secured, the secured debts shall be scaled down pro rata to eighty per cent. of the value of the property on which such debts are secured and the unsecured debts shall be scaled down pro rata to eighty per cent. of the value of the other property belonging to the debtor over which no debts are secured.

- 53. (1) The amount of debts so scaled down shall for the purposes No recovery of this Act be deemed to be the amount due by the debtor in respect of of amount in excess of debts scaled down.
- (2) No sum in excess of the amount of debts so scaled down shall be recoverable from the debtor or from any property belonging to him, nor shall the debtor be liable to arrest nor shall his property be liable to be attached, sold or proceeded against in any manner in execution of any decree or order against him in so far as such decree or order is for an amount in excess of the amount scaled down under this Act.
- 54. (1) After determining the amount of debts scaled down in the Award. manner provided in section 52, the Board shall make an award.
- (2) The award shall be in the prescribed form and shall include the following particulars:—
 - (a) a list of the properties of the debtor both movable and immovable with particulars of any mortgage, lien or charge subsisting thereon;
 - (b) particulars of all debts secured and unsecured which have been scaled down in accordance with section 52 together with the details of the properties on which secured debts are charged:

Provided that the amount of the secured debts so scaled down shall be charged on the properties on which they may have been secured; and the amount of unsecured debts shall be charged on the remaining property of the debtor:

Provided further in the case of debts in respect of which a settlement has been reached and certified, the amount of debts shall be as agreed to in the said settlement;

- (c) particulars of all debts of the kind specified in section 3;
- (d) particulars of any alienation or incumbrance declared to be void under section 49;
 - (c) the amount to be paid to each creditor for each debt due to him;
- (f) the manner in which and the times at which the amounts referred to in clauses (b) and (c) shall be paid;
 - (g) the priority in which the debts shall be paid:

Provided that in fixing the priority the following order shall be followed:—

- (i) debts due to Government, which are charged on the immovable property belonging to the debtor or which are recoverable as the current years land revenue,
- (ii) debts due to local authorities, which are charged on the immovable property belonging to the debtor or which are recoverable as the current year's dues,
- (iii) loans given by resource societies or by persons authorised to advance loans under section 78 for the financing of crops after the coming into force of this Act, and other loans given for financing crops after 1st January 1939 and before the date of the coming into force of this Act.
 - (ir) secured debts,
- (r) debts due to Government, local authorities and other bodies including co-operative societies, and recoverable as arrears of land revenue,
 - (vi) other debts due to co-operative societies,
 - (vii) unsecured debts:

Provided further that in the case of debts falling under the same class, their priority inter se shall be determined in the order of the dates on which such debts may have been incurred. If such debts are incurred on the same date, they shall be paid pro rata;

(h) the instalments in which the debts shall be paid:Provided that the total annual instalments shall not exceed 25:

Provided further that in directing in what instalments the debts shall be paid the Board shall ascertain the net annual income of the debtor and the annual instalments payable by the debtor shall not exceed his net annual income.

Explanation.—For the purposes of this clause the net annual income of the debtor shall mean the balance of his annual income after deducting such sum as may be considered necessary for the maintenance of the debtor and his dependents and the sum due by the debtor to pay the debts due to Government and to local authorities, and to pay off loans borrowed for the purpose of financing of crops;

(i) the conditions subject to which the immovable property, if any, in possession of the creditor shall be delivered to the debtor:

Provided that the Board shall not refuse to pass an order for the delivery of possession merely on the ground that the time fixed for the payment of the secured debt has not arrived or on the ground that the secured debt has not been completely dicharged or on both;

(j) the rate of interest, if any, payable on each amount referred to in clause (e):

Provided that such rate shall not exceed the rate notified in this behalf by the Provincial Government not exceeding 6 per cent. per annum or any rate agreed between the parties when the debt was originally incurred or rate allowed by the decree in respect of such debt, whichever is lowest;

- (k) the property of the debtor which and the conditions subject to which such property shall be liable to be sold for the recovery of any particular debt ;
 - (l) costs, if any, to be paid by the parties:

Provided that, where the debtor has failed to make an application under section 17 within the period of one year from the date on which a Board is established under section 4 and the creditor has made an application after such period, the whole of the costs shall be directed to be paid by the debtor:

Provided further that, if an application is rejected in consequence of untrue or incorrect statement made or information supplied by the creditor the costs shall be directed to be paid by the creditor making such statement or giving such information;

- (m) the parties by whom and the manner in which the court fees due shall be paid; and
- (n) any other matter which in the opinion of the Provincial Government may be necessary for the purpose of doing complete justice or making a complete adjustment of debts and which the Provincial Government may by rules prescribe to be included in awards.
- 55. (1) Before making the award under sub-section (1) of section 54 Board to the Board may call upon the creditors to state in writing whether they propere a agree-

- (a) that all the debts of the debtor should be so further scaled effects through the down as to be reduced to a sum not exceeding half the value of the Provincial immovable property of the debtor; and
- (b) that they shall receive in lieu of all the debts due to them bonds issued by the Bombay Provincial Land Mortgage Bank registered under the Bombay Co-operative Societies Act, 1925, or by such other hank as may be specified by the Provincial Government by a notification in the Official Gazette, such bonds being guaranteed by the Provincial Government and being equivalent in value to the sum referred to in (a).
- (2) If all the creditors agree to the aforesaid conditions, the Board shall prepare a scheme for the adjustment of the debts accordingly and shall send the scheme to the said bank for acceptance. If the said Bank agrees to accept the proposal, the Board shall make an award in the form prescribed directing that the sum so scaled down shall be charged on all the immovable property of the debtor and the bonds for the amount referred to in sub-section (1) shall be issued to the creditor in full estisfaction of all the debts due to them from the debtor.

- (3) All sums due under an award made in favour of the Bank under sub-section (2) shall be recoverable as arrears of land revenue.
- (4) Notwithstanding anything contained in this Act, no appeal shall lie against an award made under sub-section (2).

Debts not to be scaled down in ease of cellusion. 56. If the Board making an award under section 54 is at any stage of the proceeding satisfied that any claim by a creditor in such proceeding had been put forward in collusion between the debtor and such creditor with a view to defeat the lawful claims of any of the other creditors the Board shall not scale down any of the debts of such debtor in the manner provided in section 52 but shall make an award for the full amount of the debts due from such debtor.

Re-opening of award and readjustment of debts. 57. If, after an award is made under section 54, the Board finds on an application made to it by any party or otherwise, that the debtor has other property which was not disclosed to the Board when the award was made, or that any property included in the award did not belong to the debtor, the Board may, notwithstanding anything contained in this Act, re-open the award and re-adjust the debts in accordance with the provisions of this Act:

Provided that where the Board is satisfied that the non-disclosure of such property was in consequence of any fraud on the part of the debtor, the Board in revising the award shall not give the debtor the benefit of section 52.

Reference by the Board.

- 58. (1) Where, at the hearing of any application under this Chapter, any question of law or usage having the force of law arises, on which the Board entertains reasonable doubt, the Board may either of its own motion or on the application of any of the parties, draw up a statement of the facts of the case and the point on which doubt is entertained, and refer such statement with its own opinion on the point for the decision of the First Class Subordinate Judge, within whose jurisdiction the Board may have been established.
- (2) An appeal against an award which embodies the decision of the First Class Subordinate Judge on such reference shall lie to the District Court notwithstanding anything contained in section 9.

Amount ordered in the award to be held to be the amount due in all suits and proceedings.

59. Notwithstanding any law or custom or contract to the contrary, the amount ordered to be paid to any creditor or bank by any debtor in any award made under section 24, 54 or 55 shall be held to be the amount due from such debtor to the creditor or the bank, as the case may be, on the date of such award in any suit or proceeding to which any of the parties to the award is a party.

Court fees to be charged. 60. (1) An award made under section 54 or 55 shall direct the party who has been ordered to pay the costs to pay one-half of the difference between the court fee actually paid on the application for adjustment of debts or in the case of suits and applications for execution transferred

to the Board under section 37 on the plaint in the suit or on such application and the fee which would have been payable under section 7 of the VII of Court-fees Act, 1870, as if the application for adjustment of debts, or the suit or the application for execution had been a suit for money and the total amount of the debts declared due from the debtor had been the amount claimed in such suit:

Provided that where the costs are payable by any co-operative society or by any bank referred to in section 55 the amount of the court fees payable by such society or bank shall not be directed to be recovered from such society or bank:

Provided further that where an award includes any sum in respect of which a creditor had obtained a decree of a civil court, allowance shall be made in calculaing the amount of the court fee payable in respect of the award for the court fee already paid in respect of such decree.

- (2) Notwithstanding anything contained in any law such fee shall be the first charge on the property of the party ordered to pay the costs.
- 61. (1) The Board shall transmit an award made under section 24, Transmission of award to Court:

Provided that before the award is so transmitted the balance of court 'fees payable under the award shall be paid by the party ordered by the Board to pay the same.

- (2) If the debtor fails to pay the balance of the amount of court fees ordered to be paid by such debtor, the Board may transmit the awards to the Court on the application made by any creditor if such creditor pays such amount of court fees. Any amount so paid by the creditor shall be added by the Board to the amount payable by the debtor under the award.
 - 62. (1) The Court shall register any award transmitted by the Board—Award to be
 - (i) if within the period provided in this Act, no appeal is filed registered. against the award under section 9, or
 - (ii) if an appeal is filed under the said section and such appeal is dismissed, or
 - (iii) if the award is modified by the Court, in such modified form, or
 - (iv) if the award is transmitted to the Board for reconsideration of any points, after considering the decision of the Board on the said points and after making such modifications in the award as it thinks fit.
- (2) From the date on which the award is registered under sub-section (1), it shall, in supersession of all transactions between the parties and in supersession of all previous decisions of a civil court in respect of the debts mentioned in it, be binding on the debtor and his creditors and the successors in interest of such debtor and creditors.

Recovery of smount due under an award. 63. The award so registered shall be executable as a decree of the Court in which it is registered:

Provided that an amount due under an award made under section 55 shall also be recoverable in the manner specified in sub-section (3) of the said section:

Provided further that nothing in this section shall affect the right of Government or a local authority or a co-operative society to have recourse to any mode of recovery allowable by any law for the time being in force.

Postponement of payment of instalment in case of remissions, etc.

- 64. (1) Whenever from any cause the payment of one-half or more of the land revenue payable to the Provincial Government is suspended or remitted, the payment of the whole of the instalment due for that year and the full amount of the instalment due for each subsequent year under an award made under section 24 or 54 shall be postponed for one year.
- (2) Whenever from any cause the payment of any portion less than one-half of the land revenue payable to the Provincial Government is suspended or remitted one-half of the amount of the instalment for that year and the full amount of the instalment due for each subsequent year under an award made under section 24 or 54 shall be postponed for one year.

No alienation by the debtor to be binding. 65. Notwithstanding any law or contract but subject to the provisions of section 66 no alienation made by a debtor who is a party to an award made under this Act of any property included in such award shall be valid except with the previous sanction of the Provincial Government.

Board or Court may order sale of debtor's property in liquidation of his debt. 66. Notwithstanding anything contained in this Act, if the Board to which an application for adjustment of detts lies under section 17 in respect of the debts of any debtor, or the Court before which an appeal lies against the award is at any time satisfied that it is in the interest of a debtor that any part of his property should be sold in liquidation of his debt or part thereof, such Board or Court may order the sale of such part of the property for such purpose. The property ordered to be sold under this section shall be sold by the Collector in the manner prescribed:

Provided that the part of the property ordered to be sold under this section shall not exceed the part liable to be sold under sub-section (3) of section 68.

Pleaders etc. excluded from appearance.

67. No pleader, vakil, or mukhtyar and no advocate or attorney of a High Court, shall be entitled to appear on behalf of any party in any proceeding before the Board under this Act:

Provided that if the Board after examining the parties to any proceeding before it is of opinion that any of the parties is not

sufficiently competent to represent his case and that in the interest of justice it is necessary to allow such party the assistance of any pleader, vakil or mukhtyar, or advocate or attorney of a High Court the Board may allow such party at its own cost to be represented by a pleader, vakil or mukhtyar, or advocate or attorney of a High Court:

Provided further that a woman exempted from personal appearance IV of in a court under section 132, Code of Civil Procedure, 1908, shall be entitled to appear in any proceeding before the Board through any agent duly appointed for the purpose.

CHAPTER IV.

INSOLVENCY PROCEEDINGS.

- 68. (1) If at any stage of the proceedings under Chapter III the Board to Board is satisfied that the paying capacity of the debtor is inadequate debtor to pay the total amount of his debts as scaled down under section 52, insolvent in or if for any reason the Board finds that the debts due from the debtor certain circannot be liquidated by annual instalments not exceeding twenty-five in number, the Board shall make an order adjudicating the debtor to be an insolvent.
- (2) If the Court to which an award is transmitted for execution finds that the two consecutive or any three instalments cannot be recovered by the sale of the moveable property of the debtor, the Court may pass an order adjudicating the debtor to be an insolvent.
- (3) After the debtor has been adjudicated an insolvent either by the Board or the Court, the Board or the Court, as the case may be, shall direct that one-half of the property of the debtor liable to attachment and sale under section 60 of the Code of Civil Procedure, 1908, shall be immediately sold free of all incumbrances in liquidation of all the debts outstanding against such debtor:

Provided that if after one-half of the assets of the debtor are sold the property remaining with the debtor exceeds 6 acres of irrigated land or 18 acres of dry land or any land assessed at Rs. 30 whichever is greater then all the excess property over and above the aforesaid land shall also be sold free of all incumbrances.

69. The order of adjudication made under section 68 whether by the Procedure in Board or the Court in appeal shall be deemed to be an order made by insolvency a competent Court in exercise of its powers under section 27 of the proceedings.

- 70. The proceeds realised by the sale of the property of the insolvent under section 68 shall be distributed in the order of priority specified in the provisoes to clause (g) of sub-section (2) of section 54.
- Bar to appli-71. No application or proceeding in regard to the insolvency of the cation in insolvency in debtor shall lie in or shall be dealt with by any other Court. other Courts.
- Appeals barred.
- 72. No appeal shall lie from any order passed under this Chapter except on the ground that the insolvent has failed to disclose all the material facts relating to his assets and liabilities.

CHAPTER V.

MISCELLANEUS.

Dar of civil suits or proceedings.

- 73. Except as otherwise provided by this Act and notwithstanding anything contained in any other law no Civil Court shall entertain or proceed with any suit or proceeding in respect of-
 - (i) any matter pending before the Board or the Court under this Act, or
 - (ii) the validity of any procedure or the legality of any award, order or decision of the Board or of the Court, or
 - (iii) the recovery of any debt made payable under the award.

Application Act.

74. Save as expressly provided in this Act the provisions of the of Limitation Indian Limitation Act, 1908, shall apply to all claims in respect of debts in the proceedings under this Act as if such proceedings were proceedings in a suit in a Civil Court.

Period of proceeding before Board or Court to be excluded.

75. In computing the period of limitation for institution of any suit or proceeding in respect of any debt due from any person who is held not to be a debtor by the Board or in an appeal by the Court, the period during which the proceedings were pending before the Board or Court or the Collector in respect of such debt shall be excluded.

Certificate to the creditor who borrowed sums from another for lending them to debtor.

- 76. (1) If any creditor claims that for advancing the amount of any debt of a debtor he had borrowed the whole or part of the amount of such debt from another person, the Board shall grant a certificate in the form prescribed to such creditor. Such certificate shall specify the name of such creditor, the amount claimed as due by him from the debtor, the amount awarded and the rate of interest allowed thereon by the Board and the name of the person from whom the amount of such debt was claimed to have been borrowed.
- (2) A certificate granted under this section may be produced in any proceeding and the Court before which such proceeding is pending may

take it into consideration in awarding the claim for interest and instalments, if any, between such creditor and such person.

- 77. (1) No debtor who is a party to an award under this Act and Debtor not who is indebted to a resource society or any person authorised to advance the standing loans under section 78 shall alienate or encumber the standing crops crops, etc. or the produce of his land without the previous permission of the society or of the person, as the case may be. Any such alienation made without such permission shall be void.
- (2) Any debtor who alienates or incumbers the standing crop or the produce of his land in contravention of sub-section (1) or a person who knowingly permits such alienation or incumbrance to be created in his favour, shall, on conviction, be punishable with imprisonment which may extend to six months or with fine which may extend to Rs. 500.
- 78. (1) The Provincial Government may by notification in the Power of Official Gazette authorise in any local area any individual, joint stock Provincial Government company or other association to advance loans to debtors in respect to authorise of whose debts an adjustment has been made under this Act. individuals, joint stock
- (2) Such authority shall be granted on such conditions as may be companies or other associations
 prescribed.

- 79. The Provincial Government may by notification in the Official Power of Gazette delegate to the Collector or any other officer any of the powers Provincial Government to delegate powers to the Collector or any other officer.
- 80. The chairman and other members of a Board shall be deemed Chairman and members of be public servants within the meaning of section 21 of the Indian of Board to be public servants.
 - 81., No suit, prosecution or legal proceeding shall lie against the Indémnity. chairman or other member of a Board or against any officer of Government in respect of anything in good faith done or intended to be done under this Act.

82. Whoever-

- (a) intentionally makes any false statement in any proceeding Penalty. under this Act.
 - (b) intentionally produces before the Board any false document;
- (c) files under section 19 a statement which is false or incorrect to his knowledge; or
 - (d) abets any act punishable under this section

shall, on conviction, be liable to imprisonment which may extend to six months or to fine or to both.

Rules.

- 83. (1) The Provincial Government may from time to time make rules for the purpose of carrying into effect the purposes of this Act.
- (2) In particular and without prejudice to the generality of the foregoing provision, such rules may be made for all or any of the following purposes, namely:—
 - (a) the manner of publication of the notification under section 4 and the qualifications of persons constituting a Board under subsection (3) (iii) and the manner of appointment of assessors under sub-section (7) thereof;
 - (b) the procedure in proceedings before the Board under section 7 including the inspection of site by members of the Board and examination of witnesses on commission under sub-section (2) thereof, and on appeals before Courts under section 9;
 - (c) the form of application under section 18 and the signing and verification thereof;
 - (d) the form of statement of debts under sub-sections (1) and (2) of section 22;
 - (e) the form of application under sub-section (2) of section 23 and the manner of signing and verification thereof and the manner of giving notice under sub-section (3) of section 23;
 - (f) the manner in which the notice under section 31 shall be served or published;
 - (g) the inventories of property, lists of creditors and of the debts due to and from a debtor, the examination in respect of property or creditors, the time at which the debtor shall attend before the Board and do other things in relation to property under sub-section (1) of section 33, and the books of accounts, the examination to be submitted to and the information to be supplied in respect of the debt due to a creditor by the debtor under sub-section (2) of section 33;
 - (h) the manner of summoning persons under sub-section (1) of section 31;
 - (i) the time within which the Collector or co-operative society or a local authority or holder of a decree or order for maintenance is required to intimate to the Board the amount of the debt due by the debtor under section 47;
 - (j) the manner in which the market value of the property and assets of a debtor shall be determined under sub-section (5) of section 50;

of

- (k) the manner of determining the value of property and other assets under section 51;
- (1) the form of award under sub-section (2) of section 54 and under section 24 and sub-section (2) of section 55; and other particulars to be included in the award under section 24 and clause (n) of subsection (2) of section 54;
- (m) the manner of sale of property by the Collector under section 66;
- (n) the form of certificate to be granted to a creditor under section 76:
- (o) the conditions on which any individual, joint stock company or other association shall be authorised to advance loans under section 78.
- (3) The rules made under this section shall, subject to the condition of previous publication, be published in the Official Gazette.
- On the date on which this Act comes into force, the Bombay Repeal of Small Holders Relief Act, 1938, herein referred to as the said Act shall, Bom. VIII of 1938. notwithstanding anything contained in sub-section (3) of section 1 of the said Act, but save as provided in the provisions of section 11 of the said Act, be deemed to have expired. Any right, privilege, obligation 1938. or liability or contract referred to in section 11 of the said Act shall revive and be enforceable as provided in the said section:

Provided that in regard to persons who are debtors and in respect of whose debts an application under section 17 of this Act can be made, such rights, privileges, obligations and liabilities or contracts shall be enforceable in so far as the enforcement thereof is not inconsistent with the provisions of this Act.

85. (1) On the date on which this Act comes into force, the Dekkhan Repeal of XVII Act XVII Agriculturists' Relief Act, 1879, shall be repealed. of of 1879. 1879.

- (2) Nothing in sub-section (1) shall be deemed to affect, in regard to persons who are debtors and in respect of whose debts an application under section 17 can be made,-
 - (a) the terms or incidents of any contract made or effected before the date on which this Act comes into force;
 - (b) the validity, invalidity, effect or consequences of anything already done or suffered to be done before the aforesaid date:
 - (c) any right, title, obligation or liability already acquired, accrued or incurred before such date;

- (d) any remedy or proceeding in respect of such right, title, obligation or liability, or
- (e) anything done in the course of any proceeding pending ir. any Court on the aforesaid date;

and any such remedy or proceeding may be enforced, instituted or continued, in so far as the enforcement, institution or continuance is not inconsistent with the provisions of this Act:

Provided that such repeal shall not in any way affect the transfer under section 37 of any suits or proceedings to which such debtor was a party.

Transitory provisions.

- 86. In respect of transactions entered into before the date of the coming into force of this Act by or with—
 - (a) debtors in respect of whose debts no application can be made under section 17 of this Act, or
 - (b) persons who are not debtors,

BOMBAY ACT No. XXIX OF 1939.*

[THE BOMBAY TENANCY ACT, 1939.]

[2nd April 1940.]

An Act to provide for the protection of tenants in the Province of Bombay.

WHEREAS it is expedient to provide for the protection of tenants of agricultural lands in the Province of Bombay and for certain other purposes; It is hereby enacted as follows:—

CHAPTER I.

PRELIMINARY.

- 1. (1) This Act may be called the Bombay Tenancy Act, 1939.

 Short title,

 (2) It extends to the whole of the Province of Bombay except the City extent and commencement.
- (3) It shall come into force on such date as the Provincial Government may, by notification in the Official Gazette, appoint in this behalf.
- 2. In this Act, unless there is anything repugnant in the subject or Definitions. context.—
 - (1) "Agriculture" includes horticulture, the raising of crops or garden produce, dairy farming, poultry farming, stock breeding and grazing, but does not include cutting of grass or wood only.
- (2) "Co-operative Society" means a society registered under the provisions of the Bombay Co-operative Societies Act, 1925, or a society deemed to have been registered under the said Act.
 - (3) "Improvement" means with reference to any land, any work which adds to the value of the land and which is suitable thereto as also consistent with the purpose for which it is held; and includes—
 - (a) the construction of tanks, wells, water channels, embankments and other works for storage, supply or distribution of water for agricultural purposes;

- (b) the construction of works for the drainage of land or for the protection of land from floods or from erosion or other damage from water;
- (c) the reclaiming, clearing, enclosing, levelling or terracing of land;
- (d) the erection of buildings on the land, required for the convenient or profitable use of such land for agricultural purposes; and
- (e) the renewal or reconstruction of any of the foregoing works or alterations therein or additions thereto as are not of the nature of ordinary repairs; but does not include such clearances, embankments, levellings, enclosures, temporary wells, water channels and other works as are commonly made by the tenants in the ordinary course of agriculture.
- (4) "Land" means land which is used for agricultural purposes and includes the sites of farm buildings appurtenant thereto.
- (5) "Mamlatdar" includes a Mahalkari and any other officer whom the Provincial Government may appoint to perform the duties of a Mamlatdar under this Act.
 - (6) "Person" includes an undivided Hindu family,
 - (7) "Prescribed" means prescribed by rules made under this Act.
- (8) "Profits of Agriculture" means the surplus remaining with the cultivator after the expenses of cultivation including the wages of the cultivator working on the land are deducted from the gross produce.
 - (9) "Reasonable rent" means the rent determined under section 12.
- (10) "Rent" means any consideration, in money or kind or both, paid or payable by a tenant on account of the use or occupation of the land held by him but shall not include the rendering of any personal service.
- (11) "To cultivate personally" means to cultivate on one's own account—
 - (i) by one's own labour, or
 - (ii) by the labour of any member of one's family, or
 - (iii) by servants or hired labour under one's personal supervision or the personal supervision of any member of one's family.

Explanation I.—A tenant who is a widow or a minor or is subject to any physical or 1 ental disability shall be deemed to cultivate the land personally if it is cultivated by her or his servants or by hired labour.

Explanation II.—In the case of an undivided Hindu family, the land shall be deemed to have been cultivated personally if it is cultivated by any member of such family.

(12) "Year" means the year ending on the 31st of March or on such date as the Provincial Government may, by a notification, appoint for any locality.

Bom. V of 1879. (13) Words and expressions used in this Act but not defined shall have the meaning assigned to them in the Bombay Land Revenue Code, 1879.

CHAPTER II.

PROTECTED TENANTS.

- 3. A tenant shall be deemed to be a protected tenant in respect of Protected any land if—
 - (i) he has held such land continuously for a period of not less than' six years immediately preceding the first day of January 1938; and
 - (ii) he has cultivated such land personally during the aforesaid period.

Explanation I.—If the person who held such land on the first day of January 1938 came to hold the same by inheritance or succession from another person or if he has held such land as a tenant and is an heir to such other person, the period during which such other person held such land as a tenant shall be included in calculating the period of six years under this section.

Explanation II.—If the person who held such land on the first day of January 1938 held as a tenant at any time within six years before the said date from the same landlord in the same village any other land which he cultivated personally, the period during which he held such other land shall be included in calculating the period of six years under this section.

Explanation III.—Where any land is held by two or more persons jointly as tenants, all such persons shall, if any one of them cultivated and continues to cultivate such land personally and if the other conditions specified in this section are fulfilled, be deemed to be protected tenants in respect of such land.

4. (1) Any tenant who held any land continuously for a period of not Tenants less than six years immediately preceding the first day of April 1937 evicted after but who was evicted from such land on or after such date and who fulfils 1937 to be the conditions specified in clause (ii) of section 3 shall also be deemed protected to be a protected tenant for the purposes of this Act:

Provided that any tenant who has been evicted from the land in conBom. sequence of his failure to tender the rent referred to in section 9 of the
VIII Bombay Small Holders Relief Act, 1938, as provided therein, shall not be
deemed to be a protected tenant for the purposes of this Act, unless he
pays to the landlord such rent within four months from the date on which
this Act comes into force.

(2) A person who is deemed to be a protected tenant under subsection (1) shall, if he intimates in writing to the landlord within one most Bk H 1638—14

year after the coming into force of this Act that he is willing to hold the land on the same terms and conditions on which he held it at the time when he was evicted, be entitled to recover possession of the land—

- (a) if the land has been leased by the landlord for a period expiring after the 31st day of May 1940, from the date on which such lease expires; and
 - (b) in other cases, from the 1st day of June 1940.

And on so recovering possession, he shall, subject to the provisions of this Act, hold the land on the said terms and conditions.

(3) The provisions of this section shall not apply in cases where the landlord is using the land for any of the purposes mentioned in sub-section (1) of section 7.

Rights and liabilities of a protected tenant.

- 5. (1) The rent payable by a protected tenant shall be the rent agreed upon between such tenant and his landlord or in the absence of any such agreement the rent payable according to the usage of the locality or if there is no such agreement or usage, or where there is a dispute as regards the reasonableness of the rent payable according to such agreement or usage, the reasonable rent.
- '(2) Notwithstanding any agreement, usage, decree or order of a Court of law, the tenancy of any land held by a protected tenant as such tenant shall not be terminated unless such tenant—
 - (a) fails to pay the arrears of rent due, if any, for the year ending on 31st day of March 1939 within four months from the date on which this Act comes into force;
 - (b) fails to pay in any year within fifteen days from the day fixed for the payment of the last instalment of land revenue in accordance with the rules made under the Bombay Land Revenue Code, 1879, Bom. for that year the rent of such land for that year or if an application V of for the determination of reasonable rent is pending before the Mamlatdar or the First Class Sub-Judge under section 12, fails to deposit within fifteen days from the aforesaid date with the Mamlatdar or the First Class Sub-Judge, as the case may be, a sum equal to the amount of rent which he would have been liable to pay for that year if no such application had been made and in case the reasonable rent determined under section 12 is higher than the sum deposited by him fails to pay the balance due from him within two months from the date of the decision of the Mamlatdar or the First Class Sub-Judge, as the case may be;
 - (c) has done any act which is destructive or permanently injurious to the land;
 - . (d) has sublet the land or fails to cultivate it personally; or
 - (e) has used such land for a purpose other than agriculture.

- (3) Notwithstanding anything contained in sub-section (2), the tenancy of any land held by a minor who is a protected tenant shall not be liable to be terminated under the said sub-section only on the ground that such land has been sub-let on behalf of the said minor.

 - (a) for cultivating personally or using personally the land for any agricultural purpose; or
 - (b) for any non-agricultural purpose.
 - (2) If after the landlord takes possession of the land after the termination of the tenancy under sub-section (1), he fails to use it for any of the purposes mentioned in sub-section (1) within one year from the date on which he took possession or ceases to use it at any time for any of the aforesaid purposes within 12 years from the date on which he took such possession, the tenant whose tenancy has been terminated shall, if he gives a notice in writing to the landlord that he is willing to hold such land on the same terms and conditions on which he held it at the time when his tenancy was terminated, be entitled to recover possession of such land from the commencement of the year following that in which such notice is given:

Provided that the tenant shall give the notice under this sub-section within 2 years from the date

- (a) of the expiration of one year during which the landlord has failed to use the land for any of the purposes mentioned in sub-section (1), or
- (b) on which the landlord has ceased to use the land for any of the said purposes,

as the case may be.

Provided further that no such tenant shall be entitled to recover possession of such land if he has once refused to hold the land on the same terms and conditions on which he held it on being required in writing to do so by the landlord or has failed to reply to such requisition within 3 months of the receipt thereof.

(3) If a landlord after taking possession of the land after the termination of the tenancy under sub-section (1) on the ground that he requires it mo-1 Bk H 1638—144

for the purpose of personal cultivation, dies leaving as his heir, a widow or a minor or a person who is subject to mental or physical disability, such heir shall be deemed to cultivate the land personally, if such land is cultivated by her or his servants or by hired labour.

- (4) After the tenant has recovered possession under sub-section (2) he shall, subject to the provisions of this Act, hold such land on the same terms and conditions on which he held it at the time his tenancy was terminated.
- (5) After the tenant has recovered possession under sub-section (2), if he satisfies the Mamlatdar by an application under section 13 that the land was not at the time of the termination of the tenancy required bona fide by the landlord for any of the purposes mentioned in sub-section (1), the tenant shall be entitled to such compensation as may be awarded by the Mamlatdar for any loss caused to him by eviction. Nothing in this sub-section shall apply to any tenant who was evicted under a decree or order of a competent Court if such Court has recorded a finding at the time of passing such decree or order, that the land was required bona fide by the landlord for any of the purposes mentioned in sub-section (1).

Explanation I.—Any notice given for the termination of the tenancy of a protected tenant before the commencement of this Act shall not be deemed to be a valid notice for the purposes of sub-section (1).

Explanation II.—For the purposes of this section, a tenant shall include • his heir as specified in sub-section (3) of section 9.

Explanation III.—For the purposes of this section, a landlord shall be deemed to use land personally for any agricultural purpose, if he uses such land on his own account—

- (i) by his own labour, or
- (ii) by the labour of any member of his family, or
- (iii) by servants or hired labour under his personal supervision or the personal supervision of any member of his family.

Compensation for improvement made by a protected tenant.

- 8. (1) A protected tenant who has made an improvement on the land held by him as such tenant before the notice to terminate the tenancy is given to him shall on eviction be entitled to compensation for such improvement.
- (2) The compensation to which a protected tenant shall be entitled under sub-section (1) shall be the estimated value at the time of eviction of such improvement. In estimating such value regard shall be paid to—
 - (a) the amount by which the value of the land is increased by the improvement;
 - (b) the present condition of the improvement and the probable duration of its effects;

- (c) the labour and capital provided or spent by the tenant for the making of the improvement; and
- (d) any reduction or remission of rent or other advantage allowed to the tenant by the landlord in consideration of the improvement.
- 9. (1) If a protected tenant dies, the landlord shall continue the Continuation tenancy on the same terms and conditions on which such protected tenant of tenancy was holding it at the time of his death to such one of his heirs who, within of a protected four months of the death of such tenant, gives notice in writing to the tenant. landlord that he is willing to hold the land on such terms and conditions.
- (2) If the notice referred to in sub-section (1) is given by two or more heirs of the deceased tenant, the landlord shall continue the tenancy to such one of those heirs as is selected by all the heirs by an agreement amongst themselves and communicated to the landlord in writing within four months from the death of such tenant, or if no such agreement is communicated to the landlord within such time, to such heir as the Collector after consultation with the landlord may select.
- (3) The lineal male descendants of a protected tenant or his adopted son or, in the absence of any lineal male descendant or an adopted son, his widow shall be deemed to be his heirs for the purposes of this section.
- (4) Where any land is held by more than one protected tenant jointly the tenancy of such land shall, on the death of any one of such protected tenants, be continued, subject to the provisions of this Act, to the surviving protected tenant or tenants and the heirs of the deceased tenant determined in the manner provided in sub-section (2), as the case may be.
- 10. No sub-division of a land held by a protected tenant shall be Sub-division recognised or be binding on the landlord unless such sub-division is not to be effected with the consent in writing of the landlord.

 binding on landlord unless made with his consent.
- 11. The rights conferred on a protected tenant by this Act shall Bar to not be liable to seizure, attachment or sale by process of any Court seizure, and it shall not be lawful to mortgage, charge, lease or alienate any attachment and sale by such rights.
- 12. (1) For the determination of the reasonable rent of any land Enquiries held by a protected tenant as such tenant, the protected tenant or his as regards landlord may apply in writing to the Mamlatdar within whose jurisdiction reasonable such land is situated. Such application shall be in such form as may be prescribed.
- (2) On the receipt of an application under sub-section (1) the Mamlatdar shall give notice to the landlord or to the protected tenant, as the case may be, and, after holding a formal enquiry in the manner

provided in the Bombay Land Revenue Code, 1879, shall determine the Bomreasonable rent of the land.

- (3) Any party aggrieved by the decision of the Mamlatdar under subsection (2) may, within two months from such decision, file an appeal before the First Class Subordinate Judge, within whose jurisdiction the land is situated.
- (1) The Subordinate Judge in appeal may for reasons to be recorded in writing annul. reverse, modify or confirm the decision of a Mamlatdar or he may direct further enquiry to be made on any point or take additional evidence as he may think necessary.
- (5) In determining the reasonable rent regard shall, subject to the provisions of section 15, be had to the following factors:
 - (a) the rental values of lands used for similar purposes in the locality;
 - (b) the profits of agriculture of similar lands in the locality;
 - (c) the prices of crops and commodities in the locality;
 - (d) the improvements made in the land by the landlord;
 - (e) the assessment payable in respect of the land; and
 - (f) such other factors as may be prescribed.
- (6) The Mamlatdar and the Subordinate Judge in proceedings under this section shall have the same powers as are vested in Courts in respect of the following matters under the Code of Civil Procedure, 1908, in trying $\frac{\mathbf{V}}{1908}$ a suit, namely:—
 - (a) proof of facts by affidavit;
 - (b) summoning and enforcing the attendance of any person and examining him on oath; and
 - (c) compelling the production of documents.

The Mamlatdar and the Subordinate Judge may have also such other powers as may be prescribed.

- (7) The Mamlatdar or the First Class Subordinate Judge may award costs in any proceeding under this section, and such order shall be deemed to be a decree of a Civil Court and shall be executable as such.
- (S) A protected tenant may at any time, during the pendency of proceedings under this section deposit with the Mamlatdar or the First Class Subordinate Judge, as the case may be, a sum equal to the amount of rent which if no proceedings had been instituted under this section he would have been liable to pay in respect of the land of which the reasonable rent is to be determined. On the completion of proceedings, the Mamlatdar or the First Class Subordinate Judge shall direct that the amount so deposited or such part of it as is equal to the amount determined as reasonable rent under this section shall be paid to the landlord and shall make such other order as may be necessary.

(9) Every order passed by the Mamlatdar under this Act, if not appealed against, and every order passed by the First Class Subordinate Judge in appeal competent to pass such orders, shall hold good for a period of five years and shall not be called in question in any Court during that period:

Provided that the Mamlatdar or the First Class Subordinate Judge, as the case may be, may, during the said period of five years-

- (i) reduce the rent if on an application made to him by a tenant he is satisfied that on account of deterioration of the land by floods or other cause beyond the control of the tenant the land has been wholly or partially rendered unfit for the purposes of cultivation, or
- (ii) enhance the rent if on an application made to him by a landlord he is satisfied that on account of any improvement made in the land by or at the expense of the landlord the produce of the land is increased.
- (10) Notwithstanding anything contained in the Court-fees Act, 1870, 1870. every application under this Act to the Mamlatdar and every appeal to the First Class Subordinate Judge shall bear a Court-fee stamp of such value as may be prescribed.
 - (11) Any party to proceedings under this section may appear by any person authorized in writing to act on his behalf.
 - 13. - (2) On receipt of such application the Mamlatdar shall hold an enquiry and determine the amount of compensation, if any, payable to the tenant after following the procedure prescribed in section 12, as far as is practicable.
- (3) Any person aggrieved by any order passed by the Mamlatdar under sub-section (2) may appeal to the Collector within two months from the date of such order.
- (4) The order of the Mamlatdar under sub-section (2) shall, subject to an appeal to the Collector under sub-section (3) and the provisions of section 28, be final. The order of the Collector shall, subject to the provisions of section 28, also be final.
- (5) Any order passed by the Mamlatdar under sub-section (2) or by the Collector under sub-section (3) shall be deemed to be a decree of a civil Court and shall be executable as such.

CHAPTER III.

TENANTS GENERALLY.

- Abolition of
- 14. (1) Notwithstanding any agreement, usage or law, it shall not be all cesses, etc. lawful for any landlord to levy any cess, rate, tax or service of any description or denomination whatsoever, from any tenant in respect of any land held by him as a tenant other than the rent lawfully due in respect of such land.
 - (2) Any person who levies any such cess, rate, tax or service in contravention of the provisions of sub-section (1) shall, on conviction be punishable with fine which may extend to Rs, 1,000.

Power of Government to fix maximum rate of rent.

- 15. (1) The Provincial Government may from time to time by notification in the Official Gazette fix the maximum rate of rent payable by tenants for lands situated in such areas as may be specified in the notification.
- (2) Notwithstanding any agreement, usage, decree or order of a Court, a landlord shall not be entitled to recover rent from any tenant for any land in any such area at a rate exceeding the rate fixed for such land in such area in such notification.
- (3) Every such notification shall be placed before each Chamber of the Provincial Legislature and shall be liable to be rescinded or modified by a resolution passed in which each of the said Chambers concurs during the next following session.

(1) Notwithstanding anything contained in section 84A of the $_{\mathrm{Bom}}$ or remissions Bombay Land Revenue Code, 1879, whenever from any cause the payment v of of the whole land revenue payable to Government by a landlord in respect 1879. of any land is suspended or remitted, the landlord shall suspend or remit, as the case may be, the payment to him of the rent of such land by his tenant. If in the case of such land the land revenue is partially suspended or remitted, the landlord shall suspend or remit the rent payable by the tenant of such land in the same proportion:

> Provided that the landlord shall not be bound to suspend or remit the rent or portion thereof which is payable in the form of a share of the

> (2) If no land revenue is payable to Government in respect of such land and if from any cause, the payment of the whole or any part of the land revenue payable to Government in respect of any other land in the neighbourhood of such land has been suspended or remitted, the Collector shall, subject to the general or special orders of Government. in the manner provided in sub-section (1) suspend or remit, as the case may be, the payment to the landlord of the rent or part of it due in respect of such land.

- (3) No application for assistance under sections 86 and 87 of the Bombay Bom. Land Revenue Code, 1879, shall be entertained, no suit shall lie and no 1879, decree of a Civil Court shall be executed for recovery by a landlord of any rent, the payment of which has been remitted, or during the period for which the payment of such rent has been suspended under this section. The period during which the payment of rent is suspended under this section shall be excluded in computing the period of limitation prescribed for any suit or proceeding for the recovery of such rent.
- (4) Notwithstanding anything contained in sections 86 and 87 of Bom. the Bombay Land Revenue Code, 1879, the Collector shall, in passing an V of 1879. order under sub-section (2) of section 87 of the said Code, for rendering assistance to the landlord, allow to the tenant a set off for the sum, if any, paid by such tenant to the landlord in excess of the amount of rent due from him after deducting the amount required to be remitted under sub-section (1) or sub-section (2) of this Act or under section 84A of the said Code. The set off under this sub-section shall be allowed only in respect of the sums paid by such tenant to such landlord during. a period of 3 years immediately preceding the date of the application made under section 86 of the said Code.
 - 17. (1) If in any alienated village or village held on khoti or talukdari Bar to tenure, a tenant is in occupation of a dwelling house built at the expense eviction dwelling of such tenant or his predecessor-in-title on a site belonging to his land-house. lord, such tenant shall not be evicted from such dwelling house (with the materials and the site thereof and the land immediately appurtenant thereto and necessary for its enjoyment) unless—

landlord shall make an application to the Mamlatdar for the determination of the value of the site. On receipt of such application the Mamlatdar after giving notice to the tenant and after holding a formal enquiry shall determine the value of the site. The determination by the Mamlatdar of the amount of the value of such site shall, subject to the provisions of section 28, be final. The Mamlatdar may, by an order in writing, require the tenant to deposit such amount within three months from the date of such order. On the deposit of such amount the site shall be deemed to have been transferred to the tenant and the amount deposited shall be paid to the landlord. The Mamlatdar shall, on payment of the prescribed fees, grant a certificate in the prescribed form to such tenant specifying therein the site so transferred and the name of such tenant.

- (4) If the tenant fails to intimate his willingness to purchase the site within the time specified in sub-section (2) or fails to deposit the amount of the value within the time specified in sub-section (3), the tenant shall be deemed to have relinquished his right of first option to purchase the site and the landlord shall then be entitled to evict the tenant on payment of such compensation for the value of the structure of such dwelling house as may be determined by the Mamlatdar after holding an enquiry in the manner provided in sub-section (3). The decision of the Mamlatdar as regards the amount of compensation under this section shall, subject to the provisions of section 28, be final.
- (5) Any sale of a site held in contravention of this section shall be null and void.

19. (1) If a protected tenant or any other tenant has before the coming into force of this Act planted or thereafter plants any trees on the land leased to him, he shall be entitled to the produce and the wood of such trees during the continuance of such tenancy and shall on the termination of such tenancy be entitled to such compensation for the said trees as may be determined by the Mamlatdar after holding an enquiry in the manner provided by sub-section (3) of section 18:

Provided that a tenant who is governed by section 23 shall be entitled to such compensation if the trees are planted by him with the consent of the landlord:

ORDINANCE No. I OF 1939.

[THE BOMBAY FODDER AND GRAIN CONTROL ORDINANCE, 1939.]

[12th August, 1939.]

An Ordinance to provide for the control and distribution of fodder and grain including the regulation of prices thereof in the Province of Bombay.

WHEREAS the Governor of Bombay is satisfied that circumstances exist in certain areas of the Province of Bombay which render it necessary for him to take immediate action for the purpose of controlling and regulating the supply and distribution of fodder and grain including the regulation of prices thereof;

AND WHEREAS the Legislature of the Province is not in session;

AND WHEREAS steps are being taken to move a Bill in the Chambers of the Provincial Legislature for the said purpose and it is necessary to make immediate provision for taking action until the said Bill is passed into an Act;

Now, THEREFORE, in exercise of the powers conferred by section 88 of the Government of India Act, 1935, and in pursuance of the instructions from the Governor General under proviso (b) to sub-section (1) of the said section, the Governor of Bombay is pleased to promulgate the following Ordinance:—

- 1. Short title and extent.—(1) This Ordinance may be called the Bombay Fodder and Grain Control Ordinance, 1939.
 - (2) It shall extend to the whole of the Province of Bombay.
- 2. Definitions.—(1) In this Ordinance, unless there is anything repurmant in the subject or context,—
 - (i) "Famine area" means any area declared to be a famine area under section 3;
 - (ii) "Scarcity area" means any area declared to be a scarcity area under section 3;
 - (iii) "Standard price" means the maximum price fixed for sale of fodder or grain under section 3.
- X of (2) The provisions of the General Clauses Act, 1897, and of the 1897. Bombay General Clauses Act, 1904, shall apply to the interpretation of Rom. this Ordinance.

- 3. Power to declare famine and scarcity areas and to fix standard prices.—(1) The Provincial Government, may, from time to time by notification in the Official Gazette, declare that a famine or scarcity prevails in any local area in the Province; and thereupon the said area shall be deemed to be a famine area or a scarcity area, as the case may be, for the purposes of this Ordinance for such period as the Provincia Government may direct.
- (2) On a declaration being made under sub-section (1), the Provincia Government may also by like notification declare that all contracts for the sale of fodder or grain of any kind entered into on or after the date specified in the notification shall be subject to the provisions of thi. Ordinance.
- (3) The Provincial Government may, by notification in the Officia Gazette, fix a standard price for the sale of fodder or grain in any famina area or scarcity area or in such other area as may be specified in the notification.
- 4. Sum in excess of the standard price not to be recovered.—No persor shall recover on account of sale of fodder or grain of any kind in any area for which a standard price has been fixed under sub-section (3) or section 3 any sum in excess of the standard price.
- 5. Prohibition against removal of fodder or grain from any loca area.—No person shall remove from any local area specified in this behalf by the Provincial Government by a notification in the Officia Gazette, fodder or grain of any kind without permission in writing of the Collector or such other officer as may be authorised by him in this behalf.
- 6. Sums in excess of standard price not to be recoverable.—(1) Any sum agreed to be paid as consideration for the sale of fodder or grain of any kind in excess of the standard price shall be irrecoverable.
- (2) If any such sum has been paid, it shall, at any time within a period of six months from the date of the payment thereof, be recoverable by the person paying the same from the person to whom it was paid.
- 7. Penalty for contravention of section 4 or 5.—Whoever contravenes any of the provisions of section 4 or 5 shall, on conviction, be punishable with imprisonment for a term which may extend to two years or with fine which may extend to Rs. 1,000 or with both.
- 8. Rules.—The Provincial Government may by notification in the Official Gazette make rules for carrying out the provisions of this Ordinance.

- 5. Options in cotton void.—Notwithstanding anything contained in the said Act or in any other law for the time being in force, all options in cotton entered into after the date on which this Ordinance comes into force shall be void.
- 6. Savings.—Nothing in this Ordinance shall affect or be deemed to affect—
 - (a) the terms and incidents of any option in cotton made or effected before the date on which this Ordinance comes into force;
 - (b) the validity, invalidity, effect or consequences of anything already done or suffered before the aforesaid date in regard to such options in cotton;
 - (c) any right, title, obligation or liability acquired, accrued or incurred in regard to such options in cotton before the aforesaid date:
 - (d) any remedy or proceeding in respect of such right, title, obligation or liability;
 - (e) anything done in the course of any proceeding pending in any court on the aforesaid date relating to such options in cotton.
