PREFACE

An attempt has been made in this book to bring together in a classified form the important recommendations for ready reference relating to secondary education of the three all-India bodies which are actively associated with the expansion and reconstruction of secondary education in the country. The oldest of these, the Central Advisory Board of Education, has over the last 25 years advised the Central and the State Governments on all matters affecting national educational policies. The development of education during the last two decades bears ample testimony to the influence which the Board has exercised on the evolution of uniform educational policies for the entire country. It was at the instance of the Board that the Secondary Education Commission was set up by the Government of India. When the report of the Commission was published, the Board advised the Government of India to establish an expert body to help in the implementation of the farreaching recommendations of the Commission. Thus the All-India Council of Secondary Education came into being in 1955. State Education Ministers have met in three conferences held in 1957, 1959 and 1960. A conference provides an opportunity to have a high level review of the progress of important educational schemes in the context of the overall economic and social development of the country and take policy decisions about the modifications and adjustments which are required to be made from time to time. The reader will thus find in the present compilation detailed guidance given by these bodies on such topics as the setting up of multipurpose schools, examination reform, the teaching of science, in-service training of teachers, etc.

It is hoped that the present publication which contains all important decisions taken up to 1960 will be found useful for reference purposes by all those interested in the development of secondary education.

RECONSTRUCTION OF SECONDARY EDUCATION

1. Teachers

1950 Item 17

The Board considered the recommendation of the standing committee on the age of retirement and recommended that in the case of a government teacher the present age of retirement, i.e., 55, should continue, but in the case of a non-government teacher the age of retirement may be extended from 55 to 60 though the extension should not be automatic. Each case of extension should be reviewed and a teacher should be retired if he so desired or if the school authorities felt that he should retire on grounds of efficiency, health, etc. (C.A.B.E.)

1955 ISt meeting Item 3

The Council noted with satisfaction the action so far taken by the Ministry of Education for the reconstruction of secondary education. The Council recommended that the Central Government should suggest to the State Governments that, in the matter of recruitment of teachers for primary schools, preference should be given to those who qualify from the higher secondary schools. The measure was calculated to increase the popularity of the new pattern and as such make the transition smoother. (A.I.C.S.E.)

1956 2nd meeting Item 9

Schemes for the training of teachers of higer secondary Committee schools:-

to advise on fraining of teachers

The notes of Messers, Habibul Rahman and Kazimi were considered, and it was decided that the chairman might be authorised to appoint a committee of three to advise on the training of teachers for higher secondary and multipurpose schools. (A.I.C.S.E.).

1956 3rd meeting Item 7.7

With regard to the period of training for teachers of Higher Secondary Schools and the minimum for secondary qualification required of the teachers selected for such schools training, it was resolved to refer the question to the Committee appointed by the Ministry of Education for the Examination of the curriculum and the pattern of training in Secondary Training Colleges.

In connection with the proposal to augment the staff of the Training Colleges, the total work-load of the lecturer in the College including the amount of work he did in the Extension Services Department came up for consideration. It was generally agreed that if the teacherstudent ratio was kept at 1 to 10, staff co-operation in the Extension Services Departments would be more readily available and that, while the system of remunerating lecturers for Extension Services work need not be discontinued, it was desirable to reduce the number of lectures to the minimum.

As regards the suggestion to attach a training department to a Polytechnic or an Agricultural College in each of the four zones for the training of teachers in Technology, Fine Arts or Agriculture, the consensus of opinion was that no single solution would suffice for the problem of training teachers in vocational subjects. was agreed that, where facilities did not exist for providing such practical training in the workshops of technical schools, various alternative measures would have to be devised and that these would have to be worked out by the staff of the Training Colleges in cooperation with technical and professional experts. (A.I.C.S.E.)

The Council welcomed the Scheme for strengthening Training of the Teaching of Science in Secondary Schools by deputing science teatraining college lecturers and secondary schools teachers under the Science Teachers' Fellowships programme to the U.S.A., Canada and the U.K. (A.I.C.S.E.).

The Council approved the following recommendation secondary made by the Standing Committee:

"It was resolved that this Memorandum be placed before the Council and the Chairman be authorised to explore the possibility of organising such courses. It was also suggested that the Chairman should take up this matter with the University Grants Commission and the Inter-University Board." (A.I.C.S.E.)

It was decided by the Council that the training colleges and universities, should be requested to include these practical subjects in the regular training programme for the B.Ed. or B.T. or L.T. degree courses. In the case of diploma holders it was suggested that training colleges might organise special training courses for them leading to a diploma in the teaching of specified technical or practical subjects. (A.I.C.S.E.).

Pending the setting up of higher pose schools secondray schools, it may be possible for some of the secondary schools, to have some diversified courses of instruction. However, so far as the higher secondary pattern of technical education is concerned, it is essential that at least one member of the team of teachers in any of the technological subjects who will be the head of the department should be a graduate in that subject and he may be assisted by those who have the national diploma or its equivalent in that field. The pattern of the higher technical institution has got to be standardized. The Board, therefore, recommended that a small committee should be set up to inspect some of the schools that offer the electives in the field of technical, science and other practical subjects in the States and to report on the working arrangements made, the standards maintained and on all other relevant matters connected with this problem.

The report should deal with the following factors:-

- (i) The equipment and accommodation available for the particular course of study, inclusive of workshop pattern, field exercises, etc.
- (ii) Personnel employed with qualifications, salary scales, etc.
- (iii) Number of students in each department.
- (iv) Opportunities for employment or the avenues available for employment to those who have

finished their training and any other relevant matters.

So far as the training of teachers of multi-purpose schools is concerned, the Board felt that the training must be evolved by experts in the field. These should be persons qualified in particular spheres of technical education and should work with experts in pedagogy from the training colleges. It was suggested that the Ministry of Education might like to constitute a small committee to go into the whole question.

The Board suggested that the two committees suggested above should be requested to submit their reports before the 31st of October so that the reports could be placed before the next meeting of the Central Advisory Board of Education. (C.A.B.E.)

Regarding teacher training, the Board recommended Qualificathat the scheme for such training should be on the following lines:-

- (a) that all heads of departments employed at the for short higher secondary stage should be M.As. or M.Scs. or M.A. courses persons with a Diploma I Certificate from the university of teachersindicating their competence to teach at the higher Terms of deputation secondary stage, other categories having pedagogic for training training of the B.T. standard as required for higher secondary schools. It was suggested that a certain number of teachers from different institutions should be deputed for a period of one year to a university for practical training in approved laboratories for science subjects and in the other approved departments for the other subjects.
- (b) that a teacher should get advice regarding his studies in his preparation for the Master's degree from the university departments prior to his joining the course. He should put in one academic year's study in the university for the course concerned, at the end of which he should either take the M.A. or M.Sc. examination to be held for the regular students preparing for these courses or sit for a diploma examination, details of which should be worked out by the university. The possession of diploma would qualify a teacher for work at the higher secondary stage. The present provision for teachers to appear privately should continue.
- (c) that a candidate should be allowed to sit for either or both the diploma and the degree examinations conducted by the university and that in case of those who were not successful for one or the other test, a second

departments -Facilities -Selection

appearance should be permitted after private study at the end of another year. Teachers selected for advance study preferably have qualified for the B.T. degree and should have put in a minimum of five years of teaching in a recognised school. The headmaster of the school should be the authority to recommend teachers. The number of teachers so recommended would be scrutinized by the university, with a view to selecting the actual number that would be trained in the university in a particular year. The recommendations of the headmaster should be forwarded to the university through the state government concerned.

- (d) that such teachers will be deputed by their respective managements and during the period of deputation they will be entitled to:—
 - (i) the salary that they were drawing prior to the date of deputation;
 - (ii) a subsistence allowance, which may be fixed by each state government, during the period of their training; and
 - (iii) the teacher deputed for such training should enter into a bond with the management and the state government concerned to serve for a minimum period of five years after the completion of his training.
- (e) that the salary of the substitute to be appointed in the vacancy created and who need not necessarily be a trained graduate will be regarded as part of the approved expenditure of the school. The expenditure involved in such teacher-training will be under the following heads:
 - (i) Deputation of the teachers under the conditions suggested as well as the employment of the substitute in his place.
 - (ii) The expenditure likely to be incurred by the university or institution for training such teachers. The expenditure may be of two types:
 - (a) Non-recurring expenditure for the expansion of laboratory facilities or in the increase of library books
 - (b) Expenditure to be incurred in appointing additional personnel for the training courses. This expenditure will have to be decided

on an ad hoc basis depending on the number of persons that are to be trained in each particular subject. The optimum number of trainees in a post-graduate training centre should be 12; in no case should the number exceed 20.

A non-recurring grant of Rs. 2,500 per student for Financing of increased accommodation in the laboratory may be given expansion in for the science subjects and a non-recurring grant of Rs. 1,000 per student for accommodation for the Humanities. As for the recurring grant for equipment, Physics, Chemistry, Botany and Zoology should get Rs. 1,000 each, while Mathematics and Humanities should each be given Rs. 500.

training.

For each of the Science subjects-Physics, Chemistry, Zoology and Botany-increased accommodation should be provided in the laboratories at the rate of 50 sq. ft. per student. For Humanities and Mathematics and other subjects, the lecture room space should be calculated at 12 sq. ft. per student. It is suggested that the effective plinth area may be six rooms, 12' x 30'. The total effective floor area will be 2160 sq. ft.

The recurring expenditure will be mainly on the laboratories and equipment as well as on the extra staff that will have to be recruited for the purpose. The recurring expenditure so far as the Science subjects are concerned may be Rs. 600 per student per year. So far as other subjects are concerned, the expenditure will be mainly in regard to the library facilities. A sum of Rs. 5,000 per year may be needed by way of additions to the existing facilities in universities and colleges which undertake this work.

It will be necessary in each of the subjects to have at least an extra Reader and a Lecturer on the usual University Grants Commission scales. The laboratory staff required for Science subjects may consist of two attendants for each of the laboratory subjects, also in the usual scale.

So far as the responsibility for financial aid in regard to the scheme outlined above is concerned, it was suggested :-

> (i) that the State government should take up the responsibility for meeting items of expenditure

connected with the deputation of teachers, etc. and that this expenditure should form part of the approved expenditure to be shared between the Centre and the States within the plan provision; and

(ii) that the University Grants Commission may be requested to meet the expenditure to be incurred by the universities and training departments as this forms part of post-graduate The grant should be given development. without the liability of the university for a matching contribution. (C.A.B.E.)

2. Reorganisation of Schools etc.

1956 Item;8

The Board felt concerned that progress made in Second Five securing the cooperation of universities and boards of and Secondsecondary education in introducing the new pattern of dary secondary and university education was slow and apprehended that considerable difficulty would be faced by students if this pattern were not accepted by the universities and boards of secondary education concerned by the time the first batch of students take their final school examination.

The Board recommended, therefore, that the Government of India and state governments should pursue the matter vigorously with the universities and the boards of secondary education.

The Board discussed the issue of finances required to complete the reorganisation of the secondary and university stages in accordance with the recommendations of the Secondary Education Commission and felt that the provision of Rs. 320 crores suggested for education in the Second Five Year Plan was totally inadequate for this purpose and for implementing the other necessary development schemes. The Board then passed the following resolution unanimously:-

> "This meeting of the Central Advisory Board of Education has given careful consideration to the provision proposed in the Second Five Year Plan of Educational Development in the country, and regrets to note that the importance of education for national development and progress has not been fully appreciated particularly in view of the imperative need both to expand and to reform education in the country. It also wishes to point out that the

proposals in the draft Plan are likely to retard instead of accelerating the rate of progress in education already achieved in the country since Independence. It is definitely of the opinion that the amount of Rs. 320 crores is utterly inadequate even to meet the barest needs of the situation and it would not be possible to formulate any worthwhile Plan within thisfigure. The Board strongly recommends that a sum of at least Rs. 500 crores should beprovided for this purpose, which should include adequate funds for the improvement of teachers' salaries in order to bring them up toa level, where men and women of the requisite ability can be attracted to and retained in the profession." (C.A.B.E.).

With respect to the issue about the relationship Post-Basic between post-Basic education and the reorganized pattern of Secondary education, the Conference was of the view multipurthat two parallel systems of education should not exist at the Secondary stage, as that would lead to difficulties in regard to further education of the products of post-Basic schools and their employment. The Conference recommended that the post-Basic schools should be regarded as one type of Multi-purpose schools. The courses and standard of instruction imparted in these schools should be equivalent to those in the Multi-purpose schools, and a suitable examination should be devised for them by the Boards of Secondary Education. With this arrangement, the question of separate reorganisation of post-Basic diplomas and certificates would not arise. (E.M.C.).

The Board felt that for the development of secondary Priority for schools and other educational institutions, construction construction of additional accommodation was absolutely essential. recommended, therefore, that as far as practicable there should be no restrictions in this regard and that the educational buildings should be given the same high priority as is accorded to the construction of hospitals. (C.A.B.E.)

1957 Item 3(c)

The Board was emphatic that multilateral schools and Post-Basic post-Basic schools should not be regarded as two parallel systems but as integral parts of the same system of with multisecondary education. (C.A.B.E.)

The Board considered the question of the three-year Maximum degree course in the light of the Second Deshmukh period within which Committee Report and was strongly of the view that, conversion having regard to the fact that almost all the universities to be effectand even the Uttar Pradesh Government (where there were very special difficulties) have fallen in line with the proposal and that about 18 or 20 universities have already introduced the three-year degree course, the University of Bombay should also fall in line with the scheme at an early date in the interest of uniformity of standards.

It was further suggested that the University Grants Commission and the Inter-University Board might be requested to pay special attention, while examining the syllabus, to the question of securing as far as possible uniformity of standards.

With regard to the recommendations of the second Deshmukh Committee, the Board generally accepted them. It suggested, however, that recommendation No. 1 of the Report might be modified to read as follows:

> "The reorganisation of secondary education is a preliminary step to the implementation of the three-year degree course. The period required for raising high schools to higher secondary schools, should not be extended beyond 10-15 The question of the continuation of the pre-university classes adopted as a transitional arrangement should be reviewed from time to time." (C.A.B.E.)

1959 Liem 4

The Board recommended that from the year 1960-61 Upgrading all new secondary schools should be given affiliation only on the new pattern of higher secondary schools.

into higher secondary schools by the end of 3rđ Plan. ancial share. Teaching of science and humanitics

The Board agreed with the recommendation of the All Centre's fin-India Council for Secondary Education that high priority should be given to the conversion of high schools into higher secondary schools and that the upgrading of high schools should be regarded as an essential feature of the whole scheme of reorganisation of secondary education.

The Board agreed with the recommendation of the All-India Council for Secondary Education that state governments should be persuaded to change over most, if not all, of their high schools to the higher secondary pattern by the end of the third Plan period.

The Board agreed with the recommendation of the All-India Council for Secondary Education that in so far as the third Five Year Plan was concerned the central government should assure the state governments of recurring and non-recurring contribution on the conversion of high schools into higher secondary schools on a scale not less than what prevailed at present.

The Board further recommended that with regard to the upgrading of schools, it would be necessary for the Government of India to provide for a certain amount of non-recurring and recurring grants. The non-recurring grant would be required for improvement in accommodation and for improvement and expansion of laboratory It desired that a suitable formula should be worked out to apply to all schools. The Board made the following suggestions in this behalf:-

- (a) For a unit of forty students in a class and for a school to be raised from high school to higher secondary school, the non-recurring expenditure, taking accommodation, equipment and laboratory into consideration, may be Rs. 50,000.
- (b) A recurring expenditure of Rs. 10,000 may be provided towards improvement of salaries of teachers with better qualifications etc.

From the point of view of modern requirements, it was considered essential that every school should provide for the teaching of both Humanities and Science and students generally should be taught both subjects in the higher secondary schools. There might be more emphasis on the one or the other, but it was essential to teach both subjects to every pupil. (C.A.B.E.)

1959 Item 3

The Board emphasised that the model Basic school Basic edu-(now designated as Central Basic School) at New Delhi urban areas should be set up at an early date and, in any case, before the end of 1959.

The Board desired that a detailed study should be made of the progress of Basic education in urban areas, particularly in relation to the suitability of the crafts employed and the other characteristics of Basic education. The Board suggested that while implementing the general policy of reorganising the post-Basic schools as one type of multi-purpose schools, the State Boards of Secondary Education should develop suitable techniques of evaluating the students of post-Basic schools. (C.A.B.E.)

1959 Item 10(b)

The Board accepted the recommendation made by Placement of the Government of Bombay that a liaison should established between multi-purpose schools and the indus-dustries tries concerned.

It was understood that steps had been taken in at least eight States to set up Youth Employment Units of the National Employment Service. The Board hoped that such units would be established in all the States and eventually in the major district headquarters. long run it would be for these agencies to contact industries or other employing agencies on the one hand and schools on the other, with a view to arranging the effective placement of young school-leavers. (C.A.B.E.)

The Conference resolved that:

1959 Item 5

"In order to complete the reorganization of Second-tion during ary education as early as possible, at least 50 third Plan per cent of the existing High Schools should be converted into Higher Secondary Schools during the Third Five-Year Plan. It should also be provided that, during this period. ordinarily no new High School (or Class X School) would be opened and that all Secondary Schools to be established would be of the Higher Secondary pattern. In this connection, the Conference recommended that the pattern of Central assistance for the establishment of Higher Secondary Schools should be the same as for the conversion of High Schools into Higher Secondary Schools.

Reorganisa-

"Since this reorganisation will depend largely on the staffing of the new schools by qualified teachers, it was necessary that steps should be taken in time to recruit and train additional teachers required for the reorganised and new Higher Secondary Schools.

"The Conference resolves that the conversion the existing High Schools into Higher Secondary Schools in the Third Plan is the minimum programme of reconstruction that the country should adopt. Any further reduction in this target may jeopardise the very purpose reorganisation. The Conference, recommends to the Planning Commission, Ministry of Education and the State Governments that adequate provision should be made in the Third Five-Year Plan for this purpose." (E.M.C.)

3. Curricula, Medium of Instruction etc.

1935 Item 1(2)

(2) A radical readjustment of the present system of Diversified education in schools should be made in such a way as not only to prepare pupils for professional and university courses, but also to enable them, at the completion of appropriate stages, to be diverted to occupations or to separate vocational institutions.

- (3) These stages should be:-
- (a) The Primary stage, which should aim at providing at least a minimum of general education and training and will ensure permanent literacy.
- (b) The lower secondary stage, which will provide a self-contained course of general education and will constitute a suitable foundation either for higher education or for specialised practical courses.

In rural areas, the courses at this stage should be aptitudes and be made compulsory.

Some form of manual training at this stage should be provided, which would aim at the development of practical aptitudes and be made compulsory.

- (c) The higher secondary stage, in which would be included institutions with varying lengths of courses-
 - (i) Preparing students for admission to universities in arts and science:

- (ii) for the training of teachers in rural areas;
- (iii) for agricultural training;
- (iv) for clerical training; and
- (v) for training in selected technical subjects which chosen in consultation with should be employers.

Where separate institutions are not possible for the diversified courses, some of them might be incorporated in a higher secondary course of enlarged scope which would permit a choice of alternative groups of subjects and would end in Leaving Certificates.

- (4) At the end of the lower secondary school course there should be the first public examination.
- (5) Candidates desirous of joining the subordinate clerical services of Government and of local bodies should pass such qualifying examinations as might be prescribed by proper authority and should not be more than 19 years of age at the date of their examination.

The certificates granted to pupils completing other specialised courses should receive government recognition.

- (6) Expert advice would be of value in organising the scheme of reconstruction outlined above; and also for suggesting methods of training masters who would assist pupils and parents in the selection, by the pupils, of courses of study with due regard to their aptitudes.
- (7) Each province should organise Employment Bureaux for the purpose of advising students and of eliciting support and guidance of employers interested in the problem.
- (8) Every local government should actively explore the possibility of finding new avenues of employment and occupation. (C.A.B.E.)

1942 Item 16

The Board had before them the recommendation of Evolution of the Standing Committee on the issues raised in a letter a standard No. 7525/F., dated the 8th October, 1941, from the Government of Bombay regarding the question of the introduction of Hindustani in primary and secondary schools. It was agreed that it was desirable to evolve a standard Hindustani, if possible, but at the same time it was pointed out that there is a form of Hindustani in common use over a large part of Northern India and that the

Government of Bombay might find in this the solution of their difficulty.

The Board also gave directions that the Bureau of Education should collect such Hindustani literature as is now being used in primary and secondary schools in provinces other than Bombay and forward it to the Government of Bombay for their information and guidance. (C.A.B.E.)

1944 Item 31

The Board considered the question of basic English Basic in relation to the Indian educational system. They noted that the views expressed by eminent Indian educationists so far did not generally favour the adoption of basic English in this country. They also noted that a few experiments have been started by certain provincial authorities in a few localities and it was too early yet toexpect any definite results therefrom. In view, however, of the interest that was being taken in basic English in England and America, the Board authorised the Educational Adviser to appoint a Committee to report on the matter as and when he considered it necessary. (C.A.B.E.)

1946 Item 11

The Board agreed with the recommendation of the Study standing committee that the introduction of Russian, Russian, Chinese Chinese and other modern languages at the high school the high stage was, at present, impracticable, but suggested that school stage these languages should be taught in universities. They also recommended that the Government of India should establish a central school on the model of the School of Oriental Studies in London for the study of more important foreign languages. Should circumstances so demand, governments may also promote the establishment of departments for the study of these languages in Indian universities by making suitable grants. (C.A.B.E.).

The Board then proceeded to consider the question of Physical edumaking physical education an examination subject in high examination schools. While the Board were in sympathy with the subject objective of the proposal that schools should take all possible care for the promotion of the physical welfare of children in their care, they were unable to accept the view that 'physical fitness' could be included as an examination subject. Apart from the practical difficulties, the Board felt that their object of physical education would be defeated if the suggestion was accepted. Further, the Board were of the opinion that establishment of an expert Committee on Physical Education would at this stage not serve any useful purpose. The Board in the first-instance would like to see what provision has been

made in regard to the health of the school child, in the first five-year programmes of educational development. (C.A.B.E.)

1949 Item 18(a) The Board considered the recommendations of the standing committee.

the Medium of instruction to Separate schools for linguistic groups

The Hon'ble Minister for Education, Bengal, reported that the West Bengal Government gave facilities for instruction in the mother-tongue to children speaking Hindi, Urdu, Gujarati, Assamese, Oriya and Tamil up to matriculation stage, through separate classes or separate schools where number would justify, but in the secondary stage all students had to study the regional language as a compulsory second language.

The Hon'ble Minister for Education, U.P., reported that his Government recognised Bengali, Gujarati and Marathi as media of instruction at the secondary stage in addition to Hindi which was the recognised medium of instruction at that stage and agreed to extend the same facilities to Urdu-speaking children in terms of the recommendations of the Board.*

The Hon'ble Minister for Education, Madras, stated that facilities for instruction up to the matriculation stage were offered in all the four regional languages in Madras City, but elsewhere the language of the locality was the only recognised medium of instruction.

The Director of Public Instruction, Bombay, reported that in his province similar facilities were—offered for Marathi, Gujarati, Canarese and Urdu.

The Secretary, Department of Education, East Punjab reported that at present there was no provision for teaching Urdu in the high school stage, but his Government would be prepared to make necessary arrangements as soon as a sufficient number of students desired such an arrangement.

When the draft report was circulated to members, the Hon'ble Mr. Sampurnanand, Minister for Education, U.P. wrote to say that the position of the United Provinces Government had not been correctly brought out as regards item 13 (a). He said that he had intended to convey at the meeting that Urdu, unlike Marathi, Bengali and Guirti was 10 the language of any particular province and no linguistic minority could, therefore, claim it as its language. In his opinion, its use as medium in secondary or higher Basic schools would seriously handicap students taking it, in the Service and in their university studies where Hindi would become the medium in five years.

that where the mother-tongue was different from the regional or stage language, arrangements must be made for instruction in mother-tongue by appointing at least teacher to teach all the classes, provided there are at least 40 such pupils in a school. The regional or state language where it is different from the mother-tongue should be introduced not earlier than class III nor later than the end of the junior Basic stage. In order to facilitate the switch over to the regional language as medium of instruction at the secondary stage, children should be given the option of answering questions in their mother-tongue for the first two years after the junior Basic stage.

If, however, the number of pupils speaking a language other than the regional or state language is sufficient to justify a separate school in an area, the medium of instruction in such a school may be the language of the pupils. Such an arrangement would, in particular, be necessary in Metropolitan cities or places where large populations speaking different languages live or areas with a floating population of different languages. Suitable provision should be made by the provincial authorities for the recognition of such schools imparting education through a medium other than the regional or state language,

Resolved that the proposal of the Madras Government, Hindi may that in regions where Hindustani is not the regional be taught in language, it may be taught in secondary schools, in the scripts Roman or the regional script and the script of Hindustani taught at a later stage when the pupils come to high school or college classes, is an experiment which should be watched with interest. (C.A.B.E.)

The Board considered the recommendation of the Manual standing committee relating to compulsory physical work work for students. The Board recognised the importance of such work and recommended that the Government of India may appoint a committee to consider the question in detail and draw up a programme for such work. The Board also recommended that both teachers and students should participate in such a scheme. (C.A.B.E.).

The Board considered a proposal to introduce Study of Gandhian Literature as a compulsory subject to be taught Gandhian in all schools and colleges. They felt that it would be undesirable to introduce compulsion in a matter like

this, but they recommended that the attention state governments should be drawn to the obvious desirability of the life and teaching of the Father of the Nation being studied in all educational institutions. (C.A.B.E.).

The Council noted with satisfaction the work done by Mathematics the Coordination Committee in the preparation of the as a core syllabi for the new Scheme of Courses. It was pointed out by the Additional Secretary, however, that the preparation of the syllabi had been completed as a kind of rush job and were intended merely to help the State Governments in making a beginning with the new courses. Once the beginning had been made, the State Governments would have to set in motion their own research grammes to perfect them and to accord them better with both the needs of the pupils and those of the community.

With regard to the inclusion of Mathematics in the core curriculum, the Council agreed with the recommendations of the Secondary Education Commission that Elementary Mathematics should be taught to every pupil at this stage. It was suggested in this connection that the subject under B (ii) on page 93 of the Report of the Secondary Education Commission should be read as "General Science and Elementary Mathematics" in place of "General Science including Mathematics."

With regard to the exact contents of the course in Elementary Mathematics, the Council reserved its opinion till the same has been finalised by the Coordination Committee.

The Council also considered the recommendation of the Coordination Committee that Elements of Psychology and Logic should not be taught at the Secondary stage. The Council felt that since the subject was included only as an optional under the group of Humanities, the provision could be allowed to stand in the present form. (C.A.B.E.)

Having regard to the necessity of learing a modern Study European language for further studies in Science and English as a Technology, it was decided that (i) English should be subject taught as a compulsory language both at the Secondary and the University stages, and that the State Governments should take such steps as may be considered appropriate

to ensure that, at the end of the Secondary stage, students acquire adequate knowledge of English so as to be able to receive education through this language at the university level.

- (ii) English should not be introduced earlier than Class IV. The precise point at which English should be started at the Middle stage was left to each individual State to decide.
- (iii) The following formula was approved in regard to the study of languages at Secondary schools:-
- (a) (i) Mother tongue, (ii) or Regional language, (iii) or composite course of mother tongue and a regional language, (iv) or a composite course of mother tongue and classical language.
 - (b) English
- (c) Hindi (for non-Hindi speaking areas) or another modern Indian language (for Hindi speaking areas) (E.M.C.)

The Board reviewed the opinion about the two Compulsory formulae for teaching of languages in secondary schools study of three languages as by State governments, and the recommendations made by an all-India the Conference of Education Ministers in September, 1956. While some of the State governments had not yet completed their examination of the subject, the Board noted with satisfaction that there was a substantial measure of agreement on the principal recommendation underlying both the formulae namely, the provision for compulsory study of three languages at the secondary stage. The Board further observed that, as between the two formulae proposed by the Board, the prependerant weight of opinion among State governments was in favour of the second formula, either in the terms actually proposed by the Board or subject to certain modifications designed to give effect to the principal recommendation with due regard to local conditions.

The Board suggested that the Central Advisory Board of Education should invite the attention of the Government of India to the measure of agreement reached so far and recommended that it might be accepted as the basis of an all-India policy in this behalf and that all State governments should consider taking necessary decisions, at an early date, so as to give effect to this all-India policy with due regard to local conditions. (C.A.B.E.)

The Board carefully considered the recommendations Study of the Sanskrit Commission which envisaged the modification of the three-language formula with a view to includ- subject ing Sanskrit as a compulsory subject of study in the secondary curriculum. While the Board fully recognised the importance of the study of Sanskrit both from the cultural and linguistic points of view and the need for encouraging it in all possible ways, it felt that it would not be desirable to include a fourth language as a compulsory subject, as this would either make the curriculum much too heavy or result in substituting Sanskrit in place of Hindi, which is the official language of the Union. The present threelanguage formula which has been approved by the Central Advisory Board of Education, should not, therefore, be disturbed as it provides for the study of Sanskrit either on an optional basis as a separate subject or as part of the composite course. (C.A.B.E.)

The Board stressed the need to make provision for mittee moral and spiritual instruction in all educational institutions. It authorised the Chairman to appoint a committee tions to make a detailed study of the entire question and make suitable recommendations in the matter. (C.A.B.E.).

There was some difference of opinion on this proposal subject of the Rajasthan Government. Briefly, the argument in favour of the proposal was that the largest number of failures occurred in the subject and that a large number of students who did not go to a university had no use for English. The argument for retaining English as a compulsory subject was that it still occupied an important

place in administration and in the educational and cultural life of the country, that students were generally unable to decide early whether they would proceed to higher education and whether they had the capacity to pass the examination in English and that in any case past experience had shown that even when English was made optional, the demand for the subject continued to be universal.

Taking all the pros and cons into consideration, the Board decided in favour of maintaining the status quo. (C.A.B.E.)

1960 Item

The Board recommended that in view of the great Teaching of importance of Science teaching in our schools, steps should be taken by the States to provide for the teaching of General Science in every secondary school, and of elective science in all the old and new higher secondary and multipurpose schools, by the end of the third Plan. This meant that the supply of the requisite number of Science (B.Sc. Hons./M.Sc.) graduates should be provided for by expanding facilities in the existing colleges and increasing their intake, by preparing existing teachers through condensed courses (as was being done in West Bengal and Andhra Pradesh) and by opening new institutions. The Board wishes to stress the urgency of the problem which called for the immediate attention of the States, the Centre and the University Grants Commission.

With regard to the shortage of trained women Science graduates, the Board suggested that women teachers may be employed on a part-time basis if they were not able to work full-time, and even if this expedient did not solve the problem, men teachers may be appointed in the schools for girls so long as the supply of women science teachers did not improve. (C.A.B.E.).

1960 Item

Discussing the recommendation of the Committee on Preparation Moral and Religious Instruction that "we should lay of reference special stress on the teaching of moral and spiritual material for values", the Board felt that the inculcation of values could be effected better through creating the right atmosphere in the educational institutions than by direct teaching. The Board also felt that the treatment should not hurt susceptibilities and, therefore, great caution must be exercised to separate moral and spiritual values from dogmas and tenets.

The Board agreed that in order to secure a balanced presentation of values, the Centre should prepare reference material in the form of books for the use of

these Religious

teachers. The highest talent available in the country should be drawn upon in the preparation of these books so that the essential values of each religion may be clearly brought out without getting involved in theological doctrines.

The Board next considered the suggestions made in the report on the frame-work of instruction at the secondary stages, and expressed its agreement with (a) and (b). Regarding (c), it was felt that at least one period, rather than one hour, a week should be provided exclusively for the use of the books referred to above.

It endorsed the principle contained in (d), namely that all the activities in the school contribute to the development of the pupil's personality. Regarding the suggestion in (e) that "qualities of character and behaviour should form an essential part of the overall assessment of a student's performance", the Board felt that would be difficult to establish a relationship between these qualities and the academic achievement of a student but that in his cumulative record or school leaving certificate, mention should be made of his qualities of character and behaviour, (C.A.B.E.).

1960 Item 7

The Council made the following recommendations on Science teathis subject:-

ching and the Third and Plan

- (1) The Directorate should bring out a handbook for the guidance of science club sponsors containing the objectives and hints on organising the science clubs and also giving information on the equipment necessary for the clubs.
- (2) The assessment of science clubs located outside the jurisdiction of the Extension Services Departments may also be entrusted to the staff of the departments concerned, and the State governments should be requested to bear the T.A. and D.A. of the Co-ordinators for this work.
- (3) State departments should be requested to treat the recurring expenditure on the running of science clubs as admissible for grant.
- (4) In order to initiate students into creative scientific activities, science clubs should also be established in colleges affiliated to universities. The recommendation may be passed on to the U.G.C.
- (5) State Departments and Universities should be requested to conduct training courses and workshops to train

teachers in the use, care and maintenance of science apparatus.

- (6) In order to bring about speedy improvement in science education at the secondary level, Science Development Officers should be appointed one at each State head-quarters and one in each division or region. The scheme should be given the same scale of assistance by Government of India, as is given at present to a similar project at the primary level.
- (7) The Council approves of the 1st of December as the National Science Day and recommends that since the day is to be used as an occasion for promoting science talent, the celebration should be organised for the whole week preceding December 1. During this week science fairs and competitions should be held throughout the country. The Central government should arrange for the grant of awards at different levels for the best exhibits. As the movement develops and gathers strength, colleges and primary schools should also be brought into the programme.
- (8) The Council is of the view that science education (general as well as elective) should be provided in as many schools as possible and that the original target of introducing general science in all the secondary schools where it did not exist at present and elective science in all the old and new higher secondary schools during the Third Plan, should be retained. A careful examination should be undertaken by the Directorate with the help of the Science Sub-Committee to see if estimates of expenditure on buildings and equipment could be reduced to make this target possible within the available Plan allocation.
- (9) In order to meet the shortage in science teacher supply, the Council recommends the following measures for adoption by the States:
 - (a) States which are faced with a shortage of teachers in science as well as in other subjects may consider raising the age of retirement of teachers to 60, provided the individuals are physically fit.
 - (b) Teachers with M.Sc. qualifications should be paid the same scales of pay as they would get in colleges in the State.
 - (c) Certificate courses of 9 month's duration may be organised by universities for giving training to

- B.Sc. teachers in two subjects of the science curriculum. The teachers should be released from duty on study leave, paid full salary during the period of study and given suitable stipends to enable them to meet their personal expenditure during the training period.
- (d) Short certificate courses of 4½ months' duration may also be organised for graduate teachers in one subject.
- (e) A suitable percentage of seats should be reserved in the M.Sc. classes of universities for B.Sc. teachers of high schools to enable them to go through the full M.Sc. course. Teachers should be selected on the basis of efficiency and interest in the subject. Care should be taken to select only such persons as would return to give to the schools the benefit of their training.
- (f) A diploma course has been introduced by the Punjab University since 1958, where a two year course is given to Intermediate science students. The course is of a composite nature consisting of instruction in four science subjects. The subject which they have not studied beyond matriculation is brought up to the Intermediate level and the main subject studied in the Intermediate is intensified to be equivalent to the B.Sc. standard. This is an experiment which may also be tried in other Universities.
- the matriculation (g) Bright students at should be induced to take up science courses through a provision of free-ships, scholarships This measure would go a long way in producing science teachers in areas where B.Sc. teachers are in shortage. These scholarships may be of 4 or 5 years' duration depending on whether the students have completed the higher secondary or the matriculation stage. An integrated course covering both content and pedagogy would be very useful in this field. These courses should be considered as centrally sponsored schemes on a cent per cent assistance basis during the Third Five-Year Plan. The students coming into these courses should be required to enter into a bond to serve the state for a period of not less than 5 years as teachers in secondary schools.

- (h) The U.G.C. should be requested to make a considerable increase in the science seats provided in the college.
- (i) As the question of supply of science teachers is a problem of great magnitude and complexity, desired results could be achieved only if proper coordination is effected between universities and State agencies in working programmes of science teacher preparation.
- (j) As we have no precise figures at present of the statewise requirement of science teachers, or of the percentage of science graduates who come to the teaching profession, a study should be undertaken by the Directorate to make a correct assessment in this regard so that on the basis of the data collected, concrete solutions could be worked out.
- (10) The programme of srengthening science in schools is of such magnitude and urgency that if it is to be fulfilled efficiently, it is imperative that a separate and suitable staffed science unit should be established in the Directorate to implement science programmes. The Central Science Club-cum-Workshop should also be revived immediately so that the functions which it was designed to fulfil and which are vital to science education may be resumed.
- (11) The Council welcomes the idea of the setting up of a Central Institute of Science during the Third Plan and recommends that it should be an autonomous body managed by a Board of Governors.
- (12) The training courses for teachers of all types of schools, junior Basic, primary or higher secondary, should be of two years' duration and should include content courses in general science.
- (13) Courses at the B.Sc. level should provide for general science as a major subject.
- (14) Regarding the need for wider circulation of 'Vigyan Shikshak' (a Publication of the All India Science Teachers' Association), it was decided that the association should be subsidized towards this publication. At the same time State Departments of Education should be requested to authorise their schools to subscribe to the journal.

- (15) The time spent by a teacher on laboratory work should be counted as part of his teaching load.
- (16) The All India Science Teachers' Association, the D.E.P.S.E. and the Central Institute of Science should undertake the preparation of teachers' guides and manuals with the assistance of expert committees.
- (17) Regarding the suggestion made by the Sub-Committee that Science students should also study advanced Mathematics whatever their groups may be, the matter may be further examined by the Science Sub-Committee.
- (18) The Directorate should initiate a study on the working of the science syllabus in the various states as well as in some of the foreign countries.
- (19) The Council considered that it was very essential to prepare standardised designs of apparatus and make them available to industries and institutions and recommended that the equipment should be distributed by a suitable machinery to be worked out by the Ministry of Education in conjunction with the Central Scientific Instruments Organisation. The Council also recommended that a hand-book on the use of apparatus should be prepared by the Directorate in conjunction with the Director of the C.S.I.O.
- (20) The Directorate should bring out a handbook of suggestions for teachers of general science.
- (21) The Council recommends that the UNESCO Source Book which has already been found very useful by science teachers, should be translated into the regional languages and made available to all the secondary schools.
- (22) The Council considered that it was essential to give training to science teachers and laborartory assistants in laboratory techniques and recommended that the assistance of the UNESCO might be sought in setting up Regional Centres for organising such training programmes. (A.I.C.S.E.).

The Board considered the question of encouraging Extra-curriextra-curricular activities through educational institutions cular activities—concern on the lines of the Recreation Club Scheme as submitted of the state by the Assam Government and they adopted the recommendation of the Standing Committee that the matter

was not a question of all-India policy. They were satisfied that provinces were alive to the importance of recreation and extra-curricular activities in schools and felt that the development in this direction should be a matter for each province to work out for itself. (C.A.B.E.)

In view mittee for of the good work done by the Central Advisory Commit- Broadcasts tee of Broadcasting, the Board were unable to agree to its suspension and authorised the Educational Adviser to consult the Controller of Broadcasting and determine how the Central Committee could be reconstituted so that it could effectively function as a central advisory body on school broadcasts.

The Board also recommended that local committees should be set up in the different broadcasting stations concerned and they should be composed of educationists selected by the Directors of Public Instruction in those areas. The Board found themselves unable to agree to the suggestion of the Controller of Broadcasting that the Station Directors should have the option of nominating educationists on their committees. (C.A.B.E.)

The Educational Adviser, having discussed with the Contract Director-General, All India Radio, the question of reconstituting the Central Committee on educational broadcasts, Adviser and reported to the Board that the Director-General while General for appreciating the need of a regular means of liaison bet- School ween education and broadcasting authorities, doubted the efficacy of regular regional committees for this purpose and considered that this would make undue demai ds on the time of his very limited staff. It was suggested that a panel of officers should be established for each regional station by Station Directors in consultation with the Directors of Public Instruction but that liaison at the Centre should take the form of direct contact between the Educational Adviser and the Director-General. Educational Adviser recommended that this arrangement might be tried as an experiment for a year or two. Board accepted the recommendation of the Educational Adviser and decided that this scheme should be tried for two years in the first instance. (C.A.B.E.).

Opinion in general was that provincial governments etc., should be requested to provide the requisite facilities for school children to enable them to take advantage of educational broadcasts. The Board also reiterated the recommendation made by them at their tenth meeting in 1944 for a closer collaboration between All India Radio and educational authorities. (C.A.B.E.).

Annexure A

Report of the Committee on School Broadcasts

In pursuance of a decision of the All India Council for Secondary Education, the Chairman appointed a small committee of five members to consider measures that could be taken for a more effective utilisation of school broadcasts. The following were the members of the committee.

- 1. Shri C. L. Kapur
- 2. Shri M. N. Kapur
- 3. Shrimati K. Bhatia
- 4. Shrimati H. J. Moos
- 5. Shri A. R. Dawood (Convener)

The committee met twice in the office of the Council on Monday, the 23rd September and Friday, the 27th September, 1957. All the members were present at the two meetings except Mrs. H. J. Moos, who could not attend on account of her absence from Delhi. K. Bhan, Secretary of the Council attended the first meeting by special request. Shri Natarajan, Director, Advisory Field Services, actively associated himself with the work of the committee.

The committee considered the suggestions received from various State Governments regarding the measures that could be taken for a more effective utilisation of school broadcasts. Shri C. L. Kapur (of the All India Radio) gave a brief account of the steps that had been

taken or are proposed to be taken by the All India Radio for the same purpose. After a general discussion, the committee made the following recommendations:

I. The All India Radio should make strenuous efforts to secure talented Assistant Producers with the necessary qualifications for their school broadcasts programmes. Besides seeking the co-operation of the Directors of Public Instruction for this purpose, the All India Radio should explore the possibility of engaging the services of retired teachers of the requisite competence and ability. Experienced teachers in non-Government schools could also be employed for this work on a part-time basis, as was being done in the case of the school broadcast programmes of the Bombay station of the All India Radio. In selecting suitable persons for the posts of Assistant Producers, the A.I.R. should also bear in mind the names of teachers who have consistently given good talks in school broadcast programmes during the last ten or fifteen years.

Wider publicity should be given to these posts by inviting applications through announcement over the radio and through the school broadcast bulletins.

- 2. In order that the broadcasts may be closely related to the needs of the pupils, it is necessary that the programmes should be drawn up and the scripts prepared with the help of persons who are actively connected with the work of the schools. In addition to the consultative panel which will examine and offer its opinions on the outline of programme submitted by the A.I.R., there should be committees of subject-teachers for scrutinising the programmes and giving their suggestions regarding material for the script with reference to the special needs of the pupils. Suggestions from other practising teachers may also be invited. The final script should be prepared by a specialist in the subject, taking note of all the material received. The actual broadcasting would normally be done by a person with a good radio voice who is specially selected for this purpose. It was desirable that 40 per cent of the talks or features in the programme should be of permanent value to be repeated year after year, and 20 per cent of the programme should provide for pupil participation. Direct talks by eminent persons should be recorded and the recorded discs should be made available to schools
- 3. Observations on the programmes broadcast to the schools should be invited from teachers and other regular-

listeners. The lecturers of teachers' training colleges, particularly those with Extension Services Departments, should be requested to co-operate with the All India Radio by monitoring the broadcasts as a regular activity of the college.

- 4. In order that the schools may get maximum benefit from these broadcasts and be able to use the valuable material collected for these programmes as an aid in class room teaching at a later stage, arrangements should be made by the A.I.R. to get the talks and features recorded on discs which would be made available to the schools at a reasonable cost. The A.I.R. may enter into a contract with a commercial firm for the production of these discs for school use on a large scale. The publication of the talks and features in the form of printed booklets would also help in a more effective utilisation of the material.
- 5. Instead of depending entirely on Central revenues, the different stations of the A.I.R. should be able to have some independent finances of their own in order to enable them to experiment with certain programmes, undertake research and carry out other measures of an unofficial character in connection with the development of school broadcasts. If the production of records of school broadcasts and the publication of the material used in these broadcasts are undertaken on a commercial basis as described above, a developmental fund can be built up to be used by the All India Radio for the purposes mentioned.
 - 6. A Radio Club of pupils and teachers should be organised in each listening school. These school clubs should become members of a Central Radio Club associated with each radio station. The fee for each school club for membership of the Central Radio Club will be Rs. 12 per annum which is the amount of concession in licence fee given for radio sets used in schools. The Central Radio Club will assist its members in effective listening by providing advance bulletins and other publicity literature, books and visual aids in connection with the school broadcasts. It will also guarantee to its members, the supply of discs and other material relating to the broadcasts at concessional rates.

- 7. In addition to the consultative panels on school broadcasts associated with the different All India Radio stations, it is necessary to have a Central Consultative Panel that would be able to consider problems of an All India character and give guidance to the radio stations all over the country in respect of these broadcasts. The All India Council for Secondary Education may be closely associated with this Consultative Panel which should give representation to organisations of headmasters, teachers and other educational associations.
- 8. The Government of India should arrange that radio sets and other listening-in apparatus should be supplied to schools at certain concession rates prescribed by the Government and that schools may be enabled to make the payment for such apparatus by instalments, if they so desire.
- 9. Short courses for teachers in the organisation of radio listening in schools and a better utilisation of school broadcasts should be arranged on a large scale by all the radio stations. Such courses would yield better results if they are organised in co-operation, wherever possible, with the Extension Services Departments that have been established in about 50 training colleges in the country.
- 10. In order to promote a more effective utilisation of school broadcasts, the A.I.R. should expand its Educational Section at each station and appoint special officers who will visit listening schools from time to time and give them technical guidance in the proper use of the listening-in-apparatus and a better use of the school broadcasts.
- 11. A radio servicing organisation is needed for giving technical assistance to the schools in the proper maintenance of radio sets and the other listening in apparatus. The A.I.R. should explore the possibility of setting up such an organisation as part of the service provided by every station in co-operation with commercial firms. The help of the Community Development Project which has already got a servicing staff for this purpose may also be sought for placing the necessary technical skill at the disposal of the listening schools.
- 12. Secondary schools should be required to levy a small fee of Re. 1 per annum from each pupil to create a fund for audio-visual education and they should be permitted to use this fund for building up audio-visual equipment, including a library of discs, tape records, films, filmstrips, etc.

It was strongly recommended that some form of extracurricular activity must be made available to all the students in all schools all over the country and that for this purpose a proper assessment of various schemes and activities was necessary so that maximum advantage may be secured out of the funds available.

The Board recommended that adequate steps, including provision of suitable incentives to attract promising students to different sports and to help them to cultivate them, should be taken at an early date. (C.A.B.E.)

Dr. Rama Rao. Director of the Central Bureau of Educational and Vocational Guidance, gave an account of the work being done at the Bureau in the field of the construction and validation of different kinds of tests. other members also gave an account of what was being done in their States or institutions. Finally, the Council recommended that the following measures be taken in this behalf:-

- (a) Secondary Boards of Education should be encouraged to undertake research in this field by setting up special Research Units. These may be on the lines of the Research Unit set up by the Cambridge University, or nearer home, on the lines of the Committee set up by the Ajmer Board for this purpose.
- (b) Every encouragement should be given to the Training Colleges to conduct research in the subject, particularly in improving the essay type of examination, perfecting the short answer type of tests and constructing and standardising achievement tests with particular reference to the syllabuses prepared by the Central Co-ordination Committee. It was further suggested that there should be complete coordination between the Training Colleges and the Boards of Secondary Education in the matter.
- (c) It was suggested that a Committee should be set up to advise and periodically report to the Council on the subject of examinations. (A.l. C.S.E.)

The Standing Committees had recommended that the Committee Chairman be authorised to appoint a committee of seven to examine different Item ? persons with the following terms of reference:-

- (a) The nature of the questions in respect of the written examination with reference to (a) the extent to which the objective type of examination (or the new type of examination) may be used; (b) the modifications necessary in the essay type of questions, to minimise the subjective element in the evaluation of these questions, and to give appropriate weightage to the objective and the essay type of questions.
- (b) The nature of the practical examinations to be conducted in respect of the practical subjects included in the scheme of studies suggested by the Secondary Education Commission under section C (Crafts) and D (Diversified courses of studies).
- (c) The final assessment of the pupil on the basis of his performance in the periodi-

cal tests and in the day-to-day work of the pupil at school and the steps to be taken to ensure a common minimum standard for such assessment.

- (d) The necessity of an agency for constantly evaluating the examination criteria of the different States and advising State Boards of Education on measures likely to maintain and improve standards.
- (e) The problem of selection of pupils for Secondary schools and for the diversified courses with special reference to the school records to be maintained in the Senior Basic schools and the Middle schools.
- (f) The preparation of achievement tests by the State Boards of Education and their evaluation by a Central Committee. This was agreed to with the following additions:-
 - (a) Examination of the question of physical conditions under which examinations are being conducted, and
 - (b) the individual variations in the marks given by the different examiners,
 - (c) Any other relevant consideration which the Committee might wish to take in this connection.

- "(i) State Governments should take early remedy the situation arising from lack of accommodation, inadequate equipment and unqualified and untrained teachers.
- . (ii) State Boards of Secondary Education should examine the complaint about the heavy load in the syllabus and the means to be adopted for the proper handling of the syllabuses so that the emphasis may not be so much on the mastery of subject matter as on the educational growth of the child. It was also resolved to recommend to the State Boards that curriculum committees should be established for constant evalution of the syllabi and, wherever necessary, making suitable modifications.
- (iii) State Boards of Education should also examine the possibility of making changes in the pattern of

examinations on the lines recommended by the Seminar on Examinations held at Bhopal and the Conference on Reform of Examinations held at New Delhi and should be urged to take early steps to implement them. suggestion that in each subject, examinations may be conducted at two levels-an ordinary and an advanced levelmay also be examined by the State Boards.

(iv) State Governments should consider whether the jurisdiction of the Boards of Secondary Education could not be suitably limited, so that no Board would have the responsibility of examining several thousands of candidates at a single public examination as at present". (A.I.C.S.E.)

The scheme of setting up an Examination Unit in the Examination current year was approved by the Council. The Council also approved the following modifications recommended in the Budget by the Standing Committee:

"The travel cost of the staff was reduced from Rs. 15,000 to Rs. 6,000 and the travel cost and boarding charges of the participants were reduced from Rs. 30,000 to Rs. 15,000. The printing charges were reduced from Rs. 16,000 to Rs. 10,000 and the total budget for the year 1957-58 was altered to Rs. 70,000. It was further resolved that this amount be met from out of the provision for Experimental projects."

It was resolved that with these modifications the estimates be approved.

It was further resolved that a Selection Committee consisting of Messrs. Chak, Habibul Rahman, Sohanlal and the Chairman be appointed for the purpose of selecting five Evaluation Officers for the Unit to be set up in the current year. (A.I.C.S.E.)

The Council approved the recommendations made by Establishthe Standing committee regarding the establishment of the ment of refive regional offices at Chandigarh, Allahabad, Calcutta, Baroda and Madras. It agreed that each Regional Office would be in charge of a Field Adviser of the Council and would consist of the Field Adviser and the three Evaluation Officers. The work of this office would be to remain in close touch with Extension Services Centres and the associated schools working out the various projects of the Council, such as Science Clubs, Experimental Projects, Evaluation Workshops and Follow up Work.

It was decided that the Council should write to the Education Departments of the States and the State Boards that the Evaluation Officers would work in close cooperation with the teachers so that Examination reform may be linked up with improved practices in teaching and to request them to give the necessary facilities for the purpose. The Council agreed that the question of examination Reform of failures went deeper than mere testing. A solution, there-examination fore, was to be sought in a fundamental reform of the examination system so as to relate it closely to teaching objectives and learning processes. The Council was in full agreement with the programme of examination reform already launched by the Directorate, and made the following recommendations for the furtherence of this programme:

- (1) State Governments should extend the maximum cooperation in the early implementation of examination reform.
- (2) Secondary School Examination Boards should introduce the new type questions into their examinations after giving due notice to the schools.
- (3) Wider publicity should be given to this subject of examination reform so that the principles underlying it might be widely understood.
- (4) A full bibliography on the subject should be compiled and made available to teachers and administrators. (A.I.C.S.E.).

(1) The Council considered that the problem of Examination Reform was of the utmost national importance and that in order to ensure satisfactory progress in the reform the setting up of State Evaluation Units was of the greatest urgency. The Council, therefore, recommended that State Departments should

1960 Item 5 take early steps to set up State Evaluation Units and that the scheme should be centrally assisted.

- (2) The Council also recommended that the Central Examination Unit in the Directorate should be further augmented so as to ensure sufficient progress in the reform.
- (3) The Council approved of the following programme of the Examination Unit for the year 1960-61.
- May 25-July 10, 1960. Evaluation Officers will conduct ten workshops in two rounds for introducing the new concept of evaluation to the staff of the training colleges.
- This will be followed at a later stage by intensive work with the training colleges included in these workshops.
- July-August 1960. A six to eight-week workshop will be arranged for training State Evaluation Officers.
- September 1960 to March 1961. The Evaluation Officers will work in close collaboration with the State Evaluation Units and will be available to the States at their request. (A.I.C.S.E.)

6. Experiments, Equipments etc.

Appendix E

Interim Report of the Committee on Experimental Projects

With regard to experimental projects in secondary schools the meeting of the Council held in June, 1957, in Simla passed the following Resolution:

Item No. 10

To appoint a special committee to lay down criteria for encouraging worthwhile experiments in secondary schools and for selecting experimental schools.

This subject was discussed at some length and it was finally agreed to authorise the Chairman to appoint a committee which will examine projects received from the various schools and recommend the sanction of suitable grants. It was resolved that assistance should be given to both small projects of a classroom nature and to major projects affecting the organisation of the whole school and that a ceiling of Rs. 10,000 per school may be fixed for the present. State Governments and Extension services Departments should be requested to suggest names of good schools out of which selected schools may be invited to submit their schemes for examination by the committee and for the sanction of grants.

In accordance with this Resolution, State Governments and Extension Services Departments were requested to suggest the names of suitable schools that would be able to undertake experimental projects. They were also requested to ask the headmaster of each selected school to forward a detailed proposal regarding the projects proposed to be undertaken, indicating the aim and scope of the project, the programme of work and the estimates of expenditure. For the purpose of sanctioning the proposals received, the Chairman appointed a Committee consisting of the following seven members:

- 1. Prof. T. K. N. Menon, Dean, Faculty of Education and Psychology, Baroda.
- Dr. E. A. Pires, Principal, Central Institute of Education, Delhi.
- 3. Shri C. L. Kapur, Chief Producer of Educational Broadcasts, A.I.R., New Delhi.
- Shri M. N. Kapur, Principal, Modern School, New Delhi.
- Shri Ved Prakash, Assistant Educational Adviser, Ministry of Education, New Delhi.
- Shri S. Natarajan, Director, Advisory Field Services, AICSE., New Delhi.

 Shri A. R. Dawood, Deputy Director, Advisory Field Services, AICSE, New Delhi.

The first meeting of the committee was held on the 24th October, 1957, in the Committee Room of the Ministry of Education, New Delhi. All the members attended the meeting. Shri K. G. Saiyidain, Chairman of the Council was also present. Among others who attended the meeting were Dr. R. K. Bhan, Secretary, AICSE and Dr. C. B. Mandenhall, Consultant, AICSE. After a few introductory remarks by the Chairman of the Council regarding the significance of this pilot project, Shri Natarajan pointed out that proposals were received from about 200 schools in different parts of the country. Many of the schools that had sent in the proposals were selected by the State Departments of Education. Others were recommended by some of the Extension Services Departments. Shri Natarajan gave the following detailed statement regarding the number of schools in each State that had sent in the projects:-

Andhra Pradesh 15, Assam 2, Bombay 46, Kerala 15, Madhya Pradesh 4, Mysore 12, Punjab 11, Rajasthan 10, Tripura 3, Uttar Pradesh 26 (through Extension Centres) and 10 (through the State Education Department).

Some States like Madras had asked for extension of time for sending the proposals.

The committee then discussed the criteria to be laid down for the selection of schools for this experiment and the assessment of grants to them. The following recommendations were made in this connection:

- 1. The project proposed to be undertaken should be worthwhile i.e., it should provide valuable learning experiences for the pupils.
- The activity proposed to be undertaken through the project must not be one which schools are normally expected to carry out in their dayto-day work.
- 3. The schools selected for the project should be 'Good' schools, they should have a competent staff, possess adequate facilities for the proposed experimentation and should be able to provide time for their teachers to work on the project. In this connection it was prointed out that since the schools selected were those

recommended by the State Departments of Education—or the Extension Services centres—the presumption was that they were 'Good' schools, capable of undertaking the proposed experiments.

- The committee, however, felt that before a project was finally accepted, details should be obtained from the schools regarding the items referred to above.
- 4. The project should be such that its results should be capable of influencing practices in other schools.
- 5. No grant can be given for accommodation, but non-recurring expenditure for purchase of reference books, materials and necessary equipment within reasonable limits may be considered as admissible.
- 6. Assistance should not be given for the appointment of additional staff, except in very special cases, for the purpose of the project is that the regular school staff should be involved in the experiment.
- 7. No extra remuneration should be paid to teachers from the schools for working on the project. It was necessary, however, for the headmaster to see that the teaching load is not increased on account of their participation in the project.
- 8. It is desirable that not more than one project should be sanctioned for one school. It was also desirable that the projects selected should be as varied as possible and the same project should not be undertaken by several schools.

Shri Saiyidain then stressed the value of getting the full approval and co-operation of the State Governments concerned before the projects were started in the institutions. He also suggested that the Council might invite proposals, through the State Governments, from some non-aided progressive schools including Anglo-Indian schools and Public schools.

Shri Saiyidain then informed the committee that it would also have to consider important aspects of another major experiment which the Council proposed to undertake, the experiment on the lines of the 8-year study conducted in the U.S.A. some years ago. For this experiment it was proposed to select 30 schools from all over

India at the rate of about 2 from each State and get them released from the control of the Education Department and the restrictive influence of an external examination, so that they could develop independently their own courses and programmes of studies. The committee, said Shri Saiyidain, would have to consider the comments received from the various State Governments and Universities regarding this experiment and give its opinion as ways and means of implementing the projects.

The committee then selected some of the projects submitted by the schools of Delhi State and Bombay and examined them in the light of the criteria laid down. After a long discussion it was agreed that it was not possible for the whole committee to screen all projects. It was, therefore, decided to appoint a small committee to scrutinise them in the first instance and submit a report of their findings to the committee as a whole later on. (A.I.C.S.E.).

The Committee was also authorised to lay down science club conditions for financial assistance to the science clubs. activities The Council further resolved that applications for assistance from science clubs might be invited through State Governments and the grants to these clubs could be made through the State Governments. It was further resolved that such grants should not be utilized for payment of remuneration to the sponsors of science clubs but should be utilised only for purchase of equipment and promotion of activities. (A.I.C.S.E.).

The Council commended to the Government of India the proposal for setting up an industrial concern for the design and manufacture of standard scientific instruments for use in the secondary schools.

It was resolved that during the year 1958-59 a workshop on General Science in high and higher secondary schools be organised for the development of leadership among Science teachers and that State Governments be requested to depute two Science teachers from each State. (A.I.C.S.E.).

(4) The Council endorsed the recommendation of the sub-committee, that a list of problems which called for experimentation and research should be prepared by the Directorate so that the schools that wished to undertake experimental studies might select those problems which they could handle at their level (A.I.C.S.E.).

They were impressed with the propagandist value of such an experiment with a view to the education of public opinion. In this connection the Board also wished to emphasise the great and urgent need for training a sufficiently large medical personnel. The hope was further expressed that the Health Survey Committee of the Central Advisory Board of Health would take into account the proposals contained in the Board's Report on Post-War Educational Development regarding the Health of the School Child and Physical Education in Schools. (C.A.B.E.)

- (I) The Council was of the opinion that it was essen- Guidance tial to provide a full programme of vocational guidance in every high/higher secondary and multi-purpose school during the Third Plan. The best arrangement would be to have full time Counsellers in every multi-purpose school but where that was not possible, the Council recommended that the proposal put forward by the Central Bureau of Educational and Vocational Guidance of providing minimum programme of vocational guidance be implemented. This programme should consist of providing teacher-counsellors in all the 1500 multi-purpose schools, a career master in every high and higher secondary school and one peripatetic Field Counsellor for every 15 multipurpose schools. The Council considered that this was the minimum basic programme that should be implemented during the Third Plan so that it would constitute the foundation for a full-fledged guidance programme in subsequent years.
- (2) The Council recommended that co-ordination committees should be set up in all the States where they do not exist at present in order to co-ordinate the present activities of vocational guidance conducted by the Ministry of Education and the Ministry of Labour and Employment.

- (3) District Committees should be established in order to co-ordinate the vocational guidance activities at the district level. These committees should include the representatives of the Education Departments, Employment Officers, Heads of Secondary Schools and others concerned in the programme. The Council also recommended that these District Committees should work in conjunction with the National Small Scale Services Institutes set up by the Ministry of Commerce and Industry in the various regions and districts of the country.
- (4) The Council recommeded that the question of having a uniform pattern of training in vocational guidance for teacher-counsellors and youth employment officers should be further examined by a Committee of experts in the subject. (A.I.C.S.E.).

12. Extension Services and Regional Seminars

4959 Items 9 and 10

The Council noted with satisfaction that steps had Extension been taken to introduce Extension Services in 24 selected Services in Training Colleges. The Council generally approved the Colleges list of services proposed by the institutions concerned and expressed the hope that these will be adequately strengthened and expanded in the near future. In this connection, the Chairman clarified that from next year the programme was likely to be expanded to cover eventually all the 54 colleges that had sent in proposals in this behalf.

With regard to the procedure of payment of grants, the Chairman informed the Council that the Ministry was exploring the possibility of making the payment direct to the Principals of the Colleges concerned. If this materialised the Principal of each institution will have to open a personal ledger account for this purpose. The Education Departments of the State Governments would, of course, be duly informed of the amounts transferred to the training institutions in their areas from time to time. In the case of the University Departments of Education, grants would be sent direct to the Principals or Heads of the Department under advice to Vice-Chancellors concerned. (A.I.C.S.E.)

(h) The Standing Committee had suggested that the Secondary Teachers' Association in different States might be invited to organise seminars for subject teachers and that a grant up to Rs. 2,500 per seminar might be given by the All India Council for Secondary Education. After discussion, it was decided that this should be done in consultation D.P.I's of the States and the Headmasters as well as the Teachers Association should be approached. (A.I.C.S.E.)

In regard to the continuance of the project during the Second Plan period the Council resolved that:

> (i) expenditure for the 23 colleges of the first flight for the remaining part of the Second Plan period might be of the same order as has been provided for in the case of the training colleges brought under the project in the second flight namely Rs. 20,000 per per colleges,

(ii) this expenditure might be met by the All India Council for Secondary Education Government of India be requested for a grant to cover this expenditure. The Council also resolved to request the State Governments to bear the travel costs of the participants which would work out to about Rs. 6,000 per annum

It was agreed that the expenditure incurred by the services and the personlocal participants in connection with their journey bus or other similar conveyance should be met by Council, and that the actual charges should be paid to teachers coming from within municipal limits. Details should be worked out within a ceiling of Rs. 500 out of the budget sanctioned for each Extension Services Department. The Principal and Director of the Extension Services Centre have to determine the rates of payment, taking due note of the local conditions regarding means of transport.

With regard to the problem of reorganisation arising out of the continuance of the project, the Chairman was authorised to scrutinise the staff list of the Extension Services in the colleges in the First group so that the services of competent Co-ordinators might be retained in deserving cases on salaries that would be drawn by them at the time the first term of the project expired. It was suggested that the difference in the salary thus payable to the Co-ordinators and the minimum of the revised scale might be treated as personal pay. (A.I.C.S.E.).

After considerable discussion it was agreed that the ceiling of Rs. 7 per day per participant for the Seminars sponsored by the Council should not be exceeded. It was suggested that the Council should inform the State Governments as soon as possible about the programme of Seminars for the next year and that the State Governments should be requested to take early action and select the participants so that they might be in a position to inform the Council of the special problems they would bring up for study at the seminars. It was also decided that the Directors of the Seminars should continue to function in an honorary capacity for some time even after the seminar was over and keep in touch with the participants, so as to effect an immediate follow-up. They might be authorised to incur necessary expenditure postage etc., for correspondence with the participants. (A.I.C.S.E.).

- (2) the project should be extended to all the training collges by the State Governments making adequate provision in the Third Five Year Plan for the purpose; and
- (3) The Extension Services should be made an integral and permanent part of the programme of every training college by the State Governments taking over the financial responsibility

of the existing Extension Centres so that in the Third Plan period they might become State schemes.

The Council also recommended that State ments should extend their assistance in strengthening this programme in the following ways:-

- (1) Managements of schools should be directed to depute teachers to the seminars, courses and other in-service programmes organised by the Extension Services Departments.
- (2) Follow-up measures should be taken on the recommendations made at seminars, workshops
- (3) T. A. & D. A. should be made available to participants in time.
- (4) Inspecting officers should be directed to watch and periodically assess the extent to which the participating schools utilse the facilities offered by the Extension Services Centres.
- (5) Individual experimentation should be encouraged in schools on new methods and techniques discussed at seminars and workshops. (A.I.C.S.E.).

- (2) The Council endorsed the Sub-Committee's recommendations regarding the minimum qualifications for a Co-ordinator, namely, that he should possess a good Master's degree (preferably first class) and a degree or diploma in education, and should have five years' teaching experience, of which at least two years should be in secondary schools and two years in training colleges.
- (3) In view of the key position held by the Coordinator in the in-service training programme, the Council felt that there was need for making careful selections for the post and therefore recommended that the Directorate should continue to have the final word in the Co-ordinator's selection.
- (4) In respect of Co-ordinators in Government training colleges who were not eligible for deputation allowance after the transfer of administrative control, the Council recommended that a special pay of Rs. 100/- should be paid to them in addition to their usual salary as lecturers in the training colleges. In respect of Co-ordinators in non-Government colleges, the Council was of the opinion that the present scale of Rs. 400-500 might continue.
- (5) In respect of those Centres where the nature of activities justified additional funds, the Council recommended that an additional grant of Rs. 2,000/- per annum might be sanctioned over and above the present practice of allotting Rs. 18,500/-
- (6) The Council endorsed the recommendation of the Sub-committee that a Co-ordination Committee should be established in each State consisting of the Director of Public Instruction/Director of Education of the State, Honorary Directors of all Extension Centres in the State and one other educationist. The Board had under consideration the question raised by the Assam and Bihar Governments in regard to nar (a) maintenance of discipline in schools and colleges and tion (b) participation of students in politics. The Board construdents sidered the views expressed by the Standing Committee.

In regard to (a) the Board were of the opinion that disciplinary action should be taken by the heads of the institutions against members of the staff who encourage students to participate in political activities of a subversive type; and that educational authorities should ensure greater contact between their staff and students and also secure the co-operation of parents and public men in maintaining discipline in schools and colleges. They felt that punitive action as a general measure against students would defeat its own purpose.

In regard to (b) the Board were of the opinion that opportunities should be provided for discussion of all political subjects within schools and colleges, but active participation in political movements should be discouraged. (C.A.B.E.)

The Board agreed with the recommendation of the Improvestanding committee on the reports received from proditions helps vincial governments etc., with regard to the question of discipline discipline in schools and colleges. They felt that the real solution of the problem of maintaining discipline in schools and colleges and checking the undesirable participation of students in politics lay in an all-round improvement of conditions in schools and There must be better residential and tutorial arrangements and fuller and freer extra-curricular activities for students but even more important is an improvement in the position and conditions of service of teachers. Not until the status of teachers is raised will they be able to establish closer and healthier relations with students so as properly to influence and guide them and their parents. In schools it is particularly necessary teachers should be in a position to establish contact with parents and there should be close co-operation between the two; but they will not be secure recognition from parents for this purpose unless the status accorded to them is commensurate with the obligations they would thus assume. - "The Board after very careful consideration of the stage of termination of secondary education and the qualifications necessary for entry into the universities arrived at the following unanimous conclusion:-
- (a) The degree course should be of three years and 17 plus should be the minimum age for entry into universities.
- (b) The end of secondary education at 17 plus should mark a terminal stage in education and prepare students for life. It should also be of a standard which would enable them to participate with profit in a three-year course.
- (c) The Government of India be requested to appoint a committee to draw up an integrated syllabus for the School Final Examination to achieve the above objective.
- (d) The last class in the secondary stage should be called the 11th class and may be reached after schooling of not less than ten years, the actual duration of the school system in the various states to be determined by the State Governments concerned.

The Board is of opinion that for the implementation of these recommendations, it is necessary that financial assistance in a liberal measure should be provided by the central and state governments. This Board therefore requests the central and state governments and the Planning Commission to provide necessary finances in the second Five-Year Plan for the implementation of these recommendations. (C.A.B.E.)

Survey

The directive of the Constitution in favour of free and compulsory education up to the age of 14 years should be fulfilled in ten years i.e., during the second and the third plan period. Such immediate measures as are needed to make the achievement of this aim possible should be taken in cooperation with the States. In this connection it was suggested that a suitable machinery at the all India level might be set up to solve the financial, ministrative and pedagogic problems of primary education, if necessary on the lines of the All India Council for Secondary Education. With regard to the note on the educational survey by Shri J. P. Naik, the Board welcomed the suggestions and recommended that the proposed survey should not be limited to primary education only but should include secondary education, including technical education at the secondary level.

With regard to the contribution from private sectors, it was agreed that besides contributing the nonrecurring costs through voluntary labour, local communities through their elected representatives should be enabled to raise additional revenues through a cess for education for which each State should enact suitable legislation. This will make it possible for local communities to take a larger share in implementing programmes of educational expansion and development in addition to those already approved in the draft. The Education Minister, Madras, raised the broader issue that a uniform policy with reference to linguistic linguistic minorities in the various States should be formulated by the Education Ministry and placed before the Governments for consideration. Thereafter an agreed formula could be evolved which could be adopted as a uniform policy in all the States. (E.M.C.)

(1) Preparation of teachers for the practical courses Teachers envisaged under the Multi-purpose Scheme.

for practical courses etc.

(2) Helping State Governments to secure well-qualified teachers for the teaching of such new subjects as General Science.

With regard to these two proposals, the Council expressed the view that it could not undertake the task of training teachers, as this was the responsibility of the State Governments which had already provided funds for the same in their Plan programme.

(3) Strengthening teachers' organisations for devoting attention to the improvement in the techniques of teaching classroom subjects.

It was resolved that specific project grants be given to bonafide Teachers' Associations approved by the State Education Departments. It was further resolved that the nature of the project was to be decided by the Council and that each application for grant would be considered on its merits.

(4) Encouraging educational institutions and teachers to try out experiments on the new techniques in their respective fields.

The provision of Rs. 1,00,000 for encouraging such experiments was approved. Mr. Menon's suggestion that an ad-hoc committee should be constituted for this purpose was accepted by the Council, and it was resolved that the Chairman should appoint a small committee of three or four members to examine the projects carefully before recommending them for support.

(5) Selecting a certain number of centres and converting them into experimental centres with a view to developing initiative and responsibility in the teachers, so that the schools might be released from the restrictive influence of an external examination and an external syllabus prescribed for them on the lines of the eight-year study of the U.S.A.

The Council agreed that for this experimental project about 25 to 30 schools in the country should be selected at the rate of two from each of the larger States and one from each of the smaller ones. It was resolved that each selected school be given a non-recurring grant up to Rs. 50,000 and a recurring grant up to Rs. 25,000 for the first year and non-recurring grant of Rs. 25,000 for each succeeding year of the project. It was further resolved that the selection of institutions for this project should be made on the recommendations of the State Departments of Education and with reference to well-defined criteria-The Council also expressed the view that each school included in the project should have the guidance of an advisory committee consisting of outstanding educationists in the State.

(6) Exchange of teachers:

The Council was not in favour of an inter-State exchange of school teachers, but was of the opinion that an inter-State exchange of lecturers of Training Colleges could help to stimulate and improve teaching practices. It, therefore, suggested that a programme of such inter-State exchange of lecturers should be arranged by the Ministry of Education, the Ministry bearing the travelling expenses of the visiting lecturers and the host college bearing the expenses on account of the lecturers' salaries and other allowances.

(7) Science Clubs in Schools for pupils:

The Council express the view that in the initial stages provision should be made for about 200 science clubs in the country. It was resolved that an average of Rs. 1,250 should be sanctioned for each club and that a total sum of Rs. 2,50,000 should be provided for this purpose. (A.I.C.S.E.)

The Council considered the original targets in the Targets in field of secondary education during the Third Plan work- Five-Year ed out by the Working Group on Education and the pos- Plan sible reduction in these targets that would be necessitated by the actual allocations of funds during the Plan period and recommended that the original targets fixed in the Draft Plan in respect of additional enrolment of 15 Jakhs. conversion of high into higher secondary schools and the provision of science should not be reduced.

The Council fully supported the proposal to establish four regional training colleges and some model multipurpose schools during the Third Plan and considered that this was a very essential measure to raise the stan-

dards of the multi-purpose schools. It suggested that Bombay, Calcutta, Madras, Hyderabad and Delhi as possible places for the location of the four colleges. As regards the model multi-purpose schools, the Council agreed that there was need for such schools, on which other institutions could pattern themselves and suggested that wherever possible existing schools which could be upgraded to model institutions should be so converted, the remaining schools being developed as new institutions. The Council was of the opinion that careful criteria should be worked out for the selection of schools which could be upgraded.

The Council welcomed the idea of the travel seminars but recommended that it should be ensured that those who participated in the seminar should return to those positions where their experience would be used directly for the improvement of the multi-purpose scheme.

In view of the fact that the education of girls and women is lagging far behind that of boys and that there is an acute shortage of women personnel required for various development programmes particularly in the fields of education, health and social welfare, the Council recommended that every attempt should be made to retain the provision for the special programme included in the Draft Third Plan as suggested by the National Council for Women's Education. If, however, any cut is necessitated in the total programme, not greater than a proportionate reduction should be made in respect of this sector and the amount earmarked should not be diverted to any other purpose. (A.I.C.S.E.)
