Page 5. Organisation of the Masses.

Make this your motto. Create self respect in them.

Only the organised masses can acquire their rights; save the country from eternal destruction and confer true freedom and real equality on them.

Page, 13. We want to destroy the exisiting Govt. because it is prejudicial to us and has placed us in sorts of troubles.

Page 22 First of all we should acquire Political Independence; because it is the first step towards our goal. But we know very well that we shall not get everything which we want by making slight changes in the existing Govt. and which changes are necessary for every Indian (desirous) of living like men. Every one living upon his honest earnings must try against this Constitution, because the existing constitution acknowledges the right of the Rich to plunder the Poor.

Page 26. The Govt. is essentially the representative of the people. It is the duty of the National Govt. to safeguard National interests. Who are the people of India? Who are the backbone

of India? the Rich or the Labourer? 90% Indians are either peasants or workers. These are the men who produce everything, who cultivate, weave, build houses, roads and Railways, sink mines, run the railways and the ships. They work for the life and progress of the Society. This clearly shows that the interests of this party are the interests of the Nation. The national welfare of India means the welfare of the Peasants & Workers of India.

### Do the work and show.

Under this circumstance the national Govt. should be representative of the peasants and workers. Only that Govt. can be called National which represents that element, which creates the society. It will safeguard the Nation and the interests of the majority. The Rich can not watch the Poor, because they flourish to deprive others. But when the poor workers gain strength, their only demand shall be that everybody should work and enjoy his labours and no one shall be competent to plunder another.



Page 51. Therefore so long as a foreign Govt. governs the country, the National Capitalists shall be suffering.



Page 52. We want to change the existing Constitution because it is misusing our community. In India the workers and peasants are poor, they starve, they die in thousands of fammine and of plague, because the looting wealthy Community is depriving them of the fruit of their labours. Those who govern the country are foreigners and naturally use us more than the Capitalists of the country. The more we fight against semi foreigner Imperialists,

the more we try for National Freedom. But the foundation stone of our exertions is different from that of the higher class. The rich high class wants changes in the foreign Govt. The poor peasants and workers want the same, but in their own interests. What are their interests. Are they the same as of the higher class. No.

The destruction of Capitalist Constitution is necessary.

In other words Muncipal employees who maintain the flourishing condition of cities and towns, (employees of) civil Railways, Posts and Telegraph departments, etc. and factory workers, should make their joint unions and then establish a big common labour association. Similarly, the labourers working in mines and fields should, after making their respective Sabhas, secure their heritage. Petty shopkeepers who undoubtedly have the same position as labours (lit, working labourers) should also

raise a voice of protest against income tax and exhorbi-Page 12. tant house rents. Literate people belonging to the lower classes should make demonstrations for freedom of press and of speech and against oppressive laws. In short, all those classes who in the true sense of the term deserve freedom, are desirous of (getting) it and are prepared to (make) sacrifice, should paralyse the Government machinery on all the four sides, and this very mass power can bring about a complete revolution.

### PEASANTS PROGRAMME.

### Immediate Programme.

- (1) The Revenue should be reduced by at least  $\frac{1}{3}$ rd. Now it must never increase; because it is already so much that it is crushing the poor peasants. If the Revenue is enhanced at the time of any settlement, its payment should be refused.
  - (2) Appraisement to the extent of  $\frac{1}{2}$ .
- (3) Interest should be stopped by law: i. e. interest should never be charged more then 6 p. c. and he (?) should have no right to obtain anything from the peasants without payment.
- (4) Interest should be stopped after the father's death. The children or the heirs should pay only the (principal) amount, and interest accumulating prior to the death. In no case interest should exceed the principal.
  - (5) Every adult person should have a vote.
- (6) Income below Rs 2000/- should not be assessed with 'Malia'
- (7) Only those men can join the Jathabandi whose land is 60 Bighas or less.
  - (8) Indirect taxes &c. should be stopped- Chaukidara Tax.
  - (9) Free Education.
- (10) Government should referain (themselves) from selling lands. Whereever the land happens to be, more than one Square should no where be given, and it should be given only to such persons as cultivate Khud kasht lands. (or "as cultivate it themselves)

(11) Pay of (men in) Government service should be reduced.

If the crop fails, the revenue should be totally remitted and help should be given by distribution of Taqavi &c.

The peasants should be helped by Government for improvement of cultivation. It is only then that they can purchase newly invented implements and increase the produce.

No one should be imprisoned on account of loans taken on interest.

# P. 890 (2) (T)

### THE PROGRAMME IS THIS.

- z. Zamindari and Jagir Dari (Landlordism \*) should be abolished without any remuneration and they should be given only as much land as they can themselves cultivate:
  - \* Original Word

- 2. Every man should have a right to vote by right of his being a man, and not by right of his possessing property.
- 3. The programme for bettering the condition of the labourers should be accepted-More than 8 hours labour by them, should be prohibited by law.
- 4. The debts on India should not be acknowledged because they have been contracted to bind India and not to free her.
- 5. Indian States should be abolished—They should be included in India, and governed according to the principles of Republic.
- 6. The peasants and the labourers should be organised separately, with regard to their requirements, enumerated (lit. included) in the programme. For purposes of obtaining freedom, the Revolutionary mass Action should be accepted to be acted upon.





#### WAR.

Last time when we had assembled, I had spoken about the danger of (the out break of) a new war and that war is now being seen fast approaching and it is not known when this big demon, who gets satisfied by unhesitatingly making human beings the victim to (lit. morsel of) cannon, may again show its ominous oppearance. Our policy regarding it is quite clear (and that is) that if the war breaks out we, shall raise a storm of an agitation in the country, so that India may not render any sort of assistance to the British Imperialism.

#### Public Safety Bill and Youngmen.

Pupblic Safety Bill is now being introduced in India. Communist ideas will be checked by this bill. In other words this bill is in reality, being framed for us, for ours is the only body which wants to establish a republic of labourers and peasants in India. In their speeches the Home Member and several other Government members have said that communist ideas are spreading with rapidity amongst the youths of India. That these ideas are harmful and that society apprehends serious danger from them. Considering us as simple-minded persons they have introduced this bill so as to save us from these ideas and they appear to be very anxious for our good. But, are these ideas really dangerous? I think that these ideas are in no way dangerous for us. They are however, really dangerous for the existing administration (lit: system) which is based on the foundations of capitalists and imperialism. These ideas which are leading us towards revolution are a hundred blessings to us, for they "will do us no harm, nay, our chains ( of slavery) will be broken asunder and we shall get a (new) world". But these ideas can really be dangerous for those who are ruling this country and whose Government will soon vanish away by these ideas.

There is no room for doubt that all the articles of comfort are (meant) for the capitalists, while sorrow, labour and toil only are for the labourers. Do not keep in view the external condition of the labourer (and) forget the internal condition of his house, but it is a matter for consideration why the sanitary department known as the municipality which realises taxes from the labourers as well' does not look to the sanitation of Mohallas inhabited by the labourers See the sahitary condition of the places inhabited by capitalists.... (sic!). A straw can hardly be found there. The roads shine like a mirror, (Now) take the Mohallas inhabited by labourers. You will find heaps of filth here and there. Cleanliness is such that like the desert of Africa dust flies from one side to the other the whole day long and falls on the clothes and in the eyes of wayfarers. Well sir, what is the reason of this? What is the cause of this indifference? Does it not constitute taking undue advantage of the weakness of labourers? The poor labourer keeps quiet after saying:

"O oppressor (lit: inventor of oppression)! tease me as much as you like."

Bombay:—Madanpura, Jacob Circle, Lal Bagh, Kumatipura, Warli, Dadar, Mazgaon, Seuri, Bandra, Mahim, Bhaikulla, Village Pareil, Dongri, Umar Khari, etc., etc.

Calcutta: - Mattia bridge, Lower circular road, etc., etc.

Cawnpore: -Gwal Toli, etc.

Delhi:-Hindu Rao ka Bara, Ajmeri Gate, etc., etc.

Ajmere:—Behind the Durgah.

Lahore: - Mention not its name. It is dust out and out.

Where do capitalists live:-

Bombay:—Chopati, Malabar Hills, Colaba, Appollo, Mahalaxmi and on the seaside.

Calcutta:-In Maidan and by the sea side.

Cawnpore: -Around and near the cantonment.

Lahore:-Near the river.

There are many other cities about which we can say but we have counted these particular cities by way of example. The roads

of) stones are visible there. Lighting arrangements are inadequate (as a result of which) the wayfarers stumble day and night. If anything enjoys freedom in these Mohallas it is dust.

Thou thyself canst not distinguish between thy profit and loss. In short, O labourer and hard working (person); thou art a strange personality! (Thou) art lying in the pit of ruin (and) dost not evidently appear to be adopting any means of safety. Thou hast not the ability to discriminate between a friend (lit: wealth) and foe; then say how will thy salvation be.

God bless you. After a long time the breeze from (my) country at last brought a message of life. The tumultuous ideas in my mind which has become half-silent again revived. The tree nope again began to flourish (lit. blossom). Those who keep the path of love (and) had for sometime lost their way in wilderness again reached the highway, but this highway abounds in steel thorns. The travellers on the path of revolution may not think (themselves) out of (lit. safe from) danger. This impassable journey will be completed with difficulties and precaution.

All your complaints 'are' reasonable. I cordinally accept all of our grievences. I lower my head before the dagger of the arbitration of (my) friends (and) accept whatever punishment is proposed, but when all the defence story is related all (of your) complaints will prove of no avail. We must have written you and started correspondence with you: but where? We learnt from (the perusal of) newspapers that you had been released from Ferrangi's prison, but surely correspondence could not be carried on with you through newspapers. We received no letter from you. We were very anxious to start correspondence with you, but we failed (in doing so). Who is to be blamed for this? Your sacrifices will not go in vain. You possess a high place in the hearts of (your) friends.

You ridicule my retreat from Pondicherry. If the party had ordered me to surrender to the enemy instead of retreating, I had no objection to it whatsoever. I did not run out of fear.

"I am not (such) a person that you mayest see my back on the day of fight".

"I am (such) a nerson that thou mayest find my head (weltering) in dust and blood."

Do no take it as a brag. I do not know how to brag; you will soon see that. Company will be enjoyed it friends (rem in) alive. As regards the matter that I could do no work it is undoubtedly true. The number of travellers (on the path of revolution) was not so large that they could be led easily. I myself was entrapped in the cage as soon as I came and all of my roads had been blocked. This will not happen on the next occasion—complete success or destruction, there is no intermediate course for me.

Now I write a few things about work:

(1) Received all letters of Bagarhotta. An instalment of money has been sent to him on the address given by him which must have reached him by now (since) a month has elasped. More money will be sent to you if you will soon start a newspaper of the party
