The 4th edition of the Manual of Bombay Acts and Regulations in two volumes published in 1932, and kept upto date fromtime to time by the insertion of new Amending and Independent Acts, having been exhausted, the author feels no small amount of pleasure to bring out this 5th edition of the same.

This edition incorporates all the unrepealed Bombay Regulations and Acts assented to by the Bombay Legislature from 1827 to February 1937, with exhaustive annotations and Government Rules thereunder amended upto date.

As such voluminous works have their utility solely as reference books, not a single unrepealed Bombay Act or Regulation in force in the Bombay Presidency is omitted, which must be considered a speciality of this edition.

To enhance the utility of the publication and to make it a complete and thorough work of reference in all respects, all the Bombay Acts amending General (India) Acts in their application to the Presidency of Bombay are also included.

Regarding Sind, all the Bombay Acts (with the exception of the Karachi Municipal Act of 1933) solely applicable to the Province of Sind, are separately printed and supplied free to the customers from Sind.

Thus it will be seen that no pains have been spared to make this publication an exhaustive work of reference for the Bombay Presidency including Sind.

It is, therefore, earnestly hoped that the legal public, whose patronage has done so much to encourage this work, will continue to extend the same warm and generous support to this new edition, as of old.

The Cattle-Trespass (Amendment) Act, 1924

Bom. Act No. IX of 1924

An Act further to amend the Cattle trespass Act, 1871

WHEREAS it is expedient further to amend the Cattle-trespass Act, 1871, in its application to the Presidency of Bombay in manner hereinafter appearing; It is enacted follows :---

1. This Act may be called the Cattle-trespass (Amendment) Act, 1924.

2. Amendment of section 6 of Act I of 1871.—After the proviso to section 6 of the Cattle-trespass Act, 1871, the following shall be inserted, namely :—

The Cattle- trespass (Bombay Amendment) Act, 1926

(Bom. Act No. IV of 1926).

[11th May 1926

An Act further to amend the Cattle Trespass Act, 1871, in its application to the Presidency of Bombay

WHEREAS it is expedient further to amend the Cattle-trespass Act, 1871, as amended by Bom. Act IX of 1924, in its application to the Presidency of Bombay in manner hereinafter appearing; It is hereby enacted as follows :--

1. This Act may be called the Cattle-trespass (Bombay Amendment) Act, 1926.

1. Amendment of section 6 of Act I of 1871.—In section 6 of the Cattle-trespass Act, 1871,

(I) for the second proviso, the following proviso shall be substituted, namely :--

Provided further that in the Presidency of Bombay

(a) in any local area which has been declared to be a village under clause (a) of section 3 of the Bombay Village Panchayats Act, 1920, when the police patel, or the head of the village, is the sarpanch or a member of the Panchayat, the Panchayat may appoint another person to be pound-keeper;

(b) in any local area in which the functions of the Magistrate of the District under this section are transferred to the local authority, the local authority may appoint another person to be pound-keeper;"

1. This Act may be called the Cattle-trespass (Bombay Amendment) Act, 1931.

2. Amendment of section 14 Act I of 1871.—In the provise to section 14 of the Cattle-trespass Act, 1871, for the words "Magistrate of the District" the words "officer authorised to sell them by public auction" shall be substituted.

The Coroners (Bombay Amendment) Act, 1930

Bombay Act No. XIII of 1930

[3rd September 1930.

An Act further to amend the Coroners' Act, 1871, in it application to the Presidency town of Bombay.

WHEREAS it is expedient further to amend the Coroners' Act, 1871, in its application to the Presidency town of Bombay, in manner hereinafter appearing : and Whereas the previous sanction of the Governor General required by section 80A (3) of the Government of India Act has been obtained for the passing of this Act; it is hereby enacted as follows :—

Short title.

1. This Act may be called the Coroners' (Bombay Amendment) Act, 1930.

Substitution of new sections for sections 8 to 20 of Act IV of 1871. 2. For sections 8 to 20 of the Coroners' Act, 1871, hereinafter called the said Act, the following shall be substituted, namely :---

8. (1) When the Coroner is informed that the dead body of a person is lying within his jurisdiction and there is reasonable cause to suspect that such person has died under any of the circumstances mentioned

in section 9 or has died a sudden death of which the cause is unknown, the Coroner may proceed to hold a preliminary inquiry on the body without a jury.

Ż

(2) For the purpose of an inquiry under subsection (1) the Coroner shall, as soon as practicable, after receipt of the information proceed to view and examine the body. Such view and examination shall be held in the presence of the Police Officer to whose section the case belongs and, if possible, in the presence of the relations or friends, if any, of the deceased and the Coroner may reduce to writing such observations as the appearance of the body requires. When the inquiry is concluded if the Coroner is satisfied as to the cause of death and if a *post-mortem* examination is in his opinion not necessary, the Coroner may authorise the body to be disposed of.

Inquest by jury. 9. (1) If it appears to the Coroner either before or in the course of an inquiry under section 8, that there is reason to suspect :--

(a) that the deceased came by his death by homicide, suicide or infanticide; or

(b) that the death was caused by an accident, or poison, or machinery; or

(c) that the death was caused by an occurrence arising out of the use of a vehicle in a street, public road or in private place; or

(d) that the death occurred in a prison in which the deceased was a prisoner or that it occurred whilst the deceased was in the custody of the police; or

(e) that the death occurred in circumstances the continuance or possible recurrence of which is prejudicial to the health or safety of the public or any section of the public;

and in any other case, if it appears to the Coroner either before or in the course of the preliminary inquiry that there is reason for holding an inquest by jury, he shall proceed to hold such inquest, whether or not the cause of death arose within his jurisdiction.

(2) Such inquest shall ordinarily be held in the Coroner's Courthouse.

(3) The Coroner may hold one inquest on the bodies of several persons provided that they all are believed to have come by their deaths, in or in consequence of one and the same incident.

(4) Every such inquest shall be deemed to be a judicial proceeding within the meaning of section 193 of the Indian Penal Code and for the purpose of any such inquest the Coroner shall have and may exercise all the powers of a Criminal Court under section 476 and section 480 of the Code of Criminal Procedure, 1898.

(5) The Coroner may hold an inquest by jury simultaneously with the preliminary inquiry.

10. (1) When a person dies in a prison situate within the local

Report to Coroner when prisoner or person in police enstody dies, limits of the Coroner's jurisdiction or whilst he is in the custody of the police the Superintendent of the prison or the police officer in charge of the section concerned, as the case may be, shall

report the death to the Coroner and await his orders before the body is disposed of.

(2) Any Superintendent of Prison or any such police officer who fails to comply with the requirement in sub-section (1) shall, on conviction before a Magistrate, be punished with fine which may extend to five hundred rupees. 11. (1) Any person who, with the intention of preventing the holding of an inquest on a dead body which the

Penalty for disposal of body to prevent an inquest Coroner is bound to hold under section 9, buries, cremates or otherwise disposes of it, and any

person who with such intention abets such burial, cremation or disposal of a dead body shall, on conviction before a Magistrate, be punished with fine which may extend to five hundred rupees.

(2) Such punishment shall be in addition to the punishment to which such person may be liable for any offence of which he may be found guilty in respect of the death of the deceased or under section 201 of the Indian Penal Code.

12. A coroner may order a body to be disinterred within a resonable time after the death of the deceased person,

Power to order body to be disinterred. either for the purpose of taking an original inguisition where none has been taken, or a fur-

quisition where none has been taken, or a further inquisition where further inquisition is, in the opinion of the Coroner, necessary or desirable in the interests of justice.

13. In order to the impanelling of a jury for an inquest under section 9 the Coroner shall summon not less

Summoning jury. Section 9 the Coroner shall summon hot less sons to appear before him at a time and place to be specified in the summons for the purpose of inquiring where, when and by what means the deceased came by his death.

14. (1) On the day and at the hour fixed for the inquest the Opening Court. Jurors to be sworn.

jurors on whom summonses under section 13 have been duly served. If not less than five jurors are in attendance the Coroner shall administer an oath to each juror to give a true verdict according to the evidence.

(2) If the number of jurors in attendance is less than five, or, if in the course of an inquest at any time before the return of the verdict a juror is absent and it is not practicable to enforce his immediate attendance, the Coroner may appoint such number of persons as may be necessary to serve as jurors in the inquest.

Inquest may be on Sunday or public holiday. 14A. An inquest under this Act or its adjourned hearing under section 21 may be held on a Sunday or a public holiday.

15. At or before the first sitting of an inquest on a body the Coroner shall view the body and if before the

View of body body bas been disposed of, a majority of the jurors so desire, it shall be viewed by the jurors also :

Provided that when a preliminary inquiry on the body has been held under section 8, or if from the medical evidence or from a medical certificate, the Coroner is satisfied that no advantage will result from such viewing, the Coroner may dispense with a view of the body at the inquest.

16. The Coroner shall then make proclamation for the attendance of witnesses, or, where the inquiry is con-Proclamation for witnesses ducted in secret, shall call in separately such as know anything concerning the death.

17. (1) It shall be the duty of all persons acquainted with the circumstances attending the death to appear be-Summoning witnesses. fore the inquest as witnesses. The Coroner shall inquire of such circumstances and the cause of death, and if before or during the inquiry he is informed that any person, whether within or without the local limits of his jurisdiction, can give evidence or produce any document material thereto, may issue a summons requiring him to attend and give evidence or produce such document on the inquest.

(2) When any person so summoned fails to appear and the summons has been proved to be duly served on him in time to admit of his appearing in accordance therewith and no reasonable excuse is offered for such failure, the Coroner may, after recording his reasons in writing, issue a warrant for his arrest. Such warrant shall be exe-outed as if it were issued under section 90 of the Code of Criminal Procedure, 1898.

(3) Any person disobeying a summons issued under sub-section (1) shall be deemed to have committed an offence under section 174, section 175 or section 176 of the Indian Penal Code, as the case may be.

(4) For the purpose of causing prisoners to be brought up to give evidence the Coroner shall be deemed a criminal court within the meaning of Part IX of the Prisoners Act, 1900.

18. (1) If before proceeding to view a body under section 8 or at

Post-mortem examinations, Fees to medical witnesses. Report of Ohemical Examiner.

the view or at any stage of an inquest by jury, it appears to the Coroner that a post-mortem examination of the body is necessary to ascertain the cause of death, he may direct such examination to be held by his Surgeon or by a

duly qualified Registered Medical Practitioner invited to attend as a witness. The Coroner may also direct an analysis of any of the organs or parts of the body or of their contents. Every Medical witness other than the Chemical Examiner to Government and the Coroner's Surgeon shall be entitled to such reasonable remuneration as the Coroner thinks fit. For the purpose of such post mortem examination the Coroner may order the removal of the body to any place within his jurisdiction which may be provided for that purpose.

(2) Any document purporting to be 'a report under the hand of any Chemical Examiner or Assistant Chemical Examiner to Government upon any matter or thing duly submitted to him for examination, or analysis and report in the course of any proceeding under this Act, may be used as evidence in any inquest under this Act and in any subsequent inquiry, trial or other proceeding under the Code of Criminal Procedure, 1898.

19. (1) All evidence given under this Act shall, except in the

Evidence to be on oath. Evidence on behalf of accused Interpreter.

case provided in sub-section (2), be on oath and the Coroner shall be bound to receive the evidence on behalf of the person who is alleged to have caused or to be concerned in causing the death of the deceased person.

(2) If such person himself wishes to make a statement it shall be the duty of the Coroner to warn him that he is not bound to make any statement; but if such person persists, the Coroner shall, without administering him any oath, record his statement in full after duly warning him that any incriminating statement which he may make may be used in evidence in any subsequent inquiry, trial or other proceeding under the Code of Criminal Procedure, 1898.

(3) For the purpose of section 26 of the Indian Evidence Act, 1872, a Coroner shall be deemed to be a Magistrate.

(4) Witnesses unacquainted with the English language shall be examined through the medium of an interpreter, who shall be sworn to interpret truly as well the oath as the question put to, and the answer given by each witness.

(5) After each witness has been examined, the Coroner shall enquire iwhether the jury wish any further questions to be put to the witness, and if the jury wish that any such questions shall be put the Coroner shall put them accordingly.

Mode of recording evidence. 20. (1) The evidence given to the jury shall be recorded in the manner prescribed in section 356 of the Code of Criminal Procedure, 1898.

(2) For the purpose of this section the Coroner shall be deemed to be a Magistrate.

3. After section 21 of the said Act, the following section shall be inserted, namely :---

"21A. (1) If on an inquest touching a death, the Coroner is in-

Inquest to be adjourned if criminal proceedings have been instituted before a Magistrate. formed, before the jury have given their verdict, that criminal proceedings have been instituted against some person before a Magistate in respect of an offence touching the death of the deceased, he may adjourn the inquest until after

the conclusion of the criminal proceedings and may, if he thinks fit, discharge the jury.

(2) After the conclusion of the criminal proceedings which it shall be the duty of the police to communicate to the Ooroner, the Coroner may, subject as hereinafter provided, if he thinks fit, resume the adjourned inquest:

Provided that at such resumed inquest no inquisition shall be held against any person in respect of any offence with which he was charged or of which he could have been convicted in the proceedings referred to in sub-section (1), and no finding shall be recorded which is inconsistent with the determination of any matter by the result of those proceedings.

(3) Where the Coroner resumes an inquest which has been adjourned and the Jury has been discharged, he shall proceed in all respects as if the inquest had not previously been begun and the provisions of this Act shall apply accordingly as if the resumed inquest were a fresh inquest, except that it shall not be obligatory on the Coroner to view the body.

(4) If, having regard to the result of the criminal proceedings, the Coroner decides not to resume the inquest, he shall furnish the Commissioner of Police with a certificate stating the result of the criminal proceedings and any particulars necessary for the registration of the death which may have been ascertained.

(5) For the purposes of this section, the expression 'the criminal proceedings' means the proceedings before a Magistrate and before any court to which the accused person is committed for trial or before which an appeal from the conviction of that person is heard, and criminal proceedings shall not be deemed to be concluded until no further appeal can be made in the course thereof."

Substitution of new section 31 for section 31 of lowing shall be substituted, namely :---Act IV of 1871.

"31. (1) The Coroner shall prepare and from time to time revise

a list of sufficient number of persons of good character and adequate education, liable to serve as jurors in his Court.

(2) All male persons between the ages of twenty-one and sixty whose names are not in the Common Jury list of the High Court, shall, subject to the exemptions mentioned in section 320 of the Code of Criminal Procedure, 1898, be liable to serve as jurors in the Coroner's Court.

(3) Whenever any person has been duly summoned to appear as a juror by a Coroner, and fails or neglects to attend at the time and place specified in the summons, the Coroner may cause him to be openly called in his Court three times to appear and serve as a juror, and upon the non-appearance of such person, and proof that such summons has been served upon him or left at his usual place of abode, may impose such fine upon the defaulter, not exceeding fifty rupees, as to the Coroner seems fit :

Provided that the Coroner may, in his discretion, remit any fine so imposed."

WHEREAS it is expedient to amend the Code of Criminal Procedure, 1898, in its application to the Presidency of Bombay, for the purposes hereinafter appearing ; And whereas the previous sanction of the Governor-General required under sub-section (3) of section 80A of the Government of India Act has been obtained for the passing of this Act ; It is hereby enacted as follows :----

(1) This Act may be called the Bombay 1. Short title and extent, Criminal Procedure (Election Offences) Amendment Act, 1935.

(2) It shall apply to the whole of the Presidency of Bombay.

(1) This Act may be called the Identifi-1. Short title and extent. cation of Prisoners (Bombay Amendment) Act, 1935.

(2) It extends to the whole of the Presidency of Bombay.

Amendment of section .4 of XXXIII of 1920.

WHEREAS it is expedient to amend the Identification of Prisoners Act, 1920, in its application to the Presidency of Bombay, for the purpose hereinafter appearing ; And whereas the previous sanction of the Governor General required by sub-section (3) of section 80A of the Government of India Act has been obtained for the passing of this Act; It is hereby enacted as follows :-

1. (1) This Act may be called the Identifi-Short title and extent, cation of Prisoners (Bombay Second Amendment) Act, 1935.

(2) It extends to the whole of the Presidency of Bombay.

2. In clause (α) of section 3 of the Identification of Prisoners Act, 1920, hereinafter called the said Act, after

Amendment of section 4, Act XXXIII of 1920,

Female Infanticide Prevention (Amendment)Act

BOMBAY ACT No. III OF 1897

WHEREAS it is expedient to amend as to the Presidency of Bombay, in manner hereinafter appearing, Act VIII of 1870 of the Governor General of India in Council; And whereas the previous sanction of the Governor General required by section 5 of the Indian Councils Act, 1892, has been obtained for the passing of this Act; It is hereby enacted as follows :--

1. Application of accumulated funds collected under Act VIII of 1870 .-- Notwithstanding any thing contained in Act VIII of 1870 (an Act for the prevention of the murder of female infants) or in the rules made thereunder, it shall be lawful for the Governor of Bombay in Council, from time to time, by notifications published in the official Gazette, to direct that the whole or any part of any moneys, or of any income or accumulated interest accrued or accruing from any moneys heretofore levied or recovered from, or paid by any inhabitants of the district of Kaira, under or for the purposes of the said Act, or any rule made in pursuance thereof, shall be applied for the educational benefit of the Lewa or Kunbi castes or any members thereof in the Kaira District, in such manner as the Local Government may deem expedient, and that the whole or any part of any moneys heretofore levied or recovered from, or paid by, any inhabitants of the district of Ahmedabad, under or for the purposes of the said Act, or any rule made in pursuance thereof, shall be applied for the educational benefit of the Lewa and Kadva Kunbi castes or any members thereof in the Ahmedabad District, in such manner as the Local Government may deem expedient, and to cancel or vary such notifications.

2. Commencement of Act VIII of 1870 in Bombay Presidency.--Notwithstanding anything contained in section 7 of Act VIII of 1870, the said Act shall be deemed to extend, and from the 21st December 1870 to have extended, to the Presidency of Bombay.

The Indian Limitation (Amendment) Act, 1912 BOM. AOT No. XIII OF 1912

An Act to amend the Indian Limitation Act, 1908

WHEREAS it is expedient to amend the Indian Limitation Act, 1908, in the manner hereinafter appearing :

And whereas the previous sanction of the Governor General required by section 5 of the Indian Councils Act, 1892, has been obtained for the passing or this Act; It is hereby enacted as follows :--

1. This Act may be called the Indian Limitation (Amendment) Act, 1912.

2. Notwithstanding anything contained in the Indian Limitation Act, 1908, hereinafter called the said Act, in computing the period of two years mentioned in section 31 of the said Act in the case of any suit by a mortgagee for foreclosure or for sale for which a certificate granted under section 46 of the Dekkhan Agriculturists' Relief Act, 1870, is required the time intervening between the application made by the mortgagee under section 39 of the last mentioned Act. and the institution of such suit shall be excluded, provided that such suit has already been instituted, or is instituted within six months from the commencement of this Act; and no such suit shall be dismissed on the ground that the certificate was not obtained within the year immediately preceding the filing of the suit.

3. Applicability of section 4 of the Indian Limitation Act, 1908.--The period of two years mentioned in section 31 of the said Act shall for the purposes of this Act be deemed to be a period of limitation within the meaning of section 4 of the said Act.

4. Retrospective effect of section 3.—The provisions of section 3 shall be deemed to have come into operation from the 7th day of August, 1908.

5. Provision for restoration of suits.—(1) Where the claim of a mortgagee for foreclosure or for sale for which a certificate granted under s. 46 of the Dekkhan Agriculturists' Relief Act, 1879, is required has been wholly or in part dismissed or withdrawn after the seventh day of August, 1910, and before the commencement of this Act either in a Court of first instance or of appeal or of revision, and the Court on application made as hereinafter provided is satisfied that such claim was so dismissed or withdrawn on the ground that,

(a) the time intervening between the application made by the mortgagee under section 39 of the Dekkhan Agriculturists' Relief Act, 1879, and the grant of the certificate under section 46 of the last mentioned Act or the institution of the suit, as the case may be, could not be excluded in computing the period of two years mentioned in section 31 of the said Act, or

(b) the certificate was not obtained within the year immediately preceding the filing of the suit, or

(c) the period of two years mentioned in section 31 of the said Act was not a period of limitation within the meaning of section 4 of the said said Act,

the case shall be restored on an application in writing to the Court, by which the claim was dismissed or in which it was withdrawn; provided that such application is made within six months from the commencement of this Act.

(2) Where any such claim as aforesaid has been dismissed for failure to prosecute such claim after the seventh day of August, 1910, and before the commencement of this Act, either in a court of first instance or of appeal or of revision, and the court on application made as hereinafter provided is satisfied that such failure was due to the belief that such claim, if prosecuted, would be dismissed for any of the grounds specified in clauses (a), (b) and (c) of sub-section (1),

the case shall be restored on an application in writing to the Court by which the claim was dismissed; provided that such application is made within six months from the commencement of this Act.

(3) The provisions of sections 2, 3 and 4 shall apply to any case restored under either of the foregoing sub-sections.

6. Provision for restoration of applications.—Any application by the mortgagee under section 39 of the Dekkhan Agriculturists' Relief Act, 1879, in respect of any claim for sale or foreclosure as to which the mortgagee was entitled to the benefit of the two years' period mentioned in section 31 of the said Act, made on or before the eighth day of August, 1910, and dismissed after the twenty-third day of February, 1911, shall be restored to the file of the Conciliator provided that the application for such restoration is made within two months from the commencement of this Act.

7. Third parties protected.—Nothing in this Act shall affect the interests of third parties that may have come into existence between the Twenty-third of February, 1911, and the twenty-eighth of September, 1912.

WHEREAS it is expedient further to amend the Indian Motor Vehicles Act, 1914, in its application to the Presidency of Bombay in manner hereinafter appearing; and whereas the previous sanction of the Governor General required by sub-section (3) of section 80A of the Government of India Act has been obtained for the passing of this Act; It is hereby enacted as follows :---

Short title.

1. This Act may be called the Indian Motor Vehicles (Bombay Amendment) Act, 1931.

2. After section 18 of the Indian Motor

(2) In any such event as is referred to in sub-section (1) the provisions of sub-sections (3) to (7) of section 18 shall, so far as may be, apply to such permits and the holders thereof as if such permits were licences under this Act and the holders of such permits were holders of such licences, and as if

An Act to amend the Mussalman Wakf Act, 1923, in its application to the Presidency of Bombay.

WHEBAS it is expedient to amend to Mussalman Wakf Act, 1923, in its application to the Presidency of Bombay for the purposes hereinafter appearing;

AND WHEREAS the previous sanction of the Governor General required by sub-section (3) of section 80A of the Government of India Act and the sanction of the Governor under section 80C of the said Act have been obtained for the passing of this Act ;

It is hereby enacted as follows :--

Short title.

1. This Act may be called the Mussalman Wakf (Bombay Amendment) Act, 1935.:

2. After the preamble of the Mussalman Heading after the pre. amle of XLII of 1923, 3 Wakf Act, 1923, hereinafter called the principal Act, the heading "Part I" shall be inserted.

Amendment of section 2 of XLII of 1923.

3. In section 2 of the principal Act,-

fix, a statement containing all or any of the particulars referred to in the said section, including a copy of the deed or instrument, if any, creating the wakf.

(2) The provisions of section 4 shall apply to a statement furnished under this section as if such statement had been furnished under section 3.

PART IV.

Powers of the Court to Enquire.

(1) The court may, either on its own motion or upon the 6C. application of any person claiming to have an Power of court to inquire interest in a wakf, hold an enquiry in the prescribed manner at any time to ascertain-

(i) whether a wakf is a wakf to which this Act applies;

(ii) whether any property is the property of such wakf and whether the whole or any substantial portion of the subject matter of such wakf is situate within the local limits of the jurisdiction of the court; and

(iii) who is the mutawalli of such wakf.

(2) If it comes to the knowledge of the court that a suit has been instituted in any civil court in regard to any of the matters mentioned in sub-section (1), it shall stay the enquiry so far as it relates to; or is likely to be affected by, the court's findings or order in regard to such matters, until the suit is finally decided in that court.

(3) The court shall from time to time ascertain whether such suit has been finally decided and after the final decision of the suit, it shall proceed with the enquiry in regard to such matters, if any, as may not have been decided in such suit.

(4) On completion of the enquiry provided for in sub-sections (1) and (3), the court shall record its findings as to the matters mentioned in the said sub-sections, except such matters as may have been decided in the aforesaid suit.

(5) Save as provided in this section, the court shall not, when acting under this section, try or determine any question of the title of any person claiming adversely to the wakf.

PART V.

Registration of Wakfs, Wakf Accounts and Wakf Administration Funds.

6D. (1) The court shall, after the submission of a statement under section 3 or section 4 or section 6A and Registration of Wakis. an enquiry, if necessary, held under section 6C,

or merely after an enquiry held under section 6C, record, in such form as may be prescribed in a register called the

(b) the gross annual income from such property;

(c) the gross amount of such income which has been collected during the five years preceding the date on which the statement is furnished, or during the period which has elapsed since the creation of the wakf, whichever period is shorter;

(d) the amount of the Government revenue and cesses and of all rents annually payable in respect of the wakf property;

(e) an estimate of the expenses annually incurred in the realisation of the income of the wakf property, based on such details as are available of any such expenses incurred within the period to which the particulars under clause (c) relate;

(f) the amount set apart under the wakf for-

- (i) the salary of the mutawalli and allowances to individuals;
- (ii) purely religious purposes;
- (iii) charitable purposes;
- (iv) any other purposes;

(g) the name of the mutawalli; and

(h) such other particulars as may be prescribed.

(2) Statements, if any, furnished under sections 3, 4 and 6A shall be filed with the said Register of Wakfs.

6E. (1) When any change occurs in any of the particulars recorded in the Register of Wakfs, the muta-Amendment of entries walli shall, within three months of the occurin Register of Wakfs. rence of such change, report to the court such change in the prescribed form, accompanied by the prescribed fee. The provisions of sections 3 and 4 shall, so far as may be, apply to

any such statement.

(2) For the purpose of verifying the correctness of the entries in the Register of Wakfs or ascertaining any change which may have occurred in such register, the court may hold an enquiry in the prescribed manner. The provisions of section 6C shall, so far as may be, apply to any such inquiry.

(3) If the court, after receiving a report under sub-section (1) and holding an enquiry, if necessary, under sub-section (2), or merely after an enquiry held under sub-section (2), is satisfied that a change has occurred in any of the particulars recorded in the Register of Wakfs with regard to a wakf, it shall amend in the prescribed manner the entry or entries affected by such change and shall file the report furnished under sub-section (1) along with the statement, if any, relating to the said wakf filed under section 3.

Entries in the Register of Wakfs and findings recorded under section 6C to be final, subject to section 6G.

6F. The entries made by the court in the Register of Wakfs and the findings recorded under section 6C shall, subject to the provisions of section 6G, be final for the purposes of this Act.

(3) Every auditor acting under sub-section (2) shall have access to the accounts and to all books, vouchers and other documents and records in the possession and under the control of the mutawalli :

Provided that, if it is proved to the satisfaction of the court that the gross annual income of any particular wakf is less than two hundred rupees, the court may by order in writing exempt such wakf from the provisions of this section.

61. Every wakf shall, for the purpose of meeting the charges Annual contribution from wakfs.

(a) any fee which may be levied under this Act,

(b) contributions under section 61,

(c) any sums received by the Wakf Administration Fund from private sources,

(d) any sums allotted by Government or by any local authority to the Wakf Administration Fund.

The Wakf Administration Fund of a district shall be under Application of Wakf Administration Fund. the control and management of the court and shall be applicable to the payment of charges for and expenses incidental to the registration, superintendence, administration and control of wakfs, the maintenance of the Register of Wakfs, the scrutiny and audit of accounts of wakfs, the institution and defence of suits and proceedings relating to wakfs, and generally carrying into effect the purposes of this Act.

Supervision and Control.

6L. (1) There shall be constituted in each district a wakf com-Constitution and appointment of Wakf Committee. Constitution and appointdence, administration and control of wakfs.

(2) The Committee shall consist of:-

(a) the members of the Indian and Local Legislatures,

(b) two members elected in the prescribed manner by the mutawallis of all wakfs in the district registered under the Act,

(c) two members elected in the prescribed manner by the members of each district local board in the district professing the Mussalman faith from among their number, (d) one member elected in the prescribed manner by the members professing the Mussalman faith of each municipality in the district constituted under the Bombay District Municipal Act, 1901,

(e) two members elected in the prescribed manner by the members professing the Mussalman faith of each municipality in the district constituted under the City of Bombay Municipal Act, 1888, the City of Karachi Municipal Ac^{*}, 1933, or the Bombay Municipal Boroughs Act, 1925, and

(f) such other members not exceeding one-fourth of the total number of the members of the Committee as the Local Government may nominate:

Provided that no person who does not ordinarily reside in the district or does not profess the Mussalman faith shall be eligible to be a member of the Committee.

6M. (1) It shall be competent to the court to refer at any time to Functions of Wakf Committee. Founctions of Wakf Committee. For advice, opinion, enquiry, report or recommendation, within such time as the court may direct, any matter relating to the registration, superintendence, administration and control of wakfs, and in particular any matter relating to-

(a) the conduct of a mutawalli or a trustee in the administration of a wakf or his fitness to continue as a mutawalli or a trustee,

(b) the settlement, cancellation or alteration of a scheme for the administration of a wakf, or

(c) the application of the funds of a wakf or any surplus thereof.

(2) When the court has referred any of the matters mentioned in sub-section (1) to a wakf committee or any members thereof for advice, opinion, enquiry, report or recommendation, and the committee or the members thereof, as the case may be, have, either unanimously or by a majority, made their recommendation in relation to the matter referred to them, the court may pass orders as it thinks fit after giving due consideration to such recommendation—

(i) suspending, removing or dismissing a mutawalli or trustee,

(ii) appointing a new mutawalli or trustee,

(iii) settling, cancelling or altering a scheme for the administration of a wakf,

(iv) directing the application, investment or deposit of the funds of a wakf or any surplus thereof in a particular manner or to a particular purpose,

(v) generally for carrying out the purposes of the Act.

Provided that nothing in this section shall be deemed to authorise the court to pass any order which is inconsistent with the objects and purposes of the wakf.

Provided further that no order under this section shall be passed to the prejudice of any mutawalli or trustee without giving such mutawalli or trustee an opportunity to be heard.

(3) For the performance of any of the duties under sub-section (2) the Wakf Committee or any members thereof to whom the court has referred any matter for advice, opinion, enquiry, report, or recommen-

dation, the committee or such members thereof may by order in writing require-

(a) the production of any document necessary for the purpose ;

(b) the attendance of any person for the purpose of giving evidence or for the production of any document referred to in clause (a).

(4) The provisions of sub-sections (2) and (3) of section 6C shall, so far as may be, apply to any inquiry under sub-section (1) or (2).

ed with fine which may extend to one hundred rupees. (2) The Local Government may, by general or special order, appoint places to be infirmaries for the treatment and care of animals in respect of which offences against sub-section (1) have been com-

(3) The Magistrate before whom a prosecution for such an offence has been instituted may direct that the animal in respect of which the offence is alleged or proved to have been committed shall be sent for treatment and care to an infirmary and be there detained until, except as provided for in sub-section (4), it is in his opinion or in the opinion of some other Magistrate, again fit for the work or labour on which it has been ordinarily employed. If, however, the Magistrate decides that the animal will never again be fit he may direct that it shall be destroyed or sent to a pinjrapole.

(4) Within any specified area the Local Government may, when any animal has been sent to an infirmary under sub-section (2). authorize any veterinary officer to issue a certificate that in his opinion such animal is fit for the work or labour on which it has been ordinarily employed and such animal shall not be released from detention unless and until such certificate shall have been issued or the Magistrate directs that it shall be destroyed or sent to a pinjrapole.

(5) The cost of the transport to the infirmary and the treatment, feeding and watering of the animal in the infirmary shall be payable by the owner of the animal according to such scale of rates as the District Magistrate or, in the case of an infimary in a Presidency town, the Commissioner of Police may from time to time prescribe.

*(6) (a) If in the case of an animal directed to be destroyed or sent to a pinjrapole under sub-section (4), the owner refuses or neglects to pay the costs incurred in respect of the animal under subsection (5), such cost shall be recoverable from the owner as a fine on the order of a Magistrate, provided that no such order shall be made without the owner being given an opportunity of showing cause, before the Magistrate, why such costs should not be recovered;

(b) if, in the case of an animal certified under sub-section (4) to be fit for work or labour, the owner refuses or neglects to remove the animal within such time as a magistrate may prescribe and to pay the cost incurred in respect of the animal under sub-section (5) the magistrate may direct the animal to be sold and the proceeds of the sale to be applied to the payment of such cost.

(7) The surplus, if any, of the proceeds of the sale shall, on application made by the owner within two months after the date of the sale, be paid to him.

(8) If the cost incurred under sub-section (5) shall exceed the proceeds of the sale, the excess to such extent as shall seem reasonable shall be recoverable from the owner as a fine on the order of a Magistrate, provided that no such order shall be made without the owner being given a reasonable opportunity of urging his objections, if any, before the Magistrate.

(2) This Act shall extend in the first instance to the Province of Sind or such area in the said Province with effect from such date as the Local Government may by notification in the local official Gazette appoint. (b) A licence shall be liable to be suspended, withdrawn or cancelled only on the ground that the owner or person in charge of the cotton ginning or cotton pressing factory in respect of which a licence was granted has been convicted of an offence punishable under this Act:

Provided that no licence shall be suspended, withdrawn or cancelled under this clause until after the expiration of the season in which the said owner or person has been so convicted.

(3) If any person works a cotton ginning or cotton pressing factory in respect of which a licence has not been granted or that been suspended, withdrawn or cancelled, such person shall be punishsble :---

(a) on a first conviction, with fine which may extend to five hundred rupees and, if the offence has continued for more than one day, with an additional fine which may extend to one hundred rupees for every day subsequent to the first day during which the offence has continued ; and

(b) on every subsequent conviction, with fine which may extend to fifteen hundred rupees and, if the offence has continued for more than one day, with an additional fine which may extend to two hundred rupees for every day subsequent to the first day during which the offence has continued."

(a) who knowing or having reason to believe that any cotton is watered or contains seed in excess of the prescribed proportion or contaians any foreign substance, gins or presses or allows such cotton to be ginned or pressed in such factory, or

(b) who in area specified in the notification under sub-section (1) gins or presses or allows to be ginned or pressed any cotton which he knows or has reason to believe to contain an admixture of cotton.

shall, on conviction, be punishable with fine which may extend to five thousand rupees. 1.45

(3) Any owner of cotton who knowingly waters any cotton which is ginned and which is being, or is intended to be, pressed in a cotton pressing factory, or mixes seed or foreign substance with such cotton, or in any area specified in sub-section (1) makes any admixture of cotton, or abets or knowingly allows or connives at any such watering, mixing or admixture of cotton, shall, on conviction, be punishable with fine which may extend to five thousand rupees.

Explanation.—For the purposes of this section, cotton shall not be deemed to be watered, unless such cotton contains moisture in excess of the normal quantity. The normal quantity of moisture in any given quantity of cotton is the amount of moisture that such cotton is reasonably expected to have, regard being had to the place or places at or to which, and the time or times of the year in which, such cotton has been picked, collected, stored, conveyed, left ginned or pressed. A certificate given by the prescribed authority as to the normal quantity of moisture that a given quantity of such cotton should have and the quantity of moisture that it possesses shall be evidence of such matters, until the contrary is proved ; and if the latter quantity exceeds the former it shall be evidence, until the contrary is proved, that the cotton is watered.

Examination of cotton, packages or bales.

3B. (1) The Local Government or any gazetted officer authorised by it in this behalf may on its or his own motion or on receipt of a complaint that there has been a contravention of the provisions of section 3A in respect of any

cotton, package or of any bale and in the case of a complaint, on payment of the prescribed fee by the complainant, cause such cotton or the contents of such package or bale to be examined by tha prescribed person or body.

(2) A certifiate given by such person after examination of the contents of any bale under sub-section (1) shall be admissible in evidence and be presumptive proof of the facts mentioned therein until the contrary is proved.

3C. (1) The Local Government may authorise any gazetted

officer to enter into and inspect, at any reasonable time, any cotton ginning or cotton pressing factory for the purpose of ascertaining whether there is any contravention

therein of any of the provisions of this Act or of any rule made thereunder or of any of the conditions subject to which a licence has been granted in respect of such factory and to seize all things in respect of which an offence punishable under this Act appears to have been committed.

(2) The owner or the person in charge of every cotton ginning or cotton pressing factory shall give every reasonable assistance to the inspecting officer in the performance of his duties under sub-section (1).

(3) The owner or the person in charge of such factory shall, in every instance, be permitted to attend during the inspection and the things seized during such inspection shall be sealed in the prescribed manner."

"5. (1) The owner of every cotton ginning factory shall submit to the prescribed authority, within such time and in such form, as may be prescribed, monthly returns showing the

(2) The Local Governmant shall compile from the monthly returns submitted under sub-section (1), and shall publish in such manner as the Governor-General in Council may direct, a state-1 ment showing the total quantity of cotton ginned in the province during the month and from the commencement of the season to the end of the month to which the returns relate;

Provided that the quantity of cotton ginned in any individual factory shall not be published.

(3) The owner of every cotton pressing factory shall submit to the prescribed authority, within such time and in such form, as may be prescribed, weekly returns showing the total number of bales of cotton pressed during the preceding week and from the commencement of the season to the end of that week, and the approximate average net weight of the bales pressed in that week.

(4) The Local Government shall compile from the weekly returns submitted under sub-section (3), and shall publish in such manner as the Governor-General in Council may direct, a statement showing the total number of bales pressed in the province during the week and from the commencement of the season to the end of the week to which the returns relate:

Provided that the numb r of bales pressed in any individual factory shall not be published.

(5) If default is made in submitting any return as required by sub-section (1) or sub-section (3), the owner of the factory shall, on conviction, be punishable with fine which may extend to fifty rupees,

(6) When the owner of a cotton ginning or cotton pressing factory has notified to the prescribed authority that the work of ginning cotton or pressing bales in that factory has been suspended, it shall not be necessary for the owner to submit returns under sub-section (1) or sub-section (3) until such work has been resumed."

The Indian Lunacy, Bombay District Municipal and Bombay Municipal Boroughs (Amendment) Act, 1936

BOMBAY ACT No. XV OF 1936

[27th November 1936.

An Act to amend the Indian Lunacy Act, 1912, in its application to the Presidency of Bombay, the Bombay District Municipal Act, 1901, and the Bombay Municipal Boroughs Act, 1925

WHEREAS it is expedient to amend the Indian Lunacy Act, 1912, in its application to the Presidency of Bombay, the Bombay District Municipal Act, 1901, and the Bombay Municipal Boroughs Act, 1925, for the purposes hereinafter appearing; And whereas the previous sanction of the Governor General required by sub-section (3) of section 80A of the Government of India Act has been obtained for the passing of this passing of this Act; It is hereby enacted as follows :---

1. This Act may be called the Indian Lunacy, Bombay District Municipal and Bombay Municipal Short title. Boroughs (Amendment) Act, 1936.

Amendment of section 2. In the Indian Lunacy Act, 1912-

(1) In section 88—

(i) after the words "has the means to maintain him", the words "or if any local authority is liable for the cost of maintenance of such lunatic under any law for the time being in force" shall be inserted;

(*ii*) the words "or any local authority liable for the cost of maintenance of such lunatic under any law for the time being in force" shall be deleted;

(*iii*) after the word "resides", the words "or the local authority liable for the cost of his maintenance is constituted" shall be inserted;

(iv) at the end of the marginal note, the following words shall be added, namely —

"or by local authority liable for such costs.

Amendment of section (2) In section 89-

(i) in sub-section (1)—

(a) after the words "such lunatic" where they occur for the second time, the words "or that any local authority is liable for the cost of maintenance of such lunatic under any law for the time being in force" shall be inserted;

(b) after the words "such person", the words "or from such local authority" shall be added ;

(c) at the end, the following proviso shall be added, namely :---

"Provided that no order for the recovery of the cost of maintenance of such lunatic from a local authority shall be made if he has an estate applicable to his maintenance or if there is any person legally bound, and having the means, to maintain him."

(*ii*) in sub-section (2), after the word "person", the words "or the local authority" shall be inserted.

Amendment of section **3**. In section 55 of the Bombay District 55 of Bom. III of 1901. Municipal Act, 1901—

(1) the words "habitually resident within or" shall be deleted;

(2) for the proviso the following shall be substituted namely:-

"Provided that wheere an application is made to the High Court or a District Court under the provisions of section 88 of the Indian Luanacy Act, 1912, no order for the payment of the cost of maintenance of the lunatic by a municipality shall be made without an opportunity being given to such municipality to show that the lunatic has an estate applicable to his maintenance or that there is a person legally bound, and having the means, to maintain him.

Provided further that the municipality shall not be liable under this section for the maintenance and treatment of any lunatic or leper in any such asylum, hospital or house as aforesid, unless such lunatic or leper, immediately previous to his admission thereto, has been resident in the municipal district for at least one year.

The officer in charge of an asylum to which lunatics or lepers for whose maintenance and treatment a municipality is liable under this section are admitted shall maintain a clear account of the cost of maintenance and treatment incurred on account of such person detained in the asylum and shall furnish a copy thereof to the municipality."
